# On the average behavior of the Fourier coefficients of $j^{t h}$ symmetric power $L$-function over a certain sequences of positive integers

#### Abstract

In this paper, we investigate the average behavior of the $n^{\text {th }}$ normalized Fourier coefficients of the $j^{\text {th }}(j \geq 2$ be any fixed interger) symmetric power $L$-function (i.e., $L\left(s, s y m^{j} f\right)$ ), attached to a primitive holomorphic cusp form $f$ of weight $k$ for the full modular group $S L(2, \mathbb{Z})$ over a certain sequences of positive integers. Precisely, we prove an asymptotic formula with an error term for the sum

$$

[^0]where $x$ is sufficiently large, and
$$
L\left(s, s y m^{j} f\right):=\sum_{n=1}^{\infty} \frac{\lambda_{s y m^{j} f}(n)}{n^{s}} .
$$

When $j=2$, the error term which we obtain, improves the earlier known result.

## 1 Introduction

Let $L(s, f)$ be the $L$-function associated with the primitive holomorphic cusp form $f$ of weight $k$ for the group $S L(2, \mathbb{Z})$ and let $\lambda_{f}(n)$ be the normalized $n^{\text {th }}$ Fourier coefficient of the Fourier expansion of $f(z)$ at the cusp $\infty$, i.e.,

$$
f(z)=\sum_{n=1}^{\infty} \lambda_{f}(n) n^{\frac{k-1}{2}} e^{2 \pi i n z}
$$

where $\Im(z)>0$. Then the $L$-function attached to $\lambda_{f}(n)$ is defined as

$$
L(s, f)=\sum_{n=1}^{\infty} \frac{\lambda_{f}(n)}{n^{s}}
$$

for $\Re(s)>1$, where $\lambda_{f}(n)$ are the eigenvalues of all the Hecke operators $T_{n}$.

Let $\chi$ be the Dirichlet character modulo $N$. Then $f$ is known as a modular form of weight $k$ and level $N$ with Nebentypus $\chi$, if

f\left(\frac{a z+b}{c z+d}\right)=\chi(d)(c z+d)^{k} f(z)
$$

for all $z \in \mathbb{H}$ (upper half plane) and $\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \Gamma_{0}(N)$, where $\Gamma_{0}(N)$ is the congruence subgroup, i.e.,

$$
\Gamma_{0}(N)=\left\{\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right) \in S L(2, \mathbb{Z}): c \equiv 0 \quad(\bmod N)\right\}
$$

In 1974, Deligne [2] proved that for any prime $p$ there exist complex numbers $\alpha(p)$ and $\beta(p)$ such that

$$

\alpha(p)+\beta(p)=\lambda_{f}(p) \tag{1.1}
\end{equation*}
$$

and

$$
\begin{equation*}
|\alpha(p)|=|\beta(p)|=1=\alpha(p) \beta(p) \tag{1.2}
\end{equation*}
$$

Then $L(s, f)$ can be written as

$$
L(s, f)=\prod_{p}\left(1-\frac{\alpha(p)}{p^{s}}\right)^{-1}\left(1-\frac{\beta(p)}{p^{s}}\right)^{-1} .
$$

Also, $\left|\lambda_{f}(n)\right| \leq d(n)$, where $d(n)$ is the divisor function.

The symmetric square $L$-function is defined as

$$
\begin{aligned}
L\left(s, s^{2} m^{2} f\right) & :=\sum_{n=1}^{\infty} \frac{\lambda_{s y m^{2} f}(n)}{n^{s}} \\
& =\prod_{p}\left(1-\frac{\alpha^{2}(p)}{p^{s}}\right)^{-1}\left(1-\frac{\beta^{2}(p)}{p^{s}}\right)^{-1}\left(1-\frac{1}{p^{s}}\right)^{-1}
\end{aligned}
$$

for $\Re(s)>1$, where $\lambda_{s y m^{2} f}(n)$ is multiplicative.

Several authors have studied the average behavior of these Fourier coefficients. In 2006, Fomenko [3] was able to prove some results for the symmetric square $L$-functions. He showed that

$$
\sum_{n \leq x} \lambda_{s y m^{2} f}(n) \ll x^{\frac{1}{2}} \log ^{2} x
$$

and further he could establish that

$$
\sum_{n \leq x} \lambda_{s y m^{2} f}^{2}(n)=c x+O\left(x^{\theta}\right)
$$

where $\theta<1$.
For more related results, see [19], [12], [7] and [13].

In 2013, Zhai [20] proved an asymptotic formula for

$$
\sum_{\substack{a^{2}+b^{2} \leq x \\(a, b) \in \mathbb{Z}^{2}}} \lambda_{f}^{l}\left(a^{2}+b^{2}\right)
$$

for $x \geq 1$, and $3 \leq l \leq 8$. For results related to mean square and higher moments of the coefficients of symmetric square $L$-functions on a certain
sequence of positive integers, see [16] and [17].

In an earlier paper [18], we considered the sum

$$
S^{*}:=\sum_{\substack{a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2} \leq x \\\left(a_{1}, a_{2}, a_{3}, a_{4}, a_{5}, a_{6}\right) \in \mathbb{Z}^{6}}} \lambda_{\text {sym }}^{2} 2\left(a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2}\right),
$$

for sufficiently large $x$ and established the asymptotic formula:

$$
\begin{equation*}
S^{*}=c^{*} x^{3}+O\left(x^{\frac{14}{5}+\epsilon}\right) \tag{1.3}
\end{equation*}
$$

where $c^{*}$ is an effective constant (see Theorem 1.1 of [18]).

The main aim of this paper is to generalize and improve the result obtained in [18] by using recent celebrated work ([14, [15]) of Newton and Thorne, and better subconvexity bounds for the related $L$-functions. More precisely, we prove

Theorem 1.1. Let $j \geq 2$ be any fixed integer. For sufficiently large $x$, and $\epsilon>0$ any small constant, we have

$$
\sum \quad \lambda_{s y m^{j} f}^{2}\left(a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2}\right)=c(j) x^{3}+O\left(x^{3-\frac{6}{3(j+1)^{2}+1}+\epsilon}\right)
$$

$a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2} \leq x$
$\left(a_{1}, a_{2}, a_{3}, a_{4}, a_{5}, a_{6}\right) \in \mathbb{Z}^{6}$
where $c(j)$ is an effective constant defined by

$$
c(j)=\frac{16}{3} L(3, \chi) \prod_{n=1}^{j} L\left(1, s y m^{2 n} f\right) L\left(3, s y m^{2 n} f \otimes \chi\right) H_{j}(3),
$$

and $\chi$ is the non-principal Dirichlet character modulo 4.
Remark. When $j=2$, Theorem 1.1 gives the error term $O\left(x^{\frac{39}{14}+\epsilon}\right)$, which improves the error term in (1.3).

## 2 Preliminaries and some important lemmas

Let $r_{k}(n):=\#\left\{\left(n_{1}, n_{2}, \ldots, n_{k}\right) \in \mathbb{Z}^{k}: n_{1}^{2}+n_{2}^{2}+\cdots+n_{k}^{2}=n\right\}$ allowing zeros, distinguishing signs, and order. We will be concerned with the function $r_{6}(n)$.

Lemma 2.1. For any positive integer $n$, we have

$$
\begin{equation*}
r_{6}(n)=16 \sum_{d \mid n} \chi\left(d^{\prime}\right) d^{2}-4 \sum_{d \mid n} \chi(d) d^{2} \tag{2.1}
\end{equation*}
$$

where $d d^{\prime}=n$, and $\chi$ is the non-principal Dirichlet character modulo 4, i.e.,

$$
\chi(n)= \begin{cases}1 & \text { if } n \equiv 1 \quad(\bmod 4) \\ -1 & \text { if } n \equiv-1 \quad(\bmod 4) \\ 0 & \text { if } n \equiv 0 \quad(\bmod 2)\end{cases}
$$

Proof. See, for instance, Lemma 2.1 of [18].

We can reframe (2.1) as

$$
\begin{align*}
r_{6}(n) & =16 \sum_{d \mid n} \chi(d) \frac{n^{2}}{d^{2}}-4 \sum_{d \mid n} \chi(d) d^{2} \\
& =16 l(n)-4 v(n)  \tag{say}\\
& =l_{1}(n)-v_{1}(n)
\end{align*}
$$

where $l_{1}(n)=16 l(n)$ and $v_{1}(n)=4 v(n)$.

Observe that $l(n)$ is a multiplicative function since $\chi(d)$ is completely multiplicative and hence multiplicative and $f(d)=\frac{n^{2}}{d^{2}}$ is also completely multiplicative. Therefore, $\chi(d) \frac{n^{2}}{d^{2}}$ is multiplicative and if $g(d)$ is any multiplicative function, then $\sum_{d \mid n} g(d)$ is also multiplicative. Similarly, $v(n)$ is also multiplicative.

Note that,

$$
\begin{gathered}
l(p)=p^{2}+\chi(p) \\
l\left(p^{2}\right)=p^{4}+p^{2} \chi(p)+\chi\left(p^{2}\right),
\end{gathered}
$$

and

$$
\begin{gathered}
v(p)=1+p^{2} \chi(p) \\
v\left(p^{2}\right)=1+p^{2} \chi(p)+p^{4} \chi\left(p^{2}\right) .
\end{gathered}
$$

Also, we can write

$$
\begin{aligned}
& \sum_{\substack{\left.2 \\
+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2} \leq x \\
, a_{3}, a_{4}, a_{5}, a_{6}\right) \in \mathbb{Z}^{6}}} \lambda_{\text {sym }^{2} f}^{2}\left(a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2}\right) \\
& =\sum_{n \leq x} \lambda_{\text {sym }^{2} f}^{2}(n) \sum_{\substack{n=a_{1}^{2}+a_{2}^{2}+a_{3}^{2}+a_{4}^{2}+a_{5}^{2}+a_{6}^{2} \\
\left(a_{1}, a_{2}, a_{3}, a_{4}, a_{5}, a_{6}\right) \in \mathbb{Z}^{6}}} 1 \\
& =\sum_{n \leq x} \lambda_{\text {sym }^{2} f}^{2}(n) r_{6}(n) \\
& =\sum_{n \leq x} \lambda_{s y m^{2} f}^{2}(n)\left(l_{1}(n)-v_{1}(n)\right) \\
& =16 \sum_{n \leq x} \lambda_{s y m^{2} f}^{2}(n) l(n)-4 \sum_{n \leq x} \lambda_{s y m^{2} f}^{2}(n) v(n),
\end{aligned}
$$

where $l(n)=\sum_{d \mid n} \chi(d) \frac{n^{2}}{d^{2}}$, and $v(n)=\sum_{d \mid n} \chi(d) d^{2}$.

For $j \geq 2$ (an integer), and $\Re(s)>1$, the $j^{\text {th }}$ symmetric power $L$-function of $f$ is defined as :

$$
\begin{align*}
L\left(s, s y m^{j} f\right) & :=\sum_{n=1}^{\infty} \frac{\lambda_{s y m^{j} f}(n)}{n^{s}} \\
& =\prod_{p} \prod_{i=0}^{j}\left(1-\frac{\alpha^{j-i}(p) \beta^{i}(p)}{p^{s}}\right)^{-1} . \tag{2.3}
\end{align*}
$$

Observe that,

$$
\begin{equation*}
\lambda_{s y m^{j} f}(p)=\sum_{m=0}^{j} \alpha^{j-m}(p) \beta^{m}(p) \tag{2.4}
\end{equation*}
$$

Since $\lambda_{\text {sym }}{ }^{j}(n)$ is a multiplicative function, and $\left|\lambda_{\text {symj }}{ }^{j}(n)\right| \leq d_{j+1}(n)$ (from (1.1), and (1.2)), where $d_{j+1}(n)$ is the number of ways of expressing $n$ as a product of $j+1$ factors), so we can write the Euler product of $L\left(s, s y m^{j} f\right)$ as

$$
\begin{equation*}
\prod_{p}\left(1+\frac{\lambda_{s y m^{j} f}(p)}{p^{s}}+\cdots+\frac{\lambda_{s y m^{j} f}\left(p^{l}\right)}{p^{l s}}+\cdots\right) \tag{2.5}
\end{equation*}
$$

Comparing (2.3), and (2.5), we get (2.4).
Also, due to Hecke

$$
\begin{equation*}
\lambda_{s y m}{ }^{j} f(p)=\lambda_{f}\left(p^{j}\right) . \tag{2.6}
\end{equation*}
$$

Further, note that

$$
\begin{equation*}
\lambda_{f}^{2}\left(p^{j}\right)=1+\sum_{l=1}^{j} \lambda_{f}\left(p^{2 l}\right) \tag{2.7}
\end{equation*}
$$

since,

$$
\begin{aligned}
\lambda_{f}^{2}\left(p^{j}\right) & =\left(\sum_{m=0}^{j} \alpha^{j-m}(p) \beta^{m}(p)\right)^{2} \\
& =\left(\sum_{m=0}^{j} \alpha^{j-m}(p) \beta^{m}(p)\right)\left(\sum_{m^{\prime}=0}^{j} \alpha^{j-m^{\prime}}(p) \beta^{m^{\prime}}(p)\right) \\
& =\sum_{m=0}^{j} \sum_{m^{\prime}=0}^{j}\left(\alpha^{2 j-\left(m+m^{\prime}\right)}(p)\right)\left(\beta^{\left(m+m^{\prime}\right)}(p)\right)
\end{aligned}
$$

(We put $m+m^{\prime}=t$. Observe that for every fixed integer $t$ in the interval $[0,2 l]$ and for every fixed integer $m$ in the interval $[0, l]$, there is a unique integer $m^{\prime}$ in the interval $[0, l]$ satisfying $m+m^{\prime}=t$ and thus,)

$$
\begin{aligned}
& =\sum_{l=0}^{j}\left(\sum_{t=0}^{2 l} \alpha^{2 j-t}(p) \beta^{t}(p)\right) \\
& =1+\sum_{l=1}^{j}\left(\sum_{t=0}^{2 l} \alpha^{2 j-t}(p) \beta^{t}(p)\right) \\
& =1+\sum_{l=1}^{j} \lambda_{f}\left(p^{2 l}\right) .
\end{aligned}
$$

Lemma 2.2. Let $f$ be a normalized primitive holomorphic cusp form of weight $k$ for $S L(2, \mathbb{Z})$, and let $\lambda_{\text {symj }^{j}}(n)$ be the $n^{\text {th }}$ normalized Fourier co-
efficient of the $j^{\text {th }}$ symmetric power L-function associated to $f$. If

$$
F_{j}(s)=\sum_{n=1}^{\infty} \frac{\lambda_{s y m^{j} f}^{2}(n) l(n)}{n^{s}}
$$

for $\Re(s)>3$, then

$$
F_{j}(s)=G_{j}(s) H_{j}(s)
$$

where

$$
G_{j}(s):=\zeta(s-2) L(s, \chi) \prod_{n=1}^{j} L\left(s-2, s y m^{2 n} f\right) L\left(s, s y m^{2 n} f \otimes \chi\right)
$$

and $\chi$ is the non-principal character modulo 4.
Here, $H_{j}(s)$ is a Dirichlet series which converges uniformly, and absolutely in the half plane $\Re(s)>\frac{5}{2}$, and $H_{j}(s) \neq 0$ on $\Re(s)=3$.

Proof. We observe that $\lambda_{s y m^{j} f}^{2}(n) l(n)$ is multiplicative and hence

$$
\begin{equation*}
F_{j}(s)=\prod_{p}\left(1+\frac{\lambda_{s y m^{j} f}^{2}(p) l(p)}{p^{s}}+\cdots+\frac{\lambda_{s y m^{j} f}^{2}\left(p^{m}\right) l\left(p^{m}\right)}{p^{m s}}+\cdots\right) \tag{2.8}
\end{equation*}
$$

Using (2.6) and (2.7), we note that,

$$
\begin{align*}
\lambda_{s y m^{2} f}^{2}(p) l(p) & =\lambda_{f}^{2}\left(p^{j}\right)\left(p^{2}+\chi(p)\right) \\
& =\left(1+\sum_{l=1}^{j} \lambda_{f}\left(p^{2 l}\right)\right)\left(p^{2}+\chi(p)\right) \\
& =\left(1+\sum_{l=1}^{j} \lambda_{s y m^{2 l} f}(p)\right)\left(p^{2}+\chi(p)\right) \\
& =p^{2}+\chi(p)+\sum_{l=1}^{j} \lambda_{s y m^{2 l} f}(p) p^{2}+\sum_{l=1}^{j} \lambda_{s y m^{2 l} f}(p) \chi(p) \\
& =: b(p) \tag{say}
\end{align*}
$$

From the structure of $b(p)$, we define the coefficients $b(n)$ as

$$
\sum_{n=1}^{\infty} \frac{b(n)}{n^{s}}=\zeta(s-2) L(s, \chi) \prod_{n=1}^{j} L\left(s-2, s y m^{2 n} f\right) L\left(s, s y m^{2 n} f \otimes \chi\right)
$$

which is absolutely convergent in $\Re(s)>3$. We also note that,

$$
\begin{align*}
& \prod_{p}\left(1+\frac{b(p)}{p^{s}}+\cdots+\frac{b\left(p^{m}\right)}{p^{m s}}+\cdots\right) \\
& =\zeta(s-2) L(s, \chi) \prod_{n=1}^{j} L\left(s-2, s y m^{2 n} f\right) L\left(s, s y m^{2 n} f \otimes \chi\right) \\
& =G_{j}(s) \tag{say}
\end{align*}
$$

for $\Re(s)>3$. Observe that $b(n) \ll_{\epsilon} n^{2+\epsilon}$ for any small positive constant $\epsilon$.

Now, we note that

$$
\begin{aligned}
\left|\frac{b(p)}{p^{s}}+\frac{b\left(p^{2}\right)}{p^{2 s}}+\cdots+\frac{b\left(p^{m}\right)}{p^{m s}}+\cdots\right| & \ll \sum_{m=1}^{\infty} \frac{p^{(2+\epsilon) m}}{p^{m \sigma}} \\
& \leq \sum_{m=1}^{\infty} \frac{p^{(2+\epsilon) m}}{p^{(3+2 \epsilon) m}} \quad(\text { in } \Re(s) \geq 3+2 \epsilon) \\
& =\sum_{m=1}^{\infty} \frac{1}{p^{(1+\epsilon) m}} \\
& =\frac{\frac{1}{p^{1+\epsilon}}}{1-\frac{1}{p^{1+\epsilon}}} \\
& =\frac{1}{p^{1+\epsilon}-1} \\
& <1 .
\end{aligned}
$$

Let us write

$$
A=\frac{\lambda_{s y m^{j} f}^{2}(p) l(p)}{p^{s}}+\cdots+\frac{\lambda_{s y m^{j} f}^{2}\left(p^{m}\right) l\left(p^{m}\right)}{p^{m s}}+\cdots
$$

and

$$
B=\frac{b(p)}{p^{s}}+\cdots+\frac{b\left(p^{m}\right)}{p^{m s}}+\cdots .
$$

From the above calculations, we observe that $|B|<1$ in $\Re(s) \geq 3+2 \epsilon$.

Note that,

$$
\begin{aligned}
\frac{1+A}{1+B} & =(1+A)\left(1-B+B^{2}-B^{3}+\cdots\right) \quad(\text { in } \Re(s) \geq 3+2 \epsilon) \\
& =1+A-B-A B+\text { higher terms } \\
& =1+\frac{\lambda_{s y m^{j} f}^{2}\left(p^{2}\right) l\left(p^{2}\right)-b\left(p^{2}\right)}{p^{2 s}}+\cdots+\frac{c_{m}\left(p^{m}\right)}{p^{m s}}+\cdots,
\end{aligned}
$$

with $c_{m}(n) \ll_{\epsilon} n^{2+\epsilon}$. So,

$$
\begin{array}{rlr}
\prod_{p}\left(\frac{1+A}{1+B}\right) & =\prod_{p}\left(1+\frac{\lambda_{s y m^{j} f}^{2}\left(p^{2}\right) l\left(p^{2}\right)-b\left(p^{2}\right)}{p^{2 s}}+\cdots+\frac{c_{m}\left(p^{m}\right)}{p^{m s}}+\cdots\right) \\
& <_{\epsilon} 1 . & \left(\text { in } \Re(s)>\frac{5}{2}\right)
\end{array}
$$

Thus,

\begin{array}{rlr}
H_{j}(s) & :=\frac{F_{j}(s)}{G_{j}(s)} \\
& =\prod_{p}\left(\frac{1+A}{1+B}\right) \\
& \lll \epsilon 1, \quad\left(\text { in } \Re(s)>\frac{5}{2}\right)
\end{array}
$$

and also $H_{j}(s) \neq 0$ on $\Re(s)=3$.

Lemma 2.3. Let $f$ be a normalized primitive holomorphic cusp form of weight $k$ for $S L(2, \mathbb{Z})$, and let $\lambda_{\text {symj }}(n)$ be the $n^{\text {th }}$ normalized Fourier coefficient of the $j^{\text {th }}$ symmetric power $L$-function associated to $f$. If

$$
\widetilde{F}_{j}(s)=\sum_{n=1}^{\infty} \frac{\lambda_{s y m}{ }^{2} f(n) v(n)}{n^{s}}
$$

for $\Re(s)>3$, then

$$
\widetilde{F}_{j}(s)=\widetilde{G}_{j}(s) \widetilde{H}_{j}(s),
$$

where

$$
\widetilde{G}_{2}(s):=\zeta(s) L(s-2, \chi) \prod_{n=1}^{j} L\left(s, s y m^{2 n} f\right) L\left(s-2, s y m^{2 n} f \otimes \chi\right)
$$

and $\chi$ is the non-principal character modulo 4.
Here $\widetilde{H}_{j}(s)$ is a Dirichlet series which converges uniformly, and absolutely in the half plane $\Re(s)>\frac{5}{2}$, and $\widetilde{H}_{j}(s) \neq 0$ on $\Re(s)=3$.

Proof. We observe that $\lambda_{\text {sym }}^{2} f(n) v(n)$ is multiplicative, and hence

$$
\begin{equation*}
\widetilde{F}_{2}(s)=\prod_{p}\left(1+\frac{\lambda_{s y m^{j} f}^{2}(p) v(p)}{p^{s}}+\cdots+\frac{\lambda_{s y m^{j} f}^{2}\left(p^{m}\right) v\left(p^{m}\right)}{p^{m s}}+\cdots\right) \tag{2.9}
\end{equation*}
$$

Using (2.6) and (2.7), we note that,

$$
\begin{align*}
\lambda_{s_{y m}{ }^{2} f}^{2}(p) v(p) & =\lambda_{f}^{2}\left(p^{j}\right)\left(1+p^{2} \chi(p)\right) \\
& =\left(1+\sum_{l=1}^{j} \lambda_{f}\left(p^{2 l}\right)\right)\left(1+p^{2} \chi(p)\right) \\

& =1+p^{2} \chi(p)+\sum_{l=1}^{j} \lambda_{s y m_{2 l}^{2 l}}(p)+\sum_{l=1}^{j} \lambda_{s y m_{2 l}^{2 l} f}(p) p^{2} \chi(p) \\
& =: h(p) . \tag{say}
\end{align*}
$$

From the structure of $h(p)$, we define the coefficients $h(n)$ as

which is absolutely convergent in $\Re(s)>3$. We also note that,

& =\widetilde{G}_{2}(s) \tag{say}
\end{align*}

for $\Re(s)>3$. Observe that $h(n) \ll_{\epsilon} n^{2+\epsilon}$ for any small positive constant $\epsilon$.

Now, we note that

\end{aligned}
$$

with $\widetilde{c}_{m}(n) \ll_{\epsilon} n^{2+\epsilon}$. So,

& <_{\epsilon} 1 .
\end{aligned}

Thus,

& =\prod_{p}\left(\frac{1+\widetilde{A}}{1+\widetilde{B}}\right) \\
& \ll \epsilon_{\epsilon} 1,
\end{aligned}
$$

$$
\text { (in } \left.\Re(s)>\frac{5}{2}\right)
$$

and also $\widetilde{H}_{j}(s) \neq 0$ on $\Re(s)=3$.
Lemma 2.4. For any $\epsilon>0$, we have

## 3 Proof of Theorem 1.1

From (2.2), we can write

Firstly, we consider the sum $\sum_{n \leq x} \lambda_{\text {sym }}{ }^{2} f(n) l_{1}(n)$. We begin by applying the Perron's formula (see chapter 2.4 of [5]) to $F_{j}(s)$ with $\eta=3+\epsilon$, and
$10 \leq T \leq x$. Thus we have,

We move the line of integration to $\Re(s)=\frac{5}{2}+\epsilon$, and by Cauchy's residue theorem there is only one simple pole at $s=3$, coming from the factor $\zeta(s-2)$. This contributes a residue, which is $c(j) x^{3}$, where $c(j)$ is an effective constant depending on the values of various $L$-functions appearing in $G_{j}(s)$ at $s=3$.

More precisely,

& +O\left(\frac{x^{3+3 \epsilon}}{T}\right) \\
= & c(j) x^{3}+\frac{16}{2 \pi i}\left(J_{1}+J_{2}+J_{3}\right)+O\left(\frac{x^{3+3 \epsilon}}{T}\right) . \tag{say}
\end{align*}
$$

Contribution of horizontal line integrals ( $J_{2}$ and $J_{3}$ ) in absolute value
(using Lemmas 2.2, 2.5 and 2.6) is

\begin{aligned}
& \ll \int_{\frac{5}{2}+\epsilon}^{3+\epsilon} \frac{\left|\zeta(\sigma-2+i T) \prod_{n=1}^{j} L\left(\sigma-2+i T, s y m^{2 n} f\right)\right|}{T} x^{\sigma} d \sigma \\
& \ll \int_{\frac{1}{2}+\epsilon}^{1+\epsilon} \frac{\left|\zeta(\sigma+i T) \prod_{n=1}^{j} L\left(\sigma+i T, s y m^{2 n} f\right)\right|}{T} x^{\sigma+2} d \sigma \\
& \ll\left(\frac{x^{2}}{T}\right) \max _{\frac{1}{2}+\epsilon \leq \sigma \leq 1+\epsilon} x^{\sigma} T^{\left(\frac{(j+1)^{2}}{2}-\frac{4}{21}\right)(1-\sigma)+\epsilon} \\
& \ll\left(\frac{x^{2+2 \epsilon}}{T}\right) \max _{\frac{1}{2}+\epsilon \leq \sigma \leq 1+\epsilon}\left(\frac{x}{\left.T^{\left(\frac{(j+1)^{2}}{2}-\frac{4}{21}\right)}\right)^{\sigma} T^{\left(\frac{(j+1)^{2}}{2}-\frac{4}{21}\right)} .}\right.
\end{aligned}
$$

Clearly, $\left(\frac{x}{T^{\left(\frac{(j+1)^{2}}{2}-\frac{4}{21}\right)}}\right)^{\sigma}$ is monotonic as a function of $\sigma$ for $\frac{1}{2}+\epsilon \leq \sigma \leq$ $1+\epsilon$, and hence the maximum is attained at the extremities of the interval $\left[\frac{1}{2}+\epsilon, 1+\epsilon\right]$. Thus, $\ll x^{2+2 \epsilon}\left(x^{\frac{1}{2}+\epsilon} T^{\left(\frac{(j+1)^{2}}{4}-\frac{2}{21}-1\right)}+\frac{x^{1+\epsilon}}{T}\right)$ $\ll x^{\frac{5}{2}+3 \epsilon} T^{\left(\frac{(j+1)^{2}}{4}-\frac{23}{21}+\epsilon\right)}+\frac{x^{3+3 \epsilon}}{T}$.

Contribution of the left vertical line integral $\left(J_{1}\right)$ in absolute value (using Lemmas 2.2, 2.5, 2.6 and Hölder's inequality) is

& \ll \int_{\frac{5}{2}+\epsilon-i T}^{\frac{5}{2}+\epsilon+i T} \frac{\left|\zeta\left(\frac{1}{2}+\epsilon+i t\right) \prod_{n=1}^{j} L\left(\frac{1}{2}+\epsilon+i t, s y m^{2 n} f\right)\right|}{\left|\frac{5}{2}+\epsilon+i t\right|} x^{\frac{5}{2}+\epsilon} d t \\
& \ll x^{\frac{5}{2}+\epsilon}+x^{\frac{5}{2}+\epsilon} \frac{1}{T}\left(\int_{10 \leq|t| \leq T}\left|\zeta\left(\frac{1}{2}+\epsilon+i t\right)\right|^{12} d t\right)^{\frac{1}{12}} \\
& \times\left(\int_{10 \leq|t| \leq T}\left|L\left(\frac{1}{2}+\epsilon+i t, s^{2} m^{2} f\right)\right|^{2} d t\right)^{\frac{1}{2}} \\
& \times\left\{\max _{10 \leq|t| \leq T}\left|\prod_{n=2}^{j} L\left(\frac{1}{2}+\epsilon+i t, s y m^{2 n} f\right)\right|^{\frac{2}{5}}\left(\int_{10 \leq|t| \leq T}\left|\prod_{n=2}^{j} L\left(\frac{1}{2}+\epsilon+i t, s y m^{2 n} f\right)\right|^{2} d t\right)\right\}^{\frac{5}{12}} \\
& \ll x^{\frac{5}{2}+\epsilon}+x^{\frac{5}{2}+\epsilon}\left(T^{\left.-1+2 \cdot \frac{1}{12}+3 \cdot \frac{1}{2} \cdot \frac{1}{2}+\left((j+1)^{2}-4\right)\left(\frac{1}{2} \cdot \frac{1}{2} \cdot \frac{2}{5} \cdot \frac{5}{12}\right)+\left((j+1)^{2}-4\right)\left(\frac{1}{2} \cdot \frac{5}{12}\right)\right)}\right. \\
& \ll x^{\frac{5}{2}+\epsilon T}\left(\frac{(j+1)^{2}}{4}-\frac{13}{12}+\epsilon\right) .
\end{aligned}

Note that $10 \leq T \leq x$. Thus, we obtain

We choose $T$ such that $x^{\frac{5}{2}} T^{\left(\frac{(j+1)^{2}}{4}-\frac{13}{12}\right)} \asymp \frac{x^{3}}{T}$ i.e., $T^{\left(\frac{3(j+1)^{2}-1}{12}\right)} \asymp x^{\frac{1}{2}}$.
Therefore, $T \asymp x^{\frac{6}{3(j+1)^{2}-1}}$.

Thus, we get

We move the line of integration to $\Re(s)=\frac{5}{2}+\epsilon$. Note that, there is no singularity in the rectangle obtained, and the function $\widetilde{F}_{j}(s) \frac{x^{s}}{s}$ is analytic in this region. Thus, using Cauchy's theorem for rectangle $\stackrel{S}{\text { pertaining to }}$ analytic functions, we get

& +O\left(\frac{x^{3+3 \epsilon}}{T}\right) \\
= & \frac{4}{2 \pi i}\left(J_{1}+J_{2}+J_{3}\right)+O\left(\frac{x^{3+3 \epsilon}}{T}\right) \tag{say}
\end{align*}
$$

Contribution of horizontal line integrals ( $J_{2}$ and $J_{3}$ ) in absolute value (using Lemmas 2.3, 2.4 and 2.6) is

$$
\begin{aligned}
& \ll \int_{\frac{5}{2}+\epsilon}^{3+\epsilon} \frac{\left|L(\sigma-2+i T) \prod_{n=1}^{j} L\left(\sigma-2+i T, s y m^{2 n} f \otimes \chi\right)\right|}{T} x^{\sigma} d \sigma \\
& \ll \int_{\frac{1}{2}+\epsilon}^{1+\epsilon} \frac{\left|L(\sigma+i T) \prod_{n=1}^{j} L\left(\sigma+i T, s y m^{2 n} f \otimes \chi\right)\right|}{T} x^{\sigma+2} d \sigma \\
& \ll\left(\frac{x^{2}}{T}\right) \max _{\frac{1}{2}+\epsilon \leq \sigma \leq 1+\epsilon} x^{\sigma} T^{\left(\frac{(j+1)^{2}}{2}-\frac{1}{6}\right)(1-\sigma)+\epsilon} \\
& \ll\left(\frac{x^{2+2 \epsilon}}{T}\right) \max _{\frac{1}{2}+\epsilon \leq \sigma \leq 1+\epsilon}\left(\frac{x}{T^{\left(\frac{(j+1)^{2}}{2}-\frac{1}{6}\right)}}\right)^{\sigma} T^{\left(\frac{(j+1)^{2}}{2}-\frac{1}{6}\right)} .
\end{aligned}
$$

Clearly, $\left(\frac{x}{T^{\left(\frac{(j+1)^{2}}{2}-\frac{1}{6}\right)}}\right)^{\sigma}$ is monotonic as a function of $\sigma$ for $\frac{1}{2}+\epsilon \leq \sigma \leq$ $1+\epsilon$, and hence the maximum is attained at the extremities of the interval $\left[\frac{1}{2}+\epsilon, 1+\epsilon\right]$. Thus,
$\ll x^{2+2 \epsilon}\left(x^{\frac{1}{2}+\epsilon} T^{\left(\frac{(j+1)^{2}}{4}-\frac{1}{12}-1+\epsilon\right)}+\frac{x^{1+\epsilon}}{T}\right)$
$\ll x^{\frac{5}{2}+3 \epsilon} T\left(\frac{\left(\frac{(j+1)^{2}}{4}-\frac{13}{12}+\epsilon\right)}{}+\frac{x^{3+3 \epsilon}}{T}\right.$.

Contribution of the left vertical line integral $\left(J_{1}\right)$ in absolute value (using Lemmas 2.3, 2.4, 2.6 and Hölder's inequality) is

\begin{aligned}
& \ll \int_{\frac{5}{2}+\epsilon-i T}^{\frac{5}{2}+\epsilon+i T} \frac{\left|L\left(\frac{1}{2}+\epsilon+i t\right) \prod_{n=1}^{j} L\left(\frac{1}{2}+\epsilon+i t, s y m^{2 n} f \otimes \chi\right)\right|}{\left|\frac{5}{2}+\epsilon+i t\right|} x^{\frac{5}{2}+\epsilon} d t \\
& \ll x^{\frac{5}{2}+\epsilon}+x^{\frac{5}{2}+\epsilon} \frac{1}{T}\left(\int_{10 \leq|t| \leq T}\left|L\left(\frac{1}{2}+\epsilon+i t\right)\right|^{6} d t\right)^{\frac{1}{6}} \\
& \times\left(\int_{10 \leq|t| \leq T}\left|L\left(\frac{1}{2}+\epsilon+i t, s y m^{2} f \otimes \chi\right)\right|^{2} d t\right)^{\frac{1}{2}} \\
& \times\left\{\max _{10 \leq|t| \leq T}\left|\prod_{n=2}^{j} L\left(\frac{1}{2}+\epsilon+i t, s y m^{2 n} f \otimes \chi\right)\right|\left(\int_{10 \leq|t| \leq T}\left|\prod_{n=2}^{j} L\left(\frac{1}{2}+\epsilon+i t, s y m^{2 n} f \otimes \chi\right)\right|^{2} d t\right)\right\}^{\frac{1}{3}} \\
& \ll x^{\frac{5}{2}+\epsilon}+x^{\frac{5}{2}+\epsilon}\left(T^{\left.-1+2 \cdot \frac{1}{6}+3 \cdot \frac{1}{2} \cdot \frac{1}{2}+\left((j+1)^{2}-4\right)\left(\frac{1}{2} \cdot \frac{1}{2} \cdot \frac{1}{3}\right)+\left((j+1)^{2}-4\right)\left(\frac{1}{2} \cdot \frac{1}{3}\right)\right)}\right. \\
& \ll x^{\frac{5}{2}+\epsilon} T\left(\frac{(j+1)^{2}}{4}-\frac{11}{12}\right)
\end{aligned}
$$

Note that $10 \leq T \leq x$. Thus, we obtain

We choose $T$ such that $x^{\frac{5}{2}} T^{\left(\frac{(j+1)^{2}}{4}-\frac{11}{12}\right)} \asymp \frac{x^{3}}{T}$ i.e., $T^{\left(\frac{(j+1)^{2}}{4}+\frac{1}{12}\right)} \asymp x^{\frac{1}{2}}$.
Therefore, $T \asymp x^{\frac{6}{3(j+1)^{2}+1}}$.

Thus, we get

where $c(j)$ is an effective constant given by

c(j)=\frac{16}{3} L(3, \chi) \prod_{n=1}^{j} L\left(1, s y m^{2 n} f\right) L\left(3, s y m^{2 n} f \otimes \chi\right) H_{j}(3)
$$

and $\chi$ is the non-principal Dirichlet character modulo 4.
This proves the theorem.

Concluding Remarks: Note that we have the expected upper bounds, namely,

\int_{T}^{2 T}\left|L\left(\frac{5}{8}+i t, f\right)\right|^{4} d t \ll T^{1+\epsilon}
$$

uniformly for $T \geq 1$ (see [9, [4]). Even if we move the line of integration to $\Re(s)=\frac{5}{7}$ and $\Re(s)=\frac{5}{8}$ pertaining to $l_{1}(n)$ and $v_{1}(n)$ respectively, and using the arguments of this paper, we end up with the same error term as stated in the Theorem 1.1.
