# Existence and boundary behaviour of radial solutions for weighted elliptic systems with gradient terms

#### Abstract

We are concerned with the existence and boundary behaviour of positive radial solutions for the system $$
\begin{cases}\Delta u=|x|^{a} v^{p} & \\ \text { in } \Omega, \\ \Delta v=|x|^{b} v^{q} f(|\nabla u|) & \\ \text { in } \Omega,\end{cases}
$$ where $\Omega \subset \mathbb{R}^{N}$ is either a ball centered at the origin or the whole space $\mathbb{R}^{N}, a, b, p$, $q>0$, and $f \in C^{1}[0, \infty)$ is an increasing function such that $f(t)>0$ for all $t>0$. Firstly, we study the existence of positive radial solutions in case when the system is posed in a ball corresponding to their behaviour at the boundary. Next, we take $f(t)=t^{s}, s>1, \Omega=\mathbb{R}^{N}$ and by the use of dynamical system techniques we are able to describe the behaviour at infinity of such positive radial solutions.


Keywords: radial solutions, elliptic systems, nonlinear gradient terms, dynamical systems

## 1 Introduction

In this paper, we study the positive radial solutions for the weighted semilinear elliptic system

$$
\begin{cases}\Delta u=|x|^{a} v^{p} &  \tag{1}\\ \text { in } \Omega, \\ \Delta v=|x|^{b} v^{q} f(|\nabla u|) & \\ \text { in } \Omega,\end{cases}
$$

where $\Omega \subset \mathbb{R}^{N}$ is either a ball centered at the origin with radius $R>0$ or the whole space $\mathbb{R}^{N}, a, b, p, q>0$ and $f \in C^{1}[0, \infty)$ is an increasing function such that $f(t)>0$ for all $t>0$. We start with the assumption that $u$ and $v$ are positive radially symmetric solutions of (1). There is no prior condition at the boundary for $u$ and $v$, but it will be required as we move

[^0]forward in our analysis as we are concerned with the classification of all the solutions of (1). In [25], Singh had studied the system (1) in case when $a=b=q=0$, that is, the system
\[

$$
\begin{cases}\Delta u=v^{p} & \text { in } \Omega,  \tag{2}\\ \Delta v=f(|\nabla u|) & \text { in } \Omega .\end{cases}
$$
\]

The author considered the system (22) both in case of a ball centered at the origin with positive radius and in the whole space $\mathbb{R}^{N}$ and classified all the positive radial solutions of (2) together with the behaviour of solutions at the boundary. In case $\Omega$ is a ball, system (2) with $p=1$ and $f(t)=t^{2}$, that is,

$$
\begin{cases}\Delta u=v & \text { in } \Omega  \tag{3}\\ \Delta v=|\nabla u|^{2} & \text { in } \Omega\end{cases}
$$

was first studied by Diaz, Lazzo, and Schmidt in 5. This special choice of $p$ and function $f$ appears in the study of the dynamics of viscous, heat-conducting fluid. In [5], the authors obtained that the system (3) has one positive solution which blows up at the boundary and the authors also observed that in case of small dimensions $(N \leq 9)$, there exists one sign-changing solution which also blows up at the boundary. In [6, 7], Diaz, Rakotoson, and Schmidt extended these results to time dependent systems.

The problems related to boundary blow-up solutions can be linked back to atleast a century ago, for instance, Bieberbach [3] in 1916 studied the boundary blow-up solutions for the equation $\Delta u=e^{u}$ in a planar domain. From that point of time onwards, there has been many new techniques which have been devised to tackle such solutions ( see [12, 13, 24]). In the last few decades, semilinear elliptic equations with nonlinear gradient terms have been studied extensively for such boundary blow-up solutions ( see [1, 4, 8, [9, 11, 19] ).

In [10], Ghergu, Giacomoni and Singh studied the following more general quasilinear elliptic system with nonlinear gradient terms

$$
\begin{cases}\Delta_{p} u=v^{m}|\nabla u|^{\alpha} & \text { in } \Omega,  \tag{4}\\ \Delta_{p} v=v^{\beta}|\nabla u|^{q} & \text { in } \Omega,\end{cases}
$$

in which the authors classified all the positive radial solutions in case $\Omega$ is a ball and also obtained the behaviour at infinity of such solutions.

We first consider the case when $\Omega=B_{R}$ is a ball of radius $R>0$ and centered at the origin. We obtained that in this case the system (1) has positive radially symmetric solutions $(u, v)$ such that $u$ or $v$ ( or both ) blow up around $\partial \Omega$ if and only if

$$
\begin{equation*}
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(t) d t\right)^{p /(2 p-q+1)}}<\infty \quad \text { where } F(t)=\int_{0}^{t} f(k) d k \tag{5}
\end{equation*}
$$

We also study the full classification of positive radially symmetric solutions in case the system is posed in a ball. The condtion (5) is similar to optimal conditions obtained by

Keller [18] and Osserman [20] in 1950s while studying the existence of a solution to the boundary blow-up problem

$$
\left\{\begin{align*}
\Delta u & =f(u) & & \text { in } \Omega  \tag{6}\\
u & =\infty & & \text { on } \partial \Omega
\end{align*}\right.
$$

where $\Omega \subset \mathbb{R}^{N}$ is a bounded domain and $f \in C^{1}[0, \infty)$ is a nonnegative increasing function. The authors obtained that (6) has $C^{2}(\Omega)$ solutions if and only if

$$
\begin{equation*}
\int_{1}^{\infty} \frac{d s}{\sqrt{F(s)}}<\infty \quad \text { where } F(s)=\int_{0}^{s} f(t) d t \tag{7}
\end{equation*}
$$

Equation (7) has also been seen in various other circumstances as it is related to the maximum principle for nonlinear elliptic inequalities. For example, if $u \in C^{2}(\Omega)$ is nonnegative and satisfies $\Delta u \leq f(u)$ in $\Omega$, then, if $u$ vanishes at a point in $\Omega$, it must vanish everywhere in $\Omega$. For various extensions of this result, one could refer to Vazquez [26] and to Pucci, Serrin and Zou [21, 22, 23]. Next, if $f(t)=t^{s}, s \geq 1$, then in this case we are able to find the exact rate at which the solution $(u, v)$ blows up at the infinity. Here, we have used the dynamical system techniques for cooperative systems with negative divergence to find out the exact blow up rate at infinity.

## 2 Main Results

First, we consider the system (11) in case where $\Omega=B_{R}$, that is, we study the system

$$
\begin{cases}\Delta u=|x|^{a} v^{p} & \text { in } B_{R}  \tag{8}\\ \Delta v=|x|^{b} v^{q} f(|\nabla u|) & \\ \text { in } B_{R}\end{cases}
$$

where $B_{R} \subset \mathbb{R}^{N}, N \geq 2$ is an open ball of radius $R>0$ centred at the origin, $a, b, p, q>0$ and $f \in C^{1}[0, \infty)$ is an increasing function such that $f(t)>0$ for all $t>0$.

In this paper, sometimes system (8) has one of the following boundary conditions:

- either $u$ and $v$ are bounded in $B_{R}$;
- or

$$
u \text { is bounded in } B_{R} \text { and } \lim _{|x| \nearrow R} v(x)=\infty ;
$$

- or

$$
\lim _{|x| \nearrow R} u(x)=\lim _{|x| \nearrow R} v(x)=\infty
$$

We note that by (11), the boundary condition $\lim _{|x| \not ~_{R}} u(x)=\infty$ and $v$ is bounded is not possible. Throughout this paper, $C$ denotes some positive constant which may vary from line to line, or within the same line, and $r$ will often be used in place of $|x|$.

Theorem 2.1. Let us suppose that $(u, v)$ is a positive radial solution of (8). Then, we have
(i) Both $u$ and $v$ are bounded if and only if

$$
\begin{equation*}
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(t) d t\right)^{p /(2 p-q+1)}}=\infty \tag{9}
\end{equation*}
$$

(ii) $u$ is bounded and $\lim _{|x| \nmid R} v(r)=\infty$ if and only if

$$
\begin{equation*}
\int_{1}^{\infty} \frac{s d s}{\left(\int_{0}^{s} F(t) d t\right)^{p /(2 p-q+1)}}<\infty \tag{10}
\end{equation*}
$$

(iii) $\lim _{|x| \nmid R} u(x)=\lim _{|x| \nmid R} v(x)=\infty$ if and only if

$$
\begin{equation*}
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}<\infty \quad \text { and } \int_{1}^{\infty} \frac{s d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}=\infty \tag{11}
\end{equation*}
$$

If $f(t)=t^{s}, s \geq 1$, then theorem 2.1] gives the following result:
Corollary 1. Consider the system

$$
\begin{cases}\triangle u=|x|^{a} v^{p} & \text { in } B_{R},  \tag{12}\\ \triangle v=|x|^{b} v^{q}|\nabla u|^{s} & \text { in } B_{R} .\end{cases}
$$

We have:
(i) All positive radial solutions to (12) are bounded if and only if

$$
p s+q-1 \leq 0 .
$$

(ii) There exists positive radial solutions to (12) satisfying u bounded and $\lim _{|x| \nearrow R} v(r)=\infty$ if and only if

$$
s>2\left(1+\frac{1-q}{p}\right) .
$$

(iii) There exists positive radial solutions to (12) satisfying $\lim _{|x| \lambda_{R}} u(x)=\lim _{|x| \nmid R} v(x)=$ $\infty$ if and only if

$$
\frac{1-q}{p}<s \leq 2\left(1+\frac{1-q}{p}\right)
$$

Now, we study the system (12) in the whole space $\mathbb{R}^{N}$, that is,

$$
\begin{cases}\Delta u=|x|^{a} v^{p} &  \tag{13}\\ \text { in } \mathbb{R}^{N} \\ \Delta v=|x|^{b} v^{q}|\nabla u|^{s} & \\ \text { in } \mathbb{R}^{N}\end{cases}
$$

where $a, b, p, q>0$ and $s \geq 1$.

Theorem 2.2. System (13) has positive radial solutions if and only if

$$
\begin{equation*}
p s+q-1 \leq 0 \tag{14}
\end{equation*}
$$

Theorem 2.3. Assume $p<1$ and $p s+q<1$. Let $(u, v)$ be a positive radially symmetric solution of (13). If

$$
\begin{equation*}
\frac{p(s-2)(s+a s+b+2)}{1-p s-q} \leq 2(N+a-1) \tag{15}
\end{equation*}
$$

then

$$
\lim _{|x| \rightarrow \infty} \frac{u(x)}{|x|^{\frac{(a+2)(1-p s-q)+p s(a+1)+b p+2 q}{1-p s-q}}}=\frac{\left(A B^{s} K\right)^{\frac{p}{p s+q-1}}}{D K}
$$

and

$$
\lim _{|x| \rightarrow \infty} \frac{v(x)}{|x|^{\frac{(a+1) s+b+2}{1-p s-q}}}=\left(A B^{s} K\right)^{\frac{1}{p s+q-1}}
$$

where,

$$
\begin{gathered}
A=2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q} \\
B=N+a+p\left(2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}\right), \\
K=N+\frac{b+2 q+s(1+a+2 p)}{1-p s-q} \\
D=2+a+p\left(2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}\right) .
\end{gathered}
$$

## 3 Notes on dynamical systems

Let $x=\left(x_{1}, x_{2}, x_{3}\right), y=\left(y_{1}, y_{2}, y_{3}\right)$ be any two points in $\mathbb{R}^{3}$, then for $x_{i} \leq y_{i}$ we write

$$
x \leq y
$$

where $i=1,2,3$. For $x \leq y$ and $x \neq y$, we write $x<y$.
Also, the open ordered interval is defined as

$$
[[x, y]]=\left\{z \in \mathbb{R}^{3}: x<z<y\right\} \subset \mathbb{R}^{3}
$$

Consider the initial value problem

$$
\left\{\begin{array}{l}
\xi_{t}=h(\xi) \quad \text { for } t \in \mathbb{R}  \tag{16}\\
\xi(0)=\xi_{0}
\end{array}\right.
$$

where $h: \mathbb{R}^{3} \rightarrow \mathbb{R}$ is a $C^{1}$ function. This implies that there exists a unique solution $\xi$ of (16) defined in a maximal time interval for any $\xi_{0} \in \mathbb{R}^{3}$. Let $\varphi\left(\cdot, \xi_{0}\right)$ denotes the flow associated to (16), that is, $t \longmapsto \varphi\left(t, \xi_{0}\right)$ is the unique solution of (16) defined in a maximal time interval. Let us suppose that the vector field $h$ is cooperative, that is

$$
\frac{\partial h_{i}}{\partial x_{j}} \geq 0 \quad \text { for } 1 \leq i, j \leq 3, \quad i \neq j
$$

Next, follow the results due to Hirsch [15, 16].
Theorem 3.1. (see [16, Theorem 1]) Any compact limit set of (16) contains an equilibrium or is a cycle.

Definition. A finite sequence of equilibria $\zeta_{1}, \zeta_{2}, \ldots, \zeta_{n}=\zeta_{1},(n \geq 2)$ is known as a circuit such that $W^{u}\left(\xi_{i}\right) \cap W^{s}\left(\xi_{i+1}\right)$ is non-empty. Here, $W^{u}$ and $W^{s}$ respresents the stable and unstable manifolds respectively.

Note: There is no circuit in case all the equilibria are hyperbolic and also their stable and unstable manifolds are mutually transverse.

Theorem 3.2. (see [16, Theorem 2]). Let us assume that $L \subset \mathbb{R}^{3}$ is a compact set such that:
(i) There is no circuit and all the equilibria in $L$ are hyperbolic.
(ii) The number of cycles in $L$ which have period less than or equal to $T$ is finite, where $T>0$.

Then:
(a) Every limit set in $L$ is an equilibrium or cycle.
(b) L has finite number of cycles.

Theorem 3.3. (see [15, Theorem 7]) Assume that $\xi_{1}, \xi_{2} \in \mathbb{R}^{3}$ such that $\xi_{1}<\xi_{2}$. Further, if

$$
\operatorname{div} h<0 \quad \text { in }\left[\left[\xi_{1}, \xi_{2}\right]\right]
$$

then there are no cycles of (16) in $\left[\left[\xi_{1}, \xi_{2}\right]\right]$.

## 4 Proof of Theorem 2.1

We divide our proof into the following two lemmas:
Lemma 1. Let $(u, v)$ be a positive radial solution of (8). Then

$$
\lim _{|x| \nearrow R} v(x)=\infty
$$

if and only if

$$
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}}}<\infty
$$

Proof. First, assume that $\lim _{r \rightarrow R} v(r)=\infty$. System (1) can be rewritten as

$$
\left\{\begin{array}{l}
\left(u^{\prime}(r) r^{N-1}\right)^{\prime}=r^{N+a-1} v^{p}(r), \\
\left(v^{\prime}(r) r^{N-1}\right)^{\prime}=r^{N+b-1} v^{q}(r) f(|\nabla u|), \\
u^{\prime}(0)=v^{\prime}(0)=0
\end{array}\right.
$$

An integration over $(0, r), 0<r<R$, then gives us

$$
\left\{\begin{array}{l}
u^{\prime}(r)=r^{1-N} \int_{0}^{t} t^{N+a-1} v^{p}(t) d t \\
v^{\prime}(r)=r^{1-N} \int_{0}^{t} t^{N+b-1} v^{q}(t) f(|\nabla u|) d t
\end{array}\right.
$$

from which it follows that $u$ and $v$ are increasing in $(0, R)$. We can thus take the first integral equation above and estimate $u^{\prime}$ as

$$
u^{\prime}(r) \leq r^{1-N} v^{p}(r) \int_{0}^{r} t^{N+a-1} d t=\frac{r^{a+1} v^{p}(r)}{N+a}
$$

so from (1) we have that

$$
r^{a} v^{p}(r) \leq u^{\prime \prime}(r)+\frac{N-1}{r} \cdot \frac{r^{a+1} v^{p}(r)}{N+a}
$$

which further implies,

$$
\frac{1+a}{N+a} r^{a} v^{p}(r) \leq u^{\prime \prime}(r)
$$

Similarly we have

$$
v^{\prime}(r) \leq \frac{r^{b} v^{q}(r) f\left(u^{\prime}(r)\right)}{N+b}
$$

from which it follows

$$
\frac{1+b}{N+b} r^{b} v^{q}(r) f\left(u^{\prime}(r)\right) \leq v^{\prime \prime}(r)
$$

We thus have the following two estimates for all $0<r<R$, which will be important as we proceed:

$$
\begin{align*}
\frac{1+a}{N+a} r^{a} v^{p}(r) & \leq u^{\prime \prime} \leq r^{a} v^{p}(r)  \tag{17}\\
\frac{1+b}{N+b} r^{b} v^{q}(r) f\left(u^{\prime}(r)\right) & \leq v^{\prime \prime} \leq r^{b} v^{q}(r) f\left(u^{\prime}(r)\right) \tag{18}
\end{align*}
$$

Now, where $w=u^{\prime}$, we multiply the right inequality in (18) by $v^{\prime}$ and integrate over $[0, r]$ to find

$$
\begin{align*}
\frac{v^{\prime}(r)^{2}}{2} & \leq \int_{0}^{r} t^{b} v^{q}(t) v^{\prime}(t) f(w(t)) d t \\
& \leq r^{b} f(w(r)) \int_{0}^{r}\left(\frac{v^{q+1}(t)}{q+1}\right)^{\prime} d t  \tag{19}\\
& \leq C f(w(r)) v^{q+1}(r) \quad \text { for all } 0<r<R
\end{align*}
$$

from which it follows

$$
\begin{equation*}
v^{-\frac{q+1}{2}}(r) v^{\prime}(r) \leq C \sqrt{f(w(r))} \tag{20}
\end{equation*}
$$

Now, fix $0<r_{0}<R$. From (17), we see that for all $r>r_{0}$ we have

$$
v^{p}(r) \leq C w^{\prime}(r)
$$

and multiplying this inequality by (20) we obtain

$$
v^{p-\frac{q+1}{2}}(r) v^{\prime}(r) \leq C \sqrt{f(w(r))} w^{\prime}(r)
$$

Integrating both sides of this equation over $\left(r_{0}, r\right)$ gives

$$
\begin{aligned}
v^{p+\frac{1-q}{2}}(r)-v^{p+\frac{1-q}{2}}\left(r_{0}\right) & \leq C \int_{r_{0}}^{r} w^{\prime}(t) \sqrt{f(w(t))} d t \\
& \leq C \int_{w\left(r_{0}\right)>0}^{w(r)} \sqrt{f(t)} d t \\
& \leq C \int_{w(0)=0}^{w(r)} \sqrt{f(t)} d t \quad \text { for all } r>r_{0} .
\end{aligned}
$$

Now, since $\lim _{r \rightarrow R} v(r)=\infty$, we have that there exists $\rho<R$ such that

$$
v^{p+\frac{1-q}{2}}(r)=\left(v^{p}(r)\right)^{\frac{2 p-q+1}{2 p}} \leq C \int_{0}^{w(r)} \sqrt{f(t)} d t \quad \text { for all } \rho<r
$$

Let $\tilde{r}=\max \left\{r_{0}, \rho\right\}$. Using (17) again we see

$$
\left(w^{\prime}(r)\right)^{\frac{2 p-q+1}{2 p}} \leq C \int_{0}^{w(r)} \sqrt{f(t)} d t \quad \text { for all } \tilde{r}<r
$$

from which it follows that

$$
\frac{w^{\prime}(r)}{\left(\int_{0}^{w(r)} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}}} \leq C \quad \text { for all } \tilde{r}<r
$$

We can integrate both sides of this expression over $(\tilde{r}, r)$ to find

$$
\int_{\tilde{r}}^{r} \frac{w^{\prime}(t) d t}{\left(\int_{0}^{w(t)} \sqrt{f(s)} d s\right)^{\frac{2 p}{2 p-q+1}}} \leq C \int_{\tilde{r}}^{r} d t
$$

or, after a change of variables

$$
\int_{w(\tilde{r})}^{w(r)} \frac{d s}{\left(\int_{0}^{s} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}}} \leq C(r-\tilde{r}) \leq C r
$$

Letting $r \rightarrow R$, we see

$$
\int_{w(\tilde{r})}^{\infty} \frac{d s}{\left(\int_{0}^{s} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}}} \leq C R<\infty
$$

Hence,

$$
\begin{equation*}
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}}}<\infty \tag{21}
\end{equation*}
$$

A minor adjustment of Lemma 4.1 in [25] gives us that (21) is equivalent to

$$
\begin{equation*}
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}<\infty \tag{22}
\end{equation*}
$$

Assume now that (22) holds. We see that (11) can be rewritten as

$$
\begin{cases}u(r)=u(0)+\int_{0}^{r} t^{1-N}\left(\int_{0}^{t} s^{a} v^{p}(s) d s\right) d t, & r>0  \tag{23}\\ v(r)=v(0)+\int_{0}^{r} t^{1-N}\left(\int_{0}^{t} s^{b} v^{q}(s) f\left(\left|u^{\prime}(s)\right|\right) d s\right) d t, & r>0 \\ u(0)>0, \quad v(0)>0\end{cases}
$$

Using a contraction mapping argument, we can show that system (23) has a solution (u,v) defined on some maximum interval $\left[0, R_{0}\right)$. Now, fix $\rho \in\left(0, R_{0}\right)$, and, recalling (17) and (18), we have

$$
\begin{array}{r}
f(w(r)) \leq C v^{-q}(r) v^{\prime \prime}(r) \text { for all } \rho \leq r<R_{0}, \\
w^{\prime}(r) \leq C v^{p}(r) \text { for all } \rho \leq r<R_{0} . \tag{24}
\end{array}
$$

Multiplying the two inequalities in (24) and the integrating over $[\rho, r]$ we find

$$
F(w(r))-F(w(\rho)) \leq C v^{p-q}(r) v^{\prime}(r),
$$

which we can express as

$$
F(w(r)) \leq C v^{p-q}(r) v^{\prime}(r)
$$

Using (24) again, we see that the above becomes

$$
w^{\prime}(r) F(w(r)) \leq C v^{2 p-q}(r) v^{\prime}(r) \quad \text { for all } \rho \leq r<R_{0} .
$$

Define

$$
G(r):=\int_{\rho}^{r} F(t) d t \quad \text { for all } \rho \leq r<R_{0} .
$$

We thus have

$$
\begin{aligned}
G(w(r))=\int_{\rho}^{w(r)} F(t) d t & \leq C \int_{\rho}^{r} v^{2 p-q}(t) v^{\prime}(t) d t \\
& \leq C\left[v^{p}(r)\right]^{\frac{2 p-q+1}{p}} \\
& \leq C\left[w^{\prime}(r)\right]^{\frac{2 p-q+1}{p}} \quad \text { for all } \rho \leq r<R_{0} .
\end{aligned}
$$

Hence

$$
C \leq \frac{w^{\prime}(r)}{G(w(r))^{\frac{p}{p-q+1}}} \quad \text { for all } \rho \leq r<R_{0} .
$$

Integrating the above over $[\rho, r]$ gives

$$
C(r-\rho) \leq \int_{\rho}^{r} \frac{w^{\prime}(t)}{G(w(t))^{\frac{p}{2 p-q+1}}} d t=\int_{w(\rho)}^{w(r)} \frac{d t}{G(t)^{\frac{p}{2 p-q+1}}}
$$

Now, letting $r \rightarrow R_{0}$ we see that

$$
C\left(R_{0}-\rho\right) \leq C \int_{1}^{\infty} \frac{d t}{G(t)^{\frac{p}{2 p-q+1}}}
$$

from which it follows that

$$
R_{0} \leq C \int_{1}^{\infty} \frac{d t}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}<\infty
$$

We have obtained a positive radial solution $(u, v)$ of (1) in $B_{R_{0}}$ satisfying $\lim _{r \rightarrow R_{0}} v(r)=\infty$. Now, if $R>0$ is any arbitrary radius, we set

$$
\tilde{f}(t)=\lambda^{b+\frac{a(1-q)}{p}+2\left(1+\frac{1-q}{p}\right)} f\left(\frac{t}{\lambda}\right) \quad \text { for all } t \geq 0
$$

By the above, we know there exists ( $\tilde{u}, \tilde{v}$ ) satisfying

$$
\begin{cases}\triangle \tilde{u}=r^{a} \tilde{v}^{p} & \text { in } B_{R_{0}} \\ \triangle \tilde{v}=r^{b_{v}} \tilde{f}(|\nabla \tilde{u}|) & \text { in } B_{R_{0}}\end{cases}
$$

where $B_{R_{0}}$ is a maximum ball of existence. Let

$$
\begin{cases}u(r)=\tilde{u}\left(\frac{r}{\lambda}\right) & \text { in } B_{R} \\ v(r)=\lambda^{-\frac{a+2}{p}} \tilde{v}\left(\frac{r}{\lambda}\right) & \text { in } B_{R} .\end{cases}
$$

Taking $\lambda=\frac{R}{R_{0}}$ we see that $(u, v)$ is a solution to (11) in $B_{R}$.
Lemma 2. System (8) has a positive radial solution satisfying

$$
\begin{equation*}
u \text { is bounded in } B_{R} \text { and } \lim _{|x| \nearrow R} v(x)=\infty \tag{25}
\end{equation*}
$$

if and only if

$$
\int_{1}^{\infty} \frac{s d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}<\infty
$$

Also, system (8) has a positive radial solution satisfying

$$
\begin{equation*}
\lim _{|x| \nearrow R} u(x)=\lim _{|x| \nearrow R} v(x)=\infty \tag{26}
\end{equation*}
$$

if and only if

$$
\int_{1}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}<\infty \quad \text { and } \int_{1}^{\infty} \frac{s d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}=\infty
$$

Proof. It is enough to prove this for a solution satisfying (25), so assume $(u, v)$ is a solution to (11) satisfying (25). From Lemma 1 we know that $f$ must satisfy (22). From Lemma 4.1 in [25], we know that

$$
\left(\int_{0}^{2 s} F(t) d t\right)^{\frac{p}{2 p-q+1}} \geq\left(\int_{0}^{s} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}} \quad \text { for all } s \geq 0
$$

Arguing in a similar way to Lemma 1 , we find that there exists $\rho \in(0, R)$ such that

$$
\begin{equation*}
\int_{w(r)}^{\infty} \frac{d s}{\left(\int_{0}^{2 s} F(t) d t\right)^{\frac{p}{2 p-q+1}}} \leq \int_{w(r)}^{\infty} \frac{d s}{\left(\int_{0}^{s} \sqrt{f(t)} d t\right)^{\frac{2 p}{2 p-q+1}}} \leq C_{1}(R-r) \tag{27}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{w(r)}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}} \geq C_{2}(R-r) \tag{28}
\end{equation*}
$$

for all $\rho<r<R$. Now, let $\Gamma:(0, \infty) \rightarrow(0, \infty)$ be defined as

$$
\Gamma(t)=\int_{t}^{\infty} \frac{d s}{\left(\int_{0}^{s} F(\sigma) d \sigma\right)^{\frac{p}{2 p-q+1}}}
$$

We note that $\Gamma$ is decreasing and by (22) we see $\lim _{t \rightarrow \infty} \Gamma(t)=0$. From (27) and (28) we find

$$
\Gamma(2 w(r)) \leq C_{1}(R-r) \quad \text { and } \quad \Gamma(w(r)) \geq C_{2}(R-r) \quad \text { for all } \rho \leq r<R
$$

Since $\Gamma$ is decreasing, this then implies

$$
\begin{aligned}
2 w(r) \geq \Gamma^{-1}\left(C_{1}(R-r)\right) & \text { for all } \rho \leq r<R \\
w(r) \leq \Gamma^{-1}\left(C_{2}(R-r)\right) & \text { for all } \rho \leq r<R .
\end{aligned}
$$

Now, recalling that

$$
u(r)=u(\rho)+\int_{\rho}^{r} w(t) d t \quad \text { for all } \rho \leq r<R
$$

we see that $\lim _{r \rightarrow R} u(r)=\infty$ if and only if

$$
\int_{\rho}^{R} w(t) d t=\infty
$$

if and only if

$$
\int_{\rho}^{R} \Gamma^{-1}(C(R-r)) d t=\infty
$$

for some $C>0$. Hence $\lim _{r \rightarrow R} u(r)=\infty$ if and only if

$$
\int_{0}^{C(R-\rho)} \Gamma^{-1}(u) d u=\infty
$$

if and only if

$$
\int_{0}^{1} \Gamma^{-1}(u) d u=\infty
$$

The change of variables $t=\Gamma^{-1}(u)$ then gives us that $\lim _{r \rightarrow R} u(r)=\infty$ if and only if

$$
\int_{1}^{\infty} \frac{s d s}{\left(\int_{0}^{s} F(t) d t\right)^{\frac{p}{2 p-q+1}}}=\infty
$$

To show that the opposite implication holds, one can proceed as in Lemma 1 to obtain the local existence of a solution, and then use a scaling argument.

## 5 Proof of Theorem 2.2

First, we assume that (14) holds. We have seen that this implies the existence of a positive, radial solution $(u, v)$ in a maximum ball. Both $u$ and $v$ are increasing, and by the corollary 1 we know that $u$ and $v$ are both bounded. Hence the domain of existence must be $\mathbb{R}^{N}$.

Conversely, assume that (14) does not hold, and let $(U, V)$ be a solution to (13). We know from Lemma 2 that there exists a solution $(\tilde{u}, \tilde{v})$ satisfying

$$
\lim _{r \rightarrow 1} \tilde{v}(r)=\infty
$$

Now, if $(U, V)$ is a solution to (13) in $\mathbb{R}^{N}$, then so is $\left(U_{\lambda}, V_{\lambda}\right)$, where

$$
\begin{aligned}
& U_{\lambda}(r)=\lambda^{\frac{p(b+2-s)-(a+2)(q-1)}{s p+q-1}} U(\lambda r) \\
& V_{\lambda}(r)=\lambda^{\frac{b+2+s(a+1)}{s p+q-1}} V(\lambda r) .
\end{aligned}
$$

Therefore, by considering small enough $\lambda>0$, we are justified in assuming that $V(0)>$ $\tilde{v}(0)>0$. Define

$$
R:=\sup \{r \in(0,1) \mid \quad V(t)>\tilde{v}(t) \quad \text { in }(0, r)\}
$$

and assume $R \neq 1$. Now, for all $0<r<R$ we have, where $W=U^{\prime}$ and $\tilde{w}=\tilde{u}^{\prime}$,

$$
\left(W r^{N-1}\right)^{\prime}=r^{N+a-1} V^{p}(r)>r^{N+a-1} \tilde{v}^{p}(r)=\left(\tilde{w} r^{N-1}\right)^{\prime} .
$$

An integration over $[0, r]$, where $0<r \leq R$, yields $W>\tilde{w}$ on $(0, R]$. Using a similar strategy we see

$$
\left(V^{\prime} r^{N-1}\right)^{\prime}=r^{N+b-1} V^{q}(r) W^{s}(r)>r^{N+b-1} \tilde{v}^{q}(r) \tilde{w}^{s}(r)=\lambda^{B}\left(\tilde{v}^{\prime}(r) r^{N-1}\right)^{\prime} .
$$

This implies that $V^{\prime}>\tilde{v}^{\prime}$ on $(0, R]$ and hence $V>\tilde{v}^{\prime}$ on $[0, R]$, contradicting the fact that $R \neq 1$. Hence $R=1$, and so $V>\tilde{v}$ on $(0,1)$. But this then implies that $\lim _{r \rightarrow 1} V(r)=\infty$, which contradicts the fact that $V(r)$ is a global solution.

## 6 Proof of the Theorem 2.3

We obtained that $u^{\prime}, v^{\prime}, u, v$ are increasing in the proof of the Theorem 2.1 and

$$
\left\{\begin{array}{l}
u^{\prime}(r)=r^{1-N} \int_{0}^{r} t^{N-1+a} v^{p}(t) d t \quad \text { for all } r>0 \\
v^{\prime}(r)=r^{1-N} \int_{0}^{r} t^{N-1+b} v^{q}(t)\left(u^{\prime}\right)^{s}(t) d t \quad \text { for all } r>0
\end{array}\right.
$$

which gives us

$$
\begin{equation*}
\frac{r^{a+1} v^{p}(0)}{N+a} \leq u^{\prime}(r) \leq \frac{r^{a+1} v^{p}(r)}{N+a} \quad \text { for all } r>0 \tag{29}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{v^{p s+q}(0) r^{(a+1) s+b+1}}{(N+b)(N+a)^{s}} \leq v^{\prime}(r) \leq \frac{r^{b+1} v^{q}(r) u^{\prime s}(r)}{N+b} \quad \text { for all } r>0 \tag{30}
\end{equation*}
$$

Using (29) and (30) we obtain that $u^{\prime}(r), v^{\prime}(r), u(r), v(r)$ tend to infinty as $r \rightarrow \infty$. Next, we do the following change of variables ( see [17], [2, 14] )

$$
X(t)=\frac{r u^{\prime}(r)}{u(r)}, \quad Y(t)=\frac{r v^{\prime}(r)}{v(r)}, \quad Z(t)=\frac{r^{a+1} v^{p}(r)}{u^{\prime}(r)} \text { and } W(t)=\frac{r^{b+1} v^{q}(r) u^{\prime s}(r)}{v^{\prime}(r)},
$$

where $t=\ln (r)$ for $r \in(0, \infty)$. Direct computation shows that $(X(t), Y(t), Z(t), W(t))$ satisfies

$$
\left\{\begin{array}{l}
X_{t}=X(Z-(N-2)-X) \quad \text { for all } t \in \mathbb{R}  \tag{31}\\
Y_{t}=Y(W-(N-2)-Y) \quad \text { for all } t \in \mathbb{R} \\
Z_{t}=Z(N+a+p Y-Z) \quad \text { for all } t \in \mathbb{R} \\
W_{t}=W(s Z+N-s N+s+b+q Y-W) \quad \text { for all } t \in \mathbb{R} .
\end{array}\right.
$$

Also, by L'Hopital's rule we deduce that $\lim _{t \rightarrow \infty} X(t)=2-N+\lim _{t \rightarrow \infty} Z(t)$. Hence, it is enough to study the last three equations of (31), that is,

$$
\left\{\begin{array}{l}
Y_{t}=Y(W-(N-2)-Y) \quad \text { for all } t \in \mathbb{R}  \tag{32}\\
Z_{t}=Z(N+a+p Y-Z) \quad \text { for all } t \in \mathbb{R} \\
W_{t}=W(s Z+N-s N+s+b+q Y-W) \quad \text { for all } t \in \mathbb{R}
\end{array}\right.
$$

Our system can be rewritten as

$$
\begin{equation*}
\xi_{t}=h(\xi) \tag{33}
\end{equation*}
$$

where

$$
\xi=\left(\begin{array}{c}
Y(t) \\
Z(t) \\
W(t)
\end{array}\right) \quad \text { and } \quad h(\xi)=\left(\begin{array}{c}
Y(W-(N-2)-Y) \\
Z(N+a+p Y-Z) \\
W(s Z+N-s N+s+b+q Y-W)
\end{array}\right)
$$

One notices that the system (33) is cooperative. Therefore, the following comparison principle holds:
Lemma 3. Let us assume that $\xi(t)=\left(\begin{array}{c}Y(t) \\ Z(t) \\ W(t)\end{array}\right)$ and $\tilde{\xi}(t)=\left(\begin{array}{c}\tilde{Y}(t) \\ \tilde{Z}(t) \\ \tilde{W}(t)\end{array}\right)$ are the two nonnegative solutions of (33) such that

$$
Y\left(t_{0}\right) \geq \tilde{Y}\left(t_{0}\right), \quad Z\left(t_{0}\right) \geq \tilde{Z}\left(t_{0}\right), \quad W\left(t_{0}\right) \geq \tilde{W}\left(t_{0}\right)
$$

for some $t_{0} \in \mathbb{R}$. Then, we have

$$
Y(t) \geq \tilde{Y}(t), \quad Z(t) \geq \tilde{Z}(t), \quad W(t) \geq \tilde{W}(t) \quad \text { for all } t \geq t_{0}
$$

Using (29) and (30) we deduce that $Z \geq N+a$ and $W \geq N+b$. Hence, we only have two equilibria of (32) which satisfy $Z \geq N+a$ and $W \geq N+b$, that is,

$$
\xi_{1}=\left(\begin{array}{c}
0 \\
N+a \\
N+s(a+1)+b
\end{array}\right) \quad \text { and } \xi_{2}=\left(\begin{array}{c}
2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q} \\
N+a+p\left(2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}\right) \\
N+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}
\end{array}\right) .
$$

Lemma 4. $\xi_{2}$ is asymptotically stable.
Proof. At $\xi_{2}$, we have the following linearized matrix:

$$
M=\left[\begin{array}{ccc}
-Y_{2} & 0 & Y_{2} \\
p Z_{2} & -Z_{2} & 0 \\
q W_{2} & s W_{2} & -W_{2}
\end{array}\right]
$$

and the associated characteristic polynomial of $M$ is

$$
P(\lambda)=\operatorname{det}(\lambda I-M)=\lambda^{3}+\alpha \lambda^{2}+\beta \lambda+(1-p s-q) \gamma,
$$

where

$$
\begin{aligned}
& \alpha=Y_{2}+Z_{2}+W_{2} \\
& \beta=Y_{2} Z_{2}+Z_{2} W_{2}+(1-q) Y_{2} W_{2} \\
& \gamma=Y_{2} Z_{2} W_{2} .
\end{aligned}
$$

As $p s+q<1$ and $\alpha, \beta, \gamma>0$, we have that $P(\lambda)>0$ for all $\lambda \geq 0$. In case $P$ has three real roots, then all of them are negative, which makes $\xi_{2}$ asymptotically stable. Next, we need to consider the case where $P$ has exactly one real root. So, let us assume that $\lambda_{1} \in \mathbb{R}$ and $\lambda_{2}, \lambda_{3} \in \mathbb{C} \backslash \mathbb{R}$ be the roots of characteristic polynomial $P$. We need to show that $\operatorname{Re}\left(\lambda_{2}\right)=\operatorname{Re}\left(\lambda_{3}\right)<0$, that is, $P(-\alpha)=-\beta \alpha+(1-p s-q) \gamma<0$, which is same as claiming, $\beta \alpha>(1-p s-q) \gamma$. By the use of AM-GM inequality we get that

$$
\alpha \geq 3 \sqrt[3]{Y_{2} Z_{2} W_{2}} \quad \text { and } \quad \beta \geq 3(1-q)^{\frac{1}{3}} \sqrt[3]{\left(Y_{2} Z_{2} W_{2}\right)^{2}}
$$

which further gives us the desired result, that is, $\alpha \beta>(1-p s-q) \gamma$. Hence, $\xi_{2}$ is asymptotically stable.

Lemma 5. For all $t \in \mathbb{R}$, we have

$$
\begin{gather*}
0 \leq Y(t) \leq 2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}  \tag{34}\\
N+a \leq Z(t) \leq N+a+p\left(2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}\right)  \tag{35}\\
N+s(a+1)+b \leq W(t) \leq N+\frac{b+2 q+s(1+a+2 p)}{1-p s-q} \tag{36}
\end{gather*}
$$

Proof. As $v^{\prime}(0)=0$ and $v(0)=0$, we deduce that $\lim _{t \rightarrow-\infty} Y(t)=\lim _{r \rightarrow 0} \frac{r v^{\prime}(r)}{v(r)}=0$.
Next, we show that there exists $t_{j} \rightarrow-\infty$ such that

$$
\left\{\begin{array}{l}
Y\left(t_{j}\right) \leq Y_{2}  \tag{37}\\
Z\left(t_{j}\right) \leq Z_{2} \\
W\left(t_{j}\right) \leq W_{2}
\end{array}\right.
$$

Since $\lim _{t \rightarrow-\infty} Y(t)=0$ and $\lim _{t \rightarrow-\infty} Z(t)=N+a$, we only need to prove the last part of (37). So, let us assume by contradiction that this is not true. Thus $W>W_{2}$ in $\left(-\infty, t_{0}\right)$ for some $t_{0} \in \mathbb{R}$. Then, we have

$$
W_{t}=W(s Z+N-s N+s+b+q Y-W)<0 \quad \text { in }\left(-\infty, t_{0}\right) .
$$

for small enough $t_{0}$. Therefore, $W$ is decreasing in the neighbourhood of $-\infty$, that is, there exists $\ell=\lim _{t \rightarrow-\infty} W(t)$. Again, by the use L'Hopital's rule we obtain

$$
\begin{aligned}
\ell=\lim _{t \rightarrow-\infty} W(t) & =\lim _{r \rightarrow 0} \frac{r^{b+1} v^{q}(r) u^{\prime s}(r)}{v^{\prime}(r)} \\
& =\frac{s(N+a)-s(N-1)+b+1}{1-\frac{N-1}{\ell}},
\end{aligned}
$$

which yields $\ell=N+s(a+1)+b<W_{2}$ and this contradicts the assumption that $W>W_{2}$ in a neighbourhood of $-\infty$. Hence, with this we have proven the last part of (37). Next, we apply the Comparison Lemma 3 on all the intervals $\left[t_{j}, \infty\right)$ for $j \geq 1$ in order to obtain the upper bound inequalities in Lemma 5. Similarly, the lower bound inequalities can be obtained.

Now, assume $L=\overline{\left[\left[\xi_{1}, \xi_{2}\right]\right]} \subset \mathbb{R}^{3}$. We have that $\omega(\zeta) \subseteq L$ by Lemma [5. As $\zeta_{2}$ is asymptotically stable, we get that $L$ has no circuits. Also, by (15), one could obtain that

$$
\operatorname{div} h(\xi)=-W+(s-2) Z+(-2+p+q) Y+2+a+N(1-s)+s+b<0 \quad \text { in } L
$$

By the use of Theorems 3.2 and 3.3 we get that $\omega(\xi)$ reduces to one of the equilibria $\xi_{1}$ or $\xi_{2}$. In case $\xi(t) \rightarrow \xi_{1}$ as $t \rightarrow \infty$, then we have that $Y(t) \rightarrow 0$ as $t \rightarrow \infty$. Also, we obtain that $Y_{t}>0$ in a neighbourhood of infinity by using the second equation of (31) which is impossible given that $Y(t)>0$ in $\mathbb{R}$. Therefore, $\xi(t) \rightarrow \xi_{2}$ as $t \rightarrow \infty$, that is

$$
\begin{aligned}
& \lim _{t \rightarrow \infty} X(t)=2+a+p\left(2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}\right) \\
& \lim _{t \rightarrow \infty} Y(t)=2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q} \\
& \lim _{t \rightarrow \infty} Z(t)=N+a+p\left(2+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}\right) \\
& \lim _{t \rightarrow \infty} W(t)=N+\frac{b+2 q+s(1+a+2 p)}{1-p s-q}
\end{aligned}
$$

Now, using $(X(t), Y(t), Z(t), W(t))$, we get

$$
\lim _{|x| \rightarrow \infty} \frac{u(x)}{|x|^{\frac{(a+2)(1-p s-q)+p s(a+1)+b p+2 q}{1-p s-q}}}=\frac{\left(A B^{s} K\right)^{\frac{p}{p s+q-1}}}{D K}
$$

and

$$
\lim _{|x| \rightarrow \infty} \frac{v(x)}{|x|^{\frac{(a+1) s+b+2}{1-p s-q}}}=\left(A B^{s} K\right)^{\frac{1}{p s+q-1}}
$$

where,

$$
\begin{aligned}
A & =\lim _{t \rightarrow \infty} Y(t), \\
B & =\lim _{t \rightarrow \infty} Z(t), \\
K & =\lim _{t \rightarrow \infty} W(t), \\
D & =\lim _{t \rightarrow \infty} X(t) .
\end{aligned}
$$
