# QUANTIZATION OF (-1)-SHIFTED DERIVED POISSON MANIFOLDS

#### Abstract

We investigate the quantization problem of $(-1)$-shifted derived Poisson manifolds in terms of $\mathrm{BV}_{\infty}$-operators on the space of Berezinian half-densities. We prove that quantizing such a $(-1)$-shifted derived Poisson manifold is equivalent to the lifting of a consecutive sequence of Maurer-Cartan elements, each obtained from a short exact sequence of differential graded Lie algebras. At each step, the obstruction is a certain class in the second Poisson cohomology. Consequently, a $(-1)$-shifted derived Poisson manifold is quantizable if the second Poisson cohomology group vanishes. We also prove that for any $L_{\infty}$-algebroid $\mathcal{A}$, its corresponding linear $(-1)$-shifted derived Poisson manifold $\mathcal{A}^{\vee}[-1]$ admits a canonical quantization. Finally, given a Lie algebroid $A$ and a one-cocycle $s \in \Gamma\left(A^{\vee}\right)$, the $(-1)$-shifted derived Poisson manifold corresponding to the derived intersection of coisotropic submanifolds determined by the graph of $s$ and the zero section of the Lie-Poisson $A^{\vee}$ is shown to admit a canonical quantization in terms of Evens-Lu-Weinstein module.


## Introduction

The notion of homotopy Schouten algebras was introduced by Khudaverdian-Voronov in their seminar paper [28] in 2008. In particular, they discovered a homotopy analogue of Koszul-Brylinski construction $[13,35]$ that the space of differential forms on a $P_{\infty}$-manifold [15, 46] admits a canonical homotopy Schouten algebra structure. Khudaverdian-Voronov's construction is mainly in the context of supergeometry, i.e. $\mathbb{Z}_{2}$-grading. In the context of $\mathbb{Z}$-grading, following Pridham [47, 49], the underlying geometric object in the $C^{\infty}$-context is called $(-1)$-shifted derived Poisson manifolds [3].
A (-1)-shifted derived Poisson manifold is a $\mathbb{Z}$-graded manifold $\mathcal{M}$ whose algebra of functions $C^{\infty}(\mathcal{M})$ is a homotopy Schouten algebra, called $(+1)$-shifted derived Poisson algebra in the paper. Equivalently, a $(-1)$-shifted derived Poisson manifold $\mathcal{M}$ is a differential graded ( dg ) manifold $(\mathcal{M}, Q)$ equipped with a degree $(+1)$ formal power series $\Pi \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, where $\Pi=\sum_{n \geq 2} \Pi_{n}$ with $\Pi_{n} \in \Gamma\left(S^{n} T_{\mathcal{M}}\right)$, satisfies the Maurer-Cartan equation

\{Q, \Pi\}+\frac{1}{2}\{\Pi, \Pi\}=0 . \tag{1}
\end{equation*}

Here the bracket $\{-,-\}$ refers to the standard Poisson bracket on $\Gamma\left(\hat{S} T_{\mathcal{M}}\right) \cong C^{\infty}\left(T_{\mathcal{M}}^{\vee}\right)$ corresponding to the canonical symplectic structure on $T_{\mathcal{M}}^{\vee}$. We often write $\Pi_{1}=Q$, and call $Q+\Pi$ the Poisson tensor. A ( -1 )-shifted derived Poisson manifold is usually denoted ( $\mathcal{M}, Q, \Pi$ ).
This paper is devoted to the study of quantizations of $(-1)$-shifted derived Poisson manifolds. Following Kravchenko [36], a quantization of a ( -1 )-shifted derived Poisson manifold $(\mathcal{M}, Q, \Pi)$ is a square-zero differential operator of degree $(+1)$, defining a Batalin-Vilkovisky algebra up to homotopy, whose associated $(+1)$-shifted derived Poisson algebra is the one on $C^{\infty}(\mathcal{M})$ corresponding to $(\mathcal{M}, Q, \Pi)$. For quantizations being intrinsic, instead of differential operators on $C^{\infty}(\mathcal{M})$, we consider differential operators on $\Gamma\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$, the space of Berezinian half-densities on $\mathcal{M}$. More precisely, a quantization of a $(-1)$ shifted derived Poisson manifold $(\mathcal{M}, Q, \Pi)$ is a $\mathrm{BV}_{\infty}$-operator $\Delta \in \hbar \mathrm{DO}^{+}\left(\right.$Dens $\left._{\mathcal{M}}^{1 / 2}\right)$, i.e. a square-zero self-adjoint $\hbar$-enhanced differential operator, whose extended principal symbol, evaluated at $\hbar=1$, equals to $Q+\Pi$. See Definition 3.4. In [25], Khudaverdian-Peddie constructed an example of non-quantizable
$(-1)$-shifted derived Poisson manifold, which contains only one term $\Pi_{2} \in \Gamma\left(S^{2} T_{\mathcal{M}}\right)$ with $Q$ being zero, i.e. $(-1)$-shifted Poisson manifold. See Example 3.19.

Our first main result is the following theorem describing the obstruction class to the quantizations.
Theorem A (Theorem 3.10). Let $(\mathcal{M}, Q, \Pi)$ be a $(-1)$-shifted derived Poisson manifold. Assume that the second Poisson cohomology group $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$ vanishes, then $(\mathcal{M}, Q, \Pi)$ is quantizable.

Our strategy of proof is to convert the quantization problem into the problem of lifting Maurer-Cartan elements of a short exact sequence of differential graded Lie algebras (dglas). For a given dg manifold $(\mathcal{M}, Q)$, a $(-1)$-shifted derived Poisson structure $\Pi$ is equivalent to a Maurer-Cartan element of the dgla $\left(\Gamma\left(\hat{S} T_{\mathcal{M}}\right), \quad\{\cdot, \cdot\}, \quad\{Q, \cdot\}\right)$, while a $\mathrm{BV}_{\infty}$-operator $\Delta \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, or more precisely $\Delta-\hbar \mathcal{L}_{Q}$, corresponds to a Maurer-Cartan element of the dgla $\left(\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), \quad[\cdot, \cdot]_{\hbar}, \quad\left[\hbar \mathcal{L}_{Q}, \cdot\right]_{\hbar}\right)$. These two dglas are related by the short exact sequence

0 \longrightarrow \hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \xrightarrow{i} \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \xrightarrow{\phi} \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \longrightarrow 0 \tag{2}
\end{equation*}
$$

where $\hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is considered as a dg Lie subalgebra of $\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, the morphism $i$ is the inclusion map and $\phi$ is the morphism defined by the extended principal symbol, evaluated at $\hbar=1$. Here, for any integer $t \geq 0, \hbar \mathrm{DO}_{t}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, denotes the space of those $\hbar$-enhanced differential operators $\Delta$ such that $\frac{1}{\hbar^{t}} \Delta \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Therefore, the lifting of a Maurer-Cartan element in the short exact sequence (2) is equivalent to the lifting of a consecutive sequences of Maurer-Cartan elements, each obtained from the short exact sequences of dglas:

0 \longrightarrow \frac{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \stackrel{i_{k}}{\longrightarrow} \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \xrightarrow{\phi_{k}} \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \longrightarrow 0 \tag{3}
\end{equation*}

$k=1,2, \cdots$. Here $i_{k}$ is the natural inclusion and $\phi_{k}$ is the natural projection. These are indeed squarezero extensions of dglas. The obstruction to lifting a Maurer-Cartan element is proved to be a certain class in the second Poisson cohomology $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$.

Theorem $\mathbf{A}$ describes the obstruction to the existence of quantizations, which is a sufficient condition for quantizing $(-1)$-shifted derived Poisson manifolds. In many situation, however, although the second Poisson cohomology group $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$ does not vanish, $(\mathcal{M}, Q, \Pi)$ may still be quantizable.

An important class of $(-1)$-shifted derived Poisson manifolds arises as linear Poisson structures on a vector bundle, which corresponds to $L_{\infty}$-algebroids, similar to the ordinary Lie-Poisson construction [54, 18]. In other words, $L_{\infty}$-algebroid structures on a $\mathbb{Z}$-graded vector bundle $\mathcal{A}$ are in one-one correspondence to linear ( -1 )-shifted derived Poisson manifold structures on $\mathcal{A}^{\vee}[-1]$ [3]. Our second main theorem is the following

Theorem B (Theorem 3.22). For any $L_{\infty}$-algebroid $\mathcal{A}$, its corresponding linear $(-1)$-shifted derived Poisson manifold $\mathcal{A}^{\vee}[-1]$ admits a canonical quantization.

Our construction of the $\mathrm{BV}_{\infty}$-operator utilizes the fiberwise $\hbar$-Fourier transform [52] by Voronov-Zorich [62]:

\mathcal{F}: \Gamma\left(\text { Dens }_{\mathcal{A}[1]}^{1 / 2}\right) \xrightarrow{\simeq} \Gamma\left(\text { Dens }_{\mathcal{A}^{\vee}[-1]}^{1 / 2}\right) . \tag{4}
\end{equation*}

To any $L_{\infty}$-algebroid $\mathcal{A}$, there is a Chevalley-Eilenberg differential $D$, which is a homological vector field on $\mathcal{A}[1]$. Therefore, $(\mathcal{A}[1], D)$ is a dg manifold. We prove that $\Delta:=\mathcal{F} \circ \mathcal{L}_{\hbar D} \circ \mathcal{F}^{-1} \in \hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{A}^{\vee}[-1]}^{1 / 2}\right)$ is a $\mathrm{BV}_{\infty}$-operator quantizing the linear $(-1)$-shifted derived Poisson manifold on $\mathcal{A}^{\vee}[-1]$. If $\mathcal{M}$ is a $P_{\infty^{-}}$ manifold [15, 46], its cotangent bundle $T_{\mathcal{M}}^{\vee}$ naturally carries an $L_{\infty}$-algebroid structure [28], Thus $T_{\mathcal{M}}[-1]$
is a linear $(-1)$-shifted derived Lie-Poisson manifold, whose algebra of functions are differential forms on $\mathcal{M}$. Its quantization has been studied by Khudaverdian-Voronov [28] and more recently by Shemyakova [52].
Another important class of ( -1 )-shifted derived Poisson manifolds are derived intersections of coisotropic submanifolds in a Poisson manifold. As a toy model, we consider the Lie-Poisson manifold corresponding to a Lie algebroid. Let $A$ be a Lie algebroid and $s \in \Gamma\left(A^{\vee}\right)$ a Lie algebroid 1-cocycle, i.e. a smooth section satisfying the condition that $d_{\mathrm{CE}} s=0$, where $d_{\mathrm{CE}}$ is the Chevalley-Eilenberg differential of the Lie algebroid $A$. Both the graph of $s$ and the zero section are coisotropic submanifolds of the Lie-Poisson manifold $A^{\vee}$. Their derived intersection is a ( -1 )-shifted derived Poisson manifold ( $A^{\vee}[-1], \iota_{s}, \Pi_{2}$ ), where $\Pi_{2} \in \Gamma\left(S^{2} T_{A^{\vee}[-1]}\right)$ is the Poisson tensor determined by the Schouten algebra on $C^{\infty}\left(A^{\vee}[-1]\right) \cong$ $\Gamma\left(\Lambda^{-\bullet} A\right)$. In this situation, the $\mathrm{BV}_{\infty}$-operator is related to the Evens-Lu-Weinstein module [19].

Theorem C (Theorem 3.25). Let A be a Lie algebroid and $s \in \Gamma\left(A^{\vee}\right)$ a Lie algebroid 1-cocycle. Assume that $M$ is an orientable manifold and the vector bundle $A \rightarrow M$ is also orientable as well. Then the $(-1)$-shifted derived Poisson manifold $\left(A^{\vee}[-1], \iota_{s}, \Pi_{2}\right)$ admits a canonical quantization:

\Delta=\hbar \iota_{s}+\hbar^{2} \Phi \circ d_{C E}^{E L W} \circ \Phi^{-1}: \Gamma\left(\Lambda^{-\bullet} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \rightarrow \Gamma\left(\Lambda^{-(\bullet+1)} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{5}
\end{equation*}

Here $\Phi$ is the canonical isomorphism [1, Section 5] [21, Section 6.3]:

\Phi: \Gamma\left(\Lambda^{k} A^{\vee} \otimes\left(\Lambda^{t o p} A \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \xrightarrow{\simeq} \Gamma\left(\Lambda^{t o p-k} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{6}

for $k=0,1, \cdots$.
In particular, when $A$ is $T_{M}$ and $s=d f \in \Omega^{1}(M)$ an exact one-form, where $f \in C^{\infty}(M)$, the line bundle $\left(\Lambda^{\text {top }} A \otimes \Lambda^{\text {top }} T_{M}^{\vee}\right)^{\frac{1}{2}}$ is canonically isomorphic to the trivial line bundle $M \times \mathbb{R}$ and $d_{\mathrm{CE}}^{\mathrm{ELW}}$ reduces to the ordinary de Rham differential. As an immediate consequence, we see that

\hbar \iota_{d f}+\hbar^{2} \Phi \circ d_{D R} \circ \Phi^{-1}: \Gamma\left(\Lambda^{-\bullet} T_{M} \otimes\left(\Lambda^{\mathrm{top}} T_{M}^{\vee}\right)\right) \rightarrow \Gamma\left(\Lambda^{-(\bullet+1)} T_{M} \otimes\left(\Lambda^{\mathrm{top}} T_{M}^{\vee}\right)\right) \tag{7}
\end{equation*}

is a $\mathrm{BV}_{\infty}$-operator quantizing the $(-1)$-shifted derived symplectic manifold $\left(T_{M}^{\vee}[-1], \iota_{d f}, \omega_{\mathrm{can}}\right)$, where $\Phi: \Omega^{k}(M) \rightarrow \Gamma\left(\Lambda^{\mathrm{top}-k} T_{M} \otimes\left(\Lambda^{\mathrm{top}} T_{M}^{\vee}\right)\right), \forall k=0,1, \cdots$ is the canonical isomorphism.

Finally, we note that several works on related subject have appeared recently in the literature. For instance, we refer the readers to $[4,10,22,25,26,27,49,52,48]$ and references therein. In particular, we note that recently Bandiera proved the homotopy transfer theorem for $\mathrm{BV}_{\infty}$-algebras and showed that the homotopy transfer is compatible with quantizations [2]. The work in this paper is presented in the context of $\mathbb{Z}$-graded manifolds. However, it works for supermanifolds (i.e. $\mathbb{Z}_{2}$-graded) as well.

Notation. Let $V=\oplus_{n \in \mathbb{Z}} V_{n}$ be a $\mathbb{Z}$-graded vector space over $\mathbb{R}$, where an element $v \in V_{n}$ has degree $n$, written $|v|=n$. For $k \in \mathbb{Z}$, the symbol $V[k]$ denotes the $k$-shifted space such that $(V[k])_{n}:=V_{n+k}$. In particular, an element $v \in V$ of degree $n$ lies in $(V[k])_{n-k}$ if viewed as an element of $V[k]$. The dual vector space $V^{\vee}$ is graded according to $\left(V^{\vee}\right)_{n}:=\left(V_{-n}\right)^{\vee}$, which ensures the non-degenerate paring $V \times V^{\vee} \rightarrow \mathbb{R}$ carries degree zero.
Given a graded vector space $V$, let $S(V)$ denote the symmetric algebra of $V$, where $S(V)=\oplus_{m \geq 0} S^{m}(V)$ decomposes into homogeneous terms graded naturally by weight. A weight $m$, degree $l$ element of $S(V)$ is thus

v_{1} \odot \cdots \odot v_{m} \in S^{m}(V), \quad\left|v_{1}\right|+\cdots+\left|v_{m}\right|=l
$$

The symbol $\hat{S}(V)=\prod_{m=0}^{\infty} S^{m}(V)$ denotes the $\mathfrak{m}$-adic completion of $S(V)$ with respect to the ideal $\mathfrak{m}$ generated by $V$.

A $\mathbb{Z}$-graded manifold $\mathcal{M}$ is a smooth manifold $M$ (called the support), together with a sheaf of $\mathbb{Z}$-graded commutative $C_{M}^{\infty}$-algebras over $M$, isomorphic to $C^{\infty}(U) \otimes_{\mathbb{R}} \hat{S}\left(V^{\vee}\right)$ for any sufficiently small open neighborhood $U \subset M$, where $V$ is a fixed $\mathbb{Z}$-graded vector space, and $C_{M}^{\infty}$ denotes the sheaf of $\mathbb{R}$-valued smooth functions over $M$. If $M$ and $V$ are both finite dimensional, then $\mathcal{M}$ is said to be of finite dimension. Throughout this work, we only deal with finite dimensional $\mathbb{Z}$-graded manifolds. A dg manifold is a $\mathbb{Z}$ graded manifold equipped with a homological vector field, i.e. a vector field $Q$ of degree $(+1)$ such that $Q^{2}=0$.

## 1. (-1)-Shifted Derived Poisson Manifolds

Our definitions and conventions follow those in [3], adopted from [47, 49].

### 1.1. Definition.

Definition 1.1. $A(+1)$-shifted derived Poisson algebra is a $\mathbb{Z}$-graded commutative algebra $\mathcal{A}$ endowed with a sequence of degree $(+1)$ multi-linear maps $\lambda_{n}: \mathcal{A}^{\otimes n} \rightarrow \mathcal{A}, n \geq 1$, called Poisson multi-brackets, defining a $L_{\infty}[1]$-algebra structure on $\mathcal{A}$, and such that for any all $n \geq 1$, and homogeneous elements $a_{1}, \ldots, a_{n-1} \in \mathcal{A}$ the map

$$
a \mapsto \lambda_{n}\left(a_{1}, \ldots, a_{n-1}, a\right)
$$

is a graded derivation of degree $\left(1+\left|a_{1}\right|+\cdots\left|a_{n}\right|\right)$.
Remark 1.2. In general, for any $k \in \mathbb{Z}$, one can consider $k$-shifted derived Poisson algebras [3]. For $k=$ 0 , such algebras are known as homotopy Poisson algebras [28], or $P_{\infty}$-algebras [15, 46]. The associated $\mathbb{Z}_{2}$-graded derived Poisson algebras are known as homotopy Poisson and homotopy Schouten (or $S_{\infty}$ ) algebras for even and odd $k$ respectively, which are due to Khudaverdian-Voronov [28, 59]. The general behavior of these derived Poisson structures depends on the parity of the shift, and not on the value of the integer itself.
Definition 1.3. A morphism $\phi: \mathcal{A} \rightsquigarrow \mathcal{B}$ of $(+1)$-shifted derived Poisson algebras is a sequence $\left(\phi_{i}\right)_{i \geq 1}$ of degree zero linear maps $\phi_{i}: S^{i} \mathcal{A} \rightarrow \mathcal{B}$, which defines an $L_{\infty}[1]$-morphism from $\mathcal{A}$ to $\mathcal{B}$, and in addition satisfies the derivation property:

\phi_{n+1}\left(a_{1}, \ldots, a_{n}, b c\right)=\sum_{l=0}^{n} \sum_{\tau \in \operatorname{Sh}(l, n-l)} \varepsilon(\tau) \phi_{l+1}\left(a_{\tau(1)}, \ldots, a_{\tau(l)}, b\right) \phi_{n-l+1}\left(a_{\tau(l+1)}, \ldots, a_{\tau(n)}, c\right),
$$

where $a_{1}, \ldots, a_{n}, b, c \in \mathcal{A}$ are homogeneous elements, $\operatorname{Sh}(l, n-l)$ denotes the $(l, n-l)$-shuffles, and $\varepsilon(\tau)$ is the Koszul sign.
Definition 1.4. $A(-1)$-shifted derived Poisson manifold is a $\mathbb{Z}$-graded manifold $\mathcal{M}$ whose algebra of functions $C^{\infty}(\mathcal{M})$ is a $(+1)$-shifted derived Poisson algebra.

Similar to an ordinary Poisson manifold which is defined by an anti-symmetric degree 2 bivector field, a degree $(-1)$-shifted derived Poisson manifold structure is equivalent to a formal power series of symmetric contravariant tensor fields on $\mathcal{M}$ of degree $(+1)$. A degree $l$ vector field $X \in \Gamma\left(T_{\mathcal{M}}\right)$ as a section of the tangent bundle $T_{\mathcal{M}}$ is a derivation $X: C^{\infty}(\mathcal{M}) \rightarrow C^{\infty}(\mathcal{M})$ of degree $l$. The completed symmetric algebra

\Gamma\left(\hat{S} T_{\mathcal{M}}\right):=\prod_{n \geq 0} \Gamma\left(S^{n} T_{\mathcal{M}}\right)
$$

then consists of formal power series of symmetric contravariant tensor fields. It comes furnished with the degree 0 Poisson bracket:

\left\{X_{1} \odot \cdots \odot X_{n}, Y_{1} \odot \cdots \odot Y_{m}\right\}=\sum_{k=1}^{n} \sum_{l=1}^{m} \delta_{k} \varepsilon_{l} \mathbf{X}^{\{k\}} \odot\left[X_{k}, Y_{l}\right] \odot \mathbf{Y}^{\{l\}} \tag{8}
\end{equation*}

where $\mathbf{X}^{\{k\}}=X_{1} \odot \cdots \odot X_{k-1} \odot X_{k+1} \odot \cdots \odot X_{n}, \mathbf{Y}^{\{l\}}=Y_{1} \odot \cdots \odot Y_{l-1} \odot Y_{l+1} \odot \cdots \odot Y_{n}$, and the graded signs are given by the Koszul rule $\delta_{k}=(-1)^{\left|X_{k}\right|\left(\left|X_{k+1}\right|+\cdots+\left|X_{n}\right|\right)}$ and $\varepsilon_{l}=(-1)^{\left|Y_{l}\right|\left(\left|Y_{1}\right|+\cdots+\left|Y_{l-1}\right| \mid\right.}$.
Remark 1.5. The completed symmetric algebra $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ may be naturally identified with the algebra of fiberwise formal power series on $T_{\mathcal{M}}^{\vee}$, whence the degree 0 Poisson bracket (8) coincides with the degree 0 Poisson bracket arising from the canonical symplectic structure on $T_{\mathcal{M}}^{\vee}$.

Theorem 1.6. $[47,49,3] A(-1)$-shifted derived Poisson manifold $\mathcal{M}$ is equivalent to a differential graded (dg) manifold $(\mathcal{M}, Q)$ equipped with a degree $(+1)$ formal power series $\Pi \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, where $\Pi=$ $\sum_{n \geq 2} \Pi_{n}$ with $\Pi_{n} \in \Gamma\left(S^{n} T_{\mathcal{M}}\right)$, satisfies the Maurer-Cartan equation

$$
\begin{equation*}
\{Q, \Pi\}+\frac{1}{2}\{\Pi, \Pi\}=0 . \tag{9}
\end{equation*}
$$

Here $\{-,-\}$ stands for the canonical Poisson bracket (8).
As in classical Poisson geometry, $Q+\Pi$ is often called a Poisson tensor.
Let $\mathcal{M}$ and $\mathcal{M}^{\prime}$ be $(-1)$-shifted derived Poisson manifolds with Poisson multi-brackets $\lambda_{l}:\left(C^{\infty}(\mathcal{M})\right)^{\otimes l}$ $\rightarrow C^{\infty}(\mathcal{M})$ and $\lambda_{l}^{\prime}:\left(C^{\infty}\left(\mathcal{M}^{\prime}\right)\right)^{\otimes l} \rightarrow C^{\infty}\left(\mathcal{M}^{\prime}\right), l \geqslant 1$, respectively. A morphism of $(-1)$-shifted derived Poisson manifolds from $\mathcal{M}$ to $\mathcal{M}^{\prime}$ is a map of $\mathbb{Z}$-graded manifolds $\phi: \mathcal{M} \rightarrow \mathcal{M}^{\prime}$ together with a collection of maps

$$
\varphi_{n}:\left(C^{\infty}\left(\mathcal{M}^{\prime}\right)\right)^{\otimes n} \rightarrow C^{\infty}(\mathcal{M}), \quad n=2,3, \cdots
$$

such that $\varphi_{\infty}=\left(\varphi_{1}=\phi^{*}, \varphi_{2}, \varphi_{3}, \cdots\right)$ is a morphism of degree $(+1)$ derived Poisson algebras from $\left(C^{\infty}\left(\mathcal{M}^{\prime}\right), \lambda_{1}^{\prime}, \lambda_{2}^{\prime}, \cdots, \lambda_{n}^{\prime}, \cdots\right)$ to $\left(C^{\infty}(\mathcal{M}), \lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}, \cdots\right)$ [3]. In particular, $\phi: \mathcal{M} \rightarrow \mathcal{M}^{\prime}$ is a map of dg manifolds. Geometrically, these morphisms $\varphi_{\infty}$ correspond to the thick morphisms of graded manifolds due to Voronov [60, 61, 30, 31].

Example 1.7. For a finite dimensional $L_{\infty}$-algebra $\mathfrak{g}$, the multi-brackets $l_{n}: S^{n}(\mathfrak{g}[1]) \rightarrow \mathfrak{g}[1]$ on the $L_{\infty}[1]$-algebra $\mathfrak{g}[1]$ may be extended via the Leibniz rule to equip $\mathfrak{g} \vee[-1] \cong(\mathfrak{g}[1])^{\vee}$ with the structure of $a(-1)$-shifted derived Poisson manifold. Define

$$
\lambda_{n}\left(\xi_{a_{1}}, \ldots, \xi_{a_{n}}\right):= \pm C_{a_{1} \ldots a_{n}}^{b} \xi_{b},
$$

where $\xi_{a_{1}}, \ldots, \xi_{a_{n}}$ are the coordinate functions on $\mathfrak{g} \vee[-1]$ corresponding to a basis $\left\{e_{a}\right\}$ of $\mathfrak{g}[1]$, and $C_{a_{1} \ldots a_{n}}^{b}$ are the degree $(+1)$ structure constants of the nth multi-bracket $l_{n}$.
Example 1.8. Let $A$ be a Lie algebroid and $s \in \Gamma\left(A^{\vee}\right)$ a Lie algebroid 1 -cocycle, i.e. a smooth section satisfying the condition that $d_{C E} s=0$, where $d_{C E}$ is the Chevalley-Eilenberg differential of the Lie algebroid A. Consider the dg manifold $\left(A^{\vee}[-1], Q\right)$, where the algebra of functions $C^{\infty}\left(A^{\vee}[-1]\right) \cong \Gamma\left(\Lambda^{-\bullet} A\right)$ and $Q=\iota_{s}$, the interior product with $s$. This dg manifold describes the derived intersection of the graph of $s$ with the zero section of $A^{\vee}$. Note that both the graph of $s$ and the zero section are coisotropic submanifolds of the Lie-Poisson manifold $A^{\vee}$. Let $\Pi_{2} \in \Gamma\left(S^{2}\left(T_{A^{\vee}[-1]}\right)\right)$ be the Poisson tensor defining the Schouten bracket on $C^{\infty}\left(A^{\vee}[-1]\right) \cong \Gamma\left(\Lambda^{-\bullet} A\right)$. Then $\left(A^{\vee}[-1], \iota_{s}, \Pi_{2}\right)$ is indeed a $(-1)$-shifted derived Poisson manifold, which describes the derived intersection of coisotropic submanifolds graph (s) and the zero section of the Lie-Poisson manifold $A^{\vee}$.
In particular, when $A$ is $T_{M}$ and $s \in \Omega^{1}(M)$ is a closed one-form, we have a $(-1)$-shifted derived Poisson manifold $\left(T_{M}^{\vee}[-1], \iota_{s}, \Pi_{2}\right)$, which is indeed a $(-1)$-shifted derived symplectic manifold, denoted $\left(T_{M}^{\vee}[-1], \iota_{s}, \omega_{\text {can }}\right)$. It is the derived intersection, in the symplectic manifold $T_{M}^{\vee}$, of two Lagrangian submanifolds: the graph of $s$ and the zero section.

The following example is due to Khudaverdian-Voronov [31]. See also [52].

Example 1.9. A homotopy Poisson structure on a $\mathbb{Z}$-graded manifold $\mathcal{M}$, according to KhudaverdianVoronov [28], is defined by a degree ( +2 ) formal power series $P=\sum_{n \geq 1} P_{n} \in \Gamma\left(\hat{S}\left(T_{\mathcal{M}}[-1]\right)\right)$, satisfying the equation $\llbracket P, P \rrbracket=0$, where the canonical Schouten bracket $\llbracket \cdot, \cdot \rrbracket$ carries degree $(-1)^{1}$. Thus $P$ corresponds to a degree $(+2)$ formal power series in $C^{\infty}\left(T_{\mathcal{M}}^{\vee}[1]\right)$, whose Hamiltonian vector field $d_{P}$ is a homological vector field on $T_{\mathcal{M}}^{\vee}[1]$. It in turn determines a degree $(+1)$ fiberwise linear function on the cotangent bundle $h_{P} \in C^{\infty}\left(T_{T_{\mathcal{M}}^{\prime}[1]}^{\mathcal{M}}\right)$ such that

$$
\left\{h_{P},-\right\}=d_{P}, \quad\left\{h_{P}, h_{P}\right\}=0,
$$

for the canonical degree 0 Poisson bracket on $T_{T_{\mathcal{M}}^{\vee}[1]}^{\vee}$. Via the canonical isomorphism of double vector bundles $T_{T_{\mathcal{M}}[1]}^{\vee} \cong T_{T_{\mathcal{M}[-1]}^{\vee}}^{\vee}$, one obtains a degree $(+1)$ function on $T_{T_{\mathcal{M}}[-1]}^{\vee}$ satisfying the Maurer-Cartan equation, and hence a $(-1)$-shifted derived Poisson structure on $T_{\mathcal{M}}[-1]$.
Remark 1.10. In the $\mathbb{Z}_{2}$-grading case, the multi-brackets corresponding to the $(-1)$-shifted derived Poisson structure on $T_{\mathcal{M}}[-1]$ in Example 1.9 are called the higher Koszul brackets [28, 31, 52]. In this case, if there is only a single binary bracket, it reduces to the classical Koszul bracket [35, 13, 64] defined on differential forms.
1.2. Poisson cohomology. Let $(\mathcal{M}, Q, \Pi)$ be a ( -1 )-shifted derived Poisson manifold. The Lichnerowicz differential $d_{\Pi}: \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ of degree ( +1 ) is defined by

$$
d_{\Pi}=\mathcal{L}_{Q}+\{\Pi,-\}=\{Q+\Pi,-\}, \quad\left|d_{\Pi}\right|=1
$$

That $d_{\Pi}^{2}=0$ is equivalent to the Maurer-Cartan equation (9). Then $\left(\Gamma\left(\hat{S} T_{\mathcal{M}}\right), d_{\Pi}\right)$ is a cochain complex, whose cohomology groups form the Poisson cohomology of the $(-1)$-shifted derived Poisson manifold $\mathcal{M}$ :

$$
\mathcal{H}^{k}(\mathcal{M}, Q+\Pi):=\frac{\operatorname{ker}\left(d_{\Pi}: \Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{k} \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{k+1}\right)}{\operatorname{im}\left(d_{\Pi}: \Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{k-1} \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{k}\right)}, \quad k \in \mathbb{Z}
$$

Example 1.11. Let $\mathcal{M}$ be a (-1)-shifted derived Poisson manifold with a single binary bracket defined by the degree $(+1)$ symmetric tensor field $\Pi_{2}$. Assume that $\Pi_{2}$ is nondegenerate. Hence $\mathcal{M}$ is a $(-1)$-shifted symplectic manifold, and there exists a bundle isomorphism $T_{\mathcal{M}}^{\vee} \stackrel{\simeq}{\leftrightarrows} T_{\mathcal{M}}[1]$ defined by $\alpha \mapsto \Pi_{2}(\alpha,-)$, for any differential one form $\alpha \in \Gamma\left(T_{\mathcal{M}}^{\vee}\right)$.
This isomorphism induces an isomorphism between Poisson and de Rham cohomologies in the usual sense.

## 2. $B V_{\infty}$-operators on Berezinian half-densities

2.1. Differential operators on half-densities. In this section, we recall some basic properties regarding differential operators acting on half densities [58, 52, 29, 17].

Here for a $\mathbb{Z}$-graded manifold $\mathcal{M}$, we always assume that the normal bundle $N_{\mathcal{M} / \mathcal{M}_{\text {even }}}$ to the even submanifold $\mathcal{M}_{\text {even }} \subset \mathcal{M}$ is orientable so that one can speak about half densities and the scalar product of half densities. See [29, Remark 2]. Let Dens ${ }_{\mathcal{M}}^{1 / 2}$ denote the Berezinian half-density line bundle over a graded manifold $\mathcal{M}$, and let $\Gamma\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ be the space of global smooth sections, i.e. the space of Berezinian halfdensities on $\mathcal{M}$. For a fixed coordinate system $\left(x^{a}\right)$ on $\mathcal{M}$, a local basis element will be represented by the symbol $\sqrt{\mathcal{D} x}$ and a Berezinian half-density takes the expression $\mathbf{s}=s(x) \sqrt{\mathcal{D} x}$, where $s(x) \in C^{\infty}(\mathcal{M})$. As a geometric object, a half-density $\mathbf{s}$ transforms according to the law

$$
\mathbf{s}=s(x) \sqrt{\mathcal{D} x}=s\left(x\left(x^{\prime}\right)\right)\left|\operatorname{Ber}\left(\frac{\partial x}{\partial x^{\prime}}\right)\right|^{\frac{1}{2}} \sqrt{\mathcal{D} x^{\prime}}, \quad x=x\left(x^{\prime}\right)
$$

[^0]where $\left|\operatorname{Ber}\left(\frac{\partial x}{\partial x^{\prime}}\right)\right|$ is the absolute value of the Berezinian, or superdeterminant, of the Jacobian matrix $\left(\frac{\partial x}{\partial x^{\prime}}\right)$ of the coordinate transformation $x=x\left(x^{\prime}\right)[58,52,29]$.

Example 2.1. Let $\mathcal{M}$ be a $\mathbb{Z}$-graded manifold corresponding to a graded vector bundle $E \rightarrow M$. That is, the graded manifold with support $M$ where the sheaf $\mathcal{A}$ of $\mathbb{Z}$-graded commutative $C_{M}^{\infty}$-algebras over $M$ is given by $\left.\mathcal{A}\right|_{U}=\Gamma\left(U, \hat{S}\left(E^{\vee}\right)\right)$, for any open neighborhood $U \subset M$. Then $\mathcal{M}_{\text {even }}$ corresponds to the graded vector bundle $E_{\text {even }} \rightarrow M$ of even degrees. The condition of $N_{\mathcal{M} / \mathcal{M}_{\text {even }}}$ being orientable is equivalent to requiring that the vector bundle $E_{\text {odd }} \rightarrow M$ of odd degrees is orientable as an ordinary vector bundle by forgetting about the degrees. In this case, the Berezinian line bundle $\operatorname{Ber}(\mathcal{M}) \rightarrow \mathcal{M}$ is isomorphic to the pull back bundle of the line bundle $\Lambda^{\text {top }} E_{\text {odd }} \otimes \Lambda^{\text {top }} E_{\text {even }}^{\vee} \otimes \Lambda^{\text {top }} T_{M}^{\vee} \rightarrow M$ via the projection map $\pi: \mathcal{M} \rightarrow M$ [14], while the Berezinian half-density line bundle Dens $_{\mathcal{M}}^{1 / 2}$ is isomorphic to the pull back bundle of the line bundle $\left(\Lambda^{\text {top }} E_{\text {odd }}\right)^{\frac{1}{2}} \otimes\left|\Lambda^{\text {top }} E_{\text {even }}^{\vee} \otimes \Lambda^{\text {top }} T_{M}^{\vee}\right|^{\frac{1}{2}} \rightarrow M$ via the projection map $\pi: \mathcal{M} \rightarrow M$. Here $\left|\Lambda^{\text {top }} E_{\text {even }}^{\vee} \otimes \Lambda^{\text {top }} T_{M}^{\vee}\right|$ denotes the line bundle $\Lambda^{\text {top }} E_{\text {even }}^{\vee} \otimes \Lambda^{\text {top }} T_{M}^{\vee}$ tensored by its orientation bundle. Since $E_{\text {odd }} \rightarrow M$ is orientable, $\Lambda^{\text {top }} E_{\text {odd }}$ can be identified with $\left|\Lambda^{\text {top }} E_{\text {odd }}\right|$ and hence $\left(\Lambda^{\text {top }} E_{o d d}\right)^{\frac{1}{2}}$ is defined, by abuse of notation.

Definition 2.2. A differential operator acting on Berezinian half-densities, of order $\leq n \in \mathbb{Z}$, is an endomorphism of sections

$$
\Delta: \Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \rightarrow \Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)
$$

such that:

- for any $n<0$, all operators are identically zero;
- for $n=0$, any operator $\Delta$ is identified with a function $f \in C^{\infty}(\mathcal{M})$ which acts through the $C^{\infty}(\mathcal{M})$-module structure; and
- for all $n>0$, the commutator $[\Delta, f]$ is a differential operator of order $\leq n-1$ for any operator $f$ of zero order.

Under a chosen coordinate system $\left(x^{a}\right)$, a differential operator of order $\leq n$ is determined by a basis of partial derivatives:

$$
\begin{equation*}
\Delta \mathbf{s}=\sum_{k=0}^{n} \frac{1}{k!} \Delta^{a_{1} \cdots a_{k}}(x) \partial_{a_{k}} \ldots \partial_{a_{1}} s(x) \sqrt{\mathcal{D} x}, \quad \mathbf{s} \in \Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{10}
\end{equation*}
$$

The space of all differential operators on Berezinian half-densities is denoted by $\mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$, and carries an increasing filtration determined by the order of differential operators:

$$
\begin{equation*}
\mathrm{DO}^{0}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \mathrm{DO}^{\leq 1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \mathrm{DO}^{\leq 2}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \cdots \tag{11}
\end{equation*}
$$

where $\mathrm{DO}^{\leq n}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ denotes the space of differential operators of order at most $n$. In particular, $\mathrm{DO}^{0}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right) \cong C^{\infty}(\mathcal{M})$, where functions act by the $C^{\infty}(\mathcal{M})$-module structure, while $\mathrm{DO}^{\leq 1}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is naturally identified with $\Gamma\left(T_{\mathcal{M}}\right) \oplus C^{\infty}(\mathcal{M})$, where vector fields act by taking the Lie derivative.
It is clear that $\mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a filtered associated algebra when being equipped with the natural multiplication of composition of operators:

$$
\mathrm{DO}^{\leq n}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right) \cdot \mathrm{DO}^{\leq m}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subseteq \mathrm{DO}^{\leq n+m}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)
$$

When being equipped with the commutator of endomorphisms, $\mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a filtered Lie algebra:

$$
\begin{equation*}
\left[\mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), \mathrm{DO}^{\leq m}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)\right] \subseteq \mathrm{DO}^{\leq n+m-1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{12}
\end{equation*}
$$

reducing the order by one. Define the associated graded algebras

$$
\begin{gathered}
\operatorname{GrDO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)=\bigoplus_{n \geq 0} \operatorname{Gr}^{n} \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), \quad \text { and } \\
\widehat{\operatorname{GrDO}}\left(\text { Dens }_{\mathcal{M}}^{1 / 2}\right)=\prod_{n \geq 0} \operatorname{Gr}^{n} \mathrm{DO}\left(\text { Dens }_{\mathcal{M}}^{1 / 2}\right)
\end{gathered}
$$

where

$$
\operatorname{Gr}^{n} \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right):=\mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) / \mathrm{DO}^{\leq n-1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)
$$

The following is an extension, in the graded context, of a well-known result for ordinary manifolds. For completeness, we will sketch a proof.

Lemma 2.3. (1). As a $C^{\infty}(\mathcal{M})$-module, $\operatorname{Gr}^{n} \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ can be naturally identified with $\Gamma\left(S^{n} T_{\mathcal{M}}\right)$. (2). Under the identification above, $\operatorname{GrDO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and $\widehat{\operatorname{GrDO}}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ can be naturally identified, as $C^{\infty}(\mathcal{M})$-modules, with $\Gamma\left(S T_{\mathcal{M}}\right)$ and $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, respectively.

Proof. (1). Introduce the $n$th principal symbol map

$$
\sigma_{n}: \mathrm{DO}^{\leq n}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right) \rightarrow \Gamma\left(S^{n} T_{\mathcal{M}}\right)
$$

as follows. Locally, write $\Delta=\sum_{k=0}^{n} \frac{1}{k!} \Delta^{a_{1} \cdots a_{k}}(x) \partial_{a_{k}} \ldots \partial_{a_{1}}$, as in Eq. (10). Then $\sigma_{n}(\Delta)$ is a weight $n$ symmetric contravariant tensor field on $\mathcal{M}$ of equal degree, given by

$$
\begin{equation*}
\sigma_{n}(\Delta)=\sigma_{n}\left(\sum_{k=0}^{n} \frac{1}{k!} \Delta^{a_{1} \cdots a_{k}}(x) \partial_{a_{k}} \ldots \partial_{a_{1}}\right)=\frac{1}{n!} \Delta^{a_{1} \cdots a_{n}}(x) \partial_{a_{n}} \odot \ldots \odot \partial_{a_{1}} . \tag{13}
\end{equation*}
$$

It is simple to check that $\sigma_{n}$ is indeed a well-defined $C^{\infty}(\mathcal{M})$-module map, and moreover, any operator $\Delta$ is of order $<n$ if and only if $\sigma_{n}(\Delta)$ vanishes identically. Thus it follows that $\operatorname{ker} \sigma_{n} \cong \mathrm{DO}^{\leq n-1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and therefore the conclusion follows.
(2). This is an immediate consequence of (1).

Again the following lemma extends a standard result for ordinary differential operators to the graded context.
Lemma 2.4. Let $\Delta \in \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and $\Delta^{\prime} \in \mathrm{DO}^{\leq m}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Then
(1).

$$
\begin{equation*}
\sigma_{n+m}\left(\Delta \cdot \Delta^{\prime}\right)=\sigma_{n}(\Delta) \sigma_{m}\left(\Delta^{\prime}\right) \quad \text { and } \tag{14}
\end{equation*}
$$

(2).

$$
\begin{equation*}
\sigma_{n+m-1}\left(\left[\Delta, \Delta^{\prime}\right]\right)=\left\{\sigma_{n}(\Delta), \sigma_{m}\left(\Delta^{\prime}\right)\right\} \tag{15}
\end{equation*}
$$

where $\{\cdot, \cdot\}$ is the degree 0 Poisson bracket on $\Gamma\left(S T_{\mathcal{M}}\right)$ as given by Eq. (8).
Proof. (1). It suffices to prove Eq. (14) locally. The operators $\Delta$ and $\Delta^{\prime}$ can be written locally as follows:

$$
\begin{aligned}
\Delta & =\sum_{k=0}^{n} \frac{1}{k!} \Delta^{a_{1} \cdots a_{k}}(x) \partial_{a_{k}} \ldots \partial_{a_{1}} \quad \text { and } \\
\Delta^{\prime} & =\sum_{k=0}^{m} \frac{1}{k!}\left(\Delta^{\prime}\right)^{a_{1} \cdots a_{k}}(x) \partial_{a_{k}} \ldots \partial_{a_{1}}
\end{aligned}
$$

Then $\Delta \cdot \Delta^{\prime} \in \mathrm{DO}^{\leq n+m}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and its leading term is equal to

$$
\frac{1}{n!m!}(-1)^{\left|\left(\Delta^{\prime}\right)^{b_{1} \cdots b_{m}}\right|\left(\left|\partial_{a_{n}}\right|+\cdots+\left|\partial_{a_{1}}\right|\right)} \Delta^{a_{1} \cdots a_{n}}(x)\left(\Delta^{\prime}\right)^{b_{1} \cdots b_{m}}(x) \partial_{a_{n}} \ldots \partial_{a_{1}} \partial_{b_{m}} \ldots \partial_{b_{1}}
$$

Therefore,

$$
\begin{aligned}
& \sigma_{n+m}\left(\Delta \cdot \Delta^{\prime}\right) \\
= & \frac{1}{n!m!}(-1)^{\left|\left(\Delta^{\prime}\right)^{b_{1} \cdots b_{m}}\right|\left(\left|\partial_{a_{n}}\right|+\cdots+\left|\partial_{a_{1}}\right|\right)} \Delta^{a_{1} \cdots a_{n}}(x)\left(\Delta^{\prime}\right)^{b_{1} \cdots b_{m}}(x) \partial_{a_{n}} \odot \ldots \odot \partial_{a_{1}} \odot \partial_{b_{m}} \odot \ldots \odot \partial_{b_{1}} \\
= & \sigma_{n}(\Delta) \sigma_{m}\left(\Delta^{\prime}\right)
\end{aligned}
$$

(2). We prove it by induction on the pair $(n, m)$. It follows from a direct verification that Eq. (15) holds in the case that $n=0,1$ and $m=0,1$. Assume that Eq. (15) holds for $n \leq N$ and $m \leq M$ with $N \geq 1$ and $M \geq 1$. We will prove that Eq. (15) holds for $n \leq N$ and $m=M+1$. Consider the case that $\Delta^{\prime}=\Delta_{1}^{\prime} \cdot \Delta_{2}^{\prime}$, where $\Delta_{1}^{\prime} \in \mathrm{DO}^{\leq m_{1}}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and $\Delta_{2}^{\prime} \in \mathrm{DO}^{\leq m_{2}}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ are of homogeneous degree, and $m=M+1=m_{1}+m_{2}$ with $m_{1} \leq M$ and $m_{2} \leq M$. Then

$$
\begin{aligned}
& \sigma_{n+m-1}\left(\left[\Delta, \Delta^{\prime}\right]\right) \\
= & \sigma_{n+m-1}\left(\left[\Delta, \Delta_{1}^{\prime} \cdot \Delta_{2}^{\prime}\right]\right) \\
= & \sigma_{n+m-1}\left(\left[\Delta, \Delta_{1}^{\prime}\right] \cdot \Delta_{2}^{\prime}+(-1)^{|\Delta|\left|\Delta_{1}^{\prime}\right|} \Delta_{1}^{\prime} \cdot\left[\Delta, \Delta_{2}^{\prime}\right]\right) \quad \text { (by Eq. (14)) } \\
= & \sigma_{n+m_{1}-1}\left(\left[\Delta, \Delta_{1}^{\prime}\right]\right) \cdot \sigma_{m_{2}}\left(\Delta_{2}^{\prime}\right)+(-1)^{|\Delta|\left|\Delta_{1}^{\prime}\right|} \sigma_{m_{1}}\left(\Delta_{1}^{\prime}\right) \sigma_{n+m_{2}-1}\left(\left[\Delta, \Delta_{2}^{\prime}\right]\right) \quad \text { (by induction assumption) } \\
= & \left\{\sigma_{n}(\Delta), \sigma_{m_{1}}\left(\Delta_{1}^{\prime}\right)\right\} \sigma_{m_{2}}\left(\Delta_{2}^{\prime}\right)+(-1)^{|\Delta|\left|\Delta_{1}^{\prime}\right|} \sigma_{m_{1}}\left(\Delta_{1}^{\prime}\right)\left\{\sigma_{n}(\Delta), \sigma_{m_{2}}\left(\Delta_{2}^{\prime}\right)\right\} \\
= & \left\{\sigma_{n}(\Delta), \sigma_{m_{1}}\left(\Delta_{1}^{\prime}\right) \sigma_{m_{2}}\left(\Delta_{2}^{\prime}\right)\right\} \quad \text { (by Eq. (14)) } \\
= & \left\{\sigma_{n}(\Delta), \sigma_{m_{1}+m_{2}}\left(\Delta_{1}^{\prime} \cdot \Delta_{2}^{\prime}\right)\right\} \\
= & \left\{\sigma_{n}(\Delta), \sigma_{m}\left(\Delta^{\prime}\right)\right\} .
\end{aligned}
$$

Since any operator in $\mathrm{DO}^{\leq M+1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ can always be written as such a product $\Delta_{1}^{\prime} \cdot \Delta_{2}^{\prime}$ module $\mathrm{DO}^{\leq M}$ (Dens ${ }_{\mathcal{M}}^{1 / 2}$ ), we conclude that Eq. (15) holds for any $n \leq N$ and $m=M+1$. By induction, it implies that Eq. (15) holds for any $n \leq N$ and $m \in \mathbb{N}$. Since both sides of Eq. (15) are skew-symmetric, the conclusion thus follows.

As a consequence, the principal symbol maps establish an isomorphism of degree zero Poisson algebras

$$
\widehat{\operatorname{GrDO}}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \xrightarrow{\simeq} \Gamma\left(\hat{S} T_{\mathcal{M}}\right)
$$

where the bracket on the completed graded algebra $\widehat{\mathrm{GrDO}}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is induced from the commutator of differential operators, and the bracket on $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ is the canonical Poisson bracket (8).
The existence of a canonical non-degenerate scalar product $\langle-,-\rangle$ on half-densities allows us to speak naturally about the (formal) adjoint of a differential operator as in the classical case [9].
Definition 2.5. Let $\Delta \in \mathrm{DO}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ be a differential operator of homogeneous degree. The (formal) adjoint operator $\Delta^{+} \in \operatorname{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is defined by the relation

$$
\langle\Delta \boldsymbol{s}, \boldsymbol{t}\rangle=(-1)^{|\Delta||\boldsymbol{s}|}\left\langle\boldsymbol{s}, \Delta^{+} \boldsymbol{t}\right\rangle,
$$

where $\boldsymbol{s}, \boldsymbol{t} \in \Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ are compactly supported half-densities of homogeneous degrees.
As in the classical case of ordinary differential operators [9, Section 2.1] [50, Section VIII], one can see that for any operator $\Delta$, the (formal) adjoint operator always exists and is unique.
The following lemma can be verified directly.
Lemma 2.6. (1) Taking the (formal) adjoint is a linear operation on $\operatorname{DO}\left(\operatorname{Dens}_{\mathcal{M}}{ }^{1 / 2}\right)$.
(2) If $\Delta$ is a differential operator of order $n$ and of homogeneous degree, then the (formal) adjoint operator $\Delta^{+}$is also of order $n$ and carries the same degree.
(3) For any operator $\Delta$, the (formal) adjoint is an involution, i.e.

$$
\left(\Delta^{+}\right)^{+}=\Delta
$$

(4) For any pair of operators $\Delta$ and $\Delta^{\prime}$ of homogeneous degrees,

$$
\left(\Delta \cdot \Delta^{\prime}\right)^{+}=(-1)^{|\Delta|\left|\Delta^{\prime}\right|} \Delta^{\prime+} \cdot \Delta^{+}
$$

Lemma 2.7. Let $\Delta$ be a first order differential operator on $\mathrm{Dens}_{\mathcal{M}}^{1 / 2}$ of homogeneous degree, described locally by $\Delta=X^{a}(x) \partial_{a}+X_{0}(x)$. The adjoint operator is given by

$$
\begin{equation*}
\Delta^{+}=-X^{a}(x) \partial_{a}-(-1)^{\left|\partial_{a} \| X^{a}\right|} \partial_{a}\left(X^{a}\right)(x)+X_{0}(x) \tag{16}
\end{equation*}
$$

Proof. By integration by parts, we have

$$
\left\langle\partial_{a} \mathbf{s}, \mathbf{t}\right\rangle=-(-1)^{\left|\partial_{a}\right||\mathbf{s}|}\left\langle\mathbf{s}, \partial_{a} \mathbf{t}\right\rangle
$$

It thus follows that

$$
\begin{equation*}
\partial_{a}^{+}=-\partial_{a} \tag{17}
\end{equation*}
$$

On the other hand,

$$
\left\langle X^{a}(x) \cdot \mathbf{s}, \mathbf{t}\right\rangle=(-1)^{\left|X^{a}\right| \mid \mathbf{s}}\left\langle\mathbf{s}, X^{a}(x) \cdot \mathbf{t}\right\rangle
$$

Thus it follows that

$$
\begin{equation*}
X^{a}(x)^{+}=X^{a}(x) \tag{18}
\end{equation*}
$$

where, by abuse of notation, $X^{a}(x)$ means the multiplication operator by $X^{a}(x)$.
Therefore, we have

$$
\begin{aligned}
\Delta^{+} & =\left(X^{a}(x) \partial_{a}+X_{0}(x)\right)^{+} \\
& =\left(X^{a}(x) \partial_{a}\right)^{+}+\left(X_{0}(x)\right)^{+} \quad(\text { by Lemma 2.6(4) }) \\
& \left.=(-1)^{\left|\partial_{a}\right|\left|X^{a}\right|} \partial_{a}^{+} \cdot X^{a}(x)^{+}+X_{0}(x)^{+} \quad \text { (by Eqs.(17) }-(18)\right) \\
& =-(-1)^{\left|\partial_{a}\right|\left|X^{a}\right|} \partial_{a} \cdot X^{a}(x)+X_{0}(x) \\
& =-X^{a}(x) \partial_{a}-(-1)^{\left|\partial_{a} \| X^{a}\right|} \partial_{a}\left(X^{a}\right)(x)+X_{0}(x)
\end{aligned}
$$

Definition 2.8. An operator $\Delta \in \operatorname{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is called self-adjoint if $\Delta^{+}=\Delta$, and anti-self-adjoint if $\Delta^{+}=-\Delta$.

Let $\mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ denote the subset consisting of all self-adjoint and anti-self-adjoint differential operators on Berezinian half-densities. Note that although both the space of self-adjoint differential operators and the space of anti-self-adjoint differential operators are vector spaces, $\mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is not a vector space. The sum of a self-adjoint and anti-self-adjoint operator is no longer self or anti-self adjoint.

Lemma 2.9. For any differential operator $\Delta \in \operatorname{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ of order $n$, we have

$$
\begin{equation*}
\sigma_{n}\left(\Delta^{+}\right)=(-1)^{n} \sigma_{n}(\Delta) \tag{19}
\end{equation*}
$$

Proof. Let $\left(x^{a}\right)$ be coordinates on $\mathcal{M}$. Assume that the leading term of $\Delta$ is $\frac{1}{n!} \Delta^{a_{1} \cdots a_{n}}(x) \partial_{a_{n}} \ldots \partial_{a_{1}}$. According to Lemma 2.6 (4) and Eqs. (17)-(18), we have

$$
\Delta^{+}=(-1)^{n} \frac{1}{n!} \Delta^{a_{1} \cdots a_{n}}(x) \partial_{a_{n}} \ldots \partial_{a_{1}}+\cdots
$$

The conclusion thus follows immediately.

Corollary 2.10. Let $\Delta \in \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ be a differential operator of order $n$. If $\Delta$ is self-adjoint, then $n$ is necessarily even. Likewise if $\Delta$ is anti-self-adjoint, then $n$ is necessarily odd. Hence, we have

$$
\Delta^{+}=(-1)^{n} \Delta
$$

Proof. Assume that $\Delta$ is a self-adjoint operator of order $n$. Then $\Delta^{+}=\Delta$. Applying the principal symbol map, we have $(-1)^{n} \sigma_{n}(\Delta)=\sigma_{n}(\Delta)$ according to Lemma 2.9. Since $\sigma_{n}(\Delta) \neq 0$, thus it follows that $n$ must be even. Similarly we prove that if $\Delta$ is anti-self-adjoint, then $n$ is necessarily odd.

Proposition 2.11. The set $\mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is closed under the commutator (12), and inherits the increasing filtration (11) determined by the order.

Proof. That this set inherits the filtration is evident. Now let $\Delta, \Delta^{\prime} \in \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ be operators of order $n$ and $m$ respectively. Consider the commutator $\left[\Delta, \Delta^{\prime}\right]$. From Lemma 2.6 and Corollary 2.10, it follows that

$$
\begin{align*}
& {\left[\Delta, \Delta^{\prime}\right]^{+}=\left(\Delta \cdot \Delta^{\prime}-(-1)^{|\Delta|\left|\Delta^{\prime}\right|} \Delta^{\prime} \cdot \Delta\right)^{+}=(-1)^{|\Delta|\left|\Delta^{\prime}\right|} \Delta^{\prime+} \cdot \Delta^{+}-\Delta^{+} \cdot \Delta^{\prime+}} \\
& \quad=(-1)^{|\Delta|\left|\Delta^{\prime}\right|+n+m} \Delta^{\prime} \cdot \Delta-(-1)^{n+m} \Delta \cdot \Delta^{\prime}=(-1)^{n+m-1}\left[\Delta, \Delta^{\prime}\right] \tag{20}
\end{align*}
$$

Since $\left[\Delta, \Delta^{\prime}\right]$ is an operator of order at most $n+m-1$, it must be either self-adjoint or anti-self-adjoint depending on the parity of $n+m-1$.

Note that although the set $\mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is closed under the commutator, it does not form a Lie algebra since it is not a vector space.

Corollary 2.12. Let $\Delta, \Delta^{\prime} \in \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ be differential operators of order $n$ and $m$, respectively. Assume that the order of the commutator $\left[\Delta, \Delta^{\prime}\right]$ is strictly less than $n+m-1$. Then $\left[\Delta, \Delta^{\prime}\right]$ must be of order strictly less than $n+m-2$ also.

Proof. A priori, the commutator $\left[\Delta, \Delta^{\prime}\right]$ is an operator of order at most $n+m-1$. If we assume that those terms of order $n+m-1$ vanish, then the commutator must be an operator of order at most $n+m-2$. According to Eq. (20) in the proof of Proposition 2.11, we have

$$
\left[\Delta, \Delta^{\prime}\right]^{+}=(-1)^{n+m-1}\left[\Delta, \Delta^{\prime}\right]
$$

and therefore we conclude that the terms of order $n+m-2$ must also vanish, since the parity of the order does not coincide with the adjoint condition. Hence $\left[\Delta, \Delta^{\prime}\right]$ is an operator of order at most $n+m-3$.

Proposition 2.13. The space of all first order anti-self-adjoint operators is a Lie algebra, which is canonically isomorphic to the Lie algebra of vector fields on $\mathcal{M}$. Specifically, if $\Delta$ is a first order anti-self-adjoint operator of degree l, then it is necessarily the Lie derivative along a degree l vector field on $\mathcal{M}$.

Proof. In local coordinates $\left(x^{a}\right)$, any first order differential operator of homogeneous degree takes the appearance $\Delta=X^{a}(x) \partial_{a}+X_{0}(x)$. The adjoint operator $\Delta^{+}$is given by Eq. (16). Imposing the anti-self-adjoint condition $\Delta=-\Delta^{+}$forces

$$
\Delta=X^{a}(x) \partial_{a}+(-1)^{\left|\partial_{a}\right|\left|X^{a}\right|} \frac{1}{2} \partial_{a}\left(X^{a}\right)(x)=\mathcal{L}_{X}
$$

which coincides with the formula for the Lie derivative on half-densities $\Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ along the vector field $X=X^{a}(x) \partial_{a} \in \Gamma\left(T_{\mathcal{M}}\right)$ of the same degree.
2.2. ( $\hbar$ )-enhanced differential operators. Introduce a degree 0 parameter $\hbar$, and define the space of $\hbar$ enhanced differential operators $\hbar \mathrm{DO}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ by

$$
\hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right):=\mathrm{DO}^{\leq 0}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \oplus \hbar \mathrm{DO}^{\leq 1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \oplus \cdots=\prod_{n \geq 0} \hbar^{n} \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)
$$

where $\hbar^{n} \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ denotes the space of differential operators of order at most $n$, acting on Berezinian half-densities enhanced with coefficients in $\mathbb{R} \llbracket \hbar \rrbracket$.
An arbitrary operator $\Delta \in \hbar \mathrm{DO}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ is written as

$$
\begin{equation*}
\Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n}, \quad \Delta_{n} \in \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{21}
\end{equation*}
$$

where the maximum possible order of each operator $\Delta_{n}$ with coefficient $\hbar^{n}$ is $n$.
The introduction of the parameter $\hbar$ allows for the definition of a secondary filtration on $\hbar \mathrm{DO}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$. Let $\Delta \in \hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ be an arbitrary operator as defined in (21), and define the non-negative integer

$$
\begin{equation*}
t(\Delta):=\min _{n \geq 0}\left\{n-\operatorname{order}\left(\Delta_{n}\right) \mid \Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n}\right\} \tag{22}
\end{equation*}
$$

For example, if any one of the operators $\Delta_{n}$ in the expansion of $\Delta$ were of order $n$, then $t(\Delta)=0$. For each $t \geq 0$, define the set of operators

$$
\hbar \mathrm{DO}_{t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right):=\left\{\Delta \in \hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \mid t(\Delta) \geq t\right\}
$$

In particular, $\hbar \mathrm{DO}_{0}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is the whole set $\hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$, whilst for an arbitrary integer $t>0$, $\hbar \mathrm{DO}_{t}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ consists of those operators $\Delta \in \hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ such that $\hbar^{-t} \Delta \in \hbar \mathrm{DO}_{0}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$. This defines a decreasing filtration on $\hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ indexed by $t$ :

$$
\begin{equation*}
\cdots \subset \hbar \mathrm{DO}_{t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \cdots \subset \hbar \mathrm{DO}_{1}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \hbar \mathrm{DO}_{0}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)=\hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{23}
\end{equation*}
$$

It is beneficial to define a commutator modified by the introduced parameter. Set the modified commutator $[-,-]_{\hbar}$ on $\hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ as the degree 0 operation

$$
\begin{equation*}
\left[\Delta, \Delta^{\prime}\right]_{\hbar}:=\frac{1}{\hbar}\left[\Delta, \Delta^{\prime}\right]=\sum_{n \geq 0} \hbar^{n} \sum_{\substack{i+j=n+1 \\ i, j \geq 0}}\left[\Delta_{i}, \Delta_{j}\right] \tag{24}
\end{equation*}
$$

with $\Delta=\sum_{i \geq 0} \hbar^{i} \Delta_{i}$ and $\Delta^{\prime}=\sum_{j \geq 0} \hbar^{j} \Delta_{j}^{\prime}$, and $[-,-]$ denotes the usual commutator.
Remark 2.14. The parameter $\hbar$ should serve as a counting variable, relating the order of an operator to the weight of the principal symbol as a contravariant tensor. Since the commutator of two operators reduces the order, it is natural to reduce the power of $\hbar$. Note that in [4], $\hbar$ is introduced as a degree 2 parameter. This shift in degree compensates the degree shift between $(-1)$-shifted derived Poisson structures and $(+1)$-shifted derived Poisson structures. Recently, Shemyakova also systematically studied ( $\hbar$ )-enhanced differential operators in connection with the study of the $\mathrm{BV}_{\infty}$ operator generating higher Koszul brackets on differential forms [52].

The following lemma is quite obvious.
Lemma 2.15. (1) For any integer $t \geq 0$ and $\Delta \in \hbar \mathrm{DO}_{t}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$, there exists a unique $\Delta^{\prime} \in$ $\hbar \mathrm{DO}_{0}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ such that $\Delta=\hbar^{t} \Delta^{\prime}$.
(2) For any integers $s, t \geq 0$, the modified commutator respects the $\hbar$-induced filtration

$$
\left[\hbar \mathrm{DO}_{s}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right), \quad \hbar \mathrm{DO}_{t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)\right]_{\hbar} \subset \hbar \mathrm{DO}_{s+t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)
$$

Corollary 2.16. The space of $\hbar$-enhanced differential operators $\hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a filtered Lie algebra under the modified commutator $[-,-]_{\hbar}$ and the filtration (23).

Definition 2.17. The extended principal symbol map is defined as

$$
\begin{equation*}
\sigma_{\hbar}: \hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket, \quad \sigma_{\hbar}(\Delta)=\sum_{n \geq 0} \hbar^{n} \sigma_{n}\left(\Delta_{n}\right) \tag{25}
\end{equation*}
$$

for any $\Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n} \in \hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$, where $\sigma_{n}$ is the nth principal symbol map as in (13), and $\Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket$ denotes the space of formal power series in $\hbar$ with coefficients in the completed symmetric algebra.

The following lemma follows immediately from Eq. (24) and Lemma 2.4.
Lemma 2.18. For any pair of operators $\Delta, \Delta^{\prime} \in \hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$,

$$
\begin{equation*}
\sigma_{\hbar}\left(\left[\Delta, \Delta^{\prime}\right]_{\hbar}\right)=\frac{1}{\hbar}\left\{\sigma_{\hbar}(\Delta), \sigma_{\hbar}\left(\Delta^{\prime}\right)\right\} \tag{26}
\end{equation*}
$$

Notice that for any operator $\Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n}$, the extended principal symbol map is non-zero only on those terms where the order of the operator $\Delta_{n}$ is exactly equal to $n$, and hence cannot see symbols of operators of lower orders. To remedy this, one can define a sequence of maps, viewing $\hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ as $\hbar \mathrm{DO}_{0}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ in the decreasing $\hbar$-induced filtration (23), which extend to each $\hbar \mathrm{DO}_{t}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ in turn. For each $t \geq 1$, define the $t$-th extended principal symbol map

$$
\begin{equation*}
\sigma_{\hbar}^{t}: \hbar \mathrm{DO}_{t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket, \quad \sigma_{\hbar}^{t}(\Delta)=\hbar^{t} \sigma_{\hbar}\left(\hbar^{-t} \Delta\right) \tag{27}
\end{equation*}
$$

for $\Delta \in \hbar \mathrm{DO}_{t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. The extended principal symbol map (25) fits into this sequence with $t=0$.
Corollary 2.19. For operators $\Delta \in \hbar \mathrm{DO}_{t}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, and $\Delta^{\prime} \in \hbar \mathrm{DO}_{s}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, the sequence of extended symbol maps preserve the modified commutator

$$
\begin{equation*}
\sigma_{\hbar}^{t+s}\left(\left[\Delta, \Delta^{\prime}\right]_{\hbar}\right)=\frac{1}{\hbar}\left\{\sigma_{\hbar}^{t}(\Delta), \sigma_{\hbar}^{s}\left(\Delta^{\prime}\right)\right\} \tag{28}
\end{equation*}
$$

Definition 2.20. An operator $\Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n} \in \hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is called self-adjoint if $\Delta_{n}$ is selfadjoint for all even $n$, and anti-self-adjoint for all odd $n$.

Remark 2.21. If we introduce an adjoint operation on the formal parameter $\hbar$ such that $\hbar^{+}=-\hbar$, then the self-adjointness of an operator $\Delta \in \hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ can be simply written as

$$
\Delta^{+}=\Delta
$$

Denote the set of all $\hbar$-enhanced self-adjoint operators by $\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \subset \hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$, which inherits both filtrations (11) defined by order, and (23) defined by the introduction of $\hbar$.

Lemma 2.22. The space of self-adjoint differential operators $\hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a Lie subalgebra of $\hbar \mathrm{DO}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ under the modified commutator (24).

Proof. The space of self-adjoint operators is clearly a vector space. Assume that $\Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n}$ and $\Delta^{\prime}=\sum_{n \geq 0} \hbar^{n} \Delta_{n}^{\prime}$ are self-adjoint differential operators. By Eq. (24), $\left[\Delta, \Delta^{\prime}\right]_{\hbar}=\sum_{n \geq 0} \hbar^{n} \widetilde{\Delta}_{n}$, where $\widetilde{\Delta}_{n}=\sum_{i+j=n+1, i, j \geq 0}\left[\Delta_{i}, \Delta_{j}\right] \in \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. By assumption, for all $n \geq 0, \Delta_{n}$ and $\Delta_{n}^{\prime}$ are operators satisfying $\Delta_{n}^{+}=(-1)^{n} \Delta_{n}$ and $\left(\Delta_{n}^{\prime}\right)^{+}=(-1)^{n} \Delta_{n}^{\prime}$. It thus follows that

$$
\widetilde{\Delta}_{n}^{+}=\sum_{i+j=n+1, i, j \geq 0}\left[\Delta_{i}, \Delta_{j}\right]^{+}=\sum_{i+j=n+1, i, j \geq 0}(-1)^{n}\left[\Delta_{i}, \Delta_{j}\right]=(-1)^{n} \widetilde{\Delta}_{n}
$$

Here we used essentially the same computation as in (20) to prove that $\left[\Delta_{i}, \Delta_{j}\right]^{+}=(-1)^{n}\left[\Delta_{i}, \Delta_{j}\right]$. Therefore $\left[\Delta, \Delta^{\prime}\right]_{\hbar} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Hence, $\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is indeed a Lie subalgebra of $\hbar \mathrm{DO}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$.

Lemma 2.23. Let $\Delta \in \hbar \mathrm{DO}_{0}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Then $\sigma_{\hbar}(\Delta)=0$ is equivalent to that $\Delta \in \hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$.
Proof. Let $\Delta=\sum_{n \geq 0} \hbar^{n} \Delta_{n}$. Since $\sigma_{\hbar}(\Delta)=0$, it follows from (25) that $\sigma_{n}\left(\Delta_{n}\right)=0$, for all $n \geq 0$. Hence the order of $\Delta_{n}$ is at most $(n-1)$. By assumption $\Delta_{n} \in \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and $\Delta_{n}^{+}=(-1)^{n} \Delta_{n}$, so $\Delta_{n}$ cannot be of order $(n-1)$ according to Corollary 2.10 , and thus at most $n-2$. Hence it follows that $\Delta$ indeed belongs to $\hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. The converse is obvious.
Corollary 2.24. Let $\Delta$ and $\Delta^{\prime} \in \hbar \mathrm{DO}_{t}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ be self-adjoint operators with $t(\Delta)=t=t\left(\Delta^{\prime}\right)$ such that $\sigma_{\hbar}^{t}(\Delta)=\sigma_{\hbar}^{t}\left(\Delta^{\prime}\right)$. Then $\Delta-\Delta^{\prime} \in \hbar \mathrm{DO}_{t+2}^{+}\left(\right.$Dens $\left._{\mathcal{M}}^{1 / 2}\right)$.

Proof. By assumption, we have $\sigma_{\hbar}\left(\frac{1}{\hbar^{t}}\left(\Delta-\Delta^{\prime}\right)\right)=0$. According to Lemma 2.23, $\frac{1}{\hbar^{t}}\left(\Delta-\Delta^{\prime}\right) \in$ $\hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Hence $\Delta-\Delta^{\prime} \in \hbar \mathrm{DO}_{t+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$.
2.3. $\mathrm{BV}_{\infty}$-operators and $(-1)$-shifted derived Poisson manifolds. Following Kravchenko [36], we introduce the following

Definition 2.25. A $\mathrm{BV}_{\infty}$-operator acting on the line bundle $\mathrm{Dens}_{\mathcal{M}}^{1 / 2}$ is a degree $(+1)$ differential operator $\Delta \in \hbar \mathrm{DO}_{0}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ such that $\sigma_{\hbar}(\Delta) \neq 0$, and:
(1) $\lim _{\hbar \rightarrow 0} \Delta=0$,
(2) $\Delta^{2}=\frac{\hbar}{2}[\Delta, \Delta]_{\hbar}=0$.

Condition (1) ensures that $\Delta$ can be expressed as

$$
\Delta=\sum_{n \geq 1} \hbar^{n} \Delta_{n}
$$

where each $\Delta_{n} \in \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a differential operator of order at most $n$.
Remark 2.26. Choose a nowhere vanishing Berezinian density $\boldsymbol{\rho} \in \Gamma\left(\mathrm{Dens}_{\mathcal{M}}\right)$. With such a choice of Berezinian density, we may identify differential operators on $\Gamma\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ with differential operators on $C^{\infty}(\mathcal{M})$ by

$$
\begin{equation*}
\Delta_{\rho} f:=\frac{1}{\sqrt{\rho}} \Delta(f \sqrt{\boldsymbol{\rho}}), \quad f \in C^{\infty}(\mathcal{M}), \quad \Delta \in \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{29}
\end{equation*}
$$

In this case, our $\mathrm{BV}_{\infty}$-operators coincide with the homotopy BV -operators of Kravchenko [36]. See also [48, 43, 41, 10, 59, 28, 4, 52, 2].
Since the Berezinian density line bundle over $\mathcal{M}$ is always trivalizable, in fact, one can always work with differential operators on $C^{\infty}(\mathcal{M})$ instead of those on half densities $\Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Here, however, we choose to work with the latter following [24, 29, 27, 8]. This approach has the advantage of being intrinsic and
allows us to speak about the (formal) adjoint operator of a differential operator naturally, which plays a crucial role in our construction. We refer the interested readers to [24] for details on justification regarding the half densities approach as the proper framework for the Batalin-Vilkovisky (BV) formalism in the classical case.

For any $\mathbf{X} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, where $\mathbf{X}=\sum_{n \geq 0} \mathbf{X}_{n}$ with $\mathbf{X}_{n} \in \Gamma\left(S^{n} T_{\mathcal{M}}\right)$, define the map

$$
\begin{equation*}
\cdot \hbar: \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket, \quad \cdot_{\hbar}(\mathbf{X})=\mathbf{X}_{\hbar}:=\sum_{n \geq 0} \hbar^{n} \mathbf{X}_{n} \tag{30}
\end{equation*}
$$

The degree zero Poisson bracket (8) on $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ then extends to the algebra of formal power series $\Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket$ by $\hbar$-linearity. The following lemma can be easily verified directly.
Lemma 2.27. For any $\boldsymbol{X}, \boldsymbol{Y}, \boldsymbol{Z} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$,

$$
\boldsymbol{Z}=\{\boldsymbol{X}, \boldsymbol{Y}\} \quad \Leftrightarrow \quad \boldsymbol{Z}_{\hbar}=\frac{1}{\hbar}\left\{\boldsymbol{X}_{\hbar}, \boldsymbol{Y}_{\hbar}\right\}
$$

Essentially, Lemma 2.27 indicates that the map (30) is a morphism of Poisson algebras. Denote

$$
\Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{\hbar}:=\left\{\mathbf{X}_{\hbar} \mid \mathbf{X}_{\hbar}=\sum_{n \geq 0} \hbar^{n} \mathbf{X}_{n}, \text { where } X_{n} \in \Gamma\left(S^{n} T_{\mathcal{M}}\right)\right\}
$$

Then $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{\hbar}$ is a Poisson subalgebra of $\Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket$ and the map (30) is an isomorphism of Poisson algebras from $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ to $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)_{\hbar}$.

The theorem below indicates that a $\mathrm{BV}_{\infty}$-operator induces a $(-1)$-shifted derived Poisson structure. This can be proved using Voronov's derived bracket construction [59]. Below we will give an alternative proof using Theorem 1.6. Note that this result is known in the literature in various different forms. See [52, Theorem 3.2] and [10, Corollary], for instance.

Theorem 2.28. If $\Delta \in \hbar \mathrm{DO}_{0}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a $\mathrm{BV}_{\infty}$-operator, then $C^{\infty}(\mathcal{M})$ together with the sequence of multi-brackets $\left(\lambda_{n}\right)_{n \geq 1}$ defined by the following equation:

$$
\begin{equation*}
\lambda_{n}\left(f_{1}, \ldots, f_{n}\right) \boldsymbol{s}:=\lim _{\hbar \rightarrow 0}\left[\cdots\left[\Delta, f_{1}\right]_{\hbar}, \ldots, f_{n}\right]_{\hbar} \boldsymbol{s} \tag{31}
\end{equation*}
$$

for any functions $f_{1}, \ldots, f_{n} \in C^{\infty}(\mathcal{M})$, and any half-density $s \in \Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, is a $(+1)$-shifted derived Poisson algebra. Hence $\mathcal{M}$ is a (-1)-shifted derived Poisson manifold.

Proof. Write $\Delta=\sum_{n \geq 1} \hbar^{n} \Delta_{n}$, where each $\Delta_{n} \in \mathrm{DO}^{\leq n}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is of degree $(+1)$ and order at most $n$. The extended principal symbol

$$
\hat{\Pi}_{\hbar}:=\sigma_{\hbar}(\Delta)=\sum_{n \geq 1} \hbar^{n} \Pi_{n}, \quad \Pi_{n}=\sigma_{n}\left(\Delta_{n}\right) \in \Gamma\left(S^{n} T_{\mathcal{M}}\right)
$$

determines a formal power series of degree $(+1)$ symmetric contravariant tensor fields dependent on $\hbar$. Evaluating at $\hbar=1$, we obtain a degree $(+1)$ formal power series $\hat{\Pi}:=\left.\hat{\Pi}_{\hbar}\right|_{\hbar=1}=\sum_{n \geq 1} \Pi_{n} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$.
Since the operator $\Delta$ is of degree $(+1)$, its square is expressible via the commutator $\Delta^{2}=\frac{\hbar}{2}[\Delta, \Delta]_{\hbar}$. Hence it follows that $[\Delta, \Delta]_{\hbar}=0$ by definition.

According to Lemma 2.18,

$$
\sigma_{\hbar}\left([\Delta, \Delta]_{\hbar}\right)=\frac{1}{\hbar}\left\{\sigma_{\hbar}(\Delta), \sigma_{\hbar}(\Delta)\right\}=\frac{1}{\hbar}\left\{\hat{\Pi}_{\hbar}, \hat{\Pi}_{\hbar}\right\}
$$

From Lemma 2.27, it follows that $\{\hat{\Pi}, \hat{\Pi}\}=0$. One can write $\Pi_{1}=Q$, whence $(\mathcal{M}, Q)$ is a dg manifold equipped with a formal power series $\Pi=\sum_{n \geq 2} \Pi_{n}$ satisfying the Maurer-Cartan equation (9). Hence by Theorem 1.6, $\mathcal{M}$ is equipped with a $(-1)$-shifted derived Poisson structure.
To write down the multi-brackets of the corresponding $(+1)$-shifted derived Poisson algebra, we note that the right hand side of (31) is exactly equal to $\left[\cdots\left[\Delta_{n}, f_{1}\right], \ldots, f_{n}\right]$ s. Since $\Delta_{n} \in \mathrm{DO}^{\leq n}\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ and $\sigma_{n}\left(\Delta_{n}\right)=\Pi_{n}$, it is standard [59] that the latter is exactly equal to $\Pi_{n}\left(d f_{1} \odot \cdots \odot d f_{n}\right) \mathbf{s}$. This concludes the proof of the theorem.

We note that Eq. (31) is essentially Voronov's derived bracket formula [59]. Recently Bandiera proved the homotopy transfer theorem for $\mathrm{BV}_{\infty}$-algebras [2]. In particular, he showed that the homotopy transfer of a $\mathrm{BV}_{\infty}$-algebra is compatible with its induced ( +1 )-shifted derived Poisson algebra in the sense of Theorem 2.28 .

Remark 2.29. One may compare Eq. (31) with the multi-brackets constructed in [4, 10, 52, 43, 41]. As in some of these references [4, 10,52], we use the $\hbar$-modification in order to absorb the modified commutator. Finally, note that to generate a $(+1)$-shifted derived Poisson algebra structure, instead of requiring $\Delta^{2}=0$, it suffices to require that the extended principal symbol of $\Delta^{2}$ vanishes, i.e. $\sigma_{\hbar}\left(\Delta^{2}\right)=0$.

Example 2.30. Consider the special case of $\mathrm{BV}_{\infty}$-operators consisting of only one term

$$
\Delta=\hbar^{2} \Delta_{2},
$$

where $\Delta_{2}$ is a second order differential operator of degree $(+1)$ satisfying the condition that $\Delta_{2} \cdot \Delta_{2}=0$. In this case, Theorem 2.28 implies that $\lambda_{n}=0$ for all $n \neq 2$, and the binary bracket $\{-,-\}:=\lambda_{2}(-,-)$ is given by,

$$
\begin{align*}
& \{f, g\} \boldsymbol{s}:= \\
& \quad \Delta_{2}(f g \boldsymbol{s})-(-1)^{(|f|+1)|g|} g \Delta_{2}(f \boldsymbol{s})-(-1)^{|f|} f \Delta_{2}(g \boldsymbol{s})+(-1)^{|f|+|g|} f g \Delta_{2}(\boldsymbol{s}), \tag{32}
\end{align*}
$$

for any $f, g \in C^{\infty}(\mathcal{M})$ of homogeneous degree and $\boldsymbol{s} \in \Gamma\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$.
Assume that there exists a nowhere vanishing Berezinian density $\boldsymbol{\rho} \in \Gamma\left(\operatorname{Dens}_{\mathcal{M}}\right)$ such that $\Delta_{2}(\sqrt{\boldsymbol{\rho}})=0$. $B y \Delta_{\rho}$, we denote the corresponding second order differential operator on $C^{\infty}(\mathcal{M})$ as in (29) (with $\Delta$ being replaced by $\Delta_{2}$ ), then $\Delta_{\rho}$ is of degree $(+1)$ and $\Delta_{\rho}^{2}=0$. Eq. (32) implies that

$$
\begin{equation*}
\{f, g\}=\Delta_{\rho}(f g)-\Delta_{\rho}(f) g-(-1)^{|f|} f \Delta_{\rho}(g) . \tag{33}
\end{equation*}
$$

Thus $\Delta_{\rho}$ is an ordinary BV-operator and $\{\cdot, \cdot\}$ is its corresponding Schouten bracket. See [35, 20, 26, 27, 34, 64, 63].

## 3. Quantization of ( -1 )-Shifted Derived Poisson Manifolds

3.1. Quantization of graded manifolds. Recall that an (affine) connection on a graded manifold $\mathcal{M}$ is a degree zero $\mathbb{R}$-bilinear map $\nabla: \Gamma\left(T_{\mathcal{M}}\right) \times \Gamma\left(T_{\mathcal{M}}\right) \rightarrow \Gamma\left(T_{\mathcal{M}}\right)$ such that
(1) $\nabla_{f X} Z=f \nabla_{X} Z$;
(2) $\nabla_{X}(f Y)=X(f) Y+(-1)^{|f||X|} f \nabla_{X} Y$,
for any vector fields $X, Y, Z \in \Gamma\left(T_{\mathcal{M}}\right)$ and smooth functions $f, g \in C^{\infty}(\mathcal{M})$, where $X$ and $f$ are homogeneous.

We say that a connection $\nabla$ on $\mathcal{M}$ is torsion-free if its torsion vanishes. That is,

$$
\nabla_{X} Y-(-1)^{|X| \cdot|Y|} \nabla_{Y} X-[X, Y]=0
$$

for any homogeneous vector fields $X, Y \in \Gamma\left(T_{\mathcal{M}}\right)$. It is well known that torsion-free connections always exist for any graded manifold $\mathcal{M}$ [39].

Fix a torsion-free connection $\nabla$ on $\mathcal{M}$, and denote the induced linear connection on the line bundle $\mathrm{Dens}_{\mathcal{M}}^{1 / 2}$ by the same symbol $\nabla$.

Definition 3.1. Let $\mathcal{M}$ be a graded manifold with a torsion-free connection $\nabla$. Define the map of $C^{\infty}(\mathcal{M})$ modules

$$
\begin{equation*}
\mathcal{P}_{\hbar}: \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \rightarrow \hbar \mathrm{DO}\left(\text { Dens }_{\mathcal{M}}^{1 / 2}\right) \tag{34}
\end{equation*}
$$

by the inductive relations

$$
\begin{gathered}
\mathcal{P}_{\hbar}(f)=f, \quad f \in C^{\infty}(\mathcal{M}), \\
\mathcal{P}_{\hbar}(X)=\hbar \nabla_{X}, \quad X \in \Gamma\left(T_{\mathcal{M}}\right),
\end{gathered}
$$

and for homogeneous elements $X_{1}, \ldots, X_{n} \in \Gamma\left(T_{\mathcal{M}}\right)$,

$$
\begin{equation*}
\mathcal{P}_{\hbar}\left(X_{1} \odot \cdots \odot X_{n}\right)=\frac{\hbar}{n} \sum_{k=1}^{n} \varepsilon_{k}\left(\nabla_{X_{k}} \mathcal{P}_{\hbar}\left(\boldsymbol{X}^{\{k\}}\right)-\mathcal{P}_{\hbar}\left(\nabla_{X_{k}} \boldsymbol{X}^{\{k\}}\right)\right), \tag{35}
\end{equation*}
$$

where $\varepsilon_{k}=(-1)^{\left|X_{k}\right|\left(\left|X_{1}\right|+\cdots+\left|X_{k-1}\right|\right)}$ and $\boldsymbol{X}^{\{k\}}=X_{1} \odot \cdots \odot X_{k-1} \odot X_{k+1} \odot \cdots \odot X_{n}$.
Proposition 3.2. (1) $\mathcal{P}_{\hbar}$ is a well defined $C^{\infty}(\mathcal{M})$-module map;
(2) For any $\boldsymbol{X} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, we have

$$
\sigma_{\hbar}\left(\mathcal{P}_{\hbar}(\boldsymbol{X})\right)=\boldsymbol{X}_{\hbar} .
$$

Proof. Note that $\operatorname{Dens}_{\mathcal{M}}^{1 / 2}$ is a real line bundle over $\mathcal{M}$. Hence local flat non-zero sections always exist. Let $U \subset \mathcal{M}$ be any contractible open submanifold and $s \in \Gamma\left(\left.\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right|_{U}\right)$ a non-zero flat section with respect to the connection $\nabla$, i.e. $\nabla_{X} s=0$ for any $X \in \Gamma\left(\left.T_{\mathcal{M}}\right|_{U}\right)$. Thus we have an isomorphism

$$
\begin{aligned}
\Phi: \mathrm{DO}\left(\left.\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right|_{U}\right) & \xrightarrow{\simeq} D\left(\left.\mathcal{M}\right|_{U}\right) \\
\Delta & \longrightarrow \frac{\Delta(f s)}{s}
\end{aligned}
$$

for any $f \in C^{\infty}\left(\left.\mathcal{M}\right|_{U}\right)$. It is simple to check that under such an isomorphism, the map $\mathcal{P}_{\hbar}$ can be identified with the PBW map, i.e.

$$
\left(\Phi \circ \mathcal{P}_{\hbar}\right)(\mathbf{X})=\hbar^{n} \operatorname{pbw}(\mathbf{X}), \quad \forall \mathbf{X} \in \Gamma\left(\left.S^{n} T_{\mathcal{M}}\right|_{U}\right)
$$

where $\mathrm{pbw}: \Gamma\left(S T_{\mathcal{M}}\right) \rightarrow D(\mathcal{M})$ is the PBW map introduced by Liao-Stienon [39, Definition 3.1]. According to [39, Lemma 3.2], $\Phi \circ \mathcal{P}_{\hbar}$ is a well-defined $C^{\infty}(U)$-module map from $\Gamma\left(\left.\hat{S} T_{\mathcal{M}}\right|_{U}\right)$ to $D\left(\left.\mathcal{M}\right|_{U}\right)$, which implies that the inductive formula in Definition 3.1, when being restricted to $U$, gives rise to a welldefined $C^{\infty}(U)$-module map from $\Gamma\left(\left.\hat{S} T_{\mathcal{M}}\right|_{U}\right)$ to $\mathrm{DO}\left(\left.\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right|_{U}\right)$. Therefore it follows that $\mathcal{P}_{\hbar}$ is indeed a well-defined $C^{\infty}(\mathcal{M})$-module map.

To prove the second claim, we can write down explicitly the principal symbol of $\left(\Phi \circ \mathcal{P}_{\hbar}\right)(\mathbf{X})$ locally. Below we give a direct proof using induction. It is clear that the claim is true for all $\mathbf{X} \in \Gamma\left(S^{\leq 1} T_{\mathcal{M}}\right)$. Assume that it is true for any $\mathbf{X} \in \Gamma\left(S^{n-1} T_{\mathcal{M}}\right)$, where $n \geq 2$. According to Eq. (35), by induction assumption, we
have

$$
\begin{aligned}
& \sigma_{\hbar}\left(\mathcal{P}_{\hbar}\left(X_{1} \odot \cdots \odot X_{n}\right)\right) \\
= & \frac{\hbar}{n} \sum_{k=1}^{n} \varepsilon_{k}\left(X_{k} \odot\left(\sigma_{\hbar} \mathcal{P}_{\hbar}\right)\left(\mathbf{X}^{\{k\}}\right)\right) \\
= & \frac{\hbar}{n} \sum_{k=1}^{n} \varepsilon_{k} X_{k} \odot\left(\hbar^{n-1} \mathbf{X}^{\{k\}}\right) \\
= & \hbar^{n} X_{1} \odot \cdots \odot X_{n} .
\end{aligned}
$$

Hence, it follows that the claim holds for any $\mathbf{X} \in \Gamma\left(S^{n} T_{\mathcal{M}}\right)$. This concludes the proof.
Note that $\mathcal{P}_{\hbar}(\mathbf{X})$ may not be self-adjoint. In order to obtain self-adjoint operators, we need to make some modification. Introduce a linear map

$$
\mathcal{Q}_{\hbar}: \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \rightarrow \hbar \mathrm{DO}\left(\text { Dens }_{\mathcal{M}}^{1 / 2}\right)
$$

as follows. For any $\mathbf{X} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, write

$$
\mathcal{P}_{\hbar}(\mathbf{X})=\sum_{n \geq 0} \hbar^{n} \Delta_{n} \in \hbar \mathrm{DO}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) .
$$

Define

$$
\begin{equation*}
\mathcal{Q}_{\hbar}(\mathbf{X})=\sum_{n \geq 0} \frac{\hbar^{n}}{2}\left(\Delta_{n}+(-1)^{n} \Delta_{n}^{+}\right) . \tag{36}
\end{equation*}
$$

Proposition 3.3. Let $\mathcal{M}$ be a $\mathbb{Z}$-graded manifold with a torsion-free connection $\nabla$. Then $\mathcal{Q}_{\hbar}$ defined by (36) is a degree 0 map

$$
\begin{equation*}
\mathcal{Q}_{\hbar}: \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \rightarrow \hbar \mathrm{DO}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right) \tag{37}
\end{equation*}
$$

satisfying the condition that, for any $\boldsymbol{X} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$,

$$
\sigma_{\hbar}\left(\mathcal{Q}_{\hbar}(\boldsymbol{X})\right)=\boldsymbol{X}_{\hbar} .
$$

Proof. We have, for any $n \geq 0$,

$$
\left(\Delta_{n}+(-1)^{n} \Delta_{n}^{+}\right)^{+}=\Delta_{n}^{+}+(-1)^{n}\left(\Delta_{n}^{+}\right)^{+}=\Delta_{n}^{+}+(-1)^{n} \Delta_{n}=(-1)^{n}\left(\Delta_{n}+(-1)^{n} \Delta_{n}^{+}\right)
$$

Hence, it follows that $\mathcal{Q}_{\hbar}(\mathbf{X}) \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Moreover,

$$
\begin{aligned}
\sigma_{\hbar}\left(\mathcal{Q}_{\hbar}(\mathbf{X})\right) & =\sigma_{\hbar}\left(\sum_{n \geq 0} \frac{\hbar^{n}}{2}\left(\Delta_{n}+(-1)^{n} \Delta_{n}^{+}\right)\right) \\
& =\sum_{n \geq 0} \frac{\hbar^{n}}{2}\left(\sigma_{n}\left(\Delta_{n}\right)+(-1)^{n} \sigma_{n}\left(\Delta_{n}^{+}\right)\right) \quad \text { (by Eq. (19)) } \\
& =\sum_{n \geq 0} \frac{\hbar^{n}}{2}\left(\sigma_{n}\left(\Delta_{n}\right)+\sigma_{n}\left(\Delta_{n}\right)\right) \\
& =\sum_{n \geq 0} \hbar^{n} \sigma_{n}\left(\Delta_{n}\right) \\
& =\sigma_{\hbar}\left(\mathcal{P}_{\hbar}(\mathbf{X})\right) \\
& =\mathbf{X}_{\hbar} .
\end{aligned}
$$

This concludes the proof of the proposition.
3.2. Quantization of $(-1)$-shifted derived Poisson manifolds. If $\Gamma\left(\right.$ Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ carries a $\mathrm{BV}_{\infty}$-operator as defined in Definition 2.25, Theorem 2.28 states that $\mathcal{M}$ inherits a $(-1)$-shifted derived Poisson structure generated by the $\mathrm{BV}_{\infty}$-operator. But one can ask for the converse: when does a given $(-1)$-shifted derived Poisson manifold admit a $\mathrm{BV}_{\infty}$-operator which generates the derived Poisson structure? In this section, we will address this problem. First we will introduce the following (see also [16, 48]):

Definition 3.4. A quantization of a (-1)-shifted derived Poisson manifold $(\mathcal{M}, Q, \Pi)$ is a $\mathrm{BV}_{\infty}$-operator $\Delta \in \hbar \mathrm{DO}^{+}\left(\right.$Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ such that

$$
\left.\sigma_{\hbar}(\Delta)\right|_{\hbar=1}=Q+\Pi,
$$

where $\sigma_{\hbar}$ is the extended principal symbol map as in (25).
Remark 3.5. Classical BV-operators appeared in the pioneering work of Batalin-Vilkovisky $[5,6,7]$ in their study of quantization of gauge theories. The geometry and the quantization procedure of odd symplectic manifolds were studied by many authors, in particular, by Schwarz [51]. In a series of papers [24, 8, 25, 26, 27, 29], it was pointed out that $B V$-operators can be intrinsically realized as odd Laplace operators acting on half densities, which are self-adjoint. Our definition above was motivated by the consideration to extend such an approach to the general $\mathrm{BV}_{\infty}$-context. It would also be an interesting question to investigate the obstruction theory to quantization by relaxing the self-adjoint condition in the definition.

Note that, for a given dg manifold $(\mathcal{M}, Q)$, a derived Poisson structure $\Pi$ is equivalent to a Maurer-Cartan element of the dgla

$$
\begin{equation*}
\left(\Gamma\left(\hat{S} T_{\mathcal{M}}\right), \quad\{\cdot, \cdot\}, \quad\{Q, \cdot\}\right) \tag{38}
\end{equation*}
$$

On the other hand, an operator $\Delta \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is a $\mathrm{BV}_{\infty}$-operator if and only if $\Delta-\hbar \mathcal{L}_{Q}$ is a Maurer-Cartan element of the dgla

$$
\begin{equation*}
\left(\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), \quad[\cdot, \cdot]_{\hbar}, \quad\left[\hbar \mathcal{L}_{Q}, \cdot\right]_{\hbar}\right) \tag{39}
\end{equation*}
$$

Summarizing the discussion earlier, we have the following
Theorem 3.6. We have the following short exact sequence of dglas

$$
\begin{equation*}
0 \longrightarrow \hbar \mathrm{DO}_{2}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right) \xrightarrow{i} \hbar \mathrm{DO}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right) \xrightarrow{\phi} \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \longrightarrow 0, \tag{40}
\end{equation*}
$$

where $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ and $\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ stand for the dglas (38) and (39), respectively, $\hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ is considered as an ideal of the dgla $\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, the morphism $i$ is the inclusion map and $\phi$ is the morphism defined by

$$
\begin{equation*}
\phi(\Delta)=\left.\sigma_{\hbar}(\Delta)\right|_{\hbar=1}, \quad \forall \Delta \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{41}
\end{equation*}
$$

Proof. From Lemma 2.18 and Lemma 2.27, it follows that $\phi$ is indeed a Lie algebra morphism and preserves the differentials, i.e. a morphism of dglas. Proposition 3.3 implies that $\phi$ is indeed surjective. Finally, to identify the kernel of $\phi$, note that, for any $\Delta \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, the condition that $\phi(\Delta)=0$ is equivalent to that $\sigma_{\hbar}(\Delta)=0$. The latter is equivalent to that $\Delta \in \hbar \mathrm{DO}_{2}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ according to Lemma 2.23. Thus it follows that $\operatorname{ker} \phi \cong \hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. The proof is completed.

As a consequence, the quantization problem in Definition 3.4 can be reinterpreted as the lifting problem of a Maurer-Cartan element of the dgla (38) to a Maurer-Cartan element of the dgla (39), where both dglas are related by the short exact sequence (40). As is standard, we can find the solution to the latter by lifting a sequence of Maurer-Cartan elements as follows.
Note that we have the following sequence of short exact sequences of dglas, for all $k=1,2, \cdots$

$$
\begin{equation*}
0 \longrightarrow \frac{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \stackrel{i}{ }{ }^{i_{k}} \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \xrightarrow{\phi_{k}} \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \longrightarrow 0 \tag{42}
\end{equation*}
$$

where $i_{k}$ is the natural inclusion and $\phi_{k}$ is the natural projection.
As an immediate consequence of Theorem 3.6, the morphism $\phi$ in (41) induces an isomorphism of dglas, denoted by the same symbol

$$
\begin{equation*}
\phi: \frac{\hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)} \stackrel{\simeq}{\longrightarrow} \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \tag{43}
\end{equation*}
$$

Note that the extended principal symbol map (25) descends to a well defined map, for any $k=1,2, \cdots$, denoted by the same symbol, by abuse of notation

$$
\sigma_{\hbar}: \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)} \rightarrow \Gamma\left(\hat{S} T_{\mathcal{M}}\right) \llbracket \hbar \rrbracket
$$

The following lemma is thus obvious.
Lemma 3.7. $A(-1)$-shifted derived Poisson manifold $(\mathcal{M}, Q, \Pi)$ is quantizable if and only if there exists a sequence of operators $\hat{\Delta}^{(k)} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), k=1,2, \cdots$, such that $\left[\hat{\Delta}^{(k)}\right] \in \frac{\hbar \mathrm{DO}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$ is a Maurer-Cartan element and

$$
\begin{equation*}
\phi_{k}\left[\hat{\Delta}^{(k+1)}\right]=\left[\hat{\Delta}^{(k)}\right] \tag{44}
\end{equation*}
$$

where

$$
\begin{equation*}
\left[\hat{\Delta}^{(1)}\right]=\phi^{-1}(\Pi) . \tag{45}
\end{equation*}
$$

Here $\left[\hat{\Delta}^{(k)}\right] \in \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$ denotes the equivalent class of $\hat{\Delta}^{(k)} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, and $\phi$ is the isomorphism (43).
Remark 3.8. As is standard, the existence of the sequence of Maurer-Cartan elements $\left[\hat{\Delta}^{(k)}\right] \in \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$, where $\hat{\Delta}^{(k)} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), k=1,2, \cdots$, is not canonical. It depends on how one chooses the sequence. In other words, for any $n$, the existence of a Maurer-Cartan element $\left[\hat{\Delta}^{(n+1)}\right] \in \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 n+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$ depends on how $\left[\hat{\Delta}^{(n)}\right] \in \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 n}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$ is picked.

Note that (44) implies that $\sigma_{\hbar}\left(\left[\hat{\Delta}^{(k+1)}\right]\right)=\sigma_{\hbar}\left(\left[\hat{\Delta}^{(k)}\right]\right)$, and therefore, by (45), we have

$$
\sigma_{\hbar}\left(\left[\hat{\Delta}^{(k+1)}\right]\right)=\Pi_{\hbar}, \quad k=1,2, \cdots .
$$

Thus we have the following
Lemma 3.9. Let $\hat{\Delta}^{(k)} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right), k=1,2, \cdots$ be operators as in Lemma 3.7. Then, for any $k=1,2, \cdots$, we have

$$
\begin{equation*}
\sigma_{\hbar}\left(\left[\hat{\Delta}^{(k)}\right]\right)=\Pi_{\hbar} \tag{46}
\end{equation*}
$$

Finally, note that for any operator $\hat{\Delta} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, we have the following equivalent relation:

$$
\begin{equation*}
[\hat{\Delta}] \in \operatorname{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}\right) \longleftrightarrow \Delta^{2} \in \hbar \mathrm{DO}_{2 k+1}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{47}
\end{equation*}
$$

where

$$
\Delta=\hbar \mathcal{L}_{Q}+\hat{\Delta}
$$

In the sequel, we will use the interpretation of either side of (47).
3.3. Obstruction classes. In what follows, we will investigate the obstruction class for quantizing a ( -1 )shifted derived Poisson manifold. We will prove the following main theorem of the paper.
Theorem 3.10. Let $(\mathcal{M}, Q, \Pi)$ be a (-1)-shifted derived Poisson manifold. Assume that the second Poisson cohomology group $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$ vanishes, then $(\mathcal{M}, Q, \Pi)$ is quantizable.

According to Lemma 3.7, the quantization problem of a (-1)-shifted derived Poisson manifold ( $\mathcal{M}, Q, \Pi$ ) is equivalent to that of lifting a sequence of Maurer-Cartan elements in the short exact sequences of dglas (42). Our strategy is to find the obstruction class for the lifting in each such a short exact sequence, which should be of independent interest.
Assume that $\hat{\Delta}^{(k)} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ such that

$$
\left[\hat{\Delta}^{(k)}\right] \in \mathrm{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}\right)
$$

and satisfies the condition (46).
Let

$$
\Delta^{(k)}=\hbar \mathcal{L}_{Q}+\hat{\Delta}^{(k)}
$$

and

$$
\Omega^{(k)}:=\left(\Delta^{(k)}\right)^{2}=\frac{\hbar}{2}\left[\Delta^{(k)}, \Delta^{(k)}\right]_{\hbar} .
$$

Then

$$
\begin{equation*}
\sigma_{\hbar}\left(\Delta^{(k)}\right)=\hbar Q+\Pi_{\hbar} . \tag{48}
\end{equation*}
$$

According to (47), $\Omega^{(k)} \in \hbar \mathrm{DO}_{2 k+1}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ and therefore we have $\frac{\Omega^{(k)}}{\hbar^{2 k+1}} \in \hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Denote by

$$
\mathbf{S}_{\hbar}^{(k)}=\sigma_{\hbar}\left(\frac{\Omega^{(k)}}{\hbar^{2 k+1}}\right), \quad \text { and } \quad \mathbf{S}^{(k)}=\left.\mathbf{S}_{\hbar}^{(k)}\right|_{\hbar=1} .
$$

By the graded Jacobi identity, we have

$$
\left[\Delta^{(k)}, \Omega^{(k)}\right]_{\hbar}=\left[\Delta^{(k)}, \frac{\hbar}{2}\left[\Delta^{(k)}, \Delta^{(k)}\right]_{\hbar}\right]_{\hbar}=0 .
$$

Therefore, by taking the extended principal symbol, we have

$$
\frac{1}{\hbar}\left\{\hbar Q+\Pi_{\hbar}, \mathbf{S}_{\hbar}^{(k)}\right\}=\frac{1}{\hbar}\left\{\hbar Q+\Pi_{\hbar}, \sigma_{\hbar}\left(\frac{\Omega^{(k)}}{\hbar^{2 k+1}}\right)\right\}=\sigma_{\hbar}\left[\Delta^{(k)}, \frac{\Omega^{(k)}}{\hbar^{2 k+1}}\right]_{\hbar}=0 .
$$

Thus it follows that $\left\{Q+\Pi, \mathbf{S}^{(k)}\right\}=0$, i.e. $\mathbf{S}^{(k)}$ is a $d_{\Pi}$-cocycle of degree 2 .
 there exists an operator $\Psi^{(k)} \in \hbar \mathrm{DO}^{+}\left(\right.$Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ such that

$$
\hat{\Delta}^{(k)}-\hat{\Delta}^{(k)}=\hbar^{2 k} \Psi^{(k)}
$$

Let $\Delta^{\prime(k)}=\hbar \mathcal{L}_{Q}+{\hat{\Delta^{\prime}}}^{(k)}$. Therefore

$$
\Delta^{\prime(k)}=\Delta^{(k)}+\hbar^{2 k} \Psi^{(k)} .
$$

Hence we have

$$
\Omega^{\prime(k)}:=\left(\Delta^{\prime(k)}\right)^{2}=\frac{\hbar}{2}\left[\Delta^{\prime(k)}, \Delta^{\prime(k)}\right]_{\hbar}=\Omega^{(k)}+\hbar^{2 k+1}\left[\Delta^{(k)}, \Psi^{(k)}\right]_{\hbar}+\frac{\hbar^{4 k+1}}{2}\left[\Psi^{(k)}, \Psi^{(k)}\right]_{\hbar} .
$$

Then

$$
\frac{\Omega^{\prime(k)}}{\hbar^{2 k+1}}=\frac{\Omega^{(k)}}{\hbar^{2 k+1}}+\left[\Delta^{(k)}, \Psi^{(k)}\right]_{\hbar}+\frac{\hbar^{2 k}}{2}\left[\Psi^{(k)}, \Psi^{(k)}\right]_{\hbar} .
$$

By applying the extended principal map $\sigma_{\hbar}$, we have

$$
\mathbf{S}_{\hbar}^{\prime(k)}=\mathbf{S}_{\hbar}^{(k)}+\frac{1}{\hbar}\left\{\hbar Q+\Pi_{\hbar}, \sigma_{\hbar}\left(\Psi^{(k)}\right\} .\right.
$$

Hence

$$
\mathbf{S}^{\prime(k)}=\mathbf{S}^{(k)}+\left\{Q+\Pi, Z^{(k)}\right\},
$$

where $\mathbf{S}_{\hbar}^{\prime(k)}=\sigma_{\hbar}\left(\frac{\Omega^{\prime}(k)}{\hbar^{2 k+1}}\right), \mathbf{S}^{\prime(k)}=\left.\mathbf{S}_{\hbar}^{\prime(k)}\right|_{\hbar=1}$, and $Z^{(k)}=\left.\sigma_{\hbar}\left(\Psi^{(k)}\right)\right|_{h=1}$. As a result $\mathbf{S}^{(k)}$ and $\mathbf{S}^{(k)}$ define the same class in $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$, independent of the choice of the operator representative in the operator class of $\frac{\hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right)}$.
Definition 3.11. Let $\left[\hat{\Delta}^{(k)}\right] \in \operatorname{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}\right)$ be a Maurer-Cartan element satisfying the condition (46). The class $\left[\mathbf{S}^{(k)}\right] \in \mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$ is called the modular class of $\left[\hat{\Delta}^{(k)}\right]$.

In particular, for $k=1$, we have a canonical element $\left[\hat{\Delta}^{(1)}\right]=\phi^{-1}(\Pi) \in \operatorname{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\text {Dens }_{M}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2}^{+}\left(\text {Dens }_{\mathcal{M}}^{112}\right)}\right)$. Thus we are led to the following

Definition 3.12. For any ( -1 )-shifted derived Poisson manifold $(\mathcal{M}, Q, \Pi)$, the modular class of $\left[\hat{\Delta}^{(1)}\right]=$ $\phi^{-1}(\Pi) \in \operatorname{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}\right)$ is called the modular class of the derived Poisson manifold $(\mathcal{M}, Q, \Pi)$.

The modular class in Definition 3.12 is an intrinsic invariant of a $(-1)$-shifted derived Poisson manifold. However, for $k \geq 2$, the modular class $\left[\mathbf{S}^{(k)}\right] \in \mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$ is not an intrinsic invariant, it depends on the choice of the Maurer-Cartan element $\left[\hat{\Delta}^{(k)}\right] \in \operatorname{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right)}\right)$.

Remark 3.13. In the context of supergeometry, the modular class of an odd Poisson supermanifold was originally introduced by Peddie-Khudaverdian in [25] considering odd Laplace-type operators acting on functions via a choice of volume form. The class was further studied in [25], where the class was identified when considering nilpotency conditions of arbitrary second order degree $(+1)$ operators on odd Poisson supermanifolds.

Proposition 3.14. Consider the short exact sequence of dglas (42), $\forall k=1,2, \cdots$. Given any MaurerCartan element $\left[\hat{\Delta}^{(k)}\right] \in \operatorname{MC}\left(\frac{\hbar \mathrm{DO}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\text {Dens }_{\mathcal{M}}^{1 / 2}\right)}\right)$ satisfying the condition (46), the modular class $\left[\boldsymbol{S}^{(k)}\right] \in$ $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$ is the obstruction class of lifting $\left[\hat{\Delta}^{(k)}\right]$ to a Maurer-Cartan element in $\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$.

Proof. Assume that the modular class vanishes. That is, there exists a degree $(+1)$ element $X^{(k)} \in$ $\Gamma\left(\hat{S} T_{\mathcal{M}}\right)$ such that $\mathbf{S}^{(k)}=\left\{Q+\Pi, X^{(k)}\right\}$. Hence, by Lemma 2.27, we have

$$
\begin{equation*}
\mathbf{S}_{\hbar}^{(k)}=\frac{1}{\hbar}\left\{\hbar Q+\Pi_{\hbar}, X_{\hbar}^{(k)}\right\} . \tag{49}
\end{equation*}
$$

Choose a self-adjoint operator $\Phi^{(k)} \in \hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$ satisfying the condition that $\sigma_{\hbar}\left(\Phi^{(k)}\right)=X_{\hbar}^{(k)}$. This is always possible according to Proposition 3.3. Let

$$
\hat{\Delta}^{(k+1)}=\hat{\Delta}^{(k)}-\hbar^{2 k} \Phi^{(k)}
$$

It is clear that

$$
\phi_{k}\left[\hat{\Delta}^{(k+1)}\right]=\left[\hat{\Delta}^{(k)}\right] \in \frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)}
$$

Here $\left[\hat{\Delta}^{(k+1)}\right]$ denotes the class of $\hat{\Delta}^{(k+1)}$ in $\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$, while $\left[\hat{\Delta}^{(k)}\right]$ denotes the class of $\hat{\Delta}^{(k)}$ in $\frac{\hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$. It remains to prove that $\left[\hat{\Delta}^{(k+1)}\right]$ is a Maurer-Cartan element in $\frac{\hbar \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)}$. Let $\Delta^{(k+1)}=\hbar \mathcal{L}_{Q}+\hat{\Delta}^{(k+1)}$. Then

$$
\Delta^{(k+1)}=\Delta^{(k)}-\hbar^{2 k} \Phi^{(k)}
$$

Now we have

$$
\begin{aligned}
\Omega^{(k+1)}: & =\left(\Delta^{(k+1)}\right)^{2} \\
& =\frac{\hbar}{2}\left[\Delta^{(k+1)}, \Delta^{(k+1)}\right]_{\hbar} \\
& =\frac{\hbar}{2}\left[\Delta^{(k)}-\hbar^{2 k} \Phi^{(k)}, \Delta^{(k)}-\hbar^{2 k} \Phi^{(k)}\right]_{\hbar} \\
& =\Omega^{(k)}-\hbar^{2 k+1}\left[\Delta^{(k)}, \Phi^{(k)}\right]_{\hbar}+\frac{\hbar^{4 k+1}}{2}\left[\Phi^{(k)}, \Phi^{(k)}\right]_{\hbar}
\end{aligned}
$$

Thus it follows that

$$
\frac{\Omega^{(k+1)}}{\hbar^{2 k+1}}=\frac{\Omega^{(k)}}{\hbar^{2 k+1}}-\left[\Delta^{(k)}, \Phi^{(k)}\right]_{\hbar}+\frac{\hbar^{2 k}}{2}\left[\Phi^{(k)}, \Phi^{(k)}\right]_{\hbar}
$$

Hence, by applying the extended principal map $\sigma_{\hbar}$, we have

$$
\begin{aligned}
\sigma_{\hbar}\left(\frac{\Omega^{(k+1)}}{\hbar^{2 k+1}}\right) & =\sigma_{\hbar}\left(\frac{\Omega^{(k)}}{\hbar^{2 k+1}}\right)-\frac{1}{\hbar}\left\{\sigma_{\hbar}\left(\Delta^{(k)}\right), \sigma_{\hbar}\left(\Phi^{(k)}\right)\right\} \\
& =\mathbf{S}_{\hbar}^{(k)}-\frac{1}{\hbar}\left\{\hbar Q+\Pi_{\hbar}, X_{\hbar}^{(k)}\right\} \\
& =0
\end{aligned}
$$

Therefore it follows that $\Omega^{(k+1)} \in \mathrm{DO}_{2 k+3}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. According to the equivalent relation (47), $\left[\Delta^{(k+1)}\right]$ is indeed a Maurer-Cartan element in $\frac{\hbar \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}{\hbar \mathrm{DO}_{2 k+2}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)}$. This proves one direction of the proposition. The converse can be proved using the same argument by going backwards.

Remark 3.15. For any $k=1,2, \cdots$, the short exact sequence (42) is in fact a square-zero extension of dglas. Recall that a square-zero extension of dglas is a short exact sequence of dglas

$$
\begin{equation*}
0 \longrightarrow K \xrightarrow{i} L \xrightarrow{\pi} M \longrightarrow 0 \tag{50}
\end{equation*}
$$

such that $[K, K]=0$. One can prove that for a square-zero extension of dglas (50), the obstruction to lifting a Maurer-Cartan element $x$ in $M$ is a well defined class in

$$
\begin{equation*}
\mathcal{H}^{2}\left(K, d_{K}+[y,-]\right) \tag{51}
\end{equation*}
$$

where $y \in L$ is any lift of $x$, i.e. $\pi(y)=x$. Note that the differential $d_{K}+[y,-]$, and hence the cohomology group $\mathcal{H}^{2}\left(K, d_{K}+[y,-]\right)$ is independent of the choice of the lift $y$. One can prove that for the square-zero extension of dglas (42), the corresponding cohomology group (51) is isomorphic to the second Poisson cohomology group $\mathcal{H}^{2}(\mathcal{M}, Q+\Pi)$. See [42] and [11, Section 3.1.3] for references on a related problem (the case when $K$ is an abelian ideal of $L$ ).

For each $\mathbf{X} \in \Gamma\left(\hat{S} T_{\mathcal{M}}\right)$, by $\operatorname{Op}(\mathbf{X})$, we denote the set of all self-adjoint operators $\Delta \in \hbar \mathrm{DO}^{+}\left(\right.$Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ such that $\sigma_{\hbar}(\Delta)=\mathbf{X}_{\hbar}$, where $\sigma_{\hbar}$ is the extended principal symbol map (25), and $\mathbf{X}_{\hbar}$ is defined as in (30). The subset $\operatorname{Op}(\mathbf{X})$ is called the operator class of the formal power series $\mathbf{X}$.
By considering the particular case of $k=1$, Proposition 3.14 implies the following
Corollary 3.16. For any ( -1 )-shifted derived Poisson manifold ( $\mathcal{M}, Q, \Pi$ ), its modular class is the obstruction class to the existence of an operator $\hat{\Delta} \in \mathrm{Op}(\Pi)$ satisfying the condition that $\Delta^{2} \in \hbar \mathrm{DO}_{5}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$, where $\Delta=\hbar \mathcal{L}_{Q}+\hat{\Delta}$.

Now we are ready for the proof of the main theorem.
Proof of Theorem 3.10. It is an immediate consequence of Lemma 3.7, Definition 3.11, and Proposition 3.14 .
3.4. ( -1 )-shifted dg Poisson manifolds. Let $\mathcal{M}$ be a graded manifold equipped with a single degree $(+1)$ Poisson bracket $\lambda_{2}: C^{\infty}(\mathcal{M})^{\otimes 2} \rightarrow C^{\infty}(\mathcal{M})$. This is essentially the classical case [25]. The Poisson structure is defined by a degree $(+1)$ element $\Pi_{2} \in \Gamma\left(S^{2} T_{\mathcal{M}}\right)$ such that $\left\{\Pi_{2}, \Pi_{2}\right\}=0$. It is denoted by $\left(\mathcal{M}, \Pi_{2}\right)$ and is called a $(-1)$-shifted Poisson manifold.
Let $\Delta_{2} \in \mathrm{DO}^{+}\left(\right.$Dens $\left._{\mathcal{M}}^{1 / 2}\right)$ be a degree ( +1 ) self-adjoint second order differential operator such that $\sigma_{2}\left(\Delta_{2}\right)=\Pi_{2}$. Let

$$
\Delta=\hbar^{2} \Delta_{2} .
$$

Since $\Delta_{2} \circ \Delta_{2}=\frac{1}{2}\left[\Delta_{2}, \Delta_{2}\right]$ is a first order anti-self-adjoint operator, by Proposition 2.13, it is given by the Lie derivative

$$
\begin{equation*}
\Delta_{2} \circ \Delta_{2}=\mathcal{L}_{X_{1}}, \tag{52}
\end{equation*}
$$

where $X_{1} \in \Gamma\left(T_{\mathcal{M}}\right)$ is a degree 2 vector field. Hence $\frac{1}{\hbar^{3}} \Delta^{2}=\hbar \Delta_{2} \circ \Delta_{2}=\hbar \mathcal{L}_{X_{1}}$. Thus the modular class is $\left[X_{1}\right] \in \mathcal{H}^{2}\left(\mathcal{M}, \Pi_{2}\right)$.
More generally, if $(\mathcal{M}, Q)$ is a dg manifold equipped with the degree $(+1)$-Poisson bracket determined by a degree $(+1)$ element $\Pi_{2} \in \Gamma\left(S^{2} T_{\mathcal{M}}\right)$ such that

$$
\left\{\Pi_{2}, \Pi_{2}\right\}=0, \quad\left\{Q, \Pi_{2}\right\}=0
$$

then $\left(\mathcal{M}, Q, \Pi_{2}\right)$ is called a $(-1)$-shifted dg Poisson manifold. Let $\Delta_{2} \in \mathrm{DO}^{+}\left(\mathrm{Dens}_{\mathcal{M}}^{1 / 2}\right)$ be an operator as before, and $\Delta=\hbar \mathcal{L}_{Q}+\hbar^{2} \Delta_{2}$. Then

$$
\Omega:=\Delta^{2}=\hbar^{3}\left[\mathcal{L}_{Q}, \Delta_{2}\right]+\hbar^{4} \Delta_{2}^{2}=\hbar^{3}\left[\mathcal{L}_{Q}, \Delta_{2}\right]+\hbar^{4} \mathcal{L}_{X_{1}} .
$$

Therefore

$$
\begin{equation*}
\sigma_{h}\left(\frac{\Omega}{\hbar^{3}}\right)=X_{0}+\hbar X_{1}, \tag{53}
\end{equation*}
$$

where $X_{0}=\sigma_{0}\left(\left[\mathcal{L}_{Q}, \Delta_{2}\right]\right) \in C^{\infty}(\mathcal{M})$. Thus $\left[X_{0}+X_{1}\right] \in \mathcal{H}^{2}\left(\mathcal{M}, Q+\Pi_{2}\right)$ is the modular class of the ( -1 )-shifted dg Poisson manifold $\left(\mathcal{M}, Q, \Pi_{2}\right.$ ). According to Corollary 3.16, it is the obstruction class to the existence of $\hat{\Delta} \in \mathrm{Op}(\Pi)$ such that $\left(\hbar \mathcal{L}_{Q}+\hat{\Delta}\right)^{2} \in \hbar \mathrm{DO}_{5}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right)$. Note that the vanishing of the modular class $\left[X_{0}+X_{1}\right] \in \mathcal{H}^{2}\left(\mathcal{M}, Q+\Pi_{2}\right)$ does not necessarily mean that $\left(\mathcal{M}, Q, \Pi_{2}\right)$ is quantizable. However, if we assume furthermore that $X_{0}+X_{1}$ can be expressed as a particular type of coboundary, i.e. there exists a function $f \in C^{\infty}(\mathcal{M})$ such that

$$
\begin{equation*}
X_{0}+X_{1}=\left\{Q+\Pi_{2}, f\right\} \tag{54}
\end{equation*}
$$

Then

$$
\Delta^{\prime}=\hbar \mathcal{L}_{Q}+\hbar^{2}\left(\Delta_{2}-f\right)
$$

is clearly a $\mathrm{BV}_{\infty}$-quantization of $\left(\mathcal{M}, Q, \Pi_{2}\right)$.

Proposition 3.17. Let $\left(\mathcal{M}, Q, \Pi_{2}\right)$ be a $(-1)$-shifted dg Poisson manifold, $\Delta_{2} \in \mathrm{Op}(\Pi)$, and $\Delta=\hbar \mathcal{L}_{Q}+$ $\hbar^{2} \Delta_{2}$. Assume that there exists a function $f \in C^{\infty}(\mathcal{M})$ such that Eq. (54) holds where $X_{0}$ and $X_{1}$ are as in (53). Then $\left(\mathcal{M}, Q, \Pi_{2}\right)$ is quantizable.

In particular, as an immediate consequence, we recover the following theorem due to Khudaverdian-Peddie.
Corollary 3.18 ([25]). $A(-1)$-shifted Poisson manifold $\left(\mathcal{M}, \Pi_{2}\right)$ is quantizable if and only if its modular class vanishes.

Proof. If $\left(\mathcal{M}, \Pi_{2}\right)$ is quantizable, then its modular class must vanish according to Corollary 3.16. Conversely, assume that the modular class of $\left(\mathcal{M}, \Pi_{2}\right)$ vanishes. By Eq. (52), the modular cocycle is a degree 2 vector field $X_{1} \in \Gamma\left(T_{\mathcal{M}}\right)$. Since it is a coboundary by assumption, by the weight counting, we have $X_{1}=\left\{\Pi_{2}, f\right\}$ for some function $f \in C^{\infty}(\mathcal{M})$. According to Proposition $3.17,\left(\mathcal{M}, \Pi_{2}\right)$ is indeed quantizable.

Below is an example of $(-1)$-shifted Poisson manifold with non-vanishing modular class, which is adapted from [25].

Example 3.19. Let $\mathcal{M}=\mathbb{R}^{2}[-1] \times \mathbb{R}[-2]$, and choose global coordinates $\xi, \tau$, $z$ with assigned degrees

$$
|\xi|=|\tau|=-1, \quad|z|=-2
$$

Define two vector fields on $\mathcal{M}$ :

$$
P=\tau \frac{\partial}{\partial \xi}+\tau \xi \frac{\partial}{\partial z}, \quad Q=\frac{\partial}{\partial \tau}
$$

Then $|P|=0$ and $|Q|=1$. It is simple to check that

$$
[Q, Q]=0, \quad[P, P]=0, \quad[P, Q]=0
$$

Hence $\Pi_{2}=P \odot Q$ is a degree $(+1)$ contravariant tensor satisfying $\left\{\Pi_{2}, \Pi_{2}\right\}=0$. Then

$$
\begin{equation*}
\Delta_{2}=\frac{1}{2}\left(\mathcal{L}_{P} \circ \mathcal{L}_{Q}+\mathcal{L}_{Q} \circ \mathcal{L}_{P}\right) \in \mathrm{DO}^{+}\left(\operatorname{Dens}_{\mathcal{M}}^{1 / 2}\right) \tag{55}
\end{equation*}
$$

is a degree $(+1)$ self-adjoint second order differential operator such that $\sigma_{2}\left(\Delta_{2}\right)=\Pi_{2}$. The operator has the coordinate expression

$$
\Delta_{2}=\tau \partial_{\xi} \partial_{\tau}+\tau \xi \partial_{z} \partial_{\tau}+\frac{1}{2} \xi \partial_{z}+\frac{1}{2} \partial_{\xi}
$$

from which we can explicitly calculate the square:

$$
\Delta_{2} \circ \Delta_{2}=\frac{1}{4} \partial_{z}
$$

Hence $X_{1}=\frac{1}{4} \partial_{z}$. Note that $\partial_{z}$ cannot be a Hamiltonian vector field, since the $(+1)$-shifted Poisson bracket on $\mathcal{M}$ reads

$$
\{\xi, \tau\}= \pm \tau, \quad\{z, \tau\}= \pm \tau \xi
$$

which is always proportional to $\tau$. Hence $\left[\partial_{z}\right] \in \mathcal{H}^{2}\left(\mathcal{M}, \Pi_{2}\right)$ is a non-trivial modular class of the $(-1)-$ shifted Poisson manifold $\left(\mathcal{M}, \Pi_{2}\right)$. As a consequence, $\left(\mathcal{M}, \Pi_{2}\right)$ is not quantizable.
Example 3.20. As in Example 3.19, we consider the $(-1)$-shifted dg Poisson manifold $\left(\mathcal{M}, Q, \Pi_{2}\right)$. Let $\Delta=\hbar \mathcal{L}_{Q}+\hbar^{2} \Delta_{2}$, where $\Delta_{2}$ is as in (55). Then

$$
\left[\mathcal{L}_{Q}, \Delta_{2}\right]=\frac{1}{2}\left[\mathcal{L}_{Q}, \mathcal{L}_{P} \circ \mathcal{L}_{Q}+\mathcal{L}_{Q} \circ \mathcal{L}_{P}\right]=\mathcal{L}_{Q} \circ \mathcal{L}_{P} \circ \mathcal{L}_{Q}=\left(\mathcal{L}_{[Q, P]}+\mathcal{L}_{P} \circ \mathcal{L}_{Q}\right) \circ \mathcal{L}_{Q}=0
$$

Therefore $X_{0}=\sigma_{0}\left(\left[\mathcal{L}_{Q}, \Delta_{2}\right]\right)=0$, and $\left[\partial_{z}\right] \in \mathcal{H}^{2}\left(\mathcal{M}, Q+\Pi_{2}\right)$ is a non-trivial modular class of the $(-1)$-shifted dg Poisson manifold $\left(\mathcal{M}, Q, \Pi_{2}\right)$.
3.5. ( -1 )-shifted derived Poisson manifolds and $L_{\infty}$-algebroids. Following the conventions of $[12,59$, 37, 3], an $L_{\infty}$-algebroid is a $\mathbb{Z}$-graded vector bundle $\mathcal{A} \rightarrow \mathcal{M}$ together with

- a sequence of multi-liner maps $\lambda_{n}: \bigwedge^{n} \Gamma(\mathcal{A}) \rightarrow \Gamma(\mathcal{A})$ of degree $2-n, n \geq 1$, which determine an $L_{\infty}$-structure on $\Gamma(\mathcal{A})$; and
- a sequence of bundle maps $\rho_{n}: \bigwedge^{n} \mathcal{A} \rightarrow T_{\mathcal{M}}$ of degree $1-n, n \geq 0$, called multi-anchor maps, such that
(i) its induced maps $\rho_{n}: \bigwedge^{n} \Gamma(\mathcal{A}) \rightarrow \mathfrak{X}(\mathcal{M}), n \geq 1$ define an $L_{\infty}$-morphism from $\Gamma(\mathcal{A})$ to the dgla $\left(\mathfrak{X}(\mathcal{M}), \rho_{0}\right)$, and moreover,
(ii) the higher Leibniz rules hold:

$$
\begin{align*}
& \lambda_{n}\left(v_{1}, \ldots, v_{n-1}, f v_{n}\right)=\rho_{n-1}\left(v_{1}, \ldots, v_{n-1}\right)(f) v_{n}+(-1)^{|f|\left(n+\left|v_{1}\right|+\cdots+\left|v_{n-1}\right|\right)} f \lambda_{n}\left(v_{1}, \ldots, v_{n}\right)  \tag{56}\\
& \quad \text { for all } n \geq 1, v_{1}, \ldots, v_{n} \in \Gamma(\mathcal{A}) \text { and } f \in C^{\infty}(\mathcal{M})
\end{align*}
$$

When $\mathcal{M}$ is an ordinary manifold $M$ (being considered of degree zero), and the vector bundle $\mathcal{A}=$ $\oplus_{i \geq 0} \mathcal{A}^{i} \rightarrow \mathcal{M}$ is a non-negative graded vector bundle, this reduces to the $L_{\infty}$ algebroids studied by Laurent-Gengoux et. al. [38]. In particular, if $\mathcal{A}$ is a usual vector bundle concentrated in degree 0 , it becomes an ordinary Lie algebroid over $M$. Here, we adapt more general definition by allowing $\mathcal{M}$ to be $\mathbb{Z}$-graded as well. For references on $L_{\infty}$ algebroids, see [3, 28, 32, 33, 38, 57, 55, 56, 53, 23] and the references therein.

Similar to the ordinary Lie-Poisson construction, any $L_{\infty}$-algebroid gives rise to a $(-1)$-shifted derived Poisson manifold in a natural fashion.

The following proposition is standard. See [31, 3, 52].
Proposition 3.21. An $L_{\infty}$-algebroid structure on $\mathcal{A}$ is equivalent to a linear ( -1 )-shifted derived Poisson manifold structure on $\mathcal{A}^{\vee}[-1]$.

Let us explain the word linear. Note that under the isomorphism:

$$
\begin{equation*}
C^{\infty}\left(\mathcal{A}^{\vee}[-1]\right) \cong \Gamma\left(\hat{S}^{\bullet}(\mathcal{A}[1])\right) \tag{57}
\end{equation*}
$$

$C^{\infty}\left(\mathcal{A}^{\vee}[-1]\right)$, besides the underlying $\mathbb{Z}$-grading, possesses a natural non-negative $\mathbb{N}$-grading by the weight, which we denote by $N$-degree. A $(-1)$-shifted derived Poisson manifold structure on $\mathcal{A}^{\vee}[-1]$ is said to be linear, if for each $n \geq 1$, the Poisson multi-bracket $\tilde{\lambda}_{n}: C^{\infty}\left(\mathcal{A}^{\vee}[-1]\right)^{\otimes n} \rightarrow C^{\infty}\left(\mathcal{A}^{\vee}[-1]\right)$ is of $N$-degree $1-n$. More precisely, under the isomorphism (57), $\tilde{\lambda}_{n}$ is of the form:

$$
\begin{equation*}
\tilde{\lambda}_{n}: \Gamma\left(S^{k_{1}}(\mathcal{A}[1])\right) \times \cdots \times \Gamma\left(S^{k_{n}}(\mathcal{A}[1])\right) \rightarrow \Gamma\left(S^{k_{1}+\cdots k_{n}+(1-n)}(\mathcal{A}[1])\right) \tag{58}
\end{equation*}
$$

for any non-negative integers $k_{1}, \cdots, k_{n}$. In this case, we say that $\Pi_{n}$ is of $N$-degree $1-n$.
Below we describe briefly one direction of the construction in Proposition 3.21. The construction of the other direction can be carried out by going backwards.

Let $\mathcal{A} \rightarrow \mathcal{M}$ be an $L_{\infty}$-algebroid with the structure maps $\left(\lambda_{n}\right)_{n \geqslant 1}$ and $\left(\rho_{n}\right)_{n \geqslant 0}$ as in the beginning of the subsection. Then $\Gamma(\mathcal{A}[1])$ is an $L_{\infty}[1]$-algebra. The corresponding degree $(+1)$-Poisson multi-brackets $\tilde{\lambda}_{n}$ as in (58) are essentially the natural extension of $\left(\lambda_{n}\right)_{n \geqslant 1}$ by the Leibniz rule in Definition 1.1 with the help of the multi-anchor maps. Note that the 0-th anchor map $\rho_{0}$ defines a homological vector field $Q_{\mathcal{M}} \in \mathfrak{X}(\mathcal{M})$. The unary bracket $\lambda_{1}: \Gamma(\mathcal{A}) \rightarrow \Gamma(\mathcal{A})$ and $\rho_{0}$ are compatible:

$$
\lambda_{1}(f a)=Q_{\mathcal{M}}(f) a+(-1)^{|f|} f \lambda_{1}(a), \quad \forall a \in \Gamma(\mathcal{A}), f \in C^{\infty}(\mathcal{M})
$$

Hence $\Gamma(\mathcal{A})$ is a dg module over $\left(C^{\infty}(\mathcal{M}), Q_{\mathcal{M}}\right)$. As a consequence, $\mathcal{A} \rightarrow \mathcal{M}$ is a dg vector bundle [44, 45], which implies that $\mathcal{A}^{\vee} \rightarrow \mathcal{M}$ is a dg vector bundle as well. Hence $\mathcal{A}^{\vee}[-1]$ is, naturally, a dg
manifold, whose corresponding homological vector field is denoted $Q$. As before, we write $\Pi_{1}=Q$, and the corresponding degree $(+1)$ Poisson tensor $\Pi \in \Gamma\left(\hat{S}\left(T_{\mathcal{A}^{\vee}[-1]}\right)\right)$ on $\mathcal{A}^{\vee}[-1]$ is

$$
\Pi=\sum_{n \geq 1} \Pi_{n}, \quad|\Pi|=1, \quad N\left(\Pi_{n}\right)=1-n
$$

Choose a local coordinate chart $\left(x^{a}\right)$ on $\mathcal{M}$ and a local frame $\left(e_{1}, \ldots, e_{n}\right)$ on $\mathcal{A}$. Let $\left(f^{1}, \ldots, f^{n}\right)$ be its corresponding dual local frame on $\mathcal{A}^{\vee}$. These data determine a coordinate chart on $\mathcal{A}^{\vee}[-1]$ :

$$
\begin{equation*}
\left(x^{a}, \xi_{i}\right) \tag{59}
\end{equation*}
$$

and as well as a coordinate chart on $\mathcal{A}[1]$ :

$$
\begin{equation*}
\left(x^{a}, \eta^{i}\right) \tag{60}
\end{equation*}
$$

Under the local coordinate chart (59), $\Pi_{n}$ can be written explicitly as follows

$$
\begin{equation*}
\Pi_{n}=\frac{1}{(n-1)!} \rho_{i_{1} \cdots i_{n-1}}^{a}(x) \frac{\partial}{\partial \xi_{i_{1}}} \cdots \odot \frac{\partial}{\partial \xi_{i_{n-1}}} \odot \frac{\partial}{\partial x^{a}}+\frac{1}{n!} C_{i_{1} \cdots i_{n}}^{j}(x) \xi_{j} \frac{\partial}{\partial \xi_{i_{1}}} \odot \cdots \odot \frac{\partial}{\partial \xi_{i_{n}}} \tag{61}
\end{equation*}
$$

where the structure functions $\left(\rho_{i_{1} \cdots i_{n-1}}^{a}(x)\right)$ and $\left(C_{i_{1} \cdots i_{n}}^{j}(x)\right)$ are determined by the corresponding multianchors and multi-brackets:

$$
\rho_{n-1}\left(e_{i_{1}} \wedge \cdots \wedge e_{i_{n-1}}\right)= \pm \rho_{i_{1} \cdots i_{n-1}}^{a}(x) \frac{\partial}{\partial x^{a}}, \quad \lambda_{n}\left(e_{i_{1}}, \cdots, e_{i_{n}}\right)= \pm C_{i_{1} \cdots i_{n}}^{j}(x) e_{j}
$$

Theorem 3.22. For any $L_{\infty}$-algebroid $\mathcal{A}$, its corresponding linear $(-1)$-shifted derived Poisson manifold $\mathcal{A}^{\vee}[-1]$ admits a canonical quantization.

Proof. To any $L_{\infty}$-algebroid $\mathcal{A}$, there is a Chevalley-Eilenberg differential $D$, which is a homological vector field on $\mathcal{A}[1]$. Indeed, $L_{\infty}$-algebroid structures on a graded vector bundle $\mathcal{A} \rightarrow \mathcal{M}$ are equivalent to homological vector fields on $\mathcal{A}[1]$ vanishing on the zero section [3]. The homological vector field $D$ on $\mathcal{A}[1]$ is necessarily of the form $D=\sum_{n=1}^{\infty} D_{n}$, where $D_{n}$ is a derivation on $C^{\infty}(\mathcal{A}[1])$ of weight $(n-1)$ :

$$
\begin{equation*}
D_{n}: \Gamma\left(\hat{S}^{\bullet}\left(\mathcal{A}^{\vee}[-1]\right)\right) \rightarrow \Gamma\left(\hat{S}^{\bullet+n-1}\left(\mathcal{A}^{\vee}[-1]\right)\right) \tag{62}
\end{equation*}
$$

Under the local coordinate chart (60), the derivation $D_{n}$ can be written as

$$
\begin{equation*}
D_{n}= \pm \frac{1}{(n-1)!} \rho_{i_{1} \cdots i_{n-1}}^{a}(x) \eta^{i_{1}} \cdots \eta^{i_{n-1}} \frac{\partial}{\partial x^{a}} \pm \frac{1}{n!} C_{i_{1} \cdots i_{n}}^{j}(x) \eta^{i_{1}} \cdots \eta^{i_{n}} \frac{\partial}{\partial \eta^{j}} \tag{63}
\end{equation*}
$$

According to Khudaverdian-Voronov [31], the homological vector field $D \in \mathfrak{X}(\mathcal{A}[1])$ and the degree $(+1)$ Poisson tensor $\Pi \in \Gamma\left(\hat{S}\left(T_{\mathcal{A}^{\vee}[-1]}\right)\right)$ are related as follows

$$
\begin{equation*}
\Phi^{*} D=\Pi \tag{64}
\end{equation*}
$$

where

$$
\begin{equation*}
\Phi: T_{\mathcal{A}^{\vee}[-1]}^{\vee} \xrightarrow{\simeq} T_{\mathcal{A}[1]}^{\vee} \tag{65}
\end{equation*}
$$

is the canonical isomorphism [40], $D \in \mathfrak{X}(\mathcal{A}[1])$ is identified with its corresponding linear function on $T_{\mathcal{A}[1]}^{\vee}$, while $\Pi$ is considered as a formal polynomial on $T_{\mathcal{A}^{\vee}[-1]}^{\vee}$. Following Shemyakova [52, Equation (48)] (see also [61]), we denote by

$$
\begin{equation*}
\mathcal{F}: \Gamma\left(\operatorname{Dens}_{\mathcal{A}[1]}^{1 / 2}\right) \xrightarrow{\simeq} \Gamma\left(\operatorname{Dens}_{\mathcal{A}^{\vee}[-1]}^{1 / 2}\right) \tag{66}
\end{equation*}
$$

the fiberwise $\hbar$-Fourier transform ${ }^{2}$ :

$$
\begin{equation*}
\mathcal{F}\left[f(x, \eta) \mathcal{D} x^{\frac{1}{2}} \mathcal{D} \eta^{\frac{1}{2}}\right]=\left(\int_{\mathcal{A}_{x}} e^{\frac{1}{\hbar}<\xi, \eta>} f(x, \eta) \mathcal{D} \eta\right) \mathcal{D} x^{\frac{1}{2}} \mathcal{D} \xi^{\frac{1}{2}} \tag{67}
\end{equation*}
$$

[^1]where $(x, \eta) \in \mathcal{A}[1]$ and $(x, \xi) \in \mathcal{A}^{\vee}[-1]$ (we emphasize the base point $x \in \mathcal{M}$ ). Now set
\[

$$
\begin{equation*}
\Delta:=\mathcal{F} \circ \mathcal{L}_{\hbar D} \circ \mathcal{F}^{-1} \tag{68}
\end{equation*}
$$

\]

Since the fiberwise $\hbar$-Fourier transform $\mathcal{F}$ preserves the scalar products and $\mathcal{L}_{\hbar D}$ is self-adjoint, it follows that $\Delta$ is self-adjoint. Moreover, since $D$ is a homological vector field, it follows that $\Delta^{2}=0$. Finally, it is simple to check, by using local coordinates, and Eqs. (61) and (63), that $\Delta$ is indeed a quantization of the linear $(-1)$-shifted derived Poisson manifold $\mathcal{A}^{\vee}[-1]$.
3.6. Quantization of the derived intersection of coisotropic submanifolds of a Lie-Poisson manifold. Next, as a special case, we consider the case when $\mathcal{A}$ is an ordinary Lie algebroid $A$ over the base manifold $M$. In this situation, $A^{\vee}[-1]$ is a $(-1)$-shifted Poisson manifold, where the degree $(+1)$-Poisson bracket on $C^{\infty}\left(A^{\vee}[-1]\right) \cong \Gamma\left(\Lambda^{-\bullet} A\right)$ is the Schouten bracket. For the simplicity of notation, assume that the rank of the vector bundle $A$ is $n$. By $D: \Gamma\left(\Lambda^{\bullet} A^{\vee}\right) \rightarrow \Gamma\left(\Lambda^{\bullet+1} A^{\vee}\right)$, we denote the Chevalley-Eilenberg differential of the Lie algebroid. Thus $(A[1], D)$ is a dg manifold. Assume, for the sake of simplicity, that $M$ is an orientable manifold and the vector bundle $A \rightarrow M$ is orientable as well. Then both vector bundles $A \oplus T_{M}$ and $A \oplus T_{M}^{\vee}$ are orientable. We have the following standard identifications [14, 21].

$$
\begin{equation*}
\Gamma\left(\operatorname{Dens}_{A[1]}^{1 / 2}\right) \cong \Gamma\left(\Lambda A^{\vee} \otimes\left(\Lambda^{\mathrm{top}} A \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{69}
\end{equation*}
$$

while

$$
\begin{equation*}
\Gamma\left(\mathrm{Dens}_{A^{\vee}[-1]}^{1 / 2}\right) \cong \Gamma\left(\Lambda A \otimes\left(\Lambda^{\mathrm{top}} A^{\vee} \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{70}
\end{equation*}
$$

Here, by abuse of notation, $\Lambda^{\text {top }} A \otimes \Lambda^{\text {top }} T_{M}^{\vee}$ and $\Lambda^{\text {top }} A^{\vee} \otimes \Lambda^{\text {top }} T_{M}^{\vee}$ are identified with $\left|\Lambda^{\text {top }} A \otimes \Lambda^{\text {top }} T_{M}^{\vee}\right|$ and $\left|\Lambda^{\text {top }} A^{\vee} \otimes \Lambda^{\text {top }} T_{M}^{\vee}\right|$, respectively, and therefore their square root make sense. On the other hand, it is standard [1, Section 5] [21, Section 6.3] that there is a canonical isomorphism

$$
\begin{equation*}
\Phi: \Gamma\left(\Lambda^{k} A^{\vee} \otimes\left(\Lambda^{\mathrm{top}} A \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \xrightarrow{\simeq} \Gamma\left(\Lambda^{\mathrm{top}-k} A \otimes\left(\Lambda^{\mathrm{top}} A^{\vee} \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{71}
\end{equation*}
$$

It is simple to check that, under the identifications (69)-(70), the fiberwise $\hbar$-Fourier transform (66) and $\Phi$ are related as follows

$$
\begin{equation*}
\left.\mathcal{F}\right|_{\Gamma\left(\Lambda^{k} A^{\vee} \otimes\left(\Lambda^{\operatorname{top}} A \otimes \Lambda^{\operatorname{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right)}=\left(\frac{1}{\hbar}\right)^{n-k} \Phi \tag{72}
\end{equation*}
$$

where $n$ is the rank of $A$. Thus, it follows that, under the identifications (69)-(70),

$$
\mathcal{F} \circ \mathcal{L}_{\hbar D} \circ \mathcal{F}^{-1}=\hbar^{2} \Phi \circ \mathcal{L}_{D} \circ \Phi^{-1}
$$

It is known [21, 34] that, under the identification (69), as a degree $(+1)$ operator on $\Gamma\left(\operatorname{Dens}_{A[1]}^{1 / 2}\right), \mathcal{L}_{D}$ coincides with the Chevalley-Eilenberg differential of the Lie algebroid $A$ with values in the Evens-LuWeinstein module [19] $\left(\Lambda^{\text {top }} A \otimes \Lambda^{\text {top }} T_{M}^{\vee}\right)^{\frac{1}{2}}$ :

$$
d_{\mathrm{CE}}^{\mathrm{ELW}}: \Gamma\left(\Lambda^{\bullet} A^{\vee} \otimes\left(\Lambda^{\mathrm{top}} A \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \rightarrow \Gamma\left(\Lambda^{\bullet+1} A^{\vee} \otimes\left(\Lambda^{\mathrm{top}} A \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right)
$$

As a consequence, we have the following
Proposition 3.23. For any Lie algebroid $A$ over $M$, assuming that $M$ is an orientable manifold and the vector bundle $A \rightarrow M$ is orientable as well, the $(-1)$-shifted Poisson manifold $A^{\vee}[-1]$ admits a canonical quantization

$$
\begin{equation*}
\Delta=\hbar^{2} \Phi \circ d_{C E}^{E L W} \circ \Phi^{-1}: \Gamma\left(\Lambda^{-\bullet} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \rightarrow \Gamma\left(\Lambda^{-(\bullet+1)} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{73}
\end{equation*}
$$

Remark 3.24. Proposition 3.23, in different forms, have been known in the literature. When the Lie algebroid $A$ is the cotangent Lie algebroid of a Poisson manifold, this is essentially the Koszul-Brylinski operator $[35,13]$. When choosing a flat $A$-connection on $\Lambda^{\text {top }} A, \Delta$ can be identified with an $B V$-operator on $\Gamma\left(\Lambda^{-\bullet} A\right)$ as shown in [64]. See also [16, Section 9.4] for the approach from the viewpoint of factorization algebras.

Finally, we consider the $(-1)$-shifted derived Poisson manifold $\left(A^{\vee}[-1], \iota_{s}, \Pi_{2}\right)$ as in Example 1.8 , which arises as the derived intersection of two coisotropic submanifolds of the Lie-Poisson manifold $A^{\vee}$ : the graph of $s$ and the zero section.

Let $Q=\iota_{s}$. It is simple to see that, under the identification (70), the Lie derivative

$$
\mathcal{L}_{Q}: \Gamma\left(\operatorname{Dens}_{A^{\vee}[-1]}^{1 / 2}\right) \rightarrow \Gamma\left(\text { Dens }_{A^{\vee}[-1]}^{1 / 2}\right)
$$

becomes the contraction operator

$$
\iota_{s}: \Gamma\left(\Lambda A \otimes\left(\Lambda^{\mathrm{top}} A^{\vee} \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \rightarrow \Gamma\left(\Lambda A \otimes\left(\Lambda^{\mathrm{top}} A^{\vee} \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right)
$$

Thus it follows that $\Phi^{-1} \circ \iota_{s} \circ \Phi$, the conjugation by $\Phi$, coincides with the multiplication operator:

$$
m_{s}: \Gamma\left(\Lambda^{\bullet} A^{\vee} \otimes\left(\Lambda^{\mathrm{top}} A \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \rightarrow \Gamma\left(\Lambda^{\bullet+1} A^{\vee} \otimes\left(\Lambda^{\mathrm{top}} A \otimes \Lambda^{\mathrm{top}} T_{M}^{\vee}\right)^{\frac{1}{2}}\right)
$$

Since $d_{\mathrm{CE}} s=0$, it follows that

$$
\left[d_{\mathrm{CE}}^{\mathrm{ELW}}, m_{s}\right]=0
$$

Therefore

$$
\left[\Phi \circ d_{\mathrm{CE}}^{\mathrm{ELW}} \circ \Phi^{-1}, \iota_{s}\right]=0
$$

Hence $\hbar \iota_{s}+\hbar^{2} \Phi \circ d_{\mathrm{CE}}^{\mathrm{ELW}} \circ \Phi^{-1}$ is indeed a $\mathrm{BV}_{\infty}$-operator quantizing the $(-1)$-shifted derived Poisson manifold $\left(A^{\vee}[-1], \iota_{s}, \Pi_{2}\right)$.

Theorem 3.25. Let $A$ be a Lie algebroid over $M$, and $s \in \Gamma\left(A^{\vee}\right)$ a Lie algebroid 1-cocycle. Assume that $M$ is an orientable manifold and the vector bundle $A \rightarrow M$ is orientable as well. Then the $(-1)$-shifted derived Poisson manifold $\left(A^{\vee}[-1], \iota_{s}, \Pi_{2}\right)$ as in Example 1.8 admits a canonical quantization

$$
\begin{equation*}
\Delta=\hbar \iota_{s}+\hbar^{2} \Phi \circ d_{C E}^{E L W} \circ \Phi^{-1}: \Gamma\left(\Lambda^{-\bullet} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \rightarrow \Gamma\left(\Lambda^{-(\bullet+1)} A \otimes\left(\Lambda^{t o p} A^{\vee} \otimes \Lambda^{t o p} T_{M}^{\vee}\right)^{\frac{1}{2}}\right) \tag{74}
\end{equation*}
$$

In particular, when $A$ is $T_{M}$ and $s=d f \in \Omega^{1}(M)$ an exact one-form, where $f \in C^{\infty}(M)$, then $\left(\Lambda^{\text {top }} A \otimes\right.$ $\left.\Lambda^{\text {top }} T_{M}^{\vee}\right)^{\frac{1}{2}}$ is canonically isomorphic to the trivial line bundle $M \times \mathbb{R}$ and the operator $d_{\mathrm{CE}}^{\mathrm{ELW}}$ reduces to the ordinary de Rham differential. As an immediate consequence, we see that

$$
\begin{equation*}
\hbar \iota_{d f}+\hbar^{2} \Phi \circ d_{D R} \circ \Phi^{-1}: \Gamma\left(\Lambda^{-\bullet} T_{M} \otimes\left(\Lambda^{\mathrm{top}} T_{M}^{\vee}\right)\right) \rightarrow \Gamma\left(\Lambda^{-(\bullet+1)} T_{M} \otimes\left(\Lambda^{\mathrm{top}} T_{M}^{\vee}\right)\right) \tag{75}
\end{equation*}
$$

is a $\mathrm{BV}_{\infty}$-operator quantizing the $(-1)$-shifted derived symplectic manifold $\left(T_{M}^{\vee}[-1], \iota_{d f}, \omega_{\text {can }}\right)$. Here

$$
\Phi: \Omega^{k}(M) \rightarrow \Gamma\left(\Lambda^{\mathrm{top}-k} T_{M} \otimes\left(\Lambda^{\mathrm{top}} T_{M}^{\vee}\right)\right), \quad \forall k=0,1, \cdots
$$

is the canonical isomorphism.
