# INTERIOR ESTIMATES FOR THE MONGE-AMPÈRE TYPE FOURTH ORDER EQUATIONS 

LING WANG AND BIN ZHOU*


#### Abstract

In this paper, we give several new approaches to study interior estimates for a class of fourth order equations of Monge-Ampère type. First, we prove interior estimates for the homogeneous equation in dimension two by using the partial Legendre transform. As an application, we obtain a new proof of the Bernstein theorem without using Caffarelli-Gutiérrez's estimate, including the Chern conjecture on affine maximal surfaces. For the inhomogeneous equation, we also obtain a new proof in dimension two by an integral method relying on the Monge-Ampère Sobolev inequality. This proof works even when the right hand side is singular. In higher dimensions, we obtain the interior regularity in terms of integral bounds on the second derivatives and the inverse of the determinant.


## 1. Introduction

We study the regularity of the following fourth order equations of Monge-Ampère type

$$
\begin{equation*}
U^{i j} w_{i j}=f \tag{1.1}
\end{equation*}
$$

where $\left\{U^{i j}\right\}$ is the cofactor matrix of $D^{2} u$ of an unknown uniformly convex function, and

$$
w= \begin{cases}{\left[\operatorname{det} D^{2} u\right]^{-(1-\theta)},} & \theta \geq 0, \quad \theta \neq 1,  \tag{1.2}\\ \log \operatorname{det} D^{2} u, & \theta=1 .\end{cases}
$$

When $\theta=\frac{1}{n+2}$, this is the affine mean curvature equation in affine geometry Ch. When $\theta=0$, it is Abreu's equation arising from the problem of extremal metrics on toric manifolds in Kähler geometry [Ab], and is equivalent to

$$
\sum_{i, j} \frac{\partial^{2} u^{i j}}{\partial x_{i} \partial x_{j}}=f
$$

where $\left\{u^{i j}\right\}$ is the inverse matrix of $D^{2} u$. The regularity of (1.1) has been extensively studied before, see [TW1, TW2, D, Z1, Z2, CHLS, Le1, Le2, CW]. This equation is usually treated as a system of a Monge-Ampère equation and a linearized Monge-Ampère equation. Therefore, in

[^0]previous works, its regularity relies heavily on Caffarelli-Gutiérrez's deep result on the interior regularity of the linearized Monge-Ampère equation [CG], which was later extended by [LS, GN1, GN2 to the the boundary and to higher order estimates. In this paper, we investigate the interior estimates of (1.1) by several new approaches. We will mainly concentrate on the case $\theta \in[0,1]$ due to the interesting geometric background.

We first consider the case of the homogeneous equation

$$
\begin{equation*}
U^{i j} w_{i j}=0 \tag{1.3}
\end{equation*}
$$

where $w$ is given by (1.2). We apply the partial Legendre transform to give a new proof of the interior estimates of (1.3) in dimension two.

Theorem 1.1. Assume $n=2$ and $\theta \in[0,1]$. Let $\Omega \subset \mathbb{R}^{2}$ be a convex domain and let $u$ be $a$ smooth convex solution to equation (1.3) on $\Omega$ satisfying

$$
\begin{equation*}
0<\lambda \leq \operatorname{det} D^{2} u \leq \Lambda \tag{1.4}
\end{equation*}
$$

Then for any $\Omega^{\prime} \Subset \Omega$, there exists a constant $C>0$ depending on $\sup _{\Omega}|u|, \lambda, \Lambda, \theta$ and $\operatorname{dist}\left(\Omega^{\prime}, \partial \Omega\right)$, such that

$$
\|u\|_{C^{4, \alpha}\left(\Omega^{\prime}\right)} \leq C .
$$

The partial Legendre transform for the fourth order equation was first used in [LZ] where the authors deal with the second boundary value problem. After the partial Legendre transform, equation (1.3) becomes a quasi-linear second order equation (see (2.3)) for the determinant. The main ingredient in our proof is an interior integral gradient estimate (Theorem 2.2). When $\theta \in\left[0, \frac{1}{4}\right]$, condition (1.4) holds by the determinant estimates and arguments of strict convexity [TW1, Z1]. By Theorem 1.1 and a rescaling argument as in TW1, Theorem 2.1], we obtain a new proof of the following Bernstein theorem [TW1, JL, Z1] without using Caffarelli-Gutiérrez's theory.

Theorem 1.2. Assume $n=2$ and $0 \leq \theta \leq \frac{1}{4}$. Let $u$ be an entire smooth uniformly convex solution to (1.3) on $\mathbb{R}^{2}$. Then $u$ is a quadratic polynomial.

In the case of the inhomogeneous equation and in higher dimensions, the partial Legendre transform does not work. We will investigate the interior regularity by an integral method motivated by De Giorgi-Nash-Moser's theory. Consider the inhomogeneous equation with general right hand side term

$$
\begin{equation*}
U^{i j} w_{i j}=f\left(x, u, D u, D^{2} u\right) \tag{1.5}
\end{equation*}
$$

where $w$ given by (1.2) with $\theta \in[0,1]$. This equation is introduced by Le4, Le5] in the study of convex functionals with a convexity constraint related to the Rochet-Choné model for the
monopolist problem in economics. It is said to be singular since the right hand side term depends on $D^{2} u$. A typical example considered in [Le4, Le5, [Z] is

$$
\begin{equation*}
f=\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)+f^{0}(x, u) \tag{1.6}
\end{equation*}
$$

Note that when $f \in L^{\infty}(\Omega)$, once we have the determinant estimate (1.4), we can use CaffarelliGutiérrez's theory to get the interior regularity. The assumption on $f$ can be weakened to $f \in L^{\frac{n}{2}+\varepsilon}(\Omega)$ by [LN]. Hence for $f$ defined as (1.6), when $n=2$ and $p \geq 2$, we can obtain the interior regularity of $u$ directly by using interior $W^{2,1+\varepsilon}$-estimates of the Monge-Ampère equations [DFS, [S]. To settle the more singular case $1<p<2$, Le established the interior estimate of the linearized Monge-Ampère equation with right hand side term in divergence form in dimension two [Le3]. One of the main tools in Le3] are the Monge-Ampère Sobolev inequality (see Lemma (3.2). In this paper, we will use the Monge-Ampère Sobolev inequality and the $W^{2,1+\varepsilon}$-estimates for the Monge-Ampère equation directly in the fourth order equation to obtain a $W^{2, p}$-estimate of the solution (Theorem 3.3). Then we can apply the regularity theory of second order elliptic equation of divergence type to obtain a new proof for the interior estimates of (1.5).

Theorem 1.3. Assume $n=2$ and $\theta \in[0,1]$. Let $\Omega \subset \mathbb{R}^{2}$ be a convex domain. Assume

$$
f=\operatorname{div}(g)+h
$$

where $g:=\left(g^{1}(x), g^{2}(x)\right): \Omega \rightarrow \mathbb{R}^{2}$ is a bounded vector function and $h \in L^{q}(\Omega)$ for some $q>\frac{n}{2}$. Suppose $u$ is a smooth convex solution to equation (1.5) on $\Omega$ satisfying (1.4). Then for any $\Omega^{\prime} \Subset \Omega$, there exists a constant $C>0$ depending on $\sup _{\Omega}|u|, \lambda, \Lambda, \theta,\|g\|_{L^{\infty}(\Omega)},\|h\|_{L^{q}(\Omega)}$ and $\operatorname{dist}\left(\Omega^{\prime}, \partial \Omega\right)$, such that

$$
\|u\|_{W^{4, q}\left(\Omega^{\prime}\right)} \leq C
$$

Remark 1.4. (1) It is clear that the above theorem applies to the case (1.6) for any $p>1$ in dimension two. The higher dimensional case is still open.
(2) When $f \in W^{1, q}(\Omega)$ and $\theta=0$ or 1 , we give another new proof in Section 3 inspired by [CC] for the complex setting. More precisely, we get a $C^{2}$-estimate of $u$ in terms of the $W^{2, p}$-bound (Theorem (3.4), which makes (1.5) become a uniformly elliptic equation. Then the classical theory of uniformly elliptic equations can be applied.

In higher dimensions, the interior regularity and the Bernstein theorem are still widely open. In fact, according to the counterexample in [TW1] for the affine maximal surface equation, there may be no interior estimates if no further assumptions are made. More precisely, (1.4) may not hold. We give a partial result by assuming integral bounds on the second derivatives and the inverse of the determinant.

Theorem 1.5. Let $\Omega \subset \mathbb{R}^{n}$ be a convex domain and let $u$ be a smooth uniformly convex solution to equation (1.3) with $\theta \in[0,1]$ on $\Omega$. Assume that $p, q>0$ satisfy $\frac{n}{p}+\frac{1}{q}<\frac{2}{n}$. Then for any $\Omega^{\prime} \Subset$ $\Omega$, there exists a constant $C$, depending only on $p, q, \theta, \sup _{\Omega}|u|,\|u\|_{W^{2, p}(\Omega)},\left\|\left(\operatorname{det} D^{2} u\right)^{-1}\right\|_{L^{q}(\Omega)}$ and dist $\left(\Omega^{\prime}, \partial \Omega\right)$, such that

$$
\|u\|_{C^{4, \alpha}\left(\Omega^{\prime}\right)} \leq C .
$$

As an application, we obtain a Liouville type theorem in higher dimensions.
Corollary 1.6. Let $u$ be an entire smooth uniformly convex solution to (1.1) with $\theta \in[0,1]$ on $\mathbb{R}^{n}$. Suppose there are $p, q, C>0$ such that $\frac{n}{p}+\frac{1}{q}<\frac{2}{n}$ and

$$
\begin{equation*}
\int_{B_{R}(0)}\left|D^{2} u\right|^{p}+\left(\operatorname{det} D^{2} u\right)^{-q} d x \leq C R^{n}, \quad \forall R>0 \tag{1.7}
\end{equation*}
$$

Then $u$ is a quadratic polynomial.
The structure of the paper is as follows. In Section 2.1, we apply the partial Legendre transform to (1.1) in dimension two to derive a new equation. The key interior gradient estimate (Theorem [2.2) for the new equation is established in Section 2.2. Then we prove Theorem 1.1 in Section 2.3 with this key estimate. In Section 3, we first derive the $W^{2, p}$-estimate of $u$ (Theorem (3.3), and then we prove Theorem 1.3. Section 4 is devoted to some study on interior regularity in higher dimensions.

## 2. The homogeneous equation in dimension two

In this section, we present a new proof for the interior estimate for the homogeneous equation without Caffarelli-Gutiérrez's theory.
2.1. The new equation under partial Legendre transform. We first focus on the dimension two case. Write $u(x)=u\left(x_{1}, x_{2}\right)$. The partial Legendre transform in the $x_{1}$-variable is

$$
\begin{equation*}
u^{\star}(\xi, \eta)=x_{1} u_{x_{1}}\left(x_{1}, x_{2}\right)-u\left(x_{1}, x_{2}\right) \tag{2.1}
\end{equation*}
$$

where

$$
y=(\xi, \eta)=\mathcal{P}\left(x_{1}, x_{2}\right):=\left(u_{x_{1}}, x_{2}\right) \in \mathcal{P}(\Omega)=: \Omega^{\star}
$$

We have

$$
\frac{\partial(\xi, \eta)}{\partial\left(x_{1}, x_{2}\right)}=\left(\begin{array}{cc}
u_{x_{1} x_{1}} & u_{x_{1} x_{2}} \\
0 & 1
\end{array}\right), \quad \text { and } \quad \frac{\partial\left(x_{1}, x_{2}\right)}{\partial(\xi, \eta)}=\left(\begin{array}{cc}
\frac{1}{u_{x_{1} x_{1}}} & -\frac{u_{x_{1} x_{2}}}{u_{x_{1} x_{1}}} \\
0 & 1
\end{array}\right)
$$

Hence,

$$
\begin{equation*}
u_{\xi}^{\star}=x_{1}, u_{\xi \xi}^{\star}=\frac{1}{u_{x_{1} x_{1}}}, u_{\eta}^{\star}=-u_{x_{2}}, u_{\eta \eta}^{\star}=-\frac{\operatorname{det} D^{2} u}{u_{x_{1} x_{1}}}, u_{\xi \eta}^{\star}=-\frac{u_{x_{1} x_{2}}}{u_{x_{1} x_{1}}} . \tag{2.2}
\end{equation*}
$$

The partial Legendre transform has been used widely in the study of the Monge-Ampère equation [DS, [F, GP, LS, Li]. Here we apply it to equation (1.3).

In order to derive the equation under the partial Legendre transform, we consider the associated functionals of (1.3)

$$
A_{\theta}(u)= \begin{cases}\int_{\Omega}\left[\operatorname{det} D^{2} u\right]^{\theta} d x, & \theta>0, \quad \theta \neq 1 \\ \int_{\Omega} \log \operatorname{det} D^{2} u d x, & \theta=0 \\ \int_{\Omega} \operatorname{det} D^{2} u \log \operatorname{det} D^{2} u d x, & \theta=1\end{cases}
$$

The case of $\theta=0$ is essentially included in [LZ.
Proposition 2.1. Let $u$ be a uniformly convex solution to (1.3) in $\Omega$. Then in $\Omega^{\star}=\mathcal{P}(\Omega)$, its partial Legendre transform $u^{\star}$ satisfies

$$
\begin{equation*}
w^{\star} w_{\xi \xi}^{\star}+w_{\eta \eta}^{\star}+(\theta-1) w_{\xi}^{\star 2}+\frac{\theta-2}{w^{\star}} w_{\eta}^{\star 2}=0, \tag{2.3}
\end{equation*}
$$

Here $w^{\star}=-\frac{u_{\eta}^{\star} \eta}{u_{\xi \xi}^{\star}}$.
Proof. As

$$
\operatorname{det} D^{2} u=-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}, \quad d x d y=u_{\xi \xi}^{\star} d \xi d \eta
$$

we have

$$
\begin{aligned}
& A_{\theta}(u)=\int_{\Omega^{\star}}\left(-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}\right)^{\theta} u_{\xi \xi}^{\star} d \xi d \eta \\
&=\int_{\Omega^{\star}}\left(-u_{\eta \eta}^{\star}\right)^{\theta} u_{\xi \xi}^{\star} 1-\theta \\
& \\
& A_{0}(u)=\int_{\Omega^{\star}} \log \left(-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}\right) u_{\xi \xi}^{\star} d \xi d \eta=: A_{\theta}^{\star}\left(u^{\star}\right), \theta \in(0,1) ; \\
& A_{1}^{\star}(u)=\int_{\Omega^{\star}}\left(-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}\right) \log \left(-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}\right) u_{\xi \xi}^{\star} d \xi d \eta=: A_{1}^{\star}\left(u^{\star}\right) .
\end{aligned}
$$

Since $u$ is maximal with respect to the functional $A_{\theta}, u^{\star}$ is maximal with respect to the functional $A_{\theta}^{\star}$. It suffices to derive the Euler-Lagrange equation of $A_{\theta}^{\star}$. See [TW1, Z1] for the case of the Legendre transform.

First, we consider $\theta \in(0,1)$. For $\varphi \in C_{0}^{\infty}\left(\Omega^{\star}\right)$, by integration by parts,

$$
\begin{align*}
& \left.\frac{d A_{\theta}^{\star}\left(u^{\star}+t \varphi\right)}{d t}\right|_{t=0}=\int_{\Omega^{\star}}\left[-\theta\left(-u_{\eta \eta}^{\star}\right)^{\theta-1} u_{\xi \xi}^{\star}{ }^{1-\theta} \varphi_{\eta \eta}+(1-\theta)\left(-u_{\eta \eta}^{\star}\right)^{\theta}\left(u_{\xi \xi}^{\star}\right)^{-\theta} \varphi_{\xi \xi}\right] d \xi d \eta \\
& =\int_{\Omega^{\star}}\left\{-\left[\theta\left(-u_{\eta \eta}^{\star}\right)^{\theta-1} u_{\xi \xi}^{\star} 1-\theta\right]_{\eta \eta}+\left[(1-\theta)\left(-u_{\eta \eta}^{\star}\right)^{\theta}\left(u_{\xi \xi}^{\star}\right)^{-\theta}\right]_{\xi \xi}\right\} \varphi d \xi d \eta . \tag{2.4}
\end{align*}
$$

Denote $w^{\star}=-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}$. Then the equation, after the transformation, becomes

$$
-\theta\left(w^{\star \theta-1}\right)_{\eta \eta}+(1-\theta)\left(w^{\star \theta}\right)_{\xi \xi}=0 .
$$

After simplification, this is (2.3). Similarly, for $\varphi \in C_{0}^{\infty}\left(\Omega^{*}\right)$,

$$
\begin{aligned}
\left.\frac{d A_{0}^{\star}\left(u^{\star}+t \varphi\right)}{d t}\right|_{t=0} & =\int_{\Omega^{\star}}-\frac{u_{\xi \xi}^{\star}}{u_{\eta \eta}^{\star}}\left(-\frac{\varphi_{\eta \eta} u_{\xi \xi}^{\star}-u_{\eta \eta}^{\star} \varphi_{\xi \xi}}{u_{\xi \xi}^{\star}{ }^{2}}\right) u_{\xi \xi}^{\star}+\log \left(-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}\right) \varphi_{\xi \xi} d \xi d \eta \\
& =\int_{\Omega^{\star}} \frac{\varphi_{\eta \eta} u_{\xi \xi}^{\star}-u_{\eta \eta}^{\star} \varphi_{\xi \xi}}{u_{\eta \eta}^{\star}}+\log \left(-\frac{u_{\eta \eta}^{\star}}{u_{\xi \xi}^{\star}}\right) \varphi_{\xi \xi} d \xi d \eta
\end{aligned}
$$

and the equation, after the transformation, becomes

$$
-\left[\left(w^{\star}\right)^{-1}\right]_{\eta \eta}+\left(\log w^{\star}\right)_{\xi \xi}=0 .
$$

After simplification, we obtain (2.3). Finally,

$$
\begin{aligned}
\left.\frac{d A_{1}^{\star}\left(u^{\star}+t \varphi\right)}{d t}\right|_{t=0} & =\int_{\Omega^{\star}}\left(1+\log w^{\star}\right)\left(-\frac{\varphi_{\eta \eta} u_{\xi \xi}^{\star}-u_{\eta \eta}^{\star} \varphi_{\xi \xi}}{u_{\xi \xi}^{\star} 2}\right) u_{\xi \xi}^{\star}+w^{\star} \log w^{\star} \varphi_{\xi \xi} d \xi d \eta \\
& =-\int_{\Omega^{\star}}\left(1+\log w^{\star}\right)\left(w^{\star} \varphi_{\xi \xi}-\varphi_{\eta \eta}\right)+w^{\star} \log w^{\star} \varphi_{\xi \xi} d \xi d \eta
\end{aligned}
$$

Then the equation after transformation is

$$
-w_{\xi \xi}^{\star}-\left(\log w^{\star}\right)_{\eta \eta}=0,
$$

which is equivalent to (2.3).
2.2. The interior gradient estimate of (2.3). For simplicity, we change notations in this section and write (2.3) as

$$
\begin{equation*}
u u_{x x}+u_{y y}=(1-\theta) u_{x}^{2}+\frac{2-\theta}{u} u_{y}^{2} \tag{2.5}
\end{equation*}
$$

It is easy to see that this is a quasi-linear equation with the right-hand side depending on the gradient. We prove the following interior gradient estimate.

Theorem 2.2. Assume $u$ is a solution to (2.5) with $\theta \in[0,1]$ on $B_{R}:=B_{R}(0)$ and satisfies $0<\lambda \leq u \leq \Lambda$. Then there exist $\alpha, C>0$ depending on $\lambda, \Lambda, R$ and $\theta$, such that

$$
\begin{equation*}
\int_{B_{R}}|\nabla u|^{3}\left(R^{2}-x^{2}-y^{2}\right)^{\alpha} d V \leq C \tag{2.6}
\end{equation*}
$$

Proof. Let $w=v \phi \eta$, where

$$
v=\sqrt{u_{x}^{2}+u_{y}^{2}+1}, \eta=\left(R^{2}-x^{2}-y^{2}\right)^{\alpha}, \alpha>3
$$

and $\phi=\phi(u)$ is a positive function of $u$ to be determined later.
A direct calculation yields

$$
\begin{equation*}
u w_{x x}+w_{y y}=\left(u v_{x x}+v_{y y}\right) \phi \eta+2\left[u v_{x}(\phi \eta)_{x}+v_{y}(\phi \eta)_{y}\right]+\left[u(\phi \eta)_{x x}+(\phi \eta)_{y y}\right] v \tag{2.7}
\end{equation*}
$$

It is clear that

$$
\begin{align*}
v_{x} & =v^{-1}\left(u_{x} u_{x x}+u_{y} u_{x y}\right), \quad v_{y}=v^{-1}\left(u_{x} u_{x y}+u_{y} u_{y y}\right),  \tag{2.8}\\
v_{x x} & =-v^{-3}\left(u_{x} u_{x x}+u_{y} u_{x y}\right)^{2}+v^{-1}\left(u_{x x}^{2}+u_{x} u_{x x x}+u_{x y}^{2}+u_{y} u_{x x y}\right),  \tag{2.9}\\
v_{y y} & =-v^{-3}\left(u_{x} u_{x y}+u_{y} u_{y y}\right)^{2}+v^{-1}\left(u_{x y}^{2}+u_{x} u_{x y y}+u_{y y}^{2}+u_{y} u_{y y y}\right) . \tag{2.10}
\end{align*}
$$

Differentiating the equation, we have

$$
\begin{align*}
& u_{x} u_{x x}+u u_{x x x}+u_{x y y}=2(1-\theta) u_{x} u_{x x}-\frac{2-\theta}{u^{2}} u_{x} u_{y}^{2}+\frac{2(2-\theta)}{u} u_{y} u_{x y}  \tag{2.11}\\
& u_{y} u_{x x}+u u_{x x y}+u_{y y y}=2(1-\theta) u_{x} u_{x y}-\frac{2-\theta}{u^{2}} u_{y} u_{y}^{2}+\frac{2(2-\theta)}{u} u_{y} u_{y y} \tag{2.12}
\end{align*}
$$

By the Cauchy inequality, we have

$$
\begin{equation*}
\left(u_{x} u_{x x}+u_{y} u_{x y}\right)^{2} \leq\left(v^{2}-1\right)\left(u_{x x}^{2}+u_{x y}^{2}\right), \quad\left(u_{x} u_{x y}+u_{y} u_{y y}\right)^{2} \leq\left(v^{2}-1\right)\left(u_{x y}^{2}+u_{y y}^{2}\right) \tag{2.13}
\end{equation*}
$$

Then by (2.8), (2.9), (2.10), (2.11), (2.12) and (2.13), the first term in (2.7) satisfies

$$
\begin{aligned}
& u v_{x x}+v_{y y} \\
= & u\left[v^{-1}\left(u_{x x}^{2}+u_{x y}^{2}\right)-v^{-3}\left(u_{x} u_{x x}+u_{y} u_{x y}\right)^{2}\right]+v^{-1} u\left(u_{x} u_{x x x}+u_{y} u_{x x y}\right) \\
& \left.+\left[v^{-1}\left(u_{x y}^{2}+u_{y y}^{2}\right)-v^{-3}\left(u_{x} u_{x y}+u_{y} u_{y y}\right)^{2}\right]+v^{-1}\left(u_{x} u_{x y y}+u_{y} u_{y y y}\right)\right) \\
\geq & v^{-1}\left[2(1-\theta) u_{x}\left(u_{x} u_{x x}+u_{y} u_{x y}\right)+\frac{2(2-\theta)}{u} u_{y}\left(u_{x} u_{x y}+u_{y} u_{y y}\right)-\left(v^{2}-1\right) u_{x x}\right] \\
& -v^{-1} \frac{2-\theta}{u^{2}}\left(u_{x}^{2} u_{y}^{2}+u_{y}^{4}\right)+v^{-3}\left[u\left(u_{x x}^{2}+u_{x y}^{2}\right)+u_{x y}^{2}+u_{y y}^{2}\right] \\

2.3. Proof of Theorem 1.1. In order to use the partial Legendre transform, we first recall the modulus of convexity. For a convex function on $\mathbb{R}^{n}$, the modulus of convexity $m_{u}$ of $u$ is defined by

where $t>0$ and $\ell_{z}$ is the supporting function of $u$ at $z$. For a strictly convex function, $m_{u}$ must be a positive function. A result of Heinz [H] implies that in two dimensions, when $\operatorname{det} D^{2} u \geq \lambda>0$, there exists a positive function $C(t)>0$ depending on $\lambda$ such that $m_{u}(t) \geq C(t)>0$. Now for the partial Legendre transform (2.1), we consider the mapping

The following important property is revealed in Li].
Lemma 2.3 ([Li, Lemma 2.1]). There exists a constant $\delta>0$ depending on the modulus of convexity $m_{u}$ defined in (2.16), such that $B_{\delta}(0) \subset \mathcal{P}\left(B_{R}(0)\right)$.

Proof of Theorem 1.1. For any $p \in \Omega$, let $R=\frac{\operatorname{dist}(p, \partial \Omega)}{2}$. Without loss of generality, we assume $\mathcal{P}(p)=0$. It is clear that $\sup _{B_{R}(p)}|D u| \leq C$ for some constant $C$ depending on $R$ and $\sup _{\Omega}|u|$.

By Lemma [2.3, there exists $\delta>0$ such that $B_{\delta}(0) \subset \mathcal{P}\left(B_{R}(p)\right)$. According to Proposition 2.1, $u^{\star}$ satisfies (2.3) in $B_{\delta}(0)$ with

Since we can do partial Legendre transforms of $u$ in any direction, we can obtain the lower bound for the smallest eigenvalue of $D^{2} u$, which implies the boundedness of $D^{2} u$ by (1.4). Then we have all the higher order estimates of $u$.

## 3. The inhomogeneous equations in dimension two

In this section, we will study the interior estimate for the inhomogeneous equation (1.5).
We first recall the regularity theory of the second order elliptic equation in divergence form

where $g=\left(g^{1}, \cdots, g^{n}\right)$ is a vector valued function and $\left\{a_{i j}(x)\right\}$ satisfies

0<\lambda(x)|\xi|^{2} \leq a_{i j}(x) \xi_{i} \xi_{j} \leq \Lambda(x)|\xi|^{2}, \quad \forall \xi \in \mathbb{R}^{n} \backslash\{0\}
$$

and can be discontinuous. When $\left\{a_{i j}(x)\right\}$ is uniformly elliptic, a fundamental regularity theory was established by De Giorgi, Nash, Moser, etc. In [MS, Tr, the classical De Giorgi-NashMoser's theory was extended to degenerate linear elliptic equation with $\lambda(x)^{-1} \in L^{p}(\Omega)$ and $\Lambda(x) \in L^{q}(\Omega)$ where $\frac{1}{p}+\frac{1}{q}<\frac{2}{n}$. We denote by $S_{n}^{+}$the set of $n \times n$ nonnegative definite matrices.

Theorem 3.1 ([Tr, Theorem 4.2]). Let $\left\{a_{i j}\right\}: \Omega \rightarrow S_{n}^{+}$be such that $\lambda^{-1} \in L_{l o c}^{p}(\Omega)$ for some $p>n$. Let $g \in L^{\infty}\left(\Omega ; \mathbb{R}^{n}\right)$ and $h \in L^{q}(\Omega)$. Assume $p$ and $q$ satisfy $\frac{1}{q}+\frac{1}{p}<\frac{2}{n}$. Suppose that $u$ is a subsolution (supersolution) to (3.1) in $B_{R}=B_{R}(y) \subset \Omega$ and that $u \leq 0(u \geq 0)$ on $\partial B_{R}$. Then

$$
\sup _{B_{R}} u(-u) \leq C\left\|\lambda^{-1}\right\|_{L^{p}\left(B_{R}\right)}\left(\|g\|_{L^{\infty}\left(B_{R}\right)} R^{1-\frac{n}{p}}+\|h\|_{L^{q}\left(B_{R}\right)} R^{2-\frac{n}{q}-\frac{n}{p}}\right)
$$

In [LO, the author investigated the linearized Monge-Ampère equation with right hand side $f=D_{i} g^{i}+h$, i.e. $a_{i j}(x)=U^{i j}$ in (3.1). Under the stronger assumption that $\operatorname{det} D^{2} u$ is sufficiently close to a positive constant, he can use the $W^{2, p}$-estimate of the Monge-Ampère equation and Theorem 3.1 to obtain the interior regularity. It was later shown in Le3] that when $n=2$ we only need the determinant to be bounded from above and below.

Now we turn to the fourth order equation (1.5). By the divergence free property of $U^{i j}$, i.e., $\sum_{i} D_{i} U^{i j}=0$, we can rewrite equation (1.5) in divergence form

Note that in dimension two, it holds $\frac{\operatorname{det} D^{2} u}{\Delta u} I \leq U^{i j} \leq \Delta u I$. In view of Theorem 3.1, it suffices to get the $L^{p}$-bound of $\Delta u$ for sufficiently large $p$. In the following, we will use an integral method directly in (1.5) to derive it. Instead of the classical Sobolev inequality, we will need the following Monge-Ampère Sobolev inequality.

Lemma 3.2 ([Le3, Proposition 2.6]). Assume $n=2$. Let $u$ be a smooth, strictly convex function defined in a neighborhood of a bounded domain $\Omega \subset \mathbb{R}^{2}$. Suppose u satisfies

Then for any $\chi>2$ there exists a constant $C>0$, depending only on $\lambda, \Lambda$ and $\chi$, such that

The above inequality is the two dimensional counterpart of the Monge-Ampère Sobolev inequality in higher dimensions derived by Tian and Wang TW.

Theorem 3.3. Assume $n=2$ and $\theta \in[0,1]$. Let $g \in L^{\infty}\left(\Omega ; \mathbb{R}^{n}\right)$ and $h \in L^{q}(\Omega)$. Let $u$ be a uniformly convex smooth solution to equation (3.2) in $B_{R}$ satisfying (3.3). Then for any $p \geq 1$, there exists a constant $C>0$ depending on $\lambda, \Lambda, R, \theta,\|g\|_{L^{\infty}\left(B_{R}\right)},\|h\|_{L^{q}\left(B_{R}\right)}$ and $p$ such that

\|\Delta u\|_{L^{p}\left(B_{R / 2}\right)} \leq C
$$

Proof. We first consider the case $\theta \in[0,1)$. Denote

Then in (3.10), we choose $\beta=\varepsilon_{0}$ and $\chi=\frac{2 p}{\varepsilon_{0}}$ for $p \in\left(\frac{q}{q-1} \varepsilon_{0},+\infty\right)$ to get $\|\Delta u\|_{L^{p}\left(B_{R / 2}\right)} \leq C$.

For $\theta=1$, we know that $w=\ln \operatorname{det} D^{2} u$, and we can obtain the $L^{p}$-bound of $\Delta u$ following the same method used above. Alternatively, we can apply tha Legendre transform to $u$ for the case $\theta=1$ to get the estimate of $D^{2} u$ by the strictly convexity of $u$ with condition (3.3).

Now we establish the higher estimates of $u$ in terms of the $W^{2, p}$-estimate. By chaining together a sequence of balls, in a standard fashion, we know $\Delta u \in L_{\text {loc }}^{p}(\Omega)$ for any fixed $p \in[1,+\infty)$. Then by Theorem 3.1 and the same arguments as [L0, Proposition 6.1] or [Le3, Theorem 1.3], we get the Hölder continuity of $w$ and all the higher order estimates of $u$.

As we mentioned in the introduction, there is another approach to establish the $C^{2}$-estimate from $W^{2, p}$ when $f \in W^{1, q}\left(B_{1}\right)$, which holds in any dimension.

Theorem 3.4. Let $u$ be a uniformly convex smooth solution to equation (1.5) in $B_{1}$ with $\theta=0$ or 1. Assume that $f \in W^{1, q}\left(B_{1}\right)$ for some $q>\frac{n}{2}$. Suppose $u$ satisfies (3.3). Assume that $\|\Delta u\|_{L^{p_{n}}\left(B_{1}\right)}$ is bounded for some $p_{n}>\frac{n(n-1)}{2}$. Then there exists a constant $C>0$ depending on $\lambda, \Lambda,\|\Delta u\|_{L^{p_{n}}\left(B_{1}\right)}$ and $\|f\|_{W^{1, q}\left(B_{1}\right)}$, such that

u^{i j}\left(e^{\frac{1}{2} w} v\right)_{i j}\left(x_{0}\right)=\frac{1}{4} e^{\frac{1}{2} w} u^{i i} w_{i}^{2} u^{k k} w_{k}^{2}+\frac{1}{2} e^{\frac{1}{2} w} u^{i i} w_{i i} v+e^{\frac{1}{2} w} u^{i i} w_{i} v_{i}+e^{\frac{1}{2} w} u^{i i} v_{i i} . \tag{3.15}
\end{equation*}
$$

Note that

$$
\begin{align*}
u^{i i} w_{i} v_{i} & =-u^{i i} u^{k k} u^{l l} u_{i k l} w_{k} w_{l} w_{i}+2 u^{i i} u^{k k} w_{k i} w_{k} w_{i} \\
& =u^{i i} u^{k k} w_{k} w_{i}\left(w_{k i}-\sum_{l} u^{l l} u_{i k l} w_{l}\right)+u^{i i} u^{k k} w_{k i} w_{k} w_{i} . \tag{3.16}
\end{align*}
$$

Combining (3.14), (3.15) and (3.16), we have

u^{i j}\left(e^{\frac{1}{2} w} v\right)_{i j}\left(x_{0}\right)= & u^{i i} u^{k k}\left|w_{i k}-\sum_{l} u^{l l} u_{i k l} w_{l}+\frac{1}{2} w_{i} w_{k}\right|^{2} e^{\frac{1}{2} w}+u^{i i} u^{k k} w_{i k}^{2} e^{\frac{1}{2} w} \\
& -\frac{3}{2} e^{-\frac{1}{2} w} f v+2 e^{-\frac{1}{2} w} u^{k k} f_{k} w_{k} \tag{3.17}
\end{align*}
$$

By (3.12), we have

$$
\begin{equation*}
u^{i j}(\Delta u)_{i j}\left(x_{0}\right)=u^{i i} u^{j j} u_{i j k}^{2}+\Delta w . \tag{3.18}
\end{equation*}
$$

Let $z=e^{\frac{1}{2} w} v+\Delta u$. Note that

$$
\Delta w=\sum_{k} w_{k k} \leq \frac{1}{2}\left(u^{k k}\right)^{2} w_{k k}^{2} e^{\frac{1}{2} w}+\frac{1}{2} u_{k k}^{2} e^{-\frac{1}{2} w} \leq \frac{1}{2}\left(u^{k k}\right)^{2} w_{k k}^{2} e^{\frac{1}{2} w}+\frac{1}{2}(\Delta u)^{2} e^{-\frac{1}{2} w}
$$

Then by (3.17) and (3.18), we have

$$
\begin{align*}
u^{i j} z_{i j}\left(x_{0}\right) & \geq-C|f| v-C\left|f_{k}\right| v-C\left|f_{k}\right|+u^{k k} u^{l l} w_{k l}^{2} e^{\frac{1}{2} w}+\Delta w \\
& \geq-C\left(|f|+\left|f_{k}\right|\right) v-C\left|f_{k}\right|+\left(u^{k k}\right)^{2} w_{k k}^{2} e^{\frac{1}{2} w}-\frac{1}{2}\left(u^{k k}\right)^{2} w_{k k}^{2} e^{\frac{1}{2} w}-\frac{1}{2}(\Delta u)^{2} e^{-\frac{1}{2} w} \\
& \geq-C\left(|f|+\left|f_{k}\right|+\Delta u\right) z \tag{3.19}
\end{align*}
$$

where $C=C(\lambda, \Lambda)$. In the last inequality we used $z \geq \Delta u \geq n\left(\operatorname{det} D^{2} u\right)^{\frac{1}{n}} \geq n \lambda^{\frac{1}{n}}$. Since (3.19) is valid at every point in $B_{1}$, by (3.3), we have the following inequality

D_{j}\left(U^{i j} D_{i} z\right) \geq-g z-C \Delta u z \quad \text { in } B_{1} \tag{3.20}
\end{equation*}
$$

where $g=C\left(|f|+\left|f_{k}\right|\right) \in L^{q}\left(B_{1}\right)$.
Next, we drive the upper bound of $z$ by integration and iteration. Let $\eta \in C_{0}^{\infty}\left(B_{1}\right)$ be a cutoff function. Multiplying (3.20) by $\varphi=\eta^{2} z^{\beta-1}$ with $\beta \geq 2$ and by integration by parts, we have

(\beta-1) \int_{B_{1}} U^{i j} z_{i} z_{j} \eta^{2} z^{\beta-2} d x \leq & -2 \int_{B_{1}} U^{i j} z_{i} \eta_{j} \eta z^{\beta-1} d x+C \int_{B_{1}} \Delta u \cdot \eta^{2} z^{\beta} d x+\int_{B_{1}} g \eta^{2} z^{\beta} d x \\
\leq & \frac{\beta-1}{2} \int_{B_{1}} U^{i j} z_{i} z_{j} \eta^{2} z^{\beta-2} d x+\frac{2}{\beta-1} \int_{B_{1}} U^{i j} \eta_{i} \eta_{j} z^{\beta} d x \\
& +C \int_{B_{1}} \Delta u \cdot \eta^{2} z^{\beta} d x+\int_{B_{1}} g \eta^{2} z^{\beta} d x
\end{aligned}
$$

which implies

$$
\int_{B_{1}} U^{i j}\left(\eta z^{\frac{\beta}{2}}\right)_{i}\left(\eta z^{\frac{\beta}{2}}\right)_{j} d x \leq C \beta\left(\int_{B_{1}} U^{i j} \eta_{i} \eta_{j} z^{\beta} d x+\int_{B_{1}} \Delta u \cdot \eta^{2} z^{\beta} d x+\int_{B_{1}} g \eta^{2} z^{\beta} d x\right)
$$

Then by the Monge-Ampère Sobolev inequality [TW] and $\left(U^{i j}\right) \leq(\Delta u)^{n-1} I$, we have

$$
\begin{equation*}
\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{p}\left(B_{1}\right)}^{2} \leq C_{0} \beta\left(\int_{B_{1}}(\Delta u)^{n-1}|D \eta|^{2} z^{\beta} d x+\int_{B_{1}} \Delta u \cdot \eta^{2} z^{\beta} d x+\int_{B_{1}} g \eta^{2} z^{\beta} d x\right) \tag{3.21}
\end{equation*}
$$

where $p=2^{*}=\frac{2 n}{n-2}$ for $n>2$ and $p>2$ for $n=2$. Then by Hölder's inequality

$$
\int_{B_{1}} g \eta^{2} z^{\beta} d x \leq\left(\int_{B_{1}} g^{q} d x\right)^{\frac{1}{q}}\left(\int_{B_{1}}\left|\eta z^{\frac{\beta}{2}}\right|^{\frac{2 q}{q-1}}\right)^{1-\frac{1}{q}}
$$

Since $q>\frac{n}{2}$, we have $2<\frac{2 q}{q-1}<2^{*}$. By interpolation inequality, we obtain

\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 q}{q-1}}\left(B_{1}\right)} \leq \varepsilon\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{p}\left(B_{1}\right)}+C(n, q) \varepsilon^{-\frac{n}{2 q-n}}\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{2}\left(B_{1}\right)}
$$

Then we choose $\varepsilon=\left(4 C_{0}\|g\|_{L^{q}\left(B_{1}\right)} \beta+1\right)^{-\frac{1}{2}}$. By (3.21),

\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{p}\left(B_{1}\right)}^{2} \leq C \beta^{\alpha}\left(\int_{B_{1}}(\Delta u)^{n-1}|D \eta|^{2} z^{\beta} d x+\int_{B_{1}} \Delta u \cdot \eta^{2} z^{\beta} d x+\int_{B_{1}} \eta^{2} z^{\beta} d x\right) \tag{3.22}
\end{equation*}
$$

where $\alpha=\frac{2 q}{2 q-n}$. Then by Hölder's inequality, we have

$$
\begin{gather*}
\int_{B_{1}}(\Delta u)^{n-1}|D \eta|^{2} z^{\beta} d x \leq\|\Delta u\|_{L^{p_{n}}\left(B_{1}\right)} \cdot\left\||D \eta| z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{1}\right)}}^{2},  \tag{3.23}\\
\int_{B_{1}} \Delta u \cdot \eta^{2} z^{\beta} d x \leq\|\Delta u\|_{L^{p_{n}}\left(B_{1}\right)} \cdot\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-1}}\left(B_{1}\right)}^{2} . \tag{3.24}
\end{gather*}
$$

Combining (3.22), (3.23) and (3.24), we get

$$
\begin{aligned}
\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{p}\left(B_{1}\right)} & \leq C \beta^{\alpha / 2}\left(\left\||D \eta| z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{1}\right)}}+\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-1}\left(B_{1}\right)}}+\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{2}\left(B_{1}\right)}\right) \\
& \leq C \beta^{\alpha / 2}\left(\left\||D \eta| z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{1}\right)}}+\left\|\eta z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{1}\right)}}\right) .
\end{aligned}
$$

Now for any $0<r<R \leq 1$, we choose a cutoff function $\eta \in C_{0}^{\infty}\left(B_{R}\right)$ such that

0 \leq \eta \leq 1, \quad \eta \equiv 1 \text { in } B_{r} \quad \text { and } \quad|D \eta| \leq \frac{2}{R-r}
$$

Then we obtain

\left\|z^{\frac{\beta}{2}}\right\|_{L^{p}\left(B_{r}\right)} \leq \frac{C \beta^{\frac{\alpha}{2}}}{R-r}\left\|z^{\frac{\beta}{2}}\right\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{R}\right)}}
$$

By the assumption $p_{n}>\frac{n(n-1)}{2}$, we know $p>\frac{2 p_{n}}{p_{n}-n+1}$. Denote $\chi=p \frac{p_{n}-n+1}{2 p_{n}}>1$. Then

$$
\begin{equation*}
\|z\|_{L^{\frac{\beta p_{n}}{p_{n}-n+1} \chi_{\left(B_{r}\right)}}} \leq \frac{C^{\frac{2}{\beta}} \beta^{\frac{\alpha}{\beta}}}{(R-r)^{\frac{2}{\beta}}}\|z\|_{L^{\frac{\beta p_{n}}{p_{n}-n+1}\left(B_{R}\right)}} . \tag{3.25}
\end{equation*}
$$

We iterate (3.25) to get the desired estimate. Set

$$
\beta_{i}=2 \chi^{i} \quad \text { and } \quad R_{i}=r+\frac{R-r}{2^{i}}, i=0,1,2, \cdots
$$

i.e.,

$$
\beta_{i}=\chi \beta_{i-1} \text { and } R_{i-1}-R_{i}=\frac{R-r}{2^{i}}, i=1,2, \cdots
$$

By (3.25),

$$
\|z\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}} \chi^{i+1}\left(B_{R_{i+1}}\right)} \leq C^{\sum_{j=0}^{i} \frac{2}{\beta_{j}}} \cdot \prod_{j=0}^{i} \beta_{j}^{\frac{\alpha}{\beta_{j}}} \cdot 4^{\sum_{j=0}^{i} \frac{j}{\beta_{j}}} \frac{1}{(R-r)^{\sum_{j=0}^{i} \frac{2}{\beta_{j}}}} \cdot\|z\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{R}\right)}}
$$

Letting $i \rightarrow \infty$, by Young's inequality, we have

$$
\begin{aligned}
\|z\|_{L^{\infty}\left(B_{r}\right)} & \leq \frac{C}{(R-r)^{\frac{\chi}{x-1}}}\|z\|_{L^{\frac{2 p_{n}}{p_{n}-n+1}\left(B_{R}\right)}} \\
& =\frac{C}{(R-r)^{\frac{\chi}{x-1}}}\|z\|_{L^{2}\left(B_{R}\right)}^{\frac{p_{n}-n+1}{2 p_{n}}} \cdot\|z\|_{L^{\infty}\left(B_{R}\right)}^{\frac{p_{n+n-1}^{2 p_{n}}}{2 p_{n}}} \\
& \leq \frac{1}{2}\|z\|_{L^{\infty}\left(B_{R}\right)}+\frac{C}{(R-r)^{\frac{\chi}{\chi-1} \cdot \frac{2 p_{n}}{p_{n}-n+1}}}\|z\|_{L^{1}\left(B_{R}\right)} .
\end{aligned}
$$

Set $f(t)=\|z\|_{L^{\infty}\left(B_{t}\right)}$ for $t \in(0,1]$. Then for any $0<r<R \leq \bar{R}<1$,

$$
f(r) \leq \frac{1}{2} f(R)+\frac{C}{(R-r)^{\frac{\chi}{x-1}} \cdot \frac{2 p_{n}}{p_{n}-n+1}}\|z\|_{L^{1}\left(B_{\bar{R}}\right)}
$$

We apply Lemma 3.5 below to get

$$
\begin{equation*}
f(r) \leq \frac{C}{(R-r)^{\frac{\chi}{\chi-1} \cdot \frac{2 p_{n}}{p_{n}-n+1}}}\|z\|_{L^{1}\left(B_{\bar{R}}\right)} . \tag{3.26}
\end{equation*}
$$

It remains to show $\|z\|_{L^{1}\left(B_{\bar{R}}\right)} \leq C$. It is clear that $\Delta u \in L^{1}\left(B_{\bar{R}}\right)$, hence it is suffices to estimate the integral of $v$. Let $\eta \in C_{0}^{\infty}\left(B_{1}\right)$ be a cutoff function such that $\eta \equiv 1$ in $B_{\bar{R}}$. Multiplying (1.5) by $\varphi=\eta^{2} w$ and integrating by parts, we have

$$
\int_{B_{1}} U^{i j} w_{i} w_{j} \eta^{2} d x+2 \int_{B_{1}} U^{i j} w_{i} \eta_{j} \eta w d x=\int_{B_{1}} f w \eta^{2} d x
$$

Then by the Cauchy inequality, we get

$$
\begin{aligned}
\frac{1}{2} \int_{B_{1}} U^{i j} w_{i} w_{j} \eta^{2} d x & \leq 2 \int_{B_{1}} U^{i j} \eta_{i} \eta_{j} w^{2} d x+\int_{B_{1}}|f| w \eta^{2} d x \\
& \leq 2 \int_{B_{1}}(\Delta u)^{n-1}|D \eta|^{2} w^{2} d x+\int_{B_{1}}|f| w \eta^{2} d x
\end{aligned}
$$

Hence $\int_{B_{\bar{R}}} u^{k l} w_{k} w_{l} d x \leq C$ follows by $\Delta u \in L^{p_{n}}\left(B_{1}\right), f \in L^{q}\left(B_{1}\right)$. Then we complete the proof by choosing $r=\frac{1}{2}$ and $R=\bar{R}$ in (3.26).

Lemma 3.5 ([HL, Lemma 4.3]). Let $f(t) \geq 0$ be bounded in $\left[\tau_{0}, \tau_{1}\right]$ with $\tau_{0} \geq 0$. Suppose for $\tau_{0} \leq t<s \leq \tau_{1}$ we have

$$
f(t) \leq \beta f(s)+\frac{A}{(s-t)^{\alpha}}+B
$$

for some $\beta \in[0,1)$. Then for any $\tau_{0} \leq t<s \leq \tau_{1}$ there holds

$$
f(t) \leq C(\alpha, \beta)\left\{\frac{A}{(s-t)^{\alpha}}+B\right\}
$$

Remark 3.6. Note that for $n=2$, we have already got an $L^{p}$-bound of $\Delta u$ in Theorem 3.3 for all $p \in[1,+\infty)$. However, it is still unknown how to obtain $L^{p}$-bound of $\Delta u$ when $n \geq 3$ by the integral method used in Theorem 3.3. We also do not know how to obtain higher estimates for other exponents $\theta$ by the above method.

## 4. An interior estimate in higher dimensions

In this section, we will prove Theorem 1.5. By [CG, Ca, it suffices to get the interior estimates on the upper and lower bound of $\operatorname{det} D^{2} u$. Note that there exists a constant $c_{n}>0$ such that

$$
\begin{equation*}
\frac{\operatorname{det} D^{2} u}{c_{n} \cdot \Delta u} I \leq U^{i j} \leq c_{n}(\Delta u)^{n-1} I \tag{4.1}
\end{equation*}
$$

In view of (3.2) and (4.1), we first consider the following degenerate linear elliptic equation

$$
\begin{equation*}
-D_{j}\left(a_{i j}(x) D_{i} u\right)+c(x) u=f(x) \quad \text { in } \Omega \tag{4.2}
\end{equation*}
$$

Lemma 4.1. Assume $\left\{a_{i j}(x)\right\}$ satisfies

$$
\begin{equation*}
\frac{d(x)}{\lambda(x)} \leq a_{i j}(x) \leq \lambda(x)^{n-1} \quad \text { in } B_{1} \tag{4.3}
\end{equation*}
$$

where $\lambda(x) \in L^{p}\left(B_{1}\right)$, $d^{-1} \in L^{q}\left(B_{1}\right)$. Assume $c(x), f(x) \in L^{p_{0}}\left(B_{1}\right)$. Let $u \in W^{1, p}\left(B_{1}\right)$ be a subsolution in the following sense:

$$
\begin{equation*}
\int_{B_{1}} a_{i j} D_{i} u D_{j} \varphi+c u \varphi d x \leq \int_{B_{1}} f \varphi d x \quad \text { for any } \varphi \in W_{0}^{1, p}\left(B_{1}\right) \text { and } \varphi \geq 0 \tag{4.4}
\end{equation*}
$$

Suppose $p, q$ and $p_{0}$ satisfy $\frac{n}{p}+\frac{1}{q}<\frac{2}{n}$ and $p_{0} \geq \frac{p}{n-1}$. Then

$$
\sup _{B_{1 / 2}} u \leq C\left(\left\|u^{+}\right\|_{L^{1}\left(B_{1}\right)}+\|f\|_{L^{p_{0}}\left(B_{1}\right)}\right)
$$

where $C$ depends only on $p,\|\lambda\|_{L^{p}\left(B_{1}\right)},\left\|d^{-1}\right\|_{L^{q}\left(B_{1}\right)}$ and $\|c\|_{L^{p_{0}}\left(B_{1}\right)}$.
Proof. For some $k>0$ and $m>0$, set $\bar{u}=u^{+}+k$ and

$$
\bar{u}_{m}= \begin{cases}\bar{u}, & u<m \\ k+m, & u \geq m\end{cases}
$$

Let $\eta \in C_{0}^{\infty}\left(B_{1}\right)$. We choose a test function $\varphi=\eta^{2}\left(\bar{u}_{m}^{\beta} \bar{u}-k^{\beta+1}\right) \in W_{0}^{1, p}\left(B_{1}\right)$ for some $\beta \geq 0$ to be determined later. Substituting $\varphi$ into (4.4), we have

$$
\begin{aligned}
& \beta \int_{B_{1}} a_{i j} D_{i} \bar{u} D_{j} \bar{u}_{m} \bar{u}_{m}^{\beta-1} \bar{u} \eta^{2} d x+\int_{B_{1}} a_{i j} D_{i} \bar{u} D_{j} \bar{u} \bar{u}_{m}^{\beta} \eta^{2} d x \\
& \quad \leq-2 \int_{B_{1}} a_{i j} D_{i} \bar{u} D_{j} \eta \bar{u}_{m}^{\beta} \bar{u} \eta d x+\int_{B_{1}}\left(|c| \eta^{2} \bar{u}_{m}^{\beta} \bar{u}^{2}+|f| \eta^{2} \bar{u}_{m}^{\beta} \bar{u}\right) d x .
\end{aligned}
$$

Note that $D \bar{u}=D \bar{u}_{m}$ in $\{u<m\}$ and $D \bar{u}_{m}=0$ in $\{u \geq m\}$. By the Cauchy inequality, we have

$$
\begin{aligned}
& \beta \int_{B_{1}} a_{i j} D_{i} \bar{u}_{m} D_{j} \bar{u}_{m} \bar{u}_{m}^{\beta-1} \bar{u} \eta^{2} d x+\int_{B_{1}} a_{i j} D_{i} \bar{u} D_{j} \bar{u} \bar{u}_{m}^{\beta} \eta^{2} d x \\
& \quad \leq \frac{1}{2} \int_{B_{1}} a_{i j} D_{i} \bar{u} D_{j} \bar{u} \bar{u}_{m}^{\beta} \eta^{2} d x+4 \int_{B_{1}} a_{i j} D_{i} \eta D_{j} \eta \bar{u}_{m}^{\beta} \bar{u}^{2} d x+\int_{B_{1}}\left(|c| \eta^{2} \bar{u}_{m}^{\beta} \bar{u}^{2}+|f| \eta^{2} \bar{u}_{m}^{\beta} \bar{u}\right) d x
\end{aligned}
$$

Then by (4.3)

$$
\begin{align*}
& \beta \int_{B_{1}} \frac{d}{\lambda(x)}\left|D \bar{u}_{m}\right|^{2} \bar{u}_{m}^{\beta} \eta^{2} d x+\frac{1}{2} \int_{B_{1}} \frac{d}{\lambda(x)}|D \bar{u}|^{2} \bar{u}_{m}^{\beta} \eta^{2} d x \\
\leq & \beta \int_{B_{1}} a_{i j} D_{i} \bar{u}_{m} D_{j} \bar{u}_{m} \bar{u}_{m}^{\beta-1} \bar{u} \eta^{2} d x+\frac{1}{2} \int_{B_{1}} a_{i j} D_{i} \bar{u} D_{j} \bar{u} \bar{u}_{m}^{\beta} \eta^{2} d x \\
\leq & 4 \int_{B_{1}} \lambda(x)^{n-1}|D \eta|^{2} \bar{u}_{m}^{\beta} \bar{u}^{2} d x+\int_{B_{1}} c_{0} \eta^{2} \bar{u}_{m}^{\beta} \bar{u}^{2} d x \tag{4.5}
\end{align*}
$$

where $c_{0}=|c|+\frac{|f|}{k}$. Choose $k=\|f\|_{L^{p_{0}}\left(B_{1}\right)}$ if $f$ is not identically 0 . Otherwise choose arbitrary $k>0$ and let $k \rightarrow 0^{+}$. Let $w=\bar{u}_{m}^{\frac{\beta}{2}} \bar{u}$. There holds

$$
|D w|^{2}=\left|\frac{\beta}{2} \bar{u}_{m}^{\frac{\beta}{2}-1} \bar{u}_{m} D \bar{u}_{m}+\bar{u}_{m}^{\frac{\beta}{2}} D \bar{u}\right|^{2} \leq(1+\beta)\left(\beta \bar{u}_{m}^{\beta}\left|D \bar{u}_{m}\right|^{2}+\bar{u}_{m}^{\beta}|D \bar{u}|^{2}\right)
$$

Therefore by (4.5)

$$
\int_{B_{1}} \frac{d}{\lambda(x)}|D w|^{2} \eta^{2} d x \leq 8(1+\beta) \int_{B_{1}} \lambda(x)^{n-1}|D \eta|^{2} w^{2} d x+2(1+\beta) \int_{B_{1}} c_{0} w^{2} \eta^{2} d x
$$

By $|D(w \eta)|^{2} \leq 2|D w|^{2} \eta^{2}+2|D \eta|^{2} w^{2}$, we have

$$
\begin{aligned}
\int_{B_{1}} \frac{d}{\lambda(x)}|D(w \eta)|^{2} d x & \leq \int_{B_{1}}\left(\frac{2 d}{\lambda(x)}+16(1+\beta) \lambda(x)^{n-1}\right)|D \eta|^{2} w^{2} d x+4(1+\beta) \int_{B_{1}} c_{0} w^{2} \eta^{2} d x \\
\text { 4.6) } & \leq 18(1+\beta) \int_{B_{1}} \lambda(x)^{n-1}|D \eta|^{2} w^{2} d x+4(1+\beta) \int_{B_{1}} c_{0} w^{2} \eta^{2} d x .
\end{aligned}
$$

Next, we deal with the $\lambda(x)$ in the above estimate. By the assumptions $\lambda \in L^{p}\left(B_{1}\right)$ and $d^{-1} \in L^{q}\left(B_{1}\right)$, we have $\lambda d^{-1} \in L^{\frac{p q}{p+q}}\left(B_{1}\right)$. By Hölder's inequality, we have

$$
\begin{align*}
\|D(w \eta)\|_{L^{\frac{2 p q}{p q+p+q}}\left(B_{1}\right)}^{2} & \leq\left\|\lambda d^{-1}\right\|_{L^{\frac{p q}{p+q}}\left(B_{1}\right)} \cdot \int_{B_{1}} \frac{1}{\lambda(x) d^{-1}}|D(w \eta)|^{2} d x  \tag{4.7}\\
\int_{B_{1}} \lambda(x)^{n-1}|D \eta|^{2} w^{2} d x & \leq\|\lambda\|_{L^{p}\left(B_{1}\right)} \cdot\|w D \eta\|_{L^{\frac{2 p}{p-n+1}\left(B_{1}\right)}}^{2}  \tag{4.8}\\
\int_{B_{1}} c_{0} w^{2} \eta^{2} d x & \leq\left\|c_{0}\right\|_{L^{p_{0}}\left(B_{1}\right)} \cdot\left(\int_{B_{1}}(\eta w)^{\frac{2 p_{0}}{p_{0}-1}} d x\right)^{1-\frac{1}{p_{0}}} \tag{4.9}
\end{align*}
$$

Combining (4.6)-(4.9), we get

$$
\begin{aligned}
\|D(w \eta)\|_{L^{\frac{2 p q}{p q+p+q}\left(B_{1}\right)}} & \leq C(1+\beta)^{\frac{1}{2}}\left(\|w D \eta\|_{L^{\frac{2 p}{p-n+1}\left(B_{1}\right)}}+\|w \eta\|_{L^{\frac{2 p_{0}}{p_{0}-1}\left(B_{1}\right)}}\right) \\
& \leq C(1+\beta)^{\frac{1}{2}}\left(\|w D \eta\|_{L^{\frac{2 p}{p-n+1}\left(B_{1}\right)}}+\|w \eta\|_{L^{\frac{2 p}{p-n+1}\left(B_{1}\right)}}\right)
\end{aligned}
$$

for $C$ depending on $\|\lambda\|_{L^{p}\left(B_{1}\right)},\left\|d^{-1}\right\|_{L^{q}\left(B_{1}\right)},\|c\|_{L^{p_{0}}\left(B_{1}\right)}$. Here we used $p_{0} \geq \frac{n-1}{p}$. By the Sobolev inequality

$$
\|w \eta\|_{L^{\alpha}\left(B_{1}\right)} \leq C(1+\beta)^{\frac{1}{2}}\left(\|w D \eta\|_{L^{\frac{2 p}{p-n+1}\left(B_{1}\right)}}+\|w \eta\|_{L^{\frac{2 p}{p-n+1}\left(B_{1}\right)}}\right)
$$

where

$$
\begin{equation*}
\frac{1}{\alpha}=\frac{p q+p+q}{2 p q}-\frac{1}{n} \tag{4.10}
\end{equation*}
$$

Now for any $0<r<R \leq 1$, we choose a cutoff function $\eta \in C_{0}^{\infty}\left(B_{R}\right)$ such that

$$
0 \leq \eta \leq 1, \quad \eta \equiv 1 \text { in } B_{r} \quad \text { and } \quad|D \eta| \leq \frac{2}{R-r}
$$

Then we obtain

$$
\|w\|_{L^{\alpha}\left(B_{r}\right)} \leq \frac{C(1+\beta)^{\frac{1}{2}}}{R-r}\|w\|_{L^{\frac{2 p}{p-n+1}\left(B_{R}\right)}}
$$

By (4.10) and the assumption $\frac{n}{p}+\frac{1}{q}<\frac{2}{n}$, we have $\alpha>\frac{2 p}{p-n+1}$. We can do the iteration as follows.
Recalling the definition of $w$, we have

$$
\left\|\bar{u}_{m}^{\frac{\beta}{2}} \bar{u}\right\|_{L^{\alpha}\left(B_{r}\right)} \leq \frac{C(1+\beta)^{\frac{1}{2}}}{R-r}\left\|\bar{u}_{m}^{\frac{\beta}{2}} \bar{u}\right\|_{L^{\frac{2 p}{p-n+1}\left(B_{R}\right)}}
$$

Set $\gamma=\beta+2 \geq 2$. By $\bar{u}_{m} \leq \bar{u}$, we obtain

$$
\left\|\bar{u}_{m}^{\frac{\gamma}{2}}\right\|_{L^{\alpha}\left(B_{r}\right)} \leq \frac{C \gamma^{\frac{1}{2}}}{R-r}\left\|\bar{u}^{\frac{\gamma}{2}}\right\|_{L^{\frac{2 p}{p-n+1}\left(B_{R}\right)}}
$$

Letting $m \rightarrow \infty$, we get

$$
\left\|\bar{u}^{\frac{\gamma}{2}}\right\|_{L^{\alpha}\left(B_{r}\right)} \leq \frac{C \gamma^{\frac{1}{2}}}{R-r}\left\|\bar{u}^{\frac{\gamma}{2}}\right\|_{L^{\frac{2 p}{p-n+1}\left(B_{R}\right)}}
$$

i.e.,

$$
\|\bar{u}\|_{L^{\frac{\gamma}{2} \alpha}\left(B_{r}\right)} \leq \frac{(C \gamma)^{\frac{1}{\gamma}}}{(R-r)^{\frac{2}{\gamma}}}\|\bar{u}\|_{L^{\frac{\gamma}{2} \frac{2 p}{p-n+1}\left(B_{R}\right)}}
$$

Denote $\chi=\alpha \cdot \frac{p-n+1}{2 p}>1$. Then

$$
\begin{equation*}
\|\bar{u}\|_{L^{\frac{\gamma p}{p-n+1}}{ }_{\left(B_{r}\right)}} \leq \frac{(C \gamma)^{\frac{1}{\gamma}}}{(R-r)^{\frac{2}{\gamma}}}\|\bar{u}\|_{L^{\frac{\gamma p}{p-n+1}\left(B_{R}\right)}} \tag{4.11}
\end{equation*}
$$

We iterate (4.11) to get the desired estimate. Set

$$
\gamma_{i}=2 \chi^{i} \quad \text { and } \quad R_{i}=r+\frac{R-r}{2^{i}}, i=0,1,2, \cdots
$$

i.e.,

$$
\gamma_{i}=\chi \gamma_{i-1} \text { and } R_{i-1}-R_{i}=\frac{R-r}{2^{i}}, i=1,2, \cdots
$$

By (4.11),

$$
\|\bar{u}\|_{L^{\frac{2 p}{p-n+1}} \chi^{i+1}\left(B_{\left.R_{i+1}\right)}\right.} \leq C^{\sum_{j=0}^{i} \frac{1}{\gamma_{j}}} \cdot \prod_{j=0}^{i} \gamma_{j}^{\frac{1}{\gamma_{j}}} \cdot 4^{\sum_{j=0}^{i} \frac{j}{\gamma_{j}}} \frac{1}{(R-r)^{\sum_{j=0}^{i} \frac{2}{\gamma_{j}}}} \cdot\|\bar{u}\|_{L^{\frac{2 p}{p-n+1}\left(B_{R}\right)}}
$$

Letting $i \rightarrow \infty$, by Young's inequality, we have

$$
\begin{aligned}
\|\bar{u}\|_{L^{\infty}\left(B_{r}\right)} & \leq \frac{C}{(R-r)^{\frac{x}{x-1}}}\|\bar{u}\|_{L^{\frac{2 p}{p-n+1}\left(B_{R}\right)}} \\
& =\frac{C}{(R-r)^{\frac{x}{x-1}}}\|\bar{u}\|_{L^{1}\left(B_{R}\right)}^{\frac{p-n+1}{2 p}} \cdot\|\bar{u}\|_{L^{\infty}\left(B_{R}\right)}^{\frac{p+n-1}{2 p}} \\
& \leq \frac{1}{2}\|\bar{u}\|_{L^{\infty}\left(B_{R}\right)}+\frac{C}{(R-r)^{\frac{x}{x-1} \cdot \frac{2 p}{p-n+1}}}\|\bar{u}\|_{L^{1}\left(B_{R}\right)}
\end{aligned}
$$

Set $f(t)=\|\bar{u}\|_{L^{\infty}\left(B_{t}\right)}$ for $t \in(0,1]$. Then for any $0<r<R \leq 1$

$$
f(r) \leq \frac{1}{2} f(R)+\frac{C}{(R-r)^{\frac{\chi}{x-1} \cdot \frac{2 p}{p-n+1}}}\|\bar{u}\|_{L^{1}\left(B_{1}\right)}
$$

We apply Lemma 3.5 to get

$$
f(r) \leq \frac{C}{(R-r)^{\frac{\chi}{\chi-1} \cdot \frac{2 p}{p-n+1}}\|\bar{u}\|_{L^{1}\left(B_{1}\right)} . . . . . . . .}
$$

The lemma follows by choosing $r=\frac{1}{2}$ and $R=1$.
Now we can use Lemma 4.1 to obtain the interior estimates for (1.1). For simplicity, we only consider the homogeneous equation.

Proof of Theorem 1.5. Denote $a_{i j}=U^{i j}, \lambda=\Delta u$ and $d=\operatorname{det} D^{2} u$. Firstly, we consider the case $0 \leq \theta<1$. We apply Lemma 4.1 to equation (1.3), which yields

$$
\sup _{B_{1 / 2}} w \leq C\|w\|_{L^{1}\left(B_{1}\right)} \leq C\|w\|_{L^{\frac{q}{1-\theta}\left(B_{1}\right)}}
$$

Since $w=\left(\operatorname{det} D^{2} u\right)^{-(1-\theta)} \in L^{\frac{q}{1-\theta}}\left(B_{1}\right)$, we know $\sup _{B_{1 / 2}}\left\{\left(\operatorname{det} D^{2} u\right)^{-1}\right\} \leq C$. For the upper bound of the determinant, we set $w=\frac{1}{v}$. A direct calculation yields

$$
w_{i}=-\frac{v_{i}}{v^{2}}, \quad w_{i j}=\frac{2 v_{i} v_{j}}{v^{3}}-\frac{v_{i j}}{v^{2}}
$$

Then $v$ satisfies

$$
0=U^{i j} w_{i j}=\frac{2}{v^{3}} U^{i j} v_{i} v_{j}-\frac{1}{v^{2}} U^{i j} v_{i j} \geq-\frac{1}{v^{2}} U^{i j} v_{i j}
$$

i.e.,

$$
-D_{i}\left(U^{i j} D_{j} v\right) \leq 0 \quad \text { in } B_{1} .
$$

Similarly, we use Lemma 4.1 to obtain

$$
\sup _{B_{1 / 2}} v \leq C\|v\|_{L^{1}\left(B_{1}\right)} \leq C\|v\|_{L^{\frac{p}{n(1-\theta)}\left(B_{1}\right)}},
$$

which implies $\sup _{B_{1 / 2}} \operatorname{det} D^{2} u \leq C$.
Next, we consider the case $\theta=1$. Write $w=\log d$, where $d \in L^{\frac{p}{n}}\left(B_{1}\right)$. Then we have

$$
w_{i}=\frac{d_{i}}{d}, \quad w_{i j}=-\frac{d_{i} d_{j}}{d^{2}}+\frac{d_{i j}}{d}
$$

which yields

$$
0=U^{i j} w_{i j}=-\frac{1}{d^{2}} U^{i j} d_{i} d_{j}+\frac{1}{d} U^{i j} d_{i j} \leq \frac{1}{d} U^{i j} d_{i j}
$$

i.e.,

$$
-D_{i}\left(U^{i j} D_{j} d\right) \leq 0 \quad \text { in } B_{1}
$$

Similarly, write $w=-\log z$ with $z=\left(\operatorname{det} D^{2} u\right)^{-1} \in L^{q}\left(B_{1}\right)$. We have

$$
w_{i}=-\frac{z_{i}}{z}, \quad w_{i j}=\frac{z_{i} z_{j}}{z^{2}}-\frac{z_{i j}}{z}
$$

which means

$$
0=U^{i j} w_{i j}=\frac{1}{z^{2}} U^{i j} z_{i} z_{j}-\frac{1}{z} U^{i j} z_{i j} \geq-\frac{1}{z} U^{i j} z_{i j}
$$

i.e.,

$$
-D_{i}\left(U^{i j} D_{j} z\right) \leq 0 \quad \text { in } B_{1}
$$

Then we use Lemma 4.1 to obtain the bounds of $\operatorname{det} D^{2} u$.
Once we have the determinant estimates, all the interior estimates follow.
Remark 4.2. To get the upper bound of $\operatorname{det} D^{2} u$, we only need $u \in W^{2, p}\left(B_{1}\right)$ with $p>\frac{n^{2}}{2}$. In fact, by taking $\operatorname{det} D^{2} u=v^{\frac{1}{1-\theta}}(0 \leq \theta<1)$, where $v$ defined as the proof of Theorem 1.5, condition (4.3) in Lemma 4.1 becomes

$$
\frac{v^{\frac{1}{1-\theta}}}{\lambda(x)} \leq a_{i j}(x) \leq \lambda(x)^{n-1}
$$

Then the upper bound can be obtained by similar arguments as in Lemma 4.1 without assumption on $\left(\operatorname{det} D^{2} u\right)^{-1}$.

Remark 4.3. We can also consider the inhomogeneous equation

$$
\begin{equation*}
D_{j}\left(U^{i j} D_{i} w\right)=f \quad \text { in } B_{1} \tag{4.12}
\end{equation*}
$$

where $f \in L^{p_{0}}\left(B_{1}\right)$. For the lower bound of det $D^{2}$, if we assume $p_{0} \geq \frac{p}{n-1}$, we can apply Lemma 4.1 to (4.12) directly for all $\theta \in[0,1)$. However, for the upper bound of $\operatorname{det} D^{2} u, v=\frac{1}{w}$ satisfies

$$
\begin{equation*}
-D_{j}\left(U^{i j} D_{i} v\right) \leq f v^{2} \quad \text { in } B_{1} . \tag{4.13}
\end{equation*}
$$

Even we assume $p_{0}=\infty$, we only know $f v \in L^{\frac{p}{n(1-\theta)}}\left(B_{1}\right)$. Then we can only apply Lemma 4.1 to the equation (4.13) to get the upper bound of $\operatorname{det} D^{2} u$ when $\frac{1}{n} \leq \theta<1$. Hence, we have all the higher interior estimates for $\theta \in\left[\frac{1}{n}, 1\right)$. Note that the case $\theta=0$ (Abreu's equation) and $\theta=\frac{1}{n+2}$ (affine mean curvature equation) are not included.

Finally, we prove a Liouville type theorem.
Proof of Corollary 1.6. For $u$ in any $B_{R} \subset \mathbb{R}^{n}$, define $u_{R}(x)=\frac{1}{R^{2}} u(R x)$. Tthen we know that $U_{R}^{i j}\left(w_{R}\right)_{i j}=0$ in $B_{1}$. Since $u$ satisfies (1.7), we know $u_{R}$ satisfies

$$
\int_{B_{1}}\left|D^{2} u_{R}\right|^{p}+\left(\operatorname{det} D^{2} u_{R}\right)^{-q} d x \leq C
$$

Applying Theorem 1.5 to $u_{R}$, we find that there exists a $C>0$ independent of $R$, such that $\left\|u_{R}\right\|_{C^{4, \alpha}\left(B_{1 / 2}\right)} \leq C$. In particular, we know that $\left\|D^{3} u_{R}\right\|_{L^{\infty}\left(B_{1 / 2}\right)} \leq C$. Hence

$$
\left\|D^{3} u(R x)\right\|_{L^{\infty}\left(B_{\frac{1}{2}}\right)} \leq \frac{C}{R}
$$

i.e.,

$$
\left\|D^{3} u(x)\right\|_{L^{\infty}\left(B_{\frac{R}{2}}\right)} \leq \frac{C}{R}
$$

Let $R \rightarrow+\infty$, we have $D^{3} u \equiv 0$, which means $u$ is a quadratic function.
