# ANALYTIC SMOOTHING EFFECT OF THE TIME VARIABLE FOR THE SPATIALLY HOMOGENEOUS LANDAU EQUATION

#### Abstract

In this work, we study the Cauchy problem of the spatially homogeneous Landau equation with hard potentials in a close-to-quilibrium framework. We prove that the solution to the Cauchy problem enjoys the analytic regularizing effect of the time variable with an $L^{2}$ initial datum for positive time. So that the smoothing effect of Cauchy problem for the spatially homogeneous Landau equation with hard potentials is exactly same as heat equation.


## 1. Introduction

In this work, we are concerned the following Cauchy problem of spatially homogenous Landau equation

\end{array}\right.

where $F=F(t, v) \geq 0$ is the density distribution function at time $t \geq 0$, with the velocity variable $v \in \mathbb{R}^{3}$. The Landau bilinear collision operator is defined by

Q(G, F)(v)=\sum_{i, j=1}^{3} \partial_{i}\left(\int_{\mathbb{R}^{3}} a_{i j}\left(v-v_{*}\right)\left[G\left(v_{*}\right) \partial_{j} F(v)-\partial_{j} G\left(v_{*}\right) F(v)\right] d v_{*}\right),
$$

where

$$
a_{i j}(v)=\left(\delta_{i j}|v|^{2}-v_{i} v_{j}\right)|v|^{\gamma}, \quad \gamma \geq-3
$$

is a symmetric non-negative matrix such that $a_{i j}(v) v_{i} v_{j}=0$. Here, $\gamma$ is a parameter which leads to the classification of the hard potential if $\gamma>0$, Maxwellian molecules if $\gamma=0$, soft potential if $\gamma \in]-3,0[$ and Coulombian potential if $\gamma=-3$.

The Landau equation was introduced as a limit of the Boltzmann equation when the collisions become grazing in [10, 21]. The global existence, uniqueness of classical solutions for the spatially homogeneous Landau equation with hard potentials, regularizing effects and large-time behavior have been addressed by Desvillettes and Villani [8, 20]. Moreover, they proved the smoothness of the solution in $C^{\infty}(] 0, \infty\left[; \mathcal{S}\left(\mathbb{R}^{3}\right)\right)$. Carrapatoso [5] proved an exponential in time convergence to the equilibrium. In [1], the authors proved the solution is analytic of $v$ variables for any $t>0$ and the Gevrey regularity in [2,3].

Let $\mu$ be the Maxwellian distribution

[^0]we shall linearize the Landau equation (1.1) around $\mu$ with the fluctuation of the density distribution function

since $Q(\mu, \mu)=0$, the Cauchy problem (1.1) for $f=f(t, v)$ takes the form

with $F_{0}(v)=\mu+\sqrt{\mu} f_{0}(v)$, where

In the Maxwellian molecules case, Villani [20] has proved a linear functional inequality between entropy and entropy dissipation by constructive methods, from which one deduces an exponential convergence of the solution to the Maxwellian equilibrium in relative entropy, which in turn implies an exponential convergence in $L^{1}$-distance. In [9], Desvillettes and Villani have proved a functional inequality for entropy dissipation is not linear, from which one obtains a polynomial in time convergence of solutions towards the equilibrium in relative entropy, which implies the same type of convergence in $L^{1}$-distance. In [13], the authors studied the spatially homogeneous Landau equation and non-cutoff Boltzmann equation in a close-to-quilibrium framework and proved the Gelfand-Shilov smoothing effect(see also $[15,17]$ ). Guo [11] constructed global classical solutions for the spatially inhomogeneous Landau equation near a global Maxwellian in a periodic box, and the smoothness of the solutions have been studied in [4, 16, 12]. The analytic smoothing effect of the velocity variable for the nonlinear Landau equation has been studied in $[14,18]$. The variant regularity results in a close to equilibrium setting were considered by [19, 6, 7].

Let us give the definition of analytic function spaces $\mathcal{A}(\Omega)$ where $\Omega \subset \mathbb{R}^{n}$ is a open domain. We say that $u \in \mathcal{A}(\Omega)$ if $u \in C^{\infty}(\Omega)$ and there exists a constant $C$ such that for all multi-indices $\alpha \in \mathbb{N}^{n}$,

Remark that, by using the Sobolev embedding, we can replace the $L^{\infty}$ norm by the $L^{2}$ norm, or norm in any Sobolev space in the above definition.

In this work, we consider the Cauchy problem (1.2) with $\gamma \geq 0$, show that the solution of the Cauchy problem (1.2) with initial datum in $L^{2}\left(\mathbb{R}^{3}\right)$ enjoys the analytic regularizing effect of time variable. Our main result reads as follow.
Theorem 1.1. Assume $f_{0} \in L^{2}\left(\mathbb{R}^{3}\right)$ and $T>0$, let $f$ be the solution of the Cauchy problem (1.2) with $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)}$ small enough. Then there exists a constant $C>0$ such that for any $k \in \mathbb{N}$, we have

\left.\left.\left\|\partial_{t}^{k} f(t)\right\|_{L^{2}\left(\mathbb{R}^{3}\right)} \leq \frac{C^{k+1}}{t^{k}} k!, \quad \forall t \in\right] 0, T\right] \tag{1.3}

Remark 1.2. In the paper [14], for $f_{0} \in L^{2}\left(\mathbb{R}^{3}\right)$ with $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)} \leq \epsilon$ small enough, the solution of the Cauchy problem (1.2) satisfies $f(t) \in \mathcal{A}\left(\mathbb{R}^{3}\right)$ for all $0<t \leq T$, i. e. there exists a constant $C>0$ such that

$$

which implies that $f \in C^{\infty}(] 0, T\left[; \mathcal{A}\left(\mathbb{R}^{3}\right)\right)$, so that we prove only the estimate (1.3) for the smooth solution of (1.2). Combine with the results of [14], we have proved that, if $f$ is the solution of the nonlinear Cauchy problem (1.2) with $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)}$ small enough, then we have

$$

which implies that, the smoothing effect properties of Cauchy problem for the spatially homogeneous Landau equation with hard potentials is exactly same as semilinear heat equation.

## 2. Analysis of Landau collision operator

The operators $\mathcal{L}_{1}, \mathcal{L}_{2}$ and $\Gamma$ are defined in [11] as follow:

\mathcal{L}_{2} f=-\sum_{i, j=1}^{3} \mu^{-\frac{1}{2}} \partial_{i}\left\{\mu\left[a_{i j} *\left(\mu^{\frac{1}{2}} \partial_{j} f+\mu^{\frac{1}{2}} \frac{v_{j}}{2} f\right)\right]\right\} \\
\Gamma(f, g)= \\
\sum_{i, j=1}^{3}\left\{\partial_{i}\left[\left(a_{i j} *\left(\mu^{\frac{1}{2}} f\right)\right) \partial_{j} g\right]-\left[a_{i j} *\left(\frac{v_{i}}{2} \mu^{\frac{1}{2}} f\right)\right] \partial_{j} g\right. \\
\left.-\partial_{i}\left[\left(a_{i j} *\left(\mu^{\frac{1}{2}} \partial_{j} f\right)\right) g\right]+\left[a_{i j} *\left(\frac{v_{i}}{2} \mu^{\frac{1}{2}} \partial_{j} f\right)\right] g\right\}
\end{gather*}

Since the use of a different normalization for the Maxwellian, these representations are different in a few places by a factor of $\frac{1}{2}$ from those in [11]. The linear operator $\mathcal{L}$ is nonnegative.

For later use, we derive some results for the linear operator $\mathcal{L}$. For simplicity, with $s \in \mathbb{R}$, we define

where $\bar{a}_{i j}=a_{i j} * \mu$.
From Corollary 1 in [11], there exists $C_{1}>0$ such that

\|f\|_{L_{A}^{2}}^{2} \geq C_{1}\left(\left\|\mathbf{P}_{v} \nabla f\right\|_{2, \gamma / 2}^{2}+\left\|\left(\mathbf{I}-\mathbf{P}_{v}\right) \nabla f\right\|_{2,1+\gamma / 2}^{2}+\|f\|_{2,1+\gamma / 2}^{2}\right)
$$

where for any vector-valued function $g=\left(g_{1}, g_{2}, g_{3}\right)$, define the projection to the vector $v \in \mathbb{R}^{3}$ as

Noticing that $f=\mathbf{P}_{v} \nabla f+\left(\mathbf{I}-\mathbf{P}_{v}\right) \nabla f$, we have

From representation (2.1), we can get the coercivity of the operator $\mathcal{L}_{1}$.
Lemma 2.1. Let $f \in \mathcal{S}\left(\mathbb{R}^{3}\right)$, then there exists a constant $C_{2}>0$ such that

$$

Proof. By the representation (2.1) and integrating by parts, we have

\left(\mathcal{L}_{1} f, f\right)_{L^{2}}= & \sum_{i, j=1}^{3}\left[\left(\left(a_{i j} * \mu\right) \partial_{j} f, \partial_{i} g\right)_{L^{2}}+\frac{1}{4}\left(\left(a_{i j} * \mu\right) v_{i} v_{j} f, g\right)_{L^{2}}\right] \\
& -\frac{1}{2} \sum_{i, j=1}^{3}\left(\partial_{i}\left[\left(a_{i j} * \mu\right) v_{j}\right] f, g\right)_{L^{2}} \\
= & \|f\|_{L_{A}^{2}}-\frac{1}{2} \sum_{i, j=1}^{3}\left(\partial_{i}\left[\left(a_{i j} * \mu\right) v_{j}\right] f, f\right)_{L^{2}} .
\end{aligned}
$$

Using

it follows that

\sum_{i, j=1}^{3} \int_{\mathbb{R}^{3}} \partial_{i}\left[\left(a_{i j} * \mu\right) v_{j}\right] f^{2} d v & =\sum_{i, j=1}^{3} \int_{\mathbb{R}^{3}} \partial_{i}\left(\int_{\mathbb{R}^{3}} a_{i j}\left(v-v^{\prime}\right) v_{j}^{\prime} \mu\left(v^{\prime}\right) d v^{\prime}\right) f^{2} d v \\
& =\sum_{i, j=1}^{3} \int_{\mathbb{R}^{3}} \partial_{i}\left[a_{i j} *\left(v_{j} \mu\right)\right] f^{2} d v
\end{aligned}

Expanding $\partial_{i} a_{i j}\left(v-v^{\prime}\right)$ to get

we can deduce that

and using

we can conclude that

& =\frac{1}{2}\left|\sum_{i, j=1}^{3} \int_{\mathbb{R}^{3}} \int_{\mathbb{R}^{3}} \partial_{i} a_{i j}\left(v-v^{\prime}\right) v_{j}^{\prime} \mu\left(v^{\prime}\right) d v^{\prime} f^{2}(v) d v\right| \\
& \leq \frac{1}{2} \sum_{i, j=1}^{3} \sum_{l=1}^{3}\left|\int_{\mathbb{R}^{3}} \int_{\mathbb{R}^{3}} v_{l}^{\prime} v_{j}^{\prime} \mu\left(v^{\prime}\right) \int_{0}^{1} \partial_{l} \partial_{i} a_{i j}\left(v-s v^{\prime}\right) d s d v^{\prime} f^{2}(v) d v\right| \\
& \leq C_{2} \int_{\mathbb{R}^{3}}(1+|v|)^{\gamma} f^{2}(v) d v .
\end{aligned}
$$

We thus complete the proof of the lemma 2.1.

We recall the trilinear estimate, which has been addressed in [14].
Lemma 2.2. ( [14] ) Let $F, G, H \in \mathcal{S}\left(\mathbb{R}^{3}\right)$, then there exists a constant $C_{3}>0$ such that

Let $F=\sqrt{\mu}, G=f, H=g$ and $F=f, G=\sqrt{\mu}, H=g$ in lemma 2.2, then we have the following estiamtes for the operators $\mathcal{L}_{1}$ and $\mathcal{L}_{2}$.
Corollary 2.3. Let $f, g \in \mathcal{S}\left(\mathbb{R}^{3}\right)$, then there exists a constant $C_{4}>0$ such that

## 3. Energy estimates

For $g \in \mathcal{S}\left(\mathbb{R}^{3}\right)$, we need the following interpolation inequality, for all $0<\delta<1$

From Hölder's inequality and inequality (2.2), it follows that

& \|g\|_{2, \gamma / 2}^{2}=\int_{\mathbb{R}^{3}}(1+|v|)^{\gamma} g^{\frac{2 \gamma}{\gamma+2}}(v) g^{\frac{4}{\gamma+2}}(v) d v \\
& \leq\|g\|_{2, \gamma / 2+1}^{\frac{2 \gamma}{\gamma+2}}\|g\|_{L^{2}}^{\frac{4}{\gamma+2}} \leq\left(\frac{1}{C_{1}}\|g\|_{L_{A}^{2}}\right)^{\frac{2 \gamma}{\gamma+2}}\|g\|_{L^{2}}^{\frac{4}{\gamma+2}}
\end{aligned}
$$

then by using the Yong inequality

and $\gamma \geq 0$, we get

\left(\frac{1}{C_{1}}\|g\|_{L_{A}^{2}}\right)^{\frac{2 \gamma}{\gamma+2}}\|g\|_{L^{2}}^{\frac{4}{\gamma+2}} & \leq \frac{\gamma}{\gamma+2} \delta\|g\|_{L_{A}^{2}}^{2}+\frac{2}{\gamma+2} C_{1}^{-\gamma} \delta^{-\gamma / 2}\|g\|_{L^{2}}^{2} \\
& \leq \delta\|g\|_{L_{A}^{2}}^{2}+C_{1}^{-\gamma} \delta^{-\gamma / 2}\|g\|_{L^{2}}^{2}
\end{aligned}

Let $C_{\delta}=C_{1}^{-\gamma} \delta^{-\gamma / 2}$, then it follows that (3.1) holds.
We study now the energy estimates of solution of Cauchy problem (1.2), we have
Lemma 3.1. Assume $f_{0} \in L^{2}\left(\mathbb{R}^{3}\right)$ and $T>0$, let $f$ be the solution of the Cauchy problem (1.2) with $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)}$ small enough. Then there exists a constant $B_{0}>0$ such that

\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)}^{2}+\|f\|_{L^{2}\left([0, T] ; L_{A}^{2}\left(\mathbb{R}^{3}\right)\right)}^{2} \leq B_{0}^{2}\left\|f_{0}\right\|_{L^{2}\left(\mathbb{R}^{3}\right)}^{2} \leq \epsilon^{2} B_{0}^{2} \tag{3.2}
\end{equation*}

We will take $\epsilon$ small such that $0<\epsilon B_{0} \leq 1$.
Proof. By (1.2), we have that

\frac{1}{2} \frac{d}{d t}\|f\|_{L^{2}}^{2}+\left(\mathcal{L}_{1} f, f\right)_{L^{2}}=(\Gamma(f, f), f)_{L^{2}}-\left(\mathcal{L}_{2} f, f\right)_{L^{2}}
$$

Using lemma 2.1 and taking $\delta=\frac{1}{8 C_{2}}$ in (3.1), for all $0 \leq t \leq T$, we can conclude

\left(\mathcal{L}_{1} f, f\right)_{L^{2}} \geq\|f\|_{L_{A}^{2}}^{2}-C_{2}\|f\|_{2, \gamma / 2}^{2} \geq \frac{7}{8}\|f\|_{L_{A}^{2}}^{2}-\tilde{C}_{2}\|f\|_{L^{2}}^{2}
$$

and $\tilde{C}_{2}$ depends on $C_{1}$. Since $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)} \leq \epsilon$, using lemma 2.2 and taking $\epsilon$ such that $C_{3} \epsilon \leq \frac{1}{8}$, for all $0 \leq t \leq T$, we have

(\Gamma(f, f), f)_{L^{2}} \leq C_{3}\|f\|_{L^{2}}\|f\|_{L_{A}^{2}}^{2} \leq \frac{1}{8}\|f\|_{L_{A}^{2}}^{2}
$$

corollary 2.3 and Hölder's inequality implies

\left|\left(\mathcal{L}_{2} f, f\right)_{L^{2}}\right| \leq C_{4}\|f\|_{L^{2}}\|f\|_{L_{A}^{2}} \leq \frac{1}{8}\|f\|_{L_{A}^{2}}^{2}+2 C_{4}^{2}\|f\|_{L^{2}}^{2}
$$

Combining the above estimates, one has

$$

integrating from 0 to $t$ to get

\end{equation*}

then by Gronwall inequality, we get for $0 \leq t \leq T$

Substituting (3.4) into (3.3) and taking $B_{0} \geq \sqrt{\left(2 \tilde{C}_{2}+4 C_{4}^{2}\right) T} e^{2\left(2 \tilde{C}_{2}+4 C_{4}^{2}\right) T}$, one can obtain

Lemma 3.2. Assume $f_{0} \in L^{2}\left(\mathbb{R}^{3}\right)$ and $T>0$, let $f$ be the solution of the Cauchy problem (1.2) with $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)}$ small enough. Then there exists a constant $B_{1}>0$ such that

## 4. Proof of main Theorem

In this section, we shall show the analytic regularity of time variable for $t>0$. We construct the following estimate, from which we can deduce the inequality (1.3) directly.

Proposition 4.1. Assume $f_{0} \in L^{2}\left(\mathbb{R}^{3}\right)$ and $T>0$, let $f$ be the solution of the Cauchy problem (1.2) with $\|f\|_{L^{\infty}\left([0, T] ; L^{2}\left(\mathbb{R}^{3}\right)\right)}$ small enough. Then there exists $a$ constant $B>0$ such that, for any $k \in \mathbb{N}_{+}$

& \quad \leq 4\left(e^{4 \tilde{C}_{3} T} 4 \tilde{C}_{3} T+1\right)\left(A_{1}+A_{2}\right) B^{2(k-2)}((k-2)!)^{2}
\end{aligned}
$$

We prove then

$$
\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{\infty}\left([0, T], L^{2}\right)}^{2}+\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, T], L_{A}^{2}\right)}^{2} \leq B^{2(k-1)}((k-2)!)^{2}
$$

if we choose the constant $B$ such that

$$
4\left(e^{4 \tilde{C}_{3} T} 4 \tilde{C}_{3} T+1\right)\left(A_{1}+A_{2}\right) \leq B^{2}
$$

so that the constant $B$ depends only on $C_{1}, C_{2}, C_{3}, C_{4}, T$ and small $\epsilon$. We finish the proof of proposition 4.1.

## 5. Proofs of technical Lemmas

Before give the proof of lemma 4.2, lemma 4.3 and lemma 4.4, we need the following lemma

Lemma 5.1. For all $k \in \mathbb{N}, k \geq 5$, we have

$$
\begin{equation*}
\sum_{2 \leq j \leq k-3} \frac{k(k-1)}{j(j-1)(k-j-1)(k-j-2)} \leq 12 \tag{5.1}
\end{equation*}
$$

Proof. Without loss of generality, we may assume $k-1$ is even, then the summation can be rewritten as

$$
\sum_{2 \leq j \leq \frac{k-3}{2}} \frac{k(k-1)}{j(j-1)(k-1-j)(k-2-j)}+\sum_{\frac{k-1}{2} \leq j \leq k-3} \frac{k(k-1)}{j(j-1)(k-1-j)(k-2-j)} .
$$

For the first term in above, since $j \leq \frac{k-3}{2}$, we have $k-j \geq \frac{k+3}{2}$. Then it follows that

$$
\sum_{2 \leq j \leq \frac{k-3}{2}} \frac{k(k-1)}{j(j-1)(k-1-j)(k-2-j)} \leq \sum_{2 \leq j \leq \frac{k-3}{2}} \frac{4}{j(j-1)} \leq 4
$$

For the second term, by $j \geq \frac{k-1}{2}$, we have

$$
\sum_{\frac{k-1}{2} \leq j \leq k-3} \frac{k(k-1)}{j(j-1)(k-1-j)(k-2-j)} \leq \sum_{\frac{k-1}{2} \leq j \leq k-3} \frac{8}{(k-1-j)(k-2-j)} \leq 8
$$

Thus (5.1) holds true.

## Proof of Lemma 4.2

For $k \geq 2$, by (1.2), one has

$$
\begin{aligned}
\partial_{t}^{k} f & =\partial_{t}\left(\partial_{t}^{k-1} f\right)=-\mathcal{L}\left(\partial_{t}^{k-1} f\right)+\partial_{t}^{k-1} \Gamma(f, f) \\
& =-\mathcal{L}\left(\partial_{t}^{k-1} f\right)+\sum_{0 \leq j \leq k-1} C_{k-1}^{j} \Gamma\left(\partial_{t}^{j} f, \partial_{t}^{k-1-j} f\right)
\end{aligned}
$$

Then we have

$$
\begin{aligned}
k \int_{0}^{t} \tau^{2 k-1}\left\|\partial_{\tau}^{k} f\right\|_{L^{2}}^{2} d \tau= & k \sum_{0 \leq j \leq k-1} C_{k-1}^{j} \int_{0}^{t} \tau^{2 k-1}\left(\Gamma\left(\partial_{\tau}^{j} f, \partial_{\tau}^{k-1-j} f\right), \partial_{\tau}^{k} f\right)_{L^{2}} \\
& -k \int_{0}^{t} \tau^{2 k-1}\left(\mathcal{L}\left(\partial_{\tau}^{k-1} f\right), \partial_{\tau}^{k} f\right)_{L^{2}} d \tau \\
= & S_{1}+S_{2}
\end{aligned}
$$

Using lemma 2.2, we can conclude

$$
\begin{aligned}
\left|S_{1}\right| \leq & C_{3} k \\
& \sum_{0 \leq j \leq k-1} C_{k-1}^{j} \int_{0}^{t}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{2}}\left\|\tau^{k-1-j} \partial_{\tau}^{k-1-j} f\right\|_{L_{A}^{2}}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L_{A}^{2}} d \tau \\
\leq & 4 C_{3}^{2} k^{2}\left(\sum_{0 \leq j \leq k-1} C_{k-1}^{j}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{\infty}\left([0, t] ; L^{2}\right)}\left\|\tau^{k-1-j} \partial_{\tau}^{k-1-j} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}\right)^{2} \\
& +\frac{1}{16}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}
\end{aligned}
$$

From (4.3), one can obtain

$$
\begin{align*}
& \sum_{0 \leq j \leq k-1} C_{k-1}^{j}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{\infty}\left([0, t] ; L^{2}\right)}\left\|\tau^{k-1-j} \partial_{\tau}^{k-1-j} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)} \\
\leq & \sum_{0 \leq j \leq k-1} C_{k-1}^{j} B^{j-1}(j-2)!B^{k-2-j}(k-3-j)!  \tag{5.2}\\
\leq & B^{k-3}(k-3!)\left(\sum_{2 \leq j \leq k-3} \frac{k(k-1)}{j(j-1)(k-1-j)(k-2-j)}+6\right)
\end{align*}
$$

Substituting (5.1) into (5.2) we get

$$
\sum_{0 \leq j \leq k-1} C_{k-1}^{j}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{\infty}\left([0, t] ; L^{2}\right)}\left\|\tau^{k-1-j} \partial_{\tau}^{k-1-j} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)} \leq 18 B^{k-3}(k-3)!
$$

from which we can conclude

$$
\left|S_{1}\right| \leq \frac{1}{16}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}+C_{6}\left(B^{k-3}(k-2)!\right)^{2}
$$

with $C_{6}$ depends only on $C_{1}, C_{2}, C_{3}, C_{4}$ and $T$, where we use $\frac{k}{k-2} \leq 3$.
For the term $S_{2}$, using corollary 2.3 and (4.3), we have

$$
\begin{aligned}
\left|S_{2}\right| \leq & C_{4} k \int_{0}^{t}\left(\left\|\tau^{k-1} \partial_{\tau}^{k-1} f\right\|_{L^{2}}+\left\|\tau^{k-1} \partial_{\tau}^{k-1} f\right\|_{L_{A}^{2}}\right)\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L_{A}^{2}} d \tau \\
\leq & 4 C_{4}^{2} k^{2}\left(T\left\|\tau^{k-1} \partial_{\tau}^{k-1} f\right\|_{L^{\infty}\left([0, t] ; L^{2}\right)}^{2}+\left\|\tau^{k-1} \partial_{\tau}^{k-1} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}\right) \\
& +\frac{1}{16}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2} \\
\leq & 4 C_{4}^{2} k^{2}(T+1)\left(B^{k-2}(k-3)!\right)^{2}+\frac{1}{16}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2} \\
\leq & C_{7}\left(B^{k-2}(k-2)!\right)^{2}+\frac{1}{16}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}
\end{aligned}
$$

with $C_{7}$ depends only on $C_{1}, C_{2}, C_{3}, C_{4}$ and $T$.

Taking $A_{1}=C_{6}+C_{7}$, so that $A_{1}$ depends only on $C_{1}, C_{2}, C_{3}, C_{4}$ and $T$, then combining $S_{1}$ and $S_{2}$, we get

$$
k \int_{0}^{t} \tau^{2 k-1}\left\|\partial_{\tau}^{k} f\right\|_{L^{2}}^{2} d \tau \leq \frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}+A_{1}\left(B^{k-2}(k-2)!\right)^{2}
$$

## Proof of Lemma 4.3

Using Hölder's inequality and (4.3), we have

$$
\begin{aligned}
& C_{3} \sum_{1 \leq j \leq k-1} C_{k}^{j} \int_{0}^{t}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{2}}\left\|\tau^{k-j} \partial_{\tau}^{k-j} f\right\|_{L_{A}^{2}}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L_{A}^{2}} d \tau \\
& \leq 2 C_{3}^{2}\left(\sum_{1 \leq j \leq k-1} C_{k}^{j}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{\infty}\left([0, t] ; L^{2}\right)}\left\|\tau^{k-j} \partial_{\tau}^{k-j} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}\right)^{2} \\
& \quad+\frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2} \\
& \leq 2 C_{3}^{2}\left(B^{k-2}(k-2)!\right)^{2}\left(\sum_{2 \leq j \leq k-3} \frac{k(k-1)}{j(j-1)(k-j)(k-j-1)}+6\right)^{2} \\
& \quad+\frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2} \\
& \leq 2 C_{3}^{2}\left(B^{k-2}(k-2)!\right)^{2}\left(\sum_{2 \leq j \leq k-3} \frac{k(k-1)}{j(j-1)(k-j-1)(k-j-2)}+6\right)^{2} \\
& \quad+\frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2} .
\end{aligned}
$$

Then from (5.1), we can get

$$
\begin{aligned}
& C_{3} \sum_{1 \leq j \leq k-1} C_{k}^{j} \int_{0}^{t}\left\|\tau^{j} \partial_{\tau}^{j} f\right\|_{L^{2}}\left\|\tau^{k-j} \partial_{\tau}^{k-j} f\right\|_{L_{A}^{2}}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L_{A}^{2}} d \tau \\
& \leq \frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}+A_{2}\left(B^{k-2}(k-2)!\right)^{2},
\end{aligned}
$$

with $A_{2}$ depends only on $C_{1}, C_{2}, C_{3}, C_{4}$ and $T$.

## Proof of Lemma 4.4

For the inequality (4.6), using Hölder's inequality and (3.2), one has

$$
\begin{aligned}
& C_{3} \int_{0}^{t}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}}\|f\|_{L_{A}^{2}}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L_{A}^{2}} d \tau \\
& \leq \frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}+2 C_{3}^{2}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{\infty}\left([0, t] ; L^{2}\right)}^{2} \int_{0}^{t}\|f\|_{L_{A}^{2}}^{2} d \tau \\
& \leq \frac{1}{8}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}+2 C_{3}^{2} B_{0}^{2} \epsilon^{2}
\end{aligned}
$$

For the inequality (4.7), the inequality (3.2) implies

$$
\begin{aligned}
\int_{0}^{t}\|f\|_{L^{2}}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L_{A}^{2}}^{2} d \tau & \leq\|f\|_{L^{\infty}\left([0, T] ; L^{2}\right)}\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2} \\
& \leq B_{0} \epsilon\left\|\tau^{k} \partial_{\tau}^{k} f\right\|_{L^{2}\left([0, t] ; L_{A}^{2}\right)}^{2}
\end{aligned}
$$
