# ON A TWISTED JACQUET MODULE OF GL( $2 n$ ) OVER A FINITE FIELD

#### Abstract

Let $F$ be a finite field and $G=\mathrm{GL}(2 n, F)$. In this paper, we explicitly describe a certain twisted Jacquet module of an irreducible cuspidal representation of $G$.


## 1. Introduction

Let $F$ be a finite field and $G=\operatorname{GL}(n, F)$. Let $P$ be a parabolic subgroup of $G$ with Levi decomposition $P=M N$. Let $\pi$ be any irreducible finite dimensional complex representation of $G$ and $\psi$ be an irreducible representation of $N$. Let $\pi_{N, \psi}$ be the sum of all irreducible representations of $N$ inside $\pi$, on which $\pi$ acts via the character $\psi$. It is easy to see that $\pi_{N, \psi}$ is a representation of the subgroup $M_{\psi}$ of $M$, consisting of those elements in $M$ which leave the isomorphism class of $\psi$ invariant under the inner conjugation action of $M$ on $N$. The space $\pi_{N, \psi}$ is called the twisted Jacquet module of the representation $\pi$. It is an interesting question to understand for which irreducible representations $\pi$, the twisted Jacquet module $\pi_{N, \psi}$ is non-zero and to understand its structure as a module for $M_{\psi}$.

In [2], [1], inspired by the work of Prasad in [6], we studied the structure of a certain twisted Jacquet module of a cuspidal representation of GL $(4, F)$ and GL $(6, F)$. Based on our calculations, we had conjectured the structure of the module for $\mathrm{GL}(2 n, F)$ (see Section 1 in [1]). For a more detailed introduction and the motivation to study the problem, we refer the reader to Section 1 in [2].

Before we state our result, we set up some notation. Let $F$ be a finite field and $F_{n}$ be the unique field extension of $F$ of degree $n$. Let $G=\mathrm{GL}(2 n, F)$ and $P=M N$ be the standard maximal parabolic subgroup of $G$ corresponding to the partition $(n, n)$. We have, $M \simeq \mathrm{GL}(n, F) \times \mathrm{GL}(n, F)$ and $N \simeq \mathrm{M}(n, F)$. We let $\pi=\pi_{\theta}$ to be an irreducible cuspidal representation of $G$ associated to the regular character $\theta$. Let $\psi$ be any character of $N \simeq \mathrm{M}(n, F)$ and $\psi_{0}$ be a fixed non-trivial character of $F$. We let

Let $\psi_{A}: N \rightarrow \mathbb{C}^{\times}$be the character given by

\end{array}\right]\right)=\psi_{0}(\operatorname{Tr}(A X))
$$

[^0]Let $H_{A}=M_{1} \times M_{2}$ where $M_{1}$ is the Mirabolic subgroup of GL $(n, F)$ and $M_{2}=$ $w_{0} M_{1}{ }^{T} w_{0}{ }^{-1}$ where

1 & \ldots & 0

Let $U$ be the subgroup of unipotent matrices in $\mathrm{GL}(2 n, F)$ and $U_{A}=U \cap H_{A}$. Then, we get $U_{A} \simeq U_{1} \times U_{2}$ where $U_{1}$ and $U_{2}$ are the upper triangular unipotent subgroups of $\mathrm{GL}(n, F)$. For $k=1,2$, let $\mu_{k}: U_{k} \rightarrow \mathbb{C}^{\times}$be the non-degenerate character of $U_{k}$ given by

& & 1 & \ddots & \vdots \\

\end{array}\right]\right)=\psi_{0}\left(x_{12}+x_{23}+\cdots+x_{(n-1), n}\right)
$$

Let $\mu: U_{A} \rightarrow \mathbb{C}^{\times}$be the character of $U_{A}$ given by

\mu(u)=\mu_{1}\left(u_{1}\right) \mu_{2}\left(u_{2}\right)
$$

where $u=\left[\begin{array}{cc}u_{1} & 0 \\ 0 & u_{2}\end{array}\right] \in U_{A}$.
Theorem 1.1. Let $\theta$ be a regular character of $F_{n}^{\times}$and $\pi=\pi_{\theta}$ be an irreducible cuspidal representation of $G$. Then

$$
\left.\pi_{N, \psi_{A}} \simeq \theta\right|_{F \times} \otimes \operatorname{ind}_{U_{A}}^{H_{A}} \mu
$$

as $M_{\psi_{A}}$ modules.

## 2. Preliminaries

In this section, we mention some preliminary results that we need in our paper.
2.1. Character of a Cuspidal Representation. Let $F$ be the finite field of order $q$ and $G=\mathrm{GL}(m, F)$. Let $F_{m}$ be the unique field extension of $F$ of degree $m$. A character $\theta$ of $F_{m}^{\times}$is called a "regular" character, if under the action of the Galois group of $F_{m}$ over $F, \theta$ gives rise to $m$ distinct characters of $F_{m}^{\times}$. It is a well known fact that the cuspidal representations of $\mathrm{GL}(m, F)$ are parametrized by the regular characters of $F_{m}^{\times}$. To avoid introducing more notation, we mention below only the relevant statements on computing the character values that we have used. We refer the reader to Section 6 in [4] for more precise statements on computing character values.

Theorem 2.1. Let $\theta$ be a regular character of $F_{m}^{\times}$. Let $\pi=\pi_{\theta}$ be an irreducible cuspidal representation of $\mathrm{GL}(m, F)$ associated to $\theta$. Let $\Theta_{\theta}$ be its character. If $g \in \mathrm{GL}(m, F)$ is such that the characteristic polynomial of $g$ is not a power of a polynomial irreducible over $F$. Then, we have

$$
\Theta_{\theta}(g)=0 .
$$

Theorem 2.2. Let $\theta$ be a regular character of $F_{m}^{\times}$. Let $\pi=\pi_{\theta}$ be an irreducible cuspidal representation of $\mathrm{GL}(m, F)$ associated to $\theta$. Let $\Theta_{\theta}$ be its character. Suppose that $g=s . u$ is the Jordan decomposition of an element $g$ in $\operatorname{GL}(m, F)$. If $\Theta_{\theta}(g) \neq 0$, then the semisimple element $s$ must come from $F_{m}^{\times}$. Suppose that $s$
comes from $F_{m}^{\times}$. Let $z$ be an eigenvalue of $s$ in $F_{m}$ and let $t$ be the dimension of the kernel of $g-z$ over $F_{m}$. Then

$$
\Theta_{\theta}(g)=(-1)^{m-1}\left[\sum_{\alpha=0}^{d-1} \theta\left(z^{q^{\alpha}}\right)\right]\left(1-q^{d}\right)\left(1-\left(q^{d}\right)^{2}\right) \cdots\left(1-\left(q^{d}\right)^{t-1}\right)
$$

where $q^{d}$ is the cardinality of the field generated by $z$ over $F$, and the summation is over the distinct Galois conjugates of $z$.

See Theorem 2 in [6] for this version.
2.2. Kirillov Representation. Let $F$ be a finite field with $q$ elements and $G=$ $\mathrm{GL}(n, F)$. Let $P_{n}$ be the Mirabolic subgroup of $G$ and let $U$ be the subgroup of unipotent matrices of $G$. In this section, we recall the Kirillov representation of the Mirabolic subgroup $P_{n}$ of $G$. Let $\psi_{0}$ be a non-trivial character of $F$ and let $\psi: U \rightarrow \mathbb{C}^{\times}$be the non-degenerate character of $U$ given by

$$
\psi\left(\left[\begin{array}{ccccc}
1 & x_{12} & x_{13} & \cdots & x_{1, n} \\
& 1 & x_{23} & \cdots & x_{2, n} \\
& & 1 & \cdots & \vdots \\
& & & \ddots & x_{(n-1), n} \\
& & & & 1
\end{array}\right]\right)=\psi_{0}\left(x_{12}+x_{23}+\cdots+x_{(n-1), n}\right) .
$$

Then, $\mathcal{K}=\operatorname{ind}_{U}^{P_{n}} \psi$ is called the Kirillov representation of $P_{n}$.

Theorem 2.3. $\mathcal{K}=\operatorname{ind}_{U}^{P_{n}} \psi$ is an irreducible representation of $P_{n}$.
We refer the reader to Theorem 5.1 in [3] for a proof.
2.3. Multiplicity one Theorem for $\mathrm{GL}(n, F)$ over a finite field $F$. We continue with the notation of section 2.2 .

Theorem 2.4. Let $\mathcal{G}=\operatorname{ind}_{U}^{G}(\psi)$. The representation $\mathcal{G}$ of $G$ is multiplicity free.
We refer to Theorem 6.1 in [3] for a proof.
2.4. Twisted Jacquet Module. In this section, we recall the character and the dimension formula of the twisted Jacquet module of a representation $\pi$.

Let $G=\operatorname{GL}(k, F)$ and $P=M N$ be a parabolic subgroup of $G$. Let $\psi$ be a character of $N$. For $m \in M$, let $\psi^{m}$ be the character of $N$ defined by $\psi^{m}(n)=$ $\psi\left(m n m^{-1}\right)$. Let

$$
V(N, \psi)=\operatorname{Span}_{\mathbb{C}}\{\pi(n) v-\psi(n) v \mid n \in N, v \in V\}
$$

and

$$
M_{\psi}=\left\{m \in M \mid \psi^{m}(n)=\psi(n), \forall n \in N\right\} .
$$

Clearly, $M_{\psi}$ is a subgroup of $M$ and it is easy to see that $V(N, \psi)$ is an $M_{\psi}$-invariant subspace of $V$. Hence, we get a representation $\left(\pi_{N, \psi}, V / V(N, \psi)\right)$ of $M_{\psi}$. We call $\left(\pi_{N, \psi}, V / V(N, \psi)\right)$ the twisted Jacquet module of $\pi$ with respect to $\psi$. We write $\Theta_{N, \psi}$ for the character of $\pi_{N, \psi}$.
Proposition 2.5. Let $(\pi, V)$ be a representation of $\mathrm{GL}(k, F)$ and $\Theta_{\pi}$ be the character of $\pi$. We have

$$
\Theta_{N, \psi}(m)=\frac{1}{|N|} \sum_{n \in N} \Theta_{\pi}(m n) \overline{\psi(n)}
$$

We refer the reader to Proposition 2.3 in [2] for a proof.

Remark 2.6. Taking $m=1$, we get the dimension of $\pi_{N, \psi}$. To be precise, we have

$$
\operatorname{dim}_{\mathbb{C}}\left(\pi_{N, \psi}\right)=\frac{1}{|N|} \sum_{n \in N} \Theta_{\pi}(n) \overline{\psi(n)}
$$

2.5. $q$-Hypergeometric Identity. In this section, we record a certain $q$-identity from [5] which we use in calculating the dimension of the twisted Jacquet module. Before we state it, we set up some notation. Let $\mathrm{M}(n, m, r, q)$ be the set of all $n \times m$ matrices of rank $r$ over the finite field $F$ of order $q$ and $(a ; q)_{n}$ be the $q$-Pochhammer symbol defined by

$$
(a ; q)_{n}=\prod_{i=0}^{n-1}\left(1-a q^{i}\right)
$$

Proposition 2.7. Let $a$ be an integer greater than or equal to $2 n$. Then

$$
\sum_{r \geq 0} \mathrm{M}(n, n, r, q)(q ; q)_{a-r}=q^{n^{2}} \frac{(q ; q)_{a-n}^{2}}{(q ; q)_{a-2 n}}
$$

We refer the reader to Lemma 2.1 in [5] for a proof of the above proposition in a more general set up.

## 3. Dimension of the Twisted Jacquet Module

Let $\pi=\pi_{\theta}$ be an irreducible cuspidal representation of $G$ corresponding to the regular character $\theta$ of $F_{2 n}^{\times}$and $\Theta_{\theta}$ be its character. In this section, we calculate the dimension of $\pi_{N, \psi_{A}}$, where

$$
A=\left[\begin{array}{cccc}
1 & 0 & \ldots & 0 \\
0 & 0 & \ldots & 0 \\
\vdots & \vdots & \ddots & \vdots \\
0 & 0 & \ldots & 0
\end{array}\right]
$$

Throughout, we write $\mathrm{M}(n, m, r, q)$ denote the set of $n \times m$ matrices of rank $r$ over the finite field $F$ of cardinality $q$. For $\alpha \in F$ and $0 \leq r \leq n$, consider the subset $Y_{n, r}^{\alpha}$ of $\mathrm{M}(n, F)$ given by

$$
Y_{n, r}^{\alpha}=\{X \in \mathrm{M}(n, F) \mid \operatorname{Rank}(X)=r, \operatorname{Tr}(A X)=\alpha\}
$$

Lemma 3.1. We have

$$
|\mathrm{M}(n, n, r, q)|=q^{r}|\mathrm{M}(n, n-1, r, q)|+\left(q^{n}-q^{r-1}\right)|\mathrm{M}(n, n-1, r-1, q)| .
$$

Proof. Let $S=q^{r}|\mathrm{M}(n, n-1, r, q)|+\left(q^{n}-q^{r-1}\right)|\mathrm{M}(n, n-1, r-1, q)|$. It is well known that

$$
|\mathrm{M}(n, m, r, q)|=\prod_{j=0}^{r-1} \frac{\left(q^{n}-q^{j}\right)\left(q^{m}-q^{j}\right)}{\left(q^{r}-q^{j}\right)}
$$

Thus, we have

$$
\begin{aligned}
S & =q^{r} \prod_{j=0}^{r-1} \frac{\left(q^{n}-q^{j}\right)\left(q^{n-1}-q^{j}\right)}{\left(q^{r}-q^{j}\right)}+\left(q^{n}-q^{r-1}\right) \prod_{j=0}^{r-2} \frac{\left(q^{n}-q^{j}\right)\left(q^{n-1}-q^{j}\right)}{\left(q^{r-1}-q^{j}\right)} \\
& =\prod_{j=0}^{r-1} \frac{\left(q^{n}-q^{j}\right)\left(q^{n}-q^{j+1}\right)}{\left(q^{r}-q^{j}\right)}+\left(q^{n}-q^{r-1}\right) \prod_{j=0}^{r-2} \frac{\left(q^{n}-q^{j}\right)\left(q^{n}-q^{j+1}\right)}{\left(q^{r}-q^{j+1}\right)} \\
& =\frac{q^{n}-q^{r}}{q^{n}-1}|\mathrm{M}(n, n, r, q)|+\frac{\left(q^{n}-q^{r-1}\right)\left(q^{r}-1\right)}{\left(q^{n}-q^{r-1}\right)\left(q^{n}-1\right)}|\mathrm{M}(n, n, r, q)| \\
& =|\mathrm{M}(n, n, r, q)| .
\end{aligned}
$$

Lemma 3.2. Let $r \in\{1,2,3, \ldots, n\}$ and $\alpha, \beta \in F^{\times}$. Then we have

$$
\left|Y_{n, r}^{\alpha}\right|=\left|Y_{n, r}^{\beta}\right| .
$$

Proof. Consider the map $\phi: Y_{n, r}^{\alpha} \rightarrow Y_{n, r}^{\beta}$ given by

$$
\phi(X)=\alpha^{-1} \beta X .
$$

Suppose that $\phi(X)=\phi(Y)$. Since $\alpha^{-1} \beta \neq 0$, it follows that $\phi$ is injective. For $Y \in$ $Y_{n, r}^{\beta}$, let $X=\alpha \beta^{-1} Y$. Clearly, we have $\operatorname{Tr}(A X)=\alpha$ and $\operatorname{Rank}(X)=\operatorname{Rank}(Y)=r$. Thus $\phi$ is surjective and hence the result.

## Lemma 3.3.

$\left|Y_{n, r}^{0}\right|=q^{-1}|\mathrm{M}(n, n, r, q)|+\left(q^{r}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r, q)|+\left(q^{r-2}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r-1, q)|$.
Proof. Let $\mathfrak{B}=\left\{e_{1}, e_{2}, \ldots, e_{n}\right\}$ be a basis of $F^{n}$ over $F$ and $X \in Y_{n, r}^{0}$. Then,

$$
[X]_{\mathfrak{B}}=\left[\begin{array}{ll}
0 & w \\
v & Y
\end{array}\right]
$$

where $w$ is an $1 \times(n-1)$ row vector, $v$ is an $(n-1) \times 1$ column vector and $Y$ is an $(n-1) \times(n-1)$ block matrix. We also write

$$
\left[\begin{array}{c}
w \\
Y
\end{array}\right]=\left[\begin{array}{llll}
v_{1} & v_{2} & \cdots & v_{n-1}
\end{array}\right]
$$

where $v_{i}$ is an $n \times 1$ column vector for $1 \leq i \leq n-1$.
Let $V$ be the $n-1$ dimensional hyperplane spanned by the vectors $\left\{e_{2}, e_{3}, \ldots, e_{n}\right\}$. It is easy to see that $\left[\begin{array}{l}0 \\ v\end{array}\right] \in V$. We let $W$ be the space spanned by the vectors $\left\{v_{1}, v_{2}, \ldots, v_{n-1}\right\}$. Since $X \in Y_{n, r}^{0}$, the rank of the $n \times(n-1)$ matrix

$$
\left[\begin{array}{l}
w \\
Y
\end{array}\right]=\left[\begin{array}{llll}
v_{1} & v_{2} & \cdots & v_{n-1}
\end{array}\right]
$$

has only two possibilities, either $r$ or $r-1$. We consider both these cases separately.

Case 1) Suppose that

$$
\operatorname{Rank}\left(\left[\begin{array}{c}
w \\
Y
\end{array}\right]\right)=\operatorname{Rank}\left(\left[\begin{array}{llll}
v_{1} & v_{2} & \cdots & v_{n-1}
\end{array}\right]\right)=r
$$

Then $\operatorname{dim} W=r$. It follows that, $\left[\begin{array}{l}0 \\ v\end{array}\right] \in W$ and hence $\left[\begin{array}{l}0 \\ v\end{array}\right] \in V \cap W$. Therefore, the number of choices for $\left[\begin{array}{llll}v_{1} & v_{2} & \cdots & v_{n-1}\end{array}\right]$ is $|\mathrm{M}(n, n-1, r, q)|$.
a) If $w=0$, then

$$
W \subseteq V
$$

Hence, $V \cap W=W$ and $\operatorname{dim}(V \cap W)=\operatorname{dim} W=r$. Since $\left[\begin{array}{l}0 \\ v\end{array}\right] \in V \cap W$, the number of possibilities of $\left[\begin{array}{l}0 \\ v\end{array}\right]$ will be $q^{r}$. Also, the total number of matrices $\left[\begin{array}{l}w \\ Y\end{array}\right]$ with rank $r$ and $w=0$ is $|\mathrm{M}(n-1, n-1, r, q)|$.
b) If $w \neq 0$, we have $W \nsubseteq V$. Therefore,

$$
\begin{aligned}
\operatorname{dim}(W \cap V) & =\operatorname{dim} V+\operatorname{dim} W-\operatorname{dim}(V+W) \\
& =n-1+r-n=r-1
\end{aligned}
$$

Since $\left[\begin{array}{l}0 \\ v\end{array}\right] \in V \cap W$, the number of possibilities of $\left[\begin{array}{l}0 \\ v\end{array}\right]$ will be $q^{r-1}$. The number of matrices $\left[\begin{array}{l}w \\ Y\end{array}\right]$ with rank $r$ and $w \neq 0$, is

$$
|\mathrm{M}(n, n-1, r, q)|-|\mathrm{M}(n-1, n-1, r, q)| .
$$

Case 2) Suppose that

$$
\operatorname{Rank}\left(\left[\begin{array}{c}
w \\
Y
\end{array}\right]\right)=\operatorname{Rank}\left(\left[\begin{array}{llll}
v_{1} & v_{2} & \cdots & v_{n-1}
\end{array}\right]\right)=r-1
$$

Then $\operatorname{dim} W=r-1$. Therefore, $v \notin W$ and hence $\left[\begin{array}{l}0 \\ v\end{array}\right] \in V \backslash W$. Also,we have that the total number of matrices $\left[\begin{array}{l}w \\ Y\end{array}\right]$ with rank $r-1$ is $\mid \mathrm{M}(n, n-$ $1, r-1, q) \mid$.
a) If $w=0$, then $W \subseteq V$. Therefore, $V \cap W=W$ and $\operatorname{dim}(V \cap W)=$ $\operatorname{dim} W=r-1$. Since $\left[\begin{array}{l}0 \\ v\end{array}\right] \in V \backslash W$, the number of possibilities of $\left[\begin{array}{l}0 \\ v\end{array}\right]$ will be $q^{n-1}-q^{r-1}$. Furthermore, The total number of matrices $\left[\begin{array}{l}w \\ Y\end{array}\right]$ with rank $r-1$ and $w=0$ is $|\mathrm{M}(n-1, n-1, r-1, q)|$.
b) If $w \neq 0$, then $W \nsubseteq V$. Therefore,

$$
\begin{aligned}
\operatorname{dim}(W \cap V) & =\operatorname{dim} V+\operatorname{dim} W-\operatorname{dim}(V+W) \\
& =n-1+r-1-n=r-2
\end{aligned}
$$

Since $v \in V \backslash W$, the number of possibilities of $\left[\begin{array}{l}0 \\ v\end{array}\right]$ will be $q^{n-1}-q^{r-2}$. The total number of matrices in this case will be $|\mathrm{M}(n, n-1, r-1, q)|-\mid \mathrm{M}(n-$ $1, n-1, r-1, q) \mid$.

Using Lemma 3.1, and the above computations, we have

$$
\begin{aligned}
\left|Y_{n, r}^{0}\right| & =q^{r}|\mathrm{M}(n-1, n-1, r, q)|+q^{r-1}(|\mathrm{M}(n, n-1, r, q)|-|\mathrm{M}(n-1, n-1, r, q)|) \\
& +\left(q^{n-1}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r-1, q)| \\
& +\left(q^{n-1}-q^{r-2}\right)(|\mathrm{M}(n, n-1, r-1, q)|-|\mathrm{M}(n-1, n-1, r-1, q)|) \\
& =q^{r-1}|\mathrm{M}(n, n-1, r, q)|+\left(q^{n-1}-q^{r-2}\right)|\mathrm{M}(n, n-1, r-1, q)| \\
& +\left(q^{r}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r, q)| \\
& +\left(q^{n-1}-q^{r-1}-q^{n-1}+q^{r-2}\right)|\mathrm{M}(n-1, n-1, r-1, q)| \\
& =q^{r-1}|\mathrm{M}(n, n-1, r, q)|+\left(q^{n-1}-q^{r-2}\right)|\mathrm{M}(n, n-1, r-1, q)| \\
& +\left(q^{r}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r, q)|+\left(q^{r-2}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r-1, q)| \\
& =q^{-1}|\mathrm{M}(n, n, r, q)|+\left(q^{r}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r, q)| \\
& +\left(q^{r-2}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r-1, q)| .
\end{aligned}
$$

Lemma 3.4. We have
$\left|Y_{n, r}^{1}\right|=q^{-1}|\mathrm{M}(n, n, r, q)|-q^{r-1}|\mathrm{M}(n-1, n-1, r, q)|+q^{r-2}|\mathrm{M}(n-1, n-1, r-1, q)|$.
Proof. Using Lemma 3.2, we have

$$
\left|Y_{n, r}^{0}\right|+(q-1)\left|Y_{n, r}^{1}\right|=|\mathrm{M}(n, n, r, q)| .
$$

Thus we get,

$$
\begin{aligned}
\left|Y_{n, r}^{1}\right| & =\frac{\mathrm{M}(n, n, r, q)\left|-\left|Y_{n, r}^{0}\right|\right.}{q-1} \\
& =\frac{\mathrm{M}(n, n, r, q)\left|-q^{-1}\right| \mathrm{M}(n, n, r, q) \mid}{q-1} \\
& -\frac{\left(q^{r}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r, q)|+\left(q^{r-2}-q^{r-1}\right)|\mathrm{M}(n-1, n-1, r-1, q)|}{q-1} \\
& =q^{-1}|\mathrm{M}(n, n, r, q)|-q^{r-1}|\mathrm{M}(n-1, n-1, r, q)|+q^{r-2}|\mathrm{M}(n-1, n-1, r-1, q)| .
\end{aligned}
$$

Lemma 3.5. We have

$$
\left|Y_{n, r}^{0}\right|-\left|Y_{n, r}^{1}\right|=q^{r}|\mathrm{M}(n-1, n-1, r, q)|-q^{r-1}|\mathrm{M}(n-1, n-1, r-1, q)| .
$$

Proof. Follows from Lemma 3.3 and Lemma 3.4 .
Lemma 3.6. Let $r \in\{0,1,2, \ldots, n\}$ and $X \in \mathrm{M}(n, n, r, q)$. We have

$$
\Theta_{\theta}\left(\left[\begin{array}{cc}
1 & X \\
0 & 1
\end{array}\right]\right)=\left\{\begin{array}{cc}
(-1)(q ; q)_{2 n-1}, & \text { if } r=0 \\
(-1)(q ; q)_{2 n-2}, & \text { if } r=1 \\
\vdots & \\
(-1)(q ; q)_{n-1}, & \text { if } r=n
\end{array}\right.
$$

Proof. The proof follows from Theorem [2.2]above and rewriting the character values using the $q$-Pochhammer symbol.

Theorem 3.7. Let $\theta$ be a regular character of $F_{2 n}^{\times}$and $\pi=\pi_{\theta}$ be an irreducible cuspidal representation of $\mathrm{GL}(2 n, F)$. We have

$$
\operatorname{dim}_{\mathbb{C}}\left(\pi_{N, \psi_{A}}\right)=(q-1)^{2}\left(q^{2}-1\right)^{2} \cdots\left(q^{n-1}-1\right)^{2}=(q ; q)_{n-1}^{2} .
$$

Proof. It is easy to see that the dimension of $\pi_{N, \psi_{A}}$ is given by

$$
\operatorname{dim}_{\mathbb{C}}\left(\pi_{N, \psi_{A}}\right)=\frac{1}{q^{n^{2}}} \sum_{X \in \mathrm{M}(n, F)} \Theta_{\theta}\left(\left[\begin{array}{cc}
1 & X \\
0 & 1
\end{array}\right]\right) \overline{\psi_{0}(\operatorname{Tr}(A X))}
$$

Clearly, we have $\mathrm{M}(n, F)=\bigcup_{r=0}^{n}\left(\bigcup_{\alpha \in F} Y_{n, r}^{\alpha}\right)$. Using this, we see that

$$
\begin{aligned}
\operatorname{dim}_{\mathbb{C}}\left(\pi_{N, \psi_{A}}\right) & =\frac{1}{q^{n^{2}}} \sum_{r=0}^{n} \sum_{X \in Y_{n, r}^{\alpha}} \Theta_{\theta}\left(\left[\begin{array}{cc}
1 & X \\
0 & 1
\end{array}\right]\right) \overline{\psi_{0}(\alpha)} \\
& =\frac{1}{q^{n^{2}}} \sum_{r=0}^{n}(-1)(q ; q)_{2 n-1-r}\left(\left|Y_{n, r}^{0}\right|-\left|Y_{n, r}^{1}\right|\right) \\
& =-\frac{1}{q^{n^{2}}}\left[(q ; q)_{2 n-1} q^{0}|\mathrm{M}(n-1, n-1,0, q)|\right. \\
& \left.+\sum_{r=1}^{n}(q ; q)_{2 n-1-r}\left(q^{r}|\mathrm{M}(n-1, n-1, r, q)|-q^{r-1}|\mathrm{M}(n-1, n-1, r-1, q)|\right)\right] \\
& =-\frac{1}{q^{n^{2}}} \sum_{r=0}^{n-1} q^{r}\left((q ; q)_{2 n-1-r}-(q ; q)_{2 n-2-r}\right)|\mathrm{M}(n-1, n-1, r, q)| \\
& =\frac{1}{q^{n^{2}}} \sum_{r=0}^{n-1} q^{2 n-1}|\mathrm{M}(n-1, n-1, r, q)|(q ; q)_{2 n-2-r} \\
& =\frac{1}{q^{(n-1)^{2}}} \sum_{r=0}^{n-1}|\mathrm{M}(n-1, n-1, r, q)|(q ; q)_{2 n-2-r} \\
& =(q ; q)_{n-1}^{2} .
\end{aligned}
$$

Remark 3.8. Suppose that $B=A w_{0}$. It is easy to see that $\Theta_{N, \psi_{A}}\left(\left[\begin{array}{cc}m_{1} & 0 \\ 0 & m_{2}\end{array}\right]\right)=$ $\Theta_{N, \psi_{B}}\left(\left[\begin{array}{cc}w_{0} m_{1} w_{0} & 0 \\ 0 & m_{2}\end{array}\right]\right)$. Thus we have that $\operatorname{dim}_{\mathbb{C}}\left(\pi_{N, \psi_{A}}\right)=\operatorname{dim}_{\mathbb{C}}\left(\pi_{N, \psi_{B}}\right)$.

## 4. Main Theorem

In this section, we prove the main result of this paper. Before we continue, we set up some notation and record a few preliminary results that we need. Let $G=$ $\mathrm{GL}(2 n, F)$ and $P$ be the maximal parabolic subgroup of $G$ with Levi decomposition $P=M N$, where $M \simeq \mathrm{GL}(n, F) \times \mathrm{GL}(n, F)$ and $N \simeq \mathrm{M}(n, F)$. We write $F_{n}$ for the unique field extension of $F$ of degree $n$. Let $\psi_{0}$ be a fixed non-trivial additive character of $F$. Let

A=\left[\begin{array}{cccc}
0 & \ldots & 0 & 1 \\
0 & \ldots & 0 & 0 \\
\vdots & \ddots & \vdots & \vdots \\
0 & \ldots & 0 & 0
\end{array}\right]
$$

Let $\psi_{A}: N \rightarrow \mathbb{C}^{\times}$be the character of $N$ given by

$$
\psi_{A}\left(\left[\begin{array}{cc}
1 & X \\
0 & 1
\end{array}\right]\right)=\psi_{0}(\operatorname{Tr}(A X))
$$

Let $H_{A}=M_{1} \times M_{2}$ where $M_{1}$ is the Mirabolic subgroup of GL $(n, F)$ and $M_{2}=$ $w_{0} M_{1}^{\top} w_{0}{ }^{-1}$. Let $U$ be the subgroup of unipotent matrices in $\operatorname{GL}(2 n, F)$. Let $U_{A}=H_{A} \cap U$. Clearly, we have $U_{A} \simeq U_{1} \times U_{2}$ where $U_{1}$ and $U_{2}$ are the upper triangular unipotent subgroups of GL $(n, F)$. For $k=1,2$, let $\mu_{k}: U_{k} \rightarrow \mathbb{C}^{\times}$be the non-degenerate character of $U_{k}$ given by

$$
\mu_{k}\left(\left[\begin{array}{ccccc}
1 & x_{12} & x_{13} & \cdots & x_{1 n} \\
& 1 & x_{23} & \cdots & x_{2 n} \\
& & 1 & \ddots & \vdots \\
& & & \ddots & x_{n-1, n} \\
& & & & 1
\end{array}\right]\right)=\psi_{0}\left(x_{12}+x_{23}+\cdots+x_{n-1, n}\right)
$$

Let $\mu: U_{A} \rightarrow \mathbb{C}^{\times}$be the character of $U_{A}$ given by

$$
\mu(u)=\mu_{1}\left(u_{1}\right) \mu_{2}\left(u_{2}\right)
$$

where $u=\left[\begin{array}{ll}u_{1} & \\ & u_{2}\end{array}\right]$.
Lemma 4.1. Let $M_{\psi_{A}}=\left\{m \in M \mid \psi_{A}^{m}(n)=\psi_{A}(n), \forall n \in N\right\}$. Then we have

$$
M_{\psi_{A}}=\left\{\left.\left[\begin{array}{cccc}
C & x & & \\
0 & a & & \\
& & a & y \\
& & 0 & D
\end{array}\right] \right\rvert\, a \in F^{\times}, C, D \in \mathrm{GL}(n-1, F), x, y \in F^{n-1}\right\}
$$

Proof. Let $g=\left[\begin{array}{ll}g_{1} & \\ & g_{2}\end{array}\right] \in M$. Then $g \in M_{\psi_{A}}$ if and only if $A g_{1}=g_{2} A$. It follows that $g \in M_{\psi_{A}}$ if and only if $g_{1}=\left[\begin{array}{ll}C & x \\ 0 & a\end{array}\right]$ and $g_{2}=\left[\begin{array}{ll}a & y \\ 0 & D\end{array}\right]$.

Lemma 4.2. Let $Z$ be the center of $G=\operatorname{GL}(2 n, F)$. Let $H_{A}$ be a subgroup of $G$ as above. Then,

$$
M_{\psi_{A}} \simeq Z \times H_{A}
$$

Proof. Trivial.
Lemma 4.3. Let $\rho_{1}=\operatorname{ind}_{U_{1}}^{M_{1}} \mu_{1}$ and $\rho_{2}=\operatorname{ind}_{U_{2}}^{M_{2}} \mu_{2}$. Consider the representation $(\rho, V)$ of $M_{\psi_{A}}$ given by

$$
\rho=\left.\theta\right|_{F^{\times}} \otimes \operatorname{ind}_{U_{A}}^{H_{A}} \mu=\left.\theta\right|_{F^{\times}} \otimes\left(\rho_{1} \otimes \rho_{2}\right)
$$

Then $(\rho, V)$ is an irreducible representation of $M_{\psi_{A}}$.
Proof. Since $\rho_{1}$ is the Kirillov representation of the Mirabolic subgroup $M_{1}$ of $\mathrm{GL}(n, F)$, we have that $\rho_{1}$ is irreducible (see Theorem 2.3). In a similar way, we can see that $\rho_{2}$ is also irreducible. Hence the result.

Lemma 4.4. Let $P_{\psi_{A}}=M_{\psi_{A}} N$. Consider the map $\tilde{\rho}: P_{\psi_{A}} \rightarrow \operatorname{GL}(V)$ given by

$$
\tilde{\rho}(p)=\tilde{\rho}(m n)=\psi_{A}\left(m n m^{-1}\right) \rho(m)
$$

where $m \in M_{\psi_{A}}, n \in N$. Then $(\tilde{\rho}, V)$ is a representation of $P_{\psi_{A}}$.

Proof. Let $p_{1}=m_{1} n_{1}, p_{2}=m_{2} n_{2} \in P_{\psi_{A}}$. Then, we have

$$
\begin{aligned}
\tilde{\rho}\left(p_{1} p_{2}\right) & =\tilde{\rho}\left(m_{1} n_{1} m_{2} n_{2}\right) \\
& =\tilde{\rho}\left(m_{1} m_{2}\left(m_{2}^{-1} n_{1} m_{2}\right) n_{2}\right) \\
& =\psi_{A}\left(m_{1} m_{2}\left(m_{2}^{-1} n_{1} m_{2} n_{2}\right) m_{2}^{-1} m_{1}^{-1}\right) \rho\left(m_{1} m_{2}\right) \\
& =\psi_{A}\left(n_{1}\left(m_{2} n_{2} m_{2}^{-1}\right)\right) \rho\left(m_{1} m_{2}\right) \\
& =\psi_{A}\left(n_{1}\right) \psi_{A}\left(m_{2} n_{2} m_{2}^{-1}\right) \rho\left(m_{1}\right) \rho\left(m_{2}\right) \\
& =\psi_{A}\left(m_{1} n_{1} m_{1}^{-1}\right) \rho\left(m_{1}\right) \psi_{A}\left(m_{2} n_{2} m_{2}^{-1}\right) \rho\left(m_{2}\right) \\
& =\tilde{\rho}\left(p_{1}\right) \tilde{\rho}\left(p_{2}\right) .
\end{aligned}
$$

Lemma 4.5. Let $(\tilde{\rho}, V)$ be the representation of $P_{\psi_{A}}$ given by

$$
\tilde{\rho}(p)=\tilde{\rho}(m n)=\psi_{A}\left(m n m^{-1}\right) \rho(m)
$$

where $m \in M_{\psi_{A}}, n \in N$. Then, $(\tilde{\rho}, V)$ is irreducible.
Proof. Let $W$ be a non-trivial $P_{\psi_{A}}$-invariant subspace of $V$. For $w \in W, p \in P_{\psi_{A}}$, we have

$$
\tilde{\rho}(p) w=\psi_{A}\left(m n m^{-1}\right) \rho(m) w \in W
$$

Therefore $\rho(m) w \in W$, for all $m \in M_{\psi_{A}}, w \in W$. Since $\rho$ is irreducible (see Lemma 4.3), the result follows.

Lemma 4.6. Consider the representation $\tilde{\rho}$ of $P_{\psi_{A}}$. We have

$$
\left.\tilde{\rho}\right|_{U}=\left.\psi_{A} \otimes \rho\right|_{U_{A}} .
$$

Proof. Clearly we have $U=U_{A} N$. Hence for $u=x n \in U$, we have

$$
\tilde{\rho}(u)=\psi_{A}\left(x n x^{-1}\right) \rho(x)=\psi_{A}(n) \rho(x) .
$$

Lemma 4.7. Let $\rho=\left.\theta\right|_{F \times} \otimes \operatorname{ind}_{U_{A}}^{H_{A}} \mu$ be the representation of $M_{\psi_{A}}$ and $\tilde{\rho}$ be the corresponding representation of $P_{\psi_{A}}$. For any $z \in Z$, we have

$$
\omega_{\tilde{\rho}}(z)=\omega_{\rho}(z)=\theta(z)
$$

Proof. For $z \in Z$, we have

$$
\begin{aligned}
\chi_{\tilde{\rho}}(z) & =\operatorname{Tr}(\tilde{\rho}(z)) \\
& =\omega_{\tilde{\rho}}(z) \operatorname{deg}(\rho) \\
& =\operatorname{Tr}(\rho(z)) \\
& =\omega_{\rho}(z) \operatorname{deg}(\rho) \\
& =\operatorname{Tr}\left(\left.\theta\right|_{F} \times(z) \otimes \operatorname{ind}_{U_{A}}^{H_{A}} \mu(1)\right) \\
& =\theta(z) \operatorname{deg}(\rho)
\end{aligned}
$$

It follows that $\omega_{\tilde{\rho}}(z)=\omega_{\rho}(z)=\theta(z)$.
Lemma 4.8. Let $\chi: F^{\times} \rightarrow \mathbb{C}^{\times}$be a character of $F^{\times}$. Consider the representation $(\tilde{\rho}, V)$ of $P_{\psi_{A}}$ defined above. Let $\sigma_{\chi}: P_{\psi_{A}} \rightarrow \mathrm{GL}(V)$ be the map

$$
\sigma_{\chi}(p)=\sigma_{\chi}(z h n)=\chi(z) \tilde{\rho}(h n)
$$

where $z \in Z, h \in H_{A}, n \in N$. Then $\sigma_{\chi}$ is an irreducible representation of $P_{\psi_{A}}$.

Proof. It is easy to see that $\sigma_{\chi}$ is a representation of $P_{\psi_{A}}$. Let $W$ be a non-trivial subspace of $V$ invariant under $P_{\psi_{A}}$ and let $w \neq 0 \in W$. We have

$$
\sigma_{\chi}(z h n) w=\chi(z) \tilde{\rho}(h n) w \in W
$$

Therefore,

$$
\tilde{\rho}(z h n) w=\tilde{\rho}(z) \tilde{\rho}(h n) w=\omega_{\tilde{\rho}}(z) \tilde{\rho}(h n) w \in W .
$$

Since $\tilde{\rho}$ is irreducible, it follows that $V=W$ and hence the result.
Lemma 4.9. Let $\chi_{1}, \chi_{2} \in \widehat{F^{\times}}$such that $\chi_{1} \neq \chi_{2}$. Then,

$$
\sigma_{\chi_{1}} \not \not ㇒ \sigma_{\chi_{2}} .
$$

Proof. Let $z_{0} \in Z$ such that $\chi_{1}\left(z_{0}\right) \neq \chi_{2}\left(z_{0}\right)$. Let $\chi_{\sigma_{\chi_{1}}}, \chi_{\sigma_{\chi_{2}}}$ be the characters of $\sigma_{\chi_{1}}$ and $\sigma_{\chi_{2}}$. Suppose that $\sigma_{\chi_{1}} \simeq \sigma_{\chi_{2}}$. We have

$$
\begin{aligned}
\chi_{\sigma_{\chi_{1}}}\left(z_{0}\right) & =\operatorname{Tr}\left(\sigma_{\chi_{1}}\left(z_{0}\right)\right) \\
& =\chi_{1}\left(z_{0}\right) \operatorname{deg}(\rho) \\
& =\chi_{\sigma_{\chi_{2}}}\left(z_{0}\right) \\
& =\operatorname{Tr}\left(\sigma_{\chi_{2}}\left(z_{0}\right)\right) \\
& =\chi_{2}\left(z_{0}\right) \operatorname{deg}(\rho) .
\end{aligned}
$$

The result follows.
Lemma 4.10. For $\chi \in \widehat{F^{\times}}$, we have

$$
\operatorname{Hom}_{P_{\psi_{A}}}\left(\sigma_{\chi}, \operatorname{ind}_{U}^{P_{\psi_{A}}} \psi\right) \neq 0
$$

Proof. Using Fröbenius Reciprocity, we have

$$
\operatorname{Hom}_{P_{\psi_{A}}}\left(\sigma_{\chi}, \operatorname{ind}_{U}^{P_{\psi_{A}}} \psi\right)=\operatorname{Hom}_{U}\left(\left.\sigma_{\chi}\right|_{U}, \psi\right) .
$$

Thus it is enough to show that $\operatorname{Hom}_{U}\left(\left.\sigma_{\chi}\right|_{U}, \psi\right) \neq 0$. For $u \in U$, we have

$$
\left.\sigma_{\chi}\right|_{U}(u)=\sigma_{\chi}(u)=\chi(1) \tilde{\rho}(u)=\left.\tilde{\rho}\right|_{U}(u)
$$

Therefore,

$$
\begin{aligned}
\operatorname{Hom}_{U}\left(\left.\sigma_{\chi}\right|_{U}, \psi\right) & =\operatorname{Hom}_{U}\left(\left.\tilde{\rho}\right|_{U}, \psi\right) \\
& =\operatorname{Hom}_{U}\left(\left.\psi_{A} \otimes \rho\right|_{U_{A}}, \psi\right) \\
& =\operatorname{Hom}_{U}\left(\psi_{A} \otimes \bigoplus_{s \in U_{A} \backslash H_{A} / U_{A}} \operatorname{ind}_{s^{-1} U_{A} s \cap U_{A}}^{U_{A}} \mu^{s}, \psi\right) \\
& =\operatorname{Hom}_{U}\left(\psi_{A} \otimes \mu, \psi\right) \oplus \bigoplus_{1 \neq s \in U_{A} \backslash H_{A} / U_{A}} \operatorname{Hom}_{U}\left(\psi_{A} \otimes \operatorname{ind}_{s^{-1} U_{A} s \cap U_{A}}^{U_{A}} \mu^{s}, \psi\right) \\
& =\operatorname{Hom}_{U}(\psi, \psi) \oplus \bigoplus_{1 \neq s \in U_{A} \backslash H_{A} / U_{A}} \operatorname{Hom}_{U}\left(\psi_{A} \otimes \operatorname{ind}_{s^{-1} U_{A} s U_{A}}^{U_{A}} \mu^{s}, \psi\right)
\end{aligned}
$$

$$
\neq 0
$$

Lemma 4.11. Let $\chi \in \widehat{F^{\times}}$and $\sigma_{\chi}$ be the irreducible representation of $P_{\psi_{A}}$. Then

$$
\operatorname{ind}_{U}^{P_{\psi_{A}}} \psi=\bigoplus_{\chi \in \widehat{F^{x}}} \sigma_{\chi}
$$

Proof. The result clearly follows from a simple application of Lemma 4.9 and Lemma 4.10, and computing the degree of $\operatorname{ind}_{U}^{P_{\psi_{A}}}(\psi)$. To be precise, suppose that

$$
\operatorname{ind}_{U}^{P_{\psi_{A}}}(\psi)=\left(\bigoplus_{x \in \widehat{F^{\times}}} d_{\chi} \sigma_{\chi}\right) \oplus d \sigma
$$

where $d_{\chi} \geq 1, d \geq 0$ and $\sigma$ is some representation of $P_{\psi_{A}}$. By degree comparison, we have that

$$
\operatorname{deg}\left(\bigoplus_{\chi \in \widehat{F^{\times}}} d_{\chi} \sigma_{\chi}\right)=\sum_{\chi \in \widehat{F^{\times}}} d_{\chi} \operatorname{deg}\left(\sigma_{\chi}\right)=\sum_{\chi \in \widehat{F^{\times}}} d_{\chi} \operatorname{deg}(\rho)
$$

Clearly

$$
\sum_{\chi \in \widehat{F^{\times}}} d_{\chi} \operatorname{deg}(\rho) \geq(q-1) \operatorname{deg}(\rho)=\operatorname{deg}\left(\operatorname{ind}_{U}^{P_{\psi_{A}}}(\psi)\right)
$$

On the other hand, we have

\operatorname{deg}\left(\bigoplus_{\chi \in \widehat{F^{x}}} d_{\chi} \sigma_{\chi}\right)+d \operatorname{deg}(\sigma)=\operatorname{deg}\left(\operatorname{ind}_{U}^{P_{\psi} A}(\psi)\right)
$$

It follows that

d=0, d_{\chi}=1, \forall \chi \in F^{\times}
$$

Hence the result.
Lemma 4.12. Let $m=a h \in M_{\psi_{A}}$, where $a \in Z$ and $h \in H_{A}$. Then,

\Theta_{N, \psi_{A}}(m)=\theta(a) \Theta_{N, \psi_{A}}(h) .
$$

Proof. We have

\begin{aligned}
\Theta_{N, \psi_{A}}(m) & =\Theta_{N, \psi_{A}}(a h) \\
& =\frac{1}{|N|} \sum_{n \in N} \Theta_{\theta}(a h n) \overline{\psi_{A}(n)} \\
& =\frac{1}{|N|} \sum_{n \in N} \operatorname{Tr}\left(\pi(a h n) \overline{\psi_{A}(n)}\right. \\
& =\frac{1}{|N|} \sum_{n \in N} \operatorname{Tr}\left(\pi(a) \pi(h n) \overline{\psi_{A}(n)}\right. \\
& =\omega_{\pi}(a) \frac{1}{|N|} \sum_{n \in N} \operatorname{Tr}\left(\pi(h n) \overline{\psi_{A}(n)}\right. \\
& =\omega_{\pi}(a) \Theta_{N, \psi_{A}}(h)
\end{aligned}
$$

where $\omega_{\pi}$ is the central character of $\pi$. Explicitly, we have

$$
\Theta_{\theta}(a)=\operatorname{Tr}(\pi(a))=\operatorname{Tr}\left(\omega_{\pi}(a)\right)=\omega_{\pi}(a) \operatorname{dim}(\pi)
$$

Using Theorem 2.2 it is easy to see that

\Theta_{\theta}(a)=\theta(a) \operatorname{dim}(\pi)
$$

Thus, we have $\omega_{\pi}(a)=\theta(a)$ and the result follows.
Lemma 4.13. Let $\chi \neq \theta \in \widehat{F^{\times}}$. Then

\operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\chi}\right)=0
$$

Proof. It is enough to show that $\operatorname{dim}_{\mathbb{C}} \operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\chi}\right)=0$. Clearly, we have

$$
\begin{aligned}
\operatorname{dim}_{\mathbb{C}} \operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\chi}\right) & =\left\langle\chi_{\left.\pi\right|_{P_{\psi_{A}}}}, \chi_{\sigma_{\chi}}\right\rangle \\
& =\sum_{z h n \in P_{\psi_{A}}} \chi_{\pi}(z h n) \overline{\chi_{\sigma_{\chi}}(z h n)} \\
& =\sum_{h n \in H_{A} N} \sum_{z \in Z} \omega_{\pi}(z) \chi_{\pi}(h n) \overline{\chi(z) \chi_{\tilde{\rho}}(h n)} \\
& =\sum_{h n \in H_{A} N} \sum_{z \in Z} \theta(z) \overline{\chi(z)} \chi_{\pi}(h n) \overline{\chi_{\tilde{\rho}}(h n)} \\
& =\sum_{z \in Z} \theta(z) \overline{\chi(z)} \sum_{h n \in H_{A} N} \chi_{\pi}(h n) \overline{\chi_{\tilde{\rho}}(h n)} \\
& =\langle\theta, \chi\rangle \sum_{h n \in H_{A} N} \chi_{\pi}(h n) \overline{\chi_{\tilde{\rho}}(h n)} \\
& =0
\end{aligned}
$$

It follows that

$$
\operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\chi}\right)=0, \forall \chi \in \widehat{F^{\times}}, \chi \neq \theta
$$

Lemma 4.14. Consider the restriction $\left.\theta\right|_{F \times}$ of the regular character $\theta$. Then

$$
\sigma_{\theta}=\tilde{\rho}
$$

as $P_{\psi_{A}}$ representations.
Proof. Using Lemma 4.7 we have $\omega_{\tilde{\rho}}(z)=\theta(z)$. Thus for $p=z h n \in P_{\psi_{A}}$, we have

$$
\begin{aligned}
\sigma_{\theta}(z h n) & =\theta(z) \rho(h n) \\
& =\omega_{\tilde{\rho}}(z) \tilde{\rho}(h n) \\
& =\tilde{\rho}(z h n) .
\end{aligned}
$$

4.1. Proof of the Main Theorem. For the sake of completeness, we recall the statement below.

Theorem 4.15. Let $\theta$ be a regular character of $F_{2 n}^{\times}$and $\pi=\pi_{\theta}$ be an irreducible cuspidal representation of $G$. Then

$$
\left.\pi_{N, \psi_{A}} \simeq \theta\right|_{F \times} \otimes \operatorname{ind}_{U_{A}}^{H_{A}} \mu
$$

as $M_{\psi_{A}}$ modules.

Proof. Using transitivity of induction and Lemma 4.11, we have that

$$
\begin{aligned}
\operatorname{Hom}_{G}\left(\pi, \operatorname{ind}_{U}^{G} \psi\right) & =\operatorname{Hom}_{G}\left(\pi, \operatorname{ind}_{P_{\psi_{A}}}^{G}\left(\operatorname{ind}_{U}^{P_{\psi_{A}}} \psi\right)\right) \\
& =\operatorname{Hom}_{G}\left(\pi, \operatorname{ind}_{P_{\psi_{A}}}^{G}\left(\bigoplus_{\chi \in \widehat{F^{\times}}} \sigma_{\chi}\right)\right) \\
& =\bigoplus_{\chi \in \widehat{F^{\times}}} \operatorname{Hom}_{G}\left(\pi, \operatorname{ind}_{P_{\psi_{A}}}^{G} \sigma_{\chi}\right) \\
& =\bigoplus_{\chi \in \widehat{F^{\times}}} \operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\chi}\right) \\
& =\operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\theta}\right) \oplus \underset{\theta \neq \chi \in \widehat{F^{\times}}}{\bigoplus \operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \sigma_{\chi}\right)} \\
& =\operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \tilde{\rho}\right)
\end{aligned}
$$

Hence,
$\operatorname{Hom}_{G}\left(\pi, \operatorname{ind}_{U}^{G}(\psi)\right)=\operatorname{Hom}_{P_{\psi_{A}}}\left(\left.\pi\right|_{P_{\psi_{A}}}, \tilde{\rho}\right) \simeq \operatorname{Hom}_{G}\left(\pi, \operatorname{ind}_{P_{\psi_{A}}}^{G} \tilde{\rho}\right) \simeq \operatorname{Hom}_{M_{\psi_{A}}}\left(\pi_{N, \psi_{A}}, \rho\right)$.
Using the multiplicity one theorem for $\operatorname{GL}(n)$ (give precise statement in preliminaries), we conclude that

$$
\operatorname{dim}_{\mathbb{C}} \operatorname{Hom}_{M_{\psi_{A}}}\left(\pi_{N, \psi_{A}}, \rho\right)=1
$$

and it follows that

$$
\pi_{N, \psi_{A}} \simeq \rho
$$

as $M_{\psi_{A}}$ representations.
