# LONG-TIME DYNAMICS OF THE WAVE EQUATION WITH NONLOCAL WEAK DAMPING AND SUP-CUBIC NONLINEARITY IN 3-D DOMAINS

#### Abstract

In this paper, we study the long-time dynamics for the wave equation with nonlocal weak damping and sup-cubic nonlinearity in a bounded smooth domain of $\mathbb{R}^{3}$. Based on the Strichartz estimates for the case of bounded domains, we first prove the global well-posedness of the Shatah-Struwe solutions. Then we establish the existence of the global attractor for the Shatah-Struwe solution semigroup by the method of contractive function. Finally, we verify the existence of a polynomial attractor for this semigroup.


## 1. Introduction

In this paper, we consider the following damped wave equation:

\left.u\right|_{\partial \Omega}=0, \quad t \in \mathbb{R}^{+}, \\
\left.u\right|_{t=0}=u_{0},\left.\quad u_{t}\right|_{t=0}=u_{1}, \quad x \in \Omega .
\end{array}\right.
$$

Here, $\Omega \subset \mathbb{R}^{3}$ is a bounded domain with smooth boundary, $\|\cdot\|$ stands for the usual norm of $L^{2}(\Omega), k, p>0$ are fixed constants, $g \in L^{2}(\Omega)$ is independent of time, and the nonlinearity $f \in C^{1}(\mathbb{R})$ satisfies the following growth and dissipation conditions:

where $C$ is a positive constant , $0<\kappa \leq 4$ and $\lambda_{1}>0$ is the first eigenvalue of $-\Delta$ on $L^{2}(\Omega)$ with Dirichlet boundary conditions.

The long-time dynamics of wave equations with nonlocal damping terms has been investigated extensively by many authors (see e.g. [2, 6, 16, 17, 18]). Recently, in [21, the authors studied the long-time behavior of a beam model with the nonlocal weak damping $\left\|u_{t}\right\|^{p} u_{t}$, and in [22, 23], they also considered the following wave equation with nonlocal weak damping and anti-damping in $\mathbb{R}^{n}(n \geq 3)$

u_{t t}-\Delta u+k\left\|u_{t}\right\|^{p} u_{t}+f(u)=\int_{\Omega} K(x, y) u_{t}(y) d y+h(x), \tag{1.4}
\end{equation*}

where $\int_{\Omega} K(x, y) u_{t}(y) d y$ is the anti-damping term and the growth exponent $q$ of the nonlinearity $f$ is up to the range: $0<q \leq \frac{n}{n-2}$ (in the case $n=3,0<q \leq 3$ ). They obtained the wellposedness of problem (1.4) in the natural energy space $H_{0}^{1}(\Omega) \times L^{2}(\Omega)$ and proved the existence of global attractors. It is worth mentioning that the nonlocal weak damping $\left\|u_{t}\right\|^{p} u_{t}$ was first proposed.

We are motivated by [22] to study problem (1.1) where the growth exponent $q$ of the nonlinearity $f$ is allowed to be sup-cubic: $3<q<5$ (see condition (1.2)). Differently from Eq. (1.4), since we are more interested in the nonlinearity with higher growth exponent, the anti-damping term is not considered in (1.1).

Similarly to the weakly damped wave equation, the long-time dynamics of problem (1.1) depends strongly on the growth rate of nonlinearity $f$. One can verify the global well-posedness of weak energy solutions (solutions in the space $\left.H_{0}^{1}(\Omega) \times L^{2}(\Omega)\right)$ to problem (1.1) only for the cases

[^0]when the growth rate of $f$ is cubic or sub-cubic. Fortunately, with the help of suitable versions of Strichartz estimates and Morawetz-Pohozhaev identity in the case of bounded domains, one can obtain the global well-posedness of so-called Shatah-Struwe solutions (see Definition 3.2) with sup-cubic nonlinearity $f$. Recently, Kalantarov et al. [10] proved the existence and regularities of the compact global attractor of the Shatah-Struwe solution semigroup arising from weakly damped wave equation:

$$
where the nonlinearity $f(u)$ is up to quintic growth. After that, Liu et al. [12] considered the weakly damped wave equation with the source term $g \in H^{-1}$ and they obtained the existence of a global attractor as well as exponential attractor when the growth exponent of the nonlinearity satisfies $1<q<\frac{25}{7}$. Furthermore, in [13, 14, 15], the authors analyzed a more general situation, with fractional damping term $(-\Delta)^{\theta} u_{t}, \theta \in[0,1]$ in place of $u_{t}$. In this paper, we are devoted to study the long-time dynamics of Shatah-Struwe solutions to problem (1.1).

We want to point out here that the nonlocal weak damping and the sup-cubic nonlinearity together bring us difficulties to prove the well-posedness. Since the function $\left\|u_{t}\right\|$ is not weakly continuous in $L^{2}$, it is difficult to use Galerkin's method directly to obtain the existence of solutions. Noticing that $\left\|u_{t}\right\|^{p} u_{t}$ is a monotone operator in $L^{2}(\Omega)$, the authors in [22] used Theorem 1.5 in [8] to obtain the well-posedness. However, in the sup-cubic case, $f(u): H_{0}^{1} \rightarrow L^{2}$ is no longer locally Lipschitz, thus Theorem 1.5 in [8] is invalid. Inspired by [20], we combine the Galerkin's method and the monotonicity of $\left\|u_{t}\right\|^{p} u_{t}$ and finally obtain the well-posedness of problem (1.1).

The polynomial attractor is a concept to quantitatively describe the attractive velocity of attractors. A polynomical attractor is a positively invariant compact set which attracts any bounded set at a polynomial rate (see Definition [5.1). In [23, 24], the authors introduced the concept of $\varphi$-attractor for the first time and established some criteria for the existence of a polynomial attractor. Moreover, they applyed these abstract theorems to Eq. (1.4) and obtained the existence of polynomial attractors with sub-critical ( $q<\frac{n}{n-2}$ ) or critical ( $q=\frac{n}{n-2}$ ) nonlinearity $f$. In this paper, we will use the abstract theorem established in [24] to prove the existence of a polynomial attractor of the Shatah-Struwe solution semigroup generated by problem (1.1).

The rest of this paper is organized as follows. In Section 2, we give some preliminary things including Strichartz estimates and some abstract results. In Section 3, we discuss the global well-posedness of Shatah-Struwe solutions. In Section 4, we prove the existence of the global attractor for the corresponding dynamical system. Finally, the existence of a polynomial attractor is established in Section 6.

## 2. Preliminaries

We first introduce the following abbreviations:

L^{p}=L^{p}(\Omega), \quad H_{0}^{1}=H_{0}^{1}(\Omega), \quad\|\cdot\|=\|\cdot\|_{L^{2}}

with $p \geq 1$. The notation $(\cdot, \cdot)$ stands for the usual inner product in $L^{2} . X \hookrightarrow Y$ denotes that the space $X$ continuously embeds into $Y$ and $X \hookrightarrow \hookrightarrow Y$ denotes that $X$ compactly embeds into $Y$. Let

equipped with the usual graph norm:

We now recall the Strichartz estimates for wave equations in bounded domains. (see [3, 4, [5] for details).

\left.u\right|_{\partial \Omega}=0, \quad t \in \mathbb{R}^{+}, \\
\xi_{u}(0)=\xi_{0}, \quad x \in \Omega
\end{array}\right.
$$

Lemma 2.1. 3] Let $\xi_{0} \in \mathcal{E}, G \in L^{1}\left(0, T ; L^{2}\right)$ and $u(t)$ be a solution of equation (2.1) such that $\xi_{u} \in C(0, T ; \mathcal{E})$. Then $u \in L^{4}\left(0, T ; L^{12}\right)$ and the following estimate holds:

where the constant $C_{T}$ may depend on $T$, but is independent of $\xi_{0}$ and $G$.
We also state some lemmas, which are indispensable for our proof.
Lemma 2.2. [24, Lemma 4.2] Let $(H,\langle\cdot, \cdot\rangle)$ be a an inner product space and $\|\cdot\|_{H}$ be the norm induced by $\langle\cdot, \cdot\rangle$. For any constant $p>1$, there exists $c_{p}>0$, such that $\forall x, y \in H$, $\|x\|_{H} \cdot\|y\|_{H} \neq 0$,

Lemma 2.3. [13] Suppose that a function $y(s) \in C([a, b))$ satisfies $y(a)=0, y(s) \geq 0$ and

for some $\sigma>1,0<C_{0}<\infty$ and $0<\varepsilon<\frac{1}{2}\left(\frac{1}{2 C_{0}}\right)^{\frac{1}{\sigma-1}}$. Then

Lemma 2.4. (Aubin-Dubinskii-Lions Lemma, 11) Assume that $X \subset Y \subset Z$ is a triple of Banach spaces such that $X \hookrightarrow \hookrightarrow Y \hookrightarrow Z$.
(i) Let $W_{1}=\left\{u \in L^{p}(a, b ; X) \mid u_{t} \in L^{q}(a, b ; Z)\right\}$ for some $1 \leq p \leq \infty$ and $q \geq 1$. Here $u_{t}$ denotes the derivative of $u$ in the distributional sense. Then, $W_{1} \hookrightarrow \hookrightarrow L^{p}(a, b ; Y)$. If $q>1$, then $W_{1} \hookrightarrow \hookrightarrow C(a, b ; Z)$.
(ii) Let $W_{2}=\left\{u \in L^{\infty}(a, b ; X) \mid u_{t} \in L^{r}(a, b ; Z)\right\}$ for some $r>1$, then $W_{2} \hookrightarrow \hookrightarrow C(a, b ; Y)$.

## 3. Well-posedness

The aim of this section is to study the well-posedness of the Shatah-Struwe solutions of problem (1.1). We start with the definition of weak solutions.
Definition 3.1. For any $T>0$, a function $u(t), t \in[0, T]$ is said to be a weak solution of problem (1.1) if $\xi_{u} \in L^{\infty}(0, T ; \mathcal{E})$ and Eq. (1.1) is satisfied in the sense of distribution, i.e.

-\int_{0}^{T}\left(u_{t}, \phi_{t}\right) d t+k \int_{0}^{T}\left\|u_{t}\right\|^{p}\left(u_{t}, \phi\right) d t+\int_{0}^{T}(\nabla u, \nabla \phi) d t+\int_{0}^{T}(f(u), \phi) d t=\int_{0}^{T}(g, \phi) d t
$$

for any $\phi \in C_{c}^{\infty}((0, T) \times \Omega)$.
To the best of our knowledge, the uniqueness of the weak solution to (1.1) is still unknown when the nonlinearity satisfies (1.2). Thus, following [10], we introduce the so-called ShatahStruwe solutions.

Definition 3.2. A weak solution $u(t), t \in[0, T]$ is a Shatah-Struwe solution of problem (1.1)) if the following additional regularity holds:

u \in L^{4}\left(0, T ; L^{12}\right)
$$

We first prove the local existence of Shatah-Struwe solutions.
Theorem 3.3. Let the nonlinearity $f$ satisfy assumptions (1.2) and (1.3). Then for any initial data $\xi_{0} \in \mathcal{E}$, there exists $T=T\left(\left\|\xi_{0}\right\|_{\mathcal{E}}\right)>0$ such that problem (1.1) admits a Shatah-Struwe solution $u(t)$ on the interval $t \in[0, T]$ and the following estimate holds:

\left\|\xi_{u}(t)\right\|_{\mathcal{E}}+\|u\|_{L^{4}\left(0, T ; L^{12}\right)} \leq Q\left(\left\|\xi_{0}\right\|_{\mathcal{E}}\right), \quad t \in[0, T] \tag{3.1}
\end{equation*}
$$

for some monotone function $Q$ which is independent of $u$.

Proof. Let $F(s)=\int_{0}^{s} f(\tau) d \tau$. Choose $\mu_{0} \in \mathbb{R}^{+} \cap\left(-\mu, \lambda_{1}\right)$. By (1.3), there exists $M>0$ such that

\begin{cases}F(s) \geq-\frac{\lambda_{1}+\mu_{0}}{4} s^{2}-C, & |s| \geq M \\ |F(s)| \leq C, & |s| \leq M\end{cases}

Then

\int_{\Omega} F(u) d x \geq-\frac{\lambda_{1}+\mu_{0}}{4} \int_{\Omega}|u|^{2} d x-C \geq-\frac{\lambda_{1}+\mu_{0}}{4 \lambda_{1}}\|\nabla u\|^{2}-C . \tag{3.2}
\end{equation*}
$$

We first assume that $\left\|\xi_{0}\right\|_{\mathcal{E}} \leq R$ and obtain some a priori estimates to the solutions of problem (1.1). Multiplying (1.1) by $u_{t}$ in $L^{2}$ yields

\end{equation*}

where

E\left(u, u_{t}\right)=\frac{1}{2}\left\|\xi_{u}\right\|_{\mathcal{E}}^{2}+\int_{\Omega} F(u) d x-(g, u) .
$$

By (1.2), integrating (3.3) over $(0, t)$ gives

E\left(u(t), u_{t}(t)\right) \leq E\left(u_{0}, u_{1}\right) \leq \frac{1}{2}\left\|\xi_{0}\right\|_{\mathcal{E}}^{2}+C\left(1+\left\|u_{0}\right\|_{L^{6}}^{6}\right)+\frac{1}{2}\left(\left\|u_{0}\right\|^{2}+\|g\|^{2}\right) \leq C_{R}, \quad t \geq 0 . \tag{3.4}
\end{equation*}
$$

Using Poincaré's inequality and Young inequality, we have

|(g, u)| \leq \frac{\lambda_{1}-\mu_{0}}{8 \lambda_{1}}\|\nabla u\|^{2}+C(\|g\|) \tag{3.5}
\end{equation*}
$$

Thus, we can deduce from (3.2) and (3.5) that

E\left(u, u_{t}\right) \geq \frac{\lambda_{1}-\mu_{0}}{8 \lambda_{1}}\left\|\xi_{u}\right\|_{\mathcal{E}}^{2}-C \tag{3.6}
\end{equation*}

Combining (3.4) and (3.6), we have

\end{equation*}

We will use the so-called Galerkin method. Let $\lambda_{1} \leq \lambda_{2} \leq \cdots$ be the eigenvalues of the operator $-\Delta$ with homogeneous Dirichlet boundary conditions on $\Omega$ and $e_{1}, e_{2}, \cdots$ be the corresponding eigenfunctions. Let $P_{N}: L^{2} \rightarrow L^{2}$ be the orthoprojector to the linear subspace $\operatorname{span}\left\{e_{1}, e_{2}, \cdots, e_{N}\right\}$. Then, the Galerkin approximations to problem (1.1) are definded as follows:

\xi_{u^{N}}(0)=\xi_{0}^{N}:=P_{N} \xi_{0}
\end{array}\right.
$$

Obviously, Eq. (3.8) is locally uniquely solvable and the solutions $u^{N}(t, x)$ are $C^{\infty}$-smooth in $x$. Note that for all $N,\left\|\xi_{0}^{N}\right\|_{\mathcal{E}} \leq\left\|\xi_{0}\right\|_{\mathcal{E}} \leq R$. Thus estimate (3.7) holds for $u^{N}$, that is

In order to estimate the $L^{4}\left(L^{12}\right)-\operatorname{norm}$ of $u^{N}$, we split the solution $u^{N}=v^{N}+w^{N}$ where $v^{N}$ solves

Multiplying (3.10) by $v_{t}^{N}$ in $L^{2}$ yields

\frac{1}{2}\left(\left\|\xi_{v^{N}}\right\|_{\mathcal{E}}^{2}+2\left(g, v_{t}^{N}\right)\right)+k\left\|u_{t}^{N}\right\|^{p} \cdot\left\|v_{t}^{N}\right\|^{2}=0
$$

Integrating this equation over $(0, t)$ and using Young inequality, we have

\left\|\xi_{v^{N}}(t)\right\|_{\mathcal{E}} \leq \sqrt{3}\left\|\xi_{v^{N}}(0)\right\|_{\mathcal{E}}+C(\|g\|) \leq C_{R}, \quad t \geq 0 \tag{3.12}
\end{equation*}

Due to Lemma 2.1 and estimates (3.9) and (3.12), we get for any $t \leq 1$,

\left\|v^{N}\right\|_{L^{4}\left(0, t ; L^{12}\right)} & \leq C\left(\left\|\xi_{0}^{N}\right\|_{\mathcal{E}}+\int_{0}^{t}\left(\left\|P_{N} g\right\|+k\left\|u_{t}^{N}\right\|^{p} \cdot\left\|v_{t}^{N}\right\|\right) d \tau\right) \\
& \leq C\left(\left\|\xi_{0}\right\|_{\mathcal{E}}+t \cdot\|g\|+t \cdot k C_{R}\right)  \tag{3.13}\\
& \leq C_{R}
\end{align*}
$$

Then, using the interpolation inequality, we have

\left\|v^{N}\right\|_{L^{5}\left(0, t ; L^{10}\right)} \leq C\left\|v^{N}\right\|_{L^{4}\left(0, t ; L^{12}\right)}^{\frac{4}{5}} \cdot\left\|v^{N}\right\|_{L^{\infty}\left(0, t ; H_{0}^{1}\right)}^{\frac{1}{5}} \leq C_{R}, \quad 0 \leq t \leq 1 \tag{3.14}
\end{equation*}
$$

For the variable $w^{N}$, estimates (3.9) and (3.12) imply

\end{equation*}

Due to the growth condition (1.2) and estimate (3.14), we have for $0 \leq t \leq 1$,

\left\|P_{N} f\left(v^{N}+w^{N}\right)\right\|_{L^{1}\left(0, t ; L^{2}\right)} & \leq \int_{0}^{t}\left\|f\left(v^{N}+w^{N}\right)\right\| d \tau \\
& \leq C \int_{0}^{t}\left(1+\left\|\left|v^{N}\right|^{5-\kappa}+\left|w^{N}\right|^{5-\kappa}\right\|\right) d \tau \\
& \leq C \int_{0}^{t}\left(1+\left\|v^{N}\right\|_{L^{10}}^{5-\kappa}+\left\|w^{N}\right\|_{L^{10}}^{5-\kappa}\right) d \tau \\
& \leq C\left(t+t^{\frac{\kappa}{5}}\left\|v^{N}\right\|_{L^{5}\left(0, t ; L^{10}\right)}\right)+C\left\|w^{N}\right\|_{L^{5}\left(0, t ; L^{10}\right)}^{5} \\
& \leq C\left(t+t^{\frac{\kappa}{5}} C_{R}\right)+C\left\|w^{N}\right\|_{L^{5}\left(0, t ; L^{10}\right)}^{5} .
\end{aligned}
$$

Applying now Lemma 2.1 to Eq. (3.11) and using (3.15) and the interpolation inequality, we end up with

\left\|w^{N}\right\|_{L^{4}\left(0, t ; L^{12}\right)} & \left.\leq C\left(\left\|P_{N} f\left(v^{N}+w^{N}\right)\right\|_{L^{1}\left(0, t ; L^{2}\right)}+k \int_{0}^{t}\left\|u_{t}^{N}\right\|^{p} \cdot\left\|w_{t}^{N}\right\|\right) d \tau\right) \\
& \leq C\left(t+t^{\frac{\kappa}{5}} C_{R}+t \cdot k C_{R}\right)+C\left\|w^{N}\right\|_{L^{5}\left(0, t ; L^{10}\right)}^{5}  \tag{3.16}\\
& \leq C\left(t+t^{\frac{\kappa}{5}} C_{R}+t C_{R}\right)+C_{R}\left\|w^{N}\right\|_{L^{4}\left(0, t ; L^{12}\right)}^{4} .
\end{align*}
$$

For any $\varepsilon>0$, take $T=T(\varepsilon, R) \leq 1$, such that

Let $Y_{N}(t)=\left\|w^{N}\right\|_{L^{4}\left(0, t ; L^{12}\right)}$, then $Y_{N}(t)$ is continuous on $t$ and

Y_{N}(t) \leq \varepsilon+C_{R}\left(Y_{N}(t)\right)^{4}, \quad \forall t \in[0, T], \quad Y_{N}(0)=0
$$

By Lemma 2.3, if we choose $\varepsilon<\frac{1}{2}\left(\frac{1}{2 C_{R}}\right)^{\frac{1}{3}}$, then

Combining estimates (3.9), (3.13) and (3.17), we get for some $T=T(R)$,

\left\|\xi_{u^{N}}\right\|_{L^{\infty}(0, T ; \mathcal{E})}+\left\|u^{N}\right\|_{L^{4}\left(0, T ; L^{12}\right)} \leq C_{R} \tag{3.18}
\end{equation*}
$$

Denote $\Omega_{T}=\Omega \times[0, T]$. From growth condition (1.2), we also have

\begin{aligned}
& \left\|f\left(u^{N}\right)\right\|_{L^{\frac{6}{5}}\left(\Omega_{T}\right)} \leq C\left(\int_{0}^{T}\left(1+\left\|u^{N}\right\|_{L^{6}}^{6}\right) d \tau\right)^{\frac{5}{6}} \leq C\left(T\left(1+C_{R}\right)\right)^{\frac{5}{6}} \\
& \|k\| u_{t}^{N}\left\|^{p} u_{t}^{N}\right\|_{L^{2}\left(\Omega_{T}\right)} \leq k\left(\int_{0}^{T}\left\|u_{t}^{N}\right\|^{2 p+2} d \tau\right)^{\frac{1}{2}} \leq k\left(T C_{R}\right)^{\frac{1}{2}} .
\end{aligned}
$$

Now, by Alaoglu's theorem and Lemma 2.4, we can extract a subsequence, still denoted by $\left\{u^{N}\right\}$, such that

& u^{N} \rightarrow u \text { weakly in } L^{4}\left(0, T ; L^{12}\right) \\
& f\left(u^{N}\right) \rightarrow f(u) \text { weakly in } L^{\frac{6}{5}}\left(\Omega_{T}\right) \text { and } P_{N} f\left(u^{N}\right) \rightarrow f(u) \text { weakly in } L^{\frac{6}{5}}\left(\Omega_{T}\right) \\
& k\left\|u_{t}^{N}\right\|^{p} u_{t}^{N} \rightarrow \eta \text { weakly in } L^{2}\left(\Omega_{T}\right) .
\end{aligned}
$$

From Eq. (3.8), we also have $u_{t t}^{N} \rightarrow u_{t t}$ weakly* in $L^{\infty}\left(0, T ; H^{-1}\right)$. Passing the limit $N \rightarrow \infty$ in Eq. (3.8), we get

We claim that $\eta=k\left\|u_{t}\right\|^{p} u_{t}$ in $L^{2}\left(\Omega_{T}\right)$, and hence $u(t), t \in[0, T]$ is a Shatah-Struwe solution of problem (1.1) and estimate (3.1) follows from (3.18) and the lower semi-continuity of the norm of weakly and weakly* limit.

Indeed, for any $\varphi \in L^{2}\left(\Omega_{T}\right)$, by Lemma 2.2,

and we need to verify that the solution $u$ also satisfies a similar equality, that is

Since $u \in L^{\infty}\left(0, T ; H_{0}^{1}\right) \cap L^{4}\left(0, T ; L^{12}\right)$, by growth condition (1.2) and the interpolation inequality, we have

Then, $u_{t} \in L^{\infty}\left(0, T ; L^{2}\right)$ implies that $f(u) u_{t} \in L^{1}([0, T] \times \Omega)$, and we can approximate $u$ by smooth function and argue in a standard way to deduce that for almost all $t \in[0, T]$,

For every $0 \leq \tau \leq t \leq T$, multiplying this equation by $u_{t}^{n}$ and integrating on $\Omega \times[\tau, t]$, we get

\end{equation*}
$$

Note that $\xi_{u^{n}}(t) \rightarrow \xi_{u}(t), \xi_{u^{n}}(\tau) \rightarrow \xi_{u}(\tau)$ in $\mathcal{E}, u_{t}^{n} \rightarrow u_{t}$ in $L^{2}$ strongly for a.e. $t \in[0, T]$ and $f(u) \in L^{1}\left(0, T ; L^{2}\right)$, we may pass to the limit $n \rightarrow \infty$ in (3.24) and use Lebesgue dominated convergence theorem to obtain that

holds for every $0 \leq \tau \leq t \leq T$. Thus, (3.22) is proved. On the other hand, by (3.2), the Fatou lemma and the lower semi-continuity of the norm of weakly* limit,

& \leq \liminf _{N \rightarrow \infty} \int_{\Omega} F\left(u^{N}\right) d x+\frac{\lambda_{1}+\mu_{0}}{4}\|u\|^{2} \\
\left\|\xi_{u^{N}}\right\|_{\mathcal{E}}^{2} & \leq \liminf _{N \rightarrow \infty}\left\|\xi_{u}\right\|_{\mathcal{E}}^{2}
\end{aligned}
$$

Now, it follows from (3.21), (3.22) and above estimates,

\begin{aligned}
& \limsup _{N \rightarrow \infty} \int_{0}^{T}\left(k\left\|u_{t}^{N}\right\|^{p} u_{t}^{N}, u_{t}^{N}\right) d \tau=\limsup _{N \rightarrow \infty}\left(E\left(u_{0}^{N}, u_{1}^{N}\right)-E\left(u^{N}(T), u_{t}^{N}(T)\right)\right) \\
&=E\left(u_{0}, u_{1}\right)-\liminf _{N \rightarrow \infty} E\left(u^{N}(T), u_{t}^{N}(T)\right) \\
& \leq E\left(u_{0}, u_{1}\right)-E\left(u(T), u_{t}(T)\right) \\
&=\int_{0}^{T}\left(\eta, u_{t}\right) d \tau \\
& \lim _{N \rightarrow \infty} \int_{0}^{T}\left(k\left\|u_{t}^{N}\right\|^{p} u_{t}^{N}, \varphi\right) d \tau=\int_{0}^{T}(\eta, \varphi) d \tau \\
& \lim _{N \rightarrow \infty} \int_{0}^{T}\left(k\|\varphi\|^{p} \varphi, u_{t}^{N}\right) d \tau=\int_{0}^{T}\left(k\|\varphi\|^{p} \varphi, u_{t}\right) d \tau .
\end{aligned}
$$

Then, by (3.20),

0 \leq \limsup _{N \rightarrow \infty} \int_{0}^{T}\left(k\left\|u_{t}^{N}\right\|^{p} u_{t}^{N}-k\|\varphi\|^{p} \varphi, u_{t}^{N}-\varphi\right) d \tau \leq \int_{0}^{T}\left(\eta-k\|\varphi\|^{p} \varphi, u_{t}-\varphi\right) d \tau .

Taking $\varphi=u_{t}-\lambda \psi$ with $\lambda>0$ and $\psi \in L^{2}\left(\Omega_{T}\right)$, we get

This means that $\eta=k\left\|u_{t}\right\|^{p} u_{t}$ in $L^{2}\left(\Omega_{T}\right)$ and the proof is complete.
Remark 3.4. Since (3.22) holds and $\eta=k\left\|u_{t}\right\|^{p} u_{t}$, we know that a Shatah-Struwe solution $u(t), t \in[0, T]$ satisfies the energy equality:

In particular, $\xi_{u} \in C(0, T ; \mathcal{E})$. Indeed, from (3.25), we know that $t \rightarrow\left\|\xi_{u}(t)\right\|_{\mathcal{E}}$ is continuous. On the other hand, since $\xi_{u} \in L^{\infty}(0, T ; \mathcal{E}) \cap C\left(0, T ; L^{2} \times H^{-1}\right)$ and $\mathcal{E}$ is a reflexive space, we have $\xi_{u} \in C_{w}(0, T ; \mathcal{E})$. Then, the uniform convexity of $\mathcal{E}$ gives that $\xi_{u} \in C(0, T ; \mathcal{E})$.
Corollary 3.5. Let the assumptions of Theorem 3.3 hold. Then, for any initial data $\xi_{0} \in$ $\mathcal{E}$, there exists a unique global Shatah-Struwe solution $u(t)$ of problem (1.1) and we have the following estimate

$$
\begin{equation*}
\left\|\xi_{u}(t)\right\|_{\mathcal{E}}+\|u\|_{L^{4}\left(t, t+1 ; L^{12}\right)} \leq Q\left(\left\|\xi_{0}\right\|_{\mathcal{E}}\right), \quad t \geq 0 \tag{3.26}
\end{equation*}
$$

where the monotone function $Q$ is independent of $u$ and $t$.

Proof. Suppose that $u(t), t \in[0, T]$ is a Shatah-Struwe solution with initial data $\xi_{u}(0)=\xi_{0}$. By Remark (3.4, $u$ satisfies the energy equality (3.25). Integrating (3.25) over $(0, t)$ yields

for some monotone function $Q_{1}$. Then, from (3.6), we have

for some monotone function $Q_{2}$ which is independent of $u$ and $t$. According to this estimate, the energy norm $\left\|\xi_{u}(t)\right\|_{\mathcal{E}}$ cannot blow up in a finite time. Therefore, the local Shatah-Struwe solution $u(t)$ can be extended globally in time and the estimate (3.26) follows from (3.1) and (3.27). We remain to show the uniqueness of Shatah-Struwe solution.

Let $u(t), v(t), t \in[0, T]$ be two Shatah-Struwe solutions of problem (1.1) with initial data $\left\|\xi_{u}(0)\right\|_{\mathcal{E}},\left\|\xi_{v}(0)\right\|_{\mathcal{E}} \leq R$. Then,

\|u\|_{L^{4}\left(0, T ; L^{12}\right)}+\|v\|_{L^{4}\left(0, T ; L^{12}\right)} \leq C(R, T)
$$

Let $w(t)=u(t)-v(t)$, then $w$ solves

Multiplying this equation by $w_{t}$ and integrating over $x \in \Omega$ (which can be justified according to Remark (3.4), we get

\frac{1}{2} \frac{d}{d t}\left\|\xi_{w}(t)\right\|_{\mathcal{E}}^{2}+\left(k\left\|u_{t}\right\|^{p} u_{t}-\left\|v_{t}\right\|^{p} v_{t}, w_{t}\right)+\left(f(u)-f(v), w_{t}\right)=0 \tag{3.28}
\end{equation*}
$$

By Lemma 2.2 and condition (1.2),

$$
\begin{align*}
&\left(k\left\|u_{t}\right\|^{p} u_{t}-\left\|v_{t}\right\|^{p} v_{t}, w_{t}\right) \geq k C_{p}\left\|u_{t}-v_{t}\right\|^{p+2} \geq 0,  \tag{3.29}\\
&\left|\left(f(u)-f(v), w_{t}\right)\right| \leq C\left(\left(1+|u|^{4}+|v|^{4}\right)|w|,\left|w_{t}\right|\right) \\
& \leq C\left(1+\|u\|_{L^{12}}^{4}+\|v\|_{L^{12}}^{4}\right)\|w\|_{L^{6}}\left\|w_{t}\right\|  \tag{3.30}\\
& \leq C\left(1+\|u\|_{L^{12}}^{4}+\|v\|_{L^{12}}^{4}\right)\left\|\xi_{w}\right\|_{\mathcal{E}} .
\end{align*}
$$

Inserting (3.29) and (3.30) into (3.28), we have

\frac{1}{2} \frac{d}{d t}\left\|\xi_{w}\right\|_{\mathcal{E}}^{2} \leq C\left(1+\|u\|_{L^{12}}^{4}+\|v\|_{L^{12}}^{4}\right)\left\|\xi_{w}\right\|_{\mathcal{E}}^{2}
$$

Applying the Gronwall inequality, we get
$\left\|\xi_{w}(t)\right\|_{\mathcal{E}}^{2} \leq\left\|\xi_{w}(0)\right\|_{\mathcal{E}}^{2} \exp \left\{C \int_{0}^{t}\left(1+\|u\|_{L^{12}}^{4}+\|v\|_{L^{12}}^{4}\right) d \tau\right\} \leq C(R, T)\left\|\xi_{u}(0)-\xi_{v}(0)\right\|_{\mathcal{E}}^{2}, \quad t \in[0, T]$.
Therefore, $\xi_{w}(t) \equiv 0$ on $[0, T]$ if the initial data $\xi_{u}(0)=\xi_{v}(0)$ and the proof is complete.
We now define the solution semigroup $S(t): \mathcal{E} \rightarrow \mathcal{E}$ associated with problem (1.1):

S(t) \xi_{0}:=\xi_{u}(t),
$$

where $u(t)$ is the unique Shatah-Struwe solution $u(t)$ of problem (1.1) corresponding to initial data $\xi_{0}$. Moreover, according to the proof of Corollary 3.5, $S(t): \mathcal{E} \rightarrow \mathcal{E}$ is locally Lipschitz continuous.

## 4. Global attractor

Theorem 4.1. Under the conditions (1.2) and (1.3), the dynamical system $(\mathcal{E}, S(t))$ is dissipative.

Proof. Following exactly from the proof process of Theorem 3.1 in [22], where we take $n=3$, $K(x, y) \equiv 0$ and replace the growth condition (1.4) in [22] with condition (1.2) in this paper, we can obtain the dissipativity of $(\mathcal{E}, S(t))$.

Now, we are ready to verify the asymptotical compactness of $(\mathcal{E}, S(t))$ by applying the contractive function method.

Definition 4.2. [7, 8 Let $X$ be a Banach space, $B \subset X$ be a bounded subset. A function $\Psi: X \times X \rightarrow \mathbb{R}$ is said to be a contractive function on $B \times B$ if for any sequence $\left\{x_{n}\right\}_{n=1}^{\infty} \subset B$, there is a subsequence $\left\{x_{n_{k}}\right\}_{n=1}^{\infty} \subset\left\{x_{n}\right\}_{n=1}^{\infty}$ such that

$$
\liminf _{k \rightarrow \infty} \liminf _{l \rightarrow \infty} \Psi\left(x_{n_{k}}, x_{n_{l}}\right)=0 .
$$

Denote the set of all contractive functions on $B \times B$ by $\mathcal{C}(B)$.
Lemma 4.3. 7, 8] Let $\{S(t)\}_{t \geq 0}$ be a continuous semigroup on a Banach space $(X,\|\cdot\|)$. If for any positively invariant bounded set $B \subset X$ and for any $\varepsilon>0$, there exist $T=T(\varepsilon, B)$ and a contractive function $\Psi_{\varepsilon, T, B} \in \mathcal{C}(B)$ such that

\left\|S(T) y_{1}-S(T) y_{2}\right\| \leq \varepsilon+\Psi_{\varepsilon, T, B}\left(y_{1}, y_{2}\right), \quad \forall y_{1}, y_{2} \in B

Then, $\{S(t)\}_{t \geq 0}$ is asymptotically compact.
To establish the main result in this section, we need the following result.
Lemma 4.4. Under the condition (1.2), the operator

$$
\begin{gathered}
T_{f}: \mathcal{M} \longrightarrow L^{1}\left(0, T ; L^{2}\right) \\
u \longmapsto f(u)
\end{gathered}
$$

is compact, where $\mathcal{M}=\left\{u \in L^{\infty}\left(0, T ; H_{0}^{1}\right) \cap L^{4}\left(0, T ; L^{12}\right) \mid u_{t} \in L^{\infty}\left(0, T ; L^{2}\right)\right\}$.
Proof. For any $u, v \in \mathcal{M}$, by the growth condition (1.2) we have

\|f(u)-f(v)\|_{L^{1}\left(0, T ; L^{2}\right)} & =\int_{0}^{T}\|(f(u)-f(v))\| d t \\
& \leq C \int_{0}^{T}\left\|\left(1+|u|^{4-\kappa}+|v|^{4-\kappa}\right)|u-v|\right\| d t \\
& \leq C \int_{0}^{T}\left\|1+|u|^{4-\kappa}+|v|^{4-\kappa}\right\|_{L^{\frac{12}{1-\kappa}}}\|u-v\|_{L^{\frac{12}{k+2}}} d t \\
& \leq C \int_{0}^{T}\left(1+\|u\|_{L^{12}}^{4-\kappa}+\|v\|_{L^{12}}^{4-\kappa}\right)\|u-v\|_{L^{\frac{12}{k+2}}} d t \\
& \leq C\left(T+\|u\|_{L^{4}\left(0, T ; L^{12}\right)}+\|v\|_{L^{4}\left(0, T ; L^{12}\right)}\right) \cdot \sup _{t \in[0, T]}\|u-v\|_{L^{\frac{12}{k+2}}} .
\end{aligned}
$$

Since $2 \leq \frac{12}{\kappa+2}<6$, we have $H_{0}^{1} \hookrightarrow \hookrightarrow L^{\frac{12}{k+2}} \hookrightarrow L^{2}$. Using Lemma [2.4, we know that $\mathcal{M} \hookrightarrow\{u \in$ $\left.L^{\infty}\left(0, T ; H_{0}^{1}\right) \mid u_{t} \in L^{\infty}\left(0, T ; L^{2}\right)\right\} \hookrightarrow \hookrightarrow C\left(0, T ; L^{\frac{12}{k+2}}\right)$. Therefore, $T_{f}$ is a compact operator.

Theorem 4.5. Under the conditions (1.2) and (1.3), the dynamical system $(\mathcal{E}, S(t))$ is asymptotically compact.
Proof. Let $B \subset \mathcal{E}$ be a positively invariant bounded set.
A priori estimates. For any $\xi, \xi^{\prime} \in B$, let $\xi_{u}(t)=S(t) \xi, \xi_{v}(t)=S(t) \xi^{\prime}$, and $z(t)=$ $u(t)-v(t)$. Then $z(t)$ satisfies

$$
\begin{equation*}
z_{t t}-\Delta z+k\left\|u_{t}\right\|^{p} u_{t}-k\left\|v_{t}\right\|^{p} v_{t}+f(u)-f(v)=0, \xi_{z}(0)=\xi-\xi^{\prime} . \tag{4.1}
\end{equation*}
$$

Denote

$$
E_{z}(t)=\frac{1}{2}\left\|\xi_{z}(t)\right\|_{\mathcal{E}}^{2}
$$

Multiplying (4.1) by $z_{t}$ and integrating over $x \in \Omega$,

$$
\begin{equation*}
\frac{d}{d t} E_{z}(t)+\left(k\left\|u_{t}\right\|^{p} u_{t}-k\left\|v_{t}\right\|^{p} v_{t}, z_{t}\right)+\left(f(u)-f(v), z_{t}\right)=0 \tag{4.2}
\end{equation*}
$$

Integrating (4.2) on $[t, T]$,

$$
\begin{equation*}
E_{z}(T)+k \int_{t}^{T}\left(\left\|u_{t}\right\|^{p} u_{t}-\left\|v_{t}\right\|^{p} v_{t}, z_{t}\right) d \tau=E_{z}(t)-\int_{t}^{T}\left(f(u)-f(v), z_{t}\right) d \tau \tag{4.3}
\end{equation*}
$$

Integrating (4.3) on $[0, T]$ with respect to $t$,

$$
\begin{equation*}

Multiplying (4.1) by $z$ and integrating over $x \in \Omega, t \in[0, T]$,

For any sequence $\left\{\xi_{n}\right\}_{n=1}^{\infty} \subset B$, let $\xi_{u^{n}}(t)=S(t) \xi_{n}$. Since $B$ is positively invariant and $\left\{u^{n}(t)\right\}_{n=1}^{\infty}, t \in[0, T]$ are Shatah-Struwe solutions, we have

Theorem 4.6. Under the conditions (1.2) and (1.3), the dynamical system $(\mathcal{E}, S(t))$ generated by the Shatah-Struwe solutions of problem (1.1) possesses a global attractor.

Proof. From Corollary 3.5, the Shatah-Struwe solution semigroup $S(t): \mathcal{E} \rightarrow \mathcal{E}$ is well-defined and continuous for any fixed $t \geq 0$. Then, by the standard abstract results about the existence of attractor (see e.g. [1, 9, 19]), we can conclude that Theorem 4.6 is an immediate consequence of Theorem 4.1 and Theorem 4.5,

## 5. Polynomical attractor

In this section, we will show that the dynamical system $(\mathcal{E}, S(t))$ possesses a polynomial attractor. We begin with the definition.
Definition 5.1. [24, Definition 2.6] Let $\{S(t)\}_{t \geq 0}$ be a continuous semigroup on a complete metric space $(X, d)$. Assume that $\varphi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$satisfies $\varphi(t) \rightarrow 0$ as $t \rightarrow \infty$. A compact set $\mathcal{A}^{*} \subset X$ is said to be a generalized $\varphi$-attractor for the dynamical system $(X, S(t))$ if
(i) $\mathcal{A}^{*}$ is positively invariant, i.e. $S(t) \mathcal{A}^{*} \subset \mathcal{A}^{*}, \forall t \geq 0$;
(ii) there exists $t_{0} \in \mathbb{R}$ such that for any bounded set $B \subset X$ there exists $t_{B} \geq 0$ such that

\operatorname{dist}\left(S(t) B, \mathcal{A}^{*}\right) \leq \varphi\left(t+t_{0}-t_{B}\right), \quad \forall t \geq t_{B},
$$

where $\operatorname{dist}(A, B):=\sup _{x \in A} \inf _{y \in B} d(x, y)$ is the Hausdorff semidistance. In particular, if $\varphi(t)=$ $C t^{-\beta}$ for certain positive constants $C, \beta$, then $\mathcal{A}^{*}$ is called a generalized polynomial attractor;
if $\varphi(t)=C e^{-\beta t}$ for certain positive constants $C, \beta$, then $\mathcal{A}^{*}$ is called a generalized exponential attractor.

Lemma 5.2. [24, Theorem 3.1] Let $\{S(t)\}_{t \geq 0}$ be a dissipative continuous semigroup on a complete metric space $(X, d)$ and $\mathcal{B}_{0}$ be a positively invariant bounded absorbing set. Assume that there exist positive constants $C, T, \delta_{0}, \beta \in(0,1)$, functions $g_{l}:\left(\mathbb{R}^{+}\right)^{m} \rightarrow \mathbb{R}^{+}(l=1,2)$ and pseudometrics $\varrho_{T}^{i}(i=1,2, \cdots, m)$ on $\mathcal{B}_{0}$ such that
(i) $g_{l}$ is non-decreasing with respect to each variable, $g_{l}(0, \cdots, 0)=0$ and $g_{l}$ is continuous at $(0, \cdots, 0)$;
(ii) $\varrho_{T}^{i}(i=1,2, \cdots, m)$ is precompact on $\mathcal{B}_{0}$, i.e. any sequence $\left\{x_{n}\right\} \subset \mathcal{B}_{0}$ has a subsequence $\left\{x_{n_{k}}\right\}$ which is Cauchy with respect to $\varrho_{T}^{i}$;
(iii) for any $y_{1}, y_{2} \in \mathcal{B}_{0}$ satisfying $\varrho_{T}^{i}\left(y_{1}, y_{2}\right) \leq \delta_{0}(i=1,2, \cdots, m)$, the following inequalities holds:

&\left.+g_{1}\left(\varrho_{T}^{1}\left(y_{1}, y_{2}\right), \varrho_{T}^{2}\left(y_{1}, y_{2}\right), \cdots, \varrho_{T}^{m}\left(y_{1}, y_{2}\right)\right)\right]^{\beta}  \tag{5.2}\\
&+g_{2}\left(\varrho_{T}^{1}\left(y_{1}, y_{2}\right), \varrho_{T}^{2}\left(y_{1}, y_{2}\right), \cdots, \varrho_{T}^{m}\left(y_{1}, y_{2}\right)\right) .
\end{align*}

Then, the dynamical system $(X, S(t))$ possesses a generalized polynomial attractor $\mathcal{A}^{*}$ and there exists $t_{0}>0$ such that

\end{equation*}

holds for every bounded set $B \subset X$, where $t_{*}(B)$ satisfies $S(t) B \subset \mathcal{B}_{0}\left(\forall t \geq t_{*}(B)\right)$ and $\alpha\left(\mathcal{B}_{0}\right)$ denotes the noncompactness measure of $\mathcal{B}_{0}$.

We are ready to state the main result in this section.
Theorem 5.3. Under the conditions (1.2) and (1.3), the dynamical system $(\mathcal{E}, S(t))$ generated by the Shatah-Struwe solutions of problem (1.1) possesses a generalized polynomial attractor $\mathcal{A}^{*}$ and there exists $t_{0}>0$ such that

\operatorname{dist}\left(S(t) B, \mathcal{A}^{*}\right) \leq\left\{\left(\alpha\left(\mathcal{B}_{0}\right)\right)^{-p}+\frac{p k C_{p}}{2^{p+2}}\left(t-t_{0}-t_{*}(B)-1\right)\right\}^{-\frac{1}{p}}
$$

holds for every bounded set $B \subset X$, where $\mathcal{B}_{0} \subset \mathcal{E}$ is a positively invariant bounded absorbing set of $(\mathcal{E}, S(t))$ and $t_{*}(B)$ satisfies $S(t) B \subset \mathcal{B}_{0}\left(\forall t \geq t_{*}(B)\right)$.
Proof. By Theorem 4.1, the dynamical system $(\mathcal{E}, S(t))$ is dissipative and let $\mathcal{B}_{0} \subset \mathcal{E}$ be a positively invariant bounded absorbing set of $(\mathcal{E}, S(t))$.

For any $y_{1}, y_{2} \in \mathcal{B}_{0}$, let $\xi_{u}(t)=S(t) y_{1}, \xi_{v}(t)=S(t) y_{2}$ and $z(t)=u(t)-v(t)$. Let $T$ be an arbitrary positive constant, then since $\mathcal{B}_{0}$ is positively invariant and $u(t), v(t)$ are Shatah-Struwe solutions, we have

\leq C_{T} \sup _{t \in[0, T]}\|z(t)\|_{L^{\frac{12}{k+2}}} \\

Since $2 \leq \frac{12}{\kappa+2}<6$, we have $H_{0}^{1} \hookrightarrow \hookrightarrow L^{\frac{12}{k+2}} \hookrightarrow L^{2}$. Using Lemma [2.4, we know that $\{u \in$ $\left.L^{\infty}\left(0, T ; H_{0}^{1}\right) \mid u_{t} \in L^{\infty}\left(0, T ; L^{2}\right)\right\} \hookrightarrow \hookrightarrow C\left(0, T ; L^{\frac{12}{\kappa+2}}\right)$. Thus, $\varrho_{T}\left(y_{1}, y_{2}\right)=\sup _{t \in[0, T]}\|z(t)\|_{L^{\frac{12}{\kappa+2}}}$ is precompact on $\mathcal{B}_{0}$. Then, by the definition of $E_{z}(t)$, we infer from (5.11) and (5.10),

\begin{equation*}
\left\|S(T) y_{1}-S(T) y_{2}\right\|_{\mathcal{E}}^{2} \leq\left\|y_{1}-y_{2}\right\|_{\mathcal{E}}^{2}+2 C_{T} \varrho_{T}\left(y_{1}, y_{2}\right) \tag{5.12}
\end{equation*}
$$

and

$$
\begin{align*}
\left\|S(T) y_{1}-S(T) y_{2}\right\|_{\mathcal{E}}^{2} \leq & 2\left(2 k T C_{p}\right)^{-\frac{2}{p+2}}\left(\left\|y_{1}-y_{2}\right\|_{\mathcal{E}}^{2}-\left\|S(T) y_{1}-S(T) y_{2}\right\|_{\mathcal{E}}^{2}+2 C_{T} \varrho_{T}\left(y_{1}, y_{2}\right)\right)^{\frac{2}{p+2}} \\
& +2 C_{T} \varrho_{T}\left(y_{1}, y_{2}\right) \tag{5.13}
\end{align*}
$$

By Lemma 5.2. we deduce from (5.12) and (5.13) that the dynamical system $(\mathcal{E}, S(t))$ possesses a generalized polynomial attractor $\mathcal{A}^{*}$ and there exists $t_{0}>0$ such that

$$
\begin{equation*}
\operatorname{dist}\left(S(t) B, \mathcal{A}^{*}\right) \leq\left\{\left(\alpha\left(\mathcal{B}_{0}\right)\right)^{-p}+\frac{p}{2\left(T^{\frac{2}{p+2}}+2^{\frac{2 p+2}{p+2}}\left(k C_{p}\right)^{-\frac{2}{p+2}}\right)^{\frac{p+2}{2}}}\left(t-t_{0}-2 T-t_{*}(B)-1\right)\right\}^{-\frac{1}{p}} \tag{5.14}
\end{equation*}
$$

holds for every bounded set $B \subset X$, where $t_{*}(B)$ satisfies $S(t) B \subset \mathcal{B}_{0}\left(\forall t \geq t_{*}(B)\right)$. Since $T>0$ is arbitrary, we can pass the limit $T \rightarrow 0$ in (5.14) and obtain that

$$
\operatorname{dist}\left(S(t) B, \mathcal{A}^{*}\right) \leq\left\{\left(\alpha\left(\mathcal{B}_{0}\right)\right)^{-p}+\frac{p k C_{p}}{2^{p+2}}\left(t-t_{0}-t_{*}(B)-1\right)\right\}^{-\frac{1}{p}}
$$

The proof is complete.
