# OPTIMAL GEVREY STABILITY OF HYDROSTATIC APPROXIMATION FOR THE NAVIER-STOKES EQUATIONS IN A THIN DOMAIN

#### Abstract

In this paper, we study the hydrostatic approximation for the Navier-Stokes system in a thin domain. When the convex initial data with Gevrey regularity of optimal index $\frac{3}{2}$ in $x$ variable and Sobolev regularity in $y$ variable, we justify the limit from the anisotropic Navier-Stokes system to the hydrostatic Navier-Stokes/Prandtl system. Due to our method in the paper is independent of $\varepsilon$, by the same argument, we also get the hydrostatic Navier-Stokes/Prandtl system is well-posedness in the optimal Gevrey space. Our results improve the Gevrey index in 15, 35 whose Gevrey index is $\frac{9}{8}$.


## 1. INTRODUCTION

1.1. Presentation the problem and related results. In this article, we study 2-D incompressible Navier-Stokes equations in a thin domain where the aspect ratio and the Reynolds number have certain constraints:

where $t \geq 0,(x, y) \in \mathcal{S}^{\varepsilon}=\{(x, y) \in \mathbb{T} \times \mathbb{R}: 0<y<\varepsilon\}$. Here, $U(t, x, y), P(t, x, y)$ stand for the velocity and pressure function respectively and $\eta$ is a positive constant independent of $\varepsilon$. The width of domain $\mathcal{S}^{\varepsilon}$ is $\varepsilon$, and the boundary condition in (1.1) corresponds to non-slip condition at the walls $y=0, \varepsilon$. In addition, the system is prescribed with the initial data of the form

This is a classical model with applications to oceanography, meteorology and geophysical flows, where the vertical dimension of the domain is very small compared with the horizontal dimension of the domain.

To study the process $\varepsilon \rightarrow 0$, we firstly fix the domain independent of $\varepsilon$. Here, we rescale the system (1.1) as follows:

$$

We put above relations into (1.1), then (1.1) is reduced to a scaled anisotropic Navier-Stokes system:

\varepsilon^{2}\left(\partial_{t} v^{\varepsilon}+u^{\varepsilon} \partial_{x} v^{\varepsilon}+v^{\varepsilon} \partial_{y} v^{\varepsilon}-\varepsilon^{2} \partial_{x}^{2} v^{\varepsilon}-\eta \partial_{y}^{2} v^{\varepsilon}\right)+\partial_{y} p^{\varepsilon}=0, \\
\partial_{x} u^{\varepsilon}+\partial_{y} v^{\varepsilon}=0, \\
\left.\left(u^{\varepsilon}, v^{\varepsilon}\right)\right|_{y=0,1}=0, \\
\left.\left(u^{\varepsilon}, v^{\varepsilon}\right)\right|_{t=0}=\left(u_{0}, v_{0}\right),

where $(x, y) \in \mathcal{S}=\{(x, y) \in \mathbb{T} \times(0,1)\}$.
To simplify the notations, we take $\eta=1$ in this paper and denote $\Delta_{\varepsilon}=\varepsilon^{2} \partial_{x}^{2}+\partial_{y}^{2}$.
Formally, taking $\varepsilon \rightarrow 0$ in (1.3), we derive the hydrostatic Navier-Stokes/Prandtl system (see [22, 31):

\partial_{y} p_{p}=0 \quad \text { in } \mathcal{S} \times(0, \infty) \\
\partial_{x} u_{p}+\partial_{y} v_{p}=0 \quad \text { in } \mathcal{S} \times(0, \infty), \\
\left.\left(u_{p}, v_{p}\right)\right|_{y=0,1}=0, \\
\left.u_{p}\right|_{t=0}=u_{0} \quad \text { in } \mathcal{S}
\end{array}\right.
$$

The goal in this paper is to justify the limit from the scaled anisotropic Navier-Stokes system (1.3) to the hydrostatic Navier-Stokes/Prandtl system (1.4), for a class of convex data in the optimal Gevrey class with index $\gamma=\frac{3}{2}$.

Before presenting the precise statement of the main result in this paper, we recall some results on system (1.4). If $\eta=0$ in the system (1.4), we get the hydrostatic Euler system:

\end{array}\right.
$$

There are a lot of research on the system (1.5), and readers can refer to [3, 4, 4, 16, 20, 19, 26, 31, 38. Renardy (31 proved the linearization of (1.5) has a growth like $e^{|k| t}$ if the initial data is not uniform convexity (or concavity) in variable $y$. Local well-posedness in the analytic setting was established in [20]. Under the convexity condition, Masmoudi and Wong [26] got the well-posedness of (1.5) in the Sobolev space.

Next, we recall some results on the well-posedness of the hydrostatic Navier-Stokes/Prandtl system (1.4). Similar to the classical Prandtl equation, (1.4) lose one derivative because of term $v_{p} \partial_{y} u_{p}$. Paicu, Zhang and the Zhang [30] obtained the global well-posedness of system (1.4) when the initial data is small in the analytical space. Meantime, Renardy [31] also proved that the linearization of the hydrostatic Navier-Stokes equations at certain parallel shear flows is ill-posed, and may have a growth $e^{|k| t}$ which is the same as (1.5) when the initial data is not convex. Thus, in order to obtain well-posedness results that break through the analytic space, one may need the convexity condition on the velocity. For that, under the convexity condition, Gérard-Varet, Masmoudi and Vicol proved the (1.4) is local wellposedness in the Gevrey class with index $9 / 8$ in [15]. In [15], they firstly derive the vorticity
equations $\omega=\partial_{y} u$ :

where the worst term is $\partial_{x} v$ leading to one derivative loss. Then, they use the "hydrostatic trick" which means that they take inner product with $\partial_{x} \omega / \partial_{y} \omega\left(\partial_{y} \omega \geq c_{0}>0\right)$ instead of $\partial_{x} \omega$ to take advantage of the cancellation:

Such an idea was used previously in [26]. To close the energy estimates, "hydrostatic trick" is not enough due to the "bad" boundary condition of $\omega$

which lose one derivative too. To overcome that, [15] introduce the following decomposition

where $\omega^{b l}$ is the boundary corrector which satisfies that

Following the above decomposition, [15] obtain the well-posedness results of (1.4) in the Gevrey class with index $\gamma=\frac{9}{8}$.

To search the best functional space for the system (1.4), based on the Tollmien-Schlichting instabilities for Navier-Stokes [17], Gérard-Varet, Masmoudi and Vicol also give the following conjecture: "Our conjecture - based on a formal parallel with Tollmien-Schlichting instabilities for Navier-Stokes [18] - is that the best exponent possible should be $\gamma=\frac{3}{2}$, but such result is for the time being out of reach."

During studying the anisotropic Navier-Stokes system (1.3) and the hydrostatic NavierStokes/Prandtl system (1.4), another important problem is to justify the inviscid limit. Under analytical setting, Paicu, Zhang and Zhang [30 justified the limit from (1.3) to (1.4). Based on the work [15], we [35] justified the limit in the Gevrey class with index $\gamma=\frac{9}{8}$.

In this paper, we aim to prove the conjecture of Gérard-Varet, Masmoudi and Vicol. To do that, we use some idea from the classical inviscid limit theory. Next, we recall the recent development on the classical Prandtl equation and the inviscid limit theory.

There are a lot of papers studying the well-posedness of Prandtl equation in some special functional space. For monotonic initial data, [29, 1, 27] used different method to get local existence and uniqueness of classical solutions to the Prandtl equation in Sobolev space. Without monotonic condition, [24, 32] proved that Prandtl equation are well-posedness in the analytic class; [14, 23, 6] proved well-posedness of the Prandtl equations in Gevrey class for a class of concave initial data. Without any structure assumption, Dietert and GérardVaret [8] proved well-posedness in Gevrey space with index $\gamma=2$. According to [10], $\gamma=2$ may be the optimal index for the well-posedness theory. For more results on the Prandtl equation, see 18, 37, 36, 39, 40.

On the inviscid limit problem, we refer to [33, 34, 21, 28, 25, 9 for the analytical class. Note that to go from analytic to Gevrey data is a challenging problem. The first results in Gevrey class is given by [12]. Gérard-Varet, Masmoudi and Maekawa [12] proved stability of the

Prandtl expansion for the perturbations in the Gevrey class when $U^{B L}(t, Y)$ is a monotone and concave function where the boundary layer is the shear type like

where $\nu$ is the the viscosity coefficient. Later, Chen, Wu and Zhang [7] improved the results in [12] to get the $L^{2} \cap L^{\infty}$ stability. Very recently, Gérard-Varet, Masmoudi and Maekawa [13] used a very clever decomposition to get the optimal Prandtl expansion around concave boundary layer. Their results generalized the one obtained in [12, 7] which restricted to expansions of shear flow type. In their paper, they decompose the stream function $\phi$ as follows:

where $\phi_{\text {slip }}$ enjoys a "good" boundary condition and $\phi_{b c}$ is a corrector which recover the boundary condition. This kind of decomposition is also used in [7. To estimate $\phi_{b c}$, they also need the following decomposition

$$

where $\phi_{b c, S}$ satisfies the Stokes equation, $\phi_{b c, T}$ is to correct the stretching term with "good" boundary condition and $\phi_{b c, R}$ solves formally the same system as $\phi_{s l i p}$. In this paper, we apply the decomposition in [13] to justify the limit from (1.3) to (1.4).
1.2. Statement of the main results. Before stating the main results, we give some assumption on initial data. Assume that initial data belong into the following Gevrey class:

where $H^{r, s}$ is the anisotropic Sobolev space defined by

More precisely, we consider initial data of the form

$$
u^{\varepsilon}(0, x, y)=u_{0}(x, y), \quad v^{\varepsilon}(0, x, y)=v_{0}(x, y),

which satisfy the compatibility conditions

& \int_{0}^{1} \partial_{x} u_{0} d y=0,\left.\quad \partial_{y}^{2} u_{0}\right|_{y=0,1}=\int_{0}^{1}\left(-\partial_{x} u_{0}^{2}+\partial_{y}^{2} u_{0}\right)-\int_{\mathcal{S}} \partial_{y}^{2} u_{0} d x d y . \tag{1.8}
\end{align*}

Moreover, we assume the initial velocity satisfies the convex condition

Now, we are in the position to state the main results in our paper.
Theorem 1.1. Let initial data $u_{0}$ satisfy (1.6)-(1.9). Then there exist $T>0$ and $C>0$ independent of $\varepsilon$ such that there exists a unique solution of the scaled anisotropic Navier-Stokes equations (1.3) in $[0, T]$, which satisfies that for any $t \in[0, T]$, it holds that

where $\left(u_{p}, v_{p}\right)$ is the solution to (1.4).

Remark 1.2. Although we do not give the proof that the system (1.4) is well-posedness in Gevrey class $\frac{3}{2}$, one can follow the proof of Theorem 1.1 to obtain the well-posedness. To avoid repeatability in the proof, we omit the details. Actually, the main difference between $\varepsilon=0$ and $\varepsilon \neq 0$ is on the construction boundary corrector $\phi_{b c, S}$, and readers can find more details in Remark 8.1.

Remark 1.3. In the recent work 11 by Gérard-Varet, Iyer and Maekawa, they establish well-posedness of Hydrostatic Navier-Stokes system in Gevrey class $\frac{3}{2}$. In our present work, we focus on the inviscid limit problem.
1.3. Sketch of the proof. In this subsection, we sketch the main ingredients in our proof.
(1) Introduce the error equations. In Section 3, we deduce the error equations. We introduce the error

which satisfies

\partial_{t} u^{R}-\Delta_{\varepsilon} u^{R}+v^{R} \partial_{y} u^{p}+\partial_{x} p^{R}=\cdots,  \tag{1.10}\\
\varepsilon^{2}\left(\partial_{t} v^{R}-\Delta_{\varepsilon} v^{R}\right)+\partial_{y} p^{R}=\cdots
\end{array}\right.
$$

Here $\left(u^{p}, v^{p}, p^{p}\right)$ is approximate solution given in (3.1). The key point in this paper is to obtain the uniform estimate (in $\varepsilon$ ) of ( $u^{R}, \varepsilon v^{R}$ ) in the Gevrey class with index $\gamma=\frac{3}{2}$. In view of (1.10), since $v^{R}$ is controlled via the relation $v^{R}=-\int_{0}^{y} \partial_{x} u^{R} d y^{\prime}$, the main difficulty comes from the term $v^{R} \partial_{y} u^{p}$, which loses one tangential derivative. In [35], we justify the limit in Gevrey class $\frac{9}{8}$. For the data in the Gevrey class with optimal index $\gamma=\frac{3}{2}$, we need to introduce new ideas.
(2) Introduce the vorticity formulation. In order to eliminate $p^{R}$, we introduce vorticity $\omega^{R}=-\varepsilon^{2} \partial_{x} v^{R}+\partial_{y} u^{R}$ and rewrite the equation of $\omega^{R}$ by stream function $\phi$ which satisfies

v^{R}=-\partial_{x} \phi, \quad u^{R}=\partial_{y} \phi+C(t), \quad C(t)=\frac{1}{2 \pi} \int_{\mathcal{S}} u^{R} d x d y .
$$

Thus, we get

$$

\left(\partial_{t}-\Delta_{\varepsilon}\right) \Delta_{\varepsilon} \phi-\partial_{x} \phi \partial_{y} \omega^{p}=\cdots, & (x, y) \in \mathcal{S}  \tag{1.11}\\
\left.\phi\right|_{y=0,1}=0,\left.\quad \partial_{y} \phi\right|_{y=0,1}=C(t), & x \in \mathbb{T}
\end{array}\right.
$$

We notice the term $\partial_{x} \phi \partial_{y} \omega^{p}$ also lose one tangential derivative. But under the convexity condition $\partial_{y} \omega^{p} \geq c_{0}>0$, one can use "hydrostatic trick" to deal with this term. Testing $\frac{\omega^{R}}{\partial_{y} \omega^{p}}$ to the (1.11) instead of $\omega^{R}$, we have the following cancellation:

-\int_{\mathcal{S}} \partial_{x} \phi \partial_{y} \omega^{p} \cdot \frac{\omega^{R}}{\partial_{y} \omega^{p}} d x d y=-\int_{\mathcal{S}} \partial_{x} \phi \triangle_{\varepsilon} \phi d x d y=\int_{\mathcal{S}} \partial_{x}\left|\nabla_{\varepsilon} \phi\right|^{2} d x d y=0
$$

where we use $\left.\phi\right|_{y=0,1}=0$. However, the boundary condition of $\phi$ is $\left.\partial_{y} \phi\right|_{y=0,1}=C(t)$ which brings an essential difficulty.

By the energy estimates, taking inner product in $X^{r}$ (the definition is given in section 2) with $-\partial_{t} \phi$, we get

\sup _{s \in[0, t]}\left(\lambda\left\|\nabla_{\varepsilon} \phi(s)\right\|_{X^{\frac{7}{3}}}^{2}+\left\|\Delta_{\varepsilon} \phi(s)\right\|_{X^{2}}^{2}\right)
$$

$$
\leq C \int_{0}^{t}\left(\varepsilon^{-2}\left\|\varphi \Delta_{\varepsilon} \phi\right\|_{X^{2}}^{2}+\varepsilon^{-2}\left\|\nabla_{\varepsilon} \phi\right\|_{X^{2}}^{2}+\cdots\right) d s
$$

where $\varphi(y)=y(1-y)$. All we need to do is to control $\varepsilon^{-1}\left\|\varphi \Delta_{\varepsilon} \phi\right\|_{X^{2}}$ and $\varepsilon^{-1}\left\|\nabla_{\varepsilon} \phi\right\|_{X^{2}}$ by the left hand side of (1.12).

Motivated by [13], we expect to achieve that by a decomposition of stream function $\phi=\phi_{s l i p}+\phi_{b c}$ in Gevrey $\frac{3}{2}$ regularity. Here $\phi_{s l i p}$ enjoys a "good" boundary condition and $\phi_{b c}$ is a corrector which recover the boundary condition. In the following, we present the decomposition precisely.
(3) Gevrey estimate under artificial boundary conditions. $\phi_{s l i p}$ enjoying a good boundary condition is defined by

\left.\phi_{\text {slip }}\right|_{y=0,1}=0,\left.\quad \omega_{\text {slip }}\right|_{y=0,1}=0, \quad x \in \mathbb{T},
\end{array}\right.
$$

where $\omega_{\text {slip }}=\Delta_{\varepsilon} \phi_{\text {slip }}$. By "hydrostatic trick" and Navier-slip boundary conditions to obtain

\lambda \int_{0}^{t}\left(\left\|\omega_{s l i p}\right\|_{X^{\frac{7}{3}}}^{2}+\left\|\nabla_{\varepsilon} \phi_{s l i p}\right\|_{X^{\frac{7}{3}}}^{2}+\left.\left|\nabla_{\varepsilon} \phi_{s l i p}\right|_{y=0,1}\right|_{X^{\frac{7}{3}}} ^{2}\right) d s \leq \frac{C}{\lambda} \int_{0}^{t}\left\|\varepsilon \Delta_{\varepsilon} \phi\right\|_{X^{2}}^{2} d s+\cdots \tag{1.14}
\end{equation*}
$$

The full study of the Orr-Sommerfeld formulation (1.13) with Navier-slip boundary conditions is given in Section 7.
(4) Recovery the non-slip boundary condition. In Step (3), we use the slip boundary condition, not the real boundary condition $\left.\partial_{y} \phi\right|_{y=0,1}=C(t)$. To recover the boundary condition, we introduce the following system:

$$

where $\omega_{b c}=\Delta_{\varepsilon} \phi_{b c}$ and $i=0,1$. And we need to choose a suitable $h^{i}$ such that

Next, we give the main idea for proving the existence of $h^{i}$ :

1. We define $\phi_{b c, S}=\phi_{b c, S}^{0}+\phi_{b c, S}^{1}$, where $\phi_{b c, S}^{i}$ solve

where $x \in \mathbb{T}, y \in(0,+\infty)$ for $i=0$ and $y \in(-\infty, 1)$ for $i=1$. Taking Fourier transformation on $t$ and $x$, we can write the precise expression of the solution to obtain the Gevrey estimate for $\phi_{b c, S}^{i}$ :

where $\varphi^{0}(y)=y, \varphi^{1}(y)=1-y$. Compared with the decomposition in [35], we get more regularity of $\partial_{x} \phi_{b c, S}^{i}$ which is a key point to get the optimal Gevrey regularity. The details for this step is given in Section 8.1.
2. We correct the nonlocal term constructed in the above step, by consider the following equations:

More details are given in Section 8.3.
3. We define $\phi_{b c}=\phi_{b c, S}+\phi_{b c, R}$ where $\phi_{b c, S}=\sum_{i=0,1} \phi_{b c, S}^{i}$ and $\phi_{b c, R}=$ $\sum_{i=0,1} \phi_{b c, R}^{i}$, which solve system (1.15). To match the boundary condition on the derivative of $\left.\partial_{y} \phi\right|_{y=0,1}=C(t)$, we need

which means that $\left(1+R_{b c}\right)$ is an invertible operator when $\lambda$ is large. That means that $\phi_{b c, S}$ and $\phi_{b c, R}$ are well-defined and (1.15) is well-posedness. Details are given in Section 8.4.
Due to the transport terms, we need to introduce a new auxiliary function $\phi_{b c, T}$ between Step 1 and Step 2. For more details, see Section 8.2.
(5) Close the energy estimates (1.12). Summing estimates (1.17) and (1.19) in Step (4), we get estimate for $\phi_{b c}$ :

- Vorticity of Prandtl part $\omega^{p}$ is defined by $\omega^{p}=\partial_{y}^{2} u^{p}$.
- Vorticity of reminder part $\omega^{R}=\Delta_{\varepsilon} \phi$ is defined by $\omega^{R}=\varepsilon^{2} \partial_{x} v^{R}-\partial_{y} u^{R}$. In this paper, we also define $\omega_{b c, j}^{i}=\Delta_{\varepsilon} \phi_{b c, j}^{i}$ where $i=0,1$ and $j \in\{R, T\}$
- Cut-off functions $\varphi(y)=y(1-y)$ and $\varphi^{i}(y)=i+(-1)^{i} y$.
- $C(t)=\frac{1}{2 \pi} \int_{\mathcal{S}} u^{R} d x d y$.
- The Fourier transform of $f_{\Phi}$ is defined by $e^{(1-\lambda t)\langle k\rangle^{\frac{2}{3}}} \widehat{f}(k)$.


## 2. GEVREY NORMS AND PRELIMINARY LEMMAS

At the beginning of this section, we give the definition of the functional space $X^{r}$ and the Gevrey class. First, we define

## 4. Estimate of $\nabla_{\varepsilon} \phi$ and $\Delta_{\varepsilon} \phi$ in Gevrey space

Before giving the estimate of $\nabla_{\varepsilon} \phi$ and $\Delta_{\varepsilon} \phi$, we need the estimates of the reminder terms $R_{1}$ and $R_{2}$ which are defined by the approximate solution $u^{p}$ and $v^{p}$. For $\left(u^{p}, v^{p}\right)$, we have the following bound:

If we set $\varepsilon=0$ and follow the step by step in this paper, we can get the the conjecture proved. Here, to avoid the repeatability, we leave the proof to the readers.

Then, by the definition of $\left(R_{1}, R_{2}\right)$ in (3.4)-(3.5), using Lemma 2.2 to get that

## 5. Sketch the proof to Theorem 1.1

In this section, we shall sketch the proof of Theorem 1.1. In the paper, we use the continue argument. Here, we define

5.1. The key a priori estimates. In this subsection, we shall present the key a priori estimates used in the proof of Theorem 1.1.

By Proposition 4.3, we need the estimates of $\int_{0}^{t}\left(\left\|\nabla_{\varepsilon} \phi\right\|_{X^{2}}^{2}+\left\|\varphi \Delta_{\varepsilon} \phi\right\|_{X^{2}}^{2}\right) d s$ to close the energy.

Proposition 5.1. Let $\phi$ be the solution of (3.20). Then there exists $\lambda_{0} \geq 1$ and $0<T<$ $\min \left\{T_{p}, \frac{1}{2 \lambda}\right\}$ such that for $\lambda \geq \lambda_{0}$ and $t \in[0, T]$, it holds that

The proof of the above proposition is the main part in this paper and we prove it in the section 6 .
5.2. Proof of Theorem 1.1. Before we prove the Theorem 1.1, we firstly give the estimates for the nonlinear terms:

\leq C \int_{0}^{t}\left(\left\|e^{(1-\lambda s)}\left(\mathcal{N}_{u}, \varepsilon \mathcal{N}_{v}\right)\right\|_{L^{2}}^{2}+\varepsilon^{8}\right) d s+\frac{C}{\lambda} \int_{0}^{t}\left\|\nabla_{\varepsilon} \phi\right\|_{X^{2}}^{2} d s

Remark 6.4. We use weighted quantity $\left\|e^{(1-\lambda t)}\left(u^{R}, \varepsilon v^{R}\right)\right\|_{L^{2}}$ instead of $\left\|\left(u^{R}, \varepsilon v^{R}\right)\right\|_{L^{2}}$ to obtain small constant factor in front of $\int_{0}^{t}\left\|\nabla_{\varepsilon} \phi\right\|_{X^{2}}^{2} d s$ in (6.5).

The goal in this section is to establish uniform (in $\varepsilon$ ) estimate of vorticity $\omega=\triangle_{\varepsilon} \phi$.

In view of (7.2), the terrible term comes from $\partial_{x} \phi_{\Phi} \partial_{y} \omega^{p}$, which lose one tangential derivative. & =-\frac{1}{2} \int_{\mathcal{S}} \partial_{x}\left|\left\langle D_{x}\right\rangle^{2} \nabla_{\varepsilon} \phi_{\Phi}\right|^{2} d x d y=0,
\end{aligned}

by using $\left.\phi\right|_{y=0,1}=0$.
Estimate of $T^{6}, T^{7}$ and $T^{8}$. Let's estimate commutators by Lemma 2.3, Since $\partial_{y} \omega^{p} \geq$ $c_{0}>0$, we use Lemma [2.3] to ensure that

Here we use (7.3) and (7.5) in the last estimate.
Estimate of $T^{9}$ and $T^{10}$. Integration by parts and boundary condition $\left.\omega\right|_{y=0,1}=0$ give that

\leq & \frac{1}{10} \int_{0}^{t}\left\|\nabla_{\varepsilon} \omega\right\|_{X^{2}}^{2} d s+C \int_{0}^{t}\left\|\mathcal{N}_{u}, \varepsilon \mathcal{N}_{v}\right\|_{X^{2}}^{2} d s
\end{aligned}
$$

+\left(C+\frac{\lambda}{4}\right) \int_{0}^{t}\|\omega\|_{X^{\frac{7}{3}}}^{2} d s+\frac{C}{\lambda} \int_{0}^{t}\left\|\varepsilon^{2} f_{1}+f_{2}-C(t) \partial_{x} \omega^{p}\right\|_{X^{\frac{5}{3}}}^{2} d s

Taking $\lambda$ large enough, we deduce

On the other hand, (7.5) gives

## 8. Construction of the boundary corrector: Proof of Proposition 6.2

In the previous section, we construct a solution to the Orr-Sommerfeld equation with artificial boundary conditions: we replace condition $\left.\partial_{y} \phi\right|_{y=0,1}=0$ by $\left.\Delta_{\varepsilon} \phi\right|_{y=0,1}=0$. To go back to the original system, we need to correct Neumann condition. Thus, we define $\phi_{b c}$ satisfies the following system:

\end{array}\right.
$$

To estimate $\phi_{b c}$, we use the following decomposition:

The definitions and estimates of $\phi_{b c, S}, \phi_{b c, T}$ and $\phi_{b c, R}$ are given in the following subsections.
8.1. The estimates of $\phi_{b c, S}$ : Stokes equation. In this subsection, we deal with $\phi_{b c, S}$.

Because of two boundary $y=0$ and $y=1$, we define

where $\phi_{b c, S}^{0}$ satisfies the following Stokes equation:

\left.\phi_{b c, S}^{0}\right|_{t=0}=0,
\end{array}\right.
$$

and $\phi_{b c, S}^{1}$ satisfies the following Stokes equation

\left\{\begin{array}{l}
\left(\partial_{t}-\Delta_{\varepsilon}\right) \Delta_{\varepsilon} \phi_{b c, S}^{1}=0, \quad(x, y) \in \mathbb{T} \times(-\infty, 1)  \tag{8.3}\\
\left.\phi_{b c, S}^{1}\right|_{y=1}=0,\left.\quad \partial_{y} \phi_{b c, S}^{1}\right|_{y=1}=h^{1}, \\
\left.\phi_{b c, S}^{1}\right|_{t=0}=0,
\end{array}\right.
$$

where $t \in[0, T]$. Here $\left(h^{0}, h^{1}\right)$ is a given boundary data satisfying $\left(h^{0}(t), h^{1}(t)\right)=0$ for $t=0$ and $t \geq T$. Here, we point out that $h^{i}$ is defined by

where the operator $\mathcal{A}$ is a zero-order operator which is defined later.
In the following, we only give the process for $\phi_{b c, S}^{0}$. The case of $\phi_{b c, S}^{1}$ is almost the same and we leave details to readers.

At first, we give zero extension of $\phi_{b c, S}^{0}$ and $h^{0}$ with $t \leq 0$ such that we can take Fourier transform in $t$. Let $\widehat{\phi_{b c, S}^{0}}=\widehat{\phi_{b c, S}^{0}}(\zeta, k, y)$ be the Fourier transform of $\phi_{b c, S}^{0}$ on $x$ and $t$. Then $\widehat{\left(\phi_{b c, S}^{0}\right)} \Phi$ satisfies the ODE:

\end{array}\right.
$$

where $\zeta \in \mathbb{R}$ and $k \in \mathbb{Z}$. Assuming the decay of $\left(|k| \phi_{b c, S}^{0}, \partial_{y} \phi_{b c, S}^{0}\right)$ and the boundedness of $\partial_{y} \phi_{b c, S}^{0}$, we obtain the formula:

where the square root is taken so that the real part is positive, and it follows that

\left(\partial_{y}^{2}-\varepsilon^{2}|k|^{2}\right)\left(\widehat{\left.\phi_{b c, S}^{1}\right)} \Phi\right. & =-(\gamma+\varepsilon|k|) e^{-\gamma(1-y)} \widehat{h_{\Phi}^{1}} . \tag{8.12}

Remark 8.1. For $\varepsilon=0$ in (8.2), $\triangle_{0}=\partial_{y}^{2}$.

\end{equation*}

solves (8.4) with $\varepsilon=0$ and $\widehat{\left(\widehat{\phi_{b c, S}^{0}}\right)_{\Phi}}$ holds $\lim _{y \rightarrow+\infty}=\frac{\widehat{h_{\Phi}^{0}}}{\gamma_{0}}$. Though $\widehat{\left(\phi_{b c, S}^{0}\right)_{\Phi}}$ don't tend to zero as $y$ tends to infinity, the solution $\left(\widehat{\left.\phi_{b c, S}^{0}\right)_{\Phi}}\right.$ is only used to correct boundary condition near
$y=0$ and we don't care about its value at infinity. It is easy to deduce

and we find these two term are decay to zero as $y$ tends to infinity. By the same method, we can get another solution near $y=1$ :

These constructions are main difference between $\varepsilon=0$ and $\varepsilon \neq 0$, but they enjoy the same properties stated below.

where $i=0,1$ and $L_{\zeta, y}^{2}=l_{\zeta}^{2}\left(L_{y}^{2}(0,+\infty)\right)$ for $i=0$ and $L_{\zeta, y}^{2}=l_{\zeta}^{2}\left(L_{y}^{2}(-\infty, 1)\right)$ for $i=1$.
It is also holds that

\sum_{k \in \mathbb{Z}} \| k\left(\widehat{\left.\phi_{b c, S}^{i}\right)}\left\|_{\Phi}\right\|_{L_{\zeta, y}^{2}} \leq \frac{C}{\lambda^{\frac{1}{2}}}\left\|k\langle k\rangle^{-\frac{1}{3}} \widehat{h_{\Phi}^{i}}\right\|_{L_{\zeta}^{2}}\right. \tag{8.17}
\end{equation*}
$$

where $i=0,1$ and $L_{\zeta, y}^{2}=l_{\zeta}^{2}\left(L_{y}^{2}(0,1)\right)$.
Proof. We only give the proof for $i=0$. The case $i=1$ is almost the same and we omit details to readers.
(8.16) follows from (8.5), (8.8) and the Plancherel theorem, by observing the estimate for multipliers

& \leq C \frac{(\varepsilon|k|)^{\frac{1}{2}}}{\varepsilon|k|+\lambda^{\frac{1}{2}}\langle k\rangle^{\frac{1}{3}}} \leq \frac{C}{\lambda^{\frac{1}{4}}\langle k\rangle^{\frac{1}{6}}} .

Combining case 1-2 together, we complete (8.19), which yields (8.16). The estimate (8.17) is proved by using (8.5), Placherel theorem and

$$

we get that

$$
\left\{\begin{array}{l}
\left(\partial_{t}-\Delta_{\varepsilon}\right) \Delta_{\varepsilon} \phi_{b c}+u^{p} \partial_{x} \Delta_{\varepsilon} \phi_{b c}+v^{p} \partial_{y} \Delta_{\varepsilon} \phi_{b c}+\partial_{y} \phi_{b c} \partial_{x} \omega^{p}-\partial_{x} \phi_{b c} \partial_{y} \omega^{p}=0  \tag{8.69}\\
\left.\phi_{b c}\right|_{y=0,1}=0,\left.\quad \partial_{y} \phi_{b c}\right|_{y=0}=h^{0}+R_{b c}^{00}+R_{b c}^{01},\left.\quad \partial_{y} \phi_{b c}\right|_{y=1}=h^{1}+R_{b c}^{10}+R_{b c}^{11} \\
\left.\phi_{b c}\right|_{t=0}=0
\end{array}\right.
$$

Here $R_{b c}^{j i}(j=0,1, i=0,1)$ are linear operators and are defined by

$$
\begin{aligned}
& R_{b c}^{00}=\left.\left(\partial_{y} \phi_{b c, T}^{0}+\partial_{y} \phi_{b c, R}^{0}\right)\right|_{y=0}, \\
& R_{b c}^{01}=\left.\left(\partial_{y} \phi_{b c, S}^{1}+\partial_{y} \phi_{b c, T}^{1}+\partial_{y} \phi_{b c, R}^{1}\right)\right|_{y=0}, \\
& R_{b c}^{10}=\left.\left(\partial_{y} \phi_{b c, S}^{0}+\partial_{y} \phi_{b c, T}^{0}+\partial_{y} \phi_{b c, R}^{0}\right)\right|_{y=1}, \\
& R_{b c}^{11}=\left.\left(\partial_{y} \phi_{b c, T}^{1}+\partial_{y} \phi_{b c, R}^{1}\right)\right|_{y=1} .
\end{aligned}
$$

Compared with the system (8.1), we need to find $\left(h^{0}, h^{1}\right)$ such that

$$
\left\{\begin{array}{l}
h^{0}+R_{b c}^{00}+R_{b c}^{01}=-\left.\partial_{y} \phi_{s l i p}\right|_{y=0}+C(t)  \tag{8.70}\\
h^{1}+R_{b c}^{10}+R_{b c}^{01}=-\left.\partial_{y} \phi_{s l i p}\right|_{y=1}+C(t)
\end{array}\right.
$$

hold. To do that, we define an operator $R_{b c}\left[h^{0}, h^{1}\right]$, which is defined by

R_{b c}\left[h^{0}, h^{1}\right]=\left(\begin{array}{ll}
R_{b c}^{00} & R_{b c}^{01}  \tag{8.71}\\
R_{b c}^{10} & R_{b c}^{11}
\end{array}\right)
$$

is a $2 \times 2$ matrix operator and is well-defined on the Banach space

$$
\begin{equation*}
Z_{b c}=\left\{\left.\left(h^{0}, h^{1}\right) \in L^{2}\left(0, t ; L^{2}\right)\left|\int_{0}^{t}\right|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}} ^{2} d s<+\infty\right\} . \tag{8.72}
\end{equation*}
$$

Proposition 8.12. There exists $\lambda_{0} \geq 1$ such that if $\lambda \geq \lambda_{0}$, the map $R_{b c}: Z_{b c} \rightarrow Z_{b c}$ defined by (8.71) satisfies

$$
\begin{equation*}
\int_{0}^{t}\left|R_{b c}\left[h^{0}, h^{1}\right]\right|_{X^{\frac{7}{3}}}^{2} d s \leq \frac{C}{\lambda^{\frac{1}{2}}} \int_{0}^{t}\left|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}}^{2} d s \tag{8.73}
\end{equation*}
$$

Hence, the operator $I+R_{b c}$ is invertible in $Z_{b c}$. Moreover, there exists $\left(h_{0}, h_{1}\right) \in Z_{b c}$ such that (8.70) holds and $\left(h_{0}, h_{1}\right)$ is defined by

$$
\left(h_{0}, h_{1}\right)=\left(I+R_{b c}\right)^{-1}\left(-\left.\partial_{y} \phi_{s l i p}\right|_{y=0}+C(t),-\left.\partial_{y} \phi_{s l i p}\right|_{y=1}+C(t)\right) .
$$

Proof. First, by Lemma 8.4, Proposition 8.8, Corollary 8.7 and Proposition 8.11, it is easy to get

$$
\int_{0}^{t}\left|R_{b c}\left[h^{0}, h^{1}\right]\right|_{X^{\frac{7}{3}}}^{2} d s \leq \frac{C}{\lambda^{\frac{1}{2}}} \int_{0}^{t}\left|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}}^{2} d s
$$

Taking $\lambda$ large enough, we get that the operator $I+R_{b c}$ is invertible in $Z_{b c}$. Thus, there exists $\left(h_{0}, h_{1}\right) \in Z_{b c}$ such that (8.70) holds.

Let's continue to prove Proposition 6.2. According to Proposition 8.3, Proposition 8.6, Corollary 8.8 and Proposition 8.11, we get by (8.68) that

\begin{aligned}
\int_{0}^{t}\left\|\nabla_{\varepsilon} \phi_{b c}\right\|_{X^{\frac{7}{3}}}^{2} d s & \leq \int_{0}^{t}\left\|\nabla_{\varepsilon} \phi_{b c, S}\right\|_{X^{\frac{5}{2}}}^{2} d s+\int_{0}^{t}\left\|\nabla_{\varepsilon} \phi_{b c, T}\right\|_{X^{\frac{5}{2}}}^{2} d s+\int_{0}^{t}\left\|\nabla_{\varepsilon} \phi_{b c, R}\right\|_{X^{\frac{7}{3}}}^{2} d s \\
& \leq \frac{C}{\lambda^{\frac{1}{2}}} \int_{0}^{t}\left|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}}^{2} d s,
\end{aligned}
$$

and

$$
\int_{0}^{t}\left\|\varphi \Delta_{\varepsilon} \phi_{b c}\right\|_{X^{2}}^{2} d s \leq \int_{0}^{t}\left\|\varphi \Delta_{\varepsilon} \phi_{b c, S}\right\|_{X^{\frac{5}{2}}}^{2} d s+\int_{0}^{t}\left\|\varphi \Delta_{\varepsilon} \phi_{b c, T}\right\|_{X^{\frac{5}{2}}}^{2} d s+\int_{0}^{t}\left\|\Delta_{\varepsilon} \phi_{b c, R}\right\|_{X^{\frac{7}{3}}}^{2} d s
$$

$$
\leq \frac{C}{\lambda^{\frac{1}{2}}} \int_{0}^{t}\left|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}}^{2} d s
$$

which imply

$$
\int_{0}^{t}\left\|\nabla_{\varepsilon} \phi_{b c}\right\|_{X^{\frac{7}{3}}}^{2}+\left\|\varphi \Delta_{\varepsilon} \phi_{b c}\right\|_{X^{2}}^{2} d s \leq \frac{C}{\lambda^{\frac{1}{2}}} \int_{0}^{t}\left|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}}^{2} d s
$$

Due to Proposition 8.12 and taking $\mathcal{A}=\left(I+R_{b c}\right)^{-1}$, we know $\mathcal{A}$ is a zero-order bounded operator in $Z_{b c}$ and obtain

$$
\begin{aligned}
\int_{0}^{t}\left|\left(h^{0}, h^{1}\right)\right|_{X^{\frac{7}{3}}}^{2} d s & =\int_{0}^{t}\left|\mathcal{A}\left(-\left.\partial_{y} \phi_{\text {slip }}\right|_{y=0}+C(s),-\left.\partial_{y} \phi_{s l i p}\right|_{y=1}+C(s)\right)\right|_{X^{\frac{7}{3}}}^{2} d s \\
& \leq C \int_{0}^{t}\left(\left.\left|\nabla_{\varepsilon} \phi_{s l i p}\right|_{y=0,1}\right|_{X^{\frac{7}{3}}} ^{2}+|C(s)|^{2}\right) d s
\end{aligned}
$$

which finish this proposition.
