# Negative Shannon Information Hides Networks

#### Abstract

Shannon information was defined for characterizing the uncertainty information of classical probabilistic distributions. As an uncertainty measure it is generally believed to be positive. This holds for any information quantity from two random variables because of the polymatroidal axioms. However, it is unknown why there is negative information for more than two random variables on finite dimensional spaces. We first show the negative tripartite Shannon mutual information implies specific Bayesian network representations of its joint distribution. We then show that the negative Shannon information is obtained from general tripartite Bayesian networks with quantum realizations. This provides a device-independent witness of negative Shannon information. We finally extend the result for general networks. The present result shows new insights in the network compatibility from non-Shannon information inequalities.


## I. INTRODUCTION

For a given discrete Markov process a fundamental problem is how to characterize the information produced in such a statistical process. Suppose the statistical outcomes of a set of possible events $\left\{x_{1}, \cdots, x_{n}\right\}$ with respectively occurrence frequencies as $p_{1}, \cdots, p_{n} \in[0,1]$. Is there a measure of how uncertain is of the outcome except for its distribution? For any such a quantity denotes as $H\left(p_{1}, p_{2}, \cdots, p_{n}\right)$, it is reasonable to satisfy the following axioms: (1) $H$ is continuous function in each variable $p_{i}$ of the probability. (2) $H$ is an increasing function of sample number for the uniform distribution. (3) $H$ is weighted summation of its single values if any one choice is changed into two. These axioms imply the unique entropy given by Shannon [1] as

H\left(p_{1}, p_{2}, \cdots, p_{n}\right)=-\sum_{i=1}^{n} p_{i} \log p_{i} \tag{1}
\end{equation*}

This features the average uncertainty of a given statistical process.

The Shannon entropy shows a remarkable application for mutual information of two discrete random variables as

I(X ; Y)=H(X)+H(Y)-H(X, Y) \tag{2}
\end{equation*}

where the mutual information means the uncertainty between two variables $X$ and $Y$. It is a measure of the information to which knowledge of one variable reduces uncertainty about the other. These entropy functions satisfy the polymatroidal axioms [5] of $H(X), I(X ; Y) \geq 0$ for any finite dimensional variables $X$ and $Y$. Shannon actually shows general information inequalities which are the "physical laws" for characterizing the fundamental limits in classical communications and compression [1]. However, this intrigues a surprising feature of negative information for three or more discrete variables beyond the polymatroidal axioms. Each one in fact presents a so-called non-Shannon inequality [6]. One primitive example is from the mutual information contained in three
discrete variables $X, Y$ and $Z$ on finite dimensional spaces as

I(X ; Y ; Z)= & I(X ; Y)-I(X ; Y \mid Z) \\
= & H(X)+H(Y)+H(Z)+H(X, Y, Z) \\
& -H(X, Y)-H(Y, Z)-H(X, Z) \tag{3}
\end{align*}
$$

where $I(X ; Y \mid Z)=H(Y, Z)+H(X, Z)-H(Z)-$ $H(X, Y, Z)$ denotes the mutual information conditional on the outcome of variable $Z$. One example is shown in Fig [1. The proper local measurements on the network (a) may generate a joint probability distribution $P_{x y z}$ with the notation of $P_{x y z}=\frac{1}{4}[000]+\frac{1}{4}[011]+$ $\frac{1}{4}[101]+\frac{1}{4}[110]$, where $[x y z]$ denotes joint event $(X=$ $x, Y=y, Z=z)$, and the probability of joint outcome $[x y z]=[000],[011],[101]$ or [110] is $\frac{1}{4}$. This probability distribution yields to a negative information of $I(X ; Y ; Z)=-1$. Especially, the new correlations are built for two independent parties Alice and Bob assisted by the other's local operations, that is, the mutual information conditional on the outcome of $Z$ is given by $I(X ; Y \mid Z)=1$ while the mutual information $I(X ; Y)$ is zero. This may imply a simple explanation of the Shannon negative information from Bayesian networks [7]. This intrigues a natural problem for characterizing general negative Shannon information.

In Hilbert space formulation of Bayesian network in Fig 1(a), each bipartite edge is replaced by an entanglement [8, 9], as shown in Fig (b). Under the proper postulates of quantum state representation, quantum measurement, Born rule and tensor decomposition of compose systems, the quantum probability is given by $p(x, y, z)=\operatorname{Tr}\left(\left(M_{x} \otimes M_{y} \otimes M_{z}\right) \rho_{1} \otimes \rho_{2}\right)$, where $\left\{M_{x}\right\}$, $\left\{M_{y}\right\}$, and $\left\{M_{z}\right\}$ denotes respective quantum measurements of Alice, Bob and Matchmaker, and $\operatorname{Tr}(\cdot)$ denotes the trace operation of matrix. This quantum probability shows not only the similar features of classical statistics of $I(X ; Y ; Z) \leq 0$, but also the quantumness of entanglement [8, 10], i.e., two independent parties Alice and Bob can build quantum entanglement assisted by the other's local operations and classical communication [11, 12]. This provides a simple physical model for

This follows $I(X ; Y)=0$ and $I(X ; Y \mid Z)=1$. This means Alice and Bob who are initially independent of each other (e.g., $I(X ; Y)=0$ ) can build new correlations conditional on local measurements of Matchmaker (e.g., $I(X ; Y \mid Z)=0$ ).
verifying Bayesian network and the new quantumness of entanglement assisted by other party from its statistical distribution.

Our motivation in this work is to investigate a general problem of the Bayesian network compatibility of the negative Shannon mutual information. For a given tripartite joint probability distribution with negative mutual information on finite sample spaces, we firstly classify all the compatible Bayesian networks. We show there are intrinsic network configurations for these distributions, that is, chain network consisting of two edges or triangle network consisting of three edges. This implies a
device-independent verification of negative Shannon mutual information using quantum networks. The feature of negative Shannon mutual information is generic for any tripartite quantum entangled network or general multipartite networks.

## II. RESULT

## A. Negative Shannon mutual information in Bayesian network model

We first introduce some notations of Bayesian networks [7]. A graph $\mathcal{G}$ consists of a vertex (or node) set $V$, and an edge (or link) set $E$. The vertices in a given graph are corresponding to measurable variables, and the edges denote certain relationships that hold in pairs of variables. A bi-directed edge denotes the existence of unobserved common causes. These edges will be marked as curved arcs with two arrowheads, as shown in Fig,2, If all edges are directed, we then have a directed graph.

Directed graph may include directed cycles. One example is given by $X \rightarrow Y \rightarrow Z \rightarrow X$ with $X, Y, Z \in V$, which represents mutual causation or feedback processes. The self-loops (e.g., $X \rightarrow X$ ) are not allowed in what follows. A graph that contains no directed cycle is called acyclic. A graph that is both directed and acyclic is called a directed acyclic graph (DAG). A family in a graph is a set of nodes containing a node and all its parents, where the parents of one node mean all nodes which are connected to it.

Denote a probability distribution as $P_{x}=\tilde{\Sigma}_{x} p_{x}[x]$ with random variable $X$ on a finite sample space $\mathcal{X}$, where $[x]$ denotes the event of $X=x$ and $p_{x}$ denotes the probability of the outcome $x$. The notation $\tilde{\Sigma}$ does not mean the summation but a notation of union of all possible events of a given probability distribution. Similar notations will be used for multivariate joint distributions $P_{x_{1} \cdots x_{n}}$ on finite sample space $\times_{i=1}^{n} \mathcal{X}_{i}$. Consider the task of specifying an arbitrary joint distribution $P_{x_{1} \cdots x_{n}}=\tilde{\Sigma}_{x_{1} \cdots x_{n}} p_{x_{1} \cdots x_{n}}\left[x_{1} \cdots x_{n}\right]$ for $n$ random variables, $X_{1}, \cdots, X_{n}$ on finite sample spaces $\mathcal{X}_{1}, \cdots, \mathcal{X}_{n}$, respectively, and $\left[x_{1} \cdots x_{n}\right]$ denotes the joint event of $X_{1}=x_{1}, \cdots, X_{n}=x_{n}$. The basic Bayes rule allows us decompose $p_{x_{1} \cdots x_{n}}$ into

p_{x_{1} \cdots x_{n}}=\prod_{j} p_{x_{j} \mid x_{1}, \cdots, x_{j-1}} \tag{4}
\end{equation*}
$$

where $p_{x_{j} \mid x_{1}, \cdots, x_{j-1}}$ denotes the probability of outcome $x_{j}$ conditional on the outcomes of predecessors $x_{1}, \cdots, x_{j-1}$. Suppose that each $x_{j}$ is dependent of a small subset $p a\left(x_{j}\right)$ of its predecessors. We have the following definition.

Definition 1. (Markovian Parents) 7] Let $V=$ $\left\{X_{1}, \cdots, X_{n}\right\}$ be an ordered set of measurable variables, and let $P_{x_{1}, \cdots, x_{n}}$ be the joint probability distribution on
these variables. A set of variables $P A_{j}$ is said to be Markovian parents of $X_{j}$ if $P A_{j}$ is a minimal set of predecessors of $X_{j}$ that renders $X_{j}$ independent of all its other predecessors, that is,

$$
\begin{equation*}
p_{x_{j} \mid p a_{j}}=p_{x_{j} \mid x_{1}, \cdots, x_{j-1}} \tag{5}
\end{equation*}
$$

and such that no proper subset of $P A_{j}$ satisfies (5).
Definition 1 implies for each $X_{j}$ there is a set $P A_{j}$ of preceding variables for determining its probability. This can be represented by DAG, where $P A_{j}$ denotes all the parent nodes toward the node $X_{j}$ [7]. Definition 1 provides a simple recursive algorithm for constructing such a DAG for a given $P_{x_{1} \cdots x_{n}}=\tilde{\sum}_{x_{1}, \cdots, x_{n}} p_{x_{1} \cdots x_{n}}\left[x_{1} \cdots x_{n}\right]$ as follows.

## Algorithm 1

(i) Starting with the pair $\left(X_{1}, X_{2}\right)$, we draw an arrow from $X_{1}$ to $X_{2}$ if and only if the two variables are dependent.
(ii) For $X_{3}$, we draw an arrow from either $X_{1}$ or $X_{2}$ to $X_{3}$ if $X_{3}$ is dependent of $X_{1}$ or $X_{2}$;
(iii) For $j \geq 3$, one can select any minimal set $P A_{j}$ of $X_{j}$ 's possible predecessors. And then, draw an arrow from each member in $P A_{j}$ to $X_{j}$.

This follows an iterative algorithm to get a DAG of Bayesian network compatible with the given distribution $P_{x_{1} \cdots x_{n}}$. It has been shown that $P A_{j}$ is unique for a given distribution $P_{x_{1} \cdots x_{n}}$ 7]. From the Reichenbach's common cause principle [7, 14], it allows a Markovian decomposition as

p_{x_{1} \cdots x_{n}}=\prod_{j} p_{x_{j} \mid p a\left(x_{j}\right)} \tag{6}
\end{equation*}

The Markovian dependence is represented by the directed acyclic graph (DAG) of Bayesian networks 7].

The DAG shows probabilistic and statistical importance for data mining and efficient inferences. A basic problem in statistics theory is to explore the related DAG for a given statistical distribution. The most common way to explore possible DAGs from observations is based on the Markov decomposition in Eq.(6) and the faithfulness assumption [7, 15].

Definition 2 [7] (Markov Compatibility) If a probability function $P_{x_{1} \cdots x_{n}}$ admits the factorization of (6) relative to DAG $\mathcal{G}$, then $\mathcal{G}$ and $P_{x_{1} \cdots x_{n}}$ are compatible.

In classical realization of Bayesian networks, each edge is represented by one measurable variable on proper measurable space, and each outcome depends on all the related variables [7]. The joint distribution is a multivariate function of all outcomes. This allows us to decompose $P_{x_{1} \cdots x_{n}}$ with one measurable variable $\lambda$ [10] as:

p_{x_{1} \cdots x_{n}}=\int_{\Omega} p\left(x_{1} \mid \lambda\right) \cdots p\left(x_{n} \mid \lambda\right) \mu(\lambda) d \lambda \tag{7}

where $(\Omega, \mu(\lambda))$ denotes the measurable space of unobservable latent variable $\lambda$, and $\mu(\lambda)$ denotes the probability of $\lambda$, and $p\left(x_{n} \mid \lambda\right)$ denotes the characteristic function of outcome $x_{n}$ conditional on the variable $\lambda$. This kind of Bayesian networks with latent variables shows non-trivial constraints on its correlations 16, 17].

For a joint distribution of two random variables $X$ and $Y$ on finite sample spaces $\mathcal{X} \times \mathcal{Y}$, Eq.(11) is used for featuring the common uncertainty of both variables [1]. The nonnegative of $H$ and $I$ from the polymatroidal axioms [5] is useful for solving the Markov compatibility with single latent variable in Eq.(77). Instead, the entropy function in Eq.(3) shows the tripartite mutual uncertainty only for Markov chains [14], that is,

I(X ; Y ; Z) \geq 0 \tag{8}
\end{equation*}

if $\{X, Y, Z\}$ (under any order) consists of a Markov chain 7] (see proofs in Appendix A). This inspires a generalized unordered Markov condition of $I(X ; Y ; Z) \geq 0$. The joint probability distribution can be generated from one single latent variable as Eq.(7). Remarkably, there are joint distributions implying negative Shannon mutual information, that is, $I(X ; Y ; Z)<0$. One example is shown in Fig 2(a). The coarse-grained single-variable model (17) does not imply any intrinsic feature of this case. Instead, we prove new Markov compatibilities for these distributions using Bayesian networks (7].

Case one. From the definition in Eq.(3) the first scenarios satisfies the following constrains:

I(X ; Y)=0, I(X ; Y \mid Z)>0 \tag{9}
\end{equation*}

Different from the Markov conditional independence of
$p(x, y \mid z)=p(x \mid z) p(y \mid z)$ 7], the present condition in Eq.(9) implies a conditional dependence, that is, two independent random variables $X$ and $Y$ on $\mathcal{X} \times \mathcal{Y}$ can build new correlations conditional on the outcome of variable $Z$. It can be mathematically formulated as $p(x, y)=p(x) p(y)$ and $p(x, y \mid z) \neq p(x \mid z) p(y \mid z)$. The socalled anti-Markov condition provides a primitive explanation of nonnegative Shannon mutual information with $I(X ; Y ; Z)<0$.

Especially, consider the example shown in Fig 2(a). Combined with classical Birkhoff transformation 18] (e.g., a doubly stochastic matrix $\left(a_{i j}\right)$ which satisfies each column or each row consists of a probability distribution, i.e., $\sum_{i} a_{i j}=\sum_{j} a_{i j}=1$ and $a_{i j} \geq 0$ ), the joint distribution $P_{x y z}=\frac{1}{4}[000]+\frac{1}{4}[011]+\frac{1}{4}[101]+\frac{1}{4}[110]$ can be obtained from the following joint distribution of four variables as

$$
\begin{equation*}
P_{x y z_{1} z_{2}}=\frac{1}{4}[0000]+\frac{1}{4}[0101]+\frac{1}{4}[1010]+\frac{1}{4}[1111] \tag{10}
\end{equation*}
$$

where the outcomes of the variable $Z$ are classically encoded as: $\mathcal{F}: z_{1} z_{2} \mapsto z=z_{1} \oplus z_{2}$. Different from the joint distribution $P_{x y z}$, the new distribution in Eq.(10) allows the following Markovian decomposition of $P_{x y z_{1} z_{2}}=P_{x z_{1}} P_{y z_{2}}$, where $P_{x z_{1}}$ and $P_{y z_{2}}$ are joint distributions of two variables given by $P_{x z_{1}}=$ $P_{y z_{2}}=\frac{1}{2}[00]+\frac{1}{2}[11]$. This means both the variables $X$ and $Y$ are independent. Moreover, it is easy to get $H(X)=H(Y)=1, H(X, Y)=H(X, Y, Z)=2$ and $H(X, Z)=H(Y, Z)=1$. This implies the distribution $P_{x y z_{1} z_{2}}$ satisfies the inequality (9).

Now, we continue the proof. Combining with Eq.(7) the distribution $P_{x y z}$ allows a classical chain network decomposition as shown in Fig[2(a). This can be represented by

$$
\begin{align*}
p_{x y z}= & \int_{\Omega_{1} \otimes \Omega_{2}} p(x \mid \lambda) p(y \mid \gamma) p(z \mid \lambda, \gamma) \\
& \times \mu(\lambda) \mu(\gamma) d \lambda d \gamma \tag{11}
\end{align*}
$$

where $(\Omega, \mu(\lambda))$ denotes the measurable space of the latent variable $\lambda$, and $\mu(\lambda)$ denotes the probability of $\lambda$, and similar definitions for the latent variable $\gamma$. This example can be extended for general probability distribution satisfying the condition in Eq. (9). Interestingly, a further analysis shows the rigidity of this Bayesian network compatibility with any joint distribution satisfying the condition in Eq. (9) (see Appendix B).

Result 1. Any joint distribution satisfying the condition in Eq.(9) is compatible with a chain Bayesian network.

In Hilbert space formulation, a finite-dimensional pure state is represented by a normalized vector $|\phi\rangle$ in Hilbert space $\mathcal{H}_{A}[9]$. An ensemble of pure states $\left|\phi_{i}\right\rangle$ with a mixing probability $p_{i}$ is represented by a density matrix $\rho=\sum_{i} p_{i}\left|\phi_{i}\right\rangle\left\langle\phi_{i}\right|$ on Hilbert space $\mathcal{H}_{A}$. Here, $\rho$ is positive semidefinite matrix with unit trace. The multipartite quantum system is defined on the tensor of local states,
i.e., the tensor of Hilbert space as $\otimes_{i=1}^{n} \mathcal{H}_{A_{i}}$. Any measurement acting on $\mathcal{H}_{A}$ consists of an ensemble $\left\{M_{x_{i}}\right\}$ of projection operators or generalized positive semidefinite operators satisfying $\sum_{x_{i}} M_{x_{i}}=\mathbb{1}_{A_{i}}$ with the identity operator $\mathbb{1}_{A_{i}}$. After all the local measurements on a given state $\rho$ on Hilbert space $\otimes_{i=1}^{n} \mathcal{H}_{A_{i}}$, from Born rule, the quantum joint probability is given by

\begin{equation*}
p_{x_{1} \cdots x_{n}}=\operatorname{Tr}\left[\left(M_{x_{1}} \otimes \cdots \otimes M_{x_{n}}\right) \rho\right] \tag{12}
\end{equation*}
$$

for the joint outcome $x_{1}, \cdots, x_{n}$.
For special case of two particles $A$ and $B$, a state $\rho$ on Hilbert space $\mathcal{H}_{A} \otimes \mathcal{H}_{B}$ is entangled if it cannot be decomposed into

$$
\begin{equation*}
\rho=\sum_{i} p_{i} \rho_{A}^{(i)} \otimes \rho_{B}^{(i)} \tag{13}
\end{equation*}
$$

where $\left\{p_{i}\right\}$ is a probability distribution, $\rho_{A}^{(i)}$ and $\rho_{B}^{(i)}$ are states of respective particle $A$ and $B$. Similar definitions may be extended for multiple particles 19].

Instead of classical chain network in Fig 2(a), for any joint distribution $P_{x y z}$ satisfying the condition (9) it is compatible with quantum networks consisting of two generalized Einstein-Podolsky-Rosen (EPR) states [8]: $\left|\phi_{1}\right\rangle_{A B}=\frac{1}{\sqrt{2}}(|00\rangle+|11\rangle)$ and $\left|\phi_{2}\right\rangle_{B^{\prime} C}=\frac{1}{\sqrt{2}}(|00\rangle+|11\rangle)$, as shown in Fig (b). A simple local measurement strategy implies a quantum joint distribution

\begin{equation*}
P_{x y z}=\frac{1}{4}[0000]+\frac{1}{4}[0101]+\frac{1}{4}[1010]+\frac{1}{4}[1111] \tag{14}
\end{equation*}
$$

where Alice and Bob performs respective projection measurements $\left\{M_{x}, x \in\{0,1\}\right\}$ and $\left\{M_{y}, y \in\{0,1\}\right\}$ while the other performs local measurement $\left\{M_{z}=|z\rangle\langle z|, z \in\right.$ $\{00, \cdots, 11\}\}$. This provides a possible experimental verification of any negative Shannon information satisfying Eq.(9). As a directive result, any joint distribution in Eq.(14) generated from local measurements on the quantum chain network in Fig:2(b) with any bipartite states $\rho_{1}$ and $\rho_{2}$ is compatible with the classical distribution in Eq.(11), that is,

\mathcal{S}_{c}=\mathcal{S}_{q} \tag{15}
\end{equation*}

where $\mathcal{S}_{c}$ consists of all classical probability distributions in Eq. (11) with respect to any two measurable variables $\lambda$ and $\gamma$, or equivalently represented by $\mathcal{S}_{c}=\left\{P_{x y z}^{(c)} \mid I(X ; Y)=0, I(X ; Y \mid Z)>0\right\} ; \mathcal{S}_{q}$ consists of all the quantum probability distributions in Eq.(14) derived from any two quantum states $\rho_{1}$ and $\rho_{2}$, that is, $\mathcal{S}_{q}=\left\{P_{x y z}^{(q)} \mid I(X ; Y)=0, I(X ; Y \mid Z)>0\right\}$. The equality (15) means that there is no quantum nonlocality beyond classical networks for quantum chain network if each party has only one set of local measurements. This means that for a tripartite chain network its classical realization with two independent variables can simulate all quantum correlations from any realization of two independent entangled states with one measurement setting
per party. This is different from previous results with more than one measurement settings on chain networks [12, 13]. It is also different from the triangle network consisting of three variables with one measurement setting [20]. This may inspire another interesting problem for what the network ingredients may inspire the quantum nonlocality for a general network.

Case two. For dependent random variables $X$ and $Y$ on respective finite sample spaces $\mathcal{X}$ and $\mathcal{Y}$, it suggests the second scenarios for $I(X ; Y ; Z) \leq 0$ as

I(X ; Y)>0, I(X ; Y \mid Z)>0 \tag{16}
\end{equation*}
$$

One example is shown as

$$
\begin{align*}
P_{x y z}= & \frac{1}{8}[000]+\frac{1}{8}[011]+\frac{1}{8}[102]+\frac{1}{8}[113] \\
& +\frac{1}{8}[220]+\frac{1}{8}[231]+\frac{1}{8}[322]+\frac{1}{8}[333] \tag{17}
\end{align*}
$$

which has $I(X ; Y)=1$ and $I(X ; Y \mid Z)=2$. Here, the conditional mutual information $I(X ; Y \mid Z)$ is defined in Eq.(3). By using the binary representation of $i, g: i \mapsto$ $i_{1} i_{2}$, we may construct a compatible network model [7] by two steps. One is to split $P_{x y z}$ into two joint distributions of $P_{x_{1} y_{1}}=\frac{1}{2}[00]+\frac{1}{2}[11]$ and $P_{x_{2} y_{2} z}$ in Eq.(10) by using local classical transformation $g$, that is,

$$
\begin{align*}
P_{g(x) g(y) z}= & P_{x_{1} x_{2} y_{1} y_{2} z}=P_{x_{1} y_{1}} \times P_{x_{2} y_{2} z} \\
= & \frac{1}{8}[00000]+\frac{1}{8}[00011]+\frac{1}{8}[01002]+\frac{1}{8}[01013] \\
& +\frac{1}{8}[10100]+\frac{1}{8}[10111]+\frac{1}{8}[11102]+\frac{1}{8}[11113]  \tag{22}\\
& g^{-1} \tag{18}
\end{align*}
$$

are quantum tripartite joint probability $P_{x y z}$ which cannot be generated from any classical triangle network consisting of three measurable variables and local measurements. Interestingly, all of their quantum distributions satisfy the condition in Eq.(16). This implies the inequivalence of quantum and classical realizations of triangle network in Fig 2(c). Thus the decomposition in Eq.(19) provides a sufficient condition to verify triangle network, and may be evaluated by using numeric methods 21].

The other is a tripartite network consisting of one latent variable as shown in Fig[2(d). One example is the distribution $P_{x y z}=\frac{1}{3}[001]+\frac{1}{3}[010]+\frac{1}{3}[100]$, which cannot be generated from all networks in Fig [2(a)-(c) 22 24].

This yields to a further problem to distinguish different configurations of triangle networks. Here, we present an informational method as (see proofs in Appendix C):
$I(X ; Y ; Z) \leq \min \{H(X \mid Y, Z), H(Y \mid X, Z), H(Z \mid X, Y)\}$

$$
\begin{align*}
I(X ; Y ; Z)> & \frac{3}{2}(H(X)+H(Y)+H(Z))  \tag{20}\\
& -H(X, Y)-H(X, Z)-H(Y, Z) \tag{21}
\end{align*}
$$

which hold for the network in Fig (2). Instead, for the network in Fig.2(d) it follows

$$
\begin{aligned}
I(X ; Y ; Z) \leq & 4 H(X, Y, Z)-H(X, Y) \\
& -H(X, Z)-H(Y, Z)
\end{aligned}
$$

and

$$
\begin{align*}
I(X ; Y ; Z)> & \frac{4}{3}(H(X)+H(Y)+H(Z)) \\
& -H(X, Y)-H(X, Z)-H(Y, Z) \tag{23}
\end{align*}
$$

Example 1. Consider a Greenberger-Horne-Zeilinger (GHZ)-type distribution:

$$
\begin{equation*}
P_{g h z}=a[000]+(1-a)[111] \tag{24}
\end{equation*}
$$

where $a \in[0,1]$. This distribution can be generated by local projection measurements under the computation basis $\{|0\rangle,|1\rangle\}$ on a GHZ state $[25]: \sqrt{a}|000\rangle+\sqrt{1-a}|111\rangle$. It is easy to prove that $I(X ; Y ; Z) \geq 0$ for $a \geq 0$. Moreover, we show that this distribution is generated from a triangle network in Fig2(d) by violating the inequality (21) for $a>0$.

Example 2. Consider a mixture of GHZ-type distribution and W-type distribution as

$$
\begin{equation*}
P_{x y z}=p P_{g h z}+(1-p) P_{w} \tag{25}
\end{equation*}
$$

where $P_{g h z}=\frac{1}{2}[000]+\frac{1}{2}[111], P_{w}=\frac{1}{3}[001]+\frac{1}{3}[010]+$ $\frac{1}{3}[100]$, and $p \in[0,1]$. Here, the W-type distribution $P_{w}$ can be generated by local projection measurements under the computation basis $\{|0\rangle,|1\rangle\}$ on a W state [22]: $\frac{1}{\sqrt{3}}(|001\rangle+|010\rangle+|100\rangle)$. It follows from $I(X ; Y ; Z) \leq 0$ for $p \leq 0.814$ assisted by numeric evaluations. Moreover,

the distribution is generated from a triangle network in Fig 2(d) by violating the inequality (20) or (21) for $p \geq$ 0.836 .

Example 3. Consider a generalized W-type distribution [22]:

$$
\begin{equation*}
P_{w}=a[001]+b[010]+(1-a-b)[100], \tag{26}
\end{equation*}
$$

where $a, b \geq 0$ and $0 \leq a+b \leq 1$. We show that this distribution implies a negative Shannon mutual information of $I(X ; Y ; Z)<0$ for any $a, b$ (Appendix D ). Unfortunately, this distribution cannot be verified by using the inequalities (20) and (21). Instead, we verify any one of the following distributions (Appendix E)

$$
\begin{align*}
P_{x y z} & =a[001]+b[010]+c[100]+d[011],  \tag{27}\\
P_{x y z} & =a[001]+b[011]+c[100]+d[110], \tag{28}
\end{align*}
$$

and its permutations using the second-order inflation method [23], as shown in Fig.3, where $a, b, c, d \geq 0$ and $a+b+c+d=1$. Here, the triangle network consisting of $X_{1}, Y_{1}, Z_{1}$ and $\lambda_{1}, \gamma_{1}, \eta_{1}$ is the first-order inflation of the initial network consisting of $X, Y, Z$ and variables $\lambda, \gamma, \eta$. Moreover, the triangle network consisting of $X_{2}, Y_{2}, Z_{2}$ and $\lambda_{2}, \gamma_{2}, \eta_{2}$ is the second-order inflation of the initial network.

## B. Generic negative Shannon mutual information

Results 1 and 2 show specific network decompositions can be arisen from of negative Shannon mutual information. Our consideration here is for exploring its converse problem, that is, what information can be learned from a given tripartite network configuration? In general, for
a given tripartite Bayesian network $\mathcal{N}$ (consisting of one, two, or three independent measurable variables), define the minimal tripartite mutual information as

$$
\begin{equation*}
I_{\min }(X ; Y ; Z)=\min _{P_{x y z}}\{I(X ; Y ; Z)\} \tag{29}
\end{equation*}
$$

where the minimum is over all the possible distributions $P_{x y z}$ generated from $\mathcal{N}$. Informally, any one in a tripartite Bayesian network can locally generate additional information for others than its absence. This shows generic negative Shannon mutual information for tripartite networks (Appendix F).

Result 3. Any distribution from tripartite Bayesian networks satisfies

$$
\begin{equation*}
I_{\min }(X ; Y ; Z) \leq 0 \tag{30}
\end{equation*}
$$

Result 3 intrigues an interesting indicator of any tripartite network by defining the tripartite information increasing as

$$
\begin{align*}
\Delta & :=\max \{I(X ; Y \mid Z)-I(X ; Y)\} \\
& =-I_{\min }(X ; Y ; Z) \tag{31}
\end{align*}
$$

This can be used to characterize how much information can be built by local operations and classical communication (LOCC) of one party. It is of a fundamental rule of management science. One example is the organizational theory [26], where the indicator $\Delta$ can be used to characterize the increasing information by group behaviors associated with the network relationship. This may be extended and applied for general organizational theory beyond the scope of this paper.

## C. Negative Shannon mutual information from general networks

Results 1-3 shows the negative Shannon mutual information of three variables imply the compatible Bayesian networks. A natural problem is to explore general networks. Our method here is from so-called multipartite independent networks [27], that is, there are some nodes which have not shared any entanglement. Especially, consider an $n+m$-partite quantum network $\mathcal{N}_{n}$ consisting of generalized EPR states [8]: $\left|\phi_{1}\right\rangle=$ $\cos \theta_{i}|00\rangle+\sin \theta_{i}|11\rangle$ with $\theta_{i} \in\left(0, \frac{\pi}{2}\right), i=1, \cdots, N$. Our goal here is to consider the multipartite independent network [27]. Especially, assume that there are $n$ number of nodes $\mathrm{A}_{1}, \cdots, \mathrm{~A}_{n}$ in $\mathcal{N}_{n}$ with $n \geq 2$ such that each pair of them has not shared any entanglement, as shown in Fig 4.

Denote $X_{i} \in \mathcal{X}_{i}$ and $Y_{j} \in \mathcal{Y}_{j}$ as the respective outcomes of $\mathrm{A}_{i}$ and $\mathrm{B}_{j}$ under local projection measurements, $i=1, \cdots, n ; j=1, \cdots, m$. Our main result here is to prove that any general $n$-independent quantum network $\mathcal{N}_{n}$ (with $n \geq 3$ ) shows different features beyond $\mathcal{N}_{2}$, that is, the chain network in Fig 2(b). Specially, we show that both negative and positive mutual information can be generated from $\mathcal{N}_{n}$ with $n \geq$

3. Here, by using Eq.(3) iteratively and the equality $H\left(X_{1}, \cdots, X_{j} \mid X_{j+1}\right)=H\left(X_{1}, \cdots, X_{j}, X_{j+1}\right)-H\left(X_{j+1}\right)$ the mutual information of multivariate is defined as
$I\left(X_{1} ; \cdots ; X_{n} ; Y\right)=I\left(X_{1} ; \cdots ; X_{n}\right)-I\left(X_{1} ; \cdots ; X_{n} \mid Y(32)\right.$
where $I\left(X_{1} ; \cdots ; X_{n}\right)$ denotes the mutual information of variables $X_{1}, \cdots, X_{n}$ and can be defined by $I\left(X_{1} ; \cdots ; X_{n}\right)=$ $\sum_{\text {odd } i \leq n} \sum_{1 \leq j_{1}<\cdots<j_{i} \leq n} H\left(X_{j_{1}}, \cdots, X_{j_{i}}\right) \quad-$ $\sum_{\text {even } s \leq n} \sum_{1 \leq \ell_{1}<\cdots<\ell_{i} \leq n} H\left(X_{\ell_{1}}, \cdots, X_{\ell_{i}}\right), \quad$ and $I\left(X_{1} ; \cdots ; X_{n} \mid \bar{Y}\right)$ denotes the mutual information of $X_{1}, \cdots, X_{n}$ conditional on the outcomes of $Y=Y_{1} \cdots Y_{m}$ and can be defined as $I\left(X_{1} ; \cdots ; X_{n}\right)=$ $\sum_{\text {odd } i \leq n} \sum_{1 \leq j_{1}<\cdots<j_{i} \leq n} H\left(X_{j_{1}}, \cdots, X_{j_{j}} \mid Y\right)$ $\sum_{\text {even }_{s \leq n}} \sum_{1 \leq \ell_{1}<\cdots<\ell_{i} \leq n} H\left(X_{\ell_{1}}, \cdots, X_{\ell_{i}} \mid Y\right)$.

We firstly show some local operations may generate positive Shannon information for others as (Appendix G)

$$
\begin{align*}
& I\left(X_{1} ; \cdots ; X_{n}\right)=0 \\
& I\left(X_{1} ; \cdots ; X_{n} \mid Y\right)>0 \tag{33}
\end{align*}
$$

where the joint probability distribution $P_{X_{1} \cdots X_{n} Y}$ is obtained from local measurements on the network $\mathcal{N}_{k}$. This implies negative Shannon mutual information as

$$
\begin{equation*}
I\left(X_{1} ; \cdots ; X_{n} ; Y\right)<0 \tag{34}
\end{equation*}
$$

Moreover, there are some local operations may generate negative Shannon mutual information for others as (Appendix G)

$$
\begin{align*}
& I\left(X_{1} ; \cdots ; X_{n}\right)=0  \tag{35}\\
& I\left(X_{1} ; \cdots ; X_{n} \mid Y\right)<0 \tag{36}
\end{align*}
$$

This implies positive Shannon mutual information as

$$
\begin{equation*}
I\left(X_{1} ; \cdots ; X_{n} ; Y\right)>0 \tag{37}
\end{equation*}
$$

which is different from Eq.(34). Thus the general $k$ independent quantum network with $k \geq 3$ can generate both negative and positive Shannon mutual information
beyond Result 1 for tripartite chain network even if both have similar Bell nonlocality [27]. This intrigues new kinds of non-Shannon-type information for any independent set.

Example 4. One example is the joint distribution in Eq.(10). Another example is given by

$$
\begin{equation*}
P_{x y z}=\tilde{\sum}_{i, j} p_{i} q_{j}\left[x_{i} y_{j} z_{i j}\right] \tag{38}
\end{equation*}
$$

with three finite-dimensional random variables $X, Y, Z$, where $\left\{p_{i}\right\}$ and $\left\{q_{j}\right\}$ are probability distributions. Consider classical transformation $g: z_{i j} \mapsto x_{i} y_{j}$, it follows

$$
\left.P_{x y g(z)}=\tilde{\sum}_{i, j} p_{i} q_{j}\left[x_{i} y_{j} x_{i} y_{j}\right]=\tilde{\sum}_{i} p_{i}\left[x_{i} x_{i}\right] \tilde{\sum}_{j} q_{j}\left[y_{j} y_{j}\right] ; 39\right)
$$

$\underset{\sim}{w}$ which raises two independent joint distributions of $\tilde{\sum}_{i} p_{i}\left[x_{i} x_{i}\right]$ and $\tilde{\sum}_{j} q_{j}\left[y_{j} y_{j}\right]$. It is easy to check that the joint distribution $P_{x y g(z)}$ satisfying the constriction in Eq.(9), i.e., a negative information of $I(X ; Y ; Z)<0$. From Result 1, there is a tripartite chain network compatible with the distribution in Eq.(38). From Eq.(33) the present example can be extended for general star network which is compatible with the joint distribution

$$
\begin{equation*}
P_{x_{1} \cdots x_{n} y}=\sum_{i_{1}, \cdots, i_{n}}^{\sim} p_{i_{1}} \cdots p_{i_{n}}\left[x_{i_{1}} \cdots x_{i_{n}} y_{i_{1} \cdots i_{n}}\right] \tag{40}
\end{equation*}
$$

with $n+1$ finite-dimensional variables $X_{1}, \cdots, X_{n}, Y$, where $\left\{p_{i_{j}}\right\}$ are probability distributions, $j=1, \cdots, n$.

Example 5. For the triangle network one example is given by Eq.(17). Another is given by

$$
\begin{equation*}
P_{x y z}=\sum_{i, j, k} p_{i} q_{j} r_{k}\left[x_{i j} y_{j k} z_{k i}\right] \tag{41}
\end{equation*}
$$

with three finite-dimensional variables $X, Y, Z$, where $\left\{p_{i}\right\},\left\{q_{j}\right\}$ and $\left\{r_{k}\right\}$ are probability distributions. Consider local mappings $g_{1}: x_{i j} \mapsto(i, j), g_{2}: y_{j k} \mapsto(j, k)$ and $g_{3}: z_{k, i} \mapsto(k, i)$. It follows a new joint distribution
$P_{g_{1}(x) g_{2}(y) g_{3}(z)}=\tilde{\sum_{i, j, k}} p_{i} q_{j} r_{k}[i j, j k, k i]=\tilde{\sum_{i}} p_{i}[i i] \sum_{j} q_{j}[j j] \tilde{\sum_{k}} r_{k}$
which raises three independent joint distributions of $\tilde{\sum}_{i} p_{i}[i i], \tilde{\sum}_{j} q_{j}[j j]$ and $\tilde{\sum}_{k} r_{k}[k k]$. This means the joint distribution in Eq. (42) satisfy the conditions in Eqs.(16) and (19). From Result 2, there is a tripartite triangle network consisting of three variables compatible with the distribution in Eq. (41).

## III. CONCLUSIONS

For tripartite Shannon mutual information Results 1 and 2 imply a compatible chain network for special decomposition of its joint distribution in two cases. This means the negative Shannon mutual information hide different network configurations compatible with specific decompositions of joint distributions. This is different
from recent results for featuring higher-order statistical correlations [36] which takes use of Euler diagram corresponding to Shannon information. The main reason is that negative Shannon mutual information can be featured by using non-Shannon inequalities beyond Euler diagram. Here, the set bounded by Shannon-type information inequalities is denoted as polymatroidal region. A general problem is to determine whether all the polymatroids are entropic. Especially, the negative Shannon information of three random variables implies the existence of non-entropic polymatroids on the boundary [6, 28, 29]. This is further extended for four or more random variables, which even allow unconstrained non-Shannon-type information inequalities [6]. A natural problem is then to explore the Markov compatibility of general non-Shannon-type information. Another problem is to explore different formations of Shannon-type information 30].

In summary, we provided an operational characterization of negative Shannon mutual information. The
main idea is inspired by Bayesian networks. We have investigated the intrinsic network compatibility of all tripartite joint distributions. Similar results are proved for its quantum realizations. This provided a general method for experimentally verifying negative Shannon information in a device-independent manner. These results should be interesting in the information theory, deep learning, quantum nonlocality, and quantum networks.

## Appendix A: The nonnegative tripartite Shannon mutual information

In this section, we prove $I(X ; Y ; Z) \geq 0$ if three random variables $\{X, Y, Z\}$ on finite sample spaces consist of a Markov chain, that is, $X \rightarrow Y \rightarrow Z, X \rightarrow Z \rightarrow Y$, or $Y \rightarrow X \rightarrow Z$. The following proof holds for each case because of the symmetry of $I(X ; Y ; Z)$, that is, $I(X ; Y ; Z)=I(X ; Z ; Y)=I(Y ; X ; Z)$.

Assume that $X, Y$ and $Z$ consist of a Markov chain $X \rightarrow Y \rightarrow Z$. This implies that $X$ and $Z$ are independent conditional on $Y$. It follows that $p_{x y z}=p_{x \mid y} p_{z \mid y}$, where $P_{x y z}=\tilde{\sum}_{x y z} p_{x y z}[x y z]$ is the joint distribution of $X, Y$ and $Z$, and $p_{x \mid y}$ and $p_{z \mid y}$ are marginal conditional distributions. This implies

$$
\begin{align*}
I(X ; Z \mid Y) & =H(Y Z)+H(X Z)-H(Z)-H(X Y Z) \\
& =0 . \tag{A1}
\end{align*}

Combined with the definition of $I(X ; Y ; Z)$ we have

This has proved the result.

## Appendix B: Proof of Result 1

## 1. Classical Bayesian networks

The "hidden variable" (or latent variable) is firstly introduced in Ref. [8] for arguing the incompleteness of

quantum mechanics. These additional variables were from the assumptions of the causality and locality. Instead, Bohm 31] construct a hidden variable interpretation of elementary quantum theory. That particular interpretation has indeed a grossly nonlocal structure, according to the result to be proved by Bell [10]. Especially, the outcome $A$ of measurement $M_{A}$ is depending on its physical observable and hidden variable, that is, $p\left(M_{A}\right)=\int_{\lambda} A\left(M_{A}, \lambda\right) \mu(\lambda) d \lambda$, where $\mu(\lambda)$ is the probability distribution of $\lambda$. Thus the expectation value of two measurements $M_{A}$ and $M_{B}$ is given by

\end{equation*}

This is generally inconsistent with the quantum mechanical expectation value $P_{q}\left(M_{A}, M_{B}\right)$ on compose system $\rho_{A B}$ for more than one set of measurements, that is, $P_{h}\left(M_{A}, M_{B}\right) \neq P_{q}\left(M_{A}, M_{B}\right)$, which is firstly verified with Bell inequality [10]. Nevertheless, they are consistent with each other for single set of measurements [8].

Our goal is to prove Result 1 by using classical chain network, as shown in Fig (a). Specially, this classical realization is rigid which includes two subcases as follows:

C1. Any distribution $P_{x y z}$ derived from local measurement on classical networks satisfies

which includes negative and zero information beyond Result 1.

C 2 . For any distribution $P_{x y z}=\tilde{\sum}_{x y z} p_{x y z}[x y z]$ satisfying the condition in Eq. (B2) there exists local postprocessing function $g: \mathcal{Z} \rightarrow \mathcal{Z}_{1} \times \mathcal{Z}_{2}$ satisfying

\end{equation*}

where $P_{x y z_{1} z_{2}}$ is compatible with a chain network, that is, $P_{x y z_{1} z_{2}}=P_{x z_{1}} P_{y z_{2}}, P_{x z_{1}}=\tilde{\sum}_{x z_{1}} p_{x z_{1}}\left[x z_{1}\right]$ and $P_{y z_{2}}=\tilde{\sum}_{y z_{2}} p_{y z_{2}}\left[y z_{2}\right]$.
The proof is as follows.
Case 1. For a given chain network in Fig 5(a), consider its classical realization with two independent measurable variables $\lambda_{1}$ and $\lambda_{2}$. This implies a network decomposition of any joint distribution $P_{x y z}=$ $\tilde{\sum}_{x y z} p_{x y z}[x y z]$ as

where $\Omega=\Omega_{1} \times \Omega_{2}$. It is forward to prove that

& =\sum_{z} \int_{\Omega} p(x \mid \lambda) p(y \mid \gamma) p(z \mid \lambda, \gamma) \mu(\lambda) \mu(\gamma) d \lambda d \gamma \\
& =\int_{\Omega} p(x \mid \lambda) p(y \mid \gamma) \mu(\lambda) \mu(\gamma) d \lambda d \gamma \\
& =\int_{\Omega_{1}} p(x \mid \lambda) \mu(\lambda) d \lambda \int_{\Omega_{2}} p(y \mid \gamma) \mu(\gamma) d \gamma \\
& =p_{x} p_{y} \tag{B5}
\end{align*}
$$

where $p_{x}=\sum_{y z} p_{x y z}$ and $p_{y}=\sum_{x z} p_{x y z}$. This implies that the distribution $P_{x y z}$ defined in Eq.(B4) satisfies the condition in Eq. (B2).

Case 2. For a specific joint distribution $P_{x y z}=$ $\tilde{\sum}_{x, y, z} p_{x y z}[x y z]$ with three random variables $X, Y$ and $Z$ on finite sample spaces, assume that $P_{x y z}$ satisfies $I(X ; Y)=I(X ; Y \mid Z)=0$, that is, $X$ and $Y$ are both independent and conditional independent on $Z$. In this case, we have Markovian decomposition of $p_{x y z}$ as

& p_{x y z}=p_{x} p_{y} p_{z \mid x y}, \forall, x, y, z  \tag{B6}\\
& p_{x y z}=p_{z} p_{x \mid z} p_{y \mid z}, \forall, x, y, z \tag{B7}

From Algorithm 1, we can obtain two chain networks: one represents the distribution $P_{x y z}$ with two edges from $X$ to $Z$ and $Y$ to $Z$, the other represents the distribution $P_{x y z}$ with two edges from $Z$ to $X$ and $Z$ to $Y$. Both imply an undirected Bayesian network. This has completed the proof.

In what follows, we prove the result by considering $P_{x y z}$ satisfies $I(X ; Y)=0$ and $I(X ; Y \mid Z)>0$. This implies a Markovian decomposition of Eq.(B6). From Algorithm 1, we can obtain a chain network consisting of two edges for representing the distribution $P_{x y z}$, one is from $X$ to $Z$ and the other is $Y$ to $Z$, as shown in Fig (b), that is, two independent variables $X$ and $Y$ are the predecessors of $Z$.

We will prove the converse-directed chain Bayesian network shown in Fig (c) for representing the distribution $P_{x y z}$ satisfying Eq.(B3). The distribution $P_{x y z}$ is rewritten into

where $p_{x y}=\sum_{z} p_{x y z}$, and $Q_{x y}$ denotes the probability distribution of $Z$ conditional on $X=x$ and $Y=y$ and is defined by

with $p_{z \mid x y}=\frac{p_{x y z}}{p_{x y}}$.
Consider a joint distribution from the chain network as

& =\tilde{\sum}_{x=z_{1}, y=z_{2}} p_{x} p_{y}\left[x y z_{1} z_{2}\right] \tag{B10}
\end{align*}

where $P_{x z_{1}}=\tilde{\sum}_{x, z_{1}} p_{x z_{1}}\left[x z_{1}\right]$ and $P_{y z_{2}}=\tilde{\sum}_{y, z_{2}} p_{y z_{2}}\left[y z_{2}\right]$. From the condition in Eq.(B2), it follows from Eq.(B8) that

Hence, it is sufficient to show that the distribution in Eq.(B11) can be obtained from the distribution in Eq. B10 using local classical post-processing of $Z_{1}$ and $Z_{2}$. Note that $Q_{x y}$ in Eq. (B9) is a probability distribution, that is $\sum_{z} \frac{p_{x y z}}{p_{x y}}=\sum_{z} p_{z \mid x y}=1$. Define the following classical mapping

that is, the output of $z_{1}=x$ and $z_{2}=y$ is mapping into a probability distribution $Q_{x y} . g$ is a classical postprocessing function of probability. In fact, define a nonnegative matrix as

where $\vec{v}=\left(p_{z=1 \mid x y}, \cdots, p_{z=n \mid x y}, 0, \cdots, 0\right)$ denotes $n^{2}$ dimensional nonnegative vector associated with the probability distribution $Q_{x y}, \mathrm{~g}_{i, j}$ denote $n^{2}$ different permutations of vector $\vec{v}$ such that $\mathrm{g}_{x, y}(\vec{v})=\vec{v}$ for each pair of $x$ and $y$. Here, we assume there are $n$ samples of $x, y$. This implies

where $\vec{e}_{x y}$ denotes the $n^{2}$-dimensional unit vector with the $x y$-th component being 1 and others being 0 . It is easy to prove that $S_{x y}$ are double stochastic matrices, that is, the entries are non-negative, and each row and column sums to 1. From Birkhoff's theorem [18], it shows that the set of doubly stochastic matrices is a convex set whose extreme points are the permutation matrices. This means that all the transformations $S_{x y}$ can be realized in
statistics. Moreover, all the outputs $\{x y\}$ are distinguishable. This means that each $S_{x y}$ can be locally performed for each pair of outputs $x$ and $y$. So, we have proved that the distribution in Eq. (B11) can be obtained from the distribution in Eq. (B10) by using local classical postprocessing of $Z_{1}$ and $Z_{2}$. From Algorithm 1, we obtain the Bayesian network in Fig 5 (c).

In classical realization of Bayesian network, since the variables $x$ and $y$ are independent, from Eq.(7) in the maintext there are two independent measurable variables $\lambda_{1}$ and $\lambda_{2}$ such that

where $p(x \mid \lambda)$ and $p(y \mid \gamma)$ are characteristic functions, that is, $p(x \mid \lambda), p(y \mid \gamma) \in\{0,1\}$. Note that the function in Eq.(B12) is measurable. Combined with Eqs.(4) and (B3) we get from the independence of $X$ and $Y$ that
$\left.p_{x y z}=\int_{\Omega} p(x \mid \lambda) p(y \mid \gamma) g\left(p\left(\left(z_{1} z_{2}\right) \mid \lambda, \gamma\right)\right) \mu(\lambda) d \lambda \mu(\gamma) d \mathbb{P}, 17\right)$ where $\Omega=\Omega_{1} \times \Omega_{2}$, as shown in Fig 5 (a). This has completed the proof.

## 2. Quantum chain networks

Our goal in this section is to prove Result 1 by using quantum chain network, as shown in Fig.2(b). Specially, the quantum realization is also rigid, that is, any distribution $P_{x y z}$ derived from local measurements on this quantum network satisfies Eq.(B2). Moreover, for any distribution $P_{x y z}=\tilde{\sum}_{x y z} p_{x y z}[x y z]$ satisfy the condition in Eq.((B2) there exists a quantum chain network consisting of two bipartite states $\rho_{A C_{1}}$ on Hilbert space $\mathcal{H}_{A} \otimes \mathcal{H}_{C_{1}}$ and $\varrho_{B C_{2}}$ on Hilbert space $\mathcal{H}_{B} \otimes \mathcal{H}_{C_{2}}$, and local measurements $\left\{M_{x}^{(A)}\right\},\left\{M_{y}^{(B)}\right\}$ and $\left\{M_{z}^{\left(C_{1} C_{2}\right)}\right\}$ such that

$$
\begin{equation*}
p_{x y z}=\operatorname{Tr}\left[\left(M_{x}^{(A)} \otimes M_{y}^{(B)} \otimes M_{z}^{\left(C_{1} C_{2}\right)}\right) \rho_{A C_{1}} \otimes \varrho_{B C_{2}}[]\right. \tag{B18}
\end{equation*}
$$

In fact, consider a quantum network consisting of any bipartite states $\rho_{A C_{1}}$ on Hilbert space $\mathcal{H}_{A} \otimes \mathcal{H}_{C_{1}}$ and $\varrho_{B C_{2}}$ on Hilbert space $\mathcal{H}_{B} \otimes \mathcal{H}_{C_{2}}$. For any POVM measurements $\left\{M_{x}^{(A)}\right\},\left\{M_{y}^{(B)}\right\}$ and $\left\{M_{z}^{\left(C_{1} C_{2}\right)}\right\}$, we have

p_{x y}=\operatorname{Tr}\left[\left(M_{x}^{(A)} \otimes M_{y}^{(B)}\right) \rho_{A} \otimes \varrho_{B}\right] \tag{B19}
\end{equation*}

where $\rho_{A}$ and $\varrho_{B}$ are reduced density matrices of the systems $A$ and $B$, respectively. It follows that $p_{x y}=p_{x} p_{y}$ which satisfies the condition (B2).

In fact, the proof in Appendix B. 1 above has suggested a proof by using mixed states for quantum networks, where we can define $\rho_{A C_{1}}=\sum_{x, z_{1}} p_{x z_{1}}\left|x z_{1}\right\rangle\left\langle x z_{1}\right|$ and $\rho_{B C_{2}}=\sum_{y, z_{2}} p_{y z_{2}}\left|y z_{2}\right\rangle\left\langle y z_{2}\right|$. Each particle is measured under the computation basis $\{|x\rangle\},\{|y\rangle\}$ or $\left\{\left|z_{i}\right\rangle\right\}$.

The output of $z_{1} z_{2}$ is transformed into $z$ by using classically post-proposing function in Eq. (B12). Note that the post-proposing function is depending of the output $z_{1} z_{2}$. This generally cannot be realized by local quantum measurements on $C_{1}$ and $C_{2}$. Instead, in what follow we consider a quantum network consisting of two entangled states. With new quantum realization, any distribution satisfying the condition in Eq.(B2) can be generated by local quantum measurements without classical postprogressing.

For a given distribution $P_{x y z}=\tilde{\sum}_{x y z} p_{x y z}[x y z]$ satisfying the condition in Eq. (B2), we get marginal distributions $P_{x y}=\tilde{\sum}_{x y} p_{x y}[x y], P_{x}=\tilde{\sum}_{x} p_{x}[x]$ and $P_{y}=\tilde{\sum}_{y} p_{y}[y]$, where $p_{x y}=\sum_{z} p_{x y z}, p_{x}=\sum_{y, z} p_{x y z}$, and $p_{y}=\sum_{x, z} p_{x y z}$. Define a general joint state

|\Phi\rangle_{A B C}=\sum_{x, y, z} \sqrt{p_{x y z}}|x, y, z\rangle \tag{B20}
\end{equation*}
$$

from the joint distribution $P_{x y z}$. It follows that

p_{x y z}=\operatorname{Tr}[(|x\rangle\langle x| \otimes|y\rangle\langle y| \otimes|z\rangle\langle z|)|\Phi\rangle\langle\Phi|] \tag{B21}
\end{equation*}

that is, the quantum probability under local projection measurement is compatible with the given distribution $P_{x y z}$.

From two distributions $P_{x}$ and $P_{y}$, define two entangled states as

& =\sum_{x, y} \sqrt{p_{x y}}|x, y\rangle_{A^{\prime} B^{\prime}}|x, y\rangle_{C_{1}}\left(d_{2} \mathrm{~B} 24\right)
\end{aligned}
$$

from the equality of $p_{x y}=p_{x} p_{y}$ because of the condition in Eq. (B2). The reduced density matrix of the joint system $A^{\prime} B^{\prime}$ is given by

where $\rho_{A^{\prime}}=\sum_{x} p_{x}|x\rangle\langle x|$ and $\rho_{B^{\prime}}=\sum_{y} p_{y}|y\rangle\langle y|$.
Now, from Eq. ( (B24) we get the Schmidt decomposition of $\left|\phi_{1}\right\rangle_{A_{1} C_{1}}\left|\phi_{2}\right\rangle_{B_{1} C_{2}}$ as

where $\{|x, y\rangle\}$ are orthogonal states from the distinguishability of samples $\{x\}$ and $\{y\}$.

From Eq. (B20) we have

- Assume that $\left|\varphi_{x y}\right\rangle_{C}$ are orthogonal states. In this case, there is a local unitary mapping given by $U$ : $\left|\varphi_{x y}\right\rangle_{C} \mapsto|x y=z\rangle_{C_{1} C_{2}}$ because Eq.(B27) is the Schmidt decomposition of $|\Phi\rangle$. This implies
$\left(\mathbb{1}_{A B} \otimes U_{C}^{-1}\right)\left|\phi_{1}\right\rangle_{A_{1} C_{1}}\left|\phi_{2}\right\rangle_{B_{1} C_{2}}=|\Phi\rangle_{A B C}$.
By performing local projection measurements under bases $\left\{M_{x}=|x\rangle\left\langle\left. x\right|_{A_{1}}\right\},\left\{M_{y}=|y\rangle\left\langle\left. y\right|_{B_{1}}\right\}\right.\right.$ and $\left\{M_{\varphi_{x y}}=\left|\varphi_{x y}\right\rangle\left\langle\left.\varphi_{x y}\right|_{C}\right\}\right.$, we get a joint distribution $P_{x y z}=\tilde{\sum}_{x y z} q_{x y z}[x y z]$ with

q_{x y z} & =\operatorname{Tr}\left[\left(M_{x} \otimes M_{y} \otimes M_{\varphi_{x y}}\right) \rho_{1} \otimes \rho_{2}\right] \\
& =\operatorname{Tr}\left[\left(M_{x} \otimes M_{y} \otimes M_{z}\right)\left(\mathbb{1}_{A B} \otimes U_{C}^{-1}\right)\left(\rho_{1} \otimes \rho_{2}\right)\right] \\
& =p_{x y z} \tag{B29}
\end{align*}
$$

from Eqs. (B21) and (B28), where $\rho_{i}=\left|\phi_{i}\right\rangle\left\langle\phi_{i}\right|$, and $\left\{\Pi_{z}=|z\rangle\left\langle\left. z\right|_{C_{1} C_{2}}\right\}\right.$. This has completed the proof.

- Assume that $\left|\varphi_{x y}\right\rangle_{C}$ are not orthogonal states. In this case, we define local transformations $U_{x y}$ on the systems $C_{1} C_{2}$ and $C^{\prime}$ as follows

& =\sum_{x, y} \sqrt{p_{x y}}|x y\rangle_{A_{1} B_{1}}|x y\rangle_{C_{1} C_{2}}\left|\varphi_{x y}\right\rangle_{C}(\mathrm{~B} 31)
\end{aligned}
$$

By performing local measurements under projections $\left\{M_{x}=|x\rangle\left\langle\left. x\right|_{A_{1}}\right\},\left\{M_{y}=|y\rangle\left\langle\left. y\right|_{B_{1}}\right\},\left\{M_{x y}=\right.\right.\right.$ $|x y\rangle\left\langle\left. x y\right|_{C_{1} C_{2}}\right\}$ and $\left\{M_{\varphi_{x y}}=\left|\varphi_{x y}\right\rangle\left\langle\varphi_{x y}\right| C\right\}$, we get a joint distribution $P_{x y z}=\tilde{\sum}_{x y z} q_{x y z}[x y z]$ with

q_{x y z}= & \operatorname{Tr}\left[\left(M_{x} \otimes M_{y} \otimes M_{x y} \otimes M_{\varphi_{x y}}\right) \rho_{1} \otimes \rho_{2} \otimes|0\rangle\left\langle\left. 0\right|_{C^{\prime}}\right]\right. \\
= & \operatorname{Tr}\left[\left(M_{x} \otimes M_{y} \otimes M_{x y} \otimes M_{z}\right)\left(\mathbb{1}_{A_{1} B_{1}} \otimes_{x y} U_{x y}\right)\right. \\
& \times\left(\rho_{1} \otimes \rho_{2} \otimes|0\rangle\left\langle\left. 0\right|_{C^{\prime}}\right)\right] \\
= & \operatorname{Tr}\left[\left(M_{x} \otimes M_{y} \otimes M_{x y} \otimes M_{z}\right)|\Psi\rangle\langle\Psi|\right] \\
= & p_{x y z} \tag{B32}
\end{align*}
$$

from Eqs. (B21) and (B31). This has completed the proof.

## Appendix C: Proofs of Inequalities (19)-(23)

For a triangle network consisting of three independent random variables $X, Y$ and $Z$ on finite sample spaces the joint distribution satisfies the following inequality [32] as

The inequality (C5) implies

& =\frac{1}{2}\left(\sum_{x} p_{x} \log \frac{1}{p_{x}}+\sum_{y} p_{y} \log \frac{1}{p_{y}}+\sum_{z} p_{z} \log \frac{1}{p_{z}}\right) \\
& =\frac{1}{2}(H(X)+H(Y)+H(Z)) \tag{C6}
\end{align*}

from the increasing function of $f(x)=\log x$. Combining with the definition of $I(X ; Y ; Z)$, it follows the inequality (20).

For a triangle network consisting of one variable $\lambda$, its joint distribution $P_{x y z}$ satisfies as

& -(1-a) \log _{2}(1-a)-(1-b) \log _{2}(1-b) \\
& -(1-c) \log _{2}(1-c) \\
< & 0 \tag{D4}
\end{align*}

from [35, Appendix A]. Here, the total Shannon mutual information of the W-type distribution is shown in Fig.S6.

Moreover, consider classical transformations of the Wtype distribution in Eq.(D1) with local doubly stochastic matrices defined by

Interestingly, assisted by numeric simulations the maximal Shannon mutual information $I_{1}(X ; Y ; Z)$ over all

probabilistic transformations in Eqs.(D5)-(D7) is almost constant for any $a, b, c$, that is, $I_{1}(X ; Y ; Z) \approx 0.5307$. Meanwhile, the W-type distribution in Eq.(D1) achieves the minimal Shannon mutual information according to the local probabilistic transformations in Eqs.(D5)-(D7), that is,

up to the error scale of $10^{-7}$.

## Appendix E: Generalized W-type distributions in Eqs.(27) and (28)

In this section we firstly prove how to verify generalized W-type distributions in Eqs.(27) and (28) by using the network inflation [23]. And then, we prove the negative Shannon mutual information for these distributions.

## 1. Witnessing generalized W-type distribution

In this section we prove that any one of the following W-type distributions

is compatible with tripartite network consisting of one variable for any $a, b, c, d \in(0,1)$ and $a+b+c+d=$ 1 using the second-order inflation method [23]. Here, we only consider the distributions in Eqs. (E1) and (E4)
while similar proof holds for other distributions from the permutations of three variables.

Case 1. We prove the distribution $P_{x y z}$ in Eq.(E1) which is compatible with the tripartite network consisting of three latent variables, as shown in Fig.3(a).

From Eq.(E1) we get the marginal distributions as follows

for any $a, b, c \in(0,1)$ and $a+b+c+d=1$. Suppose that $P_{x y z}$ is compatible with the triangle network consisting of random variables $X, Y$ and $Z$ (generated from latent variables $\lambda, \gamma$ and $\eta$ ), as shown in Fig.3(a). A second-order spiral inflation is shown in Fig.3(b). Consider the firstorder inflation network consisting of random variables $X_{1}, Y_{1}$ and $Z_{1}$ (generated from latent variables $\lambda_{1}, \gamma_{1}$ and $\eta_{1}$ ). From Lemma 4 [23], it follows all the marginal distributions of $\{A B C\},\left\{X Z_{1}\right\},\left\{Y_{1} Z\right\},\left\{X_{1} Y\right\},\left\{X_{1}\right\},\left\{Y_{1}\right\}$ and $\left\{Z_{1}\right\}$ which have the same marginal distribution with Eqs.(E7)-(E12) should be compatible with the first-order inflation network in Fig.3(b), that is,

P_{x z_{1}} & =c[10]+b[00]+(a+d)[01],  \tag{E13}\\
P_{y_{1} z} & =c[00]+b[10]+a[01]+d[11],  \tag{E14}\\
P_{x_{1} y} & =a[00]+c[10]+(b+d)[01],  \tag{E15}\\
P_{x_{1}} & =P_{x}, P_{y_{2}}=P_{y}, P_{z_{1}}=P_{z} \tag{E16}
\end{align*}
$$

From Eq.(E13) it implies that $X=0$ whenever $Z_{1}=1$. Similarly, we get $Y=0$ whenever $X_{1}=1$ from Eq.(E15), that is,

\operatorname{Pr}\left[X=0 \mid Z_{1}=1\right]=\operatorname{Pr}\left[Y=0 \mid X_{1}=1\right]=1 \tag{E17}
\end{equation*}

Consider the second-order inflation network consisting of random variables $X_{2}, Y_{2}$ and $Z_{2}$ (generated from latent variables $\lambda_{2}, \gamma_{2}$ and $\eta_{2}$ ). From Lemma 4 23], it follows all the marginal distributions of $\{X Y Z\},\left\{Y Z_{2}\right\},\left\{X Y_{2}\right\},\left\{X_{2} Z\right\},\left\{X_{2}\right\},\left\{Y_{2}\right\}$ and $\left\{Z_{2}\right\}$ which have the same marginal distribution with Eqs.(E7)-(E12) should be compatible with the secondorder inflation network in Fig.3(b), that is,

P_{y z_{2}} & =c[00]+b[10]+a[01]+d[11],  \tag{E18}\\
P_{x y_{2}} & =a[00]+c[10]+(b+d)[01],  \tag{E19}\\
P_{x_{2} z} & =c[10]+b[00]+(a+d)[01],  \tag{E20}\\
P_{x_{2}} & =P_{x}, P_{y_{2}}=P_{y}, P_{z_{2}}=P_{z} \tag{E21}
\end{align*}
$$

From Eq. (E19) it implies that $X=0$ whenever $Y_{2}=1$. Similarly, we get $Z=0$ whenever $X_{2}=1$ from Eq. (E20), that is,

\operatorname{Pr}\left[X=0 \mid Y_{2}=1\right]=\operatorname{Pr}\left[Z=0 \mid X_{2}=1\right]=1 \tag{E22}
\end{equation*}

From Fig.3(b) the inflation shows the random variables $X_{1}, Y_{1}, Z_{1}, X_{2}, Y_{2}, Z_{2}$ should be marginally independent in any compatible distribution. From Eqs.(E12) and (E16) it follows that

Combined with Eqs. (E17) and (E22), it follows that

which is contradicted to Eq.(E1). This has proved that the distribution in Eq. (E1) is incompatible with the tripartite network in Fig.3(a).

Case 2. We prove the distribution in Eq. (E4) is compatible with the tripartite network consisting of three latent variables, as shown in Fig.3(a).

From Eq.(E4) we get the marginal distributions as follows

for any $a, b, c, d \in(0,1)$ and $a+b+c+d=1$. Suppose that $P_{x y z}$ is compatible with the triangle network consisting of three latent variables, as shown in Fig.3(a). From Lemma 4 [23] it follows all the marginal distributions of sets $\{A B C\},\left\{X Z_{1}\right\},\left\{Y_{1} Z\right\},\left\{X_{1} Y\right\},\left\{X_{1}\right\},\left\{Y_{1}\right\}$ and $\left\{Z_{1}\right\}$ which have the same marginal distribution with Eqs. (E25)- E30) should be compatible with the firstorder inflation network in Fig.3(b), that is,

From Eq. E32 it implies that $Y=0$ whenever $X_{1}=1$, that is,

Moreover, all the marginal distributions of $\{X Y Z\},\left\{Y Z_{2}\right\},\left\{X Y_{2}\right\},\left\{X_{2} Z\right\},\left\{X_{2}\right\},\left\{Y_{2}\right\}, \quad$ and $\left\{Z_{2}\right\}$ which have the same marginal distribution with Eqs. (E25)-(E30) should be compatible with the second-order inflation network in Fig.3(b), that is,

Combined with Eqs. (E35) and (E40), it follows that

which is contradicted to Eq.(E4). This has proved that the distribution in Eq. $(\overline{\mathrm{E} 4})$ is incompatible with the tripartite network in Fig.3(a).

## 2. Negative Shannon mutual information

Here, we firstly consider the W-type distribution in Eq.(E1). We show that its Shannon mutual information satisfies $I_{w s}(X ; Y ; Z) \leq 0$ for the subcase of $a=c$ or $b=c$. Similar proofs hold for other two distributions in Eqs.(E2) and (E3). In fact, from the marginal distributions in Eqs. (E7)- (E12) we get

H(Y, Z)= & H(X, Y, Z)=-a \log _{2} a-b \log _{2} b \\
& -c \log _{2} c-d \log _{2} d . \tag{E43}
\end{align*}
$$

This implies the Shannon mutual information as

I_{w s}(X ; Y ; Z)= & H(X)+H(Y)+H(Z)+H(X, Y, Z) \\
& -H(X, Y)-H(X, Z)-H(Y, Z) \\
= & a \log _{2} a+b \log _{2} b+c \log _{2} c \\
& -(1-c) \log _{2}(1-c)-(a+c) \log _{2}(a+c) \\
& -(b+c) \log _{2}(b+c) . \tag{E44}
\end{align*}
$$

Now, consider the subcase of $a=c$. From Eq.(E44) it follows that

I_{w s}(X ; Y ; Z)= & b \log _{2}(b)-(1-a) \log _{2}(1-a)-2 a \\
& -(b+a) \log _{2}(b+a) \tag{E45}
\end{align*}
$$

The first-order of partial derivatives are given by

\end{align*}

for any $a, b \geq 0$. This implies that $I_{w s}(X ; Y ; Z) \leq 0$ from $I_{w s}(X ; Y ; Z)=0$ with $a=b=0$. From the symmetry of $a$ and $b$ in Eq.(E44), we can prove the result for the subcase of $b=c$.

Moreover, under the probabilistic transformations in Eqs.(D5)-(D7) the maximal Shannon mutual information satisfies $I_{1}(X ; Y ; Z) \geq 0.5294$ for any $a, b$. Different from the W-type distribution in Eq.(D1) the probabilistic transformations in Eqs. (D5)-(D7) can change the minimal Shannon mutual information $I_{2}(X ; Y ; Z)$. Specially, we show that

I_{w s}(X ; Y ; Z) \preceq I_{2}(X ; Y ; Z) \tag{E48}
\end{equation*}
$$

for any $0 \leq a, b \leq 1$. This shows a different feature of the W-type distribution in Eq. (E1) from in Eq.(D1).
Now, we consider the W-type distribution in Eq. (E4). Different from the distributions in Eqs.(E1)-(E3) its Shannon mutual information satisfies $I_{w s}(X ; Y ; Z) \geq 0$ for any $a, b, c, d$. In fact, from the marginal distributions in Eqs.(E25)-(E30) we get

= & -(a+b) \log _{2}(a+b) \\

H(X, Z)= & H(Y, Z)=H(X, Y, Z) \\
= & -a \log _{2} a-b \log _{2} b \\
& -c \log _{2} c-d \log _{2} d . \tag{E51}
\end{align*}

This implies the Shannon mutual information satisfying

& \geq 0 \tag{E52}
\end{align*}

Similar proofs hold for other two distributions in Eqs.(E5) and (E6).

## Appendix F: Proof of Result 3

The proof of Result 3 is completed using quantum realization of Bayesian network, which includes any classical realization. We firstly prove the result for a tripartite quantum network consisting of any pure three-qubit state $|\Phi\rangle_{A B C}$ on Hilbert space $\mathcal{H}_{A} \otimes \mathcal{H}_{B} \otimes \mathcal{H}_{C}$. Consider its Schmidt decomposition with respect to the bipartition $A$ and $B C$ as

where $\lambda_{i}$ 's are Schmidt coefficients satisfying $\sum_{i} \lambda_{i}^{2}=1$, and $\left\{\left|\phi_{i}\right\rangle\right\}$ are orthogonal states of the particle $A$ while $\left\{\left|\psi_{i}\right\rangle\right\}$ are orthogonal states of joint system $B C$.

If $s=1,|\Phi\rangle$ is a product state. In this case, for any local POVM operators $\left\{M_{x}\right\},\left\{N_{y}\right\},\left\{L_{z}\right\}$, we have

p_{x y z} & =\operatorname{Tr}\left[|\Phi\rangle\langle\Phi|\left(M_{x} \otimes N_{y} \otimes L_{z}\right)\right] \\
& =\operatorname{Tr}\left(\left|\phi_{1}\right\rangle\left\langle\phi_{1}\right| M_{x}\right) \operatorname{Tr}\left(\left|\psi_{1}\right\rangle\left\langle\psi_{1}\right|\left(N_{y} \otimes L_{z}\right)\right) \\
& =p_{x} p_{y z} \tag{F2}
\end{align*}
$$

for any $x, y, z$. This implies that

I(X ; Y ; Z)=I(Y ; Z)-I(Y ; Z \mid X)=0 \tag{F3}
\end{equation*}
$$

It follows that $I_{\min }(X ; Y ; Z)=0$.
If $s=2,|\Phi\rangle$ is an entanglement. In this case, by using proper local unitary transformations for each particle, we obtain three entangled states as

& \left.+\gamma_{2}|10\rangle+\gamma_{3}|11\rangle\right)  \tag{F5}\\
\left|\Phi_{3}\right\rangle= & \lambda_{1}|0\rangle(\alpha|00\rangle+\beta|11\rangle)+\lambda_{2}|1\rangle(\gamma \beta|00\rangle \\
& \left.-\gamma \alpha|11\rangle+\gamma_{1}|01\rangle+\gamma_{2}|10\rangle\right) \tag{F6}
\end{align*}
$$

For the GHZ-type state in Eq. (F4) each party performs the projection measurement under the computation basis $\{|0\rangle,|1\rangle\}$. They get the tripartite probability distribution as

which can be classically transformed into

\end{equation*}

by using a post-processing transformation

\mathcal{T}:[i] \mapsto \frac{1}{2}[0]+\frac{1}{2}[1], i=0,1 \tag{F9}
\end{equation*}
$$

for each party. For the distribution $P_{x y z}^{\prime}$ in Eq. (F8) we get

This implies that $I_{\min }(X ; Y ; Z) \leq 0$. Moreover, we can show that there are local POVM measurements such that $I_{\text {min }}(X ; Y ; Z)<0$ for any $\lambda_{1} \in(0,1)$ assisted by numeric evaluations.

For the entanglement in Eq. (F5), each party performs the projection measurement under the computation basis $\{|0\rangle,|1\rangle\}$. They get a joint probability distribution as

\begin{align*}
P_{x y z}= & \lambda_{1}^{2}[000]+\lambda_{2}^{2} \gamma_{1}^{2}[101]+\lambda_{2}^{2} \gamma_{2}^{2}[110] \\
& +\lambda_{2}^{2} \gamma_{3}^{2}[111] \tag{F11}
\end{align*}
$$

which can be classically transformed into the distribution in Eq.(F8) by using the post-processing transformation in Eq. (F9) for each party. This implies that $I_{\text {min }}(X ; Y ; Z) \leq 0$. Moreover, we can prove there are local measurements such that $I_{\min }(X ; Y ; Z)<0$ for almost all $\lambda_{i}, \gamma_{j} \in(0,1)$ assisted by numeric evaluations.

For the entanglement in Eq. (F6) each party performs the projection measurement under the computation basis $\{|0\rangle,|1\rangle\}$. And then, they can transform the joint probability distribution into the distribution Eq.(F8) by using the post-processing transformation (F9). This implies that $I_{\min }(X ; Y ; Z) \leq 0$. Moreover, there are local measurements such that $I_{\text {min }}(X ; Y ; Z)<0$ for almost all $\lambda_{i}, \alpha, \beta, \gamma_{j}, \in(0,1)$ assisted by numeric evaluations.

Similarly result holds for any high-dimensional entanglement $|\Phi\rangle$ on Hilbert space $\mathcal{H}_{A} \otimes \mathcal{H}_{B} \otimes \mathcal{H}_{C}$. Here, each joint distribution under local projection measurements can be changed into a separable distribution by using the post-processing transformation in Eq. (F9) for any outcome.

## Appendix G: Shannon mutual information from general networks

Consider a general $n+m$-partite quantum network $\mathcal{N}_{n}$, as shown in Fig.4. Our goal here is to prove both negative and positive mutual information can be generated from $\mathcal{N}_{n}$ with $n \geq 3$.

## 1. Generating positive mutual information

In this subsection, we show some local operations may build positive Shannon mutual information for others as

where the joint probability distribution $P_{X_{1} \cdots X_{n} Y}$ is obtained from local measurements on the network $\mathcal{N}_{k}$. This implies negative Shannon mutual information as

I\left(X_{1} ; \cdots ; X_{n} ; Y\right):= & I\left(X_{1} ; \cdots ; X_{n}\right) \\
& -I\left(X_{1} ; \cdots ; X_{n} \mid Y\right) \\
\leq & 0 \tag{G2}
\end{align*}
$$

where all the random variables $Y:=Y_{1} \cdots Y_{m}$ are regarded as one high-dimensional variable.

In fact, define local measurements of $\mathrm{A}_{i}$ as $\left\{M_{x_{i}}=\right.$ $\left.\left|x_{i}\right\rangle\left\langle x_{i}\right|\right\}$ which satisfy $\sum_{x_{i}} M_{x_{i}}=\mathbb{1}_{A_{i}}$ with the identity operator $\mathbb{1}_{A_{i}}$ on the state space of $\mathrm{A}_{i}, i=1, \cdots, n$. Let $\left\{M_{y_{j}}\right\}$ with $M_{y_{j}} \in\left\{|i\rangle \pm\left|2^{s_{j}}-i-1\right\rangle, i=0, \cdots, 2^{s_{j}-1}\right\}$ be local measurements of $\mathrm{B}_{j}$ and satisfy $\sum_{y_{j}} M_{y_{j}}=\mathbb{1}_{B_{j}}$ with the identity operator $\mathbb{1}_{B_{j}}$ on the state space of $\mathrm{B}_{j}$, where $s_{j}$ denotes the number of particle contained in the node $\mathrm{B}_{j}, j=1, \cdots, n$. Since all the nodes $\mathrm{A}_{1}, \cdots, \mathrm{~A}_{n}$ are independent, the joint probability of the outcome $x_{1} \cdots x_{n}$ is given by

p_{x_{1} \cdots x_{n}} & =\operatorname{Tr}\left(\otimes_{i=1}^{n} M_{x_{i}} \rho_{A_{1} \cdots A_{n}}\right) \\
& =\otimes_{i=1}^{n} \operatorname{Tr}\left(M_{x_{i}} \rho_{A_{i}}\right) \\
& =\prod_{i=1}^{n} p_{x_{i}} \tag{G3}
\end{align*}
$$

where $\rho_{A_{1} \cdots A_{n}}$ denotes the reduced density matrix of $\mathrm{A}_{1}, \cdots, \mathrm{~A}_{n}, \rho_{A_{i}}$ denotes the reduced density matrix of $\mathrm{A}_{i}$, and $p_{x_{i}}$ denotes the probability of the outcome $x_{i}$ by $\mathrm{A}_{i}$. From Eq.(G3) it follows that

Now, consider the projection measurement $\left\{M_{y_{j}}\right\}$ of $\mathrm{B}_{1}, \cdots, \mathrm{~B}_{m}$, and send out the measurement outcomes for $\mathrm{A}_{1}, \cdots, \mathrm{~A}_{n}$. It is easy to check that the joint state of $\mathrm{A}_{1}, \cdots, \mathrm{~A}_{n}$ is changed into an $n$-qubit GHZ state

under proper local unitary operations [11], where $\varphi$ depends on parameters $\theta_{1}, \cdots, \theta_{n}$. Now, under the local projection measurement $\left\{M_{x_{i}}\right\}$, it follows the joint distribution

P_{x_{1} \cdots x_{n}}=\cos ^{2} \varphi[0 \cdots 0]+\sin ^{2} \varphi[1 \cdots 1] \tag{G6}
\end{equation*}

We obtain that

I\left(X_{1} ; \cdots ; X_{n} \mid Y\right)= & -\cos ^{2} \varphi \log \left(\cos ^{2} \varphi\right) \\
& -\sin ^{2} \varphi \log \left(\sin ^{2} \varphi\right) \\
> & 0 \tag{G7}
\end{align*}
$$

for any $\theta_{1}, \cdots, \theta_{n} \in\left(0, \frac{\pi}{2}\right)$. From Eqs. (G4) and (G7) we get that

This has proved the result. One example is long chain network or star network 27].

## 2. Generating positive Shannon mutual information

In this subsection, we show some local operations may generate negative Shannon mutual information for others as

& I\left(X_{1} ; \cdots ; X_{n} \mid Y\right)<0 \tag{G10}
\end{align*}

where the joint probability distribution $P_{X_{1} \cdots X_{n} Y_{1} \cdots Y_{m}}$ is obtained from local measurements on the network $\mathcal{N}_{k}$. This implies positive Shannon mutual information as

$$
\begin{align*}
I\left(X_{1} ; \cdots ; X_{n} ; Y\right)= & I\left(X_{1} ; \cdots ; X_{n}\right) \\
& -I\left(X_{1} ; \cdots ; X_{n} \mid Y\right) \\
> & 0 \tag{G11}
\end{align*}
$$

which is different from Eq. (G2). This means that the $n$ independent network shows different correlations beyond the chain network in Fig.2(b) for any $n \geq 3$.

The proof is constructed as follows. Consider a special case of $\mathcal{N}_{q}$ as $n=3$ and $m=1$. Here, each pair of $\mathrm{A}_{i}$ and B shares one EPR state $\left|\phi_{i}\right\rangle$. In this case, the total state of $\mathcal{N}_{q}$ is given by

where $a_{i_{1} i_{2} i_{3}}=\prod_{j=1}^{3} \cos ^{i_{j}+1 \bmod 2} \theta_{j} \sin ^{i_{j}} \theta_{j}$. B performs a local measurement under the quantum Fourier basis $\left\{\Pi_{y}\right\}$ with $\Pi_{y} \in\left\{\left|\varphi_{i}\right\rangle\left\langle\varphi_{i}\right\}\right.$, where $\left|\varphi_{i}\right\rangle$ are defined as

\left|\varphi_{i}\right\rangle= & \frac{1}{2}\left(|001\rangle+\omega^{i}|010\rangle\right. \\
& \left.+\omega^{2 i}|100\rangle+\omega^{3 i}|011\rangle\right) \\
\left|\varphi_{4+i}\right\rangle= & \frac{1}{2}\left(|110\rangle+\omega^{i}|101\rangle\right. \\
& +\omega^{2 i}|000\rangle+\omega^{3 i}|111\rangle \tag{G13}
\end{align*}
$$

with an unit root $\omega=\sqrt{-1}, i=1, \cdots, 4$. After the local measurement, by proper local operation of $A_{1}$, the joint state of $A_{1}, A_{2}$ and $A_{3}$ is changed into

\left|\Phi_{i}\right\rangle= & a_{001}|001\rangle+\omega^{-i} a_{010}|010\rangle \\
& \left.+\omega^{-2 i} a_{100}|100\rangle+\omega^{-3 i} a_{011}|011\rangle\right), \\
\left|\Phi_{4+i}\right\rangle= & a_{110}|010\rangle+\omega^{-i} a_{101}|001\rangle \\
& +\omega^{-2 i} a_{000}|100\rangle+\omega^{-3 i} a_{111}|011\rangle \tag{G14}
\end{align*}
$$

where $i=1, \cdots, 4$. Under the local projection of all parties $\mathrm{A}_{j}$ 's, it implies a joint distribution as

P_{x_{1} x_{2} x_{3}}= & a_{001}^{2}[001]+a_{010}^{2}[010]  \tag{G15}\\
& +a_{100}^{2}[100]+a_{011}^{2}[011]
\end{align*}
$$

or

P_{x_{1} x_{2} x_{3}}= & a_{110}^{2}[010]+a_{101}^{2}[001] \\
& +a_{000}^{2}[100]+a_{111}^{2}[011] \tag{G16}
\end{align*}
$$

Combined with Appendix E.2, it follows that

\end{equation*}

for $\theta_{1}=\theta_{3}$. This has completed the proof from Eqs.(G4) and G17.
