# MODULATION THEORY FOR THE FLAT BLOW-UP SOLUTIONS OF NONLINEAR HEAT EQUATION

#### Abstract

In this paper, we revisit the proof of the existence of a solution to the semilinear heat equation in one space dimension with a flat blow-up profile, already proved by Bricmont and Kupainen together with Herrero and Velázquez. Though our approach relies on the well-celebrated method, based on the reduction of the problem to a finite-dimensional one, then the use of a topological "shooting method" to solve the latter, the novelty of our approach lays in the use of a modulation technique to control the projection of the zero eigenmode arising in the problem. Up to our knowledge, this is the first time where modulation is used with this kind of profiles. We do hope that this simplifies the argument.


## 1. Introduction

We consider the following nonlinear heat equation (NLH)

$$
\left\{\begin{array}{l}
u_{t}=\Delta u+|u|^{p-1} u  \tag{1.1}\\
u(., 0)=u_{0} \in L^{\infty}\left(\mathbb{R}^{N}, \mathbb{R}\right),
\end{array}\right.
$$

where $p>1$ and $u(x, t): \mathbb{R}^{N} \times[0, T) \rightarrow \mathbb{R}$. Equation (1.1) is considered as a model for many physical situations, such as heat transfer, combustion theory, thermal explosion, etc. (see more in Kapila [14], Kassoy and Poland [15, 16], Bebernes and Eberly [2]). Firstly, note that equation (1.1) is well-posed in $L^{\infty}$. More precisely, for each $u_{0} \in L^{\infty}\left(\mathbb{R}^{N}\right)$, one of the following statements holds:

- either the solution is global in time;
- or the maximum existence time is finite i.e. $T_{\max }<+\infty$ and

$$

\lim _{t \rightarrow T_{\max }}\|u(\cdot, t)\|_{L^{\infty}}=+\infty \tag{1.2}
\end{equation*}

In particular, $T_{\max }>0$ is called the blowup time of the solution and a point $a \in \mathbb{R}^{N}$ is called a blowup point of the solution if there exists sequence $\left(a_{n}, t_{n}\right) \rightarrow(a, T)$ as $n \rightarrow+\infty$ such that

$$
\left|u\left(a_{n}, t_{n}\right)\right| \rightarrow+\infty \text { as } n \rightarrow+\infty .
$$

Blowup for equation (1.1) has been studied intensively by many mathematicians and no list can be exhaustive. This is the case for the question of deriving blowup profiles, which is completely understood in one space dimension (see in particular Herrero and Velázquez [10, 8, 11, 12]), unlike

[^0]the higher dimensional case, where much less is known (see for example Velázquez [20, 21, 22], Zaag [23, 24, 26, 25] together with the recent contributions by Merle and Zaag [17, 18]).

In the one dimensional case, Herrero and Velázquez proved the following, unless the solution is space independent (see also Filippas and Kohn [7]):
(i) Either

\sup _{|x-a| \leq K \sqrt{(T-t)|\ln (T-t)|}}\left|(T-t)^{\frac{1}{p-1}} u(x, t)-\varphi\left(\frac{x-a}{\sqrt{(T-t)|\ln (T-t)|}}\right)\right| \rightarrow 0
$$

where $\varphi(z)=\left(p-1+b_{g}|z|^{2 k}\right)^{\frac{1}{p-1}}$ and $b_{g}=\frac{(p-1)^{2}}{4 p}$ is unique. (note that Herrero and Velázquez proved that this behavior is generic in [12, 9]).
(ii) Or

$$
\sup _{|x-a| \leq K(T-t)^{\frac{1}{2 k}}}\left|(T-t)^{\frac{1}{p-1}} u(x, t)-\varphi_{k}\left(\frac{x-a}{(T-t)^{\frac{1}{2 k}}}\right)\right| \rightarrow 0
$$

where $\varphi_{k}(z)=\left(p-1+b|z|^{2 k}\right)^{\frac{1}{p-1}}$, where $b$ is an arbitrary positive number.
In particular, we are interested in constructing blowup solution with a prescribed behaviors, via a "generic approximation", called the blowup profile of the solution.

The existence of such solutions was observed by Velázquez, Galaktionov and Herrero [13] who indicated formally how one might find these solution. Later, Bricmont and Kupiainen [3], will give a rigorous proof of construction of such profiles (see also Herrero and Velázquez [8] for the profile $\varphi_{4}$ ). In [1], Angenent and Velázquez gives a construction of blow up solution for the mean curvature flow inspied by the construrction of (ii). Most of the constructions are made in one dimension $N=1$. In higher dimension $N \geq 2$, recently Merle and Zaag give the construction of a new profile of type I with a superlinear power in the Sobolev subcritical range, for more details see [18].

In this paper we revisit the construction of ii) given in Section 4 of [3]. Our construction has the advantage that it uses the modulation parameter. We shall use a topological "shooting" argument to prove existence of Solutions constructed in Theorem 1.1. The construction is essentially an adaptation of Wazewski's principle (see [6], chapter II and the references given there). The use of topological methods in the analysis of singularities for blow-up phenomena seems to have been introduced by Bressan in [5].

The following is the main result in the paper
Theorem 1.1. Let $p>1$ and $k \in \mathbb{N}, k \geq 2$, then there exist $\delta_{0}$ and $\tilde{T}>0$ such that for all $\delta \in\left(0, \delta_{0}\right)$ and $T \in(0, \tilde{T})$, we can construct initial datum $u_{0} \in L^{\infty}(\mathbb{R})$ such that the corresponding solution to equation (1.1) blowup in finite time $T$ and only at the origin. Moreover, there exists the flow $b(t) \in C^{1}(0, T)$ such that the following description is valid
(i) For all $t \in[0, T)$, it holds that

$$
\begin{equation*}
\left\|(T-t)^{\frac{1}{p-1}} u(\cdot, t)-f_{b(t)}\left(\frac{|\cdot|^{2 k}}{T-t}\right)\right\|_{L^{\infty}(\mathbb{R})} \lesssim(T-t)^{\frac{\delta}{2}\left(1-\frac{1}{k}\right)} \text { as } s \rightarrow \infty . \tag{1.3}
\end{equation*}
$$

(ii) There exists $b^{*}>0$ such that $b(t) \rightarrow b^{*}$ as $t \rightarrow T$ and

$$
\begin{equation*}
\left|b(t)-b^{*}\right| \lesssim(T-t)^{\delta\left(1-\frac{1}{k}\right)}, \forall t \in(0, T), \tag{1.4}
\end{equation*}
$$

where $f_{b(t)}$ is defined by

$$
\begin{equation*}
f_{b(t)}(y)=\left(p-1+b(t) y^{2 k}\right)^{-\frac{1}{p-1}} \tag{1.5}
\end{equation*}
$$

Remark 1.1. One of the most important steps of the proof is to project the linearized partial differential equation (2.8) on the $H_{m}$, given by (3.3). We note that this is technically different from the work of Bricomont and Kupiainen [3], where the authors project the integral equation. Consequently, we will have additional difficulty coming from the projection of the the different terms, see for example Lemma 5.1 and Lemma 5.2.

Remark 1.2. We note that $\frac{b_{0}}{2} \leq b(t) \leq 2 b_{0}$ and (1.4), it holds that

\left\|\left(p-1+b(t) y^{2 k}\right)^{-\frac{1}{p-1}}-\left(p-1+b^{*} y^{2 k}\right)^{-\frac{1}{p-1}}\right\|_{L^{\infty}(\mathbb{R})} \lesssim\left|b(t)-b^{*}\right| \lesssim(T-t)^{\delta\left(1-\frac{1}{k}\right)},
$$

which yields

$$
\begin{equation*}
\left\|(T-t)^{\frac{1}{p-1}} u(\cdot, t)-f_{b^{*}}\left(\frac{|\cdot|^{2 k}}{T-t}\right)\right\|_{L^{\infty}(\mathbb{R})} \lesssim(T-t)^{\frac{\delta}{2}\left(1-\frac{1}{k}\right)} \text { as } s \rightarrow \infty . \tag{1.6}
\end{equation*}
$$

The paper is organised as follows. In Section 2 and 3, we give the formulation of the problem. In Section 4 we give the proof of the existence of the profile assuming technical details. In particular, we construct a shrinking set and give an example of initial data giving rise to the blow-up profile and at the end of the section we give the proof of Theorem 1.1. The topological argument of Section 4 uses a number of estimates given by Proposition 4.5, we give the proof of this proposition in Section 5.

## 2. Formulation of the problem

Let us consider $T>0$, and $k \in \mathbb{N}, k \geq 2$, and $u$ be a solution to (1.1) which blows up in finite time $T>0$. Then, we introduce the following blow-up variable:

w(y, s)=(T-t)^{-\frac{1}{p-1}} u(x, t), y=\frac{x}{(T-t)^{\frac{1}{2 k}}}, \quad s=-\ln (T-t) . \tag{2.1}
\end{equation*}

Since $u$ solves (1.1), for all $(x, t) \in \mathbb{R}^{N} \times[0, T)$, then $w(y, s)$ reads the following equation

\frac{\partial w}{\partial s}=I^{-2}(s) \Delta w-\frac{1}{2 k} y \cdot \nabla w-\frac{1}{p-1} w+|w|^{p-1} w \tag{2.2}
\end{equation*}

where $I(s)$ is defined by

I(s)=e^{\frac{s}{2}\left(1-\frac{1}{k}\right)} . \tag{2.3}

Adopting the setting investigated by [3], we consider $C^{1}$-flow $b$ and introduce

where $f_{b}$ and $e_{b}$ respectively defined as

and the flow $b$ will arise as an unknown functions that will be constructed together with the linearized solution $q$. Since $f_{b} e_{b}=f_{b}^{p}$, by (2.4) $q$ can be written as follows

In the following we consider $(q, b)(s)$ which satisfies the following equation

\mathcal{N}(q) & =\left|1+e_{b} q\right|^{p-1}\left(1+e_{b} q\right)-1-p e_{b} q  \tag{2.10}\\
\mathcal{D}_{s}(\nabla q) & =-\frac{4 p k b}{p-1} I^{-2}(s) e_{b} y^{2 k-1} \nabla q,  \tag{2.11}\\
\mathcal{R}_{s}(q) & =I^{-2}(s) y^{2 k-2}\left(\alpha_{1}+\alpha_{2} y^{2 k} e_{b}+\left(\alpha_{3}+\alpha_{4} y^{2 k} e_{b}\right) q\right),  \tag{2.12}\\
\mathcal{M}(q) & =\frac{p}{p-1} y^{2 k}\left(1+e_{b} q\right) \tag{2.13}

and the constants $\alpha_{i}$ are given by

## 3. Decomposition of the solution

### 3.1. Fundamental solution involving to $\mathcal{L}_{s}$

Let us define Hilbert space $L_{\rho_{s}}^{2}(\mathbb{R})$ by

and $I(s)$ is defined by (2.3).
In addition, we denote

H_{m}(y, s)=I^{-m}(s) h_{m}(I(s) y)=\sum_{\ell=0}^{\left[\frac{m}{2}\right]} \frac{m!}{\ell!(m-2 \ell)!}\left(-I^{-2}(s)\right)^{\ell} y^{m-2 \ell} \tag{3.3}
\end{equation*}

where $h_{m}(z)$ be Hermite polynomial (physic version)

h_{m}(z)=\sum_{\ell=0}^{\left[\frac{m}{2}\right]} \frac{m!}{\ell!(m-2 \ell)!}(-1)^{\ell} z^{m-2 \ell} \tag{3.4}

Jordan block's decomposition of $\mathcal{L}_{s}$
By a simple computation (relying on fundamental identities of Hermite polynomials), we have

\left(1-\frac{m}{2 k}\right) H_{m}(y, s)+m(m-1)\left(1-\frac{1}{k}\right) I^{-2}(s) H_{m-2} & \text { if } m \geq 2  \tag{3.6}\\
\left(1-\frac{m}{2 k}\right) H_{m}(y, s) & \text { if } m=\{0,1\}
\end{array} .\right.
$$

We define $\mathcal{K}_{s, \sigma}$ as the fundamental solution to

By using the Mehler's formula, we can explicitly write its kernel as follows

### 3.2. Decomposition of $q$.

For the sake of controlling the unknown function $q \in L_{\rho_{s}}^{2}$, we will expand it with respect to the polynomials $H_{m}(y, s)$. We start by writing

as the projection of $q$ on $H_{m}$. In addition, $q_{-}(y, s)$ can be seen as the projection of $q$ onto $\left\{H_{m}, m \geq\right.$ $[M]+1\}$ and we also denote as follow

### 3.3. Equivalent norms

Let us consider $L_{M}^{\infty}$ defined by

It is straightforward to check that

C_{1}(s)\|q\|_{L_{M}^{\infty}} \leq\|q\|_{s} \leq C_{2}(s)\|q\|_{L_{M}^{\infty}} \text { where } C_{i, i=1,2}(s)>0 .

Finally, we derive that $L_{M}^{\infty}(\mathbb{R})$ is also complete with the norm $\|.\|_{s}$.

## 4. The existence assuming some technical results

As mentioned before, we only give the proof in the one dimensional case. This section is devoted to the proof of Theorem 1.1. We proceed in five steps, each of them making a separate subsection.

- In the first subsection, we define a shrinking set $V_{\delta, b_{0}}(s)$ and translate our goal of making $q(s)$ go to 0 in $L_{M}^{\infty}(\mathbb{R})$ in terms of belonging to $V_{\delta, b_{0}}(s)$.
- In the second subsection We exhibit a $k$ parameter initial data family for equation (2.8) whose coordinates are very small (with respect to the requirements of $V_{\delta, b_{0}}(s)$ ) except for the $k+1$ first parameter $q_{0}, . ., q_{2 k-1}$.
- In the third subsection, we solve the local in time Cauchy problem for equation (2.8) coupled with some orthogonality condition.
- In the fourth subsection, using the spectral properties of equation (2.8), we reduce our goal from the control of $q(s)$ (an infinite dimensional variable) in $V_{\delta, b_{0}}(s)$ to the control of its $2 k$ first components $\left(q_{0}, . ., q_{2 k-1}\right)$ (a (k)-dimensional variable) in $\left[-I(s)^{-\delta}, I(s)^{-\delta}\right]^{2 k}$.
- In the last subsection, we solve the finite dimensional problem using the shooting lemma and conclude the proof of Theorem 1.1.


### 4.1. Definition of the shrinking set $V_{\delta, b_{0}}(s)$

In this part, we introduce the shrinking set that controls the asymptotic behaviors of our solution
Definition 4.1. Let us consider an integer $k>1$, the reals $\delta>0, b_{0}>0$ and $M$ given by (3.12), we define $V_{\delta, b_{0}}(s)$ be the set of all $(q, b) \in L_{M}^{\infty} \times \mathbb{R}$ satisfying

\left|q_{m}\right| \leq I^{-\delta}(s), \quad \forall 0 \leq m \leq[M], \quad m \neq 2 k,  \tag{4.1}\\
\left|q_{2 k}\right| \leq I^{-2 \delta}(s),  \tag{4.2}\\
\left|q_{-}\right|_{s} \leq I^{-\delta}(s), \tag{4.3}
\end{gather*}

and

\frac{b_{0}}{2} \leq b \leq 2 b_{0} \tag{4.4}
\end{equation*}

where $q_{m}$ and $q_{-}$defined in (3.11), $I(s)$ defined as in (2.3) and $|\cdot|_{s}$ norm defined in (3.18).

### 4.2. Preparation of Initial data

In this part, we aim to give a suitable family of initial data for our problem. Let us consider $\left(d_{0}, d_{1}, \ldots, d_{2 k-1}\right) \in \mathbb{R}^{2 k}, \delta>0$ and $b_{0}>0$, we then define

\psi\left(d_{0}, \ldots, d_{2 k-1}, y, s_{0}\right)=\sum_{i=0}^{2 k-1} d_{i} I^{-\delta}\left(s_{0}\right) y^{i} \tag{4.5}

then, we have the following result
Lemma 4.2 (Decomposition of initial data in different components). Let us consider $\left(d_{i}\right)_{0 \leq i \leq 2 k-1} \in$ $\mathbb{R}^{2 k}$ satisfying $\max _{0 \leq i \leq 2 k-1}\left|d_{i}\right| \leq 1$ and $b_{0}>0$ given arbitrarily. Then, there exists $\delta_{1}\left(b_{0}\right)$ such that for all $\delta \leq \delta_{1}$, there exists $s_{1}\left(\delta_{1}, b_{0}\right) \geq 1$ such that for all $s_{0} \geq s_{1}$, the following properties are valid with $\psi\left(d_{0}, \ldots, d_{2 k-1}\right)$ defined in (4.5):
(i) There exits a quadrilateral $\mathbb{D}_{s_{0}} \subset[-2,2]^{2 k}$ such that the mapping

is linear one to one from $\mathbb{D}_{s_{0}}$ to $\hat{\mathcal{V}}\left(s_{0}\right)$, with

\hat{\mathcal{V}}(s)=\left[-I(s)^{-\delta}, I(s)^{-\delta}\right]^{2 k} \tag{4.7}
\end{equation*}

where $\left(\psi_{0}, \ldots, \psi_{2 k-1}\right)$ are the coefficients of initial data $\psi\left(d_{0}, \ldots, d_{2 k-1}\right)$ given by the decomposition (3.11). In addition to that, we have

\left.\Gamma\right|_{\partial \mathbb{D}_{s_{0}}} \subset \partial \hat{\mathcal{V}}\left(s_{0}\right) \text { and } \operatorname{deg}\left(\left.\Gamma\right|_{\partial \mathbb{D}_{s_{0}}}\right) \neq 0 \tag{4.8}
\end{equation*}
$$

(ii) For all $\left(d_{0}, \ldots, d_{2 k-1}\right) \in \mathbb{D}_{s_{0}}$, the following estimates are valid

\begin{equation*}
\left|\psi_{0}\right| \leq I^{-\delta}\left(s_{0}\right), \ldots .,\left|\psi_{2 k-1}\right| \leq I^{-\delta}\left(s_{0}\right), \quad \psi_{2 k}=\psi_{M}=0 \text { and } \psi_{-} \equiv 0 \tag{4.9}
\end{equation*}

Proof. The proof of the Lemma is quite the same as [19, Proposition 4.5].

- The proof of item (i): From (4.5), definition's $H_{n}$ in (3.3) and (3.13), we get

Remark 4.3. Note that $s_{0}=-\ln (T)$ is the master constant. In almost every argument in this paper it is almost to be sufficiently depending on the choice of all other constants ( $\delta_{0}$ and $b_{0}$ ). In addition, we denote $C$ as the universal constant that is independent to $b_{0}$ and $s_{0}$.

### 4.3. Local in time solution for the problem (2.8) \& (4.11)

As we setup in the beginning, besides main solution $q$, modulation flow $b$ plays an important role in our analysis, since it helps us to disable the perturbation of the neutral mode corresponding to eigenvalue $\lambda_{2 k}=0$ of linear operator $\mathcal{L}_{s}$. In particular, the modulation flow is one of the main contributions of our paper. The uniqueness of the flow $b$ is defined via the following orthogonal condition

As a matter of fact, the cancellation ensures that $q_{2 k}=0$, the projection of the solution on $H_{2 k}$, corresponding to eigenvalue $\lambda_{2 k}=0$, since the neutral issues to the control of our solution. Consequently, our problem given by (2.8) is coupled with the condition (4.11). In the following, we aim to establish the local existence and uniqueness.

Proposition 4.4 (Local existence of the coupled problem (2.8) \& (4.11)). Let $\left(d_{i}\right)_{0 \leq i \leq 2 k-1} \in \mathbb{R}^{2 k}$ satisfying $\max _{0 \leq i \leq 2 k-1}\left|d_{i}\right| \leq 2$ and $\delta>0, b_{0}>0$, there exists $s_{2}\left(\delta, b_{0}\right) \geq 1$, such that for all $s_{0} \geq s_{2}$, the following property holds: If we choose initial data $\psi$ as in (4.5), then, there exists $s^{*}>s_{0}$ such that the coupled problem (2.8) \& (4.11) uniquely has solution on $\left[s_{0}, s^{*}\right]$. Assume furthermore that the solution $(q, b)(s) \in \mathcal{V}_{\delta, b_{0}}(s)$ for all $s \in\left[s_{0}, s^{*}\right]$, then, the solution can be extended after the time $s^{*}$ i.e. the existence and uniqueness of $(q, b)$ are valid on $\left[s_{0}, s^{*}+\varepsilon\right]$, for some $\varepsilon>0$ small.

Proof. Let us consider initial $w_{0}$ defined as in (2.4) with $q\left(s_{0}\right)=\psi\left(d_{0}, d_{1}, \ldots, d_{2 k-1}\right)$ given as in (4.5), since equation (1.1) is locally well-posedness in $L^{\infty}$, then, the solution $w$ to equation (2.2) exists on $\left[s_{0}, \tilde{s}\right]$ for some $\tilde{s}>s_{0}$. Next, we need to prove that $w$ is uniquely decomposed as in (2.4) and $(q, b)(s)$ solves (2.8) and (4.11). The result follows the Implicit function theorem. Let us define the functional $\mathscr{F}$ by

According to (2.4), we express $w\left(s_{0}\right)$ as follows

+ & \frac{1}{p-1}\left\langle y^{2 k}, H_{2 k}\right\rangle_{L_{\rho_{s_{0}}}^{2}}:=A+B
\end{align*}
$$

Using (3.3) and (3.5), we immediately have

& =I^{-\delta}\left(s_{0}\right) \sum_{i=0}^{2 k-1} d_{i}\left(\int_{|y| \leq 1} e_{b_{0}}\left(y, s_{0}\right) y^{i+2 k} H_{2 k} \rho_{s_{0}}(y) d y+\int_{|y| \geq 1} e_{b_{0}}\left(y, s_{0}\right) y^{i+2 k} H_{2 k} \rho_{s_{0}}(y) d y\right) \\
& =A_{1}+A_{2}
\end{aligned}
$$

Since $e_{b_{0}} y^{2 k}$ is bounded, we apply Lemma A. 2 to get

By equality (4.13) and (4.14) and using the Implicit function Theorem, we obtain the existence of a unique $s^{*}>0$ and $b \in C^{1}\left(s_{0}, s^{*}\right)$ such that $q$ defined as in (2.7), verifies (2.8), and the orthogonal condition (4.11) hold. Moreover, if we assume furthermore that $(q, b)$ is shrunk in the set $V_{A, \delta, b_{0}}(s)$ for all $s \in\left[s_{0}, s^{*}\right]$, then, we can repeat the computation for (??) in using the bounds given in Definition (4.1) and we obtain

### 4.4. Reduction to a finite dimensional problem

As we defined shrinking set $V_{\delta, b_{0}}$ in Definition 4.1, it is sufficient to prove there exists a unique global solution $(q, b)$ on $\left[s_{0},+\infty\right)$ for some $s_{0}$ sufficient large that

In particular, we show in this part that the control of infinite problem is reduced to a finite dimensional one. To get this key result, we first show the following priori estimates .

Let $b_{0}>0$ and $k \in \mathbb{N}, k \geq 2, b_{0}>0$, then there exists $\delta_{3}\left(k, b_{0}\right)>0$ such that for all $\delta \in\left(0, \delta_{3}\right)$, there exists $s_{3}\left(\delta, b_{0}\right)$ such that for all $s_{0} \geq s_{3}$, the following property holds: Assume $(q, b)$ is a solution to problem (2.8) \& (4.11) that $(q, b)(s) \in \mathcal{V}_{\delta, b_{0}}(s)$ for all $s \in[\tau, \bar{s}]$ for some $\bar{s} \geq s_{0}$, and $q_{2 k}(s)=0$ for all $s \in[\tau, \bar{s}]$, then for all $s \in\left[\tau, s_{1}\right], s_{0} \leq \tau \leq \bar{s}$, the following properties hold:
(i) (ODEs on the finite modes). For all $j \in\{0, \ldots,[M]\}$, we have

(ii) (Smallness of the modulation b(s)). It satisfies that

Proof of Proposition 4.5. This result plays an important role in our proof. In addition to that, the proof based on a long computation which is technical. To help the reader in following the paper, we will give the complete proof in Section 4.5.

Consequently, we have the following result
Proposition 4.6 (Reduction to a finite dimensional problem). Let $b_{0}>0$ and $k \in \mathbb{N}, k \geq 2$, then there exists $\delta_{4}\left(b_{0}\right)$ such that for all $\delta \in\left(0, \delta_{4}\right)$, there exists $s_{4}\left(b_{0}, \delta\right)$ such that for all $s_{0} \geq$ $s_{4}$, the following property holds: Assume that $(q, b)$ is a solution to (2.8) \& (4.11) corresponding to initial data $(q, b)\left(s_{0}\right)=\left(\psi\left(d_{0}, \ldots, d_{2 k-1}\right), s_{0}\right)$ where $\left.\psi\left(d_{0}, \ldots, d_{2 k-1}\right), s_{0}\right)$ defined as in (4.5) with $\max _{0 \leq i \leq 2 k-1}\left|d_{i}\right| \leq 2$; and $(q, b)(s) \in V_{\delta, b_{0}}(s)$ for all $s \in\left[s_{0}, \bar{s}\right]$ for some $\bar{s}>s_{0}$ that $(q, b)(\bar{s}) \in$ $\partial V_{\delta, b_{0}}(\bar{s})$, then the following properties are valid:
(i) (Reduction to finite modes): Consider $q_{0}, \ldots, q_{2 k-1}$ be projections defined as in (3.13) then, we have

$$

where $I(s)$ is given by (2.3).
(ii) (Transverse crossing) There exists $m \in\{0, . ., 2 k-1\}$ and $\omega \in\{-1,1\}$ such that

Remark 4.7. In (ii) of Proposition 4.6, we show that the solution $q(s)$ crosses the boundary $\partial V_{\delta, b_{0}}(s)$ at $s_{1}$ with positive speed, in other words, that all points on $\partial V_{\delta, b_{0}}\left(s_{1}\right)$ are strict exit points in the sense of [6, Chapter 2].

Proof. Let us start the proof Proposition 4.6 assuming Proposition 4.5. Let us consider $\delta \leq \delta_{3}$ and $s_{0} \geq s_{3}$ that Proposition 4.5 holds.

- Proof of item (i) To get the conclusion of this item, we aim to show that for all $s \in\left[s_{0}, \bar{s}\right]$

Hence, with $j>2 k, \delta \leq \delta_{4,1}$ and initial data $q_{j}\left(s_{0}\right)=0$ that $q_{j}\left(s_{0}\right) \in\left(-\frac{1}{2} I^{-\delta}\left(s_{0}\right), \frac{1}{2} I^{-\delta}\left(s_{0}\right)\right)$, it follows that

Thus, (4.19) follows. Finally, using the definition of $V_{\delta, b_{0}}(s)$, the fact $(q, b)(\bar{s}) \in \partial V_{\delta, b_{0}}(\bar{s})$, estimates (4.18), (4.19), and item (ii) of Proposition 4.6, we get the conclusion of item (ii).

- Proof of item (ii): From item (ii) of Proposition 4.6, there exist $m=0, . .2 k-1$ and $\omega= \pm 1$ such that $q_{m}\left(s_{1}\right)=\omega I\left(s_{1}\right)^{-\delta}$. By (ii) of Proposition 4.5, we see that for $\delta>0$

which concludes the proof of Proposition 4.6. It remains to prove Proposition 4.5. This will be done in Section 5.

### 4.5. Topological "shooting method" for the finite dimension problem and proof of Theorem 1.1

In this part we aim to give the complete proof to Theorem 1.1 by using a topological shooting method:

The proof of Theorem 1.1. Let us consider $\delta>0, T>0,\left(T=e^{-s_{0}}\right),\left(d_{0}, . ., d_{2 k-1}\right) \in \mathbb{D}_{s_{0}}$ such that problem $(2.8) \&(4.11)$ with initial data $\psi\left(d_{0}, \ldots, d_{2 k-1}, s_{0}\right)$ defined as in (4.5) has a solution $(q(s), b(s))_{d_{0}, . ., d_{2 k-1}}$ defined for all $s \in\left[s_{0}, \infty\right)$ such that

Let $b_{0}, \delta$ and $s_{0}$ such that Lemma 4.5, Propositions 4.6 and Proposition 4.5 hold, and we denote $T=e^{-s_{0}}$ (positive since $s_{0}$ is large enough). We proceed by contradiction, from (ii) of Lemma 4.5, we assume that for all $\left(d_{0}, \ldots, d_{2 k-1}\right) \in \mathbb{D}_{s_{0}}$ there exists $s_{*}=s_{*}\left(d_{0}, . ., d_{2 k-1}\right)<+\infty$ such that

\end{aligned}
$$

By using item (i) of Proposition 4.6, we get $\left(q_{0}, . ., q_{2 k-1}\right)\left(s_{*}\right) \in \partial \hat{\mathcal{V}}\left(s_{*}\right)$ and we introduce $\Phi$ by

& \mathbb{D}_{s_{0}} \rightarrow \partial[-1,1]^{2 k} \\
& \\
& \left(d_{0}, . . d_{2 k-1}\right) \rightarrow I^{\delta}(s)\left(q_{0}, . ., q_{2 k-1}\right)\left(s_{*}\right),
\end{aligned}
$$

which is well defined and satisfies the following properties:
(i) $\Phi$ is continuous from $\mathbb{D}_{s_{0}}$ to $\partial[-1,1]^{2 k}$ thanks to the continuity in time of $q$ on the one hand, and the continuity of $s_{*}$ in $\left(d_{0}, \ldots, d_{2 k-1}\right)$ on the other hand, which is a direct consequence of the trasversality in item (ii) of Proposition 4.6.
(ii) It holds that $\left.\Phi\right|_{\partial \mathbb{D}_{s_{0}}}$ has nonzero degree. Indeed, for all $\left(d_{0}, \ldots, d_{2 k-1}\right) \in \partial \mathbb{D}_{s_{0}}$, we derive from item (i) of Lemma 4.2 that $s_{*}\left(d_{0}, \ldots, d_{2 k-1}\right)=s_{0}$ and

\operatorname{deg}\left(\left.\Phi\right|_{\partial \mathbb{D}_{s_{0}}}\right) \neq 0 .

From Wazewski's principle in degree theory such a $\Phi$ cannot exist. Thus, we can prove that there exists $\left(d_{0}, \ldots, d_{2 k-1}\right) \in \mathbb{D}_{s_{0}}$ such that the corresponding solution $(q, b)(s) \in V_{\delta, b_{0}}(s), \forall s \geq s_{0}$. In particular, we derive from (2.4), $M=\frac{2 k p}{p-1}$, and the following estimate

\left\|w(y, s)-f_{b}\right\|_{L^{\infty}}=\left\|f_{b} e_{b} q\right\|_{L^{\infty}} \leq C I^{-\delta}(s)
$$

So, we conclude item (i) of Theorem 1.1.
The proof of item (ii): From (ii) of Proposition 4.5, it immediately follows that there exists $b^{*} \in \mathbb{R}_{+}^{*}$ such that

b(s) \rightarrow b^{*} \text { as } s \rightarrow+\infty
$$

which is equivalent to

In particular, by integrating the first inequality given by between $s$ and $\infty$ and using the fact that $b(s) \rightarrow b^{*}$ (see (5.36)), we obtain

Note that $s=-\ln (T-t)$ then, (4.20) follows and the conclusion of item (ii) of Theorem 1.1.

## 5. Proof to Proposition 4.5

In this section, we prove Proposition 4.5. We just have to project equation (2.8) to get equations satisfied by the different coordinates of the decomposition (3.11). More precisely, the proof will be carried out in 2 subsections,

- In the first subsection, we write equations satisfied by $q j, 0 \leq j \leq M$, then, we prove (i), (ii) of Proposition 4.5.
- In the second subsection, we first derive from equation (2.8) an equation satisfied by $q_{-}$and prove the last identity in (iii) of Proposition 4.5.


### 5.1. The proof to items (i) and (ii) of Proposition 4.5

- In Part 1, we project equation (2.8) to get equations satisfied by $q_{j}$ for $0 \leq j \leq[M]$.
- In Part 2: We will use the precise estimates from part I to conclude items (i) and (ii) of Proposition 4.5.

Part 1: The projection of equation (2.8) on the eigenfunctions of the operator $\mathcal{L}_{s}$.
Let $(q, b)$ be solution to problem (2.8) \& (4.11) trapped in $V_{\delta, b_{0}}(s)$ for all $s \in\left[s_{0}, \bar{s}\right]$ for some $\bar{s}>s_{0}$. Then, we have the following:
a) First term $\partial_{s} q$ : In this part, we aim to estimate the error between $\partial_{s} q_{n}(s)$ and $P_{n}\left(\partial_{s} q\right)$ by the following Lemma

Lemma 5.1. For all $n \in\{0,1, \ldots,[M]\}$, it holds that

\end{aligned}

& -\left\langle q, H_{n}(s) \frac{\partial_{s} \rho_{s}}{\rho_{s}}\right\rangle_{L_{\rho_{s}}^{2}}\left\langle H_{n}, H_{n}\right\rangle_{L_{\rho_{s}}^{2}}^{-1}+\partial_{s}\left\langle H_{n}, H_{n}\right\rangle_{\rho_{s}}\left\langle H_{n}, H_{n}\right\rangle_{L_{\rho_{s}}^{2}}^{-1} q_{n} \\

We now aim to estimate $\tilde{L}$ provided that $(q(s), b(s)) \in V_{A, b_{0}, \delta}(s)$ and we also recall that

+ & \left(1-\frac{1}{k}\right)(n+2)(n+1) I^{-2}(s) q_{n+2},

for all $n \in\{0, \ldots,[M]\}$ and $\forall s \in\left[s_{0}, s^{*}\right]$ (with convention that $q_{j}=0$ if $j<0$ ) and for some $\tilde{c}_{n} \in \mathbb{R}$. $+\left\langle q, \partial_{s} H_{n}(s)\right\rangle_{L_{\rho_{s}}^{2}}\left\langle H_{n}, H_{n}\right\rangle_{L_{\rho_{s}}^{2}}^{-1}:$

& +(2 n+1) q_{n}\left\|H_{n}\right\|^{2}+2 n(n-1) q_{n-2} I^{-2}\left\|H_{n-2}\right\|^{2} \\
& =\left(n q_{n}+2(n+2)(n+1) I^{-2} q_{n+2}\right)\left\|H_{n}\right\|^{2} .

In this part, we aim to estimate to the projection of $\mathcal{N}(q)$ on $H_{n}$, for some $n \in\{0,1, \ldots,[M]\}$. More precisely, we have the following Lemma:

Lemma 5.3. Let $b_{0}>0$, then, there exists $\delta_{5}\left(b_{0}\right)>0$ such that for all $\delta \in\left(0, \delta_{5}\right)$ there exists $s_{5}\left(b_{0}, \delta\right) \geq 1$ such that for all $s_{0} \geq s_{5}$, the following property is valid: Assume $(q, b)(s) \in V_{\delta, b_{0}}(s)$ for all $s \in\left[s_{0}, \bar{s}\right]$ for some $\bar{s}>s_{0}$, then, we have

\left|P_{n}(\mathcal{N})\right| \leq C I^{-2 \delta}(s), \forall \text { and } n \in\{0,1, \ldots,[M]\}, \tag{5.5}
\end{equation*}

for all $s \in\left[s_{0}, \bar{s}\right]$ and $0 \leq n \leq[M]$.
Proof. We argue as in [3]. First, let us recall the nonlinear term $\mathcal{N}$ and $P_{n}(\mathcal{N})$ defined as in (2.10) and (3.13), respectively. The main goal is to use the estimates defined in $V_{\delta, b_{0}}(s)$ to get an improved bound on $P_{n}(\mathcal{N})$. Firstly, we recall the following identity

- In Part 1, we project equation (2.8) using projector $P_{-}$defined in (3.14) .
- In Part 2, we prove the estimate on $q_{-}$given by (iii) of Proposition 4.5.

Part 1: The projection of equation (2.8) using the projector $P_{-}$. Let $(q, b)$ be solution to problem (2.8) \& (4.11) trapped in $V_{\delta, b_{0}}(s)$ for all $s \in\left[s_{0}, \bar{s}\right]$ for some $\bar{s}>s_{0}$. Then, we have the following results:

## First term $\partial_{s} q$.

Lemma 5.7. For all $s \in\left[s_{0}, \bar{s}\right]$, it holds that

& =-\sum_{n=0}^{[M]} P_{n}\left(\partial_{s} q\right) H_{n}+\sum_{n=0}^{[M]} \partial_{s} q_{n} H_{n}+\sum_{n=2}^{[M]} q_{n} \partial_{s} H_{n},
\end{aligned}
$$

we recall by (5.3) that for all $n \geq 2$

then by Lemma 5.1, we obtain the desired result

& =\sum_{n=0}^{M}\left(1-\frac{n}{2 k}\right) q_{n} H_{n}+I^{-2}\left(1-\frac{1}{k}\right) \sum_{n=0}^{M-2}(n+1)(n+2) q_{n+2} H_{n}
\end{aligned}
$$

We deduce from Lemma 5.2 that

Let $b_{0}>0$, then there exists $\delta_{10}\left(b_{0}\right)$ such that for all $\delta \in\left(0, \delta_{10}\right)$, then there exists $s_{10}\left(\delta, b_{0}\right) \geq 1$ such that for all $s_{0} \geq s_{10}$ the following folds: Assume $(q, b)(s) \in V_{\delta, b_{0}}(s), \forall s \in\left[s_{0}, \bar{s}\right]$ for some $\bar{s}$ arbitrary, then it holds that

\end{align*}

where $\chi Q$ is bounded. Then, we divide the sum $A_{1}$ as follows

& =\chi \sum_{\mathbf{n}, p, p+\sum_{n} n_{i} \leq M} c_{\mathbf{n}, p} b(s)^{\frac{p}{2 k}} y^{p} \Pi_{i=1}^{[M]} q_{i}^{n_{i}} H_{i}^{n_{i}}+\chi \sum_{\mathbf{n}, p, p+\sum n_{i}>M} c_{\mathbf{n}, p} b(s)^{\frac{p}{2 k}} y^{p} \Pi_{i=1}^{[M]} q_{i}^{n_{i}} H_{i}^{n_{i}} \\
& =A_{1,1}+A_{1,2},
\end{aligned}

In the first sum, $A_{1,1}$, we replace $\chi=1-\chi^{c}$ by $-\chi^{c}$, since 1 will not contribute to $A_{-}$. Using the fact that $|y| \geq 1$ and by (4.4), we get

= & d_{1}+d_{2} .

For the estimation of the firs term $d_{1}$, we argue in a similar fashion as in the projection of $P_{n}(\mathcal{M})$, see Lemma 5.4. For the second term, we argue as in Bricomont Kupiainen [3]. Indeed, we need to bound $\partial_{z} K_{s, \tau}$. From equations (3.8) we obtain

\left|q_{-}(s)\right|_{s} \leq e^{-\frac{s-\tau}{p-1}}\left|q_{-}(\tau)\right|_{\tau}+C\left(I^{-\frac{3}{2} \delta}(s)+e^{-\frac{s-\tau}{p-1}} I^{-\frac{3}{2} \delta}(\tau)\right)
$$

which concludes the proof of the last identity of Proposition 4.5.

## A. Computation on Hermite polynomials

Lemma A.1. Let us consider $H_{m}$ defined as in (3.3), for some $m \geq 0$, let us consider

$$
f(y)=\sum_{j=0}^{\ell} f_{j} y^{j}, f_{j} \in \mathbb{R}
$$

Then, the following holds

$$
\left|\left\langle f, H_{m}\right\rangle_{L_{\rho_{s}}^{2}}\right| \leq\left\{\begin{array}{rll}
C I^{-2 m} & \text { if } & m \leq \ell  \tag{A.1}\\
0 & \text { if } & m>\ell
\end{array}\right.
$$

Proof. We note first that for all integer $j$

$$
\begin{aligned}
\left\langle y^{j}, H_{m}\right\rangle_{L_{\rho_{s}}^{2}} & =I^{-m} \int y^{j} h_{m}(y I) \rho_{s} d y, \\
& =I^{-m-j} \int z^{j} h_{m}(z) \rho d z \text { where } z=I y . \\
& =C I^{-m-j} .
\end{aligned}
$$

then we conclude that

$$
\frac{\left\langle y^{j}, H_{m}\right\rangle_{L_{\rho_{s}}^{2}}}{\left\|H_{m}\right\|_{L_{\rho_{s}}^{2}}}=C I^{m-j}
$$

and

$$
\frac{\left|\left\langle f, H_{m}\right\rangle_{L_{\rho_{s}}^{2}}\right|}{\left\|H_{m}\right\|_{L_{\rho_{s}}^{2}}^{2}} \leq\left\{\begin{array}{rlc}
C & \text { if } & \ell \geq m \\
0 & \text { if } & \ell<m
\end{array}\right.
$$

which end the proof of Lemma.

Lemma A.2. Let us consider $m \in \mathbb{N}, I(s)$ defined as in (2.3) and $f \in L_{K}^{\infty}$ for some $K>0$, where $L_{K}^{\infty}$ is defined by (3.15). Then, we have

$$
\begin{equation*}
\left|\int_{|y| \geq 1} f H_{m} \rho_{s} d y\right| \leq C(m, K)\|f\|_{L_{M}^{\infty}} e^{-\frac{1}{8} I(s)} \text {, with } s \geq s_{0} \text {. } \tag{A.2}
\end{equation*}
$$

consequently, if $f$ has the form

$$
f(y)=\sum_{j=0}^{\ell} f_{j} y^{j}, f_{j} \in \mathbb{R},
$$

then, we have

$$
\left|\int_{|y| \leq 1} f(y) H_{m}(y, s) \rho_{s}(y) d y\right| \leq\left\{\begin{array}{rll}
C I^{-2 m}(s) & \text { if } & \ell \geq m  \tag{A.3}\\
C e^{-\frac{I(s)}{8}} & \text { if } & \ell<m
\end{array}\right.
$$

Proof. Let us decompose as follows

$$
\int_{\mathbb{R}} f H_{m} \rho_{s} d y=\int_{|y| \leq 1} f H_{m} \rho_{s} d y+\int_{|y| \geq 1} f H_{m} \rho_{s} d y .
$$

From (3.2), we get

$$
\left|H_{m}(y)\right| \leq C\left(1+y^{m}\right) .
$$

Then, we get

$$
\left|\int_{y \geq 1} f H_{m} \rho_{s} d y\right| \leq C\|f\|_{L_{K}^{\infty}} \int_{y \geq 1}\left(1+y^{m+K}\right) e^{-\frac{I^{2}(s) y^{2}}{4}} I(s) d y .
$$

By changing variable $z=I(s) y$, we obtain

$$
\begin{aligned}
\int_{y \geq 1}\left(1+y^{m+K}\right) e^{-\frac{I^{2}(s) y^{2}}{4}} I(s) d y & =\int_{z \geq I(s)}\left(1+z^{m+K} I^{-m-K}(s)\right) e^{-\frac{z^{2}}{4}} d z \\
& \leq \int_{z \geq I(s)}\left(1+z^{2 m+M}\right) e^{-\frac{z^{2}}{4}} d z \\
& \leq e^{-\frac{I^{2}(s)}{8}} \int_{0}^{\infty}\left(1+z^{m+K}\right) e^{-\frac{z^{2}}{8}} d z \\
& \leq C e^{-\frac{I(s)}{8}}
\end{aligned}
$$

which concludes the proof of the Lemma.

Lemma A. 3 (Some scaled Hermite polynomial identities). Let us consider $H_{n}, n \in \mathbb{N}$ defined as in (3.3) be scaled Hermite polynomials and $\ell \in \mathbb{N}$, then, we have

$$
\begin{equation*}
y^{\ell} H_{n}(y, s)=\sum_{j=0}^{\left[\frac{\ell+n}{2}\right]} c_{j, \ell, n}(s) H_{n+\ell-2 j}(y, s) . \tag{A.4}
\end{equation*}
$$

In particular, when $\ell=1$ and $\ell=2$, we have

$$
\begin{align*}
y^{2} H_{n}(y, s) & =H_{n+2}(y, s)+(4 n+2) I^{-2}(s) H_{n}(y, s)+4 n(n-1) I^{-4}(s) H_{n-2}(y, s)  \tag{A.5}\\
y H_{n-1}(y, s) & =H_{n}(y, s)+I^{-2}(s) 2(n-1) H_{n-2}(y, s) . \tag{A.6}
\end{align*}
$$

Proof. The result immediately follows the fact that $\left\{H_{n}, n \geq 0\right\}$ is a basic of $L_{\rho}^{2}$ and $y^{\ell} H_{n}(y, s)$ is a polynomial of order $n+\ell$. In addition to that, we also have the property that $\left\langle y^{\ell} H_{n}, H_{k}\right\rangle_{L_{\rho}^{2}}=0$ whenever $k+\ell<n$, then, the terms of $H_{n+\ell-2 j}, j>\left[\frac{\ell+n}{2}\right]$ don't appear in the sum (A.4). Thus, the result of (A.4) completely follows. In addition to that, we also specify the constants $c_{j, \ell, n}$ by

$$
c_{i, \ell, n}=\frac{\left\langle y^{\ell} H_{n} H_{n+\ell-2 j}\right\rangle_{L_{\rho}^{2}}}{\left\|H_{n+\ell-2 j}\right\|_{L_{\rho}^{2}}} .
$$

Finally, for the special cases $\ell=1,2$, we get (A.5) and (A.6), and we concludes the proof of the Lemma.

Lemma A.4. It holds that

$$
\left|K_{\tau \sigma} q_{-}\right|_{\tau} \leq C e^{-\frac{1}{p-1}(\tau-\sigma)}\left|q_{-}\right|_{\sigma} .
$$

Proof. We proceed as in the proof of Lemma 1 in Section 4, page 569 from [4]. We start by recalling the change of variable $z=y I(s)$ and we note

$$
\theta(z)=q_{-}(y)=q_{-}\left(\frac{z}{I}\right) \tilde{\theta}(z)=\left(\mathcal{K}_{\tau \sigma} \theta\right)\left(\frac{y}{I}\right),
$$

then we have

$$
\tilde{\theta}=e^{(\tau-\sigma) \mathcal{L}} \theta,
$$

where $e^{s \mathcal{L}}$ is the semigrpup generated by the operator $\mathcal{L} q=\Delta q-\frac{y}{2} q+q$

$$
e^{s \mathcal{L}}\left(z, z^{\prime}\right)=\frac{1}{\left[4 \pi\left(1-e^{-t}\right)\right]^{\frac{N}{2}}} \exp \left[-\frac{\left(z^{\prime}-z e^{-s / 2}\right)^{2}}{4\left(1-e^{-s}\right)}\right] .
$$

From the definition of the shrinking set $\mathcal{V}_{\delta, s}$ given by Definition 4.1, we have

$$
|\theta(z)| \leq I^{M}\left(1+|z|^{M}\right)\left|q_{-}\right|_{\sigma},
$$

with

$$
\left(\theta, h_{m}\right)=\frac{\int \theta h_{m}(z) \rho(z) d z}{\left\|h_{m}\right\|^{2}} \text { for } m \leq[M] \text { and } \rho(z)=\frac{e^{-z^{2} / 4}}{(4 \pi)^{N / 2}},
$$

where $M=\frac{2 k p}{p-1}$.
Proceeding as in the derivation of equation (66) in Section 3 and Lemma 4, in section 3 from [4] and using Definition 4.1 we get for $\tau-\sigma \geq 1$,

$$
|\tilde{\theta}(z)| \leq C e^{(\tau-\sigma)} e^{-([M]+1) \frac{\tau-\sigma}{2}} I^{-M}\left(1+|z|^{M}\right)\left|q_{-}\right|_{\sigma} \text { for } 0 \leq m \leq[M]+1 .
$$

We recall that $M=\frac{2 k p}{p-1}$ and using the fact that

$$
e^{-\frac{M}{2}(\tau-\sigma)} I^{-M}(\sigma)=e^{-\frac{p}{p-1}(\tau-\sigma)} I^{-M}(\tau),
$$

then we obtain the desired result

$$
\left|\mathcal{K}_{\tau \sigma} q_{-}(y)\right| \leq C e^{-\frac{(\tau-\sigma)}{p-1}}\left(I^{-M}(\tau)+|y|^{M}\right)\left|q_{-}\right|_{\sigma} .
$$

Lemma A.5. There exists a constant $C$ such that if $\phi$ satisfies

$$
\forall x \in \mathbb{R}, \quad|\phi(x, \tau)| \leq\left(I^{-M}(\tau)+|x|^{M}\right)
$$

then for all $y \in \mathbb{R}$ and $s \geq s_{0}$, we have

$$
\left|K_{\tau \sigma}(\phi)(y, \tau)\right| \leq C e^{-\frac{(\tau-\sigma)}{p-1}}\left(I^{-M}(\tau)+|y|^{M}\right) .
$$

Proof. The proof is similar to the proof of Lemma A. 4 and we use the fact that for $z=y I(s)$, if

$$
|\Phi(z, \tau)| \leq\left(1+|z|^{M}\right)
$$

then

$$
\left|e^{s \mathcal{L}} P_{-}(\Phi)(z)\right| \leq C e^{\frac{[M]+1}{2} s}\left(1+|z|^{M}\right) .
$$
