# ON CERTAIN GENUS 0 ENTIRE FUNCTIONS 

RUIMING ZHANG


#### Abstract

In this work we prove that an entire function $f(z)$ has only negative zeros if and only if its order is strictly less 1 , its root sequence is realpart dominating and there exists an nonnegative integer $m$ the real function $\left(-\frac{1}{x}\right)^{m} \frac{d^{k}}{d x^{k}}\left(x^{k+m} \frac{d^{m}}{d x^{m}}\left(\frac{f^{\prime}(x)}{f(x)}\right)\right)$ are completely monotonic on $(0, \infty)$ for all nonnegative integer $k$. As an application we state a necessary and sufficient condition for the Riemann hypothesis and generalized Riemann hypothesis for a primitive Dirichlet character.


## 1. Introduction

In this work we study the zeros of entire function $f(z)$,

$$
\begin{equation*}
f(z)=\sum_{n=0}^{\infty} a_{n} z^{n}, \quad a_{0} \cdot a_{n}>0 \tag{1.1}
\end{equation*}
$$

of order $\rho(f)$ strictly less than 1 where $\rho(f)$ is defined by

$$
\begin{equation*}
\rho(f)=\limsup _{n \rightarrow \infty} \frac{n \log n}{-\log \left|a_{n}\right|} \tag{1.2}
\end{equation*}
$$

Many transcendental $q$-special functions such as Ramanujan's entire function $A_{q}(-z)$ is of this type, 8].

Since $\rho(f)<1$, then $f(z)$ is necessarily of genus 0 . If it has any roots, then there exists a sequence of complex numbers $\left\{\lambda_{n}\right\}_{n=1}^{\infty}$ such that [1, 4]

with

\end{equation*}

Furthermore, for any $1>\alpha>\rho(f)$, 4, Theorem 2.5.18]

\sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|^{\alpha}}<\infty \tag{1.5}
\end{equation*}
$$

In this work we prove the following:

[^0]Theorem 1. Let $f(z)$ be an entire function defined in (1.1), (1.3) such that it has a nonzero root and it's of order strictly less than 1. If there is a positive number $\beta_{0}$ with $\beta_{0} \in(0,1)$ such that the sequence $\left\{\lambda_{n}\right\}_{n \in \mathbb{N}}$ in (1.3) and (1.4) satisfies

\Re\left(\lambda_{n}\right) \geq \beta_{0}\left|\lambda_{n}\right|>0, \quad \forall n \in \mathbb{N} . \tag{1.6}
\end{equation*}
$$

Then $f(z)$ has only negative zeros if and only if there exists an nonnegative integer $m \in \mathbb{N}_{0}$, all the functions

G_{k}^{(m)}(x)=\frac{(-1)^{m}}{x^{m+k}}\left(x \frac{d}{d x} x\right)^{k}\left(x^{m} \frac{d^{m}}{d x^{m}}\left(\frac{f^{\prime}(x)}{f(x)}\right)\right), \quad \forall k \in \mathbb{N}_{0} \tag{1.7}
\end{equation*}
$$

are completely monotonic on $(0, \infty)$. The function $G_{k}^{(m)}(x)$ also has a simpler representation,

G_{k}^{(m)}(x)=\left(-\frac{1}{x}\right)^{m} \frac{d^{k}}{d x^{k}}\left(x^{k+m} \frac{d^{m}}{d x^{m}}\left(\frac{f^{\prime}(x)}{f(x)}\right)\right) \tag{1.8}
\end{equation*}
$$

they also satisfy the recursion,

\begin{align*}
G_{0}^{(m)}(z) & =(-1)^{m} \frac{d^{m}}{d z^{m}}\left(\frac{f^{\prime}(z)}{f(z)}\right)  \tag{1.9}\\
G_{k}^{(m)}(z) & =(k+m) G_{k-1}^{(m)}(z)+z \frac{d}{d z} G_{k-1}^{(m)}(z), \quad \forall k \in \mathbb{N}
\end{align*}
$$

Since the Ramanujan's entire function $A_{q}(z)$ is an entire function of order 0 with only positive zeros for $0<q<1$, [8]. Then for all nonnegative integer $k, m$ and $0<q<1$, the real functions $\frac{(-1)^{m+1}}{x^{m}} \frac{d^{k}}{d x^{k}}\left(x^{k+m} \frac{d^{m}}{d x^{m}}\left(\frac{A_{q}^{\prime}(-x)}{A_{q}(-x)}\right)\right)$ are completely monotonic on $(0, \infty)$. However, there are many other transcendental special functions of the form

g(z)=\sum_{n=0}^{\infty}(-1)^{n} a_{n} z^{2 n}, \quad a_{0} \cdot a_{n}>0 \tag{1.10}
\end{equation*}
$$

for example, the Riemann $\Xi(z)$, and the Bessel functions $\frac{J_{\nu}(z)}{z^{\nu}}, \frac{J_{\nu}^{(2)}(z ; q)}{z^{\nu}}$ with $\nu>-1,0<q<1,[2, ~ 8]$. If the order of $g(z)$ is strictly less than 2 ,

$$
\begin{equation*}
\rho(g)=\limsup _{n \rightarrow \infty} \frac{2 n \log (2 n)}{-\log \left|a_{n}\right|}=2 \rho(f)<2 \tag{1.11}
\end{equation*}
$$

then it is not hard to see that Theorem (1) can be applied to $g(z)$ that has at less one zero. The condition (1.6) is replaced by

$$

\Re\left(z_{n}^{2}\right)>0, \quad\left|\Im\left(z_{n}\right)\right| \leq M, \quad \forall n \in \mathbb{N} \tag{1.12}
\end{equation*}
$$

Here $M>0$ is a positive constant that only depends on $g(z)$, and $\left\{ \pm z_{n}\right\}_{n \in \mathbb{N}}$ are the roots of $g(z)$ with $\Re\left(z_{n}\right)>0, \forall n \in \mathbb{N}$.

Clearly, $f(z)=g(i \sqrt{z})$ transforms $g(z)$ in (1.10) into $f(z)$ in (1.1) of order strictly less than 1 , and the zeros $\left\{ \pm z_{n}\right\}_{n \in \mathbb{N}}$ of $g(z)$ into the zeros $\left\{-\lambda_{n}\right\}_{n \in \mathbb{N}}$ of $f(z)$ with $\lambda_{n}=z_{n}^{2}$. Therefore, $\lambda_{n}>0$ if and only if $z_{n} \in \mathbb{R}$.

Since $g(z)$ is an entire function not identically 0 , then $\left\{ \pm z_{n}\right\}_{n \in \mathbb{N}}$ has no limit points on the finite complex plane. By (1.10) and (1.12) we must have

\lim _{N \rightarrow \infty}\left|z_{n}\right|=+\infty, \quad \lim _{N \rightarrow \infty} \Re\left(z_{n}\right)=+\infty \tag{1.13}
\end{equation*}
$$

Without loss of generality we may let

0<\Re\left(z_{1}\right) \leq \Re\left(z_{2}\right)<\cdots \leq \Re\left(z_{n}\right) \leq \Re\left(z_{n+1}\right) \leq \ldots \tag{1.14}
\end{equation*}
$$

Then for any $\epsilon \in(0,1)$ there exists a $N_{\epsilon} \in \mathbb{N}$ such that

\epsilon\left|z_{n}\right|^{2} \geq 2 M^{2}, \quad \forall n \geq N_{\epsilon} . \tag{1.15}
\end{equation*}

Hence, for all $n \geq N_{\epsilon}$

0<\Re\left(z_{n}^{2}\right)=\left|z_{n}\right|^{2}-2\left(\Im\left(z_{n}\right)\right)^{2} \geq\left|z_{n}\right|^{2}-2 M^{2} \geq(1-\epsilon)\left|z_{n}\right|^{2} \tag{1.16}
\end{equation*}
$$

Let

$$
\begin{equation*}
\beta_{0}=\min \left\{1-\epsilon, \frac{\Re\left(z_{1}^{2}\right)}{\left|z_{1}^{2}\right|}, \ldots, \frac{\Re\left(z_{N_{\epsilon}}^{2}\right)}{\left|z_{N_{\epsilon}}^{2}\right|}\right\} \in(0,1) \tag{1.17}
\end{equation*}
$$

then it is clear that

$$
\begin{equation*}
\Re\left(z_{n}^{2}\right) \geq \beta_{0}\left|z_{n}^{2}\right|, \quad \forall n \in \mathbb{N} \tag{1.18}
\end{equation*}
$$

thus $\lambda_{n}=z_{n}^{2}$ satisfies (1.6).
It is known that for $\nu>-1$ the even entire function $\frac{J_{\nu}(z)}{z^{\nu}}$ is of order 1 with only real zeros, while for $\nu>-1,0<q<1$ the $q$-Bessel function $\frac{J_{\nu}^{(2)}(z ; q)}{z^{\nu}}$ is an even entire functions that of order 0 with only real zeros, 8 . Applying Theorem 1 to the Bessel functions we conclude that for all nonnegative integers $k, m$ and any positive number $q$ satisfying $0<q<1$, the functions $\left(-\frac{1}{x}\right)^{m} \frac{d^{k}}{d x^{k}}\left(x^{k+m} \frac{d^{m}}{d x^{m}}\left(\frac{f^{\prime}(x)}{f(x)}\right)\right)$ are completely monotonic on $(0, \infty)$ where $f(x)=x^{-\nu / 2} I_{\nu}(\sqrt{x})$ or $f(x)=x^{-\nu / 2} I_{\nu}^{(2)}(\sqrt{x} ; q)$.

## 2. Proof of the Theorem

### 2.1. The heat kernel $\Theta(x)$.

Lemma 2. Let $f(z)$ be an entire function defined in (1.1), (1.3) with order $\rho(f)<1$ such that there exists a positive number $\beta_{0} \in(0,1)$ it satisfies (1.6). Then its associated heat kernel

\Theta(t)=\sum_{n=1}^{\infty} e^{-\lambda_{n} t}, \quad t>0 \tag{2.1}
\end{equation*}
$$

is in $C^{\infty}(0, \infty)$, and for any

k \in \mathbb{N}_{0}, 1>\alpha>p(f), 0<\beta<\beta_{0} \inf \left\{\left|\lambda_{n}\right| \mid n \in \mathbb{N}\right\} \tag{2.2}
\end{equation*}
$$

the function $\Theta(t)$ satisfies

\Theta^{(k)}(t)=\mathcal{O}\left(t^{-\alpha-k}\right), \quad t \rightarrow 0^{+} \tag{2.3}
\end{equation*}
$$

and

\begin{equation*}
\Theta^{(k)}(t)=\mathcal{O}\left(e^{-\beta t}\right), \quad t \rightarrow+\infty . \tag{2.4}
\end{equation*}
$$

Furthermore, for all $k \in \mathbb{N}_{0}$ and $x \geq 0$,

\int_{0}^{\infty} t^{k} e^{-x t}|\Theta(t)| d t \leq \frac{k!}{\beta_{0}^{k+1}} \sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|^{k+1}}<\infty \tag{2.5}
\end{equation*}
$$

and

(-1)^{k}\left(\frac{f^{\prime}(x)}{f(x)}\right)^{(k)}=\sum_{n=1}^{\infty} \frac{k!}{\left(x+\lambda_{n}\right)^{k+1}}=\int_{0}^{\infty} e^{-x t} t^{k} \Theta(t) d t . \tag{2.6}
\end{equation*}
$$

Proof. Since for any $y>0$

\sup _{x>0} x^{y} e^{-x}=\left(\frac{y}{e}\right)^{y}, \tag{2.7}
\end{equation*}
$$

then for any $t>0, k \geq 0$ by (1.5) and (1.6),

& \sum_{n=1}^{\infty}\left|\lambda_{n}^{k} e^{-\lambda_{n} t}\right|=\sum_{n=1}^{\infty}\left|\lambda_{n}\right|^{k} e^{-\Re\left(\lambda_{n}\right) t} \leq \sum_{n=1}^{\infty} \frac{\left(\beta_{0} t\left|\lambda_{n}\right|\right)^{k+\alpha} e^{-\beta_{0}\left|\lambda_{n}\right| t}}{\left(\beta_{0} t\right)^{\alpha+k}\left|\lambda_{n}\right|^{\alpha}} \\
& \leq \frac{\sup _{x>0} x^{k+\alpha} e^{-x}}{\left(\beta_{0} t\right)^{\alpha+k}} \sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|^{\alpha}}=\left(\frac{k+\alpha}{e \beta_{0} t}\right)^{k+\alpha} \sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|^{\alpha}}<\infty, \tag{2.8}
\end{align*}
$$

which proves that $\Theta(t) \in C^{\infty}(0, \infty)$ and (2.3).
Let $0<\beta<\beta_{0} \inf \left\{\left|\lambda_{n}\right| \mid n \in \mathbb{N}\right\}$, then there exists a positive number $\epsilon$ with $0<\epsilon<1$ such that

\beta=\epsilon \beta_{0} \inf \left\{\left|\lambda_{n}\right| \mid n \in \mathbb{N}\right\} \leq \epsilon \beta_{0}\left|\lambda_{n}\right|, \quad \forall n \in \mathbb{N} . \tag{2.9}
\end{equation*}
$$

Thus for $t \geq 1$ by (2.8),

& \left|e^{\beta t} \Theta^{(k)}(t)\right| \leq \sum_{n=1}^{\infty}\left|\lambda_{n}\right|^{k} e^{-\left(\beta_{0}\left|\lambda_{n}\right|-\beta\right) t} \leq \sum_{n=1}^{\infty}\left|\lambda_{n}\right|^{k} e^{-(1-\epsilon) \beta_{0}\left|\lambda_{n}\right| t}  \tag{2.10}\\
& \leq \sum_{n=1}^{\infty}\left|\lambda_{n}\right|^{k} e^{-(1-\epsilon) \beta_{0}\left|\lambda_{n}\right|}<\infty,
\end{align*}
$$

which establishes (2.4).
For all $x, k \geq 0$ since

& \int_{0}^{\infty} t^{k} e^{-x t}|\Theta(t)| d t \leq \int_{0}^{\infty} t^{k}\left(\sum_{n=1}^{\infty} e^{-\left(x+\Re\left(\lambda_{n}\right)\right) t}\right) d t \leq \sum_{n=1}^{\infty} \int_{0}^{\infty} t^{k} e^{-\left(x+\beta_{0}\left|\lambda_{n}\right|\right) t} d t  \tag{2.11}\\
& \leq \sum_{n=1}^{\infty} \frac{k!}{\left(x+\beta_{0}\left|\lambda_{n}\right|\right)^{k+1}} \leq \frac{k!}{\beta_{0}^{k+1}} \sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|^{k+1}}<\infty,
\end{align*}
$$

then,

& \left(\frac{f^{\prime}(x)}{f(x)}\right)^{(k)}=\sum_{n=1}^{\infty} \frac{(-1)^{k} k!}{\left(x+\lambda_{n}\right)^{k+1}} \\
& =(-1)^{k} \sum_{n=1}^{\infty} \int_{0}^{\infty} t^{k} e^{-\left(x+\lambda_{n}\right) t} d t=(-1)^{k} \int_{0}^{\infty} e^{-x t} t^{k} \Theta(t) d t \tag{2.12}
\end{align*}
$$

Lemma 3. Let $f(z), \Theta(x)$ and $\left\{\lambda_{n}\right\}_{n=1}^{\infty}$ be defined as in Theorem $\mathbb{\square}$ and Lemma 圆, Then the sequence $\left\{\lambda_{n}\right\}_{n=1}^{\infty}$ is positive if and only if the function $\Theta(x)$ is completely monotonic on $(0, \infty)$.

Proof. Assume that $\left\{\lambda_{n}\right\}_{n=1}^{\infty}$ is positive, then

(-1)^{k} \Theta^{(k)}(t)=\sum_{n=1}^{\infty} \lambda_{n}^{k} e^{-\lambda_{n} t} \geq 0, \quad \forall t>0, k \in \mathbb{N}_{0} \tag{2.13}
\end{equation*}
$$

hence $\Theta(t)$ is completely monotonic by definition.
On the other hand if $\Theta(t)$ is completely monotonic on $(0, \infty)$, then by the Bernstein's theorem there exists a nonnegative measure $d \mu(t)$ on $[0, \infty)$ such that [9, 10]

\Theta(t)=\sum_{n=1}^{\infty} e^{-\lambda_{n} t}=\int_{0}^{\infty} e^{-y t} d \mu(y), \quad \forall t>0 \tag{2.14}
\end{equation*}
$$

For any $x \geq 0$ we multiply $e^{-x t}$ both sides of (2.14) and integrate it with respect to $t$ from 0 to $\infty$ to get

& \int_{0}^{\infty} e^{-x t} \Theta(t) d t=\sum_{n=1}^{\infty} \frac{1}{x+\lambda_{n}}=\frac{f^{\prime}(x)}{f(x)}  \tag{2.15}\\
& =\int_{0}^{\infty} e^{-x t}\left(\int_{0}^{\infty} e^{-y t} d \mu(y)\right) d x=\int_{0}^{\infty} \frac{d \mu(y)}{x+y}
\end{align*}
$$

The exchange of orders between summation and integration, and between integrations are guaranteed by (2.5), (2.6) and Fubini's theorem.

By Fatou's Lemma and (2.5), (2.6) and (2.15),

& 0<\int_{0}^{\infty} \frac{d \mu(y)}{y}=\int_{0}^{\infty} \liminf _{x \downarrow 0} \frac{d \mu(y)}{x+y} \leq \liminf _{x \downarrow 0} \int_{0}^{\infty} \frac{d \mu(y)}{x+y} \\
& =\liminf _{x \downarrow 0}\left|\frac{f^{\prime}(x)}{f(x)}\right| \leq \liminf _{x \downarrow 0}\left|\sum_{n=1}^{\infty} \frac{1}{x+\Re\left(\lambda_{n}\right)}\right| \leq \frac{1}{\beta_{0}} \sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|} . \tag{2.16}
\end{align*}
$$

For $x, y>0$ since $\frac{1}{(x+y)^{2}}<\frac{1}{4 x y}$ then,

\int_{0}^{\infty} \frac{d \mu(y)}{(x+y)^{2}} \leq \frac{1}{4 x} \int_{0}^{\infty} \frac{d \mu(y)}{y}<\infty \tag{2.17}
\end{equation*}

For $x, y>0,|h|<\frac{x}{2}$ by (2.15), Lebesgue's dominated convergence theorem and the inequality

we obtain

& -\frac{d}{d x}\left(\frac{f^{\prime}(x)}{f(x)}\right)=-\frac{d}{d x} \int_{0}^{\infty} \frac{d \mu(y)}{x+y} \\
& =\lim _{h \rightarrow 0} \frac{1}{h} \int_{0}^{\infty}\left(\frac{1}{x+y}-\frac{1}{x+y+h}\right) d \mu(y)  \tag{2.19}\\
& =\lim _{h \rightarrow 0} \int_{0}^{\infty} \frac{d \mu(y)}{(x+y)(x+y+h)}=\int_{0}^{\infty} \frac{d \mu(y)}{(x+y)^{2}} .
\end{align*}
$$

Then by Fatou's Lemma and (2.6),

& 0<\int_{0}^{\infty} \frac{d \mu(y)}{y^{2}}=\int_{0}^{\infty} \liminf _{x \downarrow 0} \frac{d \mu(y)}{(x+y)^{2}} \leq \liminf _{x \downarrow 0} \int_{0}^{\infty} \frac{d \mu(y)}{(x+y)^{2}} \\
& =\liminf _{x \downarrow 0}\left|\frac{d}{d x}\left(\frac{f^{\prime}(x)}{f(x)}\right)\right| \leq \liminf _{x \downarrow 0}\left|\sum_{n=1}^{\infty} \frac{1}{\left(x+\Re\left(\lambda_{n}\right)\right)^{2}}\right| \leq \frac{1}{\beta_{0}^{2}} \sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}\right|^{2}} \tag{2.20}
\end{align*}
$$

Let

$$
\begin{equation*}
s(z)=\int_{0}^{\infty} \frac{d \mu(y)}{z+y} \tag{2.21}
\end{equation*}
$$

we first show that $s(z)$ is continuous and bounded on $\Re(z) \geq 0$ and analytic in $\Re(z)>0$.

For $\Re(z) \geq 0$ since

$$
\begin{equation*}
\int_{0}^{\infty} \frac{d \mu(y)}{|z+y|} \leq \int_{0}^{\infty} \frac{d \mu(y)}{\Re(z)+y} \leq \int_{0}^{\infty} \frac{d \mu(y)}{y}<\infty \tag{2.22}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{0}^{\infty} \frac{d \mu(y)}{|z+y|^{2}} \leq \int_{0}^{\infty} \frac{d \mu(y)}{(\Re(z)+y)^{2}} \leq \int_{0}^{\infty} \frac{d \mu(y)}{y^{2}}<\infty \tag{2.23}
\end{equation*}
$$

then both integrals

$$
\begin{equation*}
\int_{0}^{\infty} \frac{d \mu(y)}{z+y}, \quad \int_{0}^{\infty} \frac{d \mu(y)}{(z+y)^{2}} \tag{2.24}
\end{equation*}
$$

converge absolutely for $\Re(z) \geq 0$ and uniformly on any of its compact subsets. Thus they are continuous on $\Re(z) \geq 0$ by (2.22) and (2.23). Similar to the proof of (2.19) we can show that

s^{\prime}(z)=-\int_{0}^{\infty} \frac{d \mu(y)}{(z+y)^{2}}, \quad \Re(z)>0 \tag{2.25}
\end{equation*}
$$

Then $s(z)$ is analytic in $\Re(z)>0$.
Next we prove that $s(z)$ is continuous on any of its compact subsets of $\{z \mid \Re(z) \leq 0, \Im(z) \neq 0\}$ and analytic in $\{z \mid \Re(z)<0, \Im(z) \neq 0\}$.

Let $\Re(z)=-a \leq 0$ and $b=\Im(z) \neq 0$, then for any positive number $\epsilon>0$,

& \int_{0}^{\infty} \frac{d \mu(y)}{|(y-a)+b i|}=\int_{0}^{a+\epsilon} \frac{d \mu(y)}{|(y-a)+b i|}+\int_{a+\epsilon}^{\infty} \frac{d \mu(y)}{|(y-a)+b i|} \\
& \leq \frac{1}{|b|} \int_{0}^{a+\epsilon} \frac{y d \mu(y)}{y}+\int_{a+\epsilon}^{\infty} \frac{y}{(y-a)} \frac{d \mu(y)}{y} \\
& \leq \frac{a+\epsilon}{|b|} \int_{0}^{a+\epsilon} \frac{d \mu(y)}{y}+\int_{a+\epsilon}^{\infty} \frac{y-a+a}{y-a} \frac{d \mu(y)}{y} \\

& \leq\left(1+\frac{a}{\epsilon}+\frac{a+\epsilon}{|b|}\right) \int_{0}^{\infty} \frac{d \mu(y)}{y}<\infty
\end{aligned}
$$

and

& \int_{0}^{\infty} \frac{d \mu(y)}{|(y-a)+b i|^{2}} \leq \frac{1}{b^{2}} \int_{0}^{a+\epsilon} \frac{y^{2} d \mu(y)}{y^{2}}+\int_{a+\epsilon}^{\infty} \frac{(y-a+a)^{2}}{(y-a)^{2}} \frac{d \mu(y)}{y^{2}} \\
& \leq\left(\frac{a+\epsilon}{b}\right)^{2} \int_{0}^{a+\epsilon} \frac{d \mu(y)}{y^{2}}+\int_{a+\epsilon}^{\infty}\left(1+\frac{a}{y-a}\right)^{2} \frac{d \mu(y)}{y^{2}} \\
& \leq\left(\frac{a+\epsilon}{b}\right)^{2} \int_{0}^{a+\epsilon} \frac{d \mu(y)}{y^{2}}+\left(1+\frac{a}{\epsilon}\right)^{2} \int_{a+\epsilon}^{\infty} \frac{d \mu(y)}{y^{2}}  \tag{2.27}\\
& \leq\left(\left(\frac{a+\epsilon}{b}\right)^{2}+\left(1+\frac{a}{\epsilon}\right)^{2}\right) \int_{0}^{\infty} \frac{d \mu(y)}{y^{2}}<\infty
\end{align*}
$$

Then both integrals

converge absolutely and uniformly on any of the compact subsets of $\{z \mid \Re(z) \leq 0, \Im(z) \neq 0\}$. Similar to the case $\Re(z) \geq 0$, the above estimates imply that $s(z)$ is continuous on $\{z \mid \Re(z) \leq 0, \Im(z) \neq 0\}$, analytic in $\{z \mid \Re(z)<0, \Im(z) \neq 0\}$.

For any $z_{0}$ with $\Re\left(z_{0}\right)=0$ and $\Im\left(z_{0}\right) \neq 0$, there exists a positive number $\epsilon>0$ such that the disk $D\left(z_{0}, \epsilon\right)=\left\{z:\left|z-z_{0}\right|<\epsilon\right\}$ is completely contained in $\{z: z \in \mathbb{C} \backslash(-\infty, 0], \Im(z)>0\}$ or $\{z: z \in \mathbb{C} \backslash(-\infty, 0], \Im(z)<0\}$. Without losing any generality we may assume that $\Im\left(z_{0}\right)>0$ and $D\left(z_{0}, \epsilon\right) \subset\{z: z \in \mathbb{C} \backslash(-\infty, 0], \Im(z)>0\}$, and the other case can be treated similarly.

We first observe that $s(z)$ is continuous on the closure of $D\left(z_{0}, \epsilon / 3\right)$ except possibly on its intersection with the imaginary axis $\Re(z)=0$ where it has only one-sided continuity. For any $z$ in the intersection, let $\left\{z_{j}\right\}$ be a sequence in the closure of $D\left(z_{0}, \epsilon / 3\right)$ that converges to $z$. If all $\left\{z_{j}\right\}$ except finitely many are completely inside one of $\Re(z) \geq 0$ and $\{z \mid \Re(z) \leq 0, \Im(z) \geq \epsilon / 3\}$, then by the one-sided continuity we have $s\left(z_{j}\right) \rightarrow s(z)$ as $j \rightarrow \infty$. Otherwise, the sequence can be decomposed into two converging subsequences $\left\{z_{j_{1}}\right\}$ and $\left\{z_{j_{2}}\right\}$, which are completely contained inside in $\Re(z) \geq 0$ and $\{z \mid \Re(z) \leq 0, \Im(z) \geq \epsilon / 3\}$ respectively. However, by the one-sided continuities proved on both sets we have $s\left(z_{j_{k}}\right) \rightarrow s(z)$ as $j_{k} \rightarrow \infty$ for $k=1,2$. Therefore, $s(z)$ is continuous on the closure of $D\left(z_{0}, \epsilon / 3\right)$.

Given any closed piecewise $C^{1}$ curve $\gamma$ in $D\left(z_{0}, \epsilon / 3\right)$. If it does not intersect the imaginary axis $\Re(z)=0$, then it's completely contained in one of two disjoint regions, $\Re(z)>0$ and $\{z \mid \Re(z)<0, \Im(z)>0\}$. From the above discussion $s(z)$ is analytic in both of them, then by Cauchy's integration theorem we have $\oint_{\gamma} s(z) d z=$ 0 . Otherwise, $\gamma$ can be decomposed into a sum of closed piecewise $C^{1}$ curves $\left\{\gamma_{j}\right\}$ in $D\left(z_{0}, \epsilon / 3\right)$ by adding the line segments with opposed directions on $\Re(z)=0$ enclosed by $\gamma$. Then $s(z)$ is continuous on the closed sets enclosed by each $\gamma_{j}$ and analytic in their interiors. By a weaker version of Cauchy's integration theorem for each $j$ we have $\oint_{\gamma_{j}} s(z) d z=0$ and [1]

Then by Morera's theorem $s(z)$ is analytic in $D\left(z_{0}, \epsilon / 3\right)$, in particular at $z_{0}$.
In the summary of above discussion we have proved that $s(z)$ is continuous on $\mathbb{C} \backslash(-\infty, 0)$ and analytic in $\mathbb{C} \backslash(-\infty, 0]$.

Since the meromorphic function

If there exists an $n_{0} \in \mathbb{N}$ such that $\lambda_{n_{0}}$ is not positive. Since $\Re\left(\lambda_{n_{0}}\right)>0$ and $-\lambda_{n_{0}}$ is not negative, then $s(z)$ is analytic at $-\lambda_{n_{0}}$. Hence,

### 2.2. Proof of Theorem.

For any $k \in \mathbb{N}_{0}$ and $t>0$, it is clear that $(-1)^{k} \Theta^{(k)}(t) \geq 0$ if and only if $\Theta_{k}(t) \geq 0$. By (2.3), (2.4) and (2.6) $G_{k}^{(m)}(x) \in C^{\infty}(0, \infty)$ exists for all nonnegative integers $k, m$.

For each $k, m \in \mathbb{N}_{0}$, apply the Bernstein theorem to $G_{k}^{(m)}(x)$ we get that $\Theta_{k}(t) \geq$ 0 if and only if $G_{k}^{(m)}(x)$ is completely monotonic on $(0, \infty)$.

For any $k \in \mathbb{N}$ and $x>0$, by (2.3), (2.4) and integration by parts,

## 3. An Application

The Riemann $\xi$-function is defined by [2, 7],

It is well-known that $\xi(s)$ is an order 1 entire function that satisfies $\xi(s)=\xi(1-s)$, and it has infinitely many zeros, all of them are in the vertical strip $\sigma \in(0,1)$. Then the Riemann Xi function $\Xi(s)=\xi\left(\frac{1}{2}+i s\right)$ is an even entire function of order 1 , and it has infinitely many zeros, all of them are in the horizontal strip $t \in(-1 / 2,1 / 2)$. The Riemann hypothesis is that all the zeros of $\xi(s)$ are on $\sigma=\frac{1}{2}$,or equivalently, all the zeros $\left\{ \pm z_{n}\right\}_{n=1}^{\infty}$ of $\Xi(s)$ are real where $z_{1} \approx 14.1347$.

Let

Corollary 4. The Riemann hypothesis is true if and only if there exists an nonnegative integer $m$, all the functions

It is well-known that $\xi(s, \chi)$ is an order 1 entire function with infinitely many zeros, all of them are in the horizontal strip $t \in(-1 / 2,1 / 2)$, [5]. Then $f(s, \chi)$ is an order 1 even entire function with infinitely many zeros, all of them are in the horizontal strip $t \in(-1 / 2,1 / 2)$. Clearly, all the zeros of $\xi(s, \chi)$ on the critical line $\sigma=\frac{1}{2}$ if and only if all the zeros of $f(s, \chi)$ are real. Therefore, the generalized Riemann hypothesis for $L(s, \chi)$ is equivalent to that all the zeros $\left\{ \pm z_{n}(\chi)\right\}_{n \in \mathbb{N}}$ of $f(s, \chi)$ are real where $\Re\left(z_{n}^{2}\right)>0$.

Let

$$
\begin{equation*}
\lambda_{n}(\chi)=z_{n}^{2}(\chi), \quad n \in \mathbb{N} \tag{3.29}
\end{equation*}
$$

then it is know that for any $\epsilon>0,[5,7]$

$$
\begin{equation*}
\sum_{n=1}^{\infty} \frac{1}{\left|\lambda_{n}(\chi)\right|^{1 / 2+\epsilon}}<\infty \tag{3.30}
\end{equation*}
$$

Let

$$
\begin{equation*}
\Theta_{\Xi}(t, \chi)=\sum_{n=1}^{\infty} e^{-\lambda_{n}^{2}(\chi) t}, \quad \forall t>0 \tag{3.31}
\end{equation*}
$$

then for all $k \in \mathbb{N}_{0}$ by Lemma 2 we have

$$
\begin{equation*}
\Theta_{\Xi}^{(k)}(t, \chi)=\mathcal{O}\left(t^{-1 / 2-\epsilon-k}\right), \quad t \downarrow 0 \tag{3.32}
\end{equation*}
$$

Similar to Corollary 4 we apply Theorem 1 to $f(s, \chi)$ we obtain the following corollary:

Corollary 5. The generalized Riemann hypothesis for a primitive Dirichlet character $\chi$ is true if and only if there exists a nonnegative integer $m$ all the functions

$$
\begin{equation*}
\left(-\frac{1}{x}\right)^{m} \frac{d^{k}}{d x^{k}}\left(x^{k+m} \frac{d^{m}}{d x^{m}}\left(\frac{f^{\prime}(\sqrt{x}, \chi)}{\sqrt{x} f(\sqrt{x}, \chi)}\right)\right), \quad k \in \mathbb{N}_{0} \tag{3.33}
\end{equation*}
$$

are completely monotonic on $(0, \infty)$ where $f(s, \chi)$ is defined by (2.25).
