ON CERTAIN GENUS 0 ENTIRE FUNCTIONS

ABSTRACT. In this work we prove that an entire function f(z) has only negative zeros if and only if its order is strictly less 1, its root sequence is realpart dominating and there exists an nonnegative integer m the real function $\left(-\frac{1}{x}\right)^m \frac{d^k}{dx^k} \left(x^{k+m} \frac{d^m}{dx^m} \left(\frac{f'(x)}{f(x)}\right)\right)$ are completely monotonic on $(0, \infty)$ for all nonnegative integer k. As an application we state a necessary and sufficient condition for the Riemann hypothesis and generalized Riemann hypothesis for a primitive Dirichlet character.

1. INTRODUCTION

In this work we study the zeros of entire function f(z),

(1.1)
$$f(z) = \sum_{n=0}^{\infty} a_n z^n, \quad a_0 \cdot a_n > 0,$$

of order $\rho(f)$ strictly less than 1 where $\rho(f)$ is defined by

(1.2)
$$\rho(f) = \limsup_{n \to \infty} \frac{n \log n}{-\log |a_n|}$$

Many transcendental q-special functions such as Ramanujan's entire function $A_q(-z)$ is of this type, [8].

Since $\rho(f) < 1$, then f(z) is necessarily of genus 0. If it has any roots, then there exists a sequence of complex numbers $\{\lambda_n\}_{n=1}^{\infty}$ such that [1, 4]

(1.3)
$$\frac{f(z)}{f(0)} = \prod_{n=1}^{\infty} \left(1 + \frac{z}{\lambda_n}\right)$$

with

(1.4)
$$\sum_{n=1}^{\infty} \frac{1}{|\lambda_n|} < \infty.$$

Furthermore, for any $1 > \alpha > \rho(f)$, [4, Theorem 2.5.18]

(1.5)
$$\sum_{n=1}^{\infty} \frac{1}{|\lambda_n|^{\alpha}} < \infty.$$

In this work we prove the following:

Theorem 1. Let f(z) be an entire function defined in (1.1), (1.3) such that it has a nonzero root and it's of order strictly less than 1. If there is a positive number β_0 with $\beta_0 \in (0,1)$ such that the sequence $\{\lambda_n\}_{n \in \mathbb{N}}$ in (1.3) and (1.4) satisfies

(1.6)
$$\Re(\lambda_n) \ge \beta_0 |\lambda_n| > 0, \quad \forall n \in \mathbb{N}.$$

Then f(z) has only negative zeros if and only if there exists an nonnegative integer $m \in \mathbb{N}_0$, all the functions

(1.7)
$$G_k^{(m)}(x) = \frac{(-1)^m}{x^{m+k}} \left(x \frac{d}{dx} x \right)^k \left(x^m \frac{d^m}{dx^m} \left(\frac{f'(x)}{f(x)} \right) \right), \quad \forall k \in \mathbb{N}_0$$

are completely monotonic on $(0,\infty)$. The function $G_k^{(m)}(x)$ also has a simpler representation,

(1.8)
$$G_k^{(m)}(x) = \left(-\frac{1}{x}\right)^m \frac{d^k}{dx^k} \left(x^{k+m} \frac{d^m}{dx^m} \left(\frac{f'(x)}{f(x)}\right)\right),$$

they also satisfy the recursion,

(1.9)

$$G_0^{(m)}(z) = (-1)^m \frac{d^m}{dz^m} \left(\frac{f'(z)}{f(z)}\right),$$

$$G_k^{(m)}(z) = (k+m)G_{k-1}^{(m)}(z) + z\frac{d}{dz}G_{k-1}^{(m)}(z), \quad \forall k \in \mathbb{N}.$$

Since the Ramanujan's entire function $A_q(z)$ is an entire function of order 0 with only positive zeros for 0 < q < 1, [8]. Then for all nonnegative integer k, mand 0 < q < 1, the real functions $\frac{(-1)^{m+1}}{x^m} \frac{d^k}{dx^k} \left(x^{k+m} \frac{d^m}{dx^m} \left(\frac{A'_q(-x)}{A_q(-x)} \right) \right)$ are completely monotonic on $(0, \infty)$. However, there are many other transcendental special functions of the form

(1.10)
$$g(z) = \sum_{n=0}^{\infty} (-1)^n a_n z^{2n}, \quad a_0 \cdot a_n > 0,$$

for example, the Riemann $\Xi(z)$, and the Bessel functions $\frac{J_{\nu}(z)}{z^{\nu}}$, $\frac{J_{\nu}^{(2)}(z;q)}{z^{\nu}}$ with $\nu > -1$, 0 < q < 1, [2, 8]. If the order of g(z) is strictly less than 2,

(1.11)
$$\rho(g) = \limsup_{n \to \infty} \frac{2n \log(2n)}{-\log|a_n|} = 2\rho(f) < 2,$$

then it is not hard to see that Theorem (1) can be applied to g(z) that has at less one zero. The condition (1.6) is replaced by

(1.12)
$$\Re(z_n^2) > 0, \quad |\Im(z_n)| \le M, \quad \forall n \in \mathbb{N}.$$

Here M > 0 is a positive constant that only depends on g(z), and $\{\pm z_n\}_{n \in \mathbb{N}}$ are the roots of g(z) with $\Re(z_n) > 0$, $\forall n \in \mathbb{N}$.

Clearly, $f(z) = g(i\sqrt{z})$ transforms g(z) in (1.10) into f(z) in (1.1) of order strictly less than 1, and the zeros $\{\pm z_n\}_{n\in\mathbb{N}}$ of g(z) into the zeros $\{-\lambda_n\}_{n\in\mathbb{N}}$ of f(z) with $\lambda_n = z_n^2$. Therefore, $\lambda_n > 0$ if and only if $z_n \in \mathbb{R}$.

Since g(z) is an entire function not identically 0, then $\{\pm z_n\}_{n\in\mathbb{N}}$ has no limit points on the finite complex plane. By (1.10) and (1.12) we must have

(1.13)
$$\lim_{N \to \infty} |z_n| = +\infty, \quad \lim_{N \to \infty} \Re(z_n) = +\infty.$$

Without loss of generality we may let

(1.14)
$$0 < \Re(z_1) \le \Re(z_2) < \dots \le \Re(z_n) \le \Re(z_{n+1}) \le \dots$$

Then for any $\epsilon \in (0,1)$ there exists a $N_{\epsilon} \in \mathbb{N}$ such that

(1.15) $\epsilon |z_n|^2 \ge 2M^2, \quad \forall n \ge N_{\epsilon}.$

Hence, for all $n \geq N_{\epsilon}$

(1.16)
$$0 < \Re(z_n^2) = |z_n|^2 - 2(\Im(z_n))^2 \ge |z_n|^2 - 2M^2 \ge (1-\epsilon)|z_n|^2.$$

Let

(1.17)
$$\beta_0 = \min\left\{1 - \epsilon, \frac{\Re(z_1^2)}{|z_1^2|}, \dots, \frac{\Re(z_{N_\epsilon}^2)}{|z_{N_\epsilon}^2|}\right\} \in (0, 1),$$

then it is clear that

(1.18)
$$\Re(z_n^2) \ge \beta_0 \left| z_n^2 \right|, \quad \forall n \in \mathbb{N},$$

thus $\lambda_n = z_n^2$ satisfies (1.6).

It is known that for $\nu > -1$ the even entire function $\frac{J_{\nu}(z)}{z^{\nu}}$ is of order 1 with only real zeros, while for $\nu > -1$, 0 < q < 1 the q-Bessel function $\frac{J_{\nu}^{(2)}(z;q)}{z^{\nu}}$ is an even entire functions that of order 0 with only real zeros, [8]. Applying Theorem 1 to the Bessel functions we conclude that for all nonnegative integers k, m and any positive number q satisfying 0 < q < 1, the functions $\left(-\frac{1}{x}\right)^m \frac{d^k}{dx^k} \left(x^{k+m} \frac{d^m}{dx^m} \left(\frac{f'(x)}{f(x)}\right)\right)$ are completely monotonic on $(0, \infty)$ where $f(x) = x^{-\nu/2} I_{\nu}(\sqrt{x})$ or $f(x) = x^{-\nu/2} I_{\nu}^{(2)}(\sqrt{x};q)$.

2. Proof of the Theorem

2.1. The heat kernel $\Theta(x)$.

Lemma 2. Let f(z) be an entire function defined in (1.1), (1.3) with order $\rho(f) < 1$ such that there exists a positive number $\beta_0 \in (0,1)$ it satisfies (1.6). Then its associated heat kernel

(2.1)
$$\Theta(t) = \sum_{n=1}^{\infty} e^{-\lambda_n t}, \quad t > 0$$

is in $C^{\infty}(0,\infty)$, and for any

(2.2)
$$k \in \mathbb{N}_0, \ 1 > \alpha > p(f), \ 0 < \beta < \beta_0 \inf\left\{ \left| \lambda_n \right| \, \middle| \, n \in \mathbb{N} \right\},$$

the function $\Theta(t)$ satisfies

(2.3)
$$\Theta^{(k)}(t) = \mathcal{O}\left(t^{-\alpha-k}\right), \quad t \to 0^+$$

and

(2.4)
$$\Theta^{(k)}(t) = \mathcal{O}\left(e^{-\beta t}\right), \quad t \to +\infty.$$

Furthermore, for all $k \in \mathbb{N}_0$ and $x \ge 0$,

(2.5)
$$\int_0^\infty t^k e^{-xt} |\Theta(t)| \, dt \le \frac{k!}{\beta_0^{k+1}} \sum_{n=1}^\infty \frac{1}{|\lambda_n|^{k+1}} < \infty$$

and

(2.6)
$$(-1)^k \left(\frac{f'(x)}{f(x)}\right)^{(k)} = \sum_{n=1}^{\infty} \frac{k!}{(x+\lambda_n)^{k+1}} = \int_0^{\infty} e^{-xt} t^k \Theta(t) dt.$$

Proof. Since for any y > 0

(2.7)
$$\sup_{x>0} x^y e^{-x} = \left(\frac{y}{e}\right)^y,$$

then for any t > 0, $k \ge 0$ by (1.5) and (1.6),

(2.8)
$$\sum_{n=1}^{\infty} \left| \lambda_n^k e^{-\lambda_n t} \right| = \sum_{n=1}^{\infty} \left| \lambda_n \right|^k e^{-\Re(\lambda_n)t} \le \sum_{n=1}^{\infty} \frac{\left(\beta_0 t \left| \lambda_n \right| \right)^{k+\alpha} e^{-\beta_0 \left| \lambda_n \right| t}}{\left(\beta_0 t\right)^{\alpha+k} \left| \lambda_n \right|^{\alpha}} \le \frac{\sup_{x>0} x^{k+\alpha} e^{-x}}{\left(\beta_0 t\right)^{\alpha+k}} \sum_{n=1}^{\infty} \frac{1}{\left| \lambda_n \right|^{\alpha}} = \left(\frac{k+\alpha}{e\beta_0 t}\right)^{k+\alpha} \sum_{n=1}^{\infty} \frac{1}{\left| \lambda_n \right|^{\alpha}} < \infty,$$

which proves that $\Theta(t) \in C^{\infty}(0, \infty)$ and (2.3).

Let $0 < \beta < \beta_0 \inf \left\{ |\lambda_n| \mid n \in \mathbb{N} \right\}$, then there exists a positive number ϵ with $0 < \epsilon < 1$ such that

(2.9)
$$\beta = \epsilon \beta_0 \inf \left\{ \left| \lambda_n \right| \middle| n \in \mathbb{N} \right\} \le \epsilon \beta_0 \left| \lambda_n \right|, \quad \forall n \in \mathbb{N}.$$

Thus for $t \ge 1$ by (2.8),

(2.10)
$$\left| e^{\beta t} \Theta^{(k)}(t) \right| \leq \sum_{n=1}^{\infty} \left| \lambda_n \right|^k e^{-(\beta_0 |\lambda_n| - \beta)t} \leq \sum_{n=1}^{\infty} \left| \lambda_n \right|^k e^{-(1-\epsilon)\beta_0 |\lambda_n| t}$$
$$\leq \sum_{n=1}^{\infty} \left| \lambda_n \right|^k e^{-(1-\epsilon)\beta_0 |\lambda_n|} < \infty,$$

which establishes (2.4). For all $x, k \ge 0$ since

For all
$$x, k \ge 0$$
 since (2.11)

$$\int_{0}^{\infty} t^{k} e^{-xt} |\Theta(t)| dt \leq \int_{0}^{\infty} t^{k} \left(\sum_{n=1}^{\infty} e^{-(x+\Re(\lambda_{n}))t} \right) dt \leq \sum_{n=1}^{\infty} \int_{0}^{\infty} t^{k} e^{-(x+\beta_{0}|\lambda_{n}|)t} dt$$
$$\leq \sum_{n=1}^{\infty} \frac{k!}{(x+\beta_{0}|\lambda_{n}|)^{k+1}} \leq \frac{k!}{\beta_{0}^{k+1}} \sum_{n=1}^{\infty} \frac{1}{|\lambda_{n}|^{k+1}} < \infty,$$
hen

then,

(2.12)
$$\begin{pmatrix} \frac{f'(x)}{f(x)} \end{pmatrix}^{(k)} = \sum_{n=1}^{\infty} \frac{(-1)^k k!}{(x+\lambda_n)^{k+1}} \\ = (-1)^k \sum_{n=1}^{\infty} \int_0^\infty t^k e^{-(x+\lambda_n)t} dt = (-1)^k \int_0^\infty e^{-xt} t^k \Theta(t) dt.$$

Lemma 3. Let f(z), $\Theta(x)$ and $\{\lambda_n\}_{n=1}^{\infty}$ be defined as in Theorem 1 and Lemma 2. Then the sequence $\{\lambda_n\}_{n=1}^{\infty}$ is positive if and only if the function $\Theta(x)$ is completely monotonic on $(0, \infty)$. *Proof.* Assume that $\{\lambda_n\}_{n=1}^{\infty}$ is positive, then

(2.13)
$$(-1)^k \Theta^{(k)}(t) = \sum_{n=1}^{\infty} \lambda_n^k e^{-\lambda_n t} \ge 0, \quad \forall t > 0, k \in \mathbb{N}_0,$$

hence $\Theta(t)$ is completely monotonic by definition.

On the other hand if $\Theta(t)$ is completely monotonic on $(0, \infty)$, then by the Bernstein's theorem there exists a nonnegative measure $d\mu(t)$ on $[0, \infty)$ such that [9, 10]

(2.14)
$$\Theta(t) = \sum_{n=1}^{\infty} e^{-\lambda_n t} = \int_0^\infty e^{-yt} d\mu(y), \quad \forall t > 0.$$

For any $x \ge 0$ we multiply e^{-xt} both sides of (2.14) and integrate it with respect to t from 0 to ∞ to get

(2.15)
$$\int_0^\infty e^{-xt} \Theta(t) dt = \sum_{n=1}^\infty \frac{1}{x+\lambda_n} = \frac{f'(x)}{f(x)}$$
$$= \int_0^\infty e^{-xt} \left(\int_0^\infty e^{-yt} d\mu(y) \right) dx = \int_0^\infty \frac{d\mu(y)}{x+y}.$$

The exchange of orders between summation and integration, and between integrations are guaranteed by (2.5), (2.6) and Fubini's theorem.

By Fatou's Lemma and (2.5), (2.6) and (2.15),

(2.16)
$$0 < \int_0^\infty \frac{d\mu(y)}{y} = \int_0^\infty \liminf_{x\downarrow 0} \frac{d\mu(y)}{x+y} \le \liminf_{x\downarrow 0} \int_0^\infty \frac{d\mu(y)}{x+y}$$
$$= \liminf_{x\downarrow 0} \left| \frac{f'(x)}{f(x)} \right| \le \liminf_{x\downarrow 0} \left| \sum_{n=1}^\infty \frac{1}{x+\Re(\lambda_n)} \right| \le \frac{1}{\beta_0} \sum_{n=1}^\infty \frac{1}{|\lambda_n|}$$

For x, y > 0 since $\frac{1}{(x+y)^2} < \frac{1}{4xy}$ then,

(2.17)
$$\int_0^\infty \frac{d\mu(y)}{(x+y)^2} \le \frac{1}{4x} \int_0^\infty \frac{d\mu(y)}{y} < \infty.$$

For x, y > 0, $|h| < \frac{x}{2}$ by (2.15), Lebesgue's dominated convergence theorem and the inequality

(2.18)
$$\frac{2}{|(x+y)(x+y+h)|} \le \frac{1}{(x+y)^2} + \frac{1}{(x/2+y)^2}$$

we obtain

(2.19)
$$-\frac{d}{dx}\left(\frac{f'(x)}{f(x)}\right) = -\frac{d}{dx}\int_{0}^{\infty}\frac{d\mu(y)}{x+y} = \lim_{h \to 0}\frac{1}{h}\int_{0}^{\infty}\left(\frac{1}{x+y} - \frac{1}{x+y+h}\right)d\mu(y) = \lim_{h \to 0}\int_{0}^{\infty}\frac{d\mu(y)}{(x+y)(x+y+h)} = \int_{0}^{\infty}\frac{d\mu(y)}{(x+y)^{2}}.$$

Then by Fatou's Lemma and (2.6),

(2.20)
$$0 < \int_{0}^{\infty} \frac{d\mu(y)}{y^{2}} = \int_{0}^{\infty} \liminf_{x \downarrow 0} \frac{d\mu(y)}{(x+y)^{2}} \le \liminf_{x \downarrow 0} \int_{0}^{\infty} \frac{d\mu(y)}{(x+y)^{2}}$$
$$= \liminf_{x \downarrow 0} \left| \frac{d}{dx} \left(\frac{f'(x)}{f(x)} \right) \right| \le \liminf_{x \downarrow 0} \left| \sum_{n=1}^{\infty} \frac{1}{(x+\Re(\lambda_{n}))^{2}} \right| \le \frac{1}{\beta_{0}^{2}} \sum_{n=1}^{\infty} \frac{1}{|\lambda_{n}|^{2}}$$

Let

(2.21)
$$s(z) = \int_0^\infty \frac{d\mu(y)}{z+y},$$

we first show that s(z) is continuous and bounded on $\Re(z) \ge 0$ and analytic in $\Re(z) > 0$.

For $\Re(z) \ge 0$ since

(2.22)
$$\int_0^\infty \frac{d\mu(y)}{|z+y|} \le \int_0^\infty \frac{d\mu(y)}{\Re(z)+y} \le \int_0^\infty \frac{d\mu(y)}{y} < \infty$$

and

(2.23)
$$\int_0^\infty \frac{d\mu(y)}{|z+y|^2} \le \int_0^\infty \frac{d\mu(y)}{(\Re(z)+y)^2} \le \int_0^\infty \frac{d\mu(y)}{y^2} < \infty,$$

then both integrals

(2.24)
$$\int_0^\infty \frac{d\mu(y)}{z+y}, \quad \int_0^\infty \frac{d\mu(y)}{(z+y)^2}$$

converge absolutely for $\Re(z) \ge 0$ and uniformly on any of its compact subsets. Thus they are continuous on $\Re(z) \ge 0$ by (2.22) and (2.23). Similar to the proof of (2.19) we can show that

(2.25)
$$s'(z) = -\int_0^\infty \frac{d\mu(y)}{(z+y)^2}, \quad \Re(z) > 0,$$

Then s(z) is analytic in $\Re(z) > 0$.

Next we prove that s(z) is continuous on any of its compact subsets of $\{z | \Re(z) \le 0, \Im(z) \ne 0\}$ and analytic in $\{z | \Re(z) < 0, \Im(z) \ne 0\}$.

Let $\Re(z) = -a \leq 0$ and $b = \Im(z) \neq 0$, then for any positive number $\epsilon > 0$,

$$\int_{0}^{\infty} \frac{d\mu(y)}{|(y-a)+bi|} = \int_{0}^{a+\epsilon} \frac{d\mu(y)}{|(y-a)+bi|} + \int_{a+\epsilon}^{\infty} \frac{d\mu(y)}{|(y-a)+bi|}$$

$$\leq \frac{1}{|b|} \int_{0}^{a+\epsilon} \frac{yd\mu(y)}{y} + \int_{a+\epsilon}^{\infty} \frac{y}{(y-a)} \frac{d\mu(y)}{y}$$

$$\leq \frac{a+\epsilon}{|b|} \int_{0}^{a+\epsilon} \frac{d\mu(y)}{y} + \int_{a+\epsilon}^{\infty} \frac{y-a+a}{y-a} \frac{d\mu(y)}{y}$$

$$\leq \frac{a+\epsilon}{|b|} \int_{0}^{a+\epsilon} \frac{d\mu(y)}{y} + \left(1+\frac{a}{\epsilon}\right) \int_{a+\epsilon}^{\infty} \frac{d\mu(y)}{y}$$

$$\leq \left(1+\frac{a}{\epsilon}+\frac{a+\epsilon}{|b|}\right) \int_{0}^{\infty} \frac{d\mu(y)}{y} < \infty$$

and

$$\int_{0}^{\infty} \frac{d\mu(y)}{|(y-a)+bi|^{2}} \leq \frac{1}{b^{2}} \int_{0}^{a+\epsilon} \frac{y^{2}d\mu(y)}{y^{2}} + \int_{a+\epsilon}^{\infty} \frac{(y-a+a)^{2}}{(y-a)^{2}} \frac{d\mu(y)}{y^{2}}$$

$$\leq \left(\frac{a+\epsilon}{b}\right)^{2} \int_{0}^{a+\epsilon} \frac{d\mu(y)}{y^{2}} + \int_{a+\epsilon}^{\infty} \left(1+\frac{a}{y-a}\right)^{2} \frac{d\mu(y)}{y^{2}}$$

$$\leq \left(\frac{a+\epsilon}{b}\right)^{2} \int_{0}^{a+\epsilon} \frac{d\mu(y)}{y^{2}} + \left(1+\frac{a}{\epsilon}\right)^{2} \int_{a+\epsilon}^{\infty} \frac{d\mu(y)}{y^{2}}$$

$$\leq \left(\left(\frac{a+\epsilon}{b}\right)^{2} + \left(1+\frac{a}{\epsilon}\right)^{2}\right) \int_{0}^{\infty} \frac{d\mu(y)}{y^{2}} < \infty.$$

Then both integrals

(2.28)
$$\int_0^\infty \frac{d\mu(y)}{y+z}, \quad \int_0^\infty \frac{d\mu(y)}{(y+z)^2}$$

converge absolutely and uniformly on any of the compact subsets of $\{z | \Re(z) \leq 0, \Im(z) \neq 0\}$. Similar to the case $\Re(z) \geq 0$, the above estimates imply that s(z) is continuous on $\{z | \Re(z) \leq 0, \Im(z) \neq 0\}$, analytic in $\{z | \Re(z) < 0, \Im(z) \neq 0\}$.

For any z_0 with $\Re(z_0) = 0$ and $\Im(z_0) \neq 0$, there exists a positive number $\epsilon > 0$ such that the disk $D(z_0, \epsilon) = \{z : |z - z_0| < \epsilon\}$ is completely contained in $\{z : z \in \mathbb{C} \setminus (-\infty, 0], \Im(z) > 0\}$ or $\{z : z \in \mathbb{C} \setminus (-\infty, 0], \Im(z) < 0\}$. Without losing any generality we may assume that $\Im(z_0) > 0$ and $D(z_0, \epsilon) \subset \{z : z \in \mathbb{C} \setminus (-\infty, 0], \Im(z) > 0\}$, and the other case can be treated similarly.

We first observe that s(z) is continuous on the closure of $D(z_0, \epsilon/3)$ except possibly on its intersection with the imaginary axis $\Re(z) = 0$ where it has only one-sided continuity. For any z in the intersection, let $\{z_j\}$ be a sequence in the closure of $D(z_0, \epsilon/3)$ that converges to z. If all $\{z_j\}$ except finitely many are completely inside one of $\Re(z) \ge 0$ and $\{z|\Re(z) \le 0, \Im(z) \ge \epsilon/3\}$, then by the one-sided continuity we have $s(z_j) \to s(z)$ as $j \to \infty$. Otherwise, the sequence can be decomposed into two converging subsequences $\{z_{j_1}\}$ and $\{z_{j_2}\}$, which are completely contained inside in $\Re(z) \ge 0$ and $\{z|\Re(z) \le 0, \Im(z) \ge \epsilon/3\}$ respectively. However, by the one-sided continuities proved on both sets we have $s(z_{j_k}) \to s(z)$ as $j_k \to \infty$ for k = 1, 2. Therefore, s(z) is continuous on the closure of $D(z_0, \epsilon/3)$.

Given any closed piecewise C^1 curve γ in $D(z_0, \epsilon/3)$. If it does not intersect the imaginary axis $\Re(z) = 0$, then it's completely contained in one of two disjoint regions, $\Re(z) > 0$ and $\{z | \Re(z) < 0, \Im(z) > 0\}$. From the above discussion s(z) is analytic in both of them, then by Cauchy's integration theorem we have $\oint_{\gamma} s(z)dz =$ 0. Otherwise, γ can be decomposed into a sum of closed piecewise C^1 curves $\{\gamma_j\}$ in $D(z_0, \epsilon/3)$ by adding the line segments with opposed directions on $\Re(z) = 0$ enclosed by γ . Then s(z) is continuous on the closed sets enclosed by each γ_j and analytic in their interiors. By a weaker version of Cauchy's integration theorem for each j we have $\oint_{\gamma_i} s(z)dz = 0$ and [1]

(2.29)
$$\oint_{\gamma} s(z)dz = \sum_{j} \oint_{\gamma_{j}} s(z)dz = \sum_{j} 0 = 0.$$

Then by Morera's theorem s(z) is analytic in $D(z_0, \epsilon/3)$, in particular at z_0 .

In the summary of above discussion we have proved that s(z) is continuous on $\mathbb{C}\setminus (-\infty, 0)$ and analytic in $\mathbb{C}\setminus (-\infty, 0]$.

Since the meromorphic function

(2.30)
$$\frac{f'(z)}{f(z)} = \sum_{n=1}^{\infty} \frac{1}{z + \lambda_n}$$

is analytic in $\mathbb{C} \setminus \{-\lambda_n\}_{n \in \mathbb{N}}$, and s(z) is analytic in $\mathbb{C} \setminus (-\infty, 0]$, while by (2.15) they are equal on $z \ge 0$, then we must have

(2.31)
$$\frac{f'(z)}{f(z)} = s(z), \quad z \in \mathbb{C} \setminus \left(\{ -\lambda_n \}_{n \in \mathbb{N}} \cup (-\infty, 0] \right)$$

by analytic continuation.

If there exists an $n_0 \in \mathbb{N}$ such that λ_{n_0} is not positive. Since $\Re(\lambda_{n_0}) > 0$ and $-\lambda_{n_0}$ is not negative, then s(z) is analytic at $-\lambda_{n_0}$. Hence,

(2.32)
$$\lim_{z \to -\lambda_{n_0}} s(z) = s\left(-\lambda_{n_0}\right) = \int_0^\infty \frac{d\mu(y)}{y - \lambda_{n_0}} \neq \infty.$$

On the other hand since $-\lambda_{n_0}$ is a zero of f(z), then it is a simple pole of $\frac{f'(z)}{f(z)}$ with a positive residue. Hence,

(2.33)
$$\lim_{z \to -\lambda_{n_0}} \frac{f'(z)}{f(z)} = \infty.$$

Combining (2.32) and (2.33) we have reached the following contradiction,

(2.34)
$$\infty \neq s\left(-\lambda_{n_0}\right) = \lim_{z \to -\lambda_{n_0}} s(z) = \lim_{z \to -\lambda_{n_0}} \frac{f'(z)}{f(z)} = \infty$$

This contradiction proves that $\{\lambda_n\}_{n\in\mathbb{N}}$ must be a positive sequence.

2.2. Proof of Theorem.

Proof. For $k, m \in \mathbb{N}_0$, t > 0 and z with $\Re(z) > 0$ we define

(2.35)
$$\Theta_k(t) = (-t)^k \Theta^{(k)}(t), \quad G_k^{(m)}(z) = \int_0^\infty e^{-zt} t^m \Theta_k(t) dt, \quad \forall k \in \mathbb{N}$$

and

(2.36)
$$\Theta_0(t) = \Theta(t), \quad G_0^{(m)}(z) = \int_0^\infty e^{-zt} t^m \Theta(t) dt = (-1)^m \frac{d^m}{dz^m} \left(\frac{f'(z)}{f(z)}\right).$$

For any $k \in \mathbb{N}_0$ and t > 0, it is clear that $(-1)^k \Theta^{(k)}(t) \ge 0$ if and only if $\Theta_k(t) \ge 0$. By (2.3), (2.4) and (2.6) $G_k^{(m)}(x) \in C^{\infty}(0,\infty)$ exists for all nonnegative integers k, m.

For each $k, m \in \mathbb{N}_0$, apply the Bernstein theorem to $G_k^{(m)}(x)$ we get that $\Theta_k(t) \geq 0$ 0 if and only if $G_k^{(m)}(x)$ is completely monotonic on $(0, \infty)$. For any $k \in \mathbb{N}$ and x > 0, by (2.3), (2.4) and integration by parts,

$$G_{k}^{(m)}(x) = \int_{0}^{\infty} e^{-xt} t^{m} \Theta_{k}(t) dt = (-1)^{k} \int_{0}^{\infty} t^{k+m} e^{-xt} \frac{d}{dt} \Theta^{(k-1)}(t) dt$$

$$(2.37) = \int_{0}^{\infty} (k+m-xt) e^{-xt} t^{m} \Theta_{k-1}(t) dt = (k+m) G_{k-1}^{(m)}(x) + x \frac{d}{dx} G_{k-1}^{(m)}(x)$$

$$= x^{1-k-m} \frac{d}{dx} \left(x^{k+m} G_{k-1}^{(m)}(x) \right) = \frac{1}{x^{k+m}} \left(x \frac{d}{dx} x \right) \left(x^{k-1+m} G_{k-1}^{(m)}(x) \right),$$

(2.38)
$$x^{k+m}G_k^{(m)}(x) = \left(x\frac{d}{dx}x\right)\left(x^{k-1+m}G_{k-1}^{(m)}(x)\right) = \dots = \left(x\frac{d}{dx}x\right)^k\left((-x)^m\frac{d^m}{dx^m}\left(\frac{f'(x)}{f(x)}\right)\right),$$

it leads to

(2.39)
$$G_k^{(m)}(x) = \frac{(-1)^m}{x^{m+k}} \left(x\frac{d}{dx}x\right)^k \left(x^m \frac{d^m}{dx^m} \left(\frac{f'(x)}{f(x)}\right)\right).$$

On the other hand, for any $k \in \mathbb{N}$ and x > 0 by (2.3), (2.4) and integration by parts, (2.40)

$$\begin{aligned} G_{k}^{(2,40)} & G_{k}^{(m)}(x) = \int_{0}^{\infty} e^{-xt} t^{m} \Theta_{k}(t) dt = \int_{0}^{\infty} e^{-xt} (-t)^{k} t^{m} \Theta^{(k)}(t) dt \\ & = \int_{0}^{\infty} \frac{d^{k}}{dt^{k}} \left(e^{-xt} t^{k+m} \right) \Theta(t) dt = \int_{0}^{\infty} \left(e^{y} y^{-m} \frac{d^{k}}{dy^{k}} \left(e^{-y} y^{k+m} \right) \right) \bigg|_{y=xt} e^{-xt} t^{m} \Theta(t) dt \\ & = k! \int_{0}^{\infty} \left(\frac{e^{y} y^{-m}}{k!} \frac{d^{k}}{dy^{k}} \left(e^{-y} y^{k+m} \right) \right) \bigg|_{y=xt} e^{-xt} t^{m} \Theta(t) dt = k! \int_{0}^{\infty} L_{k}^{(m)}(xt) e^{-xt} t^{m} \Theta(t) dt, \end{aligned}$$

which gives

(2.41)
$$G_k^{(m)}(x) = k! \int_0^\infty L_k^{(m)}(xt) e^{-xt} t^m \Theta(t) dt,$$

where we have applied the Rodrigues formula for Laguerre polynomials, [2, 8]

(2.42)
$$L_n^{(\alpha)}(x) = \frac{x^{-\alpha} e^x}{n!} \frac{d^n}{dx^n} \left(e^{-x} x^{n+\alpha} \right).$$

Since

(2.43)
$$L_k^{(m)}(xt) = \frac{e^{xt}}{k!x^m} \frac{d^k}{dx^k} \left(e^{-tx} x^{k+m} \right),$$

(2.44)

$$G_{k}^{(m)}(x) = k! \int_{0}^{\infty} L_{k}^{(m)}(xt) e^{-xt} t^{m} \Theta(t) dt = x^{-m} \int_{0}^{\infty} \frac{d^{k}}{dx^{k}} \left(e^{-tx} x^{k+m} \right) t^{m} \Theta(t) dt$$
$$= x^{-m} \frac{d^{k}}{dx^{k}} x^{k+m} \int_{0}^{\infty} e^{-tx} t^{m} \Theta(t) dt = \left(-\frac{1}{x} \right)^{m} \frac{d^{k}}{dx^{k}} \left(x^{k+m} \frac{d^{m}}{dx^{m}} \left(\frac{f'(x)}{f(x)} \right) \right).$$

3. An Application

The Riemann ξ -function is defined by [2, 7],

(3.1)
$$\xi(s) = \pi^{-s/2}(s-1)\Gamma\left(1+\frac{s}{2}\right)\zeta(s), \quad s = \sigma + it, \ \sigma, t \in \mathbb{R},$$

where $\Gamma(s), \, \zeta(s)$ are the respective analytic continuations of

(3.2)
$$\Gamma(s) = \int_0^\infty e^{-x} x^{s-1} dx, \quad \sigma > 0$$

then,

and

(3.3)
$$\zeta(s) = \sum_{n=1}^{\infty} \frac{1}{n^s}, \quad \sigma > 1$$

It is well-known that $\xi(s)$ is an order 1 entire function that satisfies $\xi(s) = \xi(1-s)$, and it has infinitely many zeros, all of them are in the vertical strip $\sigma \in (0, 1)$. Then the Riemann Xi function $\Xi(s) = \xi \left(\frac{1}{2} + is\right)$ is an even entire function of order 1, and it has infinitely many zeros, all of them are in the horizontal strip $t \in (-1/2, 1/2)$. The Riemann hypothesis is that all the zeros of $\xi(s)$ are on $\sigma = \frac{1}{2}$, or equivalently, all the zeros $\{\pm z_n\}_{n=1}^{\infty}$ of $\Xi(s)$ are real where $z_1 \approx 14.1347$. Let

(3.4)
$$\lambda_n = z_n^2, \quad n \in \mathbb{N},$$

then it is know that for any $\epsilon > 0$, [5, 7]

(3.5)
$$\sum_{n=1}^{\infty} \frac{1}{|\lambda_n|^{1/2+\epsilon}} < \infty.$$

Let

(3.6)
$$\Theta_{\Xi}(t) = \sum_{n=1}^{\infty} e^{-\lambda_n^2 t}, \quad \forall t > 0,$$

then for all $k \in \mathbb{N}_0$ by Lemma 2 we have

(3.7)
$$\Theta_{\Xi}^{(k)}(t) = \mathcal{O}\left(t^{-1/2 - \epsilon - k}\right), \quad t \downarrow 0$$

Since [7]

(3.8)
$$\Xi(s) = \int_{-\infty}^{\infty} \Phi(u) e^{ius} du = 2 \int_{0}^{\infty} \Phi(u) \cos(us) du,$$

where

(3.9)
$$\Phi(u) = \Phi(-u) = \sum_{n=1}^{\infty} \left(4n^4 \pi^2 e^{9u/2} - 6n^2 \pi e^{5u/2} \right) e^{-n^2 \pi e^{2u}} > 0.$$

Then,

(3.10)
$$\xi\left(\frac{1}{2}+s\right) = \sum_{n=0}^{\infty} a_n s^{2n}, \quad a_n = \frac{2}{(2n)!} \int_0^\infty \Phi(u) u^{2n} du > 0$$

and

(3.11)
$$f(s) = \xi\left(\frac{1}{2} + \sqrt{s}\right) = \sum_{n=0}^{\infty} a_n s^n$$

defines an entire function of order $\frac{1}{2}$, and $\Xi(s)$ has only real roots if and only if f(s) has only negative roots. Apply Theorem 1 to f(s) we obtain the following corollary:

Corollary 4. The Riemann hypothesis is true if and only if there exists an nonnegative integer m, all the functions

(3.12)
$$\left(-\frac{1}{x}\right)^m \frac{d^k}{dx^k} \left(x^{k+m} \frac{d^m}{dx^m} \left(\frac{\xi'\left(\frac{1}{2} + \sqrt{x}\right)}{\sqrt{x}\xi\left(\frac{1}{2} + \sqrt{x}\right)}\right)\right), \quad k \in \mathbb{N}_0$$

10

are completely monotonic on $(0, \infty)$.

For a primitive Dirichlet character $\chi(n)$ modulo q, let [2, 3, 5, 7]

(3.13)
$$\xi(s,\chi) = \left(\frac{q}{\pi}\right)^{(s+\kappa)/2} \Gamma\left(\frac{s+\kappa}{2}\right) L(s,\chi),$$

where κ is the parity of χ and $L(s, \chi)$ is the analytic continuation of

(3.14)
$$L(s,\chi) = \sum_{n=1}^{\infty} \frac{\chi(n)}{n^s}, \quad \sigma > 1.$$

Then $\xi(s, \chi)$ is an entire function of order 1 such that [5]

(3.15)
$$\xi(s,\chi) = \epsilon(\chi)\xi(1-s,\overline{\chi}),$$

where

(3.16)
$$\epsilon(\chi) = \frac{\tau(\chi)}{i^{\kappa}\sqrt{q}}, \quad \tau(\chi) = \sum_{n=1}^{q} \chi(n) \exp\left(\frac{2\pi i n}{q}\right).$$

Let

(3.17)
$$G(s,\chi) = \xi(s,\chi) \cdot \xi(s,\overline{\chi}),$$

then

(3.18)
$$G(s,\chi) = \epsilon(\chi) \cdot \epsilon(\overline{\chi}) G(1-s,\chi).$$

Since [5]

(3.19)
$$\tau(\overline{\chi}) = \overline{\tau(\chi)}, \quad |\tau(\chi)| = \sqrt{q},$$

then

(3.20)
$$G(s, \chi) = G(1 - s, \chi)$$

Since the entire function $\xi\left(\frac{1}{2} + is, \chi\right)$ has an integral representation, [5]

(3.21)
$$\xi\left(\frac{1}{2}+is,\chi\right) = \int_{-\infty}^{\infty} e^{isy}\varphi\left(y,\chi\right)dy,$$

where

(3.22)
$$\varphi(y,\chi) = 2\sum_{n=1}^{\infty} n^{\kappa} \chi(n) \exp\left(-\frac{n^2 \pi}{q} e^{2y} + \left(\kappa + \frac{1}{2}\right) y\right),$$

then

(3.23)
$$\xi\left(\frac{1}{2}+is,\chi\right) = \sum_{n=0}^{\infty} i^n a_n(\chi) s^n, \quad a_n(\chi) = \int_{-\infty}^{\infty} y^n \varphi\left(y,\chi\right) dy.$$

It is known that the fast decreasing smooth function $\varphi(y,\chi)$ satisfies the functional equation [5]

(3.24)
$$\varphi(y,\chi) = \frac{i^{\kappa}\sqrt{q}}{\tau(\overline{\chi})}\varphi(-y;\overline{\chi}), \quad y \in \mathbb{R},$$

then for all $n \in \mathbb{N}_0$,

(3.25)
$$a_n(\overline{\chi}) = \int_{-\infty}^{\infty} y^n \varphi(y, \overline{\chi}) \, dy = (-1)^n \int_{-\infty}^{\infty} y^n \varphi(-y, \overline{\chi}) \, dy$$
$$= \frac{(-1)^n \tau(\overline{\chi})}{i^\kappa \sqrt{q}} \int_{-\infty}^{\infty} y^n \varphi(y, \chi) \, dy = \frac{(-1)^n \tau(\overline{\chi})}{i^\kappa \sqrt{q}} a_n(\chi).$$

Let

(3.26)
$$f(s,\chi) = s^{-2\mu} G\left(\frac{1}{2} + is,\chi\right) = s^{-2\mu} \xi\left(\frac{1}{2} + is,\chi\right) \cdot \xi\left(\frac{1}{2} + is,\overline{\chi}\right),$$

where $\mu \in \mathbb{N}_0$ is the least nonnegative integer such that $a_{\mu}(\chi) \neq 0$, then the even entire function $f(s, \chi)$ has the series expansion

(3.27)
$$f(s,\chi) = f(-s,\chi) = \sum_{n=0}^{\infty} (-1)^n b_n(\chi) s^{2n},$$

where $b_0(\chi) = \frac{(-1)^{\mu} \tau(\overline{\chi})}{i^{\kappa} \sqrt{q}} a_{\mu}^2(\chi)$ and for $n \in \mathbb{N}$,

(3.28)
$$b_{n}(\chi) = \sum_{j=0}^{2n} a_{j+\mu}(\chi) a_{2n-j+\mu}(\overline{\chi})$$
$$= \frac{(-1)^{\mu} \tau(\overline{\chi})}{i^{\kappa} \sqrt{q}} \sum_{j=0}^{2n} (-1)^{j} a_{j+\mu}(\chi) a_{2n-j+\mu}(\chi).$$

It is well-known that $\xi(s,\chi)$ is an order 1 entire function with infinitely many zeros, all of them are in the horizontal strip $t \in (-1/2, 1/2)$, [5]. Then $f(s,\chi)$ is an order 1 even entire function with infinitely many zeros, all of them are in the horizontal strip $t \in (-1/2, 1/2)$. Clearly, all the zeros of $\xi(s,\chi)$ on the critical line $\sigma = \frac{1}{2}$ if and only if all the zeros of $f(s,\chi)$ are real. Therefore, the generalized Riemann hypothesis for $L(s,\chi)$ is equivalent to that all the zeros $\{\pm z_n(\chi)\}_{n\in\mathbb{N}}$ of $f(s,\chi)$ are real where $\Re(z_n^2) > 0$.

Let

(3.29)
$$\lambda_n(\chi) = z_n^2(\chi), \quad n \in \mathbb{N},$$

then it is know that for any $\epsilon > 0$, [5, 7]

(3.30)
$$\sum_{n=1}^{\infty} \frac{1}{|\lambda_n(\chi)|^{1/2+\epsilon}} < \infty$$

Let

(3.31)
$$\Theta_{\Xi}(t,\chi) = \sum_{n=1}^{\infty} e^{-\lambda_n^2(\chi)t}, \quad \forall t > 0,$$

then for all $k \in \mathbb{N}_0$ by Lemma 2 we have

(3.32)
$$\Theta_{\Xi}^{(k)}(t,\chi) = \mathcal{O}\left(t^{-1/2-\epsilon-k}\right), \quad t \downarrow 0.$$

Similar to Corollary 4 we apply Theorem 1 to $f(s, \chi)$ we obtain the following corollary:

Corollary 5. The generalized Riemann hypothesis for a primitive Dirichlet character χ is true if and only if there exists a nonnegative integer m all the functions

(3.33)
$$\left(-\frac{1}{x}\right)^m \frac{d^k}{dx^k} \left(x^{k+m} \frac{d^m}{dx^m} \left(\frac{f'(\sqrt{x},\chi)}{\sqrt{x}f(\sqrt{x},\chi)}\right)\right), \quad k \in \mathbb{N}_0$$

are completely monotonic on $(0, \infty)$ where $f(s, \chi)$ is defined by (2.25).
