# Almost Commutative Manifolds and Their Modular Classes

#### Abstract

An almost commutative algebra, or a $\rho$-commutative algebra, is an algebra which is graded by an abelian group and whose commutativity is controlled by a function called a commutation factor. The same way as a formulation of a supermanifold as a ringed space, we introduce concepts of the $\rho$-commutative versions of manifolds, Q-manifolds, Berezin volume forms, and the modular classes. They are generalizations of the ones in supergeometry. We give examples including a $\rho$-commutative version of the Schouten bracket and a noncommutative torus.


## 1 Introduction

For the study of noncommutative algebras, it is convenient to impose a constraint for the noncommutativity of the algebras, which is often called a commutation rule. A commutative algebra is an algebra with a commutation rule $f g=g f$ for all element $f, g$ of the algebra. A superalgebra is a $\mathbb{Z} / 2 \mathbb{Z}$-graded algebra which has a commutation rule $f g=-g f$ if homogeneous elements $f, g$ are odd, and $f g=g f$ otherwise. A $\rho$-commutative (or almost commutative, $\epsilon$-commutative) algebra is an algebra graded by an arbitrary abelian group $G$ with its commutation rule controlled by a map called a commutation factor [15, 2, 5, 4]. This condition characterizing noncommutativity covers not only commutative algebras or superalgebras, but quaternions, quantum planes, and noncommutative tori, etc. $\rho$-Lie algebras are also defined as the $\rho$-commutative version of Lie algebras.

Meanwhile, we have a characteristic class called the modular class of a Q-manifold. A Q-manifold or a dg-manifold is a supermanifold with an odd vector field squared to zero as a derivation on functions. This condition for a vector field appears in various cases. Lie algebroids, $L_{\infty}$-algebras, and the de Rham or Dolbeault complexes are formulated as Q-manifolds [8]. In the aspect of mathematical physics, the classical BRST formalism is one of the application of Q-manifolds [11]. Theories of characteristic classes of Qmanifolds are studied by Kotov [9], Lyakhovich-Mosman-Sharapov [10], and Bruce [3]. The modular class is one of them which generalizes the modular class of a higher Poisson manifold.

The main goal of this paper is to introduce a concept of the modular classes for $\rho$-Q-manifolds and give examples of them. Supermanifolds are constructed by replacing the local functional algebras of the underlying manifold with a graded-commutative $\mathbb{Z} / 2 \mathbb{Z}$-algebra. We apply the same procedure to a manifold but with a $\rho$-commutative algebra. We call the resulting manifold a $\rho$-manifold. Vector fields on a $\rho$-manifold are $\rho$-derivations on the $\rho$-commutative functional algebra. An odd vector field squared to zero in this case defines a $\rho$-Q-manifold. The $\rho$-commutative version of a Berezin volume form is defined, which allows us to define the modular class of a $\rho$-Q-manifold the same way as a Q-manifold. We give examples of $\rho$-Qmanifolds and their modular classes, e.g., the tangent or cotangent bundle of a $\rho$-manifold, the degree shift of them, and the BRST differential on noncommutative tori.

In Section 2, we review the theory of $\rho$-commutative algebras and $\rho$ Lie algebras. We mainly give definitions and examples of them here. In Section 3, we review the matrix algebra whose entries are in a $\rho$-commutative algebra. We introduce the determinant and the Berezinian in this version by [7, 6]. In Section 4, we discuss the specific algebra which is a subalgebra of the set of formal power series with $G$-graded indeterminates. This section is devoted to the preparation for argument of $\rho$-manifolds. In Section 5 , we define a $\rho$-manifold and a $\rho$-Q-manifold. Here we discuss the de Rham complex and the degree- $i$ Schouten bracket of a $\rho$-manifold. In Section 6, we introduce the Berezinian bundle of a $\rho$-manifold and its orientability using the result of Section 3. In section 7, we define the modular class of a $\rho$-Qmanifold and calculate them in several situations, for example, the degree- $i$ Schouten bracket and noncommutative tori.

Notations. We write $\mathbb{K}=\mathbb{R}$ or $\mathbb{C}$ for a coefficient field. The underlying manifold $M$ can be a smooth or real analytic or holomorphic manifold. The term 'manifold' in this paper means either of them unless otherwise specified. $\mathscr{O}(M)$ means the algebra of real-valued smooth functions $C^{\infty}(M, \mathbb{R})$ or complex-valued smooth functions $C^{\infty}(M, \mathbb{C})$ if $M$ is smooth, real-analytic functions $C^{\omega}(M, \mathbb{R})$ if $M$ is real-analytic, holomorphic functions $C^{\omega}(M, \mathbb{C})$ if $M$ is holomorphic. For $\mathbb{K}=\mathbb{R}$ and $\mathscr{O}(M)$ being the set of a real-valued smooth or real-analytic functions, we call this case the real category. For $\mathbb{K}=\mathbb{C}$ and $\mathscr{O}(M)$ being the set of a complex-valued smooth or holomorphic functions, we call this case the complex category.

## $2 \rho$-commutative algebras and $\rho$-Lie algebras

In this section, we briefly review the theory of $\rho$-commutative algebras and $\rho$-Lie algebras.

Definition 2.1. Let $G$ be an abelian group. A commutation factor on $G$ is a map $\rho: G \times G \rightarrow \mathbb{K}$ satisfying the following conditions:
(i) $\rho(i, j) \rho(j, i)=1$ for all $i, j \in G$,
(ii) $\rho(i+j, k)=\rho(i, k) \rho(j, k)$ for all $i, j, k \in G$.

Directly from this definition, it is easily shown that

$$
\begin{gathered}
\rho(i, j) \neq 0, \quad \rho(i, j)=\rho(j, i)^{-1}=\rho(-j, i)=\rho(j,-i), \quad \rho(i, i)= \pm 1, \\
\rho(0, i)=\rho(i, 0)=1, \quad \rho(i, j+k)=\rho(i, j) \rho(i, k)
\end{gathered}
$$

for all $i, j, k \in G$.
Let $G$ be an abelian group and $A=\bigoplus_{i \in G} A_{i}$ be a $G$-graded algebra over $\mathbb{K}$. We write $|f|:=i$ if and only if $f \in A_{i}$. Unless otherwise mentioned, we assume $f$ is a $G$-homogeneous element when we consider the degree $|f|$.

Definition 2.2. A $G$-graded algebra $A$ is said to be a $\rho$-commutative algebra if

$$
f g=\rho(|f|,|g|) g f
$$

holds for all $f, g \in A$.
Example 2.3. For any abelian group $G$ and for the trivial commutation factor $\rho: G \times G \rightarrow\{1\} \hookrightarrow \mathbb{K}$, a $\rho$-commutative algebra is simply an usual commutative algebra with an extra $G$-grading.

Example 2.4. Let $G=\mathbb{Z} / 2 \mathbb{Z}$ and define $\rho: \mathbb{Z} / 2 \mathbb{Z} \times \mathbb{Z} / 2 \mathbb{Z} \rightarrow \mathbb{K}$ by

$$
\rho(i, j):=(-1)^{i j}
$$

for all $i, j \in G$. In this case, a $\rho$-commutative algebra coincides with a superalgebra.

Example 2.5. Fix an integer $m>0$ and a skew-symmetric matrix $\Theta=$ $\left(\theta_{k l}\right)_{k, l} \in M(m, \mathbb{R})$. Let $\mathbb{K}=\mathbb{C}$ and $G=\mathbb{Z}^{m}$. Write an element of $G$ like $\mathbf{i}=\left(i_{1}, i_{2}, \ldots, i_{m}\right) \in G$. Define a map $\rho: G \times G \rightarrow \mathbb{C}$ by

$$
\rho(\mathbf{i}, \mathbf{j}):=\exp \left(2 \pi \sqrt{-1} \mathbf{i}^{\top} \Theta \mathbf{j}\right)
$$

for all $\mathbf{i}, \mathbf{j} \in G$. This map becomes a commutation factor on $\mathbb{Z}^{m}$ because the skew-symmetricity of $\Theta$ implies that the equations

$$
\begin{aligned}
\rho(\mathbf{i}, \mathbf{j}) \rho(\mathbf{j}, \mathbf{i}) & =\exp \left(2 \pi \sqrt{-1}\left(\mathbf{i}^{\top} \Theta \mathbf{j}+\mathbf{j}^{\top} \Theta \mathbf{i}\right)\right) \\
& =\exp \left(2 \pi \sqrt{-1}\left(\mathbf{i}^{\top} \Theta \mathbf{j}-\mathbf{i}^{\top} \Theta \mathbf{j}\right)\right)=1
\end{aligned}
$$

and

$$
\begin{aligned}
\rho(\mathbf{i}+\mathbf{j}, \mathbf{k}) & =\exp \left(2 \pi \sqrt{-1}\left((\mathbf{i}+\mathbf{j})^{\top} \Theta \mathbf{k}\right)\right) \\
& =\exp \left(2 \pi \sqrt{-1}\left(\mathbf{i}^{\top} \Theta \mathbf{k}+\mathbf{j}^{\top} \Theta \mathbf{k}\right)\right)=\rho(\mathbf{i}, \mathbf{k}) \rho(\mathbf{j}, \mathbf{k})
\end{aligned}
$$

hold for all $\mathbf{i}, \mathbf{j}, \mathbf{k} \in G$.
Let $A_{\Theta}$ be an algebra generated by indeterminates $u^{1}, u^{2}, \ldots, u^{m}$ with relations

$$
u^{k} u^{l}=\exp \left(2 \pi \sqrt{-1} \theta_{k l}\right) u^{l} u^{k}
$$

for $1 \leq k, l \leq m$. This algebra has a natural $G$-grading $A_{\Theta}=\bigoplus_{\mathbf{i} \in G}\left(A_{\Theta}\right)_{\mathbf{i}}$ where

$$
\left(A_{\Theta}\right)_{\mathbf{i}}:= \begin{cases}\mathbb{C} \cdot\left\{\left(u^{1}\right)^{i_{1}}\left(u^{2}\right)^{i_{2}} \cdots\left(u^{m}\right)^{i_{m}}\right\} & \text { if } i_{k} \geq 0 \text { for all } 1 \leq k \leq m, \\ 0 & \text { otherwise. }\end{cases}
$$

Then, $A_{\Theta}$ becomes a $\rho$-commutative algebra over $\mathbb{C}$ with respect to the commutation factor $\rho$ defined above. Moreover, $A_{\Theta}$ is nothing but the algebra of functions on the $m$-dimensional noncommutative torus [13]. The case $m=2$ is discussed in (4).

Remark 2.6. When a $G$-graded $\rho$-commutative algebra is given, we often consider another algebra associated with it which is graded by $G^{\prime}:=\mathbb{Z} \times G$, and whose commutation factor $\rho^{\prime}: G^{\prime} \times G^{\prime} \rightarrow \mathbb{K}$ is defined by

$$
\rho^{\prime}((s, i),(t, j)):=(-1)^{s t} \rho(i, j)
$$

for $(s, i),(t, j) \in G^{\prime}$. In this case, the $G^{\prime}$-degree on a $\rho^{\prime}$-algebra is written by $|\cdot|^{\prime}$. We use these notations from now on.

Example 2.7. Suppose $V=\bigoplus_{i \in G} V_{i}$ is a $G$-graded vector space and $\rho$ is a commutation factor on $G$. The $\rho$-symmetric algebra $S_{\rho}^{\bullet} V:=\bigoplus_{k \geq 0} S_{\rho}^{k} V$ on $V$ is defined by

$$
S_{\rho}^{k} V:=V^{\otimes k} / I
$$

for $k \geq 0$ where $I$ is the two-sided ideal of $V^{\otimes k}$ generated by

$$
\{v \otimes w-\rho(|v|,|w|) w \otimes v \mid v, w \in V\} .
$$

This algebra is clearly a $\rho$-commutative algebra.
On the other hand, the $\rho$-antisymmetric algebra $\wedge_{\rho}^{\bullet} V:=\bigoplus_{k \geq 0} \wedge_{\rho}^{k} V$ on $V$, which is defined by

$$
\wedge_{\rho}^{k} V:=V^{\otimes k} / J
$$

for $k \geq 0$ where $J$ is the ideal generated by

$$
\{v \otimes w+\rho(|v|,|w|) w \otimes v \mid v, w \in V\},
$$

is not $\rho$-commutative. However, it is regarded as a $G^{\prime}$-graded $\rho^{\prime}$-commutative algebra if we consider a $G^{\prime}$-grading $|\omega|^{\prime}:=(k,|\omega|)$ for $\omega \in \wedge_{\rho}^{k} V$.

Example 2.8. Let $R$ be a usual commutative algebra over $\mathbb{K}$ and $x^{1}, \ldots$, $x^{m}$ be $G$-graded indeterminates. A well-known construction of formal power series

$$
R \llbracket x^{1}, \ldots, x^{m} \rrbracket:=\left\{\sum_{\mathbf{w} \in \mathbb{Z}_{\geq 0}^{\times m}} f_{\mathbf{w}} x^{\mathbf{w}} \mid f_{\mathbf{w}} \in R \text { for every } \mathbf{w}\right\},
$$

where $x^{\mathbf{w}}$ is a multi-index notation $x^{\mathbf{w}}:=\left(x^{1}\right)^{w_{1}}\left(x^{2}\right)^{w_{2}} \cdots\left(x^{m}\right)^{w_{m}}$ for $\mathbf{w}=$ $\left(w_{1}, w_{2}, \ldots, w_{m}\right) \in \mathbb{Z}_{\geq 0}^{\times m}$, does not provide a $\rho$-commutative algebra in general. It is a direct product of $G$-homogeneous subspaces

$$
R \llbracket x^{1}, \ldots, x^{m} \rrbracket=\prod_{i \in G} R \llbracket x^{1}, \ldots, x^{m} \rrbracket_{i},
$$

not a direct sum if $G$ is an infinite group. Here, for every $i \in G$,

$$
:=\left\{\begin{array}{l}
R \llbracket x^{1}, \ldots, x^{m} \rrbracket_{i} \\
\left.\sum_{\mathbf{w} \in \mathbb{Z}_{\geq 0}^{\times m}} f_{\mathbf{w}} x^{\mathbf{w}} \in R \llbracket x^{1}, \ldots, x^{m} \rrbracket| | x^{\mathbf{w}} \mid=i \text { for every } \mathbf{w}\right\} .
\end{array}\right.
$$

For this reason, we consider a direct sum

$$
R \llbracket x^{1}, \ldots, x^{m} \rrbracket_{\bullet}:=\bigoplus_{i \in G} R \llbracket x^{1}, \ldots, x^{m} \rrbracket_{i}
$$

rather than a direct product. This subspace $R \llbracket x^{1}, \ldots, x^{m} \rrbracket$ 。 of $R \llbracket x^{1}, \ldots, x^{m} \rrbracket$ is certainly a $\rho$-commutative algebra.

Definition 2.9. Let $G$ be an abelian group and $\rho: G \times G \rightarrow \mathbb{K}$ be a commutation factor. A $G$-graded vector space $\mathfrak{g}=\bigoplus_{i \in G} \mathfrak{g}_{i}$ over $\mathbb{K}$ is said to be a $\rho$-Lie algebra of degree $d \in G$ if it is equipped with a $\mathbb{K}$-bilinear map $[-,-]_{\rho}: \mathfrak{g} \times \mathfrak{g} \rightarrow \mathfrak{g}$ satisfying
(i) $|\mathfrak{g}|:=\left|[-,-]_{\rho}\right|=d$, that is, $\left|[f, g]_{\rho}\right|=|f|+|g|+d$,
(ii) $[f, g]_{\rho}=-\rho(|f|,|g|)[g, f]_{\rho} \quad(\rho$-antisymmetricity),
(iii) $[f,[g, h]]_{\rho}=[[f, g], h]_{\rho}+\rho(|f|+d,|g|+d)[g,[f, h]]_{\rho} \quad$ ( $\rho$-Jacobi identity) for all $f, g, h \in \mathfrak{g}$.

In particular, a $\rho$-Lie algebra $\mathfrak{g}$ of degree $d$ is said to be a $\rho$-Lie antialgebra if $\rho(d, d)=-1$.

A $\rho$-Lie algebra is originally introduced by Scheunert [15] as an " $\epsilon$ Lie algebra" and also known as a Lie colored algebra [12]. A $\rho$-commutative algebra also has another name as an $\epsilon$-commutative algebra [15], a colored algebra [14], or an almost commutative algebra [2, 4], etc.

Example 2.10. Any $G$-graded algebra $A$ with a commutation factor $\rho$ on $G$ becomes a $\rho$-Lie algebra of degree 0 by the $\rho$-commutator on $A$, which is a $\mathbb{K}$-bilinear map $[-,-]_{\rho}: A \times A \rightarrow A$ defined by

$$
[f, g]_{\rho}:=f g-\rho(|f|,|g|) g f
$$

for $f, g \in A$.
Example 2.11. Let $A=\bigoplus_{i \in G} A_{i}$ be a $\rho$-commutative algebra. A homomorphism $X: A \rightarrow A$ of degree $|X| \in G$ is called a $\rho$-derivation if

$$
X(f g)=(X f) g+\rho(|X|,|f|) f(X g)
$$

holds for all $f, g \in A$. The vector space consisting of all $\rho$-derivations on $A$ is denoted by $\rho \operatorname{Der}(A)$, which has a natural $G$-grading $\rho \operatorname{Der}(A)=$ $\bigoplus_{i \in G} \rho \operatorname{Der}(A)_{i}$ where

$$
\rho \operatorname{Der}(A)_{i}:=\{X \in \rho \operatorname{Der}(A)| | X \mid=i\}
$$

The space $\rho \operatorname{Der}(A)$ of $\rho$-derivations becomes a $\rho$-Lie algebra of degree 0 by the $\rho$-commutator

$$
[X, Y]_{\rho}(f)=X(Y f)-\rho(|X|,|Y|) Y(X f)
$$

Moreover, it has a structure of a well-defined left $A$-module

$$
(f X)(g):=f(X g) \quad(X \in \rho \operatorname{Der}(A), f, g \in A)
$$

by the $\rho$-commutativity of $A$.
Here we introduce a $\rho$-commutative version of a differential graded algebra or a Q-algebra 4].

Definition 2.12. A pair $(A, Q)$ is called a $\rho$-commutative $Q$-algebra (or $\rho$-Q-algebra for short) if
(i) $A$ is a $\rho$-commutative algebra, and $Q \in \rho \operatorname{Der}(A)$,
(ii) $\rho(|Q|,|Q|)=-1$,
(iii) $[Q, Q]_{\rho}(=2 Q \circ Q)=0$.

This derivation $Q$ is called a homological $\rho$-derivation.
Example 2.13. For any $\rho$-commutative algebra $A$, the pair $(A, 0)$ is a $\rho^{\prime}$ -Q-algebra. Note that we cannot simply say that $\rho(|Q|,|Q|)=-1$ because $G$ might not admit a commutation factor $\rho$ with $\rho(i, i)=-1$ for some $i \in G$. For example, any commutation factor on $\mathbb{Z} / 3 \mathbb{Z}$ is trivial.

Example 2.14. Let $\mathfrak{g}$ be an $n$-dimensional $G$-graded $\rho$-Lie algebra over $\mathbb{K}$. Take a basis $\left(e_{1}, e_{2}, \ldots, e_{m}\right)$ of $\mathfrak{g}$ and denote the structure constant by $\left\{\gamma_{a b}^{c}\right\}_{a, b, c}$, i.e. it satisfies

$$
\left[e_{a}, e_{b}\right]_{\rho}=\sum_{c=1}^{m} \gamma_{a b}^{c} e_{c}
$$

for all $1 \leq a, b \leq m$. Set $\Pi \mathfrak{g}^{*}:=\mathfrak{g}^{*}$ as a set, with a $G^{\prime}$-grading $|\xi|^{\prime}:=(1,|\xi|)$ for $\xi \in \Pi \mathfrak{g}^{*}$ where the $G$-grading on the vector space $\mathfrak{g}^{*}$ is a natural one induced by the $G$-grading $|\cdot|$ on $\mathfrak{g}$.

Then, the algebra $S_{\rho^{\prime}}^{\bullet}\left(\Pi \mathfrak{g}^{*}\right)$ has a homological $\rho^{\prime}$-derivation

$$
Q:=\frac{1}{2} \sum_{c=1}^{m} \gamma_{a b}^{c} \xi^{a} \xi^{b} \frac{\partial}{\partial \xi^{c}}
$$

where $\left(\xi^{1}, \xi^{2}, \ldots, \xi^{m}\right)$ is the dual basis of $\left(e_{1}, e_{2}, \ldots, e_{m}\right)$. In fact, the condition $[Q, Q]_{\rho}=0$ is equivalent to the $\rho$-Jacobi identity of the original bracket on $\mathfrak{g}$.

A $\rho$-commutative Q-algebra is a generalization of a Q -algebra in superalgebras. It is a special case where a $\rho$-commutative algebra $A$ is the one in Example 2.4.

## 3 The graded matrix algebras

Let $A$ be a $G$-graded $\rho$-commutative algebra. Assume $G$ is finitely generated.
Definition 3.1. Let $I=\left(i_{1}, i_{2}, \ldots, i_{n}\right) \in G^{\times n}$ and $J=\left(j_{1}, j_{2}, \ldots, j_{m}\right) \in$ $G^{\times m}$. We define the $A$-bimodule

$$
M(I \times J ; A):=\{(n \times m) \text {-matrices whose entries are in } A\}
$$

with $G$-grading $M(I \times J ; A)=\bigoplus_{d \in G} M_{d}(I \times J ; A)$ defined by

$$
M_{d}(I \times J ; A):=\left\{\begin{array}{l|l}
\left(f_{k, l}\right)_{k, l=1}^{n} \in M(I \times J ; A) & \begin{array}{c}
\left|f_{k, l}\right|=i_{k}-j_{l}+d \\
\text { for all } k \text { and } l
\end{array}
\end{array}\right\}
$$

The left and right actions by $A$ are defined by

$$
g F:=\left(\rho\left(i_{k},|g|\right) g f_{k, l}\right)_{k, l}, \quad F g:=\left(\rho\left(j_{l},|g|\right) f_{k, l} g\right)_{k, l}
$$

for all $g \in A$ and $F=\left(f_{k, l}\right)_{k, l} \in M(I \times J ; A)$.
For $I=J$, the $A$-bimodule $M(I \times I ; A)$, simply written as $M(I ; A)$, turns out to be an $A$-algebra.

The group consisting of invertible matrices of $G$-degree 0 is written as

$$
\mathrm{GL}_{0}(I ; A):=\left\{F \in M_{0}(I ; A) \mid F \text { is invertible }\right\} .
$$

Definition 3.2. Let $F=\left(f_{k, l}\right)_{k, l} \in M(I \times J ; A)$. The (super)transpose of $F$ is the matrix $F^{\top}=\left(g_{l, k}\right)_{l, k} \in M((-J) \times(-I) ; A)$ with

$$
g_{l, k}:=\rho\left(i_{k}, j_{l}-i_{k}\right) f_{k, l}
$$

where $-I:=\left(-i_{1}, \ldots,-i_{n}\right) \in G^{\times n}$ and $-J:=\left(-j_{1}, \ldots,-j_{m}\right) \in G^{\times m}$.
Now we introduce a $\rho$-commutative version of determinant by [6, 7]. Let $I=\left(i_{1}, i_{2}, \ldots, i_{n}\right) \in G^{\times n}$. $I$ is said to be even if $I \in\left(G_{0}\right)^{\times n}$, and odd if $I \in\left(G_{1}\right)^{\times n}$. Denote the set of all bijections from $I$ to $I$ by $\operatorname{Aut}(I)$.

Definition 3.3. Let $F=\left(f_{k, l}\right)_{k, l} \in M_{0}(I ; A)$. For each $1 \leq k \leq n$, let $t_{k}$ be an indeterminate with $\left|t_{k}\right|=i_{k}$.
(a) Suppose that $I$ is even. $\rho \operatorname{det}(F) \in A_{0}$ is defined as the unique element characterized by

$$
=\sum_{\sigma \in \operatorname{Aut}(I)} f_{1, \sigma(1)} t_{\sigma(1)} \cdot f_{2, \sigma(2)} t_{\sigma(2)} \cdots \cdots f_{n, \sigma(n)} t_{\sigma(n)}
$$

in $A \otimes_{\mathbb{K}} S_{\rho}^{\bullet}\left\langle t_{1}, t_{2}, \ldots, t_{n}\right\rangle$.
(b) Suppose that $I$ is odd. $\rho \operatorname{det}(F) \in A_{0}$ is defined as the unique element characterized by

$$
=\sum_{\sigma \in \operatorname{Aut}(I)} f_{1, \sigma(1)} t_{\sigma(1)} \wedge f_{2, \sigma(2)} t_{\sigma(2)} \wedge \cdots \wedge f_{n, \sigma(n)} t_{\sigma(n)}
$$

in $A \otimes_{\mathbb{K}} \wedge_{\rho}^{\bullet}\left\langle t_{1}, t_{2}, \ldots, t_{n}\right\rangle$.
We call $\rho \operatorname{det}(F)$ the $\rho$-determinant or the graded determinant of $F$ in both cases.

Lemma 3.4. Suppose that $I$ is even or odd. The map

$$
\rho \operatorname{det}: M_{0}(I ; A) \rightarrow A_{0}
$$

defined above satisfies the following properties.
(a) If $F \in M_{0}(I ; A)$ is invertible, then $\rho \operatorname{det}(F) \in\left(A_{0}\right)^{\times}$.
(b) $\rho \operatorname{det}(F G)=\rho \operatorname{det}(F) \rho \operatorname{det}(G)$ for all $F, G \in M_{0}(I ; A)$.
(c) Let $F=\left(\mathbf{f}_{k}\right)_{k}, G=\left(\mathbf{g}_{k}\right)_{k}, H=\left(\mathbf{h}_{k}\right)_{k} \in M_{0}(I ; A)$ in the row vector representation. Let $1 \leq k_{0} \leq n$. Suppose that $\mathbf{f}_{k_{0}}+\mathbf{g}_{k_{0}}=\mathbf{h}_{k_{0}}$ and $\mathbf{f}_{k}=\mathbf{g}_{k}=\mathbf{h}_{k}$ for all $k \neq k_{0}$. Then, $\rho \operatorname{det}(F)+\rho \operatorname{det}(G)=\rho \operatorname{det}(H)$.
(d) Let $F=\left(\mathbf{f}_{k}\right)_{k}, G=\left(\mathbf{g}_{k}\right)_{k} \in M_{0}(I ; A)$ in the row vector representation. Let $1 \leq k_{0} \leq n$ and $c \in A_{0}$. Suppose that $c \mathbf{f}_{k_{0}}=\mathbf{g}_{k_{0}}$ and $\mathbf{f}_{k}=\mathbf{g}_{k}$ for all $k \neq k_{0}$. Then, $c \cdot \rho \operatorname{det}(F)=\rho \operatorname{det}(G)$.
(e) Let $F=\left(\mathbf{f}_{k}\right)_{k} \in M_{0}(I ; A)$ in the row vector representation. Suppose that $\mathbf{f}_{k}=\mathbf{f}_{l}$ for some $1 \leq k<l \leq n$. Then, $\rho \operatorname{det}(F)=0$.

Proof. See [6, 7].
In fact, you can define the $\rho$-determinant of a matrix of non-zero $G$-degree and find that the similar properties hold. However, we do not need it for discussions from here on. For more details, see [6, 7].

Lemma 3.5. Suppose that $I$ is even or odd. Let $F=\left(f_{k, l}\right)_{k, l}=\left(\mathbf{f}_{k}\right)_{k} \in$ $M(I ; A)$. Let $\varepsilon$ be an indeterminate of $G$-degree $-|F|$. Then, as a matrix over $A \otimes_{\mathbb{K}} \mathbb{K}[\varepsilon] /\left(\varepsilon^{2}\right)$, we have

$$
\rho \operatorname{det}(1+\varepsilon F)=1+\operatorname{tr}(\varepsilon F)
$$

Proof. Expand $\rho \operatorname{det}(1+\varepsilon F)$ by using properties of the $\rho$-determinant. If a matrix has two or more rows whose entries are all factored by $\varepsilon$, then the $\rho$-determinant of the matrix is 0 by the definition, i.e.,

$$
\rho \operatorname{det}\left(\begin{array}{c}
\vdots \\
\rho\left(i_{k},|\varepsilon|\right) \varepsilon \mathbf{f}_{k} \\
\vdots \\
\rho\left(i_{l},|\varepsilon|\right) \varepsilon \mathbf{f}_{l} \\
\vdots
\end{array}\right)=0
$$

Hence, setting row vectors $\mathbf{f}_{k}^{\prime}:=\rho\left(i_{k},|\varepsilon|\right) \varepsilon \mathbf{f}_{k}$ and $\mathbf{e}_{k}:=\left(\delta_{k, l}\right)_{l}$, we see that

$$
\begin{aligned}
& \rho \operatorname{det}(1+\varepsilon F) \\
= & \rho \operatorname{det}(1)+\rho \operatorname{det}\left(\begin{array}{c}
\mathbf{f}_{1}^{\prime} \\
\mathbf{e}_{2} \\
\vdots \\
\mathbf{e}_{n}
\end{array}\right)+\rho \operatorname{det}\left(\begin{array}{c}
\mathbf{e}_{1} \\
\mathbf{f}_{2}^{\prime} \\
\vdots \\
\mathbf{e}_{n}
\end{array}\right)+\cdots+\rho \operatorname{det}\left(\begin{array}{c}
\mathbf{e}_{1} \\
\mathbf{e}_{2} \\
\vdots \\
\mathbf{f}_{n}^{\prime}
\end{array}\right) \\
= & 1+\rho\left(i_{1},|\varepsilon|\right) \varepsilon f_{1,1}+\rho\left(i_{2},|\varepsilon|\right) \varepsilon f_{2,2}+\cdots+\rho\left(i_{n},|\varepsilon|\right) \varepsilon f_{n, n} .
\end{aligned}
$$

This lemma is considered as an infinitesimal version of a relation between the determinant of the exponential and the exponential of the trace.

Then, we introduce a $\rho$-commutative version of Berezinian. Let $I=$ $\left(i_{1}, \ldots, i_{n}, i_{n+1}, \ldots, i_{n+m}\right) \in\left(G_{0}\right)^{\times n} \times\left(G_{1}\right)^{\times m}$.

Definition 3.6. Let $F=\left(f_{k, l}\right)_{k, l} \in M_{0}(I ; A)$. Suppose that $F$ is written in the block matrix

$$
F=\left(\begin{array}{ll}
F_{00} & F_{01} \\
F_{10} & F_{11}
\end{array}\right)
$$

so that $F_{00} \in M_{0}\left(\left(i_{1}, \ldots, i_{n}\right), A\right)$. Define

$$
\rho \operatorname{Ber}(F):=\left\{\begin{array}{r}
\rho \operatorname{det}\left(F_{00}-F_{01} F_{11}^{-1} F_{10}\right) \cdot \rho \operatorname{det}\left(F_{11}\right)^{-1} \\
\text { if both } F_{00} \text { and } F_{11} \text { are invertible }, \\
0 \quad \text { otherwise }
\end{array}\right.
$$

We call $\rho \operatorname{Ber}(F)$ the $\rho$-Berezinian or the graded Berezinian of $F$.

## Proposition 3.7.

(i) $\rho \operatorname{Ber}(F G)=(\rho \operatorname{Ber} F)(\rho \operatorname{Ber} G)$ for all $F, G \in \mathrm{GL}_{0}(I ; A)$.
(ii) $\rho \operatorname{Ber} F=\left(\rho \operatorname{det} F_{00}\right) \rho \operatorname{det}\left(F_{11}-F_{10} F_{00}^{-1} F_{01}\right)^{-1}$ for all $F \in \mathrm{GL}_{0}(I ; A)$.
(iii) $\rho \operatorname{Ber}\left(F^{\top}\right)=\rho \operatorname{Ber} F$ for all $F \in \operatorname{GL}_{0}(I ; A)$.
(iv) Suppose that $I$ is even and $J$ is odd. Then, we have

$$
\begin{aligned}
& \rho \operatorname{Ber}\left(\begin{array}{cc|cc}
E_{00} & 0 & F_{00} & 0 \\
E_{10} & E_{11} & F_{10} & F_{11} \\
\hline G_{00} & 0 & H_{00} & 0 \\
G_{10} & G_{11} & H_{10} & H_{11}
\end{array}\right)\left(=: \rho \operatorname{Ber}\left(\begin{array}{cc}
E & F \\
G & H
\end{array}\right)\right) \\
= & \rho \operatorname{Ber}\left(\begin{array}{cc}
E_{00} & F_{00} \\
G_{00} & H_{00}
\end{array}\right) \rho \operatorname{Ber}\left(\begin{array}{cc}
E_{11} & F_{11} \\
G_{11} & H_{11}
\end{array}\right)
\end{aligned}
$$

for $E \in \operatorname{GL}_{0}(I ; A), F \in M_{0}(I \times J ; A), G \in M_{0}(J \times I ; A)$, and $H \in$ $\mathrm{GL}_{0}(J ; A)$.

Proof. See [7] for (i). (ii), (iii), and (iv) are shown by straightforward computations.

Definition 3.8. Let $F=\left(f_{k, l}\right)_{k, l} \in M(I ; A)$. Define

$$
\rho \operatorname{tr}(F):=\sum_{k=1}^{n+m} \rho\left(\left|i_{k}\right|+|F|,\left|i_{k}\right|\right) f_{k, k} .
$$

We call $\rho \operatorname{tr}(F)$ the $\rho$-trace or the graded trace of $F$.
Lemma 3.9. Let $F \in M(I ; A)$. Let $\varepsilon$ be an indeterminate of $G$-degree $-|F|$. Then, as a matrix over $A \otimes_{\mathbb{K}} \mathbb{K}[\varepsilon] /\left(\varepsilon^{2}\right)$, we have

$$
\rho \operatorname{Ber}(1+\varepsilon F)=1+\rho \operatorname{tr}(\varepsilon F) .
$$

Proof. We use the same notation as in Definition 3.6. Note that $1+\varepsilon F_{11}$ is invertible in $A \otimes_{\mathbb{K}} \mathbb{K}[\varepsilon] /\left(\varepsilon^{2}\right)$, and that $\left(1+\varepsilon F_{11}\right)^{-1}=1-\varepsilon F_{11}$. Since $I$ is even and $J$ is odd, we can apply Lemma 3.5 to $F_{00}$ and $F_{11}$. Then we obtain

$$
\begin{aligned}
& \rho \operatorname{Ber}(1+\varepsilon F) \\
= & \rho \operatorname{det}\left(\left(1+\varepsilon F_{00}\right)-\left(\varepsilon F_{01}\right)\left(1+\varepsilon F_{11}\right)^{-1}\left(\varepsilon F_{10}\right)\right) \rho \operatorname{det}\left(1+\varepsilon F_{11}\right)^{-1} \\
= & \rho \operatorname{det}\left(1+\varepsilon F_{00}-\varepsilon F_{01}\left(1-\varepsilon F_{11}\right) \varepsilon F_{10}\right) \rho \operatorname{det}\left(1-\varepsilon F_{11}\right) \\
= & \rho \operatorname{det}\left(1+\varepsilon F_{00}\right) \rho \operatorname{det}\left(1-\varepsilon F_{11}\right) \\
= & \left(1+\operatorname{tr}\left(\varepsilon F_{00}\right)\right)\left(1-\operatorname{tr}\left(\varepsilon F_{11}\right)\right) \\
= & 1+\operatorname{tr}\left(\varepsilon F_{00}\right)-\operatorname{tr}\left(\varepsilon F_{11}\right)=1+\rho \operatorname{tr}(\varepsilon F) .
\end{aligned}
$$

## $4 \rho$-commutative functions

In this section, we discuss the $G$-graded $\rho$-commutative algebra

$$
\mathscr{O}_{\rho}(U):=\mathscr{O}(U) \llbracket x^{n+1}, \ldots, x^{n+m} \rrbracket
$$

with $x^{1}, \ldots, x^{n}$ being coordinates on a neighbourhood $U$ of a manifold. This algebra corresponds to the space of local functions on a $\rho$-manifold to be defined in the next section. We call $x^{1}, \ldots, x^{n}$ together with $x^{n+1}, \ldots, x^{n+m}$ coordinate functions on $U$. This algebra consists of elements of the form

$$
f=\sum_{\substack{\mathbf{w} \in \mathbb{Z}_{\geq 0}^{\times m}}} f_{\mathbf{w}} x^{\mathbf{w}}
$$

where each $\mathbf{w}=\left(w_{1}, w_{2}, \ldots, w_{m}\right) \in \mathbb{Z}_{\geq 0}^{\times m}$ is a multi-index notation with

$$
x^{\mathbf{w}}=\left(x^{n+1}\right)^{w_{1}}\left(x^{n+2}\right)^{w_{2}} \cdots\left(x^{n+m}\right)^{w_{m}},
$$

and $f_{\mathrm{w}} \in \mathscr{O}(U)$. Since $\left(x^{n+b}\right)^{2}=0$ if $x^{n+b}$ is odd, we always assume that $f_{\mathbf{w}}=0$ if there is $1 \leq b \leq m$ such that $x^{n+b}$ is odd and $w_{b} \geq 2$. If $f$ is assumed to be homogeneous of degree $i \in G$, then we suppose $f_{\mathbf{w}}=0$ unless $\left|x^{\mathbf{w}}\right|=i$.

We denote by $\mathscr{I}$ the two-sided ideal of $\mathscr{O}_{\rho}(U)$ generated by the set $\left\{x^{n+1}\right.$, $\left.\ldots, x^{n+m}\right\}$. Namely, $\mathscr{I}$ consists of all formal power series in $x^{n+1}, \ldots, x^{n+m}$ without terms of polynomial degree 0 , with coefficients in $\mathscr{O}(U)$.
Lemma 4.1. Let $D$ be a $\rho$-derivation on $\mathscr{O}_{\rho}(U)$. Then, for every function $f=\sum_{\mathbf{w}} f_{\mathbf{w}} x^{\mathbf{w}} \in \mathscr{O}_{\rho}(U)$, the equation

$$
D(f)=\sum_{\mathbf{w}} D\left(f_{\mathbf{w}} x^{\mathbf{w}}\right)
$$

holds.

Proof. The proof is almost same as the case of usual formal power series. By definition, we have $D\left(\mathscr{I}^{2}\right) \subset \mathscr{I}$ and then $D\left(\mathscr{I}^{k+1}\right) \subset \mathscr{I}^{k}$ for all $k \geq 1$. Then $D$ induces the well-defined derivation

$$
D: \mathscr{O}_{\rho}(U) / \mathscr{I}^{k+1} \rightarrow \mathscr{O}_{\rho}(U) / \mathscr{I}^{k}
$$

Let $f=\sum_{\left|x^{\mathbf{w}}\right|=i} f_{\mathbf{w}} x^{\mathbf{w}} \in \mathscr{O}_{\rho}(U)_{i}$. Set $g:=\sum_{\left|x^{\mathbf{w}}\right|=i} D\left(f_{\mathbf{w}} x^{\mathbf{w}}\right)$. This $g$ is a well-defined formal power series because $D\left(\mathscr{I}^{k+1}\right) \subset \mathscr{I}^{k}$ implies that each monomial of $g$ only depends on $D\left(f_{\mathbf{w}} x^{\mathbf{w}}\right)$ in finitely many w. In $\mathscr{O}_{\rho}(U) / \mathscr{I}^{k}$, we have

$$
\begin{aligned}
& D\left(f+\mathscr{I}^{k+1}\right)-\left(g+\mathscr{I}^{k}\right) \\
= & D\left(\sum_{\left|x^{\mathbf{w}}\right|=i,|\mathbf{w}| \leq k} f_{\mathbf{w}} x^{\mathbf{w}}+\mathscr{I}^{k+1}\right)-\left(\sum_{\left|x^{\mathbf{w}}\right|=i,|\mathbf{w}| \leq k} D\left(f_{\mathbf{w}} x^{\mathbf{w}}\right)+\mathscr{I}^{k}\right) \\
= & D\left(\sum_{\left|x^{\mathbf{w}}\right|=i,|\mathbf{w}| \leq k} f_{\mathbf{w}} x^{\mathbf{w}}\right)-\sum_{\left|x^{\mathbf{w}}\right|=i,|\mathbf{w}| \leq k} D\left(f_{\mathbf{w}} x^{\mathbf{w}}\right)+\mathscr{I}^{k} \\
= & 0+\mathscr{I}^{k},
\end{aligned}
$$

where $|\mathbf{w}|:=\sum_{l=1}^{m} w_{l}$ for $\mathbf{w} \in \mathbb{Z}_{\geq 0}^{\times m}$. Thus, $D(f)-g \in \mathscr{I}^{k}$ for all $k \geq 1$. Since $\bigcap_{k \geq 1} \mathscr{I}^{k}=\{0\}$, we conclude that $D(f)=g$.

Lemma 4.1 implies that any $\rho$-derivation on $\mathscr{O}_{\rho}(U)$ is uniquely determined by its action on the generators $x^{1}, x^{2}, \ldots, x^{n+m}$. We denote by $\frac{\partial}{\partial x^{1}}, \frac{\partial}{\partial x^{2}}$, $\ldots, \frac{\partial}{\partial x^{n+m}}$ the $\rho$-derivations on $\mathscr{O}_{\rho}(U)$ which satisfies $\frac{\partial}{\partial x^{a}}\left(x^{b}\right)=\delta_{a, b}$ for all $1 \leq a, b \leq n+m$.

Lemma 4.2. Let $f \in \mathscr{O}_{\rho}(U)$ and $X \in \rho \operatorname{Der}\left(\mathscr{O}_{\rho}(U)\right)$. Let $\varepsilon$ be an indeterminate with $|\varepsilon|=-|X|$. For a coordinate $x=\left(x^{a}\right)_{a}$ on $U$, in $\mathscr{O}_{\rho}(U) \otimes \mathbb{K} \llbracket \rrbracket \rrbracket /\left(\varepsilon^{2}\right)$, it holds that

$$
f\left(\left(x^{a}+\varepsilon X^{a}\right)_{a}\right)=f(x)+\varepsilon \sum_{a=1}^{n+m} X^{a} \frac{\partial f}{\partial x^{a}}
$$

where $X=\sum_{a} X^{a} \frac{\partial}{\partial x^{a}}$.
Proof. For each $f_{\mathbf{w}} \in \mathscr{O}(U)$, we have

$$
\begin{aligned}
f_{\mathbf{w}}\left(\left(x^{a}+\varepsilon X^{a}\right)_{a}\right) & =\sum_{\mathbf{v} \in \mathbb{Z}_{\geq 0}^{\times n}} \frac{1}{\mathbf{v}!} \frac{\partial f_{\mathbf{w}}}{\partial x^{\mathbf{v}}}\left(\varepsilon X^{1}\right)^{v_{1}}\left(\varepsilon X^{2}\right)^{v_{2}} \cdots\left(\varepsilon X^{n}\right)^{v_{n}} \\
& =f_{\mathbf{w}}+\varepsilon \sum_{a=1}^{n} X^{a} \frac{\partial f_{\mathbf{w}}}{\partial x^{a}} .
\end{aligned}
$$

For each monomial $x^{\mathbf{w}}$, we have

$$
\begin{aligned}
& \left(x^{n+1}+\varepsilon X^{n+1}\right)^{w_{1}} \cdots\left(x^{n+m}+\varepsilon X^{n+m}\right)^{w_{m}} \\
= & x^{n+1} \cdots x^{n+m}+\sum_{b=1}^{m} x^{n+1} \cdots x^{n+b-1} \varepsilon X^{n+b} x^{n+b+1} \cdots x^{n+m} \\
= & x^{n+1} \cdots x^{n+m}+\varepsilon \sum_{b=1}^{m} X^{b} \frac{\partial}{\partial x^{n+b}}\left(x^{n+1} \cdots x^{n+m}\right) .
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
& f\left(\left(x^{a}+\varepsilon X^{a}\right)_{a}\right) \\
= & \sum_{\mathbf{w}}\left(f_{\mathbf{w}}+\varepsilon \sum_{a=1}^{n} X^{a} \frac{\partial f_{\mathbf{w}}}{\partial x^{a}}\right) \\
& \cdot\left(x^{n+1} \cdots x^{n+m}+\varepsilon \sum_{b=1}^{m} X^{n+b} \frac{\partial}{\partial x^{n+b}}\left(x^{n+1} \cdots x^{n+m}\right)\right) \\
= & \sum_{\mathbf{w}}\left(f_{\mathbf{w}} x^{n+1} \cdots x^{n+m}+\varepsilon \sum_{a=1}^{n+m} X^{a} \frac{\partial}{\partial x^{a}}\left(f_{\mathbf{w}} x^{n+1} \cdots x^{n+m}\right)\right) \\
= & f+\varepsilon \sum_{a=1}^{n+m} X^{a} \frac{\partial f}{\partial x^{a}} .
\end{aligned}
$$

Now, we prepare the exponential function and the logarithmic function. They are defined only for functions of $G$-degree 0 . However, they satisfy desired properties and differential equations.

Definition 4.3. For $f=f_{0}+f_{1} \in \mathscr{O}_{\rho}(U)_{0}$ with $f_{0} \in \mathscr{O}(U)$ and $f_{1} \in \mathscr{I}$, define

$$
\exp f:=\exp f_{0} \cdot \sum_{k=0}^{\infty} \frac{1}{k!}\left(f_{1}\right)^{k}
$$

Definition 4.4. Let $f \in \mathscr{O}_{\rho}(U)_{0}^{\times}$. Set $f=: f_{0}(1+h)$ where $f_{0} \in \mathscr{O}(U)^{\times}$ and $h \in \mathscr{I}$. Define

$$
\log f:=\log f_{0}+\sum_{k=1}^{\infty} \frac{(-1)^{k-1}}{k} h^{k} .
$$

as long as $\log f_{0}$ makes sense.
In the real category, $\log f$ is defined if $f_{0}$ values in strictly positive number. In the complex category, $\log f$ is defined if $f_{0}$ values in a simply connected domain in $\mathbb{C}$, and if $\log f_{0}$ is one branch of logarithm.

Proposition 4.5. For all $f, g \in \mathscr{O}_{\rho}(U)_{0}$, the following properties hold.
(i) $\exp (f+g)=\exp f \cdot \exp g$.
(ii) $\frac{\partial}{\partial x^{a}}(\exp f)=\frac{\partial f}{\partial x^{a}} \exp f$ for every $1 \leq a \leq m+n$.

Proof. We use the same notation in Definition 4.3. Since both $f_{1}$ and $g_{1}$ have $G$-degree $0, \mathbb{K} \llbracket f_{1}, g_{1} \rrbracket$ is regarded as a usual commutative formal power series with two indeterminates. For (i), we have

$$
\begin{aligned}
\exp f \cdot \exp g & =\exp \left(f_{0}\right) \exp \left(g_{0}\right)\left(\sum_{k=0}^{\infty} \frac{1}{k!} f_{1}^{k}\right)\left(\sum_{k=0}^{\infty} \frac{1}{k!} g_{1}^{k}\right) \\
& =\exp \left(f_{0}+g_{0}\right)\left(\sum_{k=0}^{\infty} \frac{1}{k!}\left(f_{1}+g_{1}\right)^{k}\right) \\
& =\exp (f+g) .
\end{aligned}
$$

For (ii), we have

$$
\begin{aligned}
& \frac{\partial}{\partial x^{a}}(\exp f) \\
= & \left(\exp f_{0}\right) \frac{\partial f_{0}}{\partial x^{a}} \sum_{k=0}^{\infty} \frac{1}{k!}\left(f_{1}\right)^{k}+\left(\exp f_{0}\right) \sum_{k=1}^{\infty} \frac{1}{(k-1)!} \frac{\partial f_{1}}{\partial x^{a}}\left(f_{1}\right)^{k-1} \\
= & \left(\exp f_{0}\right)\left(\frac{\partial f_{0}}{\partial x^{a}}+\frac{\partial f_{1}}{\partial x^{a}}\right) \sum_{k=0}^{\infty} \frac{1}{k!}\left(f_{1}\right)^{k}=\frac{\partial f}{\partial x^{a}} \exp f .
\end{aligned}
$$

Proposition 4.6. For all $f, g \in \mathscr{O}_{\rho}(U)_{0}^{\times}$, the following properties hold as long as both sides make sense.
(i) $\log (f g)=\log f+\log g$.
(ii) $\frac{\partial}{\partial x^{a}}(\log f)=\frac{\partial f}{\partial x^{a}} \frac{1}{f}$ for every $1 \leq a \leq m+n$.

Proof. The proof is similar to Proposition 4.5.

## $5 \rho$-manifolds

In this section, we define $\rho$-manifolds by the analogy with supermanifolds or other graded manifolds (e.g. [1, 16]).

Definition 5.1. Let $G$ be an abelian group and $\rho$ be a commutation factor on $G$. A $\rho$-manifold is a ringed space $\left(M, \mathscr{O}_{\rho}\right)$ such that
(i) its underlying space $M$ is a connected $n$-dimensional manifold,
(ii) there is an open covering $\left\{U_{\alpha}\right\}_{\alpha}$ of $M$ which has a smooth coordinate $\left\{\left(x_{\alpha}^{1}, x_{\alpha}^{2}, \ldots, x_{\alpha}^{n}\right)\right\}_{\alpha}$ and a family

$$
\left\{\left(x_{\alpha}^{n+1}, x_{\alpha}^{n+2}, \ldots, x_{\alpha}^{n+m}\right) \in\left(\mathscr{O}_{\rho}\left(U_{\alpha}\right)\right)^{\times m}\right\}_{\alpha}
$$

with

$$
\mathscr{O}_{\rho}(U) \cong \mathscr{O}(U) \llbracket x_{\alpha}^{n+1}, x_{\alpha}^{n+2}, \ldots, x_{\alpha}^{n+m} \rrbracket
$$

We call each open set $U_{\alpha}$ and tuple of local functions $\left(x_{\alpha}^{1}, x_{\alpha}^{2}, \ldots, x_{\alpha}^{n+m}\right)$, a coordinate neighbourhood and its coordinate functions, respectively.

Remark 5.2. Since $M$ is connected, a tuple of degrees

$$
\left(\left|x_{\alpha}^{n+1}\right|,\left|x_{\alpha}^{n+2}\right|, \ldots,\left|x_{\alpha}^{n+m}\right|\right) \in G^{\times m}
$$

is constant on indices $\alpha$ up to permutations of components. Hence, we may replace $G$ with its subgroup finitely generated by $\left|x_{\alpha}^{n+1}\right|,\left|x_{\alpha}^{n+2}\right|, \ldots,\left|x_{\alpha}^{n+m}\right|$ for some index $\alpha$. We choose an index $\alpha$ and assume that all coordinate functions $y=\left(y^{1}, \ldots, y^{m+n}\right)$ satisfy $I:=\left(\left|x_{\alpha}^{1}\right|, \ldots,\left|x_{\alpha}^{n+m}\right|\right)=\left(\left|y^{1}\right|, \ldots,\left|y^{n+m}\right|\right)$.

Definition 5.3. For a $\rho$-manifold ( $M, \mathscr{O}_{\rho}$ ), we define

$$
\operatorname{Vect}_{\rho}(M):=\rho \operatorname{Der}\left(\mathscr{O}_{\rho}(M)\right),
$$

and we call its element a vector field on ( $M, \mathscr{O}_{\rho}$ ).
On the intersection of coordinates $x=\left(x^{a}\right)_{a}$ on $U$ and $y=\left(y^{a}\right)_{a}$ on $V$, the Jacobian matrix $J_{x y}$ is defined by

$$
J_{x y}:=\left(\frac{\partial y^{a}}{\partial x^{b}}\right)_{a, b}=\left(\begin{array}{ccc}
\frac{\partial y^{1}}{\partial x^{1}} & \cdots & \frac{\partial y^{1}}{\partial x^{n+m}} \\
\vdots & \ddots & \vdots \\
\frac{\partial y^{n+m}}{\partial x^{1}} & \cdots & \frac{\partial y^{n+m}}{\partial x^{n+m}}
\end{array}\right) \in \operatorname{GL}_{0}\left(I ; \mathscr{O}_{\rho}(U \cap V)\right) .
$$

Proposition 5.4. For a $\rho$-manifold $M$ and its coordinate $\left(x^{a}\right)_{a}$ on $U$, there exist the unique $\rho$-derivations $\frac{\partial}{\partial x^{1}}, \ldots, \frac{\partial}{\partial x^{n+m}}$ on $\mathscr{O}_{\rho}(U)$ with
(i) $\frac{\partial}{\partial x^{a}}\left(x^{b}\right)=\delta_{a, b}$ for all $1 \leq a, b \leq m+n$,
(ii) $\operatorname{Vect}_{\rho}(U) \cong\left\langle\frac{\partial}{\partial x^{1}}, \ldots, \frac{\partial}{\partial x^{n+m}}\right\rangle$ as $\mathscr{O}_{\rho}(U)$-modules,
(iii) as a $\mathbb{K}$-linear map $\mathscr{O}_{\rho}(U) \rightarrow \mathscr{O}_{\rho}(U)$,

$$
\frac{\partial}{\partial x^{a}} \frac{\partial}{\partial x^{b}}=\rho\left(-\left|x^{a}\right|,-\left|x^{b}\right|\right) \frac{\partial}{\partial x^{b}} \frac{\partial}{\partial x^{a}} \quad(1 \leq a, b \leq n+m),
$$

(iv) on the intersection of $U$ with a coordinate $x=\left(x^{a}\right)_{a}$ and $V$ with another coordinate $y=\left(y^{a}\right)_{a}$,

$$
\frac{\partial}{\partial x^{b}}=\sum_{a=1}^{n+m} \frac{\partial y^{a}}{\partial x^{b}} \frac{\partial}{\partial y^{a}} \quad(1 \leq b \leq n+m)
$$

Proof. We define $\frac{\partial}{\partial x^{a}}$ by extending (i) as a $\rho$-derivation on $\mathscr{O}_{\rho}(U)$.
To see (ii), let $X \in \operatorname{Vect}_{\rho}(U)$ and set $\widetilde{X}:=\sum_{a=1}^{n+m} X\left(x^{a}\right) \frac{\partial}{\partial x^{a}}$. Clearly, $X\left(x^{a}\right)=\widetilde{X}\left(x^{a}\right)$ and $X\left(\left(x^{a}\right)^{k}\right)=\widetilde{X}\left(\left(x^{a}\right)^{k}\right)$. From the result for derivations on $\mathscr{O}(M)$, it also holds that $X(g)=\widetilde{X}(g)$ for $g \in \mathscr{O}(U)$. For any function $f=\sum_{\mathbf{w}} f_{\mathbf{w}} x^{\mathbf{w}}$, we have

$$
\begin{aligned}
& (X-\widetilde{X})(f) \\
= & \sum_{\mathbf{w}}(X-\widetilde{X})\left(f_{\mathbf{w}}\right) x^{\mathbf{w}} \\
& +\sum_{\mathbf{w}} f_{\mathbf{w}} \sum_{b=1}^{m} \rho_{\mathbf{w}, b}\left(x^{n+1}\right)^{w_{1}} \cdots(X-\widetilde{X})\left(\left(x^{n+b}\right)^{w_{b}}\right) \cdots\left(x^{n+m}\right)^{w_{m}} \\
= & 0
\end{aligned}
$$

where $\rho_{\mathbf{w}, b}$ is some constant determined from the commutation between the derivation $X-\widetilde{X}$ and $\left(x^{n+c}\right)^{w_{c}}$ for $c<b$.
(iii) is proved by a direct computation. It is enough to show for $n+1 \leq$ $a<b \leq n+m$.

For (iv), let $f=\sum_{\mathbf{w}} f_{\mathbf{w}} y^{\mathbf{w}}$. It holds that

$$
\sum_{a=1}^{n} \frac{\partial y^{a}}{\partial x^{b}} \frac{\partial f_{\mathbf{w}}}{\partial y^{a}}=\frac{\partial f_{\mathbf{w}}}{\partial x^{b}}
$$

because if $1 \leq b \leq n$ then it is just a chain rule for the underlying manifold $M$, and if $n+1 \leq b \leq n+m$ then both sides are 0 . It also holds that

$$
\begin{aligned}
& \sum_{c=1}^{m} \frac{\partial y^{n+c}}{\partial x^{b}} \frac{\partial y^{\mathbf{w}}}{\partial y^{n+c}} \\
= & \sum_{c=1}^{m} \rho\left(-\left|x^{b}\right|, \sum_{c^{\prime}=1}^{a-1} w_{c^{\prime}}\left|y^{n+c^{\prime}}\right|\right)\left(y^{n+1}\right)^{w_{1}} \cdots\left(y^{n+c-1}\right)^{w_{c-1}} \\
= & \frac{\partial y^{\mathbf{w}}}{\partial x^{b}}
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
\sum_{a=1}^{n+m} \frac{\partial y^{a}}{\partial x^{b}} \frac{\partial}{\partial y^{a}}(f) & =\sum_{\mathbf{w}}\left(\sum_{a=1}^{n+m} \frac{\partial y^{a}}{\partial x^{b}} \frac{\partial f_{\mathbf{w}}}{\partial y^{a}} y^{\mathbf{w}}+\sum_{a=1}^{n+m} \frac{\partial y^{a}}{\partial x^{b}} f_{\mathbf{w}} \frac{\partial y^{\mathbf{w}}}{\partial y^{a}}\right) \\
& =\sum_{\mathbf{w}}\left(\sum_{a=1}^{n} \frac{\partial y^{a}}{\partial x^{b}} \frac{\partial f_{\mathbf{w}}}{\partial y^{a}} y^{\mathbf{w}}+\sum_{a=n+1}^{n+m} \frac{\partial y^{a}}{\partial x^{b}} f_{\mathbf{w}} \frac{\partial y^{\mathbf{w}}}{\partial y^{a}}\right) \\
& =\sum_{\mathbf{w}}\left(\frac{\partial f_{\mathbf{w}}}{\partial x^{b}} y^{\mathbf{w}}+f_{\mathbf{w}} \frac{\partial y^{\mathbf{w}}}{\partial x^{b}}\right)=\frac{\partial f}{\partial x^{b}} .
\end{aligned}
$$

Definition 5.5. A vector bundle $E$ on a $\rho$-manifold ( $M, \mathscr{O}_{\rho}$ ) of rank $r$ is a locally free $\mathscr{O}_{\rho}$-module $\Gamma(-, E)$ of rank $r$. In other words, the sheaf $\Gamma(-, E)$ satisfies the following conditions.
(i) There is a tuple $I=\left(i_{1}, \ldots, i_{r}\right) \in G^{\times r}$.
(ii) There is an open covering $\left\{V_{\alpha}\right\}_{\alpha}$ of $M$ which forms an atlas $\left\{\left(x_{\alpha}^{1}, \ldots\right.\right.$, $\left.\left.x_{\alpha}^{n+m}\right)\right\}_{\alpha}$ on $\left(M, \mathscr{O}_{\rho}\right)$ and satisfies $\Gamma\left(V_{\alpha}, E\right) \cong\left\langle e_{1}^{\alpha}, \ldots, e_{r}^{\alpha}\right\rangle$ as $\mathscr{O}_{\rho}\left(V_{\alpha}\right)$ modules with $\left(\left|e_{1}^{\alpha}\right|, \ldots,\left|e_{r}^{\alpha}\right|\right)=-I$.
(iii) On the intersection $V_{\alpha \beta}:=V_{\alpha} \cap V_{\beta}$, there exists a matrix $g_{\alpha \beta} \in$ $G L_{0}\left(I ; \mathscr{O}_{\rho}\left(V_{\alpha \beta}\right)\right)$, called the transition functions or the transition rules, such that the transformation between $\left(e_{k}^{\alpha}\right)_{k}$ and $\left(e_{l}^{\beta}\right)_{l}$ has the matrix representation

$$
\left(e_{1}^{\alpha}\left|V_{\alpha \beta} \cdots e_{r}^{\alpha}\right|_{V_{\alpha \beta}}\right)=\left(e_{1}^{\beta}\left|V_{\alpha \beta} \cdots e_{r}^{\beta}\right|_{V_{\alpha \beta}}\right) g_{\alpha \beta} .
$$

Moreover, the family of transition functions $\left\{g_{\alpha \beta}\right\}_{V_{\alpha \beta} \neq \varnothing}$ satisfies the cocycle condition

$$
\begin{array}{cl}
g_{\alpha \alpha}=1 & \text { for all } \alpha, \text { and } \\
g_{\alpha \beta} g_{\beta \gamma} g_{\gamma \alpha}=1 & \text { for all } \alpha, \beta, \gamma \text { with } V_{\alpha} \cap V_{\beta} \cap V_{\gamma} \neq \varnothing
\end{array}
$$

In this case, setting the dual of $e_{k}^{\alpha}$ as $\xi_{\alpha}^{k}$ for each $k$, the sheaf $\mathscr{E}$ defined by

$$
\mathscr{E}\left(V_{\alpha}\right):=\mathscr{O}\left(V_{\alpha}\right) \llbracket x_{\alpha}^{n+1}, \ldots, x_{\alpha}^{n+m}, \xi_{\alpha}^{1}, \ldots, \xi_{\alpha}^{r} \rrbracket \bullet
$$

forms a $\rho$-manifold. We call $\xi_{\alpha}^{1}, \ldots, \xi_{\alpha}^{r}$ the linear coordinates on $E$. They are transformed as

$$
\left(\begin{array}{c}
\left.\xi_{\beta}^{1}\right|_{V_{\alpha \beta}} \\
\vdots \\
\left.\xi_{\beta}^{r}\right|_{V_{\alpha \beta}}
\end{array}\right)=g_{\alpha \beta}\left(\begin{array}{c}
\left.\xi_{\alpha}^{1}\right|_{V_{\alpha \beta}} \\
\vdots \\
\left.\xi_{\alpha}^{r}\right|_{V_{\alpha \beta}}
\end{array}\right) .
$$

Example 5.6. Let $\left(M, \mathscr{O}_{\rho}\right)$ be a $\rho$-manifold. The tangent bundle of $M$ is a vector bundle $T M$ over $M$ defined by the linear coordinates $\left(\partial_{x}^{1}\right)^{*}, \ldots,\left(\partial_{x}^{n+m}\right)^{*}$ for each coordinate $\left(x^{a}\right)_{a}$ on a neighbourhood $U$ with $\left|\left(\partial_{x}^{a}\right)^{*}\right|=\left|x^{a}\right|$ for $1 \leq a \leq n+m$, and by the transition functions being the Jacobian matrices. On the intersection of coordinates $\left(x^{a},\left(\partial_{x}^{a}\right)^{*}\right)_{a}$ and $\left(y^{a},\left(\partial_{y}^{a}\right)^{*}\right)_{a}$, the linear coordinates $\left(\left(\partial_{x}^{a}\right)^{*}\right)_{a}$ and $\left(\left(\partial_{y}^{a}\right)^{*}\right)_{a}$ are transformed as

$$
\left(\partial_{y}^{a}\right)^{*}=\sum_{b=1}^{n+m}\left(\partial_{x}^{b}\right)^{*} \frac{\partial y^{a}}{\partial x^{b}}
$$

Example 5.7. Similarly, the cotangent bundle $T^{*} M$ of $M$ is defined by the linear coordinates $p_{1}, \ldots, p_{n+m}$ with $\left|p_{a}\right|=-\left|x^{a}\right|$, and by the transition functions being the transposition of the Jacobian matrices. The linear coordinates are transformed as

$$
q_{a}=\sum_{b=1}^{n+m} \frac{\partial x^{b}}{\partial y^{a}} p_{b}
$$

from $\left(x^{a}, p_{a}\right)_{a}$ to $\left(y^{a}, q_{a}\right)_{a}$.
We introduce two different types of the degree shift of a vector bundle.
Definition 5.8. Let $E$ be a vector bundle of rank $r$ on a $\rho$-manifold ( $M, \mathscr{O}_{\rho}$ ) characterized by the linear coordinates $\xi_{\alpha}^{1}, \ldots, \xi_{\alpha}^{r}$ and the transition functions $g_{\alpha \beta}=\left(\left(g_{\alpha \beta}\right)_{b}^{a}\right)_{a, b}$ with

$$
\xi_{\beta}^{a}=\sum_{a=1}^{r}\left(g_{\alpha \beta}\right)_{b}^{a} \xi_{\alpha}^{b} \quad\left(\left(g_{\alpha \beta}\right)_{b}^{a} \in \mathscr{O}_{\rho}\left(U_{\alpha \beta}\right)\right)
$$

(a) The shift of $E$ or the shifted $E$ is a vector bundle $\Pi E$ over the $\rho^{\prime}$ manifold $\left(M, \mathscr{O}_{\rho^{\prime}}\right)=\left(M, \mathscr{O}_{\rho}\right)$ by the linear coordinates $\left(\xi^{\prime}\right)_{\alpha}^{1}, \ldots,\left(\xi^{\prime}\right)_{\alpha}^{r}$ and the transition rules

$$
\begin{equation*}
\left(\xi^{\prime}\right)_{\beta}^{a}=\sum_{a=1}^{r}\left(g_{\alpha \beta}\right)_{b}^{a}\left(\xi^{\prime}\right)_{\alpha}^{b} \tag{5.1}
\end{equation*}
$$

with $G^{\prime}$-degrees $\left|\left(\xi^{\prime}\right)_{\alpha}^{a}\right|^{\prime}:=\left(1,\left|\xi_{\alpha}^{a}\right|\right)$ for $1 \leq a \leq r$.
(b) Let $i \in G$. The degree $i$-shift of $E$ is a vector bundle $[-i] E$ over the $\rho$-manifold $\left(M, \mathscr{O}_{\rho}\right)$ by the linear coordinates $\left(\xi^{\prime}\right)_{\alpha}^{1}, \ldots,\left(\xi^{\prime}\right)_{\alpha}^{r}$ and the transition rules (5.1) with $G$-degrees $\left|\left(\xi^{\prime}\right)_{\alpha}^{a}\right|:=\left|\xi_{\alpha}^{a}\right|-i$ for $1 \leq a \leq r$.

The double shift $\Pi \Pi E$ is naturally isomorphic to the original vector bundle $E$ by definition, but the double degree $i$-shift $[-i][-i] E=[-2 i] E$ is not in general.

Example 5.9. The shifted tangent bundle $\Pi T M$ of $\left(M, \mathscr{O}_{\rho}\right)$ is described by the linear coordinates $d x^{1}, \ldots, d x^{n+m}$ with $\left|d x^{a}\right|^{\prime}=\left(1,\left|x^{a}\right|\right)$ and the transition rule

$$
d y^{a}=\sum_{b=1}^{n+m} d x^{b} \frac{\partial y^{a}}{\partial x^{b}}
$$

from $\left(x^{a}, d x^{a}\right)_{a}$ to $\left(y^{a}, d y^{a}\right)_{a}$.
The sheaf of functions on $\Pi T M$ is called the de Rham complex of ( $M, \mathscr{O}_{\rho}$ ) and denoted by $\Omega_{M}^{\bullet}$ or simply $\Omega^{\bullet}$. Functions on $\Pi T M$ are called differential forms on ( $M, \mathscr{O}_{\rho}$ ).

This is the analogy of the de Rham complex of non-graded manifolds. The fundamental operations on differential forms are also defined like the de Rham differential

$$
d:=\sum_{a} d x^{a} \frac{\partial}{\partial x^{a}},
$$

the Lie derivative along $X \in \operatorname{Vect}_{\rho}(M)$ on $\Omega^{\bullet}(M)$

$$
L_{X}:=\sum_{a}\left(d x^{a} \frac{\partial X^{b}}{\partial x^{a}} \frac{\partial}{\partial d x^{b}}+X^{a} \frac{\partial}{\partial x^{a}}\right),
$$

and the interior product of $X \in \operatorname{Vect}_{\rho}(M)$

$$
i_{X}:=\sum_{a} X^{a} \frac{\partial}{\partial d x^{a}} .
$$

Here we used a local description $X=\sum_{a} X^{a} \frac{\partial}{\partial x^{a}}$ of a vector field $X \in$ $\operatorname{Vect}_{\rho}(M)$. The Cartan identities in this version

$$
\left[L_{X}, L_{Y}\right]_{\rho^{\prime}}=L_{[X, Y]}, \quad\left[d, L_{X}\right]_{\rho^{\prime}}=0, \quad \text { etc. }
$$

can be shown [5].
Example 5.10. The shifted cotangent bundle $\Pi T^{*} M$ is described by the linear coordinates $x_{1}^{*}, \ldots, x_{n+m}^{*}$ with $\left|x_{a}^{*}\right|^{\prime}=\left(1,-\left|x^{a}\right|\right)$ and the transition rule

$$
y_{a}^{*}=\sum_{b=1}^{n+m} \frac{\partial x^{b}}{\partial y^{a}} x_{b}^{*}
$$

from $\left(x^{a}, x_{a}^{*}\right)_{a}$ to $\left(y^{a}, y_{a}^{*}\right)_{a}$.
Example 5.11. Consider the degree $i$-shift of the cotangent bundle $T^{*} M$ using the notation in Example 5.10. The linear coordinates on $[-i] T^{*} M$ are $x_{1}^{*}, \ldots, x_{n+m}^{*}$ with $G$-gradings $\left|x_{a}^{*}\right|=-\left|x^{a}\right|-i$. The degree-i Schouten bracket on $\mathscr{O}_{\rho}\left([-i] T^{*} M\right)$ is defined by

$$
\begin{equation*}
\llbracket f, g \rrbracket:=\sum_{a=i}^{n+m}\left(\rho\left(|f|+\left|x^{a}\right|+i,\left|x^{a}\right|+i\right) \frac{\partial f}{\partial x_{a}^{*}} \frac{\partial g}{\partial x^{a}}-\rho\left(\left|x^{a}\right|,|f|+i\right) \frac{\partial f}{\partial x^{a}} \frac{\partial g}{\partial x_{a}^{*}}\right) \tag{5.2}
\end{equation*}
$$

locally on a coordinate $\left(x^{a}, x_{a}^{*}\right)_{a}$. The degree-0 Schouten bracket on $T^{*} M$ corresponds to the Poisson bracket.

Lemma 5.12. Take a coordinate $\left(x^{a}, x_{a}^{*}\right)_{a}$ on $[-i] T^{*} M$ and rewrite it as

$$
\left(x^{1}, \ldots, x^{n+m}, x_{1}^{*}, \ldots, x_{n+m}^{*}\right)=:\left(z^{1}, \ldots, z^{2(n+m)}\right) .
$$

Then, we have

$$
\llbracket f, g \rrbracket=\sum_{a, b=1}^{2(n+m)} \rho\left(\left|z^{a}\right|,|f|-\left|z^{a}\right|\right) \frac{\partial f}{\partial z^{a}} \llbracket z^{a}, z^{b} \rrbracket \frac{\partial g}{\partial z^{b}} .
$$

Proof. Note that $\llbracket x_{a}^{*}, x^{b} \rrbracket=\delta_{a, b}$ and $\llbracket x^{a}, x_{b}^{*} \rrbracket=-\rho\left(\left|x^{a}\right|,\left|x^{a}\right|+i\right) \delta_{a, b}$ for $1 \leq a, b \leq n+m$ by the definition. Hence, we have

$$
\begin{aligned}
& \sum_{a, b=1}^{2(n+m)} \rho\left(\left|z^{a}\right|,|f|-\left|z^{a}\right|\right) \frac{\partial f}{\partial z^{a}} \llbracket z^{a}, z^{b} \rrbracket \frac{\partial g}{\partial z^{b}} \\
= & \sum_{a=1}^{n+m} \rho\left(\left|x_{a}^{*}\right|,|f|-\left|x_{a}^{*}\right|\right) \frac{\partial f}{\partial x_{a}^{*}} \llbracket x_{a}^{*}, x^{a} \rrbracket \frac{\partial g}{\partial x^{a}} \\
& +\sum_{a=1}^{n+m} \rho\left(\left|x^{a}\right|,|f|-\left|x^{a}\right|\right) \frac{\partial f}{\partial x^{a}} \llbracket x^{a}, x_{a}^{*} \rrbracket \frac{\partial g}{\partial x_{a}^{*}} \\
= & \sum_{a=1}^{n+m} \rho\left(-\left|x^{a}\right|-i,|f|+\left|x^{a}\right|+i\right) \frac{\partial f}{\partial x_{a}^{*}} \frac{\partial g}{\partial x^{a}} \\
& +\sum_{a=1}^{n+m} \rho\left(\left|x^{a}\right|,|f|-\left|x^{a}\right|\right) \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+i\right) \frac{\partial f}{\partial x^{a}} \frac{\partial g}{\partial x_{a}^{*}} \\
= & \llbracket f, g \rrbracket .
\end{aligned}
$$

Proposition 5.13. The degree- $i$ Schouten bracket has the following properties.
(i) $|\llbracket f, g \rrbracket|=|f|+|g|+i$,
(ii) $\llbracket f, g \rrbracket=-\rho(|f|+i,|g|+i) \llbracket g, f \rrbracket$,
(iii) $\llbracket f, \llbracket g, h \rrbracket \rrbracket=\llbracket \llbracket f, g \rrbracket, h \rrbracket+\rho(|f|+i,|g|+i) \llbracket g, \llbracket f, h \rrbracket \rrbracket$,
(iv) $\llbracket f, g h \rrbracket=\llbracket f, g \rrbracket h+\rho(|f|+i,|g|) g \llbracket f, h \rrbracket$
for all $f, g, h \in \mathscr{O}_{\rho}\left([-i] T^{*} M\right)$.

Proof. Each property is checked by using Lemma 5.12. For example, (iv) follows from

$$
\begin{aligned}
\llbracket f, g h \rrbracket= & \rho\left(\left|z^{a}\right|,|f|-\left|z^{a}\right|\right) \frac{\partial f}{\partial z^{a}} \llbracket z^{a}, z^{b} \rrbracket \frac{\partial g}{\partial z^{b}} h \\
& +\rho\left(\left|z^{a}\right|,|f|-\left|z^{a}\right|\right) \frac{\partial f}{\partial z^{a}} \llbracket z^{a}, z^{b} \rrbracket g \cdot \rho\left(-\left|z^{b}\right|, g\right) \frac{\partial h}{\partial x^{b}} \\
= & \rho\left(\left|z^{a}\right|,|f|-\left|z^{a}\right|\right) \frac{\partial f}{\partial z^{a}} \llbracket z^{a}, z^{b} \rrbracket \frac{\partial g}{\partial z^{b}} h \\
& +\rho(i+|f|, g) \rho\left(\left|z^{a}\right|,|f|-\left|z^{a}\right|\right) g \frac{\partial f}{\partial z^{a}} \llbracket z^{a}, z^{b} \rrbracket \frac{\partial h}{\partial x^{b}} \\
= & \llbracket f, g \rrbracket h+\rho(|f|+i,|g|) g \llbracket f, h \rrbracket .
\end{aligned}
$$

Definition 5.14. A $\rho$ - $Q$-manifold is a pair $(M, Q)$ of a $\rho$-manifold $M$ and a vector field $Q \in \operatorname{Vect}_{\rho}(M)$ such that the pair $\left(\mathscr{O}_{\rho}(M), Q\right)$ forms a $\rho$-Qalgebra. In this case, $Q$ is called a homological vector field on $M$.

Example 5.15. Any $\rho$-manifold with the zero vector field $Q=0$ is obviously a $\rho^{\prime}$-Q-manifold (cf. Example 2.13).

Example 5.16. Let $M$ be a $\rho$-manifold. As we discussed in Example 5.9, the de Rham differential $d=\sum_{a} d x^{a} \frac{\partial}{\partial x^{a}}$ is squared to zero. In fact,

$$
\begin{aligned}
d(d f) & =\sum_{a, b} d x^{a} \frac{\partial}{\partial x^{a}}\left(d x^{b} \frac{\partial f}{\partial x^{b}}\right)=\sum_{a, b} \rho\left(-\left|x^{a}\right|,\left|x^{b}\right|\right) d x^{a} d x^{b} \frac{\partial^{2} f}{\partial x^{a} \partial x^{b}} \\
& =\sum_{b, a} \rho\left(-\left|x^{b}\right|,\left|x^{a}\right|\right) d x^{b} d x^{a} \frac{\partial^{2} f}{\partial x^{b} \partial x^{a}} \\
& =\sum_{b, a} \rho\left(-\left|x^{b}\right|,\left|x^{a}\right|\right) \cdot\left(-\rho\left(\left|x^{b}\right|,\left|x^{a}\right|\right)\right) \cdot \rho\left(-\left|x^{b}\right|,-\left|x^{a}\right|\right) d x^{a} d x^{b} \frac{\partial^{2} f}{\partial x^{a} \partial x^{b}} \\
& =-\sum_{b, a} \rho\left(-\left|x^{a}\right|,\left|x^{b}\right|\right) d x^{a} d x^{b} \frac{\partial^{2} f}{\partial x^{a} \partial x^{b}}=0
\end{aligned}
$$

for all $f \in \mathscr{O}_{\rho}(\Pi T M)=\Omega^{\bullet}(M)$. Thus, a pair $(\Pi T M, d)$ is a $\rho^{\prime}$-Q-manifold.
Next, we assume $M$ is a $\rho$-Q-manifold with a homological vector field $Q$. Since the Lie derivative along $Q$ on $\Omega^{\bullet}(M)$ is squared to zero because

$$
2 L_{Q} \circ L_{Q}=\left[L_{Q}, L_{Q}\right]_{\rho^{\prime}}=L_{[Q, Q]_{\rho}}=0
$$

a pair $\left(\Pi T M, L_{Q}\right)$ also becomes a $\rho^{\prime}$ - Q -manifold.
Moreover, the Cartan identity for $\Omega^{\bullet}(M)$ implies that $\left[d, L_{Q}\right]_{\rho^{\prime}}=0$. It follows that $\left[d+L_{Q}, d+L_{Q}\right]_{\rho^{\prime}}=0$, which gives another $\rho^{\prime}$-Q-manifold $\left(\Pi T M, d+L_{Q}\right)$.

Example 5.17. Consider the degree- $i$ Schouten bracket Example 5.11) on the degree- $i$ shift of the cotangent bundle $[-i] T^{*} M$. Suppose that $M$ has a homological vector field $Q$. A natural correspondence

$$
\begin{gathered}
\operatorname{Vect}_{\rho}(U) \longrightarrow \mathscr{O}_{\rho}\left([-i] T^{*} U\right) \\
\frac{\partial}{\partial x^{a}} \longmapsto x_{a}^{*}
\end{gathered}
$$

on $U$ with a coordinate $x=\left(x^{a}\right)_{a}$ maps $\left.Q\right|_{U}=\sum_{a} Q^{a} \frac{\partial}{\partial x^{a}}$ to a local function $\sum_{a} Q^{a} x_{a}^{*}$, which is patched up to some global function $f_{Q}$ of degree $\left|f_{Q}\right|=$ $|Q|-i$ because the transition rules for $\left(\frac{\partial}{\partial x^{a}}\right)_{a}$ and $\left(x_{a}^{*}\right)_{a}$ are identical. This map is of degree $-i$. Then, $\widetilde{Q}:=\llbracket f_{Q},-\rrbracket$ is a $\rho$-derivation on $\mathscr{O}_{\rho}\left([-i] T^{*} M\right)$ of degree $|Q|$ by (iv) in Proposition 5.13. Using Lemma 5.12, we have locally

$$
\begin{aligned}
& \llbracket f_{Q}, f_{Q} \rrbracket \\
= & \rho\left(-\left|x^{a}\right|-i,|Q|+\left|x^{a}\right|\right) \frac{\partial}{\partial x_{a}^{*}}\left(Q^{b} x_{b}^{*}\right) \frac{\partial}{\partial x^{a}}\left(Q^{c} x_{c}^{*}\right) \\
& -\rho\left(\left|x^{a}\right|,|Q|\right) \frac{\partial}{\partial x^{a}}\left(Q^{b} x_{b}^{*}\right) \frac{\partial}{\partial x_{a}^{*}}\left(Q^{c} x_{c}^{*}\right) \\
= & Q^{a} \frac{\partial Q^{c}}{\partial x^{a}} x_{c}^{*}-\rho\left(\left|x^{a}\right|,|Q|\right) \rho\left(\left|x^{a}\right|+i,|Q|+\left|x^{a}\right|\right) \frac{\partial Q^{b}}{\partial x^{a}} x_{b}^{*} Q^{a} \\
= & 2 Q^{a} \frac{\partial Q^{c}}{\partial x^{a}} x_{c}^{*}=0 .
\end{aligned}
$$

The last equality is just an interpretation of the condition $[Q, Q]_{\rho}=0$. Hence, for all $f \in \mathscr{O}_{\rho}\left([-i] T^{*} M\right)$, we have

$$
\begin{aligned}
& \widetilde{Q}(\widetilde{Q} f)=\llbracket f_{Q}, \llbracket f_{Q}, f \rrbracket \rrbracket \\
= & \llbracket \llbracket f_{Q}, f_{Q} \rrbracket, f \rrbracket+\rho\left(\left|f_{Q}\right|+i,\left|f_{Q}\right|+i\right) \llbracket f_{Q}, \llbracket f_{Q}, f \rrbracket \rrbracket \\
= & -\llbracket f_{Q}, \llbracket f_{Q}, f \rrbracket \rrbracket,
\end{aligned}
$$

which yields that $\widetilde{Q} \circ \widetilde{Q}=0$. Therefore, $\left([-i] T^{*} M, \widetilde{Q}\right)$ is a $\rho$-Q-manifold.
Example 5.18. A noncommutative torus Example 2.5 is considered as a $\rho$-manifold $M$ whose underlying manifold is a point. A $\rho$-commutative algebra $A_{\Theta}$ is $\mathbb{Z}^{\times m}$-graded and its generators are graded positively, which gives

$$
A_{\Theta}=C^{\omega}(\{*\}, \mathbb{C}) \llbracket u^{1}, \ldots, u^{m} \rrbracket_{\bullet}=\mathbb{C}\left[u^{1}, \ldots, u^{m}\right]
$$

Its BRST quantization corresponds to the $\rho^{\prime}$-commutative algebra $C_{\rho^{\prime}}^{\omega}(\Pi \mathfrak{g} \times$ $M, \mathbb{C})$ where $\mathfrak{g}$ is the Lie algebra of $m$-dimensional torus. The corresponding BRST differential $Q$ is

$$
Q=-\sum_{a=1}^{m} 2 \pi \sqrt{-1} \eta^{a} u^{a} \frac{\partial}{\partial u^{a}} \in \operatorname{Vect}_{\rho^{\prime}}(\Pi \mathfrak{g} \times M)
$$

where each $\eta^{a} \in C_{\rho^{\prime}}^{\omega}(\Pi \mathfrak{g}, \mathbb{C})$ is a coordinate function with

$$
\left|\eta^{a}\right|^{\prime}=(1,(0, \ldots, 0)) \in \mathbb{Z} \times \mathbb{Z}^{\times m}
$$

This $Q$ becomes a homological vector field on $\Pi \mathfrak{g} \times M$.

## 6 Volume forms on a $\rho$-manifold

For a while, let $M$ be a $G$-graded $\rho$-manifold.
Definition 6.1. Let $M$ be a $\rho$-manifold. The $\rho$-Berezinian bundle on $M$ is the line bundle $\rho \operatorname{Ber}(M)$ on $M$ characterized by a local frame $D(x)$ of degree 0 on a coordinate neighbourhood $x=\left(x^{a}\right)_{a}$, and the transition rule

$$
D(y)=D(x) \rho \operatorname{Ber}\left(\frac{\partial y^{a}}{\partial x^{b}}\right)_{a, b}
$$

between coordinate neighbourhoods $y=\left(y^{a}\right)_{a}$ and $x=\left(x^{b}\right)_{b}$.
Since the Jacobian matrix $\left(\frac{\partial y^{a}}{\partial x^{b}}\right)_{a, b}$ between neighbourhoods clearly satisfies the cocycle condition, by Proposition 3.7, a vector bundle $\rho \operatorname{Ber}(M)$ is welldefined.

Definition 6.2. A $\rho$-manifold $M$ is said to be orientable if there is a global section vol $\in \Gamma(M, \rho \operatorname{Ber}(M))$ whose restriction to each neighbourhood $U_{x}$ with a coordinate $x=\left(x^{a}\right)_{a}$ is of a form $\operatorname{vol}_{U_{x}}=D(x) s(x)$ with $s(x)$ $\in\left(C_{\rho}^{\infty}\left(U_{x}\right)\right)_{0}$ invertible.

In this case, we call this section vol a $\rho$-Berezin volume form on $M$ or simply a volume form on $M$. We denote by $\operatorname{Vol}(M)$ the set of all $\rho$-Berezin volume forms on $M$.

Definition 6.3. Let $M$ be a $\rho$-manifold and $\operatorname{vol}_{1}, \operatorname{vol}_{2} \in \Gamma(M, \rho \operatorname{Ber}(M))$ be two $\rho$-Berezin volume forms. $\operatorname{vol}_{1}$ and $\operatorname{vol}_{2}$ are said to be equivalent if $\mathrm{vol}_{2}=\mathrm{vol}_{1} \cdot \exp h$ for some $h \in \mathscr{O}_{\rho}(M)_{0}$.

Remark 6.4. Let us consider the equivalence of volume forms in the nongraded case. The $\rho$-Berezinian bundle is just the determinant line bundle $\operatorname{det} M$ on $M$. A volume form on $M$ is a non-vanishing section on $\operatorname{det} M$, which makes $\operatorname{det} M$ trivial.

In the real category, since any positive function is the exponential of some function, two volume forms are equivalent if and only if they are identical up to a multiple by a positive function. This equivalence relation divide $\operatorname{Vol}(M)$ into two equivalence classes.

In the complex category, the situation is a bit more complicated. For example, on a punctured complex plane $M=\mathbb{C}^{\times}$, we have two volume
forms $\mathrm{vol}_{1}=1 d z$ and $\mathrm{vol}_{2}=z d z$ which are not equivalent. Since the action of $\mathscr{O}(M)^{\times}$by multiplication on $\operatorname{Vol}(M)$ is transitive and free, if we pick some volume form, then $\operatorname{Vol}(M)$ is identified with $\mathscr{O}(M)^{\times}$. Recall that the exponential sheaf sequence

$$
0 \longrightarrow \mathbb{Z}^{2 \pi \sqrt{-1}} \mathscr{O} \xrightarrow{\exp } \mathscr{O}^{\times} \longrightarrow 0
$$

yields a long exact sequence

$$
0 \rightarrow H^{0}(M, \mathbb{Z}) \rightarrow H^{0}(M, \mathscr{O}) \rightarrow H^{0}\left(M, \mathscr{O}^{\times}\right) \xrightarrow{\delta} H^{1}(M, \mathbb{Z}) \rightarrow \cdots
$$

The identification $H^{0}(M, \mathscr{O})=\mathscr{O}(M)$ and $H^{0}\left(M, \mathscr{O}^{\times}\right)=\mathscr{O}^{\times}(M)$ gives

$$
\begin{aligned}
\mathscr{O}(M)^{\times} / \sim & =\mathscr{O}(M)^{\times} / \operatorname{Im}\left(\exp : H^{0}(M, \mathscr{O}) \rightarrow H^{0}\left(M, \mathscr{O}^{\times}\right)\right) \\
& =\mathscr{O}(M)^{\times} / \operatorname{Ker} \delta
\end{aligned}
$$

where $\sim$ means the equivalence relation in Definition 6.3. The connecting homomorphism $\delta$ satisfies

$$
(\delta f)(\gamma)=\frac{1}{2 \pi \sqrt{-1}} \int_{f \circ \gamma} \frac{d z}{z}
$$

for a loop $\gamma \in H_{1}(M, \mathbb{Z})$. Therefore, the equivalence relation $\sim$ between volume forms means they have "the same winding number".

Example 6.5. If $M$ is a point or an open subset of $\mathbb{K}^{n}$, then $M$ has a trivial $\rho$-Berezin volume form vol $=D(x) \cdot 1$.

Example 6.6. Let us consider the shifted tangent bundle $\Pi T M$ Example 5.9) of $M$ with coordinates $x=\left(x^{a}\right)_{a}$. To deal with the Jacobian matrix, we write the even coordinates as $x^{\text {even }}:=\left(x^{a}\right)_{\left|x^{a}\right|}$ : even and the odd coordinates as $x^{\text {odd }}:=\left(x^{a}\right)_{\left|x^{a}\right|}$ : odd. The $\rho^{\prime}$-Berezinian of the Jacobian matrix is written in block matrices as

$$
\begin{aligned}
& \rho^{\prime} \operatorname{Ber} J_{(x, d x),(y, d y)} \\
& =\rho^{\prime} \text { Ber }\left(\begin{array}{cccc}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & 0 & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) & 0 \\
\left(\frac{\partial d y^{\text {odd }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial d y^{\text {odd }}}{\partial d x^{\text {odd }}}\right) & \left(\frac{\partial d y^{\text {odd }}}{\partial x^{\text {odd }}}\right) & \left(\frac{\partial d y^{\text {odd }}}{\partial d x^{\text {even }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right) & 0 & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {odd }}}\right) & 0 \\
\left(\frac{\partial d y^{\text {even }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial d y^{\text {even }}}{\partial d x^{\text {odd }}}\right) & \left(\frac{\partial d y^{\text {even }}}{\partial x^{\text {odd }}}\right) & \left(\frac{\partial d y^{\text {even }}}{\partial d x^{\text {even }}}\right)
\end{array}\right) \\
& =\rho^{\prime} \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right)
\end{array}\right) \rho^{\prime} \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial d y^{\text {odd }}}{\partial d y^{\text {odd }}}\right) & \left(\frac{\partial d y^{\text {odd }}}{\partial d x^{\text {even }}}\right) \\
\left(\frac{\partial y^{\text {even }}}{\partial d x^{\text {odd }}}\right) & \left(\frac{\partial d y^{\text {ven }}}{\partial d x^{\text {even }}}\right)
\end{array}\right) \\
& =\rho^{\prime} \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{x^{\text {ven }}}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right)
\end{array}\right) \rho^{\prime} \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right)
\end{array}\right)^{-1} \\
& =1 \text {. }
\end{aligned}
$$

Here we used Proposition 3.7 (iv). Hence, $\Pi T M$ has a $\rho^{\prime}$-Berezin volume form vol $=D(x, d x) \cdot 1$.

Example 6.7. For the cotangent bundle $T^{*} M$ Example 5.7, we have

$$
\begin{aligned}
& \rho \operatorname{Ber} J_{(x, p),(y, q)} \\
& =\rho \operatorname{Ber}\left(\begin{array}{cccc}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & 0 & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) & 0 \\
\left(\frac{\partial q_{\text {eve }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial q_{\text {even }}}{\partial p_{\text {even }}}\right) & \left(\frac{\partial \text { even }^{\text {even }}}{\partial x^{\text {odd }}}\right) & \left(\frac{\partial q_{\text {even }}}{\partial p_{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right) & 0 & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {odd }}}\right) & 0 \\
\left(\frac{\partial q_{\text {odd }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial q_{\text {odd }}}{\partial p_{\text {even }}}\right) & \left(\frac{\partial q_{\text {odd }}}{\partial x^{\text {odd }}}\right) & \left(\frac{\partial q_{\text {odd }}}{\partial p_{\text {odd }}}\right)
\end{array}\right) \\
& =\rho \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {oden }}}\right) & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right)
\end{array}\right) \rho \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial q_{\text {even }}}{\partial p_{\text {even }}}\right) & \left(\frac{\partial q_{\text {even }}}{\partial p_{\text {ovd }}}\right) \\
\left(\frac{\partial q_{\text {odd }}}{\partial p_{\text {oven }}}\right) & \left(\frac{\partial q_{\text {odd }}}{\partial p_{\text {odd }}}\right)
\end{array}\right) \\
& =\rho \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {eden }}}\right) & \left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right)
\end{array}\right) \rho \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial x^{\text {even }}}{\partial y^{\text {even }}}\right) & \left(\frac{\partial x^{\text {even }}}{\partial y^{\text {odd }}}\right) \\
\left(\frac{\partial x^{\text {odd }}}{\partial y^{\text {eden }}}\right) & \left(\frac{\partial x^{\text {odd }}}{\partial y^{\text {even }}}\right)
\end{array}\right)^{\top} \\
& =1 \text {. }
\end{aligned}
$$

Here we used Proposition 3.7 (iii) and (iv). Hence, $T^{*} M$ has a $\rho$-Berezin volume form vol $=D(x, p) \cdot 1$.

Example 6.8. For the tangent bundle $T M$ (Example 5.6), we have

$$
\begin{aligned}
& \rho \operatorname{Ber} J_{(x, p),(y, q)}
\end{aligned}
$$

$$
\begin{aligned}
& =\rho \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {ven }}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {odd }}}\right) \\
\left(\frac{\partial y^{\text {do }}}{\partial x^{\text {ven }}}\right) & \left(\frac{\partial y^{\text {do }}}{\partial x^{\text {ven }}}\right)
\end{array}\right)^{2} \\
& =\left(\rho \operatorname{Ber} J_{x y}\right)^{2} \text {. }
\end{aligned}
$$

Therefore, the tangent bundle $T M$ has a $\rho$-Berezin volume form if the base $\rho$-manifold $M$ has a $\rho$-Berezin volume form vol $=D(x) s(x)$. In this case, $\widetilde{\text { vol }}:=D\left(x,\left(\partial_{x}\right)^{*}\right) s(x)^{2}$ becomes a $\rho$-Berezin volume form on $T M$.

Example 6.9. For the shifted cotangent bundle $\Pi T^{*} M$ (Example 5.10), we have

$$
\begin{aligned}
& \rho^{\prime} \operatorname{Ber} J_{\left(x, x^{*}\right),\left(y, y^{*}\right)}
\end{aligned}
$$

$$
\begin{aligned}
& =\rho^{\prime} \operatorname{Ber}\left(\begin{array}{ll}
\left(\frac{\partial y^{\text {even }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {even }}}{\partial x^{\text {oodd }}}\right) \\
\left(\frac{\partial y^{\text {odd }}}{\partial x^{\text {even }}}\right) & \left(\frac{\partial y^{\text {od }}}{\partial x^{\text {even }}}\right)
\end{array}\right)^{2} \\
& =\left(\rho \operatorname{Ber} J_{x y}\right)^{2} \text {. }
\end{aligned}
$$

Therefore, the shifted cotangent bundle $\Pi T^{*} M$ has a $\rho$-Berezin volume form given by vol $:=D\left(x, x^{*}\right) s(x)^{2}$ if the base $\rho$-manifold $M$ has a $\rho$-Berezin volume form vol $=D(x) s(x)$.

Example 6.10. Consider the degree- $i$ shifted cotangent bundle $[-i] T^{*} M$ (Example 5.11). If $i$ is even, then the parity of each coordinate $x_{a}^{*}$ is the same with that of $x_{a}$. Hence, the $\rho$-Berezinian of the Jacobian matrix is always 1 similarly to Example 6.7. Thus $[-i] T^{*} M$ has a $\rho$-Berezin volume form $\mathrm{vol}=D\left(\left(x^{a}, x_{a}^{*}\right)_{a}\right) \cdot 1$.

If $i$ is odd, then the parity of each coordinate $x_{a}^{*}$ is opposite to that of $x_{a}$. Hence, the $\rho$-Berezinian of the Jacobian matrix is the square of the $\rho$-Berezinian of the Jacobian matrix on the base $\rho$-manifold similarly to Example 6.9. Consequently, $[-i] T^{*} M$ has a $\rho$-Berezin volume form vol $=$ $D\left(x, x^{*}\right) s(x)^{2}$ if $M$ itself has a $\rho$-Berezin volume form vol $=D(x) s(x)$.

By deforming the coordinates infinitesimally, we consider Lie derivative of a section of $\rho$-Berezinian bundle.

Let $X$ be a vector field on a $\rho$-manifold $M$. Infinitesimal deformation of a coordinate $\left(x^{a}\right)_{a}$ on a neighbourhood $U_{x}$ is regarded as

$$
x^{a} \mapsto x^{a}+\varepsilon X^{a}=: y^{a}
$$

where $X=\sum_{a} X^{a} \frac{\partial}{\partial x^{a}}$ is the local description of $X$ on $U_{x}$, and $\varepsilon$ is an infinitesimal parameter, i.e., an indeterminate of degree $-|X|$ with $\varepsilon^{2}=0$.

The Jacobian matrix of this deformation becomes

$$
\begin{aligned}
\left(\frac{\partial}{\partial x^{b}}\left(x^{a}+\varepsilon X^{a}\right)\right)_{a, b} & =\left(\delta_{a, b}+\rho\left(-\left|x_{b}\right|,|\varepsilon|\right) \varepsilon \frac{\partial X^{a}}{\partial x^{b}}\right)_{a, b} \\
& =1+\varepsilon \cdot\left(\rho\left(-\left|x_{a}\right|-\left|x_{b}\right|,|\varepsilon|\right) \frac{\partial X^{a}}{\partial x^{b}}\right)_{a, b}
\end{aligned}
$$

From Lemma 3.9, the deformation of the local frame $D(x)$ becomes

$$
\begin{aligned}
D(y) & =D(x) \rho \operatorname{Ber}\left(\frac{\partial}{\partial x^{b}}\left(x^{a}+\varepsilon X^{a}\right)\right)_{a, b} \\
& =D(x) \rho \operatorname{Ber}\left(1+\varepsilon \cdot\left(\rho\left(-\left|x_{a}\right|-\left|x_{b}\right|,|\varepsilon|\right) \frac{\partial X^{a}}{\partial x^{b}}\right)_{a, b}\right) \\
& =D(x)\left(1+\rho \operatorname{tr}\left(\varepsilon \cdot\left(\rho\left(-\left|x_{a}\right|-\left|x_{b}\right|,|\varepsilon|\right) \frac{\partial X^{a}}{\partial x^{b}}\right)_{a, b}\right)\right) \\
& =D(x)\left(1+\varepsilon \sum_{a} \rho\left(\left|x_{a}\right|,\left|x_{a}\right|+|X|\right) \frac{\partial X^{a}}{\partial x^{a}}\right)
\end{aligned}
$$

On the other hand, for every local function $s(x) \in C_{\rho}^{\infty}\left(U_{x}\right)$, we have

$$
s(y)=s(x)+\varepsilon X^{a} \frac{\partial s}{\partial x^{a}}
$$

from Lemma 4.2. Thus,

$$
\begin{aligned}
D(y) s(y) & =D(x)\left(1+\varepsilon \sum_{a} \rho\left(\left|x_{a}\right|,\left|x_{a}\right|+|X|\right) \frac{\partial X^{a}}{\partial x^{a}}\right)\left(s(x)+\varepsilon X^{a} \frac{\partial s}{\partial x^{a}}\right) \\
& =D(x) s(x)+\varepsilon D(x) \sum_{a} \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+|X|\right) \frac{\partial}{\partial x^{a}}\left(X^{a} s\right) .
\end{aligned}
$$

Therefore, the Lie derivative along $X$ of a section of $\rho \operatorname{Ber}(M)$ is described locally by

$$
\begin{equation*}
L_{X}(D(x) s(x))=D(x) \sum_{a} \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+|X|\right) \frac{\partial}{\partial x^{a}}\left(X^{a} s\right) \tag{6.1}
\end{equation*}
$$

for a coordinate $x=\left(x^{a}\right)_{a}$ on $U_{x}$ and a local function $s(x) \in C_{\rho}^{\infty}\left(U_{x}\right)$.
The Lie derivative of a $\rho$-Berezin volume form on a $\rho$-manifold is again a section of $\rho$-Berezinian bundle. The divergence of a $\rho$-Berezin volume form is defined as follows.

Definition 6.11. Let vol be a $\rho$-Berezin volume form on $M$. For a vector field $X \in \operatorname{Vect}_{\rho}(M)$, define the function $\operatorname{Div}_{\text {vol }} X$ called the divergence of $X$ with respect to vol by

$$
\operatorname{vol} \cdot\left(\operatorname{Div}_{\mathrm{vol}} X\right)=L_{X}(\mathrm{vol})
$$

In a coordinate $x=\left(x^{a}\right)_{a}$, it is written as

$$
\operatorname{Div}_{\mathrm{vol}} X=\sum_{a} \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+|X|\right) s^{-1} \frac{\partial}{\partial x^{a}}\left(X^{a} s\right)
$$

where vol $=: D(x) s(x)$.
Proposition 6.12. For all $X, Y \in \operatorname{Vect}_{\rho}(M), f, g \in C_{\rho}^{\infty}(M)$ with $|g|=0$, and a $\rho$-Berezin volume form vol on $M$, the following properties hold:
(i) $\operatorname{Div}_{\mathrm{vol}}(f X)=f \operatorname{Div}_{\text {vol }} X+\rho(|f|,|X|) X(f)$,
(ii) $\operatorname{Div}_{\mathrm{vol} \cdot \exp (g)} X=\operatorname{Div}_{\mathrm{vol}} X+X(g)$,
(iii) $\operatorname{Div}_{\text {vol }}[X, Y]_{\rho}=X\left(\operatorname{Div}_{\text {vol }} Y\right)-\rho(|X|,|Y|) Y\left(\operatorname{Div}_{\text {vol }} X\right)$.

Proof. By a direct computation.
The definition of the divergence and its properties above coincide with the ones in the case of supermanifolds [3].

## 7 The modular class of a $\rho$-manifold

For a $\rho$-Q-manifold $(M, Q)$, the condition $Q^{2}=0$ implies that the subalgebra

$$
\mathscr{O}_{\rho}(M)_{Q}:=\bigoplus_{k \in \mathbb{Z}} \mathscr{O}_{\rho}(M)_{k|Q|} \subset \mathscr{O}_{\rho}(M)
$$

has a structure of a cochain complex by an action of $Q$. We write the cohomology group of this cochain complex $\left(\mathscr{O}_{\rho}(M)_{Q}, Q\right)$ as $H_{Q}^{\bullet}(M)$.

Lemma 7.1. For a $\rho$-Q-manifold $(M, Q)$ with a $\rho$-Berezin volume form vol,

$$
Q\left(\operatorname{Div}_{\mathrm{vol}} Q\right)=0
$$

Proof. Write vol $=D(x) s(x)$ locally. Since $L_{Q} \circ L_{Q}=0$, we have

$$
\begin{aligned}
0 & =L_{Q} L_{Q}(\mathrm{vol})=L_{Q}\left(D(x) s(x) \operatorname{Div}_{\mathrm{vol}} Q\right) \\
& =\rho\left(\left|x^{a}\right|,|Q|+\left|x^{a}\right|\right) D(x) \frac{\partial}{\partial x^{a}}\left(Q^{a} s(x) \operatorname{Div}_{\mathrm{vol}} Q\right) \\
& =(D(x) s(x))\left(\operatorname{Div}_{\mathrm{vol}} Q\right)^{2}+D(x) s(x) Q\left(\operatorname{Div}_{\mathrm{vol}} Q\right) \\
& =\mathrm{vol} \cdot Q\left(\operatorname{Div}_{\mathrm{vol}} Q\right) .
\end{aligned}
$$

Definition 7.2. The modular class of a $\rho$-Q-manifold $(M, Q)$ with a $\rho$ Berezin volume form vol is the cohomology class of the divergence of $Q$, i.e.

$$
\operatorname{Mod}_{Q}(M ; \operatorname{vol}):=\left[\operatorname{Div}_{\mathrm{vol}} Q\right] \in H_{Q}^{1}(M) .
$$

Lemma 7.3. Suppose that $(M, Q)$ is an orientable $\rho$-Q-manifold. The modular class of $(M, Q)$ does not depend on equivalent $\rho$-Berezin volume forms. Moreover, in the real category, it holds also for $\rho$-Berezin volume forms which are not equivalent.

Proof. Suppose that $\mathrm{vol}_{1}$ and $\mathrm{vol}_{2}$ are equivalent $\rho$-Berezin volume forms on $M$. There is some function $h \in \mathscr{O}_{\rho}(M)_{0}$ such that $\operatorname{vol}_{2}=\operatorname{vol}_{1} \cdot \exp h$. From Proposition 6.12 (ii), it holds that $\operatorname{Div}_{\mathrm{vol}_{2}} Q=\operatorname{Div}_{\mathrm{vol}_{1}} Q+Q(h)$.

In the real category, for any pair of volume forms $\mathrm{vol}_{1}$ and $\mathrm{vol}_{2}$, there is some invertible function $f=\sum_{\mathbf{w}} f_{\mathbf{w}} x^{\mathbf{w}} \in \mathscr{O}_{\rho}(M)_{0}$ with $\operatorname{vol}_{2}=\operatorname{vol}_{1} \cdot f$. Let $f_{0} \in \mathscr{O}(M)$ be the term in $f$ which has no $G$-graded indeterminates. The invertibility of $f$ implies that $f_{0}$ is always positive or always negative. Hence, we have $\operatorname{vol}_{2}=\operatorname{vol}_{1} \cdot( \pm \exp (\log |f|))$ and

$$
\operatorname{Div}_{\mathrm{vol}_{2}} Q=\operatorname{Div}_{\mathrm{vol}_{1}} Q \pm Q(\log |f|)
$$

Remark 7.4. In the real category, since the modular class does not depend on $\rho$-Berezin volume forms, we also write $\operatorname{Mod}_{Q}(M):=\operatorname{Mod}_{Q}(M ; \operatorname{vol})$.

Example 7.5. Consider the de Rham complex of a $\rho$-manifold $M$ with a coordinate $x=\left(x^{a}\right)_{a}$. By Example 6.6, a $\rho^{\prime}$-manifold $\Pi T M$ has a $\rho$-Berezin volume form vol which is locally $D(x, d x) \cdot 1$. It follows that

$$
\begin{aligned}
& \operatorname{Div}_{\mathrm{vol}} d \\
= & \sum_{a=1}^{n+m} \rho^{\prime}\left(\left|x^{a}\right|,\left|x^{a}\right|+|d|\right) \frac{\partial}{\partial x^{a}}\left(d x^{a}\right)+\sum_{a=1}^{n+m} \rho^{\prime}\left(\left|d x^{a}\right|,\left|d x^{a}\right|+|d|\right) \frac{\partial}{\partial d x^{a}}(0) \\
= & 0 .
\end{aligned}
$$

Therefore, $\operatorname{Mod}_{d}(\Pi T M ; \operatorname{vol})=0$.
Example 7.6. Consider the de Rham complex ( $\Pi T \mathbb{C}^{\times}, Q=d z \frac{\partial}{\partial z}$ ) of $\mathbb{C}^{\times}$. Here we regard $\mathbb{C}^{\times}$as a non-graded holomorphic manifold. We have a $\rho$ Berezin volume form $\operatorname{vol}_{1}:=D(z, d z) \cdot 1$. We also have another volume form $\operatorname{vol}_{2}:=D(z, d z) \cdot z$. We see that $\operatorname{Div}_{\mathrm{vol}_{1}} Q=\frac{\partial}{\partial z}(d z)=0$ and $\operatorname{Div}_{\mathrm{vol}_{2}} Q=$ $\frac{1}{z} \frac{\partial}{\partial z}(d z \cdot z)=\frac{1}{z} d z$. Since there is no holomorphic function $f$ on $\mathbb{C}^{\times}$which satisfies $\frac{\partial}{\partial z}(f)=\frac{1}{z}$, we have $\operatorname{Mod}_{Q}\left(M ; \operatorname{vol}_{2}\right) \neq 0=\operatorname{Mod}_{Q}\left(M ; \operatorname{vol}_{1}\right)$. Indeed, the two volume forms $\mathrm{vol}_{1}$ and $\mathrm{vol}_{2}$ are not equivalent.

Example 7.7. Let $(M, Q)$ be a $\rho$-Q-manifold with a $\rho$-Berezin volume form vol. Consider a $\rho$-manifold $[-i] T^{*} M \quad(i \in G)$ with its homological vector field $\widetilde{Q}:=\llbracket f_{Q},-\rrbracket$ defined in Example 5.17. Denote by vol the $\rho$-Berezin volume form on $[-i] T^{*} M$ induced by vol with a local description $\widetilde{\text { vol }}=$
$\widetilde{D}\left(x, x^{*}\right) \widetilde{s}\left(x, x^{*}\right)$. Since $\widetilde{s}=1$ if $i$ is even and $\widetilde{s}=s^{2}$ if $i$ is odd, its logarithm is written as

$$
\log \widetilde{s}=(1-\rho(i, i)) \log s .
$$

Hence,

$$
\widetilde{Q}(\log \widetilde{s})=\widetilde{Q}((1-\rho(i, i)) \log s)=(1-\rho(i, i)) Q(\log s) .
$$

The non- $\widetilde{Q}$-exact term of the divergence of $\widetilde{Q}$ becomes

$$
\begin{aligned}
& \sum_{a=1}^{n+m} \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+|Q|\right) \frac{\partial Q^{a}}{\partial x^{a}}-\sum_{a, b=1}^{n+m} \rho\left(\left|x_{a}^{*}\right|,\left|x_{a}^{*}\right|+|Q|\right) \frac{\partial}{\partial x_{a}^{*}}\left(\frac{\partial Q^{b}}{\partial x^{a}} x_{b}^{*}\right) \\
= & \sum_{a=1}^{n+m} \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+|Q|\right) \frac{\partial Q^{a}}{\partial x^{a}}-\sum_{a=1}^{n+m} \rho\left(\left|x_{a}^{*}\right|,\left|x_{a}^{*}\right|+|Q|\right) \rho\left(-\left|x_{a}^{*}\right|,|Q|\right) \frac{\partial Q^{a}}{\partial x^{a}} \\
= & (1-\rho(i, i)) \sum_{a=1}^{n+m} \rho\left(\left|x^{a}\right|,\left|x^{a}\right|+|Q|\right) \frac{\partial Q^{a}}{\partial x^{a}} .
\end{aligned}
$$

Therefore, we obtain

$$
\operatorname{Div}_{\widetilde{\mathrm{vol}}} \widetilde{Q}=(1-\rho(i, i)) \operatorname{Div}_{\mathrm{vol}} Q
$$

and

$$
\operatorname{Mod}_{\widetilde{Q}}\left([-i] T^{*} M ; \widetilde{\mathrm{vol}}\right)=(1-\rho(i, i)) \operatorname{Mod}_{Q}(M, \mathrm{vol}) .
$$

Example 7.8. We continue the example of noncommutative tori Example 5.18). For the BRST differential $Q$ on the functional algebra $A_{\Theta}$ on a noncommutative torus, the divergence of $Q$ with respect to the trivial $\rho$-Berezin volume form vol on a point $M=\{*\}$ is

$$
\begin{aligned}
\operatorname{Div}_{\mathrm{vol}} Q & =-\sum_{a=1}^{m} \rho^{\prime}\left(\left|u^{a}\right|^{\prime},\left|u^{a}\right|^{\prime}+|Q|^{\prime}\right) \frac{\partial}{\partial u^{a}}\left(2 \pi \sqrt{-1} \eta^{a} u^{a}\right) \\
& =-\sum_{a=1}^{m} \rho\left(\left|u^{a}\right|,\left|u^{a}\right|\right) 2 \pi \sqrt{-1} \eta^{a} \\
& =-2 \pi \sqrt{-1} \sum_{a=1}^{m} \eta^{a} .
\end{aligned}
$$

Hence, we obtain

$$
\operatorname{Mod}_{Q}(\Pi \mathfrak{g} \times M ; \mathrm{vol})=-2 \pi \sqrt{-1} \sum_{a=1}^{m}\left[\eta^{a}\right] \in H_{Q}^{1}(\Pi \mathfrak{g} \times M)
$$
