# GLOBAL UNIFORM IN N ESTIMATES FOR SOLUTIONS OF A SYSTEM OF HARTREE-FOCK-BOGOLIUBOV TYPE IN THE GROSS-PITAVESKII REGIME. 

XIAOQI HUANG


#### Abstract

We extend the recent work of Chong et al., 2022 7 to the critical case. More precisely, we prove global in time, uniform in $N$ estimates for the solutions $\phi, \Lambda$ and $\Gamma$ of a coupled system of Hartree-Fock-Bogoliubov type with interaction potential $\frac{1}{N} V_{N}(x-y)=N^{2} v(N(x-y))$. We assume that the potential $v$ is small which satisfies some technical conditions, and the initial conditions have finite energy. The main ingredient is a sharp estimate for the linear Schrödinger equation with potential in $6+1$ dimension, which may be of interest in its own right.


## 1. Introduction.

Consider the $N$-body linear Schrödinger equation which governs the time-evolution of $N$ boson systems

where $x_{i} \in \mathbb{R}^{3}, N$ is large and $V_{N}(x)=N^{3} v(N x)$ for some Schwarz class potential $v$. The conditions on the potential will be discussed below. A physically appealing case concerns initial data forming a tensor product of the same one-particle state, in spirit of the Bose-Einstein condensation. We refer to [20] for extensive background on Bose-Einstein condensation.

The goal is to find a rigorous, simple approximation to $\psi_{N}$ which is consistent with

in an appropriate sense, where $\phi$ is often called the mean-field limit.
In the stationary case, a survey of results concerning the ground state properties of the dilute bosonic gases can be found in [20]. In the time dependent case, in the work of Erdös, Schlein and Yau [10, 11, 12, by using the BBGKY hierarchies and the density matrix $\gamma_{N, t}$ formalism, the convergence of the exact dynamics to the mean-field limit is asserted in the trace norm as $N \rightarrow \infty$, provided that the the mean-field limit $\phi(t, x)$ satisfies the Gross-Pitaevskii equation

[^0]Here $a_{0}$ is the scattering length of the potential $v$, physically, the scattering length measures the effective range of the potential $V$, see e.g., [12] for a precise definition of scattering length. Also in the recent work of Pickl [21], the Gross-Pitaevskii equation is derived using a different method. We refer to reader to [3, 2, 23, (9, 4] for more backgrounds on the problem of approximating the many-body Schrödinger dynamics and related results in the Gross-Pitaveskii regime.

The Hartree-Fock-Bogoliubov type equations are derived in Fock space, which has been used in order to get estimates for the rate of convergence of the approximation to the exact solution. In the mean-field regime, we also refer to the earlier work of Rodnianski and Schlein [23], which gives the convergence rate for marginal densities $\gamma_{N, t}^{(k)}$, and the work of Lewin, Nam and Schlein [19], which gives efficient direct estimates in $L^{2}\left(\mathbb{R}^{N}\right)$ using the Hartree state approach. In the Gross-Pitaveskii regime, we refer to the work of Brennecke and Schlein [6] for explicit rate of condensation.

The ideas behind the use of HFB system is to introduce pair excitations(given by a Bogoliubov transformation $e^{\mathcal{B}}$ ) as a second order correction to the mean field approximation. The exact evolution of (1.1) is approximated by a construction involving two function: the condensate $\phi(t, x)$ and a pair excitation function $k(t, x, y)$, and it is

where

with $a_{x}^{*}$ and $a_{x}$ being the creation and annihilation operator in Fock space, and $e^{-\sqrt{N} \mathcal{A}(\phi)}$ is a unitary operator on Fock space, the Weyl operator. And

The unitary operator $e^{\mathcal{B}(k)}$ is the representation of an real symplectric matrix. Also, $\Omega$ is the vacuum. See for instance [14] for background on this construction.

In order for $\psi_{\text {approx }}$ to be an approximation to the exact evolution, $\phi$ and $k$ must satisfy certain PDEs. They were introduced in [14] and independently in a different context in [1], see also [16], [15] for more details on the argument motivating the use of Hartree-Fock-Bogoliubov type equations. We also mention that in Benedikter, de Oliveira and Schlein [2], a similar approach is considered, where the authors impose the Gross-Pitaevskii equation equation for $\phi$ and define $k$ by an explicit formula, and give a rate of convergence result in terms of the marginal density.

In the remaining of this paper, we shall focus on the analysis of the systems of PDEs. In particular, our main result, which we used in the analysis of nonlinear system, is the estimate for linear Schrödinger equation stated in the next section. The linear estimate in section 2 generalizes the recent work of Chong et al., 2022 [7] to the critical case.

The functions described by these equations are: the condensate $\phi(t, x)$ and the density matrices

Here $(u \circ v)(x, y)=\int u(x, z) v(z, y) d z$, the pair excitation function $k$ is an auxiliary function, which does not explicitly appear in the system.

There are several equivalent ways of expressing the equations, in this section we shall use a compact, matrix formulation as in [7]. We separate the condensate part from the pair interaction part: define $\Gamma_{c}=\bar{\phi} \otimes \phi, \Lambda_{c}=\phi \otimes \phi, \Gamma_{p}=\frac{1}{N} \overline{\operatorname{sh}(k)} \circ \operatorname{sh}(k)$ and $\Lambda_{p}=\frac{1}{2 N} \operatorname{sh}(2 k)$. Also denote $\rho(t, x)=\Gamma(t, x, x)$

To write the Hartree-Fock-Bogoliubov equations in matrix notation, denote

for some Schwarz class potential which will be discussed below. Define

where $I$ is the identity operator.
The evolution equations for $\Psi$ and $\Phi$ are

In addition, the condensate $\phi$ satisfies

Here $A^{*}(x, y)=\bar{A}(y, x),[A, B]=A \circ B-B \circ A$ and $V_{N}$ acts as pointwise multiplication by $V_{N}(x-y)$. See (5.1)-(5.4) for a scalar form of the above equations.

The solutions $\phi, \Lambda_{p}, \Lambda_{c} \Gamma_{p}$ and $\Gamma_{c}$ all depend on $N$. This has been suppressed to simplify the notation. However, we will always keep track of dependence on $N$ in our estimates.

Next we review the conserved quantities of these equations, see [14] for more details. The first conserved quantities is the total number of particles(normalized by division by N):

From here we see that

The second conserved quantity is the energy per particle

The above holds for any Schwarz potential $v$. In addition, in order to use the estimates of [8], we assume
$v$ is spherically symmetric and
$v \geq 0, \frac{\partial v}{\partial r}(r) \leq 0$.
For the initial conditions, we assume that

The size of the initial condition $C_{0}$ is important, as we shall see in the end of section 5 , our assumption on the size of the potential $v$ depends on the size of initial data. Thus, we keep track of the constant $C_{0}$ from now on.

Note that the kinetic energy is

If we assume $E \leq C_{0}$, then we have an $H^{1}$ estimate for $\Lambda$, uniformly in time $(\operatorname{and} N)$ :

Also, $\Gamma$ satisfies the $H^{2}$ type estimate

See [15], 14, as well as [1] for these conserved quantities.
By Plancherel theorem, we see that (1.19) implies that for all time $t$

Here, and also later on, $\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}$ means $\left(1-\Delta_{x}\right)^{\frac{1}{4}}$, which is a Fourier multiplier with symbol $\left(1+|\xi|^{2}\right)^{\frac{1}{4}}$, and similarly for $\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}}$.

Similarly, by (1.18) and Plancherel, we also have

In order to state the main result for this paper in the simplest possible form, we define the following partial Strichartz norms:

Recall $(p, q)$ are admissible in $3+1$ dimensions if $\frac{2}{p}+\frac{3}{q}=\frac{3}{2}, 2 \leq p \leq \infty$.
The main result of this paper is

Theorem 1.1. Let $\Lambda=\Lambda_{p}+\Lambda_{c}$, $\Gamma=\Gamma_{p}+\Gamma_{c}$ be solutions of (1.10), (1.11), while the potential satisfies (1.16) and (2.12) below, and the initial conditions satisfy (1.17). Then we have

for some constant $C$ independent of $N$. The above estimate still hold if we replace $\Lambda$ by $\Lambda_{c}$ or $\Lambda_{p}$, or replace $\Gamma$ by $\Gamma_{c}$ or $\Gamma_{p}$.

We also have a theorem for $\operatorname{sh}(2 k)$ (without dividing by $N$ ).
Theorem 1.2. Let $\Lambda, \Gamma, \phi$ be solutions of (1.10), (1.11), while the potential satisfies (1.16) and (2.12) below, and the initial conditions satisfy (1.17). Assume also that

Remark 1.3. Here (1.27) improves the results in [7], Theorem 1.3 in two ways. First, the potential $N^{2} v(N(x-y))$ we considered here represents a stronger interaction between particles, compared with the $N^{3 \beta-1} v\left(N^{\beta}(x-y)\right), \beta<1$ type potentials considered in [7]. Second, the $\|\operatorname{sh}(2 k)\|_{\mathcal{S}_{x, y}}$ norm stays bounded uniformly in $N$, compared with the $\log N$ growth in 7]. Although our argument is written for the case where the potential is $N^{2} v(N(x-y))$, it also works for the $N^{3 \beta-1} v\left(N^{\beta}(x-y)\right)$ case. For example, the uniform in $N$ estimates in (1.27) still hold for the case where the potential is equal to $N^{3 \beta-1} v\left(N^{\beta}(x-y)\right)$.

The above estimates also imply some estimates for $\operatorname{sh}(k)$. In particular,

$$

This is because $\operatorname{sh}(k)=\frac{1}{2} \operatorname{sh}(2 k) \circ \operatorname{ch}(k)^{-1}$ and $\operatorname{ch}(k)^{-1}$ has bounded operator norm.
Finally, we also have estimates for $\phi$. Define the standard Strichartz spaces

Corollary 1.4. Under the assumptions of Theorem 1.1, and the additional assumption $\left\|\langle\nabla\rangle^{\frac{1}{2}} \phi(0, \cdot)\right\|_{L^{2}} \leq C$, we have

We shall mention the difficulties surrounding equation (1.10) and (1.11). Denote

Schematically, treating $V_{N}$ as $\delta$ and ignoring the constants, the equations become

Recall that $V_{N}(x)=N^{3} v(N x)$, and $\frac{V_{N}}{N}$ in the $\Lambda_{p}$ equation satisfies the critical scaling in the sense that $\frac{V_{N}}{N} \in L^{3 / 2}$ uniformly in $N \geq 1$. In the case of one body problem, there is a vast amount of literature in the study of Schrödinger operators $-\Delta+V$ with critically singular potentials from different aspects see e.g., [24, 22, 18, 5, 17, And $V \in L^{n / 2}$ for dimension $n \geq 3$ is almost the minimal condition to ensure the Schrödinger operators $-\Delta+V$ is bounded from below and self-adjoint.

For the two-body problem in our case, borrowing ideas in [7], our method for treating the nonlinear term requires the Strichartz-type estimates for $\left\langle\nabla_{x}\right\rangle^{\alpha}\left\langle\nabla_{y}\right\rangle^{\alpha} \Lambda_{p}$ or $c$ and $\left\langle\nabla_{x}\right\rangle^{\alpha}\left\langle\nabla_{y}\right\rangle^{\alpha} \Gamma_{p \text { or } c}$ with $\alpha \geq \frac{1}{2}$. However, the $\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}}$ derivative is the threshold for the linear equation in the sense that if we apply $\left\langle\nabla_{x}\right\rangle^{\alpha}\left\langle\nabla_{y}\right\rangle^{\alpha}$ with $\alpha>\frac{1}{2}$ to the terms $\frac{V_{N}}{N} \Lambda_{p}$ or $\frac{V_{N}}{N} \Lambda_{c}$ in the $\Lambda_{p}$ equation, we get a singularity which is essentially $N^{2 \alpha-1} V_{N} \Lambda$. And since $\left\|N^{2 \alpha-1} V_{N}\right\|_{L^{p}} \rightarrow \infty$ as $N \rightarrow \infty$ for any $1 \leq p \leq \infty$, such terms can not be treated using standard techniques.

The structure of the rest of the paper is the following. In section 2, we list the notations used in this paper and state our main estimate, Theorem 2.1 for the linear Schrödinger equation in $6+1$ dimension. In sections 3 and 4 , we prove Theorem 2.1. In section 5 , we prove Theorem 1.1 using the linear estimate Theorem 2.1. In section 6 and section 7, we use prove Theorem 1.2 and Corollary 1.4 In the last section, we use Theorem 2.1 to prove a "collapsing estimate" for the linear equation, which may be of interest on its own right.

## 2. List of notations and statement of the main linear estimates.

Let us define the partial Strichartz norms

Define the full Strichartz norm

& \quad+\underset{(p, q) \text { admissible }}{ }\|\Lambda\|_{L^{p}(d t) L^{q}(d(x-y)) L^{2}(d(x+y)) .}

And define the restricted dual Strichartz norm, excluding the end-points $p^{\prime}=2, p^{\prime}=1$ : let $p_{1}$ large and $p_{0}>2$ but close to 2 , for admissible pairs $(p, q)$, define

Let us also recall the standard Littlewood-Paley decomposition. Let $\phi(x)$ such that $\hat{\phi} \in C_{0}^{\infty}$ and $\hat{\phi}(\xi)=1$ in $|\xi|<1, \hat{\phi}(\xi)=0$ in $|\xi|>2$. Define the $\phi_{k}$ for $k \geq 0$ by $\hat{\phi}_{k}(\xi)=\hat{\phi}\left(\frac{\xi}{2^{k}}\right)$ and denote

If $A \lesssim B$, there is a constant C such that $A \leq C B$, and we use $A \sim B$ to denote the case when $A \lesssim B$ and $B \lesssim A$.

Define $\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} f=\left(1-\Delta_{x}\right)^{\frac{1}{4}} f$ such that the Fourier transform of $\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} f$ is $\left(1+|\xi|^{2}\right)^{\frac{1}{4}} \hat{f}$, and similarly the Fourier transform of $\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} f$ is $\left(1+|\eta|^{2}\right)^{\frac{1}{4}} \hat{f}$ for any $f \in L^{2}\left(\mathbb{R}^{6}\right)$.

Let $x, y \in \mathbb{R}^{3}$, define

Consider the equation

& \quad+N^{2} v(N(x-y)) H(t, x, y)  \tag{2.11}\\
& \Lambda(0, \cdot)=\Lambda_{0}
\end{align*}
$$

where we shall assume that

v \text { is Schwarz } \sup _{1 \leq p \leq \infty}\|v\|_{p}<\varepsilon, \text { and } \operatorname{supp} \hat{v} \subset B_{1}(0) . \tag{2.12}
\end{equation*}

Here $\hat{v}$ denotes the Fourier transform and $B_{1}(0)$ denotes the unit ball in $\mathbb{R}^{3}$, and $\varepsilon$ is a fixed small constant to be specified later which depends on $C_{0}$ in (1.17). The condition $\operatorname{supp} \hat{v} \subset B_{1}(0)$ is essentially not required for our proof, but it can simplify our argument, see the discussion in the beginning of section 4 for more details.

The simplest form of theorem is
Theorem 2.1. Let $\Lambda$ satisfy (2.11), and assume $v$ satisfy (2.12), we have

& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}+\varepsilon\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} H\right\|_{L^{2}(d t) L^{6}(x-y) L^{2}(d(x+y))} \\
& \quad+\varepsilon\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} H\right\|_{\text {collapsing }}+\varepsilon\left\|\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{\text {collapsing }}  \tag{2.13}\\
& \quad+\varepsilon\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} H\right\|_{\text {collapsing }}+\varepsilon\left\|\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} H\right\|_{\text {collapsing }}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Lambda_{0}\right\|_{L^{2}} .

Remark 2.2. The main difficulty in proving the theorem is the presence of the term $N^{2} v(N(x-y)) \Lambda(t, x, y)$, where $N^{2} v\left(N(x-y) \in L^{3 / 2}\right.$ satisfies the critical scaling. The term $N^{2} v(N(x-y)) H(t, x, y)$ in (2.11) is a technical term which arises from the term $N^{2} v(N(x-y)) \Lambda(t, x, y)$, since in our application, we split $\Lambda=\Lambda_{p}+\Lambda_{c}$ and take $\Lambda=\Lambda_{p}$ and $H=\Lambda_{c}$ in (2.11). And the presence of $H(t, x, y)$ does not lead to any essential difficulty in the proof of the above theorem.

We also remark that in the case $H=0$, by using the above theorem plus an abstract argument, one can replace the $\|\cdot\|_{\text {low collapsing }}$ norm on the left side of (2.13) by the $\|\cdot\|_{\text {collapsing }}$ norm and the same result still holds. See the discussion in section 8 for more details.

All the implicit constants in $\lesssim$ are independent of $N$ and $\varepsilon$, and the choice of the small constant $\varepsilon$ in (2.12) will depend on the implicit constants and $C_{0}$ in (1.17).

## 3. Preliminary estimates for solutions to the linear Schrödinger equation.

We will use the following Strichartz estimate. In 6+1 dimensions,
Theorem 3.1 (Theorem 2.4, 2.5 of [8]). Let $\mathbf{S} u=f+g, u(0, \cdot)=u_{0}$. Then

\|u\|_{\mathcal{S}} \lesssim\|f\|_{L^{2}(d t) L^{\frac{6}{5}}(x-y) L^{2}(d(x+y))}+\|g\|_{\mathcal{S}_{r}^{\prime}}+\left\|u_{0}\right\|_{L^{2}}
$$

Now we shall present the main theorem of this section.
Theorem 3.2. Let $\mathbf{S} u=f u(0, \cdot)=0$ Then

\|u\|_{\mathcal{S}_{x, y}} \lesssim\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}+\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} .
$$

Remark 3.3. A frequency localized version of the above Theorem appears in [7], Proposition 4.7, which is also a motivation of the above theorem. The $\mathcal{S}_{x, y}$ norm is crucial here, we do not expect the above estimate to be true if we replace it by the full Strichartz norm $\mathcal{S}$ as in (2.2).

Proof. The main ideas is to divide the frequency support of $u$ into several regions, and use Strichartz estimate for the regions where $\tau \sim|\xi|^{2}+|\eta|^{2}$, and use Sobolev for the remaining regions. As we shall see later, the proof of Theorem 3.4 3.5 below uses essentially the same idea.

To begin with, we shall use the decomposition $u=\sum_{k=0}^{\infty} P_{|\xi-\eta| \sim 2^{k}} u$, where for the case $k=0$, we are abusing notations a bit by letting $P_{|\xi-\eta| \sim 1} u$ to denote the operator $P_{|\xi-\eta|<1} u$. We have the square function estimate(see e.g., Lemma 3.5 in [7]).

\|u\|_{\mathcal{S}_{x, y}} & \sim\left\|\left(\sum_{k=0}^{\infty}\left|P_{|\xi-\eta| \sim 2^{k}} u\right|^{2}\right)^{\frac{1}{2}}\right\|_{\mathcal{S}_{x, y}} \\
& \lesssim\left(\sum_{k=0}^{\infty}\left\|P_{|\xi-\eta| \sim 2^{k}} u\right\|_{\mathcal{S}_{x, y}}^{2}\right)^{\frac{1}{2}} . \tag{3.1}

We shall focus on the dyadic pieces where $k \geq 1$, since by the Strichartz estimate and the Sobolev estimate, one can easily show that

Now let $u_{k}=P_{|\xi-\eta| \sim 2^{k}} u, f_{k}=P_{|\xi-\eta| \sim 2^{k}} f$, and decompose $u_{k}=u_{k}^{1}+u_{k}^{2}+u_{k}^{3}$, where

& \mathcal{F} u_{k}^{2}=\frac{\mathcal{F}\left(P_{10|\tau|^{\frac{1}{2}} \leq 2^{k}} f_{k}\right)}{\tau+|\xi|^{2}+|\eta|^{2}}, \text { this no longer has initial conditions } 0  \tag{3.2}\\
& \mathbf{S} u_{k}^{3}=0, \quad \text { a correction so that } u_{k}^{2}+u_{k}^{3} \text { has initial condition } 0
\end{align*}
$$

For $u_{k}^{1}$, by the Strichartz estimate

$$
\begin{aligned}
\left\|u_{k}^{1}\right\|_{\mathcal{S}} & \lesssim\left\|f_{k}\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))} \\
& \lesssim\left\|f_{k}\right\|_{L^{\frac{6}{5}}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \\
& \lesssim 2^{\frac{k}{2}}\left\|f_{k}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}
\end{aligned}
$$

where in the last line we used the fact that $f_{k}$ is frequency supported in $|\xi-\eta| \sim 2^{k}$ and Bernstein's inequality, which is a (elementary) generalization of the classical Bernstein's inequality to $L^{2}$ valued functions.

Now we make another dyadic decomposition, write

f_{k}=\sum_{\ell \geq 0} P_{|\tau| \sim 2^{2 k+\ell}} f_{k}=\sum_{\ell} f_{k, \ell} \tag{3.3}
\end{equation*}

Note that for each fixed $\ell, k$, we have

\left\|f_{k, \ell}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} & \sim 2^{-\frac{\ell}{4}-\frac{k}{2}}\left\|\left.\partial_{t}\right|^{\frac{1}{4}} f_{k, \ell}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \\
& \lesssim 2^{-\frac{\ell}{4}-\frac{k}{2}}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} P_{|\tau| \sim 2^{2 k+\ell}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}
\end{aligned}
$$

where in the first line we used Bernstein's inequality, and in the second line we used the fact that

\left\|P_{|\xi-\eta| \sim 2^{k}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \lesssim\|f\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \tag{3.4}
\end{equation*}
$$

which can be proved, for example, using the generalized Young's inequality on the space of $L^{2}$ valued functions.

Thus, by Minkowski's inequality

\left(\sum_{k=0}^{\infty}\left\|u_{k}^{1}\right\|_{\mathcal{S}_{x, y}}^{2}\right)^{\frac{1}{2}} & \lesssim\left(\sum_{k=0}^{\infty} 2^{k}\left\|\sum_{\ell} f_{k, \ell}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim \sum_{\ell}\left(\sum_{k=0}^{\infty} 2^{k}\left\|f_{k, \ell}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim \sum_{\ell} 2^{-\frac{\ell}{4}}\left(\sum_{k}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} P_{|\tau| \sim 2^{2 k+\ell}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim \sum_{\ell} 2^{-\frac{\ell}{4}}\left(\left\|\left(\sum_{k} \|\left.\left.\partial_{t}\right|^{\frac{1}{4}} P_{|\tau| \sim 2^{2 k+\ell}} f\right|^{2}\right)^{\frac{1}{2}}\right\|_{\left.L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))\right)}^{2}\right)^{\frac{1}{2}} \\
& \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))},
\end{aligned}
$$

where in the last line we used the square function estimate in $t$ variable.
For $u_{k}^{2}$, the denominator is comparable with $|\xi-\eta|^{2}+|\xi+\eta|^{2} \geq 2^{2 k} \geq 100 \tau$. Thus, by Sobolev's estimates at an angle, which is Lemma 3.2 in [7], we have

& \quad \lesssim\left\|\left\langle\nabla_{x+y}\right\rangle u_{k}^{2}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)}  \tag{3.5}\\
& \quad \lesssim\left\|\left(\left\langle\nabla_{x-y}\right\rangle+\left\langle\nabla_{x+y}\right\rangle\right)^{-2}\left\langle\nabla_{x+y}\right\rangle f_{k}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)}
\end{align*}
$$

This is also the place where we require the norm on the left side to be $\mathcal{S}_{x, y}$, since we do not have Sobolev-type estimates like

Let us first assume $|\xi+\eta| \leq|\xi-\eta|$, and make the decomposition

& \left\|\left(\left\langle\nabla_{x-y}\right\rangle+\left\langle\nabla_{x+y}\right\rangle\right)^{-2}\left\langle\nabla_{x+y}\right\rangle f_{k, j}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)} \\
& \sim 2^{-\frac{j}{2}}\left\|\left\langle\nabla_{x-y}\right\rangle^{-\frac{3}{2}}\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} f_{k, j}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)}  \tag{3.7}\\
& \lesssim 2^{-\frac{j}{2}}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} f_{k, j}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \\
& \lesssim 2^{-\frac{j}{2}}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} P_{|\xi+\eta| \sim 2^{k-j}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}
\end{align*}
$$

where in the third line we used Bernstein's inequality, and in the last line we used the fact that

\left\|f_{k}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \lesssim\|f\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}

Thus, by Minkowski's inequality

&\left(\sum_{k=0}^{\infty}\left\|u_{k}^{2}\right\|_{L^{2}(d t) L^{6}(d x) L^{2}(d y)}^{2}+\left\|u_{k}^{2}\right\|_{L^{2}(d t) L^{6}(d y) L^{2}(d x)}^{2}\right)^{\frac{1}{2}} \\
& \lesssim\left(\sum_{k=0}^{\infty}\left\|\sum_{j}\left(\left\langle\nabla_{x-y}\right\rangle+\left\langle\nabla_{x+y}\right\rangle\right)^{-2}\left\langle\nabla_{x+y}\right\rangle f_{k, j}\right\|_{L^{2}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim \sum_{j}\left(\sum_{k}\left\|\left(\left\langle\nabla_{x-y}\right\rangle+\left\langle\nabla_{x+y}\right\rangle\right)^{-2}\left\langle\nabla_{x+y}\right\rangle f_{k, \ell}\right\|_{L^{2}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim \sum_{j} 2^{-\frac{j}{2}}\left(\sum_{k}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} P_{|\xi+\eta| \sim 2^{k-j}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim \sum_{j} 2^{-\frac{j}{2}}\left(\left\|\left(\sum_{k}\left|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} P_{|\xi+\eta| \sim 2^{k-j}} f\right|^{2}\right)^{\frac{1}{2}}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}
\end{aligned}

where in the last line we used the square function estimate in $x+y$ variable.
The case $|\xi+\eta| \geq|\xi-\eta|$ is similar.
For the other endpoint $p=\infty$, define

& \sim 2^{-\ell / 4}\left\|\left\langle\nabla_{x-y}\right\rangle^{-\frac{3}{2}}\left|\partial_{t}\right|^{\frac{1}{4}} f_{k, \ell}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)}  \tag{3.10}\\
& \lesssim 2^{-\ell / 4}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f_{k, \ell}\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \\
& \lesssim 2^{-\ell / 4}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} P_{|\tau| \sim 2^{2 k-\ell}} f\right\|_{L^{1}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))}

Now let $u_{k}=P_{|\xi-\eta| \sim 2^{k}} u$ and $f_{k}=P_{|\xi-\eta| \sim 2^{k}} f$. We shall use the same decomposition as in (3.2), write $u_{k}=u_{k}^{1}+u_{k}^{2}+u_{k}^{3}$.

For $u_{k}^{1}$, by Strichartz and Bernstein's inequality

The argument below also works for $k<0$.

Now let $u_{k}=P_{|\xi-\eta| \sim 2^{k}} u$ and $f_{k}=P_{|\xi-\eta| \sim 2^{k}} f$. We decompose $u_{k}=u_{k}^{1}+u_{k}^{2}+u_{k}^{3}+u_{k}^{4}$, where

$\mathbf{S} u_{k}^{4}=0, \quad u_{k}^{4}(0, \cdot)=P_{|\xi-\eta| \sim 2^{k}} u_{0}$.
It is easy to handle $u_{k}^{4}$, since in the case where $|\xi+\eta|<|\xi-\eta|$,

\left\|\left|\partial_{t}\right|^{\frac{1}{4}} u_{k}^{2}\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))} \lesssim\left\|\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} f_{k}\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))},
$$

when $|\tau|^{\frac{1}{2}} \geq 10 \cdot 2^{k}$. It remains to show that (3.19) holds if $|\tau|^{\frac{1}{2}} \geq 10 \cdot 2^{k}$, which would be a consequence of (3.20)-(3.22). And as before, the estimates (3.20) and (3.21) in this case follow by Sobolev's estimates at an angle.

To prove (3.22) when $|\tau|^{\frac{1}{2}} \geq 10 \cdot 2^{k}$, first by Sobolev in the $x-y$ direction, we have

& \lesssim 2^{-k / 2}\left\|\left\langle\nabla_{x-y}\right\rangle f_{k}\right\|_{L^{1}(d t) L^{2}(d x) L^{2}(d y)} \\
& \lesssim\left\|\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} f_{k}\right\|_{L^{1}(d t) L^{2}(d x) L^{2}(d y)}
\end{align*}
$$

To deal with $u_{k}^{3}$, note that since $u_{k}^{3}$ is solution to free Schrödinger equation, and since we are assuming $|\xi-\eta|^{2}+|\xi+\eta|^{2} \sim 2^{2 k}$

\begin{align*}
\left\|\left|\partial_{t}\right|^{\frac{1}{4}} u_{k}^{3}\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))} & \lesssim 2^{k / 2}\left\|u_{k}^{3}(0, \cdot, \cdot)\right\|_{L^{2}(d x) L^{2}(d y)} \\
& =2^{k / 2}\left\|u_{k}^{2}(0, \cdot, \cdot)\right\|_{L^{2}(d x) L^{2}(d y)}  \tag{3.27}\\
& \leq 2^{k / 2}\left\|u_{k}^{2}\right\|_{L^{\infty}(d t) L^{2}(d x) L^{2}(d y)}
\end{align*}

Thus, it suffices to control $\left\|u_{k}^{2}\right\|_{L^{\infty}(d t) L^{2}(d x) L^{2}(d y)}$.

& \lesssim 2^{-k / 2}\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{-1} f_{k}\right\|_{L^{2}(d t) L^{2}(d(x-y)) L^{2}(d(x+y))} \\
& \lesssim 2^{-k / 2}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f_{k}\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}
\end{align*}
$$

Similarly,

\left\|u_{k}^{2}\right\|_{L^{\infty}(d t) L^{2}(d x) L^{2}(d y)} & \lesssim\left\|\int\left|\frac{\mathcal{F}\left(P_{|\tau|^{\frac{1}{2}} \geq 10 \cdot 2^{k}} f_{k}\right)}{\tau+|\xi|^{2}+|\eta|^{2}}\right| d \tau\right\|_{L^{2}(d \xi) L^{2}(d \eta)} \\
& \lesssim 2^{-k}\left\|f_{k}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)}  \tag{3.29}\\
& \lesssim 2^{-k / 2}\left\|\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} f_{k}\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))} .
\end{align*}

It remains to show that

for all admissible pairs $(p, q)$, with $\frac{2}{p}=\frac{3}{2}-\frac{3}{q}, 2 \leq p<\infty$.
To prove (3.32) when $|\tau|^{\frac{1}{2}} \geq 10 \cdot 2^{k}$, for admissible pair $(p, q)$ with $p<\infty$,

& \lesssim 2^{-\frac{2 k}{p}}\left\|\mathcal{F}\left(P_{|\tau|^{\frac{1}{2}} \geq 10 \cdot 2^{k}} f_{k}\right)\right\|_{L^{2}(d \xi) L^{2}(d \eta) L^{p}(d \tau)} \\
& \lesssim 2^{-\frac{2 k}{p}}\left\|f_{k}\right\|_{L^{p^{\prime}}(d t) L^{2}(d x) L^{2}(d y)}  \tag{3.34}\\
& \lesssim 2^{-\frac{2 k}{p}} 2^{\left(\frac{3}{2}-\frac{3}{q}\right) k}\left\|f_{k}\right\|_{L^{p^{\prime}}(d t) L^{q^{\prime}}(d x) L^{2}(d y)} \\
& \lesssim\left\|f_{k}\right\|_{L^{p^{\prime}}(d t) L^{q^{\prime}}(d x) L^{2}(d y)} \\
& \lesssim 2^{-k / 2}\left\|\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} f_{k}\right\|_{L^{p^{\prime}}(d t) L^{q^{\prime}}(d x) L^{2}(d y)}

& \lesssim 2^{-k / 2}\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{-1} f_{k}\right\|_{L^{2}(d t) L^{2}(d(x-y)) L^{2}(d(x+y))} \\
& \lesssim 2^{-k / 2}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f_{k}\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}
\end{align*}

The same argument also gives,

\end{equation*}

for the case $10|\tau|^{\frac{1}{2}} \leq 2^{k}$, which would be a consequence of (3.20)-(3.22).
To prove (3.20),

& \lesssim 2^{-k}\left\|f_{k}\right\|_{L^{2}(d t) L^{2}(d x) L^{2}(d y)} \\

& \quad \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} g\right\|_{\mathcal{S}_{r}^{\prime}}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} u_{0}\right\|_{L^{2}} .
\end{aligned}
$$

We will also need
Lemma 3.8. If $\mathbf{S} u=g, u(0, \cdot)=u_{0}$. Then

\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} u\right\|_{\text {collapsing }} \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} g\right\|_{\mathcal{S}_{r}^{\prime}}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} u_{0}\right\|_{L^{2}} \tag{3.38}
\end{equation*}

The proof of Lemma 3.6 and Lemma 3.8 are similar, for simplicity, we shall only present the proof of Lemma 3.8 here. The proof essentially follows from ideas in Lemma 5.1, 5.3 in [15].

Proof. We shall first prove the homogeneous estimate, let $\mathbf{S} u=0$, with $u(0, \cdot)=u_{0}$. Our goal is to show

This is stronger than desired, since $\left\|\left|\nabla_{x}\right|^{\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}} u_{0}\right\|_{L^{2}} \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} u_{0}\right\|_{L^{2}}$, and also by Lemma 3.6, we have

To prove (3.39), let $\widetilde{\Lambda}$ denote the space-time Fourier. For fixed $x-y$, doing CauchySchwarz with measures,

& \lesssim \int \delta\left(\tau-|\xi|^{2}-|\eta|^{2}\right) \frac{|\xi+\eta|}{|\xi||\eta|} d(\xi-\eta)  \tag{3.40}\\
& \lesssim \int \delta\left(\tau-|\xi|^{2}-|\eta|^{2}\right)\left|\nabla_{x}^{\frac{1}{2}} \nabla_{y}^{\frac{1}{2}} \Lambda_{0}(\xi, \eta)\right|^{2} d(\xi-\eta)
\end{align*}
$$

In order to prove the estimate, we must show

\sup _{\tau, \xi} \int \delta\left(\tau-|\xi|^{2}-|\eta|^{2}\right) \frac{|\xi+\eta|}{|\xi||\eta|} d(\xi-\eta) \lesssim 1
$$

Without loss of generality, consider the region $|\xi| \leq|\eta|$. If $|\xi| \sim|\eta|, \frac{|\xi+\eta|}{|\xi||\eta|} \lesssim \frac{1}{|\xi-\eta|}$ and the integral can be evaluated in polar coordinates. If $|\xi| \ll|\eta|$ then $|\xi+\eta| \sim|\xi-\eta|$ Writing $\frac{|\xi+\eta|}{|\xi| \eta \mid} \lesssim \frac{1}{|\xi|} \lesssim \frac{1}{|\xi-\eta| \sqrt{1-\cos (\theta)}}$ where $\theta$ is the angle between $\xi-\eta$ and $\xi+\eta$, we estimate

The inhomogeneous estimate (3.38) just follows from the homogeneous estimate (3.39) and the Christ-Kiselev lemma. More precisely, let $T_{1}=e^{i t\left(\Delta_{x}+\Delta_{y}\right)}$, so $T_{1}: L^{2}\left(\mathbb{R}^{6}\right) \rightarrow$ $L^{p}(d t) L^{q}(d x) L^{2}(d y)$ and

Fix $x-y$ and let $T_{2}: H^{\alpha}(d x) H^{\alpha}(d y) \rightarrow L^{2}(d t) H^{\alpha}(d(x+y))$ be the operator $f \rightarrow$ $\left(e^{i t\left(\Delta_{x}+\Delta_{y}\right)} f\right)(t, x-y, x+y)$. Then the inhomogeneous estimate follows by applying the Christ-Kiselev lemma to $T_{2} T_{1}^{*}$.

Lemma 3.9. If $\mathbf{S} u=g, u(0, \cdot)=u_{0}$. Then

\left\|\left|\partial_{t}\right|^{\frac{1}{4}} u\right\|_{\text {collapsing }} \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} g\right\|_{\mathcal{S}_{r}^{\prime}}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} u_{0}\right\|_{L^{2}} . \tag{3.42}
\end{equation*}
$$

Proof. For the homogeneous estimate, it follows from the same argument as above. However, we can not apply Christ-Kiselev lemma here to get inhomogeneous estimate since $\left|\partial_{t}\right|^{\frac{1}{4}}$ does not commute with $1_{[0, t]}$ when we write out the solution using Duhamel's formula. Let $\mathbf{S} u=g$, with $u(0, \cdot)=0$, it suffices to prove

To prove this, we shall decompose the Fourier support $\tau$ and $|\xi+\eta|$ of $u$ into finitely many regions.

Case 1: $\tau^{\frac{1}{2}} \leq 10(1+|\xi+\eta|)$.

In this case, it suffices to control $u_{1}$ since $u_{2}$ is only supported where $|\tau|=|\xi|^{2}+|\eta|^{2}$. The goodness about $u_{1}$ is that it has the same Fourier support with $f$. The strategy is based on

\left\|\left|\partial_{t}\right|^{\frac{1}{4}} u_{1}\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)}=\left\|\tau^{\frac{1}{4}} \frac{\mathcal{F} f}{\tau+|\xi|^{2}+|\eta|^{2}}\right\|_{L^{\infty}(d(x-y)) L^{2}(d \tau) d(\xi+\eta)} \\
\lesssim\left\|\int|\tau|^{\frac{1}{4}}\left|\frac{\mathcal{F}(f)}{\tau+|\xi|^{2}+|\eta|^{2}}\right| d(\xi-\eta)\right\|_{L^{2}(d \tau d(\xi+\eta))}
\end{gathered}
$$

It suffices to show

$$
\begin{align*}
\| \int|\tau|^{\frac{1}{4}} & \left.\frac{\mathcal{F} f}{\tau+|\xi|^{2}+|\eta|^{2}} \right\rvert\, d(\xi-\eta) \|_{L^{2}(d \tau d(\xi+\eta))}  \tag{3.45}\\
& \lesssim\left\|\left|\nabla_{x}\right|^{\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}} f\right\|_{L^{p^{\prime}}(d t) L^{q^{\prime}}(d x) L^{2}(d y)}
\end{align*}
$$

as well as

\begin{align*}
\| \int|\tau|^{\frac{1}{4}} & \left.\frac{\mathcal{F} f}{\tau+|\xi|^{2}+|\eta|^{2}} \right\rvert\, d(\xi-\eta) \|_{L^{2}(d \tau d(\xi+\eta))}  \tag{3.46}\\
& \lesssim\left\|\left|\nabla_{x}\right|^{\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}} f\right\|_{L^{p^{\prime}}(d t) L^{q^{\prime}}(d y) L^{2}(d x)}
\end{align*}
$$

for all admissible pairs $(p, q)$, where $\frac{2}{p}=\frac{3}{2}-\frac{3}{q}, 2 \leq p<\infty$.
For $2 \leq p<\infty$, by Cauchy-Schwarz, we have

& \lesssim A\left\|\left|\partial_{t}\right|^{\frac{1}{p}-\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}}\left|\nabla_{x}\right|^{\frac{1}{2}-\frac{2}{p}} f\right\|_{L^{2}(d t) d(x-y) d(x+y)}
\end{align*}
$$

where

A=\sup _{\tau, \xi+\eta} \frac{|\tau|^{\frac{3}{4}-\frac{1}{p}}}{|\tau|}\left(\int_{|\xi-\eta|<|\tau|^{\frac{1}{2}}} \frac{|\xi|^{\frac{4}{p}-1}}{|\eta|} d(\xi-\eta)\right)^{\frac{1}{2}} \tag{3.48}
\end{equation*}

Changing variables, this is something like

After a change of variables this is reduced to $\tau=1$, and $A$ is bounded.
Since by Sobolev,

& \quad=\left\|\left|\partial_{t}\right|^{\frac{1}{2}-\frac{1}{p}}\left|\nabla_{x}\right|^{\frac{3}{q}-\frac{3}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}}\left|\nabla_{x}\right|^{\frac{1}{2}} f\right\|_{L^{2}(d t d x d y)}  \tag{3.49}\\
& \quad \lesssim\left\|\left|\nabla_{x}\right|^{\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}} f\right\|_{L^{p^{\prime}}(d t) L^{q^{\prime}}(d x) L^{2}(d y)}

Thus the proof of (3.45) is complete, and the proof of (3.46) is similar.

Case 3: $|\xi|+|\eta|>2|\tau|^{\frac{1}{2}}$

In this case, due to Case 1, we can assume additionally that $|\tau|^{\frac{1}{2}}>10(1+|\xi+\eta|)$. Thus $|\xi-\eta|>|\xi+\eta|$, so also $|\xi-\eta|>|\tau|^{\frac{1}{2}}$. As before, it suffices to show (3.45) and (3.46).

& \lesssim A\left\|\left|\partial_{t}\right|^{\frac{1}{p}-\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}}\left|\nabla_{x}\right|^{\frac{1}{2}-\frac{2}{p}} f\right\|_{L^{2}(d t) d(x-y) d(x+y)}
\end{align*}
$$

In this case,

A^{2}=\sup _{\xi+\eta, \tau} \int_{2|\xi-\eta|>|\xi+\eta|+|\tau|^{\frac{1}{2}}} \frac{|\tau|^{\frac{3}{2}-\frac{2}{p}}}{|\xi-\eta|^{4}} \frac{|\xi|^{\frac{4}{p}-1}}{|\eta|} d(\xi-\eta) \tag{3.51}
\end{equation*}

Again we scale to $|\tau|^{\frac{1}{2}}+|\xi+\eta|=1$ and have to estimate

This is bounded uniformly in $|u|<1$. As before, the rest of the proof follow from Sobolev's inequality, and the proof of (3.46) is similar.

Case $4: \frac{1}{2}(|\xi|+|\eta|)<|\tau|^{\frac{1}{2}}<2(|\xi|+|\eta|)$, In this case, due to Case 1, we can assume additionally that $|\tau|^{\frac{1}{2}}>10(1+|\xi+\eta|)$ so in this case $|\tau|^{\frac{1}{2}} \sim|\xi| \sim|\eta| \sim|\xi-\eta|$.

We shall use the decomposition $u=\sum_{k=0}^{\infty} P_{|\tau| \sim 2^{k}} u$, and the square function estimate

& \lesssim\left(\sum_{k=0}^{\infty} 2^{2 k}\left\|P_{|\tau| \sim 2^{k}} u\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)}\right)^{\frac{1}{2}}
\end{align*}
$$

For each fixed dyadic piece $P_{|\tau| \sim 2^{k}} u$, in the current case, we have

& \lesssim 2^{-k / 2}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} P_{|\eta| \sim 2^{k / 2}} u\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))}
\end{aligned}
$$

where we used Bernstein's inequality in rotated coordinates twice, see e.g., Lemma 3.1 in [7] for more details.

Thus,

& \lesssim\left(\sum_{k=0}^{\infty}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} P_{|\eta| \sim 2^{k / 2}} f\right\|_{\mathcal{S}^{\prime}}^{2}\right)^{\frac{1}{2}}  \tag{3.53}\\
& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} f\right\|_{\mathcal{S}^{\prime}}
\end{align*}
$$

where we used Strichartz (Theorem 3.1) in the second line, and square function estimates in $y$ the the last line.

## 4. Proof of Theorem 2.1.

In this section, we shall see how we can apply the theorems in the previous section to prove Theorem 2.1] Throughout this section, besides (2.12), we shall use extensively the fact that

\operatorname{supp} \hat{v} \subset B_{1}(0)
$$

This assumption implies that, the multiplication operator $T u=v_{N} u$ can at most enlarge the Fourier support of $u$ by a set of size $N$, which will greatly simplify our proof, especially the proof of Theorem 4.1 below. If we assume $v$ satisfies (2.12) without this condition, one can follow similar steps in this section to get the same conclusion. In that case, the multiplication operator $T u=v_{N} u$ can enlarge the Fourier support of $u$ by a set of arbitrary large size, but with a rapidly decay constant if the new Fourier support deviates from the Fourier support of $u$ by a large distance. For the sake of simplicity, we do not present the full details here for this general case.

To begin with, we shall first prove the following theorem involving collapsing norms at low frequency

Theorem 4.1. Let $\Lambda$ satisfy (2.11), we have

& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}+\varepsilon\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} H\right\|_{\text {collapsing }}+\varepsilon\left\|\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{\text {collapsing }}  \tag{4.1}\\
& \quad+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Lambda_{0}\right\|_{L^{2}}
\end{align*}
$$

where the norms $\|\cdot\|_{\text {collapsing }}$ and $\|\cdot\|_{\text {low collapsing }}$ are defined as in (2.8) and (2.9), and $\varepsilon$ is defined as in (2.12).

Remark 4.2. Due to the criticalness of the potential $N^{2} v(N(x-y))$ in (2.11), it is still open to us if one can prove the above theorem without the frequency assumption on $\Lambda$, i.e., to replace on the left side the $\|\cdot\|_{\text {low collapsing }}$ by the full collapsing norm. However, in the case where $\Lambda$ satisfy (2.11) with $H=0$, we do know how to control the full collapsing norm

$$

by using a different argument, the details are given in Section 8. Also in [7, a stronger version of the theorem is proved for the case when one replace $N^{2} v(N(x-y))$ by $N^{3 \beta-1} v\left(N^{\beta}(x-y)\right)$ for some $\beta<1$.

Proof. We shall focus on $\left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{\text {low collapsing }}$, the proof for the term $\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} \Lambda\right\|_{\text {low collapsing }}$ is similar. And we will first show that

& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}+\varepsilon\left\|\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{\text {collapsing }}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Lambda_{0}\right\|_{L^{2}} .
\end{align*}
$$

Let $\rho \in C_{0}^{\infty}\left(\mathbb{R}^{3}\right)$ be a smooth partition of unity, which satisfies

\sum_{j \in \mathbb{Z}^{3}} \rho(\xi-j) \equiv 1, \forall \xi \in \mathbb{R}^{3}
$$

We also assume that $0 \leq \rho \leq 1, \rho \equiv 1$ if $|\xi| \leq \frac{1}{2}$, and $\operatorname{supp} \rho \in B_{1}(0)$, the unit ball in $\mathbb{R}^{3}$ centered at origin. Let $\psi_{j}(x-y)$ be the inverse Fourier transform of $\rho\left(\frac{\xi-\eta}{40 N}-j\right)$. For each fixed $j \in \mathbb{Z}^{3}, \psi_{j}$ is Fourier supported in a ball of radius $40 N$ centered at $40 N \cdot j$. Denote

P_{j} f=\psi_{j} * f
$$

so that the Fourier transform of $P_{j} f=\rho\left(\frac{\xi-\eta}{40 N}-j\right) \hat{f}$. In particular, let $P_{0} f$ denote projection onto ball of radius $40 N$ centered at origin, so that the Fourier transform of $P_{0} f=\rho\left(\frac{\xi-\eta}{40 N}\right) \hat{f}$.

Define

\end{equation*}

It is clear that

\left\|P_{|\xi-\eta|<20 N}\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{\text {collapsing }} \lesssim\left\|P_{0}\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{\text {collapsing }} \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{\mathcal{N}} .
$$

Thus it suffices to show that

& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}+\varepsilon\left\|\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{\text {collapsing }}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Lambda_{0}\right\|_{L^{2}} . \tag{4.4}
\end{align*}

We shall first deal with the last term in the norm, where $k=N$. Note that for each fixed $j \in \mathbb{Z}^{3}$, the Fourier transform in $x-y$ direction of $P_{j}\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda$ is supported in a ball of radius $40 N$, by Bernstein's inequality,

\end{align*}

Recall that

& \quad+ C\left\|N^{2} v(N(x-y))\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))} \\
&+C\left\|\left(\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}+\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}}\right) G\right\|_{\mathcal{S}_{r}^{\prime}} \\
& \quad+C\left\|\left(\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}+\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}}\right) \Lambda_{0}\right\|_{L^{2}},  \tag{4.6}\\
& \leq C \varepsilon\left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))} \\
&+ C \varepsilon N^{-1 / 2}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{L^{\infty}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \\
&+C\left\|\left(\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}+\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}}\right) G\right\|_{\mathcal{S}_{r}^{\prime}} \\
&+C\left\|\left(\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}+\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}}\right) \Lambda_{0}\right\|_{L^{2}}
\end{align*}
$$

where we used Hölder in the second inequality. By choosing $\varepsilon$ small enough such that $C \varepsilon<1 / 2$, we have

& +C\left\|\left(\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}+\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}}\right) G\right\|_{\mathcal{S}_{r}^{\prime}} \\
& +C\left\|\left(\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}+\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}}\right) u_{0}\right\|_{L^{2}},  \tag{4.7}\\
& \leq C \varepsilon N^{-1 / 2}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} H\right\|_{L^{\infty}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \text {, } \\
& +C\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}+C\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} u_{0}\right\|_{L^{2}} .
\end{align*}

If we combine (4.5) and (4.7), we get

## Proof of Theorem 2.1.

To prove Theorem [2.1, it remains to control $\|\Lambda\|_{\mathcal{S}_{x, y}}$, where $\|\cdot\|_{\mathcal{S}_{x, y}}$ is defined as in (2.1).

Case 1. Let us first assume $|\xi+\eta| \geq \frac{N}{10}$, the norms we are going to control are different for the case $|\xi+\eta|<\frac{N}{10}$, but in both cases the norms contains $\|\Lambda\|_{\mathcal{S}_{x, y}}$. In this case, the norm with respect to which the potential is a perturbation should be

The projection on $|\xi+\eta| \geq \frac{N}{10}$ is necessary, as we shall see later in the proof, we do not know how to control the collapsing norms in (4.16) and (4.17) without this assumption.

Let $\rho(t, x)=\Gamma(t, x, x)$.

& +C\left\|\Lambda_{p, T}(t, x, x+z)\right\|_{L^{2}(d t) L^{3}(d x)}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Gamma_{p, T}(t, x, y)\right\|_{L^{4}(d t) L^{3}(d x) L^{2}(d y)} \\
& \leq C\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} \Lambda_{p, T}(t, x, x+z)\right\|_{L^{2}(d t) L^{2}(d x)}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Gamma_{p, T}(t, x, y)\right\|_{L^{4}(d t) L^{3}(d x) L^{2}(d y)} .
\end{aligned}
$$

Thus, by Minkowski integral inequality it suffices to show that

where in the third inequality we used Bernstein's inequality in rotated coordinates along with the fact that $|\xi| \geq 20 N$ and $|\eta| \geq 20 N$.

We continue with estimates for $\left\|\Lambda_{c, T}\right\|_{\mathcal{N}_{2}(\Lambda)}$. This is an easy version of the previous theorem. Using Lemma 3.7.Lemma 3.9 and Strichartz estimates (Theorem 3.1), and then applying Lemma 5.35.5 in this section to handle the nonlinear terms, we get

We want to show that $X(T), Y(T)$ depends continuously on $T$. To see this, for any fixed $T \geq 0$, we have

with 0 initial condition. It is not hard to see that, by crude energy estimates

To handle the inhomogeneous term $-\frac{V_{N}}{2} \Lambda$, we shall need the following lemma.

& \leq C \varepsilon N^{\frac{1}{2}}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} P_{>N} P_{|\xi+\eta|<\frac{N}{10}} \Lambda_{p}\right\|_{L^{6}(d(x-y)) L^{2}(d t) L^{2}(d(x+y))} \\

If we repeat the argument in the proof of Lemma 5.5 and using (5.23), we have

& \quad \leq C \int \left\lvert\, N^{3} v(N z)\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} \Lambda_{p}(t, x, x+z)\right\|_{L^{2}(d t) L^{2}(d x)}\left\|p_{2}\right\|_{L^{4}(d t) L^{3}(d x) L^{2}(d y)} d z\right. \\
& \quad \leq C \varepsilon\|\Lambda\|_{\mathcal{N}_{1}(\Lambda)}\left\|p_{2}\right\|_{L^{4}(d t) L^{3}(d x) L^{2}(d y)}
\end{aligned}
$$

Similarly, we also have

$$
\begin{aligned}
& \left\|\left(V_{N} \bar{\Lambda}_{p}\right) \circ \operatorname{sh}(2 k)\right\|_{L^{\frac{8}{5}}(d t) L^{\frac{4}{3}}(d x) L^{2}(d y)} \\
& \quad \leq C \int \mid N^{3} v(N z) \|\left\langle\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} \Lambda_{p}(t, x, x+z)\left\|_{L^{2}(d t) L^{2}(d x)}\right\| \operatorname{sh}(2 k) \|_{L^{4}(d t) L^{3}(d x) L^{2}(d y)} d z\right. \\
& \quad \leq C \varepsilon\|\Lambda\|_{\mathcal{N}_{1}(\Lambda)}\|\operatorname{sh}(2 k)\|_{L^{4}(d t) L^{3}(d x) L^{2}(d y)}
\end{aligned}
$$

If we choose $\varepsilon$ small enough such that $\varepsilon C \leq \frac{1}{10}$, combing the above estimates, and using the fact that $\left\|\Lambda_{p}\right\|_{\mathcal{N}_{1}(\Lambda)}+\left\|\Lambda_{c}\right\|_{\mathcal{N}_{2}(\Lambda)} \lesssim 1$ from the main theorem of the last section, we get, by Strichartz

\end{align*}
$$

## 7. Estimates for the condensate $\phi$.

The non-linear equation for $\phi$ can be regarded as a linear equation on a background given by $\Gamma$ and $\Lambda$, for which we already have estimates:

&-\int d y\left\{V_{N}\left(x_{1}-y\right) \Gamma_{p}\left(y, x_{1}\right)\right\} \phi(y)  \tag{7.1}\\
& \quad+\int d y\left\{V_{N}\left(x_{1}-y\right) \Lambda_{p}\left(x_{1}, y\right)\right\} \bar{\phi}(y)
\end{align*}
$$

Define the standard Strichartz spaces

\|\phi\|_{\mathcal{S}}=\sup _{(p, q) \text { admissible }}\|\phi\|_{L^{p}(d t) L^{q}(d x)}
$$

Proof. We shall estimate the right hand side of the equation for $\phi$ in dual Strichartz norms, if we repeat the proof of Lemma 5.3•5.5, it is not hard to show

& \left\|\langle\nabla\rangle^{\frac{1}{2}} \int d y\left\{V_{N}\left(x_{1}-y\right) \Gamma(y, y)\right\} \phi\left(x_{1}\right)\right\|_{L^{\frac{8}{5}}(d t) L^{\frac{1}{3}}(d x)} \leq C \varepsilon\left\|\langle\nabla\rangle^{\frac{1}{2} \phi}\right\|_{L^{2}(d t) L^{6}(d x)} \\
& \left\|\langle\nabla\rangle^{\frac{1}{2}} \int d y\left\{V_{N}\left(x_{1}-y\right) \Gamma_{p}\left(y, x_{1}\right)\right\} \phi(y)\right\|_{L^{\frac{8}{\delta}}(d t) L^{\frac{4}{3}}(d x)} \leq C \varepsilon\left\|\langle\nabla\rangle^{\frac{1}{2}} \phi\right\|_{L^{2}(d t) L^{6}(d x)}  \tag{7.2}\\
& \left\|\langle\nabla\rangle^{\frac{1}{2}} \int d y\left\{V_{N}\left(x_{1}-y\right) \Lambda_{p}\left(x_{1}, y\right)\right\} \bar{\phi}(y)\right\|_{L^{\frac{4}{3}}(d t) L^{\frac{L^{\frac{3}{2}}}{2}}(d x)} \leq C \varepsilon\left\|\langle\nabla\rangle^{\frac{1}{2}} \phi\right\|_{L^{4}(d t) L^{3}(d x)} .
\end{align*}
$$

Thus,

\left\|\langle\nabla\rangle^{\frac{1}{2}} \phi\right\|_{\mathcal{S}} \leq C\left\|\langle\nabla\rangle^{\frac{1}{2}} \phi(0, \cdot)\right\|_{L^{2}}+3 C \varepsilon\left\|\langle\nabla\rangle^{\frac{1}{2}} \phi\right\|_{\mathcal{S}} .
$$

This gives us desired result by taking $\varepsilon C \leq \frac{1}{10}$.

## 8. Remarks on the collapsing norm of $\Lambda$.

In this section, we shall see how we can use Theorem 2.1 to prove the following
Theorem 8.1. Let $\Lambda$ satisfy

\mathbf{S} \Lambda(t, x, y)+N^{2} v(N(x-y)) \Lambda(t, x, y)=G(t, x, y), \Lambda(0, \cdot)=\Lambda_{0} \tag{8.1}
\end{equation*}

where we assume $v$ satisfy (2.12), we have

\begin{align*}
& \left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} \Lambda\right\|_{\text {collapsing }}+\left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{\text {collapsing }}  \tag{8.2}\\
& \quad \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}+\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Lambda_{0}\right\|_{L^{2}} .
\end{align*}
$$

Recall that we already have desired estimates if we replace $\|\cdot\|_{\text {collapsing }}$ by $\|\cdot\|_{\text {low collapsing }}$, by using the results in Theorem 2.1.

Proof. We shall first treat the homogeneous equation, let

Let $H=-\Delta_{x}-\Delta_{y}+N^{2} v(N(x-y)), H_{0}=-\Delta_{x}-\Delta_{y}$. If we let $W$ denote the wave operator in Yajima's paper [24], acting in $x-y$ direction, we have $e^{i t H}=W e^{i t H_{0}} W^{*}$,
where * denotes the dual operator. We also have, for the potential $v$ satisfying (2.12), $W$ is a bounded operator from $L^{p} \rightarrow L^{p}$ for any $1 \leq p \leq \infty$, with bound independent of $N$ (see 11 Proposition 5.1). Moreover, by calculating the integral kernel of $W$ explicitly, the $L^{p} \rightarrow L^{p}$ boundness of $W$ extends to the space of $L^{2}$ valued function, ). Thus,

& \sup _{x-y}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} e^{-i t H} \Lambda_{0}\right\|_{L^{2}(d t d(x+y))}+\left.\sup _{x-y}\| \| \frac{\partial}{\partial t}\right|^{1 / 4} e^{-i t H} \Lambda_{0} \|_{L^{2}(d t d(x+y))} \\
& =\sup _{x-y}\left\|W\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} e^{i t H_{0}} W^{*} \Lambda_{0}\right\|_{L^{2}(d t d(x+y))}+\sup _{x-y}\left\|W\left|\frac{\partial}{\partial t}\right|^{1 / 4} e^{i t H_{0}} W^{*} \Lambda_{0}\right\|_{L^{2}(d t d(x+y))} \\
& \lesssim \sup _{x-y}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} e^{i t H_{0}} W^{*} \Lambda_{0}\right\|_{L^{2}(d t d(x+y))}+\sup _{x-y}\left\|\left|\frac{\partial}{\partial t}\right|^{1 / 4} e^{i t H_{0}} W^{*} \Lambda_{0}\right\|_{L^{2}(d t d(x+y))} \\
& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} W^{*} \Lambda_{0}\right\|_{L^{2}(d x d y)},
\end{aligned}
$$

where we used Lemma 3.8 3.9 in the last inequality.
Recall $W^{*}=\lim _{t \rightarrow \infty} e^{i t H_{0}} e^{-i t H}$, where the limit exists in the strong operator topology, see e.g., Proposition 5.1 in [11] and also [13] for a proof of the existence of strong limit when $v$ satisfy (2.12). Thus, for each fixed $g \in C_{0}^{\infty}\left(\mathbb{R}^{6}\right)$ with $\|g\|_{2}=1$

& \left\langle\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} W^{*} \Lambda_{0}, g\right\rangle \\
& =\left\langle W^{*} \Lambda_{0},\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} g\right\rangle \\
& =\lim _{t \rightarrow \infty}\left\langle e^{i t H_{0}} e^{-i t H} \Lambda_{0},\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} g\right\rangle \\
& =\lim _{t \rightarrow \infty}\left\langle e^{-i t H} \Lambda_{0},\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} e^{-i t H_{0}} g\right\rangle  \tag{8.4}\\
& =\lim _{t \rightarrow \infty}\left\langle\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} e^{-i t H} \Lambda_{0}, e^{-i t H_{0}} g\right\rangle \\
& \leq\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} e^{-i t H} \Lambda_{0}\right\|_{L^{\infty}(d t) L^{2}(d x d y)} \\
& \leq\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} e^{-i t H} \Lambda_{0}\right\|_{S_{x, y}} \\
& \leq\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \Lambda_{0}\right\|_{L^{2}}
\end{align*}
$$

where the second equality is a consequence of the existence of strong limit, and in the last inequality we used the special case of Theorem 2.1 with $G=H=0$. By taking supremum among all choices of $g$, we have

Now we shall consider the inhomogeneous equation, let

\mathbf{S} \Lambda(t, x, y)+N^{2} v(N(x-y)) \Lambda(t, x, y)=G(t, x, y), \Lambda(0, \cdot)=0 \tag{8.5}
\end{equation*}
$$

If we let $H$ be defined as above, we have by Duhamel's formula

$$

We shall first show that

& \sup _{x-y}\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} \int_{0}^{t} e^{-i(t-s) H} G(s, \cdot) d s\right\|_{L^{2}(d t d(x+y))} \\
& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}} . \tag{8.6}
\end{align*}
$$

To prove (8.6), it suffices to show that, for any fixed $x-y$ and fixed $T>0$,

\begin{aligned}
& \left\|\chi_{[0, T]}(t)\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} \int_{0}^{t} e^{-i(t-s) H} G(s, \cdot) d s\right\|_{L^{2}(d t d(x+y))} \\
& \quad \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}
\end{aligned}
$$

which, by the Christ-Kiselev lemma, is a consequence of

$$
\begin{align*}
& \left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} \int_{0}^{T} e^{-i(t-s) H} G(s, \cdot) d s\right\|_{L^{2}(d t d(x+y))}  \tag{8.7}\\
& \quad \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}
\end{align*}
$$

If we apply the homogeneous estimates proved above, the left side of (8.7) is bounded by

\begin{align*}
& \left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \int_{0}^{T} e^{i s H} G(s, \cdot) d s\right\|_{L^{2}(d x d y)} \\
& \quad=\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} e^{i T H} \int_{0}^{T} e^{-i(T-s) H} G(s, \cdot) d s\right\|_{L^{2}(d x d y)}  \tag{8.8}\\
& \quad \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} \int_{0}^{T} e^{-i(T-s) H} G(s, \cdot) d s\right\|_{L^{2}(d x d y)} \\
& \quad \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}
\end{align*}
$$

where in the third line we used the special case of Theorem 2.1 with $G=H=0$ (estimates for the homogeneous equation), and in the last line we used the special case of Theorem 2.1 with $\Lambda_{0}=H=0$ (inhomogeneous equation with zero initial data).

To prove inhomogeneous estimate for $\left|\partial_{t}\right|^{\frac{1}{4}}$ derivative, as before we can not use the Christ-Kiselev lemma, we shall follow the ideas in the prove of Lemma 3.9. Write $\Lambda=$ $\Lambda_{1}+\Lambda_{2}$, where

\begin{aligned}
& \mathbf{S} \Lambda_{1}=G(t, x, y), \quad \text { with initial conditions } 0 \\
& \mathbf{S} \Lambda_{2}=-N^{2} v(N(x-y)) \Lambda(t, x, y), \quad \text { with initial conditions } 0
\end{aligned}
$$

For both $\Lambda_{1}$ and $\Lambda_{2}$, it suffices to consider the region where

$$
\begin{equation*}
\tau^{\frac{1}{2}} \geq 10(1+|\xi+\eta|),|\xi| \geq 20 N,|\eta| \geq 20 N \text { and }|\xi-\eta| \geq 20 N \tag{8.9}
\end{equation*}
$$

since otherwise we have $\left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda\right\|_{\text {collapsing }} \lesssim\left\|\left\langle\nabla_{x+y}\right\rangle^{\frac{1}{2}} \Lambda\right\|_{\text {collapsing }}$, or we already know how to control collapsing norm when $|\xi|<20 N,|\eta|<20 N$, or $|\xi-\eta|<20 N$.

The estimate for $\Lambda_{1}$ just follows from Lemma 3.9 directly, and for $\Lambda_{2}$, we claim that it suffices to show

Proposition 8.2. Let $\mathbf{S} u=f$ with $u(0, \cdot)=0$, then if the Fourier support $\tau, \xi, \eta$ of $u$ satisfy (8.9), we have

& \left\|\left|\partial_{t}\right|^{\frac{1}{4}} u\right\|_{\text {collapsing }} \lesssim \min \left\{\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}\right.  \tag{8.10}\\
& \left.\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}+N^{-\frac{1}{2}}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f\right\|_{L^{2}(d t d x d y)}\right\}
\end{align*}
$$

Remark 8.3. Note that the $\tau$ support of $u$ may be different from $f$, so $\tau$ support of $f$ may not satisfy (8.9), but the $\xi, \eta$ support of $f$ does satisfy (8.9).

We shall first see how we can apply the Proposition to get desired results.
Case 1: $|\xi+\eta| \geq \frac{N}{10}$.
In this case,

Thus, by Proposition 8.2

& \left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda_{2}\right\|_{\text {collapsing }} \\
& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} N^{2} v(N(x-y)) P_{|\xi| \geq 19 N} P_{|\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))} \\
& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} P_{|\xi| \geq 19 N} P_{|\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))}
\end{aligned}
$$

where in the last inequality we used the fact that when $|\xi| \geq 19 N,|\eta| \geq 19 N,\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}}$ essentially only fall on $\Lambda$, as well as Hölder's inequality. Recall that when $|\xi+\eta|>\frac{N}{10}$, the last line appears as part of the norm for $\Lambda$ in the proof of Theorem 2.1 (see (4.15)), thus it is bounded by $\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}$ for $\Lambda$ satisfying (8.5).

Case 2: $|\xi+\eta|<\frac{N}{10}$.
In this case,

\mathbf{S} P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 20 N} \Lambda_{2} \sim-N^{2} v(N(x-y)) P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 19 N} \Lambda(t, x, y)
$$

Thus, by Proposition 8.2

& \left\|\left|\partial_{t}\right|^{\frac{1}{4}} \Lambda_{2}\right\|_{\text {collapsing }} \\
& \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} N^{2} v(N(x-y)) P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))} \\
& \quad+\left\|\left|\partial_{t}\right|^{\frac{1}{4}} N^{\frac{3}{2}} v(N(x-y)) P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t d x d y)} \\
& \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))} \\
& \quad+N^{\frac{1}{2}}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))} \\
& \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} P_{|\xi+\eta|<\frac{N}{10}} P_{|\xi-\eta| \geq 19 N} \Lambda(t, x, y)\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))}
\end{aligned}
$$

where in the second inequality we used the fact that when $|\xi-\eta| \geq 19 N,\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}}$ essentially only fall on $\Lambda$, as well as Hölder's inequality. And in the last inequality we used Bernstein's inequality and the fact that $|\xi-\eta| \geq 20 N$.

Recall that when $|\xi+\eta|<\frac{N}{10}$, the last line appears as part of the norm for $\Lambda$ in the proof of Theorem 2.1 (see (4.40) ), thus it is bounded by $\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} G\right\|_{\mathcal{S}_{r}^{\prime}}$ for $\Lambda$ satisfying (8.5).

Thus it remains to prove Proposition 8.2, to see this, we shall follow the ideas in the proof of Lemma 3.9,

Proof of Proposition 8.2.
Case 1: If $|\tau|^{\frac{1}{2}}>2(|\xi|+|\eta|)$.

Write $u=u^{1}+u^{2}$, where

$$
\begin{align*}
\mathcal{F} u^{1} & =\frac{\mathcal{F} f}{\tau+|\xi|^{2}+|\eta|^{2}}, \text { this no longer has initial conditions } 0  \tag{8.11}\\
\mathbf{S} u^{2} & =0, \quad \text { a correction so that } u^{1}+u^{2} \text { has initial condition } 0
\end{align*}
$$

In this case, it suffices to control $u_{1}$ since $u_{2}$ is only supported where $|\tau|=|\xi|^{2}+|\eta|^{2}$. The goodness about $u_{1}$ is that it has the same Fourier support with $f$. The strategy is based on

$$
\begin{gather*}
\left\|\left|\partial_{t}\right|^{\frac{1}{4}} u_{1}\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)}=\left\|\tau^{\frac{1}{4}} \frac{\mathcal{F} f}{\tau+|\xi|^{2}+|\eta|^{2}}\right\|_{L^{\infty}(d(x-y)) L^{2}(d \tau d(\xi+\eta))} \\
\lesssim\left\|\int|\tau|^{\frac{1}{4}}\left|\frac{\mathcal{F}(f)}{\tau+|\xi|^{2}+|\eta|^{2}}\right| d(\xi-\eta)\right\|_{L^{2}(d \tau d(\xi+\eta))} \tag{8.12}
\end{gather*}
$$

By Cauchy-Schwarz, we have

$$
\begin{align*}
& \operatorname{RHS}(8.12)  \tag{8.13}\\
& \lesssim\left\|\frac{|\tau|^{\frac{1}{4}}}{|\tau|} \int_{|\xi-\eta|<|\tau|^{\frac{1}{2}}}|\mathcal{F} f| d(\xi-\eta)\right\|_{L^{2}(d \tau d(\xi+\eta))} \\
& \lesssim A\left\|\left|\nabla_{y}\right|^{\frac{1}{2}}\left|\nabla_{x}\right|^{-\frac{1}{2}} f\right\|_{L^{2}(d t d(x-y) d(x+y))}
\end{align*}
$$

where

$$
\begin{equation*}
A=\sup _{\tau, \xi+\eta} \frac{|\tau|^{\frac{1}{4}}}{|\tau|}\left(\int_{|\xi-\eta|<|\tau|^{\frac{1}{2}}} \frac{|\xi|}{|\eta|} d(\xi-\eta)\right)^{\frac{1}{2}} \tag{8.14}
\end{equation*}
$$

Changing variables, this is something like

$$
A=\sup _{\tau,|u|<|\tau|^{\frac{1}{2}}} \frac{|\tau|^{\frac{1}{4}}}{|\tau|}\left(\int_{|v|<|\tau|^{\frac{1}{2}}} \frac{|u+v|}{|u-v|} d v\right)^{\frac{1}{2}}
$$

After a change of variables this is reduced to $\tau=1$, and $A$ is bounded. By Sobolev's estimate at an angle, we have

$$
\left\|\left|\nabla_{y}\right|^{\frac{1}{2}}\left|\nabla_{x}\right|^{-\frac{1}{2}} f\right\|_{L^{2}(d t d(x-y) d(x+y))} \lesssim\left\|\left|\nabla_{x}\right|^{\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}
$$

Similarly, by Cauchy-Schwarz, we have

$$
\begin{align*}
& \operatorname{RHS}(8.12)  \tag{8.15}\\
& \lesssim\left\|\frac{|\tau|^{\frac{1}{4}}}{|\tau|} \int_{|\xi-\eta|<|\tau|^{\frac{1}{2}}}|\mathcal{F} f| d(\xi-\eta)\right\|_{L^{2}(d \tau d(\xi+\eta))} \\
& \lesssim A\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left|\nabla_{x-y}\right|^{-\frac{1}{2}} f\right\|_{L^{2}(d t) d(x-y) d(x+y)}
\end{align*}
$$

where

$$
\begin{equation*}
A=\sup _{\tau, \xi+\eta} \frac{1}{|\tau|}\left(\int_{|\xi-\eta|<|\tau|^{\frac{1}{2}}}|\xi-\eta| d(\xi-\eta)\right)^{\frac{1}{2}} \tag{8.16}
\end{equation*}
$$

which is bounded. By Sobolev's inequality, we have

$$
\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left|\nabla_{x-y}\right|^{-\frac{1}{2}} f\right\|_{L^{2}(d t) d(x-y) d(x+y)} \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left|\nabla_{x-y}\right|^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))} .
$$

Case 2: $|\xi|+|\eta|>2|\tau|^{\frac{1}{2}}$
In this case, since we are assuming that $|\tau|^{\frac{1}{2}}>10(1+|\xi+\eta|)$. we have $|\xi-\eta|>|\xi+\eta|$, and also $|\xi-\eta|>|\tau|^{\frac{1}{2}}$. As before, it suffices to bound the right hand side of (8.12). By Cauchy-Schwarz

$$
\begin{align*}
& \operatorname{RHS}(8.12) \\
& \lesssim\left\|\int_{2|\xi-\eta|>|\xi+\eta|+|\tau|^{\frac{1}{2}}} \left\lvert\, \frac{|\tau|^{\frac{1}{4}}|\mathcal{F} f|}{|\xi-\eta|^{2}} d(\xi-\eta)\right.\right\|_{L^{2}(d \tau d(\xi+\eta))}  \tag{8.17}\\
& \lesssim A\left\|\left|\nabla_{y}\right|^{\frac{1}{2}}\left|\nabla_{x}\right|^{-\frac{1}{2}} f\right\|_{L^{2}(d t d(x-y) d(x+y))} \\
& \lesssim A\left\|\left|\nabla_{x}\right|^{\frac{1}{2}}\left|\nabla_{y}\right|^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}
\end{align*}
$$

where we used Sobolev's estimate at an angle in the last inequality. In this case,

$$
\begin{equation*}
A^{2}=\sup _{\xi+\eta, \tau} \int_{2|\xi-\eta|>|\xi+\eta|+|\tau|^{\frac{1}{2}}} \frac{|\tau|^{\frac{1}{2}}}{|\xi-\eta|^{4}} \frac{|\xi|}{|\eta|} d(\xi-\eta) \tag{8.18}
\end{equation*}
$$

Again we scale to $|\tau|^{\frac{1}{2}}+|\xi+\eta|=1$ and have to estimate

$$
\int_{|v|>1} \frac{1}{|v|^{4}} \frac{|u+v|}{|u-v|} d v
$$

This is bounded uniformly in $|u|<1$.
Similarly, since we are assuming $|\xi-\eta| \geq 20 N$, by Cauchy-Schwarz

$$
\begin{aligned}
& \operatorname{RHS}(8.12) \\
& \lesssim \int_{|\xi-\eta| \geq 20 N} \frac{|\tau|^{\frac{1}{4}}|\mathcal{F} f|}{|\xi-\eta|^{2}} d(\xi-\eta) \|_{L^{2}(d \tau d(\xi+\eta))} \\
& \lesssim N^{-\frac{1}{2}}\left\|\left|\partial_{t}\right|^{\frac{1}{4}} f\right\|_{L^{2}(d t d(x-y) d(x+y))}
\end{aligned}
$$

Case $4: \frac{1}{2}(|\xi|+|\eta|)<|\tau|^{\frac{1}{2}}<2(|\xi|+|\eta|)$, In this case, since we are assuming that $|\tau|^{\frac{1}{2}}>10(1+|\xi+\eta|)$, this implies $|\tau|^{\frac{1}{2}} \sim|\xi| \sim|\eta| \sim|\xi-\eta|$.

We shall use the decomposition $u=\sum_{k=0}^{\infty} P_{|\tau| \sim 2^{k}} u$, and the square function estimate

$$
\begin{align*}
&\left\|\left|\partial_{t}\right|^{\frac{1}{4}} u\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)} \\
& \sim\left\|\left(\left.\left.\sum_{k=0}^{\infty}\left|P_{|\tau| \sim 2^{k}}\right| \partial_{t}\right|^{\frac{1}{4}} u\right|^{2}\right)^{\frac{1}{2}}\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)}  \tag{8.19}\\
& \lesssim\left(\sum_{k=0}^{\infty} 2^{2 k}\left\|P_{|\tau| \sim 2^{k}} u\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)}\right)^{\frac{1}{2}}
\end{align*}
$$

For each fixed dyadic piece $P_{|\tau| \sim 2^{k}} u$, in the current case, we have

$$
P_{|\tau| \sim 2^{k}} u=P_{|\tau| \sim 2^{k}} P_{|\xi| \sim 2^{k / 2}} P_{|\eta| \sim 2^{k / 2}} u,
$$

which implies

$$
\begin{aligned}
\left\|\mid P_{|\tau| \sim 2^{k}} u\right\|_{\text {collapsing }} & \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}} P_{|\xi| \sim 2^{k / 2}} P_{|\eta| \sim 2^{k / 2}} u\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))} \\
& \lesssim 2^{-k / 2}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} P_{|\eta| \sim 2^{k / 2}} u\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))}
\end{aligned}
$$

where we used Bernstein's inequality in rotated coordinates twice, see e.g., Lemma 3.1 in (7). Thus,

$$
\begin{align*}
& \left\|\left|\partial_{t}\right|^{\frac{1}{4}} u\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)} \\
& \lesssim\left(\sum_{k=0}^{\infty}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} P_{|\eta| \sim 2^{k / 2}} u\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}} \\
& \lesssim\left(\sum_{k=0}^{\infty}\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} P_{|\eta| \sim 2^{k / 2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}}  \tag{8.20}\\
& \lesssim\left\|\left\langle\nabla_{x}\right\rangle^{\frac{1}{2}}\left\langle\nabla_{y}\right\rangle^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}
\end{align*}
$$

where we used Strichartz (Theorem3.1) in the second line, and square function estimates in $y$ the the last line.

Similarly, for each fixed dyadic piece $P_{|\tau| \sim 2^{k}}\left|\partial_{t}\right|^{\frac{1}{4}} u$, in this case since $|\xi-\eta| \sim 2^{\frac{k}{2}}$, by Bernstein's inequality, we have

$$
\begin{align*}
& \left\|\left.\left|P_{|\tau| \sim 2^{k}}\right| \partial_{t}\right|^{\frac{1}{4}} u\right\|_{\text {collapsing }} \\
& \quad \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} P_{|\xi-\eta| \sim 2^{\frac{k}{2}}} u\right\|_{L^{2}(d t) L^{6}(d(x-y)) L^{2}(d(x+y))}  \tag{8.21}\\
& \quad \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} P_{|\xi-\eta| \sim 2^{\frac{k}{2}}} f\right\|_{\left.L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))\right)^{\prime}},
\end{align*}
$$

where in the last inequality we used Theorem 3.5. Thus,

$$
\begin{align*}
& \left\|\left.\partial_{t}\right|^{\frac{1}{4}} u\right\|_{L^{\infty}(d(x-y)) L^{2}(d(x+y) d t)} \\
& \lesssim\left(\sum_{k=0}^{\infty}\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} P_{|\xi-\eta| \sim 2^{\frac{k}{2}}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}^{2}\right)^{\frac{1}{2}}  \tag{8.22}\\
& \lesssim\left\|\left|\partial_{t}\right|^{\frac{1}{4}}\left\langle\nabla_{x-y}\right\rangle^{\frac{1}{2}} f\right\|_{L^{2}(d t) L^{\frac{6}{5}}(d(x-y)) L^{2}(d(x+y))}
\end{align*}
$$

where we used square function estimates in $x-y$ the the last line.
