# DECOMPOSITION OF THE REGULAR REPRESENTATION FOR DIHEDRAL QUANDLES

#### Abstract

We decompose the regular quandle representation of a dihedral quandle $\mathcal{R}_{n}$ into irreducible quandle subrepresentations.


## 1. Introduction

Let $\mathcal{R}_{n}$ be the dihedral quandle of order $n$, and let $\mathbb{C} \mathcal{R}_{n}$ be the $\mathbb{C}$-vector space of all $\mathbb{C}$-valued functions on $\mathcal{R}_{n}$. Then $\mathbb{C} \mathcal{R}_{n}$ has the structure of a quandle representation of $\mathcal{R}_{n}$, which we call the regular representation of $\mathcal{R}_{n}$. In this note we provide, for all positive integers $n$, the decomposition of this regular representation into irreducible quandle subrepresentations. This problem was first addressed using the notion of a quandle ring in [2] in 2019, although the results given there are incomplete and do not address dihedral quandles of odd order. Our main result here was recently reported by one of the authors at the Knots in Washington Meeting on April 23, 2022, and will be included in a more comprehensive forthcoming publication on the representation theory of quandles. The authors would also like to note the recent arxiv submission [7], where these results are obtained with a different approach for the dihedral quandles of even order.

## 2. Review of Racks and Quandles

We give a quick review of racks and quandles in this section.
Definition 2.1. $[3,5,6]$ A rack is a set $X$ provided with a binary operation

$$
\begin{array}{cccc}
\triangleright: & X \times X & \longrightarrow & X \\
(x, y) & \longmapsto & x \triangleright y
\end{array}
$$

such that
(i) for all $x, y \in X$, there is a unique $z \in X$ such that $y=z \triangleright x$;
(ii) (right distributivity) for all $x, y, z \in X$, we have $(x \triangleright y) \triangleright z=(x \triangleright z) \triangleright(y \triangleright z)$.

For $x \in X$, we denote by $R_{x}: X \rightarrow X$ the map given by

$$
R_{x}(y)=y \triangleright x .
$$

Observe that property (i) also reads that for any fixed element $x \in X$, the map $R_{x}$ is a bijection. Also, notice that the right distributivity condition is equivalent to the relation $R_{x}(y \triangleright z)=R_{x}(y) \triangleright R_{x}(z)$ for all $y, z \in X$; that is, $R_{x}$ is an automorphism of the quandle $X$.

Unless otherwise stated, we will always assume our racks (or quandles) to be finite racks (or quandles).

Definition 2.2. A quandle is a rack such that $x \triangleright x=x, \forall x \in X$.

As each $R_{x}$ permutes the elements of $X$, we can consider the subgroup $\left\langle R_{x}\right\rangle_{x \in X}$ in $S_{X}$ (the symmetric group on $X$ ) generated by the $R_{x}$, which we denote by $\operatorname{Inn}(X)$ (the group of inner automorphisms of $X$ ). This group acts on the set $X$, and so the group action partitions $X$ into distinct orbits. We say the quandle $X$ is connected if $\operatorname{Inn}(X)$ acts transitively on $X$ (and hence there is only one orbit). If ( $X, \triangleright)$ and $(Y, \triangleright)$ are two quandles, a map $f: X \rightarrow Y$ is a quandle homomorphism if $f(x \triangleright y)=f(x) \triangleright f(y)$ for all $x, y \in X$.

Example 2.3. Any group $G$ with the operation $x \triangleright y=y x y^{-1}$ is a quandle, called conjugation quandle and denoted by $\operatorname{Conj}(\mathrm{G})$.
Example 2.4. Any group $G$ with the operation $x \triangleright y=y x^{-1} y$ is a quandle, called the Core quandle of $G$ and denoted Core(G).
Example 2.5. Let $G$ be a group and $f \in \operatorname{Aut}(G)$. Then one can define a quandle structure on $G$ by $x \triangleright y=f\left(x y^{-1}\right) y$. It is called a generalized Alexander quandle. If $G$ is abelian, the operation becomes $x \triangleright y=f(x)+(I d-f)(y)$, where $I d$ stands for the identity map. This quandle is called an Alexander quandle.
Example 2.6. The set $\mathcal{R}_{n}=\{1,2, \ldots, n\}$, with quandle operation $x \triangleright y=2 y-x(\bmod n)$ is a quandle, called a dihedral quandle. This is an Alexander quandle on the the group $\mathbb{Z}_{n}$ where $f$ is multiplication by -1 .
For the remainder of this manuscript, $\mathcal{R}_{n}$ will denote the dihedral quandle of order $n$.

## 3. Representation theory

As mentioned in the introduction, the results here will be included in a later manuscript providing more results for the (complex) representation theory of (finite) quandles. The terminology used here to describe this theory is adapted from group representation theory, a topic for which there is a wealth of literature. There are many accessible introductions to this topic; see, for example, Chapters 4 and 5 of [4].

All vector spaces henceforth are defined over $\mathbb{C}$. For any positive integer $k$, we set $\omega_{k}=e^{2 \pi i / k}$. A representation of a finite quandle $(X, *)$ on a finite dimensional complex vector space $V$ is a quandle homomorphism $\rho: X \rightarrow \operatorname{Conj}(G L(V))$. In other words, for all $x, y \in X$, we have $\rho(x * y)=\rho(y) \rho(x) \rho(y)^{-1}$. To simplify the notation, we will denote $\rho(x)$ by just $\rho_{x}$. Let $V$ and $W$ be two representations of a quandle $X$. If $\rho^{V}: X \rightarrow \operatorname{Conj}(G L(V))$ and $\rho^{W}: X \rightarrow \operatorname{Conj}(G L(W))$ are two representations of $X$, then a linear map $\phi: V \rightarrow W$ for which the following square commutes

for all $x$ is called an intertwiner. If, furthermore, $\phi$ is an isomorphism then we say that the two representations are isomorphic as representations of $X$, or equivalent. If $\phi: V \hookrightarrow W$ is the inclusion of the linear subspace $V$ into $W$, then we say that $V$ is a subrepresentation of $W$. Equivalently, a subspace $U$ of $W$ is a subrepresentation of $W$ if $U$ is invariant under $\rho^{W}(X)$.

A representation $V$ of a quandle $X$ is called irreducible if its only quandle subrepresentations are $\{0\}$ and $V$. A representation ia called indecompasable if it cannot be written as direct sum of nontrivial subrepresentations.

If $\phi: \operatorname{Inn}(X) \rightarrow \operatorname{Aut}(V)$ is a group homomorphism, then the induced map

$$
\begin{gathered}
\tilde{\phi}: X \rightarrow \operatorname{Conj}(\operatorname{Aut}(V)), \\
\tilde{\phi}(x):=\phi\left(R_{x}\right),
\end{gathered}
$$

is a quandle homomorphism. Therefore any group representation $\operatorname{lnn}(X)$ induces a quandle representation of $X$.

## 4. The regular representation of a quandle

For any finite quandle $X$, we denote by $\mathbb{C} X$ the $\mathbb{C}$-vector space of $\mathbb{C}$-valued functions on $X$; equivalently it is the $\mathbb{C}$-vector space generated by basis vectors $\left\{e_{x}\right\}_{x \in X}$, whose elements are formal sums $f=\sum_{x \in X} a_{x} e_{x}, a_{x} \in \mathbb{C}$. The regular representation of $X$ is

$$
\lambda: X \rightarrow \operatorname{Conj}(G L(\mathbb{C} X)),
$$

where $\lambda_{t}(f)(x):=f\left(R_{t}^{-1}(x)\right)$. This action of $X$ is equivalent to the right $X$-action on $\mathbb{C} X$ given by the linear extension of $e_{x} \cdot t=e_{R_{t}(x)}=e_{x * t}$. We note that a subspace $W$ of $\mathbb{C} X$ is a quandle subrepresentation of $\mathbb{C} X$ if and only if $W$ is a subrepresentation of $\mathbb{C} X$ as a group representation of $\operatorname{Inn}(X)$. If a distinction is necessary, we will refer to a vector space as either a quandle representation or a group representation. If two vector spaces $U, V$ are isomorphic as quandle representations of $X$, we will write $U \cong_{X} V$; if they are isomorphic as group representations of some group $G$, we will write $U \cong_{G} V$.

When $|X| \geq 2$, The regular representation always has two nontrivial subrepresentations, one of which is always irreducible: the one-dimensional subspace $\mathbb{C} 1$, where $\mathbf{1}$ is the constant function $\mathbf{1}(x)=1$, for all $x \in X$. Its vector space complement, $(\mathbb{C} 1)^{\perp}$, is also a subrepresentation, since $(\mathbb{C} 1)^{\perp}=\left\{\sum_{x \in X} a_{x} e_{x} \mid \sum a_{x}=0\right\}$, and action by any $t \in X$ only permutes the coefficients $a_{x}$. So $\mathbb{C} X$ decomposes into a direct sum of subrepresentations

$$
\mathbb{C} X=\mathbb{C} \mathbf{1} \oplus(\mathbb{C} 1)^{\perp}
$$

For $x, y \in X$ let $v_{x y}=e_{x}-e_{y}$. If we enumerate $X=\left\{x_{1}, \ldots, x_{n}\right\}$, then a basis for $(\mathbb{C} 1)^{\perp}$ is $\left\{v_{x_{1} x_{2}}, v_{x_{2} x_{3}}, \ldots, v_{x_{n-1} x_{n}}\right\}$.

## 5. The regular representation of a dihedral quandle

The rest of this paper is devoted to the regular quandle representation of a dihedral quandle $\mathcal{R}_{n}$. We first explicitly describe some quandle representations of $\mathcal{R}_{n}$.

Since quandle subrepresentations of $\mathbb{C} \mathcal{R}_{n}$ are in correspondence with group subrepresentations of $\mathbb{C} \mathcal{R}_{n}$ (under the action of $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$ ), we obtain the full decomposition of $\mathbb{C} \mathcal{R}_{n}$ as a quandle representation of $\mathcal{R}_{n}$ by finding the decomposition as a group representation of $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$. We note that this correspondence between group and quandle representations does not hold in general, but it is characteristic of the regular representation. In general, there is no reason to expect any correspondence or similarity between quandle representations of a quandle $X$ and group representations of $\operatorname{Inn}(X)$.

By virtue of the aforementioned correspondence, and the fact that the group $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$ is a dihedral group, we will consider in detail the representation theory of dihedral groups. We will let $D_{m}$ be the dihedral group of order $2 m$. Then it is shown in [1] that

$$
\operatorname{Inn}\left(\mathcal{R}_{n}\right) \cong \begin{cases}D_{n / 2}, & n \text { even } \\ D_{n}, & n \text { odd }\end{cases}
$$

We describe the (isomorphism classes of) finite-dimensional irreducible group representations of the dihedral group $D_{m}$ here, to facilitate statement of results below. The dihedral group $D_{m}$ has a presentation given by

$$
\left.D_{m}=\langle\alpha, \beta||\alpha|=|\beta|=2,|\alpha \beta|=m\right\rangle .
$$

We fix generators $\alpha, \beta$ for this presentation. The classification of the finite-dimensional irreducible group representations of $D_{m}$ falls into two cases: $m$ even and $m$ odd. If $\lambda, \mu \in \mathbb{C}$, we will denote by $\mathbb{C}(\lambda, \mu)$ the one-dimensional group representation of $D_{m}$ on which $\alpha$ and $\beta$ act by scalar multiplication by $\lambda$ and $\mu$, respectively. And for nonzero $\lambda \in \mathbb{C}$, we will denote by $W(\lambda)$ the two-dimensional group representation of $D_{m}$ for which the matrix representations of $\alpha$ and $\beta$ are

$$
\alpha \mapsto\left[\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right], \quad \beta \mapsto\left[\begin{array}{cc}
0 & \lambda \\
\lambda^{-1} & 0
\end{array}\right] .
$$

With this notation fixed, we provide the classification of the finite-dimensional irreducible group representations of $D_{m}$. All such group representations are either 1- or 2- dimensional, and are listed here:

| $D_{m}$ | $m$ even | $m$ odd |
| :---: | :---: | :---: |
| 1-dimensional <br> group representations | $\mathbb{C}(1,1), \mathbb{C}(1,-1)$, <br> $\mathbb{C}(-1,1), \mathbb{C}(-1,-1)$ | $\mathbb{C}(1,1), \mathbb{C}(-1,-1)$ |
| 2-dimensional <br> group representations | $W\left(\omega_{m}^{s}\right)$, <br> $1 \leq s \leq m / 2-1$ | $W\left(\omega_{m}^{s}\right)$, <br> $1 \leq s \leq(m-1) / 2$ |

We will denote by $\Gamma\left(D_{m}\right)$ the set of (isomorphism classes of) finite-dimensional irreducible group representations of $D_{m}$. For example, $D_{8}$ has 4 representations of dimension 1 and 4 irreducible representations of dimension 2 , and they are

$$
\Gamma\left(D_{8}\right)=\left\{\mathbb{C}( \pm 1, \pm 1), \quad \mathbb{C}( \pm 1, \mp 1), \quad W\left(\omega_{8}\right), \quad W\left(\omega_{8}^{2}\right), \quad W\left(\omega_{8}^{3}\right)\right\}
$$

while $D_{9}$ has 2 representations of dimension 1 and 3 irreducible representations of dimension 2 , and they are

$$
\Gamma\left(D_{9}\right)=\left\{\mathbb{C}( \pm 1, \pm 1), \quad W\left(\omega_{9}\right), \quad W\left(\omega_{9}^{2}\right), \quad W\left(\omega_{9}^{3}\right), \quad W\left(\omega_{9}^{4}\right)\right\} .
$$

Since $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$ is a dihedral group generated by $R_{1}$ and $R_{2}$, these group representations also provide us with examples of 1-dimensional and 2 -dimensional irreducible quandle representations of $\mathcal{R}_{n}$. We will make this precise as follows: let $\mathbb{C}(\lambda, \mu)$ be the 1-dimensional representation of $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$ for which $R_{1}$ and $R_{2}$ act by scalar multiplication by $\lambda$ and $\mu$, respectively, and let $W(\lambda)$ be the two-dimensional representation of $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$ for which $R_{1}$ and $R_{2}$ have matrix representations

$$
R_{1} \mapsto\left[\begin{array}{cc}
0 & 1 \\
1 & 0
\end{array}\right], \quad R_{2} \mapsto\left[\begin{array}{cc}
0 & \lambda \\
\lambda^{-1} & 0
\end{array}\right] .
$$

Now we consider the regular quandle representation $\mathbb{C} \mathcal{R}_{n}$ of $\mathcal{R}_{n}$ and the subrepresentation $(\mathbb{C} 1)^{\perp}$, in cases $n$ even or $n$ odd. In either case, $(\mathbb{C} 1)^{\perp}$ is spanned by $\left\{v_{i j}\right\}_{1 \leq i, j \leq n}$.

If $n=2 r$ is even, $\mathcal{R}_{n}$ has two orbits: the even orbit $\{2,4, \ldots, 2 r\}$, and the od $\bar{d}$ orbit $\{1,3, \ldots, 2 r-1\}$. Let

$$
\Phi_{n, 0}=\operatorname{sp}\left\{v_{i j}\right\}_{i \neq j \text { even }}, \quad \Delta_{n, 0}=\left\{v_{24}, v_{46}, \ldots, v_{2 r-2} 2 r\right\},
$$

and

$$
\Phi_{n, 1}=\operatorname{sp}\left\{v_{i j}\right\}_{i \neq j \text { odd }}, \quad \Delta_{n, 1}=\left\{v_{13}, v_{35}, \ldots, v_{2 r-32 r-1}\right\}
$$

We call $\Phi_{n, 0}$ and $\Phi_{n, 1}$ the even and odd subspaces, respectively, of $(\mathbb{C} 1)^{\perp}$. For $i=0,1$, $\Delta_{n, i}$ is a basis for $\Phi_{n, i}$.

If $n$ is odd, $\mathcal{R}_{n}$ has a single orbit. In this case, we set

$$
\Phi_{n}=\operatorname{sp}\left\{v_{i j}\right\}_{i \neq j}, \quad \Delta_{n}=\left\{v_{12}, v_{23}, \ldots, v_{n-1 n}\right\}
$$

and $\Delta_{n}$ is a basis for $\Phi_{n}$. Because the orbits of $\mathcal{R}_{n}$ are as described above, all of the subspaces $\Phi_{n, i}, \Phi_{n}$ are quandle subrepresentations of $\mathbb{C} \mathcal{R}_{n}$.

Theorem 5.1. If $n$ is even, then the decomposition of the regular representation $\mathbb{C} \mathcal{R}_{n}$ of $\mathcal{R}_{n}$ into irreducible quandle subrepresentations is, for $n \equiv 0 \bmod 4$,

$$
\mathbb{C} \mathcal{R}_{n} \cong \mathcal{R}_{n} \mathbb{C}(1,1)^{\oplus 2} \oplus \mathbb{C}( \pm 1, \mp 1) \bigoplus_{s=1}^{n / 4-1} W\left(\omega_{n / 2}^{s}\right)^{\oplus 2}
$$

and for $n \equiv 2 \bmod 4$,

$$
\mathbb{C} \mathcal{R}_{n} \cong \mathcal{R}_{n} \mathbb{C}(1,1)^{\oplus 2} \bigoplus_{s=1}^{(n-2) / 4} W\left(\omega_{n / 2}^{s}\right)^{\oplus 2}
$$

If $n$ is odd, then the decomposition of $\mathbb{C} \mathcal{R}_{n}$ into irreducible quandle subrepresentations of $\mathcal{R}_{n}$ is

$$
\mathbb{C} \mathcal{R}_{n} \cong{ }_{\mathcal{R}_{n}} \mathbb{C}(1,1) \bigoplus_{s=1}^{(n-1) / 2} W\left(\omega_{n}^{2 s}\right)
$$

Proof. For arbitrary $n$, let $\hat{\mathbf{1}}=\sum_{i=1}^{n}(-1)^{i} e_{i} \in(\mathbb{C} \mathbf{1})^{\perp}$. Then, as already pointed out before, $\mathbb{C} \mathcal{R}_{n}$ decomposes as $\mathbb{C} \mathcal{R}_{n}=\mathbb{C} \mathbf{1} \oplus(\mathbb{C} \mathbf{1})^{\perp}$, and $\mathbb{C} \mathbf{1} \cong_{\mathcal{R}_{n}} \mathbb{C} \hat{\mathbf{1}} \cong_{\mathcal{R}_{n}} \mathbb{C}(1,1)$. We proceed distinguishing the cases $n$ even or $n$ odd.

Case 1: $n$ is even. Let $n=2 r$. In this case, each $\Phi_{n, i}$ (for $i=0,1$ ) is a subrepresentation of $\mathbb{C} \mathcal{R}_{n}$ of dimension $r-1$, and $(\mathbb{C} 1)^{\perp}$ decomposes into $\mathcal{R}_{n}$-subrepresentations as

$$
(\mathbb{C} \mathbf{1})^{\perp}=\mathbb{C} \hat{\mathbf{1}} \oplus \Phi_{n, 0} \oplus \Phi_{n, 1}
$$

Now set $\left[a_{1}, \ldots, a_{r-1}\right]_{0}=\sum_{i=1}^{r-1} a_{i} v_{2 i, 2 i+2}$ (the coordinate vector in the basis $\Delta_{n, 0}$ ). The right multiplication operators $R_{1}$ and $R_{2}$ together generate all of $\operatorname{Inn}\left(\mathcal{R}_{n}\right) \cong D_{n / 2}$, and with respect to the basis $\Delta_{n, 0}$, the matrix representations of these operators on $\Phi_{n, 0}$ are

$$
\left[R_{1}\right]_{\Delta_{n, 0}}=\left[\begin{array}{ccccc}
0 & 0 & \cdots & 0 & -1  \tag{1}\\
0 & 0 & \cdots & -1 & 0 \\
\vdots & \vdots & . \cdot & \vdots & \vdots \\
0 & -1 & \cdots & 0 & 0 \\
-1 & 0 & \cdots & 0 & 0
\end{array}\right], \quad\left[R_{2}\right]_{\Delta_{n, 0}}=\left[\begin{array}{ccccc}
1 & 0 & \cdots & 0 & 0 \\
1 & 0 & \cdots & 0 & -1 \\
\vdots & \vdots & . & \vdots & \vdots \\
1 & 0 & \cdots & 0 & 0 \\
1 & -1 & \cdots & 0 & 0
\end{array}\right]
$$

For example, for $n=12$, we have

$$
\begin{gathered}
R_{1}\left(\left[a_{1}, a_{2}, a_{3}, a_{4}, a_{5}\right]_{0}\right)=\left[-a_{5},-a_{4},-a_{3},-a_{2},-a_{1}\right]_{0} \\
R_{2}\left(\left[a_{1}, a_{2}, a_{3}, a_{4}, a_{5}\right]_{0}\right)=\left[a_{1}, a_{1}-a_{5}, a_{1}-a_{4}, a_{1}-a_{3}, a_{1}-a_{2}\right]_{0}
\end{gathered}
$$

For $1 \leq s \leq r-1$, let

$$
\mathbf{u}_{s}:=\left[1-\omega_{r}^{s}, 1-\left(\omega_{r}^{s}\right)^{2}, \cdots, 1-\left(\omega_{r}^{s}\right)^{r-1}\right]_{0}=\sum_{i=1}^{r-1}\left(1-\left(\omega_{r}^{s}\right)^{i}\right) v_{2 i, 2 i+2}, \quad \text { and } \quad \mathbf{v}_{s}:=R_{1}\left(\mathbf{u}_{s}\right)
$$

Then $\mathbf{v}_{s}=\sum_{i=1}^{r-1}\left(\left(\omega_{r}^{s}\right)^{r-i}-1\right) v_{2 i, 2 i+2}$, and

$$
\begin{aligned}
R_{2}\left(\mathbf{u}_{s}\right) & =\sum_{i=1}^{r-1}\left(\left(\omega_{r}^{s}\right)^{r+1-i}-\omega_{r}^{s}\right) v_{2 i, 2 i+2} \\
& =\omega_{r}^{s} \sum_{i=1}^{r-1}\left(\left(\omega_{r}^{s}\right)^{r-i}-1\right) v_{2 i, 2 i+2} \\
& =\omega_{r}^{s} \mathbf{v}_{s}
\end{aligned}
$$

Since all $R_{i}$ are involutions, we also have $R_{2}\left(\mathbf{v}_{s}\right)=\left(\omega_{r}^{-1}\right)^{s} \mathbf{u}_{s}$. Let $U_{s, 0}$ be the subspace of $\Phi_{n, 0}$ spanned by $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$. The above identities show that each $U_{s, 0}$ is a quandle subrepresentation of $\Phi_{n, 0}$. If $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$ are linearly dependent, then $U_{s, 0}$ is a 1-dimensional quandle subrepresentation. And if $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$ are linearly independent, the matrix representations of $R_{1}$ and $R_{2}$ with respect to the basis $\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}$ are

$$
\left[R_{1}\right]_{\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}}=\left[\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right], \quad\left[R_{2}\right]_{\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}}=\left[\begin{array}{cc}
0 & \omega_{r}^{s} \\
\omega_{r}^{-s} & 0
\end{array}\right]
$$

which gives us $U_{s, 0} \cong W\left(\omega_{r}^{s}\right)$ (both an $\mathcal{R}_{n}$-quandle and an $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$-group isomorphism). From the identity $\left(\omega_{r}^{r-s}\right)^{\ell}=\left(\omega_{r}^{s}\right)^{-\ell}$ (for any integers $\ell, s$ ), we obtain $\mathbf{u}_{s}=-\mathbf{v}_{r-s}$, for $1 \leq s \leq r-1$. Therefore $U_{s, 0}=U_{r-s, 0}, 1 \leq s \leq r-1$. And since each $W\left(\omega_{r}^{s}\right)$ is an irreducible group representation for $\operatorname{Inn}\left(\mathcal{R}_{n}\right)$ for $1 \leq s \leq r-1$, it follows that $U_{s, 0} \cong \cong_{\mathcal{R}_{n}} U_{v, 0}$ if and only if $s=v$, for $1 \leq s, v \leq\lfloor r / 2\rfloor$, and $U_{s, 0} \cap U_{v, 0}=\{0\}$ for $1 \leq s \neq v \leq\lfloor r / 2\rfloor$. We summarize these results here:

For $r$ even, $U_{\ell, 0} \cap U_{s, 0}=\{0\}$ for $1 \leq \ell \neq s \leq r / 2$, and $\operatorname{dim}\left(U_{s, 0}\right)=\left\{\begin{array}{ll}2, & 1 \leq s<r / 2 \\ 1, & s=r / 2\end{array}\right.$.
For $r$ odd, $U_{\ell, 0} \cap U_{s, 0}=\{0\}$ for $1 \leq \ell \neq s \leq(r-1) / 2$, and $\operatorname{dim}\left(U_{s, 0}\right)=2$ for all $s$.
Hence we obtain a decomposition of $\Phi_{n, 0}$ into irreducible quandle subrepresentations:

$$
\Phi_{n, 0} \cong_{\mathcal{R}_{n}} \bigoplus_{s=1}^{\lfloor r / 2\rfloor} U_{s, 0} \cong_{\mathcal{R}_{n}} \begin{cases}W\left(\omega_{r}\right) \oplus \cdots \oplus W\left(\omega_{r}^{r / 2-1}\right) \oplus \mathbb{C}(-1,1), & r \text { even } \\ W\left(\omega_{r}\right) \oplus \cdots \oplus W\left(\omega_{r}^{(r-1) / 2}\right), & r \text { odd }\end{cases}
$$

The decomposition of $\Phi_{n, 1}$ is achieved in an similar fashion - with a few small changes. We first replace $R_{1}, R_{2}$ with $R_{n / 2}$ and $R_{1}$, respectively. The matrix representations of these transformations, with respect to the basis $\Delta_{n, 1}$, are given by

$$
\left[R_{n / 2}\right]_{\Delta_{n, 1}}=\left[\begin{array}{ccccc}
0 & 0 & \cdots & 0 & -1  \tag{2}\\
0 & 0 & \cdots & -1 & 0 \\
\vdots & \vdots & . & \vdots & \vdots \\
0 & -1 & \cdots & 0 & 0 \\
-1 & 0 & \cdots & 0 & 0
\end{array}\right], \quad\left[R_{1}\right]_{\Delta_{n, 1}}=\left[\begin{array}{ccccc}
1 & 0 & \cdots & 0 & 0 \\
1 & 0 & \cdots & 0 & -1 \\
\vdots & \vdots & . & \vdots & \vdots \\
1 & 0 & \cdots & 0 & 0 \\
1 & -1 & \cdots & 0 & 0
\end{array}\right]
$$

Then we define

$$
\begin{aligned}
\mathbf{u}_{s} & :=\left[1-\omega_{r}^{s}, 1-\left(\omega_{r}^{s}\right)^{2}, \cdots, 1-\left(\omega_{r}^{s}\right)^{r-1}\right]_{1} \\
& =\sum_{i=1}^{r-1}\left(1-\left(\omega_{r}^{s}\right)^{i}\right) v_{2 i-1,2 i+1}, \quad \text { and } \mathbf{v}_{s}:=\omega_{r}^{-s} R_{n / 2}\left(\mathbf{u}_{s}\right)
\end{aligned}
$$

Then we can show that $R_{1}\left(\mathbf{u}_{s}\right)=\mathbf{v}_{s}$, and since

$$
R_{2}=R_{n / 2+2}=R_{n / 2 \triangleright 1}=R_{1} R_{n / 2} R_{1}^{-1}=R_{1} R_{n / 2} R_{1}
$$

we have $R_{2}\left(\mathbf{u}_{s}\right)=R_{1} R_{n / 2} R_{1}\left(\mathbf{u}_{s}\right)=\omega_{r}^{s} \mathbf{v}_{s}$. For $1 \leq s \leq r-1$, we define $U_{s, 1}$ to be the subspace of $\Phi_{n, 1}$ spanned by $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$. Then, as above, we have

$$
\operatorname{dim}\left(U_{s, 1}\right)= \begin{cases}1, & s=r / 2, r \text { even } \\ 2, & s \neq r / 2\end{cases}
$$

and for $s \neq r / 2$, the matrix representations of $R_{1}$ and $R_{2}$ are

$$
\left[R_{1}\right]_{\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}}=\left[\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right], \quad\left[R_{2}\right]_{\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}}=\left[\begin{array}{cc}
0 & \omega_{r}^{s} \\
\omega_{r}^{-s} & 0
\end{array}\right]
$$

This shows

$$
\Phi_{n, 1} \cong \bigoplus_{s=1}^{\lfloor r / 2\rfloor} U_{s, 1} \cong \mathcal{R}_{n} \begin{cases}W\left(\omega_{r}\right) \oplus \cdots \oplus W\left(\omega_{r}^{r / 2-1}\right) \oplus \mathbb{C}(1,-1), & r \text { even } \\ W\left(\omega_{r}\right) \oplus \cdots \oplus W\left(\omega_{r}^{(r-1) / 2}\right), & r \text { odd }\end{cases}
$$

For $r$ even $(n \equiv 0 \bmod 4)$, the one-dimensional quandle subrepresentations of $\mathbb{C} \mathcal{R}_{n}$ are:

$$
\mathbb{C} \mathbf{1} \cong \mathbb{C}(1,1), \quad \mathbb{C} \hat{\mathbf{1}} \cong \mathbb{C}(1,1), \quad U_{r / 2,0} \cong \mathbb{C}(-1,1), \quad U_{r / 2,1} \cong \mathbb{C}(1,-1)
$$

and the two-dimensional irreducible quandle subrepresentations are $U_{s, 0} \cong U_{s, 1} \cong W\left(\omega_{r}^{s}\right)$, $1 \leq s \leq r / 2-1$.

For $r$ odd $(n \equiv 2 \bmod 4)$, the one-dimensional quandle subrepresentations of $\mathbb{C} \mathcal{R}_{n}$ are:

$$
\mathbb{C} \mathbf{1} \cong \mathbb{C}(1,1) \quad \text { and } \quad \mathbb{C} \hat{\mathbf{1}} \cong \mathbb{C}(1,1)
$$

and the two-dimensional irreducible quandle subrepresentations are $U_{s, 0} \cong U_{s, 1} \cong W\left(\omega_{r}^{s}\right)$, $1 \leq s \leq(r-1) / 2$.

Case 2: $n$ odd. Let $n=2 r+1$. With respect to the basis $\Delta_{n}=\left\{v_{12}, v_{23}, \ldots, v_{n-1, n}\right\}$, the elements $R_{1}, R_{2} \in \operatorname{Inn}\left(\mathcal{R}_{n}\right)$ have matrix representations

$$
\left[R_{1}\right]_{\Delta_{n}}=\left[\begin{array}{ccccc}
0 & \cdots & 0 & -1 & 1 \\
0 & \cdots & -1 & 0 & 1 \\
\vdots & . \cdot & \vdots & \vdots & \vdots \\
-1 & 0 & \cdots & 0 & 1 \\
0 & 0 & \cdots & 0 & 1
\end{array}\right], \quad\left[R_{2}\right]_{\Delta_{n}}=\left[\begin{array}{ccccc}
1 & 0 & \cdots & 0 & 0 \\
1 & 0 & \cdots & 0 & -1 \\
\vdots & \vdots & . \cdot & \vdots & \vdots \\
1 & 0 & \cdots & 0 & 0 \\
1 & -1 & \cdots & 0 & 0
\end{array}\right]
$$

For $1 \leq s \leq n-1$, let

$$
\mathbf{u}_{s}=\left[1-\omega_{n}^{s}, 1-\left(\omega_{n}^{s}\right)^{2}, \cdots, 1-\left(\omega_{n}^{s}\right)^{n-1}\right], \quad \text { and } \quad \mathbf{v}_{s}=R_{1}\left(\mathbf{u}_{s}\right)
$$

We can then show that $\mathbf{v}_{s}=\omega_{n}^{-s}\left(\omega_{n}^{-s}-1,\left(\omega_{n}^{-s}\right)^{2}-1, \ldots,\left(\omega_{n}^{-s}\right)^{n-1}-1\right)$.
Let $U_{s}$ be the subspace of $\Phi_{n}$ spanned by $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$. We can show that $\mathbf{u}_{s}=\mathbf{v}_{n-s}$, hence $U_{s}=U_{n-s}$. Furthermore, we have

$$
\begin{aligned}
R_{2}\left(\mathbf{u}_{s}\right) & =R_{2}\left(1-\omega_{n}^{s}, 1-\left(\omega_{n}^{s}\right)^{2}, \ldots, 1-\left(\omega_{n}^{s}\right)^{n-1}\right) \\
& =\left(1-\omega_{n}^{s},\left(\omega_{n}^{s}\right)^{n-1}-\omega_{n}^{s},\left(\omega_{n}^{s}\right)^{n-2}-\omega_{n}^{s}, \ldots,\left(\omega_{n}^{s}\right)^{2}-\omega_{n}^{s}\right) \\
& =\omega_{n}^{2 s} \omega_{n}^{-s}\left(\omega_{n}^{-s}-1,\left(\omega_{n}^{-s}\right)^{2}-1, \ldots,\left(\omega_{n}^{-s}\right)^{n-1}-1\right) \\
& =\omega_{n}^{2 s} \mathbf{v}_{s} .
\end{aligned}
$$

Therefore, if $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$ are linearly independent, the matrix representations of $R_{1}$ and $R_{2}$ with respect to the basis $\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}$ of $U_{s}$ are again

$$
\left[R_{1}\right]_{\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}}=\left[\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right], \quad\left[R_{2}\right]_{\left\{\mathbf{u}_{s}, \mathbf{v}_{s}\right\}}=\left[\begin{array}{cc}
0 & \omega_{n}^{2 s} \\
\omega_{n}^{-2 s} & 0
\end{array}\right],
$$

We can show linear independence of $\mathbf{u}_{s}$ and $\mathbf{v}_{s}$ for $1 \leq s \leq r$, which gives us the decomposition

$$
(\mathbb{C} \mathbf{1})^{\perp}=\bigoplus_{s=1}^{r} U_{s}
$$

and we obtain the desired decomposition into irreducible representations

$$
\mathbb{C} \mathcal{R}_{n} \cong \mathbb{C}(1,1) \bigoplus_{s=1}^{r} W\left(\omega_{n}^{2 s}\right)
$$

Examples. The decomposition of $\mathbb{C} \mathcal{R}_{n}$ given in Theorem 5.1 falls into 3 cases: $n \equiv$ $0 \bmod 4, n \equiv 2 \bmod 4$, and $n$ odd. We provide three examples below, one for each of these cases, wherein we provide the decomposition and all irreducible subrepresentations of $\mathbb{C} \mathcal{R}_{10}, \mathbb{C} \mathcal{R}_{11}$, and $\mathbb{C} \mathcal{R}_{12}$ :

Regular quandle representation of $\mathcal{R}_{10}$ :

$$
\mathbb{C R}_{10}=\mathbb{C} \mathbf{1} \oplus \overbrace{\mathbb{C} \hat{\mathbf{1}} \oplus \underbrace{U_{1,0} \oplus U_{2,0}}_{\Phi_{10,0}} \oplus \underbrace{U_{1,1} \oplus U_{2,1}}_{\Phi_{10,1}}}^{(\mathbb{C} 1)^{\perp}}
$$

subrep of $\mathbb{C} \mathcal{R}_{10} \quad$ irrep of $D_{5}$ generated by dimension

| $\mathbb{C} \mathbf{1}$ | $\cong \mathbb{C}(1,1)$ | $\mathbf{1}$ | 1 |
| :--- | :--- | :--- | :--- |
| $\mathbb{C} \hat{\mathbf{1}}$ | $\cong \mathbb{C}(1,1)$ | $\hat{\mathbf{1}}$ | 1 |
| $U_{1,0}$ | $\cong W\left(\omega_{5}\right)$ | $\sum_{i=1}^{4}\left(1-\omega_{5}^{i}\right) v_{2 i, 2 i+2}$ | 2 |
| $U_{2,0}$ | $\cong W\left(\omega_{5}^{2}\right)$ | $\sum_{i=1}^{4}\left(1-\omega_{5}^{2 i}\right) v_{2 i, 2 i+2}$ | 2 |
| $U_{1,1}$ | $\cong W\left(\omega_{5}\right)$ | $\sum_{i=1}^{4}\left(1-\omega_{5}^{i}\right) v_{2 i-1,2 i+1}$ | 2 |
| $U_{2,1}$ | $\cong W\left(\omega_{5}^{2}\right)$ | $\sum_{i=1}^{4}\left(1-\omega_{5}^{2 i}\right) v_{2 i-1,2 i+1}$ | 2 |

Regular quandle representation of $\mathcal{R}_{11}$ :

$$
\mathbb{C} \mathcal{R}_{11}=\mathbb{C} 1 \oplus \overbrace{U_{1} \oplus U_{2} \oplus U_{3} \oplus U_{4} \oplus U_{5}}^{(\mathbb{C} 1)^{\perp}}
$$

| subrep of $\mathbb{C} \mathcal{R}_{11}$ | irrep of $D_{11}$ | generated by | dimension |
| :---: | :--- | :--- | :---: |
| $\mathbb{C} \mathbf{1}$ | $\cong \mathbb{C}(1,1)$ | $\mathbf{1}$ | 1 |
| $U_{1}$ | $\cong W\left(\omega_{11}^{2}\right)$ | $\sum_{i=1}^{8}\left(1-\omega_{11}^{2 i}\right) e_{i}$ | 2 |
| $U_{2}$ | $\cong W\left(\omega_{11}^{4}\right)$ | $\sum_{i=1}^{8}\left(1-\omega_{11}^{4 i}\right) e_{i}$ | 2 |
| $U_{3}$ | $\cong W\left(\omega_{11}^{6}\right)$ | $\sum_{i=1}^{8}\left(1-\omega_{11}^{6 i}\right) e_{i}$ | 2 |
| $U_{4}$ | $\cong W\left(\omega_{11}^{8}\right)$ | $\sum_{i=1}^{8}\left(1-\omega_{11}^{8 i}\right) e_{i}$ | 2 |
| $U_{5}$ | $\cong W\left(\omega_{11}^{10}\right)$ | $\sum_{i=1}^{8}\left(1-\omega_{11}^{10 i}\right) e_{i}$ | 2 |

Regular quandle representation of $\mathcal{R}_{12}$ :

$$
\mathbb{C} \mathcal{R}_{12}=\mathbb{C} \mathbf{1} \oplus \overbrace{\mathbb{C} \hat{\mathbf{1}} \oplus \underbrace{U_{1,0} \oplus U_{2,0} \oplus U_{3,0}}_{\Phi_{12,0}} \oplus \underbrace{U_{1,1} \oplus U_{2,1} \oplus U_{3,1}}_{\Phi_{12,1}}}^{\perp}
$$

subrep of $\mathbb{C} \mathcal{R}_{12} \quad$ irrep of $D_{6}$ generated by dimension

| $\mathbb{C} \mathbf{1}$ | $\cong \mathbb{C}(1,1)$ | $\mathbf{1}$ | 1 |
| :--- | :--- | :--- | :--- |
| $\mathbb{C} \hat{\mathbf{1}}$ | $\cong \mathbb{C}(1,1)$ |  | 1 |
| $U_{1,0}$ | $\cong W\left(\omega_{6}\right)$ | $\sum_{i=1}^{5}\left(1-\omega_{6}^{i}\right) v_{2 i, 2 i+2}$ | 2 |
| $U_{2,0}$ | $\cong W\left(\omega_{6}^{2}\right)$ | $\sum_{i=1}^{5}\left(1-\omega_{6}^{2 i}\right) v_{2 i, 2 i+2}$ | 2 |
| $U_{3,0}$ | $\cong \mathbb{C}(-1,1)$ | $\sum_{i=1}^{5}\left(1-(-1)^{i}\right) v_{2 i, 2 i+2}$ | 1 |
| $U_{1,1}$ | $\cong W\left(\omega_{6}\right)$ | $\sum_{i=1}^{5}\left(1-\omega_{6}^{i}\right) v_{2 i-1,2 i+1}$ | 2 |
| $U_{2,1}$ | $\cong W\left(\omega_{6}^{2}\right)$ | $\sum_{i=1}^{5}\left(1-\omega_{6}^{2 i}\right) v_{2 i-1,2 i+1}$ | 2 |
| $U_{3,1}$ | $\cong \mathbb{C}(1,-1)$ | $\sum_{i=1}^{5}\left(1-(-1)^{i}\right) v_{2 i-1,2 i+1}$ | 1 |
