Nonlinear corrections in the quantization of a weakly nonideal Bose gas at zero temperature. II. The general case

Abstract

In the present paper, discussion of the canonical quantization of a weakly nonideal Bose gas at zero temperature within the framework of the Bogolyubov approach is continued. Contrary to the previous paper on this subject, here the two-body interaction potential is considered in the general form. It is shown that in such a case consideration of the first nonlinear correction also leads to the automatic particle number conservation without any additional assumptions or modification of the resulting effective Hamiltonian.

1 Introduction

In the renowned paper [1], N.N. Bogolyubov proposed an approach to quantize a weakly non-ideal Bose gas at zero temperature, which led to explanation of the superfluidity phenomenon at microscopic level. Over the following years, the method of Bogolyubov was actively studied and developed, see, for example, reviews [2–4] and books [5–7] for a detailed discussion of the topic.

However, the method in its original form has a well-known drawback, which is a nonconservation of particle number in the effective theory describing quasi-particles, the latter manifests itself through nondiagonal terms in the resulting quadratic effective Hamiltonian. There exist several standard methods to solve this problem (see, for example, discussion in [3]), in some of which the unphysical nondiagonal part of the effective Hamiltonian is simply included into background energy of the system. Meanwhile, one should mention some fairly new approaches, which provide the particle number conservation in more consistent ways, as well as their generalizations.

The first approach is to deal with a system with a well-defined number of particles [8], which is achieved by removing the terms that violate the U(1) symmetry by means of a projection operator (see also [9] for a different approach leading to the same results). Later, both approaches [8,9] were generalized [10], including for the cases of n-component systems [11,12].

The second approach was proposed in papers [13, 14], in which a special particle number conserving ansatz (the Leggett ansatz) for the ground state was used. Later, this approach was also generalized to the inhomogeneous [15] and time-dependent [16] cases.

An interesting unification of the approaches of [8] and [13, 14] can be found in [17], in which a special ansatz for the ground state is also used (namely, the coherent state), whereas the resulting evolution equations are naturally reduced to those of [8] (see [18] for a further development of the approach).

A completely different method to maintain the particle number conservation was proposed in paper [19], in which it was demonstrated that the use of only the linear approximation within the Bogolyubov approach is in principle insufficient for a correct description of even free quasiparticles, and the use of only the linear approximation is exactly the origin of the resulting particle number nonconservation. Meanwhile, the use of additional nonoscillation modes in the linear approximation (these modes are exact solutions of the linearized Heisenberg equation) together with the use of the first nonlinear correction allows one to slightly modify the method of Bogolyubov and to solve the problem of nonconserved particle number in a natural way (i.e., without any modification of the initial Hamiltonian of the system or the resulting effective Hamiltonian, as well as without any additional assumptions about the properties of the ground state of the system). Although technically the approach proposed in [19] may look quite complicated, in essence it is very simple — the terms (zero order) \times (first nonlinear correction) are of the same order as the terms (linear order)², so they compensate the unphysical nondiagonal terms in the operator of particle number (and, consequently, in the effective Hamiltonian), which emerge from the terms $(linear\ order)^2$ when only the linear approximation is taken into account, and ensure the automatic particle number conservation at the quadratic level. Moreover, it turns out that formally the approximate solution of the Heisenberg equation discussed in [19] differs from the standard one of [1]. It should be noted that the use of nonoscillation modes is a very important ingredient of the method.

In paper [19], two-body interaction potential of the form [21]

$$V(|\vec{x} - \vec{y}|) = g\delta^{(3)}(\vec{x} - \vec{y}), \tag{1}$$

where g > 0, was considered, leading to the well-known Gross-Pitaevskii differential equation [22,23]. In the present paper, an arbitrary form of the two-body interaction potential $V(|\vec{x}-\vec{y}|)$ is considered. One might think that the successful finding of a suitable nonlinear solution of the Heisenberg equation in [19] was a consequence of the fact that for the simplified two-body interaction potential (1) the Heisenberg equation reduces to a standard local differential equation, while in the case of arbitrary two-body interaction potential the Heisenberg equation reduces to a nonlocal integro-differential equation. However, it will be shown below that a suitable nonlinear solution of the latter equation can be found as well.

This paper is more technical than the previous paper [19]. A detailed discussion of the method can be found in [19], so I will not reproduce it below. Moreover, some of the bulky calculations, which are necessary for calculating the canonical commutation relations, fully coincide with those already performed in [19], so I will refer to [19] when necessary. The main notations used in the present paper fully coincide with those used in [19].

Basically, the present paper has the structure that is similar to the one of [19]. It is organized as follows. In Section 2 the basic setup is described. In Section 3 equations of motion

and commutation relations for perturbations are derived. In Section 4 the linear approximation, including the nonoscillation modes, is discussed. In Section 5 an explicit solution for the first nonlinear correction is presented and the corresponding commutation relations are shown to be satisfied. In Section 6 operators of the resulting integrals of motion are calculated. The obtained results are briefly discussed in Conclusion. Appendix contains an auxiliary material.

2 Setup

As in paper [1], within the second quantization formalism we take the standard Hamiltonian

$$\hat{H} = \int d^3x \left(\frac{\hbar^2}{2m} \sum_{i=1}^3 \partial_i \hat{\Psi}^{\dagger}(t, \vec{x}) \partial_i \hat{\Psi}(t, \vec{x}) + \frac{1}{2} \int d^3y \hat{\Psi}^{\dagger}(t, \vec{x}) \hat{\Psi}^{\dagger}(t, \vec{y}) V(|\vec{x} - \vec{y}|) \hat{\Psi}(t, \vec{x}) \hat{\Psi}(t, \vec{y}) \right)$$
(2)

for a system in a spatial "box" of size $L \times L \times L$ with periodic boundary conditions for $\hat{\Psi}(t, \vec{x})$. The operators $\hat{\Psi}(t, \vec{x})$ and $\hat{\Psi}^{\dagger}(t, \vec{x})$ are supposed to satisfy the standard canonical commutation relations

$$[\hat{\Psi}(t,\vec{x}), \hat{\Psi}^{\dagger}(t,\vec{y})] = \delta^{(3)}(\vec{x} - \vec{y}), \qquad [\hat{\Psi}(t,\vec{x}), \hat{\Psi}(t,\vec{y})] = 0. \tag{3}$$

The operator of the conserved particle number is

$$\hat{N} = \int d^3x \hat{\Psi}^{\dagger}(t, \vec{x}) \hat{\Psi}(t, \vec{x}). \tag{4}$$

For the Hamiltonian \hat{H} defined by (2) and with (3), the Heisenberg equation

$$\frac{d\hat{\Psi}(t,\vec{x})}{dt} = \frac{i}{\hbar}[\hat{H},\hat{\Psi}(t,\vec{x})] \tag{5}$$

leads to the well-known nonlinear integro-differential equation for the operator $\hat{\Psi}(t, \vec{x})$:

$$i\hbar\dot{\hat{\Psi}}(t,\vec{x}) = -\frac{\hbar^2}{2m}\Delta\hat{\Psi}(t,\vec{x}) + \int d^3y V(|\vec{x}-\vec{y}|)\hat{\Psi}^{\dagger}(t,\vec{y})\hat{\Psi}(t,\vec{y})\hat{\Psi}(t,\vec{x}), \tag{6}$$

where $\dot{}=\frac{\partial}{\partial t}$ and $\Delta=\sum_{i=1}^{3}\partial_{i}^{2}$.

Since the occupation number is supposed to be large, the creation and annihilation operators of condensed particles can be replaced by c-numbers [1]. This replacement corresponds to a classical solution of Eq. (6) of the form

$$\Psi_0(t) = \sqrt{\frac{\omega}{g}} e^{-\frac{i}{\hbar}\omega t} \tag{7}$$

with $\omega > 0$ and

$$g = \int d^3y V(|\vec{x} - \vec{y}|) > 0.$$
 (8)

For solution (7), its energy and particle number are

$$E_0 = \frac{\omega^2 L^3}{2g}, \quad N_0 = \frac{\omega L^3}{g}.$$
 (9)

3 Equations of motion for perturbations, integrals of motion and commutation relations

Let us represent the operator $\hat{\Psi}(t, \vec{x})$ as

$$\hat{\Psi}(t, \vec{x}) = e^{-\frac{i}{\hbar}\omega t} \left(\sqrt{\frac{\omega}{g}} + \hat{\psi}(t, \vec{x}) \right), \tag{10}$$

where $\hat{\psi}(t, \vec{x})$ satisfies the full nonlinear integro-differential equation of motion, which follows directly from Eq. (6):

$$i\hbar\dot{\hat{\psi}}(t,\vec{x}) = -\frac{\hbar^2}{2m}\Delta\hat{\psi}(t,\vec{x}) + \frac{\omega}{g}\int d^3y V(|\vec{x}-\vec{y}|) \left(\hat{\psi}(t,\vec{y}) + \hat{\psi}^{\dagger}(t,\vec{y})\right) + \sqrt{\frac{\omega}{g}}\int d^3y V(|\vec{x}-\vec{y}|) \left[\left(\hat{\psi}(t,\vec{y}) + \hat{\psi}^{\dagger}(t,\vec{y})\right)\hat{\psi}(t,\vec{x}) + \hat{\psi}^{\dagger}(t,\vec{y})\hat{\psi}(t,\vec{y})\right] + \dots$$
(11)

Here "..." denotes the terms of the higher orders in $\hat{\psi}^{\dagger}(t, \vec{x})$ and $\hat{\psi}(t, \vec{x})$. In order to solve this equation using the methods of perturbation theory, we can expand the operator $\hat{\psi}(t, \vec{x})$ into the series

$$\hat{\psi}(t,\vec{x}) = \hat{\varphi}(t,\vec{x}) + \sum_{n=1}^{\infty} \beta^n \hat{\phi}_n(t,\vec{x}), \tag{12}$$

where $\beta=\frac{1}{\sqrt{N_0}}=\sqrt{\frac{g}{\omega L^3}}\ll 1$ and $\hat{\varphi}(t,\vec{x})$ is a solution of the well-known linear integro-differential equation

$$i\hbar\dot{\hat{\varphi}}(t,\vec{x}) = -\frac{\hbar^2}{2m}\Delta\hat{\varphi}(t,\vec{x}) + \frac{\omega}{g}\int d^3y V(|\vec{x}-\vec{y}|)\left(\hat{\varphi}(t,\vec{y}) + \hat{\varphi}^{\dagger}(t,\vec{y})\right),\tag{13}$$

which follows from Eq. (11). Of course, analytical finding of all terms $\hat{\phi}_n(t, \vec{x})$ in (12) is impossible, so, as in [19], we will restrict ourselves to the linear and quadratic orders only. Let us denote the first nonlinear correction $\hat{\phi}_1(t, \vec{x})$ as $\hat{\phi}(t, \vec{x})$, reduce the operator $\hat{\psi}(t, \vec{x})$ to

$$\hat{\psi}(t, \vec{x}) = \hat{\varphi}(t, \vec{x}) + \beta \hat{\phi}(t, \vec{x}), \tag{14}$$

and substitute this simplified representation into Eq. (11). Combining all terms of the order of β , we obtain the inhomogeneous integro-differential equation

$$i\hbar\dot{\hat{\phi}}(t,\vec{x}) + \frac{\hbar^2}{2m}\Delta\hat{\phi}(t,\vec{x}) - \frac{\omega}{g}\int d^3y V(|\vec{x}-\vec{y}|) \left(\hat{\phi}(t,\vec{y}) + \hat{\phi}^{\dagger}(t,\vec{y})\right)$$

$$= \frac{\omega\sqrt{L^3}}{g}\int d^3y V(|\vec{x}-\vec{y}|) \left(\left(\hat{\varphi}(t,\vec{y}) + \hat{\varphi}^{\dagger}(t,\vec{y})\right)\hat{\varphi}(t,\vec{x}) + \hat{\varphi}^{\dagger}(t,\vec{y})\hat{\varphi}(t,\vec{y})\right). \tag{15}$$

In principle, the nonlinear correction $\hat{\phi}(t, \vec{x})$ can be considered as a backreaction. In this connection, it should be noted that the ansatz fully analogous to (14) was used in [24] for examining backreaction of linear quantum perturbations on the classical background of the system.²

It was shown in [19] that for representation (10) the operator of particle number of perturbations looks like (this is the exact result)

$$\hat{N}_p = \hat{N} - N_0 = \int d^3x \left(\sqrt{\frac{\omega}{g}} \left(\hat{\psi}^\dagger + \hat{\psi} \right) + \hat{\psi}^\dagger \hat{\psi} \right). \tag{16}$$

Substituting representation (10) into (2), eliminating the terms with ∂_i by means of the non-linear Eq. (11), and retaining only linear and quadratic in $\hat{\psi}$ and $\hat{\psi}^{\dagger}$ terms, we obtain

$$\hat{E}_p = \hat{E} - E_0 = \omega \hat{N}_p + \frac{i\hbar}{2} \int d^3x \left(\hat{\psi}^{\dagger} \dot{\hat{\psi}} - \dot{\hat{\psi}}^{\dagger} \hat{\psi} \right). \tag{17}$$

Although Eq. (11) differs from the analogous equation in [19], operator (17) coincides with the analogous operator in [19]. Then, substituting representation (14) into (16) and (17), using the fact that $\sqrt{\frac{\omega}{g}} = \frac{1}{\beta\sqrt{L^3}}$, and retaining only the terms of the order of β^{-1} and $\beta^0 = 1$, we get

$$\hat{N}_p = \int d^3x \left(\sqrt{\frac{\omega}{g}} \left(\hat{\varphi}^{\dagger} + \hat{\varphi} \right) + \hat{\varphi}^{\dagger} \hat{\varphi} + \frac{1}{\sqrt{L^3}} \left(\hat{\phi}^{\dagger} + \hat{\phi} \right) \right), \tag{18}$$

$$\hat{E}_p = \omega \hat{N}_p + \frac{i\hbar}{2} \int d^3x \left(\hat{\varphi}^{\dagger} \dot{\hat{\varphi}} - \dot{\hat{\varphi}}^{\dagger} \hat{\varphi} \right), \tag{19}$$

which have exactly the same forms as the corresponding operators in [19]. It is exactly the term $\sim (\hat{\phi}^{\dagger} + \hat{\phi})$ that provides contributions compensating the unphysical nondiagonal operators in (18) originating from the term $\sim \hat{\phi}^{\dagger}\hat{\phi}$.

Now let us consider the canonical commutation relations. Suppose that for the linear solution the commutation relations

$$[\hat{\varphi}(t, \vec{x}), \hat{\varphi}(t, \vec{y})] = 0, \tag{20}$$

$$[\hat{\varphi}(t,\vec{x}),\hat{\varphi}^{\dagger}(t,\vec{y})] = \delta^{(3)}(\vec{x} - \vec{y}) \tag{21}$$

are exactly satisfied. Since in our approximation only the first nonlinear correction is taken into account, with (20) and (21) the relevant parts of the canonical commutation relations are reduced to [19]

$$[\hat{\psi}(t,\vec{x}), \hat{\psi}(t,\vec{y})] \to 0 + \beta[\hat{\phi}(t,\vec{x}), \hat{\varphi}(t,\vec{y})] + \beta[\hat{\varphi}(t,\vec{x}), \hat{\phi}(t,\vec{y})] = 0, \tag{22}$$

$$[\hat{\psi}(t,\vec{x}), \hat{\psi}^{\dagger}(t,\vec{y})] \to \delta^{(3)}(\vec{x} - \vec{y}) + \beta[\hat{\phi}(t,\vec{x}), \hat{\varphi}^{\dagger}(t,\vec{y})] + \beta[\hat{\varphi}(t,\vec{x}), \hat{\phi}^{\dagger}(t,\vec{y})] = \delta^{(3)}(\vec{x} - \vec{y}), \quad (23)$$

resulting in

$$[\hat{\phi}(t,\vec{x}),\hat{\varphi}(t,\vec{y})] + [\hat{\varphi}(t,\vec{x}),\hat{\phi}(t,\vec{y})] = 0, \tag{24}$$

$$[\hat{\phi}(t,\vec{x}),\hat{\varphi}^{\dagger}(t,\vec{y})] + [\hat{\varphi}(t,\vec{x}),\hat{\phi}^{\dagger}(t,\vec{y})] = 0.$$

$$(25)$$

Commutation relations (24) and (25) imply that the canonical commutation relations are satisfied up to and including the terms $\sim \beta$.

4 Linear approximation

First, let us consider Eq. (13). Using the standard representation

$$V(|\vec{x} - \vec{y}|) = \frac{1}{L^3} \sum_{j} e^{\frac{i}{\hbar} \vec{k}_j (\vec{x} - \vec{y})} v_j, \tag{26}$$

with

$$\vec{k}_j = \frac{2\pi\hbar}{L}\vec{j}, \qquad \vec{j} = (j_1, j_2, j_3),$$
 (27)

where j_1, j_2, j_3 are integers,³ $v_{-j} = v_j$ (follows from $V(|\vec{x} - \vec{y}|) = V(|\vec{y} - \vec{x}|)$), $v_{-j} = v_j^*$ (follows from $V^*(|\vec{x} - \vec{y}|) = V(|\vec{x} - \vec{y}|)$), and $v_0 = g$, one can get the well-known solution of Eq. (13)

$$\hat{\varphi}_{o}(t,\vec{x}) = \frac{1}{\sqrt{L^{3}}} \sum_{j \neq 0} \left(c_{j} e^{-\frac{i}{\hbar} (\gamma_{j} t - \vec{k}_{j} \vec{x})} \hat{a}_{j} - d_{j} e^{\frac{i}{\hbar} (\gamma_{j} t - \vec{k}_{j} \vec{x})} \hat{a}_{j}^{\dagger} \right)$$

$$= \frac{1}{\sqrt{L^{3}}} \sum_{j \neq 0} e^{\frac{i}{\hbar} \vec{k}_{j} \vec{x}} \left(c_{j} e^{-\frac{i}{\hbar} \gamma_{j} t} \hat{a}_{j} - d_{j} e^{\frac{i}{\hbar} \gamma_{j} t} \hat{a}_{-j}^{\dagger} \right)$$

$$(28)$$

with

$$c_{j} = \frac{\omega \tilde{v}_{j}}{\sqrt{2\gamma_{j} \left(\frac{\vec{k}_{j}^{2}}{2m} + \omega \tilde{v}_{j} - \gamma_{j}\right)}}, \qquad d_{j} = \sqrt{\frac{\vec{k}_{j}^{2}}{2m} + \omega \tilde{v}_{j} - \gamma_{j}}{2\gamma_{j}}, \tag{29}$$

where $\tilde{v}_j = \frac{v_j}{v_0} = \frac{v_j}{g}$ and $j_1^2 + j_2^2 + j_3^2 \neq 0$,

$$\gamma_j = \sqrt{\frac{\vec{k}_j^2}{2m} \left(\frac{\vec{k}_j^2}{2m} + 2\omega \tilde{v}_j\right)},\tag{30}$$

and

$$[\hat{a}_i, \hat{a}_l^{\dagger}] = \delta_{il}, \qquad [\hat{a}_i, \hat{a}_l] = 0. \tag{31}$$

It is easy to check that $c_j^2 - d_j^2 = 1$. Here the operators \hat{a}_j and \hat{a}_j^{\dagger} are annihilation and creation operators of quasi-particles.

Linear solution (28) as it is does not satisfy the necessary commutation relation (21), which is the consequence of the absence of the operators \hat{a}_0 , \hat{a}_0^{\dagger} in the linear solution (28):

$$[\hat{\varphi}_{o}(t,\vec{x}),\hat{\varphi}_{o}^{\dagger}(t,\vec{y})] = \delta^{(3)}(\vec{x} - \vec{y}) - \frac{1}{L^{3}}.$$
(32)

As in [19], this problem can be solved by recalling that apart from the standard oscillation modes presented in the linear solution (28), Eq. (13) provides two other solutions, which also satisfy the periodic boundary conditions. These solutions do not depend on the spatial coordinate \vec{x} , so Eq. (13) takes the form

$$i\hbar\dot{\hat{\varphi}}_{\rm no}(t,\vec{x}) = \omega\left(\hat{\varphi}_{\rm no}(t,\vec{x}) + \hat{\varphi}_{\rm no}^{\dagger}(t,\vec{x})\right)$$
 (33)

for these modes. This is exactly the linear equation for nonoscillation modes that emerges in the theory with potential (1), and its solutions were found in [19]:

$$\hat{\varphi}_{\text{no }1}(t,\vec{x}) = \frac{1}{2a\sqrt{L^3}} \left(\hat{a}_0 - \hat{a}_0^{\dagger} \right) \tag{34}$$

(in the classical case this Goldstone mode corresponds to the global U(1) symmetry of the theory),

$$\hat{\varphi}_{\text{no 2}}(t, \vec{x}) = \frac{q}{\sqrt{L^3}} \left(\frac{1}{2} - \frac{i}{\hbar} \omega t \right) \left(\hat{a}_0 + \hat{a}_0^{\dagger} \right) \tag{35}$$

(in the classical case this mode corresponds to a change of the frequency ω of the background solution (7), in fact it is also a Goldstone-like mode resulting from the symmetry breaking associated with a choice of the frequency ω), see [19] for a more detailed discussion of these nonoscillation modes,⁴ including an explanation that the linear growth of (35) in t is not dangerous and does not lead to an instability. Here $q \neq 0$ is an arbitrary dimensionless real constant and

$$[\hat{a}_0, \hat{a}_0^{\dagger}] = 1, \quad [\hat{a}_0, \hat{a}_j] = 0, \quad [\hat{a}_0, \hat{a}_j^{\dagger}] = 0, \quad j \neq 0.$$
 (36)

Now, instead of (28), let us take

$$\hat{\varphi}(t, \vec{x}) = \frac{1}{\sqrt{L^3}} \sum_{j \neq 0} \left(c_j e^{-\frac{i}{\hbar} (\gamma_j t - \vec{k}_j \vec{x})} \hat{a}_j - d_j e^{\frac{i}{\hbar} (\gamma_j t - \vec{k}_j \vec{x})} \hat{a}_j^{\dagger} \right) + \frac{1}{2q\sqrt{L^3}} \left(\hat{a}_0 - \hat{a}_0^{\dagger} \right) + \frac{q}{\sqrt{L^3}} \left(\frac{1}{2} - \frac{i}{\hbar} \omega t \right) \left(\hat{a}_0 + \hat{a}_0^{\dagger} \right).$$
(37)

It is clear that solution (37) satisfies the linear Eq. (13). It is not difficult to check that (37) exactly satisfies commutation relations (20) and (21). The fact that nonoscillation modes recover commutation relation (21) is not surprising — these modes add to (28) the solutions that do not depend on the spatial coordinate, thus making the corresponding set of eigenfunctions (the one that forms the delta function in (21)) complete. Analogous role is played by nonoscillation modes in theories with solitons in the nonlinear Schrödinger equation (in particular, in the case of one-dimensional solitons there are two more nonoscillation modes — the translational mode and the mode corresponding to the Galilean transformation) — they also make the set of the corresponding eigenfunctions complete [28], thus allowing one to perform a consistent procedure of quantization [29].

5 Second order

5.1 Separation of the equations of motion

As in [19], the operator $\hat{\varphi}(t, \vec{x})$ can be represented as

$$\hat{\varphi}(t, \vec{x}) = \hat{\varphi}_{\text{no}}(t) + \hat{\varphi}_{\text{o}}(t, \vec{x}), \tag{38}$$

where

$$\hat{\varphi}_{o}(t, \vec{x}) = \sum_{j \neq 0} \hat{\varphi}_{j}(t, \vec{x}) = \sum_{j \neq 0} \hat{\tilde{\varphi}}_{j}(t, \vec{x})$$
(39)

with

$$\hat{\varphi}_{\text{no}}(t) = \frac{1}{2q\sqrt{L^3}} \left(\hat{a}_0 - \hat{a}_0^{\dagger} \right) + \frac{q}{\sqrt{L^3}} \left(\frac{1}{2} - \frac{i}{\hbar} \omega t \right) \left(\hat{a}_0 + \hat{a}_0^{\dagger} \right), \tag{40}$$

The coefficients $\tilde{M}_{j,l}^{\pm}$ and $\tilde{N}_{j,l}^{\pm}$ in the latter representations are the following: if j and l are such that relation (76) holds, then $\tilde{M}_{j,l}^{+} = M_{j,l}^{\star+}$ and $\tilde{N}_{j,l}^{+} = N_{j,l}^{\star+}$; if j and l are such that relation (77) holds, then $\tilde{M}_{j,l}^{-} = M_{j,l}^{\star-}$ and $\tilde{N}_{j,l}^{-} = N_{j,l}^{\star-}$; if j and l are such that relation (89) holds, then $\tilde{M}_{j,l}^{+} = M_{j,l}^{+}$ and $\tilde{N}_{j,l}^{+} = N_{j,l}^{+}$; and if j and l are such that relation (90) holds, then $\tilde{M}_{j,l}^{-} = M_{j,l}^{-}$ and $\tilde{N}_{j,l}^{-} = N_{j,l}^{-}$. The operators $\hat{\rho}_{j,l}^{\pm}(t,\vec{x})$ have the form [19]

(note the overall factor t in (114) and (115)). The notation [j, l] in (111) labels the set of j and l for which relation (89) holds, the notation (j, l) in (111) labels the set of j and l for which relation (90) holds. Now let us turn to the commutation relations.

5.4.4 Commutation relations for the operators $\hat{\hat{\phi}}_{j,l}^{\pm}(t,\vec{x})$

Since in terms of $M_{j,l}^{\star\pm}$, $N_{j,l}^{\star\pm}$ and $M_{j,l}^{\pm}$, $N_{j,l}^{\pm}$ the operators $\hat{\phi}_{j,l}^{\pm}(t,\vec{x})$ defined by (112) and (113) have exactly the same form as those in [19], we can use the expressions for the commutators obtained in [19]. In order not to overload the text, derivation of coefficients (122)–(124) and (127), (128) is not reproduced in this paper — detailed explanations and calculations can be found in [19]. However, as now $M_{\#,\#}^{\star\pm}$, $N_{\#,\#}^{\star\pm}$, $K_{a,b}^+$, and $c_\#$, $d_\#$ depend on the parameters $\tilde{v}_\#$ and differ from those in [19], coefficients (122)–(124) and (127), (128) should be recalculated.

Exactly in the same way as it was done in [19], let us express all terms with momenta in (122)–(124) through $\gamma_{\#}$ and $\tilde{v}_{\#}$. Using (29), (64)–(67), (82), (86) and

It is a purely algebraic cancellation, i.e., equality (134) is valid for arbitrary nonzero values of γ_j , γ_l , γ_{j+l} and \tilde{v}_j , \tilde{v}_l , \tilde{v}_{j+l} . Analytical check of equality (134) demands very bulky calculations, so it is more convenient to use a program package that can perform symbolic computations (namely, reduction and simplification of analytical expressions). To check the validity of equality (134) (and subsequent equalities of this section), the computer algebra system Maxima [30] was used, see Supplementary material for the files.

It was explained in detail in [19] that in order to correctly calculate contributions of the terms with $\hat{\rho}_{j,l}^{\pm}(t,\vec{x})$ to the canonical commutation relations, it is necessary to consider the combination

$$L_{ab}^+ c_b - L_{a+ba}^- c_{a+b},$$
 (151)

$$L_{a+b,b}^{-}c_b - L_{a+b,a}^{-}c_a. (152)$$

Note that in terms of $L_{\#,\#}^{\pm}$ and $c_{\#}$ they have the same form as those in [19]. The second commutation relation for combination (146) has the form [19]

Using relations (148) and (149), commutators in (153) can be represented as

Here the remaining independent coefficients are (151) and (152) as well.

However, as now $L_{\#,\#}^{\pm}$, $J_{\#,\#}^{\pm}$ and $c_{\#}$, $d_{\#}$ depend on the parameters $\tilde{v}_{\#}$ and differ from those in [19], coefficients in (147) should be recalculated. Using (29), (64)–(67), (97), (106), and

$$\frac{\vec{k}_a^2}{2m} = \sqrt{\gamma_a^2 + (\omega \tilde{v}_a)^2} - \omega \tilde{v}_a, \qquad \frac{\vec{k}_b^2}{2m} = \sqrt{\gamma_b^2 + (\omega \tilde{v}_b)^2} - \omega \tilde{v}_b, \tag{155}$$

$$\frac{(\vec{k}_a + \vec{k}_b)^2}{2m} = \sqrt{(\gamma_a + \gamma_b)^2 + (\omega \tilde{v}_{a+b})^2} - \omega \tilde{v}_{a+b}, \tag{156}$$

it is not difficult to check that

$$L_{a,b}^{+}c_{b} - L_{a+b,a}^{-}c_{a+b} = 0, (157)$$

$$L_{a+b,b}^{-}c_b - L_{a+b,a}^{-}c_a = 0 (158)$$

for arbitrary nonzero values of γ_a , γ_b and \tilde{v}_a , \tilde{v}_b , \tilde{v}_{a+b} , see Appendix for details. Equalities (157) and (158) imply that commutation relations (24) and (25) are also satisfied for the terms containing the operators $\hat{\rho}_{j,l}^{\pm}(t,\vec{x})$.

5.5 Additional term with free parameters

As the last part of the solution, let us take the operator [19]

$$\hat{\phi}_{\text{ex}}(t, \vec{x}) = \frac{1}{\sqrt{L^3}} \left(\sum_{j \neq 0} \left(\frac{1}{2} - \frac{i\omega t}{\hbar} \right) \epsilon_j \hat{a}_j^{\dagger} \hat{a}_j - \sum_{j \neq 0} \frac{\epsilon_j}{2q} e^{\frac{i}{\hbar} \vec{k}_j \vec{x}} \left(e^{-\frac{i}{\hbar} \gamma_j t} c_j \hat{P}_j - e^{\frac{i}{\hbar} \gamma_j t} d_j \hat{P}_{-j}^{\dagger} \right) \right)$$
(159)

with $\hat{P}_j = (\hat{a}_0 - \hat{a}_0^{\dagger}) \hat{a}_j$. Here $\epsilon_{-j} = \epsilon_j$ are arbitrary dimensionless parameters. Since the operator $\hat{\phi}_{\rm ex}(t,\vec{x})$ is a solution of the homogeneous part of Eq. (15), it can always be added to the solution for $\hat{\phi}(t,\vec{x})$ obtained in the previous sections. It was shown in [19] that the necessary commutation relations (24) and (25) are satisfied for (159). As we will see in the next section, operator (159) introduces free parameters into the resulting effective theory.

6 Operators $\hat{N}_p,\,\hat{E}_p$ and $\hat{\vec{P_p}}$

Up to the terms $\sim \beta$, solution for the operator $\hat{\Psi}(t, \vec{x})$ has the form

$$\hat{\Psi}(t, \vec{x}) = e^{-\frac{i}{\hbar}\omega t} \left(\sqrt{\frac{\omega}{g}} + \hat{\varphi}(t, \vec{x}) + \beta \left(\hat{\phi}_{\text{no}}(t) + \hat{\phi}_{\times}(t, \vec{x}) + \hat{\phi}_{\text{t}}(t) \right) + \frac{1}{2} \sum_{\substack{j \neq 0, l \neq 0 \\ j \neq -l}} \hat{\phi}_{j,l}^{+}(t, \vec{x}) + \frac{1}{2} \sum_{\substack{j \neq 0, l \neq 0 \\ j \neq l}} \hat{\phi}_{j,l}^{-}(t, \vec{x}) + \hat{\phi}_{\text{ex}}(t, \vec{x}) \right) \right).$$
(160)

As was checked above, this solution satisfies the necessary commutation relations (24) and (25) (i.e., the canonical commutation relations (3) up to the terms $\sim \beta$). Substituting (160) into (18), (19) and into the momentum operator, which has the standard definition

$$\hat{\vec{P}} = -i\hbar \int d^3x \hat{\Psi}^{\dagger}(t, \vec{x}) \nabla \hat{\Psi}(t, \vec{x}), \qquad (161)$$

using the relation $\int d^3x \, e^{\pm \frac{i}{\hbar}\vec{k}_j\vec{x}} = 0$, which is valid for any $\vec{k}_j \neq 0$, and taking $q = \sqrt{\frac{L^3}{\omega g}}\tilde{q}$, where \tilde{q} is an arbitrary constant with dimension of ω (recall that the parameter q originates from (34) and (35)), after straightforward calculations one gets

$$\hat{N}_p = \frac{1}{2} \left(1 + \sum_{j \neq 0} \tilde{v}_j \left(1 - \frac{\vec{k}_j^2}{2m\gamma_j} \right) \right) + \frac{dN_0}{d\omega} \, \tilde{q} \left(\hat{a}_0 + \hat{a}_0^{\dagger} \right) + \sum_{j \neq 0} \left(\epsilon_j - \frac{\tilde{v}_j \vec{k}_j^2}{2m\gamma_j} \right) \hat{a}_j^{\dagger} \hat{a}_j, \tag{162}$$

$$\hat{E}_{p} = \frac{1}{2} \sum_{j \neq 0} \frac{\vec{k}_{j}^{2}}{2m\gamma_{j}} \left(\frac{\vec{k}_{j}^{2}}{2m} + \omega \tilde{v}_{j} - \gamma_{j} \right) + \frac{dE_{0}}{d\omega} \, \tilde{q} \left(\hat{a}_{0} + \hat{a}_{0}^{\dagger} \right) + \frac{1}{2} \frac{d^{2}E_{0}}{d\omega^{2}} \, \tilde{q}^{2} \left(\hat{a}_{0} + \hat{a}_{0}^{\dagger} \right)^{2}$$

$$+\omega\sum_{j\neq 0} \left(\epsilon_j - \frac{\tilde{v}_j \vec{k}_j^2}{2m\gamma_j}\right) \hat{a}_j^{\dagger} \hat{a}_j + \sum_{j\neq 0} \gamma_j \hat{a}_j^{\dagger} \hat{a}_j, \tag{163}$$

$$\hat{\vec{P}}_p = \sum_{j \neq 0} \vec{k}_j \hat{a}_j^{\dagger} \hat{a}_j. \tag{164}$$

In the latter formulas, the operator $\hat{a}_{j}^{\dagger}\hat{a}_{j}$ corresponds to the number of quasi-particles with momentum \vec{k}_{j} , whereas the c-number terms in (162) and (163) are the consequence of permutations of the creation and annihilation operators. As in [19], even for arbitrary ϵ_{j} the operators \hat{N}_{p} , \hat{E}_{p} do not contain any nondiagonal terms like those in [1].

Choosing

$$\epsilon_j = \frac{\tilde{v}_j \vec{k}_j^2}{2m\gamma_i} \tag{165}$$

in (159) (recall that ϵ_j are free parameters of the solution) and dropping the c-number terms that are not relevant for our analysis, for the operators in (162)–(164) we obtain

$$\hat{N}_p = \frac{dN_0}{d\omega} \, \tilde{q} \left(\hat{a}_0 + \hat{a}_0^{\dagger} \right), \tag{166}$$

$$\hat{E}_{p} = \frac{dE_{0}}{d\omega} \, \tilde{q} \left(\hat{a}_{0} + \hat{a}_{0}^{\dagger} \right) + \frac{1}{2} \frac{d^{2}E_{0}}{d\omega^{2}} \, \tilde{q}^{2} \left(\hat{a}_{0} + \hat{a}_{0}^{\dagger} \right)^{2} + \sum_{j \neq 0} \gamma_{j} \hat{a}_{j}^{\dagger} \hat{a}_{j}, \tag{167}$$

$$\hat{\vec{P}}_p = \sum_{j \neq 0} \vec{k}_j \hat{a}_j^{\dagger} \hat{a}_j. \tag{168}$$

As was explained in [19], the terms with the operator $\hat{a}_0 + \hat{a}_0^{\dagger}$ are expected for the nonoscillation mode corresponding to a change of ω in the background solution (7).⁵ Exactly as in [19], formula (166) implies that free quasi-particles do not change the particle number of the system — it is the term with the operator $\hat{a}_0 + \hat{a}_0^{\dagger}$ that is responsible for adding particles to the system (more precisely, to the condensate) or removing them from the system (for a detailed discussion, see [19]). However, as expected, free quasi-particles can change the energy of the system (which is γ_j for a quasi-particle, see (167)), and its momentum (which is \vec{k}_j for a quasi-particle, see (168)). In is interesting to note that the second term in (167) is similar to the term with the "momentum" operator of the condensate, which was introduced in [31], in the Hamiltonian derived in [31].

7 Conclusion

It is shown that the use of additional nonoscillation modes in the linear approximation together with the first nonlinear correction provides a natural solution to the problem of nonconserved particle number in the case of arbitrary two-body interaction potential as well. This happens in the same way as in the special case of simplified two-body interaction potential (1) [19]. Within the proposed approach, which only slightly modifies the original method of Bogolyubov [1], the particle number is conserved automatically and there is no need for additional methods of the particle number conservation (like those that rely on modifications of the resulting effective Hamiltonian). An important point is that both parts of the approach — the nonoscillation modes and the first nonlinear correction, are necessary to get a correct result.

⁵In full analogy with the result of [19], the term $\sim \left(\hat{a}_0 + \hat{a}_0^{\dagger}\right)^2$ is absent in (162) because $\frac{d^2N_0}{d\omega^2} = 0$ (see (9)) for the background solution (7).

⁶One can check that all formulas presented in this paper can be reduced to those of [19] by taking $v_j = v_0 = g$ (i.e., $\tilde{v}_j = 1$) for all j.

It is necessary to stress that since

$$\hat{\Psi}(0, \vec{x}) \not\equiv \Psi_0(0, \vec{x}) + \hat{\varphi}_0(0, \vec{x}), \tag{169}$$

where $\hat{\varphi}_{o}(t,\vec{x})$ is defined by (28), solution (160) cannot be considered just as an approximation of a solution of Eq. (6) with the usual initial condition $\Psi_{0}(0,\vec{x})+\hat{\varphi}_{o}(0,\vec{x})$, see the corresponding discussion in [19]. Thus, it is the consideration of a different solution of the nonlinear integrodifferential Eq. (6) that results in cancellation of the unphysical nondiagonal terms arising when one takes the standard solution. Certainly, solution (160) (as well as the original solution $\Psi_{0}(t,\vec{x})+\hat{\varphi}_{o}(t,\vec{x})$ of [1]) is not exact⁷ — in order to get a more accurate solution, one should find at least several more terms in expansion (12). However, even calculation of the second nonlinear correction $\hat{\phi}_{2}(t,\vec{x})$ seems to be a much more difficult task than calculation of the first nonlinear correction $\hat{\phi}_{1}(t,\vec{x})$ presented in this paper. This problem, as well as calculation of the interaction Hamiltonian corresponding to the new solution $\hat{\Psi}(t,\vec{x})$ defined by (160), call for further investigation.

Appendix

Let us consider equality (158). Using (106) and definitions (66), (67), the expression $L_{a+b,b}^-c_b - L_{a+b,a}^-c_a$ can be brought to the form

$$-\frac{ic_{b}}{2\hbar\gamma_{a}}\left(\left(\sqrt{\gamma_{a}^{2}+(\omega\tilde{v}_{a})^{2}}+\gamma_{a}\right)\left((\tilde{v}_{a+b}+\tilde{v}_{a})d_{a+b}d_{b}+(\tilde{v}_{a}+\tilde{v}_{b})c_{a+b}c_{b}-(\tilde{v}_{a+b}+\tilde{v}_{b})c_{a+b}d_{b}\right)\right)$$

$$-\omega\tilde{v}_{a}\left((\tilde{v}_{a}+\tilde{v}_{b})d_{a+b}d_{b}+(\tilde{v}_{a+b}+\tilde{v}_{a})c_{a+b}c_{b}-(\tilde{v}_{a+b}+\tilde{v}_{b})d_{a+b}c_{b}\right)\right)$$

$$+\frac{ic_{a}}{2\hbar\gamma_{b}}\left(\left(\sqrt{\gamma_{b}^{2}+(\omega\tilde{v}_{b})^{2}}+\gamma_{b}\right)\left((\tilde{v}_{a+b}+\tilde{v}_{b})d_{a+b}d_{a}+(\tilde{v}_{a}+\tilde{v}_{b})c_{a+b}c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})c_{a+b}d_{a}\right)\right)$$

$$-\omega\tilde{v}_{b}\left((\tilde{v}_{a}+\tilde{v}_{b})d_{a+b}d_{a}+(\tilde{v}_{a+b}+\tilde{v}_{b})c_{a+b}c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})d_{a+b}c_{a}\right)\right). \tag{170}$$

With the help of relations

$$c_j d_j = \frac{\omega \tilde{v}_j}{2\gamma_j}, \qquad c_j^2 = \frac{(\omega \tilde{v}_j)^2}{2\gamma_j \left(\sqrt{\gamma_j^2 + (\omega \tilde{v}_j)^2} - \gamma_j\right)} = \frac{\sqrt{\gamma_j^2 + (\omega \tilde{v}_j)^2} + \gamma_j}{2\gamma_j}, \tag{171}$$

which follow from (29), one can get for (170)

$$-\frac{i}{4\hbar\gamma_a\gamma_b}\left[\left(\sqrt{\gamma_a^2+(\omega\tilde{v}_a)^2}+\gamma_a\right)\left((\tilde{v}_{a+b}+\tilde{v}_a)d_{a+b}\omega\tilde{v}_b+(\tilde{v}_a+\tilde{v}_b)c_{a+b}\left(\sqrt{\gamma_b^2+(\omega\tilde{v}_b)^2}+\gamma_b\right)\right]\right]$$

⁷Meanwhile, it provides a more accurate fulfillment of the canonical commutation relations than the original solution of [1], see [19].

$$- (\tilde{v}_{a+b} + \tilde{v}_b)c_{a+b}\omega\tilde{v}_b - \omega\tilde{v}_a \left((\tilde{v}_a + \tilde{v}_b)d_{a+b}\omega\tilde{v}_b + (\tilde{v}_{a+b} + \tilde{v}_a)c_{a+b} \left(\sqrt{\gamma_b^2 + (\omega\tilde{v}_b)^2} + \gamma_b \right) \right)$$

$$- (\tilde{v}_{a+b} + \tilde{v}_b)d_{a+b} \left(\sqrt{\gamma_b^2 + (\omega\tilde{v}_b)^2} + \gamma_b \right) \left((\tilde{v}_{a+b} + \tilde{v}_b)d_{a+b}\omega\tilde{v}_a + (\tilde{v}_a + \tilde{v}_b)c_{a+b} \left(\sqrt{\gamma_a^2 + (\omega\tilde{v}_a)^2} + \gamma_a \right) \right)$$

$$- (\tilde{v}_{a+b} + \tilde{v}_a)c_{a+b}\omega\tilde{v}_a + \omega\tilde{v}_b \left((\tilde{v}_a + \tilde{v}_b)d_{a+b}\omega\tilde{v}_a + (\tilde{v}_{a+b} + \tilde{v}_b)c_{a+b} \left(\sqrt{\gamma_a^2 + (\omega\tilde{v}_a)^2} + \gamma_a \right) \right)$$

$$- (\tilde{v}_{a+b} + \tilde{v}_a)d_{a+b} \left(\sqrt{\gamma_a^2 + (\omega\tilde{v}_a)^2} + \gamma_a \right) \right]. \tag{172}$$

$$-(\tilde{v}_{a+b}+\tilde{v}_{a})d_{a}c_{b}-\omega\tilde{v}_{a+b}\left((\tilde{v}_{a}+\tilde{v}_{b})d_{a}d_{b}-(\tilde{v}_{a+b}+\tilde{v}_{a})c_{a}d_{b}-(\tilde{v}_{a+b}+\tilde{v}_{b})d_{a}c_{b}\right)\right)$$

$$+\frac{ic_{a+b}}{2\hbar\gamma_{b}}\left(\left(\sqrt{\gamma_{b}^{2}+(\omega\tilde{v}_{b})^{2}}+\gamma_{b}\right)\left((\tilde{v}_{a+b}+\tilde{v}_{b})d_{a+b}d_{a}+(\tilde{v}_{a}+\tilde{v}_{b})c_{a+b}c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})c_{a+b}d_{a}\right)\right)$$

$$-\omega\tilde{v}_{b}\left((\tilde{v}_{a}+\tilde{v}_{b})d_{a+b}d_{a}+(\tilde{v}_{a+b}+\tilde{v}_{b})c_{a+b}c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})d_{a+b}c_{a}\right)\right). \tag{173}$$

With the help of relations (171), one can get for (173)

$$-\frac{i}{4\hbar(\gamma_{a}+\gamma_{b})\gamma_{b}}\left[\left(\sqrt{(\gamma_{a}+\gamma_{b})^{2}+(\omega\tilde{v}_{a+b})^{2}}+\gamma_{a}+\gamma_{b}\right)\right] \times \left(\left(\sqrt{\gamma_{b}^{2}+(\omega\tilde{v}_{b})^{2}}+\gamma_{b}\right)\left((\tilde{v}_{a}+\tilde{v}_{b})c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})d_{a}\right)-(\tilde{v}_{a+b}+\tilde{v}_{b})c_{a}\omega\tilde{v}_{b}\right) \times \left(\left(\tilde{v}_{a}+\tilde{v}_{b}\right)d_{a}\omega\tilde{v}_{b}-(\tilde{v}_{a+b}+\tilde{v}_{a})c_{a}\omega\tilde{v}_{b}-\left(\sqrt{\gamma_{b}^{2}+(\omega\tilde{v}_{b})^{2}}+\gamma_{b}\right)(\tilde{v}_{a+b}+\tilde{v}_{b})d_{a}\right) - \left(\sqrt{\gamma_{b}^{2}+(\omega\tilde{v}_{b})^{2}}+\gamma_{b}\right)\left((\tilde{v}_{a+b}+\tilde{v}_{b})d_{a}\omega\tilde{v}_{a+b}+\left(\sqrt{(\gamma_{a}+\gamma_{b})^{2}+(\omega\tilde{v}_{a+b})^{2}}+\gamma_{a}+\gamma_{b}\right)\right) \times \left((\tilde{v}_{a}+\tilde{v}_{b})c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})d_{a}\right) + \omega\tilde{v}_{b}\left((\tilde{v}_{a}+\tilde{v}_{b})d_{a}\omega\tilde{v}_{a+b} + \left(\sqrt{(\gamma_{a}+\gamma_{b})^{2}+(\omega\tilde{v}_{a+b})^{2}}+\gamma_{a}+\gamma_{b}\right)\right) \times \left(\sqrt{(\gamma_{a}+\gamma_{b})^{2}+(\omega\tilde{v}_{a+b})^{2}}+\gamma_{a}+\gamma_{b}\right)\left(\tilde{v}_{a+b}+\tilde{v}_{b})c_{a}-(\tilde{v}_{a+b}+\tilde{v}_{a})c_{a}\omega\tilde{v}_{a+b}\right) \right].$$

Combining the similar terms, it is easy to see that this expression is equal to zero identically. Thus, equality (157) is also satisfied.
