# On a Mathematical Model of the Rotating Atmosphere of the Earth

#### Abstract

In meteorology the analysis of motions of the atmosphere on the Earth has been done using various mathematical models and using various approximations. In this article as the simplest model the compressible Euler equations with barotropic equation of state of the ideal gas is analyzed under the co-ordinate system which rotates with constant angular velocity. Mathematically rigorous inquiry is tried. Although problems remain to be open, some fundamental results are exhibited.

## 1 Introduction

In meteorology the analysis of motions of the atmosphere on the Earth has been done using various mathematical models and using various approximations. Actually models used for numerical weather prediction or climate simulation must take into account various factors besides the fundamental state variables of the gas and must meet practical computational efficiency with moderate accuracy in the process of the numerical simulations. Discussions of choice of models have been accumulated as an enormous collection in the meteorological literatures. However fundamental mathematically rigorous inquiries of the structure of solutions of the equations adopted as models in atmospheric dynamics have not yet been thoroughly done even for the simplest model. In this article we try to investigate the fundamental mathematical properties of the simplest model with the compressible Euler equations and the barotropic, or, isentropic motion of the ideal gas described in the co-ordinate system which rotates with a constant angular velocity. Although there remains open problems to be solved in mathematically rigorous way, some elementary aspects of the inquiry are exhibited in

[^0]this article.

In the following in this section the equations and the boundary condition to be considered are going to be described, and the definition of some concepts of solutions are going to be given. In Section 2 stationary solutions with comactly supported density and zero relative velocity will be discussed. The limit of allowable magnitude of the angular velocity of the rotation should be noted. In Section 3 Lagrangian co-ordinate description of the equations for the perturbations near the stationary solutions will be discussed, and in Section 4 we shall show that the linearized wave equation for the perturbations allows an application of the Hille-Yosida theory of existence of solutions. Higher order regularities of the solutions remains in an open problem. In Section 5 the so called 'variational principle' will be formurated and its efficiency will be discussed. Although the concept of eigenfrequency and eigenvectors to the wave equations for the perturbations is remarkable, the existence and completeness of eigenvectors is in an open problem when the rotation is present.

Let us describe the situation to be considred precisely.
We consider motions of an atmosphere governed by the compressible Euler equations described by the uniformly rotating coordinate system $(t, \boldsymbol{x})$ :

$R_{0}$ being a positive number. The variables $\rho, P$ are the density, the pressure and $\boldsymbol{v}=\left(v^{1}, v^{2}, v^{3}\right)^{\top}$ is the velocity field. We are denoting

G $M_{0}$ being a positive constant. Since we are concerned with the value of the potential $\Phi^{\langle\Omega\rangle}$ only on the domain $\mathbb{R}^{3} \backslash \mathfrak{B}_{0}$, we assume that $\Phi^{\langle\Omega\rangle} \in C^{\infty}\left(\mathbb{R}^{3}\right)$ and (1.5) holds for $r=\|\boldsymbol{x}\|>R_{0}$ by removing the singularity $\frac{1}{r}$ at $r=0$ by a smooth function near $r=0$, namely, we consider, instead of (1.5),

The atmosphere is surrounding the Earth of radius $R_{0}$, mass $M_{0}$ and G is the gravitational constant. $\Omega$ is the angular velocity of the rotation.

We assume
(A) $: P$ is the function of $\rho$ defined by

A, $\gamma$ being positive constants such that $1<\gamma<2$.
Under this assumption we introduce the variable $\Upsilon$ by

Since we are interested in solutions with $\rho$ which has a vacuum region on which $\rho=0$, the concept of classical solutions needs a precise definition. The following are the definitions adopted in this article.

Definition 1 An open connected subset $\mathfrak{D}$ of $\mathbb{R}^{3}$ is said to be an admissible domain with cover $\tilde{\mathfrak{D}}$ if $\tilde{\mathfrak{D}}=\mathfrak{D} \cup \mathfrak{B}_{0}$ is an open connected subset of $\mathbb{R}^{3}$ such that $\mathfrak{D}=\tilde{\mathfrak{D}} \backslash \mathfrak{B}_{0}$ and $\partial \mathfrak{D}$ is smooth.

Here and hereafter we use the following
Notation 1 Let $A, B$ be subsets of $\mathbb{R}^{3}$. CA denotes the complement of $A$ and $A \backslash B$ stands for $A \cap \complement B . \mathbf{C l} A$ stands for the closure of $A, \operatorname{Int} A$ stands for the interior of $A$, and $\partial A$ stands for the boundary of $A$, namely, $\partial A=\mathbf{C l} A \backslash \operatorname{Int} A$.

Note that, if $\mathfrak{D}$ is an admissible domain, then, for a sufficiently small positive $\delta$, we have

We want to permit the variable $\Upsilon$ to take negative values somewhere. In order to do this we extend the equations devided by $\rho$ where $\rho>0$ to the equations:

As for the variable $\Upsilon, \Upsilon \geq 0$ is not assumed. When $(\Upsilon, \boldsymbol{v})$ is a classical $(\Upsilon, \boldsymbol{v})$-solution on the admmisible domain $[0, T[\times \mathfrak{D}$, then $(\rho, \boldsymbol{v})$ defined by

But the inverse may be impossible, namely, we cannot expect that any classical $(\rho, \boldsymbol{v})$-solution comes from classical $(\Upsilon, \boldsymbol{v})$-solution by the above procedure, (1.13), since $1<\frac{1}{\gamma-1}<+\infty$ but $0<\gamma-1<1$ so that $\rho \in C^{1}$ does not imply $\rho^{\gamma-1} \in C^{1}$ at the vacumm boundary. In this sense the concept of classical $(\rho, \boldsymbol{v})$-solutions is weaker than that of classical $(\Upsilon, \boldsymbol{v})$-solutions.

Moreover we note that the uniqueness of solution cannot be expected under the concept of classical $(\rho, \boldsymbol{v})$-solutions in the following sense:

Let $(\rho, \boldsymbol{v})$ be a classical $(\rho, \boldsymbol{v})$-solution on $[0, T[\times \mathfrak{D}, \mathfrak{D}$ being an admissible domain with cover $\tilde{\mathfrak{D}}$. We are interested in motions with compactly supported $\rho$. Namely we use
Definition 5 Let $\mathfrak{D}$ be an admisible domain. ## 2 Stationary solutions

We are lokking for stationary solutions $\Upsilon=\Upsilon(\boldsymbol{x}), \boldsymbol{v}=\boldsymbol{v}(\boldsymbol{x})$. The equation to be satisfied are

Now let us consider the static stationary solution $(\rho, \boldsymbol{v})=(\rho(\boldsymbol{x}), \mathbf{0})$ : that is, $\omega(\varpi)=0$, and

We see the shape of the graph of the function $g$ according to the following three cases:

Then $g(Q)>0$ for $0 \leq Q<Q_{\infty}, g\left(Q_{\infty}\right)=0, g(Q)<0$ for $Q_{\infty}<Q<+\infty$. Here $Q_{\infty}=Q_{\infty}\left(\frac{\lambda^{3}}{\kappa}\right)$ is a number such that $Q_{\infty}>\frac{\lambda}{\kappa}$.

Case (M): $\lambda^{3}=\frac{27}{4} \kappa$.
Then $g(Q)>0$ for $0 \leq Q<\frac{\lambda}{3 \kappa}\left(=\frac{9}{4 \lambda^{2}}\right), g\left(\frac{\lambda}{3 \kappa}\right)=0, g(Q)>0$ for $\frac{\lambda}{3 \kappa}<Q<$ $Q_{\infty}, g\left(Q_{\infty}\right)=0, g(Q)<0$ for $Q_{\infty}<Q<+\infty$.

Case (H): $\lambda^{3}>\frac{27}{4} \kappa$.
Then $g(Q)>0$ for $0 \leq Q<Q_{-}, g\left(Q_{-}\right)=0, g(Q)<0$ for $Q_{-}<Q<Q_{+}$, $g\left(Q_{+}\right)=0, g(Q)>0$ for $Q_{+}<Q<Q_{\infty}, g\left(Q_{\infty}\right)=0, g(Q)<0$ for $Q_{\infty}<Q<$ $+\infty$. Here $Q_{ \pm}=Q_{ \pm}\left(\frac{\lambda^{3}}{\kappa}\right)$ are numbers such that $0<Q_{-}<\frac{\lambda}{3 \kappa}<Q_{+}<\frac{\lambda}{\kappa}$ and $Q_{ \pm} \rightarrow \frac{\lambda}{3 \kappa}$ as $\frac{\lambda^{3}}{\kappa} \rightarrow \frac{27}{4}$.

Recall that we need the function $g(Q)$ only for $0 \leq Q \leq \frac{\lambda}{\kappa}$, and we do not take care of the behavior of $g(Q)$ beyond $Q=\frac{\lambda}{\kappa}$, a fortiori, neither near nor beyond $Q=Q_{\infty}$. Anyway, correspondingly we see the shape of the set $\{F>\lambda\}$ as follows:

In Case (L), the set $\{F>\lambda\}$ is unbounded.
In Case (M), the set $\{F>\lambda\}$ consistes of two connected components, say, $\mathfrak{U}_{0}$ and $\mathfrak{U}_{\infty}$, where $\mathfrak{U}_{0}$ is bounded and included in $\left\{0 \leq X<\sqrt{\frac{\lambda}{3 \kappa}}\left(=\frac{3}{2 \lambda}\right)\right\}$ but $\mathfrak{U}_{\infty}$ is an unbounded subset of $\left\{\sqrt{\frac{\lambda}{3 \kappa}}<X<\sqrt{\frac{\lambda}{\kappa}}\right\}$. Note that $D g\left(\frac{\lambda}{3 \kappa}\right)=0$ so that $\partial \mathfrak{U}_{0}=\left\{F=\lambda, X \leq \frac{3}{2 \lambda}\right\}$ has a corner at the point $(X, Z)=\left(\sqrt{\frac{\lambda}{3 \kappa}}, 0\right)$. Namely $\partial \mathfrak{U}_{0}$ near this point can be described as

In Case (H), the set $\{F>\lambda\}$ consistes of two connected components, say $\mathfrak{U}_{0} \subset\left\{0 \leq X<\sqrt{Q_{-}}\right\}$and $\mathfrak{U}_{\infty} \subset\left\{\sqrt{Q_{+}}<X<\sqrt{\frac{\lambda}{\kappa}}\right\}$. $\mathfrak{U}_{0}$ is bounded but $\mathfrak{U}_{\infty}$ is unbounded. Note that $X$ along $\partial \mathfrak{U}_{0}$ can be solved as a smooth ( real analytic) function of $Z,|Z| \ll 1$, near the point $(X, Z)=\left(\sqrt{Q_{-}}, 0\right)$. Namely the shape of $\partial \mathfrak{U}_{0}=\left\{F=\lambda, X<\sqrt{\frac{\lambda}{3 \hbar}}\right\}$ near this point is

Therefore, applying the above observations to $\lambda=\frac{R_{0}}{R}$, we claim
Theorem 1 Compactly supported axially and equatorially symmetric static stationary solutions with the height of the stratosphere at the North Pole $R>R_{0}$
and constant angular velocity $\Omega$ exist if and only if $\kappa=\frac{\Omega^{2} R_{0}^{3}}{2 \mathrm{G} M_{0}} \leq \frac{4}{27}\left(\frac{R_{0}}{R}\right)^{3}$.
In this sense we should restrict ourselves to the case $0 \leq \kappa<\frac{4}{27} \lambda^{3}$, that is, we require the following assumption
(K): $R>R_{0}$ and it holds

Since $\frac{3}{2 \lambda}<\sqrt{\frac{\lambda}{3 \kappa}}$ and since $g\left(\frac{9}{4 \lambda^{2}}\right)<0$, which is not obvious but can be shown, we see that $\sqrt{Q_{-}}<\frac{3}{2 \lambda}$. On the other hand, we see obviosly that $\frac{3}{2 \lambda}<\sqrt{\frac{\lambda}{3 \kappa}}<\sqrt{Q_{+}}$. Therefore we have the estimate

Note that $\left(\Upsilon \cdot 1_{\varpi<3 R / 2}, \mathbf{0}\right)$ is not a classical $(\Upsilon, \boldsymbol{v})$-solution on $\left[0,+\infty\left[\times\left(\mathbb{R}^{3} \backslash \mathfrak{B}_{0}\right)\right.\right.$ in the sense of Definition 4

We are considering the uniformly rotating atmosphere which occupies

provided (K). Then the boundary $\partial \mathfrak{R}$ of he atmosphere consists of the two connected components $\Sigma_{0}=\partial \mathfrak{B}_{0}=\left\{r=R_{0}\right\}$, the surface of the Earth, and

the stratosphere of the atmosphere. We are going to show that the boundary $\Sigma_{1}$ is a physical vacuum boundary, that is, at each boundary point $\mathrm{P} \in \Sigma_{1}$ we have $\left(\nabla \Upsilon^{b} \mid \boldsymbol{n}\right)<0$, where $\boldsymbol{n}$ is the outer normal vector at P and $\Upsilon^{b}(\boldsymbol{x})=\Upsilon(\varpi, z)$. Recall that $\Upsilon=\frac{1}{\gamma-1} \frac{d P}{d \rho}$, while $\frac{d P}{d \rho}$ is the square of the sound speed.

In fact if we consider the situation in the $(X, Z)$-plane at $\mathrm{P}: X=X_{1}, Z=Z_{1}$ with $0<X_{1}<\sqrt{Q_{-}}, Z_{1}=f\left(X_{1}\right)$ where

Since $0<X_{1}, 0<f\left(X_{1}\right), D f\left(X_{1}\right)<0,0<\kappa$, we see $\left(\nabla \Upsilon^{b} \mid \boldsymbol{n}\right)<0$ at P. The exceptional cases, the $\operatorname{North} \operatorname{Pole}(X=0)$ and the Equator $\left(X=\sqrt{Q_{-}}\right)$, can
be checked easily.
Now we consider a not static stationary solution

Remark 1 In this situation with $R\left(>R_{0}\right)$ being fixed, it is sufficient that the function $\omega$ is given on the finite interval $[0,3 R / 2]$ as a function of $C^{1}$-class on this interval, under a weaker assumption than (B), and we can put

## 3 Description of the flow by the Lagrangian coordinate

Let $\mathfrak{D}_{0}$ be an admissible domain with cover $\tilde{\mathfrak{D}}_{0}$, and let $\boldsymbol{v}$ be a classical admissible velocity field on $\left[0, T_{0}\left[\times \mathfrak{D}_{0}\right.\right.$. Let $\mathfrak{D}$ with a cover $\tilde{\mathfrak{D}}$ be an admissible subdomain of $\mathfrak{D}$, which we shall call a proper asdmissible subdomain of $\mathfrak{D}$, such that $\tilde{\mathfrak{D}} \Subset \tilde{\mathfrak{D}}_{0}$, namely, there is a compact set $K$ such that $\mathbf{C l} \tilde{\mathfrak{D}} \subset \operatorname{Int} K \subset K \subset \tilde{\mathfrak{D}}_{0}$.

Then there is a positive number $T\left(<T_{0}\right)$ such that for any $(\tau, \overline{\boldsymbol{x}}) \in[0, T] \times \tilde{\mathfrak{D}}$ the initial value problem of the ordinary differential equation

admits the unique solution $\boldsymbol{x}=\boldsymbol{\varphi}(t, \tau, \overline{\boldsymbol{x}})$ which exists on $t \in[0, T]$ while $\boldsymbol{x} \in \tilde{\mathfrak{D}}_{0}$. We shall call $\varphi$ the flow associated with the velocity field $\boldsymbol{v}$. The flow $\varphi$, as a function, belongs to the class $C^{1}\left([0, T] \times[0, T] \times \mathbf{C l} \tilde{\mathfrak{D}} ; \tilde{\mathfrak{D}}_{0}\right)$.

In fact the fundamental theorems of ordinary differential equations (see e.g., [6] ) applied to the vector field $\boldsymbol{v}$ considered as a $C^{1}$-field on $\left[0, T_{0}\left[\times \tilde{\mathfrak{D}}_{0}\right.\right.$ guarantee the existence and uniqueness of the flow on $[0, T]$ valued in $\tilde{\mathfrak{D}}_{0}$ for $\boldsymbol{x} \in \operatorname{Int} K$. On the other hand the boundary condition (1.9) of $\boldsymbol{v}$ on $\partial \mathfrak{B}_{0}$ guarantees that $\partial \mathfrak{B}_{0}$ is an invarinat set of the equation so that the flow starting with $\overline{\boldsymbol{x}} \in \mathfrak{D}$ cannot touch $\partial \mathfrak{B}_{0}$ and must remain inside of $\mathfrak{C} \mathfrak{B}_{0}$, namely, $\boldsymbol{x} \in \mathfrak{D} \backslash \mathfrak{B}_{0}=\mathfrak{D}$.

Of course, abstractly speaking, we can consider the existence domain for $\varphi$ of the form $\mathcal{O}=\bigcup_{(\tau, \overline{\boldsymbol{x}}) \in\left[0, T_{0}\left[\times \tilde{\mathfrak{D}}_{0}\right.\right.} I_{\tau, \overline{\boldsymbol{x}}} \times\{\tau\} \times\{\overline{\boldsymbol{x}}\}$, where $I_{\tau, \overline{\boldsymbol{x}}} \subset\left[0, T_{0}[\right.$ is the
maximal interval of existence of the solution of (3.1a) (3.1b). The above observation says that $[0, T] \subset I_{\tau, \overline{\boldsymbol{x}}}$ uniformly for $\forall(\tau, \overline{\boldsymbol{x}}) \in[0, T] \times \tilde{\mathfrak{D}}$.

Therefore, if $\boldsymbol{x} \in \mathfrak{O}$, we see $F(\overline{\boldsymbol{x}}) \in \mathfrak{O}_{1}$ for $\overline{\boldsymbol{x}} \in \mathfrak{O}_{1}$ and $\left\|F\left(\overline{\boldsymbol{x}}^{\prime}\right)-F(\overline{\boldsymbol{x}})\right\| \leq \Theta\left\|\overline{\boldsymbol{x}}^{\prime}-\overline{\boldsymbol{x}}\right\|$ for $\overline{\boldsymbol{x}}^{\prime}, \overline{\boldsymbol{x}} \in \mathfrak{O}_{1}, \Theta$ being $\in] 0,1\left[\right.$, provided that $0 \leq t \leq T_{1} \ll 1$. Here recall that $\mathfrak{O}_{1}$ is supposed to be convex. Therefore the fixed point problem admits the unique soluton $\overline{\boldsymbol{x}}=\boldsymbol{\psi}(t, \boldsymbol{x}) \in \mathfrak{O}_{1}$ for $(t, \boldsymbol{x}) \in\left[0, T_{1}\right] \times \mathfrak{O}$. Then

Thus, if $\overline{\boldsymbol{x}} \in \mathfrak{O}_{0}$, there is $\boldsymbol{x} \in \mathfrak{O}$ such that $\overline{\boldsymbol{x}}=\boldsymbol{\psi}(t, \boldsymbol{x})$ provided that $t \in\left[0, T_{1}\right]$.

In this situation, we can claim
Theorem 2 Let $\mathfrak{D}$ be an admissible domain with cover $\tilde{\mathfrak{D}}, \stackrel{\circ}{\Upsilon}$ be an admissible $\Upsilon$-data on $\mathfrak{D}$, and $\varphi$ be an admissible flow associated with $\stackrel{\circ}{\Upsilon}$. Let $T_{1}, \mathfrak{O}$ be those
of Proposition 2, Put

Given a small $\stackrel{\circ}{\boldsymbol{\xi}}$, we consider $\stackrel{\circ}{\Upsilon}$ determined by (3.36). Of course $\stackrel{\circ}{\Upsilon}-\bar{\Upsilon}$ is small, but the topology of $\{\stackrel{\circ}{\Upsilon}>0\} \cap\{\varpi<3 R / 2\}$ is not clear, generaly speaking. In fact, as for $\{\stackrel{\circ}{\Upsilon}>0\}=\{(1-(\gamma-1)(\nabla \mid \stackrel{\circ}{\boldsymbol{\xi}})) \bar{\Upsilon}>(\nabla \bar{\Upsilon} \mid \stackrel{\circ}{\boldsymbol{\xi}})\}$, we have that $\frac{\nabla \bar{\Upsilon}}{\bar{\Upsilon}}$ may diverge along the vacuum boundary $\Sigma_{1}=\left\{\bar{\Upsilon}=0, \varpi<\frac{3 R}{2}\right\}=\{\bar{\rho}=0\}$ of $\bar{\rho}$. At least, if, for example, $\stackrel{\circ}{\boldsymbol{\xi}}_{1} \in C_{0}^{\infty}\left(\Sigma_{0} \cup \mathfrak{R}\right)$, then for $\stackrel{\circ}{\boldsymbol{\xi}}=\varepsilon \stackrel{\circ}{\boldsymbol{\xi}}_{1}$ with $\varepsilon \ll 1$, it is guaranteed that $\{\stackrel{\circ}{\Upsilon}>0\} \cap\{\varpi<3 R / 2\}=\mathfrak{R}(=\{\bar{\Upsilon}>0\} \cap\{\varpi<3 R / 2\})$. More generally, if $\frac{1}{\bar{\rho}}\left(\nabla \mid \bar{\rho} \stackrel{\circ}{\boldsymbol{\xi}}_{1}\right)=\left(\nabla \log \bar{\rho} \mid \stackrel{\circ}{\boldsymbol{\xi}}_{1}\right)+\left(\nabla \mid \stackrel{\circ}{\boldsymbol{\xi}}_{1}\right) \subset \frac{1}{\gamma-1}\left(\nabla \log \bar{\Upsilon} \mid \stackrel{\circ}{\boldsymbol{\xi}}_{1}\right)+\left(\nabla \mid \stackrel{\circ}{\boldsymbol{\xi}}_{1}\right)$ is bounded on a neighborhood of the vacuum boundary $\Sigma_{1}$ of $\bar{\rho}$, then $\bar{\rho}>0 \Leftrightarrow \stackrel{\circ}{\Upsilon}>0$ there for $\stackrel{\circ}{\boldsymbol{\xi}}=\varepsilon \stackrel{\circ}{\boldsymbol{\xi}}_{1}$ with $\varepsilon \ll 1$.

Historical Remark: The derivation of the linearized approximation of the equations in Lagrangian co-ordinate system can be found [14, Sect. 56], 11, pp. 139-140.], [2, p.11, (A)], [16, [13, p.500, (1)] and so on. But there was considered only the case of $\stackrel{\circ}{\rho}=\bar{\rho}$ and $\stackrel{\circ}{\boldsymbol{\xi}}=0$.

As for the operator $\boldsymbol{J} \cdot: \boldsymbol{v} \mapsto \boldsymbol{J} \boldsymbol{v}$, it is clear that it is a bounded linear operator on $\mathfrak{H}$. But, for the sake of generality, we replace $2 \Omega \boldsymbol{J}$ by the operator $\boldsymbol{B}: \boldsymbol{v} \mapsto B \boldsymbol{v}$ defined by an arbitrary smooth matrix-valued function $B: \boldsymbol{x} \mapsto$ $\left(B_{j}^{i}(\boldsymbol{x})\right)_{i, j} \in C^{\infty}\left(\mathfrak{R} \cup \partial \mathfrak{R} ; \mathbb{R}^{3 \times 3}\right)$. Here $\mathrm{D}(\boldsymbol{L})$ is equipped with the norm $\left(\|\boldsymbol{\xi}\|_{\mathfrak{H}^{\text {div }}}^{2}+\|\boldsymbol{L} \boldsymbol{\xi}\|_{\mathfrak{H}}^{2}\right)^{1 / 2}$.
Correspondingly we may consider the inhomogeneous initial-boundary value problem

## 5 Eigenfrequency, eigenvector, the variational principle

Astrophysicists used to discuss on the so called 'variational principle'. See 4], [5], 16, and so on. Although they discuss about self-gravitating gaseous masses, we would like to follow their discussions by applying them to the present case of the model of rotating atmosphere on the Earth, namely, we consider the linearized wave equation (4.2a).

Since the operator $\boldsymbol{J}: \boldsymbol{v} \mapsto\left[\begin{array}{ccc}0 & -1 & 0 \\ 1 & 0 & 0 \\ 0 & 0 & 0\end{array}\right] \boldsymbol{v}$ is skew symmetric, we introduce the operator $\boldsymbol{J}_{\star}$ defined by

Then the operator $\boldsymbol{J}_{\star}$ is a bounded self-adjoint operator on $\mathfrak{H}$. Recall

Let us suppose that there exists a solution $\boldsymbol{\xi}$ to (5.3) of the form

Definition 10 When the equation (5.5) [( (5.6))] is satisfied for $\sigma \in \mathbb{C}$ and $\boldsymbol{\Xi} \in \mathrm{D}(\boldsymbol{L}), \neq \mathbf{0}$, then $\sigma$ is called an eigenfrequency of the wave equation (5.3) [( (4.2a))] and $\boldsymbol{\Xi}$ is called an eigenvector associated with the eigenfrequency $\sigma$.

Note that 0 is an eigenfrequency. In fact the vector

belongs to $\operatorname{Ker} \boldsymbol{L}$ for any $\boldsymbol{a} \in C_{0}^{\infty}\left(\mathfrak{R} ; \mathbb{C}^{3}\right)$, and turns out to be an eigenvector associated with the eingenfrequency 0 provided that $\boldsymbol{\Xi} \neq \mathbf{0}$.

Here let us recall the operator $\mathbf{A}$ defined as

which was introduced in order to alpply the Hille-Yosida theory to the linear evolution equation in the preceeding section. Obviously we can claim

Proposition 6 If and only if $\sigma \in \mathbb{C}$ is an eigenfrequency of the equation (5.3) [( (4.2a) )], $\Lambda=\mathrm{i} \sigma$ is an eigenvalue of the operator $-\mathbf{A}$.

Let us introduce the following
Definition 11 We denote by $\mathfrak{L}$ the one parameter family of operators $\left(-\sigma^{2}+\right.$ $\left.\sigma 2 \Omega \boldsymbol{J}_{\star}+\boldsymbol{L}\right)_{\sigma \in \mathbb{C}}$, which is called 'quadratic pencil'. We denote

If the operator $\mathfrak{L}(\sigma)=-\sigma^{2}+\sigma 2 \Omega \boldsymbol{J}_{\star}+\boldsymbol{L}$ admits the bounded inverse defined on $\mathfrak{H}$, $\sigma$ is said to belong to the resolvent set $\varrho(\mathfrak{L})$. We denote $\sigma(\mathfrak{L})=\mathbb{C} \backslash \varrho(\mathfrak{L})$, and call it the spectrum of the quadratic pencil $\mathfrak{L}$.

If $\sigma$ is an eigenfrequency, then it belongs to the spectrum $\sigma(\mathfrak{L})$, so, $0 \in \sigma(\mathfrak{L})$, but belonging to $\sigma(\mathfrak{L})$ does not mean being an eigenfrequency a priori, of course.

Proposition $7 \varrho(\mathfrak{L})$ is an open subset of $\mathbb{C}$, and $\sigma(\mathfrak{L})$ is closed.
Proof. Let us consider $\sigma \in \varrho(\mathfrak{L})$. Then

Proof. Let $\sigma \in \varrho(\mathfrak{L})$ and $\Lambda=\mathrm{i} \sigma$. Consider the equation

since $\sigma \in \varrho(\mathfrak{L})$, while $F \mapsto U$ is continuous. Therefore $\Lambda=\mathrm{i} \sigma \in \varrho(-\mathbf{A})$, or, $\mathrm{i} \varrho(\mathfrak{L}) \subset \varrho(-\mathbf{A})$.

Inversely let $\Lambda \in \varrho(-\mathbf{A})$ and $\sigma=-\mathrm{i} \Lambda$. Consider the equation

Since $\Lambda \in \varrho(-\mathbf{A})$ is supposed, this admits the solution

and $\boldsymbol{f} \mapsto \boldsymbol{\Xi}$ is continuous, that is, $\sigma=-\mathrm{i} \Lambda \in \varrho(\mathfrak{L})$.

When $\Omega=0$, we have

where $\sigma(\boldsymbol{L})$ is the spectrum of the self-adjoint operator $\boldsymbol{L}$ in the Hilbert space $\mathfrak{H}$. Since $\mathbf{L}$ is self-adjoint and $\boldsymbol{L} \geq 0$, we have $\sigma(\boldsymbol{L}) \subset\{\lambda \in \mathbb{R} \mid \lambda \geq 0\}$. Thus it holds that

However the gap between the information (5.9) for $\Omega=0$ and that (5.11) for $\Omega \neq 0$ is too much. So, we are want to strengthen (5.11) when $\Omega \neq 0$. In order to do it, we use the following

Proposition 9 If $\sigma \in \varrho(\mathfrak{L})$, then it holds that

If $d<+\infty$, then there is a sequence $\sigma+(\Delta \sigma)_{n} \in \sigma(\mathfrak{L})$ such that $\left|(\Delta \sigma)_{n}\right| \rightarrow d$, and the assertion follows.

Let us fix $\sigma_{\infty} \in \partial \sigma(\mathfrak{L})$. We are going to show $\sigma_{\infty} \in \mathbb{R}$.
Let us consider a sequance $\left(\sigma_{n}\right)_{n}$ such that $\sigma_{n} \in \varrho(\mathfrak{L})$ and $\sigma_{n} \rightarrow \sigma_{\infty}$ as $n \rightarrow \infty$. By Proposition 9 we have $\left\|\|\left(\mathfrak{L}\left(\sigma_{n}\right)^{-1}\| \|_{\mathcal{B}(\mathfrak{H})} \rightarrow+\infty\right.\right.$, therefore there are $\boldsymbol{f}_{n} \in \mathfrak{H}$ such that $\left\|\boldsymbol{f}_{n}\right\|_{\mathfrak{H}}=1$ and $\left.\| \mathfrak{L}\left(\sigma_{n}\right)\right)^{-1} \boldsymbol{f}_{n} \|_{\mathfrak{H}} \rightarrow+\infty$ as $n \rightarrow \infty$. Put $\boldsymbol{\xi}_{n}=\mathfrak{L}\left(\sigma_{n}\right)^{-1} \boldsymbol{f}_{n}(\in \mathrm{D}(\boldsymbol{L}))$ and $\boldsymbol{\eta}_{n}=\boldsymbol{\xi}_{n} /\left\|\boldsymbol{\xi}_{n}\right\|_{\mathfrak{H}}$. Then $\left\|\boldsymbol{\eta}_{n}\right\|_{\mathfrak{H}}=1$ and

But we see

b_{n}:=2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\eta}_{n} \mid \boldsymbol{\eta}_{n}\right)_{\mathfrak{H}}, \quad c_{n}=\left(\boldsymbol{L} \boldsymbol{\eta}_{n} \mid \boldsymbol{\eta}_{n}\right)_{\mathfrak{H}}=Q\left[\boldsymbol{\eta}_{n}\right] .
$$

Therefore $b_{n}, c_{n}$ are real and

Hence, by taking a subsequence if necessary, we can suppose that $b_{n}$ tends to a limit $b_{\infty}$ such that $\left|b_{\infty}\right| \leq 2|\Omega|$. Put $c_{\infty}:=\left(\sigma_{\infty}\right)^{2}-\sigma_{\infty} b_{\infty}$. Then we see $c_{n} \rightarrow c_{\infty}$. Hence $c_{\infty}$ is real and $\geq 0$, and $\sigma_{\infty}$ turns out to enjoy the quadratic equation

This conclusion owes to [8, Theorem 1]. But their original proof is little bit logically weak, and we have needed to edit it as above.

Let us consider $\sigma_{0}=\alpha_{0}+\beta_{0} \mathrm{i} \in \sigma(\mathfrak{L})$, where $\alpha_{0}, \beta_{0} \in \mathbb{R}$. We are going to show that $\left|\beta_{0}\right| \neq 0$ implies a contradiction. By the symmetricity of $\sigma(\mathfrak{L})$ we can suppose $\beta_{0}>0$ without loss of generality. Choosing $K>2|\Omega| \vee \beta_{0}$, we consider the segment

But $\mathfrak{I m}[\sigma(\bar{t})] \geq \beta_{0}>0$, a contradiction to $\partial \sigma(\mathfrak{L}) \in \mathbb{R}$.

Therefore we can claim
Theorem 6 It holds that

Now we note that it is known that there is a sequence of eigenfrequencies $\sigma_{n, \pm}= \pm \sqrt{\lambda_{n}^{\mathcal{N}}}, n \in \mathbb{N}$, when $\Omega=0$. (See the discussion given later.) However, up to now, we have no knowledge on the existence of eigenfrequencies when $\Omega \neq 0$. When $\Omega=0$, then (5.6) reads

Proposition 11 Suppose $\Omega \neq 0$. Let $\sigma \neq 0$ be an eigenfrequency of the equation (5.3) [( 4.2a) )] and $\boldsymbol{\Xi}$ be an associated eigenvector. Then the eigenvector $\boldsymbol{\Xi}$ is impossible to be real, that is, $\mathfrak{I m}[\boldsymbol{\Xi}(\boldsymbol{x})]$ cannot vanish everywhere.

Proof. By Theorem 6 we see $\sigma \in \mathbb{R}$. Let us look at (5.6):

Now (5.15) means

-\sigma^{2} X^{3}+\frac{\partial}{\partial x^{3}}\left(-\frac{\overline{d \Upsilon}}{d \rho} \frac{\partial}{\partial x^{3}}\left(\bar{\rho} X^{3}\right)\right) & =0 \tag{5.19c}
\end{align*}

Consequently, (5.19a) and (5.19b) imply that $-\frac{\overline{d \Upsilon}}{d \rho} \frac{\partial}{\partial x^{3}}\left(\bar{\rho} X^{3}\right)$ is a function of $x^{3}$ independent of $x^{1}, x^{2}$, and, since $\sigma \neq 0$, (5.19c) implies that $X^{3}$ is so, too. However $\boldsymbol{\Xi}=\boldsymbol{X} \in \mathrm{D}(\boldsymbol{L})$ suppose the boundary condition

Let $\sigma$ be an eigenfrequency of the equation 4.2a) and $\boldsymbol{\Xi}$ be an associated eigenvector.

Then $\boldsymbol{\xi}(t, \boldsymbol{x})=e^{\mathrm{i} \sigma t} \boldsymbol{\Xi}(\boldsymbol{x})$ is a solution of the equation (??). Since the coefficients of the equation (4.2a) are real and the equation is linear, we can claim that $\boldsymbol{\xi}(t, \boldsymbol{x})^{*}, \mathfrak{R e}[\boldsymbol{\xi}(t, \boldsymbol{x})], \mathfrak{I m}[\boldsymbol{\xi}(t, \boldsymbol{x})]$ are solutions of (??), too. But, since $\sigma$ is
real by Theorem 6 we see

\left|\Xi(\boldsymbol{x})^{2}\right| \cos \left(\sigma t+\alpha_{2}(\boldsymbol{x})\right) \\
\left|\Xi(\boldsymbol{x})^{3}\right| \cos \left(\sigma t+\alpha_{3}(\boldsymbol{x})\right)
\end{array}\right],
\end{aligned}
$$

where

& \boldsymbol{\Xi}_{\mathfrak{R}}(\boldsymbol{x}):=\mathfrak{R e}[\boldsymbol{\Xi}(\boldsymbol{x})], \quad \boldsymbol{\Xi}_{\mathfrak{J}}(\boldsymbol{x}):=\mathfrak{I m}[\boldsymbol{\Xi}(\boldsymbol{x})] \\
& \tan \alpha_{j}(\boldsymbol{x})=\frac{\Xi_{\mathfrak{I}}(\boldsymbol{x})^{j}}{\Xi_{\mathfrak{R}}(\boldsymbol{x})^{j}}, \quad \text { so that } \quad \Xi(\boldsymbol{x})^{j}=\left|\Xi(\boldsymbol{x})^{j}\right| e^{\mathrm{i} \alpha_{j}(\boldsymbol{x})}
\end{aligned}
$$

Note that the field $\boldsymbol{\xi}_{\mathfrak{R}}(t, \boldsymbol{x})$ is a real-valued solution of (4.2a) such that $\boldsymbol{\xi}_{\mathfrak{R}}(0, \boldsymbol{x})=\boldsymbol{\Xi}_{\mathfrak{R}}(\boldsymbol{x})$.

Let $\sigma, \boldsymbol{\Xi}(\neq \mathbf{0})$ be an eigenfrequency and an associated eigenvector. Multiplying (5.5) by $\boldsymbol{\Xi}^{*} \bar{\rho}(\boldsymbol{x})$ and integrating it, we have

Here D. Lynden-Bell and J. P. Ostriker, [16, p.301, line 18], say:
Equation (36) [ read (5.23) ] shows that the system is stable if $c$ is positive for each eigen $\boldsymbol{\xi}[\operatorname{read} \boldsymbol{\Xi}]$. This assured if $\mathbf{C}[\operatorname{read} \boldsymbol{L}]$ is positive definite. Thus:
A sufficient condition for stability is that $\mathbf{C}[\operatorname{read} \boldsymbol{L}]$ is positive definite. This is the condition for secular stability.

This saying sounds strange. In fact, we may suppose the meaning of the words 'stability' and 'secular stability' as C. Hunter [10] defines:

A general system is said to be ordinarily or dynamically unstable if the amplitude of some mode grows exponentially in time, but ordinarily stable if every mode is oscillatory in time. An ordinarily stable system can be said to be secularly unstable if small additional dissipative forces can cause some perturbation to grow. Otherwise, the system is sad to be secularly stable.

As C. Hunter says in the same article, the definition of secular instability does not always confirm to that given above, so, we consider the (ordinary) stability. If there is an eigenfrequancy $\sigma$ which is not real, then the system described by (5.3) is unstable. It is true. But this means that there is an eigenfrequency $\sigma$ and an associated eigenvector $\boldsymbol{\Xi}$ such that

\frac{b^{2}}{4 a^{2}}+\frac{c}{a}<0
$$

Normalizing $a=\|\boldsymbol{\Xi}\|_{\mathfrak{H}}^{2}=1$, this means

Therefore we can claim that the system is unstable if there is an eigenvector $\Xi$ such that

Of course, in the situation under consideration, this cannot happen, since $Q[\boldsymbol{\Xi}] \geq$ 0 for $\forall \boldsymbol{\Xi} \in \mathrm{D}(\boldsymbol{L})$ and $b \in \mathbb{R}$.

However, logically speaking, the condition $c=Q[\boldsymbol{\Xi}]>0$ for each eigenvector $\boldsymbol{\Xi}$ is far from the condition of the stability, contrary to the saying of D. LyndenBell and J. P. Ostriker.

Moreover let us note the following fact: $Q[\boldsymbol{\Xi}] \geq 0$ for any $\boldsymbol{\Xi} \in \mathfrak{H}^{\text {div }}$, but $Q[\boldsymbol{\Xi}]=0$ does not imply $\boldsymbol{\Xi}=\mathbf{0}$; In fact

$\boldsymbol{a}$ being an arbitrary vector field belonging to $C_{0}^{\infty}(\mathfrak{\Re})$, belongs to the kernel of $\boldsymbol{L}$, that is, $Q[\boldsymbol{\Xi}]=0$.

Anyway, we are going to describe the 'variational principle'.
Let us suppose that there exist $\sigma_{0} \in \mathbb{R}$ and $\boldsymbol{\Xi}_{0} \in \mathfrak{H}^{\text {div }}(\neq \mathbf{0})$ such that

satisfies

The variation $\boldsymbol{\delta} \sigma=\boldsymbol{\delta} \sigma(\boldsymbol{\Xi})$ of $\sigma$ at $\boldsymbol{\Xi},\left\|\boldsymbol{\Xi}-\boldsymbol{\Xi}_{0}\right\|_{\mathfrak{H}^{\text {div }}} \leq \delta$, is the linear functional on $\mathfrak{H}^{\text {div }}$ defined by

\langle\boldsymbol{\delta} \sigma(\boldsymbol{\Xi}) \mid \boldsymbol{h}\rangle=\lim _{\tau \rightarrow 0} \frac{1}{\tau}(\sigma(\boldsymbol{\Xi}+\tau \boldsymbol{h})-\sigma(\boldsymbol{\Xi})) . \tag{5.31}
\end{equation*}
$$

It follows from (5.28) the equation

$$
\begin{equation*}
-\sigma^{2}\|\boldsymbol{\Xi}\|_{\mathfrak{H}}^{2}+\sigma 2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\Xi} \mid \boldsymbol{\Xi}\right)_{\mathfrak{H}}+Q[\boldsymbol{\Xi}]=0 \tag{5.32}
\end{equation*}
$$

holds for $\sigma=\sigma(\boldsymbol{\Xi}), \boldsymbol{\Xi} \in \mathfrak{H}^{\text {div }},\left\|\boldsymbol{\Xi}-\boldsymbol{\Xi}_{0}\right\|_{\mathfrak{H}^{\text {div }}} \leq \delta$. Therefore we have

$$
\begin{aligned}
& \left(-2 \sigma\|\boldsymbol{\Xi}\|_{\mathfrak{H}}^{2}+2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\Xi} \mid \boldsymbol{\Xi}\right)_{\mathfrak{H}}\right) \boldsymbol{\delta} \sigma+ \\
& -\sigma^{2} \boldsymbol{\delta}\|\boldsymbol{\Xi}\|_{\mathfrak{H}}^{2}+\sigma \boldsymbol{\delta}\left(2 \Omega J_{\star} \boldsymbol{\Xi} \mid \boldsymbol{\Xi}\right)_{\mathfrak{H}}+\boldsymbol{\delta} Q[\boldsymbol{\Xi}]=0
\end{aligned}
$$

or, precisely writing,

$$
\begin{aligned}
& \left(-2 \sigma\|\boldsymbol{\Xi}\|_{\mathfrak{H}}^{2}+2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\Xi} \mid \boldsymbol{\Xi}\right)_{\mathfrak{H}}\right)\langle\boldsymbol{\delta} \sigma(\boldsymbol{\Xi}) \mid \boldsymbol{\delta} \boldsymbol{\Xi}\rangle+ \\
& +2 \mathfrak{R e}\left[-\sigma^{2}(\boldsymbol{\Xi} \mid \boldsymbol{\delta} \boldsymbol{\Xi})_{\mathfrak{H}}+\sigma 2 \Omega\left(J_{\star} \boldsymbol{\Xi} \mid \boldsymbol{\delta} \boldsymbol{\Xi}\right)_{\mathfrak{H}}+Q(\boldsymbol{\Xi}, \boldsymbol{\delta} \boldsymbol{\Xi})\right]=0
\end{aligned}
$$

for $\forall \boldsymbol{\delta} \boldsymbol{\Xi} \in \mathfrak{H}^{\text {div }}$. Here we note that

$$
\begin{aligned}
-2 \sigma\|\boldsymbol{\Xi}\|_{\mathfrak{H}}^{2}+2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\Xi} \mid \boldsymbol{\Xi}\right)_{\mathfrak{H}} & =-2 \sigma a(\boldsymbol{\Xi})+b(\boldsymbol{\Xi})= \\
& =-\sqrt{\frac{b(\boldsymbol{\Xi})^{2}}{4 a(\boldsymbol{\Xi})^{2}}+\frac{c(\boldsymbol{\Xi})}{a(\boldsymbol{\Xi})}} \neq 0
\end{aligned}
$$

for $\left\|\boldsymbol{\Xi}-\boldsymbol{\Xi}_{0}\right\|_{\mathfrak{H}^{\text {div }}} \leq \delta$. Therefore $\boldsymbol{\delta} \sigma(\boldsymbol{\Xi})=0$ if and only if

$$
-\sigma^{2}(\boldsymbol{\Xi} \mid \boldsymbol{h})_{\mathfrak{H}}+\sigma 2 \Omega\left(J_{\star} \boldsymbol{\Xi} \mid \boldsymbol{h}\right)_{\mathfrak{H}}+Q(\boldsymbol{\Xi}, \boldsymbol{h})=0
$$

for $\forall \boldsymbol{h} \in \mathfrak{H}^{\text {div }}$. Thus we can claim the following 'variational principle':
Theorem 7 Let $\boldsymbol{\Xi}_{0} \in \mathfrak{H}^{\text {div }}$ satisfy

$$
\left\|\boldsymbol{\Xi}_{0}\right\|_{\mathfrak{H}}^{2}>0, \quad \frac{\left(2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\Xi}_{0} \mid \boldsymbol{\Xi}_{0}\right)_{\mathfrak{H}}\right)^{2}}{4\left\|\boldsymbol{\Xi}_{0}\right\|_{\mathfrak{H}}^{4}}+\frac{Q\left[\boldsymbol{\Xi}_{0}\right]}{\left\|\boldsymbol{\Xi}_{0}\right\|_{\mathfrak{H}}^{2}}>0
$$

The variation $\boldsymbol{\delta} \sigma$ of $\sigma$ (specified by (5.28)) vanishes at $\boldsymbol{\Xi}_{0}$ if and only if $\boldsymbol{\Xi}_{0} \in$ $\mathrm{D}(\boldsymbol{L})$ and enjoys the equation (5.5):

$$
-\sigma_{0}^{2} \boldsymbol{\Xi}_{0}+\sigma_{0} 2 \Omega \boldsymbol{J}_{\star} \boldsymbol{\Xi}_{0}+\boldsymbol{L} \boldsymbol{\Xi}_{0}=\mathbf{0}
$$

Then $e^{\mathrm{i} \sigma_{0} t} \mathbf{\Xi}_{0}(\boldsymbol{x})$ is a solution of the equation (5.3). Here $\sigma_{0}=\sigma\left(\boldsymbol{\Xi}_{0}\right)$.
This principle tells us that, if we want to find an eigenfrequency, we may try to find a stationary point of the functional

$$
\sigma(\boldsymbol{\Xi})=\frac{b(\boldsymbol{\Xi})}{2} \pm \sqrt{\frac{b(\boldsymbol{\Xi})^{2}}{4}+c(\boldsymbol{\Xi})}
$$

under the constraint $\|\boldsymbol{\Xi}\|_{\mathfrak{H}}=1$. But it seems that this principle is far from the solution of the problem to establish the existence and completeness of the system of eigenvectors.

For example, as a 'practical use of the variational principle', D. Lynden-Bell and J. P. Ostriker, [16, Section 2.6], proposed the following scheme:

Take sufficiently many functions $\boldsymbol{\Xi}_{(i)}, i=1, \cdots, N$ as those who consist a base, and consider the trial function

$$
\boldsymbol{\Xi}=\sum_{i=1}^{N} a^{i} \boldsymbol{\Xi}_{(i)}, \quad \boldsymbol{a}=\left[\begin{array}{c}
a^{1} \\
\cdot \\
\cdot \\
a^{N}
\end{array}\right]
$$

Put

$$
\begin{array}{ll}
\boldsymbol{A}=\left(A_{i j}\right)_{i, j}, & A_{i j}=\left(\boldsymbol{\Xi}_{(i)} \mid \boldsymbol{\Xi}_{(j)}\right)_{\mathfrak{H}} \\
\boldsymbol{B}=\left(B_{i j}\right)_{i, j}, & B_{i j}=2 \Omega\left(\boldsymbol{J}_{\star} \boldsymbol{\Xi}_{(i)} \mid \boldsymbol{\Xi}_{(j)}\right)_{\mathfrak{H}}, \\
\boldsymbol{C}=\left(C_{i j}\right)_{i, j}, & C_{i j}=Q\left(\boldsymbol{\Xi}_{(i)}, \boldsymbol{\Xi}_{(j)}\right)
\end{array}
$$

Then

$$
\sigma(\boldsymbol{\Xi})=\left(\left(-\sigma^{2} \boldsymbol{A}+\sigma \boldsymbol{B}+\boldsymbol{C}\right) \boldsymbol{a} \mid \boldsymbol{a}\right)
$$

Thus, D. Lynden-Bell and J. P. Ostriker say, the variational principle reads

$$
\delta\left(\left(-\sigma^{2} \boldsymbol{A}+\sigma \boldsymbol{B}+\boldsymbol{C}\right) \boldsymbol{a} \mid \boldsymbol{a}\right)=0
$$

and, varying $\boldsymbol{a}$, we obtain the 'secular determinant'

$$
\begin{equation*}
\operatorname{det}\left(-\sigma^{2} \boldsymbol{A}+\sigma \boldsymbol{B}+\boldsymbol{C}\right)=0 \tag{5.33}
\end{equation*}
$$

for the determination of the variationally best eigenfrequencies $\sigma$.
But it is doubtful that this scheme is so practtical, since we have no confidence that the equation (5.33), which is an algebraic equation for the unknown $\sigma$ of degree is $2 N$, can be numerically solved to determine an approximating eigenfrequency $\sigma_{N}$ so that they converge to a true eigenfrequency as $N \rightarrow \infty$.

On the other hand, since

$$
\sigma(\boldsymbol{\Xi})=\frac{b(\boldsymbol{\Xi})}{2}+\sqrt{\frac{b(\boldsymbol{\Xi})^{2}}{4}+c(\boldsymbol{\Xi})} \geq 0
$$

for $\forall \boldsymbol{\Xi} \in \mathfrak{H}^{\text {div }}$, we can consider

$$
\sigma_{*}:=\inf \left\{\sigma(\boldsymbol{\Xi}) \mid \boldsymbol{\Xi} \in \mathfrak{H}^{\text {div }},\|\boldsymbol{\Xi}\|_{\mathfrak{H}}=1\right\}
$$

and we may expect that the minimum might give an eigenfrequency. But, when $\Omega \neq 0$, we are not sure about the existence of a $\boldsymbol{\Xi}_{*}$ which attains the infimum, namely $\sigma_{*}=\sigma\left(\boldsymbol{\Xi}_{*}\right)$, in general, since the imbedding $\mathfrak{H}^{\text {div }} \hookrightarrow \mathfrak{H}$ is not compact and we may be unable to extract convergent subsequences from a minimizing sequence, say, a sequence $\left(\boldsymbol{\Xi}_{n}\right)_{n \in \mathbb{N}}$ such that $\boldsymbol{\Xi}_{n} \in \mathfrak{H}^{\text {div }},\left\|\boldsymbol{\Xi}_{n}\right\|_{\mathfrak{H}}=1, \sigma\left(\boldsymbol{\Xi}_{n}\right) \rightarrow \sigma_{*}$ as $n \rightarrow \infty$.

When $\Omega=0$, then $b(\boldsymbol{\Xi})=0$, and the variational problem

$$
\lambda_{*}\left(=\sigma_{*}^{2}\right)=\inf \left\{c(\boldsymbol{\Xi})(=Q[\boldsymbol{\Xi}]) \mid \boldsymbol{\Xi} \in \mathfrak{H}^{\text {div }},\|\boldsymbol{\Xi}\|_{\mathfrak{H}}=1\right\}
$$

actually admits the trivial solution $\lambda_{*}=0$ with any eigenvector $\in \operatorname{Ker}(\boldsymbol{L})$. But the Mini-Max principle does not work, for, since $\operatorname{dim} \cdot \operatorname{Ker}(\boldsymbol{L})=\infty$, we cannot go ahead across the 0 eigenvalue eternally, although there actually remain infinitely many positive eigenvalues. Thus also in this case the variational principle seems to be not so useful.

However, when $\Omega=0$, the equation (5.5) reduces to

$$
\begin{equation*}
-\lambda \boldsymbol{\Xi}+\boldsymbol{L} \boldsymbol{\Xi}=\mathbf{0} \tag{5.34}
\end{equation*}
$$

where $\lambda=\sigma^{2}$, and this eigenvalue problem is completely solved as follows:

Suppose $\Omega=0$. We note that the background stationary solution $\bar{\rho}$ is a spherically symmetric equilibrium, say,

$$
\begin{equation*}
\bar{\rho}(\boldsymbol{x})=\left(\frac{(\gamma-1) \mathrm{G} M_{0}}{\mathrm{~A} \gamma}\left(\frac{1}{r}-\frac{1}{R}\right)\right)^{\frac{1}{\gamma-1}} \tag{5.35}
\end{equation*}
$$

and $\mathfrak{R}=\{\bar{\rho}>0\}=\left\{R_{0}<r<R\right\}$ is an annulus. Taking the divergence of $\bar{\rho}$ times (5.34), the problem reduces to

$$
\begin{equation*}
-\lambda g-\operatorname{div} \bar{\rho}\left(\operatorname{grad} \frac{\overline{d \Upsilon}}{d \rho} g\right)=0 \tag{5.36}
\end{equation*}
$$

where

$$
\begin{equation*}
g=\operatorname{div}(\bar{\rho} \boldsymbol{\Xi}) \tag{5.37}
\end{equation*}
$$

Note that we can treat the operator $\mathcal{N}: g \mapsto \operatorname{div} \bar{\rho}\left(\operatorname{grad} \frac{\overline{d Y}}{d \rho} g\right)$ as that with the similar property to the Laplacian operator $\triangle=$ div.grad, taking into account the singular behaviors of $\bar{\rho}$ and $\frac{\overline{d \Upsilon}}{d \rho}$ at the physical vacuum boundary, say,

$$
\begin{aligned}
& \bar{\rho} \sim\left(\frac{(\gamma-1) \mathrm{G} M_{0}}{\mathrm{~A} \gamma}\right)^{\frac{1}{\gamma-1}}(R-r)^{\frac{1}{\gamma-1}} \\
& \frac{d \Upsilon}{d \rho} \sim \mathrm{~A} \gamma\left(\frac{(\gamma-1) \mathrm{G} M_{0}}{\mathrm{~A} \gamma}\right)^{\frac{\gamma-2}{\gamma-1}}(R-r)^{-\frac{2-\gamma}{\gamma-1}}
\end{aligned}
$$

near $\Sigma_{1}=\{r=R\}$. Therefore we can claim:
The operator $\mathcal{N}$ can be considered as a self-adjoint operator in the Hilbert space $\mathfrak{G}$ and its spectrum $\sigma(\mathcal{N})$ is of the Sturm-Liouville type, that is, $\sigma(\mathcal{N})=$ $\left\{\lambda_{n}^{\mathcal{N}} \mid n \in \mathbb{N}\right\}$, where $\lambda_{n}^{\mathcal{N}}$ is an eigenvalue with finite multiplicity, $0<\lambda_{0}^{\mathcal{N}}<\cdots<$ $\lambda_{n}^{\mathcal{N}}<\lambda_{n+1}^{\mathcal{N}}$, and $\lambda_{n}^{\mathcal{N}} \rightarrow+\infty$ as $n \rightarrow \infty$. Here

$$
\mathfrak{G}=L^{2}\left(\mathfrak{R} ; \frac{\overline{d \Upsilon}}{d \rho} d \boldsymbol{x}\right) \cap\left\{g \mid \int_{\mathfrak{R}} g d \boldsymbol{x}=0\right\} .
$$

Note that the imbedding of $L^{2}\left(\mathfrak{R} ; \frac{\overline{d \Upsilon}}{d \rho} d \boldsymbol{x}\right)$ into $L^{2}(\mathfrak{R} ; d \boldsymbol{x})\left(\hookrightarrow L^{1}(\mathfrak{R} ; d \boldsymbol{x})\right)$ is continuous. For a proof see the proof of [11, Theorem 2]. Hence the argument of [11] leads us to the following conclusion:

When $\Omega=0, L$ can be considered as a self-adjoint operator in the Hilbert space $\mathfrak{F}$ and its spectrum $\sigma(\boldsymbol{L})$ coincides with $\sigma(\mathcal{N}) \cup\{0\}$, while $\operatorname{dim} \cdot \operatorname{Ker}(\boldsymbol{L})=\infty$ and $\lambda=\lambda_{n}^{\mathcal{N}} \neq 0$ is an eigenvalue with finite multilicity. Here

$$
\mathfrak{F}=\{\boldsymbol{\Xi} \in \mathfrak{H} \mid \operatorname{div}(\bar{\rho} \boldsymbol{\Xi}) \in \mathfrak{G}\}=\left\{\boldsymbol{\Xi} \in \mathfrak{H}^{\operatorname{div}} \mid \int_{\mathfrak{R}} \operatorname{div}(\bar{\rho} \boldsymbol{\Xi}) d \boldsymbol{x}=0\right\}
$$

Note that $\mathfrak{F}$ is a closed subspace of $\mathfrak{H}^{\text {div }}$, since $\mathfrak{G} \ni g \mapsto \int_{\mathfrak{R}} g d \boldsymbol{x}$ is constinuous. In fact, we have $\int_{\mathfrak{R}} \frac{\overline{d \rho}}{d \Upsilon} d \boldsymbol{x}<+\infty$ thanks to $\gamma>1$ so that

$$
\left|\int g\right| \leq\left[\int \frac{\overline{d \Upsilon}}{d \rho}|g|^{2}\right]^{1 / 2}\left[\int_{\mathfrak{R}} \frac{\overline{d \rho}}{d \Upsilon}\right]^{1 / 2} \lesssim\|g\|_{L^{2}\left(\frac{d \Upsilon}{d \rho} d \boldsymbol{x}\right)}
$$

We have $\mathfrak{H}_{0}^{\text {div }} \subset \mathfrak{F}$, since

$$
\int \operatorname{div}(\bar{\rho} \varphi) d \boldsymbol{x}=0 \quad \text { for } \quad \forall \boldsymbol{\phi} \in C_{0}^{\infty}(\Re)
$$

Therefore by the well-known theorem ( [7, p.905, X.3.4.Theorem] complemented by [12, p. 177, Chapter III, Theorem 6.15]), we can say that the eigenvectors of a CONS of $\operatorname{Ker}(\boldsymbol{L})$ and all

$$
\psi_{n}=\frac{1}{\lambda_{n}^{\mathcal{N}}} \bar{\rho} \operatorname{grad}\left(-\frac{\overline{d \Upsilon}}{d \rho} \varphi_{n}^{\mathcal{N}}\right)\left\|\frac{1}{\lambda_{n}^{\mathcal{N}}} \bar{\rho} \operatorname{grad}\left(-\frac{\overline{d \Upsilon}}{d \rho} \varphi_{n}^{\mathcal{N}}\right)\right\|^{-1}
$$

$\varphi_{n}^{\mathcal{N}}$ being an eigenvalue of $\mathcal{N}$ associated with the eigenvalue $\lambda_{n}^{\mathcal{N}} \neq 0$ form a complete ortogonal system of the Hilbert space $\mathfrak{F}$.

In this sense, when $\Omega=0$, the eigenfrequency problem is completely solved.
Remark 2 Let $\Omega=0$. If we consider the operator $\boldsymbol{L}$ in the space $\mathfrak{H}$, we can claim that $\{0\} \cap \sigma(\mathcal{N})=\left\{0, \lambda_{0}^{\mathcal{N}}, \lambda_{1}^{\mathcal{N}}, \cdots\right\} \subset \sigma(\boldsymbol{L})$, but we do not know whether they coincide or not, say, we do not know whether there are real continuous spectrum between the eigenvalues or not.

However, when $\Omega \neq 0$, the above discussion seems not to work. In fact the term $2 \Omega\left(\nabla \mid \bar{\rho} J_{\star} \boldsymbol{\Xi}\right)$ may cause trouble, since it cannot be reduced to a quantity determined by $g=(\nabla \mid \bar{\rho} \boldsymbol{\Xi})$.
