# 2-local derivations and biderivations of $\mathfrak{s l}(2)$ on all simple modules *

#### Abstract

This paper generalizes the concepts of 2-local derivations and biderivations (without the skewsymmetric condition) of a finite-dimensional Lie algebra from the adjoint module to any finite-dimensional module, and determines all 2-local derivations and biderivations of the 3 -dimensional complex simple Lie algebra $\mathfrak{s l}(2)$ on its any finitedimensional simple module.

## 1. Introduction

It has been proved that derivations and generalized derivations of algebras are influential and far-reaching, which are very important subjects in the study of both algebras and their generalizations. The concepts of 2-local derivations and biderivations of Lie algebras (on the adjoint module) are first introduced in 2015 and 2011 respectively (see 3, 6, 14 ), which have aroused the interest of a great many authors in recent years, see [1] 10, 12-17]. For any complex simple Lie algebra (on the adjoint module), each 2-local derivation must be a derivation (see [3]); and every (skewsymmetric) biderivation is an inner one (see [12, 15]). In 2018, Brešar and Zhao generalized the concept of skewsymmetric biderivations of Lie algebras from the adjoint module to any module in the paper [5]. Motivated by Brešar and Zhao's work on skewsymmetric biderivations, we aim to generalize the notions of 2-local derivations and biderivations (without the skewsymmetric condition) of a finite-dimensional Lie algebra from the adjoint module to any finite-dimensional module, and determine all 2-local derivations and biderivations of $\mathfrak{s l}(2)$ on any simple module $V(n)$. It is well-known that 3-dimensional complex simple Lie algebra $\mathfrak{s l}(2)$ is so important that its simple modules determine the structure of semi-simple Lie algebras. In this paper, we determine all 2-local derivations and biderivations of $\mathfrak{s l}(2)$ on $V(2)$, which covers the result about $\mathfrak{s l}(2)$ in the paper [3] and [12]. Our main results are listed in the following, in which $\operatorname{Bder}(\mathfrak{s l}(2), V(n))$ and $\operatorname{Ibder}(\mathfrak{s l}(2))$ are defined in Subsections 2.1. and 3.2. respectively.

Theorem 1.1. Every 2-local derivation of $\mathfrak{s l}(2)$ on $V(n)$ is a derivation.

[^0]Theorem 1.2. $\operatorname{Bder}(\mathfrak{s l}(2), V(n))= \begin{cases}\operatorname{Ibder}(\mathfrak{s l}(2)) & n=2 \\ 0 & n \neq 2 .\end{cases}$

## 2. Preliminaries

In this paper, let $L$ be a finite-dimensional Lie algebra over the complex number field $\mathbb{C}$ and $V$ a finite-dimensional $L$-module. Denote by $\operatorname{Hom}(L, V)$ the set consisting of linear maps from $L$ to $V$, and $V^{L}$ the maximal trivial submodule of $V$, that is,

$$
V^{L}=\{v \in V \mid x v=0, \forall x \in L\} .
$$

### 2.1. Definitions

For $D \in \operatorname{Hom}(L, V)$, if

$$
D([x, y])=x D(y)-y D(x), \quad \forall x, y \in L
$$

then $D$ is said to be a derivation of $L$ on $V$. Denote by $\operatorname{Der}(L, V)$ the set consisting of all derivations of $L$ on $V$. It is clear that $\operatorname{Der}(L, V)$ is a finite-dimensional vector space. Let $D \in \operatorname{Der}(L, V)$. If there exists $v \in V$, such that $D(x)=x v$ for any $x \in L$, then $D$ is said to be an inner determined by $v$, denoted by $D^{v}$. Write

$$
\operatorname{Ider}(L, V)=\left\{D^{v} \mid v \in V\right\} .
$$

It is clear that $\operatorname{Ider}(L, V)$ is a subspace of $\operatorname{Der}(L, V)$.
In the following, we introduce the definitions of 2-local derivations and biderivations of $L$ on $V$, which generalizes the usual ones from the adjoint module to any finite-dimensional module.

Definition 2.1. Let $g: L \longrightarrow V$ be a map. If for any $x, y \in L$, there exists $D_{x, y} \in \operatorname{Der}(L, V)$ (depending on $x, y$ ), such that

$$
g(x)=D_{x, y}(x), \quad g(y)=D_{x, y}(y)
$$

then $g$ is said to be a 2-local derivation of $L$ on $V$.
Definition 2.2. Let $g: L \times L \rightarrow V$ be a bilinear map. If for any $x, y, z \in L$,

$$
\begin{aligned}
& g([x, y], z)=x g(y, z)-y g(x, z) \\
& g(x,[y, z])=y g(x, z)-z g(x, y)
\end{aligned}
$$

then $g$ is said to be a biderivation of $L$ on $V$. Denote by $\operatorname{Bder}(L, V)$ the set consisting of biderivations of $L$ on $V$.

### 2.2. Lemmas

In this subsection, we give some technical lemmas which will be used in the future.
Lemma 2.3. Let $V$ be a nontrivial and simple L-module. Then

$$
a_{1} D^{u_{1}}+a_{2} D^{u_{2}}+\cdots+a_{k} D^{u_{k}}=0 \Longleftrightarrow a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}=0
$$

where $u_{1}, u_{2}, \ldots, u_{k} \in V, a_{1}, a_{2}, \ldots, a_{k} \in \mathbb{C}$. In particular,

$$
D^{u_{1}}, \ldots, D^{u_{k}} \text { is a basis of } \operatorname{Ider}(L, V) \Longleftrightarrow u_{1}, \ldots, u_{k} \text { is a basis of } V .
$$

Proof. Let $x \in L$. Then

$$
\begin{aligned}
& \left(a_{1} D^{u_{1}}+a_{2} D^{u_{2}}+\cdots+a_{k} D^{u_{k}}\right)(x) \\
& =a_{1} D^{u_{1}}(x)+a_{2} D^{u_{2}}(x)+\cdots+a_{k} D^{u_{k}}(x) \\
& =a_{1} x u_{1}+a_{2} x u_{2}+\cdots+a_{k} x u_{k} \\
& =x\left(a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}\right) \\
& =D^{a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}}(x) .
\end{aligned}
$$

That is,

$$
a_{1} D^{u_{1}}+a_{2} D^{u_{2}}+\cdots+a_{k} D^{u_{k}}=D^{a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}}
$$

which implies the "if" direction.
Let $a_{1} D^{u_{1}}+a_{2} D^{u_{2}}+\cdots+a_{k} D^{u_{k}}=0$. For any $x \in L$, we have

$$
\left(a_{1} D^{u_{1}}+a_{2} D^{u_{2}}+\cdots+a_{k} D^{u_{k}}\right)(x)=0
$$

then

$$
D^{a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}}(x)=x\left(a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}\right) .
$$

It follows that

$$
a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k} \in V^{L} .
$$

Since $V$ is nontrivial and simple, we get $V^{L}=0$. Then

$$
a_{1} u_{1}+a_{2} u_{2}+\cdots+a_{k} u_{k}=0
$$

Denote by $\operatorname{Blin}(L, V)$ the set consisting of bilinear maps from $L \times L$ to $V$. Let $\mathfrak{h}$ be a Cartan subalgebra of $L$. Suppose $L$ and $V$ possess weight space decompositions with respect to $\mathfrak{h}$ :

$$
L=\mathfrak{h} \bigoplus \sum_{\alpha \in \mathfrak{h}^{*}} L_{\alpha}, \quad V=\bigoplus_{\alpha \in \mathfrak{h}^{*}} V_{\alpha}
$$

In this manner, $L$ is also an $\mathfrak{h}^{*}$-graded Lie algebra and $V$ an $\mathfrak{h}^{*}$-graded module. Then the assumption on the dimensions implies that the $L$-modules $\operatorname{Hom}(L, V)$ and $\operatorname{Blin}(L, V)$ have $\mathfrak{h}^{*}$-grading structure induced by the ones of $L$ and $V$ :

$$
\begin{aligned}
& \operatorname{Hom}(L, V)=\bigoplus_{\gamma \in \mathfrak{h}^{*}} \operatorname{Hom}(L, V)_{(\gamma)} \\
& \operatorname{Blin}(L, V)=\bigoplus_{\gamma \in \mathfrak{h}^{*}} \operatorname{Bin}(L, V)_{(\gamma)}
\end{aligned}
$$

where

$$
\begin{aligned}
\operatorname{Hom}(L, V)_{(\gamma)} & =\left\{\phi \in \operatorname{Hom}(L, V) \mid \phi\left(L_{\alpha}\right) \subset V_{\alpha+\gamma}, \forall \alpha \in \mathfrak{h}^{*}\right\} \\
\operatorname{Blin}(L, V)_{(\gamma)} & =\left\{\phi \in \operatorname{Blin}(L, V) \mid \phi\left(L_{\alpha}, L_{\beta}\right) \subset V_{\alpha+\beta+\gamma}, \forall \alpha, \beta \in \mathfrak{h}^{*}\right\} .
\end{aligned}
$$

Moreover, $\operatorname{Hom}(L, V)$ and $\operatorname{Blin}(L, V)$ are $L$-modules with the following action:

$$
(x f)(y)=x f(y)-f([x, y]),
$$

$$
(x g)(y, z)=x g(y, z)-g([x, y], z)-g(y,[x, z])
$$

where $x, y, z \in L, f \in \operatorname{Hom}(L, V), g \in \operatorname{Blin}(L, V)$. Clearly, $\operatorname{Hom}(L, V)_{(\gamma)}$ and $\operatorname{Blin}(L, V)_{(\gamma)}$ are precisely the weight spaces of weight $\gamma$ with respect to $\mathfrak{h}$ :

$$
\begin{aligned}
\operatorname{Hom}(L, V)_{(\gamma)} & =\operatorname{Hom}(L, V)_{\gamma} \\
& =\{\varphi \in \operatorname{Hom}(L, V) \mid h \varphi=\gamma(h) \varphi, \forall h \in \mathfrak{h}\}, \\
\operatorname{Blin}(L, V)_{(\gamma)} & =\operatorname{Blin}(L, V)_{\gamma} \\
& =\{\varphi \in \operatorname{Blin}(L, V) \mid h \varphi=\gamma(h) \varphi, \forall h \in \mathfrak{h}\} .
\end{aligned}
$$

It is a standard fact that $\operatorname{Der}(L, V)$ is an $\mathfrak{h}^{*}$-graded submodule (hence a weight-submodule with respect to $\mathfrak{h})$ of $\operatorname{Hom}(L, V)$ :

$$
\begin{equation*}
\operatorname{Der}(L, V)=\bigoplus_{\gamma \in \mathfrak{h}^{*}} \operatorname{Der}(L, V) \cap \operatorname{Hom}(L, V)_{\gamma} \tag{2.1}
\end{equation*}
$$

Lemma 2.4. Keep the notations as above. Then

$$
\operatorname{Bder}(L, V)=\bigoplus_{\gamma \in \mathfrak{h}^{*}} \operatorname{Bder}(L, V) \cap \operatorname{Blin}(L, V)_{\gamma}
$$

Proof. For any $g \in \operatorname{Bder}(L, V)$, there exists $g_{\gamma} \in \operatorname{Blin}(L, V)_{\gamma}$ such that $g=\sum_{\gamma \in \mathfrak{h}^{*}} g_{\gamma}$. If $x \in L_{\beta}$ with $\beta \in \mathfrak{h}^{*}$, then $g(x, \cdot)=\sum_{\gamma \in \mathfrak{h}^{*}} g_{\gamma}(x, \cdot)$. Note that $g(x, \cdot) \in \operatorname{Der}(L, V)$ and $g_{\gamma}(x, \cdot) \in \operatorname{Hom}(L, V)_{\gamma+\beta}$. Then by Equation (2.1), we have $g_{\gamma}(x, \cdot) \in \operatorname{Der}(L, V)_{\gamma+\beta}$. It follows that $g_{\gamma}(y, \cdot) \in \operatorname{Der}(L, V)$ for any $y \in L$. Similarly, $g_{\gamma}(\cdot, y) \in \operatorname{Der}(L, V)$ for any $y \in L$. Then $g_{\gamma} \in \operatorname{Bder}(L, V)$.

Lemma 2.5. Let $V$ be a nontrivial and simple $L$-module. If $\operatorname{Der}(L, V)=\operatorname{Ider}(L, V)$, then for any $g \in \operatorname{Bder}(L, V)_{\alpha}$ with $\alpha \in \mathfrak{h}^{*}$, there exist two maps $\varphi, \psi \in \operatorname{Hom}(L, V)_{\alpha}$ such that

$$
g(x, y)=x \varphi(y)=y \psi(x), \quad \forall x, y \in L
$$

Proof. Let $x \in L$. By definition we have $g(x, \cdot) \in \operatorname{Der}(L, V)$ and $g(\cdot, x) \in \operatorname{Der}(L, V)$. Since $\operatorname{Der}(L, V)=\operatorname{Ider}(L, V)$ and $V$ is a nontrivial and simple $L$-module, then there exists the unique $v \in V$ such that $g(x, \cdot)=D^{v}$, and the unique $w \in V$ such that $g(\cdot, x)=D^{w}$, that is,

$$
g(x, y)=D^{v}(y)=y v, g(y, x)=D^{w}(y)=y w, \quad \forall y \in L
$$

Define the maps $\psi: L \rightarrow V$ by $\psi(x)=v$ and $\varphi: L \rightarrow V$ by $\varphi(x)=w$, which means

$$
g(x, y)=y \psi(x), g(y, x)=y \varphi(x), \quad \forall y \in L
$$

Claim $\psi \in \operatorname{Hom}(L, V)$. In fact, for any $a \in \mathbb{C}$ and $x_{1}, x_{2}, y \in L$, the equation

$$
g\left(a x_{1}+x_{2}, y\right)=a g\left(x_{1}, y\right)+g\left(x_{2}, y\right)
$$

implies

$$
y \psi\left(a x_{1}+x_{2}\right)=a y \psi\left(x_{1}\right)+y \psi\left(x_{2}\right)=y\left(a \psi\left(x_{1}\right)+\psi\left(x_{2}\right)\right) .
$$

Since $y$ is arbitrary, we have

$$
\psi\left(a x_{1}+x_{2}\right)-a \psi\left(x_{1}\right)-\psi\left(x_{2}\right) \in V^{L}=0
$$

where the last equality holds since $V$ is nontrivial and simple. Hence

$$
\psi\left(a x_{1}+x_{2}\right)=a \psi\left(x_{1}\right)+\psi\left(x_{2}\right)
$$

that is, $\psi \in \operatorname{Hom}(L, V)$. In the following, we shall prove $\psi \in \operatorname{Hom}(L, V)_{\alpha}$. Let $\beta, \gamma \in \mathfrak{h}^{*}$, $x \in L_{\beta}, y \in L_{\gamma}$ and $h \in \mathfrak{h}$. On one hand,

$$
h g(x, y)=(\alpha+\beta+\gamma)(h) g(x, y)=(\alpha+\beta+\gamma)(h) y \psi(x)
$$

On the other hand,

$$
\begin{aligned}
h g(x, y)=h y \psi(x) & =[h, y] \psi(x)+y h \psi(x) \\
& =\gamma(h) y \psi(x)+y h \psi(x) \\
& =y(\gamma(h) \psi(x)+h \psi(x)) .
\end{aligned}
$$

Then

$$
(\alpha+\beta)(h) y \psi(x)=y h \psi(x) .
$$

Since both $\gamma$ and $y$ are arbitrary, so

$$
h \psi(x)-(\alpha+\beta)(h) \psi(x) \in V^{L}=0
$$

that is,

$$
h \psi(x)=(\alpha+\beta)(h) \psi(x) .
$$

It follows that $\psi \in \operatorname{Hom}(L, V)_{\alpha}$. Similarly, $\varphi \in \operatorname{Hom}(L, V)_{\alpha}$.
Recall that 3-dimensional simple Lie algebra $\mathfrak{s l}(2)$ has a standard basis:

$$
e:=\left(\begin{array}{ll}
0 & 1 \\
0 & 0
\end{array}\right), \quad h:=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right), \quad f:=\left(\begin{array}{ll}
0 & 0 \\
1 & 0
\end{array}\right)
$$

As we are all known, $n+1$-dimensional simple $\mathfrak{s l}(2)$-module $V(n)$ has a standard basis:

$$
v_{0}, v_{1}, \ldots, v_{n}
$$

with the action as follows:

$$
e v_{i}=i(n+1-i) v_{i-1}, \quad h v_{i}=(n-2 i) v_{i}, \quad f v_{i}=v_{i+1}
$$

where $i=0,1, \ldots, n, v_{-1}=v_{n+1}=0$. Note that $\mathbb{C} h$ is a Cartan subalgebra of $\mathfrak{s l}(2)$, and

$$
\mathfrak{s l l}(2)=\mathbb{C} h \bigoplus \mathfrak{s l}(2)_{2} \bigoplus \mathfrak{s l}(2)_{-2}, \quad V(n)=\bigoplus_{i=0}^{n} V(n)_{n-2 i},
$$

where

$$
\mathfrak{s l}(2)_{2}=\mathbb{C} e, \quad \mathfrak{s l}(2)_{-2}=\mathbb{C} f, \quad V(n)_{n-2 i}=\mathbb{C} v_{i}
$$

Write

$$
\Delta_{V}=\{n-2 i \mid i=0,1, \cdots, n\}, \quad \Delta=\{0,2,-2\} .
$$

The following lemma characterizes the weight spaces $\operatorname{Bder}(\mathfrak{s l}(2), V(n))_{\gamma}$ for $\gamma \notin \Delta_{V}$.
Lemma 2.6. Let $n \geq 1$. If $\gamma \notin \Delta_{V}$, then $\operatorname{Bder}(\mathfrak{s l}(2), V(n))_{\gamma}=0$.

Proof. Claim that $\operatorname{Bder}(\mathfrak{s l}(2), V(n))_{\gamma}=0$ if $\gamma \notin \Delta_{V} \cup \Delta$. In fact, Let $g \in \operatorname{Bder}(\mathfrak{s l}(2), V(n))_{\gamma}$. Then by Lemma 2.5 there exist $\varphi, \psi \in \operatorname{Hom}(\mathfrak{s l}(2), V(n))_{\gamma}$ such that

$$
g(x, y)=x \varphi(y)=y \psi(x), \quad \forall x, y \in \mathfrak{s l}(2)
$$

Let $x=h$ and $y \in \mathfrak{s l}(2)_{\eta}$ with $\eta \in \Delta$. Then

$$
\varphi(y) \in V(n)_{\gamma+\eta}, \quad \psi(h) \in V(n)_{\gamma}=0
$$

It follows that

$$
g(h, y)=h \varphi(y)=y \psi(h)=0
$$

and then $\varphi(y) \in V(n)_{0}$. Hence we have $\varphi(y) \in V(n)_{\gamma+\eta} \cap V(n)_{0}$. Note that $\gamma+\eta \neq 0$, and then $\varphi(y)=0$. Since $\eta$ and $y$ are arbitrary, so $\varphi=0$.

Below we shall prove that $\operatorname{Hom}(\mathfrak{s l}(2), V(n))_{\gamma}=0$ if $n$ is odd and $\gamma \in \Delta$. Let $\varphi \in$ $\operatorname{Hom}(\mathfrak{s l}(2), V(n))_{\gamma}$. Then

$$
\varphi(e) \in V(n)_{2+\gamma}, \quad \varphi(f) \in V(n)_{-2+\gamma}, \quad \varphi(h) \in V(n)_{\gamma} .
$$

Since $n$ is odd and $\gamma \in \Delta$, so $V(n)_{ \pm 2+\gamma}=V(n)_{\gamma}=0$, which implies $\varphi=0$.

## 3. Proof of the Main Results

In this section, we shall determine all 2-local derivations and biderivations of $\mathfrak{s l}(2)$ on $V(n)$.

### 3.1. 2-local derivations

Proof of Theorem 1.1 Let $g$ be a 2-local derivation of $\mathfrak{s l}(2)$ on $V(n)$. In the following we shall prove that $g$ is a derivation by steps.

Step 1 By definition, there exists $D_{h, e} \in \operatorname{Der}(\mathfrak{s l}(2), V(n))$, such that

$$
g(h)=D_{h, e}(h), \quad g(e)=D_{h, e}(e),
$$

that is,

$$
\left(g-D_{h, e}\right)(h)=g(h)-D_{h, e}(h)=0, \quad\left(g-D_{h, e}\right)(e)=g(e)-D_{h, e}(e)=0 .
$$

Note that $g_{1}:=g-D_{h, e}$ is also a 2-local derivation of $\mathfrak{s l}(2)$ on $V(n)$ and $g_{1}(h)=g_{1}(e)=0$.
Step 2 By definition, for all $x, y \in \mathfrak{s l}(2)$, there exists $D_{x, y} \in \operatorname{Der}(\mathfrak{s l}(2), V(n))$, such that

$$
g_{1}(x)=D_{x, y}(x), \quad g_{1}(y)=D_{x, y}(y)
$$

By Lemma 2.3] $\operatorname{Ider}(\mathfrak{s l}(2), V(n))$ has a basis: $D^{v_{0}}, D^{v_{1}}, \ldots, D^{v_{n}}$. Since the first cohomology of $\mathfrak{s l}(2)$ with the coefficients $V(n)$ is trivial (see [11]), we have

$$
\operatorname{Ider}(\mathfrak{s l}(2), V(n))=\operatorname{Der}(\mathfrak{s l}(2), V(n))
$$

That is, $\operatorname{Der}(\mathfrak{s l}(2), V(n))$ has a basis: $D^{v_{0}}, D^{v_{1}}, \ldots, D^{v_{n}}$. Thus we may assume that

$$
D_{x, y}=\sum_{i=0}^{n} a_{i}(x, y) D^{v_{i}}=D^{v_{x, y}}, \quad a_{i}(x, y) \in \mathbb{F}
$$

where $v_{x, y}=\sum_{i=0}^{n} a_{i}(x, y) v_{i}$. It follows that

$$
\begin{aligned}
& g_{1}(x)=D_{x, y}(x)=x\left(\sum_{i=0}^{n} a_{i}(x, y) v_{i}\right) \\
& g_{1}(y)=D_{x, y}(y)=y\left(\sum_{i=0}^{n} a_{i}(x, y) v_{i}\right)
\end{aligned}
$$

Step 3 On one hand, by Step 2 we get

$$
\begin{aligned}
& g_{1}(f)=f\left(\sum_{i=0}^{n} a_{i}(f, e) v_{i}\right)=\sum_{i=0}^{n} a_{i}(f, e) v_{i+1} \\
& g_{1}(e)=e\left(\sum_{i=0}^{n} a_{i}(f, e) v_{i}\right)=\sum_{i=0}^{n} a_{i}(f, e) i(n+1-i) v_{i-1}
\end{aligned}
$$

Since $g_{1}(e)=0$ by Step 1, we get $i(n+1-i) a_{i}(f, e)=0$ for $1 \leq i \leq n$, which implies that $a_{i}(f, e)=0$ for $1 \leq i \leq n$. Then

$$
\begin{equation*}
g_{1}(f)=a_{0}(f, e) v_{1} \tag{3.1}
\end{equation*}
$$

On the other hand, by Step 2 we get

$$
\begin{aligned}
& g_{1}(f)=f\left(\sum_{i=0}^{n} a_{i}(f, h) v_{i}\right)=\sum_{i=0}^{n} a_{i}(f, h) v_{i+1}, \\
& g_{1}(h)=h\left(\sum_{i=0}^{n} a_{i}(f, h) v_{i}\right)=\sum_{i=0}^{n} a_{i}(f, h)(n-2 i) v_{i} .
\end{aligned}
$$

Since $g_{1}(h)=0$ by Step 1 , we get $a_{i}(f, e)(n-2 i)=0$ for $0 \leq i \leq n$.
If $n$ is odd, then $a_{i}(f, h)=0$, which implies $g_{1}(f)=0$.
If $n$ is even and nonzero, then $a_{i}(f, h)=0$ for $i \neq \frac{n}{2}$, which implies

$$
\begin{equation*}
g_{1}(f)=a_{\frac{n}{2}}(f, h) v_{\frac{n}{2}+1} \tag{3.2}
\end{equation*}
$$

By Equations (3.1) and (3.2), we get

$$
a_{0}(f, e) v_{1}=a_{\frac{n}{2}}(f, h) v_{\frac{n}{2}+1}, \quad \text { if } n \text { is even and nonzero. }
$$

When $n$ is even and nonzero, $v_{1}, v_{\frac{n}{2}+1}$ are linearly independent, then $a_{0}(f, e)=a_{\frac{n}{2}}(f, h)=0$, which means $g_{1}(f)=0$.
If $n=0$, then $V(n)$ is a trivial $\mathfrak{s l}(2)$-module. It is clear that $g_{1}(f)=0$ by the definition of 2-local derivations.

In summary, $g_{1}(f)=0$.
Step 4 Let $x=x_{e} e+x_{h} h+x_{f} f \in \mathfrak{s l}(2)$, where $x_{e}, x_{h}, x_{f} \in \mathbb{C}$. By Steps 1 and 2 , we get

$$
\begin{aligned}
& g_{1}(f)=f\left(\sum_{i=0}^{n} a_{i}(x, f) v_{i}\right)=\sum_{i=0}^{n} a_{i}(x, f) v_{i+1}=0 \\
& g_{1}(e)=e\left(\sum_{i=0}^{n} a_{i}(x, e) v_{i}\right)=\sum_{i=0}^{n} a_{i}(x, e) i(n+1-i) v_{i-1}=0
\end{aligned}
$$

Then $a_{i}(x, f)=0$ for $0 \leq i \leq n-1$ and $a_{j}(x, e)=0$ for $1 \leq j \leq n$. It follows that

$$
\begin{align*}
& g_{1}(x)=x a_{n}(x, f) v_{n}=\left(x_{e} e+x_{h} h\right) a_{n}(x, f) v_{n}=a_{n}(x, f)\left(n x_{e} v_{n-1}-n x_{h} v_{n}\right),  \tag{3.3}\\
& g_{1}(x)=x a_{0}(x, e) v_{0}=\left(x_{h} h+x_{f} f\right) a_{0}(x, e) v_{0}=a_{0}(x, e)\left(n x_{h} v_{0}+x_{f} v_{1}\right) . \tag{3.4}
\end{align*}
$$

By Equations (3.3) and (3.4), we get

$$
a_{0}(x, e)\left(n x_{h} v_{0}+x_{f} v_{1}\right)=a_{n}(x, f)\left(n x_{e} v_{n-1}-n x_{h} v_{n}\right)
$$

If $n>2$, then $a_{0}(x, e)=0$ or $a_{n}(x, f)=0$, and $g_{1}(x)=0$.
By Steps 1 and 2, we get

$$
\begin{aligned}
& g_{1}(x)=x\left(\sum_{i=0}^{n} a_{i}(x, h) v_{i}\right)=\sum_{i=0}^{n} a_{i}(x, h) x v_{i}, \\
& g_{1}(h)=h\left(\sum_{i=0}^{n} a_{i}(x, h) v_{i}\right)=\sum_{i=0}^{n}(n-2 i) a_{i}(x, h) v_{i}=0 .
\end{aligned}
$$

If $n=1$, then all $a_{i}(x, h)=0$, which implies $g_{1}(x)=0$.
Let $n=2$ in the following. Then $a_{i}(x, h)=0$ for $i \neq 1$. It follows that

$$
\begin{align*}
g_{1}(x) & =x a_{1}(x, h) v_{1}=\left(x_{e} e+x_{f} f\right) a_{1}(x, h) v_{1}  \tag{3.5}\\
& =a_{1}(x, h)\left(2 x_{e} v_{0}+x_{f} v_{2}\right) .
\end{align*}
$$

By Equations (3.5) and (3.4), we get

$$
a_{0}(x, e)\left(2 x_{h} v_{0}+x_{f} v_{1}\right)=a_{1}(x, h)\left(2 x_{e} v_{0}+x_{f} v_{2}\right)
$$

If $x_{f} \neq 0$, then $a_{1}(x, h)=0$ and $a_{0}(x, e)=0$, which means $g_{1}(x)=0$. Then by Steps (1) and (3), it is sufficient to assume $x_{f}=0, x_{e} x_{h} \neq 0$ in the following. Considering Equations (3.5) and (3.3), we get

$$
a_{2}(x, f)\left(2 x_{e} v_{1}-2 x_{h} v_{2}\right)=a_{1}(x, h)\left(2 x_{e} v_{0}+x_{f} v_{2}\right)
$$

which means $a_{1}(x, h)=a_{2}(x, f)=0$. Then by Equation (3.5), we get $g_{1}(x)=0$.
In summary, $g_{1}(x)=0$ for any $x \in \mathfrak{s l}(2)$, that is $g_{1}=0$.
Step 5 By Steps 1 and 4 , we get $g=D_{h, e}$.

### 3.2. Biderivations

As we are known, $V(2)$ is isomorphic to the adjoint module of $\mathfrak{s l}(2)$ by setting $v_{0}=e$. Then for $\lambda \in \mathbb{C}$, it is easy to verify that the map

$$
f: \mathfrak{s l}(2) \times \mathfrak{s l}(2) \longrightarrow V(2), \quad(x, y) \longmapsto \lambda[x, y]
$$

is a biderivation of $\mathfrak{s l}(2)$ on $V(2)$, which is said to be inner. Write $\operatorname{Ibder}(\mathfrak{s l}(2))$ for all inner biderivations from $\mathfrak{s l}(2)$ to $V(2)$.
Proof of Theorem 1.2 Let $g \in \operatorname{Bder}(\mathfrak{s l}(2), V(0))$. Note that $V(0)$ is a trivial $\mathfrak{s l}(2)$ module, then by Definition 2.2, we have

$$
g([x, y], z)=g(x,[y, z])=0 \quad \forall x, y, z \in \mathfrak{s l}(2) .
$$

Since $[\mathfrak{s l}(2), \mathfrak{s l}(2)]=\mathfrak{s l}(2)$, so $g=0$.
In the following, we assume that $n \neq 0$. Let $g \in \operatorname{Bder}(\mathfrak{s l}(2), V(n))$. Define $g_{1}, g_{2} \in$ $\operatorname{Blin}(\mathfrak{s l}(2), V(n))$ by

$$
g_{1}(x, y)=(g(x, y)+g(y, x)) / 2, \quad g_{2}(x, y)=(g(x, y)-g(y, x)) / 2
$$

where $x, y \in L$. Then every $g_{i}$ is a biderivation and

$$
g=g_{1}+g_{2}, \quad g_{1}(x, y)=g_{1}(y, x), \quad g_{2}(x, y)=-g_{2}(y, x)
$$

where $x, y \in L$. Schur's Lemma tells us that every $\mathfrak{s l}(2)$-module homomorphism from $\mathfrak{s l}(2)$ to $V(n)$ must be of the form $\delta_{n, 2} \lambda \operatorname{id}_{\mathfrak{s l}(2)}$, where $\lambda \in \mathbb{C}$ and $\operatorname{id}_{\mathfrak{s l}(2)}$ is the identity map on $\mathfrak{s l}(2)$. Hereafter the symbol $\delta_{i, j}$ means 1 if $i=j$, and 0 otherwise. Then by [5, Theorem 2.3], we have that $g_{2}(x, y)=\delta_{n, 2} \lambda[x, y]$ for $\lambda \in \mathbb{C}$ and $x, y \in L$.

Below it is sufficient to show $g_{1}=0$. By Lemmas 2.4 and 2.6, we may assume $g_{1}=$ $g_{10}+g_{11}+\cdots+g_{1 n}$, where $g_{1 i} \in \operatorname{Bder}(\mathfrak{s l}(2), V(n))_{n-2 i}$ for $i=0,1, \ldots, n$. By Lemma 2.5 there exist two maps $\varphi_{i}, \psi_{i} \in \operatorname{Hom}(\mathfrak{s l}(2), V(n))_{n-2 i}$, such that

$$
x \psi_{i}(y)=g_{1 i}(y, x)=g_{1 i}(x, y)=x \varphi_{i}(y), \quad \forall x, y \in \mathfrak{s l l}(2) .
$$

It follows that $\psi_{i}=\varphi_{i}$, and

$$
\begin{gather*}
\varphi_{i}(h) \in V(n)_{n-2 i}, \quad \varphi_{i}(e) \in V(n)_{n-2(i-1)}, \quad \varphi_{i}(f) \in V(n)_{n-2(i+1)} \\
g_{1 i}(x, y)=x \varphi_{i}(y)=y \varphi_{i}(x), \quad \forall x, y \in \mathfrak{s l}(2) \tag{3.6}
\end{gather*}
$$

Then we assume that

$$
\varphi_{i}(h)=a_{h i} v_{i}, \quad \varphi_{i}(e)=a_{e i} v_{i-1}, \quad \varphi_{i}(f)=a_{f i} v_{i+1}
$$

where $a_{*}, \in \mathbb{C}$. Then by Equation (3.6), we get

$$
h \varphi_{i}(e)=e \varphi_{i}(h), \quad h \varphi_{i}(f)=f \varphi_{i}(h), \quad e \varphi_{i}(f)=f \varphi_{i}(e)
$$

that is,

$$
\begin{gathered}
(n-2 i+2) a_{e i} v_{i-1}=i(n+1-i) a_{h i} v_{i-1}, \\
(n-2 i-2) a_{f i} v_{i+1}=a_{h i} v_{i+1} \\
(i+1)(n-i) a_{f i} v_{i}=\left(1-\delta_{i, 0}\right) a_{e i} v_{i} .
\end{gathered}
$$

It follows that

$$
\begin{align*}
\left(1-\delta_{i, n}\right) a_{h i} & =\left(1-\delta_{i, n}\right)(n-2 i-2) a_{f i},  \tag{3.7}\\
\left(1-\delta_{i, 0}\right)(n-2 i+2) a_{e i} & =\left(1-\delta_{i, 0}\right) i(n+1-i) a_{h i},  \tag{3.8}\\
\left(1-\delta_{i, 0}\right) a_{e i} & =(i+1)(n-i) a_{f i} . \tag{3.9}
\end{align*}
$$

In the following, we shall determine $\varphi_{i}$ and $\psi_{i}$ for $0 \leq i \leq n$ by steps.
(a) If $i=0$, then

$$
a_{f i} \stackrel{3.9}{=} 0, \quad a_{h i} \stackrel{3.7}{=}(n-2) a_{f i}
$$

It follows that $g_{10}=0$.
(b) If $i=n$, then

$$
a_{e i} \stackrel{(3.9}{=} 0, \quad(2-n) a_{e i} \stackrel{\sqrt[3.8]{=}}{=} n a_{h i}
$$

It follows that $g_{1 n}=0$.
(c) If $i \neq 0$ and $i \neq n$, then by Equations (3.7)-(3.9), we have

$$
(i+1)(n-i)(n-2 i+2) a_{f i}=i(n+1-i)(n-2 i-2) a_{f i}
$$

which implies $a_{f i}=0$. It follows that $a_{e i} \stackrel{(3.9}{=} 0 \stackrel{\sqrt[3.7]{=}}{=} a_{h i}$. Hence $g_{1 i}=0$.
From (a)-(c), it follows that $g_{1}=0$.
