# ESTIMATES OF BUBBLING SOLUTIONS OF $S U(3)$ TODA SYSTEMS AT CRITICAL PARAMETERS-PART 2

#### Abstract

In this article we study bubbling solutions of regular $S U(3)$ Toda systems defined on a Riemann surface. There are two major difficulties corresponding to the profile of bubbling solutions: partial blowup phenomenon and bubble accumulation. We prove that when both parameters tend to critical positions, if there is one fully bubbling blowup point, then under one curvature assumption, all the blowup solutions near a blowup point satisfy a spherical Harnack inequality, which completely rules out the bubble-accumulation phenomenon. This fact is crucial for a number of applications.


## 1. Introduction

In this article we consider the following $S U(3)$ Toda system defined on a compact Riemann surface $(M, g)$ :

& \Delta_{g} u_{2}-\rho_{1}\left(\frac{h_{1} e^{u_{1}}}{\int_{M} h_{1} e^{u_{1}} d V_{g}}-1\right)+2 \rho_{2}\left(\frac{h_{2} e^{u_{2}}}{\int_{M} h_{2} e^{u_{2}} d V_{g}}-1\right)=0
\end{align*}

where the volume of $M$ is assumed to be 1 for convenience. $h_{1}, h_{2}$ are positive smooth functions, $\rho_{1}, \rho_{2}$ are positive constants.

The standard space for $u=\left(u_{1}, u_{2}\right)$ is that each component is in

and system (1.1) is the Euler Lagrange equation of the following variational form:

where $a^{11}=a^{22}=\frac{2}{3}, a^{12}=a^{21}=\frac{1}{3}$. It is proved by Lin-Wei-Yang-Zhang in [21] that a priori estimate holds if $\left(\rho_{1}, \rho_{2}\right) \in(4 \pi(m-1), 4 \pi m) \times(4 \pi(n-1), 4 \pi n)$ for $m, n \in \mathbb{N}$ (the set of natural numbers). Thus a degree-counting program can be defined by this a priori estimate. Since this degree counting program links the local blowup analysis with the topology of $M$, it reveals important interplay of different fields of mathematics.

[^0]Even though the a priori estimate requires $\rho=\left(\rho_{1}, \rho_{2}\right)$ to be away from multiples of $4 \pi$, it is also important to study blowup solutions when both parameters tend to multiples of $4 \pi$. For comparison if the Toda system is reduced to one equation, which is the Liouville equation, the critical parameter for Liouville equation is when the parameter $\rho$ is a multiple of $8 \pi$. The case $\rho=8 \pi$ is studied by LinWang [22] that reveals significant ties among elliptic functions, blowup solutions and the number of critical points of the Green's function on a torus. The study of Toda system with critical parameters should also lead to possibly surprising connections between fields. In fact (1.1) is the simplest Toda system that connects many fields of mathematics and physics. Since the literature is too vast to be listed, we just mention the following works closely related to the topic in this article $[1,2,3,7,8,9,10,11,12,16,17,18,19,21,23,24,26,27]$. As a matter of fact, the research of Toda system has been so dynamical that many breakthroughs come from inspirations of different fields and exciting ties among seemingly far-reached fields have been greatly strengthened by new discoveries.

A sequence of solutions $u^{k}=\left(u_{1}^{k}, u_{2}^{k}\right)$ is called bubbling solutions, or blowup solutions, if $\max _{M}\left\{u_{1}^{k}\left(p_{k}\right), u_{2}^{k}\left(p_{k}\right)\right\} \rightarrow \infty$ for $p_{k} \rightarrow p \in M$. If $u^{k}$ converges to a global $S U(3)$ Toda system after scaling according to the maximum of both components, $u^{k}$ is called a fully bubbling sequence. Otherwise $u^{k}$ is called to have a partial blowup phenomenon. In other words, fully bubbling solutions converge to an entire Toda system, while partially blown-up solutions tend to only one equation after scaling. In blowup analysis there are two major difficulties, the first one is the partial blowup phenomenon, the second one is the bubble-accumulation situation: disjoint bubbling disks may tend to the same point, which makes the study of the profile of bubbling solutions particularly challenging.

The main purpose of this article is to remove the bubble accumulation phenomenon and thus greatly simplifies the profile of bubbling solutions. The following is a curvature assumption we make on the coefficient function $h_{i}^{k}$ : For each $x \in M$,

where $\mathbb{Z}$ stands for the set of integers, $K(x)$ is the Gauss curvature at $x$. Then our main theorem is

Theorem 1.1. Let $u^{k}$ be a sequence of blowup solutions to (1.1) with parameters $\rho^{k} \rightarrow(4 \pi m, 4 \pi n)$ for some positive integers $m$ and $n$. If there exists a fully bubbling blowup point and (1.2) holds, around each blowup point $p_{l}$ we have

\end{equation*}

where $p_{l}^{k} \rightarrow p_{l}$ is a local maximum of one component of $u^{k}$.
The inequality (1.3) implies that around $p_{l}^{k}$, the spherical Harnack inequality holds for both components, thus Theorem 1.1 completely rules out the bubbleaccumulation phenomenon and provides a key estimate for construction of bubbling solutions as well the degree-counting program mentioned before. It is also important to point out that Theorem 1.1 does not rule out partial blowup phenomenon. The construction of a $(4,2)$ type blowup by Musso-Pistoia-Wei [29], which
contains a partial blowup situation, does satisfy the spherical Harnack inequality around a blowup point. It is an interesting open question whether (1.2) also leads to the elimination of partial blowup phenomenon. Here we also point out that having a simple blowup situation leads to key information about curvature as well. For example, in [24], [23] and [47], only fully bubbling solutions are assumed for Toda systems, the authors proved surprising vanishing estimates on coefficient functions, which serve as guidelines of bubble construction, degree counting and other applications.
Remark 1.1. The assumption $\rho^{k}=\left(\rho_{1}^{k}, \rho_{2}^{k}\right) \rightarrow(4 m \pi, 4 n \pi)$ is more general than the assumption in [43] where $\rho_{k} \rightarrow(4 \pi, 4 m \pi)$ or $\rho^{k} \rightarrow(4 m \pi, 4 \pi)$ was assumed.

Since the proof of the main theorem is quite involved, we describe an outline of the proof at the end of the introduction. The statement of Theorem 1.1 is equivalent to saying that the spherical Harnack inequality holds around a local maximum of a component. As is well known, if the spherical Harnack inequality does not hold, one would obtain bubbling disks mutually disjoint from one another. Inside each bubbling disk, the profile of the blowup solutions is either that of a global solution of the $S U(3)$ Toda system, or that of a global solution of a single Liouville equation. To eliminate the bubble accumulation we employ the ideas in a series of paper of Wei-Zhang [38], [39] and [40]. One major difficulty is to rule out the case that one bubbling disk of $u_{1}^{k}$ is placed between two bubbling disks of $u_{2}^{k}$. This part is placed in section three in three stages: In stage one: After removing $u_{1}^{k}$ from the equation of $u_{2}^{k}$, the equation of $u_{2}^{k}$ is similar to a singular Liouville equation with a quantized singular source. $u_{2}^{k}$ has two local maximum points and there is a Pohozaev identity corresponding to each local maximum. After working on these two Pohozaev identities we shall see that the first derivatives of the coefficient functions are involved with the location of blowup points. Next we compare the two pohozaev identities with those of a global solution. The comparison of Pohozaev identities will lead to an initial vanishing rate of certain coefficient functions. Then in stage two we improve the pointwise estimate as well as the vanishing rate of the first derivative of the coefficient functions. The key point of the proof of stage two is that the blowup solutions look like different global solutions around each local maximum, which is the main reason of the contradiction. The in stage three, we employ the argument of stage two and the vanishing rate of the first derivatives of the coefficient functions to obtain a better global pointwise estimate. In this case the precise pointwise estimate of the single Liouville equation plays a crucial role. These three stages rule out the case $(2,4)$ as well as $(4,2)$ under the curvature condition stated in Theorem 1.1 The other cases of blowup solutions violating the spherical harnack inequalities are relatively easier and they are handled in section four. There are quite a few key estimates in the proof and they are explained in details as the proof is carried out.

## 2. A locally defined system

In this section we write the $S U(3)$ Toda system as a set of locally defined equations near a fixed point. For any fixed point we use isothermal coordinates: Let $g_{0}$
be the flat metric and $\phi$ satisfy $g_{0}=e^{-\phi} g$. Then $\Delta_{g}=e^{-\phi} \Delta$ and $\phi$ satisfies

Let $\hat{u}_{i}=u_{i}-\log \int_{M} h_{i} e^{u_{i}}, \quad i=1,2$. Then we have $\int_{M} h_{i} e^{\hat{u}_{i}}=1$. Then for $\hat{u}=$ $\left(\hat{u}_{1}, \hat{u}_{2}\right)$ we have

\Delta \hat{u}_{2}-\rho_{1} h_{1} e^{\hat{u}_{1}+\phi}+2 \rho_{2} h_{2} e^{\hat{u}_{2}+\phi}=\left(2 \rho_{2}-\rho_{1}\right) e^{\phi}
\end{gathered}

Let $B_{\tau}$ be a ball of radius $\tau$ centered at the origin. For $\tau>0$ small we set $f_{1}$ and $f_{2}$ as

Then by setting

in a neighborhood of 0 , say $B_{\tau}$ we have

## 3. BLOWUP ANALYSIS FOR A LOCAL SYSTEM

In this long section we derive a vanishing estimate for a locally defined Toda system. Let $B_{1}$ be the unit ball in $\mathbb{R}^{2}$ and we consider the following locally defined system:

and postulate usual assumptions:

Boundary oscillation finite-ness:

and there is a uniform bound on the total integration:

Let $\phi_{i}^{k}$ be the harmonic function defined by the oscillation of $\mathfrak{u}_{i}$ on $\partial B_{1}$ :

\Delta \phi_{i}^{k}(x)=0, \quad \text { in } B_{1}, \quad \phi_{i}^{k}(x)=\mathfrak{u}_{i}^{k}(x)-\frac{1}{2 \pi} \int_{\partial B_{1}} \mathfrak{u}_{i}^{k} d S, \quad x \in \partial B_{1} .

The following quantity is used to describe the concentration of the integrals of $e^{u_{i}^{k}}$ : Let

Note that in this article we don't distinguish sequence and a sub-sequence. Then it is well known (see [43], for example) that

The main result of this section is:
Theorem 3.1. Let $\mathfrak{u}^{k}=\left(\mathfrak{u}_{1}^{k}, \mathfrak{u}_{2}^{k}\right)$ be solutions of (3.1) such that (3.2), (3.3), (3.4) and (3.5) hold for $\mathfrak{h}_{i}$ and $\mathfrak{u}^{k}$. Suppose $\mathfrak{u}^{k}$ is a $(2,4)$ type blowup sequence that violates the spherical Harnack inequality around the local maximum of $\mathfrak{u}_{1}^{k}$, and

\max _{B_{1}} \mathfrak{u}_{1}^{k}>\max _{B_{1}} \mathfrak{u}_{2}^{k}+5 \log \delta_{k}^{-1} \tag{3.6}
\end{equation*}
$$

where $\delta_{k}$ is the distance between one local maximum of $\mathfrak{u}_{2}^{k}$ and one local maximum of $u_{1}^{k}$. Then we have

\nabla \log h_{2}^{k}(0)+\nabla \phi_{2}^{k}(0)=o(1),

and

Remark 3.1. There are two formations of the blowup type $(2,4)$. The one that violates the spherical Harnack inquality has one bubbling disk of $\mathfrak{u}_{1}^{k}$ in the middle of two bubbling disks of $\mathfrak{u}_{2}^{k}$ on both sides. The second formation consists of a bubbling disk of $\mathfrak{u}_{1}^{k}$ on top of $\mathfrak{u}_{2}^{k}$. In the second case, if $\mathfrak{u}_{2}^{k}$ is scaled according to its maximum, the limit function is

\Delta v+2 e^{v}=4 \pi \delta_{0}, \quad \text { in } \quad \mathbb{R}^{2}, \quad \int_{\mathbb{R}^{2}} e^{v}<\infty .
$$

What Theorem 3.1 covers is the first case.

## Proof of Theorem 3.1;

Let $p_{0}^{k}$ be the location of the local maximum of $\mathfrak{u}_{1}^{k}, p_{1}^{k}$ and $p_{2}^{k}$ be the locations of local maximums if $\mathfrak{u}_{2}^{k}$. In the $(2,4)$ formation, it is known that [43]

\lim _{k \rightarrow \infty} \frac{\left|p_{1}^{k}-p_{0}^{k}\right|}{\left|p_{1}^{k}-p_{2}^{k}\right|}=\frac{1}{2}, \quad \lim _{k \rightarrow \infty} \frac{p_{1}^{k}-p_{0}^{k}}{\left|p_{1}^{k}-p_{0}^{k}\right|}=\lim _{k \rightarrow \infty} \frac{p_{1}^{k}-p_{2}^{k}}{\left|p_{1}^{k}-p_{2}^{k}\right|}
$$

Suppose $\delta_{k}=\left|p_{1}^{k}-p_{0}^{k}\right|$ and we write $p_{1}^{k}=p_{0}^{k}+\delta_{k} e^{i \theta_{k}}$. Then we set

Now the system can be written as

\Delta \tilde{v}_{2}^{k}(y)-h_{1}^{k}\left(p_{0}^{k}+\delta_{k} y\right) e^{\tilde{v}_{1}^{k}}+2 h_{2}^{k}\left(p_{0}^{k}+\delta_{k} y\right) e^{\tilde{v}_{2}^{k}}=0, \quad \text { in } \quad \Omega_{k}
$$

where $\Omega_{k}=B\left(0, \tau \delta_{k}^{-1}\right)$ for some $\tau>0$ and $G_{k}$ be the Green's function on $\Omega_{k}$ with respect to the Dirichlet boundary condition:

Then we remove $\tilde{v}_{1}^{k}$ from the equation of $\tilde{v}_{2}^{k}$. Let

we have

and let

and

\mathfrak{h}_{i}^{k}\left(\delta_{k} y\right):=h_{i}^{k}\left(p_{0}^{k}+\delta_{k} y\right), \quad i=1,2
$$

Since we will use complex numbers to represent points on $\mathbb{R}$, we use $e_{1}$ to denote $(1,0)$ and $e^{i \pi}$ to denote $(-1,0)$. For $y$ around $e_{1}$ or $e^{i \pi}$, since the singularity of $\tilde{v}_{1}^{k}$ is at the origin, standard estimate can be used to obtain

f_{1}^{k}(y)=2 \log |y|+O\left(\mu_{1}^{k} e^{-\mu_{1}^{k}}\right)+O\left(\delta_{k}^{2}\right), \quad y \in B\left(e_{1}, \tau\right) \cup B\left(e^{i \pi}, \tau\right)
$$

for some $\tau>0$ small, where we use $\mu_{1}^{k}$ and $\mu_{2}^{k}$ to denote the heights of the bubbles:

In this section we use $E_{1}$ to denote

E_{1}=O\left(\mu_{1}^{k} e^{-\mu_{1}^{k}}\right)+O\left(\delta_{k}^{2}\right)
$$

Then the equation of $v_{2}^{k}$ now becomes

It is important to observe that after scaling, the local maximum of $v_{1}^{k}$ is the origin and one local maximum of $v_{2}^{k}$ is $e_{1}$, the other local maximum of $v_{2}^{k}$ is $e^{i \pi}+o(1)$. We use $Q_{0}^{k}$ to denote $e_{1}$ and $Q_{1}^{k}$ to denote the other local maximum of $v_{2}^{k}$. (add a footnote)

By the pointwise analysis of single Liouville equation, $v_{2}^{k}$ is around $-\mu_{2}^{k}$ away from bubbling disks in $B_{10}, v_{1}^{k}(y)=-\mu_{1}^{k}+O(1)$ in the same area.

Now we provide a rough estimate for $v_{i}^{k}$ outside the bubbling area:
For $r>2$, let $\bar{v}_{2}^{k}(r)$ be the spherical average of $v_{2}^{k}$ on $\partial B_{r}$, then we have

\frac{d}{d r} \bar{v}_{2}^{k}(r)=\frac{d}{d r}\left(\frac{1}{2 \pi r} \int_{B_{r}} \Delta v_{2}^{k}\right)=-\frac{12 \pi+o(1)}{2 \pi r}
$$

Because of the fast decay of $\bar{v}_{2}^{k}(r)$ it is easy to use the Green's representation of $v_{2}^{k}$ to obtain the following stronger estimates:

& v_{1}^{k}(y)=-\mu_{1}^{k}+o(1) \log |y|+O(1), \quad 2<|y|<\tau \delta_{k}^{-1} \tag{3.10}
\end{align*}

3.1. An initial vanishing estimate of the first derivatives. Now we consider $v_{2}^{k}$ around $Q_{l}^{k}$. Using the results in [5, 45, 15] we have, for $v_{2}^{k}$ in $B\left(Q_{l}^{k}, \varepsilon\right)$, the following gradient estimate:

Before we get into the details we would like to mention that the most important observation is that the difference between the Pohozaev identities of $v_{2}^{k}$ and that of a global solution can be evaluated in detail. Using the result in the previous section we shall see that the coefficient of $\nabla \mathfrak{h}_{2}^{k}(0)$ is not zero.

First we recall the equation for $v_{2}^{k}$ :

Here we note that among 2 local maximum points, we already have $e_{1}$ as a common local maximum point for both $v_{2}^{k}$ and $V_{k}$ and we shall prove that $w_{k}$ is very small
in $B_{3}$ if we exclude $B\left(Q_{1}, \tau\right)$. Before we carry out more specific computations we emphasize the importance of

To evaluate the right hand side, first we observe that the integration away from the two bubbling disks is $O\left(e^{-\mu_{2}^{k}} \delta_{k}\right)$ based on the asymptotic behavior of $V_{k}$. So we focus on the integration over $B\left(Q_{l}^{k}, \varepsilon\right)$ for $l=0,1$.

If $l=0, Q_{0}^{k}=e_{1}$ by definition, we show that the integration over $B\left(e_{1}, \varepsilon\right)$ is an insignificant error.

For $l=1$, recall that the local maximum points of $V_{k}$ are at 1 and $e^{i \pi}$. By standard estimates for single Liouville equations, we have

= & 4 \log \frac{\left|e_{1}-Q_{l}^{k}\right|}{\left|y-Q_{l}^{k}\right|}-4 \log \frac{\left|e_{1}-e^{i \pi}\right|}{\left|y-e^{i \pi}\right|}+O\left(\mu_{2}^{k} e^{-\mu_{2}^{k}}\right) \\
= & 4 \log \frac{\left|1-Q_{l}^{k}\right|}{2}-4 \log \frac{\left|y-Q_{l}^{k}\right|}{|y+1|}+O\left(\mu_{2}^{k} e^{-\mu_{2}^{k}}\right) . \tag{3.34}
\end{align*}
$$

Finally for $B\left(e_{1}, \tau\right)$ we claim to have

and for $y \in B_{3}$ away from bubbling disks,

The proof of 3.36 follows easily from the same sample computation in the derivation of (3.21). To prove 3.35) we first remark that by scaling around $e_{1}$ and using the expansion of bubbles for single Liouville equation, we have

Now we consider the Pohozaev identity around $Q_{1}^{k}$. Let $\Omega_{1, k}=B\left(Q_{1}^{k}, \tau\right)$ for small $\tau>0$. For $v_{2}^{k}$ we have

where $\xi$ is an arbitrary unit vector. Correspondingly the Pohozaev identity for $V_{k}$ is

The second term on the left hand side of (3.38) or $\sqrt{3.39)}$ is $O\left(e^{-\mu_{2}^{k}}\right)$, so both terms are considered as errors. Now we first focus on (3.38). After using the expansion for single equation as in the evaluation of (3.16), the first term on the left hand side of (3.38) is:

\end{aligned}

Here we recall that $E=O\left(\delta_{k}^{2}\right)+O\left(\mu_{2}^{k} e^{-\mu_{2}^{k}}\right)$. In a similar fashion, the first term of the left hand side of (3.39) is

Now we evaluate $\nabla w_{k}$ on $\partial B\left(Q_{1}^{k}, r\right)$ for $r>0$ fixed. For simplicity we omit $k$ in $m_{1}^{k}$ and $Q_{1}^{k}$. For $y=-e_{1}+r e^{i \theta}$ we obtain from (3.37) that

& =4 \frac{\bar{m}_{1}}{\left(\bar{y}+e_{1}\right)^{2}}+E
\end{aligned}

Then for $y=-e_{1}+r e^{i \theta}$, we have

3.4. Improved vanishing rate of the first derivatives. Our next goal is to prove the following vanishing rate for $\nabla \mathfrak{h}_{2}^{k}(0)$ :

One major step in the proof of the main theorem is the following estimate:

## Proof of Proposition 3.1:

Obviously we can assume that $\left|\nabla \mathfrak{h}_{2}^{k}(0)\right| \delta_{k}>2 \delta_{k}^{2} \mu_{2}^{k}$ because otherwise there is nothing to prove. Now we recall the equation for $v_{2}^{k}$ is 3.9), which can be written as

$v_{2}^{k}$ is a constant on $\partial B\left(0, \tau \delta_{k}^{-1}\right)$. Moreover $v_{2}^{k}\left(e_{1}\right)=\mu_{2}^{k}$. Recall that $V_{k}$ defined in (3.29) satisfies

Let $\Omega_{k}=B\left(0, \tau \delta_{k}^{-1}\right)$, we shall derive a precise, point-wise estimate of $w_{k}$ in $B_{3} \backslash B\left(Q_{1}^{k}, \tau\right)$ where $\tau>0$ is a small number independent of $k$. Here we note that among the two local maximum points, we already have $e_{1}$ as a common local maximum point for both $v_{2}^{k}$ and $V_{k}$ and we shall prove that $w_{k}$ is very small in $B_{3}$ if we exclude all bubbling disks except the one around $e_{1}$.

Now we write the equation of $w_{k}$ as

Note that the oscillation of $w_{k}$ on $\partial \Omega_{k}$ is $O\left(\delta_{k}^{2}\right)$, which all comes from the oscillation of $V_{k}$. It is a trivial and important fact that $E_{2}$ is small round $e_{1}$ but greater around $Q_{1}$. This is the reason that our analysis will first be carried out around $e_{1}$ and pass to $Q_{1}$ later.

Let $M_{k}=\max _{x \in \bar{\Omega}_{k}}\left|w_{k}(x)\right|$. We shall get a contradiction by assuming $M_{k} / \tilde{\delta}_{k} \rightarrow$ $\infty$. This assumption implies

where we used $\mu_{1}^{k} e^{-\mu_{1}^{k}} / M_{k}=o\left(\delta_{k}^{2}\left(\mu_{2}^{k}\right)^{-1}\right.$.
Also on the boundary, since $M_{k} / \tilde{\delta}_{k} \rightarrow \infty$, we have

By (3.53)

\end{equation*}

Since $V_{k}$ is not exactly symmetric around $e_{1}$, we shall replace the re-scaled version of $V_{k}$ around $e_{1}$ by a radial function. Let $U_{k}$ be solutions of

for a small $\varepsilon>0$ independent of $k$. Since we shall use the re-scaled version, based on (3.65) we have

Here we note that the estimate in (3.65) is not optimal. In the following we shall put the proof of Proposition 3.1 into a few estimates. In the first estimate we prove

Lemma 3.2. For $\delta>0$ small and independent of $k$,

If (3.67) is not true, we have, without loss of generality that $\tilde{w}_{k} \rightarrow c>0$. This is based on the fact that $\tilde{w}_{k}$ tends to a global harmonic function with removable singularity. So $\tilde{w}_{k}$ tends to constant. Here we assume $c>0$ but the argument for $c<0$ is the same. Let

where $\tilde{E}_{0}^{k}(r)$ has the same upper bound as that of $E_{2}^{k}(r)$ :

Clearly this is a contradiction to (3.70). We have proved $c=0$, which means $\tilde{w}_{k}=o(1)$ in $B\left(e_{1}, \delta_{0}\right) \backslash B\left(e_{1}, \delta_{0} / 8\right)$. Then it is easy to use the equation for $\tilde{w}_{k}$ and standard Harnack inequality to prove $\nabla \tilde{w}_{k}=o(1)$ in the same region. Lemma 3.2 is established.

The second estimate is a more precise description of $\tilde{w}_{k}$ around $e_{1}$ :
Lemma 3.3. For any given $\sigma \in(0,1)$ there exists $C>0$ such that

Remark 3.2. The reason that we have $\sigma \in(0,1)$ is because we currently don't have a very good estimate of $\tilde{w}_{k}$ outside the bubbling area, except knowing it is $o(1)$. Once a better estimate of $\tilde{w}_{k}$ outside the bubbling disks is known, (3.71) can be improved.

Proof of Lemma 3.3; Let $W_{k}$ be defined as in (3.68). In order to obtain a better estimate we need to write the equation of $W_{k}$ more precisely than (3.69):

Here we observe that by Lemma 3.2 $W_{k}=o(1)$ on $\partial \Omega_{W k}$. Let

Then we can obtain a contradiction to $\left|g_{k}\left(z_{k}\right)\right|=1$ as follows: If $\lim _{k \rightarrow \infty} z_{k}=P \in$ $\mathbb{R}^{2}$, this is not possible because that fact that $g_{k}(0)=\left|\nabla g_{k}(0)\right|=0$ and the sublinear growth of $g_{k}$ in (3.73) implies that $g_{k} \rightarrow 0$ over any compact subset of $\mathbb{R}^{2}$ (see [5, 45]). So we have $\left|z_{k}\right| \rightarrow \infty$. But this would lead to a contradiction again by using the Green's representation of $g_{k}$ :

where $G_{k}(y, \eta)$ is the Green's function on $\Omega_{W k}$ and $o(1)$ in the equation above comes from the smallness of $W_{k}$ on $\partial \Omega_{W k}$. Let $L_{k}=\tau \varepsilon_{k}^{-1}$, the expression of $G_{k}$ is

Using this expression in (3.74) we obtain from elementary computation that the right hand side of 3.74 is $o(1)$, a contradiction to $\left|g_{k}\left(z_{k}\right)\right|=1$. Lemma 3.3 is established.

The smallness of $\tilde{w}_{k}$ around $e_{1}$ can be used to obtain the following third key estimate:

where $U(z)$ is a solution of

Here we recall that $\lim _{k \rightarrow \infty} \mathfrak{h}_{2}^{k}\left(\delta_{k} e_{1}\right)=1$. Since $W_{k}$ converges to a solution of the linearized equation:

Step two $c_{1}=c_{2}=0$. We first observe that Lemma 3.4 follows from this. Indeed, once we have proved $c_{1}=c_{2}=c_{0}=0$ around 1 and -1 , it is easy to use maximum
principle to prove $\tilde{w}_{k}=o(1)$ in $B_{3}$ using $\tilde{w}_{k}=o(1)$ on $\partial B_{3}$ and the Green's representation of $\tilde{w}_{k}$. The smallness of $\tilde{w}_{k}$ immediately implies $\tilde{w}_{k}=o(1)$ in $B_{R}$ for any fixed $R \gg 1$. Outside $B_{R}$, a crude estimate of $v_{k}$ is

A contradiction to $\max \left|\tilde{w}_{k}\right|=1$.

There are 2 local maximums with one of them being $e_{1}$. Correspondingly there are 2 global solutions $V_{k}$ and $\bar{V}_{k}$ that approximate $v_{2}^{k}$ accurately near $Q_{0}^{k}=e_{1}$ and $Q_{1}^{k}$, respectively. For $\bar{V}_{k}$ the expression is

\end{equation*}

The equation that $\bar{V}_{k}$ satisfies is

In order to employ the same strategy of proof, one needs to have two things: first $\varepsilon_{k}^{-1} \delta_{k}^{2}=O\left(\varepsilon_{k}^{\varepsilon}\right)$. This is clear from the definition of $\delta_{k}$. Second, in the proof of Lemma 3.4 and in 6.1) we need

where $M_{k}>\delta_{k}^{2}\left(\mu_{2}^{k}\right)^{7 / 4}$. Since $\delta_{k} \leq C \mu_{2}^{k} \varepsilon_{k}$, the required inequality holds. The proof of Proposition 3.1 follows.

The precise upper bound of $w_{k}$ in 3.107) leads to the vanishing rate of the Laplacian estimate : If we use

$R_{2}$ is the collection of spherical harmonic functions of degree 2 . Note that there is no appearance of $\varepsilon_{k}$ or $\varepsilon_{k}^{2}$ in the equation for $W_{k}$. This is a key point in the proof. Around $e_{1}$, the terms are small, while around -1 , the terms are far greater. This discrepancy leads to contradiction.

Let $g_{k}(r)$ be the projection of $W_{k}$ on 1 , by the same ODE analysis as before, we see that $g_{k}$ satisfies

If $\delta_{k}^{2} \varepsilon_{k}^{-1} \geq C$, the argument in the proof of (3.50) cannot be used because either $\xi_{k}$ does not tend $U$ or $c_{0}=0$ cannot be proved.
Proof of the Laplace Vanishing property for $\delta_{k} \geq \mu_{2}^{k} \varepsilon_{k}$.
In this case we write the equation of $w_{k}$ as

Note that $v_{k}$ is close to another global solution $\bar{V}_{k}$ which matches with a local maximum of $v_{k}$ at $Q_{2}^{k}$. Evaluating the right hand side of (3.109) we have

By $\left|Q_{2}^{k}-e^{i \pi}\right|=O\left(\delta_{k}^{2}\right)$ we see that $w_{k}(y)=O\left(\delta_{k}^{2}\right)$ on $\left|y-e^{i \pi}\right|=\tau$.
The standard point-wise estimate for singular equation ( see [45, 15] ) gives

& V_{k}\left(e^{i \pi}+\varepsilon_{k} z\right)+2 \log \varepsilon_{k}
\end{aligned}

=\log \frac{e^{\mu_{2}^{k}}}{\left(1+\frac{e^{\mu_{2}^{k}}}{8 \mathfrak{h}_{2}^{k}\left(\delta_{k} e_{1}\right)}|z|^{2}\right)^{2}}+\phi_{2}^{k}+O\left(\varepsilon_{k}^{2}\left(\log \varepsilon_{k}\right)^{2}\right), \quad|z| \sim \varepsilon_{k}^{-1}
$$

Thus

for $|z| \sim \varepsilon_{k}^{-1}$. Taking the average around the origin, the spherical averages of the two harmonic functions are zero and $O\left(\delta_{k}^{2}\right)$ respectively, since they take zero at the origin and a point at most $O\left(\delta_{k}^{2}\right)$ from the origin. So the spherical average of $w_{k}$ is comparable to

Obviously the proof of Theorem 3.1 can be used to rule out $(4,2)$ and $(2,4)$ if the spherical Harnack inequality is violated.

## 4. Proof of Theorem 1.1

Let $u^{k}$ be a sequence of blowup solutions and let $p$ be a blowup point. In a local coordinate, if around $p$ there is a $(2,4)$ type blowup profile with a violation of the spherical Harnack inequality around the local maximum of $u_{1}^{k}$, then we see from the derivation of (2.3) that $u^{k}=\left(u_{1}^{k}, u_{2}^{k}\right)$ can be written as a locally defined blowup solutions: $\mathfrak{u}^{k}=\left(\mathfrak{u}_{1}^{k}, \mathfrak{u}_{2}^{k}\right)$ of

& \Delta \mathfrak{u}_{2}^{k}-\mathfrak{h}_{1}^{k} e^{u_{1}^{k}}+2 \mathfrak{h}_{2}^{k} e^{u_{2}^{k}}=0,

where

where $\phi_{i}$ and $f_{i}$ are defined in (2.1) and (2.2), respectively. Since in this case we have $\lim _{k \rightarrow \infty} \Delta\left(\log \mathfrak{h}_{2}^{k}\right)(0)=0$ and

for some $m \in \mathbb{Z}$ we obtain a contradiction to the curvature assumption (1.2). The assumption that $\mu_{1}^{k}>\mu_{2}^{k}+5 \log \delta_{k}^{-1}$ is guaranteed by the existence of a fully bubbling blowup point. Around that blowup point, $u_{1}^{k}-u_{2}^{k}=O(1)$ away from bubbling disks. Then the crude estimate of $u_{1}^{k}$ and $u_{2}^{k}$ around the three disks in the formation $(2,4)$ gives that $\mu_{1}^{k}=\mu_{2}^{k}+(6+o(1)) \log \delta_{k}^{-1}+O(1)$. Thus the two types $(2,4)$ and $(4,2)$ are ruled out if their formations violate the spherical Harnack inequality.

In order to prove the main theorem we also need to rule out the blowup type $(4,4)$ if the spherical Harnack inequality is violated. In the formation of $(4,4)$. There are four situations where the spherical Harnack inequality is violated. Because of similarly we only describe two of them. In the first case there are four bubbling disks all tending to one point. Among the four disks, two bubbling disks
of $u_{2}^{k}$ are in the same line of one bubbling disk of $u_{1}^{k}$ and the distance from each local maximum of $u_{2}^{k}$ to the local maximum of $u_{1}^{k}$ is $\delta_{k}$. On the other hand there is another bubbling disk of $u_{1}^{k}$ whose center (which is also a local maximum of $u_{1}^{k}$ ) is $\bar{\delta}_{k}$ away from the previous local maximum of $u_{1}^{k}$. In this case $\bar{\delta}_{k} / \delta_{k} \rightarrow \infty$ even though $\bar{\delta}_{k} \rightarrow 0$.

The second case is that there are two bubbling disks, in the first bubbling disk, $u_{1}^{k}$ and $u_{2}^{k}$ both satisfy spherical Harnack inequality and the height of $u_{1}^{k}$ minus the height of $u_{2}^{k}$ tends to infinity. If the equation for $u_{2}^{k}$ is scaled according to the height of $u_{2}^{k}$, the new function $v_{2}^{k}$ after scaling tends to a global solution of

Beside this bubbling disk, there is another disk of $u_{1}^{k}$ that is of distance $\delta_{k}$ away from the center of the first bubbling disk.

Now we rule out the first case: Let $p_{0}^{k}$ be the center of the disk of $u_{1}^{k}$ that is placed in the middle of two $u_{2}^{k}$ disks. By setting

For this function we set $\Omega_{k}=B\left(0, \tau \delta_{k}^{-1}\right)$. Note that there is another blowup point $p_{1}^{k} \rightarrow p$, but $\left|p_{1}^{k}-p_{k}\right| / \delta_{k} \rightarrow \infty$. We use $\bar{\delta}_{k}:=\left|p_{1}^{k}-p_{0}^{k}\right|$. So after scaling, the $p_{1}^{k}$ becomes $L_{k}=\bar{\delta}_{k} / \delta_{k}$ away from the origin. We first give a rough description of the heights of bubbling disks. Let $\tilde{v}_{1}^{k}\left(p_{0}\right)=\mu_{1}^{k}$, let $\mu_{2}^{k}$ be the height of $\tilde{v}_{2}^{k}$ in one of the two disks. Let $\bar{\mu}_{1}^{k}$ be the height of $\tilde{v}_{1}^{k}$ at the other bubbling disk. By calculating the spherical average around 0 and $Q_{k}$ (which is the image of $p_{1}^{k}$ after scaling, $\left|Q_{k}\right| \sim L_{k}$ ), we have

Because of the fully bubbling disk, $u_{1}^{k}-u_{2}^{k}=O(1)$ on $\partial B\left(p_{0}^{k}, \tau\right)$, this leads to

Since $\frac{1}{\varrho_{k} \mid}=\delta_{k} / \bar{\delta}_{k}$, the equality above cannot hold if $\mu_{2}^{k} e^{-\mu_{2}^{k}}=O\left(\delta_{k}\right)$. Thus we consider $\mu_{2}^{k} e^{-\mu_{2}^{k}} \gg \delta_{k}$, which implies $\mu_{2}^{k}=O\left(\log \delta_{k}^{-1}\right)$. In this case the second gradient estimate gives

But this cannot hold because the $\frac{Q_{k}}{\left|Q_{k}\right|^{2}}$ majorizes all other terms. We have ruled out the case of $(4,4)$ if the spherical Harnack inequality does not hold in the formation of $(2,4)$.

Next we rule out the case that $(4,4)$ consists of one bubbling disk of $(2,4)$ and $(2,0)$ but the $(2,4)$ satisfies a spherical Harnack around some point. In other words $u_{1}^{k}$ stays on top of $u_{2}^{k}$. We use $\bar{\lambda}_{1}^{k}$ to represent the height of $u_{1}^{k}$ in the bubbling disk that has local maximums of $u_{2}^{k}$, we let $\lambda_{2}^{k}$ represent the height of $u_{2}^{k}$ and set $\lambda_{1}^{k}$ to represent $u_{1}^{k}$ in the other disk. The distance between these two bubbling disks is $\delta_{k} \rightarrow 0$.

Let $p_{k}$ be a local maximum of $u_{2}^{k}$ and $q_{k}$ be the local maximum of $u_{1}^{k}$, which is also the center of a bubbling disk outside the bubbling disk of $u_{2}^{k}$. By the context just mentioned, we set $2 \delta_{k}=\left|p_{k}-q_{k}\right|$. If we set

where $\varepsilon_{2, k}=e^{-\lambda_{2, k} / 2}$, then $v_{2}^{k}$ converges, along a sub-sequence to

Note that the limit function $v_{2}$ also satisfies $\int_{\mathbb{R}^{2}} e^{v_{2}}<\infty$ because of the restriction from $u_{2}^{k}$. By the classification theorem of Prajapat-Tarantello [31]

Then for $\left|x-p_{k}\right| \sim \delta_{k}$ we have

Since one assumption of Theorem 1.1] is that there is a fully bubbling point. The estimate of fully bubbling sequence, as well as Harnack inequality imply that for $\left|x-p_{k}\right| \sim \tau, u_{1}^{k}-u_{2}^{k}=O(1)$. By Green's representation formulas one can also obtain the finite difference for

Because of the fast decay of $e^{\nu_{2}^{k}}$ it is easy to use a bounded function to remove it from the right hand side of the equation. Then we have

\left.\left(\frac{1}{3} v_{1}^{k}+\frac{2}{3} v_{2}^{k}\right)\right|_{\partial B_{1}}=\left.\left(\frac{1}{3} v_{1}^{k}+\frac{2}{3} v_{2}^{k}\right)\right|_{\partial B_{L_{k}}}+O(1) \tag{4.1}
\end{equation*}
$$

where $L_{k}=\frac{1}{2} \delta_{k} \varepsilon_{2, k}^{-1}$. The value of $v_{1}^{k}$ on $\partial B_{1}$ is $-\left(\bar{\lambda}_{1}^{k}-\lambda_{2}^{k}\right)+O(1)$ based on standard estimates for single Liouville equation ([20]). It is also obvious that $v_{2}^{k}=O(1)$ on $\partial B_{1}$. On the other hand $\nu_{1}^{k}=-\lambda_{1}^{k}-4 \log \delta_{k}-\lambda_{2}^{k}+O(1)$ on $\partial B_{L_{k}}$ based on the analysis of single equation. In fact it is also the value for $v_{2}^{k}$ because of the influence of the fully bubbling profile. If we compute the value of $v_{2}^{k}$ from its limit, it is

$$
v_{2}^{k}(y)=-6 \log \left(\delta_{k} / \varepsilon_{2, k}\right)+O(1), \quad|y|=L_{k}
$$

Using these information in (4.1) we have

\bar{\lambda}_{1}^{k}=\lambda_{2}^{k}+9\left(\lambda_{2}^{k}+2 \log \delta_{k}\right)+O(1)
$$

Now we consider

$$
\hat{v}_{1}^{k}(y)=u_{1}^{k}\left(\varepsilon_{2, k} y+p_{k}\right)+2 \log \varepsilon_{2, k}
$$

The Pohozaev identity gives

$$
\varepsilon_{2, k} \nabla \log h_{1}^{k}\left(p_{k}\right)+\nabla \phi_{k}(0)=O\left(\varepsilon_{3}^{k} \mu_{3}^{k}\right)
$$

where $\phi_{k}$ is the harmonic function that eliminates the oscillation of $\hat{v}_{1}^{k}$ around $B_{1}$.

$$
\varepsilon_{3, k}=e^{-\frac{\bar{\lambda}_{1}^{k}-\lambda_{2}^{k}}{2}}, \quad \mu_{3}^{k}=\bar{\lambda}_{1}^{k}-\lambda_{2}^{k}=9\left(\lambda_{2}^{k}+2 \log \delta_{k}\right)+O(1)
$$

Recall that

$$
\begin{equation*}
\bar{\lambda}_{1}^{k}-\lambda_{2}^{k}=9\left(\lambda_{2}^{k}+2 \log \delta_{k}\right)+O(1) \tag{4.2}
\end{equation*}
$$

The harmonic function $\phi_{k}$ is determined by the singular source, which is now located at $\frac{\delta_{k}}{\varepsilon_{2, k}}$ away from the origin. The derivative of this function is comparable to $\varepsilon_{2, k} / \delta_{k}$. So the contradiction boils down to whether

$$
\frac{\varepsilon_{2, k}}{\delta_{k}} \gg \varepsilon_{3, k}^{2} \mu_{3, k} .
$$

Using (4.2) we see that we need

$$
e^{4\left(\lambda_{2}^{k}+2 \log \delta_{k}\right)} \gg 9\left(\lambda_{2}^{k}+2 \log \delta_{k}\right) .
$$

Since this quantity goes to infinity, it holds. Theorem 1.1 is established.

## 5. Appendix A

In this section we provide a proof of (3.84). Here we briefly explain the roles of each term. $\phi_{1}$ corresponds to the radial solution in the kernel of the linearized operator of the global equation. In other words, $\phi_{1}^{k} / \bar{M}_{k}$ should tend to zero. $\phi_{2}^{k} / \bar{M}_{k}$ is the combination of the two other functions in the kernel. $\phi_{4}$ is the second order term which will play a leading role later. $\phi_{3}^{k}$ comes from the difference of $\mathfrak{h}_{2}^{k}$ at $Q_{1}^{k}$ and $e_{1}$. Before we derive (3.84) we point out that

$$
\frac{\left|p_{k}\right|}{\varepsilon_{k}} \leq C \varepsilon_{k}^{-1} \mu_{2}^{k} e^{-\mu_{2}^{k}}+C \varepsilon_{k}^{-1} \delta_{k}^{2} \leq C \mu_{2}^{k} \varepsilon_{k} .
$$

The derivation of (3.84) is as follows: First by the expression of $e_{1}$ in (3.81) we have

$$
y^{2}=1+2 \varepsilon_{k} z+\varepsilon_{k}^{2} z^{2}
$$

where $y=e_{1}+\varepsilon_{k} z$. Then

$$
\begin{gathered}
\left|y^{2}-e_{1}\right|^{2}=4 \varepsilon_{k}^{2}\left|z+\frac{\varepsilon_{k}}{2} z^{2}\right|^{2} \\
\left|y^{2}-e_{1}-p_{k}\right|^{2} \\
=4 \varepsilon_{k}^{2}\left(|z|^{2}-2 \operatorname{Re}\left(\frac{\varepsilon_{k}}{2}|z|^{2} \bar{z}\right)-2 \operatorname{Re}\left(z \frac{\bar{p}_{k}}{2 \varepsilon_{k}}\right)+\left|\frac{p_{k}}{2 \varepsilon_{k}}\right|^{2}+O\left(\varepsilon_{k}^{2}|z|^{4}\right)+O\left(\mu_{2}^{k} \varepsilon_{k}^{2}|z|^{2}\right)\right)
\end{gathered}
$$

Next by the definition of $D_{k}$ in (3.80)

$$
\frac{D_{k}-\bar{D}_{k}}{\bar{D}_{k}}=\delta_{k} \nabla\left(\log \mathfrak{h}_{2}^{k}\right)\left(\delta_{k} e_{1}\right) \cdot\left(Q_{1}^{k}-1\right)+O\left(\delta_{k}^{2}\right)
$$

$$
\begin{align*}
\frac{e^{\mu_{2}^{k}-\bar{\mu}_{2}^{k}}}{\bar{D}_{k}} & =\frac{1}{D_{k}}\left(1+\frac{D_{k}-\bar{D}_{k}}{\bar{D}_{k}}+\bar{\mu}_{2}^{k}-\mu_{2}^{k}+O\left(\bar{\mu}_{2}^{k}-\mu_{2}^{k}\right)^{2}+O\left(\delta_{k}^{2}\right)\right)  \tag{5.1}\\
& =\frac{1}{D_{k}}\left(1+\delta_{k} \nabla \log \mathfrak{h}_{2}^{k}\left(\delta_{k} e_{1}\right) \cdot\left(Q_{1}^{k}-e_{1}\right)+\bar{\mu}_{2}^{k}-\mu_{2}^{k}+O\left(\bar{\mu}_{2}^{k}-\mu_{2}^{k}\right)^{2}+O\left(\delta_{k}^{2}\right)\right)
\end{align*}
$$

Then the expression of $A$ is (for simplicity we omit $k$ in some notations)

A=\left(\frac { e ^ { \overline { \mu } _ { 2 } - \mu _ { 2 } } } { \overline { D } _ { k } } \left(4\left(|z|^{2}-2 \operatorname{Re}\left(z \frac{\overline{p_{k}}}{2 \varepsilon_{k}}\right)+\frac{\left|p_{k}\right|^{2}}{4 \varepsilon_{k}^{2}}+O\left(\varepsilon_{k}|z|^{3}\right)\right)\right.\right.
$$

$$
\left.-\frac{4}{D_{k}}\left(|z|^{2}+O\left(\varepsilon_{k}\right)|z|^{3}\right)\right) / B
$$

After using (5.1) we have

$$
\begin{align*}
A=\left(\frac { 1 } { D _ { k } } \left(\delta_{k} \nabla\right.\right. & \left(\log \mathfrak{h}_{2}^{k}\left(\delta_{k} e_{1}\right)\left(Q_{1}-1\right)+\bar{\mu}_{2}^{k}-\mu_{2}^{k}+O\left(\bar{\mu}_{2}^{k}-\mu_{2}^{k}\right)^{2}\right) 4|z|^{2}  \tag{5.2}\\
& \left.-4 \operatorname{Re}\left(z \frac{\bar{p}_{k}}{\varepsilon_{k}}\right) \frac{1}{D_{k}}+\frac{\left|p_{k}\right|^{2}}{\varepsilon_{k}^{2} D_{k}}+O\left(\varepsilon_{k}\right)|z|^{3}+O\left(\delta_{k}^{2}\right)|z|^{2}\right) / B . \\
A^{2}= & \left(\frac{16}{D_{k}^{2}}\left(\operatorname{Re}\left(z \frac{-\bar{p}_{k}}{\varepsilon_{k}}\right)^{2}\right) / B^{2}+\right.\text { other terms. } \tag{5.3}
\end{align*}
$$

The numerator of $A^{2}$ has the following leading term:

$$
\frac{8}{D_{k}^{2}}\left(|z|^{2}\left(\frac{\left|p_{k}\right|}{\varepsilon_{k}}\right)^{2}\left(1+\cos \left(2 \theta-2 \theta_{1}^{k}\right)\right)\right)
$$

where $z=|z| e^{i \theta}, p_{k}=\left|p_{k}\right| e^{i \theta_{1}^{k}}$. Using these expressions we can obtain (3.84) by direct computation.

## 6. Appendix B

In this section we derive (3.91). Here we first point out that we shall use (3.84). The terms of $\phi_{1}$ and $\phi_{3}$ will lead to $o\left(\varepsilon_{k}\right)$, the integration involving $\phi_{2}$ cancels with the second term of (3.91). The computation of $\phi_{2}$ is based on this equation:

\int_{\mathbb{R}^{2}} \frac{\frac{\mathfrak{h}_{2}^{k}\left(\delta_{k} Q_{1}^{k}\right)}{4} \sigma_{k} \nabla \mathfrak{h}_{2}^{k}\left(\delta_{k} Q_{1}^{k}\right)\left(Q_{1}^{k}-e_{1}\right)|z|^{2}}{\left(1+\frac{\mathfrak{h}_{2}^{k}\left(\delta_{k} Q_{1}^{k}\right)}{8}|z|^{2}\right)^{3}} d z=8 \pi \sigma_{k} \nabla\left(\log \mathfrak{h}_{2}^{k}\right)\left(\delta_{k} Q_{1}^{k}\right)\left(Q_{1}^{k}-e_{1}\right)
$$

and by (3.51)

$$
\begin{equation*}
\nabla \log \mathfrak{h}_{2}^{k}\left(\delta_{k} Q_{1}^{k}\right)-\nabla \log \mathfrak{h}_{2}^{k}\left(\delta_{k} e_{1}\right)=O\left(\delta_{k}\right)=o\left(\varepsilon_{k}\right) \tag{6.1}
\end{equation*}
$$

The integration involving $\phi_{4}$ provides the leading term. More detailed information is the following: First for a global solution

V_{\mu, p}=\log \frac{e^{\mu}}{\left(1+\frac{e^{\mu}}{\lambda}\left|z^{N+1}-p\right|^{2}\right)^{2}}
$$

of

$$
\Delta V_{\mu, p}+\frac{8(N+1)^{2}}{\lambda}|z|^{2 N} e^{V_{\mu, p}}=0, \quad \text { in } \quad \mathbb{R}^{2}
$$

by differentiation with respect to $\mu$ we have

$$
\Delta\left(\partial_{\mu} V_{\mu, p}\right)+\frac{8(N+1)^{2}}{\lambda}|z|^{2 N} e^{V_{\mu, p}} \partial_{\mu} V_{\mu, p}=0, \quad \text { in } \quad \mathbb{R}^{2}
$$

By the expression of $V_{\mu, p}$ we see that

$$
\partial_{r}\left(\partial_{\mu} V_{\mu, p}\right)(x)=O\left(|x|^{-2 N-3}\right)
$$

Thus we have

$$
\begin{align*}
& \int_{\mathbb{R}^{2}} \partial_{\mu} V_{\mu, p}|z|^{2 N} e^{V_{\mu, p}}  \tag{6.2}\\
= & \int_{\mathbb{R}^{2}} \frac{\left(1-\frac{e^{\mu}}{\lambda}\left|z^{N+1}-P\right|^{2}\right)|z|^{2 N}}{\left(1+\frac{e^{\mu}}{\lambda}\left|z^{N+1}-P\right|^{2}\right)^{3}} d z \\
= & -\frac{\lambda}{8(N+1)^{2}} \int_{\mathbb{R}^{2}} \Delta\left(\partial_{\nu} V_{\mu, p}\right)=0 .
\end{align*}
$$

From $V_{\mu, p}$ we also have

$$
\int_{\mathbb{R}^{2}} \partial_{P} V_{\mu, p}|y|^{2 N} e^{V_{\mu, p}}=\int_{\mathbb{R}^{2}} \partial_{\bar{P}} V_{\mu, p}|y|^{2 N} e^{V_{\mu, p}}=0
$$

which gives

$$
\begin{equation*}
\int_{\mathbb{R}^{2}} \frac{\frac{e^{\mu}}{\lambda}\left(\bar{z}^{N+1}-\bar{P}\right)|z|^{2 N}}{\left(1+\frac{e^{\mu}}{\lambda}\left|z^{N+1}-P\right|^{2}\right)^{3}}=\int_{\mathbb{R}^{2}} \frac{\frac{e^{\mu}}{\lambda}\left(z^{N+1}-P\right)|z|^{2 N}}{\left(1+\frac{e^{\mu}}{\lambda}\left|z^{N+1}-P\right|^{2}\right)^{3}}=0 \tag{6.3}
\end{equation*}
$$

Now we need more precise expressions of $\phi_{1}, \phi_{3}$ and $B$ :

$$
\begin{aligned}
\phi_{1} & =\left(\mu_{2}^{k}-\bar{\mu}_{2}^{k}\right)\left(1-\frac{4}{D_{k}}\left|z+\frac{1}{2} \varepsilon_{k} z^{2}\right|^{2}\right) / B \\
\phi_{3} & \left.=\frac{8}{D_{k} B} \operatorname{Re}\left(\left(z+\frac{1}{2} \varepsilon_{k} z^{2}\right)\right)\left(\frac{-\bar{p}_{k}}{\varepsilon_{k}}\right)\right) \\
B & =1+\frac{4}{D_{k}}\left|z+z^{2} \varepsilon_{k}\right|^{2}
\end{aligned}
$$

From here we use scaling and cancellation to have

$$
\int_{B\left(0, \tau \varepsilon_{k}^{-1}\right)} \frac{\phi_{1}}{M_{k}} B^{-2}=o\left(\varepsilon_{k}\right)
$$

which is based on 6.2 and

$$
\int_{B\left(0, \tau \varepsilon_{k}^{-1}\right)} \frac{\phi_{3}}{M_{k}} B^{-2}=o\left(\varepsilon_{k}\right)
$$

which is based on (6.3). Thus (3.91) holds.
