# The exterior Dirichlet problems of Hessian quotient equations

#### Abstract

In this paper, we study the Dirichlet problem of Hessian quotient equations in exterior domains. By estimating the eigenvalues of the solution, the necessary and sufficient conditions on existence of radial solutions are obtained. Applying the solutions of ODE, the viscosity subsolutions and supersolutions are constructed and then the existence of viscosity solutions for exterior problems is established by the Perron's method.


Keywords: Hessian quotient equations; exterior Dirichlet problem; radial solutions; asymptotic behavior; necessary and sufficient conditions

## 1 Introduction

In this paper, we study the exterior Dirichlet problem of the Hessian quotient equations

\frac{S_{k}\left(D^{2} u\right)}{S_{l}\left(D^{2} u\right)} & =g(x) \text { in } \mathbb{R}^{n} \backslash \bar{\Omega},  \tag{1.1}\\
u & =\phi \text { on } \partial \Omega, \tag{1.2}
\end{align*}

where $\Omega$ is a bounded set in $\mathbb{R}^{n}, 0 \leq l<k \leq n, n \geq 2, S_{j}\left(D^{2} u\right)$ is the $j$ th elementary symmetric function of the eigenvalues $\lambda=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right)$ of Hessian matrix $D^{2} u$, i.e.,

S_{j}\left(D^{2} u\right)=\sigma_{j}\left(\lambda\left(D^{2} u\right)\right)=\sum_{1 \leq i_{1}<\cdots<i_{j} \leq n} \lambda_{i_{1}} \cdots \lambda_{i_{j}}, j=1,2, \cdots, n,
$$

and $g \in C^{0}\left(\mathbb{R}^{n} \backslash \Omega\right)$ is positive, $\phi \in C^{2}(\partial \Omega)$. For $l=0$, we set $S_{0}\left(D^{2} u\right) \equiv 1$.
The Hessian quotient equation (1.1) is fully nonlinear and is closely connected with the geometric problem. Some well-known equations are its special cases. If $l=0$, (1.1) is the $k$-Hessian equation. Particularly, (1.1) is the Poisson equation if $k=1, l=0$, while it is the Monge-Ampère equation for $k=n, l=0$. If $k=n=3, l=1$, (1.1) becomes the special Lagrangian equation $\operatorname{det} D^{2} u=\Delta u$ which stems from special Lagrangian geometry [1]: let $u$ be a solution of (1.1), then the graph of $D u$ over $\mathbb{R}^{3}$ in $\mathbb{C}^{3}$ is a special Lagrangian submanifold in $\mathbb{C}^{3}$, that is, its mean curvature vanishes everywhere and the complex structure on $\mathbb{C}^{3}$ sends the tangent space of the graph to the normal space at every point. So (1.1) has attracted a lof of attention, see [2, [12, 24, 31] and the references therein.

A classical theorem of Monge-Ampère equation states that any convex classical solution of $\operatorname{det} D^{2} u=1$ in $\mathbb{R}^{n}$ must be a quadratic polynomial which is proved by Jörgens [22] $(n=2)$, Calabi [9] $(n \leq 5)$ and Pogorelov [29] $(n \geq 2)$. One can also refer to the related results [13, 8, 23, 30]. In 2003, Caffarelli and Li [11] made the extension of

Jörgens-Calabi-Pogorelov theorem and also investigated the existence of solutions for the exterior Dirichlet problem of Monge-Ampère equation

They obtained that if $\Omega$ is a smooth, bounded, strictly convex open subset and $\phi \in$ $C^{2}(\partial \Omega)$, then for any given $b \in \mathbb{R}^{n}$ and any given $n \times n$ real symmetric positive definite matrix $A$ with $\operatorname{det} A=1$, there exists some constant $c^{*}$ depending only on $n, \Omega, \phi, b$ and $A$, such that for every $c>c^{*}$ there exists a unique function $u \in C^{\infty}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right) \cap C^{0}\left(\overline{\mathbb{R}^{n} \backslash \Omega}\right)$ which satisfies (1.3) and the asymptotic behavior at infinity

\limsup _{|x| \rightarrow \infty}\left(|x|^{n-2}\left|u(x)-\left(\frac{1}{2} x^{T} A x+b \cdot x+c\right)\right|\right)<\infty .
$$

Since then, there have been extensive studies of the exterior problem for the fully nonlinear elliptic equations. In 2011, Dai and Bao [17] $(n \geq 3)$, Dai [14] $(n \geq 3)$ studied the exterior Dirichlet problem of Hessian equation

and got the existence and uniqueness of the viscosity solutions with the asymptotic behavior. Bao, Li and Li [6] $(n \geq 3)$, Cao-Bao [10] $(n \geq 3)$ studied the viscosity solutions with the generalized asymptotic behavior of the exterior Dirichlet problem for Hessian equation. The subsequent results following [11] of the exterior Dirichlet problem for Monge-Ampère equations can be referred to [3, 4, 5, 7, 21, 28; For the Hessian quotient equations

where $0 \leq l<k \leq n, n \geq 3$, the first author [15] obtained the existence of viscosity solutions with the asymptotic behavior

\limsup _{|x| \rightarrow \infty}\left(|x|^{k-l-2}\left|u(x)-\left(\frac{\hat{a}}{2}|x|^{2}+c\right)\right|\right)<+\infty \tag{1.5}
\end{equation*}

for the exterior Dirichlet problem with $\hat{a}=\left(C_{n}^{l} / C_{n}^{k}\right)^{\frac{1}{k-l}}, k-l \geq 3$. Li and the first author [26] studied the viscosity solutions with the asymptotic behavior (1.5) for $k \leq(n+1) / 2$ which includes $k-l=1$ and $k-l=2$ not included in [15]. Recently, Li and Li [25] considered the viscosity solutions with the generalized asymptotic behavior

with $m \in(2, n]$ and $S_{k}(A) / S_{l}(A)=1$. One can also refer to [27]. We would like to remark that for $n=2$, the exterior Dirichlet problem of Monge-Ampère equations can be referred
to the earlier works by Ferrer, Martínez, and Milán [19, 20] using the complex variable methods and the works by Delanoë [18].

For convenience, we first restrict the class of functions. Define

\Gamma_{k}=\left\{\lambda \in \mathbb{R}^{n} \mid \sigma_{j}(\lambda)>0, j=1,2, \cdots, k\right\} .
$$

Let $u \in C^{2}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ and $\lambda=\lambda\left(D^{2} u\right)=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right)$ be the eigenvalues of the Hessian matrix $D^{2} u$. If $\lambda \in \overline{\Gamma_{k}}\left(\Gamma_{k}\right)$, then we call $u$ is $k$-convex (uniformly $k$-convex). If $k=n$, a uniformly $n$-convex function is a convex function. Eq. (1.1) is elliptic for uniformly $k$-convex functions.

For $m=1,2, \ldots, n$, let
$\Phi_{m}=\left\{u \in C^{1}\left(\mathbb{R}^{n} \backslash B_{1}\right) \cap C^{2}\left(\mathbb{R}^{n} \backslash \overline{B_{1}}\right) \mid u\right.$ is uniformly $m$-convex and radially symmetric. $\}$
Wang and Bao [32] studied the necessary and sufficient conditions on existence and convexity of radial solutions to the exterior Dirichlet problems of Hessian equations

S_{k}\left(D^{2} u\right) & =1, x \in \mathbb{R}^{n} \backslash \overline{B_{1}},  \tag{1.6}\\
u & =\bar{b}, x \in \partial B_{1}, \\
u & =\frac{\bar{a}}{2}|x|^{2}+\bar{c}+O\left(|x|^{2-n}\right),|x| \rightarrow \infty
\end{align*}\right.
$$

with $\bar{b}, \bar{c} \in \mathbb{R}, \bar{a}=\left(1 / C_{n}^{k}\right)^{\frac{1}{k}}$. Lately, Li and Lu [28] characterized the existence and nonexistence of solutions for exterior problem of Monge-Ampère equations.

As far as we know for Hessian quotient equations, there is no such beautiful result. In this paper, we first consider the necessary and sufficient conditions on existence of radial solutions to the exterior Dirichlet problems of Hessian quotient equations with prescribed asymptotic behavior at infinity.

Let $B_{1}$ be the unit ball in $\mathbb{R}^{n}$. The main results of this paper are the following.
Theorem 1.1. Let $2 \leq k \leq m \leq n, n \geq 3,0 \leq l<k$, and $b \in \mathbb{R}$. The exterior Dirichlet problem

u & =b \quad \text { on } \quad \partial B_{1} \tag{1.8}
\end{align*}
$$

has a unique function $u \in \Phi_{m}$ satisfying

u(x)=\frac{\hat{a}}{2}|x|^{2}+c+O\left(|x|^{2-n}\right),|x| \rightarrow \infty
$$

if and only if $c \in\left[\mu\left(\alpha_{1}\right),+\infty\right)$ for $m=k$, and $c \in\left[\mu\left(\alpha_{1}\right), \mu\left(\alpha_{2}\right)\right]$ for $m>k$, where $\hat{a}=\left(C_{n}^{l} / C_{n}^{k}\right)^{\frac{1}{k-l}}$,

c=\mu(\alpha)=b-\frac{\hat{a}}{2}+\hat{a} \int_{1}^{\infty} s\left[\left(1+\frac{\alpha}{C_{n}^{l} s^{n} U^{l}(s, \alpha)}\right)^{\frac{1}{k-l}}-1\right] d s,
$$

and $U:=U(r, \alpha):=U_{r}(\alpha)$ satisfies

Remark 1.1. If $l=0$, for the case of Hessian equation $S_{k}\left(D^{2} u\right)=1$, we then get that $\alpha_{1}=-1, \alpha_{2}=\frac{k}{m-k}$. So Theorem 1.1] corresponds to Theorem 2 in [32].
Remark 1.2. For the Hessian equations, the eigenvalue $\gamma$ of Hessian matrix $D^{2} u$ of the solutions $u$ satisfies $\gamma^{k}=\frac{1+\alpha r^{-n}}{C_{n}^{k}}$ with $\alpha=C_{n}^{k}\left(u^{\prime}(1)\right)^{k}-1$, so $\alpha$ is relatively easy to be estimated. Unlike the Hessian equations, in this paper, the eigenvalue $\gamma$ satisfies $\gamma^{k}-\frac{C_{n}^{l}}{C_{n}^{k}} \gamma^{l}-\frac{\alpha}{C_{n}^{k} r^{n}}=0$ with $\alpha=C_{n}^{k}\left(u^{\prime}(1)\right)^{k}-C_{n}^{l}\left(u^{\prime}(1)\right)^{l}$, it is difficult to estimate $\alpha$, here we use the inverse function, see Lemma 2.3.

Let $k=n=2, l=1$, then the exterior Dirichlet problem (1.7), (1.8) becomes

\operatorname{det} D^{2} u & =\Delta u \text { in } \mathbb{R}^{2} \backslash \overline{B_{1}},  \tag{1.12}\\
u & =b \text { on } \partial B_{1} . \tag{1.13}
\end{align*}
$$

Theorem 1.2. The exterior Dirichlet problem (1.12), (1.13) has a unique solution $u \in \Phi_{2}$ satisfying

u(x)=|x|^{2}+\frac{\rho}{2} \ln |x|+c+O\left(|x|^{-2}\right) \tag{1.14}
\end{equation*}
$$

if and only if $\rho \geq-1$, where $c=\nu(\rho)$ and

\nu(\rho)=b-\frac{1}{2}+\frac{\rho}{4}+\frac{\rho}{2} \ln 2-\frac{1}{2}[\sqrt{1+\rho}+\rho \ln (1+\sqrt{1+\rho})] .
$$

Next we study the existence of solutions of problem (1.1) and (1.2). Now we first recall the definition of viscosity solution.

Definition 1.1. A function $u \in C^{0}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ is said to be a viscosity subsolution of (1.1), if for any $\bar{x} \in \mathbb{R}^{n} \backslash \bar{\Omega}, v \in C^{2}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ satisfying

u(x) \leq v(x), x \in \mathbb{R}^{n} \backslash \bar{\Omega} \quad \text { and } \quad u(\bar{x})=v(\bar{x}),
$$

we have

S_{k}\left(D^{2} v(\bar{x})\right) \geq g(\bar{x})
$$

Similarly, $u \in C^{0}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ is said to be a viscosity supersolution of (1.1), if for every $\bar{x} \in \mathbb{R}^{n} \backslash \bar{\Omega}, k$-convex function $v \in C^{2}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ satisfying

u(x) \geq v(x), x \in \mathbb{R}^{n} \backslash \bar{\Omega} \quad \text { and } \quad u(\bar{x})=v(\bar{x})
$$

we have

S_{k}\left(D^{2} v(\bar{x})\right) \leq g(\bar{x})
$$

If $u \in C^{0}\left(\mathbb{R}^{n} \backslash \bar{\Omega}\right)$ is both a viscosity subsolution and a viscosity supersolution of (1.1), we call that $u$ is a viscosity solution of (1.1).

If $u$ is a viscosity subsolution (resp. supersolution, solution) to (1.1) and $u \leq$ (resp. $\geq,=) \phi(x)$ on $\partial \Omega$, we call that $u$ is a viscosity subsolution (resp. supersolution, solution) of (1.1) and (1.2).

Let $S(n)$ denote the set of the real $n \times n$ symmetric matrices, and for $A \in S(n), A$ is positive definite, let $r:=r_{A}(x):=\sqrt{x^{T} A x}$. Suppose that $g_{0} \in C^{0}([0,+\infty))$ is a positive function of $r$,

and for some constant $\underline{C}_{0}>0$,

Assume that $g \in C^{0}\left(\mathbb{R}^{n}\right)$ satisfies that

and there exists a constant $\beta>2$ such that

\end{equation*}

Define

\Lambda_{k}(A, x)=\frac{\sum_{i=1}^{n} \frac{\partial}{\partial \lambda_{i}} \sigma_{k}(\lambda(A)) \lambda_{i}^{2} x_{i}^{2}}{\sigma_{k}(\lambda(A)) \sum_{i=1}^{n} \lambda_{i} x_{i}^{2}}

and

& \bar{t}_{k}:=\bar{t}_{k}(A):=\sup _{x \in \mathbb{R}^{n} \backslash\{0\}} \Lambda_{k}(A, x), \\
& \underline{t}_{k}:=\underline{t}_{k}(A):=\inf _{x \in \mathbb{R}^{n} \backslash\{0\}} \Lambda_{k}(A, x),
\end{aligned}

where $\lambda_{i}, i=1, \ldots, n$ are the eigenvalues of the matrix $A$.
Remark 1.3. If $A=\bar{C} I$ for some $\bar{C}>0$, then $\bar{t}_{k}=\underline{t}_{k}=\Lambda_{k}=k / n$. See also Lemma 3.1. Let

\mathcal{A}_{k, l}=\left\{A \mid A \in S(n), A \text { is positive definite and satisfy } \frac{S_{k}(A)}{S_{l}(A)}=1\right\}
$$

Theorem 1.3. Let $0 \leq l<k \leq n, n \geq 3, \frac{k-l}{\bar{t}_{k}-\underline{t}_{l}}>2$ and $\Omega$ be a bounded, strictly convex subset in $\mathbb{R}^{n}, \phi \in C^{2}(\partial \Omega)$. Assume that $g$ satisfies (1.15) and (1.16). Then for any given $b \in \mathbb{R}^{n}$ and $A \in \mathcal{A}_{k, l}$, there exists some constant $\tilde{c}$, depending only on $n, b, A, \Omega, g, g_{0}$, $\|\phi\|_{C^{2}(\partial \Omega)}$, such that for every $c>\tilde{c}$, there exists a unique viscosity solution $u \in C^{0}\left(\mathbb{R}^{n} \backslash \Omega\right)$ of (1.1) and (1.2) satisfying

\limsup _{|x| \rightarrow \infty}\left(|x|^{\min \left\{\beta, \frac{k-l}{t_{k}-t_{l}}\right\}-2}(\ln |x|)^{-1}\left|u(x)-\left(u_{0}(x)+b \cdot x+c\right)\right|\right)<\infty, \text { if } \beta=\frac{k-l}{\bar{t}_{k}-\underline{t}_{l}}, \tag{1.18}
\end{equation*}

where

u_{0}(x)=\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta
$$

and $h_{0}$ satisfies

h_{0}(r)=\left(r^{-\frac{k-l}{\tau_{k}-t_{l}}} \int_{0}^{r} g_{0}(s)\left(s^{\frac{k-l}{\bar{t}_{k}-t_{l}}} h_{0}(s)^{\frac{(k-l) t_{l}}{\bar{t}_{k}-\frac{t_{l}}{l}}}\right)^{\prime} d s\right)^{\frac{\frac{t_{k}-t_{l}}{(k-l) t_{k}}}{}} . \tag{1.19}

The main difficulty of proving Theorem 1.3 is not only to construct the generalized symmetric subsolutions with asymptotic behavior, but also to construct the generalized symmetric supersolutions with asymptotic behavior which is different from the case $g \equiv 1$ in [25] where $\frac{1}{2} x^{T} A x+b \cdot x+c$ are directly the supersolutions. In addition, we use different method from which in [25] to obtain the asymptotic behavior of subsolutions and supersolutions on the basis of the expressions of subsolutions and supersolutions themselves.
Remark 1.4. If $g_{0} \equiv 1$, then $g=1+O\left(r^{-\beta}\right), r \rightarrow+\infty$ and by (1.19), $h_{0} \equiv 1$, and so

u_{0}(x)=\frac{1}{2} x^{T} A x .
$$

Remark 1.5. For the special case that $l=0, k \geq 2$, the Hessian equation $S_{k}\left(D^{2} u\right)=g(x)$ with $g(x)=g_{0}(r)+O\left(r^{-\beta}\right)$, our Theorem [1.3 is Theorem 1.3 in [16]. For the special case that $l=0, g_{0} \equiv 1$, the Hessian equation $S_{k}\left(D^{2} u\right)=g(x)$ with $g(x)=1+O\left(|x|^{-\beta}\right)$, our Theorem 1.3 extends the corresponding Theorem 1.1 in [10], where the solution $u$ satisfies the asymptotic behavior

$$

or

\limsup _{|x| \rightarrow \infty}\left(|x|^{\min \left\{\beta, \frac{k}{H_{k}}\right\}-2}(\ln |x|)^{-1}\left|u(x)-\left(\frac{1}{2} x^{T} A x+b \cdot x+c\right)\right|\right)<\infty, \text { if } \beta=\frac{k}{H_{k}},
$$

with $k \geq 2, H_{k}=H_{k}(A):=\max _{1 \leq i \leq n} A_{k}^{i}(A), A_{k}^{i}(A)=\lambda_{i}(A) \frac{\partial}{\partial \lambda_{i}} \sigma_{k}(\lambda(A)), i=1, \ldots, n$. But in our paper, if $l=0$, then $\underline{t}_{l}=0$, and our $\bar{t}_{k}$ is different from $H_{k}$. For $A \in \mathcal{A}_{k, 0}$, we can know that $\bar{t}_{k} \leq H_{k}$ which means that the result of Theorem 1.3 is better than that of Theorem 1.1 in [10].

For the special case that $l=0, k=n, g_{0} \equiv 1$, the Monge-Ampère equation det $D^{2} u=$ $g(x)$ with $g(x)=1+O\left(|x|^{-\beta}\right)$, our result (1.17) is included in the Corollary 1.1 in [4] but where (1.18) is missed.
Remark 1.6. In Theorem [1.3, since $\frac{k-l}{\bar{t}_{k}-\underline{t}_{l}}>2, k-l \geq 1$ and $0<\bar{t}_{k}-\underline{t}_{l}<1$, then the cases that $k-l=1, \bar{t}_{k}-\underline{t}_{l} \geq \frac{1}{2}$ are not included. For the two cases, the supersolutions with asymptotic behavior are not easy to seek. Maybe we need to look for new methods.

The remainders of this paper are arranged as follows. In section 2, we will prove Theorems 1.1] and 1.2. With the help of the inverse function, we estimate $\alpha=C_{n}^{k}\left(u^{\prime}(1)\right)^{k}-$ $C_{n}^{l}\left(u^{\prime}(1)\right)^{l}$, see Lemma 2.3, In Section 3, we first prove Proposition 3.2 which indicates that there does not exist generalized symmetric solution (see Definition 3.1) for the Hessian quotient equation (1.1) with $0 \leq l<k \leq n$ unless $A=\hat{a} I$. Then we construct a family of generalized symmetric smooth $k$-convex subsolutions and supersolutions of (1.1) by the solutions of ODE and in the fourth section, we will prove Theorem 1.3 by Perron's method. Finally, in Appendix, we give several lemmas which are used in this paper.

## 2 Proof of Theorem 1.1

Lemma 2.1. Let $\lambda=(\omega, \gamma, \ldots, \gamma) \in \Gamma_{m}, n \geq m \geq 2$. Then $\gamma>0$.
Proof. See Lemma 1 in [32].
Lemma 2.2. Let $\lambda=(\omega, \gamma, \ldots, \gamma) \in \mathbb{R}^{n}$ and $\sigma_{k, l}(\lambda)=1,2 \leq k \leq n, 0 \leq l<k$. Then $\lambda \in \Gamma_{m}(k \leq m \leq n)$ if and only if

Proof. Since $\sigma_{k, l}(\lambda)=1$, then

Due to $\lambda \in \Gamma_{m}$, by the definition of $\Gamma_{m}$, we get that

By Lemma 2.1, since $\gamma>0$, we have

Then we have two cases.
Case 1:

C_{n}^{l}(j-l) \gamma^{l}<C_{n}^{k}(j-k) \gamma^{k} \\
k C_{n}^{k} \gamma^{k-1}<l C_{n}^{l} \gamma^{l-1} .
\end{array}\right.
$$

For the Case 1, if $m=k$, then

\gamma^{k-l} & >\frac{l C_{n}^{l}}{k C_{n}^{k}}, j<k, \\
\gamma^{k-l} & >\frac{l C_{n}^{l}}{k C_{n}^{k}}, j=k
\end{aligned}\right.
$$

So if $m=k$, we have

\gamma^{k-l}>\frac{l C_{n}^{l}}{k C_{n}^{k}} \tag{2.4}
\end{equation*}
$$

If $m>k$, then

\begin{cases}\gamma^{k-l}>\frac{l C_{n}^{l}}{k C_{n}^{k}}, & j \leq k, \\ \frac{l C_{n}^{l}}{k C_{n}^{k}}<\gamma^{k-l}<\frac{(m-l) C_{n}^{l}}{(m-k) C_{n}^{k}}, & j \geq k+1 .\end{cases}
$$

So if $m>k$, we have

For the Case 2, whether $m=k$ or $m>k$, Case 2 is impossible. The Lemma is proved.

Lemma 2.3. Let $2 \leq k \leq m \leq n, 0 \leq l<k$, and suppose that $u \in C^{1}\left(\mathbb{R}^{n} \backslash B_{1}\right) \cap$ $C^{2}\left(\mathbb{R}^{n} \backslash \overline{B_{1}}\right)$ is a radial solution of (1.7) and (1.8). Set

\alpha=C_{n}^{k}\left(u^{\prime}(1)\right)^{k}-C_{n}^{l}\left(u^{\prime}(1)\right)^{l} .

Then $u$ is uniformly $k$-convex if and only if $\alpha \in\left[\alpha_{1},+\infty\right)$, and $u$ is uniformly $m(m>$ $k)-$ convex if and only if $\alpha \in\left[\alpha_{1}, \alpha_{2}\right]$, where $\alpha_{1}, \alpha_{2}$ are given by (1.9), (1.10).

Proof. Let $u(x)=u(r)=u(|x|) \in C^{1}\left(\mathbb{R}^{n} \backslash B_{1}\right) \cap C^{2}\left(\mathbb{R}^{n} \backslash \overline{B_{1}}\right)$ be a radial solution of (1.7) and (1.8). Then

In view of Lemma 2.1, we know that

Moreover,

Hence

Then since by (2.1), $U^{k-l}>l C_{n}^{l} / k C_{n}^{k}$, thus

Due to the implicit function theorem, (2.9) has a unique function $U=U(r, \alpha)$ and

\frac{\partial U}{\partial \alpha}=\frac{1}{r^{n}\left(k C_{n}^{k} U^{k-1}-l C_{n}^{l} U^{l-1}\right)}>0 . \tag{2.10}
\end{equation*}

And in virtue of (2.9), for $r>1$,

Set $U_{r}(\alpha):=U(r, \alpha)$. Then by (2.10), the inverse function of $U_{r}(\alpha)$ exists, we denote it as $U_{r}^{-1}(\alpha)$. Moreover, $d U_{r}^{-1} / d \alpha>0$. So by Lemma 2.2, $u$ is uniformly $m$-convex if and only if

which is equivalent to

\alpha_{1}:=\sup _{r>1} U_{r}^{-1}\left(\left(\frac{l C_{n}^{l}}{k C_{n}^{k}}\right)^{\frac{1}{k-l}}\right) \leq \alpha<+\infty, \text { if } m=k,
$$

and

\alpha_{1}:=\sup _{r>1} U_{r}^{-1}\left(\left(\frac{l C_{n}^{l}}{k C_{n}^{k}}\right)^{\frac{1}{k-l}}\right) \leq \alpha \leq \inf _{r>1} U_{r}^{-1}\left(\left(\frac{(m-l) C_{n}^{l}}{(m-k) C_{n}^{k}}\right)^{\frac{1}{k-l}}\right):=\alpha_{2} \text {, if } m>k .
$$

Lemma 2.3 is proved.

## Proof of Theorem 1.1 By (2.8),

U^{k-l}(r, \alpha)=\frac{C_{n}^{l}}{C_{n}^{k}}\left(1+\frac{\alpha}{C_{n}^{l} r^{n} U^{l}(r, \alpha)}\right) . \tag{2.12}

Integrating the above equality on both sides for $r$, we have

= & \frac{\hat{a}}{2}|x|^{2}+b-\frac{\hat{a}}{2}+\hat{a} \int_{1}^{\infty} s\left[\left(1+\frac{\alpha}{C_{n}^{l} s^{n} U^{l}(s, \alpha)}\right)^{\frac{1}{k-l}}-1\right] d s  \tag{2.13}\\
& -\hat{a} \int_{|x|}^{\infty} s\left[\left(1+\frac{\alpha}{C_{n}^{l} s^{n} U^{l}(s, \alpha)}\right)^{\frac{1}{k-l}}-1\right] d s \\
= & \frac{\hat{a}}{2}|x|^{2}+c-\hat{a} \int_{|x|}^{\infty} s\left[\left(1+\frac{\alpha}{C_{n}^{l} s^{n} U^{l}(s, \alpha)}\right)^{\frac{1}{k-l}}-1\right] d s,
\end{align*}
$$

where $\hat{a}=\left(C_{n}^{l} / C_{n}^{k}\right)^{\frac{1}{k-l}}$, and

c=\mu(\alpha)=b-\frac{\hat{a}}{2}+\hat{a} \int_{1}^{\infty} s\left[\left(1+\frac{\alpha}{C_{n}^{l} s^{n} U^{l}(s, \alpha)}\right)^{\frac{1}{k-l}}-1\right] d s \tag{2.14}
\end{equation*}
$$

Since by Lemma [2.2, we know that $U$ has a lower bound. So, for $n \geq 3$, the infinite integral in (2.14) is convergent. Let

From (2.12), $\alpha=r^{n}\left(C_{n}^{k} U^{k}-C_{n}^{l} U^{l}\right)$. By Lemma 2.2, $U^{k-l}>l C_{n}^{l} / k C_{n}^{k}$, so $\partial V / \partial \alpha>0$. Then $\mu$ is strictly increasing in $\alpha$. Based on (2.11) and (2.9), we know that for $r>1$,

Moreover, by Lemma 2.2, since $U^{k-l}>l C_{n}^{l} / k C_{n}^{k}$, then

If $k=n=m=3, l=1$, then the exterior Dirichlet problem (1.7), (1.8) becomes the problem of special Lagrangian equation

According to (2.7), the radially symmetric solution of the problem (2.15) and (2.16) satisfies

From Theorem 1.1. we can directly deduce
Corollary 2.4. The exterior Dirichlet problem (2.15), (2.16) has a unique locally convex function $u \in \Phi_{3}$ satisfying

u(x)=\frac{\sqrt{3}}{2}|x|^{2}+c+O\left(|x|^{-1}\right),|x| \rightarrow \infty
$$

if and only if $c \in\left[\mu\left(\alpha_{1}\right),+\infty\right)$, where

c=\mu(\alpha)=b-\frac{\sqrt{3}}{2}+\sqrt{3} \int_{1}^{\infty} s\left[\left(1+\frac{\alpha}{3 s^{2} \tilde{U}(s, \alpha)}\right)^{\frac{1}{2}}-1\right] d s \\
\alpha_{1}:=\sup _{r \geq 1} \tilde{U}_{r}^{-1}(1)
\end{gathered}
$$

and $\tilde{U}=\tilde{U}(r, \alpha)=\tilde{U}_{r}(\alpha)$ satisfies

\tilde{U}^{3}-3 r^{2} \tilde{U}-\alpha=0
$$

Proof of Theorem 1.2. Let $u(x)=u(|x|)=u(r)$ be the radially symmetric solution of the problem (1.12) and (1.13). Then

Since

r \sqrt{r^{2}+\rho}=r^{2}+\frac{\rho}{2}+O\left(r^{-2}\right), r \rightarrow \infty
$$

and

\ln \left(r+\sqrt{r^{2}+\rho}\right)=\ln r+\ln 2+O\left(r^{-2}\right), r \rightarrow \infty
$$

then

u(r)=r^{2}+\frac{\rho}{2} \ln r+\nu(\rho)+O\left(r^{-2}\right)
$$

where

\nu(\rho)=b-\frac{1}{2}+\frac{\rho}{4}+\frac{\rho}{2} \ln 2-\frac{1}{2}[\sqrt{1+\rho}+\rho \ln (1+\sqrt{1+\rho})] .
$$

Theorem 1.2 is proved.
Similar to [32], $\nu(\rho)$ increases in $[-1,0]$ and decreases in $[0,+\infty)$. So

\nu(\rho) \leq \nu(0)=b-1, \rho \geq-1
$$

Corollary 2.5. The exterior Dirichlet problem (1.12), (1.13) has a unique solution $u \in \Phi_{2}$ satisfying (1.14) if and only if $c \leq b-1$.

Remark 2.1. If $k=n=2, l=0$, we can refer to Theorem 2 in 32].

## 3 Generalized symmetric functions, subsolutions and supersolutions

In this section, we will construct a family of generalized symmetric smooth subsolutions and supersolutions of (1.1). Now, we first give the definitions of generalized symmetric functions and generalized symmetric solutions, see [6].

Definition 3.1. Let the diagonal matrix $A=\operatorname{diag}\left(a_{1}, \ldots, a_{n}\right)$, a function $u$ is called a generalized symmetric function with respect to $A$ if $u$ is a function of

$$
r:=r_{A}(x):=\sqrt{x^{T} A x}=\left(\sum_{i=1}^{n} a_{i} x_{i}^{2}\right)^{\frac{1}{2}} .
$$

If $u$ is both a generalized symmetric function with respect to $A$ and a subsolution (supersolution, solution) of (1.1), then we say that $u$ is a generalized symmetric subsolution (supersolution, solution) of (1.1).

Since

$$
r^{2}=x^{T} A x=\sum_{i=1}^{n} a_{i} x_{i}^{2},
$$

then

$$
2 r \partial_{x_{i}} r=\partial_{x_{i}}\left(r^{2}\right)=2 a_{i} x_{i} \text { and } \partial_{x_{i}} r=\frac{a_{i} x_{i}}{r} .
$$

So $\tilde{\Phi}(x):=\tilde{\phi}(r)$ with $\tilde{\phi} \in C^{2}[0,+\infty)$ satisfies that

$$
\begin{gathered}
\partial_{x_{i}} \tilde{\Phi}(x)=\tilde{\phi}^{\prime}(r) \partial_{x_{i}} r=\frac{\tilde{\phi}^{\prime}(r)}{r} a_{i} x_{i}, \\
\partial_{x_{i} x_{j}} \tilde{\Phi}(x)=\frac{\tilde{\phi^{\prime}}(r)}{r} a_{i} \delta_{i j}+\frac{\tilde{\phi}^{\prime \prime}(r)-\frac{\tilde{\sigma}^{\prime}(r)}{r}}{r^{2}}\left(a_{i} x_{i}\right)\left(a_{j} x_{j}\right) \\
=\tilde{h}(r) a_{i} \delta_{i j}+\frac{\tilde{h}^{\prime}(r)}{r}\left(a_{i} x_{i}\right)\left(a_{j} x_{j}\right),
\end{gathered}
$$

where $\tilde{h}(r)=\tilde{\phi}^{\prime}(r) / r$. Consequently,

D^{2} \tilde{\Phi}=\left(\tilde{h}(r) a_{i} \delta_{i j}+\frac{\tilde{h}^{\prime}(r)}{r}\left(a_{i} x_{i}\right)\left(a_{j} x_{j}\right)\right)_{n \times n} .
$$

Therefore by Lemma 5.2, we can get that

& S_{k}\left(D^{2} \tilde{\Phi}\right)=\sigma_{k}\left(\lambda\left(D^{2} \tilde{\Phi}\right)\right) \\
= & \sigma_{k}(a) \tilde{h}(r)^{k}+\frac{\tilde{h}^{\prime}(r)}{r} \tilde{h}(r)^{k-1} \sum_{i=1}^{n} \sigma_{k-1 ; i}(a) a_{i}^{2} x_{i}^{2} . \tag{3.1}
\end{align*}
$$

In this paper, we always assume that $A$ is diagonal but not $A=\hat{a} I, \hat{a}=\left(C_{n}^{l} / C_{n}^{k}\right)^{\frac{1}{k-l}}$ because the Hessian quotient equation is not invariant under affine transformation. Detailed arguments for this can be referred to [6]. Let the matrix $A=\operatorname{diag}\left(a_{1}, \ldots, a_{n}\right)$ and the vector $a=\left(a_{1}, \ldots, a_{n}\right)$. If $A \in \mathcal{A}_{k, l}$, then we have $a_{i}>0(i=1, \ldots, n)$ and $\sigma_{k}(a) / \sigma_{l}(a)=1$. For any fixed $t$-tuple $\left\{i_{1}, \ldots, i_{t}\right\} \subset\{1, \ldots, n\}, 1 \leq t \leq n-k$, let

Let $a=\left(a_{1}, \ldots, a_{n}\right) \in \mathbb{R}^{n} \backslash\{0\}$, then by the definitions of $\Lambda_{k}$ and $\bar{t}_{k}$,

\end{aligned}

and

To construct the subsolutions of (1.1), we need to seek the solutions or subsolutions in $\Gamma_{k}$ with appropriate properties of

These solutions or subsolutions are apparently subsolutions of (1.1). However, from the following Proposition 3.2, we can get that there does not exist generalized symmetric solution of (1.1) for $1 \leq k \leq n-1$ unless $A=\hat{a} I$.

Proposition 3.2. Let $A=\operatorname{diag}\left(a_{1}, \ldots, a_{n}\right) \in \mathcal{A}_{k, l}, 0 \leq l<k \leq n$, and $0<r_{1}<r_{2}<\infty$. If there exists a function $G \in C^{2}\left(r_{1}, r_{2}\right)$ such that $T(x)=G(r)=G\left(\sqrt{x^{T} A x}\right)$ is a generalized symmetric solution of (3.5), then

(i) $\bar{g}^{\frac{1}{k-l}}(r) \leq h(r, \delta) \leq \delta$, and $\partial_{r} h(r, \delta) \leq 0$.
(ii) $h(r, \delta)$ is continuous and strictly increasing in $\delta$ and

Then assertion (i) of the lemma is proved. In addition, the existence of solution can be proved by the following.

By Lemma 3.4, we know that $W_{\delta}$ is a smooth $k$-convex subsolution of (1.1), that is

$$
\begin{equation*}
\frac{S_{k}\left(D^{2} W_{\delta}(x)\right)}{S_{l}\left(D^{2} W_{\delta}(x)\right)} \geq g(x) \text { in } \mathbb{R}^{n} \backslash \bar{\Omega} \tag{4.3}
\end{equation*}
$$

Since $\Omega \subset \subset E_{r_{0}}$, then we conclude that

$$
\begin{equation*}
W_{\delta} \leq \zeta_{1} \leq \rho_{\xi} \leq \varphi \text { on } \overline{E_{r_{0}}} \backslash \Omega \tag{4.4}
\end{equation*}
$$

In addition, by Lemma 3.3, we deduce that $W_{\delta}(x)$ is strictly increasing in $\delta$ and

$$
\lim _{\delta \rightarrow+\infty} W_{\delta}(x)=+\infty \text { for any } r_{A}(x)>r_{0}
$$

In light of (3.36), we have that as $|x| \rightarrow+\infty$,

$$
W_{\delta}(x)=\left\{\begin{array}{l}
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+\mu(\delta)+O\left(|x|^{2-\min \left\{\beta, \frac{k-l}{\tau_{k}-t_{l}}\right\}}\right), \text { if } \beta \neq \frac{k-l}{\overline{t_{k}-t_{l}}}, \\
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+\mu(\delta)+O\left(|x|^{2-\frac{k-l}{t_{k}-t_{l}}} \ln |x|\right), \text { if } \beta=\frac{k-l}{\overline{t_{k}-\underline{t}_{l}}}
\end{array}\right.
$$

where

$$
\mu(\delta):=\zeta_{1}-\int_{0}^{r_{0}} \theta h_{0}(\theta) d \theta+\int_{r_{0}}^{+\infty} \theta\left[h(\theta)-h_{0}(\theta)\right] d \theta
$$

and we use the fact that $x^{T} A x=O\left(|x|^{2}\right)$ as $|x| \rightarrow+\infty$.
Define

$$
\bar{u}_{\zeta_{2}, \tau}(x):=\zeta_{2}+\int_{1}^{r_{A}(x)} \theta H(\theta, \tau) d \theta, \forall x \in \mathbb{R}^{n} \backslash \Omega
$$

where $\zeta_{2}$ is any constant and $\underline{\underline{t}_{k}} \underline{g}(1)<\tau^{k-l}<\underline{g}(1)$. Then by (3.44), we know that

$$
\begin{equation*}
\frac{S_{k}\left(D^{2} \bar{u}_{\zeta_{2}, \tau}\right)}{S_{l}\left(D^{2} \bar{u}_{\zeta_{2}, \tau}\right)} \leq g(x), \forall x \in \mathbb{R}^{n} \backslash \Omega \tag{4.5}
\end{equation*}
$$

and by (3.43), as $|x| \rightarrow+\infty$,

$$
\bar{u}_{\zeta_{2}, \tau}(x)=\left\{\begin{array}{l}
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+\nu_{\zeta_{2}}(\tau)+O\left(|x|^{2-\min \left\{\beta, \frac{k-l}{t_{k}-\underline{t}_{l}}\right\}}\right), \text { if } \beta \neq \frac{k-l}{\overline{t_{k}}-\underline{t}_{l}}, \\
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+\nu_{\zeta_{2}}(\tau)+O\left(|x|^{2-\frac{k-l}{t_{k}-\underline{L}_{l}}} \ln |x|\right), \text { if } \beta=\frac{k-l}{\overline{t_{k}}-\underline{t}_{l}}
\end{array}\right.
$$

where

$$
\nu_{\zeta_{2}}(\tau):=\zeta_{2}-\int_{0}^{1} \theta h_{0}(\theta) d \theta+\int_{1}^{+\infty} \theta\left[H(\theta, \tau)-h_{0}(\theta)\right] d \theta
$$

is convergent.
Since $W_{\delta}$ is strictly increasing in $\delta$, then for $R_{0}>r_{0}$, there exists some $\hat{\delta}>\sup _{r \in[1,+\infty)} \bar{g}^{\frac{1}{k-l}}(r)$ such that

$$
\min _{\partial E_{R_{0}}} W_{\hat{\delta}}>\max _{\partial E_{R_{0}}} \varphi
$$

Therefore we have that

$$
\begin{equation*}
W_{\hat{\delta}}>\varphi \text { on } \partial E_{R_{0}} \tag{4.6}
\end{equation*}
$$

Clearly, $\mu(\delta)$ is strictly increasing in $\delta$. By (3.37), we can know that

$$
\lim _{\delta \rightarrow+\infty} \mu(\delta)=+\infty
$$

Let

$$
\hat{c}=\hat{c}(\tau)=\sup _{E_{R_{0} \backslash \Omega}} \varphi-\int_{0}^{1} \theta h_{0}(\theta) d \theta+\int_{1}^{+\infty} \theta\left[H(\theta)-h_{0}(\theta)\right] d \theta
$$

and

$$
\tilde{c}:=\max \left\{\hat{c}, \mu(\hat{\delta}), \max _{\substack{\xi \in \partial \Omega \\ x \in E_{R_{0}} \backslash \Omega}} \rho_{\xi}(x)\right\} .
$$

So for any

$$
\begin{equation*}
c>\tilde{c} \tag{4.7}
\end{equation*}
$$

there is a unique $\delta(c)$ such that $\mu(\delta(c))=c$. Consequently, we get that as $|x| \rightarrow+\infty$,

$$
W_{\delta(c)}(x)=\left\{\begin{array}{l}
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+c+O\left(|x|^{2-\min \left\{\beta, \frac{k-l}{\bar{t}_{k}-t_{l}}\right\}}\right), \text { if } \beta \neq \frac{k-l}{\overline{t_{k}}-\underline{t_{l}}},  \tag{4.8}\\
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+c+O\left(|x|^{2-\frac{k-l}{t_{k}-\underline{t}_{l}}} \ln |x|\right), \text { if } \beta=\frac{k-l}{\overline{t_{k}-\underline{t}_{l}}},
\end{array}\right.
$$

and

$$
\delta(c)=\mu^{-1}(c)>\mu^{-1}(\mu(\hat{\delta}))=\hat{\delta}
$$

Due to the monotonicity of $W_{\delta}$ in $\delta$ and (4.6), we conclude that

$$
\begin{equation*}
W_{\delta(c)} \geq W_{\hat{\delta}}>\varphi \text { on } \partial E_{R_{0}} . \tag{4.9}
\end{equation*}
$$

For the constant $c$ in (4.7), set $\nu_{\zeta_{2}}(\tau)=c$, then as $|x| \rightarrow+\infty$,

$$
\bar{u}_{\zeta_{2}, \tau}(x)=\left\{\begin{array}{l}
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+c+O\left(|x|^{2-\min \left\{\beta, \frac{k-l}{\bar{t}_{k}-\underline{t}_{l}}\right\}}\right), \text { if } \beta \neq \frac{k-l}{\bar{t}_{k}-\underline{t}_{l}},  \tag{4.10}\\
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+c+O\left(|x|^{2-\frac{k-l}{t_{k}-t_{l}}} \ln |x|\right), \text { if } \beta=\frac{k-l}{\bar{t}_{k}-\underline{t}_{l}}
\end{array}\right.
$$

and

$$
\begin{align*}
\zeta_{2} & :=\zeta_{2}(\tau) \\
& :=c+\int_{0}^{1} \theta h_{0}(\theta) d \theta-\int_{1}^{+\infty} \theta\left[H(\theta, \tau)-h_{0}(\theta)\right] d \theta \tag{4.11}
\end{align*}
$$

Define

$$
\underline{u}(x):= \begin{cases}\max \left\{W_{\delta(c)}(x), \varphi(x)\right\}, & x \in E_{R_{0}} \backslash \Omega \\ W_{\delta(c)}(x), & x \in \mathbb{R}^{n} \backslash E_{R_{0}}\end{cases}
$$

Then by (4.9), we can get that $\underline{u} \in C^{0}\left(\mathbb{R}^{n} \backslash \Omega\right)$ and by (4.1), (4.3) and Lemma 5.4, we know that

$$
\frac{S_{k}\left(D^{2} \underline{u}(x)\right)}{S_{l}\left(D^{2} \underline{u}(x)\right)} \geq g(x) \text { in } \mathbb{R}^{n} \backslash \bar{\Omega}
$$

In light of (4.4) and (4.2), we obtain that

$$
\underline{u}=\phi \quad \text { on } \partial \Omega .
$$

In addition, from (4.8), we have that as $|x| \rightarrow+\infty, \underline{u}(x)$ satisfies the asymptotic behavior (4.10).

By the definition of $\tilde{c}, \bar{u}_{\zeta_{2}}(x)$ and $\varphi(x)$, we have that

$$
\begin{equation*}
\bar{u}_{\zeta_{2}, \tau}(x) \geq \zeta_{2} \geq \varphi(x), \quad x \in E_{R_{0}} \backslash \Omega \tag{4.12}
\end{equation*}
$$

Again by (4.4),

$$
W_{\delta(c)}(x) \leq \varphi(x) \leq \bar{u}_{\zeta_{2}, \tau}(x), \quad x \in \partial \Omega .
$$

Due to (4.3), (4.5), (4.8), (4.10) and the comparison principle, we conclude that

$$
\begin{equation*}
W_{\delta(c)}(x) \leq \bar{u}_{\zeta_{2}, \tau}(x), \quad x \in \mathbb{R}^{n} \backslash \Omega . \tag{4.13}
\end{equation*}
$$

Denote

$$
\bar{u}(x):=\bar{u}_{\zeta 2, \tau}(x), \quad x \in \mathbb{R}^{n} \backslash \Omega .
$$

In light of (4.12), (4.13) and the definition of $\underline{u}$, we know that

$$
\underline{u}(x) \leq \bar{u}(x), \quad x \in \mathbb{R}^{n} \backslash \Omega .
$$

For any $c>\tilde{c}$, let $\mathcal{S}_{c}$ denote the set of $\varrho \in C^{0}\left(\mathbb{R}^{n} \backslash \Omega\right)$ which are viscosity subsolutions of (1.1) and (1.2) satisfying $\varrho=\phi$ on $\partial \Omega$ and $\varrho \leq \bar{u}$ in $\mathbb{R}^{n} \backslash \Omega$. Apparently, $\underline{u} \in \mathcal{S}_{c}$ and so $\mathcal{S}_{c} \neq \emptyset$. Define

$$
u(x):=\sup \left\{\varrho(x) \mid \varrho \in \mathcal{S}_{c}\right\}, \quad x \in \mathbb{R}^{n} \backslash \Omega .
$$

Then

$$
\underline{u} \leq u \leq \bar{u} \text { in } \mathbb{R}^{n} \backslash \Omega
$$

Hence by the asymptotic behavior of $\underline{u}$ and $\bar{u}$, we have that as $|x| \rightarrow+\infty$,

$$
u(x)=\left\{\begin{array}{l}
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta) d \theta+c+O\left(|x|^{2-\min \left\{\beta, \frac{k-l}{\bar{t}_{k}-\underline{t}_{l}}\right\}}\right), \text { if } \beta \neq \frac{k-l}{\overline{t_{k}}-\underline{t}_{l}}, \\
\int_{0}^{r_{A}(x)} \theta h_{0}(\theta)+c+O\left(|x|^{\left.2-\frac{k-l}{t_{k}-\frac{t_{l}}{l}} \ln |x|\right), \text { if } \beta=\frac{k-l}{\overline{t_{k}-\underline{t}_{l}}} .}\right. \text {, }
\end{array}\right.
$$

Next, we will show that $u=\phi$ on $\partial \Omega$. On the one hand, since $\underline{u}=\phi$ on $\partial \Omega$, then

$$
\liminf _{x \rightarrow \xi} u(x) \geq \lim _{x \rightarrow \xi} u(x)=\phi(\xi), \quad \xi \in \partial \Omega .
$$

On the other hand, we will prove that

$$
\limsup _{x \rightarrow \xi} u(x) \leq \phi(\xi), \quad \xi \in \partial \Omega
$$

Let $\vartheta \in C^{2}\left(\overline{E_{R_{0}} \backslash \Omega}\right)$ satisfy

$$
\begin{cases}\Delta \vartheta=0, & \text { in } E_{R_{0}} \backslash \bar{\Omega}, \\ \vartheta=\phi, & \text { on } \partial \Omega, \\ \vartheta=\max _{\partial E_{R_{0}}} \bar{u}, & \text { on } \partial E_{R_{0}} .\end{cases}
$$

Due to Newtonian inequalities, for any $\varrho \in \mathcal{S}_{c}$, we have $\Delta \varrho \geq 0$ in the viscosity sense. Moreover, $\varrho \leq \vartheta$ on $\partial\left(E_{R_{0}} \backslash \Omega\right)$. Then by the comparison principle, we deduce that

$$
\varrho \leq \vartheta \text { in } E_{R_{0}} \backslash \Omega .
$$

So

$$
u \leq \vartheta \text { in } E_{R_{0}} \backslash \Omega
$$

Therefore

$$
\limsup _{x \rightarrow \xi} u(x) \leq \lim _{x \rightarrow \xi} \vartheta(x)=\phi(\xi) \text { for } \xi \in \partial \Omega
$$

In the end, we prove that $u \in C^{0}\left(\mathbb{R}^{n} \backslash \Omega\right)$ is a viscosity solution to (1.1). For any $x \in \mathbb{R}^{n} \backslash \bar{\Omega}$, choose some $\varepsilon>0$ such that $B_{\varepsilon}=B_{\varepsilon}(x) \subset \mathbb{R}^{n} \backslash \bar{\Omega}$. From Lemma 5.3, the Dirichlet problem

$$
\begin{cases}\frac{S_{k}\left(D^{2} \tilde{u}(y)\right)}{S_{l}\left(D^{2} \tilde{u}(y)\right)}=g(y), & y \in B_{\varepsilon}  \tag{4.14}\\ \tilde{u}=u, & y \in \partial B_{\varepsilon}\end{cases}
$$

has a unique $k$-convex viscosity solution $\tilde{u} \in C^{0}\left(\overline{B_{\varepsilon}}\right)$. By the comparison principle, $u \leq \tilde{u}$ in $B_{\varepsilon}$. Define

$$
\tilde{w}(y)= \begin{cases}\tilde{u}(y), & y \in B_{\varepsilon} \\ u(y), & y \in\left(\mathbb{R}^{n} \backslash \Omega\right) \backslash B_{\varepsilon}\end{cases}
$$

Then $\tilde{w} \in \mathcal{S}_{c}$. Indeed, from the comparison principle, $\tilde{u}(y) \leq \bar{u}(y)$ in $\overline{B_{\varepsilon}}$ and so $\tilde{w}(y) \leq \bar{u}(y)$ in $\mathbb{R}^{n} \backslash B_{\varepsilon}$. By Lemma 5.4, we have $\frac{S_{k}\left(D^{2} \tilde{w}(y)\right)}{S_{l}\left(D^{2} \tilde{w}(y)\right)} \geq g(y)$ in $\mathbb{R}^{n} \backslash \bar{\Omega}$. Therefore $\tilde{w} \in \mathcal{S}_{c}$. And thus by the definition of $u, u(y) \geq \tilde{w}(y)$ in $\mathbb{R}^{n} \backslash \Omega$ and so $u(y) \geq \tilde{u}(y)$ in $B_{\varepsilon}$. Hence

$$
u(y) \equiv \tilde{u}(y), \quad \forall y \in B_{\varepsilon} .
$$

But $\tilde{u}$ satisfies (4.14), then we have in the viscosity sense,

$$
\frac{S_{k}\left(D^{2} u(y)\right)}{S_{l}\left(D^{2} u(y)\right)}=g(y), \forall y \in B_{\varepsilon}
$$

In particular, we have

$$
\frac{S_{k}\left(D^{2} u(x)\right)}{S_{l}\left(D^{2} u(x)\right)}=g(x) .
$$

Because $x$ is arbitrary, we know that $u$ is a viscosity solution of (1.1). Theorem 1.3 is proved.

## 5 Appendix

Lemma 5.1. Let $2 \leq k \leq m \leq n, n \geq 3,0 \leq l<k$,

$$
\alpha>\left(\frac{l C_{n}^{l}}{k C_{n}^{k}}\right)^{\frac{l}{k-l}}\left(\frac{l}{k}-1\right) C_{n}^{l}
$$

and

$$
\begin{equation*}
\left(\frac{l C_{n}^{l}}{k C_{n}^{k}}\right)^{\frac{1}{k-l}}<U<\gamma_{m} \tag{5.1}
\end{equation*}
$$

where $\gamma_{m}$ is the same as (2.2). Then

$$
\begin{equation*}
U^{k}-\frac{C_{n}^{l}}{C_{n}^{k}} U^{l}-\frac{\alpha}{C_{n}^{k} r^{n}}=0, r>1 \tag{5.2}
\end{equation*}
$$

has a unique solution $U=U(r, \alpha)$.
Proof. Let

$$
F(U)=U^{k}-\frac{C_{n}^{l}}{C_{n}^{k}} U^{l}-\frac{\alpha}{C_{n}^{k} r^{n}}, r>1
$$

Then

$$
F^{\prime}(U)=k U^{k-1}-l \frac{C_{n}^{l}}{C_{n}^{k}} U^{l-1}>0
$$

So $F(u)$ is strictly increasing in $U$. Moreover,

$$
F\left(\left(\frac{l C_{n}^{l}}{k C_{n}^{k}}\right)^{\frac{1}{k-l}}\right)<0
$$

and $F\left(\gamma_{m}\right)>0$. Hence (5.2) has a unique solution.
Lemma 5.2. If $M=\left(p_{i} \delta_{i j}+s q_{i} q_{j}\right)_{n \times n}$ with $p, q \in \mathbb{R}^{n}$ and $s \in \mathbb{R}$, then

$$
\sigma_{k}(\lambda(M))=\sigma_{k}(p)+s \sum_{i=1}^{n} \sigma_{k-1 ; i}(p) q_{i}^{2}, k=1, \ldots, n
$$

Proof. See [6].
Lemma 5.3. Let $B$ be a ball in $\mathbb{R}^{n}$ and $f \in C^{0}(\bar{B})$ be nonnegative. Suppose $\underline{u} \in C^{0}(\bar{B})$ satisfies in the viscosity sense $S_{k}\left(D^{2} \underline{u}\right) \geq f(x)$ in $B$. Then the Dirichlet problem

$$
\begin{aligned}
\frac{S_{k}\left(D^{2} u\right)}{S_{l}\left(D^{2} u\right)}=f(x), & x \in B \\
u=\underline{u}(x), & x \in \partial B
\end{aligned}
$$

has a unique $k$-convex viscosity solution $u \in C^{0}(\bar{B})$.
Proof. See [15].
Lemma 5.4. Let $D$ be a domain in $\mathbb{R}^{n}$ and $f \in C^{0}\left(\mathbb{R}^{n}\right)$ be nonnegative. Assume $k-$ convex functions $v \in C^{0}(\bar{D}), u \in C^{0}\left(\mathbb{R}^{n}\right)$ satisfy respectively

$$
\begin{aligned}
& \frac{S_{k}\left(D^{2} v\right)}{S_{l}\left(D^{2} v\right)} \geq f(x), x \in D \\
& \frac{S_{k}\left(D^{2} u\right)}{S_{l}\left(D^{2} u\right)} \geq f(x), x \in \mathbb{R}^{n} .
\end{aligned}
$$

Moreover,

$$
\begin{gathered}
u \leq v, x \in \bar{D} \\
u=v, x \in \partial D .
\end{gathered}
$$

Set

$$
w(x)=\left\{\begin{array}{l}
v(x), x \in D \\
u(x), x \in \mathbb{R}^{n} \backslash D .
\end{array}\right.
$$

Then $w \in C^{0}\left(\mathbb{R}^{n}\right)$ is a $k$-convex function and satisfies in the viscosity sense

$$
\frac{S_{k}\left(D^{2} w\right)}{S_{l}\left(D^{2} w\right)} \geq f(x), x \in \mathbb{R}^{n}
$$

Proof. See [15].
