# HAMILTONIAN MODEL FOR COUPLED SURFACE AND INTERNAL WAVES OVER CURRENTS AND UNEVEN BOTTOM

ABSTRACT. A Hamiltonian model for the propagation of internal water waves interacting with surface waves, a current and an uneven bottom is examined. Using the so-called Dirichlet-Neumann operators, the water wave system is expressed in the Hamiltonian form, and thus the motions of the internal waves and surface waves are determined by the Hamiltonian formulation. Choosing an appropriate scaling of the variables and employing the Hamiltonian perturbation theory from Hamiltonian formulation of the dynamics, we derive a KdV-type equation with variable coefficients depending on the bottom topography to describe the internal waves.

*Keywords*: Internal waves, Hamiltonian perturbation theory, Dirichlet-Neumann operators, equatorial undercurrent, Korteweg-de Vries equation. *AMS Subject Classification* (2010): 76B55; 35Q35; 37K05; 37N10.

#### 1. INTRODUCTION

Consideration in this paper is a water wave system describing the two-dimensional nonlinear interaction between coupled surface waves, internal waves, and an underlying current with piecewise constant vorticity, in a two-layered fluid overlying an uneven bottom. Internal waves can occur in the interior stratified region of strong temperature or density gradients (thermocline or pycnocline) in the sea. On account of the physical significance of the internal waves in the analysis of the energy revenue and expenditure and the energy balance in the ocean dynamics and their significant applications in the exploitation and protection of the ocean environment and resources, there are by now numerous studies on internal waves (e.g. [1, 2, 3, 4]). The consideration of current to our water wave system is due to its significant mathematical and physical features and complexity in geophysical dynamics. Among many interested groups, the interaction of nonlinear waves and currents is of particular interest to oceanographers and climatologists due to its applications for the prediction of tsunami, rogue waves, etc. [5, 10, 11, 12]. The problem of waves with a variable bottom can be referred to the pioneering work of Johnson [30, 31], where a perturbed Korteweg-de Vries (KdV) equation [32] is derived as a model for surface waves from Euler's governing equations for irrotational inviscid fluid. Given all the above consideration, a system of coupled surface waves, internal waves, with depth-dependent currents in each domain and over an uneven bottom is of particular interest both mathematically and physically.

It is known that linear approximations are the usual means to make predictions of water-wave propagation in oceanography. Although this approach is successful in many instances, for complex flow patterns an adequate description of the phenomenon can not neglect nonlinear effects. Motivated by the recent works [7, 29], we develop a nonlinear approach that captures the main features of the dynamics under consideration by adopting the Hamiltonian framework to manage our system, which is also amenable to approximations in shallow-water (long wave) regime. The Hamiltonian perspective to deal with water waves can date back to Zakharov's pioneering work [36], where he found that the governing equations for fluids of inviscidity, irrotationality, incompressibility and uniformity of density form a canonical Hamiltonian formulation. This opened a novel way to explore the Hamiltonian canonical structure of the problems on water waves. Subsequently, this approach has been extended successfully to deal with two-layer flows [20, 21, 25, 33]. The Hamiltonian perspective to handle models with finite depth and shear with constant vorticity can be referred to [9, 35], and for wave-current interactions in a two-layer system we refer to [6, 7, 8, 13, 14, 15, 16, 17, 24, 27, 28, 34] and the references therein. Meanwhile, the Hamiltonian approach to the wave motion by the inclusion of variations of the bottom surface can be referred to the recent works of [18, 19, 22, 26] for single layer flows and of [29, 37] for two-layer fluids. The purpose of the present paper is to extend the results of Refs. [7, 29] to the cases of coupled surface and internal waves with variable bottom.

To make it convenient to analyse, we first determine the formulation of the problem in terms of Hamiltonian with the aid of the Dirichlet-Neumann operators and express the system in terms of canonical wave-related variables. The appearance of the bottom function complicates the obtained Hamiltonian structure, which is a starting point for the derivation of simpler models. Using the Hamiltonian perturbation theory [21, 22, 23] with a specific scaling of the variables inspired by [7], we develop a systematic perturbation analysis on the obtained Hamiltonian formulation to obtain the surface and internal wave motion equations in the shallow-water (long wave) regime, where the intractable Taylor expansions of the Dirichlet-Neumann operators, simpler ones compared to [17], are the core. These simplified equations enable an in-depth study of the coupling between the surface and internal waves, and how both these wave systems interact with the background current and variable bottom.

Furthermore, we derive the KdV-type equation for the internal waves. The obtained effective KdV-type equations with variable coefficients depending on the bottom topography recover the

corresponding ones in [7] for fluid without the consideration of bottom variations and the dispersion relation recovers the results in [18] for single-layer system. Our methods for a system with both surface and internal waves over uneven bottom answers partially the problems proposed in [18] and we hope the study being undertaken enable an in-depth study in these circumstances.

The remainder of this paper is organized as follows. In Section 2, we present the flows we study and give the governing equations for the problem. In Section 3, we propose the Hamiltonian formulation of the system understudied and a systematic long-wave perturbation analysis by the Hamiltonian perturbation theory is given in Section 4. Section 5 focuses on the derivation of the KdV-type equation describing the evolution of the internal waves.

#### 2. EQUATIONS OF MOTION

2.1. System set-up. The fluid system consists of the point (x, y) such that  $B(x) < y < h_2$ , and it is divided into two regions

Here  $B(x) := -h_1 + \beta(x)$  is the stationary impermeable bottom for  $-h_1$  is the average bottom level and  $\beta(x)$  is the bottom elevation function,  $\eta(x,t)$  denotes the interface elevation and the undisturbed interface is chosen at y = 0,  $h_2 + \eta_2(x,t)$  is a surface wave around the average level  $y = h_2$ . The subscript notations 1, 2 refer to values in  $\Omega_1$  and  $\Omega_2$  respectively and  $i = \{1; 2\}$  for values in both domains. The average values for the

interface elevation, surface elevation and the bottom level are assumed to be zero,

Suppose that the two regions are occupied by two homogeneous, inviscid and incompressible fluids with density  $\rho_2$  of the upper fluid and  $\rho_1$  of the lower fluid. The stable configuration is given by the immiscibility condition  $\rho_1 > \rho_2$ .

We define the stream functions,  $\psi_i$ , as

and velocity potentials,  $\varphi_i$ , as

where  $\mathbf{u}_i = (u_i, v_i, 0)$  denote the velocity fields and  $\gamma_i = -v_{i,x} + u_{i,y}$  represent the constant vorticities. This setting allows for modelling of an undercurrent, such as the Equatorial Undercurrent, and (2.3) can be written as [6]

where U(y) is the current profile defined by

Here the tilde notation is introduced to separate out the wave-only components,  $\kappa$  is a constant component of the current,  $U_1(y)$  is a continuous function such that  $U_1(-m) = 0$ ,  $U_1(-l) = -l\gamma_1 + \kappa$  and the current has a jump when  $\eta \neq 0$  as illustrated on Fig. 1 for the situation of an undisturbed fluid when  $\eta \equiv 0$ .

We make the assumption that, for any y and t, the functions  $\eta(x,t)$ ,  $\eta_2(x,t)$ ,  $\tilde{\varphi}_i(x,y,t)$ and  $\beta(x)$  are in the Schwartz class  $\mathscr{S}(\mathbb{R})$  with respect to x, where the Schwartz class  $\mathscr{S}(\mathbb{R})$  denotes the smooth, rapidly decreasing functional space. We make the assumptions

### 2.2. Governing equations. The Euler equations for the two layers are

$$\mathbf{u}_{i,t} + (\mathbf{u}_i \cdot \nabla) \,\mathbf{u}_i = -\frac{1}{\rho_i} \nabla p_i + \mathbf{g} + \mathbf{F}_i, \qquad (2.9)$$

where  $\mathbf{F}_i = 2\omega \nabla \psi_i$  are the Coriolis forces per unit mass at the equator with  $\omega$  being the rotational speed of the Earth,  $\mathbf{g} = (0, 0, -g)$  with g being the gravitational acceleration, and  $p_i$  are the corresponding pressures. The equation of mass conservation for incompressible fluid is given by

The kinematic boundary condition at the interface is given as

which, when using (2.4) of the velocity potentials, can be expressed as

where the subscript notation b refers to values at the bottom, and, additionally, the kinematic boundary condition at the top  $y = h_2 + \eta_2$  is given by

Moreover, considering the dynamic boundary condition at the interface  $p_1 = p_2$ , one can obtain the Bernoulli condition [28]

The dynamic boundary condition at the surface  $p_2 = Const.$  yields that [28]

where the subscript s refers to values at the surface  $y = h_2 + \eta_2$  and  $\chi_2 = \psi_2(x, h_2 + \eta_2, t)$ .

### 3. HAMILTONIAN FORMULATION

3.1. **Hamiltonian formulation by means of the Dirichlet-Neumann operator.** Following the idea in [7, 19, 22, 23], we present the Hamiltonian formulation for (2.9)-(2.14) in this section. The Hamiltonian of the general non-flat bottom system is given by

which is the sum of the kinetic and potential energies. The notation  $\mathfrak{h}_0$  is a constant Hamiltonian density. By (2.4) of the relationship between  $\mathbf{u}_i$  and  $\tilde{\varphi}_i$ , we obtain

By the definition of U(y) in (2.5), we split the current into 4 layers to reach that

In order to obtain the Hamiltonian in terms of variables defined at the interface and surface, we introduce the notations for the velocity potentials values at the interface and surface as

We need also the operator

$$\mathscr{B}(B,\eta,\eta_2) := \rho_1 G_{11} + \rho_2 G_1, \tag{3.18}$$

and the potentials  $\phi_1,\,\phi_2$  and  $\phi_3$  can be solved as

The third term of (3.4) is zero due to the fact that  $\int_{\mathbb{R}} \tilde{\varphi}_{1,x} dx = 0$ . Now we turn to the fourth and fifth terms of (3.4). As

## 4. HAMILTONIAN PERTURBATION ANALYSIS

4.1. Approximation of the Dirichlet-Neumann Operators. The expansion for the DN operators  $G_1(\beta, \eta)$  is [22]

4.2. Scales and approximations. We introduce the small parameters  $\varepsilon \ll 1$  and  $\delta \ll 1$  and consider the shallow-water (long wave) regime defined by the spatial scale [7]

where  $\eta$  and q, as well as  $\eta_2$  and  $q_2$  are considered of the same order of magnitude, with the surface wave having a smaller amplitude than the internal wave and the quantities  $x', t, \eta', q', \eta'_2, q'_2$  and  $\beta'$  are all of order  $\mathcal{O}(1)$ . The interpretation of the specific scaling (4.10) can be referred to [7]. The scaling (4.9)-(4.10) transforms the system (3.43) into the Hamiltonian system

#### 5. KDV-TYPE EQUATION DESCRIBING THE EVOLUTION OF THE INTERNAL WAVES

We truncate the Hamiltonian (3.27) at  $\mathcal{O}(\varepsilon^6)$  and use (4.11) to reach that the canonical equations for the variables related to the free surface are linear

$$\eta_{2,t}' = -\partial_{x'} \left[ \delta \left( \gamma_2 h_2 + \kappa \right) \eta_2' + \frac{b'}{\rho_1} \left( q' - \frac{\Gamma}{2} \eta' \right) + \delta \left( \frac{b'}{\rho_1} + \frac{h_2}{\rho_2} \right) \left( q_2' - \frac{\Gamma_2'}{2} \eta_2' \right) \right]$$

$$q_{2,t}' = -\partial_{x'} \left[ \delta \left( \gamma_2 h_2 + \kappa \right) q_2' - \delta \frac{\Gamma_2}{2} \left( \frac{b'}{\rho_1} + \frac{h_2}{\rho_2} \right) \left( q_2' - \frac{\Gamma_2}{2} \eta_2' \right) + \delta \rho_2 \left( g - 2\omega \left( \gamma_2 h_2 + \kappa \right) \right) \eta_2' - \frac{\Gamma_2}{2} \frac{b'}{\rho_1} \left( q' - \frac{\Gamma}{2} \eta' \right) \right],$$

and those for the variables at the internal waves are nonlinear

$$\eta'_{t} = -\partial_{x'} \left[ \kappa \eta' + \frac{b'}{\rho_{1}} \left( q' - \frac{\Gamma}{2} \eta' + \delta \left( q'_{2} - \frac{\Gamma_{2}}{2} \eta'_{2} \right) \right) + \varepsilon^{2} A_{2} \left( q'_{x'x'} - \frac{\Gamma}{2} \eta'_{x'x'} \right) + \varepsilon^{2} \frac{1}{\rho_{1}} q' \eta' + \varepsilon^{2} \left( \frac{\gamma_{1}}{2} - \frac{\Gamma}{2\rho_{1}} \right) \eta'^{2} \right],$$

$$q'_{t} = -\partial_{x'} \left[ \kappa q' - \frac{\Gamma b'}{2\rho_{1}} q' + A_{1}(x')\eta' - \delta \frac{\Gamma b'}{2\rho_{1}} \left( q'_{2} - \frac{\Gamma_{2}}{2} \eta'_{2} \right) - \varepsilon^{2} A_{2} \frac{\Gamma}{2} \left( q'_{x'x'} - \frac{\Gamma}{2} \eta'_{x'x'} \right) + \varepsilon^{2} \frac{1}{\rho_{1}} \frac{q'^{2}}{2} + \varepsilon^{2} \left( \gamma_{1} - \frac{\Gamma}{\rho_{1}} \right) \eta' q' + \varepsilon^{2} A_{3} \frac{\eta'^{2}}{2} \right].$$

Considering  $\delta \ll \varepsilon^2$ , we neglect the  $\delta$ -terms above and the system (5.1)-(5.4) is reduced to

which shows that the internal wave motion is decoupled from the oscillations of the free surface. From (5.5) and (5.6), we note that the motion of the free surface is determined by

the initial data as  $(q'_2 + \frac{\Gamma_2}{2}\eta'_2)_t = 0$  and by the characteristics  $(\eta', q')$  of the displacements of the internal waves and by the characteristics b' of the bottom variation. On the other hand, the equations (5.7) and (5.8) yield that the leading order linear equations for  $(\eta', q')$ satisfy

$$\eta_t' = -\partial_{x'} \left[ (\kappa - \frac{\Gamma b'}{2\rho_1})\eta' + \frac{b'}{\rho_1}q' \right], \qquad (5.9)$$

To derive the solutions for  $\eta'$  and q' of (5.9) and (5.10), we take the form

with k being the wave number and c(x') being the wave speed dependent on variable x'. Substituting (5.11) into (5.9) and (5.10) yields

and so inserting this into (5.13) gives the following quadratic expression for the wave speed c

$$\left(c - \kappa + \frac{\Gamma b'}{2\rho_1}\right)^2 - \frac{b'\left(\rho_1 - \rho_2\right)\left(g - 2\omega\kappa\right)}{\rho_1} - \frac{(b')^2\Gamma^2}{4(\rho_1)^2} = 0.$$

The solutions are

$$c(x') = \kappa - \frac{\Gamma b'}{2\rho_1} \pm \sqrt{\frac{(\Gamma b')^2}{(2\rho_1)^2} + \frac{b'(\rho_1 - \rho_2)(g - 2\omega\kappa)}{\rho_1}}.$$

The solutions of (5.16) are real as  $g \gg 2\omega\kappa$  and  $\rho_1 > \rho_2$ . Besides, recalling from (2.5) that  $\kappa$  is the speed of the underlying current at the mean level z = 0 of the internal waves, we obtain that in (5.16) that the plus sign corresponds to the speed of waves outrunning

the current (downstream linear waves), while the minus sign corresponds to the speed of waves running counter to the current (upstream linear waves).

**Remark 5.1.** Setting  $b' = h_1$ , i.e.  $\beta = 0$ , the dispersion relation (5.16) recovers the result in [7] for fluids with flat bottom and for the special case  $h_2 = 0$  (i.e., taking  $\gamma_2 = \rho_2 = 0$ ), the equation (5.16) recovers the dispersion relation in the single-layer case [18].

Inspired by the previous studies [18, 19, 29], our next step is to transfer the system (5.7)-(5.8) to the KdV-type equation. Setting

$$\begin{cases} c_0(x') = c(x') - \kappa, \\ c_1(x') = c(x') - \kappa + \frac{\Gamma b'}{2\rho_1} = \pm \sqrt{\frac{(\Gamma b')^2}{(2\rho_1)^2} + \frac{b'(\rho_1 - \rho_2)(g - 2\omega\kappa)}{\rho_1}} = \pm \sqrt{\frac{b'}{\rho_1} A_1}, \end{cases}$$
(5.17)

then (5.14) gives that

$$q' = \frac{\rho_1}{b'} c_1(x') \eta'.$$

We introduce the additional characteristic variable

$$\theta = \frac{1}{\varepsilon^2} R(X) - t,$$

where R(X) is a function such as  $R'(X) \equiv \frac{1}{c(X)}$  and  $X = \varepsilon^2 x'$ . Our next goal is to transform the system (5.7)-(5.8) from variables (x', t) to the slow variables  $(X, \theta)$ . To this end, we calculate straightforward the relations between the derivatives as

$$\partial_{x'} \equiv \frac{1}{c(X)} \partial_{\theta} + \varepsilon^2 \partial_X, \qquad \partial_t \equiv -\partial_{\theta}.$$

The system of (5.7) and (5.8) are therefore rewritten in terms of  $(\theta, X)$  as

$$-c\eta_{\theta}' + \partial_{\theta} \left( \left(\kappa - \frac{\Gamma b'}{2\rho_{1}}\right)\eta' + \frac{b'}{\rho_{1}}q' \right) + \varepsilon^{2}c\partial_{X} \left( \left(\kappa - \frac{\Gamma b'}{2\rho_{1}}\right)\eta' + \frac{b'}{\rho_{1}}q' \right)$$
$$= -\varepsilon^{2}\partial_{\theta} \left[ \frac{A_{2}}{c^{2}} \left( q_{\theta\theta}' - \frac{\Gamma}{2}\eta_{\theta\theta}' \right) + \frac{1}{\rho_{1}}q'\eta' + \left( \frac{\gamma_{1}}{2} - \frac{\Gamma}{2\rho_{1}} \right)\eta'^{2} \right] + \mathcal{O}\left(\varepsilon^{4}\right), \qquad (5.19)$$

and

$$-cq_{\theta}' + \partial_{\theta} \left( \left(\kappa - \frac{\Gamma b'}{2\rho_{1}}\right)q' + A_{1}\eta' \right) + \varepsilon^{2}c\partial_{X} \left( \left(\kappa - \frac{\Gamma b'}{2\rho_{1}}\right)q' + A_{1}\eta' \right)$$
$$= \varepsilon^{2}\partial_{\theta} \left[ \frac{A_{2}}{c^{2}} \frac{\Gamma}{2} \left( q_{\theta\theta}' - \frac{\Gamma}{2}\eta_{\theta\theta}' \right) - \frac{1}{\rho_{1}} \frac{q'^{2}}{2} - \left( \gamma_{1} - \frac{\Gamma}{\rho_{1}} \right)\eta'q' - A_{3}\frac{\eta'^{2}}{2} \right] + \mathcal{O}\left(\varepsilon^{4}\right). \quad (5.20)$$

From (5.19),

$$\begin{aligned} q'_{\theta} &= \frac{\rho_1}{b'} (c - \kappa + \frac{\Gamma b'}{2\rho_1}) \eta'_{\theta} - \varepsilon^2 \frac{\rho_1 c}{b'} \partial_X \left( (\kappa - \frac{\Gamma b'}{2\rho_1}) \eta' + \frac{b'}{\rho_1} q' \right) \\ &- \varepsilon^2 \frac{\rho_1}{b'} \partial_{\theta} \left[ \frac{A_2}{c^2} \left( q'_{\theta\theta} - \frac{\Gamma}{2} \eta'_{\theta\theta} \right) + \frac{1}{\rho_1} q' \eta' + \left( \frac{\gamma_1}{2} - \frac{\Gamma}{2\rho_1} \right) \eta'^2 \right] + \mathcal{O} \left( \varepsilon^4 \right), \end{aligned}$$

and by (5.18), the above equation can be written as

$$q_{\theta}' = \frac{\rho_1}{b'} \left(c - \kappa + \frac{\Gamma b'}{2\rho_1}\right) \eta_{\theta}' - \varepsilon^2 \frac{\rho_1 c}{b'} \partial_X \left( \left(\kappa - \frac{\Gamma b'}{2\rho_1} + c_1\right) \eta' \right) - \varepsilon^2 \frac{\rho_1}{b'} \partial_\theta \left[ \frac{A_2}{c^2} \left(\frac{\rho_1}{b'} c_1 - \frac{\Gamma}{2}\right) \eta_{\theta\theta}' + \left(\frac{c_1}{b'} + \frac{\gamma_1}{2} - \frac{\Gamma}{2\rho_1}\right) \eta'^2 \right] + \mathcal{O}\left(\varepsilon^4\right).$$

Tedious calculations and some algebraic manipulations yield that the equation (5.20) can be written with *q* excluded as

$$c\eta'_{X} + \left(c_{X} - \frac{c_{1}c}{2b'}(\frac{b'}{c_{1}})_{X}\right)\eta' + \frac{A_{2}}{c^{3}}\frac{\rho_{1}c_{0}^{2}}{2c_{1}b'}\eta'_{\theta\theta\theta} + \frac{1}{2cc_{1}}\left(\frac{b'}{\rho_{1}}\left(\rho_{1}\gamma_{1}^{2} - \rho_{2}\gamma_{2}^{2}\right) + 3c_{0}\left(\frac{c_{0}}{b'} + \gamma_{1}\right)\right)\eta'\eta'_{\theta} = 0,$$
(5.22)

where the relation (5.17) is used. This equation is a KdV-type equation [32], whose coefficients depend on functions of the slowly varying variable X.

**Remark 5.2.** Setting  $\tilde{\theta} = c\theta$ , then the equation (5.22) is reformed as

$$c\eta'_{X} + \left(c_{X} - \frac{c_{1}c}{2b'}(\frac{b'}{c_{1}})_{X}\right)\eta' + A_{2}\frac{\rho_{1}c_{0}^{2}}{2c_{1}b'}\eta'_{\tilde{\theta}\tilde{\theta}\tilde{\theta}}$$
$$+ \frac{1}{2c_{1}}\left(\frac{b'}{\rho_{1}}\left(\rho_{1}\gamma_{1}^{2} - \rho_{2}\gamma_{2}^{2}\right) + 3c_{0}\left(\frac{c_{0}}{b'} + \gamma_{1}\right)\right)\eta'\eta'_{\tilde{\theta}} = 0.$$
(5.23)

In the special case  $b' = h_1$  (i.e., taking  $\beta = 0$ ), the coefficients of the equation (5.23) recover the ones of the KdV equation in [7] for fluids with flat bottom, where a moving frame of reference and a scaling transformation are needed.
