# Two results of $n$-exangulated categories

#### Abstract

$n$-exangulated categories were introduced by Herschend-Liu-Nakaoka which are a simultaneous generalization of $n$-exact categories and $(n+2)$-angulated categories. This paper consists of two results on $n$-exangulated categories: (1) we give an equivalent characterization of the axiom (EA2); (2) we provide a new way to construct a closed subfunctor of an $n$-exangulated category.

## 1 Introduction

The notion of extriangulated categories was introduced in [7], which can be viewed as a simultaneous generalization of exact categories and triangulated categories. The data of such a category is a triplet $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$, where $\mathscr{C}$ is an additive category, $\mathbb{E}: \mathscr{C}{ }^{\mathrm{op}} \times \mathscr{C} \rightarrow \mathrm{Ab}$ is an additive bifunctor and $\mathfrak{s}$ assigns to each $\delta \in \mathbb{E}(C, A)$ a class of 3 -term sequences with end terms $A$ and $C$ such that certain axioms hold. Recently, Herschend-Liu-Nakaoka [1] introduced the notion of $n$-exangulated categories for any positive integer $n$. It should be noted that the case $n=1$ corresponds to extriangulated categories. As typical examples we know that $n$-exact categories and $(n+2)$-angulated categories are $n$-exangulated categories, see [1, Proposition 4.34] and [1, Proposition 4.5]. However, there are some other examples of $n$-exangulated categories which are neither $n$-exact nor $(n+2)$-angulated, see $[1-3,6]$.

Recall that homotopy cartesian squares in triangulated categories are the triangulated analogues of the pushout and pullback squares in abelian categories. It is well-known that the axiom (TR4) is equivalent to the homotopy cartesian axiom. Recently, Kong-Lin-Wang [4] introduced the notion of homotopy cartesian squares and proposed a new shifted octahedron in extriangulated categories. Our first main result show that Kong-Lin-Wang's result has a higher counterpart:

Theorem 1.1. (see Theorem 3.4 for details) Let $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ be a pre- $n$-exangulated category. Then $\mathscr{C}$ satisfies (EA2) if and only if $\mathscr{C}$ satisfies (EA2-1).

Relative theories are explicated by use of closed subfunctors in $n$-exangulated categories [1]. An additive subfunctor $\mathbb{F}$ of $\mathbb{E}$ is a closed subfunctor if $\left(\mathscr{C}, \mathbb{F},\left.\mathfrak{s}\right|_{\mathbb{F}}\right)$ is an $n$-exangulated category,

[^0]where $\left.\mathfrak{s}\right|_{\mathbb{F}}$ is a restriction of $\mathfrak{s}$ to $\mathbb{F}$, see [ 1 , Proposition 3.16$]$. Our second main result provide a new way to construct a closed subfunctor of an $n$-exangulated category. This is a higher counterpart of Sakai's result.

Theorem 1.2. (see Theorem 4.5 for details) Let $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ be an $n$-exangulated category and $F: \mathscr{C} \rightarrow \mathscr{A}$ a half exact functor to an abelian category $\mathscr{A}$. Then there exists a unique maximal closed subfunctor $\mathbb{F}$ of $\mathbb{E}$ such that $F$ becomes a right exact functor from $\left(\mathscr{C}, \mathbb{F},\left.\mathfrak{s}\right|_{\mathbb{F}}\right)$ to $\mathscr{A}$.

This article is organized as follows. In Section 2, we review some elementary definitions and facts on $n$-exangulated categories. In Section 3, we prove our first main result. In Section 4, we prove our second main result.

## 2 Preliminaries

In this section, we briefly review basic concepts and results concerning $n$-exangulated categories.

Let $\mathscr{C}$ be an additive category and $\mathbb{E}: \mathscr{C}^{\mathrm{op}} \times \mathscr{C} \rightarrow \mathrm{Ab}$ ( Ab is the category of abelian groups) an additive bifunctor. For any pair of objects $A, C \in \mathscr{C}$, an element $\delta \in \mathbb{E}(C, A)$ is called an $\mathbb{E}$ extension or simply an extension. We also write such $\delta$ as ${ }_{A} \delta_{C}$ when we indicate $A$ and $C$. The zero element ${ }_{A} 0_{C}=0 \in \mathbb{E}(C, A)$ is called the split $\mathbb{E}$-extension. For any pair of $\mathbb{E}$-extensions ${ }_{A} \delta_{C}$ and ${ }_{A^{\prime}} \delta^{\prime} C^{\prime}$, let $\delta \oplus \delta^{\prime} \in \mathbb{E}\left(C \oplus C^{\prime}, A \oplus A^{\prime}\right)$ be the element corresponding to $\left(\delta, 0,0, \delta^{\prime}\right)$ through the natural isomorphism $\mathbb{E}\left(C \oplus C^{\prime}, A \oplus A^{\prime}\right) \simeq \mathbb{E}(C, A) \oplus \mathbb{E}\left(C, A^{\prime}\right) \oplus \mathbb{E}\left(C^{\prime}, A\right) \oplus \mathbb{E}\left(C^{\prime}, A^{\prime}\right)$.

For any $a \in \mathscr{C}\left(A, A^{\prime}\right)$ and $c \in \mathscr{C}\left(C^{\prime}, C\right), \mathbb{E}(C, a)(\delta) \in \mathbb{E}\left(C, A^{\prime}\right)$ and $\mathbb{E}(c, A)(\delta) \in \mathbb{E}\left(C^{\prime}, A\right)$ are simply denoted by $a_{*} \delta$ and $c^{*} \delta$, respectively.

Let ${ }_{A} \delta_{C}$ and ${ }_{A^{\prime}} \delta^{\prime} C^{\prime}$ be any pair of $\mathbb{E}$-extensions. A morphism $(a, c): \delta \rightarrow \delta^{\prime}$ of extensions is a pair of morphisms $a \in \mathscr{C}\left(A, A^{\prime}\right)$ and $c \in \mathscr{C}\left(C, C^{\prime}\right)$ in $\mathscr{C}$, satisfying the equality $a_{*} \delta=c^{*} \delta^{\prime}$.

Let $\mathscr{C}$ be an additive category as before, and let $n$ be any positive integer.
Definition 2.1. [1, Definition 2.7] Let $\mathbf{C}_{\mathscr{C}}$ be the category of complexes in $\mathscr{C}$. As its full subcategory, define $\mathbf{C}_{\mathscr{C}}^{n+2}$ to be the category of complexes in $\mathscr{C}$ whose components are zero in the degrees outside of $\{0,1, \ldots, n+1\}$. Namely, an object in $\mathbf{C}_{\mathscr{C}}^{n+2}$ is a complex $X_{\bullet}=\left\{X_{i}, d_{i}^{X}\right\}$ of the form

X_{0} \xrightarrow{d_{0}^{X}} X_{1} \xrightarrow{d_{1}^{X}} \cdots \xrightarrow{d_{n-1}^{X}} X_{n} \xrightarrow{d_{n}^{X}} X_{n+1} .
$$

We write a morphism $f_{\bullet}: X_{\bullet} \rightarrow Y_{\bullet}$ simply $f_{\bullet}=\left(f_{0}, f_{1}, \ldots, f_{n+1}\right)$, only indicating the terms of degrees $0, \ldots, n+1$.

Definition 2.2. [1, Definition 2.11] By Yoneda lemma, any extension $\delta \in \mathbb{E}(C, A)$ induces natural transformations

\delta_{\sharp}: \mathscr{C}(-, C) \Rightarrow \mathbb{E}(-, A) \text { and } \delta^{\sharp}: \mathscr{C}(A,-) \Rightarrow \mathbb{E}(C,-)
$$

For any $X \in \mathscr{C}$, these $\left(\delta_{\sharp}\right)_{X}$ and $\delta_{X}^{\sharp}$ are given as follows.
(1) $\left(\delta_{\sharp}\right)_{X}: \mathscr{C}(X, C) \rightarrow \mathbb{E}(X, A): f \mapsto f^{*} \delta$.
(2) $\delta_{X}^{\sharp}: \mathscr{C}(A, X) \rightarrow \mathbb{E}(C, X): g \mapsto g_{*} \delta$.

We simply denote $\left(\delta_{\sharp}\right)_{X}(f)$ and $\delta_{X}^{\sharp}(g)$ by $\delta_{\sharp}(f)$ and $\delta^{\sharp}(g)$, respectively.
Definition 2.3. [1, Definition 2.9] Let $\mathscr{C}, \mathbb{E}, n$ be as before. Define a category $\mathbb{E}:=\mathbb{E}_{(\mathscr{C}, \mathbb{E})}^{n+2}$ as follows.
(1) A object in $\mathbb{E}_{(\mathscr{C}, \mathbb{E})}^{n+2}$ is a pair $\left\langle X_{\bullet}, \delta\right\rangle$ of $X_{\bullet} \in \mathbf{C}_{\mathscr{C}}^{n+2}$ and $\delta \in \mathbb{E}\left(X_{n+1}, X_{0}\right)$ satisfying

$$
\left(d_{0}^{X}\right)_{*} \delta=0 \text { and }\left(d_{n}^{X}\right)^{*} \delta=0 .
$$

We call such a pair an $\mathbb{E}$-attached complex of length $n+2$. We also denote it by

$$
X_{0} \xrightarrow{d_{0}^{X}} X_{1} \xrightarrow{d_{1}^{X}} \cdots \xrightarrow{d_{n-2}^{X}} X_{n-1} \xrightarrow{d_{n-1}^{X}} X_{n} \xrightarrow{d_{n}^{X}} X_{n+1} \xrightarrow{\delta} .
$$

(2) For such pairs $\left\langle X_{\bullet}, \delta\right\rangle$ and $\left\langle Y_{\bullet}, \rho\right\rangle$, a morphism $f_{\bullet}:\left\langle X_{\bullet}, \delta\right\rangle \rightarrow\left\langle Y_{\bullet}, \rho\right\rangle$ is defined to be a morphism $f_{\bullet} \in \mathbf{C}_{\mathscr{G}}^{n+2}\left(X_{\bullet}, Y_{\bullet}\right)$ satisfying $\left(f_{0}\right)_{*} \delta=\left(f_{n+1}\right)^{*} \rho$.
We use the same composition and the identities as in $\mathbf{C}_{\mathscr{G}}^{n+2}$.
Definition 2.4. [1, Definition 2.13] An $n$-exangle is a pair $\left\langle X_{\bullet}, \delta\right\rangle$ of $X_{\bullet} \in \mathbf{C}_{\mathscr{C}}^{n+2}$ and $\delta \in$ $\mathbb{E}\left(X_{n+1}, X_{0}\right)$ which satisfies the following conditions.
(1) The following sequence of functors $\mathscr{C}^{\mathrm{op}} \rightarrow \mathrm{Ab}$ is exact.

$$
\mathscr{C}\left(-, X_{0}\right) \xrightarrow{\mathscr{C}\left(-, d_{0}^{X}\right)} \cdots \xrightarrow{\mathscr{C}\left(-, d_{n}^{X}\right)} \mathscr{C}\left(-, X_{n+1}\right) \xrightarrow{\delta_{\sharp}} \mathbb{E}\left(-, X_{0}\right)
$$

(2) The following sequence of functors $\mathscr{C} \rightarrow \mathrm{Ab}$ is exact.

$$
\mathscr{C}\left(X_{n+1},-\right) \xrightarrow{\mathscr{C}\left(d_{n}^{X},-\right)} \cdots \xrightarrow{\mathscr{C}\left(d_{0}^{X},-\right)} \mathscr{C}\left(X_{0},-\right) \xrightarrow{\delta^{\sharp}} \mathbb{E}\left(X_{n+1},-\right)
$$

In particular any $n$-exangle is an object in Æ. A morphism of $n$-exangles simply means a morphism in $Æ$. Thus $n$-exangles form a full subcategory of $Æ$.

Definition 2.5. [1, Definition 2.22] Let $\mathfrak{s}$ be a correspondence which associates a homotopic equivalence class $\mathfrak{s}(\delta)=\left[{ }_{A} X \bullet C\right]$ to each extension $\delta={ }_{A} \delta_{C}$. Such $\mathfrak{s}$ is called a realization of $\mathbb{E}$ if it satisfies the following condition for any $\mathfrak{s}(\delta)=\left[X_{\mathbf{\bullet}}\right]$ and any $\mathfrak{s}(\rho)=\left[Y_{\mathbf{\bullet}}\right]$.
(R0) For any morphism of extensions $(a, c): \delta \rightarrow \rho$, there exists a morphism $f_{\bullet} \in \mathbf{C}_{\mathscr{G}}^{n+2}\left(X_{\bullet}, Y_{\bullet}\right)$ of the form $f_{\bullet}=\left(a, f_{1}, \ldots, f_{n}, c\right)$. Such $f_{\bullet}$ is called a lift of $(a, c)$.

In such a case, we simply say that " $X_{\bullet}$ realizes $\delta$ " whenever they satisfy $\mathfrak{s}(\delta)=\left[X_{\bullet}\right]$.
Moreover, a realization $\mathfrak{s}$ of $\mathbb{E}$ is said to be exact if it satisfies the following conditions.
(R1) For any $\mathfrak{s}(\delta)=\left[X_{\bullet}\right]$, the pair $\left\langle X_{\bullet}, \delta\right\rangle$ is an $n$-exangle.
(R2) For any $A \in \mathscr{C}$, the zero element ${ }_{A} 0_{0}=0 \in \mathbb{E}(0, A)$ satisfies

$$
\mathfrak{s}\left(A 0_{0}\right)=\left[A \xrightarrow{\mathrm{id}_{A}} A \rightarrow 0 \rightarrow \cdots \rightarrow 0 \rightarrow 0\right] .
$$

Dually, $\mathfrak{s}\left(0^{0} 0_{A}\right)=\left[0 \rightarrow 0 \rightarrow \cdots \rightarrow 0 \rightarrow A \xrightarrow{\mathrm{id}_{A}} A\right]$ holds for any $A \in \mathscr{C}$.
Note that the above condition (R1) does not depend on representatives of the class $\left[X_{\mathbf{0}}\right]$.
Definition 2.6. [1, Definition 2.23] Let $\mathfrak{s}$ be an exact realization of $\mathbb{E}$.
(1) An $n$-exangle $\left\langle X_{\bullet}, \delta\right\rangle$ is called an $\mathfrak{s}$-distinguished $n$-exangle if it satisfies $\mathfrak{s}(\delta)=\left[X_{\mathbf{\bullet}}\right]$. We often simply say distinguished $n$-exangle when $\mathfrak{s}$ is clear from the context.
(2) An object $X_{\bullet} \in \mathbf{C}_{\mathscr{C}}^{n+2}$ is called an $\mathfrak{s - c o n f l a t i o n}$ or simply a conflation if it realizes some extension $\delta \in \mathbb{E}\left(X_{n+1}, X_{0}\right)$.
(3) A morphism $f$ in $\mathscr{C}$ is called an $\mathfrak{s}$-inflation or simply an inflation if it admits some conflation $X_{\bullet} \in \mathbf{C}_{\mathscr{G}}^{n+2}$ satisfying $d_{0}^{X}=f$.
(4) A morphism $g$ in $\mathscr{C}$ is called an $\mathfrak{s}$-deflation or simply a deflation if it admits some conflation $X_{\bullet} \in \mathbf{C}_{\mathscr{G}}^{n+2}$ satisfying $d_{n}^{X}=g$.

Definition 2.7. [1, Definition 2.27] For a morphism $f_{\bullet} \in \mathbf{C}_{\mathscr{C}}^{n+2}\left(X_{\bullet}, Y_{\bullet}\right)$ satisfying $f_{0}=\mathrm{id}_{A}$ for some $A=X_{0}=Y_{0}$, its mapping cone $M_{\bullet}^{f} \in \mathbf{C}_{\mathscr{C}}^{n+2}$ is defined to be the complex
where $d_{0}^{M_{f}}=\left[\begin{array}{c}-d_{1}^{X} \\ f_{1}\end{array}\right], d_{i}^{M_{f}}=\left[\begin{array}{cc}-d_{i+1}^{X} & 0 \\ f_{i+1} & d_{i}^{Y}\end{array}\right] \quad(1 \leq i \leq n-1), d_{n}^{M_{f}}=\left[\begin{array}{ll}f_{n+1} & d_{n}^{Y}\end{array}\right]$.
The mapping cocone is defined dually, for morphisms $h_{\bullet}$ in $\mathbf{C}_{\mathscr{C}}^{n+2}$ satisfying $h_{n+1}=\mathrm{id}$.
Definition 2.8. [1, Definition 2.32] An pre-n-exangulated category is a triplet ( $\mathscr{C}, \mathbb{E}, \mathfrak{s}$ ) of additive category $\mathscr{C}$, additive bifunctor $\mathbb{E}: \mathscr{C}^{\mathrm{op}} \times \mathscr{C} \rightarrow \mathrm{Ab}$, and its exact realization $\mathfrak{s}$, satisfying the following condition.
(EA1) Let $A \xrightarrow{f} B \xrightarrow{g} C$ be any sequence of morphisms in $\mathscr{C}$. If both $f$ and $g$ are inflations, then so is $g \circ f$. Dually, if $f$ and $g$ are deflations, then so is $g \circ f$.

If the triplet $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ moreover satisfies the following conditions, then it is called an $n$ exangulated category
(EA2) For $\rho \in \mathbb{E}(D, A)$ and $c \in \mathscr{C}(C, D)$, let ${ }_{A}\left\langle X_{\bullet}, c^{*} \rho\right\rangle_{C}$ and ${ }_{A}\left\langle Y_{\bullet}, \rho\right\rangle_{D}$ be distinguished $n$ exangles. Then $\left(\mathrm{id}_{A}, c\right)$ has a good lift $f_{\bullet}$, in the sense that its mapping cone gives a distinguished $n$-exangle $\left\langle M_{\bullet}^{f},\left(d_{0}^{X}\right)_{*} \rho\right\rangle$.
(EA2 $\left.{ }^{\text {op }}\right)$ Dual of (EA2).
Note that in the case $n=1$, a triplet $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ is a 1 -exangulated category if and only if it is an extriangulated category, see [1, Proposition 4.3].

Example 2.9. From [1, Proposition 4.34] and [1, Proposition 4.5], we know that $n$-exact categories and $(n+2)$-angulated categories are $n$-exangulated categories. There are some other examples of $n$-exangulated categories which are neither $n$-exact nor $(n+2)$-angulated, see $[1-3,6]$.

## 3 An equivalent characterization of the axiom (EA2)

In this section we introduce the definition of homotopy cartesian squares in pre- $n$-exangulated categories and provide an equivalent statement of the axiom (EA2).

Definition 3.1. The following commutative diagram

in a pre- $n$-exangulated category $\mathscr{C}$ is called a homotopy cartesian diagram if the following sequence

is a distinguished $n$-exangle, where $\partial$ is called a differential.

Remark 3.2. The distinguished $n$-exangle (2.1) in the definition of homotopy cartesian diagram can also be written as follows

In fact, the two distinguished $n$-exangles are isomorphic:

Lemma 3.3. [1, Proposition 3.6] Let $\mathscr{C}$ be an $n$-exangulated category, ${ }_{A}\left\langle X_{\bullet}, \delta\right\rangle_{C}$ and ${ }_{B}\left\langle Y_{\bullet}, \rho\right\rangle_{D}$
be distinguished $n$-exangles. Suppose that we are given a commutative square

in $\mathscr{C}$. Then the following holds.
(1) There is a morphism $f_{\bullet}:\left\langle X_{\bullet}, \delta\right\rangle \rightarrow\left\langle Y_{\bullet}, \rho\right\rangle$ which satisfies $f_{0}=a$ and $f_{1}=b$.
(2) If $X_{0}=Y_{0}=A$ and $a=1_{A}$ for some $A \in \mathscr{C}$, then the above $f_{\bullet}$ can be taken to give a distinguished $n$-exangle $\left\langle M_{\bullet}^{f},\left(d_{0}^{X}\right)_{*} \rho\right\rangle$.

Theorem 3.4. Let $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ be a pre-n-exangulated category. Then $\mathscr{C}$ satisfies (EA2) if and only if $\mathscr{C}$ satisfies (EA2-1):

Let $X_{0} \xrightarrow{f_{0}} X_{1} \xrightarrow{f_{1}} \cdots \xrightarrow{f_{n-2}} X_{n-1} \xrightarrow{f_{n-1}} X_{n} \xrightarrow{f_{n}} X_{n+1} \xrightarrow{\delta}$ and $X_{0} \xrightarrow{g_{0}} Y_{1} \xrightarrow{g_{1}} \cdots \xrightarrow{g_{n-2}}$ $Y_{n-1} \xrightarrow{g_{n-1}} Y_{n} \xrightarrow{g_{n}} Y_{n+1} \xrightarrow{\delta^{\prime}}$ be distinguished $n$-exangles, and $\varphi_{1}: X_{1} \rightarrow Y_{1}$ be a morphism such that $\varphi_{1} f_{0}=g_{0}$. Then there exist morphisms $\varphi_{i}: X_{i} \rightarrow Y_{i}$ for $2 \leq i \leq n+1$, which give a morphism of distinguished $n$-exangles

and moreover, the following

is a homotopy cartesian diagram and $\left(f_{0}\right)_{*} \delta^{\prime}$ is the differential.

Proof. (EA2) $\Longrightarrow(E A 2-1)$. It follows from Lemma 3.3.
$($ EA2-1 $) \Longrightarrow(\mathrm{EA} 2)$. Since $\left(\mathrm{id}, \varphi_{n+1}\right):\left(\varphi_{n+1}\right)^{*} \delta^{\prime} \rightarrow \delta^{\prime}$ is a morphism of $\mathbb{E}$-extensions, by (R0), there exist morphisms $\varphi_{i}^{\prime}: X_{i} \rightarrow Y_{i}$ for $1 \leq i \leq n$ such that the following diagram commutative


By (EA2-1), there exist morphisms $\varphi_{i}^{\prime \prime}: X_{i} \rightarrow Y_{i}$ for $2 \leq i \leq n+1$, which give a morphism of distinguished $n$-exangles

and moreover, the following

is a homotopy cartesian diagram and $\left(f_{0}\right)_{*} \delta^{\prime}$ is the differential.

Since $\left(\varphi_{n+1}\right)^{*} \delta^{\prime}=\left(\varphi_{n+1}^{\prime \prime}\right)^{*} \delta^{\prime}$, that is, $\left(\varphi_{n+1}-\varphi_{n+1}^{\prime \prime}\right)^{*} \delta^{\prime}=0$, then by the exactness of

$$
\mathscr{C}\left(X_{n+1}, Y_{n}\right) \xrightarrow{\mathscr{C}\left(X_{n+1}, g_{n}\right)} \mathscr{C}\left(X_{n+1}, Y_{n+1}\right) \xrightarrow{\delta_{\sharp}^{\prime}} \mathbb{E}\left(X_{n+1}, X_{0}\right),
$$

there is a morphism $h_{n+1}: X_{n+1} \rightarrow Y_{n}$ which gives $g_{n} h_{n+1}=\varphi_{n+1}-\varphi_{n+1}^{\prime \prime}$.

Since $g_{n}\left(\varphi_{n}^{\prime}-\varphi_{n}^{\prime \prime}-h_{n+1} f_{n}\right)=g_{n} \varphi_{n}^{\prime}-g_{n} \varphi_{n}^{\prime \prime}-g_{n} h_{n+1} f_{n}=g_{n} \varphi_{n}^{\prime}-g_{n} \varphi_{n}^{\prime \prime}-\varphi_{n+1} f_{n}+\varphi_{n+1}^{\prime \prime} f_{n}=0$, then by the exactness of

$$
\mathscr{C}\left(X_{n}, Y_{n-1}\right) \xrightarrow{\mathscr{C}\left(X_{n}, g_{n-1}\right)} \mathscr{C}\left(X_{n}, Y_{n}\right) \xrightarrow{\mathscr{C}\left(X_{n}, g_{n}\right)} \mathscr{C}\left(X_{n}, Y_{n+1}\right),
$$

there is a morphism $h_{n}: X_{n} \rightarrow Y_{n-1}$ which gives $g_{n-1} h_{n}=\varphi_{n}^{\prime}-\varphi_{n}^{\prime \prime}-h_{n+1} f_{n}$.

Inductively, for $i=2,3, \cdots, n-1$, we obtain $h_{i}: X_{i} \rightarrow Y_{i-1}$ such that $g_{i-1} h_{i}=\varphi_{i}^{\prime}-\varphi_{i}^{\prime \prime}-$ $h_{i+1} f_{i}$. In particular, $g_{1}\left(\varphi_{1}^{\prime}-\varphi_{1}^{\prime}-h_{2} f_{1}\right)=-g_{1} h_{2} f_{1}=-\varphi_{2}^{\prime} f_{1}+\varphi_{2}^{\prime \prime} f_{1}+h_{3} f_{2} f_{1}=-g_{1} \varphi_{1}^{\prime}+g_{1} \varphi_{1}^{\prime}=$ 0 , and hence there exist $h_{1}: X_{1} \rightarrow Y_{0}$ which gives $g_{0} h_{1}=-h_{2} f_{1}$.

Set

$$
\varphi_{i}= \begin{cases}\varphi_{i}^{\prime}=\varphi_{i}^{\prime \prime}+h_{i+1} f_{i}+g_{i-1} h_{i} & \text { if } i=2,3, \cdots, n \\ \varphi_{i}^{\prime}+h_{i+1} f_{i} & \text { if } i=1\end{cases}
$$

then $\varphi_{1} f_{0}=\left(\varphi_{1}^{\prime}+h_{2} f_{1}\right) f_{0}=\varphi_{1}^{\prime} f_{0}=g_{0}, \varphi_{2} f_{1}=\left(\varphi_{2}^{\prime \prime}+h_{3} f_{2}+g_{1} h_{2}\right) f_{1}=\varphi_{2}^{\prime \prime} f_{1}+g_{1} h_{2} f_{1}=$ $g_{1} \varphi_{1}^{\prime}+g_{1} h_{2} f_{1}=g_{1}\left(\varphi_{1}^{\prime}+h_{2} f_{1}\right)=g_{1} \varphi_{1}$. The following commutative diagram

$$
\begin{aligned}
& \left.\cdots \xrightarrow{\left(\begin{array}{cc}
-f_{n-1} & 0 \\
\varphi_{n-1}^{\prime \prime} & g_{n-2}
\end{array}\right)} X_{n} \oplus Y_{n-1} \xrightarrow{\left(\begin{array}{cc}
-f_{n} & 0 \\
\varphi_{n}^{\prime \prime} & g_{n-1}
\end{array}\right)} X_{n+1} \oplus Y_{n} \xrightarrow{\left(\varphi_{n+1}^{\prime \prime} g_{n}\right.}\right) \xrightarrow{c} Y_{n+1}
\end{aligned}
$$

implies that

$$
\begin{gathered}
X_{1} \xrightarrow{\binom{-f_{1}}{\varphi_{1}}} X_{2} \oplus Y_{1} \xrightarrow{\left(\begin{array}{cc}
-f_{2} & 0 \\
\varphi_{2} & g_{1}
\end{array}\right)} X_{3} \oplus Y_{2} \xrightarrow{\left(\begin{array}{cc}
-f_{3} & 0 \\
\varphi_{3} & g_{2}
\end{array}\right)} \cdots \\
\left.\cdots \xrightarrow{\left(\begin{array}{cc}
-f_{n-1} & 0 \\
\varphi_{n-1} & g_{n-2}
\end{array} X_{n} \oplus Y_{n-1} \xrightarrow{\left(\begin{array}{cc}
-f_{n} & 0 \\
\varphi_{n} & g_{n-1}
\end{array}\right)} X_{n+1} \oplus Y_{n} \xrightarrow{\left(\varphi_{n+1}\right.} g_{n}\right)} Y_{n+1} \xrightarrow\left[--\delta^{\left(f_{0}\right.}\right)^{\prime}\right]{ }
\end{gathered}
$$

is a distinguished $n$-exangle. Therefore, $\left(\operatorname{id}_{X_{0}}, \varphi_{n+1}\right)$ has a good lift $\left(\operatorname{id}_{X_{0}}, \varphi_{1}, \varphi_{2}, \cdots, \varphi_{n}, \varphi_{n+1}\right)$. That is to say (EA2) holds.

Corollary 3.5. In Theorem 3.4, when $n=1$, it is just the dual of Theorem 3.3 in [4].

## 4 Closed subfunctors arising from half exact functors

In this section, we introduce methods of constructing closed subfunctors of an $n$-exangulated category $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ from half exact functors. Let's start with the following key lemma.

Lemma 4.1. [1, Proposition 3.16] Let $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$ be an n-exangulated category. For any additive subfunctor $\mathbb{F} \subseteq \mathbb{E}$, the following statements are equivalent.
(1) $\left(\mathscr{C}, \mathbb{F},\left.\mathfrak{s}\right|_{\mathbb{F}}\right)$ is an $n$-exangulated category.
(2) $\left.\mathfrak{s}\right|_{\mathbb{F}}$-inflations are closed under composition.
(3) $\left.\mathfrak{s}\right|_{\mathbb{F}}$-deflations are closed under composition.

We call an additive subfunctor $\mathbb{F} \subseteq \mathbb{E}$ a closed subfunctor if it satisfies the above equivalent conditions. In this case, we call $\left(\mathscr{C}, \mathbb{F},\left.\mathfrak{s}\right|_{\mathbb{F}}\right)$ a relative theory of $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$. For a relative theory $\left(\mathscr{C}, \mathbb{F},\left.\mathfrak{s}\right|_{\mathbb{F}}\right)$, we briefly denote it by $(\mathscr{C}, \mathbb{F})$.

Definition 4.2. Let $\mathscr{A}$ be an abelian category. An additive functor $F: \mathscr{C} \rightarrow \mathscr{A}$ is called a half exact functor if the sequence

$$
F X_{0} \xrightarrow{F f_{0}} F X_{1} \xrightarrow{F f_{1}} \cdots \xrightarrow{F f_{n-2}} F X_{n-1} \xrightarrow{F f_{n-1}} F X_{n} \xrightarrow{F f_{n}} F X_{n+1}
$$

is exact for any distinguished $n$-exangle $X_{0} \xrightarrow{f_{0}} X_{1} \xrightarrow{f_{1}} \cdots \xrightarrow{f_{n-2}} X_{n-1} \xrightarrow{f_{n-1}} X_{n} \xrightarrow{f_{n}} X_{n+1} \xrightarrow{\delta}$. Moreover, if $F f_{n}$ (resp. $F f_{0}$ ) is an epimorphism (resp. monomorphism), we call $F$ a right exact functor (resp. left exact functor).

Remark 4.3. If the category $\mathscr{C}$ are extriangulated, then Definition 4.2 coincides with the definition of half exact functor (homological functor) of extriangulated categories (cf. [5, 8]).

Definition 4.4. Let $F: \mathscr{C} \rightarrow \mathscr{A}$ be a half exact functor. We define a subset $\mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$ of $\mathbb{E}\left(X_{n+1}, X_{0}\right)$ consisting of $\delta$ such that for any distinguished $n$-exangle $X_{0} \xrightarrow{f_{0}} X_{1} \xrightarrow{f_{1}} \cdots \xrightarrow{f_{n-2}}$ $X_{n-1} \xrightarrow{f_{n-1}} X_{n} \xrightarrow{f_{n}} X_{n+1} \xrightarrow{\delta}$, we have that $F f_{n}$ is an epimorphism in $\mathscr{A}$. Similarly, we define
a subset $\mathbb{E}_{L}^{F}\left(X_{n+1}, X_{0}\right)$ of $\mathbb{E}\left(X_{n+1}, X_{0}\right)$ consisting of $\delta$ such that $F f_{0}$ is a monomorphism in $\mathscr{A}$.

Note that the above definition is well-defined, that is, it does not depend on the choice of a distinguished $n$-exangle of $\delta$. Moreover, $\mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$ defines the maximum closed subfunctor such that F becomes a right exact functor.

Theorem 4.5. Let $F: \mathscr{C} \rightarrow \mathscr{A}$ be a half exact functor. Then the following statements hold.
(1) $\mathbb{E}_{R}^{F}$ is a closed subfunctor of $\mathbb{E}$, hence $\left(\mathscr{C}, \mathbb{E}_{R}^{F}\right)$ is a relative theory of $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$.
(2) $F$ restricts to a right functor $F:\left(\mathscr{C}, \mathbb{E}_{R}^{F}\right) \rightarrow \mathscr{A}$.
(3) Let $(\mathscr{C}, \mathbb{F})$ be a relative theory of $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$. If $F$ restricts to a right functor $F:(\mathscr{C}, \mathbb{F}) \rightarrow$ $\mathscr{A}$, then we have $\mathbb{F} \subseteq \mathbb{E}_{R}^{F}$.

Proof. (1) First of all, we claim that $\mathbb{E}_{R}^{F}$ is a subfunctor of $\mathbb{E}$. In fact, for any $\delta \in \mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$ and any morphism $a_{0}: X_{0} \rightarrow Y_{0}$, by (EA2 ${ }^{\text {op }}$ ), we obtain the following commutative diagram


Applying $F$ to the above diagram, we have the following commutative diagram with exact rows

in $\mathscr{A}$. Since $F f_{n}$ is epimorphic, then $F g_{n}$ is also epimorphic. So we have $a_{0} \delta \in \mathbb{E}_{R}^{F}\left(X_{n+1}, Y_{0}\right)$.
For any $\delta \in \mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$ and any morphism $a_{n+1}: Y_{n+1} \rightarrow X_{n+1}$, by (EA2), we obtain the following commutative diagram

such that

$$
\begin{aligned}
& Y_{1} \xrightarrow{\binom{-g_{1}}{a_{1}}} Y_{2} \oplus X_{1} \xrightarrow{\left(\begin{array}{cc}
-g_{2} & 0 \\
a_{2} & f_{1}
\end{array}\right)} Y_{3} \oplus X_{2} \xrightarrow{\left(\begin{array}{cc}
-g_{3} & 0 \\
a_{3} & f_{2}
\end{array}\right)} \cdots \\
& \cdots \xrightarrow{\left(\begin{array}{cc}
-g_{n-1} & 0 \\
a_{n-1} & f_{n-2}
\end{array}\right)} Y_{n} \oplus X_{n-1} \xrightarrow{\left(\begin{array}{cc}
g_{n} & 0 \\
a_{n} & f_{n-1}
\end{array}\right)} Y_{n+1} \oplus X_{n} \xrightarrow{\left(\begin{array}{lll}
\left(a_{n+1}\right. & \left.f_{n}\right)
\end{array} X_{n+1} \xrightarrow{g_{0} \delta}\right.}
\end{aligned}
$$

is a distinguished $n$-exangle. Note that $g_{0} \delta \in \mathbb{E}_{R}^{F}\left(X_{n+1}, Y_{1}\right)$ by the previous argument, we have the following exact sequence

$$
F Y_{1} \xrightarrow{F\binom{-g_{1}}{a_{1}}} F Y_{2} \oplus F X_{1} \xrightarrow{F\left(\begin{array}{cc}
-g_{2} & 0 \\
a_{2} & f_{1}
\end{array}\right)} F Y_{3} \oplus F X_{2} \xrightarrow{F\left(\begin{array}{cc}
-g_{3} & 0 \\
a_{3} & f_{2}
\end{array}\right)} \cdots
$$


in $\mathscr{A}$. In order to prove that $F g_{n}$ is an epimorphism in $\mathscr{A}$, suppose that $k: F Y_{n+1} \rightarrow M$ is a morphism in $\mathscr{A}$ satisfying $k \circ F g_{n}=0$. Let $(k, 0) \in \mathscr{C}\left(F Y_{n+1} \oplus F X_{n}, M\right)$. Since $k \circ$ $F g_{n}=0$, then $(k, 0)\left(\begin{array}{cc}-F g_{n} & 0 \\ F a_{n} & F f_{n-1}\end{array}\right)=\left(-k F g_{n}, 0\right)=0$. Thus there exists unique a morphism $s: F X_{n+1} \rightarrow M$, such that $s \circ\left(F a_{n+1}, F f_{n}\right)=(k, 0) . S o s \circ F a_{n+1}=k$ and $s \circ F f_{n}=0$. That is to say, we have the following commutative diagram


Note that $F f_{n}$ is an epimorphism, so we have $s=0$. Then $k=s \circ F a_{n+1}=0$. This shows that $F g_{n}$ is an epimorphism in $\mathscr{A}$, hence we have $\delta a_{n+1} \in \mathbb{E}_{R}^{F}$. Thus $\mathbb{E}_{R}^{F}$ is a subfunctor of $\mathbb{E}$.

Next, we need to show that $\mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$ is a subgroup of $\mathbb{E}\left(X_{n+1}, X_{0}\right)$. Note that $0 \in$ $\mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$, we only need to show $\delta^{\prime}-\delta \in \mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$ for any $\delta^{\prime}, \delta \in \mathbb{E}_{R}^{F}\left(X_{n+1}, X_{0}\right)$. For $(-\mathrm{id}, \mathrm{id}): X_{0} \oplus X_{0} \rightarrow X_{0}$ and $\binom{$ id }{ id }$: X_{n+1} \oplus X_{n+1} \rightarrow X_{n+1}$, we have $\delta^{\prime}-\delta=(-\mathrm{id}, \mathrm{id})(\delta \oplus$ $\left.\delta^{\prime}\right)\binom{$ id }{ id } , it is enough to show that $\delta \oplus \delta^{\prime} \in \mathbb{E}_{R}^{F}\left(X_{n+1} \oplus X_{n+1}, X_{0} \oplus X_{0}\right)$, and this follows from Proposition 3.2 in [1]. Thus $\mathbb{E}_{R}^{F}$ is an additive subfunctor of $\mathbb{E}$.

Finally, let $X_{n} \xrightarrow{f_{n}} X_{n+1} \xrightarrow{g_{n}} Y_{n+1}$ be any sequence of morphisms in $\mathscr{C}$. Assume that $f_{n}$ and $g_{n}$ are $\mathfrak{s}_{\mathbb{E}_{R}^{F}-\text { deflations. By (EA1), we know that } g_{n} \circ f_{n} \text { is an } \mathfrak{s} \text {-deflation. Thus we assume }}$

$$
\mathfrak{s}(\delta)=\left[Z_{0} \xrightarrow{h_{0}} Z_{1} \xrightarrow{h_{1}} Z_{2} \xrightarrow{h_{2}} \cdots \xrightarrow{h_{n-2}} Z_{n-1} \xrightarrow{h_{n-1}} X_{n} \xrightarrow{g_{n} f_{n}} Y_{n+1}\right] .
$$

Note that $F g_{n}$ and $F f_{n}$ are epimorphic, then $F\left(g_{n} f_{n}\right)$ is an epimorphism, so $\delta \in \mathbb{E}_{R}^{F}$. This shows that $\mathfrak{s}_{\mathbb{E}_{R}^{F}}$-deflations are closed under composition. Thus $\mathbb{E}_{R}^{F}$ is a closed subfunctor of $\mathbb{E}$.
(2) and (3) follow immediately from the construction of $\mathbb{E}_{R}^{F}$.

Remark 4.6. Dually, we obtain the statement with respect to $\mathbb{E}_{L}^{F}$ by applying the above proposition to a contravariant half exact functor $F: \mathscr{C} \rightarrow \mathscr{A}^{\text {op }}$.

Example 4.7. Let $\mathscr{H} \subseteq \mathscr{C}$ be a full subcategory. Define subfunctors $\mathbb{E}_{\mathscr{H}}$ and $\mathbb{E}^{\mathscr{H}}$ of $\mathbb{E}$ by

$$
\begin{aligned}
& \mathbb{E}_{\mathscr{H}}\left(X_{n+1}, X_{0}\right)=\left\{\delta \in \mathbb{E}\left(X_{n+1}, X_{0}\right) \mid\left(\delta_{\sharp}\right)_{H}=0 \text { for any } H \in \mathscr{H}\right\}, \\
& \mathbb{E}^{\mathscr{H}}\left(X_{n+1}, X_{0}\right)=\left\{\delta \in \mathbb{E}\left(X_{n+1}, X_{0}\right) \mid\left(\delta^{\sharp}\right)_{H}=0 \text { for any } H \in \mathscr{H}\right\} .
\end{aligned}
$$

In [1, Proposition 3.17], it is shown that $\mathbb{E}_{\mathscr{H}}$ and $\mathbb{E}^{\mathscr{H}}$ are closed subfunctors of $\mathbb{E}$. They are special cases of Theorem 4.5. Since the restricted Yoneda functors $Y_{\mathscr{H}}: \mathscr{C} \rightarrow \operatorname{Mod} \mathscr{H}$ and $Y^{\mathscr{H}}: \mathscr{C} \rightarrow \operatorname{Mod} \mathscr{H}^{o p}$ are half exact functors, moreover, $\mathbb{E}_{\mathscr{H}}=\mathbb{E}_{R}^{Y \mathscr{H}}$ and $\mathbb{E}^{\mathscr{H}}=\mathbb{E}_{L}^{Y^{\mathscr{H}}}$ hold. In fact, for any distinguished $n$-exangle

$$
X_{0} \xrightarrow{f_{0}} X_{1} \xrightarrow{f_{1}} \cdots \xrightarrow{f_{n-2}} X_{n-1} \xrightarrow{f_{n-1}} X_{n} \xrightarrow{f_{n}} X_{n+1} \xrightarrow{\delta},
$$

we have the following exact sequence

$$
\left.\left.\left.\left.\mathscr{C}\left(-, X_{0}\right)\right|_{\mathscr{H}} \xrightarrow{Y_{\mathscr{H}}\left(f_{0}\right)} \cdots \xrightarrow{Y_{\mathscr{H}}\left(f_{n-1}\right)} \mathscr{C}\left(-, X_{n}\right)\right|_{\mathscr{H}} \xrightarrow{Y_{\mathscr{H}}\left(f_{n}\right)} \mathscr{C}\left(-, X_{n+1}\right)\right|_{\mathscr{H}} \xrightarrow{\delta_{\sharp}} \mathbb{E}\left(-, X_{0}\right)\right|_{\mathscr{H}} .
$$

Thus we have $\mathbb{E}_{R}^{Y^{\mathscr{H}}}\left(X_{n+1}, X_{0}\right)=\mathbb{E}_{\mathscr{H}}\left(X_{n+1}, X_{0}\right)$.
Corollary 4.8. In Theorem 4.5, when $n=1$, it is just Proposition A in [9].
