# Nodal solutions for Logarithmic weighted $N$-Laplacian problem with exponential nonlinearities

#### Abstract

In this article, we study the following problem $$
-\operatorname{div}\left(\omega(x)|\nabla u|^{N-2} \nabla u\right)=\lambda f(x, u) \quad \text { in } \quad B, \quad u=0 \quad \text { on } \quad \partial B,
$$ where $B$ is the unit ball of $\mathbb{R}^{\mathbb{N}}, N \geq 2$ and $w(x)$ a singular weight of logarithm type. The reaction source $f(x, u)$ is a radial function with respect to $x$ and is subcritical or critical with respect to a maximal growth of exponential type. By using the constrained minimization in Nehari set coupled with the quantitative deformation lemma and degree theory, we prove the existence of nodal solutions.


Keywords: Weighted Sobolev space, $N$-Laplacian operator, Critical exponential growth, Nodal solutions.

## 1 Introduction and Main results

In this paper, we consider the following elliptic problem involving logarithmic weighted $N$-Laplacian:

-\operatorname{div}\left(\omega(x)|\nabla u|^{N-2} \nabla u\right) & =\lambda f(x, u) & & \text { in } \\
u & =0 & & \text { on } \quad \partial B
\end{aligned}\right.
$$

where $B=B(0,1)$ is the unit open ball in $\mathbb{R}^{N}, N>2$, $\lambda$ is a positive parameter, the weight function $w(x)$ is given by

$$
\begin{equation*}
\omega(x)=\left(\log \frac{1}{|x|}\right)^{\beta(N-1)} \text { or } \omega(x)=\left(\log \frac{e}{|x|}\right)^{\beta(N-1)} \beta \in[0,1) \tag{1.1}
\end{equation*}
$$

We assume that the nonlinearity $f(x, t): \bar{B} \times \mathbb{R} \rightarrow \mathbb{R}$ is a radial in $x$, continuous function and behaves like $\exp \left\{\alpha t^{\frac{N}{(N-1)(1-\beta)}}\right\}$ as $t \rightarrow+\infty$, for some $\alpha>0$ and $\beta \in[0,1)$.
Such an equation may arise in many fields of physics, such as in non-Newtonian fluids, reaction diffusion problem, turbulent flows in porous media and image treatment [1, 3, 18, 20]. Here we just give some references which are close to the problem we consider in this note.

Without the weight $w(x)$, the problem $\left(P_{\lambda}\right)$ has been widely studied by several authors with different nonlinearities. G. M. Figueredo and F.B. M. Nunes in [13], consider the following equation

-\operatorname{div}\left(a\left(|\nabla u|^{p}\right)|\nabla u|^{p-2} \nabla u\right)=f(u) \quad \text { in } \quad \Omega, u=0 \quad \text { on } \quad \partial \Omega, \tag{1.2}
\end{equation*}
$$

where $\Omega \subset \mathbb{R}^{N}$ is bounded, $1<p<N$, the nonlinearity $f: \mathbb{R} \rightarrow \mathbb{R}$ is a superlinear continuous function with exponential subcritical or exponential critical growth and the function $a$ is $C^{1}$. By using the minimization argument and deformation lemma, the authors proved the existence of a least energy nodal solutions for the equation (1.2) with two nodal domains.
Recently, when $a\left(|\nabla u|^{p}\right)=1$, X. sun and Y. song, see [19], studied the problem (1.2) in an open smooth bounded domain in the Heisenberg group $\mathbb{H}^{n}=\mathbb{C}^{n} \times \mathbb{R}$. We also mention the work of Y. Zhang, Y Yang and S. Liang, see [24], where they established the existence of changing-sign solutions to the problem (1.2) under logarithmic and exponential nonlinearities.

Weighted $N$-Laplacian elliptic problems of the following type

-\operatorname{div}\left(\omega(x)|\nabla u|^{N-2} \nabla u\right) & =f(x, u) & & \text { in } \\
u & >0 & & \text { in } \\
& > \\
u & =0 & & \text { on } \\
& \partial B
\end{array}\right.
$$

where the weight function $w(x)$ is given in (1.1) and the nonlinearity $f(x, t): \bar{B} \times \mathbb{R} \rightarrow \mathbb{R}$ is positive, have been investigated in literatures (see [9, 10, 11, 23] and the references therein). We notice that, the influence of weights on limiting inequalities of Trudinger-Moser type has been studied with some detail in $[5,6,7,8]$ and as consequence the weights have an important impact in the Sobolev norm.
Let $\Omega \subset \mathbb{R}^{N}$ be a bounded domain and $w \in L^{1}(\Omega)$ be a nonnegative function, the weighted sobolev space is defined as

W_{0}^{1, N}(\Omega, w)=c l\left\{u \in C_{0}^{\infty}(\Omega) / \int_{B}|\nabla u|^{N} w(x) d x<\infty\right\}
$$

For different proprieties and embedding results for the weighted Sobolev spaces, we can refer to [16].
Since the logarithmic weights have a particular significance and considered as the limiting situations of the embedding of the spaces $W_{0}^{1, N}(\Omega, w)$, we will consider the weight defined by (1.1). We then, restrict our attention to radial functions and consider the subspace

\mathbf{E}=W_{0, \text { rad }}^{1, N}(B, w)=c l\left\{\left.u \in C_{0, \text { rad }}^{\infty}(B)\left|\int_{B}\right| \nabla u\right|^{N} \omega(x) d x<\infty\right\}
$$

endowed with the norm

$$
\|u\|=\left(\int_{B}|\nabla u|^{N} \omega(x) d x\right)^{\frac{1}{N}}
$$

The choice of the weight induced in (1.1) and the space $\mathbf{E}$ are also motivated by the following exponential inequalities.
Theorem 1.1 [7] Let $\beta \in[0,1)$ and let $w$ be given by (1.1), then

\int_{B} e^{|u|^{\gamma}} d x<+\infty, \forall u \in \mathbf{E}, \text { if and only if } \gamma \leq \gamma_{N, \beta}=\frac{N}{(N-1)(1-\beta)}=\frac{N^{\prime}}{1-\beta} \tag{1.3}
\end{equation*}
$$

and

$$
\begin{equation*}
\sup _{\substack{u \in \mathbb{E} \\\|u\| \leq 1}} \int_{B} e^{\alpha|u|^{\gamma_{N, \beta}}} d x<+\infty \quad \Leftrightarrow \quad \alpha \leq \alpha_{N, \beta}=N\left[\omega_{N-1}^{\frac{1}{N-1}}(1-\beta)\right]^{\frac{1}{1-\beta}} \tag{1.4}
\end{equation*}
$$

where $\omega_{N-1}$ is the area of the unit sphere $S^{N-1}$ in $\mathbb{R}^{N}$ and $N^{\prime}$ is the Hölder conjugate of $N$.
Let $\gamma:=\gamma_{N, \beta}=\frac{N^{\prime}}{1-\beta}$, in view of inequalities (1.5) and (1.6), we say that $f$ has subcritical growth at $+\infty$ if

\lim _{s \rightarrow+\infty} \frac{|f(x, s)|}{e^{\alpha s^{\gamma}}}=0, \quad \text { for all } \alpha>0 \tag{1.5}
\end{equation*}
$$

and $f$ has critical growth at $+\infty$ if there exists some $\alpha_{0}>0$,

$$
\begin{equation*}
\lim _{s \rightarrow+\infty} \frac{|f(x, s)|}{e^{\alpha s^{\gamma}}}=0, \quad \forall \alpha>\alpha_{0} \text { and } \quad \lim _{s \rightarrow+\infty} \frac{|f(x, s)|}{e^{\alpha s^{\gamma}}}=+\infty, \quad \forall \alpha>\alpha_{0} \tag{1.6}
\end{equation*}
$$

In this paper, we deal with problem $\left(P_{\lambda}\right)$ under subcritical and critical growth nonlinearities. Furthermore, we suppose that $f(x, t)$ satisfies the following hypothesis:
$\left(V_{1}\right) f: B \times \mathbb{R} \rightarrow \mathbb{R}$ is $C^{1}$ and radial in $x$.
( $V_{2}$ ) There exist $\theta>N$ such that we have

$$
0<\theta F(x, t) \leq t f(x, t), \forall(x, t) \in B \times \mathbb{R} \backslash\{0\}
$$

where

$$
F(x, t)=\int_{0}^{t} f(x, s) d s
$$

$\left(V_{3}\right)$ For each $x \in B, t \mapsto \frac{f(x, t)}{|t|^{N-1}}$ is increasing for $t \in \mathbb{R} \backslash\{0\}$.
$\left(V_{4}\right) \lim _{t \rightarrow 0} \frac{|f(x, t)|}{|t|^{N-1}}=0$.
We give an example of such nonlinearity. The nonlinearity $f(x, t)=|t|^{N-1} t+|t|^{N} t \exp \left(\alpha|t|^{\gamma}\right)$ satisfies the assumptions $\left(V_{1}\right),\left(V_{2}\right),\left(V_{3}\right)$ and $\left(V_{4}\right)$.

We will consider the following definition of solutions.

Definition 1.1 We say that a function $u \in \mathbf{E}$ is a weak solution of the problem $\left(P_{\lambda}\right)$ if

\int_{B}|\nabla u|^{N-2} \nabla u \cdot \nabla \varphi w(x) d x=\lambda \int_{B} f(x, u) \varphi d x, \forall \varphi \in \mathbf{E} .
$$

Let $\mathcal{J}_{\lambda}: \mathbf{E} \rightarrow \mathbb{R}$ be the functional given by

\mathcal{J}_{\lambda}(u)=\frac{1}{N} \int_{B}|\nabla u|^{N} w(x) d x-\lambda \int_{B} F(x, u) d x \tag{1.7}
\end{equation*}
$$

where

$$
F(x, t)=\int_{0}^{t} f(x, s) d s
$$

The energy functional $\mathcal{J}_{\lambda}$ is well defined and of class $C^{1}$ since there exist $a, C>0$ positive constants and there exists $t_{1}>1$ such for that

$$
|f(x, t)| \leq C e^{a t^{\gamma}}, \quad \forall|t|>t_{1}
$$

whenever the nonlinearity $f(x, t)$ is critical or subcritical at $+\infty$.
It is quite clear that finding non trivial weak solutions to the problem $\left(P_{\lambda}\right)$ is equivalent to finding non-zero critical points of the functional $\mathcal{J}_{\lambda}$. Moreover, we have

$$
\left\langle\mathcal{J}_{\lambda}^{\prime}(u), \varphi\right\rangle=\mathcal{J}_{\lambda}^{\prime}(u) \varphi=\int_{B}\left(\omega(x)|\nabla u|^{N-2} \nabla u \nabla \varphi\right) d x-\lambda \int_{B} f(x, u) \varphi d x, \varphi \in \mathbf{E}
$$

We define the Nehari set as

$$
\mathcal{N}_{\lambda}:=\left\{u \in \mathbf{E}:\left\langle\mathcal{J}_{\lambda}^{\prime}(u), u^{+}\right\rangle=\left\langle\mathcal{J}_{\lambda}^{\prime}(u), u^{-}\right\rangle=0, u^{+} \neq 0, u^{-} \neq 0\right\}
$$

where $u^{+}=\max \{u(x), 0\}, u^{-}=\min \{u(x), 0\}$.
It's easy to verify the following decomposition

$$
\mathcal{J}_{\lambda}(u)=\mathcal{J}_{\lambda}\left(u^{+}\right)+\mathcal{J}_{\lambda}\left(u^{-}\right)
$$

and

$$
\left\langle\mathcal{J}_{\lambda}^{\prime}(u), u^{+}\right\rangle=\left\langle\mathcal{J}_{\lambda}^{\prime}\left(u^{+}\right), u^{+}\right\rangle \text {and }\left\langle\mathcal{J}_{\lambda}^{\prime}(u), u^{-}\right\rangle=\left\langle\mathcal{J}_{\lambda}^{\prime}\left(u^{-}\right), u^{-}\right\rangle
$$

We also give the following definitions of the so called nodal solutions and least energy sign-changing solution of problem $\left(P_{\lambda}\right)$.

Definition $1.2 \quad \bullet v \in \mathbf{E}$ is called nodal or sign-changing solution of problem $\left(P_{\lambda}\right)$ if $v$ is a solution of problem $\left(P_{\lambda}\right)$ and $v^{ \pm} \neq 0$ a.e in $B$.

- $v \in \mathbf{E}$ is called least energy sign-changing solution of problem $\left(P_{\lambda}\right)$ if $v$ is a sign-changing solution of $\left(P_{\lambda}\right)$ and

$$
\mathcal{J}_{\lambda}(v)=\inf \left\{\mathcal{J}_{\lambda}(u): \mathcal{J}_{\lambda}^{\prime}(u)=0, u^{ \pm} \neq 0 \text { a.e in } B\right\}
$$

Influenced by the works cited above, we try to find a minimize of the energy functional $\mathcal{J}_{\lambda}$ over the following minimization problem,

$$
c_{\lambda}=\inf _{u \in \mathcal{N}_{\lambda}} \mathcal{J}_{\lambda}(u)
$$

Our approach is based on the Nehari manifold method, which was introduced in [15] and is by now a wellestablished and useful tool in finding solutions of problems with a variational structure, see [14].
To our best knowledge, there are few results for the nodal solutions to the N -weighted Lapalace equation with critical exponential nonlinearity on the weighted Sobolev space $\mathbf{E}$.
Now, we give our main results as follows:
Theorem 1.2 Let $f(x, t)$ be a function that has a subcritical growth at $+\infty\left(V_{1}\right),\left(V_{2}\right),\left(V_{3}\right)$, and $\left(V_{4}\right)$ are satisfied. For $\lambda>0$, the problem $\left(P_{\lambda}\right)$ has a least energy nodal (sign-changing) radial solution $v \in \mathcal{N}_{\lambda}$.

For a critical growth nonlinearity, the following result holds.
Theorem 1.3 Assume that $f(x, t)$ has a critical growth at $+\infty$ for some $\alpha_{0}$ and $\left(V_{1}\right),\left(V_{2}\right),\left(V_{3}\right)$ and $\left(V_{4}\right)$ are satisfied. Then, there exists $\lambda^{*}>0$ such that for $\lambda>\lambda^{*}$, problem $\left(P_{\lambda}\right)$ has a least energy nodal (sign-changing) radial solution $v \in \mathcal{N}_{\lambda}$.

This present work is organized as follows: in section 2, some preliminaries for the compactness analysis are presented. In section 3, we give some technical key lemmas. In section 4 we prove our result in the subcritical case. Section 5 is devoted for the critical case which is more difficult. We use a concentration compactness result of Lions type to prove Theorem 1.3.
Finally, we note that a constant $C$ may change from line to another and sometimes we index the constants in order to show how they change.

## 2 Preliminaries for the compactness analysis

In this section, we will present a number of technical Lemmas for our future use. We begin by the radial Lemma.

Lemma 2.1 [7]Let u be a radially symmetric function in $C_{0}^{1}(B)$. Then, we have

|u(x)| \leq \frac{|\log (|x|)|^{\frac{1-\beta}{N^{\prime}}}}{\omega_{N-1}^{\frac{1}{N}}(1-\beta)^{\frac{1}{N^{\prime}}}}\|u\|
$$

where $\omega_{N-1}$ is the area of the unit sphere $S^{N-1}$ in $\mathbb{R}^{N}$.
It follows that the embedding $\mathbf{E} \hookrightarrow L^{q}(B)$ is continuous for all $q \geq 1$, and that there exists a constant $C>0$ such that $\|u\|_{N^{\prime} q} \leq C\|u\|$, for all $u \in \mathbf{E}$. Moreover, the embedding $\mathbf{E} \hookrightarrow L^{q}(B)$ is compact for all $q \geq N$.

Lemma 2.2 Let $\left(u_{k}\right)_{k}$ be a sequence in $\mathbf{E}$. Suppose that, $\left\|u_{k}\right\|=1, u_{k} \rightharpoonup u$ weakly in $\mathbf{E}, u_{k}(x) \rightarrow$ $u(x)$ a.e. in $B, \nabla u_{k}(x) \rightarrow \nabla u(x)$ a.e. in $B$ and $u \not \equiv 0$. Then

$$
\sup _{k} \int_{B} e^{p \alpha_{N, \beta}\left|u_{k}\right|^{\gamma}} d x<+\infty, \text { where } \alpha_{N, \beta}=N\left[w_{N-1}^{\frac{1}{N-1}}(1-\beta)\right]^{\frac{1}{1-\beta}},
$$

for all $1<p<\mathcal{U}(u)$, where $\mathcal{U}(u)$ is given by:

$$
\mathcal{U}(u):=\left\{\begin{array}{cl}
\frac{1}{\left(1-\|u\|^{N}\right)^{\frac{\gamma}{N}}} & \text { if }\|u\|<1 \\
+\infty & \text { if }\|u\|=1
\end{array}\right.
$$

Proof: For $a, b \in \mathbb{R}, q>1$. If $q^{\prime}$ its conjugate i.e. $\frac{1}{q}+\frac{1}{q^{\prime}}=1$ we have, by young inequality, that

e^{a+b} \leq \frac{1}{q} e^{q a}+\frac{1}{q^{\prime}} e^{q^{\prime} b}
$$

Also, we have

$$
(1+a)^{q} \leq(1+\varepsilon) a^{q}+\left(1-\frac{1}{(1+\varepsilon)^{\frac{1}{q-1}}}\right)^{1-q}, \quad \forall a \geq 0, \quad \forall \varepsilon>0 \text { and } \forall q>1
$$

So, we get

$$
\begin{aligned}
\left|u_{k}\right|^{\gamma} & =\left|u_{k}-u+u\right|^{\gamma} \\
& \leq\left(\left|u_{k}-u\right|+|u|\right)^{\gamma} \\
& \leq(1+\varepsilon)\left|u_{k}-u\right|^{\gamma}+\left(1-\frac{1}{(1+\varepsilon)^{\frac{1}{\gamma-1}}}\right)^{1-\gamma}|u|^{\gamma}
\end{aligned}
$$

which implies that

$$
\begin{aligned}
\int_{B} e^{p \alpha_{N, \beta}\left|u_{k}\right|^{\gamma}} d x & \leq \frac{1}{q} \int_{B} e^{p q \alpha_{N, \beta}(1+\varepsilon)\left|u_{k}-u\right|^{\gamma}} d x \\
& +\frac{1}{q^{\prime}} \int_{B} e^{p q^{\prime} \alpha_{N, \beta}\left(1-\frac{1}{\left.(1+\varepsilon)^{\frac{1}{\gamma-1}}\right)^{1-\gamma}|u|^{\gamma}}\right.} d x
\end{aligned}
$$

for any $p>1$. Since $\left(1-\frac{1}{(1+\varepsilon)^{\frac{1}{\gamma-1}}}\right)^{1-\gamma} \leq 1$, then

$$
\frac{1}{q^{\prime}} \int_{B} e^{p q^{\prime} \alpha_{N, \beta}\left(1-\frac{1}{\left.(1+\varepsilon)^{\frac{1}{\gamma-1}}\right)^{1-\gamma}|u|^{\gamma}}\right.} d x \leq \frac{1}{q^{\prime}} \int_{B} e^{p q^{\prime} \alpha_{N, \beta}|u|^{\gamma}} d x=\frac{1}{q^{\prime}} \int_{B} e^{\left(\left(p q^{\prime} \alpha_{N, \beta}\right)^{\frac{1}{\gamma}}|u|\right)^{\gamma}} d x
$$

From (1.5), the last integral is finite.
To complete the evidence, we have to prove that for every $p$ such that $1<p<\mathcal{U}(u)$,

$$
\begin{equation*}
\sup _{k} \int_{B} e^{p q \alpha_{N, \beta}(1+\varepsilon)\left|u_{k}-u\right|^{\gamma}} d x<+\infty \tag{2.1}
\end{equation*}
$$

for some $\varepsilon>0$ and $q>1$.
In the following, we suppose that $\|u\|<1$ and in the case of $\|u\|=1$, the proof is similar.
When

$$
\|u\|<1
$$

and

$$
p<\frac{1}{\left(1-\|u\|^{N}\right)^{\frac{\gamma}{N}}},
$$

there exists $\nu>0$ such that

$$
p\left(1-\|u\|^{N}\right)^{\frac{\gamma}{N}}(1+\nu)<1 .
$$

On the other hand, From the Brezis-Lieb's lemma [4] it holds that

$$
\left\|u_{k}-u\right\|^{N}=\left\|u_{k}\right\|^{N}-\|u\|^{N}+o(1) \text { where } o(1) \rightarrow 0 \text { as } k \rightarrow+\infty
$$

Then,

$$
\left\|u_{k}-u\right\|^{N}=1-\|u\|^{N}+o(1)
$$

so,

$$
\lim _{k \rightarrow+\infty}\left\|u_{k}-u\right\|^{\gamma}=\left(1-\|u\|^{N}\right)^{\frac{\gamma}{N}}
$$

Therefore, for every $\varepsilon>0$, there exists $k_{\varepsilon} \geq 1$ such that

$$
\left\|u_{k}-u\right\|^{\gamma} \leq(1+\varepsilon)\left(1-\|u\|^{N}\right)^{\frac{\gamma}{N}}, \quad \forall k \geq k_{\varepsilon} .
$$

Then, for $q=1+\varepsilon$ with $\varepsilon=\sqrt[3]{1+\nu}-1$ and for any $k \geq k_{\varepsilon}$, we have

p q(1+\varepsilon)\left\|u_{k}-u\right\|^{\gamma} \leq 1 .
$$

Consequently,

$$
\begin{aligned}
\int_{B} e^{p q \alpha_{N, \beta}(1+\varepsilon)\left|u_{k}-u\right|^{\gamma}} d x & \leq \int_{B} e^{(1+\varepsilon) p q \alpha_{N, \beta}\left(\frac{\left|u_{k}-u\right|}{\left.\| u_{k}-u \mid\right)}\right)^{\gamma}\left\|u_{k}-u\right\|^{\gamma}} d x \\
& \leq \int_{B} e^{\alpha_{N, \beta}\left(\frac{\left|u_{k}-u\right|}{\left\|u_{k}-u\right\|}\right)^{\gamma}} d x \\
& \leq \sup _{\|u\| \leq 1} \int_{B} e^{\alpha_{N, \beta}|u|^{\gamma}} d x<+\infty .
\end{aligned}
$$

Now, (2.1) follows from (1.4). This complete the proof. A second important Lemma.
Lemma 2.3 [14] Let $\Omega \subset \mathbb{R}^{\mathbb{N}}$ be a bounded domain and $f: \bar{\Omega} \times \mathbb{R}$ be a continuous function. Let $\left\{u_{n}\right\}_{n}$ be a sequence in $L^{1}(\Omega)$ converging to $u$ in $L^{1}(\Omega)$. Assume that $f\left(x, u_{n}\right)$ and $f(x, u)$ are also in $L^{1}(\Omega)$. If

$$
\int_{\Omega}\left|f\left(x, u_{n}\right) u_{n}\right| d x \leq C
$$

where $C$ is a positive constant, then

$$
f\left(x, u_{n}\right) \rightarrow f(x, u) \text { in } L^{1}(\Omega)
$$

## 3 Some technical lemmas

In the following we assume, unless otherwise stated, that the function $f$ satisfies the conditions $\left(V_{1}\right)$ to $\left(V_{4}\right)$. Let $u \mathbf{E}$ with $u^{ \pm} \not \equiv 0$ a.e. in the ball $B$, and we define the function $\Upsilon_{u}:[0, \infty) \times[0, \infty) \rightarrow \mathbb{R}$ and mapping $L_{u}:[0, \infty) \times[0, \infty) \rightarrow \mathbb{R}^{2}$ as

\Upsilon_{u}(p, q)=\mathcal{J}_{\lambda}\left(p u^{+}+q u^{-}\right), \tag{3.1}
\end{equation*}
$$

and

Lemma 3.1 (i) For each $u \mathbf{E}$ with $u^{+} \neq 0$ and $u^{-} \neq 0$, there exists an unique couple $\left(p_{u}, q_{u}\right) \in$ $(0, \infty) \times(0, \infty)$ such that $p_{u} u^{+}+q_{u} u^{-} \in \mathcal{N}_{\lambda}$. In particular, the set $\mathcal{N}_{\lambda}$ is nonempty.
(ii) For all $p, q \geq 0$ with $(p, q) \neq\left(p_{u}, q_{u}\right)$, we have

Now we will show the uniqueness of the couple $\left(p_{u}, q_{u}\right)$. Indeed, it is sufficient to show that if $u \in \mathcal{N}_{\lambda}$ and $p_{0} u^{+}+q_{0} u^{-} \in \mathcal{N}_{\lambda}$ with $p_{0}>0$ and $q_{0}>0$, then $\left(p_{0}, q_{0}\right)=(1,1)$. Let us assume that $u \in \mathcal{N}_{\lambda}$ and $p_{0} u^{+}+q_{0} u^{-} \in \mathcal{N}_{\lambda}$. Therefore, if $\left\{\lambda_{n}\right\} \subset(0, \infty)$ satisfies $\lambda_{n} \rightarrow \infty$ as $n \rightarrow \infty$, then up to subsequence, there exists $\bar{p}, \bar{q}>0$, such that $p_{\lambda_{n}} \rightarrow \bar{p}$ and $q_{\lambda_{n}} \rightarrow \bar{q}$.
We Claim that $\bar{p}=\bar{q}=0$. We proceed by contradiction and suppose that $\bar{p}>0$ and $\bar{q}>0$. For each $n \in \mathbb{N}, p_{\lambda_{n}} u^{+}+q_{\lambda_{n}} u^{-} \in \mathcal{N}_{\lambda_{n}}$. So,

Choose $\tau \in\left(0, \min \left\{\frac{1}{4}, \frac{\delta}{4\left\|u_{0}\right\|}\right\}\right)$. Let $D=(1-\tau, 1+\tau) \times(1-\tau, 1+\tau)$ and define $g: D \rightarrow \mathbf{E}$, by

According to the Quantitative Deformation Lemma [[21], Lemma 2.3], there exists a deformation $\eta \in C([0,1] \times g(D), \mathbf{E})$ such that:
(1) $\eta(1, v)=v$, if $v \notin \mathcal{J}_{\lambda}^{-1}\left(\left[c_{\lambda}-2 \epsilon, c_{\lambda}+2 \epsilon\right]\right) \cap S_{2 \delta}$
(2) $\eta\left(1, \mathcal{J}_{\lambda}^{c_{\lambda}+\epsilon} \cap S_{\delta}\right) \subset \mathcal{J}_{\lambda}{ }^{c_{\lambda}-\epsilon}$,
(3) $\mathcal{J}_{\lambda}(\eta(1, v)) \leq \mathcal{J}_{\lambda}(v)$, for all $v \in \mathbf{E}$.

By lemma $3.1(i i)$, we have $\mathcal{J}_{\lambda}(g(\rho, \vartheta)) \leq c_{\lambda}$. In addition, we have,

Then we have $\operatorname{det} \mathrm{J} \neq 0$. Therefore, the point $(0,1)$ is the unique isolated zero of the $C^{1}$ function $\Upsilon_{0}$. By using the Brouwer's degree in $\mathbb{R}^{2}$, we deduce that $\operatorname{deg}\left(\Upsilon_{0}, D, 0\right)=1$.
Now, it follows from (3.20) and (1) that $g(\rho, \vartheta)=\bar{g}(\rho, \vartheta)$ on $\partial D$. For the boundary dependence of Brouwer's degree ( see [[12], Theorem 4.5]), there holds $\operatorname{deg}\left(\Upsilon_{1}, D, 0\right)=\operatorname{deg}\left(\Upsilon_{0}, D, 0\right)=1$. Therefore, there exists some $(\bar{\rho}, \bar{\vartheta}) \in D$ such that

From Lemma (3.1), it follows that there exists a unique couple $\left(p_{\nu}, q_{\nu}\right) \in[0, \infty) \times[0, \infty)$ such that $p_{\nu} v_{1}+q_{\nu} v_{2} \in \mathcal{N}_{\lambda}$. So, $\mathcal{J}_{\lambda}\left(p_{\nu} v_{1}+q_{\nu} v_{2}\right) \geq c_{\lambda}$. Moreover, using (3.21), we obtain that $\left\langle\mathcal{J}_{\lambda}^{\prime}(\nu), \nu^{ \pm}\right\rangle=0$. Then, by Lemma (3.2), we have $0<p_{\nu}, q_{\nu} \leq 1$.

Then, up to a subsequence, there exists $u \in \mathbf{E}$ such that

It is clearly that $\left\{v_{n}\right\}$ is bounded by Lemma (3.3). Then, up to a subsequence, there exists $v \in \mathbf{E}$ such that

and $v^{-} \neq 0$.
From the lower semi continuity of norm and (4.7), it follows that

Proof of Theorem 1.2. From Lemma 3.5, Lemma 3.6 and Lemma 4.2, we deduce that $v$ is a least energy sign-changing solution form problem $\left(P_{\lambda}\right)$ with exactly tow nodal domains.

## 5 The critical case

Lemma 5.1 There exists $\lambda^{*}>0$ such that if $\lambda \geq \lambda^{*}$, and $\left\{v_{n}\right\} \subset \mathcal{N}_{\lambda}$ is a minimizing sequence for $c_{\lambda}$, then there exists some $v \in \mathcal{N}_{\lambda}$ such that $\mathcal{J}_{\lambda}(v)=c_{\lambda}$.

Proof. Let $\left\{v_{n}\right\} \subset \mathcal{N}_{\lambda}$ be a sequence such that $\lim _{n \rightarrow \infty} \mathcal{J}_{\lambda}\left(v_{n}\right)=c_{\lambda}$. We have

Claim 1. $\nabla v_{n}(x) \rightarrow \nabla v(x)$ a.e. in $B$ and $v$ is a solution of the problem $\left(P_{\lambda}\right)$.
Indeed, for any $\xi>0$, let $\mathcal{A}_{\eta}=\left\{x \in B,\left|v_{n}-v\right| \geq \xi\right\}$. For all $t \in \mathbb{R}$, for all positive $c>0$, we have

$$
c t \leq e^{t}+c^{2}
$$

It follows that for $t=\alpha_{N, \beta}\left(\frac{\left|v_{n}-v\right|}{\left\|v_{n}-v\right\|}\right)^{\gamma}, c=\frac{1}{\alpha_{N, \beta}}\left\|v_{n}-v\right\|^{\gamma}$, we get

$$
\begin{aligned}
\left|v_{n}-v\right|^{\gamma} & \leq e^{\alpha_{N, \beta}\left(\frac{\left|v_{n}-v\right|}{\left\|v_{n}-v\right\|}\right)^{\gamma}}+\frac{1}{\alpha_{N, \beta}^{2}}\left\|v_{n}-v\right\|^{2 \gamma} \\
& \leq e^{\alpha_{N, \beta}\left(\frac{\left|v_{n}-v\right|}{\left\|v_{n}-v\right\|}\right)^{\gamma}}+C_{1}(N)
\end{aligned}
$$

where $C_{1}(N)$ is a constant depending only on $N$ and the upper bound of $\left\|v_{n}\right\|$. So, if we denote by $\mathcal{L}\left(\mathcal{A}_{\xi}\right)$ the Lebesgue measure of the set $\mathcal{A}_{\xi}$, we obtain

$$
\begin{aligned}
\mathcal{L}\left(\mathcal{A}_{\xi}\right)=\int_{\mathcal{A}_{\xi}} e^{\left|v_{n}-v\right|^{\gamma}} e^{-\left|v_{n}-v\right|^{\gamma}} d x & \leq e^{-\xi^{\gamma}} \int_{\mathcal{A}_{\xi}} \exp \left(e^{\alpha_{N, \beta}\left(\frac{\left|v_{n}-v\right|}{\left\|v_{n}-v\right\|}\right)^{\gamma}}+C_{1}(N)\right) d x \\
& \leq e^{-\xi^{\gamma}} e^{C_{1}(N)} \int_{B} \exp \left(\alpha_{N, \beta}\left(\frac{\left|v_{n}-v\right|}{\left\|v_{n}-v\right\|}\right)^{\gamma}\right) d x \\
& \leq e^{-\xi^{\gamma}} C_{2}(N) \xrightarrow[\rightarrow]{ } 0 \text { as } \xi \rightarrow+\infty
\end{aligned}
$$

where $C_{2}(N)$ is a positive constant depending only on $N$ and the upper bound of $\left\|v_{n}\right\|$. It follows that

$$
\begin{equation*}
\int_{\mathcal{A}_{\xi}}\left|\nabla v_{n}-\nabla v\right| d x \leq C e^{-\frac{1}{2} \xi^{\gamma}}\left(\int_{B}\left|\nabla v_{n}-\nabla v\right|^{2} \omega(x) d x\right)^{\frac{1}{2}} \rightarrow 0 \text { as } \xi \rightarrow+\infty \tag{5.8}
\end{equation*}
$$

We define for $\xi>0$, the following truncation function

$$
T_{\xi}(s):=\left\{\begin{array}{cc}
s & \text { if }|s|<\xi \\
\xi \frac{s}{|s|} & \text { if }|s| \geq \xi
\end{array}\right.
$$

If we take $\varphi=T_{\xi}\left(v_{n}-v\right) \in \mathbf{E}$, in (5.2) then with $\nabla \varphi=\chi_{\mathcal{A}_{\xi}} \nabla\left(v_{n}-v\right)$, we obtain

$$
\begin{array}{r}
\left|\int_{B \backslash \mathcal{A}_{\xi}} \omega(x)\left(\left|\nabla v_{n}\right|^{N-2} \nabla v_{n}-|\nabla v|^{N-2} \nabla v\right) \cdot\left(\nabla v_{n}-\nabla v\right) d x\right| \leq \\
\left.\left|\int_{B \backslash \mathcal{A}_{\xi}} \omega(x)\right| \nabla v\right|^{N-2} \nabla v \cdot\left(\nabla v_{n}-\nabla v\right) d x \mid+\int_{B} f\left(x, v_{n}\right) T_{\xi}\left(v_{n}-v\right) d x+\varepsilon_{n}\left\|v_{n}-v\right\| \leq \\
\left.\left|\int_{B} \omega(x)\right| \nabla v\right|^{N-2} \nabla v \cdot\left(\nabla v_{n}-\nabla v\right) d x \mid+\int_{B} f\left(x, v_{n}\right) T_{\xi}\left(v_{n}-v\right) d x+\varepsilon_{n}\left\|v_{n}-v\right\|
\end{array}
$$

where $\varepsilon_{n} \rightarrow 0$ as $n \rightarrow+\infty$.
Since $v_{n} \rightharpoonup v$ weakly, then $\int_{B} \omega(x)|\nabla v|^{N-2} \nabla v \cdot\left(\nabla v_{n}-\nabla v\right) \rightarrow 0$. Moreover, by (5.4) and the Lebesgue dominated convergence Theorem, we get

$$
\int_{B} f\left(x, v_{n}\right) T_{\xi}\left(v_{n}-v\right) d x \rightarrow 0 \text { as } n \rightarrow+\infty
$$

Using the well known inequality,

\left.\left.\langle | x\right|^{N-2} x-|y|^{N-2} y, x-y\right\rangle \geq 2^{2-N}|x-y|^{N} \forall x, y \in \mathbb{R}^{N}, \quad N \geq 2
$$

$\langle\cdot, \cdot\rangle$ is the inner product in $\mathbb{R}^{\mathbb{N}}$, one has

$$
\int_{B \backslash \mathcal{A}_{\xi}} \omega(x)\left|\nabla v_{n}-\nabla v\right|^{N} d x \rightarrow 0 .
$$

Therefore,

$$
\begin{equation*}
\int_{B \backslash \mathcal{A}_{\xi}}\left|\nabla v_{n}-\nabla v\right| d x \leq\left(\int_{B \backslash \mathcal{A}_{\xi}} \omega(x)\left|\nabla v_{n}-\nabla v\right|^{N} d x\right)^{\frac{1}{N}}\left(\mathcal{L}\left(B \backslash \mathcal{A}_{\xi}\right)\right)^{\frac{1}{N^{\prime}}} \rightarrow 0 \text { as } n \rightarrow+\infty \tag{5.9}
\end{equation*}
$$

From (5.8) and (5.9), we deduce that

$$
\int_{B}\left|\nabla v_{n}-\nabla v\right| d x \rightarrow 0 \text { as } n \rightarrow+\infty
$$

Therefore, $\nabla v_{n}(x) \rightarrow \nabla u(x)$ a.e. in $B$.

On the other hand,

$$
\left(\left|\nabla v_{n}\right|^{N-2} \nabla v_{n}\right) \text { is bounded in }\left(L^{\frac{N}{N-1}}(B, \omega)\right)^{N}
$$

Then, up to subsequence, we can assume that

$$
\begin{equation*}
\left|\nabla v_{n}\right|^{N-2} \nabla v_{n} \rightharpoonup|\nabla v|^{N-2} \nabla v \text { weakly in }\left(L^{\frac{N}{N-1}}(B, \omega)\right)^{N} . \tag{5.10}
\end{equation*}
$$

Therefore, passing to the limit in (5.2) and using (5.4), (5.10), the convergence everywhere of the gradient, we obtain that $v$ is a solution of problem $\left(P_{\lambda}\right)$. Claim 1 is proved.
$\underline{\text { Claim 2. }} v^{+} \neq 0$ and $v^{-} \neq 0$. Suppose, by contradiction, $v^{+}=0$. Therefore, $\int_{B} F\left(x, v_{n}\right) d x \rightarrow 0$ and consequently we get

\frac{1}{N}\left\|v_{n}\right\|^{N} \rightarrow c_{\lambda}<\frac{1}{N}\left(\frac{\alpha_{N, \beta}}{\alpha_{0}}\right)^{\frac{N}{\gamma}} . \tag{5.11}

First, we claim that there exists $q>1$ such that

\int_{B}\left|f\left(x, v_{n}\right)\right|^{q} d x \leq C \tag{5.12}
\end{equation*}
$$

By (5.2), we have

\left|\left\|v_{n}\right\|^{N}-\int_{B} f\left(x, v_{n}\right) v_{n} d x\right| \leq C \varepsilon_{n}
$$

So

\left\|v_{n}\right\|^{N} \leq C \varepsilon_{n}+\left(\int_{B}\left|f\left(x, v_{n}\right)\right|^{q} d x\right)^{\frac{1}{q}}\left(\int_{B}\left|v_{n}\right|^{q^{\prime}} d x\right)^{\frac{1}{q^{\prime}}}
$$

where $q^{\prime}$ is the conjugate of $q$. Since $\left(v_{n}\right)$ converge to 0 in $L^{q^{\prime}}(B)$

\lim _{n \rightarrow+\infty}\left\|v_{n}\right\|^{N}=0
$$

According to Lemma 3.3, this result cannot occur. Now for the proof of the claim (5.12), since $f$ has critical growth, for every $\varepsilon>0$ and $q>1$ there exists $t_{\varepsilon}>0$ and $C>0$ such that for all $|t| \geq t_{\varepsilon}$, we have

$$
|f(x, t)|^{q} \leq C e^{\alpha_{0}(\varepsilon+1) t^{\gamma}}
$$

Consequently,

$$
\begin{aligned}
\int_{B}\left|f\left(x, v_{n}\right)\right|^{q} d x & =\int_{\left\{\left|v_{n}\right| \leq t_{\varepsilon}\right\}}\left|f\left(x, v_{n}\right)\right|^{q} d x+\int_{\left\{\left|v_{n}\right|>t_{\varepsilon}\right\}}\left|f\left(x, v_{n}\right)\right|^{q} d x \\
& \leq \omega_{N-1} \max _{B \times\left[-t_{\varepsilon}, t_{\varepsilon}\right]}|f(x, t)|^{q}+C \int_{B} e^{\alpha_{0}(\varepsilon+1)\left|v_{n}\right|^{\gamma}} d x
\end{aligned}
$$

Since $N c_{\lambda}<\left(\frac{\alpha_{N, \beta}}{\alpha_{0}}\right)^{\frac{N}{\gamma}}$, there exists $\eta \in\left(0, \frac{1}{N}\right)$ such that $N c_{\lambda}=(1-\eta)\left(\frac{\alpha_{N, \beta}}{\alpha_{0}}\right)^{\frac{N}{\gamma}}$. On the other hand, $\left\|v_{n}\right\|^{\gamma} \rightarrow\left(N c_{\lambda}\right)^{\frac{\gamma}{N}}$, so there exists $n_{\eta}>0$ such that for all $n \geq n_{\eta}$, we get $\left\|v_{n}\right\|^{\gamma} \leq(1-\eta) \frac{\alpha_{N, \beta}}{\alpha_{0}}$. Therefore,

$$
\alpha_{0}(1+\varepsilon)\left(\frac{\left|v_{n}\right|}{\left\|v_{n}\right\|}\right)^{\gamma}\left\|v_{n}\right\|^{\gamma} \leq(1+\varepsilon)(1-\eta) \alpha_{N, \beta}
$$

We choose $\varepsilon>0$ small enough to get

$$
\alpha_{0}(1+\varepsilon)\left\|v_{n}\right\|^{\gamma} \leq \alpha_{N, \beta} .
$$

So, the second integral is uniformly bounded in view of (1.4) and the claim is proved.
Since $\left(v_{n}\right)$ is bounded, up to a subsequence, we can assume that $\left\|v_{n}\right\| \rightarrow \rho>0$. We affirm that $\mathcal{J}_{\lambda}(v)=c_{\lambda}$. Indeed, by $\left(V_{2}\right)$ and claim 2, we have

$$
\begin{equation*}
\mathcal{J}_{\lambda}(v)=\frac{1}{N} \int_{B}[f(x, v) v-N F(x, v)] d x \geq 0 \tag{5.13}
\end{equation*}
$$

Now, using the lower semi continuity of the norm and (5.5), we get,

$$
\mathcal{J}_{\lambda}(v) \leq \frac{1}{N} \liminf _{n \rightarrow \rightarrow \infty}\left\|v_{n}\right\|^{N}-\int_{B} F(x, v) d x=c_{\lambda} .
$$

Suppose that

$$
\mathcal{J}_{\lambda}(v)<c_{\lambda}
$$

Then

$$
\begin{equation*}
\|v\|^{N}<\rho^{N} \tag{5.14}
\end{equation*}
$$

In addition,

$$
\begin{equation*}
\frac{1}{N} \lim _{n \rightarrow+\infty}\left\|v_{n}\right\|^{N}=\left(c_{\lambda}+\int_{B} F(x, v) d x\right) \tag{5.15}
\end{equation*}
$$

which means that

$$
\rho^{N}=N\left(c_{\lambda}+\int_{B} F(x, v) d x\right) .
$$

Set

$$
u_{n}=\frac{v_{n}}{\left\|v_{n}\right\|} \quad \text { and } \quad u=\frac{v}{\rho}
$$

We have $\left\|u_{n}\right\|=1, u_{n} \rightharpoonup u$ in $\mathbf{E}, u \not \equiv 0$ and $\|u\|<1$. So, by Lemma 2.2, we get

$$
\sup _{n} \int_{B} e^{p \alpha_{N, \beta}\left|u_{n}\right|^{\gamma}} d x<+\infty
$$

provided $1<p<\left(1-\|u\|^{N}\right)^{-\frac{\gamma}{N}}$.
By (5.5) and (5.15), we have the following equality

$$
N c_{\lambda}-N \mathcal{J}_{\lambda}(v)=\rho^{N}-\|v\|^{N}
$$

From (5.13), Lemma 4.1 and the last equality, we obtain

$$
\begin{equation*}
\rho^{N} \leq N c_{\lambda}+\|v\|^{N}<\left(\frac{\alpha_{N, \beta}}{\alpha_{0}}\right)^{\frac{N}{\gamma}}+\|v\|^{N} . \tag{5.16}
\end{equation*}

Since

\rho^{\gamma}=\left(\frac{\rho^{N}-\|v\|^{N}}{1-\|u\|^{N}}\right)^{\frac{1}{(N-1)(1-\beta)}},
$$

we deduce from (5.16) that

\rho^{\gamma}<\left(\frac{\left(\frac{\alpha_{N, \beta}}{\alpha_{0}}\right)^{\frac{N}{\gamma}}}{1-\|u\|^{N}}\right)^{\frac{1}{(N-1)(1-\beta)}} \tag{5.17}
\end{equation*}
$$

On one hand, we have this estimate $\int_{B}\left|f\left(x, v_{n}\right)\right|^{q} d x<C$. Indeed, since $f$ has critical growth, for every $\varepsilon>0$ and $q>1$ there exists $t_{\varepsilon}>0$ and $C>0$ such that for all $|t| \geq t_{\varepsilon}$, we have

|f(x, t)|^{q} \leq C e^{\alpha_{0}(\varepsilon+1) t^{\gamma}}
$$

So,

\begin{aligned}
\int_{B}\left|f\left(x, v_{n}\right)\right|^{q} d x & =\int_{\left\{\left|v_{n}\right| \leq t_{\varepsilon}\right\}}\left|f\left(x, v_{n}\right)\right|^{q} d x+\int_{\left\{\left|v_{n}\right|>t_{\varepsilon}\right\}}\left|f\left(x, v_{n}\right)\right|^{q} d x \\
& \leq \omega_{N-1} \max _{B \times\left[-t_{\varepsilon}, t_{\varepsilon}\right]}|f(x, t)|^{q}+C \int_{B} e^{\alpha_{0}(\varepsilon+1)\left|v_{n}\right|^{\gamma}} d x \\
& \leq C_{\varepsilon}+C \int_{B} e^{\alpha_{0}(1+\varepsilon)\left\|v_{n}\right\|^{\gamma} \frac{\left|v_{n}\right|}{\left\|v_{n}\right\|^{\gamma}}} d x \leq C
\end{aligned}
$$

provided $\alpha_{0}(1+\varepsilon)\left\|v_{n}\right\|^{\gamma} \leq p \alpha_{N, \beta}$ and $1<p<\mathcal{U}(u)=\left(1-\|u\|^{N}\right)^{\frac{-\gamma}{N}}$.
From (5.17), there exists $\delta \in\left(0, \frac{1}{2}\right)$ such that $\rho^{\gamma}=(1-2 \delta)\left(\frac{\left(\frac{\alpha_{N, \beta}}{\alpha_{0}}\right)^{\frac{N}{\gamma}}}{1-\|u\|^{N}}\right)^{\frac{1}{(N-1)(1-\beta)}}$.
Since $\lim _{n \rightarrow+\infty}\left\|v_{n}\right\|^{\gamma}=\rho^{\gamma}$, then, for $n$ large enough

$$
\alpha_{0}(1+\varepsilon)\left\|v_{n}\right\|^{\gamma} \leq(1+\varepsilon)(1-\delta) \alpha_{N, \beta}\left(\frac{1}{1-\|u\|^{N}}\right)^{\frac{\gamma}{N}} .
$$

We choose $\varepsilon>0$ small enough such that $(1+\varepsilon)(1-\delta)<1$ which implies that

$$
\alpha_{0}(1+\varepsilon)\left\|v_{n}\right\|^{\gamma}<\alpha_{N, \beta}\left(\frac{1}{1-\|u\|^{N}}\right)^{\frac{\gamma}{N}}
$$

Hence, the sequence $\left(f\left(x, v_{n}\right)\right)$ is bounded in $L^{q}, q>1$.
Using the Hölder inequality, we deduce that

$$
\begin{aligned}
\left|\int_{B} f\left(x, v_{n}\right)\left(v_{n}-v\right) d x\right| & \leq\left(\int_{B}\left|f\left(x, v_{n}\right)\right|^{q} d x\right)^{\frac{1}{q}}\left(\int_{B}\left|v_{n}-v\right|^{q^{\prime}} d x\right)^{\frac{1}{q^{\prime}}} \\
& \leq C\left(\int_{B}\left|v_{n}-v\right|^{q^{\prime}} d x\right)^{\frac{1}{q^{\prime}}} \rightarrow 0 \text { as } n \rightarrow+\infty
\end{aligned}
$$

where $\frac{1}{q}+\frac{1}{q^{\prime}}=1$.
Since $\left\langle\mathcal{J}_{\lambda}{ }^{\prime}\left(v_{n}\right),\left(v_{n}-v\right)\right\rangle=o_{n}(1)$, it follows that

$$
\int_{B}\left(\omega(x)\left|\nabla v_{n}\right|^{N-2} \nabla v_{n} \cdot\left(\nabla v_{n}-\nabla v\right) d x\right) \rightarrow 0 .
$$

On the other side,

$$
\int_{B} \omega(x)\left|\nabla v_{n}\right|^{N-2} \nabla v_{n} \cdot\left(\nabla v_{n}-\nabla v\right) d x=\left|\left|v_{n} \|^{N}-\int_{B} \omega(x)\right| \nabla v_{n}\right|^{N-2} \nabla v_{n} \cdot \nabla v d x .
$$

Passing to the limit in the last equality, we get

$$
\rho^{N}-\|v\|^{N}=0
$$

therefore $\|v\|=\rho$. This is in contradiction with (5.12). Therefore, $\mathcal{J}_{\lambda}(v)=c_{\lambda}$. By Claim 1, $\mathcal{J}_{\lambda}^{\prime}(v)=0$ and by Claim 2, $v \neq 0$.

Proof of Theorem 1.3. From Lemma 3.6 and Lemma 5.1, we deduce that $v$ is a least energy signchanging solution for problem $\left(P_{\lambda}\right)$ with exactly tow nodal domains.
