

# ROBUST MIXED FINITE ELEMENT METHODS FOR A QUAD-CURL SINGULAR PERTURBATION PROBLEM

**ABSTRACT.** Robust mixed finite element methods are developed for a quad-curl singular perturbation problem. Lower order  $H(\text{grad curl})$ -nonconforming but  $H(\text{curl})$ -conforming finite elements are constructed, which are extended to nonconforming finite element Stokes complexes and the associated commutative diagrams. Then  $H(\text{grad curl})$ -nonconforming finite elements are employed to discretize the quad-curl singular perturbation problem, which possess the sharp and uniform error estimates with respect to the perturbation parameter. The Nitsche's technique is exploited to achieve the optimal convergence rate in the case of the boundary layers. Numerical results are provided to verify the theoretical convergence rates. In addition, the regularity of the quad-curl singular perturbation problem is established.

## 1. INTRODUCTION

Let  $\Omega \subset \mathbb{R}^3$  be a bounded polyhedral domain. In this work, we shall develop robust finite element methods for the quad-curl singular perturbation problem

$$(1.1) \quad \begin{cases} \varepsilon^2 \text{curl}^4 \mathbf{u} + \text{curl}^2 \mathbf{u} = \mathbf{f} & \text{in } \Omega, \\ \text{div } \mathbf{u} = 0 & \text{in } \Omega, \\ \mathbf{u} \times \mathbf{n} = \text{curl } \mathbf{u} = \mathbf{0} & \text{on } \partial\Omega, \end{cases}$$

where  $\mathbf{f} \in \mathbf{H}(\text{div}, \Omega)$  with  $\text{div } \mathbf{f} = 0$  and positive perturbation parameter  $\varepsilon$  has an upper bound. In particular, we are interested in the case  $\varepsilon$  approaching zero, for which the boundary layer phenomenon appears. The wellposedness of problem (1.1) is closely related to the following Stokes complex in three dimensions

$$(1.2) \quad 0 \xrightarrow{\subset} \mathbf{H}_0^1(\Omega) \xrightarrow{\nabla} \mathbf{H}_0(\text{grad curl}, \Omega) \xrightarrow{\text{curl}} \mathbf{H}_0^1(\Omega; \mathbb{R}^3) \xrightarrow{\text{div}} L_0^2(\Omega) \rightarrow 0,$$

where  $\mathbf{H}_0(\text{grad curl}, \Omega) := \{\mathbf{v} \in \mathbf{H}_0(\text{curl}, \Omega) : \text{curl } \mathbf{v} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3)\}$ .

To discretize the quad-curl problem,  $H(\text{grad curl})$ -conforming finite elements are constructed in [27, 14, 26, 8], while the conforming finite elements in three dimensions suffer from the large number of degrees of freedom (DoFs). To lower the number of DoFs, some nonstandard discretizations of Stokes complex (1.2) are advanced, for example, conforming macro-element Stokes complex on Alfeld split meshes in [15] and conforming virtual element Stokes complex in [3]. In addition,

the nonconforming finite element Stokes complexes in [16, 28] have rather lower dimensions, for example the  $H(\text{grad curl})$ -nonconforming finite element in [16] has only 14 DoFs. We refer to [7] for a decoupled finite element method for the quad-curl problem.

Although the  $H(\text{grad curl})$ -nonconforming elements in [16, 28] solve the quad-curl problem correctly and have optimal convergence rates, the convergence rates will deteriorate when they were applied to discretize the double curl problem, i.e. problem (1.1) with  $\varepsilon = 0$ , since these nonconforming elements are also  $H(\text{curl})$ -nonconforming; see Section 7.9 in [4]. We numerically test the Huang element in [16] for the double curl problem in Section 6, and do not observe any convergence, similarly as the Morley element method for Poisson equation [21, Section 3]. Hence the convergence would also deteriorate if using these nonconforming finite elements to discretize the quad-curl singular perturbation problem (1.1) with very small  $\varepsilon$ .

To this end, we will construct  $H(\text{grad curl})$ -nonconforming but  $H(\text{curl})$ -conforming finite elements for problem (1.1) in this paper. For tetrahedron  $K$ , the space of shape functions  $\mathbf{W}_k(K) := \nabla\mathbb{P}_{k+1}(K) \oplus \mathbf{x} \times \mathbb{P}_1(K; \mathbb{R}^3) \oplus b_K\mathbb{P}_1(K; \mathbb{R}^3)$  for  $k = 1, 2$  is an enrichment of Nédélec finite element space  $\mathbf{V}_k^{ND}(K) = \nabla\mathbb{P}_{k+1}(K) \oplus \mathbf{x} \times \mathbb{P}_1(K; \mathbb{R}^3)$  [19, 20] with bubble functions. The dimension of  $\mathbf{W}_1(K)$  is 32. The DoFs for space  $\mathbf{W}_k(K)$  are inherited from those of Nédélec elements

$$\begin{aligned} \int_e \mathbf{v} \cdot \mathbf{t} q \, ds & \quad \forall q \in \mathbb{P}_k(e), e \in \mathcal{E}(K), \\ \int_F \mathbf{v} \times \mathbf{n} \cdot \mathbf{q} \, dS & \quad \forall \mathbf{q} \in \mathbf{RM}_{k-2}(F), F \in \mathcal{F}(K), \\ \int_F (\text{curl } \mathbf{v}) \times \mathbf{n} \cdot \mathbf{q} \, dS & \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}(K). \end{aligned}$$

After constructing the global  $H(\text{grad curl})$ -nonconforming space  $\mathbf{W}_{h0}$ , we derive the nonconforming finite element discretization of Stokes complex (1.2)

$$0 \xrightarrow{c} V_h^g \xrightarrow{\nabla} \mathbf{W}_{h0} \xrightarrow{\text{curl}} \mathbf{V}_{h0}^d \xrightarrow{\text{div}} \mathcal{Q}_h \rightarrow 0,$$

where  $V_h^g$  is the  $(k+1)$ th order Lagrange element space,  $\mathbf{V}_{h0}^d$  is the  $H^1$ -nonconforming finite element space in [24], and  $\mathcal{Q}_h$  is the piecewise constant space. The associated commutative diagrams are also established with lower smooth interpolations.

With the  $H(\text{grad curl})$ -nonconforming space  $\mathbf{W}_{h0}$  and the Lagrange element space  $V_h^g$ , we propose a robust mixed finite element method for the quad-curl singular perturbation problem (1.1). The discrete Poincaré inequality and the discrete inf-sup condition are proved. In addition, we create the regularity of the quad-curl singular perturbation problem (1.1) with the help of the regularity of the Stokes equation under the assumption domain  $\Omega$  is convex. After deriving interpolation error estimates in detail, we achieve the optimal convergence rate  $O(h)$  of the energy error for any fixed  $\varepsilon$ , and the uniform convergence rate  $O(h^{1/2})$  of the energy error with respect to  $\varepsilon$  in consideration of the boundary layers.

The uniform convergence rate  $O(h^{1/2})$  is sharp but apparently not optimal. Then we modify the previous mixed finite element method by applying the Nitsche's technique [22, 23, 13]. The resulting discrete method has the uniform convergence rate  $O(h^2)$  of the energy error when  $\varepsilon$  approaches zero, which is optimal. Numerical experiments are provided to confirm these uniform convergence rates.

The rest of this paper is organized as follows. We construct a nonconforming finite element Stokes complex in Section 2. The regularity of the quad-curl singular perturbation problem is discussed in Section 3. In Section 4 we propose and analyze a robust mixed finite element method. A modified mixed finite element method based on Nitsche's technique is devised in Section 5. Some numerical results are shown in Section 6.

## 2. NONCONFORMING FINITE ELEMENT STOKES COMPLEXES

In this section we will construct two  $H(\text{grad curl})$ -nonconforming but  $H(\text{curl})$ -conforming finite elements, and present the corresponding finite element Stokes complexes.

**2.1. Notation.** Given integer  $m \geq 0$  and a bounded domain  $D \subset \mathbb{R}^d$  with integer  $d \geq 1$ , let  $H^m(D)$  be the space of all square-integrable functions whose distributional derivatives up to order  $m$  are also square-integrable. The norm and seminorm are denoted by  $\|\cdot\|_{m,D}$  and  $|\cdot|_{m,D}$ , respectively. Set  $L^2(D) = H^0(D)$  with inner product  $(\cdot, \cdot)_D$ . When  $D$  is  $\Omega$ ,  $\|\cdot\|_{m,D}$ ,  $|\cdot|_{m,D}$  and  $(\cdot, \cdot)_D$  will be abbreviated as  $\|\cdot\|_m$ ,  $|\cdot|_m$  and  $(\cdot, \cdot)$ . Denote by  $H_0^m(D)$  the closure of  $C_0^\infty(D)$  with respect to the norm  $\|\cdot\|_{m,D}$ . Let  $\mathbb{P}_k(D)$  stand for the set of all polynomials in  $D$  with the total degree no more than  $k$ . Denote the vector version of  $H^m(D)$ ,  $H_0^m(D)$  and  $\mathbb{P}_k(D)$  by  $\mathbf{H}^m(D; \mathbb{R}^d)$ ,  $\mathbf{H}_0^m(D; \mathbb{R}^d)$  and  $\mathbb{P}_k(D; \mathbb{R}^d)$ , respectively. Let  $Q_D^k$  be the  $L^2$ -orthogonal projector onto space  $\mathbb{P}_k(D)$  or  $\mathbb{P}_k(D; \mathbb{R}^d)$ .

The gradient operator, curl operator and divergence operator are denoted by  $\nabla$ ,  $\text{curl}$  and  $\text{div}$ , respectively. Let  $\mathbf{H}(\text{curl}, D)$  be the space of all functions  $\mathbf{v}$  in  $\mathbf{L}^2(D; \mathbb{R}^3)$  satisfying  $\text{curl } \mathbf{v} \in \mathbf{L}^2(D; \mathbb{R}^3)$ , and  $\mathbf{H}(\text{div}, D)$  be the space of all functions  $\mathbf{v}$  in  $\mathbf{L}^2(D; \mathbb{R}^3)$  satisfying  $\text{div } \mathbf{v} \in L^2(D)$ . The associated spaces with the vanishing trace are denoted by  $\mathbf{H}_0(\text{curl}, D)$  and  $\mathbf{H}_0(\text{div}, D)$ . Let

$$\begin{aligned} \mathbf{H}(\text{grad curl}, D) &:= \{\mathbf{v} \in \mathbf{H}(\text{curl}, D) : \text{curl } \mathbf{v} \in \mathbf{H}^1(D; \mathbb{R}^3)\}, \\ \mathbf{H}_0(\text{grad curl}, D) &:= \{\mathbf{v} \in \mathbf{H}_0(\text{curl}, D) : \text{curl } \mathbf{v} \in \mathbf{H}_0^1(D; \mathbb{R}^3)\}, \\ \mathbf{H}^1(\text{curl}, D) &:= \{\mathbf{v} \in \mathbf{H}^1(D; \mathbb{R}^3) : \text{curl } \mathbf{v} \in \mathbf{H}^1(D; \mathbb{R}^3)\}, \\ \mathbf{H}_0^1(\text{curl}, D) &:= \{\mathbf{v} \in \mathbf{H}_0^1(D; \mathbb{R}^3) : \text{curl } \mathbf{v} \in \mathbf{H}_0^1(D; \mathbb{R}^3)\}. \end{aligned}$$

Denote by  $L_0^2(D)$  the subspace of  $L^2(D)$  having zero mean value.

Let  $\{\mathcal{T}_h\}_{h>0}$  be a regular family of tetrahedral meshes of  $\Omega$ . Denote by  $\mathcal{F}_h$ ,  $\mathcal{F}_h^i$ ,  $\mathcal{E}_h$ ,  $\mathcal{E}_h^i$ ,  $\mathcal{V}_h$  and  $\mathcal{V}_h^i$  the set of all faces, interior faces, edges, interior edges, vertices and interior vertices of the partition  $\mathcal{T}_h$ , respectively. For each tetrahedron  $K \in \mathcal{T}_h$ , let  $\mathbf{n}_K$  be the unit outward normal vector to  $\partial K$ , which will be abbreviated as  $\mathbf{n}$  if not causing any confusion. We fix a unit normal vector  $\mathbf{n}_F$  for each face  $F \in \mathcal{F}_h$ , and a unit tangential vector  $\mathbf{t}_e$  for each edge  $e \in \mathcal{E}_h$ . We also abbreviate  $\mathbf{n}_F$  and  $\mathbf{t}_e$  as  $\mathbf{n}$  and  $\mathbf{t}$  accordingly when not causing any confusion. For  $K \in \mathcal{T}_h$ , denote by  $\mathcal{F}(K)$ ,  $\mathcal{E}(K)$  and  $\mathcal{V}(K)$  the set of all faces, edges and vertices of  $K$ , respectively. For  $F \in \mathcal{F}_h$ , let  $\mathcal{E}(F)$  be the set of all edges of  $F$ . And for  $e \in \mathcal{E}(F)$ , denote by  $\mathbf{n}_{F,e}$  the unit vector being parallel to  $F$  and outward normal to  $\partial F$ . Set  $\mathbf{t}_{F,e} := \mathbf{n}_F \times \mathbf{n}_{F,e}$ , where  $\times$  is the exterior product. For elementwise smooth function  $\mathbf{v}$ , define

$$\|\mathbf{v}_h\|_{1,h}^2 := \sum_{K \in \mathcal{T}_h} \|\mathbf{v}_h\|_{1,K}^2, \quad |\mathbf{v}_h|_{1,h}^2 := \sum_{K \in \mathcal{T}_h} |\mathbf{v}_h|_{1,K}^2.$$

Let  $\nabla_h$  be the elementwise counterpart of  $\nabla$  with respect to  $\mathcal{T}_h$ .

**2.2.  $H(\text{grad curl})$ -nonconforming finite elements.** We focus on constructing  $H(\text{grad curl})$ -nonconforming but  $H(\text{curl})$ -conforming finite elements in this subsection.

For tetrahedron  $K$ , let

$$\mathbf{V}_k^{ND}(K) := \nabla \mathbb{P}_{k+1}(K) \oplus \mathbf{x} \times \mathbb{P}_1(K; \mathbb{R}^3) \quad \text{for } k = 1, 2.$$

Then  $\mathbf{V}_1^{ND}(K)$  is the first order Nédélec finite element space of the first kind [19], and  $\mathbf{V}_2^{ND}(K)$  is the second order Nédélec finite element space of the second kind [20]. Now enrich  $\mathbf{V}_k^{ND}(K)$  with bubble functions to define the space of shape functions for  $H(\text{grad curl})$ -nonconforming finite elements as

$$\mathbf{W}_k(K) := \mathbf{V}_k^{ND}(K) \oplus b_K \mathbb{P}_1(K; \mathbb{R}^3) \quad \text{for } k = 1, 2,$$

where  $b_K := \lambda_1 \lambda_2 \lambda_3 \lambda_4$  is the bubble function of  $K$ , and  $\lambda_i$  ( $i = 1, 2, 3, 4$ ) are the barycentric coordinates corresponding to the vertices of  $K$ . Clearly  $\mathbb{P}_k(K; \mathbb{R}^3) \subseteq \mathbf{V}_k^{ND}(K) \subset \mathbf{W}_k(K)$ . We have

$$\dim \mathbf{W}_k(K) = \begin{cases} 32, & k = 1, \\ 42, & k = 2. \end{cases}$$

We propose the following degrees of freedom (DoFs) for space  $\mathbf{W}_k(K)$

$$(2.1) \quad \int_e \mathbf{v} \cdot \mathbf{t} q \, ds \quad \forall q \in \mathbb{P}_k(e), e \in \mathcal{E}(K),$$

$$(2.2) \quad \int_F \mathbf{v} \times \mathbf{n} \cdot \mathbf{q} \, dS \quad \forall \mathbf{q} \in \mathbf{RM}_{k-2}(F), F \in \mathcal{F}(K),$$

$$(2.3) \quad \int_F (\text{curl } \mathbf{v}) \times \mathbf{n} \cdot \mathbf{q} \, dS \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}(K),$$

where  $\mathbf{RM}_{k-2}(F) := \mathbb{P}_0(F; \mathbb{R}^2) \oplus \mathbf{x}^\perp \mathbb{P}_{k-2}(F)$  with  $\mathbf{x}^\perp := (\mathbf{n} \times \mathbf{x})|_F$ , and  $\mathbf{RT}(F) := \mathbb{P}_0(F; \mathbb{R}^2) \oplus \mathbf{x} \mathbb{P}_0(F)$ . DoFs (2.1)-(2.2) are inspired by the Nédélec elements. Indeed DoFs (2.1)-(2.2) are uni-solvent for  $\mathbf{V}_k^{ND}(K)$  [19, 20]. DoF (2.3) is related to the bubble space  $b_K \mathbb{P}_1(K; \mathbb{R}^3)$ .

To show the unisolvence of the  $H(\text{grad curl})$ -nonconforming finite elements, we recall an  $H^1$ -nonconforming finite element for Stokes problem in [24]. Let  $\mathbf{V}^d(K) = \mathbb{P}_1(K; \mathbb{R}^3) \oplus \text{curl}(b_K \mathbb{P}_1(K; \mathbb{R}^3))$ . The unisolvent DoFs for  $\mathbf{V}^d(K)$  are (cf. [24, Lemma 4])

$$(2.4) \quad \int_F (\mathbf{v} \cdot \mathbf{n}) q \, dS \quad \forall q \in \mathbb{P}_1(F), F \in \mathcal{F}(K),$$

$$(2.5) \quad \int_F (\mathbf{v} \times \mathbf{n}) \cdot \mathbf{q} \, dS \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}(K).$$

DoF (2.5) corresponds to DoF (2.3).

**Lemma 2.1.** *For  $\mathbf{v} \in \mathbf{x} \times \mathbb{P}_1(K; \mathbb{R}^3) + b_K \mathbb{P}_1(K; \mathbb{R}^3)$  satisfying  $\text{curl } \mathbf{v} = \mathbf{0}$ , we have  $\mathbf{v} = \mathbf{0}$ .*

*Proof.* Let  $\mathbf{v} = \boldsymbol{\phi} + b_K \boldsymbol{\psi}$  with  $\boldsymbol{\phi} \in \mathbf{x} \times \mathbb{P}_1(K; \mathbb{R}^3)$  and  $\boldsymbol{\psi} \in \mathbb{P}_1(K; \mathbb{R}^3)$ . Then  $\text{curl } \boldsymbol{\phi} = -\text{curl}(b_K \boldsymbol{\psi}) \in \mathbb{P}_1(K; \mathbb{R}^3)$ , and

$$(\text{curl } \boldsymbol{\phi}) \cdot \mathbf{n} = -\text{curl}(b_K \boldsymbol{\psi}) \cdot \mathbf{n} = -(\mathbf{n} \times \nabla) \cdot (b_K \boldsymbol{\psi}) = 0 \text{ on } \partial K.$$

By the unisolvence of the lowest order Brezzi-Douglas-Marini (BDM) element [6], we get  $\text{curl } \phi = \mathbf{0}$  and  $\text{curl}(b_K \psi) = \mathbf{0}$ . Noting that  $\text{curl} : \mathbf{x} \times \mathbb{P}_1(K; \mathbb{R}^3) \rightarrow \mathbb{P}_1(K; \mathbb{R}^3)$  is injective, it follows  $\phi = \mathbf{0}$ .

Since  $\text{curl}(b_K \psi) = \mathbf{0}$  and  $b_K \psi \in \mathbf{H}_0^1(K; \mathbb{R}^3)$ , by the de Rham complex [10], there exists  $w \in H_0^2(K)$  satisfying  $b_K \psi = \nabla w$ . It is easy to see  $w \in H_0^2(K) \cap \mathbb{P}_6(K)$ , which means  $w$  has a factor  $b_K^2 \in \mathbb{P}_8(K)$ . Thus  $w = 0$  and  $\psi = \mathbf{0}$ .  $\square$

As an immediate result of Lemma 2.1,

$$(2.6) \quad \mathbf{W}_k(K) \cap \ker(\text{curl}) = \mathbf{V}_k^{ND}(K) \cap \ker(\text{curl}) = \nabla \mathbb{P}_{k+1}(K),$$

where  $\ker(\text{curl})$  means the kernel space of operator  $\text{curl}$ .

**Lemma 2.2.** *The degrees of freedom (2.1)-(2.3) are unisolvent for space  $\mathbf{W}_k(K)$ .*

*Proof.* The number of degrees of freedom (2.1)-(2.3) is

$$6(k+1) + 20 + 4(k-1) = 10k + 22,$$

which equals to the dimension of  $\mathbf{W}_k(K)$ .

Assume  $\mathbf{v} \in \mathbf{W}_k(K)$  and all the DoFs (2.1)-(2.3) vanish. Since  $\mathbf{v}|_{\partial K} \in \mathbf{V}_k^{ND}(K)|_{\partial K}$  and DoFs (2.1)-(2.2) are unisolvent for  $\mathbf{V}_k^{ND}(K)$ , we obtain  $\mathbf{v} \times \mathbf{n} = \mathbf{0}$  on  $\partial K$ . As a result,

$$(\text{curl } \mathbf{v}) \cdot \mathbf{n} = (\mathbf{n} \times \nabla) \cdot \mathbf{v} = 0 \quad \text{on } \partial K.$$

Noting that  $\text{curl } \mathbf{v} \in \mathbf{V}^d(K)$  and DoFs (2.4)-(2.5) are unisolvent for  $\mathbf{V}^d(K)$ , we get from the last identity and the vanishing DoF (2.3) that  $\text{curl } \mathbf{v} = \mathbf{0}$ . Due to (2.6),  $\mathbf{v} \in \nabla \mathbb{P}_{k+1}(K) \subset \mathbf{V}_k^{ND}(K)$ . Therefore  $\mathbf{v} = \mathbf{0}$  follows from the unisolvence of Nédélec elements.  $\square$

Define the global  $H(\text{grad curl})$ -nonconforming element space

$$\mathbf{W}_{h0} := \{\mathbf{v}_h \in \mathbf{W}_h : \text{DoF (2.3) on } \partial\Omega \text{ vanishes}\},$$

where

$$\begin{aligned} \mathbf{W}_h := \{ & \mathbf{v}_h \in \mathbf{L}^2(\Omega; \mathbb{R}^3) : \mathbf{v}_h|_K \in \mathbf{W}_k(K) \text{ for each } K \in \mathcal{T}_h, \\ & \text{all the DoFs (2.1)-(2.3) are single-valued,} \\ & \text{and all the DoFs (2.1)-(2.2) on } \partial\Omega \text{ vanish}\}. \end{aligned}$$

By definition, all the DoFs (2.1)-(2.3) for functions in  $\mathbf{W}_{h0}$  vanish on  $\partial\Omega$ . Noting that (2.1)-(2.2) are exactly the unisolvent DoFs for the Nédélec element space  $\mathbf{V}_k^{ND}(K)$ , by  $\mathbf{W}_k(K)|_{\partial K} = \mathbf{V}_k^{ND}(K)|_{\partial K}$ , we have  $\mathbf{W}_h \subset \mathbf{H}_0(\text{curl}, \Omega)$ .

**2.3. Finite element Stokes complexes.** We will consider the nonconforming finite element discretization of the Stokes complex (1.2) in this section. Recall the Lagrange element space

$$V_h^g := \{v_h \in H_0^1(\Omega) : v_h|_K \in \mathbb{P}_{k+1}(K) \text{ for each } K \in \mathcal{T}_h\},$$

the piecewise constant space

$$\mathcal{Q}_h := \{q_h \in L_0^2(\Omega) : q_h|_K \in \mathbb{P}_0(K) \text{ for each } K \in \mathcal{T}_h\},$$

and the  $H^1$ -nonconforming finite element space in [24]

$$\mathbf{V}_{h0}^d := \{\mathbf{v}_h \in \mathbf{V}_h^d : \text{all the DoFs (2.4)-(2.5) on } \partial\Omega \text{ vanish}\},$$

where

$$\mathbf{V}_h^d := \{\mathbf{v}_h \in \mathbf{H}_0(\operatorname{div}, \Omega) : \mathbf{v}_h|_K \in \mathbf{V}^d(K) \text{ for each } K \in \mathcal{T}_h, \\ \text{all the DoFs (2.4)-(2.5) are single-valued}\}.$$

Thanks to the weak continuity, the space  $\mathbf{V}_{h0}^d$  possesses the norm equivalence [5]

$$\|\mathbf{v}_h\|_{1,h} \simeq |\mathbf{v}_h|_{1,h} \quad \forall \mathbf{v}_h \in \mathbf{V}_{h0}^d.$$

**Lemma 2.3.** *The nonconforming finite element Stokes complexes*

$$(2.7) \quad 0 \xrightarrow{\subset} V_h^g \xrightarrow{\nabla} \mathbf{W}_{h0} \xrightarrow{\operatorname{curl}} \mathbf{V}_{h0}^d \xrightarrow{\operatorname{div}} \mathcal{Q}_h \rightarrow 0,$$

$$(2.8) \quad 0 \xrightarrow{\subset} V_h^g \xrightarrow{\nabla} \mathbf{W}_h \xrightarrow{\operatorname{curl}} \mathbf{V}_h^d \xrightarrow{\operatorname{div}} \mathcal{Q}_h \rightarrow 0$$

are exact.

*Proof.* For the proof of (2.8) is similar, we only prove (2.7) is an exact sequence. It is straightforward to check that each space in sequence (2.7) is mapped into the succeeding space by the given differential operator, hence sequence (2.7) is a complex. We refer to [24] for  $\operatorname{div} \mathbf{V}_{h0}^d = \mathcal{Q}_h$ .

It follows from Stokes complex (1.2) and (2.6) that  $\mathbf{W}_{h0} \cap \ker(\operatorname{curl}) = \nabla V_h^g$ . Then

$$\begin{aligned} \dim \operatorname{curl} \mathbf{W}_{h0} &= \dim \mathbf{W}_{h0} - \dim V_h^g \\ &= (k+1)\#\mathcal{E}_h^i + (k+4)\#\mathcal{F}_h^i - \#\mathcal{V}_h^i - k\#\mathcal{E}_h^i - (k-1)\#\mathcal{F}_h^i \\ &= \#\mathcal{E}_h^i + 5\#\mathcal{F}_h^i - \#\mathcal{V}_h^i, \end{aligned}$$

By  $\operatorname{div} \mathbf{V}_{h0}^d = \mathcal{Q}_h$ ,

$$\dim \mathbf{V}_{h0}^d \cap \ker(\operatorname{div}) = \dim \mathbf{V}_{h0}^d - \dim \mathcal{Q}_h = 6\#\mathcal{F}_h^i - \#\mathcal{T}_h + 1.$$

Employing the Euler's formula, we get

$$\dim \mathbf{V}_{h0}^d \cap \ker(\operatorname{div}) - \dim \operatorname{curl} \mathbf{W}_{h0} = \#\mathcal{V}_h^i - \#\mathcal{E}_h^i + \#\mathcal{F}_h^i - \#\mathcal{T}_h + 1 = 0,$$

which indicates  $\mathbf{V}_{h0}^d \cap \ker(\operatorname{div}) = \operatorname{curl} \mathbf{W}_{h0}$ .  $\square$

**2.4. Interpolations and commutative diagram.** To introduce interpolations for complexes (2.7)-(2.8), we recall the finite element de Rham complex [1]

$$0 \xrightarrow{\subset} V_h^g \xrightarrow{\nabla} \mathbf{V}_h^{ND} \xrightarrow{\operatorname{curl}} \mathbf{V}_h^{BDM} \xrightarrow{\operatorname{div}} \mathcal{Q}_h \rightarrow 0,$$

where

$$\mathbf{V}_h^{ND} := \{\mathbf{v}_h \in \mathbf{H}_0(\operatorname{curl}, \Omega) : \mathbf{v}_h|_K \in \mathbf{V}_k^{ND}(K) \text{ for each } K \in \mathcal{T}_h\},$$

$$\mathbf{V}_h^{BDM} := \{\mathbf{v}_h \in \mathbf{H}_0(\operatorname{div}, \Omega) : \mathbf{v}_h|_K \in \mathbb{P}_1(K; \mathbb{R}^3) \text{ for each } K \in \mathcal{T}_h\}.$$

Let  $I_h^g : L^2(\Omega) \rightarrow V_h^g$ ,  $I_h^{ND} : \mathbf{L}^2(\Omega; \mathbb{R}^3) \rightarrow \mathbf{V}_h^{ND}$ ,  $I_h^{BDM} : \mathbf{L}^2(\Omega; \mathbb{R}^3) \rightarrow \mathbf{V}_h^{BDM}$  and  $Q_h : L^2(\Omega) \rightarrow \mathcal{Q}_h$  be the local bounded projections devised in [11], then it holds the commutative diagram

$$(2.9) \quad \begin{array}{ccccccccc} 0 & \xrightarrow{\subset} & H_0^1(\Omega) & \xrightarrow{\nabla} & \mathbf{H}_0(\operatorname{curl}, \Omega) & \xrightarrow{\operatorname{curl}} & \mathbf{H}_0(\operatorname{div}, \Omega) & \xrightarrow{\operatorname{div}} & L_0^2(\Omega) & \longrightarrow & 0 \\ & & \downarrow I_h^g & & \downarrow I_h^{ND} & & \downarrow I_h^{BDM} & & \downarrow Q_h & & \\ 0 & \xrightarrow{\subset} & V_h^g & \xrightarrow{\nabla} & \mathbf{V}_h^{ND} & \xrightarrow{\operatorname{curl}} & \mathbf{V}_h^{BDM} & \xrightarrow{\operatorname{div}} & \mathcal{Q}_h & \longrightarrow & 0 \end{array} .$$

We also have

$$(2.10) \quad \|\mathbf{v} - I_h^{ND} \mathbf{v}\|_0 \lesssim h^j |\mathbf{v}|_j \quad \forall \mathbf{v} \in \mathbf{H}_0(\text{curl}, \Omega) \cap \mathbf{H}^j(\Omega, \mathbb{R}^3), j = 1, 2, k + 1,$$

$$(2.11) \quad \|I_h^{BDM} \mathbf{v}\|_0 \lesssim \|\mathbf{v}\|_0 + h \|\text{div} \mathbf{v}\|_0 \quad \forall \mathbf{v} \in \mathbf{H}_0(\text{div}, \Omega),$$

$$(2.12) \quad \sum_{K \in \mathcal{T}_h} h_K^{2(i-j)} |\mathbf{v} - I_h^{BDM} \mathbf{v}|_{i,K}^2 \lesssim |\mathbf{v}|_j^2 \quad \forall \mathbf{v} \in \mathbf{H}_0(\text{div}, \Omega) \cap \mathbf{H}^j(\Omega, \mathbb{R}^3),$$

for  $i = 0, 1$  and  $j = 1, 2$ .

Based on DoFs (2.1)-(2.3), define  $I_h^{gc} : \mathbf{L}^2(\Omega; \mathbb{R}^3) \rightarrow \mathbf{W}_h$  as follows:

$$\begin{aligned} ((I_h^{gc} \mathbf{v}) \cdot \mathbf{t}, q)_e &= ((I_h^{ND} \mathbf{v}) \cdot \mathbf{t}, q)_e \quad \forall q \in \mathbb{P}_k(e), e \in \mathcal{E}_h, \\ ((I_h^{gc} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= ((I_h^{ND} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F \quad \forall \mathbf{q} \in \mathbf{RM}_{k-2}(F), F \in \mathcal{F}_h, \\ (\text{curl}(I_h^{gc} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= (\{\text{curl}(I_h^{ND} \mathbf{v}) \times \mathbf{n}\}, \mathbf{q})_F \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}_h, \end{aligned}$$

where  $\{\cdot\}$  is the average operator across  $F$  for interior face  $F \in \mathcal{F}_h^i$ , and the identity operator for  $F \in \mathcal{F}_h^\partial := \mathcal{F}_h \setminus \mathcal{F}_h^i$ . Similarly define  $I_{h0}^{gc} : \mathbf{L}^2(\Omega; \mathbb{R}^3) \rightarrow \mathbf{W}_{h0}$  as follows:

$$\begin{aligned} ((I_{h0}^{gc} \mathbf{v}) \cdot \mathbf{t}, q)_e &= ((I_h^{ND} \mathbf{v}) \cdot \mathbf{t}, q)_e \quad \forall q \in \mathbb{P}_k(e), e \in \mathcal{E}_h, \\ ((I_{h0}^{gc} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= ((I_h^{ND} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F \quad \forall \mathbf{q} \in \mathbf{RM}_{k-2}(F), F \in \mathcal{F}_h, \\ (\text{curl}(I_{h0}^{gc} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= (\{\text{curl}(I_h^{ND} \mathbf{v}) \times \mathbf{n}\}, \mathbf{q})_F \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}_h^i. \end{aligned}$$

Based on DoFs (2.4)-(2.5), define  $I_h^d : \mathbf{L}^2(\Omega; \mathbb{R}^3) \rightarrow \mathbf{V}_h^d$  as follows:

$$\begin{aligned} ((I_h^d \mathbf{v}) \cdot \mathbf{n}, q)_F &= ((I_h^{BDM} \mathbf{v}) \cdot \mathbf{n}, q)_F \quad \forall q \in \mathbb{P}_1(F), F \in \mathcal{F}_h, \\ ((I_h^d \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= (\{(I_h^{BDM} \mathbf{v}) \times \mathbf{n}\}, \mathbf{q})_F \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}_h. \end{aligned}$$

And define  $I_{h0}^d : \mathbf{L}^2(\Omega; \mathbb{R}^3) \rightarrow \mathbf{V}_{h0}^d$  as

$$\begin{aligned} ((I_{h0}^d \mathbf{v}) \cdot \mathbf{n}, q)_F &= ((I_h^{BDM} \mathbf{v}) \cdot \mathbf{n}, q)_F \quad \forall q \in \mathbb{P}_1(F), F \in \mathcal{F}_h, \\ ((I_{h0}^d \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= (\{(I_h^{BDM} \mathbf{v}) \times \mathbf{n}\}, \mathbf{q})_F \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}_h^i. \end{aligned}$$

**Lemma 2.4.** *We have the commutative diagrams*

$$(2.13) \quad \begin{array}{ccccccccc} 0 & \xrightarrow{\subset} & H_0^1(\Omega) & \xrightarrow{\nabla} & \mathbf{H}_0(\text{grad curl}, \Omega) & \xrightarrow{\text{curl}} & \mathbf{H}_0^1(\Omega; \mathbb{R}^3) & \xrightarrow{\text{div}} & L_0^2(\Omega) & \longrightarrow & 0 \\ & & \downarrow I_h^g & & \downarrow I_{h0}^{gc} & & \downarrow I_{h0}^d & & \downarrow Q_h & & \\ 0 & \xrightarrow{\subset} & V_h^g & \xrightarrow{\nabla} & \mathbf{W}_{h0} & \xrightarrow{\text{curl}} & \mathbf{V}_{h0}^d & \xrightarrow{\text{div}} & \mathcal{Q}_h & \longrightarrow & 0 \end{array},$$

$$(2.14) \quad \begin{array}{ccccccccc} 0 & \xrightarrow{\subset} & H_0^1(\Omega) & \xrightarrow{\nabla} & \mathring{\mathbf{H}}(\text{grad curl}, \Omega) & \xrightarrow{\text{curl}} & \mathring{\mathbf{H}}^1(\Omega; \mathbb{R}^3) & \xrightarrow{\text{div}} & L_0^2(\Omega) & \longrightarrow & 0 \\ & & \downarrow I_h^g & & \downarrow I_h^{gc} & & \downarrow I_h^d & & \downarrow Q_h & & \\ 0 & \xrightarrow{\subset} & V_h^g & \xrightarrow{\nabla} & \mathbf{W}_h & \xrightarrow{\text{curl}} & \mathbf{V}_h^d & \xrightarrow{\text{div}} & \mathcal{Q}_h & \longrightarrow & 0 \end{array},$$

where  $\mathring{\mathbf{H}}(\text{grad curl}, \Omega) := \mathbf{H}(\text{grad curl}, \Omega) \cap \mathbf{H}_0(\text{curl}, \Omega)$  and  $\mathring{\mathbf{H}}^1(\Omega; \mathbb{R}^3) := \mathbf{H}^1(\Omega; \mathbb{R}^3) \cap \mathbf{H}_0(\text{div}, \Omega)$ .

*Proof.* We only prove (2.13), since (2.14) can be proved similarly. For  $v \in H_0^1(\Omega)$ , by the commutative diagram (2.9), it follows

$$I_{h0}^{gc}(\nabla v) - \nabla(I_h^g v) = I_{h0}^{gc}(\nabla v) - I_h^{ND}(\nabla v) \in \mathbf{W}_{h0}.$$

Noting that  $\text{curl}(I_h^{ND}(\nabla v)) = I_h^{BDM}(\text{curl}(\nabla v)) = \mathbf{0}$ , by the definition of  $I_{h_0}^{gc}$ , all the DoFs (2.1)-(2.3) of  $I_{h_0}^{gc}(\nabla v) - I_h^{ND}(\nabla v)$  vanish, thus  $I_{h_0}^{gc}(\nabla v) - I_h^{ND}(\nabla v) = \mathbf{0}$ , i.e.,

$$(2.15) \quad I_{h_0}^{gc}(\nabla v) = \nabla(I_h^g v) \quad \forall v \in H_0^1(\Omega).$$

For  $\mathbf{v} \in \mathbf{H}_0(\text{grad curl}, \Omega)$ , by complex (2.7),  $I_{h_0}^d(\text{curl } \mathbf{v}) - \text{curl}(I_{h_0}^{gc} \mathbf{v}) \in \mathbf{V}_{h_0}^d$ . We get from  $I_h^{BDM}(\text{curl } \mathbf{v}) = \text{curl}(I_h^{ND} \mathbf{v})$  and the definitions of  $I_{h_0}^d$  and  $I_{h_0}^{gc}$  that

$$\begin{aligned} ((I_{h_0}^d(\text{curl } \mathbf{v}) - \text{curl}(I_{h_0}^{gc} \mathbf{v})) \cdot \mathbf{n}, q)_F &= ((I_h^{BDM}(\text{curl } \mathbf{v}) - \text{curl}(I_{h_0}^{gc} \mathbf{v})) \cdot \mathbf{n}, q)_F \\ &= ((\text{curl}(I_h^{ND} \mathbf{v}) - I_{h_0}^{gc} \mathbf{v})) \cdot \mathbf{n}, q)_F = 0 \end{aligned}$$

for  $q \in \mathbb{P}_1(F)$  and  $F \in \mathcal{F}_h$ , and

$$\begin{aligned} ((I_{h_0}^d(\text{curl } \mathbf{v}) - \text{curl}(I_{h_0}^{gc} \mathbf{v})) \times \mathbf{n}, \mathbf{q})_F \\ = (\{(I_h^{BDM}(\text{curl } \mathbf{v})) \times \mathbf{n}\} - \{\text{curl}(I_h^{ND} \mathbf{v}) \times \mathbf{n}\}, \mathbf{q})_F = 0 \end{aligned}$$

for all  $\mathbf{q} \in \mathbf{RT}(F)$  and  $F \in \mathcal{F}_h^i$ . Hence

$$(2.16) \quad I_{h_0}^d(\text{curl } \mathbf{v}) = \text{curl}(I_{h_0}^{gc} \mathbf{v}) \quad \forall \mathbf{v} \in \mathbf{H}_0(\text{grad curl}, \Omega).$$

For  $\mathbf{v} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3)$ , by complex (2.7),  $Q_h(\text{div } \mathbf{v}) - \text{div}(I_{h_0}^d \mathbf{v}) \in \mathcal{Q}_h$ . It follows from the definition of  $I_{h_0}^d$  and the integration by parts that

$$(\text{div}(I_{h_0}^d \mathbf{v}) - \text{div}(I_h^{BDM} \mathbf{v}), q)_K = ((I_{h_0}^d \mathbf{v} - I_h^{BDM} \mathbf{v}) \cdot \mathbf{n}, q)_{\partial K} = 0$$

for  $q \in \mathbb{P}_0(K)$  and  $K \in \mathcal{T}_h$ . Thanks to the commutative diagram (2.9),

$$(2.17) \quad \text{div}(I_{h_0}^d \mathbf{v}) = \text{div}(I_h^{BDM} \mathbf{v}) = Q_h(\text{div } \mathbf{v}).$$

Finally combining (2.15)-(2.17) gives the commutative diagram (2.13).  $\square$

### 3. REGULARITY OF THE QUAD-CURL SINGULAR PERTURBATION PROBLEM

We will analyze the regularity of the quad-curl singular perturbation problem (1.1) in this section. Hereafter we always assume domain  $\Omega$  is convex.

**3.1. Mixed formulation.** Due to the identity  $\text{curl}^2 \mathbf{v} = -\Delta \mathbf{v} + \nabla(\text{div } \mathbf{v})$  with  $\mathbf{v} = \text{curl } \mathbf{u}$ , the first equation in (1.1) can be rewritten as

$$(3.1) \quad -\varepsilon^2 \text{curl } \Delta(\text{curl } \mathbf{u}) + \text{curl}^2 \mathbf{u} = \mathbf{f}.$$

Then a mixed formulation of problem (1.1) is to find  $\mathbf{u} \in \mathbf{H}_0(\text{grad curl}, \Omega)$  and  $\lambda \in H_0^1(\Omega)$  such that

$$(3.2) \quad \varepsilon^2 a(\mathbf{u}, \mathbf{v}) + b(\mathbf{u}, \mathbf{v}) + c(\mathbf{v}, \lambda) = (\mathbf{f}, \mathbf{v}) \quad \forall \mathbf{v} \in \mathbf{H}_0(\text{grad curl}, \Omega),$$

$$(3.3) \quad c(\mathbf{u}, \mu) = 0 \quad \forall \mu \in H_0^1(\Omega),$$

where the bilinear forms

$$a(\mathbf{u}, \mathbf{v}) = (\nabla \text{curl } \mathbf{u}, \nabla \text{curl } \mathbf{v}), \quad b(\mathbf{u}, \mathbf{v}) = (\text{curl } \mathbf{u}, \text{curl } \mathbf{v}), \quad c(\mathbf{v}, \lambda) = (\mathbf{v}, \nabla \lambda).$$

For  $\mathbf{v} \in \mathbf{H}_0(\text{grad curl}, \Omega)$ , equip the squared norm

$$\|\mathbf{v}\|_\varepsilon^2 := \|\mathbf{v}\|_0^2 + \|\text{curl } \mathbf{v}\|_0^2 + \varepsilon^2 |\text{curl } \mathbf{v}|_1^2.$$

Clearly we have

$$\varepsilon^2 a(\mathbf{u}, \mathbf{v}) + b(\mathbf{u}, \mathbf{v}) \leq \|\mathbf{u}\|_\varepsilon \|\mathbf{v}\|_\varepsilon \quad \forall \mathbf{u}, \mathbf{v} \in \mathbf{H}_0(\text{grad curl}, \Omega),$$

$$c(\mathbf{v}, \mu) \leq \|\mathbf{v}\|_\varepsilon |\mu|_1 \quad \forall \mathbf{v} \in \mathbf{H}_0(\text{grad curl}, \Omega), \mu \in H_0^1(\Omega).$$



**Lemma 3.1.** *The mixed formulation (3.2)-(3.3) is well-posed, and it holds*

$$\|\mathbf{u}\|_0 + \|\operatorname{curl} \mathbf{u}\|_0 + \varepsilon |\operatorname{curl} \mathbf{u}|_1 \lesssim \|\mathbf{f}\|_0.$$

*Proof.* For nonzero  $\mu \in H_0^1(\Omega)$ , it follows the inf-sup condition

$$|\mu|_1 = \frac{c(\nabla \mu, \mu)}{\|\nabla \mu\|_0} = \frac{c(\nabla \mu, \mu)}{\|\nabla \mu\|_\varepsilon} \leq \sup_{\mathbf{v} \in \mathbf{H}_0(\operatorname{grad} \operatorname{curl}, \Omega)} \frac{c(\mathbf{v}, \mu)}{\|\mathbf{v}\|_\varepsilon}.$$

For  $\mathbf{v} \in \mathbf{H}_0(\operatorname{grad} \operatorname{curl}, \Omega)$  satisfying  $\operatorname{div} \mathbf{v} = 0$ , by Poincaré's inequality [2],

$$\|\mathbf{v}\|_\varepsilon^2 \lesssim \varepsilon^2 a(\mathbf{v}, \mathbf{v}) + b(\mathbf{v}, \mathbf{v}).$$

Then we end the proof by applying the Babuška-Brezzi theory [4].  $\square$

By taking  $\mathbf{v} = \nabla \lambda$  in (3.2), we get  $\lambda = 0$  from the fact  $\operatorname{div} \mathbf{f} = 0$ . Thus (3.2) is reduced to

$$\varepsilon^2 a(\mathbf{u}, \mathbf{v}) + b(\mathbf{u}, \mathbf{v}) = (\mathbf{f}, \mathbf{v}) \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{grad} \operatorname{curl}, \Omega).$$

**3.2. Regularity.** To derive the regularity of the solution  $\mathbf{u}$  of the quad-curl singular perturbation problem (1.1), we introduce the following auxiliary problem, i.e. double curl equation,

$$(3.4) \quad \begin{cases} \operatorname{curl}^2 \mathbf{u}_0 = \mathbf{f} & \text{in } \Omega, \\ \operatorname{div} \mathbf{u}_0 = 0 & \text{in } \Omega, \\ \mathbf{u}_0 \times \mathbf{n} = \mathbf{0} & \text{on } \partial\Omega, \end{cases}$$

which can be regarded as the limit of problem (1.1) as  $\varepsilon$  approaches zero. Since  $\Omega$  is convex, it holds

$$(3.5) \quad \|\mathbf{u}_0\|_1 + \|\operatorname{curl} \mathbf{u}_0\|_1 \lesssim \|\mathbf{f}\|_0.$$

**Lemma 3.2.** *Let  $\mathbf{u} \in \mathbf{H}_0(\operatorname{grad} \operatorname{curl}, \Omega)$  be the solution of problem (1.1) and  $\mathbf{u}_0 \in \mathbf{H}_0(\operatorname{curl}, \Omega)$  be the solution of problem (3.4), then we have*

$$(3.6) \quad \varepsilon^2 |\operatorname{curl} \mathbf{u}|_2 + \varepsilon |\operatorname{curl} \mathbf{u}|_1 + \|\mathbf{u} - \mathbf{u}_0\|_1 \lesssim \varepsilon^{1/2} \|\mathbf{f}\|_0.$$

*Proof.* Let  $\phi = \operatorname{curl} \mathbf{u} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3)$ . It follows from (3.1) and (3.4) that

$$-\varepsilon^2 \operatorname{curl}(\Delta \phi) = \mathbf{f} - \operatorname{curl}^2 \mathbf{u} = \operatorname{curl}^2(\mathbf{u}_0 - \mathbf{u}).$$

Thanks to the de Rham complex, the last equation implies that  $\phi \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3)$  satisfies the Stokes equation

$$\begin{cases} -\Delta \phi - \nabla p = \varepsilon^{-2} \operatorname{curl}(\mathbf{u}_0 - \mathbf{u}) & \text{in } \Omega, \\ \operatorname{div} \phi = 0 & \text{in } \Omega. \end{cases}$$

By the regularity of the Stokes equation [17, Section 11.5],

$$(3.7) \quad \|\operatorname{curl} \mathbf{u}\|_2 = \|\phi\|_2 \lesssim \varepsilon^{-2} \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0.$$

By (1.1) and (3.4), we get  $\varepsilon^2 \operatorname{curl}^4 \mathbf{u} = \operatorname{curl}^2(\mathbf{u}_0 - \mathbf{u})$ . Then it follows from the integration by parts that

$$\begin{aligned} \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0^2 &= -\varepsilon^2 (\operatorname{curl}^3 \mathbf{u}, \operatorname{curl}(\mathbf{u} - \mathbf{u}_0)) \\ &= -\varepsilon^2 (\operatorname{curl}^2 \mathbf{u}, \operatorname{curl}^2(\mathbf{u} - \mathbf{u}_0)) + \varepsilon^2 (\mathbf{n} \times \operatorname{curl}^2 \mathbf{u}, \operatorname{curl} \mathbf{u}_0)_{\partial\Omega}. \end{aligned}$$

Then we have

$$\begin{aligned} & \varepsilon^2 \|\operatorname{curl}^2 \mathbf{u}\|_0^2 + \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0^2 \\ &= \varepsilon^2 (\operatorname{curl}^2 \mathbf{u}, \mathbf{f}) + \varepsilon^2 (\mathbf{n} \times \operatorname{curl}^2 \mathbf{u}, \operatorname{curl} \mathbf{u}_0)_{\partial\Omega} \\ &\leq \varepsilon^2 \|\operatorname{curl}^2 \mathbf{u}\|_0 \|\mathbf{f}\|_0 + \varepsilon^2 \|\operatorname{curl}^2 \mathbf{u}\|_{0,\partial\Omega} \|\operatorname{curl} \mathbf{u}_0\|_{0,\partial\Omega}. \end{aligned}$$

Applying the multiplicative trace inequality, we acquire from (3.7) that

$$\begin{aligned} & \varepsilon^2 \|\operatorname{curl}^2 \mathbf{u}\|_0^2 + \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0^2 \\ &\lesssim \varepsilon^2 \|\mathbf{f}\|_0^2 + \varepsilon^2 \|\operatorname{curl}^2 \mathbf{u}\|_0^{1/2} \|\operatorname{curl}^2 \mathbf{u}\|_1^{1/2} \|\operatorname{curl} \mathbf{u}_0\|_1 \\ &\lesssim \varepsilon^2 \|\mathbf{f}\|_0^2 + \varepsilon \|\operatorname{curl}^2 \mathbf{u}\|_0^{1/2} \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0^{1/2} \|\operatorname{curl} \mathbf{u}_0\|_1, \end{aligned}$$

which implies

$$\varepsilon^2 \|\operatorname{curl}^2 \mathbf{u}\|_0^2 + \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0^2 \lesssim \varepsilon^2 \|\mathbf{f}\|_0^2 + \varepsilon \|\operatorname{curl} \mathbf{u}_0\|_1^2.$$

Employing (3.5) we have

$$\varepsilon \|\operatorname{curl}^2 \mathbf{u}\|_0 + \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0 \lesssim \varepsilon^{1/2} \|\mathbf{f}\|_0.$$

Since  $\operatorname{curl} \mathbf{u} \in \mathbf{H}_0(\operatorname{div}, \Omega) \cap \mathbf{H}(\operatorname{curl}, \Omega)$ ,  $\mathbf{u} - \mathbf{u}_0 \in \mathbf{H}(\operatorname{div}, \Omega) \cap \mathbf{H}_0(\operatorname{curl}, \Omega)$ , and  $\operatorname{div}(\mathbf{u} - \mathbf{u}_0) = 0$ , we acquire [12]

$$\|\operatorname{curl} \mathbf{u}\|_1 \lesssim \|\operatorname{curl}^2 \mathbf{u}\|_0 \lesssim \varepsilon^{-1/2} \|\mathbf{f}\|_0,$$

$$\|\mathbf{u} - \mathbf{u}_0\|_1 \lesssim \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0 \lesssim \varepsilon^{1/2} \|\mathbf{f}\|_0,$$

Combining the last two inequalities and (3.7) produces (3.6).  $\square$

#### 4. ROBUST MIXED FINITE ELEMENT METHOD

We will propose and analyze a robust mixed finite element method for the quad-curl singular perturbation problem in this section.

**4.1. Mixed finite element method.** Based on the mixed formulation (3.2)-(3.3), a mixed finite element methods for problem (1.1) is to find  $\mathbf{u}_{h0} \in \mathbf{W}_{h0}$  and  $\lambda_h \in V_h^g$  such that

$$(4.1) \quad \varepsilon^2 a_h(\mathbf{u}_{h0}, \mathbf{v}_h) + b(\mathbf{u}_{h0}, \mathbf{v}_h) + (\mathbf{v}_h, \nabla \lambda_h) = (\mathbf{f}, \mathbf{v}_h) \quad \forall \mathbf{v}_h \in \mathbf{W}_{h0},$$

$$(4.2) \quad (\mathbf{u}_{h0}, \nabla \mu_h) = 0 \quad \forall \mu_h \in V_h^g,$$

where

$$a_h(\mathbf{u}_{h0}, \mathbf{v}_h) = (\nabla_h \operatorname{curl} \mathbf{u}_{h0}, \nabla_h \operatorname{curl} \mathbf{v}_h) = \sum_{K \in \mathcal{T}_h} (\nabla \operatorname{curl} \mathbf{u}_{h0}, \nabla \operatorname{curl} \mathbf{v}_h)_K.$$

Equip  $\mathbf{W}_h$  with the discrete squared norm

$$\|\mathbf{v}_h\|_{\varepsilon,h}^2 := \|\mathbf{v}_h\|_0^2 + \|\operatorname{curl} \mathbf{v}_h\|_0^2 + \varepsilon^2 \|\operatorname{curl} \mathbf{v}_h\|_{1,h}^2.$$

It is easy to see that

$$\varepsilon^2 a_h(\mathbf{w}_h, \mathbf{v}_h) + b(\mathbf{w}_h, \mathbf{v}_h) \leq \|\mathbf{w}_h\|_{\varepsilon,h} \|\mathbf{v}_h\|_{\varepsilon,h} \quad \forall \mathbf{w}_h, \mathbf{v}_h \in \mathbf{W}_h + \mathbf{H}(\operatorname{grad} \operatorname{curl}, \Omega),$$

$$c(\mathbf{v}_h, \mu_h) \leq \|\mathbf{v}_h\|_{\varepsilon,h} \|\mu_h\|_1 \quad \forall \mathbf{v}_h \in \mathbf{W}_h + \mathbf{H}(\operatorname{grad} \operatorname{curl}, \Omega), \mu_h \in H^1(\Omega).$$

Next we show the well-posedness of the mixed finite element method (4.1)-(4.2) and the stability.

**Lemma 4.1.** *It holds the discrete Poincaré inequality*

$$(4.3) \quad \|\mathbf{v}_h\|_0 \lesssim \|\operatorname{curl} \mathbf{v}_h\|_0 \quad \forall \mathbf{v}_h \in \mathcal{K}_{h0}^d,$$

where  $\mathcal{K}_{h0}^d := \{\mathbf{v}_h \in \mathbf{W}_{h0} : (\mathbf{v}_h, \nabla q_h) = 0 \text{ for each } q_h \in V_h^g\}$ .

*Proof.* Noting that  $\operatorname{curl} \mathbf{v}_h \in \mathbf{H}_0(\operatorname{div}, \Omega)$ , by the de Rham complex, there exists  $\mathbf{v} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3)$  such that

$$(4.4) \quad \operatorname{curl} \mathbf{v} = \operatorname{curl} \mathbf{v}_h, \quad \|\mathbf{v}\|_1 \lesssim \|\operatorname{curl} \mathbf{v}_h\|_0.$$

Let  $\mathcal{I}_{h0}^{gc} \mathbf{v} \in \mathbf{W}_{h0}$  be the nodal interpolation of  $\mathbf{v}$  based on DoFs (2.1)-(2.3), and  $\mathcal{I}_h^{ND} \mathbf{v} \in \mathbf{V}_h^{ND}$  be the nodal interpolation of  $\mathbf{v}$  based on DoFs (2.1)-(2.2). Since  $\mathbf{v} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3)$  and  $\operatorname{curl} \mathbf{v} \in \mathbf{V}_{h0}^d$ , both  $\mathcal{I}_{h0}^{gc} \mathbf{v}$  and  $\mathcal{I}_h^{ND} \mathbf{v}$  are well-defined. According to (5.43) in [18], we have

$$\|\mathcal{I}_h^{ND} \mathbf{v}\|_0 \lesssim \|\mathbf{v}\|_1, \quad \|\operatorname{curl}(\mathbf{v} - \mathcal{I}_h^{ND} \mathbf{v})\|_{0, \partial K} \lesssim h_K^{1/2} |\operatorname{curl} \mathbf{v}|_{1, K} \quad \forall K \in \mathcal{T}_h.$$

Employing the scaling argument and the inverse inequality [9], it follows

$$\begin{aligned} \|\mathcal{I}_{h0}^{gc} \mathbf{v} - \mathcal{I}_h^{ND} \mathbf{v}\|_{0, K} &\lesssim h_K^{3/2} \|\operatorname{curl}(\mathbf{v} - \mathcal{I}_h^{ND} \mathbf{v})\|_{0, \partial K} \\ &\lesssim h_K^2 |\operatorname{curl} \mathbf{v}|_{1, K} \lesssim h_K \|\operatorname{curl} \mathbf{v}\|_{0, K}. \end{aligned}$$

Hence

$$(4.5) \quad \|\mathcal{I}_{h0}^{gc} \mathbf{v}\|_0 \leq \|\mathcal{I}_{h0}^{gc} \mathbf{v} - \mathcal{I}_h^{ND} \mathbf{v}\|_0 + \|\mathcal{I}_h^{ND} \mathbf{v}\|_0 \lesssim \|\mathbf{v}\|_1.$$

By the definition of  $\mathcal{I}_{h0}^{gc} \mathbf{v}$  and the integration by parts, we have

$$\begin{aligned} ((\operatorname{curl}(\mathcal{I}_{h0}^{gc} \mathbf{v}) - \operatorname{curl} \mathbf{v}) \cdot \mathbf{n}, q)_F &= 0 \quad \forall q \in \mathbb{P}_1(F), F \in \mathcal{F}_h, \\ ((\operatorname{curl}(\mathcal{I}_{h0}^{gc} \mathbf{v}) - \operatorname{curl} \mathbf{v}) \times \mathbf{n}, \mathbf{q})_F &= 0 \quad \forall \mathbf{q} \in \mathbf{RT}(F), F \in \mathcal{F}_h. \end{aligned}$$

Then we get from the fact  $\operatorname{curl}(\mathcal{I}_{h0}^{gc} \mathbf{v}) - \operatorname{curl} \mathbf{v} \in \mathbf{V}_{h0}^d$  that

$$\operatorname{curl}(\mathcal{I}_{h0}^{gc} \mathbf{v}) = \operatorname{curl} \mathbf{v} = \operatorname{curl} \mathbf{v}_h.$$

Due to the finite element Stokes complex (2.7),  $\mathbf{v}_h - \mathcal{I}_{h0}^{gc} \mathbf{v} \in \mathbf{W}_{h0} \cap \ker(\operatorname{curl}) = \nabla V_h^g$ . Then we achieve from (4.5) that

$$\|\mathbf{v}_h\|_0^2 = (\mathbf{v}_h, \mathbf{v}_h) = (\mathbf{v}_h, \mathcal{I}_{h0}^{gc} \mathbf{v}) \leq \|\mathbf{v}_h\|_0 \|\mathcal{I}_{h0}^{gc} \mathbf{v}\|_0 \lesssim \|\mathbf{v}_h\|_0 \|\mathbf{v}\|_1.$$

Finally (4.3) follows from the last inequality and (4.4).  $\square$

**Theorem 4.2.** *We have the discrete stability*

$$(4.6) \quad \begin{aligned} &\|\boldsymbol{\psi}_h\|_{\varepsilon, h} + |\gamma_h|_1 \\ &\lesssim \sup_{(\boldsymbol{\psi}_h, \mu_h) \in \mathbf{W}_{h0} \times V_h^g} \frac{\varepsilon^2 a_h(\boldsymbol{\psi}_h, \mathbf{v}_h) + b(\boldsymbol{\psi}_h, \mathbf{v}_h) + (\mathbf{v}_h, \nabla \gamma_h) + (\boldsymbol{\psi}_h, \nabla \mu_h)}{\|\boldsymbol{\psi}_h\|_{\varepsilon, h} + |\mu_h|_1} \end{aligned}$$

for any  $\boldsymbol{\psi}_h \in \mathbf{W}_{h0}$  and  $\gamma_h \in V_h^g$ . Then the mixed finite element method (4.1)-(4.2) is well-posed.

*Proof.* By (4.3), we derive the coercivity

$$\|\mathbf{v}_h\|_{\varepsilon, h}^2 \lesssim \varepsilon^2 a_h(\mathbf{v}_h, \mathbf{v}_h) + b(\mathbf{v}_h, \mathbf{v}_h) \quad \forall \mathbf{v}_h \in \mathcal{K}_{h0}^d.$$

Since  $\nabla V_h^g \subseteq \mathbf{W}_{h0}$  by the finite element Stokes complex (2.7), it holds the discrete inf-sup condition

$$|\mu_h|_1 = \sup_{\mathbf{v}_h \in \nabla V_h^g} \frac{(\mathbf{v}_h, \nabla \mu_h)}{\|\mathbf{v}_h\|_0} = \sup_{\mathbf{v}_h \in \nabla V_h^g} \frac{(\mathbf{v}_h, \nabla \mu_h)}{\|\mathbf{v}_h\|_{\varepsilon, h}} \leq \sup_{\mathbf{v}_h \in \mathbf{W}_{h0}} \frac{(\mathbf{v}_h, \nabla \mu_h)}{\|\mathbf{v}_h\|_{\varepsilon, h}}.$$

Thus the discrete stability (4.6) follows from the Babuška-Brezzi theory.  $\square$

By taking  $\mathbf{v}_h = \nabla \lambda_h$  in (4.1), we get  $\lambda_h = 0$ . Thus (4.1) is reduced to

$$(4.7) \quad \varepsilon^2 a_h(\mathbf{u}_{h0}, \mathbf{v}_h) + b(\mathbf{u}_{h0}, \mathbf{v}_h) = (\mathbf{f}, \mathbf{v}_h) \quad \forall \mathbf{v}_h \in \mathbf{W}_{h0}.$$

**4.2. Interpolation error estimates.** We will derive some interpolation error estimates for later uses.

**Lemma 4.3.** *We have*

$$(4.8) \quad \|\mathbf{v} - I_h^d \mathbf{v}\|_0 + h|\mathbf{v} - I_h^d \mathbf{v}|_{1,h} \lesssim h^j |\mathbf{v}|_j \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{div}, \Omega) \cap \mathbf{H}^j(\Omega; \mathbb{R}^3), j = 1, 2,$$

$$(4.9) \quad \|I_h^d \mathbf{v}\|_0 \lesssim \|\mathbf{v}\|_0 + h\|\operatorname{div} \mathbf{v}\|_0 \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{div}, \Omega) \cap \mathbf{H}^1(\Omega; \mathbb{R}^3),$$

$$(4.10) \quad \|\mathbf{v} - I_{h0}^d \mathbf{v}\|_0 + h|\mathbf{v} - I_{h0}^d \mathbf{v}|_{1,h} \lesssim h^j |\mathbf{v}|_j \quad \forall \mathbf{v} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3) \cap \mathbf{H}^j(\Omega; \mathbb{R}^3), j = 1, 2,$$

$$(4.11) \quad \|I_{h0}^d \mathbf{v}\|_0 \lesssim \|\mathbf{v}\|_0 + h\|\operatorname{div} \mathbf{v}\|_0 \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{div}, \Omega) \cap \mathbf{H}^1(\Omega; \mathbb{R}^3).$$

*Proof.* We only prove (4.10) and (4.11), since we can apply the similar argument to prove (4.8) and (4.9).

For  $\mathbf{v} \in \mathbf{H}_0^1(\Omega; \mathbb{R}^3) \cap \mathbf{H}^j(\Omega; \mathbb{R}^3)$  and  $i = 0, 1$ , we get from the scaling argument that

$$h_K^i |I_h^{BDM} \mathbf{v} - I_{h0}^d \mathbf{v}|_{i,K} \lesssim h_K^{1/2} \|[[I_h^{BDM} \mathbf{v}]]\|_{0,\partial K} = h_K^{1/2} \|[[I_h^{BDM} \mathbf{v} - \mathbf{v}]]\|_{0,\partial K},$$

which together with the trace inequality yields

$$\begin{aligned} |\mathbf{v} - I_{h0}^d \mathbf{v}|_{i,h}^2 &\lesssim |\mathbf{v} - I_h^{BDM} \mathbf{v}|_{i,h}^2 + \sum_{K \in \mathcal{T}_h} h_K^{1-2i} \|[[I_h^{BDM} \mathbf{v} - \mathbf{v}]]\|_{0,\partial K}^2 \\ &\lesssim |\mathbf{v} - I_h^{BDM} \mathbf{v}|_{i,h}^2 + \sum_{K \in \mathcal{T}_h} h_K^{-2i} (\|\mathbf{v} - I_h^{BDM} \mathbf{v}\|_{0,K}^2 + h_K^2 |\mathbf{v} - I_h^{BDM} \mathbf{v}|_{1,K}^2). \end{aligned}$$

Then (4.10) holds from (2.12).

For  $\mathbf{v} \in \mathbf{H}_0(\operatorname{div}, \Omega) \cap \mathbf{H}^1(\Omega; \mathbb{R}^3)$ , similarly we have

$$\|I_h^{BDM} \mathbf{v} - I_{h0}^d \mathbf{v}\|_0^2 \lesssim \sum_{K \in \mathcal{T}_h} h_K \|[[I_h^{BDM} \mathbf{v}]]\|_{0,\partial K}^2 \lesssim \|I_h^{BDM} \mathbf{v}\|_0^2.$$

Then

$$\|I_{h0}^d \mathbf{v}\|_0 \leq \|I_h^{BDM} \mathbf{v}\|_0 + \|I_h^{BDM} \mathbf{v} - I_{h0}^d \mathbf{v}\|_0 \lesssim \|I_h^{BDM} \mathbf{v}\|_0.$$

Then (4.11) holds from (2.11).  $\square$

**Lemma 4.4.** *Assume  $\operatorname{curl} \mathbf{u}_0 \in H^s(\Omega; \mathbb{R}^3)$  with  $1 \leq s \leq 2$ . We have*

$$(4.12) \quad \|\operatorname{curl} \mathbf{u} - I_h^d(\operatorname{curl} \mathbf{u})\|_0 \lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0 + h^s |\operatorname{curl} \mathbf{u}_0|_s,$$

$$(4.13) \quad \varepsilon |\operatorname{curl} \mathbf{u} - I_h^d(\operatorname{curl} \mathbf{u})|_{1,h} \lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0$$

with  $0 \leq r \leq 1$ .

*Proof.* It follows from (4.8)-(4.9) and (3.5)-(3.6) that

$$\begin{aligned} \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0) - I_h^d(\operatorname{curl}(\mathbf{u} - \mathbf{u}_0))\|_0 &\lesssim h^{1-r} \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0^r |\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)|_1^{1-r} \\ &\lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0. \end{aligned}$$

Apply (4.8) to get

$$\|\operatorname{curl} \mathbf{u}_0 - I_h^d(\operatorname{curl} \mathbf{u}_0)\|_0 \lesssim h^s |\operatorname{curl} \mathbf{u}_0|_s.$$

Hence (4.12) holds from the last two inequalities.

Employing (4.8) again, we get

$$|\operatorname{curl} \mathbf{u} - I_h^d(\operatorname{curl} \mathbf{u})|_{1,h} \lesssim h^{1-r} |\operatorname{curl} \mathbf{u}|_1^r |\operatorname{curl} \mathbf{u}|_2^{1-r},$$

which combined with (3.6) produces (4.13).  $\square$

**Lemma 4.5.** *We have*

$$(4.14) \quad \|\operatorname{curl} \mathbf{u} - I_{h_0}^d(\operatorname{curl} \mathbf{u})\|_0 + \varepsilon |\operatorname{curl} \mathbf{u} - I_{h_0}^d(\operatorname{curl} \mathbf{u})|_{1,h} \lesssim h^{1/2} \|\mathbf{f}\|_0.$$

*Proof.* With the help of the scaling argument,

$$\|I_h^d(\operatorname{curl} \mathbf{u}) - I_{h_0}^d(\operatorname{curl} \mathbf{u})\|_0^2 \lesssim \sum_{F \in \mathcal{F}_h^\partial} h_F \|\operatorname{curl} \mathbf{u} - I_h^{BDM}(\operatorname{curl} \mathbf{u})\|_{0,F}^2.$$

On the other hand, by the multiplicative trace inequality, (2.12) and (3.5)-(3.6), we acquire

$$\begin{aligned} & \sum_{F \in \mathcal{F}_h^\partial} h_F \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0) - I_h^{BDM}(\operatorname{curl}(\mathbf{u} - \mathbf{u}_0))\|_{0,F}^2 \\ & \lesssim h \|\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)\|_0 |\operatorname{curl}(\mathbf{u} - \mathbf{u}_0)|_1 \lesssim h \|\mathbf{f}\|_0^2, \\ & \sum_{F \in \mathcal{F}_h^\partial} h_F \|\operatorname{curl} \mathbf{u}_0 - I_h^{BDM}(\operatorname{curl} \mathbf{u}_0)\|_{0,F}^2 \lesssim h^2 |\operatorname{curl} \mathbf{u}_0|_1^2 \lesssim h^2 \|\mathbf{f}\|_0^2. \end{aligned}$$

Hence

$$\|I_h^d(\operatorname{curl} \mathbf{u}) - I_{h_0}^d(\operatorname{curl} \mathbf{u})\|_0 \lesssim h^{1/2} \|\mathbf{f}\|_0.$$

Combining the last inequality and (4.12) with  $r = 1/2$  and  $s = 1$  we derive

$$(4.15) \quad \|\operatorname{curl} \mathbf{u} - I_{h_0}^d(\operatorname{curl} \mathbf{u})\|_0 \lesssim h^{1/2} \|\mathbf{f}\|_0.$$

Applying the scaling argument, the trace inequality, (2.12) and (3.6) again,

$$\begin{aligned} |I_h^d(\operatorname{curl} \mathbf{u}) - I_{h_0}^d(\operatorname{curl} \mathbf{u})|_{1,h}^2 & \lesssim \sum_{F \in \mathcal{F}_h^\partial} h_F^{-1} \|\operatorname{curl} \mathbf{u} - I_h^{BDM}(\operatorname{curl} \mathbf{u})\|_{0,F}^2 \\ & \lesssim h |\operatorname{curl} \mathbf{u}|_1 |\operatorname{curl} \mathbf{u}|_2 \lesssim \varepsilon^{-2} h \|\mathbf{f}\|_0^2 \end{aligned}$$

Then we get from (4.13) with  $r = 1/2$  that

$$\varepsilon |\operatorname{curl} \mathbf{u} - I_{h_0}^d(\operatorname{curl} \mathbf{u})|_{1,h} \lesssim h^{1/2} \|\mathbf{f}\|_0,$$

which together with (4.15) implies (4.14).  $\square$

**Lemma 4.6.** *The following estimates hold*

$$(4.16) \quad \|\mathbf{v} - I_h^{gc} \mathbf{v}\|_0 \lesssim h^j |\mathbf{v}|_j \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{curl}, \Omega) \cap \mathbf{H}^j(\Omega; \mathbb{R}^3), j = 2, k + 1,$$

$$(4.17) \quad \|\mathbf{v} - I_h^{gc} \mathbf{v}\|_0 \lesssim h |\mathbf{v}|_1 \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{curl}, \Omega) \cap \mathbf{H}^1(\Omega; \mathbb{R}^3).$$

$$(4.18) \quad \|\mathbf{v} - I_{h_0}^{gc} \mathbf{v}\|_0 \lesssim h^j |\mathbf{v}|_j \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{grad} \operatorname{curl}, \Omega) \cap \mathbf{H}^j(\Omega; \mathbb{R}^3), j = 2, k + 1,$$

$$(4.19) \quad \|\mathbf{v} - I_{h_0}^{gc} \mathbf{v}\|_0 \lesssim h |\mathbf{v}|_1 \quad \forall \mathbf{v} \in \mathbf{H}_0(\operatorname{curl}, \Omega) \cap \mathbf{H}^1(\Omega; \mathbb{R}^3).$$

*Proof.* We only prove (4.18) and (4.19), since we can apply the similar argument to prove (4.16) and (4.17).

For  $K \in \mathcal{T}_h$ , it follows from the scaling argument, commutative diagram (2.9), commutative diagram (2.13), and the inverse inequality that

$$\begin{aligned} & \|I_h^{ND} \mathbf{v} - I_{h0}^{gc} \mathbf{v}\|_{0,K} \\ & \lesssim h_K^{3/2} \|\operatorname{curl}(I_h^{ND} \mathbf{v} - I_{h0}^{gc} \mathbf{v})\|_{0,\partial K} = h_K^{3/2} \|I_h^{BDM}(\operatorname{curl} \mathbf{v}) - I_{h0}^d(\operatorname{curl} \mathbf{v})\|_{0,\partial K} \\ & \lesssim h_K \|I_h^{BDM}(\operatorname{curl} \mathbf{v}) - I_{h0}^d(\operatorname{curl} \mathbf{v})\|_{0,K}. \end{aligned}$$

Hence

$$\|\mathbf{v} - I_{h0}^{gc} \mathbf{v}\|_{0,K} \lesssim \|\mathbf{v} - I_h^{ND} \mathbf{v}\|_{0,K} + h_K \|I_h^{BDM}(\operatorname{curl} \mathbf{v}) - I_{h0}^d(\operatorname{curl} \mathbf{v})\|_{0,K}.$$

Thus estimates (4.18)-(4.19) hold from (2.10)-(2.12) and (4.10)-(4.11).  $\square$

**4.3. Error analysis.** We first present the consistency error of the mixed finite element method (4.1)-(4.2).

**Lemma 4.7.** *We have for any  $\mathbf{v}_h \in \mathbf{W}_{h0}$  that*

$$(4.20) \quad \varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) \lesssim h \varepsilon^2 |\operatorname{curl} \mathbf{u}|_2 |\operatorname{curl} \mathbf{v}_h|_{1,h},$$

$$(4.21) \quad \varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) \lesssim h^{1/2} \varepsilon^2 |\operatorname{curl} \mathbf{u}|_1^{1/2} |\operatorname{curl} \mathbf{u}|_2^{1/2} |\operatorname{curl} \mathbf{v}_h|_{1,h}.$$

*Proof.* Since  $\mathbf{v}_h \in \mathbf{H}_0(\operatorname{curl}, \Omega)$ , we derive from (3.1) and the integration by parts that

$$-\varepsilon^2 (\Delta \operatorname{curl} \mathbf{u}, \operatorname{curl} \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) = (\mathbf{f}, \mathbf{v}_h).$$

Then

$$\begin{aligned} \varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) &= \varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + \varepsilon^2 (\Delta \operatorname{curl} \mathbf{u}, \operatorname{curl} \mathbf{v}_h) \\ (4.22) \quad &= \sum_{K \in \mathcal{T}_h} \varepsilon^2 (\partial_n(\operatorname{curl} \mathbf{u}), \operatorname{curl} \mathbf{v}_h)_{\partial K}. \end{aligned}$$

On the other hand, due to the weak continuity of  $\operatorname{curl} \mathbf{v}_h \in \mathbf{V}_{h0}^d$ , we get from the trace inequality and the error estimate of  $Q_F^0$  that

$$\begin{aligned} & \sum_{K \in \mathcal{T}_h} \varepsilon^2 (\partial_n(\operatorname{curl} \mathbf{u}), \operatorname{curl} \mathbf{v}_h)_{\partial K} \\ &= \sum_{K \in \mathcal{T}_h} \sum_{F \in \mathcal{F}(K)} \varepsilon^2 (\partial_n(\operatorname{curl} \mathbf{u}) - Q_F^0 \partial_n(\operatorname{curl} \mathbf{u}), \operatorname{curl} \mathbf{v}_h)_F \\ &= \sum_{K \in \mathcal{T}_h} \sum_{F \in \mathcal{F}(K)} \varepsilon^2 (\partial_n(\operatorname{curl} \mathbf{u}) - Q_F^0 \partial_n(\operatorname{curl} \mathbf{u}), \operatorname{curl} \mathbf{v}_h - Q_F^0 \operatorname{curl} \mathbf{v}_h)_F \\ &\lesssim \min \{ h \varepsilon^2 |\operatorname{curl} \mathbf{u}|_2 |\operatorname{curl} \mathbf{v}_h|_{1,h}, h^{1/2} \varepsilon^2 |\operatorname{curl} \mathbf{u}|_1^{1/2} |\operatorname{curl} \mathbf{u}|_2^{1/2} |\operatorname{curl} \mathbf{v}_h|_{1,h} \}. \end{aligned}$$

Thus (4.20) and (4.21) follow from (4.22).  $\square$

Now we can show the a priori error estimate.

**Theorem 4.8.** *Let  $\mathbf{u} \in \mathbf{H}_0(\text{grad curl}, \Omega)$  be the solution of the problem (1.1), and  $\mathbf{u}_{h0} \in \mathbf{W}_{h0}$  be the solution of the mixed finite element method (4.1)-(4.2). Then*

$$(4.23) \quad \begin{aligned} \|\mathbf{u} - \mathbf{u}_{h0}\|_{\varepsilon, h} &\lesssim \inf_{\mathbf{w}_h \in \mathbf{W}_{h0}} \|\mathbf{u} - \mathbf{w}_h\|_{\varepsilon, h} \\ &\quad + \sup_{\mathbf{v}_h \in \mathbf{W}_{h0}} \frac{\varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h)}{\|\mathbf{v}_h\|_{\varepsilon, h}}. \end{aligned}$$

*Proof.* For  $\mathbf{w}_h, \mathbf{v}_h \in \mathbf{W}_{h0}$ , we get from (4.7) and the fact  $\mathbf{u}_{h0} \in \mathcal{K}_{h0}^d$  that

$$\begin{aligned} &\varepsilon^2 a_h(\mathbf{w}_h - \mathbf{u}_{h0}, \mathbf{v}_h) + b(\mathbf{w}_h - \mathbf{u}_{h0}, \mathbf{v}_h) + c(\mathbf{w}_h - \mathbf{u}_{h0}, \mu_h) \\ &= \varepsilon^2 a_h(\mathbf{w}_h, \mathbf{v}_h) + b(\mathbf{w}_h, \mathbf{v}_h) + c(\mathbf{w}_h, \mu_h) - (\mathbf{f}, \mathbf{v}_h) \\ &= \varepsilon^2 a_h(\mathbf{w}_h - \mathbf{u}, \mathbf{v}_h) + b(\mathbf{w}_h - \mathbf{u}, \mathbf{v}_h) + c(\mathbf{w}_h - \mathbf{u}, \mu_h) \\ &\quad + \varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) \\ &\lesssim \|\mathbf{u} - \mathbf{w}_h\|_{\varepsilon, h} (\|\mathbf{v}_h\|_{\varepsilon, h} + |\mu_h|_1) + \varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h). \end{aligned}$$

By the discrete stability (4.6) with  $\psi_h = \mathbf{w}_h - \mathbf{u}_{h0}$  and  $\gamma_h = 0$ , we get

$$\begin{aligned} &\|\mathbf{w}_h - \mathbf{u}_{h0}\|_{\varepsilon, h} \\ &\lesssim \sup_{(\mathbf{v}_h, \mu_h) \in \mathbf{W}_{h0} \times V_h^g} \frac{\varepsilon^2 a_h(\mathbf{w}_h - \mathbf{u}_{h0}, \mathbf{v}_h) + b(\mathbf{w}_h - \mathbf{u}_{h0}, \mathbf{v}_h) + (\mathbf{w}_h - \mathbf{u}_{h0}, \nabla \mu_h)}{\|\mathbf{v}_h\|_{\varepsilon, h} + |\mu_h|_1} \\ &\lesssim \|\mathbf{u} - \mathbf{w}_h\|_{\varepsilon, h} + \sup_{\mathbf{v}_h \in \mathbf{W}_{h0}} \frac{\varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h)}{\|\mathbf{v}_h\|_{\varepsilon, h}}, \end{aligned}$$

which together with the triangle inequality implies (4.23).  $\square$

**Corollary 4.9.** *Let  $\mathbf{u} \in \mathbf{H}_0(\text{grad curl}, \Omega)$  be the solution of the problem (1.1), and  $\mathbf{u}_{h0} \in \mathbf{W}_{h0}$  be the solution of the mixed finite element method (4.1)-(4.2). Assume  $\mathbf{u} \in \mathbf{H}^{k+1}(\Omega; \mathbb{R}^3)$  and  $\text{curl } \mathbf{u} \in \mathbf{H}^2(\Omega; \mathbb{R}^3)$ . Then we have*

$$(4.24) \quad \|\mathbf{u} - \mathbf{u}_{h0}\|_{\varepsilon, h} \lesssim h^{k+1} |\mathbf{u}|_{k+1} + (h^2 + h\varepsilon) |\text{curl } \mathbf{u}|_2.$$

*Proof.* It follows from (4.18) that

$$\|\mathbf{u} - I_{h0}^{gc} \mathbf{u}\|_0 \lesssim h^{k+1} |\mathbf{u}|_{k+1}.$$

By commutative diagram (2.13) and (4.10),

$$h^j |\text{curl}(\mathbf{u} - I_{h0}^{gc} \mathbf{u})|_{j, h} = h^j |\text{curl } \mathbf{u} - I_{h0}^d(\text{curl } \mathbf{u})|_{j, h} \lesssim h^2 |\text{curl } \mathbf{u}|_2, \quad j = 0, 1.$$

Therefore (4.24) holds from (4.20) and (4.23) with  $\mathbf{w}_h = I_{h0}^{gc} \mathbf{u}$ .  $\square$

Corollary 4.9 ensures the linear convergence  $O(h)$  of  $\|\mathbf{u} - \mathbf{u}_{h0}\|_{\varepsilon, h}$  for any fixed  $\varepsilon > 0$ . However, by the regularity (3.6),  $|\text{curl } \mathbf{u}|_2 = O(\varepsilon^{-3/2})$  depends on parameter  $\varepsilon$ , therefore the upper bound  $h^{k+1} |\mathbf{u}|_{k+1} + (h^2 + h\varepsilon) |\text{curl } \mathbf{u}|_2$  in (4.24) will deteriorate when  $\varepsilon$  approaches zero. In the following we show a uniform estimate of  $\|\mathbf{u} - \mathbf{u}_{h0}\|_{\varepsilon, h}$  with respect to  $\varepsilon$ .

**Theorem 4.10.** *Let  $\mathbf{u} \in \mathbf{H}_0(\text{grad curl}, \Omega)$  be the solution of the problem (1.1),  $\mathbf{u}_0 \in \mathbf{H}_0(\text{curl}, \Omega)$  be the solution of double curl equation (3.4), and  $\mathbf{u}_{h0} \in \mathbf{W}_{h0}$  be the solution of the mixed finite element methods (4.1)-(4.2). Then we have the robust error estimates*

$$(4.25) \quad \|\mathbf{u} - \mathbf{u}_{h0}\|_{\varepsilon, h} \lesssim h^{1/2} \|\mathbf{f}\|_0,$$

$$(4.26) \quad \|\mathbf{u}_0 - \mathbf{u}_{h0}\|_{\varepsilon, h} \lesssim (\varepsilon^{1/2} + h^{1/2}) \|\mathbf{f}\|_0.$$

*Proof.* It follows from (4.19) and (3.5)-(3.6) that

$$\|\mathbf{u} - I_{h0}^{gc}\mathbf{u}\|_0 \lesssim h|\mathbf{u}|_1 \leq h|\mathbf{u} - \mathbf{u}_0|_1 + h|\mathbf{u}_0|_1 \lesssim h\|\mathbf{f}\|_0.$$

Then we get from (4.14) and  $\text{curl}(I_{h0}^{gc}\mathbf{u}) = I_{h0}^d(\text{curl}\mathbf{u})$  that

$$\|\mathbf{u} - I_{h0}^{gc}\mathbf{u}\|_{\varepsilon,h} \lesssim h^{1/2}\|\mathbf{f}\|_0.$$

On the other side, it holds from (4.21) and (3.6) that

$$\sup_{\mathbf{v}_h \in \mathbf{W}_{h0}} \frac{\varepsilon^2 a_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h)}{\|\mathbf{v}_h\|_{\varepsilon,h}} \lesssim h^{1/2}\varepsilon|\text{curl}\mathbf{u}|_1^{1/2}|\text{curl}\mathbf{u}|_2^{1/2} \lesssim h^{1/2}\|\mathbf{f}\|_0.$$

Hence we conclude (4.25) from (4.23) and the last two inequalities. Finally combining (4.25) and regularities (3.5)-(3.6) produces (4.26).  $\square$

## 5. MODIFIED MIXED FINITE ELEMENT METHOD BASED ON NITSCHÉ'S TECHNIQUE

The half-order convergence rate of  $\|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon,h}$  in (4.25) is sharp, but not optimal. To this end, we will develop a modified mixed finite element method based on the Nitsche's technique following the ideas in [22, 23, 13] in this section, which possesses the optimal convergence rate for small  $\varepsilon$ .

**5.1. Modified mixed finite element method.** By applying the Nitsche's technique to the linear form  $a_h(\mathbf{u}_h, \mathbf{v}_h)$  in the mixed finite element method (4.1)-(4.2), the modified mixed finite element method is to find  $\mathbf{u}_h \in \mathbf{W}_h$  and  $\lambda_h \in V_h^g$  such that

$$(5.1) \quad \varepsilon^2 \tilde{a}_h(\mathbf{u}_h, \mathbf{v}_h) + b(\mathbf{u}_h, \mathbf{v}_h) + (\mathbf{v}_h, \nabla \lambda_h) = (\mathbf{f}, \mathbf{v}_h) \quad \forall \mathbf{v}_h \in \mathbf{W}_h,$$

$$(5.2) \quad (\tilde{\mathbf{u}}_h, \nabla \mu_h) = 0 \quad \forall \mu_h \in V_h^g,$$

where

$$\begin{aligned} \tilde{a}_h(\mathbf{u}_h, \mathbf{v}_h) &= (\nabla_h \text{curl}\mathbf{u}_h, \nabla_h \text{curl}\mathbf{v}_h) - \sum_{F \in \mathcal{F}_h^\partial} (\partial_n(\text{curl}\mathbf{u}_h), \text{curl}\mathbf{v}_h)_F \\ &\quad - \sum_{F \in \mathcal{F}_h^\partial} (\text{curl}\mathbf{u}_h, \partial_n(\text{curl}\mathbf{v}_h))_F + \sum_{F \in \mathcal{F}_h^\partial} \frac{\sigma}{h_F} (\text{curl}\mathbf{u}_h, \text{curl}\mathbf{v}_h)_F \end{aligned}$$

with constant  $\sigma > 0$ .

Equip  $\mathbf{W}_h$  with the discrete squared norm

$$\begin{aligned} \|\mathbf{v}_h\|_{\varepsilon,h}^2 &:= \|\mathbf{v}_h\|_{\varepsilon,h}^2 + \varepsilon^2 \sum_{F \in \mathcal{F}_h^\partial} \frac{1}{h_F} \|\text{curl}\mathbf{v}_h\|_F^2 \\ &= \|\mathbf{v}_h\|_0^2 + \|\text{curl}\mathbf{v}_h\|_0^2 + \varepsilon^2 |\text{curl}\mathbf{v}_h|_{1,h}^2 + \varepsilon^2 \sum_{F \in \mathcal{F}_h^\partial} \frac{1}{h_F} \|\text{curl}\mathbf{v}_h\|_F^2. \end{aligned}$$

There exists a constant  $\sigma_0 > 0$  depending only on the shape regularity of  $\mathcal{T}_h$  such that for any fixed number  $\sigma \geq \sigma_0$ , it holds [25, Lemma 2]

$$|\text{curl}\mathbf{v}_h|_{1,h}^2 + \sum_{F \in \mathcal{F}_h^\partial} \frac{1}{h_F} \|\text{curl}\mathbf{v}_h\|_F^2 \lesssim \tilde{a}_h(\mathbf{v}_h, \mathbf{v}_h) \quad \forall \mathbf{v}_h \in \mathbf{W}_h.$$



Adopting the similar argument as in Section 4, we have the discrete stability

$$\begin{aligned} & \|\boldsymbol{\psi}_h\|_{\varepsilon,h} + |\gamma_h|_1 \\ & \lesssim \sup_{(\boldsymbol{v}_h, \boldsymbol{\mu}_h) \in \mathbf{W}_h \times V_h^g} \frac{\varepsilon^2 \tilde{a}_h(\boldsymbol{\psi}_h, \boldsymbol{v}_h) + b(\boldsymbol{\psi}_h, \boldsymbol{v}_h) + (\boldsymbol{v}_h, \nabla \gamma_h) + (\boldsymbol{\psi}_h, \nabla \boldsymbol{\mu}_h)}{\|\boldsymbol{v}_h\|_{\varepsilon,h} + |\boldsymbol{\mu}_h|_1} \end{aligned}$$

for any  $\boldsymbol{\psi}_h \in \mathbf{W}_h$  and  $\gamma_h \in V_h^g$ . Therefore the modified mixed finite element method (5.1)-(5.2) is well-posed.

**5.2. Error analysis.** First apply the same argument as the proof of Theorem 4.8 and Corollary 4.9 to derive the following error estimates.

**Theorem 5.1.** *Let  $\mathbf{u} \in \mathbf{H}_0(\text{grad curl}, \Omega)$  be the solution of the problem (1.1), and  $\mathbf{u}_h \in \mathbf{W}_h$  be the solution of the mixed finite element method (5.1)-(5.2). Then*

$$(5.3) \quad \begin{aligned} \|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon,h} & \lesssim \inf_{\mathbf{w}_h \in \mathbf{W}_h} \|\mathbf{u} - \mathbf{w}_h\|_{\varepsilon,h} \\ & \quad + \sup_{\mathbf{v}_h \in \mathbf{W}_h} \frac{\varepsilon^2 \tilde{a}_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h)}{\|\mathbf{v}_h\|_{\varepsilon,h}}. \end{aligned}$$

Assume  $\mathbf{u} \in \mathbf{H}^{k+1}(\Omega; \mathbb{R}^3)$  and  $\text{curl } \mathbf{u} \in \mathbf{H}^2(\Omega; \mathbb{R}^3)$ . Then we have

$$\|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon,h} \lesssim h^{k+1} |\mathbf{u}|_{k+1} + (h^2 + h\varepsilon) |\text{curl } \mathbf{u}|_2.$$

Finally we derive a optimal and robust error estimate of  $\|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon,h}$ .

**Lemma 5.2.** *We have for any  $\mathbf{v}_h \in \mathbf{W}_h$  that*

$$(5.4) \quad \varepsilon^2 \tilde{a}_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) \lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0 \|\mathbf{v}_h\|_{\varepsilon,h}$$

with  $0 \leq r \leq 1$ .

*Proof.* Applying the similar argument as in the proof of Lemma 4.7, we have

$$\begin{aligned} & \varepsilon^2 \tilde{a}_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) \\ & = \sum_{K \in \mathcal{T}_h} \sum_{F \in \mathcal{F}(K) \cap \mathcal{F}_h^i} \varepsilon^2 (\partial_n(\text{curl } \mathbf{u}) - Q_F^0 \partial_n(\text{curl } \mathbf{u}), \text{curl } \mathbf{v}_h - Q_F^0 \text{curl } \mathbf{v}_h)_F. \end{aligned}$$

By the error estimate of  $Q_F^0$  and the inverse inequality,

$$\begin{aligned} \varepsilon^2 \tilde{a}_h(\mathbf{u}, \mathbf{v}_h) + b(\mathbf{u}, \mathbf{v}_h) - (\mathbf{f}, \mathbf{v}_h) & \lesssim \varepsilon^2 h^{1-r} |\text{curl } \mathbf{u}|_2 \|\text{curl } \mathbf{v}_h\|_0^r |\text{curl } \mathbf{v}_h|_{1,h}^{1-r} \\ & \lesssim \varepsilon^{r+1} h^{1-r} |\text{curl } \mathbf{u}|_2 \|\mathbf{v}_h\|_{\varepsilon,h}, \end{aligned}$$

which together with (3.6) indicates (5.4).  $\square$

**Lemma 5.3.** *Assume  $\mathbf{u}_0 \in H^{s+1}(\Omega; \mathbb{R}^3)$  with  $1 \leq s \leq k$ . We have*

$$(5.5) \quad \|\mathbf{u} - I_h^{gc} \mathbf{u}\|_{\varepsilon,h} \lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0 + h^s (h |\mathbf{u}_0|_{s+1} + |\text{curl } \mathbf{u}_0|_s)$$

with  $0 \leq r \leq 1$ .

*Proof.* By (4.16)-(4.17) and (3.6),

$$\begin{aligned} \|\mathbf{u} - I_h^{gc} \mathbf{u}\|_0 & \leq \|(\mathbf{u} - \mathbf{u}_0) - I_h^{gc}(\mathbf{u} - \mathbf{u}_0)\|_0 + \|\mathbf{u}_0 - I_h^{gc} \mathbf{u}_0\|_0 \\ & \lesssim h |\mathbf{u} - \mathbf{u}_0|_1 + h^{s+1} |\mathbf{u}_0|_{s+1} \lesssim h \varepsilon^{1/2} \|\mathbf{f}\|_0 + h^{s+1} |\mathbf{u}_0|_{s+1}. \end{aligned}$$

It follows from complex (2.14), the trace inequality, (4.8) and (3.6) that

$$\begin{aligned} \varepsilon^2 \sum_{F \in \mathcal{F}_h^\partial} \frac{1}{h_F} \|\operatorname{curl}(\mathbf{u} - I_h^{gc} \mathbf{u})\|_F^2 &= \varepsilon^2 \sum_{F \in \mathcal{F}_h^\partial} \frac{1}{h_F} \|\operatorname{curl} \mathbf{u} - I_h^d(\operatorname{curl} \mathbf{u})\|_F^2 \\ &\lesssim \varepsilon^2 h^{1-r} |\operatorname{curl} \mathbf{u}|_1^r |\operatorname{curl} \mathbf{u}|_2^{1-r} \lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0. \end{aligned}$$

Thus we conclude (5.5) from (4.12)-(4.13) and the last two inequalities.  $\square$

**Theorem 5.4.** *Let  $\mathbf{u} \in \mathbf{H}_0(\operatorname{grad} \operatorname{curl}, \Omega)$  be the solution of the problem (1.1),  $\mathbf{u}_0 \in \mathbf{H}_0(\operatorname{curl}, \Omega)$  be the solution of double curl equation (3.4), and  $\mathbf{u}_h \in \mathbf{W}_h$  be the solution of the mixed finite element methods (4.1)-(4.2). Assume  $\mathbf{u}_0 \in H^{k+1}(\Omega; \mathbb{R}^3)$  and  $\operatorname{curl} \mathbf{u}_0 \in H^2(\Omega; \mathbb{R}^3)$ . Then we have the robust error estimates*

$$(5.6) \quad \|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon, h} \lesssim \varepsilon^{r-1/2} h^{1-r} \|\mathbf{f}\|_0 + h^{k+1} |\mathbf{u}_0|_{k+1} + h^2 |\operatorname{curl} \mathbf{u}_0|_2$$

with  $0 \leq r \leq 1$ , and

$$(5.7) \quad \|\mathbf{u}_0 - \mathbf{u}_h\|_{\varepsilon, h} \lesssim \varepsilon^{1/2} \|\mathbf{f}\|_0 + h^{k+1} |\mathbf{u}_0|_{k+1} + h^2 |\operatorname{curl} \mathbf{u}_0|_2.$$

*Proof.* Estimate (5.6) holds from (5.3) and (5.4)-(5.5). And (5.7) follows from (5.6) and regularities (3.5)-(3.6).  $\square$

**Remark 5.5.** For a fixed  $\varepsilon > 0$ , estimate (5.6) tells us  $\|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon, h} \lesssim h$  by choosing  $r = 0$ . When  $\varepsilon$  tends to zero, estimate (5.6) implies  $\|\mathbf{u} - \mathbf{u}_h\|_{\varepsilon, h} \lesssim h^2$  by choosing  $r = 1$ , which is robust with respect to  $\varepsilon$  and optimal in mesh size  $h$ .

## 6. NUMERICAL RESULTS

In this section, we perform numerical experiments to demonstrate the theoretical results of the mixed finite element methods (4.1)-(4.2) and (5.1)-(5.2). Let  $\Omega = (0, 1)^3$ . Choose the exact solution of double curl equation (3.4)

$$\mathbf{u}_0 = \operatorname{curl} \begin{pmatrix} 0 \\ 0 \\ \sin^2(\pi x) \sin^2(\pi y) \sin^2(\pi z) \end{pmatrix},$$

and let  $\mathbf{f} = \operatorname{curl}^2 \mathbf{u}_0$ . The analytic expression of the exact solution  $\mathbf{u}$  of the quad-curl singular perturbation problem (1.1) can not be explicitly given. We take uniform triangulations on  $\Omega$ . Set  $k = 1$ .

In the first experiment, we apply the lowest order Huang element in [16] to solve the double curl problem (3.4), i.e. mixed finite element method (5.1)-(5.2) for  $\varepsilon = 0$  with the finite element replaced by the Huang element. Numerical errors  $\|\mathbf{u}_0 - \mathbf{u}_h\|_0$  and  $\|\operatorname{curl}_h(\mathbf{u}_0 - \mathbf{u}_h)\|_0$  with respect to  $h$  are shown in Table 1. We can see that both  $\|\mathbf{u}_0 - \mathbf{u}_h\|_0$  and  $\|\operatorname{curl}_h(\mathbf{u}_0 - \mathbf{u}_h)\|_0$  have no convergence rates, similarly as the Morley element method for Poisson equation [21, Section 3]. Indeed, the convergence would deteriorate if using nonconforming finite elements to discretize the double curl problem, as illustrated in [4, Section 7.9].

Next we test the robustness of the mixed finite element method (4.1)-(4.2). Numerical errors  $\|\mathbf{u}_0 - \mathbf{u}_{h0}\|_0$ ,  $\|\operatorname{curl}(\mathbf{u}_0 - \mathbf{u}_{h0})\|_0$  and  $\|\mathbf{u}_0 - \mathbf{u}_{h0}\|_{\varepsilon, h}$  for  $\varepsilon = 0$  and  $\varepsilon = 10^{-3}$  are shown in Table 2 and Table 3 respectively. By Table 2 and Table 3, numerically  $\|\mathbf{u}_0 - \mathbf{u}_{h0}\|_0 \approx O(h)$ ,  $\|\operatorname{curl}(\mathbf{u}_0 - \mathbf{u}_{h0})\|_0 \approx O(h^{0.5})$  and  $\|\mathbf{u}_0 - \mathbf{u}_{h0}\|_{\varepsilon, h} \approx O(h^{0.5})$ , which coincide with the sharp estimate (4.26).

At last we numerically examine the modified mixed finite element method (5.1)-(5.2) by the Nitsche's technique. Numerical errors  $\|\mathbf{u}_0 - \mathbf{u}_h\|_0$ ,  $\|\operatorname{curl}(\mathbf{u}_0 - \mathbf{u}_h)\|_0$  and

$\|\mathbf{u}_0 - \mathbf{u}_h\|_{\varepsilon,h}$  for  $\varepsilon = 0$  and  $\varepsilon = 10^{-3}$  are shown in Table 4 and Table 5 respectively, from which we can observe that they all achieve the optimal convergence rate  $O(h^2)$  numerically and agree with the theoretical estimate (5.7).
