# RIGIDITY THEOREMS FOR BEST SOBOLEV INEQUALITIES 

FRANCESCO MAGGI, ROBIN NEUMAYER, AND IGNACIO TOMASETTI


#### Abstract

For $n \geq 2, p \in(1, n)$, the "best $p$-Sobolev inequality" on an open set $\Omega \subset \mathbb{R}^{n}$ is identified with a family $\Phi_{\Omega}$ of variational problems with critical volume and trace constraints. When $\Omega$ is bounded we prove: (i) for every $n$ and $p$, the existence of generalized minimizers that have at most one boundary concentration point, and: (ii) for $n>2 p$, the existence of (classical) minimizers. We then establish rigidity results for the comparison theorem "balls have the worst best Sobolev inequalities" by the first named author and Villani, thus giving the first affirmative answers to a question raised in [MV05].

## 1. Introduction

1.1. Overview. The goal of this paper is to answer some basic open questions concerning a "doubly critical" family $\left\{\Phi_{\Omega}(T)\right\}_{T \geq 0}$ of minimization problems on Sobolev functions, which, in a precise sense to be clarified below, can be interpreted as collectively defining the best Sobolev inequality on an open set $\Omega \subset \mathbb{R}^{n}$ with $C^{1}$-boundary. Given an integer $n \geq 2$ and $p \in(1, n)$, these problems are defined as

$$
\begin{equation*}
\Phi_{\Omega}(T)=\inf \left\{\left(\int_{\Omega}|\nabla u|^{p}\right)^{1 / p}: \int_{\Omega}|u|^{p^{\star}}=1, \int_{\partial \Omega}|u|^{p^{\#}}=T^{p^{\#}}\right\} \tag{1.1}
\end{equation*}
$$

and their minimizers, whenever they exist, satisfy the Euler-Lagrange equation

$$
\begin{cases}-\Delta_{p} u=\lambda u^{p^{\star}-1}, & \text { on } \Omega  \tag{1.2}\\ |\nabla u|^{p-2} \frac{\partial u}{\partial \nu_{\Omega}}=\sigma u^{p^{\#}-1}, & \text { on } \partial \Omega\end{cases}
$$

for suitable Lagrange multipliers $\lambda, \sigma \in \mathbb{R}$. We call $\int_{\Omega}|u|^{p^{\star}}=1$ and $\int_{\partial \Omega}|u|^{p^{\#}}=T^{p^{\#}}$ the "volume" and "trace" constraints of $\Phi_{\Omega}(T)$. The critical Sobolev exponents associated to $n$ and $p, p^{\star}$ and $p^{\#}$, are defined by

$$
p^{\star}=\frac{n p}{n-p}, \quad p^{\#}=\frac{(n-1) p}{n-p}=\frac{n-1}{n} p^{\star}
$$

and their precise values guarantee the scale invariance of $\Phi_{\Omega}$, i.e.

$$
\Phi_{x+r \Omega}(T)=\Phi_{\Omega}(T) \quad \forall x \in \mathbb{R}^{n}, r>0, T \geq 0
$$



Figure 1.1. The state of the art about $\Phi_{\Omega}$. The "exclusion zone" for the values of $\|\nabla u\|_{L^{p}(\Omega)}$ (under the constraint $\|u\|_{L^{p^{\star}}(\Omega)}=1$ ) is depicted in gray. It always contains the subgraph of $\Phi_{B}(T)$ on $T \in\left[0, \operatorname{ISO}(B)^{1 / p^{\#}}\right]$, see (1.12), but is always smaller than the one of a half-space $H$, see (1.19). The Sobolev inequality on $\mathbb{R}^{n}$ is equivalent to $\Phi_{\Omega}(0)=S(n, p)$, the Euclidean isoperimetric inequality to the fact that the only zero of $\Phi_{\Omega}$ (i.e. $T=\operatorname{ISO}(\Omega)^{1 / p^{\#}}$ ) is achieved to the right of the only zero of $\Phi_{B}$, and the Escobar inequality (1.6) is equivalent to the linear bound $\Phi_{H}(T) \geq E T$. Both $\left\{\left(T, \Phi_{B}(T)\right): T \in\left[0, \operatorname{ISO}(B)^{1 / p^{\#}}\right]\right\}$ and $\left\{\left(T, \Phi_{H}(T)\right): T \geq\right.$ $0\}$ can be implicitly parametrized by looking at the explicit families of minimizers given in (1.11), (1.15), (1.16) and (1.17).

When $\Omega$ is bounded, the $C^{1}$-regularity of $\partial \Omega$ guarantees that every $u \in L_{\text {loc }}^{1}(\Omega)$ with $\nabla u \in L^{p}\left(\Omega ; \mathbb{R}^{n}\right)$ lies in the competition class of $\Phi_{\Omega}(T)$ for some $T \geq 0$. In particular,

$$
\operatorname{Epi}\left(\Phi_{\Omega}\right)=\left\{(T, G) \in \mathbb{R}^{2}: T \geq 0, G \geq \Phi_{\Omega}(T)\right\}
$$

(the epigraph of $\Phi_{\Omega}$ ) collects the best possible information on the range of values achievable by $\|\nabla u\|_{L^{p}(\Omega)}$ when $\|u\|_{L^{p^{\star}}(\Omega)}$ is fixed: from this peculiar viewpoint, which is reminiscent of the one adopted in the study of Blaschke-Santaló diagrams, Epi $\left(\Phi_{\Omega}\right)$ is "the best Sobolev inequality on $\Omega$ ". The following list of results, summarized in Figure 1.1, aims to provide a hopefully complete state of the art on $\Phi_{\Omega}$, and illustrates the wealth of information stored in this family of variational problems. As a disclaimer: here we are definitely not attempting to exhaustively frame the study of $\Phi_{\Omega}$ into the incredibly vast and layered context of the theory of Sobolev-type inequalities (see e.g. [Maz85]), as that would be a long and delicate exercise, lying well beyond the scope of this introduction.
(1) Sobolev inequality on $\mathbb{R}^{n}$ : A scaling and localization argument shows that, for every open set $\Omega$, one has

$$
\begin{equation*}
\Phi_{\Omega}(0)=S(n, p):=\inf \left\{\left(\int_{\mathbb{R}^{n}}|\nabla u|^{p}\right)^{1 / p}: \int_{\mathbb{R}^{n}}|u|^{p^{\star}}=1\right\} \tag{1.3}
\end{equation*}
$$

that is, $\Phi_{\Omega}(0)$ is the best constant in the $L^{p}$-Sobolev inequality on $\mathbb{R}^{n}$. Minimizers of (1.3) are exactly given by the family $\left\{\tau_{x_{0}}\left[U_{S}^{(\alpha)}\right]\right\}_{x_{0} \in \mathbb{R}^{n}, \alpha>0}$ generated by

$$
\begin{equation*}
U_{S}(x)=\left(1+|x|^{p /(p-1)}\right)^{1-(n / p)}, \quad x \in \mathbb{R}^{n} \tag{1.4}
\end{equation*}
$$

see [Aub76, Tal76, CENV04], we see that $\Phi_{\Omega}(0)$ is attained if and only if $\Omega=\mathbb{R}^{n}$. Here and in the following, we set

$$
\begin{equation*}
\tau_{x_{0}}[v](x)=v\left(x-x_{0}\right), \quad v^{(\alpha)}(x)=\alpha^{-n / p^{\star}} v(x / \alpha) \tag{1.5}
\end{equation*}
$$

whenever $x_{0} \in \mathbb{R}^{n}$ and $\alpha>0$.
(2) Escobar inequality: The Escobar inequality ([Esc88, for $p=2]$, [Naz06, for $p \in$ $(1, n)]$ ) states that if $H$ is an (open) half-space in $\mathbb{R}^{n}$ with outer unit normal $\nu_{H}$, then

$$
\begin{equation*}
\left(\int_{H}|\nabla u|^{p}\right)^{1 / p} \geq E(n, p)\left(\int_{\partial H}|u|^{p^{\#}}\right)^{1 / p^{\#}} \tag{1.6}
\end{equation*}
$$

with equality if and only if ${ }^{1} u=\tau_{x_{0}}\left[U_{E}^{(\alpha)}\right]$ for some $x_{0} \in \mathbb{R}^{n} \backslash \bar{H}$, and where

$$
\begin{equation*}
U_{E}(x)=|x|^{-(n-p) /(p-1)}, \quad x \in \mathbb{R}^{n} \backslash\{0\} \tag{1.7}
\end{equation*}
$$

is a multiple of the fundamental solution of the $p$-Laplacian. The quantity

$$
\begin{equation*}
T_{E}=\left\|\tau_{x_{0}}\left[U_{E}^{(\alpha)}\right]\right\|_{L^{p^{\#}}(\partial H)} /\left\|\tau_{x_{0}}\left[U_{E}^{(\alpha)}\right]\right\|_{L^{p^{\star}}(H)} \tag{1.8}
\end{equation*}
$$

is independent of $x_{0} \in \mathbb{R}^{n} \backslash \bar{H}$, and is such that

$$
\begin{equation*}
\Phi_{H}\left(T_{E}\right)=E(n, p) \tag{1.9}
\end{equation*}
$$

The Escobar inequality (1.6) can be equivalently reformulated in the " $\Phi$-setting" as a linear lower bound for $\Phi_{H}$, i.e.

$$
\Phi_{H}(T) \geq E(n, p) T, \quad \forall T \geq 0
$$

This bound is sharp only if $T=T_{E}$, and is nearly optimal only if $T$ is close to $T_{E}$; but it largely suboptimal away from $T_{E}$, see Figure 1.1.
(3) Euclidean isoperimetry: It is easily seen that $\Phi_{\Omega}(T)=0$ for some $T>0$ if and only if $|\Omega|<\infty$ and $T=\operatorname{ISO}(\Omega)^{1 / p^{\#}}$, where $\operatorname{ISO}(\Omega)=\mathcal{H}^{n-1}(\partial \Omega) /|\Omega|^{(n-1) / n}$ stands for the isoperimetric ratio of $\Omega$. Since the Euclidean isoperimetric inequality states that

$$
\begin{equation*}
\operatorname{ISO}(\Omega) \geq \operatorname{ISO}(B) \tag{1.10}
\end{equation*}
$$

(with equality if and only if $\Omega$ is a ball), in the $\Phi$-setting, (1.10) is equivalent to saying that $\Phi_{B}$ has the left-most zero among all $\Phi_{\Omega}$.
(4) Balls have the worst best Sobolev inequalities: In [CL90, CL94, $p=2$ ] (by symmetrization methods and conformal invariance) and in [MV05, $p \in(1, n)$ ] (via the mass transportation method pioneered in [Kno57, MS86, CENV04]) it is shown that if $B$ is a ball, then for every $T \in\left(0, \operatorname{ISO}(B)^{1 / p^{\#}}\right)$ there is a unique $\alpha>0$ such that

$$
\begin{equation*}
\Phi_{B}(T)=\left\|\nabla U_{S}^{(\alpha)}\right\|_{L^{p}(B)} /\left\|U_{S}^{(\alpha)}\right\|_{L^{p^{\star}}(B)} \tag{1.11}
\end{equation*}
$$

with $U_{S}$ defined in (1.4). Further elaborating on the proof of this partial characterization of $\Phi_{B}$, again in [MV05] the comparison theorem that balls have the worst best Sobolev inequalities

$$
\begin{equation*}
\Phi_{\Omega}(T) \geq \Phi_{B}(T), \quad \forall T \in\left[0, \operatorname{ISO}(B)^{1 / p^{\#}}\right] \tag{1.12}
\end{equation*}
$$

is proved. This sharp lower bound, combined with (1.11), allows one to infer some sharp and more traditional-looking Sobolev-type inequalities, like the following sharp interpolation between (1.3) and (1.10)

$$
\begin{equation*}
\frac{\|\nabla u\|_{L^{p}(\Omega)}}{S(n, p)}+\frac{\|u\|_{L^{p^{\#}}}(\partial \Omega)}{\operatorname{ISO}(B)^{1 / p^{\#}}} \geq\|u\|_{L^{p^{\star}}(\Omega)} \tag{1.13}
\end{equation*}
$$

and the following sharp Sobolev inequality, additive in the domain of the $p$-Dirichlet energy,

$$
\begin{equation*}
\frac{\|\nabla u\|_{L^{p}(\Omega)}^{p}}{S(n, p)^{p}}+\frac{\|u\|_{L^{p}(\partial \Omega)}^{p}}{C(n, p)} \geq\|u\|_{L^{p^{\star}}(\Omega)}^{p} \tag{1.14}
\end{equation*}
$$

which was first conjectured by Brezis and Lieb in [BL85].

[^0](5) Full characterization of $\Phi_{H}$ : In [CL90, CL94, for $\left.p=2\right]$ and, again by optimal mass transport arguments, in $[\mathrm{MN17}$, for $p \in(1, n)]$, it is proven that if $H$ is half-space in $\mathbb{R}^{n}$, then: for each $T \in\left(0, T_{E}\right)$ (Sobolev range) there is a unique $t_{T} \in \mathbb{R}$ such that

\begin{equation*}
\Phi_{H}(T)=\left\|\nabla\left(\tau_{t_{T} \nu_{H}} U_{S}\right)\right\|_{L^{p}(H)} /\left\|\tau_{t_{T} \nu_{H}} U_{S}\right\|_{L^{p^{*}}(H)} ; \tag{1.15}
\end{equation*}
$$

\]

if $T=T_{E}$ (Escobar point), then

$$
\begin{equation*}
\Phi_{H}\left(T_{E}\right)=E(n, p)=\left\|\nabla\left(\tau_{\nu_{H}} U_{E}\right)\right\|_{L^{p}(H)} /\left\|\tau_{\nu_{H}} U_{E}\right\|_{L^{p^{\star}}(H)} ; \tag{1.16}
\end{equation*}
$$

for each $T>T_{E}$ (beyond Escobar range), there is a unique $s_{T}>1$ s.t.

$$
\begin{align*}
& \Phi_{H}(T)=\left\|\nabla\left(\tau_{s_{T} \nu_{H}} U_{B E}\right)\right\|_{L^{p}(H)} /\left\|\tau_{s_{T} \nu_{H}} U_{B E}\right\|_{L^{p^{\star}}(H)},  \tag{1.17}\\
& \text { where } U_{B E}(x)=\left(|x|^{p /(p-1)}-1\right)^{1-(n / p)}, \quad|x|>1 . \tag{1.18}
\end{align*}
$$

Up to the natural dilation and translation invariances, these functions are the unique minimizers of $\Phi_{H}(T)$. Moreover, again by [MN17]: (a): $\inf _{T \geq 0} \Phi_{H}(T)$ is achieved at $T=T_{0} \in\left(0, T_{E}\right)$, where $t_{T_{0}}=0$ and $\Phi_{H}\left(T_{0}\right)=S(n, p) / 2^{1 / n} ;(\mathbf{b})$ : by the divergence theorem, $\Phi_{H}(T)>T^{p^{\#}} / p^{\#}$ for every $T>0$, and this lower bound is sharp as $T \rightarrow \infty$; (c): finally, $\Phi_{H}$ has the best best Sobolev inequality, i.e.

$$
\begin{equation*}
\Phi_{\Omega}(T) \leq \Phi_{H}(T), \quad \forall T \geq 0 . \tag{1.1}
\end{equation*}
$$

1.2. Statements of the main results. With this summary on the state of the art for $\Phi_{\Omega}$ in mind, there are two fundamental open questions that form the subject of our paper:

Question 1: When does $\Phi_{\Omega}(T)(T>0)$ admit minimizers?
Question 2: Does rigidity hold in the comparison theorem (1.12)?
The main idea of this paper is attacking these two closely related questions by systematically exploiting the complete characterization of $\Phi_{H}$ obtained in [MN17].

Concerning Question 1, a classical concentration-compactness argument characterizes the limit behavior of minimizing sequences of $\Phi_{\Omega}(T)$ as the superposition of a standard weak limit plus at most countably many concentration points, located either in the interior of $\Omega$, or on its boundary. By exploiting properties of $\Phi_{H}$ we are able to (i): exclude all interior concentrations and all but at most one boundary concentration, thus proving existence of minimizers for a suitable "relaxed problem" $\Phi_{\Omega}^{*}(T)$; and (ii): completely exclude concentrations, and thus establish the existence of minimizers of $\Phi_{\Omega}(T)$, as soon as $\partial \Omega$ is of class $C^{2}$ and $n>2 p$. To give precise statements, it is convenient to let $\mathcal{X}_{\Omega}(T)$ denote the competition class of $\Phi_{\Omega}(T)$, and let $\mathcal{Y}_{\Omega}(T)$ denote the set of triples $(u, \mathrm{v}, \mathrm{t})$ with either $u \in \mathcal{X}_{\Omega}(T)$ and $v=\mathrm{t}=0$, or $u \in W^{1, p}(\Omega), v \in(0,1], \mathrm{t} \in(0, T]$, and

$$
\begin{equation*}
\mathrm{v}^{p^{\star}}+\int_{\Omega} u^{p^{p^{\star}}}=1, \quad \mathrm{t}^{p^{\#}}+\int_{\partial \Omega} u^{p^{\#}}=T^{p^{\#}} . \tag{1.20}
\end{equation*}
$$

The relaxed problem associated to $\Phi_{\Omega}(T)$ is then given by

$$
\begin{equation*}
\Phi_{\Omega}^{*}(T)=\inf _{\mathcal{Y}_{\Omega}(T)} \mathcal{E}, \text { where } \mathcal{E}(u, \mathrm{v}, \mathrm{t})^{p}=\int_{\Omega}|\nabla u|^{p}+\mathrm{v}^{p} \Phi_{H}\left(\frac{\mathrm{t}}{\mathrm{v}}\right)^{p} \tag{1.21}
\end{equation*}
$$

with the convention that $\mathrm{v}^{p} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p}=0$ if $(\mathrm{v}, \mathrm{t})=(0,0)$.
Theorem 1.1 (Existence of minimizers of $\Phi_{\Omega}$ ). If $n \geq 2, p \in(1, n)$, and $\Omega$ is a bounded open set with $C^{1}$-boundary in $\mathbb{R}^{n}$, then:
(i): for every $T>0$, there is a minimizer $(u, \mathrm{v}, \mathrm{t})$ of $\Phi_{\Omega}^{*}(T)$, and

$$
\begin{equation*}
\Phi_{\Omega}(T)=\Phi_{\Omega}^{*}(T) ; \tag{1.22}
\end{equation*}
$$

moreover, if $\int_{\Omega} u^{p^{\star}}>0$, then $u /\|u\|_{L^{p^{\star}}(\Omega)}$ is a minimizer of $\Phi_{\Omega}\left(\|u\|_{L^{p^{\#}}(\partial \Omega)} /\|u\|_{L^{p^{\star}}(\Omega)}\right)$;
(ii): if $\Omega$ has boundary of class $C^{2}, n>2 p, T>0$, and $(u, \mathrm{v}, \mathrm{t})$ is a minimizer of $\Phi_{\Omega}^{*}(T)$, then $\mathrm{v}=\mathrm{t}=0$, and thus $u$ is a minimizer of $\Phi_{\Omega}(T)$.

Remark 1.2. Minimizers of $\Phi_{\Omega}(T)$ solve the Euler-Lagrange equation (1.2). For the Euler-Lagrange equation satisfied by minimizers $(u, \mathrm{v}, \mathrm{t})$ of the relaxed problem $\Phi_{\Omega}^{*}(T)$, see Theorem 4.1 below.

Question 2 is motivated by the various rigidity statements associated to comparison theorems in Riemannian geometry (see, e.g. [CE08]). In that setting, a certain model space provides a universal bound on a certain global geometric quantity (comparison theorem), which is then shown to be saturated by the model space alone (rigidity statement). With this analogy in mind, we can reformulate more precisely Question 2 as follows:
Question 2, weak form: Does $\Phi_{\Omega}=\Phi_{B}$ on $\left(0, \operatorname{ISO}(B)^{1 / p^{\#}}\right)$ imply that $\Omega$ is a ball?
Question 2, strong form: Does $\Phi_{\Omega}(T)=\Phi_{B}(T)$ at just one value of $T \in\left(0, \operatorname{ISO}(B)^{1 / p^{\#}}\right)$ imply that $\Omega$ is a ball?
Concerning the weak form of Question 2, through a careful use of the properties of $\Phi_{H}$ we answer affirmatively whenever $\Omega$ is bounded and connected. These conditions are optimal, as shown by unbounded or disconnected non-rigidity examples presented in [MV05]. In fact, the argument we propose gives rigidity under the mere assumption that $\Phi_{\Omega}=\Phi_{B}$ holds on an open neighborhood of $T=0$. Concerning the strong form of Question 2, which was originally formulated in [MV05, Section 1.9], we can answer in the affirmative as a direct by-product of our existence result for minimizers of $\Phi_{\Omega}(T)$ (thus, when $\Omega$ has $C^{2}$-boundary and $n>2 p$ ) thanks to the following "conditional rigidity" statement, which is proved in [MV05] as a direct by-product of the proof of (1.12):

$$
\begin{aligned}
& \text { if } \Omega \text { is connected (possibly unbounded), } \\
& \text { if } \Phi_{\Omega}(T)=\Phi_{B}(T) \text { for a value of } T \in\left(0, \operatorname{ISO}(B)^{1 / p^{\#}}\right) \text {, } \\
& \text { and if } \left.\Phi_{\Omega}(T) \text { is known to admit minimizers (possibly just for that } T\right) \text {, } \\
& \text { then } \Omega \text { is a ball. }
\end{aligned}
$$

(We notice for future use an important consequence of (1.23), namely, we have

$$
\begin{equation*}
\Phi_{B}(T)<\Phi_{H}(T), \quad \forall T \in\left(0, \operatorname{ISO}(B)^{1 / p^{\#}}\right) \tag{1.24}
\end{equation*}
$$

indeed, by [MN17], $\Phi_{H}(T)$ admits minimizers for every $T>0$.) With these premises, we now state our main results concerning Question 2.

Theorem 1.3 (Rigidity of "Balls have the worst best Sobolev inequalities"). Let $n \geq 2$, $p \in(1, n), \Omega$ an open, bounded, connected set with $C^{1}$-boundary in $\mathbb{R}^{n}$, and assume that one of the following two conditions holds:
(i): there is $T_{*}>0$ such that $\Phi_{\Omega}(T)=\Phi_{B}(T)$ for every $T \in\left(0, T_{*}\right)$; or
(ii): $n>2 p$, the boundary of $\Omega$ is of class $C^{2}$, and there is $T \in\left(0, \operatorname{ISO}(B)^{1 / p^{\#}}\right)$ such that $\Phi_{\Omega}(T)=\Phi_{B}(T)$.
Then, $\Omega$ is a ball.
1.3. Strategy of proof. Concentration-compactness arguments and the use of sharp Sobolev-type inequalities (like the Sobolev and Escobar inequalities (1.3) and (1.6)) are the standard tools of the trade in the analysis of variational problems with critical growth. As seen, if interpreted as assertions about $\Phi_{H}$, (1.3) and (1.6) contain only very partial information (respectively, " $\Phi_{H}(0)=S(n, p)$ " and " $\Phi_{H}(T) \geq E(n, p) T$ for every $T>0$ "). From this viewpoint, our arguments provide an interesting example of the potentialities of using, in the familiar context of concentration-compactness, the full characterization of
$\Phi_{H}$ obtained in [CL94, MN17]. We now explain how this characterization is used in this paper.

We have already mentioned how the mere knowledge of the existence of minimizers in $\Phi_{H}(T)$ for every $T>0$ allows one to reduce the analysis of concentrations to the simplest possible case of a single boundary concentration (thus leading to Theorem 1.1-(i)). Finer properties of $\Phi_{H}$ are exploited in the proof of Theorem 1.1-(ii), which goes as follows. We consider the existence of a minimizer $(u, \mathrm{v}, \mathrm{t})$ of $\Phi_{\Omega}^{*}(T)$ with $v>0$, and, keeping in mind that $\Phi_{\Omega}(T)=\Phi_{\Omega}^{*}(T)$, we aim to obtain a contradiction to $v>0$ by constructing a competitor $v$ of $\Phi_{\Omega}(T)$ with

$$
\int_{\Omega}|\nabla v|^{p}<\int_{\Omega}|\nabla u|^{p}+\mathrm{v}^{p} \Phi_{H}\left(\frac{\mathrm{t}}{\mathrm{v}}\right)^{p}
$$

We seek $v$ in the form $v=u_{\varepsilon}$, for the Ansatz given by

u_{\varepsilon}(x)=\left(1-\varphi_{\varepsilon}(x)\right) u(x)+\varphi_{\varepsilon}(x)\left(U^{(\varepsilon)} \circ g\right)(x), \quad x \in \Omega \tag{1.25}
\end{equation*}
$$

Here $x_{0} \in \partial \Omega$ is a boundary point of $\Omega$ with positive mean curvature ${ }^{2}$, i.e. $\mathrm{H}_{\partial \Omega}\left(x_{0}\right)>0 ; \varphi_{\varepsilon}$ is a cut-off function between $B_{\varepsilon^{\beta}}\left(x_{0}\right)$ and $B_{2 \varepsilon^{\beta}}\left(x_{0}\right)$ for $\beta=\beta(n, p) \in(0,1)$ to be suitably chosen (the condition $n>2 p$ enters in this choice); $g$ is a boundary flattening diffeomorphism near $x_{0}$; and, finally, $U=U_{\tau}+b \varepsilon V_{\tau}$ for $\tau=\mathrm{t} / \mathrm{v}, V_{\tau}$ a standard perturbation of $U_{\tau}$, and $b$ a constant suitably chosen depending on $n, p, H_{\partial \Omega}\left(x_{0}\right)$ and $\tau$. The energy, volume and trace expansions for $u_{\varepsilon}$ as $\varepsilon \rightarrow 0^{+}$are computed to be

& - \\
& \quad-\left\{\mathcal{L}\left(U_{\tau}\right)-\frac{(n-p)}{n} \lambda_{H}(\tau) \mathcal{M}\left(U_{\tau}\right)\right\} \mathrm{H}_{\partial \Omega}\left(x_{0}\right) \mathrm{v}^{p} \varepsilon+\mathrm{o}(\varepsilon),  \tag{1.27}\\
& \int_{\Omega} u_{\varepsilon}^{p^{\star}}=1+\mathrm{o}(\varepsilon), \quad \int_{\partial \Omega} u_{\varepsilon}^{p^{\#}}=T^{p^{\#}}+\mathrm{o}(\varepsilon)
\end{align*}
$$

where $\lambda_{H}(T)$ is the volume Lagrange multiplier of $U_{T}$ (see (3.7) below), and where $\mathcal{L}$ and $\mathcal{M}$ are functionals defined on $U: H \rightarrow \mathbb{R}$ by

& \mathcal{L}(U)=\int_{H} x_{n}|\nabla U|^{p}-p x_{n}\left(\partial_{1} U\right)^{2}|\nabla U|^{p-2}  \tag{1.28}\\

Modulo $o(\varepsilon)$-perturbations of $u_{\varepsilon}$ aimed at correcting the volume and trace constraints to the exact values needed for inclusion in $\mathcal{X}_{\Omega}(T)$, we have constructed the required competitors, and proved Theorem 1.1-(ii), if we can show the existence of $c(n, p, T)>0$ such that

$$
\begin{equation*}
\mathcal{L}\left(U_{T}\right)-\frac{(n-p)}{n} \lambda_{H}(T) \mathcal{M}\left(U_{T}\right) \geq c(n, p, T), \quad \forall T>0 \tag{1.30}
\end{equation*}

Of course, the full characterization of $\Phi_{H}$ plays a crucial role in our proof of (1.30), see Lemma 3.1 below.

While Theorem 1.3-(ii) is immediate from Theorem 1.1-(ii) thanks to the rigidity criterion (1.23), the proof of Theorem 1.3-(i) requires an additional argument, which once more exploits several fine properties of $\Phi_{B}$ and $\Phi_{H}$ : these include (1.23), (1.24), and information on the signs of the Lagrange multipliers $\lambda_{H}(T)$ and $\sigma_{H}(T)$ for minimizers $U_{T}$ of $\Phi_{H}(T)$ (see (3.12) and (3.11) below).

[^1]1.4. Organization of the paper. After collecting a few preliminary results in section 2, in section 3 we study in detail various properties of $\Phi_{H}$ and of its minimizers: in particular, we prove the key inequality (1.30) (see Lemma 3.1), and discuss in detail the Ansatz (1.25) (see Lemma 3.4). Sections 4 and 5 contain, respectively, the proofs of Theorem 1.1 and Theorem 1.3. Finally, we collect some auxiliary, routine proofs in an appendix.

## 2. Notation and preparations

Some basic notation is presented in section 2.1. We then discuss, in separate subsections, four useful technical lemmas: a concentration-compactness lemma with boundary terms (Lemma 2.1); a second order expansion for the boundary flattening diffeomorphisms used in the Ansatz (1.25) (Lemma 2.3); some basic regularity information on minimizers of $\Phi_{\Omega}(T)$ (Lemma 2.5); and the basic technique of "volume/trace correcting variations" (Lemma 2.6). Some proofs are postponed to the appendix.
2.1. Notation. Throughout the paper we always assume that $n \geq 2$ and $p \in(1, n)$. We denote by $\mathcal{L}^{n}$ and $\mathcal{H}^{k}$ the Lebesgue measure and the $k$-dimensional Hausdorff measure of $\mathbb{R}^{n}$, although we simply set $|E|$ in place of $\mathcal{L}^{n}(E)$. We denote by $B_{r}(x)$ the open ball of center $x \in \mathbb{R}^{n}$ and radius $r>0$, and set $B_{r}=B_{r}(0)$, while $B$ denotes a ball of unspecified center and radius.

Following a standard shorthand notation, by " $f(x)=g(x)+\mathrm{O}_{a, b}(|x|)$ for $|x|>R$ " we mean that $|f(x)-g(x)| \leq C(a, b)|x|$ if $|x|>R$; by " $f(x)=g(x)+\mathrm{o}_{a, b}(|x|)$ as $|x| \rightarrow 0$ " we mean that $\lim _{|x| \rightarrow 0}|f(x)-g(x)| /|x|=0$ at a rate that is uniform with respect to the parameters $a$ and $b$.

In general, we will use capital letters (e.g. $U, V, \Psi$ ) to denote functions defined on the half space $H$ and lowercase letters (e.g. $u, v, \varphi$ ) to denote functions defined on an open bounded domain $\Omega$.
2.2. Concentration-compactness. The following lemma is a version of Lions' celebrated concentration-compactness lemma and provides a natural starting point to study minimizing sequences of $\Phi_{\Omega}(T)$.

Lemma 2.1 (Concentration-compactness). Let $n \geq 2, p \in(1, n)$, and let $\Omega \subset \mathbb{R}^{n}$ be open and bounded with $C^{1}$-boundary. If $\left\{u_{j}\right\}_{j}$ is a sequence in $L_{\text {loc }}^{1}(\Omega),\left\{\nabla u_{j}\right\}_{j}$ is bounded in $L^{p}\left(\Omega ; \mathbb{R}^{n}\right)$ and $u_{j} \rightharpoonup u$ as distributions in $\Omega$, then the Radon measures on $\mathbb{R}^{n}$ defined by

\begin{equation*}
\mu_{j}=\left|\nabla u_{j}\right|^{p} \mathcal{L}^{n}\left\llcorner\Omega, \quad \nu_{j}=\left.\left|u_{j}\right|\right|^{p^{\star}} \mathcal{L}^{n}\left\llcorner\Omega, \quad \tau_{j}=\left|u_{j}\right|^{p^{\#}} \mathcal{H}^{n-1}\llcorner\partial \Omega,\right.\right. \tag{2.1}
\end{equation*}
$$

have subsequential weak-star limits $\mu, \nu$ and $\tau$ which satisfy

$$
\begin{align*}
\nu & =|u|^{p^{\star}} \mathcal{L}^{n}\left\llcorner\Omega+\sum_{i \in I} v_{i}^{p^{\star}} \delta_{x_{i}},\right.  \tag{2.2}\\
\tau & =|u|^{p^{\#}} \mathcal{H}^{n-1}\left\llcorner\partial \Omega+\sum_{i \in I} \mathrm{t}_{i}^{p^{\#}} \delta_{x_{i}},\right.  \tag{2.3}\\
\mu & \geq|\nabla u|^{p} \mathcal{L}^{n}\left\llcorner\Omega+\sum_{i \in I} \mathrm{~g}_{i}^{p} \delta_{x_{i}},\right. \tag{2.4}
\end{align*}
$$

where $\left\{x_{i}\right\}_{i \in I} \subset \bar{\Omega}$ is at most countable set, $\mathrm{v}_{i}>0$ and $\mathrm{t}_{i} \geq 0$ for every $i \in I, \mathrm{t}_{i}>0$ only if $x_{i} \in \partial \Omega$, and

$$
\begin{equation*}
\mathrm{g}_{i} \geq \mathrm{v}_{i} \Phi_{H}\left(\frac{\mathrm{t}_{i}}{\mathrm{v}_{i}}\right), \quad \forall i \in I \tag{2.5}
\end{equation*}

In particular, $\mathrm{g}_{i} \geq S \mathrm{v}_{i}$ whenever $x_{i} \in \Omega$.

Proof. See appendix A.
2.3. Near-boundary coordinates. In this section, we introduce two types of coordinates for a neighborhood of a boundary point of a domain $\Omega$ : one that requires minimal regularity of the boundary of $\Omega$ and will suffice in the proofs of Theorem 1.1(i) and Theorem $1.3(\mathbf{i})$, and a second that requires $C^{2}$ regularity of the boundary of $\Omega$ and will be used in the proof of Theorem 1.1(ii) and Theorem 1.3(ii).

Given an open set $\Omega$ with $C^{1}$-boundary, we denote by $\nu_{\Omega}$ its outer unit normal and by $T_{x}(\partial \Omega)$ the tangent space to $x \in \partial \Omega$. When $\Omega$ has $C^{2}$-boundary, we denote by $\mathrm{A}_{\Omega}$ and $H_{\Omega}$ the second fundamental form and the scalar mean curvature of $\partial \Omega$ defined by $\nu_{\Omega}$. To define coordinates near boundary points of $\Omega$, for $x \in \mathbb{R}^{n}$ we set $\mathbf{p}(x)=x-x_{n} e_{n}$, $\mathbf{D}_{r}=\left\{x: x_{n}=0,|\mathbf{p} x|<r\right\}$, and $\mathbf{C}_{r}=\left\{x:\left|x_{n}\right|<r,|\mathbf{p}(x)|<r\right\}$. In particular, if $\Omega$ is an open set with $C^{1}$-boundary such that

$$
\begin{equation*}
0 \in \partial \Omega, \quad T_{0}(\partial \Omega)=\left\{x_{n}=0\right\}, \quad \nu_{\Omega}(0)=-e_{n} \tag{2.6}
\end{equation*}
$$

then we can find $r_{0}>0$ and $\ell: \mathbf{D}_{r_{0}} \rightarrow\left(-r_{0}, r_{0}\right)$ such that $\ell(0)=0, \nabla \ell(0)=0$, and

$$
\begin{aligned}
\Omega \cap \mathbf{C}_{r_{0}} & =\left\{x+t e_{n}: x \in \mathbf{D}_{r_{0}}, r_{0}>t>\ell(x)\right\}, \\
(\partial \Omega) \cap \mathbf{C}_{r_{0}} & =\left\{x+\ell(x) e_{n}: x \in \mathbf{D}_{r_{0}}\right\} .
\end{aligned}
$$

We then define the maps $F: \mathbf{D}_{r_{0}} \rightarrow \partial \Omega, f: \mathbf{C}_{r_{0}} \rightarrow \mathbb{R}^{n}$ and $\hat{f}: \mathbf{C}_{r_{0}} \rightarrow \mathbb{R}^{n}$ by setting

$$
\begin{align*}
F(x) & =x+\ell(x) e_{n}, & & x \in \mathbf{D}_{r_{0}}  \tag{2.7}\\
\hat{f}(x) & =F(\mathbf{p} x)+x_{n} e_{n}, & & x \in \mathbf{C}_{r_{0}}  \tag{2.8}\\
f(x) & =F(\mathbf{p} x)-x_{n} \nu_{\Omega}(F(\mathbf{p} x)), & & x \in \mathbf{C}_{r_{0}} \tag{2.9}
\end{align*}
$$

In this way, for every $y \in(\partial \Omega) \cap \mathbf{C}_{r_{0}}$, if we set $y=F(\mathbf{p} x)$, then

\nu_{\Omega}(y)=\frac{\nabla \ell(x)-e_{n}}{\sqrt{1+|\nabla \ell(x)|^{2}}}, \quad \mathrm{H}_{\Omega}(y)=\operatorname{div}\left(\frac{\nabla \ell}{\sqrt{1+|\nabla \ell|^{2}}}\right)(x) .

Notice that the map $f$ need not be of class $C^{1}$ if the boundary of $\Omega$ is only of class $C^{1}$, while the map $\hat{f}$ will be as regular as the boundary of $\Omega$. The following lemma summarizes basic properties about the map $\hat{f}$.

Lemma 2.2 (Near-boundary coordinates, one). If $H=\left\{x_{n}>0\right\}, \Omega$ is an open set with $C^{1}$-boundary and (2.6) holds, then there exist $r_{0}$ and $C_{0}$ positive such that the map $\hat{f}$ in (2.8) defines a $C^{1}$-diffeomorphism from $\mathbf{C}_{r_{0}}$ to its image, taking $\mathbf{D}_{r_{0}}$ into $\partial \Omega$ and with

$$
\begin{equation*}
\hat{f}\left(\mathbf{C}_{r / C_{0}} \cap H\right) \subset \Omega \cap B_{r} \subset \hat{f}\left(\mathbf{C}_{C_{0} r} \cap H\right) \quad \forall r<r_{0} / C_{0} \tag{2.10}
\end{equation*}
$$

Moreover, letting $\hat{g}=\hat{f}^{-1}$ denote the inverse of $\hat{f}$, we have

$$
\begin{array}{ll}
\nabla \hat{f}=\operatorname{Id}_{\mathbb{R}^{n}}+\mathrm{o}(1), & (\nabla \hat{g})^{*} \circ \hat{f}=\operatorname{Id}_{\mathbb{R}^{n}}+\mathrm{o}(1), \\
J \hat{f}=1+\mathrm{o}(1), & 1 \leq J^{\partial H} \hat{f} \leq 1+\mathrm{o}(1), \quad \text { for } x \in \mathbf{C}_{r_{0}} \tag{2.12}
\end{array}
$$

The orders in (2.11) and (2.12) depend on $\partial \Omega$ and on $0 \in \partial \Omega$.
Proof. See appendix B.
The map $f$ defined in (2.9) has the advantage that, when the boundary of $\Omega$ is at least of class $C^{2}$, curvature quantities appear in expansions of the metric coefficients and the volume form in these coordinates. These properties are the content of the following lemma.

Lemma 2.3 (Near-boundary coordinates, two). If $H=\left\{x_{n}>0\right\}, \Omega$ is an open set with $C^{2}$-boundary and (2.6) holds, then there exist $r_{0}$ and $C_{0}$ positive such that the map $f$ in (2.9) defines a $C^{1}$-diffeomorphism from $\mathbf{C}_{r_{0}}$ to its image, taking $\mathbf{D}_{r_{0}}$ into $\partial \Omega$ and with

$$
\begin{equation*}
f\left(\mathbf{C}_{r / C_{0}} \cap H\right) \subset \Omega \cap B_{r} \subset f\left(\mathbf{C}_{C_{0} r} \cap H\right) \quad \forall r<r_{0} / C_{0} \tag{2.13}
\end{equation*}
$$

Moreover, for $x \in \mathbf{C}_{r_{0}}$ and $x \in \mathbf{D}_{r_{0}}$ respectively, we have

\begin{equation*}
J f(x)=1-x_{n} \mathrm{H}_{\Omega}(0)+\mathrm{O}\left(|x|^{2}\right), \quad 1 \leq J^{\partial H} f(x) \leq 1+\mathrm{O}\left(|x|^{2}\right), \tag{2.14}
\end{equation*}
$$

and if $\left\{e_{i}\right\}_{i=1}^{n-1}$ is an orthonormal basis of $\mathbb{R}^{n-1} \subset \mathbb{R}^{n}$ of eigenvectors of $\nabla^{2} \ell(0)$ and $\left\{\kappa_{i}\right\}_{i=1}^{n-1}$ denote the corresponding eigenvalues (so that, by (2.6), they are the principal curvatures of $\partial \Omega$ with respect to $\nu_{\Omega}$ computed at $0 \in \partial \Omega$, and in particular $\left.\mathrm{H}_{\Omega}(0)=\sum_{i=1}^{n-1} \kappa_{i}\right)$, then, letting $g=f^{-1}$ denote the inverse of $f$, we have

\begin{equation*}
(\nabla g)^{*} \circ f=\operatorname{Id}_{\mathbb{R}^{n}}+\left(\nabla \ell \otimes e_{n}-e_{n} \otimes \nabla \ell\right)+x_{n} \sum_{i=1}^{n-1} \kappa_{i} e_{i} \otimes e_{i}+\mathrm{O}\left(|x|^{2}\right) . \tag{2.15}
\end{equation*}
$$

The orders in (2.14) and (2.15) depend on $\partial \Omega$ and on $0 \in \partial \Omega$.
Proof. See appendix B.
Remark 2.4. Given $x_{0} \in \partial \Omega$, we denote by $\pi_{x_{0}}$ the rigid motion of $\mathbb{R}^{n}$ that maps $x_{0}$ to 0 such that (2.6) holds with $\pi_{x_{0}}(\Omega)$ in place of $\Omega$. Then we set, for $\hat{f}$ and $f$ defined as in (2.8) and (2.9) respectively but with $\pi_{x_{0}}(\Omega)$ in place of $\Omega$,

$$
\hat{f}_{x_{0}}=\pi_{x_{0}}^{-1} \circ \hat{f}, \quad f_{x_{0}}=\pi_{x_{0}}^{-1} \circ f
$$

Clearly these maps are diffeomorphisms on $\mathbf{C}_{r_{0}}$, mapping $H \cap \mathbf{C}_{r_{0}}$ into a neighborhood of $x_{0}$ in $\Omega$ and $\mathbf{D}_{r_{0}}=(\partial H) \cap \mathbf{C}_{r_{0}}$ into a neighborhood of $x_{0}$ in $\partial \Omega$, and satisfies proper reformulations of the estimates in Lemmas 2.2 and 2.3. Here $r_{0}$ and $C_{0}$ depend also on the choice of $x_{0}$, and can of course be assumed uniform across $x_{0} \in \partial \Omega$ if $\partial \Omega$ is bounded.
2.4. Properties of minimizers. The following lemma gathers some fundamental properties of minimizers of $\Phi_{\Omega}$ that will be needed in the sequel.
Lemma 2.5. If $n \geq 2, p \in(1, n), T>0, \Omega$ is a bounded open set with $C^{2}$-boundary, and $u$ is a minimizer of $\Phi_{\Omega}(T)$, then $u$ is bounded and Lipschitz continuous in $\Omega$, there are $\lambda$ and $\sigma$ such that the Euler-Lagrange equation (1.2) holds in the weak sense, and the balance condition

$$
\begin{equation*}
\lambda \int_{\Omega} u^{p^{\star}-1}+\sigma \int_{\partial \Omega} u^{p^{\#-1}}=0 \tag{2.16}
\end{equation*}
$$

holds.
Proof. By a standard argument, based on similar considerations to the one presented in Lemma 2.6 below, one sees that a minimizer $u$ of $\Phi_{\Omega}(T)$ is a $W^{1, p}(\Omega)$-distributional solution of the Euler-Lagrange equation (1.2) for some $\lambda, \sigma \in \mathbb{R}$. As soon as $\Omega$ is bounded and has Lipschitz boundary, one can exploit (1.2) in conjunction with a Moser iteration argument to prove that $u \in L^{\infty}(\Omega)$ (see, e.g. [MW19, Theorem 3.1]; their result applies to (1.2) by taking, in the notation of their paper, $\mathcal{A}(x, u, \nabla u)=|\nabla u|^{p-2} \nabla u, \mathcal{B}(x, u, \nabla u)=\lambda u^{p^{\star}-1}$, and $\left.\mathcal{C}(x, u)=\sigma u^{p^{\#}-1}\right)$. On further assuming that $\partial \Omega$ is of class $C^{2}$, then the classical result [Lie92, Theorem 1.7] can be applied to deduce that $u \in C^{1, \beta}(\bar{\Omega})$ for a suitable $\beta=\beta(n, p) \in(0,1)$ (for more details, see [MW19, Theorem 3.9]). In particular, $u$ is bounded and Lipschitz continuous on $\Omega$, as claimed.
2.5. Volume/trace correcting variations. At various stages in our arguments we will need to slightly modify certain competitors so to restore the volume and trace constraints defining $\mathcal{X}_{\Omega}(T)$. The following lemma describes the basic mechanism used to this end.
Lemma 2.6 (Volume/trace correcting variations). If $n \geq 2, p \in(1, n), M>0, \Omega$ is an open set with $C^{1}$-boundary, $v \in L_{\mathrm{loc}}^{1}(\Omega)$ with $\nabla v \in L^{p}\left(\Omega ; \mathbb{R}^{n}\right)$, and if $x_{0} \in \mathbb{R}^{n}$ and $r>0$ are such that

$$
\begin{equation*}
\left.\int_{\Omega \backslash B_{r}\left(x_{0}\right)} v^{p^{\star}} \text { and } \int_{(\partial \Omega) \backslash B_{r}\left(x_{0}\right)}\right)^{p^{\#}} \text { are positive and finite, } \tag{2.17}
\end{equation*}
$$

then there exist positive constants $\eta$ and $C$, and functions $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash \bar{B}_{r}\left(x_{0}\right)\right)$ and $\psi \in C_{c}^{\infty}\left(\Omega \backslash \bar{B}_{r}\left(x_{0}\right)\right)$, all depending on $n, p, v$ and $M$ only, and with the following property. If $\left\{v_{\varepsilon}\right\}_{\varepsilon<\varepsilon_{0}} \subset L_{\text {loc }}^{1}(\Omega)$ is such that, for every $\varepsilon<\varepsilon_{0}$,

v_{\varepsilon}=v \text { on } \Omega \backslash B_{r}\left(x_{0}\right), \quad \int_{\Omega}\left|\nabla v_{\varepsilon}\right|^{p} \leq M \tag{2.18}
\end{equation*}
$$

then for every $(a, b)$ with $|a|,|b|<\eta / C$, we can find $(s, t)$ with $|s|,|t|<\eta$ such that

w_{\varepsilon}=v_{\varepsilon}+s \varphi+t \psi
$$

satisfies

\begin{gather*}
\int_{\partial \Omega}\left|w_{\varepsilon}\right|^{p^{\#}}=a+\int_{\partial \Omega}\left|v_{\varepsilon}\right|^{p^{\#}}, \quad \int_{\Omega}\left|w_{\varepsilon}\right|^{p^{\star}}=b+\left.\int_{\Omega}\left|v_{\varepsilon}\right|\right|^{p^{\star}},  \tag{2.19}\\
\left.\left|\int_{\Omega}\right| \nabla w_{\varepsilon}\right|^{p}-\int_{\Omega}\left|\nabla v_{\varepsilon}\right|^{p} \mid \leq C(|a|+|b|) . \tag{2.20}
\end{gather*}
$$

Proof. By (2.17) there are $\xi \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash \bar{B}_{r}\left(x_{0}\right)\right)$ and $\psi \in C_{c}^{\infty}\left(\Omega \backslash \bar{B}_{r}\left(x_{0}\right)\right)$ such that

\begin{equation*}
\int_{\partial \Omega} v^{p^{\#}-1} \xi=1, \quad \int_{\Omega} v^{p^{\star}-1} \psi=1 \tag{2.21}
\end{equation*}
$$

Setting $\varphi=\xi-\left(\int_{\Omega} v^{p^{\star}-1} \xi\right) \psi$, we have $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{n} \backslash \bar{B}_{r}\left(x_{0}\right)\right)$ with

$$
\begin{equation*}
\int_{\Omega} v^{p^{\star}-1} \varphi=0, \quad \int_{\partial \Omega} v^{p^{\#}-1} \varphi=1 \tag{2.22}
\end{equation*}
$$

We now define $h_{\varepsilon}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ by

$$
h_{\varepsilon}(s, t)=\left(\int_{\partial \Omega}\left|v_{\varepsilon}+s \varphi+t \psi\right|^{p^{\#}}-\int_{\partial \Omega}\left|v_{\varepsilon}\right|^{p^{\#}},\left.\int_{\Omega}\left|v_{\varepsilon}+s \varphi+t \psi\right|\right|^{p^{\star}}-\int_{\Omega}\left|v_{\varepsilon}\right| p^{p^{\star}}\right) .
$$

By (2.18) we have $h_{\varepsilon} \in C^{1, \alpha}\left(\mathbb{R}^{2} ; \mathbb{R}^{2}\right)$ for some $\alpha=\alpha(n, p) \in(0,1)$, with

\sup _{\varepsilon<\varepsilon_{0}}\left\|h_{\varepsilon}\right\|_{C^{1, \alpha}\left(\mathbb{R}^{2} ; \mathbb{R}^{2}\right)}<\infty ;
$$

moreover, $h_{\varepsilon}(0,0)=0$ and, by (2.21) and (2.22),

$$
\nabla h_{\varepsilon}(0,0)=\left(\begin{array}{cc}
p^{\#} \int_{\partial \Omega}\left|v_{\varepsilon}\right| p^{\#-1} \varphi & \left.p^{\#} \int_{\partial \Omega}\left|v_{\varepsilon}\right|\right|^{p^{\#-1}} \psi \\
\left.p^{\star} \int_{\Omega}\left|v_{\varepsilon}\right|\right|^{p^{\star}-1} \varphi & p^{\star} \int_{\Omega}\left|v_{\varepsilon}\right| p^{\star}-1
\end{array}\right)=\left(\begin{array}{cc}
p^{\#} & 0 \\
0 & p^{\star}
\end{array}\right) .
$$

We can thus apply the inverse function theorem uniformly in $\varepsilon$, to find positive constants $\eta$ and $C_{1}$ depending on $n, p$, and $v$ so that each $h_{\varepsilon}$ is invertible on $E=\{(s, t):|s|,|t|<\eta\}$, with $\left\{(a, b):|a|,|b|<\eta / C_{1}\right\} \subset h_{\varepsilon}(E)$, and $\nabla h_{\varepsilon}^{-1}(a, b) \geq \operatorname{Id}_{2 \times 2} / C_{1}$ (in the sense of positive definite matrices) for every $(a, b) \in h_{\varepsilon}(E)$. In particular, if we let $(s, t)=h_{\varepsilon}^{-1}(a, b)$ for a pair ( $a, b$ ) with $|a|,|b|<\eta / C_{1}$, then the function $w_{\varepsilon}=v_{\varepsilon}+s \varphi+t \psi$ satisfies (2.19) and $|(a, b)|=\left|h_{\varepsilon}^{-1}(s, t)\right| \geq|(s, t)| / C_{1}$. Moreover, by the elementary inequality

\left||X+Y|^{p}-|X|^{p}\right| \leq p \max \{|X|,|Y|\}^{p-1}|Y| \quad \forall X, Y \in \mathbb{R}^{n}
$$

we see that, setting $\gamma=\max \left\{\left|\nabla v_{\varepsilon}\right|,|\nabla \varphi|,|\nabla \psi|\right\}^{p}$,

$$
\begin{align*}
\left.\left|\int_{\Omega}\right| \nabla w_{\varepsilon}\right|^{p} & -\int_{\Omega}\left|\nabla v_{\varepsilon}\right|^{p} \mid \leq p \int_{\Omega} \gamma^{(p-1) / p}(|s||\nabla \varphi|+|t||\nabla \psi|) \\
& \leq C\left(\int_{\Omega} \gamma\right)^{(p-1) / p}\left(\int_{\Omega}\left(|s|^{p}|\nabla \varphi|^{p}+|t|^{p}|\nabla \psi|^{p}\right)\right)^{1 / p}  \tag{2.23}\\
& \leq C|(s, t)| \leq C_{2}|(a, b)|,
\end{align*}
$$

for a constant $C_{2}$ depending on $n, p, v$, and $M$. Letting $C=\max \left\{C_{1}, C_{2}\right\}$ concludes the proof of the lemma.

## 3. Boundary concentrations

3.1. Properties of $\Phi_{H}$-minimizers. We recall some facts proved in [MN17] about $\Phi_{H}$ and its minimizers. Recall that we denote by $T_{0}$ the minimum point of $\Phi_{H}$, so that

T_{0} \in\left(0, T_{E}\right), \quad \Phi_{H}\left(T_{0}\right)=2^{-1 / n} S(n, p) \tag{3.1}
\end{equation*}
$$

where $T_{E}$ is the "Escobar trace" defined in (1.8). If we set $H=\left\{x_{n}>0\right\}$, the minimizers of $U_{T}$ of $\Phi_{H}(T)$ for $T>0$ are characterized (modulo the obvious scaling and translation invariance of $\left.\Phi_{H}\right)$ as

U_{T}(x)=c_{T} \begin{cases}\tau_{t_{T} e_{n}} U_{S}(x)=\left(1+\left|x-t_{T} e_{n}\right|^{p^{\prime}}\right)^{1-(n / p)}, & T \in\left(0, T_{E}\right),  \tag{3.2}\\ \tau_{e_{n}} U_{E}(x)=\left|x+e_{n}\right|^{(p-n) /(p-1)}, & T=T_{E}, \\ \tau_{s_{T} e_{n}} U_{B E}(x)=\left(\left|x-s_{T} e_{n}\right|^{p^{\prime}}-1\right)^{1-(n / p)}, & T>T_{E},\end{cases}
$$

where the constants $c_{T}, t_{T}$ and $s_{T}$ are chosen in such a way that

$$
\begin{equation*}
\int_{H} U_{T}^{p^{\star}}=1, \quad \int_{\partial H} U_{T}^{p^{\sharp}}=T^{p^{\sharp}}, \quad \int_{H}\left|\nabla U_{T}\right|^{p}=\Phi_{H}(T)^{p} \tag{3.3}
\end{equation*}
$$

It is convenient to keep in mind that the various formulas for $U_{T}$ listed in (3.2) all share the same decay behavior at infinity, that is (see (3.20) below), we have

U_{T}(x) \sim|x|^{(p-n) /(p-1)}, \quad\left|\nabla U_{T}\right| \sim|x|^{(1-n) /(p-1)} \quad \text { as }|x| \rightarrow \infty \tag{3.4}
\end{equation*}
$$

(where the rate depends on the specific value of $T$ under consideration). The constants $t_{T}$ and $s_{T}$ have the following properties: $T \in\left(0, T_{E}\right) \mapsto t_{T}$ is continuous and strictly decreasing, with $t_{T}>0$ if and only if $T \in\left(0, T_{0}\right)$, and

\lim _{T \rightarrow 0^{+}} t_{T}=+\infty, \quad \lim _{t \rightarrow\left(T_{E}\right)^{-}} t_{T}=-\infty, \quad t_{T_{0}}=0 \tag{3.5}
\end{equation*}

while $T \in\left(T_{E}, \infty\right) \mapsto s_{T}$ is continuous, negative, strictly increasing, with

$$
\begin{equation*}
\lim _{T \rightarrow\left(T_{E}\right)^{+}} s_{T}=-\infty, \quad \lim _{T \rightarrow+\infty} s_{T}=-1 \tag{3.6}
\end{equation*}
$$

Denoting by $\Delta_{p} v=\operatorname{div}\left(|\nabla v|^{p-2} \nabla v\right)$ the $p$-Laplace operator, we have

$$
\left\{\begin{array}{ll}
-\Delta_{p} U_{T}=\lambda_{H}(T) U_{T}^{p^{\star}-1} & \text { on } H,  \tag{3.7}\\
\left|\nabla U_{T}\right|^{p-2} \frac{\partial U_{T}}{\partial \nu_{H}}=\sigma_{H}(T) U_{T}^{p^{\sharp}-1} & \text { on } \partial H,
\end{array} \quad \forall T>0\right.
$$

where $\lambda_{H}, \sigma_{H}:(0, \infty) \rightarrow \mathbb{R}$ are continuous and satisfy the relations

$$
\begin{equation*}
\Phi_{H}(T)^{p}=\lambda_{H}(T)+\sigma_{H}(T) T^{p^{\#}}, \quad \sigma_{H}(T)=\frac{\Phi_{H}(T)^{p-1} \Phi_{H}^{\prime}(T)}{T^{p^{\#}-1}} \tag{3.8}
\end{equation*}
$$

(see [MN17, Lemma 3.3] ${ }^{3}$ ) as well as

$$
\begin{array}{cc}
\lim _{T \rightarrow 0^{+}} \sigma_{H}(T)=-\infty, & \lim _{T \rightarrow+\infty} \sigma_{H}(T)=+\infty \\
\lim _{T \rightarrow 0^{+}} \lambda_{H}(T)>0, & \lim _{T \rightarrow+\infty} \lambda_{H}(T)=-\infty \tag{3.10}
\end{array}
$$

[^2]The signs of $\sigma_{H}$ and $\lambda_{H}$ can be easily deduced from (3.2), and satisfy

$$
\begin{array}{lcc}
\left(0, T_{0}\right)=\left\{\sigma_{H}<0\right\}, & \left(T_{0}, \infty\right)=\left\{\sigma_{H}>0\right\}, & \sigma_{H}\left(T_{0}\right)=0 \\
\left(0, T_{E}\right)=\left\{\lambda_{H}>0\right\}, & \left(T_{E}, \infty\right)=\left\{\lambda_{H}<0\right\}, & \lambda_{H}\left(T_{E}\right)=0 . \tag{3.12}
\end{array}
$$

3.2. A key inequality and further properties of $U_{T}$. In this section, we prove the key inequality (3.13) for the functions $\mathcal{L}$ and $\mathcal{M}$ introduced in (1.28) and (1.29), namely

& \mathcal{L}(U)=\int_{H} x_{n}|\nabla U|^{p}-p x_{n}\left(\partial_{1} U\right)^{2}|\nabla U|^{p-2}, \\
& \mathcal{M}(U)=\int_{H} x_{n} U^{p^{\star}}
\end{aligned}
$$

Whenever $U$ satisfies the decay properties (3.4) (e.g., when $U$ is a compactly supported perturbation of some $U_{T}$ ), we have that $\mathcal{M}(U)<\infty$; however, $\mathcal{L}(U)<\infty$ under (3.4) if and only if $n>2 p-1$; see (3.24) and (3.25) below.

Lemma 3.1 (Key inequality). If $n \geq 2, p \in(1, n), n>2 p-1$, and $T>0$, then there is a positive constant $c(n, p, T)$ such that

\mathcal{L}\left(U_{T}\right)-\frac{n-p}{n} \lambda_{H}(T) \mathcal{M}\left(U_{T}\right) \geq c(n, p, T) . \tag{3.13}
\end{equation*}
$$

The following lemma will be useful in proving Lemma 3.1.
Lemma 3.2. If $H=\left\{x_{n}>0\right\}, U: H \rightarrow \mathbb{R}$ is radially symmetric with respect to $t e_{n}$ for some $t \in \mathbb{R}$, and $\int_{H} x_{n}|\nabla U|^{p}$ is finite, then

\int_{H} x_{n}|\nabla U|^{p-2}\left\{\left(\partial_{n} U\right)^{2}-\left(\partial_{1} U\right)^{2}\right\}>0 .
$$

Proof of Lemma 3.2. We have $U(x)=\eta\left(\left|x-t e_{n}\right|\right), y=x-t e_{n}, r=|y|$, and $\hat{y}=y /|y|$, so that

x_{n}|\nabla U|^{p-2}\left\{\left(\partial_{n} U\right)^{2}-\left(\partial_{1} U\right)^{2}\right\}=\left(y_{n}+t\right)\left|\eta^{\prime}(r)\right|^{p}\left\{\left(\hat{y}_{n}\right)^{2}-\left(\hat{y}_{1}\right)^{2}\right\},
$$

and, setting $y=r z$,

$$
\begin{aligned}
& \int_{H} x_{n}|\nabla U|^{p-2}\left\{\left(\partial_{n} U\right)^{2}-\left(\partial_{1} U\right)^{2}\right\}=\int_{\left\{y_{n}>-t\right\}}\left(y_{n}+t\right)\left|\eta^{\prime}(r)\right|^{p}\left\{\left(\hat{y}_{n}\right)^{2}-\left(\hat{y}_{1}\right)^{2}\right\} \\
& =\int_{0}^{\infty}\left|\eta^{\prime}(r)\right|^{p} d r \int_{\left\{y_{n}>-t\right\} \cap \partial B_{r}}\left(y_{n}+t\right)\left\{\left(\hat{y}_{n}\right)^{2}-\left(\hat{y}_{1}\right)^{2}\right\} d \mathcal{H}_{y}^{n-1} \\
& =\int_{0}^{\infty} r^{n}\left|\eta^{\prime}(r)\right|^{p} d r \int_{\left\{z_{n}>-t / r\right\} \cap \partial B_{1}}\left(z_{n}+\frac{t}{r}\right)\left\{z_{n}^{2}-z_{1}^{2}\right\} d \mathcal{H}_{z}^{n-1} .
\end{aligned}
$$

We conclude the proof by showing that

$$
\begin{equation*}
\int_{\left\{z_{n}>-s\right\} \cap \partial B_{1}}\left(z_{n}+s\right)\left\{z_{n}^{2}-z_{1}^{2}\right\} d \mathcal{H}_{z}^{n-1}>0 \quad \text { for all } s \in(-1,1) \tag{3.14}
\end{equation*}
$$

noting that for each $s \in[1, \infty)$, this integral vanishes by symmetry while for $s \in(-\infty,-1]$ the domain of integration is empty. To see (3.14), let $\mathbf{p}: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n-2}$ denote the projection $\operatorname{map} \mathbf{p}(x)=\left(x_{2}, \ldots, x_{n-1}\right)$ (if $n=2$ there is no need to introduce $\mathbf{p}$ ). The tangential coarea factor of $\mathbf{p}$ along $\partial B_{1}$ defines a positive function $K: \partial B_{1} \rightarrow(0, \infty]$ which is $\mathcal{H}^{n-1}$-a.e. finite on $\partial B_{1}$, and which is independent of the variables $\left(x_{1}, x_{n}\right)$, i.e. $K\left(x_{1}, w, x_{n}\right)=K(w)$ for every $\left(x_{1}, w, x_{n}\right) \in \partial B_{1}$. Therefore, setting for brevity $M_{s}=\left\{z_{n}>-s\right\} \cap \partial B_{1}$,

$$
\int_{M_{s}}\left(z_{n}+s\right)\left\{z_{n}^{2}-z_{1}^{2}\right\} d \mathcal{H}_{z}^{n-1}=\int_{\mathbf{p}\left(M_{s}\right)} \frac{d \mathcal{L}_{w}^{n-2}}{K(w)} \int_{M_{s} \cap \mathbf{p}^{-1}(w)}\left(z_{n}+s\right)\left\{z_{n}^{2}-z_{1}^{2}\right\} d \mathcal{H}_{\left(z_{1}, z_{n}\right)}^{1}
$$

where

$$
M_{s} \cap \mathbf{p}^{-1}(w)=\left\{\left(z_{1}, z_{n}\right): z_{1}^{2}+z_{n}^{2}=1-|w|^{2}, z_{n}>-s\right\}, \quad s \in(-1,1) .
$$

As before, the inner integral above vanishes when $1-|w|^{2} \leq s$ by symmetry and the domain of integration is empty when $-s \geq 1-|w|^{2}$. We are thus left to prove that

$$
\int_{-\alpha}^{\pi+\alpha}(\sin \theta+\sin \alpha)\left\{\sin ^{2} \theta-\cos ^{2} \theta\right\} d \theta>0
$$

for $\alpha \in(0, \pi / 2)$ (corresponding to the case when $s \geq 0$ ) and

$$
\int_{\alpha}^{\pi-\alpha}(\sin \theta-\sin \alpha)\left\{\sin ^{2} \theta-\cos ^{2} \theta\right\} d \theta>0
$$

for $\alpha \in(0, \pi / 2)$ (corresponding to the case when $s<0)$. Direct computation shows that both of these integrals are equal to the positive quantity $(2 / 3)(\cos \alpha)^{3}$.

We now prove Lemma 3.1.
Proof of Lemma 3.1. Testing (3.7) with $x_{n} U_{T}$ we find

\lambda_{H}(T) \int_{H} x_{n} U_{T}^{p^{\star}}=-\int_{H} x_{n} U_{T} \Delta_{p} U_{T}=\int_{H}\left|\nabla U_{T}\right|^{p-2} \nabla U_{T} \cdot \nabla\left(x_{n} U_{T}\right) .
$$

Here the integration by parts is justified since $x_{n}=0$ on $\partial H$ and since by (3.4),

$$
\left.\left|\int_{H \cap \partial B_{R}} x_{n} U_{T}\right| \nabla U_{T}\right|^{p-2}\left(\nu_{B_{R}} \cdot \nabla U_{T}\right) \left\lvert\, \leq C \frac{R^{n-1} R}{R^{(n-p) /(p-1)}}\left(\frac{1}{R^{(n-1) /(p-1)}}\right)^{p-1} \rightarrow 0\right.
$$

like $R^{-(n+1) /(p-1)}$ as $R \rightarrow \infty$. We thus find that

\mathcal{L}\left(U_{T}\right)-\frac{n-p}{n} \lambda_{H}(T) \mathcal{M}\left(U_{T}\right) & =\int_{H} x_{n}\left|\nabla U_{T}\right|^{p}-p x_{n}\left(\partial_{1} U_{T}\right)^{2}\left|\nabla U_{T}\right|^{p-2} \\
- & \frac{n-p}{n}\left\{\int_{H} x_{n}\left|\nabla U_{T}\right|^{p}+\int_{H} U_{T}\left|\nabla U_{T}\right|^{p-2} \partial_{n} U_{T}\right\} .
\end{aligned}
$$

Now, since $\left|\nabla U_{T}\right|$ is symmetric by reflection with respect to the hyperplanes $\left\{x_{i}=0\right\}$, $i=1, \ldots, n-1$, we see that

$$
\begin{aligned}
\int_{H} x_{n}\left|\nabla U_{T}\right|^{p} & =\sum_{i=1}^{n-1} \int_{H} x_{n}\left(\partial_{i} U_{T}\right)^{2}\left|\nabla U_{T}\right|^{p-2}+\int_{H} x_{n}\left(\partial_{n} U_{T}\right)^{2}\left|\nabla U_{T}\right|^{p-2} \\
& =(n-1) \int_{H} x_{n}\left(\partial_{1} U_{T}\right)^{2}\left|\nabla U_{T}\right|^{p-2}+\int_{H} x_{n}\left(\partial_{n} U_{T}\right)^{2}\left|\nabla U_{T}\right|^{p-2}
\end{aligned}
$$

so that continuing from above we have

$$
\begin{aligned}
& \mathcal{L}\left(U_{T}\right)-\frac{n-p}{n} \lambda_{H}(T) \mathcal{M}\left(U_{T}\right) \\
& =\frac{p}{n} \int_{H} x_{n}\left|\nabla U_{T}\right|^{p}-p \int_{H} x_{n}\left(\partial_{1} U_{T}\right)^{2}\left|\nabla U_{T}\right|^{p-2}-\frac{n-p}{n} \int_{H} U_{T}\left|\nabla U_{T}\right|^{p-2} \partial_{n} U_{T} \\
& =\frac{p}{n} \int_{H} x_{n}\left|\nabla U_{T}\right|^{p-2}\left\{\left(\partial_{n} U_{T}\right)^{2}-\left(\partial_{1} U_{T}\right)^{2}\right\}+\frac{n-p}{n} \int_{H} U_{T}\left|\nabla U_{T}\right|^{p-2}\left(-\partial_{n} U_{T}\right) .
\end{aligned}
$$

In particular, the lemma is proved by showing that

$$
\begin{align*}
& \int_{H} x_{n}\left|\nabla U_{T}\right|^{p-2}\left\{\left(\partial_{n} U_{T}\right)^{2}-\left(\partial_{1} U_{T}\right)^{2}\right\}>0  \tag{3.15}\\
& \int_{H} U_{T}\left|\nabla U_{T}\right|^{p-2}\left(-\partial_{n} U_{T}\right)>0 \tag{3.16}
\end{align*}
$$

where the first inequality, (3.15), is immediate from Lemma 3.2 (recall that $n>2 p-1$ and $U_{T}$ is radially symmetric with respect to $t e_{n}$ for some $t \in \mathbb{R}$ ).

We are thus left to prove (3.16). This is immediate in the case when $T \geq T_{0}$, because in that case, by (3.5) and (3.6), $U_{T}$ has center of symmetry at $t e_{n}$ for some $t \leq 0$, and thus $\partial_{n} U_{T}<0$ on $H$. By (3.5), if $T \in\left(0, T_{0}\right)$, then $U_{T}$ has center of symmetry at $t e_{n}$ for some $t>0$. Correspondingly, $U_{T} \partial_{n} U_{T}$ is odd with respect to $\left\{x_{n}=t\right\}$, with $U_{T} \partial_{n} U_{T}<0$ on $\left\{x_{n}>t\right\}$ and $U_{T} \partial_{n} U_{T}>0$ on $\left\{0<x_{n}<t\right\}$ : in particular, if $p_{t}$ denotes the reflection with respect to $\left\{x_{n}=t\right\}$, then

$$
\begin{aligned}
& \int_{2 t>x_{n}>t} x_{n} U_{T}\left(-\partial_{n} U_{T}\right)=\int_{t>x_{n}>0}\left(p_{t}(x) \cdot e_{n}\right)\left[U_{T}\left(-\partial_{n} U_{T}\right)\right]\left(p_{t}(x)\right) d x \\
& \left.=\int_{t>x_{n}>0}\left(p_{t}(x) \cdot e_{n}\right)\left[U_{T} \partial_{n} U_{T}\right)\right](x) d x \geq \int_{t>x_{n}>0} x_{n} U_{T} \partial_{n} U_{T},
\end{aligned}
$$

so that

$$
\int_{H} U_{T}\left|\nabla U_{T}\right|^{p-2}\left(-\partial_{n} U_{T}\right) \geq \int_{\left\{x_{n}>2 t\right\}} U_{T}\left|\nabla U_{T}\right|^{p-2}\left(-\partial_{n} U_{T}\right)
$$

and the latter integral is positive because $\partial_{n} U_{T}<0$ on $\left\{x_{n}>t\right\}$.
3.3. Standard variations of $\Phi_{H}$-minimizers. We now introduce a "class of standard variations" of minimizers of $\Phi_{H}$. With $H=\left\{x_{n}>0\right\}$, we define $\zeta=\zeta(r, T):[0, \infty) \times$ $(0, \infty) \rightarrow[0, \infty)$, so that, setting $V_{T}(x)=\zeta\left(\left|x-e_{n}\right|, T\right)$ for $x \in \mathbb{R}^{n}$, we have

\begin{equation*}
V_{T} \in C_{c}^{\infty}(H ;[0, \infty)), \quad \int_{H} U_{T}^{p^{\star}-1} V_{T}=1, \quad \int_{\partial H} U_{T}^{p^{\#}-1} V_{T}=0 \tag{3.17}
\end{equation*}
$$

Given $T>0$ we denote by

$$
\begin{equation*}
\mathcal{U}_{T} \tag{3.18}
\end{equation*}
$$

the family of functions $U: H \rightarrow \mathbb{R}$ of the form

$$
U=U_{T}+t V_{T}, \quad|t| \leq 1
$$

The following lemma contains some basic properties of functions in $\mathcal{U}_{T}$. We notice that every $U \in \mathcal{U}_{T}$ is symmetric by reflection with respect to the coordinates $x_{1}, \ldots, x_{n-1}$.

3.4. The Ansatz for boundary concentrations. We next use the standard variations of minimizers of $\Phi_{H}$ described in Lemma 3.3 to define certain competitors for $\Phi_{\Omega}$ that provide us with a notion of "standard boundary concentration." Recall the notation $U^{(\varepsilon)}$ for dilations introduced in (1.5).

Step one: We start by noticing the following estimates for the energy, volume and trace of $v_{\varepsilon}$ in transition region for the cut-off function $\varphi_{\varepsilon}$. The estimates in this step hold in
identical form with the same proofs for $v_{\varepsilon}$ defined from $\hat{f}$ as in (3.29) and for $v_{\varepsilon}$ defined from $f$ as in (3.33); we write the proof for (3.33). First, with $v \in W^{1, p}(\Omega)$,

& +p \varepsilon \sum_{i=1}^{n-1} \kappa_{i} \int_{H \cap B_{C r_{1} / \varepsilon}} x_{n}\left(\partial_{i} U\right)^{2}|\nabla U|^{p-2}+C \varepsilon^{2} \int_{H \cap B_{C r_{1} / \varepsilon}}|x|^{2}|\nabla U|^{p}
\end{align*}
$$

Now, by the reflection symmetries of $U$ with respect to $\left\{x_{i}=0\right\}, i=1, \ldots, n-1$ (recall (3.19)), we have

$$
\int_{H \cap B_{R}} x_{n}\left(\partial_{i} U\right)^{2}|\nabla U|^{p-2}=\int_{H \cap B_{R}} x_{n}\left(\partial_{1} U\right)^{2}|\nabla U|^{p-2}, \quad \forall i=1, \ldots, n-1, \forall R>0
$$

and therefore

$$
\sum_{i=1}^{n-1} \kappa_{i} \int_{H \cap B_{C r_{1} / \varepsilon}} x_{n}\left(\partial_{i} U\right)^{2}|\nabla U|^{p-2}=h \int_{H \cap B_{C r_{1} / \varepsilon}} x_{n}\left(\partial_{1} U\right)^{2}|\nabla U|^{p-2}
$$

Setting

$$
\begin{equation*}
\mathcal{L}\left(U, B_{R}\right)=\int_{H \cap B_{R}} x_{n}|\nabla U|^{p}-p x_{n}\left(\partial_{1} U\right)^{2}|\nabla U|^{p-2} \tag{3.46}
\end{equation*}
$$

we can thus rewrite (3.45) as

$$
\int_{\Omega \cap B_{r_{1}}}\left|(\nabla g)^{*}\left[\left(\nabla U^{(\varepsilon)}\right) \circ g\right]\right|^{p} \leq \int_{H}|\nabla U|^{p}-h \varepsilon \mathcal{L}\left(U, B_{C r_{1} / \varepsilon}\right)+C \varepsilon^{2} \int_{H \cap B_{C r_{1} / \varepsilon}}|x|^{2}|\nabla U|^{p}
$$

At the same time, $\varepsilon^{2}|x|^{2} \leq C \varepsilon r_{1}|x|$ for any $x \in B_{C r_{1} / \varepsilon}$, so

$$
\begin{aligned}
& \varepsilon^{2} \int_{H \cap B_{C r_{1} / \varepsilon}}|x|^{2}|\nabla U|^{p} \leq C \varepsilon r_{1} \int_{H \cap B_{C r_{1} / \varepsilon}}|x||\nabla U|^{p} \\
& \leq C \varepsilon^{1+\beta} \int_{H}|x|\left|\nabla U_{T}\right|^{p}+C \varepsilon^{1+\beta} \int_{H}|x|\left|\nabla V_{T}\right|^{p} \leq C(n, p, T) \varepsilon^{1+\beta}
\end{aligned}
$$

where we have used the facts that $V_{T}$ is compactly supported and that $n>2 p-1$ to guarantee the convergence of the integrals in the final line. Hence,

\int_{\Omega \cap B_{r_{1}}}\left|(\nabla g)^{*}\left[\left(\nabla U^{(\varepsilon)}\right) \circ g\right]\right|^{p} & =\int_{H}|\nabla U|^{p}-h \mathcal{L}\left(U, B_{C r_{1} / \varepsilon}\right) \varepsilon+\mathrm{o}(\varepsilon) \\
& =\int_{H}|\nabla U|^{p}-h \mathcal{L}(U) \varepsilon+\mathrm{o}(\varepsilon)
\end{aligned}
$$

where the $\mathrm{o}(\varepsilon)$ term depends on $n, p$, and $T$, and in the second line we have applied (3.25). By (3.44) we deduce (3.34).
Step five: We prove (3.35). We first notice that by (3.43), $v \in \operatorname{Lip}(\Omega), r_{2}^{n}=\varepsilon^{\beta n}=\mathrm{o}(\varepsilon)$ and our choice of $\beta$ we have

\int_{\Omega} v_{\varepsilon}^{p^{\star}}=\int_{\Omega \cap B_{r_{1}}}\left(U^{(\varepsilon)} \circ g\right)^{p^{\star}}+\int_{\Omega} v^{p^{\star}}+\mathrm{o}(\varepsilon) \tag{3.47}
\end{equation*}
$$

Let $E_{\varepsilon}=g\left(B_{r_{1}} \cap \Omega\right) \subset H$ and $\tilde{E}_{\varepsilon}=E_{\varepsilon} / \varepsilon \subset E$ as in step two. Then keeping in mind (2.13) and (2.14),

$$
\begin{aligned}
\int_{\Omega \cap B_{r_{1}}}\left(U^{(\varepsilon)} \circ g\right)^{p^{\star}}=\int_{E_{\varepsilon}}\left(U^{(\varepsilon)}\right)^{p^{\star}}-h \int_{E_{\varepsilon}} x_{n}\left(U^{(\varepsilon)}\right)^{p^{\star}}+\int_{E_{\varepsilon}} \mathrm{O}\left(|x|^{2}\right)\left(U^{(\varepsilon)}\right)^{p^{\star}} \\
\quad=\int_{\tilde{E}_{\varepsilon}} U^{p^{\star}}-h \varepsilon \int_{\tilde{E}_{\varepsilon}} x_{n} U^{p^{\star}}+\int_{E_{\varepsilon}} \mathrm{O}\left(|x|^{2}\right)\left(U^{(\varepsilon)}\right)^{p^{\star}} \\
\quad=\int_{H} U^{p^{\star}}-h \varepsilon \mathcal{M}(U)+\left\{-\int_{H \backslash \tilde{E}_{\varepsilon}} U^{p^{\star}}+h \varepsilon \int_{H \backslash \tilde{E}_{\varepsilon}} x_{n} U^{p^{\star}}+\int_{E_{\varepsilon}} \mathrm{O}\left(|x|^{2}\right)\left(U^{(\varepsilon)}\right)^{p^{\star}}\right\}
\end{aligned}
$$

By (3.21) and (3.24), along with our choice of $\beta$, we see that

$$
-\int_{H \backslash \tilde{E}_{\varepsilon}} U^{p^{\star}}=o(\varepsilon), \quad h \varepsilon \int_{H \backslash \tilde{E}_{\varepsilon}} x_{n} U^{p^{\star}}=o(\varepsilon)
$$

Moreover, since $U=U_{T}+t V_{T}$ with $V_{T}$ compactly supported in $H$ and $|t| \leq 1$, we have

\begin{aligned}
\int_{E_{\varepsilon}}|x|^{2}\left(U^{(\varepsilon)}\right)^{p^{\star}} & \leq C r_{1} \varepsilon \int_{\tilde{E}_{\varepsilon}}|x| U^{p^{\star}} \leq \varepsilon^{1+\beta} \int_{H}|x| U^{p^{\star}} \\
& \leq C \varepsilon^{1+\beta} \int_{H}|x| U_{T}^{p^{\star}}+C \varepsilon^{1+\beta} \int_{H}|x| V^{p^{\star}}=\mathrm{o}(\varepsilon)
\end{aligned}
$$

with o( $(\varepsilon)$ depending on $n, p$, and $T$. So, the entire term in brackets above can be written as $\mathrm{o}(\varepsilon)$. Combining this estimate with (3.47), we deduce (3.35).
Step six: We finally prove (3.36). Notice that, by (3.43), $v \in \operatorname{Lip}(\Omega), r_{2}^{n-1}=\varepsilon^{\beta(n-1)}=\mathrm{o}(\varepsilon)$ (by the choice of $\beta$ ), we have

\int_{\partial \Omega} v_{\varepsilon}^{p^{\#}}=\int_{(\partial \Omega) \cap B_{r_{1}}}\left(U^{(\varepsilon)} \circ g\right)^{p^{\#}}+\int_{\partial \Omega} v^{p^{\#}}+\mathrm{o}(\varepsilon) \tag{3.48}
\end{equation*}
$$

Now, by $J^{\partial H} f \geq 1$, (3.23) and our choice of $\beta$ we have

$$
\int_{(\partial \Omega) \cap B_{r_{1}}}\left(U^{(\varepsilon)} \circ g\right)^{p^{\#}} \geq \int_{(\partial H) \cap B_{r_{1} / C}}\left(U^{(\varepsilon)}\right)^{p^{\#}}=\int_{\partial H} U^{p^{\#}}-\int_{(\partial H) \backslash B_{r_{1} / C \varepsilon}} U^{p^{\#}} \geq \int_{\partial H} U^{p^{\#}}+\mathrm{o}(\varepsilon)
$$

At the same time, by $J^{\partial H} f \leq 1+C|x|^{2}$, we have

$$
\begin{aligned}
& \int_{(\partial \Omega) \cap B_{r_{1}}}\left(U^{(\varepsilon)} \circ g\right)^{p^{\#}} \leq \int_{(\partial H) \cap B_{C r_{1}}}\left(1+C|x|^{2}\right)\left(U^{(\varepsilon)}\right)^{p^{\#}} \\
& \leq \int_{\partial H} U^{p^{\#}}+C \varepsilon^{2} \int_{(\partial H) \cap B_{C r_{1} / \varepsilon}}|x|^{2} U^{p^{\#}}
\end{aligned}
$$

where

$$
\begin{aligned}
& \varepsilon^{2} \int_{(\partial H) \cap B_{C r_{1} / \varepsilon}|x|^{2} U^{p^{\#}} \leq C \varepsilon^{2} \int_{0}^{C r_{1} / \varepsilon} \frac{r^{2} r^{n-2} d r}{\left(r^{(n-p) /(p-1)}\right)^{p^{\#}}}}^{\leq C \varepsilon^{2}\left(r_{1} / \varepsilon\right)^{1+n-(n-1)[p /(p-1)]}} \\
& \leq C \varepsilon^{2}\left(r_{1} / \varepsilon\right)^{(2 p-n-1) /(p-1)} \leq C \varepsilon^{2} \varepsilon^{(1-\beta)(n+1-2 p) /(p-1)} \leq C \varepsilon^{2}=\mathrm{o}(\varepsilon),
\end{aligned}
$$

thanks to $n>2 p-1$. This completes the proof.

## 4. Existence of minimizers

We first establish the existence of generalized minimizers. Recall that $\Phi_{\Omega}^{*}(T)$ was defined in (1.21).

Theorem 4.1. Let $n \geq 2, p \in(1, n)$, and let $\Omega$ be a bounded open set with $C^{1}$-boundary in $\mathbb{R}^{n}$. Then:
(i): for every $T>0, \Phi_{\Omega}(T)=\Phi_{\Omega}^{*}(T)$;
(ii): there is a minimizer $(u, \mathrm{v}, \mathrm{t})$ of $\Phi_{\Omega}^{*}(T)$;
(iii): if $(u, \mathrm{v}, \mathrm{t})$ is a minimizer of $\Phi_{\Omega}^{*}(T)$ with $\int_{\Omega} u^{p^{\star}}>0$, then $\int_{\partial \Omega} u^{p^{\#}}>0$,

$$
\begin{equation*}
u /\|u\|_{L^{p^{\star}}(\Omega)} \text { is a minimizer of } \Phi_{\Omega}\left(\|u\|_{L^{p^{\#}}(\partial \Omega)} /\|u\|_{L^{p^{\star}}(\Omega)}\right), \tag{4.1}
\end{equation*}
$$

and there exists $\lambda, \sigma \in \mathbb{R}$ such that

$$
\begin{cases}-\Delta_{p} u=\lambda u^{p^{\star}-1}, & \text { on } \Omega  \tag{4.2}\\ |\nabla u|^{p-2} \frac{\partial u}{\partial \nu_{\Omega}}=\sigma u^{p^{\#}-1}, & \text { on } \partial \Omega\end{cases}
$$

In particular, $u \in \operatorname{Lip}(\Omega)$. If, in addition, $v>0$, then $\lambda$ and $\sigma$ are given by

$$
\begin{equation*}
\lambda=\mathrm{v}^{p-p^{\star}} \lambda_{H}(\mathrm{t} / \mathrm{v}), \quad \sigma=\mathrm{v}^{p-p^{\#}} \sigma_{H}(\mathrm{t} / \mathrm{v}), \tag{4.3}
\end{equation*}
$$

and, in particular,

$$
\begin{equation*}
\frac{\mathrm{t}}{\mathrm{v}} \in\left(0, T_{0}\right) \cup\left(T_{E}, \infty\right) \tag{4.4}
\end{equation*}
$$

Proof. Step one: Since $(u, 0,0) \in \mathcal{Y}_{\Omega}(T)$ if $u \in \mathcal{X}_{\Omega}(T)$, we have $\Phi_{\Omega}^{*}(T) \leq \Phi_{\Omega}(T)$. To prove the converse inequality it is enough to show that for every $(u, \mathrm{v}, \mathrm{t}) \in \mathcal{Y}_{\Omega}(T)$,

$$
\begin{equation*}
\exists u_{j} \in \mathcal{X}_{\Omega}(T) \text { s.t. } \lim _{j \rightarrow \infty} \int_{\Omega}\left|\nabla u_{j}\right|^{p}=\int_{\Omega}|\nabla u|^{p}+\mathrm{v}^{p} \Phi_{H}\left(\frac{\mathrm{t}}{\mathrm{v}}\right)^{p} \tag{4.5}
\end{equation*}
$$

Looking back at the definition of $\mathcal{Y}_{\Omega}(T)$ in the paragraph preceding the statement of Theorem 1.1, we can assume without loss of generality that $v>0$ and $t>0$. Moreover, given $(u, \mathrm{v}, \mathrm{t}) \in \mathcal{Y}_{\Omega}(T)$ with v and t positive we can easily find $\left(u_{j}, \mathrm{v}_{j}, \mathrm{t}_{j}\right) \in \mathcal{Y}_{\Omega}(T)$ with $\mathrm{v}_{j}, \mathrm{t}_{j}, \int_{\Omega} u_{j}^{p^{\star}}$, and $\int_{\partial \Omega} u_{j}^{p^{\#}}$ positive and such that $\mathcal{E}\left(u_{j}, \mathrm{v}_{j}, \mathrm{t}_{j}\right) \rightarrow \mathcal{E}(u, \mathrm{v}, \mathrm{t})$. By a diagonal argument, it is thus sufficient proving (4.5) under the assumption that $\int_{\Omega} u^{p^{\star}}$ and $\int_{\partial \Omega} u^{p^{\#}}$ are positive. This said, we apply Lemma 3.4(i) with

$$
v=\frac{u}{\mathrm{v}}, \quad U=U_{\mathrm{t} / \mathrm{v}}
$$

to find functions $v_{j}$ with $v_{j}=v$ on $\Omega \backslash B_{2 \varepsilon_{j}}\left(x_{0}\right)$ for some $x_{0} \in \partial \Omega$ and $\varepsilon_{j} \rightarrow 0^{+}$, and with

$$
\begin{aligned}
& \int_{\Omega}\left|\nabla v_{j}\right|^{p}=\frac{1}{\mathrm{v}^{p}} \int_{\Omega}|\nabla u|^{p}+\Phi_{H}(\mathrm{t} / \mathrm{v})^{p}+G_{j} \\
& \int_{\Omega} v_{j}^{p^{\star}}=\frac{1}{\mathrm{v}^{p^{\star}}} \int_{\Omega} u^{p^{\star}}+1+V_{j} \\
& \int_{\partial \Omega} v_{j}^{p^{\#}}=\frac{1}{\mathrm{v}^{p^{\#}}} \int_{\partial \Omega} u^{p^{\#}}+(\mathrm{t} / \mathrm{v})^{p^{\#}}+T_{j}
\end{aligned}
$$

where $G_{j}, V_{j}, T_{j} \rightarrow 0$ as $j \rightarrow \infty$ at a rate depending on $n, p, \Omega, \mathrm{t} / \mathrm{v}$ and $u$ only. By Lemma 2.6, there exist $\eta$ and $C$ depending on $n, p, \Omega$, $\mathrm{t} / \mathrm{v}$ and $u$, but independent from $j$, such that for any $\left(a_{j}, b_{j}\right)$ with $\left|a_{j}\right|+\left|b_{j}\right|<\eta$, we have functions $w_{j}$ such that

$$
\begin{gather*}
\int_{\partial \Omega}\left|w_{j}\right|^{p^{\#}}=a_{j}+\int_{\partial \Omega}\left|v_{j}\right|^{p^{\#}}, \quad \int_{\Omega}\left|w_{j}\right|^{p^{\star}}=b_{j}+\int_{\Omega}\left|v_{j}\right|^{p^{\star}}  \tag{4.6}\\
\left.\left|\int_{\Omega}\right| \nabla w_{j}\right|^{p}-\int_{\Omega}\left|\nabla v_{j}\right|^{p} \mid \leq C\left(\left|a_{j}\right|+\left|b_{j}\right|\right) \tag{4.7}
\end{gather*}
$$

For $j$ large enough we can apply this statement with $a_{j}=-T_{j}$ and $b_{j}=-V_{j}$ to find a sequence $\left\{w_{j}\right\}_{j}$ with

$$
\begin{align*}
\int_{\partial \Omega}\left|w_{j}\right|^{p^{\#}}= & \frac{1}{\mathrm{v}^{p^{\#}}} \int_{\partial \Omega} u^{p^{\#}}+(\mathrm{t} / \mathrm{v})^{p^{\#}}=\frac{T^{p^{\#}}}{\mathrm{v}^{p^{\#}}}, \quad \int_{\Omega}\left|w_{j}\right|^{p^{\star}}=\frac{1}{\mathrm{v}^{p^{\star}}} \int_{\Omega} u^{p^{\star}}+1=\frac{1}{\mathrm{v}^{p^{\star}}},  \tag{4.8}\\
& \left.\left.\left|\int_{\Omega}\right| \nabla w_{j}\right|^{p}-\frac{1}{\mathrm{v}^{p}} \int_{\Omega}|\nabla u|^{p}-\Phi_{H}(\mathrm{t} / \mathrm{v})^{p}-G_{j} \right\rvert\, \leq C\left(\left|T_{j}\right|+\left|V_{j}\right|\right) . \tag{4.9}
\end{align*}
$$

Setting $u_{j}=v w_{j}$, we obtain a sequence in $\mathcal{X}_{\Omega}(T)$ that satisfies (4.5).
Step two: We prove that there is a minimizer for the generalized problem $\Phi_{\Omega}^{*}(T)$. By the argument in step one we can find a sequence $\left\{u_{j}\right\}_{j}$ in $\mathcal{X}_{\Omega}(T)$ such that $\int_{\Omega}\left|\nabla u_{j}\right|^{p} \rightarrow \Phi_{\Omega}^{*}(T)^{p}$. By Lemma 2.1, the measures $\mu_{j}, \nu_{j}$ and $\tau_{j}$ defined in (2.1) have subsequential weak-star limits $\mu, \nu$ and $\tau$ satisfying (2.2), (2.3) and (2.4) and (2.5). In particular, there is an at most countable set $\left\{x_{i}\right\}_{i \in I} \subset \bar{\Omega}$ and corresponding $\mathrm{v}_{i}>0$ and $\mathrm{t}_{i} \geq 0$ for every $i \in I$, such that

$$
\begin{equation*}
\Phi_{\Omega}^{*}(T)^{p}=\lim _{j \rightarrow \infty} \int_{\Omega}\left|\nabla u_{j}\right|^{p} \geq \int_{\Omega}|\nabla u|^{p}+S^{p} \sum_{i \in I \backslash I_{\mathrm{bd}}} \mathrm{v}_{i}^{p}+\sum_{i \in I_{\mathrm{bd}}} \mathrm{v}_{i}^{p} \Phi_{H}\left(\mathrm{t}_{i} / \mathrm{v}_{i}\right)^{p} \tag{4.10}
\end{equation*}
$$

where $u$ is the subsequential weak limit of $u_{j}$, and

$$
\begin{equation*}
1=\int_{\Omega} u^{p^{\star}}+\sum_{i \in I} \mathrm{v}_{i}^{p^{\star}}, \quad T^{p^{\#}}=\int_{\partial \Omega} u^{p^{\#}}+\sum_{i \in I_{\mathrm{bd}}} \mathrm{t}_{i}^{p^{\#}} \tag{4.11}
\end{equation*}
$$

Now set

$$
\mathrm{v}_{c}^{p^{\star}}=\sum_{i \in I} \mathrm{v}_{i}^{p^{\star}}, \quad \mathrm{t}_{c}^{p^{\#}}=\sum_{i \in I_{\mathrm{bd}}} \mathrm{t}_{i}^{p^{\#}}
$$

By an immediate adaptation of the proof of Lemma 3.4 we can easily construct a sequence $\left\{W_{j}\right\}_{j}$ in $\mathcal{X}_{H}\left(\mathrm{t}_{c} / \mathrm{v}_{c}\right)$ with the property that

$$
\int_{H}\left|\nabla W_{j}\right|^{p} \rightarrow \sum_{i \in I}\left(\frac{\mathrm{v}_{i}}{\mathrm{v}_{c}}\right)^{p} \Phi_{H}\left(\mathrm{t}_{i} / \mathrm{v}_{i}\right)^{p}
$$

Since $W_{j} \in \mathcal{X}_{H}\left(\mathrm{t}_{c} / \mathrm{v}_{c}\right)$ implies $\int_{H}\left|\nabla W_{j}\right|^{p} \geq \Phi_{H}\left(\mathrm{t}_{c} / \mathrm{v}_{c}\right)^{p}$, we deduce from (4.10) that

$$
\Phi_{\Omega}^{*}(T)^{p} \geq \int_{\Omega}|\nabla u|^{p}+\mathrm{v}_{c}^{p} \Phi_{H}\left(\mathrm{t}_{c} / \mathrm{v}_{c}\right)^{p}
$$

while (4.11) gives $\left(u, \mathrm{v}_{c}, \mathrm{t}_{c}\right) \in \mathcal{Y}_{\Omega}(T)$. This proves that $\left(u, \mathrm{v}_{c}, \mathrm{t}_{c}\right)$ is a minimizer of $\Phi_{\Omega}^{*}(T)$.

Step three: We finally prove statement (iii). If ( $u, \mathrm{v}, \mathrm{t}$ ) is a minimizer of $\Phi_{\Omega}^{*}(T)$ with $\int_{\Omega} u^{p^{\star}}>0$, it is immediate to deduce (4.1), and since $\Phi_{\Omega}(0)$ does not admit minimizers, it must also be $\int_{\partial \Omega} u^{p^{\#}}>0$. By Lemma 2.5, the Euler-Lagrange equation (4.2) for $u$ holds for some $\lambda, \sigma \in \mathbb{R}$ and $u \in \operatorname{Lip}(\Omega)$. Assuming now that $\mathrm{v}>0$, we can prove (4.3) by noticing that, given $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$, if we define

$$
\alpha(\delta)=\left(1-\int_{\Omega}(u+\delta \varphi)^{p^{\star}}\right)^{1 / p^{\star}}-v, \quad \beta(\delta)=\left(T^{p^{p^{\#}}}-\int_{\partial \Omega}(u+\delta \varphi)^{p^{\#}}\right)^{1 / p^{\#}}-\mathrm{t},
$$

then there is $\delta_{0}>0$ such that $(u+\delta \varphi, v+\alpha(\delta), \mathrm{t}+\beta(\delta)) \in \mathcal{Y}_{\Omega}(T)$ for every $|\delta|<\delta_{0}$. In particular,

$$
0=\left.\frac{d}{d \delta}\right|_{\delta=0} \int_{\Omega}|\nabla(u+\delta \varphi)|^{p}+(\mathrm{v}+\alpha(\delta))^{p} \Phi_{H}\left(\frac{\mathrm{t}+\beta(\delta)}{\mathrm{v}+\alpha(\delta)}\right)^{p},
$$

and exploiting (4.2) as well as

$$
\alpha^{\prime}(0)=-\mathrm{v}^{1-p^{\star}} \int_{\Omega} u^{p^{\star}-1} \varphi, \quad \beta^{\prime}(0)=-\mathrm{t}^{1-p^{\#}} \int_{\partial \Omega} u^{p^{\# \#}-1} \varphi,
$$

and (3.8) (i.e. $\Phi_{H}(T)=\lambda_{H}(T)+\sigma_{H}(T) T^{p^{\#}}$ and $\sigma_{H}(T) T^{p^{\#}-1}=\Phi_{H}(T)^{p-1} \Phi_{H}^{\prime}(T)$ for every $T>0$ ), we see that

$$
\begin{aligned}
0= & \int_{\Omega}|\nabla u|^{p-2} \nabla u \cdot \nabla \varphi+\mathrm{v}^{p-1} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p-1} \Phi_{H}^{\prime}(\mathrm{t} / \mathrm{v}) \beta^{\prime}(0) \\
& +\left\{\mathrm{v}^{p-1} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p}-\mathrm{t} \mathrm{v}^{p-2} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p-1} \Phi_{H}^{\prime}(\mathrm{t} / \mathrm{v})\right\} \alpha^{\prime}(0) \\
= & \lambda \int_{\Omega} u^{p^{\star}-1} \varphi+\sigma \int_{\partial \Omega} u^{p^{\#}-1} \varphi-\mathrm{v}^{p-1} \mathrm{t}^{1-p^{\#}} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p-1} \Phi_{H}^{\prime}(\mathrm{t} / \mathrm{v}) \int_{\partial \Omega} u^{p^{\#}-1} \varphi \\
& -\mathrm{v}^{p-p^{\star}}\left\{\Phi_{H}(\mathrm{t} / \mathrm{v})^{p}-(\mathrm{t} / \mathrm{v}) \Phi_{H}(\mathrm{t} / \mathrm{v})^{p-1} \Phi_{H}^{\prime}(\mathrm{t} / \mathrm{v})\right\} \int_{\Omega} u^{p^{\star}-1} \varphi \\
= & \left(\sigma-\mathrm{v}^{p-p^{\#}} \sigma_{H}(\mathrm{t} / \mathrm{v})\right) \int_{\partial \Omega} u^{p^{\#}-1} \varphi+\left(\lambda-\mathrm{v}^{p-p^{\star}} \lambda_{H}(\mathrm{t} / \mathrm{v})\right) \int_{\Omega} u^{p^{\star}-1} \varphi .
\end{aligned}
$$

Testing with $\varphi \in C_{c}^{\infty}(\Omega)$ we find $\lambda=\mathrm{v}^{p-p^{\star}} \lambda_{H}(\mathrm{t} / \mathrm{v})$, and testing with $\varphi=1$ on $\bar{\Omega}$ then gives $\sigma=\mathrm{v}^{p-p^{\#}} \sigma_{H}(\mathrm{t} / \mathrm{v})$. We finally prove (4.4), i.e. $\mathrm{t} / \mathrm{v} \notin\left[T_{0}, T_{E}\right]$. Indeed, combining the balance condition (2.16) with (4.3) we find

$$
\begin{equation*}
\mathrm{v}^{p-p^{\star}} \lambda_{H}(\mathrm{t} / \mathrm{v}) \int_{\Omega} u^{p^{\star}-1}+\mathrm{v}^{p-p^{\#}} \sigma_{H}(\mathrm{t} / \mathrm{v}) \int_{\partial \Omega} u^{p^{\#-1}}=0 \tag{4.12}
\end{equation*}
$$

where by (3.11) and (3.12) we have $\lambda_{H}>0$ in $\left[T_{0}, T_{E}\right)$ and $\sigma_{H}>0$ on $\left(T_{0}, T_{E}\right]$ (with $\lambda_{H}\left(T_{E}\right)=\sigma_{H}\left(T_{0}\right)=0$ by continuity). If $\mathrm{t} / \mathrm{v} \in\left[T_{0}, T_{E}\right)$, then (4.12) implies $\int_{\Omega} u^{p^{\star}}=0$, a contradiction; if $\mathrm{t} / \mathrm{v}=T_{E}$, then (4.12) gives $u=0$ on $\partial \Omega$, so that, by (4.1), $u$ is a minimizer of $\Phi_{\Omega}(0)$, and thus $u$ is optimal in the Sobolev inequality on $\mathbb{R}^{n}$, so that $\Omega=\mathbb{R}^{n}$, contradicting the fact that $\Omega$ is bounded.

We are now ready to prove Theorem 1.1.
Proof of Theorem 1.1. Statement (i) is an immediate consequence of Theorem 4.1. We thus focus on statement (ii), and assume that $\Omega$ is of class $C^{2}$ and that $n>2 p$. We want to prove that if $(u, v, \mathrm{t})$ is a minimizer of $\Phi_{\Omega}^{*}(T)$, then $\mathrm{v}=\mathrm{t}=0$. We assume by way of contradiction that either $\mathrm{v}>0$ or $\mathrm{t}>0$; recalling the definition of $\mathcal{Y}_{\Omega}(T)$, this implies that $\mathrm{v}>0$ and $\mathrm{t}>0$. We apply Lemma 3.4 (ii) with the choice $(v, T)=(u / \mathrm{v}, \tau)$ at a point $x_{0} \in \partial \Omega$ of positive mean curvature, noting that if $\mathrm{v}=1$ then $v \equiv 0$ and that $v$ is

Lipschitz continuous if $v \in(0,1)$ thanks to (4.1) and Lemma 2.5. Then, for every $U \in \mathcal{U}_{\tau}$, we have

$$
\begin{align*}
& \int_{\Omega}\left|\nabla v_{\varepsilon}\right|^{p} \leq \int_{H}|\nabla U|^{p}+\int_{\Omega}|\nabla v|^{p}-\mathrm{H}_{\partial \Omega}(0) \mathcal{L}(U) \varepsilon+\mathrm{o}(\varepsilon)  \tag{4.13}\\
& \int_{\Omega} v_{\varepsilon}^{p^{\star}}=\int_{H} U^{p^{\star}}+\int_{\Omega} v^{p^{\star}}-\mathrm{H}_{\partial \Omega}(0) \mathcal{M}(U) \varepsilon+\mathrm{o}(\varepsilon)  \tag{4.14}\\
& \int_{\partial \Omega} v_{\varepsilon}^{p^{\#}}=\int_{\partial H} U^{p^{\#}}+\int_{\partial \Omega} v^{p^{\#}}+\mathrm{o}(\varepsilon) \tag{4.15}
\end{align*}
$$

where $\mathcal{L}(U)$ and $\mathcal{M}(U)$ are defined in (3.46) and (1.29). We apply this with $U \in \mathcal{U}_{\tau}$ given by

$$
U=U_{\tau}+b \varepsilon V_{\tau}, \quad|\varepsilon|<\frac{1}{|b|}, \quad b=\frac{\mathrm{H}_{\partial \Omega}(0) \mathcal{M}\left(U_{\tau}\right)}{p^{\star}}
$$

The reason for the choice of $b$ will become apparent in a moment. Indeed, thanks to (3.26), (3.27) and (3.28), we have

$$
\begin{aligned}
& \int_{H}|\nabla U|^{p}=\Phi_{H}(\tau)^{p}+p b \lambda_{H}(\tau) \varepsilon+\mathrm{o}(\varepsilon) \\
& \int_{H} U^{p^{\star}}=1+p^{\star} b \varepsilon+\mathrm{o}(\varepsilon), \quad \int_{\partial H} U^{p^{\#}}=\tau^{p^{\#}}
\end{aligned}
$$

which, combined with $(4.13),(4.14),(4.15)$ and

$$
\frac{\Phi_{\Omega}(T)^{p}}{\mathrm{v}^{p}}=\Phi_{H}(\tau)^{p}+\int_{\Omega}|\nabla v|^{p}, \quad \frac{1}{\mathrm{v}^{p^{\star}}}=1+\int_{\Omega} v^{p^{\star}}, \quad(T / \mathrm{v})^{p^{\#}}=\tau^{p^{\#}}+\int_{\partial \Omega} v^{p^{p^{\#}}}
$$

implies that $w_{\varepsilon}=\vee v_{\varepsilon}$ satisfies

$$
\begin{align*}
& \int_{\Omega}\left|\nabla w_{\varepsilon}\right|^{p} \leq \Phi_{\Omega}(T)^{p}+\left\{p b \lambda_{H}(\tau)-\mathrm{H}_{\partial \Omega}(0) \mathcal{L}(U)\right\} \mathrm{v}^{p} \varepsilon+\mathrm{o}(\varepsilon)  \tag{4.16}\\
& \int_{\Omega} w_{\varepsilon}^{p^{\star}}=1+\left\{p^{\star} b-\mathrm{H}_{\partial \Omega}(0) \mathcal{M}(U)\right\} \mathrm{v}^{p^{\star}} \varepsilon+\mathrm{o}(\varepsilon)=1+\mathrm{o}(\varepsilon)  \tag{4.17}\\
& \int_{\partial \Omega} w_{\varepsilon}^{p^{\#}}=T^{p^{\#}}+\mathrm{o}(\varepsilon) \tag{4.18}
\end{align*}
$$

where in (4.16) we have used the choice of $b$ to deduce

$$
\mathcal{M}(U)=\mathcal{M}\left(U_{\tau}\right)+p^{\star} \int_{H} x_{n} U_{\tau}^{p^{\star}-1} V_{\tau} b \varepsilon+\mathrm{o}(\varepsilon), \quad\left\{p^{\star} b-\mathrm{H}_{\partial \Omega}(0) \mathcal{M}(U)\right\} \varepsilon=\mathrm{o}(\varepsilon)
$$

In the same spirit, by

$$
\lim _{\varepsilon \rightarrow 0^{+}}\left|\mathcal{L}\left(U_{\tau}+b \varepsilon V_{\tau}\right)-\mathcal{L}\left(U_{\tau}\right)\right|=0
$$

we deduce from (4.16) that

$$
\begin{align*}
\int_{\Omega}\left|\nabla w_{\varepsilon}\right|^{p} & \leq \Phi_{\Omega}(T)^{p}-\left\{\mathcal{L}\left(U_{\tau}\right)-\frac{(n-p)}{n} \mathcal{M}\left(U_{\tau}\right) \lambda_{H}(\tau)\right\} \mathrm{H}_{\partial \Omega}(0) \mathrm{v}^{p} \varepsilon+\mathrm{o}(\varepsilon)  \tag{4.19}\\
& \leq \Phi_{\Omega}(T)^{p}-C(n, p, \tau) \mathrm{H}_{\partial \Omega}(0) \mathrm{v}^{p} \varepsilon+\mathrm{o}(\varepsilon)
\end{align*}
$$

where in the second line we apply Lemma 3.1. We thus conclude that

$$
\begin{equation*}
\int_{\Omega}\left|\nabla w_{\varepsilon}\right|^{p} \leq \int_{\Omega}|\nabla u|^{p}+\mathrm{v}^{p} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p}-M \mathrm{v}^{p} \varepsilon+\mathrm{o}(\varepsilon) \tag{4.20}
\end{equation*}
$$

It remains to modify the functions $w_{\varepsilon}$ to obtain $w_{\varepsilon}^{*} \in \mathcal{X}_{\Omega}(T)$ also satisfying (4.20), allowing us to conclude the proof of the theorem by choosing $\varepsilon$ sufficiently small. We will distinguish between two cases, applying Lemma 2.6 in different ways in the two cases.
Case one: Suppose first that $\mathrm{v}<1$ and thus $\int_{\Omega} u^{p^{\star}}>0$. This also implies that $\int_{\partial \Omega} u^{p^{\#}}>0$ by Theorem 4.1-(iii). Taking into account (4.17) and (4.18), we can thus apply Lemma 2.6
in an analogous way to step one of the proof of Theorem 4.1 in order to slightly modify $w_{\varepsilon}$ into $w_{\varepsilon}^{*} \in \mathcal{X}_{\Omega}(T)$ with

$$
\begin{aligned}
& \Phi_{\Omega}(T)^{p} \leq \int_{\Omega}\left|\nabla w_{\varepsilon}^{*}\right|^{p}=\int_{\Omega}\left|\nabla w_{\varepsilon}\right|^{p}+\left(\mathrm{v}^{p^{\#}}+\mathrm{v}^{p^{\star}}\right) \mathrm{o}(\varepsilon) \\
& \leq \int_{\Omega}|\nabla u|^{p}+\mathrm{v}^{p} \Phi_{H}(\mathrm{t} / \mathrm{v})^{p}-\frac{M}{2} \mathrm{v}^{p} \varepsilon=\Phi_{\Omega}(T)^{p}-\frac{M}{2} \mathrm{v}^{p} \varepsilon<\Phi_{\Omega}(T)^{p}
\end{aligned}
$$

thus reaching a contradiction.
Case two: Next, suppose that $\mathrm{v}=1$. So, $\Phi_{\Omega}(T)=\Phi_{H}(T), u=v \equiv 0$ and $v_{\varepsilon}=\varphi_{\varepsilon}\left(U^{(\varepsilon)} \circ g\right)$. In this case, we will pull the relevant quantities back to the half space $H$ and apply Lemma 2.6 there to correct the volume and trace constraints. More specifically, for $\varepsilon<\varepsilon_{0}$, the support of $\varphi_{\varepsilon}$ is entirely contained in the domain of the diffeomorphism $f_{x_{0}}$, and so we can define $\Psi_{\varepsilon}: H \rightarrow \mathbb{R}$ by $\Psi_{\varepsilon}(y)=\varphi_{\varepsilon} \circ f(\varepsilon y)$. In this way, we can rewrite

$$
w_{\varepsilon}=v_{\varepsilon}=\left(\Psi_{\varepsilon} U\right)^{(\varepsilon)} \circ g
$$

Thanks to (2.13), $\Psi_{\varepsilon}$ is identically equal to one in $B_{\varepsilon^{\beta-1} / C} \cap H$ and vanishes outside of $B_{C \varepsilon^{\beta-1}} \cap H$. Using the area formula, we rewrite (4.17), (4.18), and (4.20) as

$$
\begin{gathered}
\int_{H}\left(\Psi_{\varepsilon} U\right)^{p^{\star}} m_{\varepsilon}=\int_{\Omega} w_{\varepsilon}^{p^{\star}} d x=1+o(\varepsilon) \\
\int_{\partial H}\left(\Psi_{\varepsilon} U\right)^{p^{\sharp}} \hat{m}_{\varepsilon}=\int_{\partial \Omega} w_{\varepsilon}^{p^{\sharp}}=T^{p^{\sharp}}+o(\varepsilon) . \\
\int_{H}\left|A_{\varepsilon}\left[\nabla\left(\Psi_{\varepsilon} U\right)\right]\right|^{p} m_{\varepsilon}=\int_{\Omega}\left|\nabla w_{\varepsilon}\right|^{p} \leq \Phi_{H}(T)-M \varepsilon+o(\varepsilon),
\end{gathered}
$$

where we have set

$$
m_{\varepsilon}(x)=J f(\varepsilon x), \quad \hat{m}_{\varepsilon}(x)=J^{\partial H} f(\varepsilon x), \quad A_{\varepsilon}(x)=(\nabla g \circ f(\varepsilon x))^{*}
$$

We now repeat the argument used in the proof of Lemma 2.6: exploiting the fact that

$$
\begin{equation*}
\Psi_{\varepsilon} U=U_{T} \quad \text { on }\left(H \cap B_{R}\right) \backslash\left(\operatorname{spt} V_{T}\right), \quad R=\frac{\varepsilon_{0}^{\beta-1}}{C} \tag{4.21}
\end{equation*}
$$

as well as that both $\int_{H}\left(\Psi_{\varepsilon} U\right)^{p^{\star}} m_{\varepsilon}$ and $\int_{\partial H}\left(\Psi_{\varepsilon} U\right)^{p^{\sharp}} \hat{m}_{\varepsilon}$ are positive and finite, we can easily find $\psi \in C_{c}^{\infty}\left(\left(H \cap B_{R}\right) \backslash\left(\operatorname{spt} V_{T}\right)\right)$ and $\varphi \in C_{c}^{\infty}\left(\left(\mathbb{R}^{n} \cap B_{R}\right) \backslash\left(\operatorname{spt} V_{T}\right)\right)$ such that

$$
\begin{align*}
\int_{H}\left(\Psi_{\varepsilon} U_{T}\right)^{p^{\star}-1} m_{\varepsilon} \psi & =\int_{\partial H}\left(\Psi_{\varepsilon} U_{T}\right)^{p^{\#}-1} \hat{m}_{\varepsilon} \varphi=1  \tag{4.22}\\
\int_{H}\left(\Psi_{\varepsilon} U_{T}\right)^{p^{\star}-1} m_{\varepsilon} \varphi & =\int_{\partial H}\left(\Psi_{\varepsilon} U_{T}\right)^{p^{\#}-1} \hat{m}_{\varepsilon} \psi=0
\end{align*}
$$

Correspondingly, we consider the maps $h_{\varepsilon}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ by

$$
h_{\varepsilon}(s, t)=\left(\int_{\partial H}\left(\left|v_{\varepsilon}+s \varphi+t \psi\right|^{p^{\#}}-\left|v_{\varepsilon}\right|^{p^{\#}}\right) \hat{m}_{\varepsilon}, \int_{H}\left(\left|v_{\varepsilon}+s \varphi+t \psi\right|^{p^{\star}}-\left|v_{\varepsilon}\right|^{p^{\star}}\right) m_{\varepsilon}\right)
$$

By (4.21), $h_{\varepsilon} \in C^{1, \alpha}\left(\mathbb{R}^{2} ; \mathbb{R}^{2}\right)$ for some $\alpha=\alpha(n, p) \in(0,1)$, with

$$
\sup _{\varepsilon<\varepsilon_{0}}\left\|h_{\varepsilon}\right\|_{C^{1, \alpha}\left(\mathbb{R}^{2} ; \mathbb{R}^{2}\right)}<\infty
$$

moreover, $h_{\varepsilon}(0,0)=0$ and, by (4.22),

$$
\nabla h_{\varepsilon}(0,0)=\left(\begin{array}{cc}
p^{\#} & 0 \\
0 & p^{\star}
\end{array}\right)
$$

We can thus apply the inverse function theorem uniformly in $\varepsilon$, to obtain functions $W_{\varepsilon}^{*}$ : $H \rightarrow \mathbb{R}$ with support in $B_{C \varepsilon^{\beta-1}}$ such that

$$
\begin{gather*}
\int_{H}\left(W_{\varepsilon}^{*}\right)^{p^{*}} m_{\varepsilon}=1, \quad \int_{\partial H}\left(W_{\varepsilon}^{*}\right)^{p^{\sharp}} \hat{m}_{\varepsilon}=T^{p^{\sharp}}, \\
\left.\left|\int_{H}\right| A_{\varepsilon}\left[\nabla\left(\Psi_{\varepsilon} U\right)\right]\right|^{p} m_{\varepsilon}-\int_{H}\left|A_{\varepsilon}\left[\nabla W_{\varepsilon}^{*}\right]\right|^{p} m_{\varepsilon} \mid=o(\varepsilon) . \tag{4.23}
\end{gather*}
$$

Finally, for $\varepsilon<\varepsilon_{0}$, define $w_{\varepsilon}^{*}: \Omega \rightarrow \mathbb{R}$ by $w_{\varepsilon}^{*}=\left(W_{\varepsilon}^{*}\right)^{(\varepsilon)} \circ g$. Changing variables once again, (4.23) tells us that $w_{\varepsilon} \in \mathcal{X}_{\Omega}(T)$ and that

$$
\begin{aligned}
\Phi_{\Omega}(T)^{p} & \leq \int_{\Omega}\left|\nabla w_{\varepsilon}^{*}\right|^{p}=\int_{\Omega}\left|\nabla w_{\varepsilon}\right|^{p}+o(\varepsilon) \\
& \leq \Phi_{H}(T)^{p}-M \varepsilon+\mathrm{o}(\varepsilon) \leq \Phi_{H}(T)^{p}-\frac{M \varepsilon}{2}<\Phi_{H}(T)=\Phi_{\Omega}(T)
\end{aligned}
$$

giving us a contradiction in this case as well. This completes the proof of the theorem.

## 5. Rigidity theorems for Best Sobolev inequalities

In this section, we prove Theorem 1.3.
Proof of Theorem 1.3. Rigidity under assumption (ii) is immediate by combining Theorem 1.1-(ii) with (1.23) and (1.24). Let us now consider assumption (i), namely, there is $T_{*}>0$ such that

$$
\begin{equation*}
\Phi_{\Omega}(T)=\Phi_{B}(T) \quad \forall T \in\left(0, T_{*}\right) \tag{5.1}
\end{equation*}
$$

Without loss of generality we can assume that $T_{*}<\operatorname{ISO}(B)^{1 / p^{\#}}$. We argue by contradiction and assume that $\Omega$ is not a ball.

By Theorem 4.1, for every $T>0$ there is $\left(u_{T}, \mathrm{v}_{T}, \mathrm{t}_{T}\right)$ a minimizer of $\Phi_{\Omega}^{*}(T)$. The basic idea of the proof will be to show that the trace-to-volume ratio of $u_{T}$ must be, on one hand, uniformly positive and, on the other hand, tending to zero as $T \rightarrow 0$, giving us a contradiction. Since $\Omega$ is connected and is not a ball by assumption, the rigidity criterion (1.23) together with (1.24) and (5.1) tell us that a classical minimizer for $\Phi_{\Omega}(T)$ cannot exist for $T \in\left(0, T_{*}\right)$, and so we immediately deduce that $\mathrm{v}_{T}<1$ for all such $T$. In other words, if we set

$$
\nu_{T}=\left(1-\mathrm{v}_{T}^{p^{\star}}\right)^{1 / p^{\star}}=\left\|u_{T}\right\|_{L^{p^{\star}}(\Omega)}, \quad \tau_{T}=\left(T^{p^{\#}}-\mathrm{t}^{p^{\#}}\right)^{1 / p^{\#}}=\|u\|_{L^{p^{\#}}(\partial \Omega)}
$$

then $\nu_{T}>0$ for all $T \in\left(0, T_{*}\right)$. So, Theorem 4.1-(iii) implies that

$$
\begin{equation*}
u_{T} / \nu_{T} \text { is a minimizer of } \Phi_{\Omega}\left(\tau_{T} / \nu_{T}\right) . \tag{5.2}
\end{equation*}
$$

In particular, this means that

$$
\begin{equation*}
\frac{\tau_{T}}{\nu_{T}} \geq T_{*} \quad \text { for all } T \in\left(0, T_{*}\right) \tag{5.3}
\end{equation*}
$$

since as we noted above, no minimizer of $\Phi_{\Omega}(\tilde{T})$ can exist for $\tilde{T}=\tau_{T} / \nu_{T}<T_{*}$. Since $T \geq \tau_{T}$, (5.3) tells us that $T / \nu_{T} \geq T_{*}$; rearranging this inequality gives us the following lower bound on $\mathrm{v}_{T}$ :

$$
\begin{equation*}
\mathrm{v}_{T}^{p^{\star}} \geq 1-\left(T / T_{*}\right)^{p^{\star}} \quad \forall T \in\left(0, T_{*}\right) \tag{5.4}
\end{equation*}
$$

From this, an upper bound on the ratio $\mathrm{t}_{T} / \mathrm{v}_{T}$ follows immediately:

$$
\begin{equation*}
\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}} \leq\left(1-\left(T / T_{*}\right)^{p^{\star}}\right)^{-1 / p^{\star}} T \quad \forall T \in\left(0, T_{*}\right) \tag{5.5}
\end{equation*}
$$

In particular $\mathrm{t}_{T} / \mathrm{v}_{T} \rightarrow 0$ as $T \rightarrow 0^{+}$.

On the other hand, we will now use the Euler-Lagrange equation for $u_{T}$ to show that

$$
\begin{equation*}
\lim _{T \rightarrow 0^{+}} \frac{\tau_{T}}{\nu_{T}}=0 \tag{5.6}
\end{equation*}
$$

which is a clear contradiction to (5.3). Indeed, by Theorem 4.1-(iii) and (5.2), $u_{T}$ satisfies the Euler-Lagrange equation

$$
\begin{cases}-\Delta_{p} u_{T}=\mathrm{v}_{T}^{p-p^{\star}} \lambda_{H}\left(\mathrm{t}_{T} / \mathrm{v}_{T}\right) u_{T}^{p^{\star}-1} & \text { on } \Omega  \tag{5.7}\\ \left|\nabla u_{T}\right|^{p-2} \frac{\partial u}{\partial \nu_{\Omega}}=\mathrm{v}_{T}^{p-p^{\#}} \sigma_{H}\left(\mathrm{t}_{T} / \mathrm{v}_{T}\right) u_{T}^{p^{\#}-1} & \text { on } \partial \Omega\end{cases}
$$

see (4.2), (4.3) and (3.7) (for the definition of $\lambda_{H}(T)$ and $\left.\sigma_{H}(T)\right)$. Testing (5.7) with $u_{T}$, we find that

$$
\begin{aligned}
\int_{\Omega}\left|\nabla u_{T}\right|^{p} & =\mathrm{v}_{T}^{p-p^{\star}} \lambda_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right) \int_{\Omega} u_{T}^{p^{\star}}+\mathrm{v}_{T}^{p-p^{\#}} \sigma_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right) \int_{\partial \Omega} u_{T}^{p^{\#}} \\
& =\mathrm{v}_{T}^{p-p^{\star}} \lambda_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right) \nu_{T}^{p^{\star}}+\mathrm{v}_{T}^{p-p^{\#}} \sigma_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right) \tau_{T}^{p^{\#}}
\end{aligned}
$$

After rearranging and multiplying through by $\mathrm{v}_{T}^{p^{\sharp}-p} \nu_{T}^{-p^{\sharp}}>0$, we arrive at the inequality

$$
\begin{equation*}
-\sigma_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right)\left(\frac{\tau_{T}}{\nu_{T}}\right)^{p^{\#}} \leq \lambda_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right)\left(\frac{\nu_{T}}{\mathrm{v}_{T}}\right)^{p^{\star}-p^{\#}} \tag{5.8}
\end{equation*}
$$

By (3.12) and the continuity of $T \mapsto \lambda_{H}(T)$, there are $C>0$ and $T_{* *}>0$ such that $\lambda_{H}(T) \in(1 / C, C)$ for every $T \in\left(0, T_{* *}\right)$. Moreover, thanks to (5.4), we can ask that $\mathrm{v}_{T} \geq 1 / C$ for $T \in\left(0, T_{* *}\right)$. In particular, by (5.5) and up to further increasing $C$, if $T<1 / C$, then $\mathrm{t}_{T} / \mathrm{v}_{T}<T_{* *}$ and thus (5.8), $\nu_{T} \leq 1$ and $\mathrm{v}_{T} \geq 1 / C$ give

$$
\begin{equation*}
-\sigma_{H}\left(\frac{\mathrm{t}_{T}}{\mathrm{v}_{T}}\right)\left(\frac{\tau_{T}}{\nu_{T}}\right)^{p^{\#}} \leq C \tag{5.9}
\end{equation*}
$$

By (3.11) and the fact that $\mathrm{t}_{T} / \mathrm{v}_{T} \rightarrow 0$ as $T \rightarrow 0$, we see that $\sigma_{H}(T) \rightarrow-\infty$ as $T \rightarrow 0^{+}$, so that (5.9) implies (5.6). We reach a contradiction to (5.3), completing the proof.

## Appendix A. Proof of Lemma 2.1

We will use the Brezis-Lieb lemma (if $(X, \mu)$ is a measure space, $q \geq 1$, and $\left\{f_{j}\right\}_{j}$ is bounded in $L^{q}(X)$, then

$$
\begin{equation*}
\int_{X}|f|^{q} d \mu=\lim _{j \rightarrow \infty} \int_{X}\left|f_{j}\right|^{q} d \mu-\int_{X}\left|f_{j}-f\right|^{q} d \mu \tag{A.1}
\end{equation*}
$$

provided $f$ is a $\mu$-a.e. limit of $\left\{f_{j}\right\}_{j}$ on $X$ ), and the two Sobolev-type inequalities

$$
\begin{align*}
\|u\|_{L^{p^{\star}}(\Omega)} & \leq C_{1}\left(\|\nabla u\|_{L^{p}(\Omega)}+\|u\|_{L^{p}(\Omega)}\right)  \tag{A.2}\\
\|u\|_{L^{p^{\#}}(\partial \Omega)} & \leq C_{2}\left(\|\nabla u\|_{L^{p}(\Omega)}+\|u\|_{L^{p}(\Omega)}\right) \tag{A.3}
\end{align*}
$$

which are valid, with constants $C_{1}$ and $C_{2}$ depending on $n, p$ and $\Omega$ only, as soon as $\Omega$ is bounded and has Lipschitz boundary.

Proof of Lemma 2.1. Step one: Since $\Omega$ is a bounded open set with Lipschitz boundary, $u_{j} \rightharpoonup u$ as distributions in $\Omega$, and $\left\{\nabla u_{j}\right\}_{j}$ is bounded in $L^{p}(\Omega)$, standard considerations show that $u \in W^{1, p}(\Omega),\left\{u_{j}\right\}_{j}$ is bounded in $L^{p^{\star}}(\Omega)$ and in $L^{p^{\#}}(\partial \Omega)$, and, up to extracting subsequences, $u_{j} \rightarrow u$ in $L^{q}(\Omega)$ for every $q \in\left[1, p^{\star}\right), u_{j} \rightarrow u$ in $L^{r}(\partial \Omega)$ for every $r<p^{\#}$, $u_{j} \rightarrow u$ pointwise $\mathcal{L}^{n}$-a.e. on $\Omega$ and $\mathcal{H}^{n-1}$-a.e. on $\partial \Omega$, and that the sequences of Radon measures $\left\{\nu_{j}\right\}_{j},\left\{\tau_{j}\right\}_{j}$ and $\left\{\mu_{j}\right\}_{j}$ defined in (2.1) admits weak-* limits $\nu, \tau$ and $\mu$, with $\operatorname{spt} \nu$ and $\operatorname{spt} \mu$ contained in $\bar{\Omega}$, and $\operatorname{spt} \tau$ contained in $\partial \Omega$.

Step two: We let $\tilde{\mu}$ denote the weak-* limit of $\left|\nabla\left(u_{j}-u\right)\right|^{p} \mathcal{L}^{n}\llcorner\Omega$ (which exists up to possibly extracting a further subsequence), and claim that $\tilde{\mu}(\{x\})=\mu(\{x\})$ for every $x \in \mathbb{R}^{n}$. Indeed, by the elementary inequality

$$
\left||v+w|^{p}-|w|^{p}\right| \leq \varepsilon|v|^{p}+C(p, \varepsilon)|w|^{p}, \quad v, w \in \mathbb{R}^{n}, \varepsilon>0,
$$

given $x \in \mathbb{R}^{n}$ and $r>0$ we see that

$$
\left.\left|\int_{B_{r}(x)}\right| \nabla u_{j}\right|^{p}-\left.\int_{B_{r}(x)}\left|\nabla\left(u_{j}-u\right)\right|^{p}\left|\leq \varepsilon \int_{B_{r}(x)}\right| \nabla\left(u_{j}-u\right)\right|^{p}+C(p, \varepsilon) \int_{B_{r}(x)}|\nabla u|^{p},
$$

so that letting first $j \rightarrow \infty$ (for $r>0$ such that $\mu\left(\partial B_{r}(x)\right)=\tilde{\mu}\left(\partial B_{r}(x)\right)=0$ ) and then $r \rightarrow 0^{+}$(along a generic sequence of radii), we find indeed $|\mu(\{x\})-\tilde{\mu}(\{x\})| \leq \varepsilon \tilde{\mu}(\{x\})$ for every $\varepsilon>0$.

Step three: If now pick $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ and set $\tilde{\nu}=\nu-|u|^{p^{*}} \mathcal{L}^{n}\llcorner\Omega$ (notice that, by lower semicontinuity, $\tilde{\nu}$ is a Radon measure), then, by exploiting, in order, $\nu_{j} \stackrel{*}{\rightharpoonup} \nu$, (A.1), (A.2), and $u_{j} \rightarrow u$ in $L^{p}(\Omega)$, we find

$$
\begin{aligned}
& \int_{\mathbb{R}^{n}}|\eta|^{p^{\star}} d \tilde{\nu} \leq \liminf _{j \rightarrow \infty} \int_{\Omega}|\eta|^{p^{\star}}\left(\left|u_{j}\right|^{p^{\star}}-|u|^{p^{\star}}\right)=\lim _{j \rightarrow \infty} \int_{\Omega}\left|\eta\left(u_{j}-u\right)\right|^{p^{\star}} \\
& \leq C_{1}^{p^{\star}} \lim _{j \rightarrow \infty}\left(\left\|\nabla\left(\eta\left(u_{j}-u\right)\right)\right\|_{L^{p}(\Omega)}+\left\|\eta\left(u_{j}-u\right)\right\|_{L^{p}(\Omega)}\right)^{p^{\star}} \\
& =C_{1}^{p^{\star}} \lim _{j \rightarrow \infty}\left\|\nabla\left(\eta\left(u_{j}-u\right)\right)\right\|_{L^{p}(\Omega)}^{p^{\star}}=C_{1}^{p^{\star}} \lim _{j \rightarrow \infty}\left\|\eta \nabla\left(u_{j}-u\right)\right\|_{L^{p}(\Omega)}^{p^{\star}} \\
& \leq C_{1}^{p^{\star}}\left(\int_{\mathbb{R}^{n}}|\eta|^{p} d \tilde{\mu}\right)^{p^{\star} / p} .
\end{aligned}
$$

In particular, for every $x \in \mathbb{R}^{n}$ one has

$$
\begin{equation*}
\tilde{\nu}\left(B_{r}(x)\right) \leq C_{1}^{p^{\star}} \tilde{\mu}\left(B_{r}(x)\right)^{p^{\star} / p} \quad \text { for a.e. } r>0 . \tag{A.4}
\end{equation*}
$$

By (A.4), $\tilde{\nu}$ is absolutely continuous with respect to $\tilde{\mu}$, so that $\tilde{\nu}=f \tilde{\mu}$ where $f$ is such that, for $\tilde{\mu}$-a.e. $x \in \mathbb{R}^{n}$,

$$
f(x)=\lim _{r \rightarrow 0^{+}} \frac{\tilde{\nu}\left(B_{r}(x)\right)}{\tilde{\mu}\left(B_{r}(x)\right)} ;
$$

in particular, again by (A.4), for $\tilde{\mu}$-a.e. $x \in \mathbb{R}^{n}$ we have

$$
f(x) \leq C_{1}^{p^{\star}} \lim _{r \rightarrow 0^{+}} \tilde{\mu}\left(B_{r}(x)\right)^{\left(p^{\star} / p\right)-1}=C_{1}^{p^{\star}} \mu(\{x\})^{\left(p^{\star} / p\right)-1} .
$$

In particular, as $p^{\star}>p$, if $X=\left\{x \in \mathbb{R}^{n}: \mu(\{x\})>0\right\}=\left\{x_{i}\right\}_{i \in I} \subset \bar{\Omega}(I$ at most countable) denotes the set of atoms of $\mu$, then $f(x)=0 \mu$-a.e. on $\mathbb{R}^{n} \backslash X$, and we have proved that

$$
\begin{equation*}
\operatorname{spt} \tilde{\nu} \subset\left\{x_{i}\right\}_{i \in I} . \tag{A.5}
\end{equation*}
$$

An entirely analogous argument, this time based on (A.3) rather than on (A.2), shows that, if $\tilde{\tau}=\tau-|u|^{p^{\#}} \mathcal{H}^{n-1}\llcorner\partial \Omega$, then

$$
\begin{equation*}
\operatorname{spt} \tilde{\tau} \subset\left\{x_{i}\right\}_{i \in I} \cap \partial \Omega . \tag{A.6}
\end{equation*}
$$

We have thus proved the validity of (2.2), (2.3) and (2.4) for suitable $\mathrm{v}_{i}, \mathrm{t}_{i} \geq 0$ and $\mathrm{g}_{i}>0$ : and of course we can discard possible points $x_{i}$ with $\mathrm{v}_{i}=0$ from these decompositions, and directly assume that $\mathrm{v}_{i}>0$ for every $i$. The fact that $\mathrm{g}_{i} \geq S \mathrm{v}_{i}$ if $x_{i} \in \Omega$ is immediate by repeating the above argument with arbitrary $\eta \in C_{c}^{\infty}(\Omega)$ (in which case $C_{1}$ can be replaced by $1 / S)$. An analogous argument, this time using Lemma 2.2 , shows that $\mathrm{g}_{i} \geq \mathrm{v}_{i} \Phi_{H}\left(\mathrm{t}_{i} / \mathrm{v}_{i}\right)$ if $x_{i} \in \partial \Omega$.

## Appendix B. Proof of Lemmas 2.2 and 2.3

This section is dedicated to the proof of Lemmas 2.2 and 2.3. We recall the standard Taylor expansions for the inverse and determinant of a matrix that is a perturbation of the identity:

$$
\begin{align*}
\left(\operatorname{Id}_{\mathbb{R}^{n}}+t A\right)^{-1} & =\operatorname{Id}_{\mathbb{R}^{n}}-t A+O\left(t^{2}\right)  \tag{B.1}\\
\operatorname{det}\left(\operatorname{Id}_{\mathbb{R}^{n}}+t A\right) & =1+t \operatorname{trace} A+O\left(t^{2}\right) \tag{B.2}
\end{align*}
$$

see for instance [Mag12, Lemma 17.4].
Proof of Lemma 2.2. Note that $\hat{f}$ can equivalently be written as $\hat{f}(x)=x+\ell(\mathbf{p}(x)) e_{n}$. We directly see that $\hat{f}$ maps $C^{1}$-diffeomorphically onto its image with inverse $\hat{g}(y)=$ $y-\ell(\mathbf{p}(y)) x_{n}$ and (2.10) holds because $\ell(0)=|\nabla \ell(0)|=0$ and $\ell$ is $C^{1}$. We compute, in the standard basis for $\mathbb{R}^{n}$, that

$$
\nabla \hat{f}\left(\mathbf{p}(x), x_{n}\right)=\left(\begin{array}{cc}
I d & 0 \\
\nabla \ell(\mathbf{p}(x)) & 1
\end{array}\right)=I d+\left(\begin{array}{cc}
0 & 0 \\
\nabla \ell(\mathbf{p}(x)) & 0
\end{array}\right)
$$

Since $\ell$ is $C^{1}$ with $\nabla \ell(0)=0$, this gives the first estimate in (2.11). The second estimate in (2.11) follows in the same way using the explicit form of $g$ above. The first estimate in (2.12) follows from (B.2) and the expression for $\nabla \hat{f}$ above. The second estimate in (2.12) follows because $\hat{f}=F$ on $\mathbf{D}_{r_{0}}$ (compare with (2.7)), and so

$$
J^{\partial H} \hat{f}=J^{\partial H} F=\sqrt{1+|\nabla \ell|^{2}}
$$

This completes the proof of the lemma.
Proof of Lemma 2.3. Step one: We compute some geometric quantities for $\partial \Omega$ using the graphical coordinates defined by the map $F$ given in (2.7). We start with first order quantities. For $x \in \mathbf{D}_{r_{0}}$ and $i=1, \ldots, n-1$, we set $\tau_{i}:=d F_{x}\left(e_{i}\right)$, i.e.,

$$
\begin{equation*}
\tau_{i}=\partial_{i} F(x)=e_{i}+\partial_{i} \ell(x) e_{n} \tag{B.3}
\end{equation*}
$$

so that $\left\{\tau_{1}, \ldots, \tau_{n-1}\right\}$ forms a basis for $T_{F(x)} \partial \Omega$. Since $\ell$ is $C^{2}$ and $\nabla \ell(x)=0$, we have

$$
\begin{equation*}
g_{i j}=\left\langle\tau_{i}, \tau_{j}\right\rangle_{\mathbb{R}^{n}}=\delta_{i j}+\partial_{i} \ell \partial_{j} \ell=\delta_{i j}+\mathrm{O}\left(|x|^{2}\right) \tag{B.4}
\end{equation*}
$$

In other words, the metric coefficients in graphical coordinates are Euclidean up to second order in $|x|$. The volume measure of $\partial \Omega$ is given by

$$
J^{\partial H} F=\sqrt{\operatorname{det} g_{i j}}=\sqrt{1+|\nabla \ell|^{2}} ;
$$

this immediately gives the second estimate in (2.14) since $f=F$ for $x \in \mathbf{D}_{r_{0}}$. The inverse metric coefficients are

$$
\begin{equation*}
g^{i j}=\delta^{i j}+\frac{\delta^{i a} \delta^{i b} \partial_{a} \ell \partial_{b} \ell}{1+|\nabla \ell|^{2}} \delta^{i j}+O\left(|x|^{2}\right) \tag{B.5}
\end{equation*}
$$

Recall that, without loss of generality, we have chosen an orthonormal basis for $\mathbb{R}^{n-1} \subset \mathbb{R}^{n}$ that diagonalizes the Hessian of $\ell$ at $x=0$. Let $\left\{\kappa_{1}, \ldots, \kappa_{n-1}\right\}$ denote the eigenvalues. The second fundamental form of $\partial \Omega$ at $x$ is defined by $A_{x}(v, w)=-\left\langle d \nu_{\Omega}(v), w\right\rangle$ for tangent vectors $v, w \in T_{x}(\partial \Omega)$. Using the shorthand $\nu:=\nu_{\Omega} \circ F: \mathbf{D}_{r_{0}} \rightarrow S^{n-1}$, the coefficients of the second fundamental form in the coordinates defined by $F$ are given by $A_{i j}=$ $\left\langle\partial_{i j} F, \nu\right\rangle_{\mathbb{R}^{n}}$. Differentiating (B.3) above, we have $\partial_{i j} F=\partial_{j} \tau_{i}=\partial_{i j} \ell e_{n}$, and thus for $i, j \in\{1, \ldots, n-1\}$ we have

$$
\begin{equation*}
A_{i j}=\left\langle\partial_{i j} F, \nu\right\rangle=\partial_{i j} \ell\left\langle e_{n}, \nu\right\rangle=\frac{-\partial_{i j} \ell}{\sqrt{1+|\nabla \ell|^{2}}}=-\partial_{i j} \ell+\mathrm{O}\left(|x|^{2}\right) \tag{B.6}
\end{equation*}
$$

We have

$$
\begin{equation*}
\partial_{i} \nu=-A_{i}^{j} \tau_{j}, \tag{B.7}
\end{equation*}
$$

and from (B.5) and (B.6) we directly compute that $A_{i}^{j}=g^{i k} A_{k j}$ is given by

$$
\begin{aligned}
A_{i}^{j}=\frac{-\partial_{i j} \ell}{\sqrt{1+|\nabla \ell|^{2}}}+O\left(|x|^{2}\right) & =-\partial_{i j} \ell+O\left(|x|^{2}\right) \\
& =-\partial_{i j} \ell(0)+O\left(|x|^{2}\right)=-\kappa_{j} \delta_{i}^{j}+O\left(|x|^{2}\right) .
\end{aligned}
$$

Step 2: Next, we use the previous step to compute geometric quantities associated to the coordinates defined by $f$. For $x \in \mathbf{C}_{r_{0}}$ and $i=1, \ldots, n-1$, we note that $\partial_{i} \mathbf{p}(x)=e_{i}$ and thus from (B.7), In what follows we will suppress the composition with $\mathbf{p}$ in our notation, writing for instance $\tau_{i}$ in place of $\tau_{i} \circ \mathbf{p}(x)$. For $i=1, \ldots, n-1$, we have

$$
\begin{align*}
\partial_{i} f(x) & =\tau_{i}-x_{n} \partial_{i} \nu(\mathbf{p}(x))  \tag{B.8}\\
& =e_{i}+\partial_{i} \ell e_{n}+x_{n} A_{i}^{j} \tau_{j}=e_{i}+\partial_{i} \ell e_{n}-x_{n} \kappa_{i} e_{i}+O\left(|x|^{2}\right), \\
\text { and } \quad \partial_{n} f(x) & =-\nu=\frac{e_{n}-\nabla \ell}{\sqrt{1+|\nabla \ell|^{2}}}=e_{n}-\nabla \ell+O\left(|x|^{2}\right) .
\end{align*}
$$

Together (B.8) and (B.9) can be expressed in consolidated form as

$$
\begin{aligned}
\nabla f=\sum_{i=1}^{n} \partial_{i} f \otimes e_{i} & =\sum_{i=1}^{n} e_{i} \otimes e_{i}+e_{n} \otimes \nabla \ell-\nabla \ell \otimes e_{n}-x_{n} \sum_{i, j=1}^{n-1} \kappa_{i}(0) e_{i} \otimes e_{i}+O\left(|x|^{2}\right) \\
& =\mathrm{Id}_{\mathbb{R}^{n}}+e_{n} \otimes \nabla \ell-\nabla \ell \otimes e_{n}-x_{n} \sum_{i, j=1}^{n-1} \kappa_{i}(0) e_{i} \otimes e_{i}+O\left(|x|^{2}\right) .
\end{aligned}
$$

In particular, from (B.2) we see that the volume form is given by

$$
J f=\sqrt{\operatorname{det} g_{i j}}=1-x_{n} H_{\Omega}(0)+O\left(|x|^{2}\right),
$$

giving us the first estimate in (2.14). We see directly from the definition that $f$ is a $C^{1}$ map, and since we see from the expression for $\nabla f$ above that $\nabla f(0)=\mathrm{Id}_{\mathbb{R}^{n}}$, we may apply the inverse function theorem to see that, up to decreasing $r_{0}, f$ defines a $C^{1}$ diffeomorphism onto its image. Letting $g=f^{-1}$ and using the expansion of the inverse (B.1), we find

$$
(\nabla g) \circ f=(\nabla f)^{-1}=\operatorname{Id}_{\mathbb{R}^{n}}-e_{n} \otimes \nabla \ell+\nabla \ell \otimes e_{n}+x_{n} \sum_{i, j=1}^{n-1} \kappa_{i}(0) e_{i} \otimes e_{i}+O\left(|x|^{2}\right)
$$

Finally, (2.13) follows from these expressions for $\nabla f$ and $\nabla g$, along with the assumptions that $\nabla \ell(0)=0$. This completes the proof of the lemma.

[^1]:    ${ }^{2}$ Our convention is that the scalar mean curvature of $\partial \Omega$ is computed with respect to the outer unit normal to $\Omega$, so that every bounded open set with $C^{2}$-boundary has at least one boundary point of positive mean curvature.

[^2]:    ${ }^{3}$ Notice that in [MN17, (3.16)] it is incorrectly stated that $\sigma_{H}(T)=\Phi_{H}(T)^{p-1} \Phi_{H}^{\prime}(T) /\left(p^{\#} T^{p^{\#}-1}\right)$, where the extra $1 / p^{\#}$-factor is wrongly introduced in the penultimate displayed equation in the proof of Lemma 3.3, where $\tau^{\prime}(0)=T^{1-p^{\#}} / p^{\#}$ should be replaced by $\tau^{\prime}(0)=T^{1-p^{\#}}$. This error is inconsequential for the arguments in [MN17], since this expression for $\sigma_{H}(T)$ is only used in equation (3.22) and subsequent displayed equations, and since, in all these subsequent identities, a generic multiplicative factor $c(n, p)$ is used (in particular, two functions of $(n, p)$ differing by a $1 / p^{\#}$-factor are both $c(n, p)$ ). It will instead be important in the proof of (4.3) to work with correct expression for $\sigma_{H}(T)$.
