# Leray-Schauder degree for the resonant $Q$-curvature problem in even dimensions

#### Abstract

In this paper, using the theory of critical points at infinity of Bahri 5 , we derive an exact bubbling rate formula for the resonant prescribed $Q$-curvature equation on closed even-dimensional Riemannian manifolds. Using this, we derive new existence results for the resonant prescribed $Q$-curvature problem under a positive mass type assumption. Moreover, we derive a compactness theorem for conformal metrics with prescribed $Q$-curvature under a non-degeneracy assumption. Furthermore, combining the bubbling rate formula with the construction of some blowing-up solutions, we compute the Leray-Schauder degree of the resonant prescribed $Q$-curvature equation under a non-degeneracy and Morse type assumption.


Key Words: GJMS operator, $Q$-curvature, Blow-up analysis, Critical points at infinity, Pseudo-gradient, Topological degree.

## 1 Introduction and statement of the results

One of the most recurrent question in conformal geometry is the problem of finding conformal metrics for which a certain curvature quantity is equal to a prescribed function, e.g. constant. As a model of such problems, we have the problem of existence of conformal metrics with prescribed Gauss curvature on closed Riemannian surfaces, namely the Nirenberg problem and the more general Kazdan-Warner problem.

There exists also analogues of the Gauss curvature in high even dimensions which enjoy similar properties which are relevant to conformal geometry. To better introduce those curvatures, we recall some facts about the theory of closed Riemannian surfaces. It is a well known fact that the Laplace-Beltrami operator on closed Riemannian surfaces $(\Sigma, g)$ is conformally covariant of bidegree $(0,2)$, and governs the transformation laws of the Gauss curvature under conformal changes of the background metric $g$. In fact, under the conformal change of metric $g_{u}=e^{2 u} g$, we have

\Delta_{g_{u}}=e^{-2 u} \Delta_{g} ; \quad-\Delta_{g} u+K_{g}=K_{g_{u}} e^{2 u} \tag{1}
\end{equation*}

where $\Delta_{g}$ and $K_{g}$ (resp. $\Delta_{g_{u}}$ and $K_{g_{u}}$ ) are the Laplace-Beltrami operator and the Gauss curvature of $(\Sigma, g)$ (resp. of $\left(\Sigma, g_{u}\right)$ ). Moreover, we have the Gauss-Bonnet formula which relates $\int_{\Sigma} K_{g} d V_{g}$ and the topology of $\Sigma$

\int_{\Sigma} K_{g} d V_{g}=2 \pi \chi(\Sigma)
$$

where $\chi(\Sigma)$ is the Euler characteristic of $\Sigma$ and $d V_{g}$ is the volume form on $\Sigma$ with respect to $g$. From this we have that $\int_{\Sigma} K_{g} d V_{g}$ is a topological invariant, hence a conformal invariant too. We point out that the conformal invariance of $\int_{\Sigma} K_{g} d V_{g}$ can also be seen just by integrating equation (1) which is of divergence structure.

In 1983, Paneitz [57] has discovered a conformally covariant differential operator $P_{g}$ on four-dimensional closed Riemannian manifolds $(M, g)$ (known now as Paneitz operator). To the Paneitz operator, Branson [12] has associated a natural curvature invariant $Q_{g}$ called $Q$-curvature. They are defined in terms of the Ricci tensor $R i c_{g}$ and the scalar curvature $R_{g}$ of the Riemannian manifold $(M, g)$ as follows

P_{g}=\Delta_{g}^{2}+d i v_{g}\left(\left(\frac{2}{3} R_{g} g-2 R i c_{g}\right) \nabla_{g}\right), \quad Q_{g}=-\frac{1}{12}\left(\Delta_{g} R_{g}-R_{g}^{2}+3\left|R i c_{g}\right|^{2}\right) \tag{2}
\end{equation*}
$$

where $d i v_{g}$ is the negative divergence and $\nabla_{g}$ is the gradient with respect to $g$. As the Laplace-Beltrami operator is conformally covariant of bidegree ( 0,2 ), and governs the transformation laws of the Gauss curvature under conformal changes, we have also that the Paneitz operator is conformally covariant of bidegree $(0,4)$, and governs the transformation laws of the $Q$-curvature under conformal changes of the background metric. Indeed under a conformal change of metric $g_{u}=e^{2 u} g$, we have

P_{g_{u}}=e^{-4 u} P_{g}, \quad P_{g} u+2 Q_{g}=2 Q_{g_{u}} e^{4 u} \tag{3}
\end{equation*}
$$

Apart from this analogy, we have also an extension of the Gauss-Bonnet identity which is the Chern-Gauss-Bonnet formula

$$
\int_{M}\left(Q_{g}+\frac{\left|W_{g}\right|^{2}}{8}\right) d V_{g}=4 \pi^{2} \chi(M)
$$

where $W_{g}$ denotes the Weyl tensor of $(M, g)$ and $\chi(M)$ is the Euler charcteristic of $M$. Hence from the pointwise conformal invariance of $\left|W_{g}\right|^{2} d V_{g}$, it follows that $\kappa_{P}:=\int_{M} Q_{g} d V_{g}$ is also conformally invariant. Moreover, the conformal invariance of $\int_{M} Q_{g} d V_{g}$ can also be seen by just integrating the second equation of (3) which is also of divergence structure, like in the case of Gauss curvature for closed Riemannian surfaces.

On the other hand, there are high order analogues of the Laplace-Beltrami operator and the Paneitz operator for high even-dimensional closed Riemannian manifolds and also to the associated curvature invariants. More precisely, given a closed $n$-dimensional Riemannian manifold ( $M, g$ ) with $n \geq 2$ and even, in [31, it was introduced a family of conformally covariant differential operators $P_{g}^{n}$ whose leading term is $\left(-\Delta_{g}\right)^{\frac{n}{2}}$. Moreover, in [12], some curvature invariants $Q_{g}^{n}$ was defined, naturally associated to $P_{g}^{n}$. In low dimensions, we have the following relations

$$
P_{g}^{2}=-\Delta_{g}, \quad Q_{g}^{2}=K_{g}, \quad P_{g}^{4}=P_{g}, \quad \text { and } \quad Q_{g}^{4}=2 Q_{g}
$$

It turns out that $P_{g}^{n}$ is self-adjoint and annihilates constants. Furthermore, as for the Laplace-Beltrami operator on closed Riemannian surfaces and the Paneitz operator on closed four-dimensional Riemannian manifolds, for every closed $n$-dimensional Riemannian manifold ( $M, g$ ) with $n \geq 2$ and even, we have that after a conformal change of metric $g_{u}=e^{2 u} g$

P_{g_{u}}^{n}=e^{-n u} P_{g}^{n}, \quad P_{g}^{n} u+Q_{g}^{n}=Q_{g_{u}}^{n} e^{n u} \tag{4}
\end{equation*}
$$

Thus, as in the 2-dimensional and 4-dimensional cases, by integrating the second equation of (4) and using the fact that $P_{g}^{n}$ is self-adjoint and annihilates constants, it follows that $\kappa_{g}^{n}:=\int_{M} Q_{g}^{n} d V_{g}$ is also conformally invariant. Furthermore, there exists also an analogue of the Chern-Gauss-Bonnet formula, which is a consequence of a formula of Alexakis [1] (see also [2]), and reads as follows

\int_{M}\left(Q_{g}^{n}+\left|\tilde{W}_{g}\right|\right) d V_{g}=\frac{(n-1)!}{2} \omega_{n} \chi(M) \tag{5}
\end{equation*}

where $\omega_{n}$ is the volume of $\mathbb{S}^{n}$ (the $n$-dimensional unit sphere of $\mathbb{R}^{n+1}$ ) with respect to the standard metric of $\mathbb{S}^{n}, \tilde{W}_{g}$ is a local conformal invariant involving the Weyl tensor $W_{g}$ and its covariant derivatives, and $\chi(M)$ is the Euler characteristic of $M$.

As for the Kazdan-Warner problem for closed Riemannian surfaces, given a closed $n$-dimensional Riemannian manifold $(M, g)$ ( $n$ even and $n \geq 4$ ) and a smooth positive function $K: M \longrightarrow R$, one can ask under which conditions on $K$, does there exists a Riemannian metric $g_{u}=e^{2 u} g$ conformally related to $g$ for which the corresponding $Q$-curvature $Q_{g_{u}}^{n}$ is $K$. Thanks to (4), the geometric problem is equivalent to finding a smooth solution of the equation

\end{equation*}

Since $\mathbb{R} \subset \operatorname{ker} P_{g}^{n}$, then it is easy to see that (6) has a solution is equivalent to

$$

P_{g}^{n} u+Q_{g}^{n}=\kappa_{g}^{n} K e^{n u} \quad \text { in } M \tag{7}
\end{equation*}

has a solution. Equation (7) has a variational structure. Indeed, using elliptic regularity theory (see [62]), we have smooth solutions of (17) can be found by looking at critical points of the following geometric functional:

J(u):=\left\langle P_{g}^{n} u, u\right\rangle+2 \int_{M} Q_{g}^{n} u d V_{g}-\frac{2}{n} \kappa_{g}^{n} \log \left(\int_{M} K e^{n u} d V_{g}\right), \quad u \in W^{\frac{n}{2}, 2}(M)
$$

where $W^{\frac{n}{2}, 2}(M)$ is the space of functions on $M$ which are of class $W^{\frac{n}{2}, 2}$ in each coordinate system.
The asymptotic behaviour of sequences of solutions

$$
\begin{equation*}
P_{g}^{n} u_{l}+t_{l} Q_{g}^{n}=t_{l} \kappa_{g}^{n} K e^{n u_{l}} \quad \text { in } \quad M \tag{8}
\end{equation*}
$$

with $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}, K: M \longrightarrow \mathbb{R}$ smooth and positive, and $t_{l} \longrightarrow 1$ as $l \longrightarrow+\infty$ plays an important role in the Variational Analysis of $J$ in the resonant case, ie when $\kappa_{g}^{n} \in(n-1)!\omega_{n} \mathbb{N}^{*}$. In this paper, we are interested in the exact bubbling rate formula for (8) in the resonant case and its applications to existence, compactness and topological degree-computation.

In order to state our results clearly, we first fix some notation and make some definitions. For $m \in \mathbb{N}^{*}$ such that

we define $\mathcal{F}_{K}: M^{m} \backslash F_{m}(M) \longrightarrow \mathbb{R}$ as follows

where $F\left(M^{m}\right)$ denotes the fat Diagonal of $M^{m}$, namely $F\left(M^{m}\right):=\left\{A:=\left(a_{1}, \cdots, a_{m}\right) \in M^{m}\right.$ : there exists $i \neq j$ with $\left.a_{i}=a_{j}\right\}, G$ is the Green's function of $P_{g}^{n}(\cdot)+\frac{1}{m} Q_{g}^{n}$ with mass $(n-1)!\omega_{n}$ satisfying the normalization $\int_{M} Q_{g}^{n}(x) G(\cdot, x) d V_{g}(x)=0$, and $H$ is its regular part, see Section 2 for more information. Furthermore, we define

Moreover, for $A=\left(a_{1}, \cdots, a_{m}\right) \in M^{m} \backslash F_{m}(M)$, we set

where

L_{g}:=-\Delta_{g}+\frac{(n-2)}{4(n-1)} R_{g}
$$

is the conformal Laplacian associated to $g$. We set also

where $\operatorname{Morse}\left(\mathcal{F}_{K}, A\right)$ denotes the Morse index of $\mathcal{F}_{K}$ at $A$. Finally, we say

& (N D)_{0} \quad \text { holds if for every } A \in \operatorname{Crit}\left(\mathcal{F}_{K}\right), \quad \mathcal{L}_{K}(A) \neq 0  \tag{15}\\
& (N D)_{-} \quad \text { holds if for every } A \in \operatorname{Crit}\left(\mathcal{F}_{K}\right), \quad \mathcal{L}_{K}(A)<0  \tag{16}\\
& (N D)_{+} \quad \text { holds if for every } A \in \operatorname{Crit}\left(\mathcal{F}_{K}\right), \quad \mathcal{L}_{K}(A)>0 \tag{17}
\end{align*}

and
$(N D)$ holds if $(N D)_{0}$ holds and $\mathcal{F}_{K}$ is a Morse function.

Now, we are ready to state our results and we start with the exact bubbling rate formula for sequences of blowing up solutions to (8) under the assumption $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$.

Theorem 1.1. Let $(M, g)$ be a closed $n$-dimensional Riemannian manifold with $n \geq 4$ even such that $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$ and $\kappa_{g}^{n}=(n-1)!m \omega_{n}$ with $m \in \mathbb{N}^{*}$. Assuming that $K$ is a smooth positive function on $M$ and $u_{l}$ is a sequence of blowing up solutions to (8) with $t_{l} \rightarrow 1$ as $l \rightarrow+\infty$, then up to a subsequence, we have that for $l$ large enough, there holds

t_{l}-1=\frac{c_{n, m}^{K}(A) e^{-2 \max _{M} u_{l}}}{\left(\mathcal{F}_{i}^{A}\left(a_{i}\right)\right)^{\frac{n-2}{n}}}\left[\mathcal{L}_{K}(A)+o_{l}(1)\right]
$$

with $A=\left(a_{1}, \cdots, a_{m}\right) \in \operatorname{Crit}\left(\mathcal{F}_{K}\right)$ and $c_{n, m}^{K}(A)$ is a positive constant depending only on $K, A, n$ and $m$.

Theorem 1.1 and our work 49 in the nonresonant case (i.e $\left.\kappa_{g}^{n} \notin(n-1)!\omega \mathbb{N}^{*}\right)$ imply the following existence result for conformal metrics with prescribed $Q$-curvature.

Corollary 1.2. Let $(M, g)$ be a closed $n$-dimensional Riemannian manifold with $n \geq 4$ even such that $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$ and $\kappa_{g}^{n}=(n-1)!m \omega_{n}$ with $m \in \mathbb{N}^{*}$. Assuming that $K$ is a smooth positive function on $M$ such that $(N D)_{-}$or $(N D)_{+}$holds, then $K$ is the $Q$-curvature of a Riemannian metric conformally related to $g$.

In the critical case, i.e $\kappa_{g}^{n}=(n-1)!\omega_{n}$, Theorem 1.1 implies the following existence of minimizer of the functional $J$.

Corollary 1.3. Let $(M, g)$ be a closed $n$-dimensional Riemannian manifold with $n \geq 4$ even such that $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R} \quad P_{g}^{n} \geq 0$ and $\kappa_{g}^{n}=(n-1)!\omega_{n}$. Assuming that $K$ is a smooth positive function on $M$ such that $(N D)_{+}$holds, then $K$ is the $Q$-curvature of a Riemannian metric $g_{u}=e^{2 u} g$ with $u$ a minimizer of $J$ on $H^{2}(M)$.

Theorem 1.1 implies also the following compactness theorem for conformal metrics with prescribed $Q$ curvature.

Corollary 1.4. Let $(M, g)$ be a closed $n$-dimensional Riemannian manifold with $n \geq 4$ even such that $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$ and $\kappa_{g}^{n}=(n-1)!m \omega_{n}$ with $m \in \mathbb{N}^{*}$. Assuming that $K$ is a smooth positive function on $M$ such that $(N D)_{0}$ holds, then for every $k \in \mathbb{N}$, there exists a large positive constant $C_{k}$ such that for every $u$ solution of (7),

\|u\|_{C^{k}(M)} \leq C_{k}
$$

Corollary 1.4 implies that the Leray-Schauder degree of equation (7) is well-defined. Indeed, we have
Theorem 1.5. Let $(M, g)$ be a closed $n$-dimensional Riemannian manifold with $n \geq 4$ even such that $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$ and $\kappa_{g}^{n}=(n-1)!m \omega_{n}$ with $m \in \mathbb{N}^{*}$. Assuming that $K$ is a smooth positive function on $M$ such that $(N D)_{0}$ holds, then the Leray-Schauder degree $d_{m}$ of equation (77) is well-defined. Furthermore, if $(N D)$ holds, then there existe $L_{0}>0$ such that

d_{m}= \begin{cases}(-1)^{\bar{m}}\left(1-\sum_{A \in \mathcal{F}_{\infty}}(-1)^{i_{\infty}(A)}\right)=\chi\left(J^{L}, J^{-L}\right)-\sum_{A \in \mathcal{F}_{\infty}}(-1)^{\bar{m}+i_{\infty}(A)} & \text { if } m=1  \tag{19}\\ (-1)^{\bar{m}}\left(\frac{1}{(m-1)!} \Pi_{i=1}^{m-1}(i-\chi(M))-\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{i_{\infty}(A)}\right) & \text { if } m \geq 2 \\ =\chi\left(J^{L}, J^{-L}\right)-\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{\bar{m}+i_{\infty}(A)} & \end{cases}
$$

for all $L \geq L_{0}$.

## 2 Notations and preliminaries

In this brief section, we fix our notations and give some preliminaries. First of all, we recall that $(M, g)$ and $K$ are respectively the given underlying closed $n$-dimensional Riemannian manifold with $n \geq 4$ even, and the prescribed function with the following properties (until otherwise said)
$\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$ and $\kappa_{g}^{n}=(n-1)!m \omega_{n}$ for some $m \in \mathbb{N}^{*}$ and $K$ is a smooth positive function on $M$.
Furthermore, $u_{l}$ and $t_{l}$ are respectively sequence of smooth functions and real numbers, satisfying

P_{g}^{n} u_{l}+t_{l} Q_{g}^{n}=t_{l} \kappa_{g}^{n} K e^{n u_{l}} \text { in } M, \text { and } t_{l} \longrightarrow 1 \text { as } l \longrightarrow+\infty \tag{21}

We are going to discuss the asymptotics near the singularity of the Green's function $G$ of the operator $P_{g}^{n}(\cdot)+\frac{1}{m} Q_{g}^{n}$ with mass $(n-1)!\omega_{n}$ satisfying the normalization $\int_{M} G(\cdot, y) Q_{g}^{n}(y) d V_{g}(y)=0$ and make some related definitions.

In the following, for a Riemmanian metric $\bar{g}$ on $M$, we will use the notation $B_{p}^{\bar{g}}(r)$ to denote the geodesic ball with respect to $\bar{g}$ of radius $r$ and center $p$. We also denote by $d_{\bar{g}}(x, y)$ the geodesic distance with respect to $\bar{g}$ between two points $x$ and $y$ of $M, \exp { }_{x}^{\bar{g}}$ the exponential map with respect to $\bar{g}$ at $x$. $i n j_{\bar{g}}(M)$ stands for the injectivity radius of $(M, \bar{g}), d V_{\bar{g}}$ denotes the Riemannian measure associated to the metric $\bar{g}$. Furthermore, we recall that $\nabla_{\bar{g}}, \Delta_{\bar{g}}, R_{\bar{g}}$ and Ric $_{\bar{g}}$ will denote respectively the gradient, the Laplace-Beltrami operator, the scalar curvature and Ricci curvature with respect to $\bar{g}$. For simplicity, we will use the notation $B_{p}(r)$ to denote $B_{p}^{g}(r)$, namely $B_{p}(r)=B_{p}^{g}(r) . M^{2}$ stands for the cartesian product $M \times M$, while $\operatorname{Diag}(M)$ is the diagonal of $M^{2}$.

For $1 \leq p \leq \infty$ and $k \in \mathbb{N}, \quad \theta \in] 0,1\left[, L^{p}(M), W^{k, p}(M), C^{k}(M)\right.$, and $C^{k, \theta}(M)$ stand respectively for the standard Lebesgue space, Sobolev space, $k$-continuously differentiable space and $k$-continuously differential space of Hölder exponent $\beta$, all with respect $g$ (if the definition needs a metric structure, and for precise definitions and properties, see [4] or [30]). Given a function $u \in L^{1}(M), \bar{u}$ and $\bar{u}_{Q^{n}}$ denote respectively its average on $M$ with respect to $g$ and the sign measure $Q_{g}^{n} d V_{g}$, that is

with $\operatorname{Vol}_{g}(M)=\int_{M} d V_{g}$ and

For $\epsilon>0$ and small, $\lambda \in \mathbb{R}_{+}, \lambda \geq \frac{1}{\epsilon}$, and $a \in M, O_{\lambda, \epsilon}(1)$ stands for quantities bounded uniformly in $\lambda$, and $\epsilon$, and $O_{a, \epsilon}(1)$ stands for quantities bounded uniformly in $a$ and $\epsilon$. For $l \in \mathbb{N}^{*}, O_{l}(1)$ stands for quantities bounded uniformly in $l$ and $o_{l}(1)$ stands for quantities which tends to 0 as $l \rightarrow+\infty$. For $\epsilon$ positive and small, $a \in M$ and $\lambda \in \mathbb{R}_{+}$large, $\lambda \geq \frac{1}{\epsilon}, O_{a, \lambda, \epsilon}(1)$ stands for quantities bounded uniformly in $a, \lambda$, and $\epsilon$. For $\epsilon$ positive and small, $p \in \mathbb{N}^{*}, \bar{\lambda}:=\left(\lambda_{1}, \cdots, \lambda_{p}\right) \in\left(\mathbb{R}_{+}\right)^{p}, \lambda_{i} \geq \frac{1}{\epsilon}$ for $i=1, \cdots, p$, and $A:=\left(a_{1}, \cdots, a_{p}\right) \in M^{p}$ (where $\left(\mathbb{R}_{+}\right)^{p}$ and $M^{p}$ denotes respectively the cartesian product of $p$ copies of $\mathbb{R}_{+}$and $\left.M\right), O_{A, \bar{\lambda}, \epsilon}(1)$ stands for quantities bounded uniformly in $A, \bar{\lambda}$, and $\epsilon$. Similarly for $\epsilon$ positive and small, $p \in \mathbb{N}^{*}, \bar{\lambda}:=\left(\lambda_{1}, \cdots, \lambda_{p}\right) \in\left(\mathbb{R}_{+}\right)^{p}, \lambda_{i} \geq \frac{1}{\epsilon}$ for $i=1, \cdots, p, \bar{\alpha}:=\left(\alpha_{1}, \cdots, \alpha_{p}\right) \in \mathbb{R}^{p}, \alpha_{i}$ close to 1 for $i=1, \cdots, p$, and $A:=\left(a_{1}, \cdots, a_{p}\right) \in M^{p}$ (where $\mathbb{R}^{p}$ denotes the cartesian product of $p$ copies of $\mathbb{R}$, $O_{\bar{\alpha}, A, \bar{\lambda}, \epsilon}(1)$ will mean quantities bounded from above and below independent of $\bar{\alpha}, A, \bar{\lambda}$, and $\epsilon$. For $x \in \mathbb{R}$, we will use the notation $O(x)$ to mean $|x| O(1)$ where $O(1)$ will be specified in all the contexts where it is used. Large positive constants are usually denoted by $C$ and the value of $C$ is allowed to vary from formula to formula and also within the same line. Similarly small positive constants are also denoted by $c$ and their value may varies from formula to formula and also within the same line.

We call $\bar{m}$ the number of negative eigenvalues (counted with multiplicity) of $P_{g}^{n}$. We point out that $\bar{m}$ can be zero, but it is always finite. If $\bar{m} \geq 1$, then we will denote by $E_{-} \subset W^{\frac{n}{2}, 2}(M)$ the direct sum of the eigenspaces corresponding to the negative eigenvalues of $P_{g}^{n}$. The dimension of $E_{-}$is of course $\bar{m}$. On the other hand, we have the existence of an $L^{2}$-orthonormal basis of eigenfunctions $v_{1}, \cdots, v_{\bar{m}}$ of E_ satisfying

As above, in the general case, namely $\bar{m} \geq 0$, for $\epsilon$ small and positive, $\bar{\beta}:=\left(\beta_{1}, \cdots, \beta_{\bar{m}}\right) \in \mathbb{R}^{\bar{m}}$ with $\beta_{i}$ close to $0, i=1, \cdots, \bar{m})\left(\right.$ where $\mathbb{R}^{\bar{m}}$ is the empty set when $\left.\bar{m}=0\right), \bar{\lambda}:=\left(\lambda_{1}, \cdots, \lambda_{p}\right) \in\left(\mathbb{R}_{+}\right)^{p}, \lambda_{i} \geq \frac{1}{\epsilon}$ for $i=1, \cdots, p, \bar{\alpha}:=\left(\alpha_{1}, \cdots, \alpha_{p}\right) \in \mathbb{R}^{p}, \alpha_{i}$ close to 1 for $i=1, \cdots, p$, and $A:=\left(a_{1}, \cdots, a_{p}\right) \in M^{p}$, $p \in \mathbb{N}^{*}, w \in W^{\frac{n}{2}, 2}$ with $\|w\|$ small, $O_{\bar{\alpha}, A, \bar{\lambda}, \bar{\beta}, \epsilon}(1)$ will stand quantities bounded independent of $\bar{\alpha}, A$, $\bar{\lambda}, \bar{\beta}$, and $\epsilon$, and $O_{\bar{\alpha}, A, \bar{\lambda}, \bar{\beta}, w, \epsilon}(1)$ will stand quantities bounded independent of $\bar{\alpha}, A, \bar{\lambda}, \bar{\beta}, w$ and $\epsilon$.
As in [56] and [53], given a point $b \in \mathbb{R}^{n}$ and $\lambda$ a positive real number, we define $\delta_{b, \lambda}$ to be the standard bubble, namely

Using the existence of conformal normal coordinates (see [17] or [33]), we have that, for $a \in M$ there exists a function $u_{a} \in C^{\infty}(M)$ such that

## 3 An expansion of $\nabla J_{t_{l}}$ at infinity

In this section, we present a useful expansion of $\nabla J_{t_{l}}$ at infinity. In order to do that, we first fix $\Lambda$ to a large positive constant. Next, like in [54] and [56] (see also [53]), for $\epsilon$ and $\eta$ small positive real numbers, we first denote by $V(m, \epsilon, \eta)$ the $(m, \epsilon, \eta)$-neighborhood of potential critical points at infinity, namely

where $\bar{C}$ is a large positive constant, $\nabla^{W^{\frac{n}{2}, 2}} J$ is the gradient of $J$ with respect to the $W^{\frac{n}{2}, 2}$-topology, $O(1):=O_{A, \bar{\lambda}, u, \epsilon}(1)$ meaning bounded uniformly in $\bar{\lambda}:=\left(\lambda_{1}, \cdots, \lambda_{n}\right), A:=\left(a_{1}, \cdots, m\right), u, \epsilon$. Next, as in [56] and [53], following the ideas of Bahri-Coron [9], we have that for $\eta$ a small positive real number with $0<2 \eta<\varrho$, there exists $\epsilon_{0}=\epsilon_{0}(\eta)>0$ such that
$\forall 0<\epsilon \leq \epsilon_{0}, \quad \forall u \in V(m, \epsilon, \eta)$, the minimization problem $\min _{B_{e, \eta}}\left\|u-\bar{u}_{Q^{n}}-\sum_{i=1}^{m} \alpha_{i} \varphi_{a_{i}, \lambda_{i}}-\sum_{r=1}^{\bar{m}} \beta_{r}\left(v_{r}-\overline{\left(v_{r}\right)}{ }_{Q^{n}}\right)\right\|_{P^{n}}$
has a unique solution, up to permutations, where $B_{\epsilon, \eta}$ is defined as follows

where here $O(1):=O_{\bar{\alpha}, A, \bar{\lambda}, \bar{\beta}, w, \epsilon}(1)$, and for the meaning of $O_{\bar{\alpha}, A, \bar{\lambda}, \bar{\beta}, w, \epsilon}(1)$, see Section 2 Furthermore, the concentration points $a_{i}$, the masses $\alpha_{i}$, the concentrating parameters $\lambda_{i}$ and the negativity parameter $\beta_{r}$ in (47) verify also

with still $O(1)$ as in (49). Using the neighborhood of potential critical points at infinity, we have the following Lemma. For its proof see Lemma 3.1 in [54] and Proposition 3. 3 in [56].

Assuming that $u_{l}$ is a sequence of blowing up critical point of $J_{t_{l}}$ with $\overline{\left(u_{l}\right)}{ }_{Q^{n}}=0, l \in \mathbb{N}$ and $t_{l} \rightarrow 1$ as $l \rightarrow+\infty$, then there exists $l_{\epsilon, \eta}$ a large positive integer such that for every $l \geq l_{\epsilon, \eta}$, we have $u_{l} \in V(m, \epsilon, \eta)$.

Now, we present some gradient estimates for $J_{t_{l}}$. We start with the following one.
Lemma 3.2. Assuming that $\eta$ is a small positive real number with $0<2 \eta<\varrho$ where $\varrho$ is as in (34), and $\epsilon \leq \epsilon_{0}$ where $\epsilon_{0}$ is as in (45), then for $a_{i} \in M$ concentration points, $\alpha_{i}$ masses , $\lambda_{i}$ concentration parameters $(i=1, \cdots, m)$ and $\beta_{r}$ negativity parameters $(r=1, \cdots, \bar{m})$ satisfying (50), we have that for $l$ large enough and for every $j=1, \cdots, m$, there holds

## 4 Refined location of $u_{l}$

In this section, we improve the location of $u_{l}$ given by Lemma 3.1. In order to do that, we divide this section into two subsections. In the first one, we derive a finite-dimensional parametrization of $u_{l}$. In the second one, we present the improvement we talked about above, by using the later parametrization of $u_{l}$.

### 4.1 Finite-dimensional parametrization of $u_{l}$

As already mentioned above, in this subsection, we give a finite-dimensional parametrization of $u_{l}$. For this end, we start with the following Lemma.

Thus, with this new variable, in $V(m, \epsilon, \eta)$ we have a splitting of the variables $(\bar{\alpha}, A, \bar{\lambda}, \bar{\beta})$ and $V_{l}$, and $-V_{l}$ is a pseudogradient of $J_{t_{l}}$ in the direction of $V_{l}$. Using this fact, we have the following Proposition which was the goal of this subsection.

### 4.2 Refined estimates for the finite-dimensional parameters of $u_{l}$

As already mentioned at the beginning of this section, in this subsection we derive refined estimates for the finite-dimensional parameters of $u_{l}$ in the formula (67). ## 5 Proof of the results

In this section, we present the proof of Theorem 1.1.Corollary 1.4. We start with the one of Theorem 1.1 . In order to do that, we are going to show the following result from which Theorem 1.1 follows directly, thanks to the formula (43) and to the used scaling blowing up formula which is given by point a) of Lemma 2.3 in [54.

Assuming that $K$ is a smooth positive function on $M$, $\epsilon$ and $\eta$ be small positive real numbers with $0<2 \eta<\varrho$ where $\varrho$ is as in (34) and $u_{l}$ is a sequence of blowing up solutions to (21), then for l large enough, we have that $u_{l} \in V_{\text {deep }}^{t_{l}}(m, \epsilon, \eta)$

Proof of Theorem 5.1
The proof is the same as the one of Theorem 5.1 in [55].

Proof of Corollary 1.2
Case 1: $(N D)_{-}$holds
In this case, the result follows from our work [49] in the nonresonant case by considering the functional $J_{1+\varepsilon}$ with $\varepsilon$ positive and small combined with Theorem 1.1.

Case 2: $(N D)_{+}$holds
In this case, the same argument as above works by considering $J_{1-\varepsilon}$ with $\varepsilon$ positive and small. We add that for $m=1$ and $\bar{m}=0$, by the existence of minimizers in the subcritical case, we can take the solution to be be a minimizer of $J$. On the other hand when $m \geq 2$, the result follows also from the characterization of the "true" critical points at infinity of $J$, and the topology of very high and very negative sublevels of $J$ established in our work [54].

Proof of Corollary 1.4
Clearly Theorem 1.1 combined with standard elliptic regularity theory imply the result.

## 6 Proof of Theorem 1.5

In this section, we prove Theorem 1.5. We start by showing a deep local characterization at infinity around critical points of $\mathcal{F}_{K}$ for blowing-up solution of the type considered in Lemma 4.5. Indeed setting

The set $V_{\text {deep }}^{t}(m, \epsilon, \eta)(A)$ is defined as in n (68) with $t_{l}$ replaced by $t$ and $A^{0}$ replaced by $A$.

Thus, using Lemma 3.6, Remark 3.7 and (79), we have

Similarly, using Lemma 3.5 and Corollary 4.2 with $t_{l}$ replaced by $t$ combined with (75), we have

Again as above, using Lemma 4.1 and Corollary 4.2 with $t_{l}$ replaced by $t$ combined with (75), we have

Finally for $t \simeq 1^{-1}$, we have $\forall i=1, \cdots, m$ there exists a unique $\lambda_{i}^{t}$ such that

Thus $u^{t}=z^{t}-\log \int_{M} e^{4 z^{t}} d V_{g}$ satisfies (73) and (74) thereby ending the proof of the proposition.
Our work 49 in the non-resonant case, Corollary 1.4 and Theorem 6.1 imply the following proposition important in the calculation of $d_{m}$ as carried below.

Proposition 6.4. Let $(M, g)$ be a closed $n$-dimensional Riemannian manifold with $n \geq 4$ even such that $\operatorname{ker} P_{g}^{n} \simeq \mathbb{R}$ and $\kappa_{g}^{n}=(n-1)!m \omega_{n}$. Assuming that $K$ is a smooth positive function on $M$ such that (ND) holds. There exist $\epsilon_{m, n}>0, C_{m}>0, C_{t}>C_{n, m}(t \simeq 1)$ with $C_{n, m}$ and $\epsilon_{m, n}$ depending only on $m$ and $n, C_{t}$ continuous in $t$ and $\lim _{t \rightarrow 1} C_{t}=+\infty$ such that for every $u$ solution of

$$
P_{g}^{n} u+t Q_{g}^{n}=t K e^{n u}
$$

with $\left|(n-1) \omega_{n}(t-1)\right|<\epsilon_{m, n}$, we have
1)
$\|u\|<C_{t} \quad \forall t \neq 1$.
2)
$\|u\| \leq C_{m, n} \quad$ for $t=1$
3)

If $t \neq 1$, then we have
i) Either $\|u\|<C_{n, m}$
ii) Or $\|u\| \geq C_{n, m}$ and $u \in V_{\text {deep }}^{t}(m, \epsilon, \eta):=\cup_{A \in \operatorname{Crit}\left(\mathcal{F}_{K}\right)} V_{\text {deep }}^{t}(m, \epsilon, \eta)(A)$.

Proof. 1) follows from the compactness result in 49] ( see also [26, 41]), while 2) follows from Corollary 1.4 and 3) follows from Theorem 6.1.

Proof of Theorem 1.5
Let $X:=\left\{u \in W^{\frac{n}{2}}(M): \int_{M} K e^{n u} d V_{h}=1\right\}$ and $T: X \longrightarrow X$ be defined by

Then $u$ is a solution of (7) is equivalent to $(I-T) u=0$. On the other hand, Corollary 1.4 and Theorem 6.4 imply the Leray-Schauder degree of (7) $d_{m}=d_{m}(K)$ is well-defined and verifies

$$

From the work of Malchiodi[43] in the non-resonant case, there exists $L_{0}>0$ such that for all $L \geq L_{0}$,

1-\chi\left(A_{m-1, \bar{m}}\right)=\chi\left(J_{t}^{L}, J_{t}^{-L}\right), \quad \forall t \in(0,1)
$$

From our work [54], up to taking $L_{0}$ larger we have

\chi\left(J^{L}, J^{-L}\right)=\chi\left(J_{t}^{L}, J_{t}^{-L}\right), \quad \forall t \in(0,1)
$$

Similarly to (7) and (91), for $t \in(0,1)$ we consider the equation

and the operator

Then Proposition 6.4 implies the Leray-Schauder degree of (92) $d_{m}^{t}$ is well-defined and is given by

d_{m}^{t}=\operatorname{deg}\left(I-T_{t}, B_{C_{t}}, 0\right), \quad \forall t \in(0,1)
$$

Furthermore, the work of Malchodi[43 implies

$$
d_{m}^{t}=1-\chi\left(A_{m-1, \bar{m}}\right), \quad \forall t \in(0,1)
$$

Let use define

$$
d_{m}^{-}=\lim _{t \rightarrow 1^{-}} d_{m}^{t}
$$

Then Theorem 1.1 Remark 6.2, and Theorem 6.4 imply

$$
d_{m}^{-}=\operatorname{deg}\left(I-T, B_{C_{n, m}}, 0\right)+\operatorname{deg}\left(I-T, V_{d e e p}^{1,-}(m, \epsilon, \eta), 0\right)
$$

where

$$
V_{\text {deep }}^{1,-}(m, \epsilon, \eta)=\cup_{A \in \mathcal{F}_{\infty}} V_{\text {deep }}^{1}(m, \epsilon, \eta)(A)
$$

On the other hand, our Morse lemma at infinity in 54 and Poncare-Hopf theorem imply

$$
\operatorname{deg}\left(I-T, V_{\text {deep }}^{1,-}(m, \epsilon, \eta), 0\right)=\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{\left.i_{\infty}(A)\right)+\bar{m}}
$$

Thus, we get

d_{m}^{-}=d_{m}+\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{i_{\infty}(A)+\bar{m}}
$$

so, we obtain

1-\chi\left(A_{m-1, \bar{m}}\right)=\chi\left(J^{L}, J^{-L}\right)=d_{m}+\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{i_{\infty}(A)}
$$

this implies

d_{m}=\chi\left(J^{L}, J^{-L}\right)-\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{i_{\infty}(A)+\bar{m}}=1-\chi\left(A_{m-1, \bar{m}}\right)-\frac{1}{m!} \sum_{A \in \mathcal{F}_{\infty}}(-1)^{i_{\infty}(A)+\bar{m}}
$$

Hence, recalling

$$
1-\chi\left(A_{m-1, \bar{m}}\right)=(-1)^{\bar{m}} \text { for } m=1
$$

and

$$
1-\chi\left(A_{m-1, \bar{m}}\right)=(-1)^{\bar{m}} \frac{1}{(m-1)!} \Pi_{i=1}^{m-1}(i-\chi(M)), \text { for } \quad m \geq 2
$$

we have the result follows.
