# Proof of Weierstrass gap theorem

#### Abstract

In this expository note we give proof of the Weierstrass gap theorem in Cohomology terminology. We analyze gap sequence for finding possible gaps and non-gaps on $X$.

## 1 Introduction:

Let $X$ be a compact Riemann surface of genus $g$. One of the important questions is the existence of meromorphic functions having pole at a single point $p$ on $X$. By the Riemann Roch theorem, we can show that there always exists a non-constant meromorphic function $f \in \mathcal{M}(X)$ which has a pole of order $\leq g+1$ at $p$ and is holomorphic in $X \backslash\{p\}$.

One of the basic results in this topic is Weierstrass gap theorem, which states that

Theorem 1 For a surface of genus $g \geq 1$ there are precisely $g$ integers

$$
\begin{equation*}
1=n_{1}<n_{2}<\cdots<n_{g}<2 g \tag{1}
\end{equation*}
$$

such that there does not exist a meromorphic function on $X$ with a pole of order $n_{k}$ at $p$.

The numbers $n_{j}$, for $j=1, \ldots, g$ are called "gaps" at $p$ and their complement in $\mathbb{N}$ are called "non-gaps". Further, the sequence is uniquely determined by the point $p$.

The case $g=0$ is trivial as there is always a function on the sphere with a simple pole. The case $g=1$ is clear since there is no meromorphic function with a single simple pole.

In this note we furnish the proof of Theorem 1 in the language of sheaf cohomology, in the spirit of proof given in Springer [4]. The proof of Noether's theorem was given in Farkas and Kra [1] from which the proof of Weierstrass gap theorem was deduced as a special case. The proofs are generally given as an application of Riemann-Roch Theorem. In section 2, we mention some of the consequences of Riemann-Roch and Serre Duality theorems. The proofs may be found in [2]. The proof of Weierstrass gap theorem is given in Section 3. In Section 4, we form a combinatorial problem which appears to be a by product from the statement of Weierstrass gap theorem and analyze gaps and non-gaps.

## 2 Some Consequences of Riemann-Roch and Serre Duality Theorems

Let $D$ be a divisor on $X$.
If $\operatorname{deg} D<0$ then $H^{0}\left(X, \mathcal{O}_{D}\right)=0$.
We can use Serre-Duality theorem to obtain equality of dimensions:

$$
\begin{equation*}
\operatorname{dim} H^{0}\left(X, \Omega_{-D}\right)=\operatorname{dim} H^{1}\left(X, \mathcal{O}_{D}\right) \tag{2}
\end{equation*}
$$

For $D=0$ we obtain

$$
\begin{equation*}
\operatorname{dim} H^{0}(X, \Omega)=g=\operatorname{dim} H^{1}(X, \mathcal{O}) \tag{3}
\end{equation*}
$$

Here $H^{0}(X, \Omega)=\Omega(X)$ which denotes the sheaf of holomorphic 1-forms on $X$.

The following equality can be obtained as an application of Seree Duality Theorem:

$$
\operatorname{dim} H^{1}(X, \Omega)=\operatorname{dim} H^{0}(X, \mathcal{O})=1
$$

Note 2 This is a known fact again saying there are no non-constant holomorphic maps on a compact Riemann surface.

Suppose $X$ is a compact Riemann surface of genus $g$. Let $K$ be the canonical divisor on $X$. Then $\operatorname{deg} K=2 g-2$.

## 3 Proof of Theorem 1 (Weierstrass Gap Theorem)

Proof. Suppose $P \in X$. If $D$ is a zero divisor, then $\operatorname{dim} H^{1}(X, \mathcal{O})=g$ and $\operatorname{deg}(D)=0$.

By the Riemann Roch theorem $\operatorname{dim} H^{0}(X, \mathcal{O})=1$. Therefore, there are no non-constant holomorphic function on $X$.

Define the divisor $D_{P}$ such that

$$
D_{P}(P)=\left\{\begin{array}{l}
1 \text { if } x=P \\
0 \text { if } x \neq P
\end{array}\right.
$$

$\operatorname{Deg}\left(D_{P}\right)=1$. Once again by the Riemann -Roch theorem,

$$
\operatorname{dim} H^{0}\left(X, \mathcal{O}_{D_{P}}\right)=2-g+\operatorname{dim} H^{0}\left(X, \Omega_{-D_{P}}\right)
$$

If $\operatorname{dim} H^{0}\left(X, \Omega_{-D_{P}}\right)=g$, then $\operatorname{dim} H^{0}\left(X, \mathcal{O}_{D_{P}}\right)=2$, hence there exists $f \in$ $\mathcal{M}(X)$ which has a simple pole at $P$ and is holomorphic in $X \backslash\{P\}$.

If $\operatorname{dim} H^{0}\left(X, \Omega_{-D_{P}}\right)=g-1$, then $\operatorname{dim} H^{0}\left(X, \mathcal{O}_{D_{P}}\right)=1$, hence there is no meromorphic function which has a simple pole at $P$ and is holomorphic in $X \backslash\{P\}$.

Now we want to see the effect of changing $D_{P}=(n-1) D_{P}$ to $D_{P}=n D_{P}$. By the Riemann - Roch Theorem

$$
\operatorname{dim} H^{0}\left(X, \mathcal{O}_{-D_{(n-1) P}}\right)=n-g+\operatorname{dim} H^{0}\left(X, \Omega_{-D_{(n-1) P}}\right)
$$

and

$$
\operatorname{dim} H^{0}\left(X, \mathcal{O}_{-D_{n P}}\right)=n+1-g+\operatorname{dim} H^{0}\left(X, \Omega_{-D_{n P}}\right)
$$

If

$$
\operatorname{dim} H^{0}\left(X, \Omega_{-D_{(n-1) P}}\right)=\operatorname{dim} H^{0}\left(X, \Omega_{-D_{n P}}\right)
$$

then

$$
\operatorname{dim} H^{0}\left(X, \mathcal{O}_{-D_{n P}}\right)=\operatorname{dim} H^{0}\left(X, \mathcal{O}_{-D_{(n-1) P}}\right)+1
$$

So there exists a meromorphic function $f \in \mathcal{M}(X)$ with a pole of order $n$ at $P$ and is holomorphic in $X \backslash\{P\}$.
If

$$
\operatorname{dim} H^{0}\left(X, \Omega_{-D_{(n-1) P}}\right)=\operatorname{dim} H^{0}\left(X, \Omega_{-D_{n P}}\right)-1
$$

then

$$
\operatorname{dim} H^{0}\left(X, \mathcal{O}_{-D_{n P}}\right)=\operatorname{dim} H^{0}\left(X, \mathcal{O}_{-D_{(n-1) P}}\right)
$$

So there will not exist a function with a pole of order $n$ at $P$ and holomorphic in $X \backslash\{P\}$.

So if $\operatorname{dim} H^{0}\left(X, \Omega_{-D_{n P}}\right)$ remains the same as $n$ increases by 1 , a new linearly independent function is added in going from the sheaf $\mathcal{O}_{D_{n_{P}}}$ to $\mathcal{O}_{D_{(n+1) P}}$.

From the Eq. 3 we have $\operatorname{dim} H^{0}(X, \Omega)=g$. We have already seen that if $D$ is the divisor of a non-vanishing meromorphc 1 -form on a compact Riemann surface of genus $g$, then $\operatorname{deg}(\omega)=2 g-2$.

Let $K$ be its canonical divisor. Then we can deduce that

$$
\operatorname{dim} H^{0}\left(X, \Omega_{-D_{(2 g-1) P}}\right)=0
$$

Therefore, the number of times $\operatorname{dim} H^{0}\left(X, \Omega_{-D_{n P}}\right)$ does not remain the same must be $g$ times and at each change it decreases by 1 .

It completes the proof.

## 4 Analyzing gaps and non-gaps

Suppose $p \in X$. If $f$ has a pole of order $s$ at $p$, and $g$ has a pole of order $t$ at $p$, then $f g$ has a pole of order $s+t$ at $p$. Therefore, the set of non-gaps forms an additive sub-semi group of $\mathbb{N}$.
Let $d$ be the least non-gap value at the point $p$, if $n>d$ is a gap then $n-d$ is again a gap value. Therefore, all the gaps occur in finite arithmetical sequences of the form $j, j+d, j+2 d, \ldots, j+\lambda_{j} d$, where $j=1,2, \ldots, d-1$ and $\lambda_{j}=0,1,2, \ldots$ See pp. 124 [3]. A point $p$ is called a hyperelliptic Weierstrass point if the non-gap sequence starts with 2 and the hyperelliptic Riemann surfaces are characterized by the gap sequence:

$$
\begin{equation*}
P=\{1,3, \ldots, 2 g-1\} \tag{4}
\end{equation*}
$$

hence the non-gaps are $\mathrm{Q}=\{2,4, \ldots, 2 \mathrm{~g}\}$
For the Exceptional Riemann surfaces the gap sequence $P$ and the nongap sequence $Q$ are given by

$$
\begin{equation*}
P=\{1,2,3, \ldots, g-1, g+1\} \text { and } Q=\{g, g+2, \ldots, 2 g-1\} . \tag{5}
\end{equation*}
$$

For example, if $g=3$ we see the possible gap sequences are $\{1,3,5\},\{1,2,3\},\{1,2,4\},\{1,2,5\}$
and corresponding non-gaps are:
$\{2,4,6\},\{4,5,6\},\{3,5,6\},\{3,4,6\}$.
The following problem may be of some interest to see possible gaps and non-gaps at a given point.

## Question 1:

Write the numbers 2 to $2 g-1$ in to two (disjoint) parts $P=\left\{n_{1}, n_{2}, \ldots, n_{g-1}\right\}$ and $Q=\left\{m_{1}, m_{2}, \ldots, m_{g-1}\right\}$ such that no number in $P$ is a sum of any combination of numbers in $Q$. How many pairs of such P and Q exist?

Clearly then $\{1\} \cup P$ gives possible gaps and $Q \cup\{2 g\}$ gives possible non-gaps.
