# On the image of an affine subspace under the inverse function within a finite field

#### Abstract

We consider the function $x^{-1}$ that inverses a finite field element $x \in \mathbb{F}_{p^{n}}(p$ is prime, $0^{-1}=0$ ) and affine $\mathbb{F}_{p^{-}}$-subspaces of $\mathbb{F}_{p^{n}}$ such that their images are affine subspaces as well. It is proven that the image of an affine subspace $L,|L|>2$, is an affine subspace if and only if $L=q \mathbb{F}_{p^{k}}$, where $q \in \mathbb{F}_{p^{n}}^{*}$ and $k \mid n$. In other words, it is either a subfield of $\mathbb{F}_{p^{n}}$ or a subspace consisting of all elements of a subfield multiplied by $q$. This generalizes the results that were obtained for linear invariant subspaces in 2006. As a consequence, we propose a sufficient condition providing that a function $A\left(x^{-1}\right)+b$ has no invariant affine subspaces $U$ of cardinality $2<|U|<p^{n}$ for an invertible linear transformation $A: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ and $b \in \mathbb{F}_{p^{n}}^{*}$. As an example, it is shown that the condition works for S-box of AES. Also, we demonstrate that some functions of the form $\alpha x^{-1}+b$ have no invariant affine subspaces except for $\mathbb{F}_{p^{n}}$, where $\alpha, b \in \mathbb{F}_{p^{n}}^{*}$ and $n$ is arbitrary.


Keywords: Finite fields, inversion, affine subspaces, invariant subspaces, APN functions.

## 1 Introduction

In this work we consider affine subspaces whose images under the function that inverses an element of a finite field are affine subspaces as well. We denote this function by $\sigma$, i.e. $\sigma: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ such that

$$
\sigma(x)= \begin{cases}x^{-1}, & \text { if } x \neq 0 \\ 0, & \text { if } x=0\end{cases}
$$

where $\mathbb{F}_{p^{n}}$ is a finite field consisting of $p^{n}$ elements. Hereinafter $p$ is a prime number. A linear subspace $L$ of $\mathbb{F}_{p^{n}}$ is its linear $\mathbb{F}_{p^{-} \text {-subspace. In other words, }}$ $L$ is an additive subgroup of $\mathbb{F}_{p^{n}}$. We denote an affine subspace of $\mathbb{F}_{p^{n}}$ by $a+L$. For any $S \subseteq \mathbb{F}_{p^{n}}, a \in \mathbb{F}_{p^{n}}$ and $f: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ we define

$$
a+S=\{a+s: s \in S\}, a S=\{a s: s \in S\} \text { and } f(S)=\{f(s): s \in S\}
$$

It is known that $\mathbb{F}_{p^{k}}$ is a subfield of $\mathbb{F}_{p^{n}}$ if and only if $k \mid n$. In this case we assume that $\mathbb{F}_{p^{k}} \subseteq \mathbb{F}_{p^{n}}$. Also, $\mathbb{F}_{p^{n}}^{*}=\mathbb{F}_{p^{n}} \backslash\{0\}$. According to the denotations above, we consider affine subspaces $U$ of $\mathbb{F}_{p^{n}}$ such that $\sigma(U)$ are affine subspaces as well. We are interested in nontrivial subspaces that satisfy $2<|U|<p^{n}$ since any set $S$ of cardinality 1,2 (for $p=2$ ) or $p^{n}$ is always an affine subspace.

These subspaces are connected with invariant subspaces. If we know all $U$, we can construct all invariant affine subspaces for a function that is affinely equivalent to $\sigma$. Recall that $S \subseteq \mathbb{F}_{p^{n}}$ is an invariant set of $f$ if $f(S) \subseteq S$. Functions $f$ and $g$ are affinely equivalent if and only if $g(x)=A(f(B(x)+b))+a$ for all $x \in \mathbb{F}_{p^{n}}$, where $A$ and $B$ are invertible linear transformations, $a, b \in \mathbb{F}_{p^{n}}$. Similarly to subspaces, we consider linear transformations assuming that $\mathbb{F}_{p^{n}}$ is a vector space over $\mathbb{F}_{p}$.

The function $\sigma$ is interesting for cryptography. For instance, S-box of AES [8, 11] is based on $\sigma$. Its invariant linear subspaces were used to investigate group properties of the AES-like round functions [1, 2, 3]. An attack using an invariant subspace of several rounds of ciphering was introduced in [9]. A more general attack which can use an invariant set is also known [17]. Note that invariant sets for both of them may be constructed starting with S-boxes, see, for instance, [5, 7]. Note that D. Goldstein et al. and S. Mattarei proved that all invariant linear subspaces of the function $\sigma$ are subfields of $\mathbb{F}_{p^{n}}$, see [6, 16]. Thus, we generalize this result in two directions: for affine subspaces and for functions that are affinely equivalent to $\sigma$.

At the same time, if $f(U)$ is not an affine subspace for any 2-dimensional affine subspace $U$ of $\mathbb{F}_{2^{n}}$, then $f$ is an APN function [12]. Moreover, only APN functions satisfy this property. They are very important for cryptography. Also, there are many open questions in this area, see, for instance, [4]. If $p=2$ and $n$ is odd, then $\sigma$ is an APN function.

Our contribution is the following. In Section 2, we prove that both $U$ and $\sigma(U),|U|>2$, are affine subspaces if and only if $U=q \mathbb{F}_{p^{k}}$, where $q \in \mathbb{F}_{p^{n}}^{*}$ and $k \mid n$ (Theorem 2). Next, we show how to apply this to construct a function of the form $A(\sigma(x))+b$ without invariant affine subspaces, where $A$ is an invertible linear transformation and $b \in \mathbb{F}_{p^{n}}^{*}$. Section 3 contains a sufficient condition for such functions to have no nontrivial invariant affine subspaces (Theorem (3)). Also, for the function $\alpha \sigma(x)+b$, where $\alpha, b \in \mathbb{F}_{p^{n}}^{*}$, we provide a criterion on the existence of invariant affine subspaces excluding the whole $\mathbb{F}_{p^{n}}$ (Theorem 4). Section 4 demonstrates that the results obtained can theoretically prove that there are no nontrivial invariant affine subspaces for S-box of AES.

## 2 Subspaces that are mapped to subspaces

In this section we find all nontrivial affine subspaces $U$ such that $\sigma(U)$ is an affine subspace as well. We start with the following well known property of linear subspaces.

Lemma 1. Let $L$ be a linear subspace of $\mathbb{F}_{p^{n}}$ and $|L|>2$. Then $\sum_{x \in L} x=0$.
Proof. Let $s=\sum_{x \in L} x, s \in \mathbb{F}_{p^{n}}$. Let $p>2$. Since $(p-1) L=L$, it holds

$$
s=\sum_{x \in L} x=\sum_{x \in L}(p-1) x=(p-1) s .
$$

But $p-1 \neq 1$. This implies that $s=0$.
Let $p=2$. Then $\operatorname{dim} L \geq 2$ and $L=L^{\prime} \cup\left(a+L^{\prime}\right)$, where $L^{\prime}$ is a ( $\operatorname{dim} L-1$ )-dimensional linear subspace of $L, a \in L$. Therefore,

$$
s=\sum_{x \in L} x=\sum_{x \in L^{\prime}} x+\sum_{x \in L^{\prime}}(a+x)=2^{\operatorname{dim} L-1} a=0 .
$$

The lemma is proven.
Actually, it is enough to consider only linear subspaces.
Theorem 1. Let $U$ be an affine subspace of $\mathbb{F}_{p^{n}},|U|>2$ and $\sigma(U)$ be an affine subspace as well. Then $U$ is a linear subspace.

Proof. Let $U=a+L$ and $\sigma(U)=U^{\prime}=a^{\prime}+L^{\prime}$, where $L$ and $L^{\prime}$ are linear subspaces, $a, a^{\prime} \in \mathbb{F}_{p^{n}}$.

First of all, we prove some property of $U$ and $U^{\prime}$. Taking into account that $|U|>2$, Lemma 1 provides that

$$
\sum_{y \in \sigma(U)} y=\sum_{y \in L^{\prime}}\left(a^{\prime}+y\right)=p^{\operatorname{dim} U} a^{\prime}+\sum_{y \in L^{\prime}} y=0+0=0 .
$$

Since $\sigma(U)=\{\sigma(x+s): s \in L\}$ for any $x \in U$, we obtain that

$$
\begin{equation*}
\sum_{s \in L} \sigma(x+s)=0 \text { for any } x \in U \tag{1}
\end{equation*}
$$

Let us define the following polynomial $h$ over $\mathbb{F}_{p^{n}}$ :

$$
h(y)=\sum_{s \in L} \prod_{t \in L \backslash\{s\}}(y+t) .
$$

Now we prove by contradiction that $U$ is a linear subspace. Suppose that $U$ is not a linear subspace. Let $x$ be any element of $U$. Therefore, $x \neq s$ for any $s \in L$. At the same time, $x+s \neq 0$ since $-s \in L$ as well. As a result,

$$
h(x)=\sum_{s \in L} \prod_{t \in L \backslash\{s\}}(x+t)=\prod_{t \in L}(x+t) \sum_{s \in L} \sigma(x+s) \stackrel{(1)}{=} 0 .
$$

Thus, any $x \in U$ is a root of $h$. However, the degree of $h$ is less than $|U|=|L|$. Also, $h \not \equiv 0$ since

$$
h(0)=\prod_{t \in L \backslash\{0\}}(0+t)=\prod_{t \in L \backslash\{0\}} t \neq 0 .
$$

In other words, $h$ cannot have $|U|$ roots. This is a contradiction. Hence, $U$ is a linear subspace. The theorem is proven.

The rest of the proofs of this section use Hua's identity [13] (it can also be found in [14, 15]). They are very similar to ones proposed in [6, 16] for linear invariant subspaces of the function $\sigma$.

Lemma 2. Let $L$ and $\sigma(L)$ be linear subspaces of $\mathbb{F}_{p^{n}}$. Then $a^{2} \sigma(b) \in L$ for any $a, b \in L$.

Proof. Hua's identity

$$
a-\left(a^{-1}+\left(b^{\prime-1}-a\right)^{-1}\right)^{-1}=a b^{\prime} a
$$

holds for any $a, b^{\prime} \in \mathbb{F}_{p^{n}}, a, b^{\prime} \neq 0, a b^{\prime} \neq 1$. Note that it works not only for fields and can be easily proven.

Let $b^{\prime}=\sigma(b)$. It is clear that $a^{2} \sigma(b) \in L$ if $a=0, b^{\prime}=0$ or $a b^{\prime}=1$. Next, we consider other cases. It means that $b^{\prime}=b^{-1}$. Since $\sigma(\sigma(L))=L$ and both $L$ and $\sigma(L)$ are linear subspaces, the identity provides that

$$
\begin{gathered}
b-a=b^{\prime-1}-a \in L, \\
a^{-1}+(b-a)^{-1} \in \sigma(L), \\
a-\left(a^{-1}+(b-a)^{-1}\right)^{-1} \in L .
\end{gathered}
$$

Hence, $a b^{\prime} a=a^{2} \sigma(b) \in L$ as well. The lemma is proven.
The following theorem describes all considered subspaces.
Theorem 2. Let $U$ be an affine subspace of $\mathbb{F}_{p^{n}}$ and $|U|>2$. Then $\sigma(U)$ is an affine subspace if and only if $U=q \mathbb{F}_{p^{k}}$, where $k \mid n$ and $q \in \mathbb{F}_{p^{n}}^{*}$.

Proof. First of all, $\sigma\left(\mathbb{F}_{p^{k}}\right)=\mathbb{F}_{p^{k}}$ for $k \mid n$ since it is a subfield of $\mathbb{F}_{p^{n}}$. Also, $\sigma\left(q \mathbb{F}_{p^{k}}\right)=q^{-1} \sigma\left(\mathbb{F}_{p^{k}}\right)$ which is a linear subspace. The sufficient condition is proven.

Next, we prove the necessary condition. Let $L=U$ and $\sigma(L)$ be an affine subspace. By Theorem 1, $L$ is a linear subspace. In fact, $\sigma(L)$ is linear as well since $0 \in L$ and $\sigma(0)=0$. Without loss of generality we assume that $1 \in L$ since we can consider any $q L$ instead of $L, q \in \mathbb{F}_{p^{n}}^{*}$. Indeed, $\sigma(q L)$ is a linear subspace since $\sigma(q L)=q^{-1} \sigma(L)$. In light of that, we need only to prove that $L$ is a subfield of $\mathbb{F}_{p^{n}}$.

According to Lemma 2, $a^{2} \sigma(b) \in L$ for any $a, b \in L$. But $1 \in L$. It means that $\sigma(b) \in L$ and $a^{2} \in L$. As a consequence, $L=\sigma(L)$ and $a^{2} b, a^{2} \in L$ for any $a, b \in L$.

We know that $0,1 \in L, L$ is an additive subgroup and all inversions belong to $L$. The final step is to prove that $b c \in L$ for any $b, c \in L$. There are two cases.

Case 1. $p=2$. Let $b, c \in L$. Since $a^{2} \in L$ for any $a \in L$, there always exists $a \in L$ such that $c=a^{2}$. Thus, $b c=a^{2} b \in L$.

Case 2. $p \neq 2$. For any $b, c \in L$ it holds that $2 b c=(c+1)^{2} b-b-c^{2} b \in L$. Indeed, all these terms belong to $L$. Since $2 \in \mathbb{F}_{p}$ and $L$ is a linear subspace, $b c \in L$ as well.

Thus, $L$ is a subfield of $\mathbb{F}_{p^{n}}$, i.e. $L=\mathbb{F}_{p^{k}}$, where $k \mid n$. The theorem is proven.

Remark 1. Theorem 圆 shows that for prime $n>2$ and $p=2$ the $A P N$ function $\sigma$ maps any nontrivial affine subspace to a set that is not an affine subspace.

## 3 Functions without invariant subspaces

Here we show how to apply the results of Section 2 to construct functions without invariant affine subspaces of the form

$$
\sigma_{A, b}(x)=A(\sigma(x))+b
$$

where $A: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ is an invertible linear transformation and $b \in \mathbb{F}_{p^{n}}$. They are affinely equivalent to $\sigma$. Let us define

$$
\mathcal{S}\left(\mathbb{F}_{p^{n}}\right)=\left\{x \in \mathbb{F}_{p^{n}}: x \notin \mathbb{F}_{p^{k}}, \text { where } k \mid n \text { and } k<n\right\}
$$

In other words, $\mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ contains all elements of $\mathbb{F}_{p^{n}}$ which do not lie in its subfields. It is always nonempty.

Theorem 3．Let $A: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ be an invertible linear transformation， $b \in \mathbb{F}_{p^{n}}^{*}$ and

$$
\begin{equation*}
b^{-1} A\left(b^{-1}\right) \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right) . \tag{2}
\end{equation*}
$$

Then $\sigma_{A, b}$ has no invariant affine subspaces $U$ such that $2<|U|<p^{n}$ ．
Proof．Let $U$ be affine subspace of $\mathbb{F}_{p^{n}}$ and $\sigma_{A, b}(U)=U$ ，where $|U|>2$ ． Theorem 2 provides that $U=q^{-1} K$ and $b+A(q K)=U$ for some subfield $K$ of $\mathbb{F}_{p^{n}}$ and $q \in \mathbb{F}_{p^{n}}^{*}$ ．This is equivalent to

$$
\begin{equation*}
q b+q A(q K)=K \tag{3}
\end{equation*}
$$

Since $0 \in K$ ，（3）provides that $q b=q b+q A(q \cdot 0) \in K$ ．Thus，$q=b^{-1} u$ ， where $u \in K \backslash\{0\}$ ．According to（3），

$$
q b+q A\left(q \cdot u^{-1}\right)=q b+u b^{-1} A\left(b^{-1} u u^{-1}\right)=q b+u b^{-1} A\left(b^{-1}\right) \in K .
$$

At the same time，both $q b$ and $u$ belong to $K$ ．Hence，$b^{-1} A\left(b^{-1}\right) \in K$ ．As a result，$b^{-1} A\left(b^{-1}\right) \notin \bigcup_{k \mid n, k<n} \mathbb{F}_{p^{k}}$ implies that $U=K=\mathbb{F}_{p^{n}}$ ．
Remark 2．The condition（⿴囗⿱夂口）is equivalent to

$$
\begin{equation*}
b^{-1} \sigma_{A, b}(b) \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right) . \tag{4}
\end{equation*}
$$

Proof．Indeed，$b^{-1} \sigma_{A, b}(b)=b^{-1} A\left(b^{-1}\right)+1$ ．At the same time，$x \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ if and only if $x+1 \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ since 1 lies in any subfield of $\mathbb{F}_{p^{n}}$ ．
Remark 3．Recall that it is not difficult to determine if $x \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ ．It is enough to check that $x^{p^{k}} \neq x$ for any $k \mid n, k<n$ ．

Even if $A$ does not satisfy（2），we can modify it and obtain a function without nontrivial invariant subspaces．

Corollary 1．Let $A: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ be invertible linear transformation，$b \in \mathbb{F}_{p^{n}}^{*}$ ． Then the transformation $A^{\prime}: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ such that

$$
A^{\prime}(x)=\alpha \beta A(x) \text {, where } \alpha \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right) \text { and } \beta=\left(b^{-1} A\left(b^{-1}\right)\right)^{-1} \text {, }
$$

together with $b$ satisfy the conditions of Theorem 圂．
Proof．$A^{\prime}$ is defined correctly since $b^{-1} A\left(b^{-1}\right) \neq 0$ ．Indeed，$A(0)=0$ and $A$ is invertible．It means that $A\left(b^{-1}\right) \neq 0$ ．Let us check the properties of $A^{\prime}$ ．It is clear that $A^{\prime}$ is linear and invertible since it is a composition of two linear invertible transformations．Also，let us check（2））：

$$
b^{-1} A^{\prime}\left(b^{-1}\right)=b^{-1} \alpha\left(b^{-1} A\left(b^{-1}\right)\right)^{-1} A\left(b^{-1}\right)=\alpha .
$$

As a result，$A^{\prime}$ and $b$ satisfy the conditions of Theorem 3，

However, the proposed condition does not guarantee that $\sigma_{A, b}$ has no invariant affine subspaces $U$ such that $1 \leq|U| \leq 2$, see, for instance, the next section. It is clear that

- any $U=\{u\} \subseteq \mathbb{F}_{p^{n}}$ is invariant for $\sigma_{A, b}$ if and only if $u$ is a fixed point of $\sigma_{A, b}$,
- any $U=\{u, v\} \subseteq \mathbb{F}_{p^{n}}$, where $u \neq v$, is an invariant affine subspace if and only if $p=2$ and either $u, v$ are fixed point of $\sigma_{A, b}$ or $u=\sigma_{A, b}(v)$, $v=\sigma_{A, b}(u)$.
It is not easy to exclude these cases for arbitrary $A$. At the same time, we can do this for the simplest linear functions.

Theorem 4. Let $\alpha, b \in \mathbb{F}_{p^{n}}^{*}, \sigma_{\alpha, b}: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ such that

$$
\sigma_{\alpha, b}(x)=\alpha \sigma(x)+b .
$$

Then $\sigma_{\alpha, b}$ has no invariant affine subspaces except for $\mathbb{F}_{p^{n}}$ if and only if

- $\alpha b^{-2} \in M_{2}$ for $p=2$, where

$$
\begin{equation*}
M_{2}=\left\{x \in \mathcal{S}\left(\mathbb{F}_{2^{n}}\right): \operatorname{tr}(x)=1\right\}, \operatorname{tr}(x)=x^{2^{0}}+x^{2^{1}}+\ldots+x^{2^{n-1}} \tag{5}
\end{equation*}
$$

- $\alpha b^{-2}+4^{-1} \in M_{p}$ for $p \neq 2$, where

$$
\begin{equation*}
M_{p}=\left\{x \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right): x \neq y^{2} \text { for any } y \in \mathbb{F}_{p^{n}}\right\} . \tag{6}
\end{equation*}
$$

Proof. Let $U$ be an invariant affine subspace of $\sigma_{\alpha, b}$. We consider a criterion of the existence of such $U$ depending on $|U|$.

Case 1. $2<|U|<p^{n}$, i.e. $U$ is nontrivial. According to Theorem 3, $\alpha b^{-2} \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ implies that such $U$ does not exist. Let us prove that such $U$ exists if $\alpha b^{-2} \notin \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$, i.e. $\alpha b^{-2} \in K$ for some subfield $K$ of $\mathbb{F}_{p^{n}},|K|<\left|p^{n}\right|$. According to (3), if

$$
q b+q \alpha q x \in K \text { for any } x \in K,
$$

then $U=q K$ is invariant. Let $q=b^{-1}$. Then, $1+\left(\alpha b^{-2}\right) x \in K$ for any $x \in K$. In other words, $U=b^{-1} K$ is invariant.

Thus, such $U$ does not exist if and only if $\alpha b^{-2} \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$. Also, if $p \neq 2$, we can see that $\alpha b^{-2} \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ if and only if $\alpha b^{-2}+4^{-1} \in \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$ since $4^{-1}$ lies in any subfield of $\mathbb{F}_{p^{n}}$.

Case 2. $|U|=1$, i.e. we consider fixed points of $\sigma_{\alpha, b}$. Let $x \in \mathbb{F}_{p^{n}}^{*}$ since 0 is not a fixed point of $\sigma_{\alpha, b}$. Then $x$ is a fixed point if and only if

$$
\alpha x^{-1}+b=x \text {. }
$$

Multiplying both parts by $x b^{-2} \neq 0$, we obtain the following equivalent equation:

$$
\begin{equation*}
y^{2}-y-\alpha b^{-2}=0, \text { where } y=x b^{-1} \tag{7}
\end{equation*}
$$

Case 2.1. $p=2$. It is known that the equation (7) has a solution if and only if $\operatorname{tr}\left(\alpha b^{-2}\right)=0$, see, for instance, [10].

Case 2.2. $p \neq 2$. The equation (7) has a solution if and only if $(y-$ $\left.2^{-1}\right)^{2}=4^{-1}+\alpha b^{-2}$ has a solution. Thus, there is a fixed point if and only if $\alpha b^{-2}+4^{-1} \in\left\{x^{2}: x \in \mathbb{F}_{p^{n}}\right\}$.

Case 3. $|U|=2$, i.e. $U=\{x, y\} \subseteq \mathbb{F}_{p^{n}}, x \neq y$. Let $U$ be invariant. Then

$$
\begin{array}{r}
\alpha \sigma(\alpha \sigma(x)+b)+b=x \text {, i.e. } \\
\quad \alpha \sigma(x)+b=\alpha \sigma(x-b) . \tag{8}
\end{array}
$$

Case 3.1. $x \in\{0, b\}$. If $x=0$, then $\alpha \sigma(0)+b=b \neq 0$. Let $x=b$. According to (8), $\alpha \sigma(b)+b=0 \neq b$. In other word, $U=\{0, b\}$ for both cases. Also, $\alpha \sigma(b)+b=0$ is equivalent to $\alpha b^{-2}=-1$. Moreover, it is not difficult to see that $\sigma_{\alpha, b}(\{0, b\})=\{0, b\}$ if and only if $\alpha b^{-2}=-1$. At the same time, $-1 \notin \mathcal{S}\left(\mathbb{F}_{p^{n}}\right)$.

Case 3.2. $x \notin\{0, b\}$. We multiply both parts of the last equation by $b^{-2} x(x-b)$ :

$$
\begin{gathered}
b^{-2} x(\alpha \sigma(x)+b)(x-b)=b^{-2} x \alpha \text {, i.e. } \\
b^{-2}\left(b x^{2}-\alpha b-b^{2} x\right)=b^{-2}(\alpha-\alpha \sigma(x) x) x \text {, or, equivalently, } \\
\left(x b^{-1}\right)^{2}-x b^{-1}-\alpha b^{-2}=0
\end{gathered}
$$

Since it is equivalent to (7), $x$ is a fixed point of $\sigma_{\alpha, b}$, see case 2 .
Finally, $\mathbb{F}_{p^{n}}$ is the only invariant affine subspace of $\sigma_{\alpha, b}$ if and only if $\alpha b^{-2} \in M_{2}$ for $p=2$ and $\alpha b^{-2}+4^{-1} \in M_{p}$ for $p \neq 2$.

Remark 4. The sets $M_{p}$ defined in (5) and (6) are nonempty.
Proof. It is straightforward that $\left|\left\{x \in \mathbb{F}_{2^{n}}: \operatorname{tr}(x)=1\right\}\right|=2^{n-1}$ and $\mid\{x \in$ $\mathbb{F}_{p^{n}}: x \neq y^{2}$ for any $\left.y \in \mathbb{F}_{p^{n}}\right\} \left\lvert\,=\frac{1}{2}\left(p^{n}-1\right)\right.$. At the same time, we can estimate the number of elements that lie in subfields of $\mathbb{F}_{p^{n}}$ :

$$
\left|\bigcup_{k \mid n, k<n} \mathbb{F}_{p^{k}}\right|<1+p+p^{2}+\ldots+p^{n-2}=\frac{p^{n-1}-1}{p-1}, \text { where } n \geq 3
$$

This implies that $M_{p}$ is nonempty for $n \geq 3$. It is not difficult to check that $M_{p}$ is nonempty for $n=1,2$ as well.

Theorem 4 allows us to construct a permutation of an arbitrary $\mathbb{F}_{p^{n}}$ without invariant affine subspaces (except for the whole $\mathbb{F}_{p^{n}}$ ). However, its algebraic structure is very simple. Also, if $n$ is not prime, there always exists a linear subspace $L \neq \mathbb{F}_{p^{n}}$ such that $\sigma_{\alpha, b}(u+L)=v+L$ for some $u, v \in \mathbb{F}_{p^{n}}$. This makes the function $\sigma_{\alpha, b}$ not very good for cryptography.

## 4 S-box of AES

The Advanced Encryption Standard (AES) is the most popular block cipher whose S-box $S: \mathbb{F}_{2}^{8} \rightarrow \mathbb{F}_{2}^{8}$ (see [8, Figure 7]) is based on the function $\sigma_{A, b}$ for certain invertible linear transformation $A$ and $b \in \mathbb{F}_{2^{8}}$, see [8, 11]. The field $\mathbb{F}_{2^{8}}$ is constructed as the quotient ring of polynomials modulo

$$
m(x)=x^{8}+x^{4}+x^{3}+x+1 \text { over } \mathbb{F}_{2}
$$

and $b=x^{6}+x^{5}+x+1=0 \times 63$. Let us consider its invariant subspaces.

- Nontrivial affine subspaces. It can be shown that $t=b^{-1} S(b) \in$ $\mathcal{S}\left(\mathbb{F}_{2^{8}}\right)$. Indeed, $S(b)=x^{7}+x^{6}+x^{5}+x^{4}+x^{3}+x+1=0 \mathrm{xFB}$. It is not difficult to check that $t=x^{7}+x^{6}+x^{3}=0 \mathrm{xC8}$. Also,

$$
\begin{aligned}
t^{2} & =x^{6}+x^{5}+x^{4}+1 \neq t \\
t^{2^{2}} & =x^{7}+x^{6}+x^{4}+x^{3}+x^{2}+1 \neq t \\
t^{2^{4}} & =x^{7}+x^{4}+x^{3}+1 \neq t
\end{aligned}
$$

Hence, $t \in \mathcal{S}\left(\mathbb{F}_{2^{8}}\right)$. In other words, Theorem 3 and Remark 2 guarantee that $S$ has no nontrivial invariant affine subspaces.

- Fixed points. It is known that $S(x) \neq x$ for any $x \in \mathbb{F}_{2}^{8}$ by the choice, see [11]. Therefore, $S$ has no invariant affine subspaces of dimension 0 .
- However,

$$
S(0 \mathrm{x} 73)=0 \mathrm{x} 8 \mathrm{~F} \text { and } S(0 \mathrm{x} 8 \mathrm{~F})=0 \mathrm{x} 73 .
$$

This implies that

$$
\{0 \times 73,0 \times 8 F\}=\left\{x^{6}+x^{5}+x^{4}+x+1, x^{7}+x^{3}+x^{2}+x+1\right\}
$$

is its invariant affine subspace of dimension 1 .
Thus, the results obtained allow us to prove theoretically that $S$ has no nontrivial invariant affine subspaces. At the same time, it has an invariant affine subspace of dimension 1 .
