# BILINEAR OPTIMAL CONTROL FOR WEAK SOLUTIONS OF THE KELLER-SEGEL LOGISTIC MODEL IN $2 D$ DOMAINS

#### Abstract

An optimal control problem associated to the Keller-Segel with logistic reaction system will be studied in $2 D$ domains. The control acts in a bilinear form only in the chemical equation. The existence of optimal control and a necessary optimality system are deduced. The main novelty is that control can be rather singular and the state (cell density $u$ and the chemical concentration $v$ ) remains only in a weak setting, which is not usual in the literature to solve optimal control problems subject to chemotaxis models (see e.g. [16]).


## 1. Introduction

1.1. The controlled model. In this work we study an optimal control problem for the (attractive or repulsive) Keller-Segel model in a $2 D$ domain $\Omega \subset \mathbb{R}^{2}$ with logistic source term and bilinear control acting on the chemical equation:

Here, $f: Q_{c}:=(0, T) \times \Omega_{c} \rightarrow \mathbb{R}$ is the control with $\Omega_{c} \subset \Omega \subset \mathbb{R}^{2}$ the control domain, and the states $u, v: Q:=(0, T) \times \Omega \rightarrow \mathbb{R}_{+}^{2}$ are the cellular density and chemical concentration, respectively. Moreover, $r \in \mathbb{R}$ and $\mu>0$ are coefficients of the

[^0]logistic reaction, and $\kappa \in \mathbb{R}$ is the chemotaxis coefficient ( $\kappa>0$ models attraction and $\kappa<0$ repulsion). We are interested in the study of a control problem associated to the following weak solution concept of system (1.1). Hereafter, $L^{2+}$ means $L^{2+\varepsilon}$ for $\varepsilon$ small enough.

Definition 1.1. Let $f \in L^{2+}\left(Q_{c}\right):=L^{2+}\left(0, T ; L^{2+}\left(\Omega_{c}\right)\right), u_{0} \in L^{2}(\Omega), v_{0} \in$ $W^{1+, 2+}(\Omega)$ with $u_{0} \geq 0$ and $v_{0} \geq 0$ a.e. in $\Omega$. A pair $(u, v)$ is called a weak solution of problem (1.1) in $(0, T)$, if

the equation (1.1) ${ }_{1}$ jointly boundary condition for $u$ hold in a variational sense, while equation (1.1) $)_{2}$ and the boundary condition for $v$ are satisfied pointwisely, and initial conditions $(1.1)_{3}$ and $(1.1)_{4}$ are satisfied in $L^{2}(\Omega)$ and $W^{1+, 2+}(\Omega)$, respectively.

Notice that, since we are in $2 D$ bounded domains, $v \in C\left([0, T] ; W^{1+, 2+}\right)$ implies $v \in L^{\infty}\left(0, T ; L^{\infty}\right)$, hence using that $f \in L^{2+}\left(Q_{c}\right)$ one has $f v \in L^{2+}(Q)$. That means that $v \in X_{2+}$ is the maximal regularity which can be obtained. The previous weak regularity for $u \in W_{2}$ will be enough to solve the following optimal control problem.

where $\left(u_{d}, v_{d}\right) \in L^{2}(Q)^{2}$ represent the target states and the nonnegative numbers $\gamma_{u}, \gamma_{v}$ and $\gamma_{f}$ measure the cost of the states and control, respectively. With respect to the control constraint, we assume

The functional $J$ defined in (1.2) describes the deviation of the cell density $u$ and the chemical concentration $v$ from a target cell density $u_{d}$ and chemical concentration $v_{d}$, respectively; plus the cost of the control $f$ measured in the $L^{2+}$-norm.
1.2. Previous results. Before continuing our discussion, let us give some motivation for the study of (1.1). In the last decades, there has been a surge of activity on the study of the chemotaxis model which describes the movement of the cells directed by the concentration gradient of a chemical substance in their environment. Moreover, it is important to consider the biological situation where the bacterial population may proliferate according to a logistic law. An interesting feature in chemotaxis corresponds to the movement of cells directed by the gradient of the chemical signal which is produced by cells themselves. When one considers also the interactions between cells and the chemical signal with liquid environments, one gets the chemotaxis-fluid system, which is basically the chemotaxis model coupled with the Navier-Stokes equations. For more details, see the excellent review [4] and the references therein.

Let us recall some issues related to the uncontrolled equations (1.1), i.e., when $f \equiv 0$. Plenty of results have been obtained here. Amongst the many articles related to the uncontrolled sysstem, let us mention those on existence of weak and strong solutions in $\mathbb{R}^{2}$. In this case, without considering logistic reaction (i.e. $r=\mu=0$ ), the existence of global weak solutions was provided by Liu and Lorz [24]. In twodimensional bounded convex domains, the existence of (global) classical solutions was obtained by M. Winkler [33]. In the presence of logistic source, the existence of global weak solutions (and the long time behavior) has been analyzed in [21] by J. Lankeit. In this case, the existence of global mild solutions was examined in [12]. For 3D domains, we also refer [34] and the references therein.

It is important to mention that remarkable progress has been made in mathematical and numerical analysis of optimal control problems for viscous flows described by the Navier-Stokes equations and other related models, see e.g., [1, 7, 26]. However, the literature related to optimal control for chemotaxis problems is still scarce. In [27], the authors study an optimal (distributed) control problem where the state problem is given by a stationary chemotaxis model coupled with the Navier-Stokes equations. We note that in $[8,9]$ the authors provide some results related to the controllability for the nonstationary Keller-Segel system and the nonstationary chemotaxis-fluid model with consumption of chemoattractant substance associated to a chemotaxis system, based on Carleman-type estimates for the solutions of the adjoint system. Recently, a bilinear optimal control problem associated to the chemotaxis-Navier-Stokes model (without logistic source) in bounded threedimensional domains was examined in [25]. For the chemo-repulsion case, this problem was studied in [16, 18] for $2 D$ and $3 D$ domains respectively, and in [17] for $2 D$ domains with a potential nonlinear production term, that is changing the production term $u$ in the $v$ equation by $u^{p}$, with $p>1$.
1.3. Main contributions of the paper. First of all, we will prove the existence and uniqueness of weak solutions of (1.1) and the continuous dependence of the weak solution $(u, v)$ respect the control $f$.

Theorem 1.2. Let $u_{0} \in L^{2}(\Omega), v_{0} \in W^{1+, 2+}(\Omega)$ with $u_{0} \geq 0$ and $v_{0} \geq 0$ in $\Omega$, and $f \in L^{2+}\left(Q_{c}\right)$. There exists a unique weak solution (u,v) of system (1.1) in sense of Definition 1.1. Moreover, there exists a positive constant

Finally, for any $r, \mu, \kappa, \Omega, T, u_{0}, v_{0}$, the constant $\mathcal{K}_{1}$ is bounded if $f$ is bounded in $L^{2+}\left(Q_{c}\right)$.

The second main result of this paper will be the existence of a global optimal solution of (1.2):

Theorem 1.3. Let $\left(u_{0}, v_{0}\right) \in L^{2}(\Omega) \times W^{1+, 2+}(\Omega)$ with $u_{0} \geq 0$ and $v_{0} \geq 0$ in $\Omega$. Assuming that either $\gamma_{f}>0$ or $\mathcal{F}$ is bounded in $L^{2+}\left(Q_{c}\right)$, then the bilinear optimal control problem (1.2) has at least one global optimal solution $(\tilde{u}, \tilde{v}, \tilde{f})$.

Finally, we obtain the existence and uniqueness of Lagrange multipliers associated to the optimal control (1.2):

Theorem 1.4. Let $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in \mathcal{S}_{a d}$ be a local optimal solution for the control problem (1.2). Then, there exists a unique Lagrange multiplier $(\lambda, \eta) \in X_{2} \times W_{2}$ satisfying the optimality system

Remark 1.5. If $\gamma_{f}>0$ and there is no convexity constraint on the control, that is, $\mathcal{F} \equiv L^{2+}\left(Q_{c}\right)$, then optimality condition (1.4) $)_{5}$ becomes

The rest of the paper is organized as follows. In Section 2 some Preliminairy results which will be used later are introduced. The proofs of Theorems 1.2, 1.3 and 1.4 are given in Sections 3, 4 and 5 respectively.

## 2. Preliminary Results

Along this manuscript the following result on $L^{p}$ regularity will be considered.
Theorem 2.1 ( [13], page 344). For $\Omega \in C^{2}$, let $1<p<3, u_{0} \in W^{2-2 / p, p}(\Omega)$ and $g \in L^{p}(Q)$. Then the problem

admits a unique solution $u$ such that

Moreover, there exists a positive constant $C:=C(p, \Omega, T)$ such that

The existence of solutions of some initial and boundary-value problems will be proven by means of:

Theorem 2.2 (Leray-Schauder fixed-point Theorem). Let $\mathcal{X}$ a Banach space and $T: \mathcal{X} \rightarrow \mathcal{X}$ a continuous and compact operator. If the set

In this paper, the following two compactness results will be applied.
Theorem 2.3 (Aubin-Lions lemma). (See [22, Théorème 5.1, p. 58].) Let $\mathcal{X}, B$ and $\mathcal{Y}$ be reflexive Banach spaces such that $\mathcal{X} \subset B \subset \mathcal{Y}$, with compact embedding $\mathcal{X} \mapsto B$ and continuous embedding $B \hookrightarrow \mathcal{Y}$. It is defined

for a finite $T>0$ and $p_{0}, p_{1} \in(1,+\infty)$. Then, the injection of $W$ into $L^{p_{0}}(0, T ; B)$ is compact.

Theorem 2.4 (Simon's compactness result). (See [30, Corollary 4].) Let $\mathcal{X}, B$ and $\mathcal{Y}$ be Banach spaces such that $\mathcal{X} \subset B \subset \mathcal{Y}$, with compact embedding $\mathcal{X} \mapsto B$ and continuous embedding $B \hookrightarrow \mathcal{Y}$. Let $F$ be a bounded set in $L^{\infty}(0, T ; \mathcal{X})$ such that the set $\partial_{t} F=\left\{\frac{\partial f}{\partial t} ; f \in F\right\}$ is bounded in $L^{r}(0, T ; \mathcal{Y})$ for some $r>1$. Then $F$ is relatively compact in $C([0, T] ; B)$.

## 3. Proof of Theorem 1.2

The proof of Theorem 1.2 will be made in the next two subsections. For the existence, we use the Leray-Schauder fixed point theorem. The uniqueness is get by a comparison argument.
3.1. Existence. Let us introduce the spaces

and the operator $R: \mathcal{X}_{u} \times \mathcal{X}_{v} \rightarrow W_{2} \times X_{2+} \hookrightarrow \mathcal{X}_{u} \times \mathcal{X}_{v}$ defined by $R(\bar{u}, \bar{v})=(u, v)$ is the solution of the decoupled linear problem

where $\bar{u}_{+}:=\max \{\bar{u}, 0\} \geq 0, \bar{v}_{+}:=\max \{\bar{v}, 0\} \geq 0$. In fact, first we compute $v$ and after $u$. In the following lemmas we will prove the hypotheses of Leray-Schauder fixed point theorem.

Lemma 3.1. The operator $R: \mathcal{X}_{u} \times \mathcal{X}_{v} \rightarrow \mathcal{X}_{u} \times \mathcal{X}_{v}$ is well defined and compact.
Proof. Since $f \in L^{2+}\left(Q_{c}\right)$ and $\bar{v} \in L^{\infty}(Q)$ implies $f \bar{v} \in L^{2+}(Q)$, hence there exists a unique $v \in X_{2+}$ solution of the $v$-problem in (3.2). By considering the linear parabolic $u$-problem in (3.2), one has $u \in W_{2}$ owing to $v \in X_{2+}$, hence $\nabla v \in L^{4+}(Q)$ and then $\bar{u}_{+} \nabla v \in L^{2}(Q)$. Finally, since $R$ maps bounded sets of $\mathcal{X}_{u} \times \mathcal{X}_{v}$ into bounded sets of $W_{2} \times X_{2+}$, then $R$ is compact from $\mathcal{X}_{u} \times \mathcal{X}_{v}$ to itself.

Lemma 3.2. The set

is bounded in $\mathcal{X}_{u} \times \mathcal{X}_{v}$ (independently of $\alpha \in[0,1]$ ). In fact, $T_{\alpha}$ is also bounded in $W_{2} \times X_{2+}$, because there exists

Proof. Let $(u, v) \in T_{\alpha}$ for $\alpha \in(0,1]$ (the case $\alpha=0$ is trivial). Then, owing to Lemma 3.1, $(u, v) \in W_{2} \times X_{2+}$ and satisfies the following problem:

endowed with the corresponding initial and boundary conditions. Therefore, it suffices to look for a bound of $(u, v)$ in $W_{2} \times X_{2+}$ independent of $\alpha$. This bound is carried out into six steps:

Step 1: Non-negativity: $u, v \geq 0$.
By taking in (3.6) $1_{1} \varphi=u_{-}:=\min \{u, 0\} \leq 0$ (that is possible because $u \in L^{2}\left(H^{1}\right)$ ), and considering that $u_{-}=0$ if $u \geq 0, \nabla u_{-}=\nabla u$ if $u \leq 0$, and $\nabla u_{-}=0$ if $u>0$, we have

thus $u_{-} \equiv 0$ and, consequently, $u \geq 0$. Similarly, testing (3.6) $)_{2}$ by $v_{-}:=\min \{v, 0\} \leq$ 0 we obtain

which implies $v_{-} \equiv 0$, then $v \geq 0$. Therefore $\left(u_{+}, v_{+}\right)=(u, v)$. In particular, $(u, v, f)$ is also the solution of problem (3.6) changing $u_{+}$by $u$ and $v_{+}$by $v$. Therefore, fixed-point of $R$ are in particular weak solutions of problem (1.1).

Step 2: Boundedness of $\int_{\Omega} u(x, t) d x$.
By taking $\varphi=1$ in $(3.6)_{1}$, we obtain:

Using the change of variable $y(t)=\int_{\Omega} u(x, t) d x,(3.8)$ becomes:

$z(t) \geq z(0) e^{-r t}+\frac{\mu}{r|\Omega|}\left(1-e^{-r t}\right) \geq z(0) e^{-r t}+z(0)\left(1-e^{-r t}\right)=z(0)$ and therefore

Integrating directly in $(0, T)$ for a fixed $T$ in (3.7), and using (3.14), we obtain that:

Taking $v$ as test function in (3.6) $)_{2}$, we obtain:

\text { because }(\alpha \in(0,1]) & \leq\|u\|_{L^{2}}\|v\|_{L^{2}}+\|f\|_{L^{2}}\|v\|_{L^{4}}^{2}  \tag{3.17}\\
& \leq\|u\|_{L^{2}}\|v\|_{L^{2}}+\|f\|_{L^{2}}\|v\|_{L^{2}}\|v\|_{H^{1}} \\
& \leq \delta\|v\|_{H^{1}}^{2}+C_{\delta}\left(\|u\|_{L^{2}}^{2}+\|f\|_{L^{2}}^{2}\|v\|_{L^{2}}^{2}\right)
\end{align*}
$$

where we used the following standard inequality in 2D domains

Therefore, by taking $\delta$ small enough,

From Gronwall's lemma, and thanks to the boundedness of $u$ and $f$ in $L^{2}(Q)$, one has $v$ bounded in $L^{\infty}\left(0, T ; L^{2}(\Omega)\right) \cap L^{2}\left(0, T ; H^{1}(\Omega)\right)$.

By taking $-\Delta v$ as test function in $(3.6)_{2}$, we obtain:

& \leq\|u\|_{L^{2}}\|\Delta v\|_{L^{2}}+\|f\|_{L^{2+}}\|v\|_{H^{1}}\|\Delta v\|_{L^{2}}  \tag{3.19}\\
& \leq \delta\left(\|\Delta v\|_{L^{2}}^{2}+\|v\|_{H^{1}}^{2}\right)+C_{\delta}\left(\|u\|_{L^{2}}^{2}+\|f\|_{L^{2}}^{2}\|v\|_{H^{1}}^{2}\right)
\end{align*}

Adding (3.17) to (3.19), we obtain:

From Gronwall's lemma, one has $v$ bounded in $L^{\infty}\left(0, T ; H^{1}(\Omega)\right) \cap L^{2}\left(0, T ; H^{2}(\Omega)\right)$.
Step 5: $u$ is bounded in $L^{\infty}\left(0, T ; L^{2}(\Omega)\right) \cap L^{2}\left(0, T ; H^{1}(\Omega)\right)$.
By testing (3.6) $)_{1}$ by $u$, after a few computations, we get,

\leq C\|u\|_{L^{2}}^{2}\|\nabla v\|_{L^{4}}^{4}+\frac{1}{2}\|u\|_{H^{1}}^{2}+\left(r_{+}+1\right)\|u\|_{L^{2}}^{2},
\end{array}

Then, we arrive at

Therefore, applying the Gronwall lemma and using Step 4, we obtain that $u$ is bounded in $L^{\infty}\left(0, T ; L^{2}(\Omega)\right) \cap L^{2}\left(0, T ; H^{1}(\Omega)\right)$.

Step 6: $v$ is bounded in $L^{\infty}\left(0, T ; W^{1+, 2+}(\Omega)\right) \cap L^{2+}\left(0, T ; W^{2,2+}(\Omega)\right)$. From Step 4 we can deduce that $v \in L^{\infty-}(Q)$, and from Step 5, we can deduce that $u \in L^{4}(Q)$. Therefore, $u+f v \in L^{2+}(Q)$. Then, heat regularity result in Theorem 2.1, allows us to deduce that $v \in X_{2^{+}}$and the corresponding bound on $X_{2^{+}}$depending on $\left\|v_{0}\right\|_{W^{1+}, 2^{+}}(\Omega)$ and the bound of $u+f v$ in $L^{2+}(Q)$.

This finishes Lemma 3.2.
Lemma 3.3. The operator $R: \mathcal{X}_{u} \times \mathcal{X}_{v} \rightarrow \mathcal{X}_{u} \times \mathcal{X}_{v}$, defined in (3.2), is continuous.
The proof is similar to Lemma 3.4 in [16].

Consequently, from Lemmas 3.1, 3.2 and 3.3, it follows that the operator $R$ satisfy the conditions of the Leray-Schauder fixed-point theorem. Thus, we conclude that the map $R(\bar{u}, \bar{v})$ has at least a fixed point, $R(u, v)=(u, v)$, which is a weak solution to system (1.1) in ( $0, T$ ).
Finally, we observe that estimate (1.3) follows the same steps giving in the proof of Lemma 3.2 (now for the case $\alpha=1$ ).
3.2. Uniqueness of solution. This proof follows the same argument than in [16], but it is included here for reader convenience. Let $\left(u_{1}, v_{1}\right),\left(u_{2}, v_{2}\right) \in W_{2} \times X_{2}$ two weak solutions of system (1.1). Substracting equations (1.1) for ( $u_{1}, v_{1}$ ) and $\left(u_{2}, v_{2}\right)$, and denoting $u:=u_{1}-u_{2}$ and $v:=v_{1}-v_{2}$, we obtain the following system

u(0, \cdot) & =0, v(0, \cdot)=0 \text { in } \Omega \\
\frac{\partial u}{\partial \mathbf{n}} & =0, \frac{\partial v}{\partial \mathbf{n}}=0 \text { on }(0, T) \times \partial \Omega
\end{align*}\right.
$$

Testing (3.22) $)_{1}$ by $u \in L^{2}\left(H^{1}\right)$ and $(3.22)_{2}$ by $-\Delta v \in L^{2}(Q)$ we have (3.23)

\begin{aligned}
\frac{1}{2} \frac{d}{d t}\left(\|u\|^{2}+\|\nabla v\|^{2}\right) & +\|\nabla u\|^{2}+\|\Delta v\|^{2}+\|\nabla v\|^{2}+\mu \int_{\Omega} u^{2}\left(u_{1}+u_{2}\right) d x \\
& =r\|u\|^{2}+\kappa\left(u_{1} \nabla v+u \nabla v_{2}, \nabla u\right)+(u+f v,-\Delta v)
\end{aligned}
$$

The term $\mu \int_{\Omega} u^{2}\left(u_{1}+u_{2}\right) d x$ has the good sign.

Applying the Hölder and Young inequalities, we obtain

& \leq \delta\left(\|\nabla v\|_{H^{1}}^{2}+\|\nabla u\|^{2}\right)+C \delta\left\|u_{1}\right\|_{L^{4}}^{4}\|\nabla v\|^{2},  \tag{3.24}\\
\left(u \nabla v_{2}, \nabla u\right) & \leq\|u\|_{L^{4}}\left\|\nabla v_{2}\right\|_{L^{4}}\|\nabla u\| \leq C\|u\|^{1 / 2}\|u\|_{H^{1}}^{1 / 2}\left\|\nabla v_{2}\right\|_{L^{4}}\|\nabla u\| \\
& \leq \delta\|u\|_{H^{1}}^{2}+C_{\delta}\left\|\nabla v_{2}\right\|_{L^{4}}^{4}\|u\|^{2},  \tag{3.25}\\
)(u,-\Delta v) & \leq \delta\|\Delta v\|^{2}+C_{\delta}\|u\|^{2}, \\
)(f v,-\Delta v) & \leq\|f\|_{L^{2+}}\|v\|_{H^{1}}\|\Delta v\|_{L^{2}} \leq \delta\|v\|_{H^{2}}^{2}+C_{\delta}\|f\|_{L^{2+}}^{2}\|v\|_{H^{1}}^{2} . \tag{3.27}
\end{align*}
$$

Adding (3.17) to (3.23), and using (3.24)-(3.27), we obtain:

& \quad \leq C\left(\|u\|^{2}+\left\|u_{1}\right\|_{L^{4}}^{4}\|\nabla v\|^{2}+\left\|\nabla v_{2}\right\|_{L^{4}}^{4}\|u\|^{2}+\|f\|_{L^{2+}}^{2}\|v\|_{H^{1}}^{2}\right)
\end{align*}
$$

In order to consider the completed norm for $v$, we take $v$ as test function in $(3.22)_{2}$, we obtain:

Since $\left\|u_{1}\right\|_{L^{4}}^{4}+\left\|\nabla v_{2}\right\|_{L^{4}}^{4}+\|f\|_{L^{2+}}^{2} \in L^{1}(0, T)$ and $u_{0}=v_{0}=0$, then Gronwall lemma implies uniqueness.

Thus, the proof of Theorem 1.2 is finished.

## 4. Proof of Theorem 1.3

The admissible set for the optimal control problem (1.2) is defined by

From Theorem 1.2 one has $\mathcal{S}_{a d} \neq \emptyset$. Let $\left\{s_{m}\right\}_{m \in \mathbb{N}}:=\left\{\left(u_{m}, v_{m}, f_{m}\right)\right\}_{m \in \mathbb{N}} \subset \mathcal{S}_{a d}$ be a minimizing sequence of $J$, that is, $\lim _{m \rightarrow+\infty} J\left(s_{m}\right)=\inf _{s \in \mathcal{S}_{a d}} J(s)$. Then, by definition of $\mathcal{S}_{a d}$, for each $m \in \mathbb{N}, s_{m}$ satisfies system $(3.7)_{1}$ variationally in $L^{2}\left(\left(H^{1}\right)^{\prime}\right)$ and $(3.7)_{2}$ a.e. $(t, x) \in Q$.
From the definition of $J$ and the assumption $\gamma_{f}>0$ or $\mathcal{F}$ is bounded in $L^{2+}\left(Q_{c}\right)$, it follows that

From (3.4)-(3.5) there exists a positive constant $C$, independent of $m$, such that

Therefore, from (4.1), (4.2), and taking into account that $\mathcal{F}$ is a closed convex subset of $L^{2+}\left(Q_{c}\right)$ (hence is weakly closed in $L^{2+}\left(Q_{c}\right)$ ), it is deduced that there exists $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in W_{2} \times X_{2+} \times \mathcal{F}$ such that, for some subsequence of $\left\{s_{m}\right\}_{m \in \mathbb{N}}$, still denoted by $\left\{s_{m}\right\}_{m \in \mathbb{N}}$, the following convergences hold, as $m \rightarrow+\infty$ :

\partial_{t} u_{m} & \rightarrow \partial_{t} \tilde{u} \quad \text { weakly in } L^{2}\left(\left(H^{1}\right)^{\prime}\right),  \tag{4.5}\\
\partial_{t} v_{m} & \rightarrow \partial_{t} \tilde{v} \quad \text { weakly in } L^{2+}(Q),  \tag{4.6}\\
f_{m} & \rightarrow \tilde{f} \quad \text { weakly in } L^{2+}\left(Q_{c}\right), \text { and } \tilde{f} \in \mathcal{F} . \tag{4.7}
\end{align*}
$$

From (4.3)-(4.6), and using Sobolev embedding and Aubin-Lions compactness results, one has

v_{m} & \left.\rightarrow \tilde{v} \quad \text { strongly in } L^{\infty}(Q)\right) .  \tag{4.9}\\
\left(u_{m}, \nabla v_{m}\right) & \left.\rightarrow(\tilde{u}, \nabla \tilde{v}) \quad \text { strongly in } L^{4-}(Q)\right) \times L^{4+}(Q) . \tag{4.10}
\end{align*}
$$

In particular, using (4.7), (4.9) and (4.10) the limit of the nonlinear terms of (3.7) can be controlled as follows

Moreover, from (4.8), ( $\left.u_{m}(0), v_{m}(0)\right)$ converges to $(\tilde{u}(0), \tilde{v}(0))$ in $H^{1}(\Omega)^{\prime} \times L^{2}(\Omega)$, and since $u_{m}(0)=u_{0}, v_{m}(0)=v_{0}$, it is deduced that $\tilde{u}(0)=u_{0}$ and $\tilde{v}(0)=v_{0}$. Thus, $\tilde{s}$ satisfies the initial conditions given in (1.1). Therefore, considering the convergences (4.3)-(4.12), and taking the limit in equation (3.6) replacing ( $u, v, f$ ) by $\left(u_{m}, v_{m}, f_{m}\right)$, as $m$ goes to $+\infty$, it is possible to conclude that $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f})$ is a weak solution of the system (1.1), that is, $\tilde{s} \in \mathcal{S}_{a d}$. Therefore,

## 5. Proof of Theorem 1.4

### 5.1. A generic Lagrange multipliers theorem.

We introduce a Lagrange multipliers theorem given by J.Zowe and S.Kurcyusz [35] (see also [32, Chapter 6], for more details) that we will apply to get first-order
necessary optimality conditions for a local optimal solution $(\tilde{u}, \tilde{v}, \tilde{f})$ of problem (1.2). First, we consider the following (generic) optimization problem:

\min _{s \in \mathbb{M}} J(s) \text { subject to } G(s)=0 \tag{5.1}
\end{equation*}
$$

where $J: \mathbb{X} \rightarrow \mathbb{R}$ is a functional, $G: \mathbb{X} \rightarrow \mathbb{Y}$ is an operator, $\mathbb{X}$ and $\mathbb{Y}$ are Banach spaces, and $\mathbb{M}$ is a nonempty closed and convex subset of $\mathbb{X}$. The corresponding admissible set for problem (5.1) is

\mathcal{S}=\{s \in \mathbb{M}: G(s)=0\} .
$$

Definition 5.1. (Lagrangian) The functional $\mathcal{L}: \mathbb{X} \times \mathbb{Y}^{\prime} \rightarrow \mathbb{R}$, given by

\mathcal{L}(s, \xi)=J(s)-\langle\xi, G(s)\rangle_{\mathbb{Y}^{\prime}} \tag{5.2}
\end{equation*}
$$

is called the Lagrangian functional related to problem (5.1).
Definition 5.2. (Lagrange multiplier) Let $\tilde{s} \in \mathcal{S}$ be a local optimal solution for problem (5.1). Suppose that $J$ and $G$ are Fréchet differentiable in $\tilde{s}$. Then, any $\xi \in \mathbb{Y}^{\prime}$ is called a Lagrange multiplier for (5.1) at the point $\tilde{s}$ if

$$
\begin{equation*}
\mathcal{L}_{s}^{\prime}(\tilde{s}, \xi)[r]=J^{\prime}(\tilde{s})[r]-\left\langle\xi, G^{\prime}(\tilde{s})[r]\right\rangle_{\mathbb{Y}^{\prime}} \geq 0 \quad \forall r \in \mathcal{C}(\tilde{s}) \tag{5.3}
\end{equation*}

where $\mathcal{C}(\tilde{s})=\{\theta(s-\tilde{s}): s \in \mathbb{M}, \theta \geq 0\}$ is the conical hull of $\tilde{s}$ in $\mathbb{M}$.
Definition 5.3. Let $\tilde{s} \in \mathcal{S}$ be a local optimal solution for problem (5.1). It will be said that $\tilde{s}$ is a regular point if

Theorem 5.4. ([32, Theorem 6.3, p.330], [35, Theorem 3.1]) Let $\tilde{s} \in \mathcal{S}$ be a local optimal solution for problem (5.1). Suppose that $J$ is Fréchet differentiable in $\tilde{s}$, and $G$ is continuous Fréchet-differentiable in $\tilde{s}$. If $\tilde{s}$ is a regular point, then there exists Lagrange multipliers for (5.1) at $\tilde{s}$.
5.2. Application of the Lagrange multiplier theory. Now, in order to reformulate the optimal control problem (1.2) in the abstract setting (5.1), we introduce the Banach spaces

Thus, the optimal control problem (1.2) is reformulated as follows

Remark 5.5. From Definition 5.1, the Lagragian associated to optimal control problem (5.4) is the functional $\mathcal{L}: \mathbb{X} \times L^{2}\left(H^{1}\right) \times L^{2-}(Q) \rightarrow \mathbb{R}$ given by

The operator $G: \mathbb{X} \rightarrow \mathbb{Y}$ is continuous-Fréchet differentiable and the Fréchet derivative of $G$ in $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in \mathbb{X}$ in the direction $r=(U, V, F) \in \mathbb{X}$ is the linear operator $G^{\prime}(\tilde{s})[r]=\left(G_{1}^{\prime}(\tilde{s})[r], G_{2}^{\prime}(\tilde{s})[r]\right)$ defined by

From Definition 5.3 one has that $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in \mathcal{S}_{\text {ad }}$ is a regular point if for any $\left(g_{u}, g_{v}\right) \in \mathbb{Y}$ there exists $r=(U, V, F) \in \widehat{W}_{2} \times \widehat{X}_{2+} \times \mathcal{C}(\tilde{f})$ such that

Since $0 \in \mathcal{C}(\tilde{f})=$ $\{\theta(f-\tilde{f}): \theta \geq 0, f \in \mathcal{F}\}$, it suffices to show the existence of $(U, V) \in \widehat{W}_{2} \times \widehat{X}_{2+}$ solving the linear problem

For this, we will use the Leray-Schauder fixed-point Theorem, for the operator

Step 1 ( $S$ is well-defined and bounded): Prove that operator $S$ defined in (5.10) maps bounded sets in $L^{4-}(Q) \times L^{\infty}(Q)$ in bounded sets in $(U, V) \in W_{2} \times X_{2+}$.

For this, one first bound $V$ and later bound $U$. Indeed, since $(\bar{U}, \bar{V}) \in L^{4-}(Q) \times$ $L^{\infty}(Q)$ implies $f \bar{V} \in L^{2+}(Q)$, then by applying $L^{2+}$-regularity to the heat equation $(5.11)_{2}$ (Theorem 2.1), it is deduced that $V \in X_{2+}$ and

Finally, using $2 D$ interpolation estimates,

Step 2 (compactness): By using that $W_{2} \times X_{2+}$ is compactly embedded in $L^{4-}(Q) \times$ $L^{\infty}(Q)$, then operator $S$ is compact.

Step 3 (continuity): In particular, using Steps 1 and 2, it is not difficult to prove the continuity of $S$ from $L^{4-}(Q) \times L^{\infty}(Q)$ to itself.

Step 4 (boundedness of possible fixed-points): Now, the aim is to show that the set of the possible fixed-points of $\alpha S$ with $\alpha \in[0,1]$ defined as $S_{\alpha}:=\{(U, V) \in$ $\widehat{W}_{2} \times \widehat{X}_{2+}:(U, V)=\alpha S(U, V)$ for some $\left.\alpha \in[0,1]\right\}$ is bounded in $L^{4-}(Q) \times L^{\infty}(Q)$ (with respect to $\alpha$ ). Indeed, if $(U, V) \in S_{\alpha}$, then $(U, V) \in \widehat{W}_{2} \times \widehat{X}_{2+}$ and solves the coupled linear problem

Using that $U(0)=V(0)=0$ and $\left\|g_{u}\right\|_{L^{2}\left(\left(H^{1}\right)^{\prime}\right)},\left\|g_{v}\right\|_{L^{2}\left(L^{2}\right)},\|f\|_{L^{2+}},\|\tilde{u}\|_{L^{4}(Q)}$ and $\|\nabla \tilde{v}\|_{L^{4}(Q)}$ are constant finite values, then the Gronwall Lemma implies that

5.4. Existence of Lagrange multipliers. Now, the existence of Lagrange multiplier for problem (1.2) associated to any local optimal solution $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in \mathcal{S}_{a d}$ will be shown.

Theorem 5.10. Let $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in \mathcal{S}_{a d}$ be a local optimal solution for the control problem (1.2). Then, there exists a Lagrange multiplier $\xi=(\lambda, \eta) \in L^{2}\left(H^{1}\right) \times$ $L^{2-}(Q)$ such that for all $(U, V, F) \in \widehat{W}_{2} \times \widehat{X}_{2+} \times \mathcal{C}(\tilde{f})$

& \gamma_{u} \int_{0}^{T} \int_{\Omega}\left(\tilde{u}-u_{d}\right) U+\gamma_{v} \int_{0}^{T} \int_{\Omega}\left(\tilde{v}-v_{d}\right) V+\gamma_{f} \int_{0}^{T} \int_{\Omega_{c}} \operatorname{sgn}(\tilde{f})|\tilde{f}|^{1+} F \\
& -\int_{0}^{T}\left\langle\partial_{t} U, \lambda\right\rangle-\int_{0}^{T} \int_{\Omega}(\nabla U-\kappa U \nabla \tilde{v}-\kappa \tilde{u} \nabla V, \nabla \lambda)+(-r U+2 \mu \tilde{u} U, \lambda) \\
& -\int_{0}^{T} \int_{\Omega}\left(\partial_{t} V-\Delta V+V-U-\tilde{f} V 1_{\Omega_{c}}\right) \eta+\int_{0}^{T} \int_{\Omega_{c}} F \tilde{v} 1_{\Omega_{c}} \eta \geq 0 \tag{5.18}
\end{align*}

Proof. From Lemma 5.9, $\tilde{s} \in \mathcal{S}_{a d}$ is a regular point, then from Theorem 5.4 there exists a Lagrange multiplier $\xi=(\lambda, \eta) \in L^{2}\left(H^{1}\right) \times L^{2-}(Q)$ such that by $(5.3)_{2}$ and Remark 5.5 one must satisfy

and the optimality condition

(\lambda, \eta) \in X_{2} \times W_{2} \tag{5.24}
\end{equation*}
$$

Proof. Let $s=T-t$, with $t \in(0, T)$ and $\tilde{\lambda}(s)=\lambda(t), \tilde{\eta}(s)=\eta(t)$. Then, system (5.23) is equivalent to

$$
\left\{\begin{array}{rlr}
\partial_{s} \tilde{\lambda}-\Delta \tilde{\lambda}-\kappa \nabla \tilde{\lambda} \cdot \nabla \tilde{v}-\tilde{\eta}-r \tilde{\lambda}+2 \mu \tilde{u} \tilde{\lambda} & =\gamma_{u}\left(\tilde{u}-u_{d}\right) \quad \text { in } Q  \tag{5.25}\\
\partial_{s} \tilde{\eta}-\Delta \tilde{\eta}+\tilde{\eta}-\kappa \nabla \cdot(\tilde{u} \nabla \tilde{\lambda})-\tilde{f} \tilde{\eta} 1_{\Omega_{c}} & =\gamma_{v}\left(\tilde{v}-v_{d}\right) \quad \text { in } Q \\
\tilde{\lambda}(0)=0, \tilde{\eta}(0) & =0 \quad \text { in } \Omega \\
\frac{\partial \tilde{\lambda}}{\partial \boldsymbol{n}}=0, \frac{\partial \tilde{\eta}}{\partial \boldsymbol{n}} & =0 \quad \text { on }(0, T) \times \partial \Omega
\end{array}\right.
$$

In order to prove the existence of a solution for (5.25), the Leray-Schauder fixedpoint Theorem can be applied as before, now over the operator

$$
\begin{equation*}
\widehat{T}:(\bar{\lambda}, \bar{\eta}) \in L^{\infty-} \times L^{4-} \mapsto(\lambda, \eta) \in X_{2} \times W_{2} \tag{5.26}
\end{equation*}
$$

where $(\lambda, \eta)=\widehat{T}(\bar{\lambda}, \bar{\eta})$ solves the decoupled problem (first computing $\lambda$ and after $\mu)$ :

$$
\left\{\begin{align*}
\partial_{s} \lambda-\Delta \lambda-\kappa \nabla \lambda \cdot \nabla \tilde{v} & =\bar{\eta}+r \bar{\lambda}-2 \mu \tilde{u} \bar{\lambda}+\gamma_{u}\left(\tilde{u}-u_{d}\right) \quad \text { in } Q  \tag{5.27}\\
\partial_{s} \eta-\Delta \eta+\eta-\kappa \nabla \cdot(\tilde{u} \nabla \lambda) & =\tilde{f} \bar{\eta} 1_{\Omega_{c}}+\gamma_{v}\left(\tilde{v}-v_{d}\right) \quad \text { in } Q \\
\lambda(0)=0, \eta(0) & =0 \quad \text { in } \Omega \\
\frac{\partial \lambda}{\partial \boldsymbol{n}}=0, \frac{\partial \eta}{\partial \boldsymbol{n}} & =0 \quad \text { on }(0, T) \times \partial \Omega
\end{align*}\right.
$$

The proof follows the same lines and it will be omitted. Indeed, the key point is to show that the set of possible fixed-points

$$
\widehat{T}_{\alpha}:=\left\{(\lambda, \eta) \in X_{2} \times W_{2}:(\lambda, \eta)=\alpha \widehat{T}(\lambda, \eta) \text { for some } \alpha \in[0,1]\right\}
$$

is bounded in $X_{2} \times W_{2}$ (with respect to $\alpha$ ). In fact, if $(\lambda, \eta) \in \widehat{T}_{\alpha}$, then $(\lambda, \eta) \in$ $X_{2} \times W_{2}$ and solves the coupled linear problem:

$$
\left\{\begin{array}{rlr}
\partial_{s} \lambda-\Delta \lambda+\kappa \nabla \lambda \cdot \nabla \tilde{v}-\alpha r \lambda+2 \alpha \mu \tilde{u} \lambda-\alpha \eta & =\alpha \gamma_{u}\left(\tilde{u}-u_{d}\right) \quad \text { in } Q  \tag{5.28}\\
\partial_{s} \eta-\Delta \eta+\eta-\tilde{f} \eta 1_{\Omega_{c}}-\kappa \nabla \cdot(\tilde{u} \nabla \lambda) & =\alpha \gamma_{v}\left(\tilde{v}-v_{d}\right) \quad \text { in } Q \\
\lambda(0)=0, \eta(0) & =0 \quad \text { in } \Omega \\
\frac{\partial \lambda}{\partial \boldsymbol{n}}=0, \frac{\partial \eta}{\partial \boldsymbol{n}} & =0 \quad \text { on }(0, T) \times \partial \Omega
\end{array}\right.
$$

Now, by taking $\lambda-\Delta \lambda \in L^{2}(Q)$ as test function in (5.28) ${ }_{1}$ and $\eta \in L^{2}\left(H^{1}\right)$ as test function in $(5.28)_{2}$, then the following bound is obtained via the Gronwall Lemma

$$
\|(\lambda, \eta)\|_{X_{2} \times W_{2}} \leq C\left(\|\tilde{u}\|_{W_{2}},\|\tilde{v}\|_{X_{2}},\|\tilde{f}\|_{L^{2+}\left(Q_{c}\right)},\left\|u_{d}\right\|_{L^{2}(Q)},\left\|v_{d}\right\|_{L^{2}(Q)}\right)
$$

Therefore, by applying Leray-Schauder fixed-point theorem, the existence of a solution of problem (5.23), $(\lambda, \eta) \in X_{2} \times W_{2}$, is obtained. The uniqueness of solution is directly deduced from the linearity of problem (5.23).

In the following result, more regularity and uniqueness of the Lagrange multiplier $(\lambda, \eta)$ than provided by Theorem 5.10 will be obtained via uniqueness of the problem (5.23).

Theorem 5.14. Let $\tilde{s}=(\tilde{u}, \tilde{v}, \tilde{f}) \in \mathcal{S}_{a d}$ be a local optimal solution for the control problem (1.2). Then the Lagrange multiplier, provided by Theorem 5.10, is unique and satisfies $(\lambda, \eta) \in X_{2} \times W_{2}$.

Proof. Let $(\lambda, \eta) \in L^{2}\left(H^{1}\right) \times L^{2-}(Q)$ be a Lagrange multiplier given in Theorem 5.10 , which is a very weak solution of problem (5.23). In particular, $(\lambda, \eta)$ satisfies (5.20)-(5.21). On the other hand, from Theorem 5.13 , system (5.23) has a unique solution $(\bar{\lambda}, \bar{\eta}) \in X_{2} \times W_{2}$. Then, it suffices to identify $(\lambda, \eta)$ with $(\bar{\lambda}, \bar{\eta})$.

With this objective, for any $(U, V) \in \widehat{W}_{2} \times \widehat{X}_{2+}$, we writte (5.23) for $(\bar{\lambda}, \bar{\eta})$ (instead of $(\lambda, \eta)$ ), testing the first equation by $U$, and the second one by $V$, and integrating by parts in $\Omega$, it is obtained
$\int_{0}^{T}\left\langle\partial_{t} U, \bar{\lambda}\right\rangle+\int_{0}^{T} \int_{\Omega}(\nabla U-\kappa U \nabla \tilde{v}) \cdot \nabla \bar{\lambda}+(-r U+2 \mu \tilde{u} U) \bar{\lambda}-U \bar{\eta}=\gamma_{u} \int_{0}^{T} \int_{\Omega}\left(\tilde{u}-u_{d}\right) U$,

$$
\begin{equation*}
\int_{0}^{T} \int_{\Omega}\left(\partial_{t} V-\Delta V+V-\tilde{f} V 1_{\Omega_{c}}\right) \bar{\eta}+\kappa \tilde{u} \nabla V \cdot \nabla \bar{\lambda}=\gamma_{v} \int_{0}^{T} \int_{\Omega}\left(\tilde{v}-v_{d}\right) V \tag{5.30}
\end{equation*}
$$

Making the difference between (5.20) for $(\lambda, \eta)$ and (5.29) for $(\bar{\lambda}, \bar{\eta})$, and between (5.21) and (5.30), and then adding the respective equations, since the right-hand side terms vanish, it can be deduced

$$
\begin{aligned}
& \int_{0}^{T}\left\langle\partial_{t} U, \lambda-\bar{\lambda}\right\rangle_{\left(H^{1}\right)^{\prime}}+\int_{0}^{T} \int_{\Omega}(\nabla U-\kappa U \nabla \tilde{v}-\kappa \tilde{u} \nabla V) \cdot \nabla(\lambda-\bar{\lambda}) \\
& +\int_{0}^{T} \int_{\Omega}(-r U+2 \mu \tilde{u} U, \lambda-\bar{\lambda}) \\
& +\int_{0}^{T} \int_{\Omega}\left(\partial_{t} V-\Delta V+V-U-\tilde{f} V 1_{\Omega_{c}}\right)(\eta-\bar{\eta})=0 .
\end{aligned}
$$

Then, if $(U, V) \in \widehat{W}_{2} \times \widehat{X}_{2+}$ is the unique solution of linear system (5.9) associated to any $\left(g_{u}, g_{v}\right) \in L^{2}\left(\left(H^{1}\right)^{\prime}\right) \times L^{2+}(Q)$ (given by Lemma 5.9), we arrive at

$$
\begin{equation*}
\int_{0}^{T}\left\langle g_{u}, \lambda-\bar{\lambda}\right\rangle_{\left(H^{1}\right)^{\prime}}+\int_{0}^{T} \int_{\Omega} g_{v}(\eta-\bar{\eta})=0 . \tag{5.31}
\end{equation*}
$$

By density arguments, it is easy to deduce that $\lambda-\bar{\lambda}=0$ and $\eta-\bar{\eta}=0$, which implies that $(\lambda, \eta)=(\bar{\lambda}, \bar{\eta})$. As a consequence of the regularity of $(\bar{\lambda}, \bar{\eta})$, it holds that $(\lambda, \eta) \in X_{2} \times W_{2}$.

All previous arguments of Section 5 prove Theorem 1.4.
