Stable Morse flow trees

Abstract

Let $L \subset J^1 M$ be a closed Legendrian, in the 1-jet space of a closed manifold M, with simple front singularities. We define a natural generalization of a Morse flow tree, namely, a stable flow tree. We show a result analogous to Gromov compactness for stable maps – a sequence of stable flow trees, with a uniform edge bound, has a subsequence that Floer-Gromov converges to a stable flow tree. Moreover, we realize Floer-Gromov convergence as the topological convergence of a certain moduli space of stable flow trees.

1. Introduction

Let (M, g) be a closed Riemannian *n*-manifold, let $J^0M \coloneqq M \times \mathbb{R}$ be *M*'s 0-jet space, and let $J^1M \coloneqq T^*M \times \mathbb{R}$ be *M*'s 1-jet space. We endow J^1M with the standard contact structure ξ , given as the kernel of $dz - \alpha$, where *z* is the \mathbb{R} -coordinate and α is the tautological 1-form on T^*M . An *n*-dimensional submanifold $L \subset J^1M$ is called *Legendrian* if it is an integral submanifold of ξ . We also endow T^*M with the standard symplectic structure, given as $-d\alpha$. An *n*-dimensional submanifold of T^*M is called *Lagrangian* if $-d\alpha$ identically vanishes on it.

(Morse) Flow trees were introduced in [Ekh07] to help compute the contact homology mology of Legendrians in 1-jet spaces. Specifically, Legendrian contact homology is an isotopy invariant of Legendrians in the framework of Symplectic Field Theory (see [EGH00]). The rigorous construction of Legendrian contact homology in 1-jet spaces was done in [EES07], where the construction involves counting rigid pseudo-holomorphic disks with punctures asymptotic to Reeb chords on the Legendrian. Finding pseudo-holomorphic disks involves solving a non-linear first order partial differential equation, thus explicit computations are quite difficult. The main result of [Ekh07] reduces this infinite-dimensional problem to a finite-dimensional problem in Morse theory by building a 1-1 correspondence between (certain types of) flow trees and (certain types of) pseudo-holomorphic disks (after appropriate perturbations of the involved data). The relation between Morse theory and pseudo-holomorphic disks can be found in the Floer-theoretic case (see [Flo89] and [FO97]), and the power of flow trees can be seen in the computations of Legendrian contact homology in [EENS13], [EN18], [RG19], and [Riz11].

A flow tree is essentially a combinatorial tree, where each edge is assigned a gradient flow of some difference of functions locally defined on M, where L is locally the multi 1-jet graph of these local functions. In this article, we generalize flow trees by constructing stable flow trees (see Definition 4.5), in analogy to the generalization of pseudo-holomorphic curves to stable maps. Recall that Gromov compactness says: for a sequence of stable maps, with uniformly bounded energy, there exists a Gromov convergent subsequence. We define a notion of convergence of stable flow trees, called Floer-Gromov convergence (see Definition 4.9). The number of edges of a stable flow tree then plays the role of the energy of a pseudo-holomorphic disk, namely, we prove the following result:

Theorem 1.1. Let T_{ν} be a sequence of stable flow trees. If $\sup_{\nu} |\mathcal{E}_{\nu}| < \infty$, where $|\mathcal{E}_{\nu}|$ is the number of edges of T_{ν} , then T_{ν} has a Floer-Gromov convergent subsequence.

Given Ekholm's 1-1 correspondence between flow trees and pseudo-holomorphic disks, such a result is expected. We define the moduli space

$$\overline{\mathcal{L}}(L,N) \coloneqq \left\{ T \in \mathcal{L}(L) : \frac{\text{there exists a sequence } T_{\nu} \in \mathcal{L}(L,N) \\ \text{that Floer-Gromov converges to } T \right\}$$

where $\mathcal{L}(L)$ is the set of stable flow trees and $\mathcal{L}(L, N)$ is the set of stable flow trees, with at most N edges. The definition of Floer-Gromov convergence is a natural one to consider, due to the following result:

Theorem 1.2. There exists a unique topology on the set $\overline{\mathcal{L}}(L, N)$ such that the topological convergence is equivalent to Floer-Gromov convergence. Moreover, $\overline{\mathcal{L}}(L, N)$ is compact with respect to this topology.

This article is structured as follows. In Section 2, we recall the theory of flow trees following [Ekh07]. In Section 3, we (formally) compactify the various moduli spaces of gradient flows of local function differences. This is necessary because Floer-Gromov convergence will essentially reduce to the convergence of the various sequences of

edges. In Section 4, we define stable flow trees, Floer-Gromov convergence, and prove Theorems 1.1 and 1.2. Finally, in Section 5, we exhibit an example of Floer-Gromov convergence, following an example in Section 7 of [Ekh07].

2. Preliminaries

2.1. Local functions and local gradients. As before, let (M, g) be a closed Riemannian *n*-manifold and let $L \subset J^1M$ be a closed Legendrian submanifold. We will assume that L is *chord generic*, i.e., that L has finitely many isolated Reeb chords. This condition may be achieved after generic perturbation and is stable.

Consider the Lagrangian projection $\Pi_{\mathbb{C}} : J^1M \to T^*M$, then $\Pi_{\mathbb{C}}(L)$ is an immersed Lagrangian. Since the Reeb field of the standard contact structure ξ on J^1M is ∂_z , it follows that there is a 1-1 correspondence between Reeb chords on L and self-transverse double points of $\Pi_{\mathbb{C}}(L)$.

We will assume that L has simple front singularities, which means L satisfies the following conditions.

- The base projection $\Pi: J^1M \to M$, restricted to L, is an immersion outside of a closed codimension 1 submanifold $\Sigma \subset L$.
- For any $\tilde{p} \in \Sigma$, the front projection $\Pi_F : J^1M \to J^0M$, restricted to L, has a standard cusp-edge singularity at \tilde{p} . Precisely, there exists coordinates $y = (y_1, \ldots, y_n)$ around $\tilde{p} \in L$ and there exists coordinates $x = (x_1, \ldots, x_n)$ around $\Pi(\tilde{p}) \in M$, such that the following holds. If z is the \mathbb{R} -coordinate on $J^0(M)$, then $\Pi_F(y) = (x(y), z(y))$, where

$$\begin{aligned} x_1(y) &= \frac{1}{2}y_1^2, \\ x_i(y) &= y_i, \quad i \ge 2, \\ z(y) &= \frac{1}{3}y_1^3 + b\frac{1}{2}y_1^2 + a_2y_2 + \dots + a_ny_n, \quad a_j, b \in \mathbb{R}. \end{aligned}$$

• The base projection, restricted to Σ , is a self-transverse immersion.

In dimensions greater than 1, this condition is not generic. We refer to $\Pi(\Sigma) \subset M$ as the *singular set*. We will assume that $\Pi|_{\Sigma}$ is self-transverse in the following way: we assume there is a stratification

$$\Pi(\Sigma) \eqqcolon \Sigma_1 \supset \cdots \supset \Sigma_k,$$

where Σ_i is the set of self-intersection points of $\Pi|_{\Sigma}$ of multiplicity at least *i*, such that Σ_i has codimension *i* in *M* (hence $i \leq n$). This condition may be achieved after generic perturbation and is stable.

Locally, L is the multi 1-jet graph of *local functions* defined on the base M, as follows.

If $p \in M \setminus \Pi(\Sigma)$, then there exists an open neighborhood $U \subset M \setminus \Pi(\Sigma)$ of p, and there exists k disjoint open sets $U_1, \ldots, U_k \subset L \setminus \Sigma$, such that

$$U_i = \{ (x, d(f_i)_x, f_i(x)) : x \in U \},\$$

for some functions $f_i \in C^{\infty}(U)$, and such that each U_i is diffeomorphic to U via the base projection. Each U_i is called a *smooth sheet* lying over p.

Similarly, a point $p \in \Sigma_j \setminus \Sigma_{j+1}$ may have smooth sheets lying over it. In addition, there exists an open neighborhood $V \subset \Sigma_j$ of p, and there exists j disjoint open sets $V_1, \ldots, V_j \subset \Sigma$, such that each V_i is diffeomorphic to V via the base projection. If we consider a sufficiently small neighborhood $U \subset M$ of p, then each $\Pi(V_i)$ subdivides U into two components $\{U_i^{\pm}\}$. Moreover, there exists two functions $\{f_i^1, f_i^2\}$ defined on U_i^+ such that both functions: extend to \overline{U}_i^+ , agree on ∂U_i^+ , and have differentials whose limits agree on ∂U_i^+ when approached from U_i^+ . Since L has simple front singularities, the local functions $\{f_i^1, f_i^2\}$ are of the form

$$f_i^1(x) = \frac{1}{3}(2x_1)^{3/2} + bx_1 + a_2x_2 + \dots + a_nx_n,$$

$$f_i^2(x) = -\frac{1}{3}(2x_1)^{3/2} + bx_1 + a_2x_2 + \dots + a_nx_n,$$
 (1)

where $\{x_1 > 0\}$, and the common limits of the differentials on $\{x_1 = 0\}$ is

$$bdx_1 + a_2dx_2 + \cdots + a_ndx_n$$

where we use the coordinates associated to the standard cusp-edge singularity \tilde{p}_i defined by $\{\tilde{p}_i\} := \Pi^{-1}(p) \cap V_i$. Remark 2.1. By compactness of M and L, there are only finitely many local functions under consideration.

Let f_i, f_j be local functions whose domains overlap on, some open set $U \subset M$, and consider their *local function difference* $F_{ij} := f_i - f_j \in C^{\infty}(U)$. We call a curve $\phi: I \to M$, where $I \subset \mathbb{R}$ is an interval, a gradient flow of L if ϕ is a solution to the gradient flow equation

$$\dot{\phi} = -\nabla F_{ij}(\phi),$$

for some local function difference F_{ij} . A 1-jet lift of ϕ is an unordered pair

$$\left\{ \tilde{\phi}^1, \tilde{\phi}^2 \right\}$$

of continuous lifts $\tilde{\phi}^k : I \to L$ of ϕ , such that either: $\tilde{\phi}^1$ lies in the sheet determined by f_i and $\tilde{\phi}^2$ lies in the sheet determined by f_j , or vice versa; and satisfies

$$\tilde{\phi}^1(t_0) = \tilde{\phi}^2(s_0)$$

if and only if $t_0 = s_0$ and the point $\tilde{\phi}^1(t_0)$ lies in Σ over $\phi(t_0)$ (equivalently, $\tilde{\phi}^2(s_0)$ lies in Σ over $\phi(s_0)$). In other words, the 1-jet lifts may only meet in Σ . We also define a *cotangent lift of* ϕ as an unordered pair

$$\left\{\overline{\phi}^1 \coloneqq \Pi_{\mathbb{C}} \circ \widetilde{\phi}^1, \overline{\phi}^2 \coloneqq \Pi_{\mathbb{C}} \circ \widetilde{\phi}^2\right\}.$$

Definition 2.2 (Definition 2.9 in [Ekh07]). The flow orientation of $\tilde{\phi}^1$ at $\tilde{p} \in L$ is given by the unique lift of the vector

$$-\nabla F_{ij}(\Pi(\tilde{p})) \in T_{\Pi(\tilde{p})}M$$

to $T_{\tilde{p}}L$, where f_i is the local function determined by $\tilde{\phi}^1$. We similarly orient $\tilde{\phi}^2$.

Remark 2.3. Definition 2.2 gives a natural orientation of a cotangent lift.

By existence and uniqueness theorems of ODEs, we see that any gradient flow of L has a maximal interval of definition. Any gradient flow of L defined on its maximal interval of definition will be called a *maximally extended gradient flow of* L. The asymptotic behavior of maximally extended gradient flows is given by the following lemma:

Lemma 2.4 (Lemma 2.8 in [Ekh07]). Let $\Phi : I \to M$ be a maximally extended gradient flow of L associated to F_{ij} . If I is an interval with an infinite end, i.e., I equals (a, ∞) or $(-\infty, b)$ for $a, b \in \mathbb{R} \cup \{\infty\}$, then

$$\lim_{t \to \pm \infty} \Phi(t) \in \operatorname{Crit}(F_{ij}),$$

where $\operatorname{Crit}(F_{ij})$ is the set of critical points of F_{ij} . If I is an interval with a compact end, i.e., I equals $(a, \ell]$ or $[\ell, b)$ for $a, b \in \mathbb{R} \cup \{\infty\}$ and $\ell \in \mathbb{R}$, then

$$\lim_{t \to \ell} \tilde{\Phi}^k(t) \in \Sigma, \ k = 1 \ or \ k = 2$$

for some 1-jet lift of Φ . In particular, $\Phi(\ell)$ lies in $\Pi(\Sigma) \cap \overline{U}$.

Proof. See Lemma 2.8 in [Ekh07].

The asymptotic behavior of (maximally extended) gradient flows of L allows us to characterize them.

Definition 2.5. Let ϕ be a gradient flow of L associated to F_{ij} with maximal extension Φ . Then ϕ (respectively Φ) is called a:

- (maximally extended) Morse flow if Φ connects two points of $\operatorname{Crit}(F_{ij})$,
- (maximally extended) fold emanating flow if Φ connects a point of $\Pi(\Sigma) \cap U$ to a point of $\operatorname{Crit}(F_{ij})$,
- (maximally extended) fold terminating flow if Φ connects a point of $\operatorname{Crit}(F_{ij})$ to a point of $\Pi(\Sigma) \cap \overline{U}$,
- (maximally extended) singular flow if Φ connects two points of $\Pi(\Sigma) \cap \overline{U}$.

2.2. Flow trees. Let T be a tree with edge set \mathcal{E} and vertex set \mathcal{V} . A source tree is a finite-edge tree T (where the edge set may be empty) such that, at each k-valent vertex $v, k \geq 3$, the edges adjacent to v are cyclically labelled.

Definition 2.6 (Definition 2.10 in [Ekh07]). A true flow tree of L is a continuous map $\phi: T \to M$, where T is a source tree, that satisfies the following conditions.

• If e is an edge of T, then $\phi : e \to M$ is an injective parameterization of a gradient flow of L. In particular, $\phi : e \to M$ cannot be constant.

• Let v be a k-valent vertex of T with (cyclically ordered) edges $e_{v,1}, \ldots, e_{v,k}$. We require that there exists cotangent lifts

$$\left\{\overline{\phi}_{v,j}^1,\overline{\phi}_{v,j}^2\right\},$$

for each edge $e_{v,j}$, such that

$$\overline{p}_{v,j} \coloneqq \overline{\phi}_{v,j}^2(v) = \overline{\phi}_{v,j+1}^1(v) \in \Pi_{\mathbb{C}}(L)$$

and such that the flow orientation of $\overline{\phi}_{v,j}^2$ at $\overline{p}_{v,j}$ is directed toward $\overline{p}_{v,j}$ if and only if the flow orientation of $\overline{\phi}_{v,j+1}^1$ at $\overline{p}_{v,j}$ is directed away from $\overline{p}_{v,j}$.

• We require that the aforementioned cotangent lifts of all the edges yield an oriented loop in $\Pi_{\mathbb{C}}(L)$.

Definition 2.7. Let T be a true flow tree. A removable vertex of T is a 2-valent vertex v such that: the assigned gradient flows of the adjacent edges, $\phi_{v,1}$ and $\phi_{v,2}$, are both gradient flows of the same local function difference F_{ij} , and these gradient flows concatenate together at

$$p_v \coloneqq \phi_{v,1}(v) = \phi_{v,2}(v)$$

to give a single gradient flow ϕ_v of F_{ij} .

The name removable vertex is warranted because these vertices are erroneous in the following sense. Given any true flow tree, we may arbitrarily add a removable vertex by picking an edge and adding a 2-valent vertex somewhere along that edge.

Remark 2.8. Definition 2.6 is the original definition of a flow tree given in [Ekh07]. However, this definition is problematic because it allows the phenomenon of removable vertices. The reason these kinds of vertices are problematic is because the dimension formulas for flow trees (Definitions 3.4 and 3.5 in [Ekh07]) do not hold for trees with removable vertices. This motivates the following definition.

Definition 2.9. A *(parameterized) flow tree* is a true flow tree that does not have any removable vertices.

Lastly, we will assume that L satisfies the *preliminary transversality condition*, found in pages 1101-1103 in [Ekh07]. We will not define this condition since its definition is quite long-winded. In short, the preliminary transversality condition affects how the various sheets of the Legendrian are allowed to meet, and the consequences of the condition ensure gradient flows of L meet the singular set in a locally stable fashion. In particular, any gradient flow of L may only meet the singular set with order of contact at most n (hence no gradient flow of L may flow along the singular set). This condition may be achieved after generic perturbation and is stable.

3. Compactification of edges

3.1. Morse theory. Let F_{ij} be a local function difference defined on some open set $U \subset M$. Since the Reeb chords of L are in 1-1 correspondence with the selftransverse double points of $\Pi_{\mathbb{C}}(L)$, and L is chord generic by assumption, it follows that F_{ij} is a Morse function with finitely many critical points. Moreover, we will assume that no critical point of any local function difference lies in the singular set. This condition may be achieved by generic perturbation and is stable.

Floer-Gromov convergence of stable flow trees will essentially reduce to convergence of the various sequences of edges. Therefore, we must first compactify the various moduli spaces of gradient flows associated to our local function differences. Since each local function difference is Morse, we will use the techniques of standard Morse theory, following Section 2 of [AD14]. However, we will only formally compactify the moduli spaces in this section, i.e., we will not build topologies on the moduli spaces of gradient flows such that the desired sequences topologically converge – we will only formally define the notion of edge convergence (Definition 3.10).

Also, we will make the following (non-generic) assumption: the Riemannian metric g on M is Euclidean in Morse neighborhoods of critical points of local function differences. This assumption is usually made in the literature to simplify various technical arguments regarding the interactions of unstable manifolds, stable manifolds, and Morse neighborhoods. We will recall the relevant definitions now.

Recall that the Morse lemma states:

Lemma 3.1. Suppose $c \in \operatorname{Crit}(F_{ij})$, then there exists a neighborhood $\Omega(c) \subset U$ and a diffeomorphism $\varphi : \Omega(c) \to \varphi(\Omega(c)) \subset \mathbb{R}^n$ such that

$$(F_{ij} \circ \varphi^{-1})(x_1, \dots, x_n) = F_{ij}(c) - \sum_{k=1}^m x_k^n + \sum_{k=m+1}^n x_k^2.$$

The number I(c) := m appearing in the Morse lemma is called the *Morse index* of c and the neighborhood $\Omega(c)$ appearing in the Morse lemma is called a *Morse* neighborhood of c.

In the rest of this section, we will use the fact that our unstable manifolds, stable manifolds, and Morse neighborhoods are of a particular form by our (non-generic) assumption on g, which we now describe. See Pages 24-29 of [AD14] for details. Let $c \in \operatorname{Crit}(F_{ij})$ and let $V \coloneqq \varphi(\Omega(c)) \subset \mathbb{R}^n$ be the image of a Morse neighborhood of c, where we assume φ identifies c with the origin. If we denote by Q the quadratic form $d^2 (F_{ij} \circ \varphi^{-1})_0$, i.e., the Hessian of f at the origin, then we see Q is: negative-definite on a subspace $V_- \subset \mathbb{R}^n$ of dimension I(c) and positive-definite on a complimentary subspace $V_+ \subset \mathbb{R}^n$. Let $\epsilon, \eta > 0$ be sufficiently small real numbers. It follows that V is of the form

$$V = \left\{ x \in \mathbb{R}^n : \frac{-\epsilon < Q(x) < \epsilon}{|x_-|^2 |x_+|^2 \le \eta(\epsilon + \eta)} \right\}$$

where $x = x_{-} \oplus x_{+}$ for $x_{\pm} \in V_{\pm}$. The boundary of V consists of three parts:

$$\partial_{\pm}V := \{ x \in V : Q(x) = \pm \epsilon, \ |x_{\mp}|^2 \le \eta \},\\ \partial_0V := \{ x \in V : |x_{-}|^2 |x_{+}|^2 = \eta(\epsilon + \eta) \}.$$




Figure 1: The image V of the Morse neighborhood $\Omega(c)$. The black border is ∂V . The blue lines are the level sets of F_{ij} . The red lines are gradient flows of F_{ij} . The axes are the sets V_{\pm} . The sets $\partial_{\pm} V$ are contained in the level sets that intersect V_{\pm} .

See Figure 1.

The unstable manifold and stable manifold of c are defined as:

$$W^{u}(c) \coloneqq \{x \in M : \exists \phi \text{ a gradient flow at } x \text{ with } \lim_{t \to -\infty} \phi(t) = c\},\$$
$$W^{s}(c) \coloneqq \{x \in M : \exists \phi \text{ a gradient flow at } x \text{ with } \lim_{t \to \infty} \phi(t) = c\},\$$

respectively. We note that, by the above description of $\Omega(c)$,

$$V_{-} = W^{u}(c) \cap \Omega(c),$$

$$V_{+} = W^{s}(c) \cap \Omega(c).$$

Moreover, by the above description of $\Omega(c)$, we see that

$$W^{u}(c) \cap \Omega(c) \cong S^{I(c)-1},$$

$$W^{s}(c) \cap \Omega(c) \cong S^{n-I(c)-1}$$

We will require the following two lemmas later in this section.

Lemma 3.2 (Lemma 3.2.5 in [AD14]). Let $x \in U \setminus \operatorname{Crit}(F_{ij})$ and let $x_{\nu} \in U$ be a sequence converging to x. Suppose y_{ν} and y are points lying on the same gradient flows of F_{ij} as x_{ν} and x, respectively, and suppose that $F_{ij}(y_{\nu}) = F_{ij}(y)$, then the sequence y_{ν} converges to y.

Proof. See Lemma 3.2.5 in [AD14].

Before the second lemma, we have to define some terminology. Recall the local form (1) for local functions near the cusp-edge. It follows that the gradient ∇F_{ij} is nonsingular on \overline{U} . Suppose $x \in \Pi(\Sigma)$ and ϕ is a gradient flow of F_{ij} that passes through x, then, since the gradient ∇F_{ij} is non-singular at x, there exists an embedded neighborhood $V \subset \Pi(\Sigma)$ of x and a coordinate chart $\varphi : W \subset M \to \mathbb{R}^n$, centered at x, that satisfies the following conditions:

- φ maps x to the origin,
- $\varphi(V)$ divides \mathbb{R}^n into two components, $W^- \coloneqq \varphi(W \cap U)$ and $W^+ \coloneqq \varphi(W \cap U^c)$,
- $-\nabla F_{ij}|_{W\cap U}$ corresponds to the coordinate vector field $\partial_{x_1}|_{W^-}$,
- and ϕ corresponds to the unique flow line of $\partial_{x_1}|_{W^- \cap \{x_2 = \dots = x_n = 0\}}$.

By the preliminary transversality condition, $-\nabla F_{ij}$ has order of contact at most n with $\Pi(\Sigma)$, i.e., ϕ has order of contact at most n with $\varphi(V)$ at the origin. In particular, ϕ cannot flow along $\varphi(V)$. Thus, there are two possibilities, ϕ either: can be extended (using the flow of ∂_{x_1}) to a flow line that touches $\varphi(V)$ at the origin and flows into W^+ , or touches $\varphi(V)$ at the origin and remains in W^- . In simpler terms, ϕ either crosses $\Pi(\Sigma)$ or doesn't. We say that ϕ ends on $\Pi(\Sigma)$ at x if ϕ can be extended, in some coordinate chart as above, to a flow line that crosses $\Pi(\Sigma)$.

Lemma 3.3. Let λ be a gradient flow of F_{ij} that ends on $\Pi(\Sigma)$ at x and let ϕ_{ν} be a sequence of gradient flows of F_{ij} . Suppose there exists a sequence of points x_{ν} in ϕ_{ν} that converge to x, then there exists a subsequence of ϕ_{ν} that ends on $\Pi(\Sigma)$ at y_{ν} , such that the sequence y_{ν} converges to x.

Proof. We construct a neighborhood $V \subset \Sigma$ of x and a coordinate chart $\varphi : W \subset M \to \mathbb{R}^n$, centered at x, as above. For $\nu \gg 0$, we may assume that ϕ_{ν} is identified with a flow line of $\partial_{x_1}|_{W^-}$, and we may assume that the sequence of points x_{ν} converges to the origin. Since λ ends on $\Pi(\Sigma)$ at x, we may extend λ to a flow line that crosses $\Pi(\Sigma)$. If we choose $z \in W^+$ on this extended flow line, then, by dependence of solutions to ODEs on initial conditions, there exists a sequence z_{ν} of points on (the extension, using the flow of ∂_{x_1} , of) ϕ_{ν} that converge to z. By continuity, it follows that (the extension, using the flow of ∂_{x_1} , of) ϕ_{ν} , and by passing to a subsequence, we see that the sequence y_{ν} converges to x, by dependence of solutions to ODEs on initial conditions. \Box

3.2. Notation. In this section, we simply define notation and terminology.

Let $a, b \in \operatorname{Crit}(F_{ij})$, where a and b are not necessarily distinct. We define the following sets:

- $\mathcal{M}_0(F_{ij}, a, b)$ the set of parameterized Morse flows of F_{ij} connecting a to b,
- *M*₀(*F_{ij}*, Π(Σ), b) the set of parameterized fold emanating flows of *F_{ij}* ending at b,
- *M*₀(*F_{ij}, a*, Π(Σ)) the set of parameterized fold terminating flows of *F_{ij}* starting at a,
- and $\mathcal{M}_0(F_{ij}, \Pi(\Sigma))$ the set of parameterized singular flows of F_{ij} .

We will drop the subscript in the notation if we would like to consider the set of maximally extended parameterized gradient flows of a certain type. There is a natural \mathbb{R} -action on each set of parameterized gradient flows, given by time-shift, i.e.,

$$(r,\phi) \mapsto \phi(t+r), \ r \in \mathbb{R}$$

Thus, we may define the quotients:

- $\mathcal{L}_0(F_{ij}, a, b) := \mathcal{M}_0(F_{ij}, a, b)/\mathbb{R}$ the set of (unparameterized) Morse flows of F_{ij} connecting a to b,
- $\mathcal{L}_0(F_{ij}, \Pi(\Sigma), b) := \mathcal{M}_0(F_{ij}, \Pi(\Sigma), b) / \mathbb{R}$ the set of (unparameterized) fold emanating flows of F_{ij} ending at b,
- $\mathcal{L}_0(F_{ij}, a, \Pi(\Sigma)) \coloneqq \mathcal{M}_0(F_{ij}, a, \Pi(\Sigma))/\mathbb{R}$ the set of (unparameterized) fold terminating flows of F_{ij} starting at a,
- and $\mathcal{L}_0(F_{ij}, \Pi(\Sigma)) := \mathcal{M}_0(F_{ij}, \Pi(\Sigma))/\mathbb{R}$ the set of (unparameterized) singular flows of F_{ij} .

Again, we will drop the subscript in the notation if we would like to only consider the set of maximally extended (unparameterized) gradient flows of a certain type.

Definition 3.4. Let $c_0, \ldots, c_{q+1} \in \operatorname{Crit}(F_{ij})$ such that

$$c_0 = a, \ c_{q+1} = b.$$

A q-times broken Morse flow of F_{ij} connecting a to b, denoted $\lambda = (\lambda^1, \ldots, \lambda^{q+1})$, is a concatenation of gradient flows:

$$\lambda^{1} \in \mathcal{L}_{0}(F_{ij}, c_{0}, c_{1}), \ \lambda^{k} \in \mathcal{L}(F_{ij}, c_{k-1}, c_{k}), \ \lambda^{q+1} \in \mathcal{L}_{0}(F_{ij}, c_{q}, c_{q+1}),$$

where $2 \leq k \leq q$. We denote by $\mathcal{L}_{q,0}(F_{ij}, a, b)$ the set of q-times broken Morse flows of F_{ij} connecting a to b.

Definition 3.5. Let $c_1, \ldots, c_{q+1} \in \operatorname{Crit}(F_{ij})$ such that

$$c_{q+1} = b.$$

A q-times broken fold emanating flow of F_{ij} ending at b, denoted $\lambda = (\lambda^1, \ldots, \lambda^{q+1})$, is a concatenation of gradient flows:

$$\lambda^1 \in \mathcal{L}_0(F_{ij}, \Pi(\Sigma), c_1), \ \lambda^k \in \mathcal{L}(F_{ij}, c_{k-1}, c_k), \ \lambda^{q+1} \in \mathcal{L}_0(F_{ij}, c_q, c_{q+1}),$$

where $2 \leq k \leq q$. We denote by $\mathcal{L}_{q,0}(F_{ij}, \Pi(\Sigma), b)$ the set of q-times broken fold emanating flows of F_{ij} ending at b.

Definition 3.6. Let $c_0, \ldots, c_q \in \operatorname{Crit}(F_{ij})$ such that

$$c_0 = a$$
.

A q-times broken fold terminating flow of F_{ij} starting at a, denoted $\lambda = (\lambda^1, \ldots, \lambda^{q+1})$, is a concatenation of gradient flows:

$$\lambda^1 \in \mathcal{L}_0(F_{ij}, c_0, c_1), \ \lambda^k \in \mathcal{L}(F_{ij}, c_{k-1}, c_k), \ \lambda^{q+1} \in \mathcal{L}_0(F_{ij}, c_q, \Pi(\Sigma)),$$

where $2 \leq k \leq q$. We denote by $\mathcal{L}_{q,0}(F_{ij}, a, \Pi(\Sigma))$ the set of q-times broken fold terminating flows of F_{ij} starting at a.

Definition 3.7. Let $c_1, \ldots, c_q \in \operatorname{Crit}(F_{ij})$. For $q \geq 1$, a *q*-times broken singular flow of F_{ij} , denoted $\lambda = (\lambda^1, \ldots, \lambda^{q+1})$, is a concatenation of gradient flows:

$$\lambda^1 \in \mathcal{L}_0(F_{ij}, \Pi(\Sigma), c_1), \ \lambda^k \in \mathcal{L}(F_{ij}, c_{k-1}, c_k), \ \lambda^{q+1} \in \mathcal{L}_0(F_{ij}, c_q, \Pi(\Sigma)),$$

where $2 \leq k \leq q$. A 0-times broken singular flow of F_{ij} is simply a singular flow of F_{ij} . We denote by $\mathcal{L}_{q,0}(F_{ij}, \Pi(\Sigma))$ the set of q-times broken singular flows F_{ij} .

Analogously, we may define a maximally extended q-times broken gradient flow of F_{ij} , of the appropriate type, by restricting to the case that the first and last component of the broken gradient flow are maximally extended gradient flows of F_{ij} , of the appropriate type. We may define the stratified sets:

$$\overline{\mathcal{L}}_{0}(F_{ij}, a, b) \coloneqq \bigcup_{q \ge 0} \mathcal{L}_{q,0}(F_{ij}, a, b),$$
$$\overline{\mathcal{L}}_{0}(F_{ij}, \Pi(\Sigma), b) \coloneqq \bigcup_{q \ge 0} \mathcal{L}_{q,0}(F_{ij}, \Pi(\Sigma), b),$$
$$\overline{\mathcal{L}}_{0}(F_{ij}, a, \Pi(\Sigma)) \coloneqq \bigcup_{q \ge 0} \mathcal{L}_{q,0}(F_{ij}, a, \Pi(\Sigma)),$$
$$\overline{\mathcal{L}}_{0}(F_{ij}, \Pi(\Sigma)) \coloneqq \bigcup_{q \ge 0} \mathcal{L}_{q,0}(F_{ij}, \Pi(\Sigma)).$$

Remark 3.8. The above stratifications are finite because, there are only finitely many critical points of F_{ij} , and the value of F_{ij} strictly decreases along any gradient flow.

We may define analogous stratified sets given by dropping the subscript. Finally, we will define the set of broken gradient flows of F_{ij} as

$$\overline{\mathcal{L}}_0(F_{ij}) \coloneqq \bigcup_{a,b \in \operatorname{Crit}(F_{ij})} \left\{ \overline{\mathcal{L}}_0(F_{ij}, a, b) \cup \overline{\mathcal{L}}_0(F_{ij}, \Pi(\Sigma), b) \cup \overline{\mathcal{L}}_0(F_{ij}, a, \Pi(\Sigma)) \right\} \cup \overline{\mathcal{L}}_0(F_{ij}, \Pi(\Sigma)),$$

where, again, omission of the subscript will be the analogous space where we consider only maximally extended broken gradient flows of F_{ij} . There is a natural inclusion $\mathcal{L}_0(F_{ij}) \to \overline{\mathcal{L}}_0(F_{ij})$, where $\mathcal{L}_0(F_{ij})$ is the set of (unparameterized) gradient flows of F_{ij} :

$$\mathcal{L}_{0}(F_{ij}) \coloneqq \bigcup_{a,b \in \operatorname{Crit}(F_{ij})} \{ \mathcal{L}_{0}(F_{ij}, a, b) \cup \mathcal{L}_{0}(F_{ij}, \Pi(\Sigma), b) \cup \mathcal{L}_{0}(F_{ij}, a, \Pi(\Sigma)) \} \cup \mathcal{L}_{0}(F_{ij}, \Pi(\Sigma)) \}$$

Similarly, there is a natural inclusion $\mathcal{L}(F_{ij}) \to \overline{\mathcal{L}}(F_{ij})$, where $\mathcal{L}(F_{ij})$ is the set of maximally extended (unparameterized) gradient flows of F_{ij}

3.3. Edge convergence. We will denote by \mathcal{I}_{ϕ} the set of intersection points of a gradient flow ϕ with the singular set. By the compactness of ϕ away from critical points, by the compactness of the singular set, and by the preliminary transversality condition, we see that \mathcal{I}_{ϕ} is a discrete finite set.

Definition 3.9. Let $\Lambda \in \overline{\mathcal{L}}(F_{ij})$. A convergence datum for Λ consists of the following data.

- A choice of Morse neighborhood $\Omega(c)$, for each $c \in \operatorname{Crit}(F_{ij})$ lying on Λ .
- A choice of neighborhood U_c^+ of the entry point of Λ into $\Omega(c)$, contained in the level set of F_{ij} that the entry point determines, for each critical point c lying on Λ .
- A choice of neighborhood U_c^- of the exit point of Λ from $\Omega(c)$, contained in the level set of F_{ij} that the exit point determines, for each critical point c lying on Λ .
- A choice of neighborhoods $\tilde{U}_p^1, \tilde{U}_p^2 \subset \Sigma$ of \tilde{p}^1, \tilde{p}^2 , respectively, where $\{\tilde{p}^1, \tilde{p}^2\}$ is a 1-jet lift of a point $p \in \mathcal{I}_{\Lambda}$, for each such intersection point.

Definition 3.10. Let $\lambda_{\nu} \in \overline{\mathcal{L}}_0(F_{ij})$ be a sequence, with maximally extended sequence $\Lambda_{\nu} \in \overline{\mathcal{L}}(F_{ij})$, and let $\lambda \in \overline{\mathcal{L}}_0(F_{ij})$, with maximal extension $\Lambda \in \overline{\mathcal{L}}(F_{ij})$. We

say that the sequence λ_{ν} edge converges to λ if there exists $\Psi^{\text{in}}, \Psi^{\text{out}} \in \overline{\mathcal{L}}(F_{ij})$, such that the concatentation $\Psi := \Psi^{\text{in}} # \Lambda \# \Psi^{\text{out}}$ is in $\overline{\mathcal{L}}(F_{ij})$, where Ψ satisfies the following condition. For every convergence datum for Ψ , and for $\nu \gg 0$, the following conditions are satisfied.

- If Λ_{ν} enters a Morse neighborhood $\Omega(c)$ in the convergence datum for Ψ , then Λ_{ν} enters through U_c^+ .
- If Λ_{ν} exits a Morse neighborhood $\Omega(c)$ in the convergence datum for Ψ , then Λ_{ν} exits through U_c^-
- For every $p_{\nu} \in \mathcal{I}_{\Lambda_{\nu}}$, with 1-jet lift $\{\tilde{p}_{\nu}^{1}, \tilde{p}_{\nu}^{2}\}$, there exists a $p \in \mathcal{I}_{\Psi}$, with 1-jet lift $\{\tilde{p}^{1}, \tilde{p}^{2}\}$ and neighborhoods $\tilde{U}_{p}^{1}, \tilde{U}_{p}^{2} \subset \Sigma$ in the convergence datum for Ψ , such that $\tilde{p}_{\nu}^{1}, \tilde{p}_{\nu}^{2}$ are contained in $\tilde{U}_{p}^{1}, \tilde{U}_{p}^{2}$, respectively.

Moreover, we require that Ψ also satisfies the following condition. Let v_{ν}^1, v_{ν}^2 denote the sequences of endpoints of the sequence λ_{ν} , where λ_{ν} flows from v_{ν}^1 to v_{ν}^2 . We require that the points

$$v^k \coloneqq \lim_{\nu \to \infty} v^k_{\nu}, \ k = 1, 2$$

lie on Ψ , and we require that λ is the restriction of Ψ that connects v^1 to v^2 .

Remark 3.11. The edge limit of a sequence λ_{ν} , if it exists, is unique. This follows by the condition on convergence of the sequences of endpoints v_{ν}^{k} and dependence of solutions to ODEs on initial conditions.

Remark 3.12. It is clear that edge convergence satisfies a diagonal property (Diagonal axiom in Definition 4.11).

We will spend the rest of this section showing that every sequence of broken gradient flows of F_{ij} has a subsequence that edge converges to some broken gradient flow of F_{ij} . This will be proved through a sequence of lemmas.

Lemma 3.13. Suppose we have a sequence $\Phi_{\nu} \in \mathcal{L}(F_{ij}, a, b)$, then there exists a subsequence that edge converges.

Proof. This is essentially the proof of Lemma 3.2.5 in [AD14], with the appropriate modifications.

If a and b are the same point, then the lemma follows, since the sequence is the constant sequence. So we may assume $a \neq b$.

Let $c_0 \coloneqq a$, let $c_{q+1} \coloneqq b$, and let $\Omega(c_0)$ be a Morse neighborhood of c_0 . We denote by $\Phi_{\nu,1}^- \in W^u(c_0) \cap \partial\Omega(c_0)$ the point that Φ_{ν} exits $\Omega(c_0)$ through. Since

$$W^u(c_0) \cap \partial \Omega(c_0) \cong S^{I(c_0)-1}$$

we may pass to a subsequence and assume that the sequence $\Phi_{\nu,1}^-$ converges to a point $\Lambda_1^- \in W^u(c_0) \cap \partial \Omega(c_0)$. Let Λ^1 be the unique maximally extended gradient flow of F_{ij} determined by Λ_1^- .

We claim that there exists $c_1 \in \operatorname{Crit}(F_{ij})$ such that Λ^1 terminates at c_1 . If this were not the case, then Λ^1 would end on $\Pi(\Sigma)$ at some point y. By dependence of solutions to ODEs on initial conditions, there exists a sequence of points x_{ν} on Φ_{ν} that converges to y. But this is a contradiction, by Lemma 3.3, to the fact that Φ_{ν} is a sequence in $\mathcal{L}(F_{ij}, a, b)$.

Let $\Omega(c_1)$ be a Morse neighborhood of c_1 . We denote by $\Lambda_1^+ \in W^s(c_1) \cap \partial \Omega(c_1)$ the point that Λ^1 enters $\Omega(c_1)$ through. By dependence of solutions to ODEs on initial conditions, there exists a point $\Phi_{\nu,1}^+ \in \partial \Omega(c_1)$ on Φ_{ν} , for $\nu \gg 0$. By Lemma 3.2, the sequence $\Phi_{\nu,1}^+$ converges to Λ_1^+ . If $c_1 = c_{q+1}$, then we are done.

Suppose that $c_1 \neq c_{q+1}$, then $\Phi_{\nu,1}^+ \notin W^s(c_1)$, hence Φ_{ν} exits $\Omega(c_1)$ through a point $\Phi_{\nu,2}^- \in \partial \Omega(c_1)$. Since $\partial \Omega(c_1)$ is compact, we may pass to a subsequence and assume that the sequence $\Phi_{\nu,2}^-$ converges to a point $\Lambda_2^- \in \partial \Omega(c_1)$. We claim that $\Lambda_2^- \in W^u(c_1)$. Suppose this were not the case, then there exists a gradient flow of F_{ij} , denoted γ , that enters $\Omega(c_1)$, through a point $\gamma_1^+ \in \partial \Omega(c_1)$ satisfying $F_{ij}(\gamma_1^+) = F_{ij}(\Phi_{\nu,1}^+)$, and exits $\Omega(c_1)$ through Λ_2^- . By Lemma 3.2, the sequence $\Phi_{\nu,1}^+$ converges to γ_1^+ , hence $\gamma_1^+ = \Lambda_1^+$. But this is a contradiction, since $\Lambda_1^+ \in W^s(c_1)$, to the fact that γ_1^+ cannot possibly be in $W^s(c_1)$. We now apply the argument at the beginning of this proof, replacing c_0 with c_1 .

We may now inductively construct a maximally extended broken gradient flow Λ of F_{ij} . By dependence of solutions to ODEs on initial conditions, and by compactness of $\Pi(\Sigma)$, we see that every point in $\mathcal{I}_{\Phi_{\nu}}$ is sufficiently close to a point in \mathcal{I}_{Λ} . It follows that Λ is the edge limit of the sequence Φ_{ν} , by construction.

Lemma 3.14. Suppose we have a sequence $\Phi_{\nu} \in \mathcal{L}(F_{ij}, \Pi(\Sigma), b)$, then there exists a subsequence that edge converges.

Proof. Let $c_{q+1} := b$. Since $\Pi(\Sigma) \cap \overline{U}$ is compact, we may pass to a subsequence and assume that the sequence of emanation points of Φ_{ν} converges to a point $\Lambda_1^- \in \Pi(\Sigma) \cap \overline{U}$. Let Λ^1 be the unique maximally extended gradient flow of F_{ij} determined by Λ_1^- .

We claim that there exists $c_1 \in \operatorname{Crit}(F_{ij})$ such that Λ^1 terminates at c_1 . If this were not the case, then Λ^1 would end on $\Pi(\Sigma)$ at some point y. By dependence of solutions to ODEs on initial conditions, there exists a sequence of points x_{ν} on Φ_{ν} that converges to y. But this is a contradiction, by Lemma 3.3, to the fact that Φ_{ν} is a sequence in $\mathcal{L}(F_{ij}, \Pi(\Sigma), b)$.

We may now apply the argument of Lemma 3.13 to inductively construct a maximally extended broken gradient flow Λ of F_{ij} . By dependence of solutions to ODEs on initial conditions, and by compactness of $\Pi(\Sigma)$, we see that every point in $\mathcal{I}_{\Phi_{\nu}}$ is sufficiently close to a point in \mathcal{I}_{Λ} . We let λ be the restriction of Λ that connects Λ_1^- to b. It follows that λ is the edge limit of the sequence Φ_{ν} , by construction.

Lemma 3.15. Suppose we have a sequence $\Phi_{\nu} \in \mathcal{L}(F_{ij}, a, \Pi(\Sigma))$, then there exists a subsequence that edge converges.

Proof. Consider the sequence Φ_{ν} as a sequence in $\mathcal{L}(-F_{ij}, \Pi(\Sigma), a)$ and apply Lemma 3.14

Lemma 3.16. Suppose we have a sequence $\Phi_{\nu} \in \mathcal{L}(F_{ij}, \Pi(\Sigma))$, then there exists a subsequence that edge converges.

Proof. Since $\Pi(\Sigma) \cap \overline{U}$ is compact, we may pass to a subsequence and assume that the sequence of emanation points of Φ_{ν} converges to a point $\Lambda_1^- \in \Pi(\Sigma) \cap \overline{U}$. Let Λ^1 be the unique maximally extended gradient flow of F_{ij} determined by Λ_1^- .

We have two cases.

- 1. There exists $c_1 \in \operatorname{Crit}(F_{ij})$ such that Λ^1 terminates at c_1 . We may now apply the argument of Lemma 3.13.
- 2. There does not exist $c_1 \in \operatorname{Crit}(F_{ij})$ such that Λ^1 terminates at c_1 , i.e., Λ^1 ends on $\Pi(\Sigma)$ at some point y. Since $\Pi(\Sigma) \cap \overline{U}$ is compact, we may pass to a subsequence and assume that the sequence of termination points of Φ_{ν} converges to a point $\Lambda_{a+1}^+ \in \Pi(\Sigma) \cap \overline{U}$. By dependence of solutions to ODEs

on initial conditions, it follows that Λ_{q+1}^+ must lie on Λ^1 . Note, we do not necessarily have that $\Lambda_{q+1}^+ = y$.

In either case, we may now inductively construct a maximally extended broken gradient flow Λ of F_{ij} . By dependence of solutions to ODEs on initial conditions, and by compactness of $\Pi(\Sigma)$, we see that every point in $\mathcal{I}_{\Phi_{\nu}}$ is sufficiently close to a point in \mathcal{I}_{Λ} . We let λ be the restriction of Λ that connects Λ_1^- to Λ_{q+1}^+ . It follows that λ is the edge limit of the sequence Φ_{ν} , by construction.

Lemma 3.17. Suppose we have a sequence $\Lambda_{\nu} \in \overline{\mathcal{L}}(F_{ij})$, then there exists a subsequence that edge converges.

Proof. By the finite stratification of $\mathcal{L}(F_{ij})$, we may pass to a subsequence and assume that Λ_{ν} is a sequence in:

$$\overline{\mathcal{L}}(F_{ij}, a, b), \ \overline{\mathcal{L}}(F_{ij}, \Pi(\Sigma), b), \ \overline{\mathcal{L}}(F_{ij}, a, \Pi(\Sigma)), \ \text{or} \ \overline{\mathcal{L}}(F_{ij}, \Pi(\Sigma)).$$

For definiteness, we will assume that Λ_{ν} is a sequence in $\overline{\mathcal{L}}(F_{ij}, a, b)$ – the other cases are analogous. If a and b are the same point, then the lemma follows, since the sequence is the constant sequence. So we may assume $a \neq b$.

By the finite stratification of $\mathcal{L}(F_{ij}, a, b)$, we may pass to a subsequence and assume that Λ_{ν} is a sequence in $\mathcal{L}_q(F_{ij}, a, b)$, for some $q \geq 0$, i.e.,

$$\Lambda_{\nu} = (\Lambda_{\nu}^1, \dots, \Lambda_{\nu}^{q+1}).$$

We may pass to a subsequence and assume that Λ_{ν}^{k} is a sequence in $\mathcal{L}(F_{ij}, c_{k-1}, c_k)$, for some $c_{k-1}, c_k \in \operatorname{Crit}(F_{ij})$, for every k. We may now apply Lemma 3.13, to each sequence Λ_{ν}^{k} individually, and construct a maximally extended broken gradient flow Λ . By dependence of solutions to ODEs on initial conditions, and by compactness of $\Pi(\Sigma)$, we see that every point in $\mathcal{I}_{\Lambda_{\nu}}$ is sufficiently close to a point in \mathcal{I}_{Λ} . It follows that Λ is the edge limit of the sequence Λ_{ν} , by construction. \Box

Proposition 3.18. Suppose we have a sequence $\lambda_{\nu} \in \overline{\mathcal{L}}_0(F_{ij})$, then there exists a subsequence that edge converges.

Proof. Let $\Lambda_{\nu} \in \overline{\mathcal{L}}(F_{ij})$ be the maximal extension of λ_{ν} . We may pass to a subsequence and, by Lemma 3.17, assume that the sequence Λ_{ν} edge converges to some

A. Let v_{ν}^1, v_{ν}^2 denote the sequences of endpoints of the sequence λ_{ν} , where λ_{ν} flows from v_{ν}^1 to v_{ν}^2 . We may pass to a subsequence and assume that the limits

$$v^k \coloneqq \lim_{\nu \to \infty} v^k_{\nu}, \ k = 1, 2$$

exist and lie on Λ . Let λ be the restriction of Λ that connects v^1 to v^2 . It follows that λ is the edge limit of the sequence λ_{ν} , by construction.

Remark 3.19. In this section, we formally compactified gradient flows by using broken gradient flows, in complete analogy to the compactification in standard Morse theory. One could make the argument that, in our case, a broken gradient flow should involve more than just breakings at critical points – perhaps we should add a breaking at every intersection point of the curve with $\Pi(\Sigma)$. However, when translating these "breakings" on $\Pi(\Sigma)$ to flow trees, this would simply result in removable vertices as in Definitions 2.7 and 4.3. Thus, we do not consider these.

Remark 3.20. The reader familiar with flow trees may be worried about the appearance of switches when compactifying edges. Here, a switch refers to a certain type of 2-valent vertex appearing in a generic flow tree, see Remark 3.8 in [Ekh07] and the surrounding discussion. The edges adjacent to a switch are, necessarily, assigned gradient flows of different local function differences. In particular, a switch vertex cannot possibly appear in the boundary of the moduli space of gradient flows of a fixed local function difference – this would require the moduli space to "know" about gradient flows of other local function differences. In the definition of Floer-Gromov convergence (Definitnion 4.9) we will see that the compactification of edges behaves as follows: given a convergent sequence of edges e_{ν} then, for $\nu \gg 0$, all edges are assigned gradient flows ϕ_{ν} of the same local function difference; these edges, necessarily, only have two vertices (the emanation point and termination point). The limiting (stable) flow tree of the sequence e_{ν} will be a chain of edges: one edge for each component of the broken gradient flow λ that ϕ_{ν} edge converges to. In particular, no switches appear.

4. Compactification of flow trees

4.1. Stable flow trees. The following is a natural generalization of Definition 2.6.

Definition 4.1. A prestable flow tree of L is a continuous map $\lambda : T \to M$, where T is a source tree, that satisfies the following conditions.

- If e is an edge of T, then $\lambda : e \to M$ is either:
 - a broken gradient flow, i.e., a *real edge*,
 - or a constant map, i.e., a *ghost edge*.
- Let v be a k-valent vertex of T with (cyclically ordered) real edges $e_{v,1}, \ldots, e_{v,k}$. We require that there exists cotangent lifts

$$\left\{\overline{\lambda}_{v,j}^1, \overline{\lambda}_{v,j}^2\right\}$$

for each edge $e_{v,j}$, such that

$$\overline{p}_{v,j} \coloneqq \overline{\lambda}_{v,j}^2(v) = \overline{\lambda}_{v,j+1}^1(v) \in \Pi_{\mathbb{C}}(L)$$

and such that the flow orientation of $\overline{\lambda}_{v,j}^2$ at $\overline{p}_{v,j}$ is directed toward $\overline{p}_{v,j}$ if and only if the flow orientation of $\overline{\lambda}_{v,j+1}^1$ at $\overline{p}_{v,j}$ is directed away from $\overline{p}_{v,j}$.

• We require that the aforementioned cotangent lifts of all the edges yield an oriented loop in $\Pi_{\mathbb{C}}(L)$.

Remark 4.2. A 1-jet lift (or a cotangent lift) of a broken gradient flow is defined in the natural way - we lift each component.

Prestable flow trees have the same issue as true flow trees, namely, the phenomenon of removable vertices:

Definition 4.3. Let T be a prestable flow tree. A removable vertex of T is a 2-valent vertex v, whose adjacent edges are real edges, such that: the assigned gradient flows of the adjacent edges, $\phi_{v,1}$ and $\phi_{v,2}$, are both gradient flows of the same local function difference F_{ij} , and these gradient flows concatenate together at

$$p_v \coloneqq \phi_{v,1}(v) = \phi_{v,2}(v)$$

to give a single gradient flow ϕ_v of F_{ij} .

Moreover, prestable flow trees also have the issue of missing vertices, which are the following:

Definition 4.4. Let T be a prestable flow tree and let $\lambda : e \to M$ be a real edge, i.e., λ is a broken gradient flow. For every breaking of λ at a critical point, we add a 2-valent vertex v to e. Such an added vertex is called a *missing vertex of* T.

Definition 4.5. A *stable flow tree* is a prestable flow tree with no removable vertices and all possible missing vertices.

Remark 4.6. Equivalently, a stable flow tree is a(n unparameterized) flow tree that allows ghost edges. Hence, the natural inclusion of the set of (unparameterized) flow trees into the set of (pre)stable flow trees is injective.

Any prestable flow tree T can be *stabilized* by deleting removable vertices and by adding missing vertices. Also, a (pre)stable flow tree T can be *destabilized* by adding removable vertices and by removing missing vertices. We will only consider destabilizations that remove missing vertices in this article.

Definition 4.7. Let T and T' be two stable flow trees. We say that T and T' have the same *combinatorial type* Γ if T and T' satisfy the following conditions.

- T and T' are isomorphic as combinatorial trees.
- For any real edge e of T, there exists a real edge e' of T' such that the associated gradient flows ϕ and ϕ' are gradient flows of the same local function difference.
- For any real edge e' of T', there exists a real edge e of T such that the associated gradient flows ϕ' and ϕ are gradient flows of the same local function difference.

We will denote by $\mathcal{L}(L)$ the set of stable flow trees. Moreover, we will denote by $\mathcal{L}(L, N)$ the set of stable flow trees, with at most N edges. There is a finite stratification

$$\mathcal{L}(L,N) = \bigcup_{\Gamma} \mathcal{L}(L,N,\Gamma),$$

where $\mathcal{L}(L, N, \Gamma)$ is the set of stable flow trees, with at most N edges, of combinatorial type Γ .

4.2. Floer-Gromov convergence. Floer-Gromov convergence is meant to be a natural generalization of edge convergence to stable flow trees. However, the definition is a bit long-winded, so we break it into two parts.

Definition 4.8. Let T_{ν} be a sequence of stable flow trees and T a prestable flow tree. We say that T_{ν} converges to T if, for $\nu \gg 0$, the following conditions hold.

- Every T_{ν} is of the same combinatorial type Γ .
- T is of the same combinatorial tree isomorphism class as the combinatorial tree isomorphism class determined by Γ .
- For every sequence $\phi_{\nu} : e_{\nu} \to M$ of real edges, the corresponding isomorphic edge $\lambda : e \to M$ is either: a real edge that the sequence ϕ_{ν} edge converges to, or a ghost edge such that the sequence ϕ_{ν} edge converges to $\lambda(e)$, where $\lambda(e)$ is thought of as the restriction of the edge limit of the sequence ϕ_{ν} to the point $\lambda(e)$.
- For every sequence $\phi_{\nu}: e_{\nu} \to M$ of ghost edges, the corresponding isomorphic edge $\lambda: e \to M$ is a ghost edge such that the sequence $\phi_{\nu}(e_{\nu})$ converges to $\lambda(e)$, in the topology of M.

Definition 4.9. Let T_{ν} be a sequence of stable flow trees and T a stable flow tree. We say that T_{ν} Floer-Gromov converges to T if there exists a prestable flow tree T', that stabilizes to T, such that T_{ν} converges to T'.

We are now ready to prove Theorem 1.1.

Proof of Theorem 1.1. Let $N \coloneqq \sup_{\nu} |\mathcal{E}_{\nu}| < \infty$. We may pass to a subsequence, since there is a finite stratification of $\mathcal{L}(L, N)$ by combinatorial type, and assume every T_{ν} is of the same combinatorial type Γ . Let T' be a combinatorial tree in the combinatorial tree isomorphism class determined by Γ . We must build a prestable flow tree structure on T' such that the sequence T_{ν} converges to T'. We will do this edge by edge.

Let $\phi_{\nu} : e_{\nu} \to M$ be a sequence of isomorphic edges and let e' be the corresponding isomorphic edge of T'. We may pass to a subsequence, since every T_{ν} is the same combinatorial type, and assume, by Proposition 3.18, that the sequence ϕ_{ν} edge converges to a broken gradient flow λ' . We now assign this broken gradient flow λ' to the edge e'.

Since $N < \infty$, we may do this for all such sequences of isomorphic edges. Hence, we have built a prestable flow tree structure on T' such that T_{ν} converges to T'. Let T be the stable flow tree obtained by stabilizing T'. It follows that T is the Floer-Gromov limit of the sequence T_{ν} , by construction. We may define the moduli space

$$\overline{\mathcal{L}}(L,N) \coloneqq \left\{ T \in \mathcal{L}(L) : \begin{array}{l} \text{there exists a sequence } T_{\nu} \in \mathcal{L}(L,N) \\ \text{that Floer-Gromov converges to } T \end{array} \right\}$$

Currently, $\overline{\mathcal{L}}(L, N)$ is only a set, but we will give this set a topology later in this section. The proof of Theorem 1.2 will require the following lemma, so we collect its proof here.

Lemma 4.10. Suppose $T_{\kappa} \in \overline{\mathcal{L}}(L, N)$ is a sequence that Floer-Gromov converges to a stable flow tree T, then T is in $\overline{\mathcal{L}}(L, N)$.

Proof. By definition of $\overline{\mathcal{L}}(L, N)$, for every κ , there exists a sequence $T_{\nu,\kappa} \in \mathcal{L}(L, N)$ that Floer-Gromov converges to T_{κ} . It suffices to show that there exists a subsequence T_{ν_r,κ_r} that Floer-Gromov converges to T. We note that, since there are only finitely many local function differences under consideration, and every local function difference has a finite number of critical points, the supremum

$$S \coloneqq \sup_{i,j} |\operatorname{Crit}(F_{ij})|$$

is finite. In particular, the moduli space $\overline{\mathcal{L}}(L, N)$ is contained in $\mathcal{L}(L, N \cdot S)$, so every sequence currently under consideration has a uniform bound on the number of edges, given by $N \cdot S$. This follows since any sequence of edges may break at most S times, so the Floer-Gromov limit of a sequence in $\mathcal{L}(L, N)$ has at most $N \cdot S$ edges.

We may assume, by taking $\kappa \gg 0$, that every T_{κ} is of the same combinatorial type Γ . Moreover, there exists a prestable flow tree T' in the combinatorial tree isomorphism class determined by Γ , that stabilizes to T, such that the sequence T_{κ} converges to T'. This is all by Definition 4.9.

For every $\kappa \gg 0$ we may assume, by taking $\nu \gg 0$, that every $T_{\nu,\kappa}$ is of the same combinatorial type Γ_{κ} . Moreover, there exists a prestable flow tree T'_{κ} in the combinatorial tree isomorphism class determined by Γ_{κ} , that stabilizes to T_{κ} , such that the sequence $T_{\nu,\kappa}$ converges to T'_{κ} . This is all by Definition 4.9.

We may pass to a subsequence, since there is a finite stratification of $\mathcal{L}(L, N \cdot S)$ by combinatorial type, and assume that, for $\nu, \kappa \gg 0$, all of the combinatorial types Γ_{κ} are the same combinatorial type Γ_0 . In particular, all of the prestable flow trees T'_{κ} are in the same combinatorial tree isomorphism class determined by Γ_0 . Finally, by destabilizing the prestable flow tree T', we may assume (the destabilization of) T' is in the combinatorial tree isomorphism class determined by Γ_0 , and by the convergence of the sequence T_{κ} to T', we may assume (the destabilization of) T' satisfies the following condition. Every sequence $\lambda'_{\kappa} : e'_{\kappa} \to M$ of isomorphic real edges of T'_{κ} edge converges to the corresponding isomorphic edge $\lambda' : e' \to M$ of (the destabilization of) T'. The same is true of the ghost edges. By the diagonal property of edge convergence, and the fact that every sequence under consideration has at most $N \cdot S$ edges, we may find a subsequence T_{ν_r,κ_r} such that every sequence $\phi_{\nu_r,\kappa_r} : e_{\nu_r,\kappa_r} \to M$ of isomorphic real edges of T_{ν_r,κ_r} edge converges to the corresponding isomorphic edge $\lambda' : e' \to M$ of (the destabilization of) T'. The same is true of the ghost edges. By stabilizing T' to obtain T, we have shown that T_{ν_r,κ_r} Floer-Gromov converges to T, as desired.

4.3. Floer-Gromov topology. We will topologize $\overline{\mathcal{L}}(L, N)$ using convergence structures. The following general facts about convergence structures can be found in Section 5.6 of [MS12].

Definition 4.11. Let X be a set. A *convergence structure* on X is a subset $\mathcal{C} \subset X \times X^{\mathbb{N}}$ that satisfies the following conditions.

- Constant: If $x_{\nu} = x_0$, for all $\nu \in \mathbb{N}$, then $(x_0, (x_{\nu})_{\nu}) \in \mathcal{C}$.
- Subsequence: If $(x_0, (x_\nu)_\nu) \in \mathcal{C}$ and $g : \mathbb{N} \to \mathbb{N}$ is strictly increasing, then $(x_0, (x_{g(\nu)})_\nu) \in \mathcal{C}$.
- Subsubsequence: If, for every strictly increasing function $g : \mathbb{N} \to \mathbb{N}$, there exists a strictly increasing function $f : \mathbb{N} \to \mathbb{N}$, such that $(x_0, (x_{(g \circ f)(\nu)})_{\nu}) \in \mathcal{C}$, then $(x_0, (x_{\nu})_{\nu}) \in \mathcal{C}$.
- Diagonal: If $(x_0, (x_\kappa)_\kappa) \in \mathcal{C}$ and, for every $\kappa \in \mathbb{N}$, $(x_\kappa, (x_{\nu,\kappa})_\nu) \in \mathcal{C}$, then there exists subsequences $\nu_r, \kappa_r \in \mathbb{N}$ such that $(x_0, (x_{\nu_r,\kappa_r})_r) \in \mathcal{C}$.
- Uniqueness: If $(x_0, (x_\nu)_\nu) \in \mathcal{C}$ and $(y_0, (x_\nu)_\nu) \in \mathcal{C}$, then $x_0 = y_0$.

We call the pair (X, \mathcal{C}) a convergence space.

Intuitively, we should think of an element $(x_0, (x_\nu)_\nu) \in \mathcal{C}$ as a sequence x_ν that converges to a point x_0 . This intuition is made precise by the following definition and lemma:

Definition 4.12. Let (X, \mathcal{C}) be a convergence space. We define $U \subset X$ to be open if and only if, for every $(x_0, (x_\nu)_\nu) \in \mathcal{C} \cap (U \times X^{\mathbb{N}}), x_\nu \in U$ for $\nu \gg 0$.

Lemma 4.13. The collection of open sets in Definition 4.12 forms a topology on X. Moreover, this topology is unique with respect to the following property. A sequence $x_{\nu} \in X$ converges to a point $x_0 \in X$ if and only if $(x_0, (x_{\nu})_{\nu}) \in C$.

For the moduli space $\overline{\mathcal{L}}(L, N)$, we consider the subset $\mathcal{C}_{FG} \subset \overline{\mathcal{L}}(L, N) \times \overline{\mathcal{L}}(L, N)^{\mathbb{N}}$ of all pairs

 $\mathcal{C}_{FG} \coloneqq \{(T, T_{\nu}) : \text{the sequence } T_{\nu} \text{ Floer-Gromov converges to } T\}.$

We are now ready to prove Theorem 1.2.

Proof of Theorem 1.2. It suffices to prove that $(\overline{\mathcal{L}}(L, N), \mathcal{C}_{FG})$ is a convergence space, and that $\overline{\mathcal{L}}(L, N)$ is compact with respect to the induced topology.

The constant axiom is obvious. The subsequence and subsubsequence axioms follow since Floer-Gromov convergence essentially reduces to edge convergence. The uniqueness axiom follows from the stabilization condition in Floer-Gromov convergence. So we only check the diagonal axiom.

Let $T_{\nu,\kappa}$ be sequences of stable flow trees that Floer-Gromov converge, as $\nu \to \infty$, to stable flow trees T_{κ} , where T_{κ} is a sequence of stable flow trees that Floer-Gromov converges, as $\kappa \to \infty$, to a stable flow tree T.

Let S be as in the proof of Lemma 4.10, then, since the moduli space $\overline{\mathcal{L}}(L, N)$ is contained in $\mathcal{L}(L, N \cdot S)$, every sequence currently under consideration has a uniform bound on the number of edges, given by $N \cdot S$.

We may assume, by taking $\kappa \gg 0$, that every T_{κ} is of the same combinatorial type Γ . Moreover, there exists a prestable flow tree T' in the combinatorial tree isomorphism class determined by Γ , that stabilizes to T, such that the sequence T_{κ} converges to T'. This is all by Definition 4.9.

For every $\kappa \gg 0$ we may assume, by taking $\nu \gg 0$, that every $T_{\nu,\kappa}$ is of the same combinatorial type Γ_{κ} . Moreover, there exists a prestable flow tree T'_{κ} in the combinatorial tree isomorphism class determined by Γ_{κ} , that stabilizes to T_{κ} , such that the sequence $T_{\nu,\kappa}$ converges to T'_{κ} . This is all by Definition 4.9.

We may pass to a subsequence, since there is a finite stratification of $\mathcal{L}(L, N \cdot S)$ by combinatorial type, and assume that, for $\nu, \kappa \gg 0$, all of the combinatorial types Γ_{κ} are the same combinatorial type Γ_0 . In particular, all of the prestable flow trees T'_{κ} are in the same combinatorial tree isomorphism class determined by Γ_0 .

Finally, by destabilizing the prestable flow tree T', we may assume (the destabilization of) T' is in the combinatorial tree isomorphism class determined by Γ_0 , and by the convergence of the sequence T_{κ} to T', we may assume (the destabilization of) T' satisfies the following condition. Every sequence $\lambda'_{\kappa} : e'_{\kappa} \to M$ of isomorphic real edges of T'_{κ} edge converges to the corresponding isomorphic edge $\lambda' : e' \to M$ of (the destabilization of) T'. The same is true of the ghost edges. By the diagonal property of edge convergence, and the fact that every sequence under consideration has at most $N \cdot S$ edges, we may find a subsequence T_{ν_r,κ_r} such that every sequence $\phi_{\nu_r,\kappa_r} : e_{\nu_r,\kappa_r} \to M$ of isomorphic real edges of T_{ν_r,κ_r} edge converges to the corresponding isomorphic edge $\lambda' : e' \to M$ of (the destabilization of) T'. The same is true of the ghost edges. By stabilizing T' to obtain T, we have shown that T_{ν_r,κ_r} Floer-Gromov converges to T, as desired.

Thus, $(\overline{\mathcal{L}}(L, N), \mathcal{C}_{FG})$ is a convergence space, and it follows that $\overline{\mathcal{L}}(L, N)$ has a unique topology with the property that topological convergence is equivalent to Floer-Gromov convergence. It remains to show $\overline{\mathcal{L}}(L, N)$ is compact with respect to this topology.

Let $T_{\nu} \in \overline{\mathcal{L}}(L, N)$ be a sequence. We may pass to a subsequence, since we have the uniform edge bound $\sup_{\nu} |\mathcal{E}_{\nu}| \leq N \cdot S$, and assume, by Theorem 1.1, that the sequence T_{ν} Floer-Gromov converges to some T. By Lemma 4.10, it follows that $T \in \overline{\mathcal{L}}(L, N)$, and this completes the proof.

5. Example of Floer-Gromov convergence

In this section, we exhibit examples of Floer-Gromov convergence of stable flow trees. These examples of (pre)stable flow trees are from Section 7 of [Ekh07].

Let $F_1, F_2 \subset J^0(\mathbb{R}^2) = \mathbb{R}^3$ be two fronts, where: F_1 is the 0-section, and F_2 is the graph of the function $z(x_1, x_2) = K - x_1$, where $K \gg 0$. We will consider the projection of the fronts, to \mathbb{R}^2 , in a square

$$-R \le |x_i| \le R, \ R > 0.$$




Figure 2: (Figure 17 in [Ekh07]) (Top) The top view of F'_1 . (Bottom) The cross-sectional view of F'_1 .

Consider the perturbation of F_1 , via Legendrian isotopy, into F'_1 , where F'_1 is a front with three sheets, denoted A, B, C, whose projection to \mathbb{R}^2 is described as follows. Consider two concentric circles in \mathbb{R}^2 , then A is the outer region, C is the middle region, and B is the inner region. The A and C sheet meet at the inner circle, and the B and C sheet meet at the outer circle. We will denote by D the single sheet of F_2 . See Figure 2.

We will use the notation in [Ekh07] for (pre)stable flow trees. Vertices will be labelled by Greek letters and edges will be labelled by numbers. For an edge, labelled by n, we write $n \coloneqq X|Y$, where X, Y are each one of the four sheets A, B, C, D, if the edge n has an associated (broken) gradient flow determined by the sheets X and Y.




Figure 3: (Figure 18 in [Ekh07]) The sequence of stable flow trees T_{ν} .




Figure 4: (Figure 19 in [Ekh07]) The original prestable flow tree \overline{T} .

We will describe our (pre)stable flow trees using the top view of the front F'_1 . Consider the sequence of one-edge stable flow trees T_{ν} , with edge 1 = A|D, starting in the region A and flowing horizontally to the region A. The sequence T_{ν} moves this edge downward until it is tangent to the circle connecting the region C to the region B. Denote this tangent one-edge stable flow tree by T, with edge 1 = A|D. Clearly, T is the Floer-Gromov limit of the sequence T_{ν} . See Figures 3 and 4

Originally, in [Ekh07], the stable flow tree T is described as a two-edge prestable

flow tree \overline{T} , with a vertex α at the tangency point, and with edges 1 = 2 = A|D. However, this vertex is a removable vertex (see Remark 3.19).




Figure 5: (Figure 20 in [Ekh07]) The sequence of stable flow trees T'_{ν} .

Now consider the sequence of four-edge stable flow trees T'_{ν} described as follows. An edge 1 = A|D, flowing from the region A to the region C, that ends at a 3-valent vertex α . From α we have two other edges: 2 = A|C flowing transversely into the circle connecting the region C to the region B, ending at a vertex β , and 3 = C|D flowing tangentially into the circle connecting the region C to the region C to the region B, ending at a vertex β , and 3 = C|D flowing tangentially into the circle connecting the region C to the region B, that ends at a 2-valent vertex γ . Finally, from γ we have one other edge 4 = A|D, flowing from the region C to the region A. The sequence T'_{ν} shrinks the edge 2, colliding the vertices α and β into the vertex γ . See Figure 5.

The Floer-Gromov limit T' of the sequence T'_{ν} will be a stable flow tree, with the same domain as the sequence, where edges 2 and 3 will be ghost edges. In particular, we see that the maps $\lambda : T \to M$ and $\lambda' : T' \to M$ will have the same image.
