# A FINITE ANALOGUE OF FINE'S FUNCTION $F(a, b ; t)$

#### Abstract

We initiate a systematic development of $F_{N}(a, b ; t)$, a finite analogue of Fine's function $F(a, b ; t)$. Our results are transformations between $F_{N}(a, b ; t)$ and $F_{N}\left(a q^{\ell}, b q^{m} ; t q^{n}\right)$, where $\ell, m$ and $n$ take the values 0 or 1 .


## 1. Introduction

In [5], Nathan J. Fine extensively studied the function $F(a, b ; t)$ which he defined by

F(a, b ; t):=\sum_{n=0}^{\infty} \frac{(a q)_{n}}{(b q)_{n}} t^{n}, \tag{1.1}
\end{equation*}
$$

where, here as well as in the rest of the paper, the following standard $q$-series notation is used:

(A)_{0} & :=(A ; q)_{0}=1, \\
(A)_{n} & :=(A ; q)_{n}=(1-A)(1-A q) \cdots\left(1-A q^{n-1}\right), \quad n \geq 1, \\
(A)_{\infty} & :=(A ; q)_{\infty}=\lim _{n \rightarrow \infty}(A ; q)_{n}, \quad|q|<1, \\
\left(A_{1}, A_{2}, \cdots, A_{m} ; q\right)_{n} & :=\left(A_{1} ; q\right)_{n}\left(A_{2} ; q\right)_{n} \cdots\left(A_{m} ; q\right)_{n} .
\end{aligned}

As shown by Fine, $F(a, b ; t)$ satisfies nice properties galore and which have applications in basic hypergeometric series, theory of partitions, modular forms and mock theta functions. The first chapter of Fine's book [5] is devoted to establishing functional equations satisfied by $F(a, b ; t)$, for example, [5] p. 2, Equation (4.1)]

F(a, b ; t)=\frac{1-a t q}{1-t}+\frac{(1-a q)(b-a t q)}{(1-b q)(1-t)} t q F(a q, b q ; t q) . \tag{1.2}
\end{equation*}

There have been attempts to generalize the theory of $F(a, b ; t)$ by considering the more general function $\sum_{n=0}^{\infty} \frac{(a q)_{n}(b q)_{n}}{(c q)_{n}(d q)_{n}} t^{n}$ although they have not been quite successful, see, for example, [8].

Another direction is to study finite analogues of $F(a, b ; t)$. Andrews and Bell [2] studied the finite analogue

\end{equation*}

[^0]They constructed another function using $F(a, b, t, N)$, namely, $S_{M, N}(a, b, t)$, which specializes to the series $S_{M, N}$ used by Euler in his unpublished proof of his famous pentagonal number theorem. One of the properties Andrews and Bell proved in their paper [2, Lemma 2.1] is that for $N \geq 1$,

F(a, b, t, N)=\frac{1-a t q}{1-t}+\frac{(1-a q)(b-a t q)}{(1-b q)(1-t)} t q F(a, b, t, N)+R_{1, N}(a, b, t) \tag{1.4}
\end{equation*}

where

R_{1, N}(a, b, t)=\sum_{j=0}^{N} \frac{(a q)_{j}}{(b q)_{j}} t^{j}\left(1-\frac{(b-a t q) q^{j}}{1-t}\right)+\frac{b-1}{1-t} \tag{1.5}
\end{equation*}
$$

Clearly, we recover (1.2) from (1.4) upon letting $N \rightarrow \infty$ in the latter since $\lim _{N \rightarrow \infty} R_{1, N}(a, b, t)=0$.
Fine iterated (1.2) to give a proof of the famous Rogers-Fine identity [5, p. 15] given by

F(a, b ; t)=\sum_{n=0}^{\infty} \frac{(a q)_{n}(a t q / b)_{n}}{(b q)_{n}(t)_{n+1}}\left(1-a t q^{2 n+1}\right)(b t)^{n} q^{n^{2}}
$$

In the same vein, Andrews and Bell iterated (1.4) and used the resulting identity along with Euler's method to give a stronger version of the Rogers-Fine identity from which they then deduce the RogersFine identity.

A new finite analogue of $F(a, b ; t)$ was studied by the authors of [4, Section 9]. It is given for $N \in \mathbb{N}$ by

\end{array}\right] \frac{(a q)_{n}(t)_{N-n}(q)_{n} t^{n}}{(b q)_{n}(t)_{N}}
$$

Clearly, $\lim _{N \rightarrow \infty} F_{N}(a, b ; t)=F(a, b ; t)$.
They naturally encountered this function in their work concerning the theory of the restricted partition function $p(n, N)$. The latter is defined as the number of partitions on $n$ whose parts are less than or equal to $N$. In this study, they derived some properties of $F_{N}(a, b ; t)$ they needed in order to prove their finite analogue of a recent identity of Garvan [6, Equation (1.3)]. These properties are the partial fraction decomposition of $F_{N}(\alpha, \beta ; t)$, namely,

\end{array}\right] \frac{(b / a)_{n}(a q)_{N-n}(a q)^{n}}{(a q)_{N}\left(1-t q^{n}\right)}
$$

This generalizes Fine's partial fraction decomposition of $F(a, b ; t)$ [5, p. 18, Equation (16.3)]:

F(a, b ; t)=\frac{(a q)_{\infty}}{(b q)_{\infty}} \sum_{n=0}^{\infty} \frac{(b / a)_{n}}{(q)_{n}} \frac{(a q)^{n}}{1-t q^{n}} \tag{1.7}
\end{equation*}
$$

They also derived a finite analogue of the Rogers-Fine identity [4, Lemma 9.2], that is, for $\beta \neq 0$,

\end{array}\right] \frac{(a q)_{n}(q)_{n}\left(\frac{a t q}{b}\right)_{n}\left(a t q^{2}\right)_{N-1}(t b)^{n} q^{n^{2}}\left(1-a t q^{2 n+1}\right)}{(b q)_{n}(t)_{n+1}\left(a t q^{2}\right)_{N+n}}
$$

These two properties were used to obtain the required finite analogue of Garvan's identity [4, Theorem 1.3].

At the end of [4], it was remarked that it would be worthwhile to develop the theory of $F_{N}(a, b ; t)$ considering the enormous impact and applications that the theory of $F(a, b ; t)$ has. We set forth such a task with a goal of systematically developing the theory of $F_{N}(a, b ; t)$.

It is to be noted that Andrews [1] has already embarked upon this task. Even though his results are expressed as transformations between ${ }_{3} \phi_{2}$, they can be equivalently written as transformations or functional equations for $F_{N}(a, b ; t)$. This rephrasing is done in Section 2. Then in Section 3 we present new results on $F_{N}(a, b ; t)$ we have found so far.

It should be mentioned here that Bowman and Wesley [3] have recently obtained new transformations for Fine's function $F(a, b ; t)$ iterating what they call as Fine's "seed" identities. A seed identity is an identity where $F(a, b ; t)$ gets transformed to $F(a q, b ; t)$ or $F(a, b q ; t)$ or $F(a, b ; t q)$. One of the goals in this paper is obtain the seed identities for $F_{N}(a, b ; t)$.

## 2. Some results of Andrews and deductions from them

In [1], Andrews obtained a finite version of Heine's transformation and then derived some corollaries from it. Andrews' transformations are for the ${ }_{3} \phi_{2}$ hypergeometric series

\end{array}\right]=F_{N}(a, b ; t),

as can be easily seen from (1.6).
Thus, we can rephrase these transformations in terms of $F_{N}(a, b ; t)$.

### 2.1. An identity of Andrews generalizing Equation (6.3) of [5]. From [1, Corollary 3],

If we let $b \rightarrow q, t \rightarrow b, c \rightarrow t q, a \rightarrow a t q / b$ in the above identity, this gives

F_{N}(a, b ; t)=\frac{\left(1-t q^{N}\right)(1-b)}{\left(1-b q^{N}\right)(1-t)} \sum_{n=0}^{N} \frac{\left(q^{-N}\right)_{n}(a t q / b)_{n}(q)_{n} q^{n}}{(t q)_{n}\left(q^{1-N} / b\right)_{n}(q)_{n}} . \tag{2.3}
\end{equation*}
$$

Using the elementary identities

& \left(\frac{q^{-N}}{c}\right)_{n}=\frac{(-1)^{n}\left(c q^{N-n+1}\right)_{n} q^{\frac{n(n-1)}{2}}}{c^{n} q^{N n}}  \tag{2.4}\\
& \frac{\left(q^{-N}\right)_{n}}{\left(\frac{q^{1-N}}{b}\right)_{n}}=\frac{(q)_{N}(b)_{N-n} b^{n}}{(q)_{N-n}(b)_{N} q^{n}}
\end{align*}

we are led to

F_{N}(a, b ; t)=\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)} \sum_{n=0}^{N}\left[\begin{array}{l}
N  \tag{2.5}\\
n
\end{array}\right] \frac{(a t q / b)_{n}(q)_{n}(b)_{N-n} b^{n}}{(t q)_{n}(b)_{N}} .
$$

Note that this identity is a finite analogue of Fine's identity [5], Equation (6.3)]:

\end{equation*}

### 2.2. Another ${ }_{3} \phi_{2}$ transformation of Andrews. Lemma 1 of [1] gives

c, & \text { at } & &
\end{array}\right]
$$

Letting $a \rightarrow q, b \rightarrow a q, c \rightarrow b q$ in the above identity and using (2.1), we get

q^{-N}, & b / a, & q & ; q, a t q^{N+1} \\
b q, & t q &
\end{array}\right] \\
& =\frac{\left(1-t q^{N}\right)}{(1-t)} \sum_{n=0}^{N}(-1)^{n}\left[\begin{array}{l}
N \\
n
\end{array}\right] \frac{(b / a)_{n}(q)_{n}(a t)^{n} q^{n(n+1) / 2}}{(b q)_{n}(t q)_{n}} . \tag{2.8}
\end{align*}
$$

Letting $b=0$ in the above result gives a finite analogue of [5, Equation (6.1)]:

F_{N}(a, 0 ; t)=\frac{\left(1-t q^{N}\right)}{(1-t)} \sum_{n=0}^{N}(-1)^{n}\left[\begin{array}{l}
N  \tag{2.9}\\
n
\end{array}\right] \frac{(q)_{n}(a t)^{n} q^{n(n+1) / 2}}{(t q)_{n}} .
$$

Also, if we let $a \rightarrow 0$ in (2.8), we obtain a finite analogue of [5, Equation (12.3)]:

\end{array}\right] \frac{(q)_{n}(b t)^{n} q^{n^{2}}}{(b q)_{n}(t q)_{n}}
$$

If we let $b=t^{-1}=e^{-i \theta}$ in (2.10), we get

\left(1-e^{i \theta}\right) F_{N}\left(0, e^{-i \theta} ; e^{i \theta}\right)=\left(1-e^{i \theta} q^{N}\right)+\sum_{n=1}^{N}\left[\begin{array}{l}
N \\
n
\end{array}\right] \frac{(q)_{n} q^{n^{2}}}{\left(1-2 q \cos \theta+q^{2}\right) \cdots\left(1-2 q^{n} \cos \theta+q^{2 n}\right)},
$$

which is a finite analogue of [5, Equation (12.32)].
Also, letting $b \rightarrow t$ in (2.10) gives a finite analogue of [5, Equation (12.33)]:

Let $r$ and $m$ be positive integers, and replace $q$ by $q^{m}, t$ by $q^{r}$ in finite analogue of [5, eqn(12.33)].Then using the definition of finite analogue of Fine's function for the left side, We obtain the finite analogue of [5, eqn(12.331)]:

\end{array}\right]_{q^{m}} \frac{\left(q^{m}, q^{m}\right)_{n} q^{m n^{2}+2 r n}}{\left[\left(1-q^{r}\right)\left(1-q^{m+r}\right) \cdots\left(1-q^{n m+r}\right)\right]^{2}}
\end{aligned}
$$

2.3. Andrews' finite Heine transformation in terms of $F_{N}(a, b ; t)$. Andrews' finite Heine transformation [1, Theorem 2] in terms of $F_{N}(a, b ; t)$ is given by

q^{-N}, & a, & b & ; q, q  \tag{2.12}\\
a t, & q^{1-N} / b & & q^{1-N} / t
\end{array}\right.
$$

Let $t \rightarrow q, b \rightarrow t, c \rightarrow a t q$ and $a \rightarrow b$ in the above result. Then

F_{N}(a, b ; t)=\frac{(a t q, q ; q)_{N}}{(t, b q ; q)_{N}} \sum_{n=0}^{N} \frac{(b)_{n}(t)_{n} q^{n}}{(a t q)_{n}(q)_{n}} . \tag{2.13}
\end{equation*}
$$

Letting $N \rightarrow \infty$ gives

F(a, b ; t)=\frac{(a t q)_{\infty}(q)_{\infty}}{(t)_{\infty}(b q)_{\infty}} \sum_{n=0}^{\infty} \frac{(b)_{n}(t)_{n} q^{n}}{(a t q)_{n}(q)_{n}} . \tag{2.14}
\end{equation*}
$$

Letting $b=1$ in (2.13) gives

F_{N}(a, 1 ; t)=\frac{(a t q)_{N}}{(t)_{N}} . \tag{2.15}
\end{equation*}
$$

An interesting result is obtained if we multiply both sides of (2.5) by $(1-t)$ and then let $t \rightarrow 1$ :

\lim _{t \rightarrow 1}(1-t) F_{N}(a, b ; t) & =\frac{(1-b)\left(1-t q^{N}\right)}{\left(1-b q^{N}\right)} F_{N}(a / b, 1 ; b) \\
& =\frac{(1-b)\left(1-t q^{N}\right)}{\left(1-b q^{N}\right)} \cdot \frac{(a q)_{N}}{(b)_{N}} \\
& =\frac{\left(1-q^{N}\right)(a q)_{N}}{(b q)_{N}}, \tag{2.16}
\end{align*}
$$

where in the last step, we used (2.15). Letting $N \rightarrow \infty$ in the above result we get Equation (6.31) in Fine's book [5]:

If we let $t \rightarrow 1$ in (2.10) and compare the right-hand side of the resulting identity with $a=0$ case of (2.16), we arrive at a finite analogue of [5, Equation (12.31)]:

The $b=1$ case of the above identity generalizes [5], Equation (12.311)].
Next, replace $a$ by $b / t$ in (2.13) and then let $b \rightarrow 0$ to get

F_{N}(b / t, 0 ; t)=\frac{(b q)_{N}(q)_{N}}{(t)_{N}} \sum_{n=0}^{N} \frac{(t)_{n} q^{n}}{(b q)_{n}(q)_{n}}, \tag{2.18}
\end{equation*}

which is a finite analogue of [5, Equation (7.3)].
Further, if we replace $a$ by $b / t$ in (2.9), we have

F_{N}(b / t, 0 ; t)=\frac{\left(1-t q^{N}\right)}{(1-t)} \sum_{n=0}^{N}\left[\begin{array}{c}
N  \tag{2.19}\\
n
\end{array}\right] \frac{(q)_{n}(-b)^{n} q^{n(n+1) / 2}}{(t q)_{n}} .
$$

Letting $t \rightarrow 0$ in (2.18) and (2.19) and comparing the right-hand sides, we get

\sum_{n=0}^{N} \frac{q^{n}}{(b q)_{n}(q)_{n}}=\frac{1}{(b q)_{N}(q)_{N}} \sum_{n=0}^{N}\left[\begin{array}{c}
N  \tag{2.20}\\

\end{array}\right](q)_{n}(-b)^{n} q^{n(n+1) / 2}
$$

This is a finite analogue of [5, Equation (7.32)]. If we now put $b=1$ in the above identity, we get a finite analogue of [5] Equation (7.322)].

Letting $b=q^{-1 / 2}$ in (2.20) and then replacing $q$ by $q^{2}$, we obtain a finite analogue of [5] Equation (7.323)]:

When $a=0,(2.13)$ reduces to

which is a finite analogue of [5] Equation (11.3)].
A finite analogue of [5, Equation (11.4)] is obtained if we let $b=t^{-1}$ in (2.21):

## 3. NEW RESULTS ON $F_{N}(a, b ; t)$

Equation (2.2) of [5] is

$$

F(a, b ; t)=1+\frac{t(1-a q)}{1-b q} F(a q, b q ; t) \tag{3.1}
\end{equation*}
$$

We begin with a finite analogue of this result which takes $(a, b) \rightarrow(a q, b q)$.

## Theorem 3.1.

F_{N}(a, b ; t)=1+\frac{t(1-a q)\left(1-q^{N+1}\right)}{(1-b q)\left(1-t q^{N}\right)} F_{N}(a q, b q ; t) \tag{3.2}
\end{equation*}

Proof.

\end{array}\right] \frac{\left(q^{2} a\right)_{n-1}(t)_{N-n}(q)_{n} t^{n-1}}{\left(b q^{2}\right)_{n-1}(t)_{N}} \\
& =1+\frac{(1-a q) t}{1-b q} \sum_{n=0}^{N-1} \frac{(q)_{N}\left(a q^{2}\right)_{n}(t)_{N-n-1} t^{n}}{(q)_{N-n-1}\left(b q^{2}\right)_{n}(t)_{N}} \\
& =1+\frac{(1-a q) t}{(1-b q)} \frac{\left(1-q^{N}\right)}{\left(1-t q^{N-1}\right)} \sum_{n=0}^{N-1} \frac{(q)_{N-1}(t)_{N-n-1}\left(a q^{2}\right)_{n} t^{n}}{(q)_{N-n-1}(t)_{N-1}\left(b q^{2}\right)_{n}} \tag{3.3}
\end{align*}
$$

Using the identity [7] p. 351, (I.11)]

\frac{(b, q)_{N}}{(a, q)_{N}} \frac{(a, q)_{N-n}}{(b, q)_{N-n}} \frac{a^{n}}{b^{n}}=\frac{\left(q^{1-N} / b, q\right)_{n}}{\left(q^{1-N} / a, q\right)_{n}} \tag{3.4}
\end{equation*}

with $b \rightarrow q, a \rightarrow t$ and replacing $N$ by $N-1$, we have

F_{N}(a, b ; t) & =1+\frac{(1-a q)\left(1-q^{N}\right) t}{(1-b q)\left(1-t q^{N-1}\right)} \sum_{n=0}^{N-1} \frac{\left(q^{1-N}\right)_{n}\left(a q^{2}\right)_{n} q^{n}}{\left(q^{2-N} / t\right)_{n}\left(b q^{2}\right)_{n}} \\
& =1+\frac{(1-a q)\left(1-q^{N}\right) t}{(1-b q)\left(1-t q^{N-1}\right)^{3}} \phi_{2}\left[\begin{array}{ccc}
q^{1-N}, & a q^{2}, & q \\
q^{2-N} / t, & b q^{2} & ; q, q
\end{array}\right]
\end{aligned}
$$

Replace $N$ by $N+1$ to get

$$
\left.\begin{array}{rl}
F_{N}(a, b ; t) & =1+\frac{(1-a q)\left(1-q^{N+1}\right) t}{(1-b q)\left(1-t q^{N}\right)}{ }^{3} \phi_{2}\left[\begin{array}{ccc}
q^{-N}, & a q^{2}, & q
\end{array} ; q, q\right. \\
q^{1-N} / t, & b q^{2} \tag{3.5}
\end{array}\right]
$$

where in the last step we used (2.1).
Our next result allows us to advance the parameter $t$ in $F_{N}(a, b ; t)$ to $t q$.

## Theorem 3.2.

$$
\begin{equation*}
F_{N}(a, b ; t)=\frac{(1-b)\left(1-t q^{N+1}\right)}{(1-t)\left(1-b q^{N+1}\right)}+\frac{\left(1-q^{N+1}\right)(b-a t q)}{\left(1-b q^{N+1}\right)(1-t)} F_{N}(a, b ; t q) . \tag{3.6}
\end{equation*}
$$

Proof. Using (2.5), we have

$$
\begin{aligned}
F_{N}(a, b ; t) & =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)} \sum_{n=0}^{N}\left[\begin{array}{c}
N \\
n
\end{array}\right] \frac{(a t q / b)_{n}(q)_{n}(b)_{N-n} b^{n}}{(t q)_{n}(b)_{N}} \\
& =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)} \sum_{n=1}^{N}\left[\begin{array}{c}
N \\
n
\end{array}\right] \frac{(a t q / b)_{n}(q)_{n}(b)_{N-n} b^{n}}{(t q)_{n}(b)_{N}} \\
& =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{(1-b)\left(1-t q^{N}\right)(1-a t q / b) b}{(1-t)\left(1-b q^{N}\right)(1-t q)} \sum_{n=1}^{N}\left[\begin{array}{c}
N \\
n
\end{array}\right] \frac{\left(a t q^{2} / b\right)_{n-1}(q)_{n}(b)_{N-n} b^{n-1}}{\left(t q^{2}\right)_{n-1}(b)_{N}} \\
& =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{(1-b)\left(1-t q^{N}\right)(1-a t q / b) b}{(1-t)\left(1-b q^{N}\right)(1-t q)} \sum_{n=0}^{N-1}\left[\begin{array}{c}
N \\
n+1
\end{array}\right] \frac{\left(a t q^{2} / b\right)_{n}(q)_{n+1}(b)_{N-n-1} b^{n}}{\left(t q^{2}\right)_{n}(b)_{N}} \\
& =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{(1-b)\left(1-t q^{N}\right)(b-a t q)\left(1-q^{N}\right)}{(1-t)\left(1-b q^{N}\right)\left(1-b q^{N-1}\right)(1-t q)} \sum_{n=0}^{N-1} \frac{(q)_{N-1}\left(a t q^{2} / b\right)_{n}(b)_{N-n-1} b^{n}}{(q)_{N-n-1}\left(t q^{2}\right)_{n}(b)_{N-1}} .
\end{aligned}
$$

Let $b \rightarrow q, a \rightarrow b$ in (3.4), replace $N$ by $N-1$ and substitute the resulting expression in the sum on the right-hand side of the above equation so that

$$
\begin{aligned}
F_{N}(a, b ; t) & =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{(1-b)\left(1-t q^{N}\right)(b-a t q)\left(1-q^{N}\right)}{(1-t)\left(1-b q^{N}\right)\left(1-b q^{N-1}\right)(1-t q)} \sum_{n=0}^{N-1} \frac{\left(a t q^{2} / b\right)_{n}\left(q^{1-N}\right)_{n} q^{n}}{\left(q^{2-N} / b\right)_{n}\left(t q^{2}\right)_{n}} \\
& =\frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{(1-b)\left(1-t q^{N}\right)(b-a t q)\left(1-q^{N}\right)}{(1-t)\left(1-b q^{N}\right)\left(1-b q^{N-1}\right)(1-t q)^{3}} \phi_{2}\left[\begin{array}{ccc}
q^{1-N}, & a t q^{2} / b, & q \\
t q^{2}, & q^{2-N} / b & ; q
\end{array}\right]
\end{aligned}
$$

Now replace $a$ by $a t q^{2} / b, b$ by $q, c$ by $t q^{2}, t$ by $b$ in (2.2), then replace $N$ by $N-1$ and use the resulting identity to transform the ${ }_{3} \phi_{2}$ on the right-hand side of the above equation so that

$$
\begin{aligned}
F_{N}(a, b ; t)= & \frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)} \\
& +\frac{(1-b)\left(1-t q^{N}\right)(b-a t q)\left(1-q^{N}\right)(1-t q)\left(1-b q^{N-1}\right)}{(1-t)\left(1-b q^{N}\right)\left(1-b q^{N-1}\right)(1-t q)(1-b)\left(1-t q^{N}\right)}{ }_{3} \phi_{2}\left[\begin{array}{ccc}
q^{1-N}, & a q, & q \\
b q, & q^{2-N} / t q, &
\end{array}\right] \\
= & \frac{(1-b)\left(1-t q^{N}\right)}{(1-t)\left(1-b q^{N}\right)}+\frac{\left(1-q^{N}\right)(b-a t q)\left(1-b q^{N-1}\right)}{\left(1-b q^{N}\right)\left(1-b q^{N-1}\right)(1-t)} \sum_{n=0}^{N-1} \frac{\left(q^{1-N}\right)_{n}(a q)_{n}(q)_{n} q^{n}}{(b q)_{n}(q)_{n}\left(q^{2-N} / t q\right)_{n}} .
\end{aligned}
$$

Finally replace $N$ by $N+1$ and use (2.4) to obtain

$$
\begin{aligned}
F_{N}(a, b ; t) & =\frac{(1-b)\left(1-t q^{N+1}\right)}{(1-t)\left(1-b q^{N+1}\right)}+\frac{\left(1-q^{N+1}\right)(b-a t q)\left(1-b q^{N}\right)}{\left(1-b q^{N+1}\right)\left(1-b q^{N}\right)(1-t)} \sum_{n=0}^{N} \frac{(q)_{N}(a q)_{n}(q)_{n}(t q)_{N-n}(t q)^{n}}{(q)_{N-n}(b q)_{n}(q)_{n}(t q)_{N}} \\
& =\frac{(1-b)\left(1-t q^{N+1}\right)}{(1-t)\left(1-b q^{N+1}\right)}+\frac{\left(1-q^{N+1}\right)(b-a t q)}{\left(1-b q^{N+1}\right)(1-t)} F_{N}(a, b ; t q) .
\end{aligned}
$$

Our next result is a generalization of [5, Equation (4.3)]:

$$
\begin{equation*}
F(a, b ; t)=\frac{1}{1-t}+\frac{(b-a) t q}{(1-t)(1-b q)} F(a, b q ; t q) . \tag{3.7}
\end{equation*}
$$

Theorem 3.3. We have

$$
\begin{equation*}
F_{N}(a, b ; t)=\frac{\left(1-t q^{N+1}\right)}{(1-t)}+\frac{\left(1-q^{N+1}\right)(b-a) t q}{(1-b q)(1-t)} F_{N}(a, b q ; t q) . \tag{3.8}
\end{equation*}
$$

Proof. From (2.8),

$$
\begin{align*}
F_{N}(a, b ; t) & =\frac{1-t q^{N}}{1-t}+\frac{\left(1-t q^{N}\right)}{(1-t)} \sum_{n=1}^{N}(-1)^{n}\left[\begin{array}{c}
N \\
n
\end{array}\right] \frac{(b / a)_{n}(q)_{n}(a t)^{n} q^{n(n+1) / 2}}{(b q)_{n}(t q)_{n}} \\
& =\frac{1-t q^{N}}{1-t}+\frac{\left(1-t q^{N}\right)(b-a) t}{(1-t)(1-b q)(1-t q)} \sum_{n=0}^{N-1}(-1)^{n} \frac{(q)_{N}(b q / a)_{n}(a t)^{n} q^{(n+2)(n+1) / 2}}{(q)_{N-n-1}\left(b q^{2}\right)_{n}\left(t q^{2}\right)_{n}} . \tag{3.9}
\end{align*}
$$

Now (2.4) with $c=1 / q$ gives

$$
\begin{equation*}
\left(q^{1-N}\right)_{n}=\frac{(-1)^{n} q^{n(n-1) / 2}(q)_{N-1}}{(q)_{N-n-1} q^{(N-1) n}} \tag{3.10}
\end{equation*}
$$

Hence

$$
\begin{align*}
F_{N}(a, b ; t) & =\frac{1-t q^{N}}{1-t}+\frac{\left(1-t q^{N}\right)(b-a)\left(1-q^{N}\right) t q}{(1-t)(1-b q)(1-t q)} \sum_{n=0}^{N-1} \frac{\left(q^{1-N}\right)_{n} q^{N n+n}(b q / a)_{n}(a t)^{n}}{\left(b q^{2}\right)_{n}\left(t q^{2}\right)_{n}} \\
& =\frac{1-t q^{N+1}}{1-t}+\frac{\left(1-t q^{N+1}\right)(b-a)\left(1-q^{N+1}\right) t q}{(1-t)(1-b q)(1-t q)} \sum_{n=0}^{N} \frac{\left(q^{-N}\right)_{n} q^{(N+1) n+n}(b q / a)_{n}(a t)^{n}}{\left(b q^{2}\right)_{n}\left(t q^{2}\right)_{n}} . \tag{3.11}
\end{align*}
$$

Now let $b \rightarrow a q, c \rightarrow b q^{2}, a \rightarrow q$ and replace $t$ by $t q$ in (2.7) to obtain

$$
\sum_{n=0}^{N} \frac{\left(q^{-N}\right)_{n} q^{(N+1) n+n}(b q / a)_{n}(a t)^{n}}{\left(b q^{2}\right)_{n}\left(t q^{2}\right)_{n}}=\frac{(1-t q)}{\left(1-t q^{N+1}\right)} F_{N}(a, b q ; t q) .
$$

Finally substitute the above equation in (3.11) to complete the proof.
In the next result, we transform $F_{N}(a, b ; t)$ to $F_{N}(a, b q ; t)$.
Corollary 3.4. We have

$$
\begin{equation*}
F_{N}(a, b ; t)=\frac{1-t q^{N+1}}{1-t}-\frac{(b-a)\left(1-t q^{N+1}\right) t}{(1-t)(b-a t)}+\frac{(b-a)\left(1-b q^{N+2}\right) t}{(1-b q)(b-a t)} F_{N}(a, b q ; t) . \tag{3.12}
\end{equation*}
$$

Proof. Replace $b$ by $b q$ in Theorem 3.2 and then substitute the resulting expression for $F_{N}(a, b q ; t q)$ in (3.8).

Letting $N \rightarrow \infty$ in Corollary 3.4 gives [5, Equation (4.4)]

$$
F(a, b ; t)=\frac{b}{b-a t}+\frac{(b-a) t}{(1-b q)(b-a t)} F(a, b q ; t) .
$$

Our next results relates $F_{N}(a, b ; t)$ with $F_{N}(a q, b ; t)$.
Corollary 3.5. We have

$$
F_{N}(a, b ; t)=1-\frac{b(1-a q)\left(1-q^{N+1}\right)\left(1-t q^{N+1}\right)}{\left(1-t q^{N}\right)\left(1-b q^{N+2}\right)(b-a q)}+\frac{(1-a q)\left(1-q^{N+1}\right)(b-a q t)}{\left(1-t q^{N}\right)(b-a q)\left(1-b q^{N+2}\right)} F_{N}(a q, b ; t) .
$$

Proof. Replace $a$ by $a q$ in Corollary 3.4 and then substitute the resulting expression for $F_{N}(a q, b q ; t)$ in Theorem 3.1 .

Letting $N \rightarrow \infty$ in Corollary 3.5 gives [5, Equation (4.5)]

$$
F(a, b ; t)=-\frac{(1-b) a q}{b-a q}+\frac{(1-a q)(b-a t q)}{b-a q} F(a q, b ; t) .
$$

Our next theorem transforms $F_{N}(a, b ; t)$ to $F_{N}(a q, b ; t q)$.

## Theorem 3.6.

$$
\begin{aligned}
F_{N}(a, b ; t)= & 1+\frac{(1-a q)\left(1-q^{N+1}\right)\left(1-t q^{N+1}\right)}{\left(1-t q^{N}\right)\left(1-b q^{N+2}\right)(1-t)}\left(t-\frac{(b-a q t)}{(b-a q)}+\frac{(b-a q t)(1-b)}{(b-a q)\left(1-b q^{N+1}\right)}\right) \\
& +\frac{(1-a q)\left(1-q^{N+1}\right)^{2}(b-a q t)\left(b-a t q^{2}\right)}{\left(1-t q^{N}\right)(b-a q)\left(1-b q^{N+2}\right)\left(1-b q^{N+1}\right)(1-t)} F_{N}(a q, b ; t q) .
\end{aligned}
$$

Proof. Replace $a$ by $a q$ in Theorem 3.2 and then substitute the resulting expression for $F_{N}(a q, b ; t)$ in Corollary 3.5.

The identity in the above theorem leads to the following identity when we let $N \rightarrow \infty$ :

$$
F(a, b ; t)=\left(\frac{1-b}{1-t}\right)\left(1-\frac{(b-a t q)}{(b-a q)} a q\right)+\frac{(1-a q)(b-a t q)\left(b-a t q^{2}\right)}{(1-t)(b-a q)} F(a q, b ; t q),
$$

which is Equation (4.6) from [5].
Our final result is the transformation between $F_{N}(a, b ; t)$ and $F_{N}(a q, b q ; t q)$.

Theorem 3.7. We have
$F_{N}(a, b ; t)=1+\frac{(1-a q)\left(1-q^{N+1}\right)\left(1-t q^{N+1}\right) t}{\left(1-t q^{N}\right)\left(1-b q^{N+2}\right)(1-t)}+\frac{(1-a q)\left(1-q^{N+1}\right)^{2}(b-a t q) t q}{(1-b q)\left(1-t q^{N}\right)\left(1-b q^{N+2}\right)(1-t)} F_{N}(a q, b q ; t q)$.
Proof. Replace $a$ and $b$ in Theorem 3.2 by $a q$ and $b q$ respectively and then substitute the resulting expression for $F_{N}(a q, b q ; t)$ in Theorem 3.1 .

Letting $N \rightarrow \infty$ in Theorem 3.7 gives [5, Equation (4.1)]:

$$
F(a, b ; t)=\frac{(1-a t q)}{(1-t)}+\frac{(1-a q)(b-a t q) t q}{(1-b q)(1-t)} F(a q, b q ; t q)
$$
