# Additive complementary dual codes over $\mathbb{F}_{4}$

#### Abstract

A linear code is linear complementary dual (LCD) if it meets its dual trivially. LCD codes have been a hot topic recently due to Boolean masking application in the security of embarked electronics (Carlet and Guilley, 2014). Additive codes over $\mathbb{F}_{4}$ are $\mathbb{F}_{4}$-codes that are stable by codeword addition but not necessarily by scalar multiplication. An additive code over $\mathbb{F}_{4}$ is additive complementary dual (ACD) if it meets its dual trivially. The aim of this research is to study such codes which meet their dual trivially. All the techniques and problems used to study LCD codes are potentially relevant to ACD codes. Interesting constructions of ACD codes from binary codes are given with respect to the trace Hermitian and trace Euclidean inner product. The former product is relevant to quantum codes.

## 1 Introduction

To begin with, let us recall some basic definitions. A linear $[n, k]$ code over a finite field $\mathbb{F}_{q}$ is a $k$-dimensional subspace of $\mathbb{F}_{q}^{n}$. The set of vectors orthogonal to $\mathcal{C}$

under the usual inner product is the dual of $\mathcal{C}$, denoted by $\mathcal{C}^{\perp}$. A linear code $\mathcal{C}$ is self-orthogonal if $\mathcal{C} \subset \mathcal{C}^{\perp}$, and self-dual if $\mathcal{C}=\mathcal{C}^{\perp}$. On the other hand, a linear code $\mathcal{C}$ is an $L C D$ code (linear complementary dual code) if $\mathcal{C} \cap \mathcal{C}^{\perp}=\{0\}$. In particular, $\mathcal{C}$ is a binary $L C D$ code if $\mathcal{C}$ is a binary linear code satisfying $\mathcal{C} \cap \mathcal{C}^{\perp}=\{0\}$.

Massey 14 introduced the notion of LCD codes in order to provide an optimum linear coding solution for the two-user binary adder channel. In a later work [15], he also showed that there exist asymptotically good LCD codes. Furthermore, Sendrier showed that LCD codes meet the asymptotic Gilbert-Varshamov bound in 17.

In 2014, Carlet and Guilley [3] introduced several constructions of LCD codes and investigated an application of LCD codes against Side-Channel Attacks (SCA) and Fault Injection Attacks (FIA). Recall from [3] that SCA consists in passively recording some leakage that is the source of information to retrieve the key, and that FIA consist in actively perturbating the device so as to obtain exploitable differences at the output.

In the approach of [3], the direct $\operatorname{sum} \mathcal{C} \oplus \mathcal{C}^{\perp}=\mathbb{F}_{q}^{n}$ is essential, and the minimum distance of $\mathcal{C}$ (resp. $\mathcal{C}^{\perp}$ ) acts as a performance criterion for SCA (resp. FIA). Since this model does not use the linearity of $\mathcal{C}$ but only its additivity, it makes sense to study additive complementary dual (ACD) codes over finite fields or finite rings. Moreover, since linear codes are additive codes, LCD codes are ACD. Furthermore, Guilley [8] reported to us that the application of ACD codes to security still makes sense. This motivates the current study.

In the same spirit, Shi et al. [18] studied ACD codes over a noncommutative non-unital ring $E$ with four elements recently. Nevertheless, little is known about a general theory of ACD codes over $\mathbb{F}_{4}$. All the techniques and problems used to study LCD codes [6] are potentially relevant to ACD codes. Interesting constructions of ACD codes from binary codes are given with respect to two trace inner products: the trace Euclidean inner product, and the trace Hermition inner product, familiar since the studies of quantum codes 2]. We have also constructed ACD $\left(6,2^{5}, 4\right),\left(35,2^{7}, 26\right)$, and $\left(96,2^{7}, 72\right)$ codes over $\mathbb{F}_{4}$ under the trace Euclidean inner product, all of which have more codewords than optimal LCD $[6,2,4]$, $[35,3,26]$, and $[96,3,72]$ codes over $\mathbb{F}_{4}$, respectively.

Our paper consists of five sections. Section 2 recalls basic definitions and notations from additive codes under the two inner products. Section 3 discusses ACD codes with respect to the trace Hermitian inner product. Section 4 discusses ACD codes with with respect to the trace Euclidean inner product. Section 5 concludes the article.

## 2 Preliminaries

Let $\mathbb{F}_{2}=\{0,1\}$ and $\mathbb{F}_{4}=\{0,1, \omega, \bar{\omega}\}$ denote the finite field of order 2 and 4 respectively, where $\bar{\omega}=\omega^{2}=\omega+1, \omega^{3}=1$.

An additive code $\mathcal{C}$ over $\mathbb{F}_{4}$ of length $n$ is an additive subgroup of $\mathbb{F}_{4}^{n}$. As $\mathcal{C}$ is a free $\mathbb{F}_{2}$-module, it has size $2^{k}$ for some $0 \leq k \leq 2 n$. We call $\mathcal{C}$ an $\left(n, 2^{k}\right)$ code. It has a basis, as a $\mathbb{F}_{2}$-module, consisting of $k$ basis vectors. Interest in additive codes over $\mathbb{F}_{4}$ has arisen because of their correspondence to quantum codes as described in [2]. There is a natural inner product on the additive codes arising from the trace
map. The trace map $\operatorname{Tr}: \mathbb{F}_{4} \rightarrow \mathbb{F}_{2}$ is given by

$$
\operatorname{Tr}(x)=x+x^{2}
$$

In particular $\operatorname{Tr}(0)=\operatorname{Tr}(1)=0$ and $\operatorname{Tr}(\omega)=\operatorname{Tr}(\bar{\omega})=1$. The conjugate of $x \in \mathbb{F}_{4}$, denoted $\bar{x}$, is the image of $x$ under the Frobenius automorphism; in other words, $\overline{0}=0, \overline{1}=1$, and $\overline{\bar{\omega}}=\omega$.

Definition 1 A generator matrix of an $\left(n, 2^{k}\right)$ additive code $\mathcal{C}$ over $\mathbb{F}_{4}$ is a $k \times n$ matrix $G$ with entries in $\mathbb{F}_{4}$ such that $\mathcal{C}=\left\{\mathbf{u} G: \mathbf{u} \in \mathbb{F}_{2}^{k}\right\}$. Note that $G$ has 2-rank $k$.

As usual, the weight $\mathrm{wt}(\mathbf{c})$ of $\mathbf{c} \in \mathcal{C}$ is the number of nonzero components of $\mathbf{c}$. The minimum weight $d$ of $\mathcal{C}$ is the smallest weight of any nonzero codeword in $\mathcal{C}$. If $\mathcal{C}$ is an $\left(n, 2^{k}\right)$ additive code of minimum weight $d, \mathcal{C}$ is called an $\left(n, 2^{k}, d\right)$ code.

Example 1 Let $\mathcal{G}_{6}$ be the $[6,3,4]$ hexacode whose generator matrix as a linear $\mathbb{F}_{4^{-}}$ code is

$$
\left[\begin{array}{llllll}
1 & 0 & 0 & 1 & \omega & \omega \\
0 & 1 & 0 & \omega & 1 & \omega \\
0 & 0 & 1 & \omega & \omega & 1
\end{array}\right] .
$$

This is also an additive code; thinking of $\mathcal{G}_{6}$ as an additive code, it has generator matrix

$$
\left[\begin{array}{llllll}
1 & 0 & 0 & 1 & \omega & \omega \\
0 & 1 & 0 & \omega & 1 & \omega \\
0 & 0 & 1 & \omega & \omega & \frac{\omega}{\omega} \\
\omega & \frac{1}{\omega} \\
0 & 0 & 0 & \frac{\omega}{\omega} & \frac{\omega}{\omega} \\
0 & 0 & \omega & \frac{\omega}{\omega} & \frac{\omega}{\omega} & \underset{\omega}{\omega}
\end{array}\right] .
$$

For $\mathbf{x}=\left(x_{1}, x_{2}, \ldots, x_{n}\right)$ and $\mathbf{y}=\left(y_{1}, y_{2}, \ldots, y_{n}\right)$ in $\mathbb{F}_{4}^{n}$, we define the Hermitian inner product, the trace Hermitian inner product and the trace Euclidean inner product of $\mathbf{x}$ and $\mathbf{y}$ as follows:

$$
(i) \mathbf{x} \cdot \mathbf{y}=\sum_{i=1}^{n} x_{i} \bar{y}_{i},(i i) \mathbf{x} \star \mathbf{y}=\sum_{i=1}^{n} \operatorname{Tr}\left(x_{i} \bar{y}_{i}\right),(i i i) \mathbf{x} \diamond \mathbf{y}=\sum_{i=1}^{n} \operatorname{Tr}\left(x_{i} y_{i}\right) .
$$

If $\mathcal{C}$ is an $\left(n, 2^{k}\right)$ additive code, the dual of $\mathcal{C}$ with respect to the Hermitian inner product, the trace Hermitian inner product and the trace Euclidean inner product are defined as follows:

$$
\begin{aligned}
\mathcal{C}^{\perp_{\mathrm{H}}} & =\left\{u \in \mathbb{F}_{4}^{n}: u \cdot v=0 \text { for all } v \in \mathcal{C}\right\} \\
\mathcal{C}^{\perp_{\mathrm{Tr}} \mathrm{H}} & =\left\{u \in \mathbb{F}_{4}^{n}: u \star v=0 \text { for all } v \in \mathcal{C}\right\}, \\
\mathcal{C}^{\perp_{\mathrm{TrE}}} & =\left\{u \in \mathbb{F}_{4}^{n}: u \diamond v=0 \text { for all } v \in \mathcal{C}\right\} .
\end{aligned}
$$

Obviously, $\mathcal{C}^{\perp_{\mathrm{H}}}, \mathcal{C}^{\perp_{\mathrm{TrH}}}$ and $\mathcal{C}^{\perp_{\mathrm{TrE}}}$ are $\left(n, 2^{2 n-k}\right)$ additive codes. If, in addition, $\mathcal{C}$ is linear, we say $\mathcal{C}$ is linear complementary dual with respect to the Hermitian inner product (or quaternary Hermitian $L C D$ ) if $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{H}}}=\{\mathbf{0}\}$. If $\mathcal{C}$ is additive, we say $\mathcal{C}$ is additive complementary dual (ACD) with respect to the trace Hermitian inner product if $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{TrH}}}=\{\mathbf{0}\}$, and $\mathcal{C}$ is additive complementary dual (ACD) with respect to the trace Euclidean inner product if $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{TrE}}}=\{\mathbf{0}\}$.

## 3 ACD codes with respect to the trace Hermitian inner product $\star$

We have a criteria for ACD codes in terms of a generator matrix as follows.
Theorem 1 ([4, Proposition 1], [15, Proposition 1]) Let $G$ be a generator matrix for an $[n, k]$ linear code $\mathcal{C}$ over a field. Then $\mathcal{C}$ is a Euclidean (resp. a Hermitian) LCD code if and only if, the $k \times k$ matrix $G G^{T}$ (resp. $G \bar{G}^{T}$ ) is invertible.
Theorem 2 ( 1$]$ ) Let $\mathcal{C}$ be an additive $\left(n, 2^{k}\right)$ code over $\mathbb{F}_{4}$ with generator matrix $G$. Then $\mathcal{C}$ is $A C D$ with respect to the trace Hermitian inner product if and only if $G \star G=G \bar{G}^{T}+\bar{G} G^{T}$ is invertible.

The following lemma is straightforward from the definition of the inner products.

Lemma 1 ([5, Lemma 2.1]) Assume $\mathcal{C}$ is a linear code over $\mathbb{F}_{4}$. Then $\mathcal{C}^{\perp_{\mathrm{Tr}}}$ is equal to the dual of $\mathcal{C}$ with respect to the Hermitian inner product. Similarly, $\mathcal{C}^{\perp_{\mathrm{TrE}}}$ is equal to the dual of $\mathcal{C}$ with respect to the Euclidean inner product.

Corollary 1 Any Hermitian LCD $[n, k, d]$ code $\mathcal{C}$ over $\mathbb{F}_{4}$ is an $A C D\left(n, 2^{2 k}, d\right)$ code over $\mathbb{F}_{4}$ with respect to the trace Hermitian inner product.

Proof Suppose that $\mathcal{C}$ is a Hermitian LCD code over $\mathbb{F}_{4}$. Then $\mathcal{C} \cap \mathcal{C}^{\perp_{H}}=\{\mathbf{0}\}$. By Lemma $\mathcal{C}^{\perp_{\mathrm{H}}}=\mathcal{C}^{\perp_{\mathrm{Tr}}}$. Thus, $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{Tr}}}=\{\mathbf{0}\}$, which means that $\mathcal{C}$ is ACD with respect to the trace Hermitian inner product. The parameters of $\mathcal{C}$ over $\mathbb{F}_{4}$ are obvious.

Corollary 2 Suppose $\mathcal{C}_{2}$ is a binary $L C D[n, k, d]$ code with generator matrix $G_{2}$. Let $\mathcal{C}_{2}^{4}$ be a linear code over $\mathbb{F}_{4}$ with generator matrix $G_{2}$. Then by regarding $\mathcal{C}_{2}^{4}$ as an additive code over $\mathbb{F}_{4}, \mathcal{C}_{2}^{4}$ is an $\operatorname{ACD}\left(n, 2^{2 k}, d\right)$ code with respect to the trace Hermitian inner product.

Proof Let $G_{2}$ be a generator matrix for $\mathcal{C}_{2}$. Then, by Theorem $G_{2} G_{2}^{T}$ is invertible over $\mathbb{F}_{2}$. Since $G_{2}=\bar{G}_{2}, G_{2}{\overline{G_{2}}}^{T}$ is invertible over $\mathbb{F}_{4}$. Hence, by Theorem $\mathbb{1} \mathcal{C}_{2}^{4}$ as a linear code over $\mathbb{F}_{4}$ is an Hermitian LCD $[n, k, d]$ code over $\mathbb{F}_{4}$. Therefore, by Corollary $\mathbb{1} \mathcal{C}_{2}^{4}$ is an $\operatorname{ACD}\left(n, 2^{2 k}, d\right)$ code with respect to the trace Hermitian inner product.

Lemma 2 (10) If $A$ is a symmetric integral matrix with zero diagonal, then 2$\operatorname{rank}(A)$ is even.

Proof We give a detailed proof here since the proof in 10 is concise. Recall that a principal submatrix of a square matrix $A$ is the matrix obtained by deleting any $m$ rows and the corresponding $m$ columns.

Let $A^{\prime}$ be a non-singular principal submatrix of $A$ such that $2-\operatorname{rank}(A)=2$ $\operatorname{rank}\left(A^{\prime}\right)$. Then $A^{\prime}$ is also symmetric integral with zero diagonal. We may assume that $A^{\prime} \equiv B(\bmod 2)$ for some skew symmetric integral matrix $B$. Over $\mathbb{Z}$, any skew symmetric matrix $B$ of odd order has determinant 0 (since $B=-B^{T}$ implies that $\operatorname{det}(B)=-\operatorname{det}\left(B^{T}\right)=-\operatorname{det}(B)$, hence $\operatorname{det}(B)=0$ ). So, if $2-r a n k\left(A^{\prime}\right)$ is odd, then $\operatorname{det}\left(A^{\prime}\right) \equiv \operatorname{det}(B) \equiv 0(\bmod 2)$. This is a contradiction since $A^{\prime}$ has a full rank, that is, $\operatorname{det}\left(A^{\prime}\right) \not \equiv 0(\bmod 2)$. Thus 2-rank $\left(A^{\prime}\right)$ is even. Therefore, 2-rank $(A)$ is even.

Theorem 3 If $\mathcal{C}$ is a trace Hermitian $A C D\left(n, 2^{k}\right)$ code over $\mathbb{F}_{4}$ with generator matrix $G$, then $k$ is even.

Proof Let $A=G \star G=G \bar{G}^{T}+\bar{G} G^{T}$. Then $A$ is a $k \times k$ symmetric integral matrix with zero diagonal. Since $\mathcal{C}$ is ACD, the 2-rank of $A$ must be $k$ by Theorem 2 By Lemma $2 k$ is even.

Lemma 3 Let $\mathcal{C}$ and $\mathcal{D}$ are two binary $\left[n, k_{1}\right]$ and $\left[n, k_{2}\right]$ linear codes. If $\mathcal{C}_{4}=a \mathcal{C}+b \mathcal{D}$, where $a \neq b$ and $a, b \in \mathbb{F}_{4} \backslash\{0\}$, then $\mathcal{C}_{4}^{\perp^{\text {TrH }}}=a \mathcal{D}^{\perp}+b \mathcal{C}^{\perp}$.
Proof Let $\mathbf{u} \in a \mathcal{D}^{\perp}+b \mathcal{C}^{\perp}$; then there exist $\mathbf{d}^{\prime} \in \mathcal{D}^{\perp}$ and $\mathbf{c}^{\prime} \in \mathcal{C}^{\perp}$ such that $\mathbf{u}=a \mathbf{d}^{\prime}+b \mathbf{c}^{\prime}$. For $\mathbf{v}=a \mathbf{c}+b \mathbf{d} \in \mathcal{C}_{4}$, where $\mathbf{c} \in \mathcal{C}$ and $\mathbf{d} \in \mathcal{D}$, we have

$$
\begin{aligned}
\mathbf{u} \star \mathbf{v} & =\left(a \mathbf{d}^{\prime}+b \mathbf{c}^{\prime}\right) \star(a \mathbf{c}+b \mathbf{d}) \\
& =\left(a \mathbf{d}^{\prime}+b \mathbf{c}^{\prime}\right) \cdot(\bar{a} \mathbf{c}+\bar{b} \mathbf{d})+\left(\bar{a} \mathbf{d}^{\prime}+\bar{b} \mathbf{c}^{\prime}\right) \cdot(a \mathbf{c}+b \mathbf{d}) \\
& =a \bar{a} \mathbf{d}^{\prime} \cdot \mathbf{c}+a \bar{b} \mathbf{d}^{\prime} \cdot \mathbf{d}+b \bar{a} \mathbf{c}^{\prime} \cdot \mathbf{c}+b \bar{b} \mathbf{c}^{\prime} \cdot \mathbf{d}+\bar{a} a \mathbf{d}^{\prime} \cdot \mathbf{c}+\bar{a} b \mathbf{d}^{\prime} \cdot \mathbf{d}+\bar{b} a \mathbf{c}^{\prime} \cdot \mathbf{c}+\bar{b} b \mathbf{c}^{\prime} \cdot \mathbf{d} \\
& =(a \bar{b}+\bar{a} b) \mathbf{d}^{\prime} \cdot \mathbf{d}+(b \bar{a}+\bar{b} a) \mathbf{c}^{\prime} \cdot \mathbf{c} \\
& =0
\end{aligned}
$$

Hence, $a \mathcal{D}^{\perp}+b \mathcal{C}^{\perp} \subseteq \mathcal{C}_{4}^{\perp}{ }_{\text {TrH }}$.
Since $a \neq b,\left|\mathcal{C}_{4}\right|=|\mathcal{C}||\mathcal{D}|=2^{k_{1}} \cdot 2^{k_{2}}=2^{k_{1}+k_{2}}$, then $\mathcal{C}_{4}^{\perp}{ }_{\mathrm{TrH}}=\frac{2^{2 n}}{\left|\mathcal{C}_{4}\right|}=2^{2 n-\left(k_{1}+k_{2}\right)}=$ $2^{2 n-k_{1}-k_{2}}$. And $\left|a \mathcal{D}^{\perp}+b \mathcal{C}^{\perp}\right|=2^{n-k_{1}} \cdot 2^{n-k_{2}}=2^{2 n-k_{1}-k_{2}}$. Therefore, $\mathcal{C}_{4}^{\perp_{\text {TrH }}}=$ $a \mathcal{D}^{\perp}+b \mathcal{C}^{\perp}$.

Proposition 1 If $\mathcal{C}$ is a self-dual $[2 n, n]$ binary code, let $\mathcal{D}$ be a binary linear code and $\mathbb{F}_{2}^{2 n}=\mathcal{C} \oplus \mathcal{D}$, then $\mathcal{C}_{4}=a \mathcal{C}+b \mathcal{D}$ is an $A C D\left(2 n, 2^{2 n}\right)$ code over $\mathbb{F}_{4}$ with respect to the trace Hermitian inner product, where $a \neq b$ and $a, b \in \mathbb{F}_{4} \backslash\{0\}$.

Proof Since $\mathcal{C}$ is self-dual, $\mathcal{C}=\mathcal{C}^{\perp}$. By $\mathbb{F}_{2}^{2 n}=\mathcal{C} \oplus \mathcal{D}$, we know that

$$
\mathcal{C} \cap \mathcal{D}=\{\mathbf{0}\}, \mathcal{C}^{\perp} \cap \mathcal{D}^{\perp}=(\mathcal{C} \oplus \mathcal{D})^{\perp}=\left(\mathbb{F}_{2}^{2 n}\right)^{\perp}=\{\mathbf{0}\},
$$

then $\mathcal{C} \cap \mathcal{D}^{\perp}=\{\mathbf{0}\}$. By Lemma 3, $\mathcal{C}_{4}^{\perp_{\mathrm{TrH}}}=a \mathcal{D}^{\perp}+b \mathcal{C}^{\perp}=a \mathcal{D}^{\perp}+b \mathcal{C}$.
If there exists $\mathbf{0} \neq \mathbf{v} \in \mathcal{C}_{4} \cap \mathcal{C}_{4}^{\perp}{ }^{\perp_{\mathrm{TrH}}}$, then there are $\mathbf{c} \in \mathcal{C}, \mathbf{d} \in \mathcal{D}$, and $\mathbf{c}, \mathbf{d}$ are nonzero such that $\mathbf{v}=a \mathbf{c}+b \mathbf{d}$. Similarly, there are $\mathbf{c}^{\prime} \in \mathcal{D}^{\perp}, \mathbf{d}^{\prime} \in \mathcal{C}$, and $\mathbf{c}^{\prime}, \mathbf{d}^{\prime}$ are nonzero such thatv $=a \mathbf{c}^{\prime}+b \mathbf{d}^{\prime}$. Hence we have $a \mathbf{c}+b \mathbf{d}=a \mathbf{c}^{\prime}+b \mathbf{d}^{\prime}$, which implies that $\mathbf{c}=\mathbf{c}^{\prime}, \mathbf{d}=\mathbf{d}^{\prime}$. Then we have $\mathbf{c} \in \mathcal{C} \cap \mathcal{D}^{\perp}, \mathbf{d} \in \mathcal{D} \cap \mathcal{C}$, where $\mathbf{c}, \mathbf{d}$ are nonzero, which is a contradiction. Therefore, $\mathcal{C}_{4}$ is an ACD code.

Corollary 3 Suppose that $\mathcal{C}$ is a self-dual $[2 n, n]$ binary code and $\mathcal{D}$ is a binary linear code such that $\mathbb{F}_{2}^{2 n}=\mathcal{C} \oplus \mathcal{D}$. Let $\mathcal{C}_{4}=a \mathcal{C}+b \mathcal{D}$. Then its minimum distance $d\left(\mathcal{C}_{4}\right)$ is equal to $\min \{d(\mathcal{C}), d(\mathcal{D})\}$.

Proof Obviously, we have $d\left(\mathcal{C}_{4}\right) \leq \min \{d(\mathcal{C}), d(\mathcal{D})\}$. On the other hand, for any nonzero codeword $a \mathbf{u}+b \mathbf{v} \in \mathcal{C}_{4}$ with $\mathbf{u} \in \mathcal{C}$ and $\mathbf{v} \in \mathcal{D}$, since $a, b \in \mathbb{F}_{4} \backslash\{0\}$ and $a \neq b, \operatorname{wt}(a \mathbf{u}+b \mathbf{v}) \geq \max \{\mathrm{wt}(a \mathbf{u}), \mathrm{wt}(b \mathbf{v})\} \geq \min \{d(\mathcal{C}), d(\mathcal{D})\}$. Therefore, $d\left(\mathcal{C}_{4}\right)=\min \{d(\mathcal{C}), d(\mathcal{D})\}$.

Remark 1 Proposition 1 shows that we can get ACD codes over $\mathbb{F}_{4}$ from binary linear self-dual codes.

Example 2 Let $\mathcal{C}$ be a binary $[4,2,2]$ code with generator matrix $G_{1}$ of the form

$$
G_{1}=\left[\begin{array}{llll}
1 & 1 & 0 & 0 \\
0 & 0 & 1 & 1
\end{array}\right] .
$$

Let $\mathcal{D}$ be a binary [4,2,2] code with generator matrix $G_{2}$ of the form

$$
G_{2}=\left[\begin{array}{llll}
1 & 1 & 0 & 1 \\
0 & 1 & 1 & 1
\end{array}\right]
$$

It is easy to check that $\mathcal{C}$ is self-dual and $\mathbb{F}_{2}^{4}=\mathcal{C} \oplus \mathcal{D}$. By Proposition $\mathcal{C}_{4}=\mathcal{C}+\omega \mathcal{D}$ is an $\left(4,2^{4}, 2\right)$ ACD code over $\mathbb{F}_{4}$ with generator matrix $G$ of the form

$$
G=\left[\begin{array}{cccc}
1 & 1 & 0 & 0 \\
0 & 0 & 1 & 1 \\
\omega & \omega & 0 & \omega \\
0 & \omega & \omega & \omega
\end{array}\right] .
$$

## 4 ACD codes with respect to the trace Euclidean inner product $\diamond$

In this section, we construct ACD codes with respect to the trace Euclidean inner product.

Lemma 4 Any Euclidean LCD $[n, k, d]$ code $\mathcal{C}$ over $\mathbb{F}_{4}$ is an $A C D\left(n, 2^{2 k}, d\right)$ code over $\mathbb{F}_{4}$ with respect to the trace Euclidean inner product.

Proof Suppose that $\mathcal{C}$ is an Euclidean LCD code over $\mathbb{F}_{4}$. Then $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{E}}}=\{\mathbf{0}\}$, where $\mathcal{C}^{\perp_{\mathrm{E}}}$ denotes the dual of $\mathcal{C}$ under the Euclidean inner product. By Lemma 1 $\mathcal{C}^{\perp_{\mathrm{E}}}=\mathcal{C}^{\perp_{\mathrm{TrE}}}$. Thus, $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{TrE}}}=\{\mathbf{0}\}$, which means that $\mathcal{C}$ is ACD with respect to the trace Euclidean inner product. The parameters of $\mathcal{C}$ over $\mathbb{F}_{4}$ are obvious.

We want a characterization of an ACD code with respect to the Euclidean inner product in terms of its generator matrix. We follow the idea from [1].

Definition 2 ( 1 ) Let $V$ be an inner product space over a field $\mathbb{F}_{q}$. An $\mathbb{F}_{q}$-linear map $T: V \rightarrow V$ is called an $\mathbb{F}_{q}$-orthogonal projection with respect to the prescribed inner product $<\cdot, \cdot>$ if
(i) $T^{2}=T$, and
(ii) $\langle\mathbf{u}, \mathbf{v}\rangle=0$ for all $\mathbf{u} \in \operatorname{Im}(T)$ and $\mathbf{v} \in \operatorname{Ker}(T)$.

Lemma 5 Using the notation of Definition 2, if $\langle\cdot, \cdot\rangle$ is nondegenerate, then $\operatorname{Ker}(T)$ is the dual of $\operatorname{Im}(T)$ under $\langle\cdot, \cdot\rangle$.

Proof From basic linear algebra, $\operatorname{dim}_{\mathbb{F}_{q}}(\operatorname{Ker}(T))=\operatorname{dim}_{\mathbb{F}_{q}}(V)-\operatorname{dim}_{\mathbb{F}_{q}}(\operatorname{Im}(T))$. Let $\mathcal{D}$ be the dual of $\operatorname{Im}(T)$ under $\langle\cdot, \cdot\rangle$. As $\langle\cdot, \cdot\rangle$ is nondegenerate, $\operatorname{dim}_{\mathbb{F}_{q}}(\mathcal{D})=\operatorname{dim}_{\mathbb{F}_{q}}(V)-$ $\operatorname{dim}_{\mathbb{F}_{q}}(\operatorname{Im}(T))$. Thus $\operatorname{Ker}(T)$ and $\mathcal{D}$ have the same dimension. By part (ii) of Definition $2, \operatorname{Ker}(T) \subseteq \mathcal{D}$. As $\operatorname{Ker}(T)$ and $\mathcal{D}$ have the same dimension, they are equal.

Lemma 6 Let $\mathcal{C}$ be a linear code of length $n$ over $\mathbb{F}_{4}$ and let $T: \mathbb{F}_{4}^{n} \rightarrow \mathbb{F}_{4}^{n}$ be an $\mathbb{F}_{4}$ linear map. Then $T$ is an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product onto $\mathcal{C}$ if and only if

$$
T(\boldsymbol{v})= \begin{cases}\boldsymbol{v} & \text { if } \boldsymbol{v} \in \mathcal{C} \\ \boldsymbol{O} & \text { if } \boldsymbol{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}\end{cases}
$$

Proof Suppose that $T: \mathbb{F}_{4}^{n} \rightarrow \mathbb{F}_{4}^{n}$ is an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product onto $\mathcal{C}$. Let $\mathbf{v} \in \mathcal{C}=\operatorname{Im}(T)$. Then there exists $\mathbf{x} \in \mathbb{F}_{4}^{n}$ such that $\mathbf{v}=T(\mathbf{x})$. So $\mathbf{v}=T(\mathbf{x})=T^{2}(\mathbf{x})=T(T(\mathbf{x}))=T(\mathbf{v})$. Now let $\mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}} ;$ then $T(\mathbf{v})=\mathbf{0}$ by Lemma 5

Conversely, assume that

$$
T(\mathbf{v})= \begin{cases}\mathbf{v} & \text { if } \mathbf{v} \in \mathcal{C} \\ \mathbf{0} & \text { if } \mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{Tr} \mathrm{E}}}\end{cases}
$$

Since $T$ is a function, $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{TrE}}}=\{\mathbf{0}\}$ implying $\mathbb{F}_{4}^{n}=\mathcal{C} \oplus \mathcal{C}^{\perp_{\mathrm{TrE}}}$. If $\mathbf{v} \in \mathcal{C}, T^{2}(\mathbf{v})=$ $T(T(\mathbf{v}))=T(\mathbf{v})=\mathbf{v}$; if $\mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}, T^{2}(\mathbf{v})=T(T(\mathbf{v}))=T(\mathbf{0})=\mathbf{0}=T(\mathbf{v})$. So $T^{2}=T$ on $\mathcal{C}$ and on $\mathcal{C}^{\perp_{\mathrm{TrE}}}$, and hence on $\mathcal{C} \oplus \mathcal{C}^{\perp_{\mathrm{TrE}}}=\mathbb{F}_{4}^{n}$ by linearity, verifying part (i) of Definition 2. Also $\operatorname{Im}(T)=\mathcal{C}$. As in the proof of Lemma 5 $\operatorname{dim}_{\mathbb{F}_{4}}\left(\mathcal{C}^{\perp_{\mathrm{TrE}}}\right)=$ $\operatorname{dim}_{\mathbb{F}_{4}}(\operatorname{Ker}(T))$. As $T(\mathbf{v})=\mathbf{0}$ for $\mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}, \mathcal{C}^{\perp_{\mathrm{TrE}}} \subseteq \operatorname{Ker}(T)$ imply $\mathcal{C}^{\perp_{\mathrm{TrE}}}=\operatorname{Ker}(T)$, verifying part (ii) of Definition 2

Lemma 7 Let $\mathcal{C}$ be a linear code of length $n$ over $\mathbb{F}_{4}$. Then $\mathcal{C}$ is $A C D$ with respect to the trace Euclidean inner product if and only if there exists an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product from $\mathbb{F}_{4}^{n}$ onto $\mathcal{C}$.

Proof Let $T_{\mathcal{C}}$ is an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product from $\mathbb{F}_{4}^{n}$ onto $\mathcal{C}$. By Lemma it follows that,

$$
T_{\mathcal{C}}(\mathbf{v})= \begin{cases}\mathbf{v} & \text { if } \mathbf{v} \in \mathcal{C} \\ \mathbf{0} & \text { if } \mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}\end{cases}
$$

Assume that $\mathcal{C}$ is not ACD with respect to the trace Euclidean inner product. Then there exists $\mathbf{u} \neq \mathbf{0}$ such that $\mathbf{u} \in \mathcal{C} \cap \mathcal{C}^{\perp}{ }^{\text {Tre }}$. Hence, $\mathbf{u}=T_{\mathcal{C}}(\mathbf{u})=\mathbf{0}$, which is a contradiction. Therefore, $\mathcal{C}$ is ACD with respect to the trace Euclidean inner product

Conversely, assume that $\mathcal{C}$ is ACD with respect to the trace Euclidean inner product. Let $\mathbf{v} \in \mathbb{F}_{4}^{n}$, then there exists a unique pair $\mathbf{u} \in \mathcal{C}$ and $\mathbf{w} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}$ such that $\mathbf{v}=\mathbf{u}+\mathbf{w}$. Defined a map $T_{\mathcal{C}}: \mathbb{F}_{4}^{n} \rightarrow \mathbb{F}_{4}^{n}$ by $T_{\mathcal{C}}(\mathbf{v})=\mathbf{u}$. Clearly, $T_{\mathcal{C}}$ is an $\mathbb{F}_{4}$-linear map such that:

$$
T_{\mathcal{C}}(\mathbf{v})= \begin{cases}\mathbf{v} & \text { if } \mathbf{v} \in \mathcal{C} \\ \mathbf{0} & \text { if } \mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}\end{cases}
$$

Hence, by Lemma 6 $T_{\mathcal{C}}$ is an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product from $\mathbb{F}_{4}^{n}$ onto $\mathcal{C}$.

Theorem 4 Let $\mathcal{C}$ be an additive $\left(n, 2^{k}\right)$ code over $\mathbb{F}_{4}$ with generator matrix $G$. Then $\mathcal{C}$ is $A C D$ with respect to the trace Euclidean inner product if and only if $G \diamond G=G G^{T}+$ $\bar{G} \bar{G}^{T}$ is invertible. Moreover, in this case the map $T_{\mathcal{C}}(\boldsymbol{v})=\operatorname{Tr}\left(\boldsymbol{v} G^{T}\right)\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G$ is an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product from $\mathbb{F}_{4}^{n}$ onto $\mathcal{C}$, where for $\mathbf{v} \in \mathbb{F}_{4}^{n}, \operatorname{Tr}\left(\mathbf{v} G^{T}\right)=\mathbf{v} G^{T}+\overline{\mathbf{v}} \bar{G}^{T}$.
Proof Assume $\operatorname{Tr}\left(G G^{T}\right)=G G^{T}+\bar{G} \bar{G}^{T}$ is not invertible. Since $\operatorname{Tr}\left(G G^{T}\right)$ is a $k \times k$ matrix, we have $\operatorname{rank}\left(\operatorname{Tr}\left(G G^{T}\right)<k\right.$. Hence

$$
k=\operatorname{null}\left(\operatorname{Tr}\left(G G^{T}\right)\right)+\operatorname{rank}\left(\operatorname{Tr}\left(G G^{T}\right)\right)<\operatorname{null}\left(\operatorname{Tr}\left(G G^{T}\right)\right)+k,
$$

then $\operatorname{null}\left(\operatorname{Tr}\left(G G^{T}\right)\right)>k-k=0$. So there exists $\mathbf{u} \in \operatorname{Ker}\left(\operatorname{Tr}\left(G G^{T}\right)\right) \backslash\{\mathbf{0}\} \subseteq \mathbb{F}_{2}^{k}$ such that $\mathbf{u} \operatorname{Tr}\left(G G^{T}\right)=\mathbf{0}$ and $\mathbf{u} G \in \mathcal{C} \backslash\{\mathbf{0}\}$. We have,

$$
\mathbf{0} \neq \mathbf{u} \in \operatorname{Ker}\left(\operatorname{Tr}\left(G G^{T}\right)\right)=\mathbf{u} G G^{T}+\mathbf{u} \bar{G} \bar{G}^{T}=(\mathbf{u} G) G^{T}+(\overline{\mathbf{u}} \bar{G}) \bar{G}^{T}
$$

Hence, $\mathbf{u} G$ is also a vector in $\mathcal{C}^{\perp_{\mathrm{TrE}}} ;$ i.e., $\mathcal{C} \cap \mathcal{C}^{\perp_{\mathrm{TrE}}} \neq\{\mathbf{0}\}$. Therefore, $\mathcal{C}$ is not ACD with respect to the trace Euclidean inner product.

Conversely, assume that $G G^{T}+\bar{G} \bar{G}^{T}$ is invertible. Let $T_{\mathcal{C}}: \mathbb{F}_{4}^{n} \rightarrow \mathcal{C}$ be defined by

$$
T_{\mathcal{C}}(\mathbf{v})=\operatorname{Tr}\left(\mathbf{v} G^{T}\right)\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G .
$$

Let $\mathbf{v} \in \mathbb{F}_{4}^{n}$. If $\mathbf{v} \in \mathcal{C}$, then there exists $\mathbf{u} \in \mathbb{F}_{2}^{k}$ such that $\mathbf{v}=\mathbf{u} G$; hence,

$$
\begin{aligned}
T_{\mathcal{C}}(\mathbf{v}) & =\operatorname{Tr}\left(\mathbf{v} G^{T}\right)\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G \\
& =\operatorname{Tr}\left(\mathbf{u} G G^{T}\right)\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G \\
& =\left(\mathbf{u} G G^{T}+\overline{\mathbf{u}} \bar{G} \bar{G}^{T}\right)\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G \\
& =\mathbf{u}\left(G G^{T}+\bar{G} \bar{G}^{T}\right)\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G \\
& =\mathbf{u} I_{k} G \\
& =\mathbf{u} G \\
& =\mathbf{v},
\end{aligned}
$$

Assume that $\mathbf{v} \in \mathcal{C}^{\perp_{\mathrm{TrE}}}$. Then $\operatorname{Tr}\left(\mathbf{v} G^{T}\right)=\mathbf{0}$, and

$$
T_{\mathcal{C}}(\mathbf{v})=\operatorname{Tr}\left(\mathbf{v} G^{T}\right)\left(G G+\bar{G} \bar{G}^{T}\right)^{-1} G=\mathbf{0}\left(G G^{T}+\bar{G} \bar{G}^{T}\right)^{-1} G=\mathbf{0} .
$$

Hence by Lemma 6 $T_{\mathcal{C}}$ is an $\mathbb{F}_{4}$-orthogonal projection with respect to the trace Euclidean inner product from $\mathbb{F}_{4}^{n}$ onto $\mathcal{C}$. By Lemma $7 \mathcal{C}$ is an ACD code with respect to the trace Euclidean inner product.

Corollary 4 If $\mathcal{C}$ and $\mathcal{D}$ are two binary $L C D\left[n, k_{1}\right]$ and $\left[n, k_{2}\right]$ codes respectively, then $\mathcal{C}_{4}=\omega \mathcal{C}+\omega^{2} \mathcal{D}$ is an $A C D\left(n, 2^{k_{1}+k_{2}}\right)$ code over $\mathbb{F}_{4}$ with respect to the trace Euclidean inner product.

Proof Since $\mathcal{C}$ and $\mathcal{D}$ are LCD codes, we have $\mathcal{C} \cap \mathcal{C}^{\perp}=\{\mathbf{0}\}, \mathcal{D} \cap \mathcal{D}^{\perp}=\{\mathbf{0}\}$. Furthermore, since $\left\{\omega, \omega^{2}\right\}$ is a trace orthogonal basis in $\mathbb{F}_{4}$, we have $\mathcal{C}_{4}^{\perp} \mathrm{TrE}=\omega \mathcal{C}^{\perp}+\omega^{2} \mathcal{D}^{\perp}$. We need to prove that $\mathcal{C}_{4} \cap \mathcal{C}_{4}^{\perp}{ }_{\mathrm{TrE}}=\{\mathbf{0}\}$. If there exists $\mathbf{0} \neq \mathbf{v} \in \mathcal{C}_{4} \cap \mathcal{C}_{4}^{\perp_{\mathrm{TrE}}}$, then there are $\mathbf{c} \in \mathcal{C}, \mathbf{d} \in \mathcal{D}$, and $\mathbf{c}, \mathbf{d}$ are nonzero such that $\mathbf{v}=\omega \mathbf{c}+\omega^{2} \mathbf{d}$. Similarly, there are $\mathbf{c}^{\prime} \in \mathcal{C}^{\perp}, \mathbf{d}^{\prime} \in \mathcal{D}^{\perp}$, and $\mathbf{c}^{\prime}, \mathbf{d}^{\prime}$ are nonzero such that $\mathbf{v}=\omega \mathbf{c}^{\prime}+\omega^{2} \mathbf{d}^{\prime}$. Hence we have $\omega \mathbf{c}+\omega^{2} \mathbf{d}=\omega \mathbf{c}^{\prime}+\omega^{2} \mathbf{d}^{\prime}$, which implies that $\mathbf{c}=\mathbf{c}^{\prime}, \mathbf{d}=\mathbf{d}^{\prime}$. Then we have $\mathbf{c} \in \mathcal{C} \cap \mathcal{C}^{\perp}, \mathbf{d} \in \mathcal{D} \cap \mathcal{D}^{\perp}$, where $\mathbf{c}, \mathbf{d}$ are nonzero, which is a contradiction. Therefore, $\mathcal{C}_{4}$ is an ACD code. Clearly, the $\mathbb{F}_{2}$-rank of $\mathcal{C}_{4}$ is $k_{1}+k_{2}$.

Corollary 5 Let $\mathcal{C}_{1}$ be a binary $[2 n, k]$ code with generator matrix $G_{1}=[A \mid B]$, where $A$ and $B$ are $k \times n$ matrices. Let $\mathcal{C}_{2}$ be an additive code with generator matrix $G=$ $\omega A+\omega^{2} B$. Then $\mathcal{C}_{2}$ is an $A C D\left(n, 2^{k}\right)$ code over $\mathbb{F}_{4}$ with respect to the trace Euclidean inner product if and only if $\mathcal{C}_{1}$ is a binary $[2 n, k] L C D$ code.

Proof Suppose that $\mathcal{C}_{1}$ is a binary LCD code. Then, by Theorem $\left.\left[\begin{array}{l}\text { t }\end{array}\right] B\right][A \mid B]^{T}=$ $A A^{T}+B B^{T}$ is invertible over $\mathbb{F}_{2}$. We also have

$$
\begin{aligned}
G \diamond G & =\left(\omega A+\omega^{2} B\right)\left(\omega A^{T}+\omega^{2} B^{T}\right)+\left(\bar{\omega} A+\overline{\omega^{2}} B\right)\left(\bar{\omega} A^{T}+\overline{\omega^{2}} B^{T}\right) \\
& =\left(\omega^{2}+\omega\right) A A^{T}+\left(\omega+\omega^{2}\right) B B^{T} \\
& =A A^{T}+B B^{T} ;
\end{aligned}
$$

hence $G \diamond G=[A \mid B][A \mid B]^{T}$ is invertible over $\mathbb{F}_{4}$. Therefore, by Theorem $4 \mathcal{C}_{2}$ is ACD with respect to the trace Euclidean inner product. Clearly, the $\mathbb{F}_{2}$-rank of $\mathcal{C}_{2}$ is $k$.

Conversely, if $\mathcal{C}_{2}$ is ACD with respect to the trace Euclidean inner product, then we reverse the above proof to show that $\mathcal{C}_{1}$ is a binary LCD code.

Example 3 Let $\mathcal{C}_{1}$ be a binary $[12,6,4]$ code with the generator matrix $G_{1}=[A \mid B]$ of the form

$$
G_{1}=\left[\begin{array}{llllll|llllll}
1 & 0 & 0 & 0 & 0 & 0 & 0 & 1 & 1 & 1 & 0 & 0 \\
0 & 1 & 0 & 0 & 0 & 0 & 1 & 1 & 1 & 0 & 1 & 1
\end{array}\right]
$$

It is easy to check that $\mathcal{C}_{1}$ is a binary LCD code. By Corollary $5 \mathcal{C}_{2}$ is a $\left(6,2^{6}, 4\right)$ ACD code with generator matrix $G$

$$
G=\left[\begin{array}{cccccc}
\omega & \omega^{2} & \omega^{2} & \omega^{2} & 0 & 0 \\
\omega^{2} & 1 & 0 & \omega^{2} & \omega^{2} & 0 \\
\omega^{2} & 0 & 1 & 0 & \omega^{2} & \omega^{2} \\
\omega^{2} & \omega^{2} & 0 & 1 & 0 & \omega^{2} \\
0 & \omega^{2} & \omega^{2} & 0 & 1 & \omega^{2} \\
0 & 0 & \omega^{2} & \omega^{2} & \omega^{2} & \omega
\end{array}\right] .
$$

Corollary 6 Let $\mathcal{C}$ be an $\left(n, 2^{k}\right)$ additive conjucyclic code with generator matrix $G$ over $\mathbb{F}_{4}$, and form the binary code

$$
\mathcal{C}^{\prime}=\{\operatorname{Tr}(\omega \boldsymbol{u}) \mid \operatorname{Tr}(\bar{\omega} \boldsymbol{u}): \boldsymbol{u} \in \mathcal{C}\}
$$

where the trace is applied componentwise and the vertical bar denotes concatenation. Then $\mathcal{C}^{\prime}$ is a binary cyclic code of length $2 n$ with generator matrix $G^{\prime}=[\omega G+\bar{\omega} \bar{G} \mid \bar{\omega} G+$ $\omega \bar{G}]$, which is $L C D$ if and only if $\mathcal{C}$ is $A C D$ with respect to the trace Euclidean inner product.

Proof Suppose that $\mathcal{C}$ is an ACD code with respect to the trace Euclidean inner product. Then $G \diamond G=G G^{T}+\bar{G} \overline{G^{T}}$ is invertible. And $\mathcal{C}^{\prime}$ is a binary cyclic code with generator matrix $G^{\prime}$. Hence:

$$
\begin{aligned}
G^{\prime} G^{\prime T} & =(\omega G+\bar{\omega} \bar{G})\left(\omega G^{T}+\bar{\omega} \bar{G}^{T}\right)+(\bar{\omega} G+\omega \bar{G})\left(\bar{\omega} G^{T}+\omega \bar{G}^{T}\right) \\
& =\omega^{2} G G^{T}+G \bar{G}^{T}+\bar{G} G^{T}+\omega \bar{G} \bar{G}^{T}+\omega G G^{T}+G \bar{G}^{T}+\bar{G} G^{T}+\omega^{2} \bar{G} \bar{G}^{T} \\
& =G G^{T}+\bar{G} \bar{G}^{T}
\end{aligned}
$$

Therefore, $\mathcal{C}^{\prime}$ is a binary LCD code.
Conversely, if $\mathcal{C}^{\prime}$ is a binary LCD code, then we reverse the above proof to show that $\mathcal{C}$ is an ACD code with respect to the trace Euclidean inner product.

Remark 2 As a natural question, one can ask whether there is an ACD $\left(n, 2^{k^{*}}, d^{*}\right)$ code over $\mathbb{F}_{4}$ under the trace Euclidean inner product which satisfies $k^{*}>2 k$ and $d^{*}=d$, given an optimal linear LCD $[n, k, d]$ code over $\mathbb{F}_{4}$ under the Euclidean inner product. In what follows, we give several examples with the above conditions. This implies that ACD codes over $\mathbb{F}_{4}$ are sometimes better than LCD codes over $\mathbb{F}_{4}$.

Example 4 By Grassl's table [7], there is an Euclidean optimal [6, 2, 4] code over $\mathbb{F}_{4}$. One can also find an optimal LCD $[6,2,4]$ code $\mathcal{K}_{1}$ over $\mathbb{F}_{4}$ with generator matrix $K_{1}$ under the Euclidean inner product.

$$
K_{1}=\left[\begin{array}{cccccc}
1 & 0 & 1 & 1 & 0 & \omega \\
0 & 1 & \omega & \omega & \omega^{2} & \omega
\end{array}\right]
$$

By a random search, we have constructed an $\operatorname{ACD}\left(6,2^{5}, 4\right)$ code $\mathcal{K}_{2,1}$ over $\mathbb{F}_{4}$ with generator matrix $K_{2,1}$ under the trace Euclidean inner product as follows. Note that $\mathcal{K}_{2,1}$ has double codewords than $\mathcal{K}_{1}$ although both have the same length and minimum weight.

$$
K_{2,1}=\left[\begin{array}{cccccc}
1 & 0 & \omega & 1 & \omega^{2} & \omega \\
\omega & 0 & \omega & \omega^{2} & 1 & \omega^{2} \\
0 & 1 & 0 & 1 & \omega & \omega \\
0 & \omega & \omega & \omega & \omega & \omega \\
0 & 0 & 1 & \omega & 1 & \omega
\end{array}\right] .
$$

The weight distribution of $\mathcal{K}_{2,1}$ is $A_{0}=1, A_{4}=17, A_{5}=8, A_{6}=6$ and the order of the permutation automorphism group of $\mathcal{K}_{2,1}$ is 4 .

We have also found two more inequivalent $\operatorname{ACD}\left(6,2^{5}, 4\right)$ codes denoted by $\mathcal{K}_{2,2}$ and $\mathcal{K}_{2,3}$ with generator matrices $K_{2,2}$ and $K_{2,3}$, respectively. The weight distributions and the orders of the permutation automorphism groups of these codes are displayed in Table 1.

0 & 0 & \omega^{2} & \omega^{2} & 1 & 1
\end{array}\right], \quad K_{2,3}=\left[\begin{array}{cccccc}
1 & 0 & 0 & 1 & \omega & \omega^{2} \\
\omega & 0 & \omega & \omega^{2} & \omega^{2} & \omega^{2} \\
0 & 1 & 0 & 1 & \omega^{2} & 1 \\
0 & \omega & \omega & 1 & \omega & 0 \\
0 & 0 & \omega^{2} & \omega & \omega^{2} & \omega
\end{array}\right] .
$$

Example 5 It is well known [4] that linear $[n, k, d]$ codes over $\mathbb{F}_{4}$ are equivalent to LCD $[n, k, d]$ codes under the Euclidean inner product. For $n=35$ and 96 with $k=3$, there are optimal linear $[35,3,26],[96,3,72]$ codes over $\mathbb{F}_{4}$ [7], which
implies that there are optimal LCD $[35,3,26],[96,3,72]$ codes over $\mathbb{F}_{4}$. Guo el al. 9$]$ constructed better additive $\left(35,2^{7}, 26\right)$ and $\left(96,2^{7}, 72\right)$ codes over $\mathbb{F}_{4}$ with generator matrices $G_{7,35}$ and $G_{7,96}$, respectively. However, these are not ACD codes under the trace Euclidean inner product. By multiplying some columns of $G_{7,35}$ and $G_{7,96}$ by nonzero elements of $\mathbb{F}_{4}$, we have constructed an $\operatorname{ACD}\left(35,2^{7}, 26\right)$ code $\mathcal{K}_{3}$ and an $\operatorname{ACD}\left(96,2^{7}, 72\right)$ code $\mathcal{K}_{4}$ over $\mathbb{F}_{4}$ with generator matrices $K_{3}$ and $K_{4}$, respectively under the trace Euclidean inner product. The weight distributions and the orders of the permutation automorphism groups of these codes are displayed in Table 1.

## 5 Conclusion

In this paper, we have studied ACD codes over $\mathbb{F}_{4}$ with respect to the trace Hermitian inner product and the trace Euclidean inner product. Interesting constructions of ACD codes from binary codes are given with respect to the both inner products. As a good motivation of ACD codes, we have also constructed several ACD $\left(n, 2^{2 k+1}, d\right)$ codes over $\mathbb{F}_{4}$ under the trace Euclidean inner product which are better than optimal Euclidean LCD $[n, k, d]$ codes over $\mathbb{F}_{4}$.
