# CONNECTED REDUCED PRODUCTS

#### Abstract

A structure $\mathbb{X}=\langle X, \rho\rangle$, where $\rho$ is a binary relation on the set $X$, is connected iff the minimal equivalence relation containing $\rho$ is the full relation on $X$. Connectivity is not a first order property but it is expressible by a $L_{\omega_{1} \omega^{-}}$ sentence. We show that, for a set $I$ the following conditions are equivalent (a) $|I|$ is less than the first measurable cardinal, (b) For each filter $\Phi \subset P(I)$ and each family $\left\{\mathbb{X}_{i}: i \in I\right\}$ of binary structures, the reduced product $\prod_{\Phi} \mathbb{X}_{i}$ is connected, iff there are a finite set $K \subset I$ and $n \in \omega$ such that $\mathbb{X}_{i}$ is connected, for each $i \in K$ and $\left\{i \in I: \mathbb{X}_{i}\right.$ is of diameter $\left.\leq n\right\} \cup K \in \Phi$, (c) The ultraproduct $\prod_{\mathcal{U}} \mathbb{G}_{\omega}$ is a disconnected graph for each non-principal ultrafilter $\mathcal{U} \subset P(I)$, where $\mathbb{G}_{\omega}$ is the linear graph on $\omega$. Moreover, the implication " $\Leftarrow$ " in (b) holds in ZFC. For a disconnected $\prod_{\Phi} \mathbb{X}_{i}$ we describe the components of $\prod_{\Phi} \mathbb{X}_{i}$.

## 1 Preliminaries

Reduced products Let $L=\{R\}$ be the language with one binary relational symbol. Let $I$ be a non-empty set, $\Phi \subset P(I)$ a filter and $\mathbb{X}_{i}=\left\langle X_{i}, \rho_{i}\right\rangle$, for $i \in I$, $L$-structures. Let $\sim_{\Phi}$ be the binary relation on the product $\prod_{i \in I} X_{i}$ defined in the following way: for $x=\left\langle x_{i}: i \in I\right\rangle, y=\left\langle y_{i}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$

$$
x \sim_{\Phi} y \Leftrightarrow\left\{i \in I: x_{i}=y_{i}\right\} \in \Phi
$$

It is evident that the relation $\sim_{\Phi}$ is an equivalence relation on the set $\prod_{i \in I} X_{i}$. Let $[x]_{\Phi}=\left\{y \in \prod_{i \in I} X_{i}: x \sim_{\Phi} y\right\} \in\left(\prod_{i \in I} X_{i}\right) / \sim_{\Phi}$ denote the equivalence class of $x$. The corresponding reduced product $\left(\prod_{i \in I} \mathbb{X}_{i}\right) / \Phi$ (shortly $\left.\prod_{\Phi} \mathbb{X}_{i}\right)$ is the structure

$$
\left\langle\left(\prod_{i \in I} X_{i}\right) / \sim_{\Phi}, \rho\right\rangle
$$

where the binary relation $\rho$ on the quotient $\left(\prod_{i \in I} X_{i}\right) / \sim_{\Phi}$ is defined by

$$
[x]_{\Phi} \rho[y]_{\Phi} \Leftrightarrow\left\{i \in I: x_{i} \rho_{i} y_{i}\right\} \in \Phi
$$

We will use the following evident fact (see [1], p. 177).

[^0]Fact 1.1 If $\Phi$ is a filter on $I$ and $J \in \Phi$, then $\Phi \upharpoonright J:=\Phi \cap P(J)$ is a filter on $J$ and $f: \prod_{\Phi} \mathbb{X}_{i} \cong \prod_{\Phi \upharpoonright J} \mathbb{X}_{j}:=\left(\prod_{i \in J} \mathbb{X}_{i}\right) / \sim_{\Phi \mid J}$, where $f\left([x]_{\Phi}\right)=[x \upharpoonright J]_{\Phi \mid J}$.

First-order properties of reduced products are well understood. If $L$ is any language, an $L$-formula is a basic Horn formula iff it is of the form $\eta_{0} \vee \ldots \vee \eta_{m-1}$, where $\eta_{i}$ 's are literals and at most one of them is atomic. The set of Horn formulas is the closure of the set of basic Horn formulas under $\wedge, \exists$ and $\forall$. It is known that each Horn formula $\varphi\left(v_{0}, \ldots, v_{n-1}\right)$ is preserved in reduced products; i.e., for each set $I$, filter $\Phi \subset P(I)$, family of $L$-structures $\left\{\mathbb{X}_{i}: i \in I\right\}$ and $n$-tuple $\left\langle x^{0}, \ldots, x^{n-1}\right\rangle \in\left(\prod_{i \in I} X_{i}\right)^{n}$ we have

$$
\begin{equation*}
\left\{i \in I: \mathbb{X}_{i} \models \varphi\left[x_{i}^{0}, \ldots, x_{i}^{n-1}\right]\right\} \in \Phi \Rightarrow \prod_{\Phi} \mathbb{X}_{i} \models \varphi\left[\left[x^{0}\right]_{\Phi}, \ldots,\left[x^{n-1}\right]_{\Phi}\right] \tag{1}
\end{equation*}
$$

By the well known result of Keisler (under CH) and Galvin (in ZFC) we have: an $L$-sentence $\varphi$ is preserved in reduced products, i.e., for each $I, \Phi$ and $\left\{\mathbb{X}_{i}: i \in I\right\}$ as above

$$
\begin{equation*}
\left\{i \in I: \mathbb{X}_{i} \models \varphi\right\} \in \Phi \Rightarrow \prod_{\Phi} \mathbb{X}_{i} \models \varphi \tag{2}
\end{equation*}
$$

iff $\varphi$ is logically equivalent to a Horn $L$-sentence (see [1], p. 365).
Putting the implication " $\Leftarrow$ " in (2) we obtain a definition of a sentence preserved under reduced factors. It is known that the positive sentences (without $\neg$ ) are of that kind (see [1], p. 340).

Connected binary structures Let $L=\{R\}$ be the language with one binary relational symbol. Let $\mathbb{X}=\langle X, \rho\rangle$ be an $L$-structure, where $\rho \subset X^{2}$ is a reflexive binary relation and let $\rho^{-1}$ be the inverse of $\rho$. For $\varepsilon \in 2:=\{0,1\}$ let

$$
\rho^{\varepsilon}= \begin{cases}\rho & \text { if } \varepsilon=0,  \tag{3}\\ \rho^{-1} & \text { if } \varepsilon=1 .\end{cases}
$$

If $x, y \in X$ and $n \in \omega$, a path of length $n+1$ from $x$ to $y$ is a pair $\langle\bar{z}, \varepsilon\rangle$, where $\bar{z}=\left\langle z_{0}, \ldots, z_{n-1}\right\rangle \in X^{n}$ and $\varepsilon=\left\langle\varepsilon_{0}, \ldots, \varepsilon_{n}\right\rangle \in 2^{n+1}$ and such that

$$
x \rho^{\varepsilon_{0}} z_{0} \rho^{\varepsilon_{1}} z_{1} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}} z_{n-1} \rho^{\varepsilon_{n}} y
$$

(So, for $n=0, x \rho^{\varepsilon_{0}} y$.) Then we will write $d(x, y) \leq n+1$ and $d(x, y)=\infty$ will denote that there is no (finite) path from $x$ to $y$.

The binary relation $\sim$ on the set $X$ defined by $x \sim y$ iff there is finite path from $x$ to $y$, is an equivalence relation, the corresponding equivalence classes are the (connected) components of $\mathbb{X}$ and the structure $\mathbb{X}$ is connected iff it has only one component. (It is easy to see that $\sim$ is the transitive closure $\left(\rho_{s}\right)_{t}$ of the symmetrization $\rho_{s}:=\rho \cup \rho^{-1}$ of the relation $\rho$.)

We extend these definitions for arbitrary $L$-structure $\mathbb{X}=\langle X, \rho\rangle$ in the following way: instead of $\rho$ we take its reflexivization $\rho_{R}:=\rho \cup \Delta_{X}$ and call $\mathbb{X}$ connected iff $\mathbb{X}_{R}:=\left\langle X, \rho_{R}\right\rangle$ is connected, components of $\mathbb{X}$ are components of $\mathbb{X}_{R}$, etc.

The statement $d(x, y) \leq n+1$ is expressible by the first order formula

$$
\varphi_{d \leq n+1}(x, y):=\exists z_{0}, \ldots, z_{n-1} \bigvee_{\varepsilon \in 2^{n+1}} x \rho^{\varepsilon_{0}} z_{0} \rho^{\varepsilon_{1}} \ldots \rho^{\varepsilon_{n-1}} z_{n-1} \rho^{\varepsilon_{n}} y
$$

It is evident that $\varphi_{d \leq n+1}$ is positive and $\neg \varphi_{d \leq n+1}$ is Horn. The property of an $L$-structure that each two points are connected by a path of length $\leq n+1$ is expressible by the first order sentence

$$
\varphi_{n}^{\mathrm{conn}}:=\forall x, y \quad \varphi_{d \leq n+1}(x, y)
$$

If such $n \in \omega$ exists we will say that $\mathbb{X}$ is of finite diameter. The connectedness of an $L$-structure is expressible by the $L_{\omega_{1} \omega}$-sentence

$$
\varphi^{\mathrm{conn}}:=\forall x, y \bigvee_{n \in \omega} \varphi_{d \leq n+1}(x, y)
$$

## 2 Connected reduced products. Components

In the sequel we assume that
(*) $I \neq \emptyset$ is a set, $\Phi$ is a filter in $P(I), \mathbb{X}_{i}=\left\langle X_{i}, \rho_{i}\right\rangle, i \in I$, are $L$-structures and $\prod \mathbb{X}_{i}:=\left\langle\prod_{i \in I} X_{i}, \sigma\right\rangle$ and $\prod_{\Phi} \mathbb{X}_{i}:=\left\langle\prod_{i \in I} X_{i} / \sim_{\Phi}, \rho\right\rangle$ are the corresponding direct and reduced product respectively.

Fact $2.1(*)$ If $x, y \in \prod_{i \in I} X_{i}, A \subset I, x \upharpoonright(I \backslash A)=y \upharpoonright(I \backslash A), n \in \omega$, and there is $\varepsilon \in 2^{n+1}$ such that for each $i \in A$ there is $\bar{z} \in X_{i}^{n}$ such that $\langle\bar{z}, \varepsilon\rangle$ is a path from $x_{i}$ to $y_{i}$, then in $\prod_{\Phi} \mathbb{X}_{i}$ there is a path from $[x]_{\Phi}$ to $[y]_{\Phi}$.

Proof. Let $\varepsilon=\left\langle\varepsilon_{0}, \ldots, \varepsilon_{n}\right\rangle$, and for $i \in A$ let $\left\langle\left\langle z_{i}^{0}, \ldots, z_{i}^{n-1}\right\rangle, \varepsilon\right\rangle$ be a path from $x_{i}$ to $y_{i}$

$$
\begin{equation*}
x_{i} \rho_{i}^{\varepsilon_{0}} z_{i}^{0} \rho_{i}^{\varepsilon_{1}} z_{i}^{1} \rho_{i}^{\varepsilon_{2}} \ldots \rho_{i}^{\varepsilon_{n-1}} z_{i}^{n-1} \rho_{i}^{\varepsilon_{n}} y_{i} . \tag{4}
\end{equation*}
$$

Let $t^{m} \in \prod_{i \in I} X_{i}$, for $m<n$, be defined by

$$
t_{i}^{m}= \begin{cases}x_{i} & \text { if } i \in I \backslash A,  \tag{5}\\ z_{i}^{m} & \text { if } i \in A .\end{cases}
$$

By (4) in the direct product we have $x \sigma^{\varepsilon_{0}} t^{0} \sigma^{\varepsilon_{1}} t^{1} \sigma^{\varepsilon_{2}} \ldots \sigma^{\varepsilon_{n-1}} t^{n-1} \sigma^{\varepsilon_{n}} y$ and, hence, in the reduced product $\prod_{\Phi} \mathbb{X}_{i}$ we have

$$
\begin{equation*}
[x]_{\Phi} \rho^{\varepsilon_{0}}\left[t^{0}\right]_{\Phi} \rho^{\varepsilon_{1}}\left[t^{1}\right]_{\Phi} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}}\left[t^{n-1}\right]_{\Phi} \rho^{\varepsilon_{n}}[y]_{\Phi} \tag{6}
\end{equation*}
$$

So, this is a path from $[x]_{\Phi}$ to $[y]_{\Phi}$.

Fact 2.2 If $\kappa \geq \omega$ is a non-measurable cardinal and $\Phi \subset P(\kappa)$ a filter consisting of infinite sets, then there is a partition $\kappa=\bigcup_{n \in \omega} I_{n}$ such that for each $F \in \Phi$ we have $F \cap I_{n} \neq \emptyset$, for infinitely many $n \in \omega$.

Proof. First let $\bigcap \Phi=\emptyset$. Let $\mathcal{U} \subset P(\kappa)$ be an ultrafilter such that $\Phi \subset \mathcal{U}$. Then the ultrafilter $\mathcal{U}$ is non-principal and, since the cardinal $\kappa$ is non-measurable, $\mathcal{U}$ is not $\omega$-complete. Thus there is a partition $\kappa=\bigcup_{n \in \omega} I_{n}$ such that $I_{n} \notin \mathcal{U}$ and, hence, $\kappa \backslash I_{n} \in \mathcal{U}$, for each $n \in \omega$. Assuming that there are $F \in \Phi$ and $m \in \omega$ such that $F \subset \bigcup_{n \leq m} I_{n}$, we would have $F \cap \bigcap_{n \leq m} \kappa \backslash I_{n}=F \backslash \bigcup_{n \leq m} I_{n}=\emptyset \in \mathcal{U}$, which is false. Thus, $\left|\left\{n \in \omega: F \cap I_{n} \neq \emptyset\right\}\right|=\omega$, for each $F \in \bar{\Phi}$.

Second let $A:=\bigcap \Phi \neq \emptyset$. If $|A|<\omega$, then, since $\Phi \subset P(\kappa) \backslash[\kappa]^{<\omega}$, $\Phi^{\prime}:=\Phi \upharpoonright(\kappa \backslash A)$ is a non-principal filter on $\kappa \backslash A$ and we work as above.

If $|A| \geq \omega, I_{0}=\kappa \backslash A$ and $A=\bigcup_{n \in \mathbb{N}} I_{n}$ is any partition of $A$, then for each $F \in \Phi$ we have $F \cap I_{n} \neq \emptyset$, for all $n \in \mathbb{N}$.

Theorem 2.3 (*) If the size of the index set I is less than the first measurable cardinal, then the following conditions are equivalent
(a) The reduced product $\prod_{\Phi} \mathbb{X}_{i}$ is connected,
(b) There are a finite set $K \subset I$ and $n \in \omega$ such that $\mathbb{X}_{i}$ is connected, for each $i \in K$, and $\left\{i \in I: \mathbb{X}_{i} \models \varphi_{n}^{\text {conn }}\right\} \cup K \in \Phi$.
The implication $(b) \Rightarrow(a)$ is true in ZFC (without any assumptions on $|I|$ ).
Proof. W.l.o.g. we can assume that $\rho_{i} \subset X_{i}, i \in I$, are reflexive relations.
(a) $\Rightarrow$ (b). We prove the contrapositive: assuming that
$\forall K \in[I]^{<\omega}\left(\forall i \in K\left(\mathbb{X}_{i} \models \varphi^{\mathrm{conn}}\right) \Rightarrow \forall n \in \omega\left\{i \in I: \mathbb{X}_{i} \models \varphi_{n}^{\mathrm{conn}}\right\} \cup K \notin \Phi\right)$
we show that $\prod_{\Phi} \mathbb{X}_{i}$ is disconnected.
If the filter $\Phi$ contains a finite set, then $\Phi$ is a principal filter generated by some $K \in[I]^{<\omega}$ and, by (7), there is $i_{0} \in K$ such that $\mathbb{X}_{i_{0}}$ is disconnected. Since $\Phi \upharpoonright K=\{K\}$, by Fact 1.1 we have $\prod_{\Phi} \mathbb{X}_{i} \cong \prod_{\Phi \upharpoonright K} \mathbb{X}_{i} \cong \prod_{i \in K} \mathbb{X}_{i}$. We
take $x_{i_{0}}, y_{i_{0}} \in X_{i_{0}}$ such that there is no path from $x_{i_{0}}$ to $y_{i_{0}}$ in $\mathbb{X}_{i_{0}}$ and choose arbitrary $x_{i}=y_{i} \in X_{i}$, for $i \in K \backslash\left\{i_{0}\right\}$. Assuming that there is a path from $x:=\left\langle x_{i}: i \in K\right\rangle$ to $y:=\left\langle y_{i}: i \in K\right\rangle$ in $\prod_{i \in K} \mathbb{X}_{i}$ we would obtain a path from $x_{i_{0}}$ to $y_{i_{0}}$ in $\mathbb{X}_{i_{0}}$, which is impossible. Thus the reduced product $\prod_{\Phi} \mathbb{X}_{i}$ is disconnected.

So, the remaining case is when $\Phi$ is a filter consisting of infinite subsets of $I$. Let $A_{n}:=\left\{i \in I: \mathbb{X}_{i} \models \varphi_{n}^{\text {conn }}\right\}$, for $n \in \omega$. Then $A_{0} \subset A_{1} \subset A_{2} \subset \ldots$ and, defining $I_{0}:=A_{0}, I_{n}:=A_{n} \backslash A_{n-1}$, for $n \in \mathbb{N}$, and $I_{\infty}=I \backslash \bigcup_{n \in \omega} A_{n}$, we have

$$
I=\bigcup_{n \in \omega} I_{n} \cup I_{\infty} .
$$

We continue with a case analysis.

1. $I_{\infty} \in \Phi$. Then $\left|I_{\infty}\right| \geq \omega$ is a non-measurable cardinal, $\Phi \upharpoonright I_{\infty}$ is a filter on $I_{\infty}$ consisting of infinite sets, and, by Fact 2.2, there is a partition $I_{\infty}=\bigcup_{n \in \omega} I_{n}^{\prime}$ such that for each $F \in \Phi \upharpoonright I_{\infty}$ we have $F \cap I_{n}^{\prime} \neq \emptyset$, for infinitely many $n \in \omega$. If $n \in \omega$, then for $i \in I_{n}^{\prime}$ we have $i \notin A_{n}$ and we choose $x_{i}, y_{i} \in X_{i}$ such that $d\left(x_{i}, y_{i}\right)>n+1$. For $i \in I \backslash I_{\infty}$ we choose arbitrary $x_{i}=y_{i} \in X_{i}$. Let $x:=\left\langle x_{i}: i \in I\right\rangle, y:=\left\langle y_{i}: i \in I\right\rangle$ and suppose that in $\prod_{\Phi} \mathbb{X}_{i}$ there is a path from $[x]_{\Phi}$ to $[y]_{\Phi}$

$$
\begin{equation*}
[x]_{\Phi} \rho^{\varepsilon_{0}}\left[z^{0}\right]_{\Phi} \rho^{\varepsilon_{1}}\left[z^{1}\right]_{\Phi} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}}\left[z^{n-1}\right]_{\Phi} \rho^{\varepsilon_{n}}[y]_{\Phi} \tag{8}
\end{equation*}
$$

Then there would be $F \in \Phi$ which witnesses that; in other words,

$$
\begin{equation*}
\forall i \in F x_{i} \rho_{i}^{\varepsilon_{0}} z_{i}^{0} \rho_{i}^{\varepsilon_{1}} z_{i}^{1} \rho_{i}^{\varepsilon_{2}} \ldots \rho_{i}^{\varepsilon_{n-1}} z_{i}^{n-1} \rho_{i}^{\varepsilon_{n}} y_{i} . \tag{9}
\end{equation*}
$$

Now let $m>n$ be such that there is $i \in F \cap I_{m}^{\prime}$. By (9) there is an $(n+1)$-path from $x_{i}$ to $y_{i}$, which is impossible by the choice of $x_{i}$ and $y_{i}\left(d\left(x_{i}, y_{i}\right)>n+1\right)$. So, there is no path from $[x]_{\Phi}$ to $[y]_{\Phi}$ in $\prod_{\Phi} \mathbb{X}_{i}$ and this structure is disconnected.
2. $I_{\infty} \notin \Phi$. Then we have $F \cap \bigcup_{n \in \omega} I_{n} \neq \emptyset$, for all $F \in \Phi$.
2.1. Each $F \in \Phi$ intersects infinitely many sets $I_{n}$. If $n \in \mathbb{N}$, then for $i \in I_{n}$ we have $i \notin A_{n-1}$ and we choose $x_{i}, y_{i} \in X_{i}$ such that $d\left(x_{i}, y_{i}\right)>n$. For $i \in I \backslash \bigcup_{n \in \mathbb{N}} I_{n}$ we choose arbitrary $x_{i}=y_{i} \in X_{i}$. Let $x:=\left\langle x_{i}: i \in I\right\rangle$, $y:=\left\langle y_{i}: i \in I\right\rangle$ and suppose that in $\prod_{\Phi} \mathbb{X}_{i}$ there is a path from $[x]_{\Phi}$ to $[y]_{\Phi}$

$$
\begin{equation*}
[x]_{\Phi} \rho^{\varepsilon_{0}}\left[z^{0}\right]_{\Phi} \rho^{\varepsilon_{1}}\left[z^{1}\right]_{\Phi} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}}\left[z^{n-1}\right]_{\Phi} \rho^{\varepsilon_{n}}[y]_{\Phi} \tag{10}
\end{equation*}
$$

Then there would be $F \in \Phi$ which witnesses that; in other words,

$$
\begin{equation*}
\forall i \in F x_{i} \rho_{i}^{\varepsilon_{0}} z_{i}^{0} \rho_{i}^{\varepsilon_{1}} z_{i}^{1} \rho_{i}^{\varepsilon_{2}} \ldots \rho_{i}^{\varepsilon_{n-1}} z_{i}^{n-1} \rho_{i}^{\varepsilon_{n}} y_{i} . \tag{11}
\end{equation*}
$$

By the assumption of 2.1 there is $m>n+1$ such that $F \cap I_{m} \neq \emptyset$. So, for $i \in F \cap I_{m}$, by (11) there is an $(n+1)$-path from $x_{i}$ to $y_{i}$, which is impossible by
the choice of $x_{i}$ and $y_{i}\left(d\left(x_{i}, y_{i}\right)>m\right)$. So, there is no path from $[x]_{\Phi}$ to $[y]_{\Phi}$ in $\prod_{\Phi} \mathbb{X}_{i}$ and this structure is disconnected.
2.2. There are $n_{0} \in \omega$ and $F_{0} \in \Phi$ such that $F_{0} \subset A_{n_{0}} \cup I_{\infty}$. By (7) taking $K=\emptyset$ we obtain $A_{n} \notin \Phi$, for all $n \in \omega$. So, assuming that $F \cap I_{\infty}=\emptyset$, for some $F \in \Phi$, we would have $A_{n_{0}} \in \Phi$, which is false. Thus

$$
\begin{equation*}
\forall F \in \Phi \quad F \cap I_{\infty} \neq \emptyset, \tag{12}
\end{equation*}
$$

and $\Phi \upharpoonright I_{\infty}$ is a proper filter on $I_{\infty}$.
2.2.1. $\left|F \cap I_{\infty}\right| \geq \omega$, for all $F \in \Phi$. Then $\left|I_{\infty}\right| \geq \omega$ is a non-measurable cardinal, $\Phi \upharpoonright I_{\infty}$ is a filter on $I_{\infty}$ consisting of infinite sets, and, by Fact 2.2 there is a partition $I_{\infty}=\bigcup_{n \in \omega} I_{n}^{\prime}$ such that for each $F \in \Phi \upharpoonright I_{\infty}$ we have $F \cap I_{n}^{\prime} \neq \emptyset$, for infinitely many $n \in \omega$. Now we continue exactly as in Case 1 .
2.2.2. The set $F \cap I_{\infty}$ is finite, for some $F \in \Phi$. Then $\Phi \upharpoonright I_{\infty}$ is a principal filter generated by some finite set $J \subset I_{\infty}$ and, hence, $A_{n_{0}} \cup J \in \Phi$. So, by (7), there is $i_{0} \in J$ such that $\mathbb{X}_{i_{0}}$ is disconnected. We take $x_{i_{0}}, y_{i_{0}} \in X_{i_{0}}$ such that there is no path from $x_{i_{0}}$ to $y_{i_{0}}$ in $\mathbb{X}_{i_{0}}$ and choose arbitrary $x_{i}=y_{i} \in X_{i}$, for $i \in I \backslash\left\{i_{0}\right\}$. Let $x:=\left\langle x_{i}: i \in I\right\rangle, y:=\left\langle y_{i}: i \in I\right\rangle$ and suppose that there is a path from $[x]_{\Phi}$ to $[y]_{\Phi}$ in $\prod_{\Phi} \mathbb{X}_{i}$,

$$
\begin{equation*}
[x]_{\Phi} \rho^{\varepsilon_{0}}\left[z^{0}\right]_{\Phi} \rho^{\varepsilon_{1}}\left[z^{1}\right]_{\Phi} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}}\left[z^{n-1}\right]_{\Phi} \rho^{\varepsilon_{n}}[y]_{\Phi} . \tag{13}
\end{equation*}
$$

Then there would be $F \in \Phi$ which witnesses that; in other words,

$$
\begin{equation*}
\forall i \in F x_{i} \rho_{i}^{\varepsilon_{0}} z_{i}^{0} \rho_{i}^{\varepsilon_{1}} z_{i}^{1} \rho_{i}^{\varepsilon_{2}} \ldots \rho_{i}^{\varepsilon_{n-1}} z_{i}^{n-1} \rho_{i}^{\varepsilon_{n}} y_{i} . \tag{14}
\end{equation*}
$$

But $i_{0} \in J \subset F$ and we obtain a path from $x_{i_{0}}$ to $y_{i_{0}}$ in $\mathbb{X}_{i_{0}}$, which is impossible. Thus the reduced product $\prod_{\Phi} \mathbb{X}_{i}$ is disconnected.
(b) $\Rightarrow$ (a). Let $K \in[I]^{<\omega}, n \in \omega$ and, defining $A:=\left\{i \in I: \mathbb{X}_{i} \models \varphi_{n}^{\text {conn }}\right\}$, suppose that
(i) $\mathbb{X}_{i}$ is connected, for each $i \in K$, and
(ii) $A \cup K \in \Phi$.

Since $\varphi_{n}^{\text {conn }} \Rightarrow \varphi^{\text {conn }}$ we can assume that $A \cap K=\emptyset$. For $x=\left\langle x_{i}: i \in I\right\rangle, y=$ $\left\langle y_{i}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$ we construct a path from $[x]_{\Phi}$ to $[y]_{\Phi}$ in $\prod_{\Phi} \mathbb{X}_{i}$.

If $i \in A$, then $\mathbb{X}_{i} \models \varphi_{n}^{\text {conn }}$ and, since $x_{i}, y_{i} \in X_{i}$, there is a path $\langle\bar{z}, \varepsilon\rangle$ of length $n+1$ from $x_{i}$ to $y_{i}$; thus we can choose one such $\varepsilon$. Let $\varepsilon^{k} \in 2^{n+1}, k<l$, be an enumeration of the $n+1$-tuples chosen in this way for $i \in A$. Then defining $A_{\varepsilon^{k}}=\left\{i \in A: \varepsilon^{k}\right.$ is chosen for $x_{i}$ and $\left.y_{i}\right\}$, for $k<l$, we have

$$
A=\bigcup_{k<l} A_{\varepsilon^{k}} .
$$

Let $y^{\prime} \in \prod_{i \in I} X_{i}$ be defined by

$$
y_{i}^{\prime}= \begin{cases}x_{i} & \text { if } i \in I \backslash A,  \tag{15}\\ y_{i} & \text { if } i \in A .\end{cases}
$$

We define sequences $s^{m}=\left\langle s_{i}^{m}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$, for $m \leq l-2$, such that there are $l$-many paths of length $(n+1)$ witnessing that $[x]_{\Phi} \sim\left[s^{0}\right]_{\Phi} \sim\left[s^{1}\right]_{\Phi} \sim \ldots \sim$ $\left[s^{l-2}\right]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}$, in the following way

$$
s_{i}^{m}= \begin{cases}x_{i} & \text { if } i \in I \backslash \bigcup_{k \leq m} A_{\varepsilon^{k}},  \tag{16}\\ y_{i} & \text { if } i \in \bigcup_{k \leq m} A_{\varepsilon^{k}} .\end{cases}
$$

Now, $x$ and $s^{0}$ satisfy the assumptions of Fact [2.1] over $A_{\varepsilon^{0}}$; so, $[x]_{\Phi} \sim\left[s^{0}\right]_{\Phi} . s^{0}$ and $s^{1}$ satisfy the assumptions of Fact 2.1 over $A_{\varepsilon^{1}}$; so, $\left[s^{0}\right]_{\Phi} \sim\left[s^{1}\right]_{\Phi}$. Continuing in this way we have that $s^{l-2}$ and $y^{\prime}$ satisfy the assumptions of Fact 2.1 over $A_{\varepsilon^{l-1}}$; so, $\left[s^{l-2}\right]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}$. Thus we have $[x]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}$.

Let $K=\left\{i_{j}: j<k\right\}$ be an enumeration. For $j<k$ the structure $\mathbb{X}_{i_{j}}$ is connected so we can choose a path $\left\langle\bar{z}_{j}, \varepsilon_{j}\right\rangle$ of length $n_{j}$ from $x_{i_{j}}$ to $y_{i_{j}}$. By (ii) we have $F:=A \cup K \in \Phi$. Let $y^{\prime \prime} \in \prod_{i \in I} X_{i}$ be defined by

$$
y_{i}^{\prime \prime}= \begin{cases}x_{i} & \text { if } i \in I \backslash F,  \tag{17}\\ y_{i} & \text { if } i \in F .\end{cases}
$$

We define sequences $t^{j}=\left\langle t_{i}^{j}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$, for $j \leq k-2$, such that $\left[y^{\prime}\right]_{\Phi} \sim\left[t^{0}\right]_{\Phi} \sim\left[t^{1}\right]_{\Phi} \sim \ldots \sim\left[t^{k-2}\right]_{\Phi} \sim\left[y^{\prime \prime}\right]_{\Phi}$, by

$$
t_{i}^{j}= \begin{cases}x_{i} & \text { if } i \in I \backslash\left(A \cup\left\{i_{0}, \ldots, i_{j}\right\}\right),  \tag{18}\\ y_{i} & \text { if } i \in A \cup\left\{i_{0}, \ldots, i_{j}\right\} .\end{cases}
$$

Namely, $y^{\prime}$ and $t^{0}$ satisfy the assumptions of Fact 2.1] over $\left\{i_{0}\right\}$; so, $\left[y^{\prime}\right]_{\Phi} \sim\left[t^{0}\right]_{\Phi}$. $t^{0}$ and $t^{1}$ satisfy the assumptions of Fact 2.1] over $\left\{i_{1}\right\}$; so, $\left[t^{0}\right]_{\Phi} \sim\left[t^{1}\right]_{\Phi}$. Continuing in this way we have that $t^{k-2}$ and $y^{\prime \prime}$ satisfy the assumptions of Fact[2.1] over $\left\{i_{k-1}\right\}$; so $\left[t^{k-2}\right]_{\Phi} \sim\left[y^{\prime \prime}\right]_{\Phi}$. Thus we have proved that $\left[y^{\prime}\right]_{\Phi} \sim\left[y^{\prime \prime}\right]_{\Phi}$ and, since $[x]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}$ and $\left[y^{\prime \prime}\right]_{\Phi}=[y]_{\Phi}$, we finally have $[x]_{\Phi} \sim[y]_{\Phi}$.

Remark 2.4 Regarding Theorem [2.3, if $|I| \geq \omega$ and the filter $\Phi$ contains all cofinite sets, then condition (b) can be replaced by the following simpler condition
(b') There is $n \in \omega$ such that $\left\{i \in I: \mathbb{X}_{i} \models \varphi_{n}^{\text {conn }}\right\} \in \Phi$.
In particular cases, when the filter $\Phi$ is minimal (i.e. $\Phi=\{I\}$ ) and when the filter $\Phi$ is maximal (an ultrafilter in $P(I)$ ) by Theorem 2.3 we have the following two corollaries.

Corollary 2.5 (Direct products and powers) If $(*)$ holds and $\Phi=\{I\}$, then
(a) $\prod_{i \in I} \mathbb{X}_{i}$ is connected iff all the structures $\mathbb{X}_{i}$ are connected and there is $n \in \omega$ such that $\mathbb{X}_{i}$ is of diameter $\leq n$, for all except finitely many $i \in I$;
(b) The direct power $\prod_{i \in I} \mathbb{X}$ is connected iff $\mathbb{X}$ is of finite diameter;
(c) If $|I|<\omega$, then $\prod_{i \in I} \mathbb{X}_{i}$ is connected iff all the structures $\mathbb{X}_{i}$ are connected.

Corollary 2.6 (Ultraproducts and ultrapowers) If ( $*$ ) holds, $\omega \leq|I|$ is less than the first measurable cardinal and $\mathcal{U} \subset P(I)$ is a non-principal ultrafilter, then
(a) $\prod_{\mathcal{U}} \mathbb{X}_{i}$ is connected, iff $\left\{i \in I: \mathbb{X}_{i} \models \varphi_{n}^{\text {conn }}\right\} \in \mathcal{U}$, for some $n \in \omega$;
(b) The ultrapower $\Pi_{\mathcal{U}} \mathbb{X}$ is connected iff $\mathbb{X}$ is of finite diameter.

The implications $\Leftarrow$ are true in ZFC (without any assumptions on $|I|$ ).
Theorem 2.7 Let $|I|$ be a measurable cardinal, $\mathcal{U}$ a non-principal $\omega$-complete ultrafilter on $I$ and $\mathbb{X}_{i}=\left\langle X_{i}, \rho_{i}\right\rangle, i \in I, L$-structures. Then

$$
\prod_{\mathcal{U}} \mathbb{X}_{i} \text { is connected } \Leftrightarrow\left\{i \in I: \mathbb{X}_{i} \text { is connected }\right\} \in \mathcal{U}
$$

Proof. $(\Leftarrow)$ Let $U:=\left\{i \in I: \mathbb{X}_{i}\right.$ is connected $\} \in \mathcal{U}$ and let $x=\left\langle x_{i}: i \in I\right\rangle, y=$ $\left\langle y_{i}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$. We construct a path from $[x]_{\mathcal{U}}$ to $[y]_{\mathcal{U}}$ in $\prod_{\mathcal{U}} \mathbb{X}_{i}$. For $i \in U$ there is a path $\left\langle\bar{z}^{i}, \varepsilon^{i}\right\rangle$ of length $n_{i}+1$ from $x_{i}$ to $y_{i}$ and we choose such $\varepsilon_{i} \in 2^{n_{i}+1}$. Since $\left|\bigcup_{n \in \omega} 2^{n+1}\right|=\omega$, there are $\leq \omega$ such choices; let $\left\{\varepsilon^{k}: k<\lambda\right\}$ be an enumeration of them; so, $\lambda \leq \omega$. Then we have $U=\bigcup_{k<\lambda} A_{k}$, where $A_{k}:=\left\{i \in U: \varepsilon^{i}=\varepsilon^{k}\right\}$ and, since $\mathcal{U}$ is $\omega$-complete, there is $k<\lambda$ such that $A_{k} \in \mathcal{U}$. Now, using Fact 2.1 we construct a path from $[x]_{\mathcal{U}}$ to $[y]_{\mathcal{U}}$.
$(\Rightarrow)$ Let $U:=\left\{i \in I: \mathbb{X}_{i}\right.$ is not connected $\} \in \mathcal{U}$. For each $i \in U$ we pick $x_{i}, y_{i} \in X_{i}$ such that $d\left(x_{i}, y_{i}\right)=\infty$, for $i \in I \backslash U$ we take arbitrary $x_{i}=y_{i} \in X_{i}$ and define $x=\left\langle x_{i}: i \in I\right\rangle, y=\left\langle y_{i}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$. Assuming that there is a path from $[x]_{\mathcal{U}}$ to $[y]_{\mathcal{U}}$ in $\prod_{\mathcal{U}} \mathbb{X}_{i}$,

$$
\begin{equation*}
[x]_{\mathcal{U}} \rho^{\varepsilon_{0}}\left[z^{0}\right]_{\mathcal{U}} \rho^{\varepsilon_{1}}\left[z^{1}\right]_{\mathcal{U}} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}}\left[z^{n-1}\right]_{\mathcal{U}} \rho^{\varepsilon_{n}}[y]_{\mathcal{U}}, \tag{19}
\end{equation*}
$$

there would be $U_{1} \in \mathcal{U}$ which witnesses that and, hence,

$$
\begin{equation*}
\forall i \in U \cap U_{1} x_{i} \rho_{i}^{\varepsilon_{0}} z_{i}^{0} \rho_{i}^{\varepsilon_{1}} z_{i}^{1} \rho_{i}^{\varepsilon_{2}} \ldots \rho_{i}^{\varepsilon_{n-1}} z_{i}^{n-1} \rho_{i}^{\varepsilon_{n}} y_{i} . \tag{20}
\end{equation*}
$$

which is impossible because $d\left(x_{i}, y_{i}\right)=\infty$, for all $i \in U$. So, there is no path from $[x]_{\mathcal{U}}$ to $[y]_{\mathcal{U}}$ in $\prod_{\mathcal{U}} \mathbb{X}_{i}$ and this structure is disconnected.

A simple example of a connected $L$-structure of infinite diameter is the linear graph $\mathbb{G}_{\omega}=\langle\omega, \rho\rangle$, where $\rho=\{\langle m, n\rangle:|m-n|=1\}$. In the absence of measurable cardinals Theorem 2.3 gives a characterization of connected reduced products of $L$-structures. In the presence of measurable cardinals we have the following equivalence.

Theorem 2.8 For each infinite set I the following conditions are equivalent
(i) The cardinal $|I|$ is less than the first measurable cardinal,
(ii) The implication (a) $\Rightarrow$ (b) of Theorem 2.3 is true for each filter $\Phi \subset P(I)$ and each family of $L$-structures $\left\{\mathbb{X}_{i}: i \in I\right\}$,
(iii) The ultraproduct $\prod_{\mathcal{U}} \mathbb{G}_{\omega}$ is a disconnected graph for each non-principal ultrafilter $\mathcal{U} \subset P(I)$.

Proof. The implication (i) $\Rightarrow$ (ii) is proved in Theorem 2.3 .
(ii) $\Rightarrow$ (iii). Let (ii) hold and let $\mathcal{U} \subset P(I)$ be a non-principal ultrafilter. Assuming that the ultraproduct $\prod_{\mathcal{U}} \mathbb{G}_{\omega}$ is connected we would have a finite set $K \subset I$ and $n \in \omega$ such that $\left\{i \in I: \mathbb{G}_{\omega} \models \varphi_{n}^{\text {conn }}\right\} \cup K=K \in \Phi$, which is false.
(iii) $\Rightarrow$ (i). Let (iii) hold. Suppose that $|I| \geq \kappa$, where $\kappa$ is the first measurable cardinal and w.l.o.g. suppose that $\kappa \subset I$. Let $\mathcal{U}_{\kappa} \subset P(\kappa)$ be a non-principal $\omega$-complete ultrafilter and let $\mathcal{U} \subset P(I)$ be its extension to $I$. Then by Fact 1.1 we have $\prod_{\mathcal{U}} \mathbb{G}_{\omega}:=\left(\prod_{i \in I} \mathbb{G}_{\omega}\right) / \mathcal{U} \cong\left(\prod_{i \in \kappa} \mathbb{G}_{\omega}\right) / \mathcal{U}_{\kappa}$ and by Theorem 2.7 the ultraproduct $\left(\prod_{i \in \kappa} \mathbb{G}_{\omega}\right) / \mathcal{U}_{\kappa}$ is connected, which is false by (iii).

The connectivity relation (and, hence, the components) of a reduced product are described by the following theorem.

Theorem 2.9 (*) If $x=\left\langle x_{i}: i \in I\right\rangle, y=\left\langle y_{i}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$, then

$$
[x]_{\Phi} \sim[y]_{\Phi} \Leftrightarrow \exists n \in \omega \quad\left\{i \in I: \mathbb{X}_{i} \models \varphi_{d \leq n+1}\left[x_{i}, y_{i}\right]\right\} \in \Phi .
$$

Proof. $(\Rightarrow)$ If $[x]_{\Phi} \sim[y]_{\Phi}$, then in $\prod_{\Phi} \mathbb{X}_{i}$ there is a path from $[x]_{\Phi}$ to $[y]_{\Phi}$; namely, there are $n \in \omega, \varepsilon \in 2^{n+1}$ and $z^{0}, \ldots, z^{n-1} \in \prod_{i \in I} X_{i}$ such that we have $[x]_{\Phi} \rho^{\varepsilon_{0}}\left[z^{0}\right]_{\Phi} \rho^{\varepsilon_{1}}\left[z^{1}\right]_{\Phi} \rho^{\varepsilon_{2}} \ldots \rho^{\varepsilon_{n-1}}\left[z^{n-1}\right]_{\Phi} \rho^{\varepsilon_{n}}[y]_{\Phi}$. Since $\Phi$ is closed under finite intersections there is $F \in \Phi$ such that for each $i \in F$ we have $x_{i} \rho_{i}^{\varepsilon_{0}} z_{i}^{0} \rho_{i}^{\varepsilon_{1}}$ $z_{i}^{1} \rho_{i}^{\varepsilon_{2}} \ldots \rho_{i}^{\varepsilon_{n-1}} z_{i}^{n-1} \rho_{i}^{\varepsilon_{n}} y_{i}$. So $F \subset\left\{i \in I: \mathbb{X}_{i} \models \varphi_{d \leq n+1}\left[x_{i}, y_{i}\right]\right\} \in \Phi$.
$(\Leftarrow)$ Let $n \in \omega$ and $A:=\left\{i \in I: \mathbb{X}_{i} \models \varphi_{d \leq n+1}\left[x_{i}, y_{i}\right]\right\} \in \Phi$. If $i \in A$, then there is a path $\langle\bar{z}, \varepsilon\rangle$ of length $n+1$ from $x_{i}$ to $y_{i}$; thus we can choose one such $\varepsilon$. Let $\varepsilon^{k} \in 2^{n+1}, k<l$, be an enumeration of the $n+1$-tuples chosen in this way for $i \in A$. Then defining $A_{\varepsilon^{k}}=\left\{i \in A: \varepsilon^{k}\right.$ is chosen for $x_{i}$ and $\left.y_{i}\right\}$, for $k<l$, we have $A=\bigcup_{k<l} A_{\varepsilon^{k}}$. Let $y^{\prime} \in \prod_{i \in I} X_{i}$, where $y^{\prime} \upharpoonright A=y \upharpoonright A$ and $y^{\prime} \upharpoonright(I \backslash A)=x \upharpoonright(I \backslash A)$. Then $\left[y^{\prime}\right]_{\Phi}=[y]_{\Phi}$. We define sequences $s^{m}=\left\langle s_{i}^{m}: i \in I\right\rangle \in \prod_{i \in I} X_{i}$, for $m \leq l-2$, such that there are $l$-many paths of length ( $n+1$ ) witnessing that $[x]_{\Phi} \sim\left[s^{0}\right]_{\Phi} \sim\left[s^{1}\right]_{\Phi} \sim \ldots \sim\left[s^{l-2}\right]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}$, by

$$
s_{i}^{m}= \begin{cases}x_{i} & \text { if } i \in I \backslash \bigcup_{k \leq m} A_{\varepsilon^{k}},  \tag{21}\\ y_{i} & \text { if } i \in \bigcup_{k \leq m} A_{\varepsilon^{k}} .\end{cases}
$$

Now, $x$ and $s^{0}$ satisfy the assumptions of Fact 2.1] over $A_{\varepsilon^{0}}$; so, $[x]_{\Phi} \sim\left[s^{0}\right]_{\Phi} . s^{0}$ and $s^{1}$ satisfy the assumptions of Fact 2.1 over $A_{\varepsilon^{1}}$; so, $\left[s^{0}\right]_{\Phi} \sim\left[s^{1}\right]_{\Phi}$. Continuing
in this way we have that $s^{l-2}$ and $y^{\prime}$ satisfy the assumptions of Fact 2.1 over $A_{\varepsilon^{l-1}}$; so, $\left[s^{l-2}\right]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}$. Thus we have $[x]_{\Phi} \sim\left[y^{\prime}\right]_{\Phi}=[y]_{\Phi}$.
