# On the geometry of a (q + 1)-arc of PG(3, q), q even

#### Abstract

In PG(3,q),  $q = 2^n$ ,  $n \ge 3$ , let  $\mathcal{A} = \{(1,t,t^{2^h},t^{2^h+1}) \mid t \in \mathbb{F}_q\} \cup \{(0,0,0,1)\}$ , with gcd(n,h) = 1, be a (q+1)-arc and let  $G_h \simeq PGL(2,q)$  be the stabilizer of  $\mathcal{A}$  in PGL(4,q). The  $G_h$ -orbits on points, lines and planes of PG(3,q), together with the point-plane incidence matrix with respect to the  $G_h$ -orbits on points and planes of PG(3,q) are determined. The point-line incidence matrix with respect to the  $G_1$ -orbits on points and lines of PG(3,q) is also considered. In particular, for a line  $\ell$  belonging to a given line  $G_1$ -orbits, say  $\mathcal{L}$ , the point  $G_1$ -orbit distribution of  $\ell$  is either explicitly computed or it is shown to depend on the number of elements x in  $\mathbb{F}_q$  (or in a subset of  $\mathbb{F}_q$ ) such that  $\operatorname{Tr}_{q|2}(g(x)) = 0$ , where g is an  $\mathbb{F}_q$ -map determined by  $\mathcal{L}$ .

**Keywords:** (q + 1)-arc; twisted cubic.

## 1 Introduction

Let PG(3,q) be the three-dimensional projective space over the finite field  $\mathbb{F}_q$  with q elements. A (q+1)-arc of PG(3,q) is a set of q+1 points of PG(3,q) no four in a plane. If  $q = 2^n$ , a (q+1)-arc of PG(3,q) is projectively equivalent to the pointset

$$\mathcal{A} = \{ P_t = (1, t, t^{2^n}, t^{2^n + 1}) \mid t \in \mathbb{F}_q \} \cup \{ (0, 0, 0, 1) \},$$
(1.1)

where gcd(n,h) = 1. If h = 1, then  $\mathcal{A}$  is called *twisted cubic* and if q is odd every (q + 1)-arc of PG(3,q) is a *twisted cubic*. Moreover  $\mathcal{A}$  and  $\{(1,t,t^{2^{n-h}},t^{2^{n-h}+1}) \mid t \in \mathbb{F}_q\} \cup \{(0,0,0,1)\}$ are projectively equivalent. The subgroup of PGL(4,q) stabilizing  $\mathcal{A}$ , say  $G_h$ , is isomorphic to PGL(2,q) whenever q > 4, and contains a subgroup isomorphic to PGL(2,q) if  $q \leq 4$ . For more details on (q + 1)-arcs of PG(3,q) the reader is referred to [9, Chapter 21].

Several authors dealt with the action of the group  $G_1$  on points, lines and planes of PG(3, q)and the determination of their related incidence matrices. Indeed, a comprehensive understanding of this topic is of some interest in purely geometric terms [4, 5, 6, 7]; in particular the classification of  $G_1$ -orbits on lines of PG(3, q) is equivalent to the classification of pencils of cubics in PG(1, q), see [8]. Moreover aspects of these problems are related and have been applied in coding theory in order to obtain asymptotically optimal multiple covering codes [1], or to study

the weight distribution of the cosets of C [3], or to compute the coset leader weight enumerator of C [2], where C is the generalized Reed-Solomon code associated with a twisted cubic.

In this paper we assume  $q = 2^n$ . In Section 3, we show that, similarly to the case h = 1, the group  $G_h$  has five orbits on points on PG(3,q) and that the point-plane incidence matrix with respect to the  $G_h$ -orbits on points and planes of PG(3,q) mirrors the case h = 1, which was computed in [1]. If  $q \not\equiv 0 \pmod{3}$ , the group  $G_h$  fixes a symplectic polarity of PG(3,q) and hence to each  $G_h$ -orbit on points there corresponds a  $G_h$ -orbit on planes of PG(3,q).

In Section 4, we show that the group  $G_h$  has  $2q + 7 + \xi$  orbits on lines of PG(3,q), providing a proof of [7, Conjecture 8.2] in the even characteristic case. Finally the point-line incidence matrix with respect to the  $G_1$ -orbits on points and lines of PG(3,q) is considered. For a line  $\ell$ belonging to a given line  $G_1$ -orbits, say  $\mathcal{L}$ , the point  $G_1$ -orbit distribution of  $\ell$  is either explicitly computed or it is shown to depend on the number of elements x in  $\mathbb{F}_q$  (or in a subset of  $\mathbb{F}_q$ ) such that  $\operatorname{Tr}_{q|2}(g(x)) = 0$ , where g is an  $\mathbb{F}_q$ -map determined by  $\mathcal{L}$ .

## 2 Preliminaries

Let  $q = 2^n$  and let  $\mathbb{F}_q$  be the finite field of order q. Let PG(3,q) be the three-dimensional projective space over  $\mathbb{F}_q$  equipped with homogeneous projective coordinates  $(X_1, X_2, X_3, X_4)$ . Denote by  $U_i$  the point having 1 in the *i*-th position and 0 elsewhere.

Let  $\mathcal{W}(3,q)$  be the symplectic polar space consisting of the subspaces of  $\mathrm{PG}(3,q)$  represented by the totally isotropic subspaces of  $\mathbb{F}_q^4$  with respect to the non-degenerate alternating form  $\beta$ given by

$$x_1y_4 + x_2y_3 + x_3y_2 + x_4y_1.$$

The subspaces of  $\mathcal{W}(3,q)$  of maximum dimension are lines and are called *generators*. Denote by  $\mathfrak{s}$  the symplectic polarity of  $\mathrm{PG}(3,q)$  defining  $\mathcal{W}(3,q)$ .

Let h be a positive integer such that gcd(h, n) = 1 and consider the (q + 1)-arc of PG(3, q)given by (1.1). This means that  $\mathcal{A}$  consists of q + 1 points of PG(3, q) such that no four of them are coplanar. For h = 1 or h = n - 1,  $\mathcal{A}$  is a twisted cubic of PG(3, q). A line of PG(3, q) joining two distinct points of  $\mathcal{A}$  is called a *real chord*. Let  $\overline{\mathcal{A}}$  be given by

$$\{ \bar{P}_t = (1, t, t^{2^h}, t^{2^h+1}) \mid t \in \mathbb{F}_{q^2} \} \cup \{ U_4 \}$$
 if *h* is odd,  
 
$$\{ \bar{P}_t = (1, t, t^{2^{n+h}}, t^{2^{n+h}+1}) \mid t \in \mathbb{F}_{q^2} \} \cup \{ U_4 \}$$
 if *h* is even. (2.1)

It holds that  $\overline{\mathcal{A}}$  is a  $(q^2 + 1)$ -arc of  $\mathrm{PG}(3, q^2)$  and  $\mathcal{A}$  is embedded in  $\overline{\mathcal{A}}$ . The line of  $\mathrm{PG}(3, q^2)$  obtained by joining  $\overline{P}_t$  and  $\overline{P}_{t^q}$ , with  $t \in \mathbb{F}_{q^2} \setminus \mathbb{F}_q$ , meets the canonical Baer subgeometry  $\mathrm{PG}(3, q)$  in the q + 1 points of a line skew to  $\mathcal{A}$ . Such a line is called an *imaginary chord*. If r is a (real or imaginary) chord, then the line  $r^{\mathfrak{s}}$  is called (*real or imaginary*) axis. For each point  $P \in \mathcal{A}$ , the tangent line to  $\mathcal{A}$  at P is the line  $\ell_P = \langle P, P' \rangle$ , with  $P' = (0, 1, 0, t^{2^h})$  if  $P = P_t$  and  $P' = U_3$  if  $P = U_4$ . At each point  $P_t$  (resp.  $U_4$ ) of  $\mathcal{A}$  there corresponds the osculating plane  $P_t^{\mathfrak{s}}$  (resp.  $U_4^{\mathfrak{s}}$ ) with equation  $t^{2^h+1}X_1 + t^{2^h}X_2 + tX_3 + X_4 = 0$  (resp.  $X_1 = 0$ ), meeting  $\mathcal{A}$  only at  $P_t$  (resp.  $U_4$ ) and containing the tangent line  $\ell_{P_t}$  (resp.  $\ell_{U_4}$ ). Hence the q+1 lines tangent to  $\mathcal{A}$  are generators

of  $\mathcal{W}(3,q)$  and they form a regulus of the hyperbolic quadric  $\mathcal{Q}^+(3,q)$ :  $X_1X_4 + X_2X_3 = 0$ . There are q(q+1)/2 real chords and q(q-1)/2 imaginary chords. Tangents, real chords and imaginary chords are all the chords of  $\mathcal{A}$ .

The group  $G_h$  of projectivities of PG(3, q) stabilizing  $\mathcal{A}$  is isomorphic to PGL(2, q) whenever  $q \geq 5$ , and the elements of  $G_h$  are represented by the matrices

$$M_{a,b,c,d} = \begin{pmatrix} a^{2^{h}+1} & a^{2^{h}}b & ab^{2^{h}} & b^{2^{h}+1} \\ a^{2^{h}}c & a^{2^{h}}d & b^{2^{h}}c & b^{2^{h}}d \\ ac^{2^{h}} & bc^{2^{h}} & ad^{2^{h}} & bd^{2^{h}} \\ c^{2^{h}+1} & c^{2^{h}}d & cd^{2^{h}} & d^{2^{h}+1} \end{pmatrix},$$

where  $a, b, c, d \in \mathbb{F}_q$  and ad+bc = 1. This group leaves  $\mathcal{W}(3, q)$  invariant, being  $M_{a,b,c,d}^t J M_{a,b,c,d} = J$ , where

$$J = \begin{pmatrix} 0 & 0 & 0 & 1 \\ 0 & 0 & 1 & 0 \\ 0 & 1 & 0 & 0 \\ 1 & 0 & 0 & 0 \end{pmatrix}$$

is the Gram matrix of  $\beta$ . We will denote by  $\overline{G}_h$  or  $\overline{G}_{n+h}$  the subgroup of PGL(4,  $q^2$ ) fixing  $\overline{A}$ , depending on h is odd or even. In both cases their elements are represented by the matrices  $M_{a,b,c,d}$ , with  $a, b, c, d \in \mathbb{F}_{q^2}$  and ad + bc = 1. For more properties on (q + 1)-arcs in even characteristic, we refer the readers to [9, Section 21.3].

### 3 Point orbits

In this section, we study the orbits on points and planes under the action of  $G_h$ . We start by proving that each point of  $PG(3,q) \setminus A$  lies on exactly one chord of A, similarly to the case  $h \in \{1, n-1\}$ , see [9, Theorem 21.1.9].

**Proposition 3.1.** Every point of  $PG(3,q) \setminus A$  lies on exactly one chord of A.

*Proof.* The points on tangent lines form the hyperbolic quadric  $Q^+(3,q)$  and they are  $(q+1)^2$  in number.

If two real chords meet, then their intersection point belongs to  $\mathcal{A}$ . Indeed, assume by contradiction that s, s' are two real chords which meet in a point  $P \notin \mathcal{A}$ , then these two lines generate a plane containing four points of  $\mathcal{A}$ , contradicting the fact that  $\mathcal{A}$  is a (q + 1)-arc. Every real chord has q - 1 points not in common with  $\mathcal{A}$  and a real chord meets  $\mathcal{Q}^+(3,q)$  in points of  $\mathcal{A}$ . Since there are q(q+1)/2 real chords, it follows that there are  $(q^3 - q)/2$  points of PG(3,q) \  $\mathcal{A}$ lying on real chords.

An imaginary chord of  $\mathcal{A}$ , when extended in  $\mathrm{PG}(3,q^2)$ , meets  $\overline{\mathcal{A}} \setminus \mathcal{A}$  in two points. Hence, two imaginary chords or a real chord and an imaginary one cannot meet outside  $\mathcal{A}$ , otherwise, when extended in  $\mathrm{PG}(3,q^2)$ , they would span a plane of  $\mathrm{PG}(3,q^2)$  containing four points of  $\overline{\mathcal{A}}$ , a contradiction. Let  $\mathcal{Q}^+(3,q^2)$  denote the hyperbolic quadric of  $\mathrm{PG}(3,q^2)$  such that  $\mathcal{Q}^+(3,q^2) \cap$  $\mathrm{PG}(3,q) = \mathcal{Q}^+(3,q)$ . It is easily seen that an imaginary chord meets  $\mathcal{Q}^+(3,q^2)$  in points of  $\overline{\mathcal{A}} \setminus \mathcal{A}$ . Hence an imaginary chord has empty intersection with  $\mathcal{Q}^+(3,q)$ . Since there are q(q-1)/2imaginary chords, there are  $(q^3 - q)/2$  points of  $\mathrm{PG}(3,q) \setminus \mathcal{A}$  lying on imaginary chords. **Proposition 3.2.** The group  $G_h$  has five orbits on points of PG(3,q):

- $\mathcal{A}$  of size q + 1;
- $\mathcal{O}_0$  of size  $(q^3 q)/3$ , consisting of points not contained in any osculating plane;
- $\mathcal{O}_1$  of size  $(q^3 q)/2$ , consisting of points on exactly one osculating plane;
- $\mathcal{O}_2 = \mathcal{Q}^+(3,q) \setminus \mathcal{A}$  of size  $q^2 + q$ , consisting of points on exactly two osculating planes;
- $\mathcal{O}_3$  of size  $(q^3 q)/6$ , consisting of points on exactly three osculating planes.

*Proof.* Taking into account Proposition 3.1, it is enough to determine the orbits of G on points of  $PG(3,q) \setminus \mathcal{A}$  lying on chords of  $\mathcal{A}$ . Moreover the group  $G_h$  acts transitively on tangent lines, real chords and imaginary chords of  $\mathcal{A}$ . Let  $\ell$  be a chord of  $\mathcal{A}$ .

If  $\ell$  is tangent we choose  $\ell = \langle U_1, U_2 \rangle$  and consider the point  $U_2 \in \ell \setminus \mathcal{A}$ . The projectivities of  $G_h$  stabilizing  $U_2$  are represented by the matrices  $M_{d^{-1},0,0,d}$ ,  $d \in \mathbb{F}_q \setminus \{0\}$ . Hence  $|Stab_{G_h}(U_2)| = q - 1$  and  $|U_2^{G_h}| = q^2 + q = |\mathcal{Q}^+(3,q) \setminus \mathcal{A}|$ . The point  $U_2$  belongs to  $U_1^{\mathfrak{s}}$  and  $U_4^{\mathfrak{s}}$  and to no other osculating plane.

If  $\ell$  is a real chord, we consider  $\ell = \langle U_1, U_4 \rangle$ . The stabilizer of  $\ell$  in  $G_h$  has order 2(q-1)and it is generated by the projectivities represented by the matrices  $M_{0,1,1,0}$  and  $M_{d^{-1},0,0,d}$ ,  $d \in \mathbb{F}_q \setminus \{0\}$ . Let  $x \in \mathbb{F}_q \setminus \{0\}$  and let  $Q = U_1 + xU_4 \in \ell \setminus \mathcal{A}$ . We will prove that

$$|Stab_{G_h}(Q)| = \begin{cases} 2 & \text{if } q \equiv -1 \pmod{3}, \\ 3 & \text{if } q \equiv 1 \pmod{3} \text{ and } x \text{ is not a cube in } \mathbb{F}_q, \\ 6 & \text{if } q \equiv 1 \pmod{3} \text{ and } x \text{ is a cube in } \mathbb{F}_q. \end{cases}$$

A projectivity represented by  $M_{d^{-1},0,0,d}$  fixes Q if and only if  $d^{2^{h}+1} = 1$  which has  $gcd(2^{h} + 1, 2^{n} - 1)$  solutions. Since

$$gcd(2^{h}+1,2^{n}-1) = \begin{cases} 3 & \text{if } n \text{ is even,} \\ 1 & \text{if } n \text{ is odd,} \end{cases}$$

the number of these projectivities fixing Q equals three or one according as  $q \equiv 1 \text{ or } -1 \pmod{3}$ , respectively. Similarly, a projectivity represented by  $M_{0,d^{-1},d,0}$  fixes Q if and only if

$$d^{2^{h}+1} = x. (3.1)$$

Equation (3.1) admits a solution if and only if  $x^{\frac{2^n-1}{\gcd(2^h+1,2^n-1)}} = 1$  and in that case it has  $\gcd(2^h + 1, 2^n - 1)$  solutions. Therefore, if  $q \equiv 1 \pmod{3}$ , the number of these projectivities fixing Q is three or zero according as x is a cube in  $\mathbb{F}_q$  or not, whereas if  $q \equiv -1 \pmod{3}$  exactly one of these projectivities leaves Q invariant. The point Q belongs to the osculating plane  $P_t^{\mathfrak{s}}$  if and only if  $t^{2^h+1} = x$ . Hence it lies on one osculating plane if  $q \equiv -1 \pmod{3}$ , whereas if  $q \equiv 1 \pmod{3}$  on three or none osculating planes according as x is a cube or not in  $\mathbb{F}_q$ .

If  $\ell$  is an imaginary chord, we consider the  $(q^2 + 1)$ -arc  $\overline{A}$  of PG(3,  $q^2$ ) given by (2.1) and the non-canonical Baer subgeometry  $\Sigma$ 

$$\{(\alpha, \beta, \beta^q, \alpha^q) : \alpha, \beta \in \mathbb{F}_{q^2}, (\alpha, \beta) \neq (0, 0)\}.$$

Some straightforward computations show that the intersection of  $\bar{\mathcal{A}}$  with  $\Sigma$  is the (q+1)-arc of  $\Sigma$  consisting of the points  $\bar{P}_t$ ,  $t \in \mathbb{F}_{q^2}$ ,  $t^{q+1} = 1$ . The projectivities fixing  $\bar{\mathcal{A}} \cap \Sigma$  belong to  $\bar{G}_h$ , if h is odd, or to  $\bar{G}_{n+h}$ , if h is even, and are those represented by the matrices  $M_{a,b,c,d}$  with  $a, b, c, d \in \mathbb{F}_{q^2}$ , ad + bc = 1,  $cd^q + ab^q = 0$  and  $a^{q+1} + b^{q+1} + c^{q+1} + d^{q+1} = 0$ . Denote by S the group  $Stab_{\bar{G}_h}(\Sigma)$  if h is odd or  $Stab_{\bar{G}_{n+h}}(\Sigma)$  if h is even. Note that  $G_h$  and S are conjugated in  $\bar{G}_h$  or  $\bar{G}_{n+h}$ . In this setting,  $\ell = \langle U_1, U_4 \rangle_{q^2} \cap \Sigma$  is an imaginary chord of  $\bar{\mathcal{A}} \cap \Sigma$ . The stabilizer of  $\ell$  in S has order 2(q+1) and it is generated by the projectivities represented by the matrices  $M_{0,1,1,0}$  and  $M_{d^{-1},0,0,d}$ ,  $d \in \mathbb{F}_{q^2}$ , with

$$d^{2^n+1} = 1. (3.2)$$

Fix  $\alpha \in \mathbb{F}_{q^2} \setminus \{0\}$  and set  $R = U_1 + \alpha^{q-1}U_4 \in \ell$ . We show that

$$|Stab_S(R)| = \begin{cases} 2 & \text{if } q \equiv 1 \pmod{3}, \\ 3 & \text{if } q \equiv -1 \pmod{3} \text{ and } \alpha^{q-1} \text{ is not a cube in } \mathbb{F}_{q^2}, \\ 6 & \text{if } q \equiv -1 \pmod{3} \text{ and } \alpha^{q-1} \text{ is a cube in } \mathbb{F}_{q^2}. \end{cases}$$

A projectivity represented by  $M_{d^{-1},0,0,d}$  fixes R if and only if

$$d^{2^{h+1}} = 1 \qquad \text{if } h \text{ is odd},$$
  

$$d^{2^{n+h}+1} = 1 \qquad \text{if } h \text{ is even}.$$
(3.3)

Let  $\bar{\omega}$  be a primitive element of  $\mathbb{F}_{q^2}$  and set  $d = \bar{\omega}^i$ . Since  $gcd(2^h + 1, 2^{2n} - 1) = 3$  if h is odd and  $gcd(2^{n+h} + 1, 2^{2n} - 1) = 3$  if h is even, equation (3.3) is satisfied by

$$i \equiv \frac{t(2^{2n}-1)}{3} \pmod{2^{2n-1}}, t = 0, 1, 2.$$

If  $q \equiv -1 \pmod{3}$ , these three solutions satisfy (3.2), whereas if  $q \equiv 1 \pmod{3}$ , the unique solution fulfilling (3.2) occurs for t = 0. Therefore there are three or one of these projectivities stabilizing R depending on  $q \equiv -1$  or 1 (mod 3), respectively. Similarly, a projectivity represented by  $M_{0,d^{-1},d,0}$  fixes R if and only if

$$d^{-(2^{h}+1)} = \alpha^{q-1} \quad \text{if } h \text{ is odd}, d^{-(2^{n+h}+1)} = \alpha^{q-1} \quad \text{if } h \text{ is even.}$$
(3.4)

In this case, if  $\alpha = \bar{\omega}^k$ , equation (3.4) admits a solution if and only if 3 divides  $k(2^n - 1)$ . Assume that 3 divides  $k(2^n - 1)$ , then (3.4) has the three solutions

$$i \equiv \frac{-k(2^n - 1)u_0 + t(2^{2n} - 1)}{3} \pmod{2^{2n-1}}, t = 0, 1, 2,$$

where  $u_0$  is an integer such that  $(2^h + 1)u_0 + (2^{2n} - 1)v_0 = 3$ , if h is odd and  $(2^{n+h} + 1)u_0 + (2^{2n} - 1)v_0 = 3$ , if h is even. If  $q \equiv -1 \pmod{3}$ , these three solutions satisfy (3.2), whereas if  $q \equiv 1 \pmod{3}$ , exactly one of these three solutions satisfies (3.2). It follows that, if  $q \equiv -1 \pmod{3}$ , the number of these projectivities fixing R is three or zero according as  $\alpha^{q-1}$  is a cube in  $\mathbb{F}_{q^2}$  or not, whereas if  $q \equiv 1 \pmod{3}$  exactly one of these projectivities leaves invariant R. The point R belongs to the osculating plane  $\overline{P}_t^{\mathfrak{s}}$  if and only if

$$t^{2^{h+1}} = \alpha^{q-1}$$
 if *h* is odd,  
$$t^{2^{n+h}+1} = \alpha^{q-1}$$
 if *h* is even

for some  $t \in \mathbb{F}_{q^2}$ , with  $t^{q+1} = 1$ . Hence it lies on one osculating plane if  $q \equiv 1 \pmod{3}$ , whereas if  $q \equiv -1 \pmod{3}$  on three or none osculating planes according as  $\alpha^{q-1}$  is a cube or not in  $\mathbb{F}_{q^2}$ .

**Corollary 3.3.** If  $q \equiv 1 \pmod{3}$ , the points of  $\mathcal{A} \cup \mathcal{O}_0 \cup \mathcal{O}_3$  are on the real chords and those of  $\mathcal{O}_1$  on the imaginary chords. If  $q \equiv -1 \pmod{3}$ , the points of  $\mathcal{O}_0 \cup \mathcal{O}_3$  are on the imaginary chords and those of  $\mathcal{A} \cup \mathcal{O}_1$  on the real chords.

The  $G_h$ -orbits on planes of  $\mathrm{PG}(3,q)$  can be described by using the symplectic polarity  $\mathfrak{s}$  of  $\mathrm{PG}(3,q)$  defining  $\mathcal{W}(3,q)$ . Let  $\mathcal{O}_j^{\mathfrak{s}} = \{P^{\mathfrak{s}} \mid P \in \mathcal{O}_j\}.$ 

**Proposition 3.4.** The group  $G_h$  has five orbits on planes of PG(3,q):

- The q + 1 osculating planes;
- $\mathcal{O}_0^{\mathfrak{s}}$  of size  $(q^3 q)/3$ , consisting of planes containing no point of  $\mathcal{A}$ ;
- $\mathcal{O}_1^{\mathfrak{s}}$  of size  $(q^3 q)/2$ , consisting of planes containing one point of  $\mathcal{A}$ ;
- $\mathcal{O}_2^{\mathfrak{s}}$  of size  $q^2 + q$ , consisting of planes containing two points of  $\mathcal{A}$ ;
- $\mathcal{O}_3^{\mathfrak{s}}$  of size  $(q^3 q)/6$ , consisting of planes containing three point of  $\mathcal{A}$ .

#### 3.1 Point plane distribution

In the case when  $\mathcal{A}$  is a twisted cubic, the point plane distribution has been determined in [1]. Most of the combinatorial arguments used in [1] can be adapted to the general case of a (q+1)-arc  $\mathcal{A}$ . Set  $\mathcal{O}_{q+1} = \mathcal{A}$ . Denote by  $r_{i,j}$  the number of planes in  $\mathcal{O}_j^{\mathfrak{s}}$  through a point in  $\mathcal{O}_i$  and by  $k_{i,j}$  the number of points of  $\mathcal{O}_i$  in a plane of  $\mathcal{O}_j^{\mathfrak{s}}$ . Hence

$$|\mathcal{O}_i|r_{i,j} = |\mathcal{O}_j^{\mathfrak{s}}|k_{i,j}. \tag{3.5}$$

Note that

$$r_{0,q+1} = 0, \ r_{q+1,q+1} = r_{1,q+1} = 1, \ r_{2,q+1} = 2, \ r_{3,q+1} = 3,$$

by Proposition 3.2. Since a plane meets  $\mathcal{A}$  in at most three points, taking into account Proposition 3.1, the following results can be easily deduced.

**Lemma 3.5.** Through a real chord of  $\mathcal{A}$  there pass q-1 planes of  $\mathcal{O}_3^{\mathfrak{s}}$  and two planes of  $\mathcal{O}_2^{\mathfrak{s}}$ , whereas through an imaginary chord of  $\mathcal{A}$  there pass q+1 planes of  $\mathcal{O}_1^{\mathfrak{s}}$ .

Lemma 3.6. The following hold.

- 1)  $r_{i,q+1} + r_{i,1} + 2r_{i,2} + 3r_{i,3} = (q+1)^2, i \in \{0, 1, 2, 3\}.$
- 2) For  $q \equiv 1 \pmod{3}$ , it holds

$$r_{2,2} + 3r_{2,3} = r_{1,2} + 3r_{1,3} = \frac{q(q+1)}{2},$$
  
$$r_{0,2} + 3r_{0,3} = r_{3,2} + 3r_{3,3} = \frac{q(q+3)}{2}.$$

3) For  $q \equiv -1 \pmod{3}$ , it holds

$$r_{2,2} + 3r_{2,3} = r_{0,2} + 3r_{0,3} = r_{3,2} + 3r_{3,3} = \frac{q(q+1)}{2},$$
  
$$r_{1,2} + 3r_{1,3} = \frac{q(q+3)}{2}.$$

*Proof.* To prove 1), let P be a point of  $PG(3,q) \setminus A$  and let us count in two ways the pairs  $(Q, \sigma)$ , where Q is a point of A,  $\sigma$  is a plane and the line  $\langle P, Q \rangle$  is contained in  $\sigma$ . The point Q can be chosen in q + 1 ways and for a fixed Q there are q + 1 planes containing both P and Q. Hence on the one hand there are  $(q + 1)^2$  pairs. On the other hand, if  $P \in \mathcal{O}_i$ , where  $i \in \{0, 1, 2, 3\}$ , then the number of these pairs equals  $r_{i,q+1} + r_{i,1} + 2r_{i,2} + 3r_{i,3}$ .

In order to show 2) and 3), by Corollary 3.3, it is enough to verify that

$$r_{i,2} + 3r_{i,3} = \begin{cases} \frac{q(q+1)}{2} & \text{if } \mathcal{O}_i \text{ consists of points not on real chords,} \\ \frac{q(q+3)}{2} & \text{if } \mathcal{O}_i \text{ consists of points off } \mathcal{A} \text{ on real chords.} \end{cases}$$

Let P be a point of  $PG(3,q) \setminus A$  and let us count in two ways the pairs  $(\ell, \sigma)$ , where  $\ell$  is a real chord,  $P \notin \ell$  and  $\sigma = \langle P, \ell \rangle$  is a plane such that  $|\sigma \cap A| \in \{2,3\}$ . If P does not belong to any real chord, then each of the q(q+1)/2 real chords gives rise to a plane  $\sigma$  which contains either one or three real chords. Hence equation  $r_{i,2} + 3r_{i,3} = q(q+1)/2$  follows. If P belongs to the real chord r, then each of the q(q+1)/2 - 1 real chords distinct from r spans with P a plane  $\sigma$ . By Lemma 3.5, among these planes there are q-1 of them which contain precisely two chords distinct from r. Therefore in this case

$$(r_{i,2}-2) + 3(r_{i,3}-(q-1)) + 2(q-1) = \frac{q(q+1)}{2} - 1$$

holds true and equation  $r_{i,2} + 3r_{i,3} = q(q+3)/2$  follows.

Proposition 3.7.

$$r_{q+1,d} = \begin{cases} 1 & \text{if } d = q+1, \\ 0 & \text{if } d = 0, \\ \frac{q(q-1)}{2} & \text{if } d \in \{1,3\}, \\ 2q & \text{if } d = 2. \end{cases}$$

Proof. The value  $r_{q+1,0}$ , is easily determined. Through a point  $Q \in \mathcal{A}$  there are q real chords. By Lemma 3.5, through a real chord there pass two planes of  $\mathcal{O}_2^{\mathfrak{s}}$  and q-1 planes of  $\mathcal{O}_3^{\mathfrak{s}}$ . Therefore  $r_{q+1,2} = 2q$  and  $r_{q+1,3} = q(q-1)/2$ , since a plane of  $\mathcal{O}_3$  contains two real chords through Q. Finally  $r_{q+1,1} = q^2 + q + 1 - (1 - 2q - q(q-1)/2) = q(q-1)/2$ .

**Proposition 3.8.** If  $q \equiv \xi \pmod{3}$ ,  $\xi \in \{\pm 1\}$ , then

$$r_{1,d} = \begin{cases} 1 & \text{if } d = q + 1, \\ \frac{q(q-\xi)}{3} & \text{if } d = 0, \\ \frac{q(q+\xi)}{2} & \text{if } d = 1, \\ q & \text{if } d = 2, \\ \frac{q(q-\xi)}{6} & \text{if } d = 3. \end{cases} \qquad r_{2,d} = \begin{cases} 2 & \text{if } d = q + 1, \\ \frac{q^2-1}{3} & \text{if } d = 0, \\ \frac{q(q-1)}{2} & \text{if } d = 1, \\ 2q - 1 & \text{if } d = 2, \\ \frac{q^2-3q+2}{6} & \text{if } d = 3. \end{cases}$$

Proof. By Corollary 3.3, if  $q \equiv 1 \pmod{3}$  (or  $q \equiv -1 \pmod{3}$ ),  $\mathcal{O}_1$  consists of the points on imaginary chords (or, together with  $\mathcal{A}$ , of the points on real chords). On the other hand, by Lemma 3.5, a plane  $\sigma$  in  $\mathcal{O}_0^{\mathfrak{s}}$  does not contain any imaginary (or real) chord and hence each of the q(q-1)/2 (or q(q+1)/2) imaginary (or real) chords of  $\mathcal{A}$  has exactly one point in common with  $\sigma$ . It follows that Equation 3.5 reads as  $\frac{q(q^2-1)}{2}r_{1,0} = \frac{q(q^2-1)}{3}\frac{q(q-\xi)}{2}$  and therefore  $r_{1,0} = q(q-\xi)/3$ . As a consequence we have that  $1 + r_{1,1} + r_{1,2} + r_{1,3} = q^2 + q + 1 - q(q-\xi)/3 = (2q^2 + (3+\xi)q+3)/3$ , which combined with Lemma 3.6 1), 2) (or Lemma 3.6 1), 3)), gives the required values of  $r_{1,1}, r_{1,2}, r_{1,3}$ .

Analogously, no tangent line is contained in a plane  $\sigma$  of  $\mathcal{O}_0^{\mathfrak{s}}$  and hence each of the q+1 tangent lines has exactly one point in common with  $\sigma$ . In this case Equation 3.5 becomes as  $q(q+1)r_{2,0} = \frac{q(q^2-1)}{3}(q+1)$  and therefore  $r_{2,0} = (q^2-1)/3$ . Moreover,  $2 + r_{2,1} + r_{2,2} + r_{2,3} = q^2 + q + 1 - (q^2-1)/3 = (2q^2 + 3q + 4)/3$ , which together with Lemma 3.6 1), 2), 3) provides the values of  $r_{2,1}, r_{2,2}, r_{2,3}$ .

**Proposition 3.9.** If  $q \equiv \xi \pmod{3}$ ,  $\xi \in \{\pm 1\}$ , then

$$r_{0,d} = \begin{cases} 0 & \text{if } d = q + 1, \\ \frac{q^2 + \xi q + 1}{3} & \text{if } d = 0, \\ \frac{q(q - \xi)}{2} & \text{if } d = 1, \\ q + 1 & \text{if } d = 2, \\ \frac{q^2 + \xi q - 2}{6} & \text{if } d = 3. \end{cases} \qquad r_{3,d} = \begin{cases} 3 & \text{if } d = q + 1, \\ \frac{q^2 + \xi q - 2}{3} & \text{if } d = 0, \\ \frac{q(q - \xi)}{2} & \text{if } d = 1, \\ q - 2 & \text{if } d = 2, \\ \frac{q^2 + \xi q + 4}{6} & \text{if } d = 3. \end{cases}$$

Proof. First we determine  $r_{3,3}$  and  $r_{0,3}$ . Fix a plane  $\sigma$  in  $\mathcal{O}_3^5$  and let us count in two ways the pairs  $(Q, \gamma)$ , where Q is a point,  $\gamma$  is an osculating plane and  $Q \in \sigma \cap \gamma$ . Since there are q + 1 osculating planes and for each of these planes there are q + 1 choices for the point Q, we have  $(q + 1)^2$  of such pairs. On the other hand,  $\sigma$  contains 3 points of  $\mathcal{A}$ ,  $q(q - \xi)/2$  points of  $\mathcal{O}_1$ , q - 2 points of  $\mathcal{O}_2$  and  $k_{3,3}$  points of  $\mathcal{O}_3$ . It follows that

$$1 \times 3 + 1 \times \frac{q(q-\xi)}{2} + 2 \times (q-2) + 3 \times k_{3,3} = (q+1)^2$$

Therefore  $k_{3,3} = (q^2 + \xi q + 4)/6$  and  $k_{0,3} = q^2 + q + 1 - 3 - q(q - \xi)/2 - (q - 2) - (q^2 + \xi q + 4)/6 = (q^2 + \xi q - 2)/3$ . By using Equation (3.5), we get  $r_{3,3} = (q^2 + \xi q + 4)/6$  and  $r_{0,3} = (q^2 + \xi q - 2)/6$ .

Next, the values  $r_{0,2}$ ,  $r_{3,2}$  can be recovered from Lemma 3.6 2), 3),  $r_{0,1}$ ,  $r_{3,1}$  from Lemma 3.6 1) and  $r_{0,0}$ ,  $r_{3,0}$  by difference.

The results so obtained are summarized in Tables 1 and 2, where  $q \equiv \xi \pmod{3}$ ,  $\xi \in \{\pm 1\}$ .

# 4 Line orbits

In this section we determine the orbits of  $G_h$  on the lines of PG(3,q). In order to do that we consider the Plücker correspondence, which sends the lines of PG(3,q) to the points of the Klein quadric

$$\mathcal{Q}^+(5,q): X_1X_6 + X_2X_5 + X_3X_4 = 0.$$

Under this embedding, the q + 1 lines tangent to  $\mathcal{A}$  are mapped to the q + 1 points of the conic

$$\mathcal{X} = \pi \cap \mathcal{Q}^+(5,q) = \{(1,0,t,t,0,t^2) \mid t \in \mathbb{F}_q\} \cup \{(0,0,0,0,0,1)\},\$$

whereas the lines of the opposite regulus of  $\mathcal{Q}^+(3,q)$  are mapped to the points of the conic

$$\mathcal{X}' = \pi^{\perp} \cap \mathcal{Q}^+(5,q) = \{(0,1,t,t,t^2,0) \mid t \in \mathbb{F}_q\} \cup \{(0,0,0,0,1,0)\}.$$

Here  $\pi$  denotes the plane  $X_2 = X_5 = X_3 + X_4 = 0$  and  $\perp$  is the polarity of PG(5, q) associated with  $\mathcal{Q}^+(5,q)$ . The  $(q+1)(q^2+1)$  generators of  $\mathcal{W}(3,q)$  are sent to the points of the parabolic quadric  $\mathcal{Q}(4,q) = \mathcal{Q}^+(5,q) \cap \Pi$ , where  $\Pi : X_3 + X_4 = 0$ . Moreover, under the Plücker map, points of  $\mathcal{W}(3,q)$  correspond to lines of  $\mathcal{Q}(4,q)$  and, hence, if  $\ell$  is a line of PG(3,q) that is not a generator of  $\mathcal{W}(3,q)$ , then  $\ell$  and  $\ell^{\perp}$  are mapped to the two reguli of a hyperbolic quadric contained in  $\mathcal{Q}(4,q)$ . To the group  $G_h$ , there corresponds a group  $\tilde{G}_h \leq \text{PGO}^+(6,q)$  represented by the matrices

$$\tilde{M}_{a,b,c,d} = \begin{pmatrix} a^{2^{h+1}} & 0 & a^{2^{h}}b^{2^{h}} & a^{2^{h}}b^{2^{h}} & 0 & b^{2^{h+1}} \\ 0 & a^{2} & ab & ab & b^{2} & 0 \\ a^{2^{h}}c^{2^{h}} & ac & b^{2^{h}}c^{2^{h}} + bc + 1 & b^{2^{h}}c^{2^{h}} + bc & bd & b^{2^{h}}d^{2^{h}} \\ a^{2^{h}}c^{2^{h}} & ac & b^{2^{h}}c^{2^{h}} + bc & b^{2^{h}}c^{2^{h}} + bc + 1 & bd & b^{2^{h}}d^{2^{h}} \\ 0 & c^{2} & cd & cd & d^{2} & 0 \\ c^{2^{h+1}} & 0 & c^{2^{h}}d^{2^{h}} & c^{2^{h}}d^{2^{h}} & 0 & d^{2^{h+1}} \end{pmatrix}$$

with  $a, b, c, d \in \mathbb{F}_q$ , ad + bc = 1. Note that the group  $\tilde{G}_h$  acts faithfully on both planes  $\pi$  and  $\pi^{\perp}$ . Hence  $\tilde{G}_h$  induces on  $\pi$  (or  $\pi^{\perp}$ ) a group isomorphic to PGL(2, q) acting in its natural representation on the q + 1 point of  $\mathcal{X}$  (or  $\mathcal{X}'$ ). Furthermore, the group  $\tilde{G}_h$  fixes the parabolic quadric  $\mathcal{Q}(4, q)$ , each of the two conics  $\mathcal{X}$  and  $\mathcal{X}'$  and the hypersurface  $\mathcal{Y}$  of  $\Pi$ :

$$\mathcal{Y} = \{ P \in \Pi \mid F_h(P) = 0 \},\$$

where

$$F_h(X_1, X_2, X_3, X_4, X_5, X_6) = X_1 X_5^{2^h} + X_2^{2^h} X_6.$$

The hypersurface  $\mathcal{Y}$  consists of q + 1 planes through the point  $\Pi^{\perp} = (0, 0, 1, 1, 0, 0)$ . Each of these planes intersects  $\mathcal{Q}(4, q)$  in exactly one of the following q + 1 lines

$$\langle (0, 1, x, x, x^2, 0), (1, 0, x^{2^h}, x^{2^h}, 0, x^{2^{h+1}}) \rangle, x \in \mathbb{F}_q, \langle (0, 0, 0, 0, 1, 0), (0, 0, 0, 0, 0, 1) \rangle.$$

These q + 1 lines are obtained by joining a point of  $\mathcal{X}$  and a point of  $\mathcal{X}'$ ; they are pairwise disjoint and hence  $|\mathcal{Y} \cap \mathcal{Q}(4,q)| = (q+1)^2$ . Taking into account Proposition 3.2, the following result holds.

**Proposition 4.1.** The group  $\tilde{G}_h$  has five orbits on lines of  $\mathcal{Q}(4,q)$ :

- $\mathcal{L}_{q+1}$  of size q+1, consisting of the lines of  $\mathcal{Y}$ ;
- $\mathcal{L}_0$  of size  $(q^3 q)/3$ , consisting of lines disjoint to  $\mathcal{Y}$ ;
- $\mathcal{L}_1$  of size  $(q^3 q)/2$ , consisting of lines meeting  $\mathcal{Y}$  in one point;
- $\mathcal{L}_2$  of size  $q^2 + q$ , consisting of lines having two points in common with  $\mathcal{Y}$ ;
- $\mathcal{L}_3$  of size  $(q^3 q)/6$ , consisting of lines intersecting  $\mathcal{Y}$  in three point.

**Remark 4.2.** Note that a line of  $\mathcal{L}_1$  and  $\mathcal{L}_3$  has no point in common with  $\mathcal{X} \cup \mathcal{X}'$ , whereas each of the lines in  $\mathcal{L}_{q+1}$  and  $\mathcal{L}_2$  meets both  $\mathcal{X}$ ,  $\mathcal{X}'$  in one point.

The  $G_h$ -action on lines of PG(3,q) is equivalent to the  $\tilde{G}_h$ -action on points and reguli of  $\mathcal{Q}(4,q)$ . Our goal is to describe these  $\tilde{G}_h$ -orbits. We first consider the  $\tilde{G}_h$ -orbits on points of  $\mathcal{Q}(4,q)$ .

**Proposition 4.3.** Let  $q \equiv \xi \pmod{3}$ ,  $\xi \in \{\pm 1\}$ . The group  $\tilde{G}_h$  has  $5 + \xi$  orbits on points of  $\mathcal{Q}(4,q)$ :

- 2 orbits,  $\mathcal{X}$  and  $\mathcal{X}'$ , of size q + 1;
- one orbit,  $\mathcal{Y} \cap (\mathcal{Q}(4,q) \setminus (\mathcal{X} \cup \mathcal{X}'))$ , of size  $q^2 1$ ;
- $2 + \xi$  orbits on points of  $\mathcal{Q}(4,q) \setminus \mathcal{Y}$  of size  $\frac{q^3-q}{2+\xi}$ .

Proof. Let  $P = U_5 + U_6$ . Then  $P \in \mathcal{Y} \cap (\mathcal{Q}(4,q) \setminus (\mathcal{X} \cup \mathcal{X}'))$  and  $Stab_{\tilde{G}_h}(P)$  is the group of order q represented by the matrices  $\tilde{M}_{1,0,c,1}$ , with  $c \in \mathbb{F}_q$ . Hence  $|P^{\tilde{G}_h}| = q^2 - 1 = |\mathcal{Y} \cap (\mathcal{Q}(4,q) \setminus (\mathcal{X} \cup \mathcal{X}'))|$ .

Let  $P = U_1 + U_5$ . In this case  $Stab_{\tilde{G}_h}(P)$  is the group of order  $2+\xi$  represented by the matrices  $\tilde{M}_{d^{-1},0,0,d}$ , with  $d \in \mathbb{F}_q$  and  $d^{2^h+1} = 1$ . Hence the group  $\tilde{G}_h$  has one or three orbits on points of  $\mathcal{Q}(4,q) \setminus \mathcal{Y}$  according as  $\xi$  equals -1 or 1, respectively. In the latter case the representatives of the orbits are  $U_1 + U_5$ ,  $U_1 + \omega U_5$  and  $U_1 + \omega^2 U_5$ , where  $\omega$  is a primitive element of  $\mathbb{F}_q$ .  $\Box$ 

In order to determine the  $G_h$ -orbits on reguli contained in  $\mathcal{Q}(4,q)$ , the following results are needed.

**Lemma 4.4.** Let s be a line of  $\pi$  secant to  $\mathcal{X}$ . The stabilizer of s in  $\tilde{G}_h$  has (q+2)/2 orbits on lines of  $\pi$  secant to  $\mathcal{X}$ :

- {*s*};
- (q-2)/2 orbits of size q-1;
- one orbit of size 2(q-1).

Proof. Since  $\tilde{G}_h$  is transitive on the q(q+1)/2 lines of  $\pi$  secant  $\mathcal{X}$  we may take s as the line joining  $U_1$  and  $U_6$ . Then  $Stab_{\tilde{G}_h}(s)$  is the group of order 2(q-1) represented by  $\langle \tilde{M}_{0,1,1,0}, \tilde{M}_{d^{-1},0,0,d} \rangle$ ,  $d \in \mathbb{F}_q$ . It is easily seen that  $Stab_{\tilde{G}_h}(s)$  permutes in a single orbit the 2(q-1) lines of  $\pi$  secant to  $\mathcal{X}$  and containing  $U_1$  or  $U_6$ . Indeed each line containing  $U_1$  (resp.  $U_6$ ) is sent to a line containing  $U_6$  (resp.  $U_1$ ) by  $\tilde{M}_{0,1,1,0}$ , while it is sent to a different line containing  $U_1$  (resp.  $U_6$ ) by  $\tilde{M}_{d^{-1},0,0,d}$ .

Every line s' of  $\pi$  secant to  $\mathcal{X}$  such that  $s \cap s' \notin \mathcal{X}$  belongs to an orbit of  $Stab_{\tilde{G}_h}(s)$  of size q-1; indeed the unique non-trivial element of  $Stab_{\tilde{G}_h}(s)$  fixing s' is the involutory elation of  $\pi$  having as axis the line s and as center the point  $s \cap s'$ .

In a similar fashion, one can prove the following results.

**Lemma 4.5.** Let e be a line of  $\pi$  external to  $\mathcal{X}$ . The stabilizer of e in  $\tilde{G}_h$  has q/2 orbits on lines of  $\pi$  external to  $\mathcal{X}$ :

- {*e*};
- (q-2)/2 orbits of size q+1.

**Theorem 4.6.** The group  $\tilde{G}_h$  has 2(q+1) orbits on reguli of  $\mathcal{Q}(4,q)$ :

- 2 orbits of size q(q-1)/2;
- 2 orbits of size q(q+1)/2;
- 2(q-2) orbits of size  $(q^3-q)/2$ ;
- 2 orbits of size  $q^3 q$ .

Proof. Let  $\Sigma$  be a solid of  $\Pi$  such that  $\Sigma \cap \mathcal{Q}(4, q)$  is a three-dimensional hyperbolic quadric  $\mathcal{Q}^+$ . Then  $\Sigma$  meets  $\pi$  and  $\pi^{\perp}$  in a line. Let  $\Sigma \cap \pi$  and  $\Sigma \cap \pi^{\perp}$  be denoted by  $\ell$  and  $\ell'$ , respectively, and  $Stab_{\tilde{G}_h}(\Sigma) = Stab_{\tilde{G}_h}(\ell \cup \ell') = Stab_{\tilde{G}_h}(\ell) \cap Stab_{\tilde{G}_h}(\ell')$ . The three lines  $\ell$ ,  $\ell'$  and  $\Sigma^{\perp}$  are pairwise orthogonal. It follows that the lines  $\ell$ ,  $\ell'$  are either both secant or both external to  $\mathcal{Q}(4, q)$ .

Assume that the former case occurs. Since  $\tilde{G}_h$  is transitive on the q(q+1)/2 lines of  $\pi^{\perp}$ secant  $\mathcal{X}'$ , we may fix  $\ell'$ . Hence  $Stab_{\tilde{G}_h}(\ell')$  is a group of order 2(q-1) fixing a line of  $\pi$  secant to  $\mathcal{X}$ . It follows that  $\ell$  has to lie in one of the (q+2)/2 orbits of Lemma 4.4. Since every member of  $Stab_{\tilde{G}_h}(\ell \cup \ell')$  stabilizes the reguli of  $\mathcal{Q}^+$ , the number of  $\tilde{G}_h$ -orbits on reguli of  $\mathcal{Q}(4,q)$  obtained in this way is twice the number of orbits of Lemma 4.4. Moreover their size is q(q+1)/2 times the size of the orbits of Lemma 4.4.

Similarly, if the latter case occurs, we may fix  $\ell'$  to be our favorite line of  $\pi^{\perp}$  external to  $\mathcal{X}'$ . In this case  $Stab_{\tilde{G}_h}(\ell')$  is a group of order 2(q+1) fixing a line of  $\pi$  external to  $\mathcal{X}$  and  $\ell$  has to be in one of the q/2 orbits of Lemma 4.5. Again it can be checked that every member of  $Stab_{\tilde{G}_h}(\ell \cup \ell')$  fixes the reguli of  $\mathcal{Q}^+$ . Therefore the number of  $\tilde{G}_h$ -orbits on reguli of  $\mathcal{Q}(4,q)$  obtained in this way is twice the number of orbits of Lemma 4.5 and their size is q(q-1)/2 times the size of the orbits of Lemma 4.5.

With the same notation used in the proof of Theorem 4.6, denote by S one of the 2(q+1) orbits on reguli of  $\mathcal{Q}(4,q)$  and by  $\Sigma$  a solid of  $\Pi$  such that

- i)  $\Sigma \cap \mathcal{Q}(4,q)$  is a three-dimensional hyperbolic quadric  $\mathcal{Q}^+$ ;
- *ii)* exactly one of the two reguli  $\mathcal{R}_1$ ,  $\mathcal{R}_2$  of  $\mathcal{Q}^+$  belongs to  $\mathcal{S}$ .

The next results, which can be deduced from the proof of Theorem 4.6, provides a solid  $\Sigma$  such that one of the two reguli  $\mathcal{R}_1, \mathcal{R}_2$  of  $\mathcal{Q}^+ = \Sigma \cap \mathcal{Q}(4,q)$  is a representative for the orbit  $\mathcal{S}$ .

**Corollary 4.7.** Let  $\zeta$  be a fixed element in  $\mathbb{F}_{q^2} \setminus \mathbb{F}_q$  such that  $(\zeta + 1)^{q+1} = 1$ .

- $|\mathcal{S}| = q(q+1)/2, \ \Sigma : X_3 = 0, \ \mathcal{Q}^+ : X_1 X_6 + X_2 X_5 = 0.$
- $|\mathcal{S}| = q^3 q, \ \Sigma : X_1 = X_3, \ \mathcal{Q}^+ : X_1^2 + X_1 X_6 + X_2 X_5 = 0.$
- $|\mathcal{S}| = (q^3 q)/2$  and  $|\Sigma \cap \mathcal{X}| = 2$ ,  $\Sigma : X_1 + \frac{z^4}{z^2 + 1}X_3 + X_6 = 0$  for some  $z \in \mathbb{F}_q \setminus \{0, 1\}$ ,  $\mathcal{Q}^+ : X_1^2 + \frac{z^4}{z^2 + 1}X_1X_3 + X_3^2 + X_2X_5 = 0.$

• 
$$|\mathcal{S}| = q(q-1)/2, \ \Sigma : X_1 + \zeta^{q+1}X_2 + \zeta^{2(q+1)}X_3 + \zeta^{q+1}X_5 + X_6 = 0,$$
  
 $\mathcal{Q}^+ : X_1^2 + \zeta^{q+1}X_1X_2 + \zeta^{2(q+1)}X_1X_3 + \zeta^{q+1}X_1X_5 + X_2X_5 + X_3^2 = 0.$ 

•  $|\mathcal{S}| = (q^3 - q)/2$  and  $|\Sigma \cap \mathcal{X}| = 0$ ,  $\Sigma : X_1 + \frac{t^{q+1}}{\zeta^{q+1}}X_2 + t^{q+1}X_3 + \frac{t^{q+1}}{\zeta^{q+1}}X_5 + X_6 = 0$ , for some  $t \in \mathbb{F}_{q^2} \setminus \{0, \zeta^2, \zeta^{2q}\}, \ (t+1)^{q+1} = 1, \ \mathcal{Q}^+ : X_1^2 + \frac{t^{q+1}}{\zeta^{q+1}}X_1X_2 + t^{q+1}X_1X_3 + \frac{t^{q+1}}{\zeta^{q+1}}X_1X_5 + X_2X_5 + X_3^2 = 0.$ 

The results of Proposition 4.3 and Theorem 4.6 provide a proof of [7, Conjecture 8.2] in the even characteristic case.

**Theorem 4.8.** Let q be even, with  $q \equiv \xi \pmod{3}$ ,  $\xi \in \{\pm 1\}$ . The group  $G_h$  has  $2q + 7 + \xi$  orbits on lines of PG(3,q):

- 2 orbits of size q + 1;
- 2 orbits of size q(q-1)/2;
- 2 orbits of size q(q+1)/2;
- one orbit of size  $q^2 1$ ;
- $2 + \xi$  orbits of size  $\frac{q^3-q}{2+\xi}$ ;
- 2(q-2) orbits of size  $(q^3-q)/2$ ;
- 2 orbits of size  $q^3 q$ .

### 4.1 Point line distribution

In this section we focus on the case when  $\mathcal{A}$  is a twisted cubic (i.e. h = 1) and we address the point line distribution with respect to  $G_1$ -orbits on points and lines of PG(3,q). Dually, this problem is equivalent to determine

- the number of lines of  $\mathcal{L}_i$  through a point of  $\mathcal{Q}(4,q)$  of a given  $\tilde{G}_1$ -orbit on points of  $\mathcal{Q}(4,q)$ ;
- the number of lines of  $\mathcal{L}_i$  in a regulus of a given  $\tilde{G}_1$ -orbit on reguli of  $\mathcal{Q}(4,q)$ .

As for  $\tilde{G}_1$ -orbits on points of  $\mathcal{Q}(4,q)$ , recall that besides the three three orbits  $\mathcal{X}$ ,  $\mathcal{X}'$  and  $\mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}')$ , there is one or three more orbits, according as  $q \equiv -1$  or 1 (mod 3). Let us call  $\mathcal{Z}_i$ ,  $i = 1, \ldots, 2 + \xi$ , these  $\tilde{G}_1$ -orbits. If  $q \equiv 1 \pmod{3}$ , from the proof of Proposition 4.3, it follows that  $\mathcal{Z}_i = R_i^{\tilde{G}_1}$ , where  $R_i = U_1 + \omega^{i-1}U_5$ , i = 1, 2, 3. In particular  $|\mathcal{Z}_i| = (q^3 - q)/3$ .

### **4.1.1** The number of lines of $\mathcal{L}_i$ through a point of $\mathcal{Q}(4,q)$

In order to determine the number of lines of  $\mathcal{L}_i$  through a point of  $\mathcal{P}$ , where  $\mathcal{P}$  is a  $\tilde{G}_1$ -orbits of points of  $\mathcal{Q}(4,q)$ , we calculate the number k of points of  $\mathcal{P}$  on a line of  $\mathcal{L}_i$  and then use the formula

$$\frac{|\mathcal{L}_i|k}{|\mathcal{P}|}$$

to derive the required result.

Let r be a line of  $\mathcal{Q}(4,q)$ . If  $r \in \mathcal{L}_{q+1}$ , then it has one point in common with both  $\mathcal{X}$  and  $\mathcal{X}', q-1$  points of  $\mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}')$  and no point of  $\mathcal{Z}_i$ . If  $r \in \mathcal{L}_2$ , it has one point in common with both  $\mathcal{X}$  and  $\mathcal{X}', (q-1)/(2+\xi)$  points of  $\mathcal{Z}_i$  and no point of  $\mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}')$ .

Assume  $q \equiv -1 \pmod{3}$ . If  $r \in \mathcal{L}_0$ , then all its points belong to  $\mathcal{Z}_1$ , while if  $r \in \mathcal{L}_1$ , then  $|r \cap (\mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}'))| = 1$  and  $|r \cap \mathcal{Z}_1| = q$ . If  $r \in \mathcal{L}_3$ , then  $|r \cap (\mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}'))| = 3$  and  $|r \cap \mathcal{Z}_1| = q - 2$ . In the case when  $q \equiv 1 \pmod{3}$ , a more refined argument is needed.

**Lemma 4.9.** Let  $q \equiv 1 \pmod{3}$ . A point P belongs to  $\mathcal{Z}_i$  if and only if  $F_1(P) = \omega^{3j+i-1}$ .

Proof. First of all observe that  $F_1(\lambda P) = \lambda^3 F_1(P)$ . Since  $\mathcal{Z}_i = R_i^{\tilde{G}_1}$ , where  $R_i = U_1 + \omega^{i-1}U_5$ , i = 1, 2, 3, it is enough to see that if  $g \in \tilde{G}_1$  is represented by  $\tilde{M}_{a,b,c,d}$ , then  $F_1(R_i) = F_1(R_i^g) = \omega^{2(i-1)}$ .

**Proposition 4.10.** Let  $q = 2^n \equiv 1 \pmod{3}$ . A line of  $\mathcal{L}_3$  has 3 points in common with  $\mathcal{Y}$ ,  $(q-(-1)^{\frac{n}{2}}2\sqrt{q}-2)/3$  points in common with  $\mathcal{Z}_1$  and  $(q+(-1)^{\frac{n}{2}}\sqrt{q}-2)/3$  in common with both  $\mathcal{Z}_2$  and  $\mathcal{Z}_3$ . A line of  $\mathcal{L}_0$  has  $(q-(-1)^{\frac{n}{2}}2\sqrt{q}+1)/3$  points in common with  $\mathcal{Z}_1$  and  $(q+(-1)^{\frac{n}{2}}\sqrt{q}+1)/3$  in common with both  $\mathcal{Z}_2$  and  $\mathcal{Z}_3$ .

*Proof.* Recall that the points of a line of  $\mathcal{Q}(4,q)$  in  $\mathcal{L}_0$  or  $\mathcal{L}_3$  are the image under the Plücker embedding of the lines of  $\mathcal{W}(3,q)$  through a point Q belonging to  $\mathcal{O}_0$  or  $\mathcal{O}_3$ , respectively. Since  $q \equiv 1 \pmod{3}$ , by Proposition 3.2, we may assume Q = (1,0,0,x), where  $x \in \mathbb{F}_q$  is not a cube, or Q = (1,0,0,1), respectively. Therefore a representative for  $\mathcal{L}_0$  is the line

$$r_x = \{ (1, \mu, 0, 0, x, \mu x) \mid \mu \in \mathbb{F}_q \} \cup \{ U_2 + x U_6 \},\$$

whereas for  $\mathcal{L}_3$  is the line

$$r = \{ (1, \mu, 0, 0, 1, \mu) \mid \mu \in \mathbb{F}_q \} \cup \{ U_2 + U_6 \}.$$

Taking into account Lemma 4.9,  $|r_x \cap \mathcal{Z}_i|$  equals the number of points of  $r_x$  whose evaluation of F has the form  $\omega^{3j+i-1}$ , for some j. In particular, the point  $U_2 + xU_6$  belongs to  $\mathcal{Z}_2$  or  $\mathcal{Z}_3$ , according as x equals  $\omega^{3l+1}$  or  $\omega^{3l+2}$ . The point  $P_{\mu} = (1, \mu, 0, 0, x, \mu x)$  belongs to  $\mathcal{Z}_1$  if and only if there exists  $\lambda \in \mathbb{F}_q$  such that

$$x\mu^3 + \lambda^3 = x^2. \tag{4.1}$$

By [10, Theorem 1], in both cases  $x = \omega^{3l+1}$  or  $x = \omega^{3l+2}$ , the number of pairs  $(\mu, \lambda) \in \mathbb{F}_q^2$  satisfying (4.1) is  $q - (-1)^{\frac{n}{2}} 2\sqrt{q} + 1$ . Since for each  $\mu$ , there are three distinct  $\lambda$  satisfying (4.1), it follows that

$$|r_x \cap \mathcal{Z}_1| = \frac{q - (-1)^{\frac{n}{2}} 2\sqrt{q} + 1}{3}.$$

Observe that  $P_{\mu} \in r_x \cap \mathbb{Z}_2$  if and only if  $P_{\mu^2} \in r_{x^2} \cap \mathbb{Z}_3$ . Hence  $|r_x \cap \mathbb{Z}_2| = |r_{x^2} \cap \mathbb{Z}_3|$ . On the other hand  $|r_x \cap \mathbb{Z}_3| = |r_{x^2} \cap \mathbb{Z}_3|$ , since  $r_x$  and  $r_{x^2}$  are in the same  $\tilde{G}_h$ -orbit. Therefore

$$|r_x \cap \mathcal{Z}_2| = |r_x \cap \mathcal{Z}_3| = \frac{q+1-|r_0 \cap \mathcal{Z}_1|}{2} = \frac{q+(-1)^{\frac{n}{2}}\sqrt{q}+1}{3}$$

Similarly, the point  $U_2 + U_6$  belongs to  $\mathcal{Z}_1$ , whereas the point  $P_{\mu} = (1, \mu, 0, 0, 1, \mu)$  belongs to  $\mathcal{Z}_1$  if and only if  $\mu^3 \neq 1$  and there exists  $\lambda \in \mathbb{F}_q$  such that

$$\mu^3 + \lambda^3 = 1. \tag{4.2}$$

By using again [10, Theorem 1] (or [10, Corollary 4]), we find that the number of pairs  $(\mu, \lambda) \in \mathbb{F}_q^2$ satisfying (4.2) is  $q - (-1)^{\frac{n}{2}} 2\sqrt{q} - 2$ . Among these solutions we have to exclude (1, 0),  $(\omega^{\frac{q-1}{3}}, 0)$ ,  $(\omega^{\frac{2(q-1)}{3}}, 0)$  and for each  $\mu$  of the remaining pairs, there are three distinct  $\lambda$  satisfying (4.2), it follows that

$$|r \cap \mathcal{Z}_1| = \frac{q - (-1)^{\frac{n}{2}} 2\sqrt{q} - 2}{3}.$$

Finally  $P_{\mu} \in r \cap \mathbb{Z}_2$  if and only if  $P_{\mu^2} \in r \cap \mathbb{Z}_3$ . Hence

$$|r \cap \mathcal{Z}_2| = |r \cap \mathcal{Z}_3| = \frac{q+1-3-|r_0 \cap \mathcal{Z}_1|}{2} = \frac{q+(-1)^{\frac{n}{2}}\sqrt{q}-2}{3}.$$

Therefore the number of lines of  $\mathcal{L}_i$  through a point of  $\mathcal{Q}(4,q)$  of a given  $\tilde{G}_1$ -orbit on points of  $\mathcal{Q}(4,q)$  can be deduced as shown in Tables 3 and 4.

### **4.1.2** The number of lines of $\mathcal{L}_i$ in a regulus of $\mathcal{Q}(4,q)$

By Theorem 4.6, the group  $\tilde{G}_h$  has 2(q+1) orbits on reguli of  $\mathcal{Q}(4,q)$ . Denote by  $\mathcal{S}$  one of these 2(q+1) orbits and by  $\Sigma$  a solid of  $\Pi$  such that

i)  $\Sigma \cap \mathcal{Q}(4,q)$  is a three-dimensional hyperbolic quadric  $\mathcal{Q}^+$ ;

*ii)* exactly one of the two reguli  $\mathcal{R}_1$ ,  $\mathcal{R}_2$  of  $\mathcal{Q}^+$  belongs to  $\mathcal{S}$ .

Recall that  $\mathcal{Y}$  consists of the q+1 lines

$$\ell_x = \{ (1, \lambda, x^2 + \lambda x, x^2 + \lambda x, \lambda x^2, x^4) \mid \lambda \in \mathbb{F}_q \} \cup \{ (0, 1, x, x, x^2, 0) \}, \ x \in \mathbb{F}_q, \\ \ell_\infty = \{ (0, 0, 0, 0, 1, \lambda) \mid \lambda \in \mathbb{F}_q \} \cup \{ U_6 \}.$$

**Theorem 4.11.** Let  $\zeta$  be a fixed element in  $\mathbb{F}_{q^2} \setminus \mathbb{F}_q$  such that  $(\zeta + 1)^{q+1} = 1$ . With the above notation, one of the following cases occurs.

- 1. If S is one of the two orbits of size q(q+1)/2, then
  - $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = 2, |\mathcal{L}_2 \cap \mathcal{R}_1| = 0,$

$$\begin{aligned} |\mathcal{L}_0 \cap \mathcal{R}_1| &= 2(q-1)/3, |\mathcal{L}_1 \cap \mathcal{R}_1| = 0, |\mathcal{L}_3 \cap \mathcal{R}_1| = (q-1)/3, & \text{if } q \equiv 1 \pmod{3}, \\ |\mathcal{L}_0 \cap \mathcal{R}_1| &= 0, |\mathcal{L}_1 \cap \mathcal{R}_1| = q-1, |\mathcal{L}_3 \cap \mathcal{R}_1| = 0, & \text{if } q \equiv -1 \pmod{3}. \end{aligned}$$

• 
$$|\mathcal{L}_{q+1} \cap \mathcal{R}_2| = |\mathcal{L}_0 \cap \mathcal{R}_2| = |\mathcal{L}_1 \cap \mathcal{R}_2| = 0, \ |\mathcal{L}_2 \cap \mathcal{R}_2| = 2, \ |\mathcal{L}_3 \cap \mathcal{R}_2| = q-1.$$

2. If S is one of the two orbits of size  $q^3 - q$ , then

• 
$$|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = 1, |\mathcal{L}_2 \cap \mathcal{R}_1| = 1,$$
  
 $|\mathcal{L}_0 \cap \mathcal{R}_1| = (q-1)/3, |\mathcal{L}_1 \cap \mathcal{R}_1| = q/2, |\mathcal{L}_3 \cap \mathcal{R}_1| = (q-4)/6, \quad if \ q \equiv 1 \pmod{3},$   
 $|\mathcal{L}_0 \cap \mathcal{R}_1| = (q+1)/3, |\mathcal{L}_1 \cap \mathcal{R}_1| = (q-2)/2, |\mathcal{L}_3 \cap \mathcal{R}_1| = (q-2)/6, \quad if \ q \equiv -1 \pmod{3}$ 

• 
$$|\mathcal{L}_{q+1} \cap \mathcal{R}_2| = |\mathcal{L}_0 \cap \mathcal{R}_2| = 0, |\mathcal{L}_1 \cap \mathcal{R}_2| = q/2, |\mathcal{L}_2 \cap \mathcal{R}_2| = 2, |\mathcal{L}_3 \cap \mathcal{R}_2| = (q-2)/2.$$

3. If S is one of the q-2 orbits with  $|S| = (q^3 - q)/2$  and  $|\Sigma \cap \mathcal{X}| = 2$ , let

$$\boldsymbol{u}_{i} = |\{x \in \mathbb{F}_{q} \setminus \{0, z+1, (z+1)^{-1}\} \mid \operatorname{Tr}_{q|2}(f_{i}(x)) = 0\}|,$$

where

$$f_1(x) = \frac{1}{z^2} \left( \frac{x(z+1)}{z^2} + \frac{z+1}{xz^2} + 1 \right), \qquad f_2(x) = \frac{z^2+1}{z^2} \left( \frac{x(z+1)}{z^2} + \frac{z+1}{xz^2} + 1 \right),$$

for some  $z \in \mathbb{F}_q \setminus \{0,1\}$ . Then

 $|\mathcal{L}_{q+1} \cap \mathcal{R}_i| = 0, |\mathcal{L}_0 \cap \mathcal{R}_i| = (2u_i + 6)/3, |\mathcal{L}_1 \cap \mathcal{R}_i| = q - u_i - 3, |\mathcal{L}_2 \cap \mathcal{R}_i| = 2, |\mathcal{L}_3 \cap \mathcal{R}_i| = u_i/3, i \in \{1, 2\}.$ 

4. If S is one of the two orbits of size q(q-1)/2, then

•  $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = |\mathcal{L}_2 \cap \mathcal{R}_1| = 0,$ 

$$\begin{aligned} |\mathcal{L}_0 \cap \mathcal{R}_1| &= |\mathcal{L}_3 \cap \mathcal{R}_1| = 0, |\mathcal{L}_1 \cap \mathcal{R}_1| = q+1, & \text{if } q \equiv 1 \pmod{3}, \\ |\mathcal{L}_0 \cap \mathcal{R}_1| &= 2(q+1)/3, |\mathcal{L}_1 \cap \mathcal{R}_1| = 0, |\mathcal{L}_3 \cap \mathcal{R}_1| = (q+1)/3, & \text{if } q \equiv -1 \pmod{3}. \end{aligned}$$

• 
$$|\mathcal{L}_{q+1} \cap \mathcal{R}_2| = |\mathcal{L}_0 \cap \mathcal{R}_2| = |\mathcal{L}_2 \cap \mathcal{R}_2| = |\mathcal{L}_3 \cap \mathcal{R}_2| = 0, \ |\mathcal{L}_1 \cap \mathcal{R}_2| = q+1.$$

5. If S is one of the q-2 orbits with  $|S| = (q^3 - q)/2$  and  $|\Sigma \cap \mathcal{X}| = 0$ , let

$$\boldsymbol{v}_i = |\{x \in \mathbb{F}_q \mid \operatorname{Tr}_{q|2}\left(g_i(x)\right) = 0\}|,$$

where

$$g_{1}(x) = \frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}} \left(x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right) \left(\left(\frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right)x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + 1\right)}{(x^{2} + \zeta^{q+1} + 1)^{2}},$$
$$g_{2}(x) = \frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}} \left(x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{q+1}}{t^{2}} + \frac{t^{q+1}}{\zeta^{2}}\right) \left(\left(\frac{t^{q+1}}{t^{2}} + \frac{t^{q+1}}{\zeta^{2}}\right)x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + 1\right)}{(x^{2} + \zeta^{q+1} + 1)^{2}},$$

for some  $t \in \mathbb{F}_{q^2} \setminus \{0, \zeta^2, \zeta^{2q}\}$ ,  $(t+1)^{q+1} = 1$ . Then

$$|\mathcal{L}_{q+1} \cap \mathcal{R}_i| = 0, |\mathcal{L}_0 \cap \mathcal{R}_i| = (2v_i + 6)/3, |\mathcal{L}_1 \cap \mathcal{R}_i| = q - v_i - 2, |\mathcal{L}_2 \cap \mathcal{R}_i| = 0, |\mathcal{L}_3 \cap \mathcal{R}_i| = (v_i + 3)/3$$
  
or

$$|\mathcal{L}_{q+1} \cap \mathcal{R}_i| = 0, |\mathcal{L}_0 \cap \mathcal{R}_i| = 2v_i/3, |\mathcal{L}_1 \cap \mathcal{R}_i| = q - v_i + 1, |\mathcal{L}_2 \cap \mathcal{R}_i| = 0, |\mathcal{L}_3 \cap \mathcal{R}_i| = v_i/3, i \in \{1, 2\}.$$

according as  $\operatorname{Tr}_{q|2}\left(\frac{z^2}{t^{q+1}}\left(1+\frac{z^{2q}}{t^2}\right)\right)$  equals 0 or 1, respectively.

*Proof.* For each of the five cases listed in Corollary 4.7, we determine  $\mathcal{Q}^+ \cap \mathcal{Y}$  and hence  $|\mathcal{L}_i \cap \mathcal{R}_j|$ ,  $i \in \{0, 1, 2, 3, q+1\}, j \in \{1, 2\}.$ 

If S is one of the two orbits of size q(q+1)/2 then

$$\mathcal{Q}^+ \cap \mathcal{Y} = \{(1, x, 0, 0, x^3, x^4) \mid x \in \mathbb{F}_q \setminus \{0\}\} \cup \ell_0 \cup \ell_\infty.$$

Assume that  $\ell_0 \in \mathcal{R}_1$ . Then  $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = |\mathcal{L}_2 \cap \mathcal{R}_2| = 2$  and  $|\mathcal{L}_{q+1} \cap \mathcal{R}_2| = |\mathcal{L}_2 \cap \mathcal{R}_1| = 0$ . We infer that  $|\mathcal{L}_3 \cap \mathcal{R}_2| = q - 1$  and  $|\mathcal{L}_1 \cap \mathcal{R}_2| = |\mathcal{L}_0 \cap \mathcal{R}_2| = 0$ . The two points  $(1, x, 0, 0, x^3, x^4)$ ,  $(1, y, 0, 0, y^3, y^4)$ ,  $x, y \in \mathbb{F}_q \setminus \{0\}$ ,  $x \neq y$ , belonging to  $\mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}')$  define a line of  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if

$$\operatorname{rk} \begin{pmatrix} 1 & x & 0 & 0 & x^3 & x^4 \\ 1 & y & 0 & 0 & y^3 & y^4 \\ 1 & 0 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 1 & 0 \end{pmatrix} = 3,$$

which gives  $xy(x^3 + y^3) = 0$ . For  $q \equiv 1 \mod 3$ ,  $|\mathcal{L}_3 \cap \mathcal{R}_1| = (q - 1)/3$ ,  $|\mathcal{L}_1 \cap \mathcal{R}_1| = 0$  and  $|\mathcal{L}_0 \cap \mathcal{R}_1| = 2(q - 1)/3$ . For  $q \equiv -1 \mod 3$ , instead, it holds  $|\mathcal{L}_3 \cap \mathcal{R}_1| = |\mathcal{L}_0 \cap \mathcal{R}_1| = 0$  and  $|\mathcal{L}_1 \cap \mathcal{R}_1| = q - 1$ .

Let S be one of the two orbits of size  $q^3 - q$ , then

$$\mathcal{Q}^+ \cap \mathcal{Y} = \{(x, x^2 + 1, x, x, x^2 + x^4, x^5) \mid x \in \mathbb{F}_q\} \cup \ell_{\infty}.$$

Assume that  $\ell_{\infty} \in \mathcal{R}_1$  and  $\langle U_2, U_6 \rangle \in \mathcal{R}_2$ . Then  $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = 1$ ,  $|\mathcal{L}_2 \cap \mathcal{R}_1| = 1$  and  $|\mathcal{L}_{q+1} \cap \mathcal{R}_2| = 0$ ,  $|\mathcal{L}_2 \cap \mathcal{R}_2| = 2$ . Let *s* be the line defined by the two points  $(x, x^2 + 1, x, x, x^2 + x^4, x^5)$ ,

 $(y, y^2 + 1, y, y, y^2 + y^4, y^5), x, y \in \mathbb{F}_q \setminus \{0, 1\}, x \neq y, \text{ of } \mathcal{Y} \setminus (\mathcal{X} \cup \mathcal{X}').$  The line s belongs to  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if

$$\operatorname{rk}\begin{pmatrix} x & x^2 + 1 & x & x & x^2 + x^4 & x^5 \\ y & y^2 + 1 & y & y & y^2 + y^4 & y^5 \\ 0 & 1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0 & 1 \end{pmatrix} = 3,$$

which gives  $xy(x + y)(y^2 + xy + x^2 + 1) = 0$ . Since

$$\left| \left\{ x \in \mathbb{F}_q \setminus \{0,1\} \mid \operatorname{Tr}\left(1 + \frac{1}{x^2}\right) = 0 \right\} \right| = \left\{ \begin{array}{l} \frac{q}{2} - 2 & \text{if } q \equiv 1 \pmod{3}, \\ \frac{q}{2} - 1 & \text{if } q \equiv -1 \pmod{3} \end{array} \right.$$

it follows that  $|\mathcal{L}_3 \cap \mathcal{R}_1| = (q-4)/6$ ,  $|\mathcal{L}_1 \cap \mathcal{R}_1| = q/2$  and  $|\mathcal{L}_0 \cap \mathcal{R}_1| = (q-1)/3$ , if  $q \equiv 1 \pmod{3}$ , whereas  $|\mathcal{L}_3 \cap \mathcal{R}_1| = (q-2)/6$ ,  $|\mathcal{L}_1 \cap \mathcal{R}_1| = (q-2)/2$  and  $|\mathcal{L}_0 \cap \mathcal{R}_1| = (q+1)/3$ , if  $q \equiv -1 \pmod{3}$ . The line *s* belongs to  $\mathcal{L}_3 \cap \mathcal{R}_2$  if and only if

$$\operatorname{rk} \begin{pmatrix} x & x^2 + 1 & x & x & x^2 + x^4 & x^5 \\ y & y^2 + 1 & y & y & y^2 + y^4 & y^5 \\ 0 & 0 & 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 0 & 0 & 1 \end{pmatrix} = 3,$$

which gives (xy+1)(x+y) = 0. Hence  $|\mathcal{L}_3 \cap \mathcal{R}_2| = (q-2)/2$ ,  $|\mathcal{L}_1 \cap \mathcal{R}_2| = q/2$  and  $|\mathcal{L}_0 \cap \mathcal{R}_2| = 0$ .

Assume that  $\mathcal{S}$  is one of the q-2 orbits with  $|\mathcal{S}| = (q^3 - q)/2$  and  $|\Sigma \cap \mathcal{X}| = 2$ , then

$$\mathcal{Q}^{+} \cap \mathcal{Y} = \left\{ T_{x} \mid x \in \mathbb{F}_{q} \setminus \{0, z+1, (z+1)^{-1}\} \right\}$$
$$\cup \left\{ U_{2}, U_{5}, (1, 0, z^{2}+1, z^{2}+1, 0, z^{4}+1), (1, 0, (z^{2}+1)^{-1}, (z^{2}+1)^{-1}, 0, (z^{4}+1)^{-1}) \right\},\$$

where

$$T_x = \frac{z^2 + 1}{z^4} \left( \frac{z^4}{z^2 + 1}, x^{-1} \left( x^4 + \frac{z^4}{z^2 + 1} x^2 + 1 \right), x^4 + 1, x^4 + 1, x \left( x^4 + \frac{z^4}{z^2 + 1} x^2 + 1 \right), \frac{z^4}{z^2 + 1} x^4 \right),$$

for some  $z \in \mathbb{F}_q \setminus \{0,1\}$ . Suppose that  $\langle (1,0,z^2+1,z^2+1,0,z^4+1), U_2 \rangle \in \mathcal{R}_1$  and  $\langle (1,0,(z^2+1)^{-1},(z^2+1)^{-1},0,(z^4+1)^{-1}),U_2 \rangle \in \mathcal{R}_2$ . In this case  $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = |\mathcal{L}_{q+1} \cap \mathcal{R}_2| = 0$  and  $|\mathcal{L}_2 \cap \mathcal{R}_1| = |\mathcal{L}_2 \cap \mathcal{R}_2| = 2$ . The line  $\langle T_x, T_y \rangle$ ,  $x, y \in \mathbb{F}_q \setminus \{0, z+1, (z+1)^{-1}\}$ ,  $x \neq y$ , belongs to  $\mathcal{L}_3 \cap \mathcal{R}_2$  or to  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if

$$(x+z+1)^2 y^2 + \frac{xz^4}{z^2+1} y + (x(z+1)+1)^2 = 0 \text{ or}$$
(4.3)

$$(x(z+1)+1)^2y^2 + xz^4y + (x+z+1)^2 = 0.$$
(4.4)

For a fixed x, equation (4.3) or (4.4) has a solution in y if and only if

$$\operatorname{Tr}_{q|2}\left(\frac{z^2+1}{z^2}\left(\frac{x(z+1)}{z^2}+\frac{z+1}{xz^2}+1\right)\right) = 0 \text{ or } \operatorname{Tr}_{q|2}\left(\frac{1}{z^2}\left(\frac{x(z+1)}{z^2}+\frac{z+1}{xz^2}+1\right)\right) = 0.$$

Let S be one of the two orbits of size q(q-1)/2. Then

$$\mathcal{Q}^{+} \cap \mathcal{Y} = \{ T_x \mid x \in \mathbb{F}_q \} \cup \{ T_{\infty} = (0, 0, 0, 0, 1, \zeta^{q+1}) \},$$
  
where  $T_x = (\zeta^{q+1}, x^2 + \zeta^{q+1}x + 1, x^3 + x, x^3 + x, x^4 + \zeta^{q+1}x^3 + x^2, \zeta^{q+1}x^4)$ 

Let  $\bar{Q}^+$  denote the quadratic extension of  $Q^+$ , and assume that  $\langle (0, 1, \zeta+1, \zeta+1, \zeta^2+1, 0), (1, 0, \zeta^2+1, \zeta^2+1, 0, \zeta^4+1) \rangle \in \bar{\mathcal{R}}_1$  and  $\langle (0, 1, \zeta+1, \zeta+1, \zeta^2+1, 0), (1, 0, \zeta^{2q}+1, \zeta^{2q}+1, 0, \zeta^{4q}+1) \rangle \in \bar{\mathcal{R}}_2$ , where  $\bar{\mathcal{R}}_1$  and  $\bar{\mathcal{R}}_2$  are the reguli of  $\bar{Q}^+$  obtained by extending  $\mathcal{R}_1$  and  $\mathcal{R}_2$ . In this case  $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = |\mathcal{L}_2 \cap \mathcal{R}_1| = |\mathcal{L}_{q+1} \cap \mathcal{R}_2| = |\mathcal{L}_2 \cap \mathcal{R}_2| = 0$ . Arguing as before we find that the line joining  $T_x$  and  $T_\infty$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if there exists  $x \in \mathbb{F}_q$  such that

$$(\zeta+1)^2 x^2 + \zeta^2 (\zeta+1)x + \zeta^4 + \zeta^2 + 1 = (\zeta+1)^2 \left( (x^2 + \zeta^{q+1}x + (\zeta^{q+1}+1)^2) = 0.$$
(4.5)

Since  $u^2 + \zeta^{q+1}u + 1 = u^2 + (\zeta + \zeta^q)u + 1 = (u + \zeta + 1)(u + \zeta^q + 1)$ , then  $\operatorname{Tr}_{q|2}\left(1 + \frac{1}{\zeta^{2(q+1)}}\right) = \operatorname{Tr}_{q|2}(1) + \operatorname{Tr}_{q|2}(1/\zeta^{2(q+1)}) = \operatorname{Tr}_{q|2}(1) + 1$ . Hence equation (4.5) has two or none solutions according as  $q \equiv -1$  or 1 (mod 3). Similarly, for a fixed  $x \in \mathbb{F}_q$ , the line joining  $T_x$  and  $T_y$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if there exists  $y \in \mathbb{F}_q \setminus \{x\}$  such that

$$\left( (\zeta+1)^2 x^2 + \zeta^2 (\zeta+1)x + \zeta^4 + \zeta^2 + 1 \right) y^2 + \zeta^2 \left( (\zeta+1)x^2 + \zeta^2 x + \zeta + 1 \right) y + \left( (\zeta^4 + \zeta^2 + 1)x^2 + \zeta^2 (\zeta+1)x + (\zeta+1)^2 \right) = (\zeta+1)^2 \left( \left( x^2 + \zeta^{q+1}x + (\zeta^{q+1}+1)^2 \right) y^2 + \zeta^{q+1} \left( x^2 + \zeta^{q+1}x + 1 \right) y + (\zeta^{q+1}+1)^2 x^2 + \zeta^{q+1}x + 1 \right) = 0.$$

$$(4.6)$$

Since  $u^2 + (x^2 + \zeta^{q+1}x + 1)u + \zeta^{q+1}(x^3 + x) = u^2 + (x^2 + (\zeta + \zeta^q)x + 1)u + (\zeta + \zeta^q)(x^3 + x) = (u + (\zeta + \zeta^q)x)(u + x^2 + 1)$ , then  $\operatorname{Tr}_{q|2}\left(1 + \frac{1}{\zeta^{2(q+1)}} + \frac{\zeta^{q+1}(x^3 + x)}{(x^2 + \zeta^{q+1}x + 1)^2}\right) = \operatorname{Tr}_{q|2}(1) + \operatorname{Tr}_{q|2}(1/\zeta^{2(q+1)}) + \operatorname{Tr}_{q|2}(\zeta^{q+1}(x^3 + x)/(x^2 + \zeta^{q+1}x + 1)^2) = \operatorname{Tr}_{q|2}(1) + 1 + 0$ . Therefore equation (4.6) has two or none solutions according as  $q \equiv -1$  or 1 (mod 3). It follows that  $|\mathcal{L}_3 \cap \mathcal{R}_1| = (q+1)/3$ ,  $|\mathcal{L}_1 \cap \mathcal{R}_1| = 0$  and  $|\mathcal{L}_0 \cap \mathcal{R}_1| = 2(q+1)/3$ , if  $q \equiv -1$  (mod 3), whereas  $|\mathcal{L}_3 \cap \mathcal{R}_1| = |\mathcal{L}_0 \cap \mathcal{R}_1| = 0$  and  $|\mathcal{L}_1 \cap \mathcal{R}_1| = q + 1$ , if  $q \equiv 1 \pmod{3}$ . Similar calculations show that no line joining  $T_x$  and  $T_\infty$  or  $T_x$  and  $T_y$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_2$ . Hence  $|\mathcal{L}_3 \cap \mathcal{R}_2| = 0$ ,  $|\mathcal{L}_1 \cap \mathcal{R}_2| = q + 1$  and  $|\mathcal{L}_0 \cap \mathcal{R}_2| = 0$ .

If S is one of the q-2 orbits with  $|S| = (q^3 - q)/2$  and  $|\Sigma \cap \mathcal{X}| = 0$ , then

$$Q^+ \cap \mathcal{Y} = \{T_x \mid x \in \mathbb{F}_q\} \cup \{T_\infty = (0, 0, 0, 0, 1, t^{q+1} / \zeta^{q+1})\},\$$

where

$$\begin{split} T_x &= \left((t^{q+1}(x^2+\zeta^{q+1}x+1),\zeta^{q+1}(x^4+t^{q+1}x^2+1),(x^3+x)(\zeta^{q+1}x^2+t^{q+1}x+\zeta^{q+1}), \\ & (x^3+x)(\zeta^{q+1}x^2+t^{q+1}x+\zeta^{q+1}),\zeta^{q+1}x^2(x^4+t^{q+1}x^2+1),t^{q+1}x^4(x^2+\zeta^{q+1}x+1)\right), \end{split}$$

for some  $t \in \mathbb{F}_{q^2} \setminus \{0, \zeta^2, \zeta^{2q}\}$ ,  $(t+1)^{q+1} = 1$ . Let  $\overline{\mathcal{Q}}^+$  denote the quadratic extension of  $\mathcal{Q}^+$ , and assume that  $\langle (0, 1, \zeta + 1, \zeta + 1, \zeta^2 + 1, 0), (1, 0, t + 1, t + 1, 0, t^2 + 1) \rangle \in \overline{\mathcal{R}}_1$  and  $\langle (0, 1, \zeta + 1, \zeta + 1, \zeta + 1, \zeta^2 + 1, 0), (1, 0, t^q + 1, t^q + 1, 0, t^{2q} + 1) \rangle \in \overline{\mathcal{R}}_2$ , where  $\overline{\mathcal{R}}_1$  and  $\overline{\mathcal{R}}_2$  are the reguli of  $\overline{\mathcal{Q}}^+$  obtained by extending  $\mathcal{R}_1$  and  $\mathcal{R}_2$ . In this case  $|\mathcal{L}_{q+1} \cap \mathcal{R}_1| = |\mathcal{L}_2 \cap \mathcal{R}_1| = |\mathcal{L}_{q+1} \cap \mathcal{R}_2| = |\mathcal{L}_2 \cap \mathcal{R}_2| = 0$ . The line joining  $T_x$  and  $T_\infty$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if there exists  $x \in \mathbb{F}_q$  such that

$$\begin{aligned} \zeta^{2}(t+1)x^{2} + t^{2}(\zeta+1)x + \zeta^{2}t^{2} + \zeta^{2} + t^{2} &= \zeta^{2}(t+1)\left(x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right) \\ &= \zeta^{2}(t+1)\left(x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{2q}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2q}}\right) = 0 \quad (4.7)\end{aligned}$$

Equation (4.7) has two or none solutions according as  $\operatorname{Tr}_{q|2}\left(\frac{\zeta^2}{t^{q+1}}\left(1+\frac{\zeta^{2q}}{t^2}\right)\right)$  equals 0 or 1, respectively. Analogously, for a fixed  $x \in \mathbb{F}_q$ , the line joining  $T_x$  and  $T_y$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_1$  if and only if there exists  $y \in \mathbb{F}_q \setminus \{x\}$  such that

$$\left(x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right)y^{2} + \frac{t^{q+1}}{\zeta^{q+1}}\left(x^{2} + \zeta^{q+1}x + 1\right)y + \left(\left(\frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right)x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + 1\right)$$

$$= 0.$$
(4.8)

Equation (4.8) admits a solution if and only if

$$\operatorname{Tr}_{q|2}\left(\frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}}\left(x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right)\left(\left(\frac{t^{2}}{t^{q+1}} + \frac{t^{q+1}}{\zeta^{2}}\right)x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + 1\right)}{(x^{2} + \zeta^{q+1} + 1)^{2}}\right) = 0.$$

The line joining  $T_x$  and  $T_\infty$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_2$  if and only if there exists  $x \in \mathbb{F}_q$  such that

$$x^{2} + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{q+1}}{\zeta^{2}} + \frac{t^{q+1}}{t^{2}} = 0$$

which has solutions if and only if  $\operatorname{Tr}_{q|2}\left(\frac{\zeta^{2(q+1)}}{t^{q+1}}\left(\frac{1}{\zeta^2}+\frac{1}{t^2}\right)\right)$  equals 0, whereas, for a fixed  $x \in \mathbb{F}_q$ , the line joining  $T_x$  and  $T_y$  belongs to  $\mathcal{L}_3 \cap \mathcal{R}_2$  if and only if there exists  $y \in \mathbb{F}_q \setminus \{x\}$  such that

$$\left( x^2 + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{q+1}}{t^2} + \frac{t^{q+1}}{\zeta^2} \right) y^2 + \frac{t^{q+1}}{\zeta^{q+1}} \left( x^2 + \zeta^{q+1}x + 1 \right) y + \left( \left( \frac{t^{q+1}}{t^2} + \frac{t^{q+1}}{\zeta^2} \right) x^2 + \frac{t^{q+1}}{\zeta^{q+1}}x + 1 \right) = 0.$$

which has solutions if and only if

$$\operatorname{Tr}_{q|2}\left(\frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}}\left(x^2 + \frac{t^{q+1}}{\zeta^{q+1}}x + \frac{t^{q+1}}{t^2} + \frac{t^{q+1}}{\zeta^2}\right)\left(\left(\frac{t^{q+1}}{t^2} + \frac{t^{q+1}}{\zeta^2}\right)x^2 + \frac{t^{q+1}}{\zeta^{q+1}}x + 1\right)}{(x^2 + \zeta^{q+1} + 1)^2}\right) = 0.$$

Finally observe that

$$\operatorname{Tr}_{q|2}\left(\frac{\zeta^2}{t^{q+1}}\left(1+\frac{\zeta^{2q}}{t^2}\right)\right) = 0 \iff \operatorname{Tr}_{q|2}\left(\frac{\zeta^{2(q+1)}}{t^{q+1}}\left(\frac{1}{\zeta^2}+\frac{1}{t^2}\right)\right) = 0.$$

The content of Theorem 4.11 is summarized in Tables 5, 6, 8, 7, 10, 11, 9 and 12.
