# On the geometry of a $(q+1)$-arc of $\mathrm{PG}(3, q), q$ even

#### Abstract

In $\mathrm{PG}(3, q), q=2^{n}, n \geq 3$, let $\mathcal{A}=\left\{\left(1, t, t^{2^{h}}, t^{2^{h}+1}\right) \mid t \in \mathbb{F}_{q}\right\} \cup\{(0,0,0,1)\}$, with $\operatorname{gcd}(n, h)=1$, be a $(q+1)$-arc and let $G_{h} \simeq \operatorname{PGL}(2, q)$ be the stabilizer of $\mathcal{A}$ in $\operatorname{PGL}(4, q)$. The $G_{h}$-orbits on points, lines and planes of $\mathrm{PG}(3, q)$, together with the point-plane incidence matrix with respect to the $G_{h}$-orbits on points and planes of $\operatorname{PG}(3, q)$ are determined. The point-line incidence matrix with respect to the $G_{1}$-orbits on points and lines of $\mathrm{PG}(3, q)$ is also considered. In particular, for a line $\ell$ belonging to a given line $G_{1}$-orbits, say $\mathcal{L}$, the point $G_{1}$-orbit distribution of $\ell$ is either explicitly computed or it is shown to depend on the number of elements $x$ in $\mathbb{F}_{q}$ (or in a subset of $\mathbb{F}_{q}$ ) such that $\operatorname{Tr}_{q \mid 2}(g(x))=0$, where $g$ is an $\mathbb{F}_{q}$-map determined by $\mathcal{L}$.


Keywords: $(q+1)$-arc; twisted cubic.

## 1 Introduction

Let $\mathrm{PG}(3, q)$ be the three-dimensional projective space over the finite field $\mathbb{F}_{q}$ with $q$ elements. A $(q+1)$-arc of $\mathrm{PG}(3, q)$ is a set of $q+1$ points of $\mathrm{PG}(3, q)$ no four in a plane. If $q=2^{n}$, a $(q+1)$-arc of $\mathrm{PG}(3, q)$ is projectively equivalent to the pointset

\mathcal{A}=\left\{P_{t}=\left(1, t, t^{2^{h}}, t^{2^{h}+1}\right) \mid t \in \mathbb{F}_{q}\right\} \cup\{(0,0,0,1)\}, \tag{1.1}
\end{equation*}
$$

where $\operatorname{gcd}(n, h)=1$. If $h=1$, then $\mathcal{A}$ is called twisted cubic and if $q$ is odd every $(q+1)$-arc of $\mathrm{PG}(3, q)$ is a twisted cubic. Moreover $\mathcal{A}$ and $\left\{\left(1, t, t^{2^{n-h}}, t^{2^{n-h}+1}\right) \mid t \in \mathbb{F}_{q}\right\} \cup\{(0,0,0,1)\}$ are projectively equivalent. The subgroup of $\operatorname{PGL}(4, q)$ stabilizing $\mathcal{A}$, say $G_{h}$, is isomorphic to $\operatorname{PGL}(2, q)$ whenever $q>4$, and contains a subgroup isomorphic to $\operatorname{PGL}(2, q)$ if $q \leq 4$. For more details on $(q+1)$-arcs of $\mathrm{PG}(3, q)$ the reader is referred to [9, Chapter 21].

Several authors dealt with the action of the group $G_{1}$ on points, lines and planes of $\operatorname{PG}(3, q)$ and the determination of their related incidence matrices. Indeed, a comprehensive understanding of this topic is of some interest in purely geometric terms [4, 5, 6, 7]; in particular the classification of $G_{1}$-orbits on lines of $\mathrm{PG}(3, q)$ is equivalent to the classification of pencils of cubics in $\mathrm{PG}(1, q)$, see [8]. Moreover aspects of these problems are related and have been applied in coding theory in order to obtain asymptotically optimal multiple covering codes [1] , or to study

[^0]the weight distribution of the cosets of $\mathcal{C}$ [3], or to compute the coset leader weight enumerator of $\mathcal{C}$ [2], where $\mathcal{C}$ is the generalized Reed-Solomon code associated with a twisted cubic.

In this paper we assume $q=2^{n}$. In Section 3, we show that, similarly to the case $h=1$, the group $G_{h}$ has five orbits on points on $\mathrm{PG}(3, q)$ and that the point-plane incidence matrix with respect to the $G_{h}$-orbits on points and planes of $\operatorname{PG}(3, q)$ mirrors the case $h=1$, which was computed in [1]. If $q \not \equiv 0(\bmod 3)$, the group $G_{h}$ fixes a symplectic polarity of $\operatorname{PG}(3, q)$ and hence to each $G_{h}$-orbit on points there corresponds a $G_{h}$-orbit on planes of $\operatorname{PG}(3, q)$.

In Section 4 , we show that the group $G_{h}$ has $2 q+7+\xi$ orbits on lines of $\mathrm{PG}(3, q)$, providing a proof of [7, Conjecture 8.2] in the even characteristic case. Finally the point-line incidence matrix with respect to the $G_{1}$-orbits on points and lines of $\operatorname{PG}(3, q)$ is considered. For a line $\ell$ belonging to a given line $G_{1}$-orbits, say $\mathcal{L}$, the point $G_{1}$-orbit distribution of $\ell$ is either explicitly computed or it is shown to depend on the number of elements $x$ in $\mathbb{F}_{q}$ (or in a subset of $\mathbb{F}_{q}$ ) such that $\operatorname{Tr}_{q \mid 2}(g(x))=0$, where $g$ is an $\mathbb{F}_{q}$-map determined by $\mathcal{L}$.

## 2 Preliminaries

Let $q=2^{n}$ and let $\mathbb{F}_{q}$ be the finite field of order $q$. Let $\mathrm{PG}(3, q)$ be the three-dimensional projective space over $\mathbb{F}_{q}$ equipped with homogeneous projective coordinates ( $X_{1}, X_{2}, X_{3}, X_{4}$ ). Denote by $U_{i}$ the point having 1 in the $i$-th position and 0 elsewhere.

Let $\mathcal{W}(3, q)$ be the symplectic polar space consisting of the subspaces of $\mathrm{PG}(3, q)$ represented by the totally isotropic subspaces of $\mathbb{F}_{q}^{4}$ with respect to the non-degenerate alternating form $\beta$ given by

$$
x_{1} y_{4}+x_{2} y_{3}+x_{3} y_{2}+x_{4} y_{1} .
$$

The subspaces of $\mathcal{W}(3, q)$ of maximum dimension are lines and are called generators. Denote by $\mathfrak{s}$ the symplectic polarity of $\operatorname{PG}(3, q)$ defining $\mathcal{W}(3, q)$.

Let $h$ be a positive integer such that $\operatorname{gcd}(h, n)=1$ and consider the $(q+1)$-arc of $\mathrm{PG}(3, q)$ given by (1.1). This means that $\mathcal{A}$ consists of $q+1$ points of $\operatorname{PG}(3, q)$ such that no four of them are coplanar. For $h=1$ or $h=n-1, \mathcal{A}$ is a twisted cubic of $\operatorname{PG}(3, q)$. A line of $\operatorname{PG}(3, q)$ joining two distinct points of $\mathcal{A}$ is called a real chord. Let $\overline{\mathcal{A}}$ be given by

\left\{\bar{P}_{t}=\left(1, t, t^{2^{h}}, t^{2^{h}+1}\right) \mid t \in \mathbb{F}_{q^{2}}\right\} \cup\left\{U_{4}\right\} & \text { if } h \text { is odd, } \\
\left\{\bar{P}_{t}=\left(1, t, t^{2^{n+h}}, t^{2^{n+h}+1}\right) \mid t \in \mathbb{F}_{q^{2}}\right\} \cup\left\{U_{4}\right\} & \text { if } h \text { is even. } \tag{2.1}
\end{array}
$$

It holds that $\overline{\mathcal{A}}$ is a $\left(q^{2}+1\right)$-arc of $\operatorname{PG}\left(3, q^{2}\right)$ and $\mathcal{A}$ is embedded in $\overline{\mathcal{A}}$. The line of $\operatorname{PG}\left(3, q^{2}\right)$ obtained by joining $\bar{P}_{t}$ and $\bar{P}_{t}$, with $t \in \mathbb{F}_{q^{2}} \backslash \mathbb{F}_{q}$, meets the canonical Baer subgeometry $\operatorname{PG}(3, q)$ in the $q+1$ points of a line skew to $\mathcal{A}$. Such a line is called an imaginary chord. If $r$ is a (real or imaginary) chord, then the line $r^{5}$ is called (real or imaginary) axis. For each point $P \in \mathcal{A}$, the tangent line to $\mathcal{A}$ at $P$ is the line $\ell_{P}=\left\langle P, P^{\prime}\right\rangle$, with $P^{\prime}=\left(0,1,0, t^{2^{h}}\right)$ if $P=P_{t}$ and $P^{\prime}=U_{3}$ if $P=U_{4}$. At each point $P_{t}$ (resp. $U_{4}$ ) of $\mathcal{A}$ there corresponds the osculating plane $P_{t}^{\mathfrak{s}}$ (resp. $U_{4}^{\mathfrak{s}}$ ) with equation $t^{2^{h}+1} X_{1}+t^{2^{h}} X_{2}+t X_{3}+X_{4}=0\left(\right.$ resp. $X_{1}=0$ ), meeting $\mathcal{A}$ only at $P_{t}$ (resp. $U_{4}$ ) and containing the tangent line $\ell_{P_{t}}$ (resp. $\ell_{U_{4}}$ ). Hence the $q+1$ lines tangent to $\mathcal{A}$ are generators
of $\mathcal{W}(3, q)$ and they form a regulus of the hyperbolic quadric $\mathcal{Q}^{+}(3, q): X_{1} X_{4}+X_{2} X_{3}=0$. There are $q(q+1) / 2$ real chords and $q(q-1) / 2$ imaginary chords. Tangents, real chords and imaginary chords are all the chords of $\mathcal{A}$.

The group $G_{h}$ of projectivities of $\operatorname{PG}(3, q)$ stabilizing $\mathcal{A}$ is isomorphic to $\operatorname{PGL}(2, q)$ whenever $q \geq 5$, and the elements of $G_{h}$ are represented by the matrices

$$
M_{a, b, c, d}=\left(\begin{array}{cccc}
a^{2^{h}+1} & a^{2^{h}} b & a b^{2^{h}} & b^{2^{h}+1} \\
a^{2^{h}} c & a^{2^{h}} d & b^{2^{h}} c & b^{2^{h}} d \\
a c^{2^{h}} & b c^{2^{h}} & a d^{2^{h}} & b d^{2^{h}} \\
c^{2^{h}+1} & c^{2^{h}} d & c d^{2^{h}} & d^{2^{h}+1}
\end{array}\right)
$$

where $a, b, c, d \in \mathbb{F}_{q}$ and $a d+b c=1$. This group leaves $\mathcal{W}(3, q)$ invariant, being $M_{a, b, c, d}^{t} J M_{a, b, c, d}=$ $J$, where

$$
J=\left(\begin{array}{llll}
0 & 0 & 0 & 1 \\
0 & 0 & 1 & 0 \\
0 & 1 & 0 & 0 \\
1 & 0 & 0 & 0
\end{array}\right)
$$

is the Gram matrix of $\beta$. We will denote by $\bar{G}_{h}$ or $\bar{G}_{n+h}$ the subgroup of $\operatorname{PGL}\left(4, q^{2}\right)$ fixing $\overline{\mathcal{A}}$, depending on $h$ is odd or even. In both cases their elements are represented by the matrices $M_{a, b, c, d}$, with $a, b, c, d \in \mathbb{F}_{q^{2}}$ and $a d+b c=1$. For more properties on $(q+1)$-arcs in even characteristic, we refer the readers to [9, Section 21.3].

## 3 Point orbits

In this section, we study the orbits on points and planes under the action of $G_{h}$. We start by proving that each point of $\operatorname{PG}(3, q) \backslash \mathcal{A}$ lies on exactly one chord of $\mathcal{A}$, similarly to the case $h \in\{1, n-1\}$, see [9, Theorem 21.1.9].

Proposition 3.1. Every point of $\mathrm{PG}(3, q) \backslash \mathcal{A}$ lies on exactly one chord of $\mathcal{A}$.
Proof. The points on tangent lines form the hyperbolic quadric $\mathcal{Q}^{+}(3, q)$ and they are $(q+1)^{2}$ in number.

If two real chords meet, then their intersection point belongs to $\mathcal{A}$. Indeed, assume by contradiction that $s, s^{\prime}$ are two real chords which meet in a point $P \notin \mathcal{A}$, then these two lines generate a plane containing four points of $\mathcal{A}$, contradicting the fact that $\mathcal{A}$ is a $(q+1)$-arc. Every real chord has $q-1$ points not in common with $\mathcal{A}$ and a real chord meets $\mathcal{Q}^{+}(3, q)$ in points of $\mathcal{A}$. Since there are $q(q+1) / 2$ real chords, it follows that there are $\left(q^{3}-q\right) / 2$ points of $\mathrm{PG}(3, q) \backslash \mathcal{A}$ lying on real chords.

An imaginary chord of $\mathcal{A}$, when extended in $\operatorname{PG}\left(3, q^{2}\right)$, meets $\overline{\mathcal{A}} \backslash \mathcal{A}$ in two points. Hence, two imaginary chords or a real chord and an imaginary one cannot meet outside $\mathcal{A}$, otherwise, when extended in $\operatorname{PG}\left(3, q^{2}\right)$, they would span a plane of $\operatorname{PG}\left(3, q^{2}\right)$ containing four points of $\overline{\mathcal{A}}$, a contradiction. Let $\mathcal{Q}^{+}\left(3, q^{2}\right)$ denote the hyperbolic quadric of $\operatorname{PG}\left(3, q^{2}\right)$ such that $\mathcal{Q}^{+}\left(3, q^{2}\right) \cap$ $\operatorname{PG}(3, q)=\mathcal{Q}^{+}(3, q)$. It is easily seen that an imaginary chord meets $\mathcal{Q}^{+}\left(3, q^{2}\right)$ in points of $\overline{\mathcal{A}} \backslash \mathcal{A}$. Hence an imaginary chord has empty intersection with $\mathcal{Q}^{+}(3, q)$. Since there are $q(q-1) / 2$ imaginary chords, there are $\left(q^{3}-q\right) / 2$ points of $\mathrm{PG}(3, q) \backslash \mathcal{A}$ lying on imaginary chords.

Proposition 3.2. The group $G_{h}$ has five orbits on points of $\operatorname{PG}(3, q)$ :

- $\mathcal{A}$ of size $q+1$;
- $\mathcal{O}_{0}$ of size $\left(q^{3}-q\right) / 3$, consisting of points not contained in any osculating plane;
- $\mathcal{O}_{1}$ of size $\left(q^{3}-q\right) / 2$, consisting of points on exactly one osculating plane;
- $\mathcal{O}_{2}=\mathcal{Q}^{+}(3, q) \backslash \mathcal{A}$ of size $q^{2}+q$, consisting of points on exactly two osculating planes;
- $\mathcal{O}_{3}$ of size $\left(q^{3}-q\right) / 6$, consisting of points on exactly three osculating planes.

Proof. Taking into account Proposition 3.1, it is enough to determine the orbits of $G$ on points of $\mathrm{PG}(3, q) \backslash \mathcal{A}$ lying on chords of $\mathcal{A}$. Moreover the group $G_{h}$ acts transitively on tangent lines, real chords and imaginary chords of $\mathcal{A}$. Let $\ell$ be a chord of $\mathcal{A}$.

If $\ell$ is tangent we choose $\ell=\left\langle U_{1}, U_{2}\right\rangle$ and consider the point $U_{2} \in \ell \backslash \mathcal{A}$. The projectivities of $G_{h}$ stabilizing $U_{2}$ are represented by the matrices $M_{d^{-1}, 0,0, d}, d \in \mathbb{F}_{q} \backslash\{0\}$. Hence $\left|\operatorname{Stab}_{G_{h}}\left(U_{2}\right)\right|=$ $q-1$ and $\left|U_{2}{ }^{G_{h}}\right|=q^{2}+q=\left|\mathcal{Q}^{+}(3, q) \backslash \mathcal{A}\right|$. The point $U_{2}$ belongs to $U_{1}^{\mathcal{S}}$ and $U_{4}^{\mathfrak{s}}$ and to no other osculating plane.

If $\ell$ is a real chord, we consider $\ell=\left\langle U_{1}, U_{4}\right\rangle$. The stabilizer of $\ell$ in $G_{h}$ has order $2(q-1)$ and it is generated by the projectivities represented by the matrices $M_{0,1,1,0}$ and $M_{d^{-1}, 0,0, d}$, $d \in \mathbb{F}_{q} \backslash\{0\}$. Let $x \in \mathbb{F}_{q} \backslash\{0\}$ and let $Q=U_{1}+x U_{4} \in \ell \backslash \mathcal{A}$. We will prove that

$$
\left|\operatorname{Stab}_{G_{h}}(Q)\right|= \begin{cases}2 & \text { if } q \equiv-1 \quad(\bmod 3), \\ 3 & \text { if } q \equiv 1 \quad(\bmod 3) \text { and } x \text { is not a cube in } \mathbb{F}_{q}, \\ 6 & \text { if } q \equiv 1 \quad(\bmod 3) \text { and } x \text { is a cube in } \mathbb{F}_{q} .\end{cases}
$$

A projectivity represented by $M_{d^{-1}, 0,0, d}$ fixes $Q$ if and only if $d^{2^{h}+1}=1$ which has $\operatorname{gcd}\left(2^{h}+\right.$ $\left.1,2^{n}-1\right)$ solutions. Since

$$
\operatorname{gcd}\left(2^{h}+1,2^{n}-1\right)= \begin{cases}3 & \text { if } n \text { is even } \\ 1 & \text { if } n \text { is odd }\end{cases}
$$

the number of these projectivities fixing $Q$ equals three or one according as $q \equiv 1$ or $-1(\bmod 3)$, respectively. Similarly, a projectivity represented by $M_{0, d^{-1}, d, 0}$ fixes $Q$ if and only if

$$
\begin{equation*}
d^{2^{h}+1}=x . \tag{3.1}
\end{equation*}
$$

Equation (3.1) admits a solution if and only if $x^{\frac{2^{n}-1}{\operatorname{gcd}\left(2^{h}+1,2^{n}-1\right)}}=1$ and in that case it has $\operatorname{gcd}\left(2^{h}+\right.$ $\left.1,2^{n}-1\right)$ solutions. Therefore, if $q \equiv 1(\bmod 3)$, the number of these projectivities fixing $Q$ is three or zero according as $x$ is a cube in $\mathbb{F}_{q}$ or not, whereas if $q \equiv-1(\bmod 3)$ exactly one of these projectivities leaves $Q$ invariant. The point $Q$ belongs to the osculating plane $P_{t}^{\mathfrak{s}}$ if and only if $t^{2^{h}+1}=x$. Hence it lies on one osculating plane if $q \equiv-1(\bmod 3)$, whereas if $q \equiv 1$ $(\bmod 3)$ on three or none osculating planes according as $x$ is a cube or not in $\mathbb{F}_{q}$.

If $\ell$ is an imaginary chord, we consider the $\left(q^{2}+1\right)$-arc $\overline{\mathcal{A}}$ of $\mathrm{PG}\left(3, q^{2}\right)$ given by (2.1) and the non-canonical Baer subgeometry $\Sigma$

$$
\left\{\left(\alpha, \beta, \beta^{q}, \alpha^{q}\right): \alpha, \beta \in \mathbb{F}_{q^{2}},(\alpha, \beta) \neq(0,0)\right\} .
$$

Some straightforward computations show that the intersection of $\overline{\mathcal{A}}$ with $\Sigma$ is the $(q+1)$-arc of $\Sigma$ consisting of the points $\bar{P}_{t}, t \in \mathbb{F}_{q^{2}}, t^{q+1}=1$. The projectivities fixing $\overline{\mathcal{A}} \cap \Sigma$ belong to $\bar{G}_{h}$, if $h$ is odd, or to $\bar{G}_{n+h}$, if $h$ is even, and are those represented by the matrices $M_{a, b, c, d}$ with $a, b, c, d \in \mathbb{F}_{q^{2}}, a d+b c=1, c d^{q}+a b^{q}=0$ and $a^{q+1}+b^{q+1}+c^{q+1}+d^{q+1}=0$. Denote by $S$ the group $\operatorname{Stab}_{\bar{G}_{h}}(\Sigma)$ if $h$ is odd or $\operatorname{Stab}_{\bar{G}_{n+h}}(\Sigma)$ if $h$ is even. Note that $G_{h}$ and $S$ are conjugated in $\bar{G}_{h}$ or $\bar{G}_{n+h}$. In this setting, $\ell=\left\langle U_{1}, U_{4}\right\rangle_{q^{2}} \cap \Sigma$ is an imaginary chord of $\overline{\mathcal{A}} \cap \Sigma$. The stabilizer of $\ell$ in $S$ has order $2(q+1)$ and it is generated by the projectivities represented by the matrices $M_{0,1,1,0}$ and $M_{d^{-1}, 0,0, d}, d \in \mathbb{F}_{q^{2}}$, with

$$
\begin{equation*}
d^{2^{n}+1}=1 . \tag{3.2}
\end{equation*}
$$

Fix $\alpha \in \mathbb{F}_{q^{2}} \backslash\{0\}$ and set $R=U_{1}+\alpha^{q-1} U_{4} \in \ell$. We show that

$$
\left|\operatorname{Stab}_{S}(R)\right|= \begin{cases}2 & \text { if } q \equiv 1 \quad(\bmod 3), \\ 3 & \text { if } q \equiv-1 \quad(\bmod 3) \text { and } \alpha^{q-1} \text { is not a cube in } \mathbb{F}_{q^{2}}, \\ 6 & \text { if } q \equiv-1 \quad(\bmod 3) \text { and } \alpha^{q-1} \text { is a cube in } \mathbb{F}_{q^{2}} .\end{cases}
$$

A projectivity represented by $M_{d^{-1}, 0,0, d}$ fixes $R$ if and only if

$$
\begin{array}{ll}
d^{2^{h}+1}=1 & \text { if } h \text { is odd } \\
d^{2^{n+h}+1}=1 & \text { if } h \text { is even } \tag{3.3}
\end{array}
$$

Let $\bar{\omega}$ be a primitive element of $\mathbb{F}_{q^{2}}$ and set $d=\bar{\omega}^{i}$. Since $\operatorname{gcd}\left(2^{h}+1,2^{2 n}-1\right)=3$ if $h$ is odd and $\operatorname{gcd}\left(2^{n+h}+1,2^{2 n}-1\right)=3$ if $h$ is even, equation (3.3) is satisfied by

$$
i \equiv \frac{t\left(2^{2 n}-1\right)}{3} \quad\left(\bmod 2^{2 n-1}\right), t=0,1,2 .
$$

If $q \equiv-1(\bmod 3)$, these three solutions satisfy (3.2), whereas if $q \equiv 1(\bmod 3)$, the unique solution fulfilling (3.2) occurs for $t=0$. Therefore there are three or one of these projectivities stabilizing $R$ depending on $q \equiv-1$ or $1(\bmod 3)$, respectively. Similarly, a projectivity represented by $M_{0, d^{-1}, d, 0}$ fixes $R$ if and only if

$$
\begin{array}{ll}
d^{-\left(2^{h}+1\right)}=\alpha^{q-1} & \text { if } h \text { is odd }, \\
d^{-\left(2^{n+h}+1\right)}=\alpha^{q-1} & \text { if } h \text { is even } . \tag{3.4}
\end{array}
$$

In this case, if $\alpha=\bar{\omega}^{k}$, equation (3.4) admits a solution if and only if 3 divides $k\left(2^{n}-1\right)$. Assume that 3 divides $k\left(2^{n}-1\right)$, then (3.4) has the three solutions

$$
i \equiv \frac{-k\left(2^{n}-1\right) u_{0}+t\left(2^{2 n}-1\right)}{3} \quad\left(\bmod 2^{2 n-1}\right), t=0,1,2,
$$

where $u_{0}$ is an integer such that $\left(2^{h}+1\right) u_{0}+\left(2^{2 n}-1\right) v_{0}=3$, if $h$ is odd and $\left(2^{n+h}+1\right) u_{0}+$ $\left(2^{2 n}-1\right) v_{0}=3$, if $h$ is even. If $q \equiv-1(\bmod 3)$, these three solutions satisfy (3.2), whereas if $q \equiv 1(\bmod 3)$, exactly one of these three solutions satisfies (3.2). It follows that, if $q \equiv-1$ $(\bmod 3)$, the number of these projectivities fixing $R$ is three or zero according as $\alpha^{q-1}$ is a cube in $\mathbb{F}_{q^{2}}$ or not, whereas if $q \equiv 1(\bmod 3)$ exactly one of these projectivities leaves invariant $R$. The point $R$ belongs to the osculating plane $\bar{P}_{t}^{\mathscr{S}}$ if and only if

$$
\begin{array}{ll}
t^{2^{h}+1}=\alpha^{q-1} & \text { if } h \text { is odd, } \\
t^{2^{n+h}+1}=\alpha^{q-1} & \text { if } h \text { is even }
\end{array}
$$

for some $t \in \mathbb{F}_{q^{2}}$, with $t^{q+1}=1$. Hence it lies on one osculating plane if $q \equiv 1(\bmod 3)$, whereas if $q \equiv-1(\bmod 3)$ on three or none osculating planes according as $\alpha^{q-1}$ is a cube or not in $\mathbb{F}_{q^{2}}$.

Corollary 3.3. If $q \equiv 1(\bmod 3)$, the points of $\mathcal{A} \cup \mathcal{O}_{0} \cup \mathcal{O}_{3}$ are on the real chords and those of $\mathcal{O}_{1}$ on the imaginary chords. If $q \equiv-1(\bmod 3)$, the points of $\mathcal{O}_{0} \cup \mathcal{O}_{3}$ are on the imaginary chords and those of $\mathcal{A} \cup \mathcal{O}_{1}$ on the real chords.

The $G_{h}$-orbits on planes of $\mathrm{PG}(3, q)$ can be described by using the symplectic polarity $\mathfrak{s}$ of $\mathrm{PG}(3, q)$ defining $\mathcal{W}(3, q)$. Let $\mathcal{O}_{j}^{\mathfrak{s}}=\left\{P^{\mathfrak{s}} \mid P \in \mathcal{O}_{j}\right\}$.

Proposition 3.4. The group $G_{h}$ has five orbits on planes of $\operatorname{PG}(3, q)$ :

- The $q+1$ osculating planes;
- $\mathcal{O}_{0}^{5}$ of size $\left(q^{3}-q\right) / 3$, consisting of planes containing no point of $\mathcal{A}$;
- $\mathcal{O}_{1}^{5}$ of size $\left(q^{3}-q\right) / 2$, consisting of planes containing one point of $\mathcal{A}$;
- $\mathcal{O}_{2}^{\mathfrak{s}}$ of size $q^{2}+q$, consisting of planes containing two points of $\mathcal{A}$;
- $\mathcal{O}_{3}^{\mathbf{5}}$ of size $\left(q^{3}-q\right) / 6$, consisting of planes containing three point of $\mathcal{A}$.


### 3.1 Point plane distribution

In the case when $\mathcal{A}$ is a twisted cubic, the point plane distribution has been determined in [1]. Most of the combinatorial arguments used in [1] can be adapted to the general case of a $(q+1)$-arc $\mathcal{A}$. Set $\mathcal{O}_{q+1}=\mathcal{A}$. Denote by $r_{i, j}$ the number of planes in $\mathcal{O}_{j}^{\mathcal{S}}$ through a point in $\mathcal{O}_{i}$ and by $k_{i, j}$ the number of points of $\mathcal{O}_{i}$ in a plane of $\mathcal{O}_{j}^{\mathfrak{5}}$. Hence

$$
\begin{equation*}
\left|\mathcal{O}_{i}\right| r_{i, j}=\left|\mathcal{O}_{j}^{\mathfrak{s}}\right| k_{i, j} \tag{3.5}
\end{equation*}
$$

Note that

$$
r_{0, q+1}=0, r_{q+1, q+1}=r_{1, q+1}=1, r_{2, q+1}=2, r_{3, q+1}=3
$$

by Proposition 3.2, Since a plane meets $\mathcal{A}$ in at most three points, taking into account Proposition [3.1, the following results can be easily deduced.

Lemma 3.5. Through a real chord of $\mathcal{A}$ there pass $q-1$ planes of $\mathcal{O}_{3}^{\mathfrak{s}}$ and two planes of $\mathcal{O}_{2}^{\mathfrak{5}}$, whereas through an imaginary chord of $\mathcal{A}$ there pass $q+1$ planes of $\mathcal{O}_{1}^{\mathfrak{s}}$.

Lemma 3.6. The following hold.

1) $r_{i, q+1}+r_{i, 1}+2 r_{i, 2}+3 r_{i, 3}=(q+1)^{2}, i \in\{0,1,2,3\}$.
2) For $q \equiv 1(\bmod 3)$, it holds

$$
\begin{aligned}
& r_{2,2}+3 r_{2,3}=r_{1,2}+3 r_{1,3}=\frac{q(q+1)}{2} \\
& r_{0,2}+3 r_{0,3}=r_{3,2}+3 r_{3,3}=\frac{q(q+3)}{2}
\end{aligned}
$$

3) For $q \equiv-1(\bmod 3)$, it holds

$$
\begin{aligned}
& r_{2,2}+3 r_{2,3}=r_{0,2}+3 r_{0,3}=r_{3,2}+3 r_{3,3}=\frac{q(q+1)}{2} \\
& r_{1,2}+3 r_{1,3}=\frac{q(q+3)}{2}
\end{aligned}
$$

Proof. To prove 1), let $P$ be a point of $\mathrm{PG}(3, q) \backslash \mathcal{A}$ and let us count in two ways the pairs $(Q, \sigma)$, where $Q$ is a point of $\mathcal{A}, \sigma$ is a plane and the line $\langle P, Q\rangle$ is contained in $\sigma$. The point $Q$ can be chosen in $q+1$ ways and for a fixed $Q$ there are $q+1$ planes containing both $P$ and $Q$. Hence on the one hand there are $(q+1)^{2}$ pairs. On the other hand, if $P \in \mathcal{O}_{i}$, where $i \in\{0,1,2,3\}$, then the number of these pairs equals $r_{i, q+1}+r_{i, 1}+2 r_{i, 2}+3 r_{i, 3}$.

In order to show 2) and 3), by Corollary 3.3, it is enough to verify that

$$
r_{i, 2}+3 r_{i, 3}= \begin{cases}\frac{q(q+1)}{2} & \text { if } \mathcal{O}_{i} \text { consists of points not on real chords } \\ \frac{q(q+3)}{2} & \text { if } \mathcal{O}_{i} \text { consists of points off } \mathcal{A} \text { on real chords. }\end{cases}
$$

Let $P$ be a point of $\mathrm{PG}(3, q) \backslash \mathcal{A}$ and let us count in two ways the pairs $(\ell, \sigma)$, where $\ell$ is a real chord, $P \notin \ell$ and $\sigma=\langle P, \ell\rangle$ is a plane such that $|\sigma \cap \mathcal{A}| \in\{2,3\}$. If $P$ does not belong to any real chord, then each of the $q(q+1) / 2$ real chords gives rise to a plane $\sigma$ which contains either one or three real chords. Hence equation $r_{i, 2}+3 r_{i, 3}=q(q+1) / 2$ follows. If $P$ belongs to the real chord $r$, then each of the $q(q+1) / 2-1$ real chords distinct from $r$ spans with $P$ a plane $\sigma$. By Lemma 3.5, among these planes there are $q-1$ of them which contain precisely two chords distinct from $r$. Therefore in this case

$$
\left(r_{i, 2}-2\right)+3\left(r_{i, 3}-(q-1)\right)+2(q-1)=\frac{q(q+1)}{2}-1
$$

holds true and equation $r_{i, 2}+3 r_{i, 3}=q(q+3) / 2$ follows.
Proposition 3.7.

$$
r_{q+1, d}= \begin{cases}1 & \text { if } d=q+1 \\ 0 & \text { if } d=0 \\ \frac{q(q-1)}{2} & \text { if } d \in\{1,3\} \\ 2 q & \text { if } d=2\end{cases}
$$

Proof. The value $r_{q+1,0}$, is easily determined. Through a point $Q \in \mathcal{A}$ there are $q$ real chords. By Lemma 3.5, through a real chord there pass two planes of $\mathcal{O}_{2}^{5}$ and $q-1$ planes of $\mathcal{O}_{3}^{5}$. Therefore $r_{q+1,2}=2 q$ and $r_{q+1,3}=q(q-1) / 2$, since a plane of $\mathcal{O}_{3}$ contains two real chords through $Q$. Finally $r_{q+1,1}=q^{2}+q+1-(1-2 q-q(q-1) / 2)=q(q-1) / 2$.

Proposition 3.8. If $q \equiv \xi(\bmod 3), \xi \in\{ \pm 1\}$, then

$$
r_{1, d}=\left\{\begin{array}{ll}
1 & \text { if } d=q+1, \\
\frac{q(q-\xi)}{3} & \text { if } d=0, \\
\frac{q(q+\xi)}{2} & \text { if } d=1, \\
q & \text { if } d=2, \\
\frac{q(q-\xi)}{6} & \text { if } d=3 .
\end{array} \quad r_{2, d}= \begin{cases}2 & \text { if } d=q+1, \\
\frac{q^{2}-1}{3} & \text { if } d=0, \\
\frac{q(q-1)}{2} & \text { if } d=1, \\
\frac{2 q-1}{} & \text { if } d=2, \\
\frac{q^{2}-3 q+2}{6} & \text { if } d=3 .\end{cases}\right.
$$

Proof. By Corollary [3.3, if $q \equiv 1(\bmod 3)($ or $q \equiv-1(\bmod 3)), \mathcal{O}_{1}$ consists of the points on imaginary chords (or, together with $\mathcal{A}$, of the points on real chords). On the other hand, by Lemma 3.5, a plane $\sigma$ in $\mathcal{O}_{0}^{5}$ does not contain any imaginary (or real) chord and hence each of the $q(q-1) / 2$ (or $q(q+1) / 2$ ) imaginary (or real) chords of $\mathcal{A}$ has exactly one point in common with $\sigma$. It follows that Equation 3.5reads as $\frac{q\left(q^{2}-1\right)}{2} r_{1,0}=\frac{q\left(q^{2}-1\right)}{3} \frac{q(q-\xi)}{2}$ and therefore $r_{1,0}=q(q-\xi) / 3$. As a consequence we have that $1+r_{1,1}+r_{1,2}+r_{1,3}=q^{2}+q+1-q(q-\xi) / 3=\left(2 q^{2}+(3+\xi) q+3\right) / 3$, which combined with Lemma 3.6 1), 2) (or Lemma 3.6 1), 3)), gives the required values of $r_{1,1}, r_{1,2}, r_{1,3}$.

Analogously, no tangent line is contained in a plane $\sigma$ of $\mathcal{O}_{0}^{5}$ and hence each of the $q+1$ tangent lines has exactly one point in common with $\sigma$. In this case Equation 3.5 becomes as $q(q+1) r_{2,0}=\frac{q\left(q^{2}-1\right)}{3}(q+1)$ and therefore $r_{2,0}=\left(q^{2}-1\right) / 3$. Moreover, $2+r_{2,1}+r_{2,2}+r_{2,3}=$ $q^{2}+q+1-\left(q^{2}-1\right) / 3=\left(2 q^{2}+3 q+4\right) / 3$, which together with Lemma 3.6 1), 2), 3) provides the values of $r_{2,1}, r_{2,2}, r_{2,3}$.

Proposition 3.9. If $q \equiv \xi(\bmod 3), \xi \in\{ \pm 1\}$, then

$$
r_{0, d}=\left\{\begin{array}{ll}
0 & \text { if } d=q+1, \\
\frac{q^{2}+\xi q+1}{3} & \text { if } d=0, \\
\frac{q(q-\xi)}{2} & \text { if } d=1, \\
q+1 & \text { if } d=2, \\
\frac{q^{2}+\xi q-2}{6} & \text { if } d=3 .
\end{array} \quad r_{3, d}= \begin{cases}3 & \text { if } d=q+1, \\
\frac{q^{2}+\xi q-2}{3} & \text { if } d=0, \\
\frac{q(q-\xi)}{2} & \text { if } d=1, \\
q-2 & \text { if } d=2, \\
\frac{q^{2}+\xi q+4}{6} & \text { if } d=3 .\end{cases}\right.
$$

Proof. First we determine $r_{3,3}$ and $r_{0,3}$. Fix a plane $\sigma$ in $\mathcal{O}_{3}^{5}$ and let us count in two ways the pairs $(Q, \gamma)$, where $Q$ is a point, $\gamma$ is an osculating plane and $Q \in \sigma \cap \gamma$. Since there are $q+1$ osculating planes and for each of these planes there are $q+1$ choices for the point $Q$, we have $(q+1)^{2}$ of such pairs. On the other hand, $\sigma$ contains 3 points of $\mathcal{A}, q(q-\xi) / 2$ points of $\mathcal{O}_{1}$, $q-2$ points of $\mathcal{O}_{2}$ and $k_{3,3}$ points of $\mathcal{O}_{3}$. It follows that

$$
1 \times 3+1 \times \frac{q(q-\xi)}{2}+2 \times(q-2)+3 \times k_{3,3}=(q+1)^{2}
$$

Therefore $k_{3,3}=\left(q^{2}+\xi q+4\right) / 6$ and $k_{0,3}=q^{2}+q+1-3-q(q-\xi) / 2-(q-2)-\left(q^{2}+\xi q+4\right) / 6=$ $\left(q^{2}+\xi q-2\right) / 3$. By using Equation (3.5), we get $r_{3,3}=\left(q^{2}+\xi q+4\right) / 6$ and $r_{0,3}=\left(q^{2}+\xi q-2\right) / 6$.

Next, the values $r_{0,2}, r_{3,2}$ can be recovered from Lemma 3.6 2), 3), $r_{0,1}, r_{3,1}$ from Lemma 3.6 1) and $r_{0,0}, r_{3,0}$ by difference.

The results so obtained are summarized in Tables 1 and 2, where $q \equiv \xi(\bmod 3), \xi \in\{ \pm 1\}$.

## 4 Line orbits

In this section we determine the orbits of $G_{h}$ on the lines of $\mathrm{PG}(3, q)$. In order to do that we consider the Plücker correspondence, which sends the lines of $\operatorname{PG}(3, q)$ to the points of the Klein quadric

$$
\mathcal{Q}^{+}(5, q): X_{1} X_{6}+X_{2} X_{5}+X_{3} X_{4}=0 .
$$

Under this embedding, the $q+1$ lines tangent to $\mathcal{A}$ are mapped to the $q+1$ points of the conic

$$
\mathcal{X}=\pi \cap \mathcal{Q}^{+}(5, q)=\left\{\left(1,0, t, t, 0, t^{2}\right) \mid t \in \mathbb{F}_{q}\right\} \cup\{(0,0,0,0,0,1)\},
$$

whereas the lines of the opposite regulus of $\mathcal{Q}^{+}(3, q)$ are mapped to the points of the conic

$$
\mathcal{X}^{\prime}=\pi^{\perp} \cap \mathcal{Q}^{+}(5, q)=\left\{\left(0,1, t, t, t^{2}, 0\right) \mid t \in \mathbb{F}_{q}\right\} \cup\{(0,0,0,0,1,0)\}
$$

Here $\pi$ denotes the plane $X_{2}=X_{5}=X_{3}+X_{4}=0$ and $\perp$ is the polarity of $\operatorname{PG}(5, q)$ associated with $\mathcal{Q}^{+}(5, q)$. The $(q+1)\left(q^{2}+1\right)$ generators of $\mathcal{W}(3, q)$ are sent to the points of the parabolic quadric $\mathcal{Q}(4, q)=\mathcal{Q}^{+}(5, q) \cap \Pi$, where $\Pi: X_{3}+X_{4}=0$. Moreover, under the Plücker map, points of $\mathcal{W}(3, q)$ correspond to lines of $\mathcal{Q}(4, q)$ and, hence, if $\ell$ is a line of $\operatorname{PG}(3, q)$ that is not a generator of $\mathcal{W}(3, q)$, then $\ell$ and $\ell^{\perp}$ are mapped to the two reguli of a hyperbolic quadric
contained in $\mathcal{Q}(4, q)$. To the group $G_{h}$, there corresponds a group $\tilde{G}_{h} \leq \mathrm{PGO}^{+}(6, q)$ represented by the matrices

$$
\tilde{M}_{a, b, c, d}=\left(\begin{array}{cccccc}
a^{2^{h+1}} & 0 & a^{2^{h}} b^{2^{h}} & a^{2^{h}} b^{2^{h}} & 0 & b^{2^{h+1}} \\
0 & a^{2} & a b & a b & b^{2} & 0 \\
a^{2^{h}} c^{2^{h}} & a c & b^{2^{h}} c^{2^{h}}+b c+1 & b^{2^{h}} c^{2^{h}}+b c & b d & b^{2^{h}} d^{2^{h}} \\
a^{2^{h}} c^{c^{h}} & a c & b^{2^{h}} c^{2^{h}}+b c & b^{2^{h}} c^{2^{h}}+b c+1 & b d & b^{2^{h}} d^{2^{h}} \\
0 & c^{2} & c d & c d & d^{2} & 0 \\
c^{2^{h+1}} & 0 & c^{2^{h}} d^{2^{h}} & c^{2^{h}} d^{2^{h}} & 0 & d^{2^{h+1}}
\end{array}\right)
$$

with $a, b, c, d \in \mathbb{F}_{q}, a d+b c=1$. Note that the group $\tilde{G}_{h}$ acts faithfully on both planes $\pi$ and $\pi^{\perp}$. Hence $\tilde{G}_{h}$ induces on $\pi$ (or $\pi^{\perp}$ ) a group isomorphic to $\operatorname{PGL}(2, q)$ acting in its natural representation on the $q+1$ point of $\mathcal{X}$ (or $\mathcal{X}^{\prime}$ ). Furthermore, the group $\tilde{G}_{h}$ fixes the parabolic quadric $\mathcal{Q}(4, q)$, each of the two conics $\mathcal{X}$ and $\mathcal{X}^{\prime}$ and the hypersurface $\mathcal{Y}$ of $\Pi$ :

$$
\mathcal{Y}=\left\{P \in \Pi \mid F_{h}(P)=0\right\}
$$

where

$$
F_{h}\left(X_{1}, X_{2}, X_{3}, X_{4}, X_{5}, X_{6}\right)=X_{1} X_{5}^{2^{h}}+X_{2}^{2^{h}} X_{6}
$$

The hypersurface $\mathcal{Y}$ consists of $q+1$ planes through the point $\Pi^{\perp}=(0,0,1,1,0,0)$. Each of these planes intersects $\mathcal{Q}(4, q)$ in exactly one of the following $q+1$ lines

$$
\left\langle\left(0,1, x, x, x^{2}, 0\right),\left(1,0, x^{2^{h}}, x^{2^{h}}, 0, x^{2^{h+1}}\right)\right\rangle, x \in \mathbb{F}_{q},\langle(0,0,0,0,1,0),(0,0,0,0,0,1)\rangle
$$

These $q+1$ lines are obtained by joining a point of $\mathcal{X}$ and a point of $\mathcal{X}^{\prime}$; they are pairwise disjoint and hence $|\mathcal{Y} \cap \mathcal{Q}(4, q)|=(q+1)^{2}$. Taking into account Proposition 3.2, the following result holds.

Proposition 4.1. The group $\tilde{G}_{h}$ has five orbits on lines of $\mathcal{Q}(4, q)$ :

- $\mathcal{L}_{q+1}$ of size $q+1$, consisting of the lines of $\mathcal{Y}$;
- $\mathcal{L}_{0}$ of size $\left(q^{3}-q\right) / 3$, consisting of lines disjoint to $\mathcal{Y}$;
- $\mathcal{L}_{1}$ of size $\left(q^{3}-q\right) / 2$, consisting of lines meeting $\mathcal{Y}$ in one point;
- $\mathcal{L}_{2}$ of size $q^{2}+q$, consisting of lines having two points in common with $\mathcal{Y}$;
- $\mathcal{L}_{3}$ of size $\left(q^{3}-q\right) / 6$, consisting of lines intersecting $\mathcal{Y}$ in three point.

Remark 4.2. Note that a line of $\mathcal{L}_{1}$ and $\mathcal{L}_{3}$ has no point in common with $\mathcal{X} \cup \mathcal{X}^{\prime}$, whereas each of the lines in $\mathcal{L}_{q+1}$ and $\mathcal{L}_{2}$ meets both $\mathcal{X}, \mathcal{X}^{\prime}$ in one point.

The $G_{h}$-action on lines of $\operatorname{PG}(3, q)$ is equivalent to the $\tilde{G}_{h}$-action on points and reguli of $\mathcal{Q}(4, q)$. Our goal is to describe these $\tilde{G}_{h}$-orbits. We first consider the $\tilde{G}_{h}$-orbits on points of $\mathcal{Q}(4, q)$.

Proposition 4.3. Let $q \equiv \xi(\bmod 3), \xi \in\{ \pm 1\}$. The group $\tilde{G}_{h}$ has $5+\xi$ orbits on points of $\mathcal{Q}(4, q)$ :

- 2 orbits, $\mathcal{X}$ and $\mathcal{X}^{\prime}$, of size $q+1$;
- one orbit, $\mathcal{Y} \cap\left(\mathcal{Q}(4, q) \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)\right)$, of size $q^{2}-1$;
- $2+\xi$ orbits on points of $\mathcal{Q}(4, q) \backslash \mathcal{Y}$ of size $\frac{q^{3}-q}{2+\xi}$.

Proof. Let $P=U_{5}+U_{6}$. Then $P \in \mathcal{Y} \cap\left(\mathcal{Q}(4, q) \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)\right)$ and $\operatorname{Stab}_{\tilde{G}_{h}}(P)$ is the group of order $q$ represented by the matrices $\tilde{M}_{1,0, c, 1}$, with $c \in \mathbb{F}_{q}$. Hence $\left|P^{\tilde{G}_{h}}\right|=q^{2}-1=\mid \mathcal{Y} \cap$ $\left(\mathcal{Q}(4, q) \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)\right) \mid$.

Let $P=U_{1}+U_{5}$. In this case $\operatorname{Stab}_{\tilde{G}_{h}}(P)$ is the group of order $2+\xi$ represented by the matrices $\tilde{M}_{d^{-1}, 0,0, d}$, with $d \in \mathbb{F}_{q}$ and $d^{2^{h}+1}=1$. Hence the group $\tilde{G}_{h}$ has one or three orbits on points of $\mathcal{Q}(4, q) \backslash \mathcal{Y}$ according as $\xi$ equals -1 or 1 , respectively. In the latter case the representatives of the orbits are $U_{1}+U_{5}, U_{1}+\omega U_{5}$ and $U_{1}+\omega^{2} U_{5}$, where $\omega$ is a primitive element of $\mathbb{F}_{q}$.

In order to determine the $\tilde{G}_{h}$-orbits on reguli contained in $\mathcal{Q}(4, q)$, the following results are needed.

Lemma 4.4. Let $s$ be a line of $\pi$ secant to $\mathcal{X}$. The stabilizer of $s$ in $\tilde{G}_{h}$ has $(q+2) / 2$ orbits on lines of $\pi$ secant to $\mathcal{X}$ :

- $\{s\}$;
- $(q-2) / 2$ orbits of size $q-1$;
- one orbit of size $2(q-1)$.

Proof. Since $\tilde{G}_{h}$ is transitive on the $q(q+1) / 2$ lines of $\pi$ secant $\mathcal{X}$ we may take $s$ as the line joining $U_{1}$ and $U_{6}$. Then $\operatorname{Stab}_{\tilde{G}_{h}}(s)$ is the group of order $2(q-1)$ represented by $\left\langle\tilde{M}_{0,1,1,0}, \tilde{M}_{d^{-1}, 0,0, d}\right\rangle$, $d \in \mathbb{F}_{q}$. It is easily seen that $\operatorname{Stab}_{\tilde{G}_{h}}(s)$ permutes in a single orbit the $2(q-1)$ lines of $\pi$ secant to $\mathcal{X}$ and containing $U_{1}$ or $U_{6}$. Indeed each line containing $U_{1}$ (resp. $U_{6}$ ) is sent to a line containing $U_{6}$ (resp. $U_{1}$ ) by $\tilde{M}_{0,1,1,0}$, while it is sent to a different line containing $U_{1}$ (resp. $U_{6}$ ) by $\tilde{M}_{d^{-1}, 0,0, d}$.

Every line $s^{\prime}$ of $\pi$ secant to $\mathcal{X}$ such that $s \cap s^{\prime} \notin \mathcal{X}$ belongs to an orbit of $\operatorname{Stab}_{\tilde{G}_{h}}(s)$ of size $q-1$; indeed the unique non-trivial element of $S t a b_{\tilde{G}_{h}}(s)$ fixing $s^{\prime}$ is the involutory elation of $\pi$ having as axis the line $s$ and as center the point $s \cap s^{\prime}$.

In a similar fashion, one can prove the following results.
Lemma 4.5. Let e be a line of $\pi$ external to $\mathcal{X}$. The stabilizer of $e$ in $\tilde{G}_{h}$ has $q / 2$ orbits on lines of $\pi$ external to $\mathcal{X}$ :

- $\{e\}$;
- $(q-2) / 2$ orbits of size $q+1$.

Theorem 4.6. The group $\tilde{G}_{h}$ has $2(q+1)$ orbits on reguli of $\mathcal{Q}(4, q)$ :

- 2 orbits of size $q(q-1) / 2$;
- 2 orbits of size $q(q+1) / 2$;
- $2(q-2)$ orbits of size $\left(q^{3}-q\right) / 2$;
- 2 orbits of size $q^{3}-q$.

Proof. Let $\Sigma$ be a solid of $\Pi$ such that $\Sigma \cap \mathcal{Q}(4, q)$ is a three-dimensional hyperbolic quadric $\mathcal{Q}^{+}$. Then $\Sigma$ meets $\pi$ and $\pi^{\perp}$ in a line. Let $\Sigma \cap \pi$ and $\Sigma \cap \pi^{\perp}$ be denoted by $\ell$ and $\ell^{\prime}$, respectively, and $\operatorname{Stab}_{\tilde{G}_{h}}(\Sigma)=\operatorname{Stab}_{\tilde{G}_{h}}\left(\ell \cup \ell^{\prime}\right)=\operatorname{Stab}_{\tilde{G}_{h}}(\ell) \cap \operatorname{Stab}_{\tilde{G}_{h}}\left(\ell^{\prime}\right)$. The three lines $\ell, \ell^{\prime}$ and $\Sigma^{\perp}$ are pairwise orthogonal. It follows that the lines $\ell, \ell^{\prime}$ are either both secant or both external to $\mathcal{Q}(4, q)$.

Assume that the former case occurs. Since $\tilde{G}_{h}$ is transitive on the $q(q+1) / 2$ lines of $\pi^{\perp}$ secant $\mathcal{X}^{\prime}$, we may fix $\ell^{\prime}$. Hence $\operatorname{Stab}_{\tilde{G}_{h}}\left(\ell^{\prime}\right)$ is a group of order $2(q-1)$ fixing a line of $\pi$ secant to $\mathcal{X}$. It follows that $\ell$ has to lie in one of the $(q+2) / 2$ orbits of Lemma 4.4. Since every member of $\operatorname{Stab}_{\tilde{G}_{h}}\left(\ell \cup \ell^{\prime}\right)$ stabilizes the reguli of $\mathcal{Q}^{+}$, the number of $\tilde{G}_{h}$-orbits on reguli of $\mathcal{Q}(4, q)$ obtained in this way is twice the number of orbits of Lemma 4.4 Moreover their size is $q(q+1) / 2$ times the size of the orbits of Lemma 4.4.

Similarly, if the latter case occurs, we may fix $\ell^{\prime}$ to be our favorite line of $\pi^{\perp}$ external to $\mathcal{X}^{\prime}$. In this case $\operatorname{Stab}_{\tilde{G}_{h}}\left(\ell^{\prime}\right)$ is a group of order $2(q+1)$ fixing a line of $\pi$ external to $\mathcal{X}$ and $\ell$ has to be in one of the $q / 2$ orbits of Lemma 4.5. Again it can be checked that every member of $S t a b_{\tilde{G}_{h}}\left(\ell \cup \ell^{\prime}\right)$ fixes the reguli of $\mathcal{Q}^{+}$. Therefore the number of $\tilde{G}_{h}$-orbits on reguli of $\mathcal{Q}(4, q)$ obtained in this way is twice the number of orbits of Lemma 4.5 and their size is $q(q-1) / 2$ times the size of the orbits of Lemma 4.5.

With the same notation used in the proof of Theorem 4.6, denote by $\mathcal{S}$ one of the $2(q+1)$ orbits on reguli of $\mathcal{Q}(4, q)$ and by $\Sigma$ a solid of $\Pi$ such that
i) $\Sigma \cap \mathcal{Q}(4, q)$ is a three-dimensional hyperbolic quadric $\mathcal{Q}^{+}$;
ii) exactly one of the two reguli $\mathcal{R}_{1}, \mathcal{R}_{2}$ of $\mathcal{Q}^{+}$belongs to $\mathcal{S}$.

The next results, which can be deduced from the proof of Theorem 4.6, provides a solid $\Sigma$ such that one of the two reguli $\mathcal{R}_{1}, \mathcal{R}_{2}$ of $\mathcal{Q}^{+}=\Sigma \cap \mathcal{Q}(4, q)$ is a representative for the orbit $\mathcal{S}$.

Corollary 4.7. Let $\zeta$ be a fixed element in $\mathbb{F}_{q^{2}} \backslash \mathbb{F}_{q}$ such that $(\zeta+1)^{q+1}=1$.

- $|\mathcal{S}|=q(q+1) / 2, \Sigma: X_{3}=0, \mathcal{Q}^{+}: X_{1} X_{6}+X_{2} X_{5}=0$.
- $|\mathcal{S}|=q^{3}-q, \Sigma: X_{1}=X_{3}, \mathcal{Q}^{+}: X_{1}^{2}+X_{1} X_{6}+X_{2} X_{5}=0$.
- $|\mathcal{S}|=\left(q^{3}-q\right) / 2$ and $|\Sigma \cap \mathcal{X}|=2, \Sigma: X_{1}+\frac{z^{4}}{z^{2}+1} X_{3}+X_{6}=0$ for some $z \in \mathbb{F}_{q} \backslash\{0,1\}$, $\mathcal{Q}^{+}: X_{1}^{2}+\frac{z^{4}}{z^{2}+1} X_{1} X_{3}+X_{3}^{2}+X_{2} X_{5}=0$.
- $|\mathcal{S}|=q(q-1) / 2, \Sigma: X_{1}+\zeta^{q+1} X_{2}+\zeta^{2(q+1)} X_{3}+\zeta^{q+1} X_{5}+X_{6}=0$,
$\mathcal{Q}^{+}: X_{1}^{2}+\zeta^{q+1} X_{1} X_{2}+\zeta^{2(q+1)} X_{1} X_{3}+\zeta^{q+1} X_{1} X_{5}+X_{2} X_{5}+X_{3}^{2}=0$.
- $|\mathcal{S}|=\left(q^{3}-q\right) / 2$ and $|\Sigma \cap \mathcal{X}|=0, \Sigma: X_{1}+\frac{t^{q+1}}{\zeta^{q+1}} X_{2}+t^{q+1} X_{3}+\frac{t^{q+1}}{\zeta^{q+1}} X_{5}+X_{6}=0$, for some $t \in \mathbb{F}_{q^{2}} \backslash\left\{0, \zeta^{2}, \zeta^{2 q}\right\},(t+1)^{q+1}=1, \mathcal{Q}^{+}: X_{1}^{2}+\frac{t^{q+1}}{\zeta^{q+1}} X_{1} X_{2}+t^{q+1} X_{1} X_{3}+\frac{t^{q+1}}{\zeta^{q+1}} X_{1} X_{5}+$ $X_{2} X_{5}+X_{3}^{2}=0$.

The results of Proposition 4.3 and Theorem 4.6 provide a proof of [7, Conjecture 8.2] in the even characteristic case.

Theorem 4.8. Let $q$ be even, with $q \equiv \xi(\bmod 3), \xi \in\{ \pm 1\}$. The group $G_{h}$ has $2 q+7+\xi$ orbits on lines of $\mathrm{PG}(3, q)$ :

- 2 orbits of size $q+1$;
- 2 orbits of size $q(q-1) / 2$;
- 2 orbits of size $q(q+1) / 2$;
- one orbit of size $q^{2}-1$;
$-2+\xi$ orbits of size $\frac{q^{3}-q}{2+\xi}$;
- $2(q-2)$ orbits of size $\left(q^{3}-q\right) / 2$;
- 2 orbits of size $q^{3}-q$.


### 4.1 Point line distribution

In this section we focus on the case when $\mathcal{A}$ is a twisted cubic (i.e. $h=1$ ) and we address the point line distribution with respect to $G_{1}$-orbits on points and lines of $\operatorname{PG}(3, q)$. Dually, this problem is equivalent to determine

- the number of lines of $\mathcal{L}_{i}$ through a point of $\mathcal{Q}(4, q)$ of a given $\tilde{G}_{1}$-orbit on points of $\mathcal{Q}(4, q)$;
- the number of lines of $\mathcal{L}_{i}$ in a regulus of a given $\tilde{G}_{1}$-orbit on reguli of $\mathcal{Q}(4, q)$.

As for $\tilde{G}_{1}$-orbits on points of $\mathcal{Q}(4, q)$, recall that besides the three three orbits $\mathcal{X}, \mathcal{X}^{\prime}$ and $\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)$, there is one or three more orbits, according as $q \equiv-1$ or $1(\bmod 3)$. Let us call $\mathcal{Z}_{i}$, $i=1, \ldots, 2+\xi$, these $\tilde{G}_{1}$-orbits. If $q \equiv 1(\bmod 3)$, from the proof of Proposition 4.3, it follows that $\mathcal{Z}_{i}=R_{i}^{\tilde{G}_{1}}$, where $R_{i}=U_{1}+\omega^{i-1} U_{5}, i=1,2,3$. In particular $\left|\mathcal{Z}_{i}\right|=\left(q^{3}-q\right) / 3$.

### 4.1.1 The number of lines of $\mathcal{L}_{i}$ through a point of $\mathcal{Q}(4, q)$

In order to determine the number of lines of $\mathcal{L}_{i}$ through a point of $\mathcal{P}$, where $\mathcal{P}$ is a $\tilde{G}_{1}$-orbits of points of $\mathcal{Q}(4, q)$, we calculate the number $k$ of points of $\mathcal{P}$ on a line of $\mathcal{L}_{i}$ and then use the formula

$$
\frac{\left|\mathcal{L}_{i}\right| k}{|\mathcal{P}|}
$$

to derive the required result.

Let $r$ be a line of $\mathcal{Q}(4, q)$. If $r \in \mathcal{L}_{q+1}$, then it has one point in common with both $\mathcal{X}$ and $\mathcal{X}^{\prime}, q-1$ points of $\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)$ and no point of $\mathcal{Z}_{i}$. If $r \in \mathcal{L}_{2}$, it has one point in common with both $\mathcal{X}$ and $\mathcal{X}^{\prime},(q-1) /(2+\xi)$ points of $\mathcal{Z}_{i}$ and no point of $\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)$.

Assume $q \equiv-1(\bmod 3)$. If $r \in \mathcal{L}_{0}$, then all its points belong to $\mathcal{Z}_{1}$, while if $r \in \mathcal{L}_{1}$, then $\left|r \cap\left(\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)\right)\right|=1$ and $\left|r \cap \mathcal{Z}_{1}\right|=q$. If $r \in \mathcal{L}_{3}$, then $\mid r \cap\left(\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)\right)=3$ and $\left|r \cap \mathcal{Z}_{1}\right|=q-2$.

In the case when $q \equiv 1(\bmod 3)$, a more refined argument is needed.
Lemma 4.9. Let $q \equiv 1(\bmod 3)$. A point $P$ belongs to $\mathcal{Z}_{i}$ if and only if $F_{1}(P)=\omega^{3 j+i-1}$.
Proof. First of all observe that $F_{1}(\lambda P)=\lambda^{3} F_{1}(P)$. Since $\mathcal{Z}_{i}=R_{i}^{\tilde{G}_{1}}$, where $R_{i}=U_{1}+\omega^{i-1} U_{5}$, $i=1,2,3$, it is enough to see that if $g \in \tilde{G}_{1}$ is represented by $\tilde{M}_{a, b, c, d}$, then $F_{1}\left(R_{i}\right)=F_{1}\left(R_{i}^{g}\right)=$ $\omega^{2(i-1)}$.

Proposition 4.10. Let $q=2^{n} \equiv 1(\bmod 3)$. A line of $\mathcal{L}_{3}$ has 3 points in common with $\mathcal{Y}$, $\left(q-(-1)^{\frac{n}{2}} 2 \sqrt{q}-2\right) / 3$ points in common with $\mathcal{Z}_{1}$ and $\left(q+(-1)^{\frac{n}{2}} \sqrt{q}-2\right) / 3$ in common with both $\mathcal{Z}_{2}$ and $\mathcal{Z}_{3}$. A line of $\mathcal{L}_{0}$ has $\left(q-(-1)^{\frac{n}{2}} 2 \sqrt{q}+1\right) / 3$ points in common with $\mathcal{Z}_{1}$ and $\left(q+(-1)^{\frac{n}{2}} \sqrt{q}+1\right) / 3$ in common with both $\mathcal{Z}_{2}$ and $\mathcal{Z}_{3}$.

Proof. Recall that the points of a line of $\mathcal{Q}(4, q)$ in $\mathcal{L}_{0}$ or $\mathcal{L}_{3}$ are the image under the Plücker embedding of the lines of $\mathcal{W}(3, q)$ through a point $Q$ belonging to $\mathcal{O}_{0}$ or $\mathcal{O}_{3}$, respectively. Since $q \equiv 1(\bmod 3)$, by Proposition 3.2, we may assume $Q=(1,0,0, x)$, where $x \in \mathbb{F}_{q}$ is not a cube, or $Q=(1,0,0,1)$, respectively. Therefore a representative for $\mathcal{L}_{0}$ is the line

$$
r_{x}=\left\{(1, \mu, 0,0, x, \mu x) \mid \mu \in \mathbb{F}_{q}\right\} \cup\left\{U_{2}+x U_{6}\right\}
$$

whereas for $\mathcal{L}_{3}$ is the line

$$
r=\left\{(1, \mu, 0,0,1, \mu) \mid \mu \in \mathbb{F}_{q}\right\} \cup\left\{U_{2}+U_{6}\right\}
$$

Taking into account Lemma 4.9, $\left|r_{x} \cap \mathcal{Z}_{i}\right|$ equals the number of points of $r_{x}$ whose evaluation of $F$ has the form $\omega^{3 j+i-1}$, for some $j$. In particular, the point $U_{2}+x U_{6}$ belongs to $\mathcal{Z}_{2}$ or $\mathcal{Z}_{3}$, according as $x$ equals $\omega^{3 l+1}$ or $\omega^{3 l+2}$. The point $P_{\mu}=(1, \mu, 0,0, x, \mu x)$ belongs to $\mathcal{Z}_{1}$ if and only if there exists $\lambda \in \mathbb{F}_{q}$ such that

$$
\begin{equation*}
x \mu^{3}+\lambda^{3}=x^{2} \tag{4.1}
\end{equation*}
$$

By [10, Theorem 1], in both cases $x=\omega^{3 l+1}$ or $x=\omega^{3 l+2}$, the number of pairs $(\mu, \lambda) \in \mathbb{F}_{q}^{2}$ satisfying (4.1) is $q-(-1)^{\frac{n}{2}} 2 \sqrt{q}+1$. Since for each $\mu$, there are three distinct $\lambda$ satisfying (4.1), it follows that

$$
\left|r_{x} \cap \mathcal{Z}_{1}\right|=\frac{q-(-1)^{\frac{n}{2}} 2 \sqrt{q}+1}{3}
$$

Observe that $P_{\mu} \in r_{x} \cap \mathcal{Z}_{2}$ if and only if $P_{\mu^{2}} \in r_{x^{2}} \cap \mathcal{Z}_{3}$. Hence $\left|r_{x} \cap \mathcal{Z}_{2}\right|=\left|r_{x^{2}} \cap \mathcal{Z}_{3}\right|$. On the other hand $\left|r_{x} \cap \mathcal{Z}_{3}\right|=\left|r_{x^{2}} \cap \mathcal{Z}_{3}\right|$, since $r_{x}$ and $r_{x^{2}}$ are in the same $\tilde{G}_{h^{-o r b i t}}$. Therefore

$$
\left|r_{x} \cap \mathcal{Z}_{2}\right|=\left|r_{x} \cap \mathcal{Z}_{3}\right|=\frac{q+1-\left|r_{0} \cap \mathcal{Z}_{1}\right|}{2}=\frac{q+(-1)^{\frac{n}{2}} \sqrt{q}+1}{3}
$$

Similarly, the point $U_{2}+U_{6}$ belongs to $\mathcal{Z}_{1}$, whereas the point $P_{\mu}=(1, \mu, 0,0,1, \mu)$ belongs to $\mathcal{Z}_{1}$ if and only if $\mu^{3} \neq 1$ and there exists $\lambda \in \mathbb{F}_{q}$ such that

$$
\begin{equation*}
\mu^{3}+\lambda^{3}=1 \tag{4.2}
\end{equation*}
$$

By using again [10, Theorem 1] (or [10, Corollary 4]), we find that the number of pairs $(\mu, \lambda) \in \mathbb{F}_{q}^{2}$ satisfying (4.2) is $q-(-1)^{\frac{n}{2}} 2 \sqrt{q}-2$. Among these solutions we have to exclude $(1,0),\left(\omega^{\frac{q-1}{3}}, 0\right)$, $\left(\omega^{\frac{2(q-1)}{3}}, 0\right)$ and for each $\mu$ of the remaining pairs, there are three distinct $\lambda$ satisfying (4.2), it follows that

$$
\left|r \cap \mathcal{Z}_{1}\right|=\frac{q-(-1)^{\frac{n}{2}} 2 \sqrt{q}-2}{3}
$$

Finally $P_{\mu} \in r \cap \mathcal{Z}_{2}$ if and only if $P_{\mu^{2}} \in r \cap \mathcal{Z}_{3}$. Hence

$$
\left|r \cap \mathcal{Z}_{2}\right|=\left|r \cap \mathcal{Z}_{3}\right|=\frac{q+1-3-\left|r_{0} \cap \mathcal{Z}_{1}\right|}{2}=\frac{q+(-1)^{\frac{n}{2}} \sqrt{q}-2}{3}
$$

Therefore the number of lines of $\mathcal{L}_{i}$ through a point of $\mathcal{Q}(4, q)$ of a given $\tilde{G}_{1}$-orbit on points of $\mathcal{Q}(4, q)$ can be deduced as shown in Tables 3 and 4 .

### 4.1.2 The number of lines of $\mathcal{L}_{i}$ in a regulus of $\mathcal{Q}(4, q)$

By Theorem 4.6, the group $\tilde{G}_{h}$ has $2(q+1)$ orbits on reguli of $\mathcal{Q}(4, q)$. Denote by $\mathcal{S}$ one of these $2(q+1)$ orbits and by $\Sigma$ a solid of $\Pi$ such that
i) $\Sigma \cap \mathcal{Q}(4, q)$ is a three-dimensional hyperbolic quadric $\mathcal{Q}^{+}$;
ii) exactly one of the two reguli $\mathcal{R}_{1}, \mathcal{R}_{2}$ of $\mathcal{Q}^{+}$belongs to $\mathcal{S}$.

Recall that $\mathcal{Y}$ consists of the $q+1$ lines

& \ell_{\infty}=\left\{(0,0,0,0,1, \lambda) \mid \lambda \in \mathbb{F}_{q}\right\} \cup\left\{U_{6}\right\} .
\end{aligned}

Theorem 4.11. Let $\zeta$ be a fixed element in $\mathbb{F}_{q^{2}} \backslash \mathbb{F}_{q}$ such that $(\zeta+1)^{q+1}=1$. With the above notation, one of the following cases occurs.

1. If $\mathcal{S}$ is one of the two orbits of size $q(q+1) / 2$, then

- $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=2,\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=0$,

\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=0,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=q-1,\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=0, & \text { if } q \equiv-1 \quad(\bmod 3) .
\end{array}
$$

- $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{0} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{1} \cap \mathcal{R}_{2}\right|=0,\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=2,\left|\mathcal{L}_{3} \cap \mathcal{R}_{2}\right|=q-1$.

2. If $\mathcal{S}$ is one of the two orbits of size $q^{3}-q$, then

- $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=1,\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=1$,

\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=(q-1) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=q / 2,\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q-4) / 6, & \text { if } q \equiv 1 \quad(\bmod 3), \\
\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=(q+1) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=(q-2) / 2,\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q-2) / 6, & \text { if } q \equiv-1 \quad(\bmod 3) .
\end{array}

- $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{0} \cap \mathcal{R}_{2}\right|=0,\left|\mathcal{L}_{1} \cap \mathcal{R}_{2}\right|=q / 2,\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=2,\left|\mathcal{L}_{3} \cap \mathcal{R}_{2}\right|=(q-2) / 2$.

3. If $\mathcal{S}$ is one of the $q-2$ orbits with $|\mathcal{S}|=\left(q^{3}-q\right) / 2$ and $|\Sigma \cap \mathcal{X}|=2$, let

f_{1}(x)=\frac{1}{z^{2}}\left(\frac{x(z+1)}{z^{2}}+\frac{z+1}{x z^{2}}+1\right), \quad f_{2}(x)=\frac{z^{2}+1}{z^{2}}\left(\frac{x(z+1)}{z^{2}}+\frac{z+1}{x z^{2}}+1\right),
$$

for some $z \in \mathbb{F}_{q} \backslash\{0,1\}$. Then
$\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{i}\right|=0,\left|\mathcal{L}_{0} \cap \mathcal{R}_{i}\right|=\left(2 \boldsymbol{u}_{i}+6\right) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{i}\right|=q-\boldsymbol{u}_{i}-3,\left|\mathcal{L}_{2} \cap \mathcal{R}_{i}\right|=2,\left|\mathcal{L}_{3} \cap \mathcal{R}_{i}\right|=\boldsymbol{u}_{i} / 3$, $i \in\{1,2\}$.
4. If $\mathcal{S}$ is one of the two orbits of size $q(q-1) / 2$, then

- $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=0$,

\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=0,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=q+1, & \text { if } q \equiv 1 \quad(\bmod 3), \\
\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=2(q+1) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=0,\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q+1) / 3, & \text { if } q \equiv-1 \quad(\bmod 3) .

- $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{0} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{3} \cap \mathcal{R}_{2}\right|=0,\left|\mathcal{L}_{1} \cap \mathcal{R}_{2}\right|=q+1$.

5. If $\mathcal{S}$ is one of the $q-2$ orbits with $|\mathcal{S}|=\left(q^{3}-q\right) / 2$ and $|\Sigma \cap \mathcal{X}|=0$, let

& g_{1}(x)=\frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}}\left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right)\left(\left(\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right) x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+1\right)}{\left(x^{2}+\zeta^{q+1}+1\right)^{2}}, \\
& g_{2}(x)=\frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}}\left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{q+1}}{t^{2}}+\frac{t^{q+1}}{\zeta^{2}}\right)\left(\left(\frac{t^{q+1}}{t^{2}}+\frac{t^{q+1}}{\zeta^{2}}\right) x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+1\right)}{\left(x^{2}+\zeta^{q+1}+1\right)^{2}},
\end{aligned}

for some $t \in \mathbb{F}_{q^{2}} \backslash\left\{0, \zeta^{2}, \zeta^{2 q}\right\},(t+1)^{q+1}=1$. Then
$\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{i}\right|=0,\left|\mathcal{L}_{0} \cap \mathcal{R}_{i}\right|=\left(2 \boldsymbol{v}_{i}+6\right) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{i}\right|=q-\boldsymbol{v}_{i}-2,\left|\mathcal{L}_{2} \cap \mathcal{R}_{i}\right|=0,\left|\mathcal{L}_{3} \cap \mathcal{R}_{i}\right|=\left(\boldsymbol{v}_{i}+3\right) / 3$, or
$\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{i}\right|=0,\left|\mathcal{L}_{0} \cap \mathcal{R}_{i}\right|=2 \boldsymbol{v}_{i} / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{i}\right|=q-\boldsymbol{v}_{i}+1,\left|\mathcal{L}_{2} \cap \mathcal{R}_{i}\right|=0,\left|\mathcal{L}_{3} \cap \mathcal{R}_{i}\right|=\boldsymbol{v}_{i} / 3$, $i \in\{1,2\}$.
according as $\operatorname{Tr}_{q \mid 2}\left(\frac{z^{2}}{t^{q+1}}\left(1+\frac{z^{2 q}}{t^{2}}\right)\right)$ equals 0 or 1 , respectively.
Proof. For each of the five cases listed in Corollary 4.7, we determine $\mathcal{Q}^{+} \cap \mathcal{Y}$ and hence $\left|\mathcal{L}_{i} \cap \mathcal{R}_{j}\right|$, $i \in\{0,1,2,3, q+1\}, j \in\{1,2\}$.

If $\mathcal{S}$ is one of the two orbits of size $q(q+1) / 2$ then

Assume that $\ell_{0} \in \mathcal{R}_{1}$. Then $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=2$ and $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=0$. We infer that $\left|\mathcal{L}_{3} \cap \mathcal{R}_{2}\right|=q-1$ and $\left|\mathcal{L}_{1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{0} \cap \mathcal{R}_{2}\right|=0$. The two points ( $1, x, 0,0, x^{3}, x^{4}$ ), $\left(1, y, 0,0, y^{3}, y^{4}\right), x, y \in \mathbb{F}_{q} \backslash\{0\}, x \neq y$, belonging to $\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)$ define a line of $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if

1 & x & 0 & 0 & x^{3} & x^{4} \\
1 & y & 0 & 0 & y^{3} & y^{4} \\

which gives $x y\left(x^{3}+y^{3}\right)=0$. For $q \equiv 1 \bmod 3,\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q-1) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=0$ and $\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=2(q-1) / 3$. For $q \equiv-1 \bmod 3$, instead, it holds $\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=0$ and $\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=q-1$.

Let $\mathcal{S}$ be one of the two orbits of size $q^{3}-q$, then

Assume that $\ell_{\infty} \in \mathcal{R}_{1}$ and $\left\langle U_{2}, U_{6}\right\rangle \in \mathcal{R}_{2}$. Then $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=1,\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=1$ and $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=$ $0,\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=2$. Let $s$ be the line defined by the two points $\left(x, x^{2}+1, x, x, x^{2}+x^{4}, x^{5}\right)$,
$\left(y, y^{2}+1, y, y, y^{2}+y^{4}, y^{5}\right), x, y \in \mathbb{F}_{q} \backslash\{0,1\}, x \neq y$, of $\mathcal{Y} \backslash\left(\mathcal{X} \cup \mathcal{X}^{\prime}\right)$. The line $s$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if

\operatorname{rk}\left(\begin{array}{cccccc}
x & x^{2}+1 & x & x & x^{2}+x^{4} & x^{5} \\
y & y^{2}+1 & y & y & y^{2}+y^{4} & y^{5} \\
0 & 1 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 & 1
\end{array}\right)=3
$$

which gives $x y(x+y)\left(y^{2}+x y+x^{2}+1\right)=0$. Since

\left|\left\{x \in \mathbb{F}_{q} \backslash\{0,1\} \left\lvert\, \operatorname{Tr}\left(1+\frac{1}{x^{2}}\right)=0\right.\right\}\right|= \begin{cases}\frac{q}{2}-2 & \text { if } q \equiv 1 \quad(\bmod 3), \\ \frac{q}{2}-1 & \text { if } q \equiv-1 \quad(\bmod 3),\end{cases}
$$

it follows that $\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q-4) / 6,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=q / 2$ and $\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=(q-1) / 3$, if $q \equiv 1(\bmod 3)$, whereas $\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q-2) / 6,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=(q-2) / 2$ and $\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=(q+1) / 3$, if $q \equiv-1$ $(\bmod 3)$. The line $s$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{2}$ if and only if

which gives $(x y+1)(x+y)=0$. Hence $\left|\mathcal{L}_{3} \cap \mathcal{R}_{2}\right|=(q-2) / 2,\left|\mathcal{L}_{1} \cap \mathcal{R}_{2}\right|=q / 2$ and $\left|\mathcal{L}_{0} \cap \mathcal{R}_{2}\right|=0$.
Assume that $\mathcal{S}$ is one of the $q-2$ orbits with $|\mathcal{S}|=\left(q^{3}-q\right) / 2$ and $|\Sigma \cap \mathcal{X}|=2$, then

\mathcal{Q}^{+} \cap \mathcal{Y}= & \left\{T_{x} \mid x \in \mathbb{F}_{q} \backslash\left\{0, z+1,(z+1)^{-1}\right\}\right\} \\
& \cup\left\{U_{2}, U_{5},\left(1,0, z^{2}+1, z^{2}+1,0, z^{4}+1\right),\left(1,0,\left(z^{2}+1\right)^{-1},\left(z^{2}+1\right)^{-1}, 0,\left(z^{4}+1\right)^{-1}\right)\right\},
\end{aligned}
$$

where
$T_{x}=\frac{z^{2}+1}{z^{4}}\left(\frac{z^{4}}{z^{2}+1}, x^{-1}\left(x^{4}+\frac{z^{4}}{z^{2}+1} x^{2}+1\right), x^{4}+1, x^{4}+1, x\left(x^{4}+\frac{z^{4}}{z^{2}+1} x^{2}+1\right), \frac{z^{4}}{z^{2}+1} x^{4}\right)$,
for some $z \in \mathbb{F}_{q} \backslash\{0,1\}$. Suppose that $\left\langle\left(1,0, z^{2}+1, z^{2}+1,0, z^{4}+1\right), U_{2}\right\rangle \in \mathcal{R}_{1}$ and $\left\langle\left(1,0,\left(z^{2}+\right.\right.\right.$ $\left.\left.1)^{-1},\left(z^{2}+1\right)^{-1}, 0,\left(z^{4}+1\right)^{-1}\right), U_{2}\right\rangle \in \mathcal{R}_{2}$. In this case $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=0$ and $\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=2$. The line $\left\langle T_{x}, T_{y}\right\rangle, x, y \in \mathbb{F}_{q} \backslash\left\{0, z+1,(z+1)^{-1}\right\}, x \neq y$, belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{2}$ or to $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if

For a fixed $x$, equation (4.3) or (4.4) has a solution in $y$ if and only if

Let $\mathcal{S}$ be one of the two orbits of size $q(q-1) / 2$. Then

& \mathcal{Q}^{+} \cap \mathcal{Y}=\left\{T_{x} \mid x \in \mathbb{F}_{q}\right\} \cup\left\{T_{\infty}=\left(0,0,0,0,1, \zeta^{q+1}\right)\right\} \\
& \text { where } T_{x}=\left(\zeta^{q+1}, x^{2}+\zeta^{q+1} x+1, x^{3}+x, x^{3}+x, x^{4}+\zeta^{q+1} x^{3}+x^{2}, \zeta^{q+1} x^{4}\right)
\end{aligned}
$$

Let $\overline{\mathcal{Q}}^{+}$denote the quadratic extension of $\mathcal{Q}^{+}$, and assume that $\left\langle\left(0,1, \zeta+1, \zeta+1, \zeta^{2}+1,0\right),\left(1,0, \zeta^{2}+\right.\right.$ $\left.\left.1, \zeta^{2}+1,0, \zeta^{4}+1\right)\right\rangle \in \overline{\mathcal{R}}_{1}$ and $\left\langle\left(0,1, \zeta+1, \zeta+1, \zeta^{2}+1,0\right),\left(1,0, \zeta^{2 q}+1, \zeta^{2 q}+1,0, \zeta^{4 q}+1\right)\right\rangle \in$ $\overline{\mathcal{R}}_{2}$, where $\overline{\mathcal{R}}_{1}$ and $\overline{\mathcal{R}}_{2}$ are the reguli of $\overline{\mathcal{Q}}^{+}$obtained by extending $\mathcal{R}_{1}$ and $\mathcal{R}_{2}$. In this case $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=0$. Arguing as before we find that the line joining $T_{x}$ and $T_{\infty}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if there exists $x \in \mathbb{F}_{q}$ such that

Since $u^{2}+\zeta^{q+1} u+1=u^{2}+\left(\zeta+\zeta^{q}\right) u+1=(u+\zeta+1)\left(u+\zeta^{q}+1\right)$, then $\operatorname{Tr}_{q \mid 2}\left(1+\frac{1}{\zeta^{2(q+1)}}\right)=$ $\operatorname{Tr}_{q \mid 2}(1)+\operatorname{Tr}_{q \mid 2}\left(1 / \zeta^{2(q+1)}\right)=\operatorname{Tr}_{q \mid 2}(1)+1$. Hence equation (4.5) has two or none solutions according as $q \equiv-1$ or $1(\bmod 3)$. Similarly, for a fixed $x \in \mathbb{F}_{q}$, the line joining $T_{x}$ and $T_{y}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if there exists $y \in \mathbb{F}_{q} \backslash\{x\}$ such that

$$
\begin{align*}
& \left((\zeta+1)^{2} x^{2}+\zeta^{2}(\zeta+1) x+\zeta^{4}+\zeta^{2}+1\right) y^{2}+\zeta^{2}\left((\zeta+1) x^{2}+\zeta^{2} x+\zeta+1\right) y \\
& +\left(\left(\zeta^{4}+\zeta^{2}+1\right) x^{2}+\zeta^{2}(\zeta+1) x+(\zeta+1)^{2}\right)= \\
& (\zeta+1)^{2}\left(\left(x^{2}+\zeta^{q+1} x+\left(\zeta^{q+1}+1\right)^{2}\right) y^{2}+\zeta^{q+1}\left(x^{2}+\zeta^{q+1} x+1\right) y+\left(\zeta^{q+1}+1\right)^{2} x^{2}+\zeta^{q+1} x+1\right) \\
& =0 \tag{4.6}
\end{align*}
$$

Since $u^{2}+\left(x^{2}+\zeta^{q+1} x+1\right) u+\zeta^{q+1}\left(x^{3}+x\right)=u^{2}+\left(x^{2}+\left(\zeta+\zeta^{q}\right) x+1\right) u+\left(\zeta+\zeta^{q}\right)\left(x^{3}+x\right)=$ $\left(u+\left(\zeta+\zeta^{q}\right) x\right)\left(u+x^{2}+1\right)$, then $\operatorname{Tr}_{q \mid 2}\left(1+\frac{1}{\zeta^{2(q+1)}}+\frac{\zeta^{q+1}\left(x^{3}+x\right)}{\left(x^{2}+\zeta^{q+1} x+1\right)^{2}}\right)=\operatorname{Tr}_{q \mid 2}(1)+\operatorname{Tr}_{q \mid 2}\left(1 / \zeta^{2(q+1)}\right)+$ $\operatorname{Tr}_{q \mid 2}\left(\zeta^{q+1}\left(x^{3}+x\right) /\left(x^{2}+\zeta^{q+1} x+1\right)^{2}\right)=\operatorname{Tr}_{q \mid 2}(1)+1+0$. Therefore equation (4.6) has two or none solutions according as $q \equiv-1$ or $1(\bmod 3)$. It follows that $\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=(q+1) / 3,\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=0$ and $\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=2(q+1) / 3$, if $q \equiv-1(\bmod 3)$, whereas $\left|\mathcal{L}_{3} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{0} \cap \mathcal{R}_{1}\right|=0$ and $\left|\mathcal{L}_{1} \cap \mathcal{R}_{1}\right|=q+1$, if $q \equiv 1(\bmod 3)$. Similar calculations show that no line joining $T_{x}$ and $T_{\infty}$ or $T_{x}$ and $T_{y}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{2}$. Hence $\left|\mathcal{L}_{3} \cap \mathcal{R}_{2}\right|=0,\left|\mathcal{L}_{1} \cap \mathcal{R}_{2}\right|=q+1$ and $\left|\mathcal{L}_{0} \cap \mathcal{R}_{2}\right|=0$.

If $\mathcal{S}$ is one of the $q-2$ orbits with $|\mathcal{S}|=\left(q^{3}-q\right) / 2$ and $|\Sigma \cap \mathcal{X}|=0$, then

$$
\mathcal{Q}^{+} \cap \mathcal{Y}=\left\{T_{x} \mid x \in \mathbb{F}_{q}\right\} \cup\left\{T_{\infty}=\left(0,0,0,0,1, t^{q+1} / \zeta^{q+1}\right)\right\},
$$

where

$$
\begin{aligned}
T_{x}= & \left(\left(t^{q+1}\left(x^{2}+\zeta^{q+1} x+1\right), \zeta^{q+1}\left(x^{4}+t^{q+1} x^{2}+1\right),\left(x^{3}+x\right)\left(\zeta^{q+1} x^{2}+t^{q+1} x+\zeta^{q+1}\right),\right.\right. \\
& \left.\left(x^{3}+x\right)\left(\zeta^{q+1} x^{2}+t^{q+1} x+\zeta^{q+1}\right), \zeta^{q+1} x^{2}\left(x^{4}+t^{q+1} x^{2}+1\right), t^{q+1} x^{4}\left(x^{2}+\zeta^{q+1} x+1\right)\right),
\end{aligned}
$$

for some $t \in \mathbb{F}_{q^{2}} \backslash\left\{0, \zeta^{2}, \zeta^{2 q}\right\},(t+1)^{q+1}=1$. Let $\overline{\mathcal{Q}}^{+}$denote the quadratic extension of $\mathcal{Q}^{+}$, and assume that $\left\langle\left(0,1, \zeta+1, \zeta+1, \zeta^{2}+1,0\right),\left(1,0, t+1, t+1,0, t^{2}+1\right)\right\rangle \in \overline{\mathcal{R}}_{1}$ and $\langle(0,1, \zeta+1, \zeta+$ $\left.\left.1, \zeta^{2}+1,0\right),\left(1,0, t^{q}+1, t^{q}+1,0, t^{2 q}+1\right)\right\rangle \in \overline{\mathcal{R}}_{2}$, where $\overline{\mathcal{R}}_{1}$ and $\overline{\mathcal{R}}_{2}$ are the reguli of $\overline{\mathcal{Q}}^{+}$obtained by extending $\mathcal{R}_{1}$ and $\mathcal{R}_{2}$. In this case $\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{1}\right|=\left|\mathcal{L}_{q+1} \cap \mathcal{R}_{2}\right|=\left|\mathcal{L}_{2} \cap \mathcal{R}_{2}\right|=0$. The line joining $T_{x}$ and $T_{\infty}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if there exists $x \in \mathbb{F}_{q}$ such that

$$
\begin{align*}
\zeta^{2}(t+1) x^{2}+t^{2}(\zeta+1) x+\zeta^{2} t^{2}+\zeta^{2}+t^{2} & =\zeta^{2}(t+1)\left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right) \\
& =\zeta^{2}(t+1)\left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{2 q}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2 q}}\right)=0 \tag{4.7}
\end{align*}
$$

Equation (4.7) has two or none solutions according as $\operatorname{Tr}_{q \mid 2}\left(\frac{\zeta^{2}}{t^{q+1}}\left(1+\frac{\zeta^{2 q}}{t^{2}}\right)\right)$ equals 0 or 1 , respectively. Analogously, for a fixed $x \in \mathbb{F}_{q}$, the line joining $T_{x}$ and $T_{y}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{1}$ if and only if there exists $y \in \mathbb{F}_{q} \backslash\{x\}$ such that

$$
\begin{align*}
& \left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right) y^{2}+\frac{t^{q+1}}{\zeta^{q+1}}\left(x^{2}+\zeta^{q+1} x+1\right) y+\left(\left(\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right) x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+1\right) \\
& =0 . \tag{4.8}
\end{align*}
$$

Equation (4.8) admits a solution if and only if

$$
\operatorname{Tr}_{q \mid 2}\left(\frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}}\left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right)\left(\left(\frac{t^{2}}{t^{q+1}}+\frac{t^{q+1}}{\zeta^{2}}\right) x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+1\right)}{\left(x^{2}+\zeta^{q+1}+1\right)^{2}}\right)=0 .
$$

The line joining $T_{x}$ and $T_{\infty}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{2}$ if and only if there exists $x \in \mathbb{F}_{q}$ such that

$$
x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{q+1}}{\zeta^{2}}+\frac{t^{q+1}}{t^{2}}=0
$$

which has solutions if and only if $\operatorname{Tr}_{q \mid 2}\left(\frac{\zeta^{2(q+1)}}{t^{q+1}}\left(\frac{1}{\zeta^{2}}+\frac{1}{t^{2}}\right)\right)$ equals 0 , whereas, for a fixed $x \in \mathbb{F}_{q}$, the line joining $T_{x}$ and $T_{y}$ belongs to $\mathcal{L}_{3} \cap \mathcal{R}_{2}$ if and only if there exists $y \in \mathbb{F}_{q} \backslash\{x\}$ such that

$$
\begin{aligned}
& \left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{q+1}}{t^{2}}+\frac{t^{q+1}}{\zeta^{2}}\right) y^{2}+\frac{t^{q+1}}{\zeta^{q+1}}\left(x^{2}+\zeta^{q+1} x+1\right) y+\left(\left(\frac{t^{q+1}}{t^{2}}+\frac{t^{q+1}}{\zeta^{2}}\right) x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+1\right) \\
& =0 .
\end{aligned}
$$

which has solutions if and only if

$$
\operatorname{Tr}_{q \mid 2}\left(\frac{\frac{\zeta^{2(q+1)}}{t^{2(q+1)}}\left(x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+\frac{t^{q+1}}{t^{2}}+\frac{t^{q+1}}{\zeta^{2}}\right)\left(\left(\frac{t^{q+1}}{t^{2}}+\frac{t^{q+1}}{\zeta^{2}}\right) x^{2}+\frac{t^{q+1}}{\zeta^{q+1}} x+1\right)}{\left(x^{2}+\zeta^{q+1}+1\right)^{2}}\right)=0 .
$$

Finally observe that

$$
\operatorname{Tr}_{q \mid 2}\left(\frac{\zeta^{2}}{t^{q+1}}\left(1+\frac{\zeta^{2 q}}{t^{2}}\right)\right)=0 \Longleftrightarrow \operatorname{Tr}_{q \mid 2}\left(\frac{\zeta^{2(q+1)}}{t^{q+1}}\left(\frac{1}{\zeta^{2}}+\frac{1}{t^{2}}\right)\right)=0
$$

The content of Theorem 4.11 is summarized in Tables [5, 6, 8, 7, 10, 11, 9 and 12 ,
