# DEGREE ZERO GROMOV-WITTEN INVARIANTS FOR SMOOTH CURVES 

DI YANG


#### Abstract

For a smooth projective curve, we derive a closed formula for the generating series of its Gromov-Witten invariants in genus $g$ and degree zero. It is known that the calculation of these invariants can be reduced to that of the $\lambda_{g}$ and $\lambda_{g-1}$ integrals on the moduli space of stable algebraic curves. The closed formula for the $\lambda_{g}$ integrals is given by the $\lambda_{g}$ conjecture, proved by Faber and Pandharipande. We compute in this paper the $\lambda_{g-1}$ integrals via solving the degree zero limit of the loop equation associated to the complex projective line.


## 1. Introduction

Let $X$ be a smooth projective variety of complex dimension $D$, and let $X_{g, n, \beta}$ be the moduli space of stable maps of degree $\beta \in H_{2}(X, \mathbb{Z})$ /torsion with target $X$ from curves of genus $g$ with $n$ distinct marked points. Here, $g, n \geq 0$. Choose a homogeneous basis $\phi_{1}=1, \phi_{2}, \ldots, \phi_{l}$ of the cohomology ring $H^{*}(X ; \mathbb{C})$ with $\phi_{\alpha} \in H^{2 q_{\alpha}}(X ; \mathbb{C}), \alpha=1, \ldots, l$, where $0=q_{1}<q_{2} \leq q_{3} \leq \cdots \leq q_{l-1}<q_{l}=D$. Note that $q_{\alpha}$ is a half integer if $\phi_{\alpha}$ is an odd degree class. We denote the Poincaré pairing on $H^{*}(X ; \mathbb{C})$ by $\langle$,$\rangle . The integrals$

are called Gromov-Witten ( $G W$ ) invariants of $X$ of genus $g$ and degree $\beta$. Here, $\mathrm{ev}_{a}, a=1, \ldots, n$, is the evaluation map, $\mathcal{L}_{a}$ is the $a$ th tautological line bundle on $X_{g, n, \beta}$, and $\left[X_{g, n, \beta}\right]^{\text {virt }}$ is the virtual fundamental class, which is an element in the Chow ring having the complex dimension

The genus $g$ free energy for the GW invariants of $X$ is defined as the generating series

\mathcal{F}_{g}^{X}(\mathbf{t} ; q)=\sum_{n, \beta} \sum_{\substack{\alpha_{1}, \ldots, \alpha_{n} \\ i_{1}, \ldots, i_{n}}} \frac{q^{\beta} t^{\alpha_{1}, i_{1}} \cdots t^{\alpha_{n}, i_{n}}}{n!} \int_{[X g, n, \beta] \operatorname{virt}} c_{1}\left(\mathcal{L}_{1}\right)^{i_{1}} \operatorname{ev}_{1}^{*}\left(\phi_{\alpha_{1}}\right) \cdots c_{1}\left(\mathcal{L}_{n}\right)^{i_{n}} \operatorname{ev}_{n}^{*}\left(\phi_{\alpha_{n}}\right), \tag{1.3}
\end{equation*}

where $\mathbf{t}=\left(t^{\alpha, i}\right)_{\alpha=1, \ldots, l, i \geq 0}$ is an infinite vector of indeterminates, and

q^{\beta}=q_{1}^{m_{1}} \cdots q_{r}^{m_{r}}\left(\text { for } \beta=m_{1} \beta_{1}+\cdots+m_{r} \beta_{r}\right) \tag{1.4}

is an element of the Novikov ring. Here, $\left(\beta_{1}, \ldots, \beta_{r}\right)$ is a basis of $H_{2}(X ; \mathbb{Z}) /$ torsion. The sum

\sum_{g \geq 0} \epsilon^{2 g-2} \mathcal{F}_{g}^{X}(\mathbf{t} ; q)=: \mathcal{F}^{X}(\mathbf{t} ; \epsilon, q)
$$

is called the free energy for the GW invariants of $X$. It should be noted that the order of each monomial $t^{\alpha_{1}, i_{1}} \cdots t^{\alpha_{n}, i_{n}}$ in (1.3) is important since the odd cohomology classes are considered and that in some literature, the monomial $t^{\alpha_{1}, i_{1}} \cdots t^{\alpha_{n}, i_{n}}$ in (1.3) is ordered as $t^{\alpha_{n}, i_{n}} \cdots t^{\alpha_{1}, i_{1}}$.

The interest of this paper is on the calculation of degree zero GW invariants. In particular, we will focus on the case when the target is a smooth projective curve. Before specializing to curves,

[^0]we will first review what is known about the degree zero invariants for a general smooth projective variety $X$.

The moduli space $X_{g, n, 0}$ is isomorphic to $\overline{\mathcal{M}}_{g, n} \times X$, where $\overline{\mathcal{M}}_{g, n}$ denotes the Deligne-Mumford moduli space [2] of stable algebraic curves of genus $g$ with $n$ distinct marked points. With this identification,

\left[X_{g, n, 0}\right]^{\mathrm{virt}}=e\left(E_{g, n}^{\vee} \boxtimes T_{X}\right) \cap\left[\overline{\mathcal{M}}_{g, n} \times X\right], \tag{1.5}
\end{equation*}

where $\mathbb{E}_{g, n}$ is the Hodge bundle on $\overline{\mathcal{M}}_{g, n}, T_{X}$ is the tangent bundle of $X$, and $e\left(\mathbb{E}_{g, n}^{\vee} \boxtimes T_{X}\right)$ is the Euler class of the obstruction bundle on $\overline{\mathcal{M}}_{g, n} \times X$. Therefore, we have the following formula for the degree zero GW invariants of $X$ :

\end{equation*}

Here $\psi_{a}, a=1, \ldots, n$, denotes the first Chern class of the $a$ th tautological line bundle on $\overline{\mathcal{M}}_{g, n}$. We see from formula (1.6) that Hodge classes on $\overline{\mathcal{M}}_{g, n}$ enter into the story, and we use $\lambda_{j}(j=0, \ldots, g)$ denote the $j$ th Chern class of $\mathbb{E}_{g, n}$. For more details and references about formula (1.6) see e.g. [25].

Denote by $\mathcal{F}_{g, \text { deg=0 }}^{X}(\mathbf{t})$ the degree zero part of the genus $g$ free energy $\mathcal{F}_{g}^{X}(\mathbf{t} ; q)$, i.e.,

\mathcal{F}_{g, \mathrm{deg}=0}^{X}(\mathbf{t})=\sum_{n} \sum_{\substack{\alpha_{1}, \ldots, \alpha_{n} \\ i_{1}, \ldots, i_{n}}} \frac{t^{\alpha_{1}, i_{1}} \cdots t^{\alpha_{n}, i_{n}}}{n!} \int_{\left[X_{g, n, 0}\right] \mathrm{virt}^{\operatorname{irt}}} c_{1}\left(\mathcal{L}_{1}\right)^{i_{1}} \operatorname{ev}_{1}^{*}\left(\phi_{\alpha_{1}}\right) \cdots c_{1}\left(\mathcal{L}_{n}\right)^{i_{n}} \operatorname{ev}_{n}^{*}\left(\phi_{\alpha_{n}}\right) . \tag{1.7}

Following [6, 21, 25], let us apply formula (1.6) for the computation of $\mathcal{F}_{g, \operatorname{deg}=0}^{X}(\mathbf{t})$.
In genus zero,

\int_{\left[X_{0, n, 0}\right]^{\mathrm{irrt}}} c_{1}\left(\mathcal{L}_{1}\right)^{i_{1}} \operatorname{ev}_{1}^{*}\left(\phi_{\alpha_{1}}\right) \cdots c_{1}\left(\mathcal{L}_{n}\right)^{i_{n}} \operatorname{ev}_{n}^{*}\left(\phi_{\alpha_{n}}\right)=\int_{\overline{\mathcal{M}}_{0, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}} \int_{X} \phi_{\alpha_{1}} \cdots \phi_{\alpha_{n}} \tag{1.8}

Together with the well-known formula $\int_{\overline{\mathcal{M}}_{0, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}}=\binom{n-3}{i_{1}, \ldots, i_{n}}$, one obtains

\mathcal{F}_{g=0, \operatorname{deg}=0}^{X}(\mathbf{t})=\sum_{n \geq 3} \frac{1}{n(n-1)(n-2)} \sum_{i_{1}+\cdots+i_{n}=n-3} \int_{X} \frac{\mathbf{t}^{i_{1}} \cdots \mathbf{t}^{i_{n}}}{i_{1}!\cdots i_{n}!}, \tag{1.9}

where $\mathbf{t}^{i}:=\sum_{\alpha} t^{\alpha, i} \phi_{\alpha}, i \geq 0$, are the cohomology-valued times.
In genus one, we know from [25] that

e\left(\mathbb{E}_{1, n}^{\vee} \boxtimes T_{X}\right)=c_{D}\left(\mathbb{E}_{1, n}^{\vee} \boxtimes T_{X}\right)=c_{D}(X)-\lambda_{1} c_{D-1}(X), \quad n \geq 1, \tag{1.10}
\end{equation*}

and so,

& \int_{\left[X_{1, n, 0}\right]^{\mathrm{virt}}} c_{1}\left(\mathcal{L}_{1}\right)^{i_{1}} \operatorname{ev}_{1}^{*}\left(\phi_{\alpha_{1}}\right) \cdots c_{1}\left(\mathcal{L}_{n}\right)^{i_{n}} \operatorname{ev}_{n}^{*}\left(\phi_{\alpha_{n}}\right) \\
& \quad=\int_{\overline{\mathcal{M}}_{1, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}} \int_{X} \phi_{\alpha_{1}} \cdots \phi_{\alpha_{n}} c_{D}(X)-\int_{\overline{\mathcal{M}}_{1, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}} \lambda_{1} \int_{X} \phi_{\alpha_{1}} \cdots \phi_{\alpha_{n}} c_{D-1}(X) . \tag{1.11}
\end{align*}

Combined with explicit computations given in e.g. [6, 7, 8, it follows that

\mathcal{F}_{g=1, \operatorname{deg}=0}^{X}(\mathbf{t})=\frac{1}{24}\left\langle c_{D}(X), \log V_{1}(\mathbf{t})\right\rangle-\frac{1}{24}\left\langle c_{D-1}(X), V(\mathbf{t})\right\rangle . \tag{1.12}

Here and below, for $\mathbf{T}=\left(T_{0}, T_{1}, T_{2}, \ldots\right)$,

V(\mathbf{T}):=\sum_{n \geq 1} \frac{1}{n} \sum_{i_{1}+\cdots+i_{n}=n-1} \frac{T_{i_{1}} \ldots T_{i_{n}}}{i_{1}!\ldots i_{n}!}, \quad V_{k}(\mathbf{T}):=\frac{\partial^{k} V(\mathbf{T})}{\partial T_{0}^{k}}(k \geq 0) \tag{1.13}

and $V_{k}(\mathbf{t}), k \geq 0$, are understood as replacing $T_{i}$ by $\mathbf{t}^{i}, i \geq 0$.
In genus bigger than or equal to two, we divide the consideration into several cases. For the case when the dimension $D$ is bigger than 3 , the virtual dimension (1.2) is negative and $\mathcal{F}_{g, \mathrm{deg}=0}^{X}(\mathbf{t})$ vanishes. For the case when $D=3$, i.e., $X$ is a threefold, Getzler and Pandharipande [21] obtain

\end{equation*}

Using this formula and the well-known formula (cf. [16, 17])

\int_{\overline{\mathcal{M}}_{g, 0}} \lambda_{g} \lambda_{g-1} \lambda_{g-2}=\frac{1}{2(2 g-2)!} \frac{\left|B_{2 g-2}\right|}{2 g-2} \frac{\left|B_{2 g}\right|}{2 g}, \quad g \geq 2 \tag{1.15}
\end{equation*}

the following closed expression for $\mathcal{F}_{g, \operatorname{deg}=0}^{X}(\mathbf{t})$ is obtained in [7]:

\mathcal{F}_{g, \operatorname{deg}=0}^{X}(\mathbf{t})=\frac{(-1)^{g}}{2(2 g-2)!} \frac{\left|B_{2 g-2}\right|}{2 g-2} \frac{\left|B_{2 g}\right|}{2 g}\left\langle c_{3}(X)-c_{2}(X) c_{1}(X), V_{1}(\mathbf{t})^{2 g-2}\right\rangle, \quad g \geq 2 \tag{1.16}

Here and below, $B_{k}$ denote the Bernoulli numbers. When $D=0$, i.e., $X$ is a point, the GW invariants of $X$ can be uniquely determined by the celebrated Witten-Kontsevich theorem (cf. [24, (30). The remaining cases are the $D=1$ case and the $D=2$ case, i.e., $X$ is a curve or a surface. The focus of this paper is the curve case, and we leave the surface case yet to a future publication.

From now on we assume that $X$ is a smooth projective curve of genus $h$. Getzler and Pandharipande [21] show that

(also true for $g=1$ being compared with (1.10)). So for all $g \geq 1$, we have

& (-1)^{g} \int_{\left[X_{g, n, 0}\right] \mathrm{virit} c_{1}\left(\mathcal{L}_{1}\right)^{i_{1}} \mathrm{ev}_{1}^{*}\left(\phi_{\alpha_{1}}\right) \cdots c_{1}\left(\mathcal{L}_{n}\right)^{i_{n}} \mathrm{ev}_{n}^{*}\left(\phi_{\alpha_{n}}\right)}^{\quad=\int_{\overline{\mathcal{M}}_{g, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}} \lambda_{g} \int_{X} \phi_{\alpha_{1}} \cdots \phi_{\alpha_{n}}-\int_{\overline{\mathcal{M}}_{g, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}} \lambda_{g-1} \int_{X} \phi_{\alpha_{1}} \cdots \phi_{\alpha_{n}} c_{1}(X)} .

In terms of generating series, we have

(-1)^{g} \mathcal{F}_{g, \operatorname{deg}=0}^{X}(\mathbf{t})=\left\langle 1, \mathcal{H}_{g}\left(\lambda_{g} ; \mathbf{t}\right)\right\rangle-\left\langle c_{1}(X), \mathcal{H}_{g}\left(\lambda_{g-1} ; \mathbf{t}\right)\right\rangle, \quad g \geq 1 \tag{1.19}
\end{equation*}
$$

Here, for an element $\varphi \in H^{*}\left(\overline{\mathcal{M}}_{g, n} ; \mathbb{C}\right)$, and for $\mathbf{T}=\left(T_{0}, T_{1}, T_{2}, \ldots\right)$,

\mathcal{H}_{g}(\varphi ; \mathbf{T}):=\sum_{n} \sum_{i_{1}, \ldots, i_{n}} \int_{\overline{\mathcal{M}}_{g, n}} \psi_{1}^{i_{1}} \cdots \psi_{n}^{i_{n}} \varphi \frac{T_{i_{1}} \ldots T_{i_{n}}}{n!} \tag{1.20}

and $\mathcal{H}_{g}(\varphi ; \mathbf{t}), g \geq 1$, are understood by replacing $T_{i}$ by $\mathbf{t}^{i}, i \geq 0$. We note that the power series $V(\mathbf{T})$ given in (1.13) is just $\partial^{2} \mathcal{H}_{0}(1 ; \mathbf{T}) / \partial T_{0}^{2}$. It remains to compute $\mathcal{H}_{g}\left(\lambda_{g} ; \mathbf{T}\right)$ and $\mathcal{H}_{g}\left(\lambda_{g-1} ; \mathbf{T}\right)$; in other words, we need to compute

It follows from the $\lambda_{g}$ conjecture [21] that the Hodge integrals in (1.21) with $\lambda_{g}$ have the explicit expression:

The $\lambda_{g}$ conjecture is proved in [18]. In [8] it is shown that formula (1.22) yields

Computation for the Hodge integrals in (1.21) with $\lambda_{g-1}$ is more involved. In [6, 7, closed expressions for $\mathcal{H}_{g}\left(\lambda_{g-1} ; \mathbf{T}\right)$ for the first few values of $g$ are found; for example,

& \mathcal{H}_{3}\left(\lambda_{2} ; \mathbf{T}\right)=-\frac{19 V_{2}^{4}}{53760 V_{1}^{4}}+\frac{151}{207360} \frac{V_{2}^{2} V_{3}}{V_{1}^{3}}-\frac{61 V_{3}^{2}}{322560 V_{1}^{2}}-\frac{373 V_{2} V_{4}}{1451520 V_{1}^{2}}+\frac{41 V_{5}}{580608 V_{1}} . \tag{1.25}

Note that on the right-hand sides, we omitted the arguments $\mathbf{T}$ in $V_{m}(\mathbf{T})$.
Before proceeding, we recall some notations. A partition is a non-increasing infinite sequence of non-negative integers $\mu=\left(\mu_{1}, \mu_{2}, \ldots\right)$. The number of non-zero components of $\mu$ is called the length of $\mu$, denoted by $\ell(\mu)$. The sum $\sum_{i \geq 1} \mu_{i}$ is called the weight of $\mu$, denote by $|\mu|$. The set of all partitions is denoted by $\mathcal{P}$, and the set of partitions of weight $k$ is denoted by $\mathcal{P}_{k}$. A partition $\mu$ of weight $k$ is also called a partition of $k$. If the length of the partition $\mu$ is positive, it is often denoted by $\mu=\left(\mu_{1}, \ldots, \mu_{\ell(\mu)}\right)$; otherwise, it can be denoted either as ( 0 ) or as (). Denote $\mu+1=\left(\mu_{1}+1, \ldots, \mu_{\ell(\mu)}+1\right)$ if $\ell(\mu)>0$, and ()$+1=()$ otherwise. The expression $m_{i}(\mu)$ will denote the multiplicity of $i$ in $\mu, i \geq 1$, and denote $m(\mu)!=\prod_{i=1}^{\infty} m_{i}(\mu)$ !. For a sequence of indeterminates $\left(y_{0}, y_{1}, y_{2}, \ldots\right), y_{\mu}:=\prod_{i=1}^{\ell(\mu)} y_{\mu_{i}}\left(\right.$ clearly, $\left.y_{()}=1\right)$.

According to [7, 8], for $g \geq 1$ there exist functions $W_{g}\left(V_{1}, \ldots, V_{2 g-1}\right)$ of $(2 g-1)$ variables of the form

Here $c_{\mu}^{g}$ are constants. For example, $W_{2}\left(V_{1}, V_{2}, V_{3}\right)=\frac{1}{480} \frac{V_{3}}{V_{1}}-\frac{11}{5760} \frac{V_{2}^{2}}{V_{1}^{2}}$. It then follows from formula (1.19) the following proposition.

Proposition 1. For $g \geq 1$, the genus $g$ free energy of $X$ of degree zero has the expression:

\mathcal{F}_{g, \mathrm{deg}=0}^{X}(\mathbf{t})=(-1)^{g} \frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!}\left\langle 1, V_{2 g-2}(\mathbf{t})\right\rangle-(-1)^{g}(2-2 h) W_{g}\left(V_{1}(\mathbf{P}), \ldots, V_{2 g-1}(\mathbf{P})\right) . \tag{1.28}
\end{equation*}
$$

Here $\mathbf{P}:=\left(t^{1,0}, t^{1,1}, \ldots\right)$.
The goal of this paper is to give a closed formula for $W_{g}\left(V_{1}, \ldots, V_{2 g-1}\right)$.
Introduce some more notations. The Lagrange number $L(\mu)$ is defined by

For $g \geq 1$, introduce the rational function $\mathcal{B}_{g}(\lambda ; \mathbf{V})$ as follows:

&-\frac{1}{2} \sum_{\substack{g_{1}+g_{2}=g \\
g_{1}, g_{2} \geq 1}} \frac{2^{2 g_{1}-1}-1}{2^{2 g_{1}-1}} \frac{\left|B_{2 g_{1}}\right|}{\left(2 g_{1}\right)!} \frac{2^{2 g_{2}-1}-1}{2^{2 g_{2}-1}} \frac{\left|B_{2 g_{2}}\right|}{\left(2 g_{2}\right)!}\left(\frac{1}{\lambda-V}\right)_{2 g_{1}-1}\left(\frac{1}{\lambda-V}\right)_{2 g_{2}-1}, \tag{1.30}
\end{align*}
$$

where $\mathbf{V}=\left(V_{0}=V, V_{1}, V_{2}, \ldots\right)$, and for a function $f(\mathbf{V})$ and $r \geq 0,(f(\mathbf{V}))_{r}$ means $\partial^{r}(f(\mathbf{V}))$ with $\partial:=\sum_{k} V_{k+1} \partial / \partial V_{k}$. Denote $\mathcal{B}_{g, j}=\operatorname{Coef}\left((\lambda-V)^{-j-1}, \mathcal{B}_{g}(\lambda ; \mathbf{V})\right)$. We will prove in Section 3 the following theorem.

Theorem 1. For $g \geq 2$, we have

c_{i, j}:=\frac{1}{j!} \sum_{\mu \in \mathcal{P}_{j-i}}\binom{\ell(\mu)+j-1}{i-1} L(\mu) \frac{V_{\mu+1}}{V_{1}^{\ell(\mu)+j}} . \tag{1.32}
\end{equation*}

Let us briefly describe the idea of the proof. Observe from (1.28) that the functions $W_{g}$ in (1.28) are independent of $X$, so we can compute $W_{g}$ by taking $X=\mathbb{P}^{1}$. The partition function

$$
Z^{\mathbb{P}^{1}}(\mathbf{t} ; \epsilon, q):=\exp \left(\mathcal{F}^{\mathbb{P}^{1}}(\mathbf{t} ; \epsilon, q)\right)
$$

is deeply connected with integrable systems [12, 28, 29, so one can apply the theory of integrable systems (Lax pairs, Virasoro constraints, etc.) to get closed expressions of them; for example, explicit $n$-point functions are obtained in 9, 20 by using the Toda lattices. In this paper, we will employ the loop equation [12] for $\mathbb{P}^{1}$.

As a special case of Theorem 1 , we will give in Section 4 a simple proof of the following theorem. Theorem A ([17, 21]). For $g \geq 1$, the following formula holds:

g_{1}, g_{2}>0}}\left(2^{2 g_{1}-1}-1\right)\left(2^{2 g_{2}-1}-1\right) \frac{\left|B_{2 g_{1}}\right|}{2 g_{1}} \frac{\left|B_{2 g_{2}}\right|}{2 g_{2}} . \tag{1.33}
\end{align*}

The paper is organized as follows. In Section 2 we review the loop equation for GW invariants of $\mathbb{P}^{1}$. In Section 3 we prove Theorem [1. Some applications are discussed in Section 4 .

## 2. Loop equation for GW invariants of $\mathbb{P}^{1}$

In this section, we review the loop equation for GW invariants of the complex projective line, that can be derived using the structure of the associated Frobenius manifold as a result of the following three properties:

1) Virasoro constraints for the genus zero free energy;
2) Existence of jet-variable representation for the higher genera free energies;
3) Virasoro constraints for the all-genus free energy.

Recall that the Frobenius manifold [5 associated to the GW invariants of $\mathbb{P}^{1}$ has the potential

Here $\left(v^{1}, v^{2}\right)$ is a system of flat coordinates for the invariant flat metric of this Frobenius manifold with $\partial_{v^{1}}$ being the unity vector field, and we will also use the notation $v=v^{1}, u=v^{2}$. The
principal hierarchy associated to this Frobenius manifold is a hierarchy of commuting evolutionary PDEs given by

\frac{\partial v^{\alpha}}{\partial t^{\beta, i}}=\sum_{\rho} \eta^{\alpha \rho} \partial_{x}\left(\frac{\partial \theta_{\beta, i+1}(v, u ; q)}{\partial v^{\rho}}\right), \quad i \geq 0, \alpha, \beta=1,2 \tag{2.2}
\end{equation*}
$$

where $\eta^{\alpha \rho}=\delta_{\alpha+\rho, 3}$, and $\left(\theta_{\alpha, k}\left(v^{1}, v^{2} ; q\right)\right)_{\alpha=1,2, k \geq 0}$ are holomorphic functions which can be defined via the generating series [11, 12]

& \theta_{1}(v, u ; q ; z):=\sum_{k \geq 0} \theta_{1, k}(v, u ; q) z^{k}=-2 e^{z v} \sum_{m \geq 0}\left(\gamma-\frac{1}{2} u+\psi(m+1)\right) q^{m} e^{m u} \frac{z^{2 m}}{m!^{2}}  \tag{2.3}\\
& \theta_{2}(v, u ; q ; z):=\sum_{k \geq 0} \theta_{2, k}(v, u ; q) z^{k}=z^{-1}\left(\sum_{m \geq 0} q^{m} e^{m u+z v} \frac{z^{2 m}}{m!^{2}}-1\right), \tag{2.4}
\end{align*}
$$

where $\gamma$ is the Euler constant and $\psi$ denotes the digamma function. The reader who is familiar with the theory of Frobenius manifolds recognizes that the above $\left(\theta_{1}(v, u ; z), \theta_{2}(v, u ; z)\right)$ give a system of the deformed flat coordinates for the Dubrovin connection of the Frobenius manifold under consideration. It is easy to observe that the $\partial / \partial t^{1,0}$ flow coincides with $\partial_{x}$; therefore, we identify $t^{1,0}$ with $x$. We also remind the reader that the integrability of the principal hierarchy (2.2) is guaranteed by the Frobenius manifold structure. Since (2.2) is integrable, one can solve equations in (2.2) together, yielding solutions of the form $(v=v(\mathbf{t} ; q), u=u(\mathbf{t} ; q))$. Following [5], define the genus zero two-point correlation functions $\Omega_{\alpha, i ; \beta, j}^{[0]}(v, u)$ by means of the generating series as follows:

\sum_{i, j \geq 0} \Omega_{\alpha, i ; \beta, j}^{[0]}(v, u ; q) z^{i} y^{j}=\frac{1}{z+y}\left(\sum_{\rho, \sigma} \frac{\partial \theta_{\alpha}(v, u ; q ; z)}{\partial v^{\rho}} \eta^{\rho \sigma} \frac{\partial \theta_{\beta}(v, u ; q ; y)}{\partial v^{\sigma}}-\eta_{\alpha \beta}\right), \quad \alpha, \beta=1,2 . \tag{2.5}
\end{equation*}
$$

Solutions $(v=v(\mathbf{t} ; q), u=u(\mathbf{t} ; q))$ to the principal hierarchy (2.2) are characterized by their initial values

\left.(v(\mathbf{t} ; q), u(\mathbf{t} ; q))\right|_{t^{\alpha, i}=x \delta^{\alpha, 1} \delta^{i, 0}, \alpha=1,2, i \geq 0} . \tag{2.6}
\end{equation*}

The topological solution $\left(v_{\text {top }}(\mathbf{t} ; q), u_{\text {top }}(\mathbf{t} ; q)\right)$ to the principal hierarchy is defined as the unique solution subjected to the initial value

(x, 0) . \tag{2.7}
\end{equation*}
$$

It is straightforward to show that this solution satisfies

\left.v_{\mathrm{top}}(\mathbf{t} ; q)\right|_{t^{\alpha, i}=0, \alpha=1,2, i>0}=t^{1,0},\left.\quad u_{\mathrm{top}}(\mathbf{t} ; q)\right|_{t^{\alpha, i}=0, \alpha=1,2, i>0}=t^{2,0} . \tag{2.8}
\end{equation*}
$$

According to [5], the topological solution $\left(v_{\text {top }}(\mathbf{t} ; q), u_{\text {top }}(\mathbf{t} ; q)\right)$ can alternatively be determined by the following genus zero Euler-Lagrange equation:

\end{equation*}

where $\tilde{t}^{\alpha, i}:=t^{\alpha, i}-\delta^{\alpha, 1} \delta^{i, 1}$.
Recall [5] (cf. [10, 12]) that the genus zero free energy of GW invariants of $\mathbb{P}^{1}$ has the expression

\mathcal{F}_{0}^{\mathbb{P}^{1}}(\mathbf{t} ; q)=\frac{1}{2} \sum_{\alpha, \beta} \sum_{i, j} \tilde{t}^{\alpha, i} \tilde{t}^{\beta}, j \Omega_{\alpha, i ; \beta, j}^{[0]}\left(v_{\mathrm{top}}(\mathbf{t} ; q), u_{\mathrm{top}}(\mathbf{t} ; q) ; q\right) \tag{2.10}
\end{equation*}

which satisfies the following genus zero Virasoro constraints [10] (cf. [14, [22, 26]):

e^{-\epsilon^{-2} \mathcal{F}_{0}^{\mathbb{P}^{1}}(\mathbf{t} ; q)} L_{m}\left(e^{\epsilon^{-2} \mathcal{F}_{0}^{\mathbb{1}^{1}}(\mathbf{t} ; q)}\right)=\mathrm{O}(1) \quad(\epsilon \rightarrow 0), \quad m \geq-1, \tag{2.11}
\end{equation*}

where $L_{m}, m \geq-1$, are the linear operators given by

L_{m}= & \epsilon^{2} \sum_{k=1}^{m-1} k!(m-k)!\frac{\partial^{2}}{\partial t^{2, k-1} \partial t^{2, m-k-1}}+\sum_{k \geq 1} \frac{(m+k)!}{(k-1)!}\left(\tilde{t}^{1, k} \frac{\partial}{\partial t^{1, m+k}}+\tilde{t}^{2, k-1} \frac{\partial}{\partial t^{2, m+k-1}}\right) \\
& +2 \sum_{k \geq 0} A_{m}(k) \tilde{t}^{1, k} \frac{\partial}{\partial t^{2, m+k-1}}+\delta_{m, 0} \frac{t^{1,0} t^{1,0}}{\epsilon^{2}}, \quad m \geq 0 \tag{2.13}
\end{align*}

with

A_{m}(0)=m!, \quad A_{m}(k)=\frac{(m+k)!}{(k-1)!} \sum_{j=k}^{m+k} \frac{1}{j}(k>0) \tag{2.14}
\end{equation*}

These operators $L_{m}, m \geq-1$, satisfy the Virasoro commutation relations:

Let us proceed with higher genera. According to [4, 11, 12, 15, 19, 22, the higher genus free energies $\mathcal{F}_{g}^{\mathbb{P}^{1}}(\mathbf{t} ; q), g \geq 1$, have the $(3 g-2)$ property, namely, there exist functions

$\mathcal{F}_{g}^{\mathbb{P}^{1}}(\mathbf{t} ; q)=F_{g}\left(v_{\mathrm{top}}(\mathbf{t} ; q), u_{\mathrm{top}}(\mathbf{t} ; q), \frac{\partial v_{\mathrm{top}}(\mathbf{t} ; q)}{\partial x}, \frac{\partial u_{\mathrm{top}}(\mathbf{t} ; q)}{\partial x}, \ldots, \frac{\partial^{3 g-2} v_{\mathrm{top}}(\mathbf{t} ; q)}{\partial x^{3 g-2}}, \frac{\partial^{3 g-2} u_{\mathrm{top}}(\mathbf{t} ; q)}{\partial x^{3 g-2}} ; q\right)$.
Moreover, the partition function of the GW invariants of $\mathbb{P}^{1}$ satisfies the Virasoro constraints [22, 27] (cf. [11, 12, 13]):

Here $L_{m}, m \geq-1$, are the above-defined operators.

\Delta F=\Delta F\left(v, u, v_{1}, u_{1}, v_{2}, u_{2}, \ldots ; \epsilon, q\right):=\sum_{g \geq 1} \epsilon^{2 g-2} F_{g}\left(v, u, v_{1}, u_{1}, \ldots, v_{3 g-2}, u_{3 g-2} ; q\right) \tag{2.19}
\end{equation*}
$$

Based on formulae (2.10), (2.11), the $(3 g-2)$ jet-representation (2.17), and the above Virasoro constraints (2.18), Dubrovin and Zhang derive [11, 12] the loop equation for GW invariants of $\mathbb{P}^{1}$, given in the following theorem. (The derivation is also revisited and slightly simplified in [31].)

Theorem B. (Dubrovin-Zhang [11, 12]). The function $\Delta F$ satisfies the following loop equation:

& +\sum_{r \geq 1} \sum_{k=1}^{r}\binom{r}{k}\left(\frac{1}{\sqrt{D}}\right)_{k-1}\left(\frac{\partial \Delta F}{\partial v_{r}}\left(\frac{v-\lambda}{\sqrt{D}}\right)_{r-k+1}-2 \frac{\partial \Delta F}{\partial u_{r}}\left(\frac{1}{\sqrt{D}}\right)_{r-k+1}\right) \\
& +\frac{q e^{u}}{\left((\lambda-v)^{2}-4 q e^{u}\right)^{2}} \\
& +\epsilon^{2} \sum_{k, l \geq 0}\left(\frac{1}{4} S\left(\Delta F, v_{k}, v_{l}\right)\left(\frac{\lambda-v}{\sqrt{D}}\right)_{k+1}\left(\frac{\lambda-v}{\sqrt{D}}\right)_{l+1}\right. \\
& \left.+S\left(\Delta F, v_{k}, u_{l}\right)\left(\frac{\lambda-v}{\sqrt{D}}\right)_{k+1}\left(\frac{1}{\sqrt{D}}\right)_{l+1}+S\left(\Delta F, u_{k}, u_{l}\right)\left(\frac{1}{\sqrt{D}}\right)_{k+1}\left(\frac{1}{\sqrt{D}}\right)_{l+1}\right) \\
& +\frac{\epsilon^{2}}{2} \sum_{k \geq 0}\left(\frac{\partial \Delta F}{\partial v_{k}}\left(q e^{u} \frac{4 q e^{u}(v-\lambda) u_{1}-\left((v-\lambda)^{2}+4 q e^{u}\right) v_{1}}{D^{3}}\right)_{k+1}\right. \\
& \left.\quad+\frac{\partial \Delta F}{\partial u_{k}}\left(q e^{u} \frac{4(v-\lambda) v_{1}-\left((v-\lambda)^{2}+4 q e^{u}\right) u_{1}}{D^{3}}\right)_{k+1}\right)=0, \tag{2.20}
\end{align*}
$$

where $D=(v-\lambda)^{2}-4 q e^{u}, S(f, a, b):=\frac{\partial^{2} f}{\partial a \partial b}+\frac{\partial f}{\partial a} \frac{\partial f}{\partial b}$, and $f_{r}$ stands for $\partial^{r}(f)$ with

\partial:=\sum_{\alpha} \sum_{m} v_{m+1}^{\alpha} \frac{\partial}{\partial v_{m}^{\alpha}} . \tag{2.21}
\end{equation*}

Moreover, the solution to the above loop equation (2.20) is unique up to a sequence of additive elements $c_{1}, c_{2}, \cdots \in \mathbb{C}[[q]]$ that can be determined by the value

and the dilaton equation

We note that the identity (2.20) should be understood to be valid identical in $\lambda$ for $\lambda$ large. In particular, the branch of $\sqrt{D}$ is taken so that $\sqrt{D} \sim \lambda$ for $\lambda$ large.

## 3. Proof of Theorem 1

In this section, we give a proof of Theorem by applying the loop equation (2.20).
Proof of Theorem 1. To simplify the notations, let us denote $P_{i}=t^{1, i}, Q_{i}=t^{2, i}, i \geq 0$, and

\mathbf{P}=\left(P_{0}, P_{1}, \ldots\right), \quad \mathbf{Q}=\left(Q_{0}, Q_{1}, \ldots\right)
$$

By (1.19) and (1.23) we know that for $g \geq 1$,

(-1)^{g} \mathcal{F}_{g, \mathrm{deg}=0}^{\mathbb{P}^{1}}(\mathbf{t} ; \epsilon)=\frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!}\left\langle 1, V_{2 g-2}(\mathbf{t})\right\rangle-2 \mathcal{H}_{g}\left(\lambda_{g-1} ; \mathbf{P}\right) . \tag{3.1}
\end{equation*}
$$

Here we recall that $\mathbf{t}=\left(t^{\alpha, i}\right)_{\alpha=1,2, i \geq 0}$. We also note that $\mathbf{t}^{i}=P_{i} 1+Q_{i}[\mathrm{pt}], i \geq 0$, are the cohomology-valued times for $\mathbb{P}^{1}$. Define a power series

By using Proposition 1 we can write (3.1) in terms of the two power series $V(\mathbf{P})$ and $U(\mathbf{P}, \mathbf{Q})$ as follows:

(-1)^{g} \mathcal{F}_{g, \operatorname{deg}=0}^{\mathbb{P}^{1}}(\mathbf{t} ; \epsilon)=\frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!} U_{2 g-2}(\mathbf{P}, \mathbf{Q})-2 W_{g}\left(V_{1}(\mathbf{P}), \ldots, V_{2 g-1}(\mathbf{P})\right), \quad g \geq 1 . \tag{3.3}
\end{equation*}
$$

(Observe that the power series $(V(\mathbf{P}), U(\mathbf{P}, \mathbf{Q}))$ is actually the degree zero part of the topological solution to the principal hierarchy (2.2) of the $\mathbb{P}^{1}$-Frobenius manifold.)

Taking the degree zero part (coefficient of $q^{0}$ ) in the Dubrovin-Zhang loop equation (2.20), we obtain

where $M$ is an upper-triangular and non-degenerate matrix and $\mathcal{C}_{g}=\left(\mathcal{B}_{g, 1}, \ldots, \mathcal{B}_{g, 2 g-1}\right)^{T}$ with $\mathcal{B}_{g, j}=\operatorname{Coef}\left((\lambda-V)^{-j-1}, \mathcal{B}_{g}(\lambda ; \mathbf{V})\right)$ as in Section 回. Since $M$ is upper-triangular, it is not difficult to calculate the explicit expression of its inverse, and we find

$$
\begin{equation*}
\left(M^{-1}\right)_{i j}=\sum_{\mu \in \mathcal{P}_{j-i}} \frac{1}{j!}\binom{\ell(\mu)+j-1}{i-1} L(\mu) \frac{V_{\mu+1}}{V_{1}^{\ell(\mu)+j}} . \tag{3.6}
\end{equation*}
$$

The theorem is then proved by noticing from (1.26) that $\sum_{m=2}^{2 g-1}(m-1) V_{m} \frac{\partial W_{g}}{\partial V_{m}}=(2 g-2) W_{g}$.
We note that it is also clear from (1.26) that (1.31) can be equivalently written as

$$
\begin{equation*}
W_{g}\left(V_{1}, \ldots, V_{2 g-2}\right)=\frac{1}{2 g-2} \sum_{k=1}^{2 g-1} k V_{k} \sum_{j=1}^{2 g-1} c_{k, j} \mathcal{B}_{g, j} \tag{3.7}
\end{equation*}
$$

Remark 1. In our proof, we used the degree zero part of the loop equation (or say of Virasoro constraints) together with (1.22). We note that it is also possible to use the Virasoro constraints themselves as the uniqueness in Theorem B suggests (of course existence of jet-representation is also needed here), and the point is that more constraints on the degree zero invariants come from the degree one part of the Virasoro constraints.

## 4. Applications

In this section, we give some applications of Proposition 1 and Theorem 1 ,
Let $X$ be a smooth projective curve of genus $h$. The notations will be the same as in Section 1. For a partition $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ with length $n$, denote

$$
\begin{equation*}
C_{\lambda_{1}, \ldots, \lambda_{n}}^{X}(q):=\sum_{\substack{d, g \geq 0 \\ 2 g-2=d(2 h-2)+|\lambda|}} q^{d} \int_{\left[X_{g, n, d}\right] \operatorname{virt}} c_{1}\left(\mathcal{L}_{1}\right)^{\lambda_{1}} \operatorname{ev}_{1}^{*}([\mathrm{pt}]) \cdots c_{1}\left(\mathcal{L}_{n}\right)^{\lambda_{n}} \operatorname{ev}_{n}^{*}([\mathrm{pt}]) \tag{4.1}
\end{equation*}
$$

We note that the integrals appearing in the above generating function is often called GW invariants in the stationary sector.

Consider the case that $X=E$ is an elliptic curve. The following closed formula for the genus $g$, $g \geq 1$, free energy (in all degrees) $\mathcal{F}_{g}^{E}(\mathbf{t} ; q)$ for the elliptic curve $E$ is obtained by Buryak [1]:

$$
\begin{equation*}
\mathcal{F}_{g}^{E}(\mathbf{t} ; q)=\sum_{\lambda \in \mathcal{P}_{2 g-2}} \frac{U_{\lambda}(\mathbf{t})}{\prod_{j \geq 1} m_{j}(\lambda)!} C_{\lambda}^{E}\left(q e^{U(\mathbf{t})}\right)-\frac{U(\mathbf{t})}{24} \delta_{g, 1} \tag{4.2}
\end{equation*}
$$

where

$$
\begin{equation*}
U(\mathbf{t}):=\frac{\partial^{2} \mathcal{F}_{0}^{E}(\mathbf{t})}{\partial t^{1,0} \partial t^{1,0}} \tag{4.3}
\end{equation*}
$$

Note that we have omitted the argument $q$ in $\mathcal{F}_{0}^{E}(\mathbf{t} ; q)$ because it actually does not depend on $q$, and that $C_{\lambda}^{E}(q)$ vanishes if $|\lambda|$ is odd. Explicitly, $U(\mathbf{t})$ has the expression:

$$
\begin{equation*}
U(\mathbf{t})=\sum_{i} Q_{i} \frac{\partial V(\mathbf{P})}{\partial P_{i}}+\sum_{i, j} t^{2, i} t^{3, j} \frac{\partial^{2} V(\mathbf{P})}{\partial P_{i} \partial P_{j}} \tag{4.4}
\end{equation*}
$$

which can be obtained from (1.9). Here $Q_{i}=t^{4, i}, P_{i}=t^{1, i}$, and $V(\mathbf{P})$ is the power series defined by (1.13) as before.

By taking the degree zero limit in Buryak's formula (4.2) we obtain that

$$
\begin{equation*}
\mathcal{F}_{g, \operatorname{deg}=0}^{E}(\mathbf{t})=\sum_{\lambda \in \mathcal{P}_{2 g-2}} \frac{U_{\lambda}(\mathbf{t})}{\prod_{j \geq 1} m_{j}(\lambda)!} C_{\lambda}^{E}(0)-\frac{U(\mathbf{t})}{24} \delta_{g, 1}, \quad g \geq 1 \tag{4.5}
\end{equation*}
$$

We have the following corollary.
Corollary 1. For $g \geq 1$ and for a partition $\lambda \in \mathcal{P}_{2 g-2}$,

$$
C_{\lambda}^{E}(0)=\left\{\begin{array}{cc}
(-1)^{g} \frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!}+\frac{1}{24} \delta_{g, 1}, & \lambda=(2 g-2)  \tag{4.6}\\
0, & \text { otherwise }
\end{array}\right.
$$

Proof. From Proposition 1 and formula (4.4) we know that

$$
\begin{equation*}
\mathcal{F}_{g, \operatorname{deg}=0}^{E}(\mathbf{t})=(-1)^{g} \frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!} U_{2 g-2}(\mathbf{t}) \tag{4.7}
\end{equation*}
$$

The corollary is then proved by comparing this expression with (4.5).
Example 1. Denote

$$
\begin{align*}
\sigma_{s}(d) & =\sum_{a \mid d} a^{s}, \quad s \geq 0  \tag{4.8}\\
E_{k}(q) & =\frac{\zeta(1-k)}{2}+\sum_{d \geq 1} \sigma_{k-1}(d) q^{d}, \quad k=2,4,6 \tag{4.9}
\end{align*}
$$

According to [28] (cf. [1, 3, 23]),

$$
\begin{align*}
& C_{(0)}^{E}(q)=E_{2}(q)-\frac{\zeta(-1)}{2}, \quad C_{(2)}^{E}(q)=\frac{E_{4}(q)}{12}+\frac{E_{2}(q)^{2}}{2}  \tag{4.10}\\
& C_{(1,1)}^{E}(q)=\frac{7 E_{6}(q)}{180}+\frac{2}{3} E_{2}(q) E_{4}(q)-\frac{8}{3} E_{2}(q)^{3} \tag{4.11}
\end{align*}
$$

The constant values of these functions agree with (4.6).
Actually, by taking the stationary sector part (i.e. by taking all $\mathbf{t}=\mathbf{0}$ except for $t^{2 h+2, i}$, s) of formula (1.28) in Proposition [1 we find that formula (4.6) with $E$ replaced by $X$ is true for an arbitrary smooth curve $X$. This general formula was obtained in [28] from the GW/Hurwitz correspondence (see pages 529-530 therein). In particular formula (4.6) is covered by the GW/Hurwitz correspondence, while we used the $\lambda_{g}$ conjecture.

It is clear that, by our formulation, on the contrary, the formula of $C_{\lambda}^{E}(0)$ and Buryak's formula (4.2) lead to a proof of the $\lambda_{g}$ conjecture.

Let us proceed to consider the $\lambda_{g-1}$ integrals and give a new proof of Theorem A.
Proof of Theorem A. From the definition (1.30) we know that $\mathcal{B}_{g}(\lambda ; \mathbf{V})$ is a rational function of $\lambda$, which has a (2g)th order pole at $\lambda=V$. More precisely, we deduce from (1.30) that
$\mathcal{B}_{g}(\lambda ; \mathbf{V})$

$$
\begin{aligned}
& \sim \frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!}(2 g-1)!\frac{V_{1}^{2 g-2}}{(\lambda-V)^{2 g}}+\frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!} \sum_{k=1}^{2 g-2}\binom{2 g-2}{k}(k-1)!(2 g-1-k)!\frac{V_{1}^{2 g-2}}{(\lambda-V)^{2 g}} \\
&-\frac{1}{2} \sum_{\substack{g_{1}+g_{2}=g \\
g_{1}, g_{2} \geq 1}} \frac{2^{2 g_{1}-1}-1}{2^{2 g_{1}-1}} \frac{\left|B_{2 g_{1}}\right|}{\left(2 g_{1}\right)!} \frac{2^{2 g_{2}-1}-1}{2^{2 g_{2}-1}} \frac{\left|B_{2 g_{2}}\right|}{\left(2 g_{2}\right)!}\left(2 g_{1}-1\right)!\left(2 g_{2}-1\right)!\frac{V_{1}^{2 g-2}}{(\lambda-V)^{2 g}} \\
&=\left(\frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{2 g} \sum_{k=1}^{2 g-1} \frac{1}{k}-\frac{1}{2^{2 g-1}} \sum_{\substack{g_{1}+g_{2}=g \\
g_{1}, g_{2} \geq 1}}\left(2^{2 g_{1}-1}-1\right) \frac{\left|B_{2 g_{1}}\right|}{2 g_{1}}\left(2^{2 g_{2}-1}-1\right) \frac{\left|B_{2 g_{2}}\right|}{2 g_{2}}\right) \frac{V_{1}^{2 g-2}}{(\lambda-V)^{2 g}} .
\end{aligned}
$$

Here, $\sim$ means keeping only the most singular terms. Therefore, using (1.31), we find

$$
\begin{aligned}
& \operatorname{Coef}\left(V_{2 g-1}, W_{g}\left(V_{1}, \ldots, V_{2 g-1}\right)\right) \\
& =\left(\frac{2^{2 g-1}-1}{2^{2 g-1}} \frac{\left|B_{2 g}\right|}{(2 g)!} \sum_{k=1}^{2 g-1} \frac{1}{k}-\frac{1}{2^{2 g-1}(2 g-1)!} \sum_{\substack{g_{1}+g_{2}=g \\
g_{1}, g_{2} \geq 1}}\left(2^{2 g_{1}-1}-1\right) \frac{\left|B_{2 g_{1}}\right|}{2 g_{1}}\left(2^{2 g_{2}-1}-1\right) \frac{\left|B_{2 g_{2}}\right|}{2 g_{2}}\right) \frac{1}{V_{1}}
\end{aligned}
$$

By noticing that $V_{k}\left(0, \ldots, 0, T_{2 g-1}, 0, \ldots\right)=T_{2 g-1} \delta_{k, 2 g-1}+\delta_{k, 1}(g \geq 2,1 \leq k \leq 2 g-1)$, the theorem is proved.
