# Orthogonality graphs of matrices over commutative rings 

The paper is devoted to studying the orthogonality graph of the matrix ring over a commutative ring. It is proved that the orthogonality graph of the ring of matrices with size greater than 1 over a commutative ring with zero-divisors is connected and has diameter 3 or 4 ; a criterion for each value is obtained. It is also shown that each of its vertices has distance at most 2 from some scalar matrix.

Key words: associative ring with identity, commutative ring, zero-divisor, matrix ring, zero-divisor graph, orthogonality graph.

## § 1. Introduction

Researching properties of associative rings in terms of graphs of some naturally occurring algebraic binary relations takes an important place in modern mathematics. Thus, a zerodivisor graph was first defined in 1986 by Beck [1] for a commutative ring. Its vertices were all zero-divisors, and edges connected exactly all pairs of distinct elements giving zero in product. But since 1999 one uses its more convenient interpretation introduced by Anderson and Livingston in [2] via excluding the zero element of the ring from its vertex set. It is also proved in [2] that the zero-divisor graph of a commutative ring is connected and has diameter at most three; in the former treatment of the graph these statements would be trivial. A number of further papers also studies various characteristics of the zero-divisor graph: center and radius [8], concepts of planarity [4] and uniqueness of determining the ring by the graph up to an isomorphism [3, 5]. For non-commutative rings, there are several types of graphs defined by zero-divisors:

The main results for orthogonality graphs of non-commutative rings found by now concern primarily matrix rings. Thus, in the case of the basic ring being a skew field, the following properties of the orthogonality graph of the $(n \times n)$-matrix ring are obtained: once $n=2$, it is disconnected and all its connected components have diameters at most 2, and, once $n \geqslant 3$, it is connected and has diameter 4. These statements are proved in 2014 for a field [9] and later, in 2017 - for an arbitrary skew field [10]; they can also be easily generalized to integral domains (by reducing to the field of fractions).

In this paper, there will be the orthogonality graph of the matrix ring over a commutative ring with zero-divisors studied and the following main result proved.

Theorem 1.1. Let $R$ be a commutative ring with zero-divisor set $Z_{R} \neq\{0\}$. Then, for any $n>1$, the orthogonality graph of the ring of $(n \times n)$-matrices over $R$ is connected and has diameter 3 or 4 , the value 3 being equivalent to the relation

and each of its vertices has distance at most 2 from some scalar matrix.
Theorem 1.2. Let $r$ be the radius of the graph under conditions of Theorem 1.1. Then 1) $2 \leqslant r \leqslant 4$;
2) if (1.1) holds, then $r \in\{2 ; 3\}$;
3) $r=2$ if and only if there exists an element $c \in R \backslash\{0\}$ such that

## § 2. Auxiliary agreements

In the paper, the following notations and agreements will be used.

1) Set-theoretical:

- While listing elements of a disordered set, figured brackets are used. As for elements of an ordered tuple, they are listed in round brackets and can be repeated.
- $D^{n}:=\underbrace{D \times \ldots \times D}_{n}$ is the $n$-ary Cartesian power of a set $D$.

2) General algebraic:

- All rings considered are supposed to be associative and with identity.
- $R$ is an arbitrary ring.
- For any subset $D \subset R$, define $D^{*}:=D \backslash\{0\}$. In particular, by $R^{*}$ denote the subset of all nonzero (not necessarily invertible as in standard interpretation) elements of $R$.
- An ideal in $R$ is proper if it does not equal $R$.
- $M_{m \times n}(R)$ is the $R$-module of $(m \times n)$-matrices over $R ; M_{n}(R)$ is the ring $M_{n \times n}(R)$. If in the brackets the ring is replaced with some of its subsets $D$, then the subset of all matrices with entries from $D$ is meant.
- $0_{n}^{m}$ is the zero $(m \times n)$-matrix; $0_{n}:=0_{n}^{n} ; E_{n}$ is the identity $(n \times n)$-matrix; $J_{r}$ is the Jordan cell of size $r$ with eigenvalue 0 . If the matrix sizes are clear from the context, then the indices can be omitted.
- $E_{k l}$ is the matrix unit $\left(a_{i j}\right), a_{i j}:=\delta_{k i} \delta_{l j}$.
- For a square matrix $A$ over a commutative ring: $\widetilde{A}$ is its cofactor matrix; $\widehat{A}:=(\widetilde{A})^{T}$.
- If $A=\left(a_{k_{1}, k_{2}}\right) \in M_{n_{1} \times n_{2}}(R), P_{i} \in\left\{1, \ldots, n_{i}\right\}^{m_{i}}(i=1,2)$, then $A_{P_{2}}^{P_{1}}$ is the matrix $\left(b_{l_{1}, l_{2}}\right) \in M_{m_{1} \times m_{2}}(R), b_{l_{1}, l_{2}}:=a_{k_{1}\left(l_{1}\right), k_{2}\left(l_{2}\right)}$, where $k_{i}\left(l_{i}\right)$ is the $l_{i}$-th element of $P_{i}$. If numbers are repeated neither in $P_{1}$, nor in $P_{2}$, then $A_{P_{2}}^{P_{1}}$ is the submatrix of $A$ with row and column numbers from $P_{1}$ and $P_{2}$ respectively.

3) On zero-divisor types:

- An element $a \in R$ is called
- a left (resp. right) zero-divisor if there exists an element $b \in R^{*}$ such that $a b=0$ (resp. $b a=0$ );
- a zero-divisor if it is either left or right zero-divisor;
- a two-sided zero-divisor if it is both left and right zero-divisor.

At that,

- in a commutative ring, the concepts of all zero-divisor types are equivalent;
- zero is a two-sided zero-divisor; if there are no other zero-divisors, then $R$ is called a ring without zero-divisors.
- An integral domain is a commutative ring without zero-divisors.

4) From general graph theory:

- All graphs considered are assumed to be undirected.
- $\Gamma=(V, E)$ is an arbitrary graph; $V$ and $E$ are its vertex and edge sets respectively. In doing so, one can (usually with more convenience) define $E$ via a symmetric binary relation on $V$.
- Two vertices are adjacent if they are connected with an edge.
- A subgraph is a graph with vertex set $V^{\prime} \subset V$ and, unless otherwise stated, with the same binary relation restricted on $V^{\prime}$.
- A path is a sequence of vertices where any two neighbor ones are adjacent.
- The length of a path is the number of its edges.
- The distance between vertices $v$ and $w$ (not. $d(v, w)$ ) is the minimum of lengths of paths between them; if they do not exist, then set $d(v, w):=+\infty$; the sign is obvious in this context and therefore will be omitted. Clearly, $(d(v, w)=0) \Leftrightarrow(v=w)$.
- The distance from a vertex $v$ to a subset $W \subset V($ not. $d(v, W))$ is the number ${ }^{*}$

- $d(v):=\sup \{d(v, w): w \in W\}(v \in V)$.
- The diameter of $\Gamma$ is the number ${ }^{*}$

\operatorname{diam}(\Gamma):=\sup \{d(v, w): v, w \in V\}=\max \{d(v): v \in W\}
$$

- 
- The radius of $\Gamma$ is the number ${ }^{*} \operatorname{rad}(\Gamma):=\min \{d(v): v \in W\}$. Clearly,

\operatorname{rad}(\Gamma) \leqslant \operatorname{diam}(\Gamma) \leqslant 2 \cdot \operatorname{rad}(\Gamma) \tag{2.1}
\end{equation*}

- A graph is connected if there exists a path between any two of its vertices.

Remark. It is easy to see that a graph with finite diameter is connected. The converse fails; an example is the set of positive integers with the neighborhood relation.
5) On special graphs in algebraic structures:

- $O(R)$ is the orthogonality graph of the ring $R$ (for a commutative ring it is the same as the zero-divisor graph).
- Vertices of $O(R)$ are all nonzero two-sided zero-divisors of $R$; the orthogonality relation $(x y=y x=0)$ is written as $(x \perp y) ; O_{R}(x)$ is the set of all vertices orthogonal to $x$.

## $\S 3$. Proofs of the results

Consider an arbitrary commutative ring $R$. Denote by $\operatorname{Ann}(a)(a \in R)$ the ideal $\{x \in$ $\in R: a x=0\}$ and by $Z_{R}$ the set $\{a \in R: \operatorname{Ann}(a) \neq 0\}$ of all zero-divisors. Further, let $S$ be the ring $M_{n}(R)(n>1)$. Via the natural ring embedding $R \hookrightarrow S, a \rightarrow a E$, identify $R$ with the subring $R E \subset S$ (and, thus, $O(R)$ - with a subgraph of the graph $O(S)$ ). For $A \in S$, set $I_{A}:=\operatorname{Ann}(\operatorname{det} A) \triangleleft R$.

The graph $O(R)$ is connected and has diameter at most 3 (see Theorem 2.3 in [2, §2]). Besides, if $R$ is a skew body, then

1) once $n=2$, the graph $O(S)$ is disconnected and all its connected components have diameters $\leqslant 2$;
2 ) once $n \geqslant 3$, the graph $O(S)$ is connected and has diameter 4 .
These results are obtained in $[9, \S 4]$ for fields (Lemma 4.1 and Theorem 4.5 respectively), and in $[10, \S 2]$ are generalized to arbitrary skew-fields (Lemma 2.2 and Theorem 2.1 respectively). They are also shifted to integral domains (by reducing to the field of fractions).

Theorem 3.1. For any matrix $A \in S$ and proper ideal $I \triangleleft R$ containing $\operatorname{det} A$, there exists a matrix $B \in S \backslash\left(M_{n}(I)\right)$ such that $A B, B A \in M_{n}(I)$.
$\square \quad$ For $m \in \mathbb{N}$, set $Q_{m}:=\{1, \ldots, m\}$ and $P_{m}:=(1, \ldots, m) \in \mathbb{N}^{m}$.
Consider all triples $\left(k, P^{\prime}, P^{\prime \prime}\right)\left(k \geqslant 0, P^{\prime}, P^{\prime \prime} \in\left(Q_{n}\right)^{k}\right)$ satisfying the relation $\operatorname{det}\left(A_{P^{\prime \prime}}^{P^{\prime}}\right) \notin$ $\notin I$. For each of them, numbers are repeated neither in $P_{1}$, nor in $P_{2}$, and, by condition, $k<n$. Besides, at least one of such triples exists: for $k:=0$ and empty tuples $P^{\prime}, P^{\prime \prime}$, the corresponding $(0 \times 0)$-matrix has determinant $1 \notin I$. Hence, we can fix one of these triples with the largest possible $k$, and then $0 \leqslant k<n, m:=k+1 \in Q_{n}$.

Case 1). $P^{\prime}=P^{\prime \prime}=P_{k}$.
By construction, $\operatorname{det}\left(A_{P_{k}}^{P_{k}}\right) \notin I$. Further, set $C:=A_{P_{m}}^{P_{m}} \in M_{m}(R)$,

0_{m}^{n-m} & 0_{n-m}
\end{array}\right) \in S
$$

Then $b_{m, m}=\operatorname{det}\left(A_{P_{k}}^{P_{k}}\right) \notin I$ implying $B \notin M_{n}(I)$. Show that $A B, A^{T} B^{T} \in M_{n}(I)$, i. e. that, for any $p, q \in Q_{n}$, the matrix entries $(A B)_{p, q}$ and $\left(A^{T} B^{T}\right)_{p, q}$ belong to $I$. Assume that $p \in Q_{n}$ and $q \in Q_{m}$ (otherwise $(A B)_{p, q}=\left(A^{T} B^{T}\right)_{p, q}=0$ ). Let $P \in\left(Q_{n}\right)^{m}$ be the tuple obtained form $P_{m}$ by changing the $q$-th element with $p$. Due to maximality of $k$ and the inequality $m>k$, we have $\operatorname{det}\left(A_{P_{m}}^{P}\right), \operatorname{det}\left(A_{P}^{P_{m}}\right) \in I$,

&\left(A^{T} B^{T}\right)_{p, q}=\sum_{i \in Q_{n}}\left(\left(A^{T}\right)_{p, i}\left(B^{T}\right)_{i, q}\right)=\sum_{i \in Q_{m}}\left(a_{i, p}(\widetilde{C})_{i, q}\right)=\operatorname{det}\left(A_{P}^{P_{m}}\right) \in I
\end{aligned}
$$

Thereby, it is proved that $A B,(B A)^{T}=A^{T} B^{T} \in M_{n}(I)$ implying $B A \in M_{n}(I)$.
Case 2). $P^{\prime}, P^{\prime \prime} \in\left(Q_{n}\right)^{k}$ are arbitrary tuples.
In each of the tuples $P^{\prime}$ and $P^{\prime \prime}$ all numbers are distinct. Hence, via suitable permutations of rows and columns, one can obtain from $A$ a matrix $A_{0}$ satisfying Case 1) with the same $k$. By proved above, there exists a matrix $B_{0} \in S \backslash\left(M_{n}(I)\right)$ such that $A_{0} B_{0}, B_{0} A_{0} \in M_{n}(I)$. At that, there exist monomial (therefore, invertible) matrices $C_{1}, C_{2} \in S$ such that $A=$ $=C_{1} A_{0} C_{2}^{-1}$. Left (resp. right) multiplying a matrix by a monomial one permutes its rows (resp. columns), and, consequently, $B:=C_{2} B_{0} C_{1}^{-1} \in S \backslash\left(M_{n}(I)\right), A B=C_{1}\left(A_{0} B_{0}\right) C_{1}^{-1} \in$ $\in M_{n}(I), B A=C_{2}\left(B_{0} A_{0}\right) C_{2}^{-1} \in M_{n}(I)$.

Corollary 3.1. If $A \in S$ and $c \in I_{A}^{*}$, then, in the subset $(c S)^{*} \subset S$, there exists an element orthogonal to $A$.
$\square \quad$ By condition, $I:=\operatorname{Ann}(c) \triangleleft R$ is a proper ideal containing det $A$. According to Theorem 3.1, there exists a matrix $B \in S \backslash\left(M_{n}(I)\right)$ such that $A B, B A \in M_{n}(I)$. Thus, $C:=c B \neq 0$ and $c(A B)=c(B A)=0$, i. e. $C \in(c S)^{*}$ and $A C=C A=0$.

Lemma 3.1. For any $A \in S$, the following conditions are equivalent:

1) $\operatorname{det} A \in Z_{R}$;
2) $I_{A} \neq 0$;
3) in $S^{*}$, there exists an element orthogonal to $A$;
4) $A$ is a two-sided zero-divisor;
5) $A$ is a zero-divisor.

The implications 1$) \Leftrightarrow 2$ ) and 3$) \Rightarrow 4) \Rightarrow 5$ ) obviously follow from definitions, and the implication 2 ) $\Rightarrow 3$ ) - from Corollary 3.1.

Prove the implication 5$) \Rightarrow 1$ ). Suppose that, without loss of generality, $A$ is a left zero-divisor, i. e. that $A B=0$ for some $B \in S^{*}$. Then $\widehat{A} A=(\operatorname{det} A) E$ implying $(\operatorname{det} A) B=$ $=\widehat{A} A B=0$. It remains to use non-triviality of $B$.

Corollary 3.2. All zero-divisors in $S$ are two-sided.
Let $Z_{S} \subset S$ be the subset of all elements $A \in S$ satisfying each of the equivalent conditions 1)-5) of Lemma 3.1, i.e. the set of all zero-divisors of the ring $S$. Then the vertex set of the graph $O(S)$ is $Z_{S}^{*}$.

Further, we will assume that $Z_{R}^{*} \neq \varnothing$.
Statement 3.1. If $I \triangleleft R$ and $I \neq 0$, then $Z_{R} \cap I \neq\{0\}$.
$\square \quad$ Suppose that $Z_{R} \cap I=\{0\}$. There exist elements $b \in I^{*}$ and $c \in Z_{R}^{*}$; then $b c \in$ $\in Z_{R} \cap I=\{0\}$. So, $b c=0 \neq c$ that implies $b \in Z_{R} \cap I^{*}=\varnothing$, a contradiction.

Lemma 3.2. If, for a subset $D \subset S$, the ideal $I:=\bigcap_{A \in D} I_{A} \triangleleft R$ is nonzero, then there exist elements $b \in Z_{R}^{*}$ and $C_{A} \in S^{*}, A \in D$, such that $b E \perp C_{A} \perp A(A \in D)$.

According to Statement 3.1, the ideal $I$ contains an element $c \in Z_{R}^{*}$. Then $b c=0$ where $b \in Z_{R}^{*}$. Further, for any $A \in D$, we have $c \in I_{A}^{*}$ and, by Corollary 3.1, there exist an element $C_{A} \in(c S)^{*}$ orthogonal to $A$; at that, $b C_{A} \in b c S=0, b E \perp C_{A}$.

## Corollary 3.3.

1) For any $A \in Z_{S}^{*}$, we have $d(A, O(R)) \leqslant 2$.
2) If $A_{1}, A_{2} \in Z_{S}^{*}$ and $I_{A_{1}} \cap I_{A_{2}} \neq 0$, then $d\left(A_{1}, A_{2}\right) \leqslant 4$.
$\square \quad$ It suffices to apply Lemma 3.2 to the subsets $\{A\},\left\{A_{1}, A_{2}\right\} \subset S$.
Lemma 3.3. If $A_{i} \in Z_{S}^{*}, c_{i} \in I_{A_{i}}^{*}(i=1,2)$ and $c_{1} c_{2}=0$, then $d\left(A_{1}, A_{2}\right) \leqslant 3$.
By Corollary 3.1, for each $i=1,2$, there exists an element $C_{i} \in\left(c_{i} S\right)^{*}$ such that $C_{i} \perp A_{i}$. In this case, $C_{1} C_{2}, C_{2} C_{1} \in c_{1} c_{2} S=0, C_{1} \perp C_{2}$.

Definition. We will say that an ideal $I \triangleleft R$ does not have zero-divisors if $I^{*} I^{*} \not \supset 0$, i. e. if the ring $^{*} I$ does not have zero-divisors.

Lemma 3.4. If $A_{1}, A_{2} \in Z_{S}^{*}$ and $d\left(A_{1}, A_{2}\right)>3$, then $I_{A_{i}}(i=1,2)$ is the same ideal without zero-divisors.

According to Lemma 3.3, $I_{A_{1}}^{*} I_{A_{2}}^{*} \not \supset 0$. It remains to prove that $I_{A_{1}}=I_{A_{2}}$.
Suppose that $I_{A_{1}} \neq I_{A_{2}}$. Without loss of generality, assume that there exists an element $c \in I_{A_{1}} \backslash I_{A_{2}}$. Setting $a:=\operatorname{det} A_{2}$, we have $I_{A_{2}}=\operatorname{Ann}(a), b:=c a \in I_{A_{1}}^{*}$ and $b I_{A_{2}}=c a I_{A_{2}}=0$ implying $b I_{A_{2}}^{*} \subset\{0\} \cap\left(I_{A_{1}}^{*} I_{A_{2}}^{*}\right)=\varnothing, I_{A_{2}}^{*}=\varnothing, I_{A_{2}}=0$, a contradiction.

Theorem 3.2. The graph $O(S)$ is connected and has diameter at most 4.
Suppose that there exist elements $A_{1}, A_{2} \in Z_{S}^{*}$ satisfying the inequality $d\left(A_{1}, A_{2}\right)>$ $>4$. By Lemma 3.4, $0 \neq I_{A_{1}}=I_{A_{2}}=I_{A_{1}} \cap I_{A_{2}}$ that contradicts with Corollary 3.3.

Theorem 3.3. We have $\operatorname{diam}(O(S)) \geqslant 3$, the strict inequality being equivalent to the existence of an ideal $\operatorname{Ann}(a) \triangleleft R\left(a \in Z_{R}\right)$ without zero-divisors.Similarly with examples from [9, 10] giving lower estimates of the diameter, for an arbitrary $a \in Z_{R}$, set $I:=\operatorname{Ann}(a) \triangleleft R$ and $A:=J_{n}+a E_{n 1} \in S$. Note that

- $A, A^{T} \in Z_{S}^{*}, O_{S}(A)=I^{*} E_{1 n}, O_{S}\left(A^{T}\right)=I^{*} E_{n 1}$;
- $a_{12}=1 \neq a_{21},\left(A A^{T}\right)_{11}=1$ and $O_{S}(A) \cap O_{S}\left(A^{T}\right)=\varnothing$, that implies $d\left(A, A^{T}\right) \geqslant 3$;
- if $I^{*} I^{*} \not \supset 0$, then $\left(O_{S}(A)\right)\left(O_{S}\left(A^{T}\right)\right)=\left(I^{*} I^{*}\right) E_{11} \not \supset 0$ and, hence, $d\left(A, A^{T}\right) \geqslant 4$.

Due to mentioned above, $\operatorname{diam}(O(S)) \geqslant 3$, the strict inequality following from the existence of an ideal $\operatorname{Ann}(a) \triangleleft R\left(a \in Z_{R}\right)$ without zero-divisors. Conversely, in the case of the strict inequality, by Lemma 3.4, for some elements $A \in Z_{S}$ and $a:=\operatorname{det} A \in Z_{R}$, the ideal $I_{A}=\operatorname{Ann}(a) \triangleleft R$ does not have zero-divisors.

Now the main Theorem 1.1 follows from Theorems 3.2 and 3.3, and Corollary 3.3. It implies (see (2.1)) the statements 1) and 2) of Theorem 1.2. Let us prove 3).

[^1]Suppose that $\operatorname{rad}(O(S))=2$. There exist elements $C \in Z_{S}^{*}, c \in R^{*}$ and $k, l \in Q_{n}$ such that $d(C, A) \leqslant 2\left(A \in Z_{S}^{*}\right)$ and $c_{k l}=c$. Further, there exists a permutation $\sigma \in S_{n}$ such that $m:=\sigma(k) \neq l$.

Let $a \in Z_{R}$ be an arbitrary element.
Set $I:=\operatorname{Ann}(a) \triangleleft R$ and $A:=\left(\sum_{i \neq k} E_{i, \sigma(i)}\right)+a E_{k m} \in S$. Note that

- $A \in Z_{S}^{*}, O_{S}(A)=I^{*} E_{m k}$;
- $A \neq C$ (otherwise $\left.a_{k l}=c \neq 0, m=l\right)$;
- $\quad(m, k) \neq(k, l)$ (otherwise $m=k=l$ ), that implies $C \notin O_{S}(A)$.

Thus, $d(C, A)=2$, so, there exists an element $B \in Z_{S}^{*}$ orthogonal to $C$ and $A$. We have $B=b E_{m k}$ where $b \in I^{*}$. Meanwhile, $B C=0,0=(B C)_{m l}=b c, b \in \operatorname{Ann}(c) \cap I^{*}$.

Due to arbitrariness of $a \in Z_{R}$, the element $c \in R^{*}$ satisfies (1.2).
Conversely, assume that (1.2) holds for some $c \in R^{*}$. Show that the element $C:=c E \in$ $\in S^{*}$ satisfies, for each $A \in Z_{S}^{*}$, the inequality $d(C, A) \leqslant 2$.

Let $A \in Z_{S}^{*}$ be an arbitrary element. Then $\operatorname{det} A \in Z_{R}$, and, by (1.2), there exists an element $b \in I_{A}^{*}$ such that $c b=0$. Further, according to Corollary 3.1, there exists an element $B \in(b S)^{*}$ orthogonal to $A$; in this case, $c B \in c b S=0, C \in Z_{S}^{*}, C \perp B \perp A, d(C, A) \leqslant 2$.

So, Theorem 1.2 is completely proved.
