# SKEW-TYPE SYMPLECTIC/ORTHOGONAL SCHUR FUNCTIONS

ABSTRACT. We introduce and study skew symplectic and orthogonal Schur functions via vertex operators. This has lead to a natural representation of these skew-type symmetric functions in terms of general branching rules. Jacobi-Trudi identities and Gelfand-Tsetlin patterns for skew symplectic/orthogonal Schur functions are also provided, which can be seen as their basic combinatorial formulas. In addition, the vertex operator approach has also given Cauchy-type identities for these two skew functions. In fact, we show that vertex operator representations are not only a key tool to study symmetric functions but also give unified realizations for skew symmetric functions of type A, C and D.

#### 1. Introduction

For a partition  $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n)$ , Schur functions, symplectic Schur functions and orthogonal Schur functions in finitely many variables are respectively defined by [18, 19, 23, 24]

(1.1) 
$$s_{\lambda}(x) = \frac{\det\left(x_i^{\lambda_j + n - j}\right)_{1 \le i, j \le n}}{\det\left(x_i^{n - j}\right)_{1 < i, j < n}},$$

(1.2) 
$$sp_{\lambda}(x^{\pm}) = \frac{\det(x_i^{\lambda_j + (n-j+1)} - x_i^{-\lambda_j - (n-j+1)})_{i,j=1}^n}{\det(x_i^{n-j+1} - x_i^{-(n-j+1)})_{i,j=1}^n},$$

(1.3) 
$$o_{\lambda}(x^{\pm}) = 2(-1)^{\frac{n(n-1)}{2}} \frac{\det(x_i^{-\lambda_j+j-n} + \delta_{\lambda_n \neq 0} \delta_{j\neq n} x_i^{\lambda_j-j+n})_{i,j=1}^n}{\det(x_i^{-j+1} + x_i^{j-1})_{i,j=1}^n},$$

where  $\delta_{a\neq b}$  equals 1 except for a=b it is 0. They appear in various contexts of mathematics, especially in representation theory of classical Lie groups (general linear groups, symplectic groups and even orthogonal groups) as characters of finite-dimensional irreducible representations [13,17,24,25]. They are also studied in generalized vertex algebras and q-characters [4,16]. Since the introduction of Schur

symplectic/orthogonal symmetric functions, there is a natural question on how to introduce the skew versions for these symmetric functions. Note that the family of symplectic Schur or orthogonal Schur functions does not generate a complete basis in the ring of symmetric functions, the classical method of using adjoint operation would not work for the definition of the skew orthogonal/symplectic Schur functions. The current available combinatorial method of constructing skew symmetric functions does not immediately shows that the skew version obeys the general branching rule (cf.(1.4) and [1]).

Let us explain our idea to construct the skew symplectic and/or skew orthogonal Schur functions. Our method relies upon vertex operator realization of the classical symmetric functions [8] and the symplectic Schur and orthogonal Schur functions [2,12]. This can be traced back to Kyoto school's work on integrable systems [5] where vertex operators were used to construct tau functions of the KP hierarchy in terms of Schur polynomials. Skew Schur functions  $s_{\lambda/\mu}$  satisfy the celebrated decomposition formula, i.e., the general branching rule

(1.4) 
$$s_{\lambda}(x_1, \dots, x_n) = \sum_{\mu \subset \lambda} s_{\mu}(x_1, \dots, x_{n-k}) s_{\lambda/\mu}(x_{n-k+1}, \dots, x_n),$$

which can be interpreted as the restriction of the irreducible representation of  $GL(n, \mathbb{C})$  to  $GL(n-k, \mathbb{C}) \times GL(k, \mathbb{C})$ . A natural problem is whether or not there exist skew symplectic Schur functions and skew orthogonal Schur functions with similar decomposition formulas, i.e., the general branching rules for symplectic/orthogonal Schur functions. The aim of this paper is to introduce and study skew (symplectic/orthogonal) Schur functions and derive their combinatorial properties such as Jacobi-Trudi identities, Gelfand-Tsetlin pattern representations and Cauchy-type identities. We also show that our vertex operator representations for skew-type symmetric functions comply with the general branching rules.

The construction of skew Schur functions and their generalizations can be formulated in terms of representation theory of infinite-dimensional Lie algebras. One starts with the infinite-dimensional Heisenberg algebra [7] with the center 1, and defines the Fock space  $\mathcal{M}^*$  and its completion  $\widetilde{\mathcal{M}^*}$  generated by the vacuum  $\langle 0|$  (which is the vacuum vector in the right module) and the Heisenberg generators with positive modes. There are three families of special elements  $(\langle \lambda|, \langle \lambda^{sp}| \text{ and } \langle \lambda^o| \text{ in the right module})$  defined by partitions  $\lambda$ , corresponding respectively to the Schur, symplectic Schur and orthogonal Schur cases. We will prove that they are orthonormal by computing the inner product with the elements  $(|\lambda\rangle, |\lambda^{sp}\rangle$  and  $|\lambda^o\rangle$  in the left module) in the Fock space  $\mathcal{M}$  respectively (see Theorem 2.1), which is key to construct (skew) symmetric functions. For the half vertex operators  $\Gamma_+(\{x\})$  and

 $\Gamma_{+}(\{x^{\pm}\})$ , we will show that:

$$\langle 0|\Gamma_{+}(\{x\}) = \sum_{\lambda} \langle \lambda|s_{\lambda}(x),$$
  
$$\langle 0|\Gamma_{+}(\{x^{\pm}\}) = \sum_{\lambda} \langle \lambda^{sp}|sp_{\lambda}(x^{\pm}) = \sum_{\lambda} \langle \lambda^{o}|o_{\lambda}(x^{\pm}),$$

where each summation is over partitions  $\lambda = (\lambda_1, \dots, \lambda_N)$  with zeros parts allowed in the end. The benefit of this approach is that we can easily obtain the well-known classical Cauchy identities for (symplectic/orthogonal) Schur functions [13, 24]. Clearly this approach is logically independent from the Jacobi-Trudi formula.

It is well known that  $\langle \mu | \Gamma_+(\{x\}) | \lambda \rangle = s_{\lambda/\mu}(x)$  [15, 20] using the half vertex operator  $\Gamma_+(\{x\})$ . We extend the vertex operator method to derive two families of symmetric functions

$$(1.5) sp_{\lambda/\mu}(x^{\pm}) = \langle \mu^{sp} | \Gamma_{+}(\lbrace x^{\pm} \rbrace) | \lambda^{sp} \rangle,$$

$$o_{\lambda/\mu}(x^{\pm}) = \langle \mu^o | \Gamma_+(\lbrace x^{\pm} \rbrace) | \lambda^o \rangle,$$

which can be interpreted as the skew symplectic/orthogonal Schur functions from the general branching rule. We also show that each skew function can be written as a Jacobi-Trudi type determinant of complete homogeneous symmetric functions with variables  $x_1, x_1^{-1}, \ldots, x_N, x_N^{-1}$ .

Exploiting the combinatorial properties of  $\langle \mu^{sp} |$  and  $\langle \mu^o |$ , we obtain Gelfand-Tsetlin pattern representations (generating functions of some Young tableaux in an equivalent form [23]) for skew symplectic/orthogonal Schur functions, which provide alternative definitions of symplectic/orthogonal Schur functions. The vertex operator method depending on the combinatorial properties of some orthogonal elements of the Fock space  $\widetilde{\mathcal{M}^*}$  may shed light on specific description of generalized shape  $\pi$  symmetric functions [6].

This paper is organized as follows. In Section 2, we recall the vertex operators related to fermionic Fock spaces  $\mathcal{M}$  and  $\mathcal{M}^*$ , and prove the orthonormality for three distinguished sets of  $\mathcal{M}$  and the completion of  $\mathcal{M}^*$ . In section 3, we derive the skew symplectic/orthogonal Schur functions and their Jacobi-Trudi identities. In Section 4, we give formulas of skew symplectic/orthogonal Schur functions in terms of Gelfand-Tsetlin pattern representations. In Section 5, we provide a vertex operator approach to the Cauchy identities for the (symplectic/orthogonal) Schur functions, which is logically independent from the Jacobi-Trudi formulas [10]. We also obtain Cauchy-type identities for skew (symplectic/orthogonal) Schur functions. Finally we show how vertex operator realizations for these three skew symmetric functions consistent with the general branching rule.

#### 2. Preliminaries

Let  $\mathcal{H}$  be the Heisenberg algebra generated by  $\{a_n|n\neq 0\}$  with the central element c=1 subject to the commutation relations [7]

$$[a_m, a_n] = m\delta_{m,-n}c, \ [a_n, c] = 0.$$

The Fock space  $\mathcal{M}$  (resp.  $\mathcal{M}^*$ ) is generated by the vacuum vector  $|0\rangle$  (resp. dual vacuum vector  $\langle 0|$ ) and subject to

$$a_n|0\rangle = \langle 0|a_{-n}, n > 0.$$

In other words,  $\mathcal{M}$  and  $\mathcal{M}^*$  are respectively left and right modules for  $\mathcal{H}$ . It is easy to see that  $\mathcal{H}$  acts on  $\mathcal{M}$  (resp.  $\mathcal{M}^*$ ) irreducibly. Moreover,  $\mathcal{M}$  (resp.  $\mathcal{M}^*$ ) is isomorphic to the symmetric algebra  $\mathbb{C}[a_{-1}, a_{-2}, \ldots]$  (resp.  $\mathbb{C}[a_1, a_2, \ldots]$ ). Note that  $\mathcal{M}^*$  is a graded space with the gradation induced from that of  $\mathcal{H}$ . Let  $\{\mathcal{M}_n^*\}$  be the filtration of the subspaces  $\mathcal{M}_n^*$  spanned by homogeneous elements with degree  $\geq n$ . Then we let  $\widetilde{\mathcal{M}^*}$  be the associated completion of the Fock space  $\mathcal{M}^*$ .

We need the following vertex operators given in [2,12] (see also [22])

$$X(z) = \exp\left(\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right) \exp\left(-\sum_{n=1}^{\infty} \frac{a_{n}}{n} z^{-n}\right) = \sum_{n \in \mathbb{Z}} X_{n} z^{-n},$$

$$X^{*}(z) = \exp\left(-\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right) \exp\left(\sum_{n=1}^{\infty} \frac{a_{n}}{n} z^{-n}\right) = \sum_{n \in \mathbb{Z}} X_{n}^{*} z^{n},$$

$$Y(z) = \exp\left(\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right) \exp\left(-\sum_{n=1}^{\infty} \frac{a_{n}}{n} (z^{-n} + z^{n})\right) = \sum_{n \in \mathbb{Z}} Y_{n} z^{-n},$$

$$Y^{*}(z) = (1 - z^{2}) \exp\left(-\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right) \exp\left(\sum_{n=1}^{\infty} \frac{a_{n}}{n} (z^{-n} + z^{n})\right) = \sum_{n \in \mathbb{Z}} Y_{n}^{*} z^{n},$$

$$W(z) = (1 - z^{2}) \exp\left(\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right) \exp\left(-\sum_{n=1}^{\infty} \frac{a_{n}}{n} (z^{-n} + z^{n})\right) = \sum_{n \in \mathbb{Z}} W_{n} z^{-n},$$

$$W^{*}(z) = \exp\left(-\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right) \exp\left(\sum_{n=1}^{\infty} \frac{a_{n}}{n} (z^{-n} + z^{n})\right) = \sum_{n \in \mathbb{Z}} W_{n}^{*} z^{n}.$$

**Lemma 2.1.** The actions of operators  $X_n, X_n^*, Y_n, Y_n^*, W_n$  and  $W_n^*$  on the (dual) vacuum are given by

$$(2.3) X_n|0\rangle = X_{-n}^*|0\rangle = \langle 0|X_{-n} = \langle 0|X_n^* = Y_n|0\rangle = Y_{-n}^*|0\rangle = W_n|0\rangle = W_{-n}^*|0\rangle = 0, for \ n > 0,$$

$$(2.4) \quad \langle 0|Y_n^* = -\langle 0|Y_{-n+2}^*, \qquad \langle 0|Y_n = \langle 0|Y_{-n}, \qquad \langle 0|W_n = -\langle 0|W_{-n-2}, \qquad \langle 0|W_n^* = \langle 0|W_{-n}^*.$$

*Proof.* Relations (2.3) are obvious, and we only need to prove (2.4). Note the fact

$$\langle 0 | \exp \left( \sum_{n=1}^{\infty} \frac{a_n}{n} (z^{-n} + z^n) \right) = \langle 0 | \frac{1}{1 - z^2} \exp \left( \sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^n \right) Y^*(z) = \frac{1}{1 - z^2} \langle 0 | Y^*(z),$$

$$\langle 0 | \exp \left( \sum_{n=1}^{\infty} \frac{a_n}{n} (z^{-n} + z^n) \right) = \langle 0 | \frac{1}{1 - z^{-2}} \exp \left( \sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{-n} \right) Y^*(z^{-1}) = \frac{-z^2}{1 - z^2} \langle 0 | Y^*(z^{-1}),$$

and we therefore have

(2.5) 
$$\langle 0|Y^*(z) = -z^2 \langle 0|Y^*(z^{-1}).$$

Comparing the coefficient of  $z^n$  in two sides of (2.5), we have

$$\langle 0|Y_n^* = -\langle 0|Y_{-n+2}^*.$$

Similarly, we can get the other commutation relations in (2.4).

The following result can be found in [12, Theorem 3.4, Proposition 3.6].

Lemma 2.2. The components of the vertex operators (2.2) satisfy the following commutation relations

$$X_{i}X_{j} + X_{j+1}X_{i-1} = 0, X_{i}^{*}X_{j}^{*} + X_{j-1}^{*}X_{i+1}^{*} = 0, X_{i}X_{j}^{*} + X_{j+1}^{*}X_{i+1} = \delta_{i,j},$$

$$(2.6) Y_{i}Y_{j} + Y_{j+1}Y_{i-1} = 0, Y_{i}^{*}Y_{j}^{*} + Y_{j-1}^{*}Y_{i+1}^{*} = 0, Y_{i}Y_{j}^{*} + Y_{j+1}^{*}Y_{i+1} = \delta_{i,j},$$

$$W_{i}W_{j} + W_{j+1}W_{i-1} = 0, W_{i}^{*}W_{j}^{*} + W_{j-1}^{*}W_{i+1}^{*} = 0, W_{i}W_{j}^{*} + W_{j+1}^{*}W_{i+1} = \delta_{i,j}.$$

A partition  $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_l)$  is a weakly decreasing sequence of positive integers. The  $\lambda_i$ 's are called the parts of  $\lambda$ , the number of parts is the length of  $\lambda$ , denoted by  $l(\lambda)$ . In this paper we will use *partitions* in the extended sense that a generalized partition is a partition appended with a string of zeros. For a given partition  $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_l)$ , let

(2.7) 
$$|\lambda\rangle = X_{-\lambda_1} X_{-\lambda_2} \cdots X_{-\lambda_l} |0\rangle, \qquad \langle \lambda| = \langle 0| X_{-\lambda_l}^* \cdots X_{-\lambda_1}^*,$$

$$(2.8) |\lambda^{sp}\rangle = Y_{-\lambda_1}Y_{-\lambda_2}\cdots Y_{-\lambda_l}|0\rangle, \langle\lambda^{sp}| = \langle 0|Y_{-\lambda_l}^*\cdots Y_{-\lambda_1}^*,$$

$$(2.9) |\lambda^o\rangle = W_{-\lambda_1} W_{-\lambda_2} \cdots W_{-\lambda_l} |0\rangle, \langle \lambda^o| = \langle 0|W_{-\lambda_l}^* \cdots W_{-\lambda_1}^*.$$

We remark that the vectors  $|\lambda\rangle$ ,  $|\lambda^{sp}\rangle$  and  $|\lambda^o\rangle$  are in  $\mathcal{M}$ ,  $\langle\lambda|$  in  $\mathcal{M}^*$ , where the vectors  $\langle\lambda^{sp}|$  and  $\langle\lambda^o|$  belong to the completion  $\widetilde{\mathcal{M}^*}$ . Due to the fact

$$\langle 0|Y_0^* \neq \langle 0|, \ \langle 0|W_0^* \neq \langle 0|,$$

the vector  $\langle \lambda^{sp} |$  (resp.  $\langle \lambda^o |$ ) differs from the vector  $\langle \mu^{sp} |$  (resp.  $\langle \mu^o |$ ) even if  $\lambda$  and  $\mu$  only differ by a string of zeros at the end. For examples,

$$\langle 0|Y_0^*Y_{-1}^*Y_{-4}^* \neq \langle 0|Y_{-1}^*Y_{-4}^* \neq \langle 0|Y_0^*Y_0^*Y_{-1}^*Y_{-4}^*,$$

$$\langle 0|W_0^*Y_{-1}^*W_{-4}^* \neq \langle 0|W_{-1}^*W_{-4}^* \neq \langle 0|W_0^*W_0^*W_{-1}^*W_{-4}^*.$$

For any  $\langle u|$  in  $\widetilde{\mathcal{M}}^*$  and  $|v\rangle$  in  $\mathcal{M}^*$ , one define  $\langle u|v\rangle$  by

$$\langle u|v\rangle = \langle u||v\rangle$$

where it is assumed that  $\langle 0|1|0\rangle = 1$ . Now we can prove the orthonormality for three distinguished sets of  $\widetilde{\mathcal{M}}^*$  through computing the following inner products.

**Theorem 2.1.** For partitions  $\mu = (\mu_1, \mu_2, \dots, \mu_l)$  and  $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_l)$ , one has that

$$\langle \mu | \lambda \rangle = \delta_{\lambda \mu},$$

(2.11) 
$$\langle \mu^{sp} | \lambda^{sp} \rangle = \delta_{\lambda\mu},$$

$$\langle \mu^o | \lambda^o \rangle = \delta_{\lambda \mu},$$

where the partitions in (2.10) are usual ones and the partitions in (2.11) and (2.12) are generalized partitions.

*Proof.* Using the commutation relations (2.6), we have

$$\begin{split} \langle \mu | \lambda \rangle = & \langle 0 | X_{-\mu_l}^* \cdots X_{-\mu_2}^* X_{-\mu_1}^* X_{-\lambda_1} X_{-\lambda_2} \cdots X_{-\lambda_l} | 0 \rangle \\ = & \langle 0 | X_{-\mu_l}^* \cdots X_{-\mu_2}^* (\delta_{\mu_1, \lambda_1} - X_{-\lambda_1 - 1} X_{-\mu_1 - 1}^*) X_{-\lambda_2} \cdots X_{-\lambda_l} | 0 \rangle. \end{split}$$

The second summand is zero if  $\mu_1 \geq \lambda_1$ , since we can move  $X_{-\mu_1-1}^*$  to the right to kill  $|0\rangle$  according to (2.3). If  $\lambda_1 > \mu_1$ , we move  $X_{-\lambda_1-1}$  to the left to kill  $\langle 0|$ . Either way shows that the inner product is simplified to

$$\langle \mu | \lambda \rangle = \delta_{\mu_1, \lambda_1} \langle 0 | X_{-\mu_l}^* \cdots X_{-\mu_2}^* X_{-\lambda_2} \cdots X_{-\lambda_l} | 0 \rangle = \cdots = \delta_{\lambda \mu}.$$

In the case of  $\langle \mu^{sp} | \lambda^{sp} \rangle$ , for  $\mu_1 \geq \lambda_1$  we also have that

(2.13) 
$$\langle \mu^{sp} | \lambda^{sp} \rangle = \delta_{\mu_1, \lambda_1} \langle 0 | Y_{-\mu_l}^* \cdots Y_{-\mu_2}^* Y_{-\lambda_2} \cdots Y_{-\lambda_l} | 0 \rangle.$$

Now we consider the subcase when  $\mu_1 < \lambda_1$ . It follows from (2.3) that

$$\langle \mu^{sp} | \lambda^{sp} \rangle = \begin{cases} 0 & \mu_1 + i - 1 \neq \lambda_i \text{ for all } 1 \leq i \leq l \\ (-1)^{i-1} \langle 0 | Y_{-\mu_l}^* \cdots Y_{-\mu_2}^* Y_{-\lambda_1 - 1} \cdots Y_{-\lambda_{i-1} - 1} Y_{-\lambda_{i+1}} \cdots Y_{-\lambda_l} | 0 \rangle, \ \mu_1 + i - 1 = \lambda_i. \end{cases}$$

Continuing the process,  $\langle \mu^{sp} | \lambda^{sp} \rangle$  equals to 0 or  $(-1)^{\epsilon} \langle 0 | Y_{-\mu_l}^* Y_{-\lambda_1 - l + 1} | 0 \rangle$ , while  $\langle 0 | Y_{-\mu_l}^* Y_{-\lambda_1 - l + 1} | 0 \rangle = -\langle 0 | Y_{-\lambda_1 - l} Y_{-\mu_l - 1}^* | 0 \rangle = 0$  since  $-\mu_l - 1 < 0$  and by (2.3). We therefore obtain (2.11) by combining the relations between  $\mu_i$  and  $\lambda_i$ . (2.9) can be proved similarly.

**Remark 2.1.** The equation (2.11) makes sense only when we fix a positive integer l and the length of partition  $\mu = (\mu_1, \dots, \mu_m, \underbrace{0, \dots, 0}_{l-m})$  is not bigger than l, where we set

$$\langle \mu^{sp} | = \langle 0 | \underbrace{Y_0^* \dots Y_0^*}_{l-m} Y_{-\mu_m}^* \dots Y_{-\mu_1}^*.$$

For example, it is easy to check that

$$\langle 0|Y_0^*Y_0^*Y_{-1}^*Y_{-4}^*Y_{-4}Y_{-1}Y_{-1}Y_{-1}|0\rangle = 0, \ \langle 0|Y_{-1}^*Y_{-4}^*Y_{-4}Y_{-1}Y_{-1}Y_{-1}|0\rangle = -1,$$

thus for l=4

$$\langle \mu^{sp} | = \langle 0 | Y_0^* Y_0^* Y_{-1}^* Y_{-4}^*.$$

The same remark applies to the orthogonal case (2.12).

## 3. Skew symplectic/orthogonal Schur functions and Jacobi-Trudi identities

In this section, we first recall the vertex operator construction of skew Schur functions  $s_{\lambda/\mu}(x)$ . Then we extend the construction to realize skew symplectic Schur functions  $s_{\lambda/\mu}(x^{\pm})$  and skew orthogonal Schur functions  $o_{\lambda/\mu}(x^{\pm})$ . Jacobi-Trudi formulas for them are also provided.

Introduce the (half) vertex operators

(3.1) 
$$\Gamma_{+}(z) = \exp\left(\sum_{n=1}^{\infty} \frac{a_n}{n} z^n\right),$$

(3.2) 
$$\Gamma_{-}(z) = \exp\left(\sum_{n=1}^{\infty} \frac{a_{-n}}{n} z^{n}\right).$$

For the sake of simplicity, we use the following notations:

(3.3) 
$$\Gamma_{+}(\{x\}) = \prod_{i=1}^{N} \Gamma_{+}(x_{i}),$$

(3.4) 
$$\Gamma_{+}(\lbrace x^{\pm} \rbrace) = \prod_{i=1}^{N} \Gamma_{+}(x_{i}) \Gamma_{+}(x_{i}^{-1}),$$

(3.5) 
$$\Gamma_{-}(\{x\}) = \prod_{i=1}^{N} \Gamma_{-}(x_i),$$

where 
$$\{x\} = (x_1, \dots, x_N), \{x^{\pm}\} = (x_1, x_1^{-1}, \dots, x_N, x_N^{-1}).$$

3.1. Skew Schur functions. For a partition  $\mu = (\mu_1, \dots, \mu_l)$ , using the relation  $X_i^* X_j^* = -X_{j-1}^* X_{i+1}^* (2.6)$ , one rewrite  $X_{-\mu_l}^* \cdots X_{-\mu_1}^*$  up to a sign by permuting the factors [9]:

$$(3.6) \varepsilon(\sigma) X_{-\mu_l}^* \cdots X_{-\mu_1}^* = X_{-\mu_{\sigma(l)} + \sigma(l) - l}^* \cdots X_{-\mu_{\sigma(i)} + \sigma(i) - i}^* \cdots X_{-\mu_{\sigma(1)} + \sigma(1) - 1}^*,$$

where  $\sigma \in S_l$ . We shall refer to this as the action of the symmetric group on the monomial elements.

**Proposition 3.1.** Let  $\mu = (\mu_1, \dots, \mu_l)$  and  $\lambda = (\lambda_1, \dots, \lambda_k)$  be two partitions. Then

(3.7) 
$$\langle \mu | \Gamma_{+}(\{x\}) | \lambda \rangle = s_{\lambda/\mu}(x),$$

where  $s_{\lambda/\mu}(x)$  is the skew Schur function [18, (5.4)].

*Proof.* Using the relations  $(|z_1| > |z_2|)$  in the second identity

$$\Gamma_{+}(z) = \Gamma_{-}(z^{-1})X^{*}(z^{-1}), \ X^{*}(z_{2}^{-1})\Gamma_{-}(z_{1}^{-1}) = (1 - \frac{z_{2}}{z_{1}})^{-1}\Gamma_{-}(z_{1}^{-1})X^{*}(z_{2}^{-1}),$$
$$\langle 0|\Gamma_{-}(z) = \langle 0|,$$

we get that

$$\langle 0|\Gamma_{+}(\{x\}) = \prod_{1 \leq i < j \leq N} (1 - \frac{x_{j}}{x_{i}})^{-1} \langle 0|X^{*}(x_{N}^{-1}) \dots X^{*}(x_{1}^{-1})$$

$$= \prod_{1 \leq i < j \leq N} (1 - \frac{x_{j}}{x_{i}})^{-1} \sum_{n_{1}, \dots, n_{N} \in \mathbb{Z}} \langle 0|X^{*}_{-n_{N}} \dots X^{*}_{-n_{1}} x_{N}^{n_{N}} \dots x_{1}^{n_{1}}.$$
(3.8)

For a partition  $\nu = (\nu_1, \dots, \nu_N)$ , the relation (3.6) tells us that the coefficient of  $\langle \nu | = \langle 0 | X_{-\nu_N}^* \dots X_{-\nu_1}^*$  in  $\langle 0 | \Gamma_+(\{x\}) \rangle$  is

$$\prod_{1 \le i < j \le N} (1 - \frac{x_j}{x_i})^{-1} \sum_{\sigma \in S_N} \varepsilon(\sigma) x_1^{\nu_{\sigma(1)} - \sigma(1) + 1} \cdots x_i^{\nu_{\sigma(i)} - \sigma(i) + i} \cdots x_N^{\nu_{\sigma(N)} - \sigma(N) + N}$$

$$= \prod_{1 \le i < j \le N} (x_i - x_j)^{-1} \sum_{\sigma \in S_N} \varepsilon(\sigma) x_1^{\nu_{\sigma(1)} - \sigma(1) + N} \cdots x_i^{\nu_{\sigma(i)} - \sigma(i) + N} \cdots x_N^{\nu_{\sigma(N)} - \sigma(N) + N}$$

$$= \frac{\det(x_i^{\nu_j + N - j})_{1 \le i, j \le N}}{\prod_{1 \le i < j \le N} (x_i - x_j)} = \frac{\det(x_i^{\nu_j + N - j})_{1 \le i, j \le N}}{\det(x_i^{N - j})_{1 \le i, j \le N}} = s_{\nu}(x),$$

where  $s_{\nu}(x)$  is the Schur function (1.1) associated with the partition  $\nu$ . We therefore get the expansion

(3.10) 
$$\langle 0|\Gamma_{+}(\lbrace x\rbrace) = \sum_{l(\nu) \leq N} \langle \nu|s_{\nu}(x),$$

where the sum is over all partitions  $\nu$  with length  $\leq N$ . Using (3.6) and the Jacobi-Trudi formula [18, (3.4)]

$$s_{\nu}(x) = \det(h_{\nu_i - i + j}(x))_{1 \le i, j \le N},$$

where the complete homogeneous function  $h_n(x)$  is defined by  $\prod_{i=1}^N \frac{1}{1-x_iz} = \sum_{n\in\mathbb{Z}} h_n(x)z^n$ , we can rewrite (3.10) as

(3.11) 
$$\langle 0|\Gamma_{+}(\{x\}) = \sum_{n_{1},n_{2},\dots,n_{N} \geq 0} \langle 0|X_{-n_{N}}^{*}\dots X_{-n_{1}}^{*}h_{n_{N}}(x)\dots h_{n_{1}}(x).$$

By (2.2), we have that

$$X^*(z)\Gamma_+(\{x\}) = \prod_{i=1}^N \frac{1}{(1-x_i z)} \Gamma_+(\{x\}) X^*(z) = \sum_{i\geq 0} h_i(x) z^i \Gamma_+(\{x\}) X^*(z),$$

i.e.,

$$X_{-n}^* \Gamma_+(\{x\}) = \Gamma_+(\{x\}) \sum_{i>0} h_i(x) X_{-n-i}^*.$$

Thus from (2.7), we have

$$\langle \mu | \Gamma_{+}(\{x\}) = \langle 0 | X_{-\mu_{l}}^{*} \cdots X_{-\mu_{1}}^{*} \Gamma_{+}(\{x\})$$

$$= \langle 0 | \Gamma_{+}(\{x\}) \sum_{i_{1}, \dots, i_{l} \geq 0} X_{-\mu_{l} - i_{l}}^{*} \cdots X_{-\mu_{1} - i_{1}}^{*} h_{i_{l}}(x) \dots h_{i_{1}}(x)$$

$$= \sum_{i_{l+1}, \dots, i_{l+N} \in \mathbb{Z}} \langle 0 | X_{-i_{l+N}}^{*} \cdots X_{-i_{l+1}}^{*} h_{i_{l+N}}(x) \cdots h_{i_{l+1}}(x)$$

$$\cdot \sum_{i_{1}, \dots, i_{l} \geq 0} X_{-\mu_{l} - i_{l}}^{*} \cdots X_{-\mu_{1} - i_{1}}^{*} h_{i_{l}}(x) \cdots h_{i_{1}}(x)$$

$$= \sum_{i_{1}, \dots, i_{l+N} \in \mathbb{Z}} \langle 0 | X_{-i_{l+N}}^{*} \cdots X_{-i_{l+1}}^{*} X_{-\mu_{l} - i_{l}}^{*} \cdots X_{-\mu_{1} - i_{1}}^{*} h_{i_{l+N}}(x) \cdots h_{i_{l+1}}(x) h_{i_{l}}(x) \dots h_{i_{1}}(x).$$

$$(3.12)$$

For a partition  $\lambda$  with  $l \leq l(\lambda) \leq l + N$ , the relations (3.6) and (3.12) imply that the coefficient of  $\langle \lambda |$  in  $\langle \mu | \Gamma_+(\{x\}) \rangle$  is

$$\sum_{\sigma \in S_{l+N}} \epsilon(\sigma) \prod_{j=1}^{l+N} h_{\lambda_{\sigma(j)} - \mu_j - \sigma(j) + j}(x) = \det(h_{\lambda_i - \mu_j - i + j})_{1 \le i, j \le l+N} = s_{\lambda/\mu}(x),$$

i.e.,

$$\langle \mu | \Gamma_+(\{x\}) = \sum_{l \le l(\lambda) \le l+N} \langle \lambda | s_{\lambda/\mu}(x).$$

Subsequently (by the orthogonality (2.10))

$$\langle \mu | \Gamma_+(\{x\}) | \lambda \rangle = s_{\lambda/\mu}(x).$$

This completes the proof.

Remark 3.1. Okounkov [20] derived (3.7) by computing  $\Gamma_+(\{x\})|\lambda\rangle$ . We can also get (3.7) using the vertex operator approach (see Appendix A). However we don't know how to generalize either method to skew-type orthogonal/symplectic cases. The method of Prop. 3.1 can be generalized to the symplectic/orthogonal Schur functions.

#### 3.2. Skew-type symplectic Schur functions. It follows from (2.4) and (2.6) that

$$\begin{split} \langle 0|Y_{-n_1}^*\cdots Y_{-n_i}^*\cdots Y_{-n_N}^* = & (-1)^{i-1}\langle 0|Y_{-n_i-i+1}^*Y_{-n_1+1}^*\cdots Y_{-n_{i-1}+1}^*Y_{-n_{i+1}}^*\cdots Y_{-n_N}^* \\ = & (-1)^i\langle 0|Y_{n_i+i+1}^*Y_{-n_1+1}^*\cdots Y_{-n_{i-1}+1}^*Y_{-n_{i+1}}^*\cdots Y_{-n_N}^* \\ = & -\langle 0|Y_{-n_1}^*\cdots Y_{-n_{i-1}}^*Y_{n_i+2i}^*Y_{-n_{i+1}}^*\cdots Y_{-n_N}^*. \end{split}$$

In other words, if we replace the *i*th factor  $Y_{-n_i}^*$  of  $\langle 0|Y_{-n_1}^*\cdots Y_{-n_i}^*\cdots Y_{-n_N}^*$  by  $-Y_{n_i+2i}^*$ , it remains the same. We use the notation  $\binom{a}{b}$  to mean either of a or b. Then for a partition  $\mu = (\mu_1 \dots \mu_l)$ ,

$$\langle 0 | \begin{pmatrix} Y^*_{-\mu_l} \\ -Y^*_{\mu_l+2} \end{pmatrix} \cdots \begin{pmatrix} Y^*_{-\mu_i} \\ -Y^*_{\mu_i+2(l+1-i)} \end{pmatrix} \cdots \begin{pmatrix} Y^*_{-\mu_1} \\ -Y^*_{\mu_1+2l} \end{pmatrix} = \langle \mu^{sp} |.$$

Note that there is a similar action of  $S_N$  on the vectors  $\langle 0|Y_{-n_1}^*\cdots Y_{-n_i}^*\cdots Y_{-n_N}^*$  as in (3.6) using the commutation relation  $Y_i^*Y_j^* = -Y_{j-1}^*Y_{i+1}^*$  (2.6). Therefore we have that

$$(3.13) \qquad \varepsilon(\sigma)\langle 0 | \begin{pmatrix} Y^*_{-\mu_{\sigma(l)} + \sigma(l) - l} \\ -Y^*_{\mu_{\sigma(l)} - \sigma(l) + l + 2} \end{pmatrix} \cdots \begin{pmatrix} Y^*_{-\mu_{\sigma(i)} + \sigma(i) - i} \\ -Y^*_{\mu_{\sigma(i)} - \sigma(i) + 2(l + 1) - i} \end{pmatrix} \cdots \begin{pmatrix} Y^*_{-\mu_{\sigma(1)} + \sigma(1) - 1} \\ -Y^*_{\mu_{\sigma(1)} - \sigma(1) + 2l + 1} \end{pmatrix} = \langle \mu^{sp} | .$$

**Proposition 3.2.** Let  $\mu = (\mu_1, \dots, \mu_l)$  be a partition,  $\{x^{\pm}\} = \{x_1, x_1^{-1}, \dots, x_N, x_N^{-1}\}$ , and  $\lambda$  a partition such that length  $l(\lambda) \leq l + N$ . Then one has that

$$\langle \mu^{sp} | \Gamma_{+}(\lbrace x^{\pm} \rbrace) | \lambda^{sp} \rangle = s p_{\lambda/\mu}(x^{\pm})$$

where

(3.15) 
$$sp_{\lambda/\mu}(x^{\pm}) = \det(a_{ij})_{1 \le i, j \le l+N}$$

with

(3.16) 
$$a_{ij} = \begin{cases} h_{\lambda_i - \mu_j - i + j}(x^{\pm}) & 1 \le j \le l + 1, \\ h_{\lambda_i - i + j}(x^{\pm}) + h_{\lambda_i - i - j + 2l + 2}(x^{\pm}) & l + 2 \le j \le l + N. \end{cases}$$

*Proof.* By definition of the vertex operator  $Y^*(z)$ , one has that

$$\langle 0|\Gamma_{+}(\{x^{\pm}\}) = \prod_{1 \leq i \leq j \leq N} \frac{1}{1 - x_{i}x_{j}} \prod_{1 \leq i < j \leq N} \frac{1}{1 - \frac{x_{i}}{x_{j}}} \langle 0|Y^{*}(x_{N}) \cdots Y^{*}(x_{1})$$

$$= \frac{\prod_{i=1}^{N} x_{i}^{i-1-N}}{\det(x_{i}^{-(N-j+1)} - x_{i}^{N-j+1})_{i,j=1}^{N}} \langle 0|Y^{*}(x_{N}) \cdots Y^{*}(x_{1}),$$
(3.17)

where we have used the Vandermonde type identity [12, 25]:

(3.18) 
$$\det(x_i^{j-1} - x_i^{2N-j+1})_{i,j=1}^N = \prod_{1 \le i \le j \le N} (x_j - x_i) \prod_{1 \le i \le j \le N} (1 - x_i x_j).$$

In view of (3.13) for partition  $\nu = (\nu_1, \dots, \nu_N)$ , the coefficient of  $\langle \nu^{sp} |$  in  $\langle 0 | Y^*(x_N) \cdots Y^*(x_1)$  is

(3.19) 
$$\sum_{\sigma \in S_N} \varepsilon(\sigma) \prod_{i=1}^N (x_i^{-\nu_{\sigma(i)} + \sigma(i) - i} - x_i^{\nu_{\sigma(i)} - \sigma(i) + 2N + 2 - i}) = \det(x_i^{-\nu_j + j - i} - x_i^{\nu_j - j + 2N + 2 - i})_{i,j=1}^N.$$

Then we have

$$\langle 0|\Gamma_{+}(\{x^{\pm}\}) = \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{sp}| \frac{\prod_{i=1}^{N} x_{i}^{i-1-N} \det(x_{i}^{-\nu_{j}+j-i} - x_{i}^{\nu_{j}-j+2N+2-i})_{i,j=1}^{N}}{\det(x_{i}^{-(N-j+1)} - x_{i}^{N-j+1})_{i,j=1}^{N}}$$

$$= \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{sp}| \frac{\det(x_{i}^{-\nu_{j}-(N-j+1)} - x_{i}^{\nu_{j}+(N-j+1)})_{i,j=1}^{N}}{\det(x_{i}^{-(N-j+1)} - x_{i}^{N-j+1})_{i,j=1}^{N}}$$

$$= \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{sp}| \frac{\det(x_{i}^{\nu_{j}+(N-j+1)} - x_{i}^{-\nu_{j}-(N-j+1)})_{i,j=1}^{N}}{\det(x_{i}^{N-j+1} - x_{i}^{-(N-j+1)})_{i,j=1}^{N}}$$

$$= \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{sp}| sp_{\nu}(x^{\pm}),$$

$$(3.20)$$

where the sum is over all partitions  $\nu=(\nu_1,\ldots,\nu_N)$  and we have used the bialternant formula of the symplectic Schur function  $sp_{\nu}(x^{\pm})$  (see (1.2)) associated to the partition  $\nu$ . Invoking (3.13) again and also by the Jacobi-Trudi formula for the symplectic Schur functions [13, Theorem 1.3.3] [12, (4.1)]:

$$sp_{\nu}(x^{\pm}) = \frac{1}{2} \det(h_{\nu_i - i + j}(x^{\pm}) + h_{\nu_i - i - j + 2}(x^{\pm}))_{1 \le i, j \le N},$$

where  $h_n(x^{\pm})$  [2, 12, 25] is defined by  $\prod_{i=1}^{N} \frac{1}{(1-x,z)(1-x^{-1}z)} = \sum_{n \in \mathbb{Z}} h_n(x^{\pm})z^n$ , we obtain another expression for  $\langle 0|\Gamma_+(\{x^{\pm}\}):$ 

(3.21)

$$\langle 0|\Gamma_{+}(\{x^{\pm}\}) = \sum_{n_{1} \geq -N+1, n_{2} \geq -N+2, \dots, n_{N} \geq 0} \langle 0|Y_{-n_{N}}^{*} \dots Y_{-n_{1}}^{*} h_{n_{1}}(x^{\pm}) \prod_{i=2}^{N} (h_{n_{i}}(x^{\pm}) + h_{n_{i}-2i+2}(x^{\pm})).$$

By definition of vertex operator  $Y^*(z)$ , we have

$$(3.22) Y^*(z)\Gamma_+(\lbrace x^{\pm}\rbrace) = \prod_{i=1}^N \frac{1}{(1-x_iz)(1-x_i^{-1}z)} \Gamma_+(\lbrace x^{\pm}\rbrace)Y^*(z)$$
$$= \sum_{i>0} h_i(x^{\pm})z^i\Gamma_+(\lbrace x^{\pm}\rbrace)Y^*(z),$$

which implies

$$Y_{-n}^* \Gamma_+(\{x^{\pm}\}) = \Gamma_+(\{x^{\pm}\}) \sum_{i \ge 0} h_i(x^{\pm}) Y_{-n-i}^*.$$

Therefore by (2.8),(3.21) and (3.13) we see that

(3.23)

$$\begin{split} &\langle \mu^{sp} | \Gamma_{+}(\{x^{\pm}\}) \\ &= \sum_{i_{1}, \dots, i_{l} \geq 0} h_{i_{1}}(x^{\pm}) \dots h_{i_{l}}(x^{\pm}) \langle 0 | \Gamma_{+}(\{x^{\pm}\}) Y^{*}_{-\mu_{l} - i_{l}} \dots Y^{*}_{-\mu_{1} - i_{1}} \\ &= \sum_{\substack{i_{1}, \dots, i_{l} \geq 0 \\ i_{l+1} \geq -N+1, \dots, i_{l+N} \geq 0}} \langle 0 | Y^{*}_{-i_{l+N}} \dots Y^{*}_{-i_{l+1}} Y^{*}_{-\mu_{l} - i_{l}} \dots Y^{*}_{-\mu_{1} - i_{1}} \prod_{k=1}^{l+1} h_{i_{k}}(x^{\pm}) \prod_{k=l+2}^{l+N} (h_{i_{k}}(x^{\pm}) + h_{i_{k} - 2(k-l) + 2}(x^{\pm})) \\ &= \sum_{\lambda = (\lambda_{1}, \dots, \lambda_{l+N})} \langle \lambda^{sp} | \sum_{\sigma \in S_{l+N}} \prod_{k=1}^{l+1} h_{\lambda_{\sigma(k)} - \mu_{k} - \sigma(k) + k}(x^{\pm}) \prod_{k=l+2}^{l+N} (h_{\lambda_{\sigma(k)} - \sigma(k) + k}(x^{\pm}) + h_{\lambda_{\sigma(k)} - \sigma(k) - k + 2l + 2}(x^{\pm})) \\ &= \sum_{\lambda = (\lambda_{1}, \dots, \lambda_{l+N})} \langle \lambda^{sp} | \det(a_{ij})_{1 \leq i, j \leq l+N}, \end{split}$$

where  $a_{ij}$  satisfy (3.16) and in the last two equations  $\lambda_{\sigma(i)} - \sigma(i) + 2(l+N+1) - i$  is greater than l+N-i.

Remark 3.2. We stress that the partition  $\mu$  of skew symplectic Schur function  $sp_{\lambda/\mu}(x^{\pm})$  in (3.14) and (3.15) are general partitions, i.e., some parts can be zeros. For instance,  $\langle 0|Y_{-1}^*\Gamma_+(\{x^{\pm}\})Y_{-2}Y_{-1}Y_{-1}|0\rangle$  is the skew symplectic Schur function  $sp_{(2,1,1)/(1)}(x^{\pm})$ , and  $\langle 0|Y_0^*Y_{-1}^*\Gamma_+(\{x^{\pm}\})Y_{-2}Y_{-1}Y_{-1}|0\rangle$  gives different expression  $sp_{(2,1,1,0)/(1,0)}(x^{\pm})$ . The same statement applies to the skew orthogonal case (3.27).

Remark 3.3. If partitions  $\lambda = (\lambda_1, \dots, \lambda_{l+N})$  and  $\mu = (\mu_1, \dots, \mu_l)$  share the common length (eg.  $\lambda$  and  $\mu$  both have length l), formula (3.15) implies that  $sp_{\lambda/\mu}(x^{\pm}) = s_{\lambda/\mu}(x^{\pm})$  since the matrix  $(a_{ij})$  is a block upper-unipotent one. One can also get the special case of skew symplectic Schur functions via Gelfand-Tsetlin patterns in the following.

3.3. Skew-type orthogonal Schur functions. We can treat the orthogonal Schur functions similarly. Using the commutation relations

$$\langle 0|W_n^*=\langle 0|W_{-n}^*,\ W_i^*W_j^*=-W_{j-1}^*W_{i+1}^*,$$

we see that the partition elements (2.9) with partitions  $\mu = (\mu_1, \dots, \mu_l)$  can be expressed as

$$(3.24) \qquad \varepsilon(\sigma)\langle 0| \begin{pmatrix} W^*_{-\mu_{\sigma(l)}+\sigma(l)-l} \\ \delta_l W^*_{\mu_{\sigma(l)}-\sigma(l)+l} \end{pmatrix} \cdots \begin{pmatrix} W^*_{-\mu_{\sigma(i)}+\sigma(i)-i} \\ \delta_i W^*_{\mu_{\sigma(i)}-\sigma(i)+2l-i} \end{pmatrix} \cdots \begin{pmatrix} W^*_{-\mu_{\sigma(1)}+\sigma(1)-1} \\ \delta_l W^*_{\mu_{\sigma(1)}-\sigma(l)+2l-1} \end{pmatrix} = \langle \mu^o|,$$

where  $\delta_i$  denotes  $\delta_{\mu_l \neq 0} \delta_{\sigma(i) \neq l}$ .

Recall the Vandermonde type identity [12,25] in this case

$$\det(x_i^{N-j} + x_i^{N+j-2})_{i,j=1}^N = 2 \prod_{1 \le i < j \le N} (x_i - x_j)(1 - x_i x_j).$$

Therefore

$$\langle 0|\Gamma_{+}(\{x^{\pm}\}) = \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{o}|2(-1)^{\frac{N(N-1)}{2}} \frac{\prod_{i=1}^{N} x_{i}^{i-N} \det(x_{i}^{-\nu_{j}+j-i} + \delta_{j\neq N} \delta_{\nu_{N}\neq 0} x_{i}^{\nu_{j}-j+2N-i})_{i,j=1}^{N}}{\det(x_{i}^{-j+1} + x_{i}^{j-1})_{i,j=1}^{N}}$$

$$= \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{o}|2(-1)^{\frac{N(N-1)}{2}} \frac{\det(x_{i}^{-\nu_{j}+j-N} + \delta_{j\neq N} \delta_{\nu_{N}\neq 0} x_{i}^{\nu_{j}-j+N})_{i,j=1}^{N}}{\det(x_{i}^{-j+1} + x_{i}^{j-1})_{i,j=1}^{N}}$$

$$= \sum_{\nu=(\nu_{1},\dots,\nu_{N})} \langle \nu^{o}|o_{\nu}(x^{\pm}),$$

$$(3.25)$$

where the sum is over all partitions  $\nu = (\nu_1, \dots, \nu_N)$  and  $o_{\nu}(x^{\pm})$  is the orthogonal Schur function associated to partition  $\nu$  (see (1.3)). Due to (3.24) and the Jacobi-Trudi formula for orthogonal Schur functions [13, Theorem 1.3.2] [12, (4.2)]

$$o_{\nu}(x^{\pm}) = \det(h_{\nu_i - i + j}(x^{\pm}) - h_{\nu_i - i - j}(x^{\pm}))_{1 < i, j < N},$$

we can write

$$(3.26) \qquad \langle 0|\Gamma_{+}(\{x^{\pm}\}) = \sum_{n_{1} \geq -N+1, n_{2} \geq -N+2, \dots, n_{N} \geq 0} \langle 0|W_{-n_{N}}^{*} \dots W_{-n_{1}}^{*} \prod_{i=1}^{N} (h_{n_{i}}(x^{\pm}) - h_{n_{i}-2i}(x^{\pm})).$$

Using the same method in Proposition 3.2 with (3.24) and (3.26), we can prove the following results.

**Proposition 3.3.** For partition  $\mu = (\mu_1, \dots, \mu_l)$ , partition  $\lambda$  with length  $l(\lambda) \leq l + N$  and  $\{x^{\pm}\}$  $\{x_1, x_1^{-1}, \dots, x_N, x_N^{-1}\}\$ , one has that

(3.27) 
$$\langle \mu^{o} | \Gamma_{+}(\lbrace x^{\pm} \rbrace) | \lambda^{o} \rangle = o_{\lambda/\mu}(x^{\pm}),$$

where

(3.28) 
$$o_{\lambda/\mu}(x^{\pm}) = \det(b_{ij})_{i,j=1}^{l+N}$$

and

$$b_{ij} = \begin{cases} h_{\lambda_i - \mu_j - i + j}(x^{\pm}) & 1 \le j \le l, \\ h_{\lambda_i - i + j}(x^{\pm}) - h_{\lambda_i - i - j + 2l}(x^{\pm}) & l + 1 \le j \le l + N. \end{cases}$$

#### 4. Gelfand-Tsetlin pattern representations for three skew-type functions

In this section, we first derive the formulas for skew Schur functions in Gelfand-Tsetlin patterns using vertex operators. We then do the same for skew symplectic/orthogonal Schur functions.

We start by recalling a special case of skew Schur functions in terms of vertex operators given in [11, Prop 2.4]. We say a partition  $\lambda$  interlaces another partition  $\nu$ , denoted as  $\nu \prec \lambda$ , if  $\lambda_i \geq \nu_i \geq \lambda_{i+1}$  for all i.

**Lemma 4.1.** For two interlacing partitions  $\nu \prec \lambda$ , where  $\nu = (\nu_1 \dots \nu_l)$  and  $\lambda = (\lambda_1 \dots \lambda_{l+1})$ , one has that

$$(4.1) s_{\lambda/\nu}(t) = t^{|\lambda| - |\nu|}.$$

It follows from Lemma 4.1 that skew Schur functions can be written as a sum over Gelfand-Tsetlin tableaux: for partitions  $\mu = (\mu_1, \dots, \mu_l) \subset \lambda = (\lambda_1, \dots, \lambda_{l+N})$ 

(4.2) 
$$s_{\lambda/\mu}(x) = \sum_{\mu=z_0 \prec z_1 \prec \dots \prec z_N = \lambda} \prod_{i=1}^N x_i^{|z_i| - |z_{i-1}|},$$

summed over all sequences of partitions  $\mu = z_0 \prec z_1 \prec \cdots \prec z_N = \lambda$ , where  $z_i = (z_{i,1}, z_{i,2}, \dots, z_{i,l+i})$  satisfy the Gelfand-Tsetlin pattern:

$$z_{i+1,j} \le z_{i,j-1} \le z_{i+1,j-1}$$
 for  $2 \le j \le l+i+1$ .

Using the similar method as in [11], we can get the Gelfand-Tsetlin pattern formulas for skew symplectic (orthogonal) Schur functions  $sp_{\lambda/\mu}(x^{\pm})(o_{\lambda/\mu}(x^{\pm}))$ . We start by proving three lemmas.

**Lemma 4.2.** For any integer m and partitions  $\alpha = (\alpha_1, \dots, \alpha_k), \beta = (\beta_1, \dots, \beta_{k+2}),$  one has

$$\langle \alpha^{sp} | \sum_{i \le m, j \le m+1} Y_i^* Y_j^* t^{i+j} | \beta^{sp} \rangle = 0.$$

*Proof.* From (2.3) and (2.6), we know that  $Y_j^*|\beta^{sp}\rangle = 0$  for  $j < -\beta_1$ . Therefore

$$\begin{split} \sum_{i \leq m, j \leq m+1} Y_i^* Y_j^* t^{i+j} |\beta^{sp}\rangle &= \sum_{-\beta_1 - 1 \leq i \leq m, -\beta_1 \leq j \leq m+1} Y_i^* Y_j^* t^{i+j} |\beta^{sp}\rangle \\ &= - \sum_{-\beta_1 - 1 \leq i \leq m, -\beta_1 \leq j \leq m+1} Y_{j-1}^* Y_{i+1}^* t^{i+j} |\beta^{sp}\rangle \\ &= - \sum_{-\beta_1 - 1 \leq a \leq m, -\beta_1 \leq b \leq m+1} Y_a^* Y_b^* t^{a+b} |\beta^{sp}\rangle, \end{split}$$

therefore  $\sum_{i \leq m, j \leq m+1} Y_i^* Y_j^* t^{i+j} |\beta^{sp}\rangle = 0$ , which completes the proof.

**Corollary 4.1.** For any integer m and partition  $\alpha = (\alpha_1, \dots, \alpha_k)$ ,

$$\langle \alpha^{sp} | \sum_{i \le m, j \le m+1} Y_i^* Y_j^* t^{i+j} = 0.$$

**Lemma 4.3.** For partitions  $\nu = (\nu_1 \dots \nu_l)$  and  $\lambda = (\lambda_1 \dots \lambda_{l+1})$ , one has

$$(4.4) sp_{\lambda/\nu}(t^{\pm}) = \sum_{\nu \prec \alpha \prec \lambda} t^{2|\alpha| - |\lambda| - |\nu|}$$

summed over all partitions  $\alpha$  such that  $\nu \prec \alpha \prec \lambda$ .

*Proof.* It follows from equation (3.23) that

(4.5) 
$$\langle \nu^{sp} | \Gamma_{+}(t^{\pm}) = \sum_{i,i_{1},\dots,i_{l} > 0} h_{i}(t^{\pm}) \prod_{j=1}^{l} h_{i_{j}}(t^{\pm}) \langle 0 | Y_{-i}^{*} Y_{-\nu_{l}-i_{l}}^{*} \cdots Y_{-\nu_{1}-i_{1}}^{*},$$

where  $h_i(t^{\pm}) = t^{-i} + t^{-i+2} + \cdots + t^{i-2} + t^i = \frac{t^{-i} - t^{i+2}}{1 - t^2}$ . Since  $Y_{j-1}^* Y_j^* = 0$  and Corollary 4.1, we have

$$\begin{split} &\sum_{i \geq \nu_l + 1, j \geq \nu_l} \langle 0 | Y_{-i}^* Y_{-j}^* (t^{-i} - t^{i+2}) (t^{\nu_l - j} - t^{j - \nu_l + 2}) \\ &= \sum_{i \geq \nu_l + 1, j \geq \nu_l} \langle 0 | Y_{-i}^* Y_{-j}^* (-t^{i+2 + \nu_l - j} - t^{j - \nu_l + 2 - i}) \\ &= \sum_{j \geq i \geq \nu_l + 1} \langle 0 | Y_{-i}^* Y_{-j}^* (-t^{i+2 + \nu_l - j} - t^{j - \nu_l + 2 - i}) + \sum_{i - 1 > j \geq \nu_l} \langle 0 | Y_{-i}^* Y_{-j}^* (-t^{i+2 + \nu_l - j} - t^{j - \nu_l + 2 - i}) \\ &= \sum_{j \geq i \geq \nu_l + 1} \langle 0 | Y_{-i}^* Y_{-j}^* (-t^{i+2 + \nu_l - j} - t^{j - \nu_l + 2 - i}) + \sum_{i - 1 > j \geq \nu_l} \langle 0 | Y_{-j - 1}^* Y_{-i + 1}^* (t^{i+2 + \nu_l - j} + t^{j - \nu_l + 2 - i}) \\ &= \sum_{j \geq i \geq \nu_l + 1} \langle 0 | Y_{-i}^* Y_{-j}^* (-t^{i+2 + \nu_l - j} - t^{j - \nu_l + 2 - i}) + \sum_{n \geq m \geq \nu_l + 1} \langle 0 | Y_{-m}^* Y_{-n}^* (t^{n+4 + \nu_l - m} + t^{m - \nu_l - n}) \\ &= \sum_{j \geq i \geq \nu_l + 1} \langle 0 | Y_{-i}^* Y_{-j}^* (t^{j+4 + \nu_l - i} + t^{i - \nu_l - j} - t^{i+2 + \nu_l - j} - t^{j - \nu_l + 2 - i}) \\ &= \sum_{j \geq i \geq \nu_l + 1} \langle 0 | Y_{-i}^* Y_{-j}^* (t^{i-j} - t^{j - i + 2}) (t^{-\nu_l} - t^{2 + \nu_l}). \end{split}$$

Thus

$$\begin{split} &\sum_{i,i_{l}\geq 0}h_{i}(t^{\pm})h_{i_{l}}(t^{\pm})\langle 0|Y_{-i}^{*}Y_{-\nu_{l}-i_{l}}^{*}\\ &=\frac{1}{(1-t^{2})^{2}}\sum_{i,i_{l}\geq 0}\langle 0|Y_{-i}^{*}Y_{-\nu_{l}-i_{l}}^{*}(t^{-i}-t^{i+2})(t^{-i_{l}}-t^{i_{l}+2})\\ &=\sum_{0\leq i\leq \nu_{l},i_{l}\geq 0}\langle 0|Y_{-i}^{*}Y_{-\nu_{l}-i_{l}}^{*}h_{i}(t^{\pm})h_{i_{l}}(t^{\pm})+\frac{1}{(1-t^{2})^{2}}\sum_{i\geq \nu_{l}+1,i_{l}\geq 0}\langle 0|Y_{-i}^{*}Y_{-\nu_{l}-i_{l}}^{*}(t^{-i}-t^{i+2})(t^{-i_{l}}-t^{i_{l}+2})\\ &=\sum_{0\leq i\leq \nu_{l},i_{l}\geq 0}\langle 0|Y_{-i}^{*}Y_{-\nu_{l}-i_{l}}^{*}h_{i}(t^{\pm})h_{i_{l}}(t^{\pm})+\sum_{\nu_{l}+i_{l}\geq i\geq \nu_{l}+1}\langle 0|Y_{-i}^{*}Y_{-\nu_{l}-i_{l}}^{*}h_{\nu_{l}}(t^{\pm})h_{\nu_{l}+i_{l}-i}(t^{\pm}). \end{split}$$

Setting  $\gamma_1 = \nu_l + i_l \ge \gamma_2 = i \ge 0$ , then the above equation becomes

$$\sum_{i,i_l \geq 0} h_i(t^\pm) h_{i_l}(t^\pm) \langle 0 | Y_{-i}^* Y_{-\nu_l - i_l}^* = \sum_{\max\{\gamma_2,\nu_l\} \leq \gamma_1} \langle 0 | Y_{-\gamma_2}^* Y_{-\gamma_1}^* h_{\min\{\gamma_2,\nu_l\}}(t^\pm) h_{\gamma_1 - \max\{\gamma_2,\nu_l\}}(t^\pm).$$

Continuing the process, equation (4.5) becomes

$$(4.6) \langle \nu^{sp} | \Gamma_{+}(t^{\pm}) \rangle$$

$$= \sum_{\lambda} \langle \lambda^{sp} | h_{\min\{\lambda_{l+1},\nu_{l}\}}(t^{\pm}) (\prod_{j=2}^{l} h_{\min\{\lambda_{j},\nu_{j-1}\}-\max\{\lambda_{j+1},\nu_{j}\}}(t^{\pm})) h_{\lambda_{1}-\max\{\lambda_{2},\nu_{1}\}}(t^{\pm})$$

$$= \sum_{\lambda} \langle \lambda^{sp} | h_{\min\{\lambda_{l+1},\nu_{l}\}}(t^{\pm}) t^{\min\{\lambda_{l+1},\nu_{l}\}} (\prod_{j=2}^{l} h_{\min\{\lambda_{j},\nu_{j-1}\}-\max\{\lambda_{j+1},\nu_{j}\}}(t^{\pm}) t^{\min\{\lambda_{j},\nu_{j-1}\}+\max\{\lambda_{j+1},\nu_{j}\}})$$

$$\cdot h_{\lambda_{1}-\max\{\lambda_{2},\nu_{1}\}}(t^{\pm}) t^{\lambda_{1}+\max\{\lambda_{2},\nu_{1}\}} t^{-|\lambda|-|\nu|}$$

$$= \sum_{\lambda} \langle \lambda^{sp} | \sum_{\nu \prec \alpha \prec \lambda} t^{2|\alpha| - |\lambda| - |\nu|},$$

where we use the fact that  $|\lambda| + |\nu| = \min\{\lambda_{l+1}, \nu_l\} + \sum_{j=2}^{l} \min\{\lambda_j, \nu_{j-1}\} + \sum_{j=2}^{l} \max\{\lambda_{j+1}, \nu_j\} + \lambda_1 + \max\{\lambda_2, \nu_1\}$  and the notations

$$0 \le \alpha_{l+1} \le \min\{\lambda_{l+1}, \nu_l\}, \ \max\{\lambda_{j+1}, \nu_j\} \le \alpha_j \le \min\{\lambda_j, \nu_{j-1}\}, \ \max\{\lambda_2, \nu_1\} \le \alpha_1 \le \lambda_1.$$

Thus the proof is completed.

**Lemma 4.4.** For partitions  $\nu = (\nu_1 \dots \nu_l)$  and  $\lambda = (\lambda_1 \dots \lambda_{l+1})$ , one has

(4.7) 
$$o_{\lambda/\nu}(t^{\pm}) = \sum_{\nu \neq \alpha \neq \lambda} (1 + \delta_{\lambda_{l+1} > 0} \delta_{\nu_l, 0}) t^{2|\alpha| - |\lambda| - |\nu|}$$

summed over all partitions  $\alpha$  such that  $\nu \prec \alpha \prec \lambda$  and  $\alpha_{l+1} \in \{0, \min\{\lambda_{l+1}, \nu_l\}\}$ .

*Proof.* Using the same method for Lemma 4.3, we have

$$\langle \nu^{o} | \Gamma_{+}(t^{\pm}) = \sum_{\lambda} \langle \lambda^{o} | (t^{-\min\{\lambda_{l+1},\nu_{l}\}} + t^{\min\{\lambda_{l+1},\nu_{l}\}}) (\prod_{j=2}^{l} h_{\min\{\lambda_{j},\nu_{j-1}\}-\max\{\lambda_{j+1},\nu_{j}\}} (t^{\pm})) h_{\lambda_{1}-\max\{\lambda_{2},\nu_{1}\}} (t^{\pm})$$

$$= \sum_{\lambda} \langle \lambda^{o} | (1 + t^{2\min\{\lambda_{l+1},\nu_{l}\}}) (\prod_{j=2}^{l} h_{\min\{\lambda_{j},\nu_{j-1}\}-\max\{\lambda_{j+1},\nu_{j}\}} (t^{\pm}) t^{\min\{\lambda_{j},\nu_{j-1}\}+\max\{\lambda_{j+1},\nu_{j}\}})$$

$$\cdot h_{\lambda_{1}-\max\{\lambda_{2},\nu_{1}\}} (t^{\pm}) t^{\lambda_{1}+\max\{\lambda_{2},\nu_{1}\}} t^{-|\lambda|-|\nu|}$$

$$= \sum_{\lambda} \langle \lambda^{o} | \sum_{\nu \neq \alpha \neq \lambda} (1 + \delta_{\lambda_{l+1}>0} \delta_{\nu_{l},0}) t^{2|\alpha|-|\lambda|-|\nu|},$$

$$(4.8)$$

summed over  $\alpha$  such that  $\nu \prec \alpha \prec \lambda$  and  $\alpha_{l+1} \in \{0, \min\{\lambda_{l+1}, \nu_l\}\}$ .

The following theorem can be proved easily with the help of Lemma 4.3 and Lemma 4.4.

**Theorem 4.1.** For partitions  $\mu = (\mu_1, \dots, \mu_l) \subset \lambda = (\lambda_1, \dots, \lambda_{l+N})$ , one has

(4.9) 
$$sp_{\lambda/\mu}(x^{\pm}) = \sum_{\mu=z_0 \prec z_1 \prec \cdots \prec z_{2N} = \lambda} \prod_{i=1}^{N} x_i^{2|z_{2i-1}| - |z_{2i}| - |z_{2i-2}|},$$

$$(4.10) o_{\lambda/\mu}(x^{\pm}) = \sum_{\mu = z'_0 \prec z'_1 \prec \cdots \prec z'_{2N} = \lambda} \prod_{i=1}^{N} (1 + \delta_{z'_{2i,l+i} > 0} \delta_{z'_{2i-2,l+i-1},0}) x_i^{2|z'_{2i-1}| - |z'_{2i}| - |z'_{2i-2}|}$$

where partitions  $z_k = (z_{k,1}, \dots, z_{k,l+\lceil \frac{k}{2} \rceil})$  satisfy the symplectic Gelfand-Tsetlin pattern

$$z_{k+1,j} \le z_{k,j-1} \le z_{k+1,j-1} \text{ for } 2 \le j \le l + \lceil \frac{k+1}{2} \rceil$$

and partitions  $z_k' = (z_{k,1}', \dots, z_{k,l+\lceil \frac{k}{2} \rceil}')$  satisfy the orthogonal Gelfand-Tsetlin pattern

$$z'_{k+1,j} \le z'_{k,j-1} \le z'_{k+1,j-1} \text{ for } 2 \le j \le l + \lceil \frac{k+1}{2} \rceil$$

 $subject\ to\ z'_{2i-1,l+i}\in\{0,\min\{z'_{2i,l+i},z'_{2i-2,l+i-1}\}\}.$ 

**Remark 4.1.** One can find an equivalent statement of (4.9) in [1], where they defined symplectic Gelfand-Tsetlin pattern by induction. For  $\mu = \emptyset$ , (4.9) and (4.10) recover the classical Gelfand-Tsetlin patterns for sympletic/orthogonal Schur functions [21].

#### 5. Cauchy-type identities and general branching rules

In this section we give a new proof of Cauchy's identities for (sympletic/orthogonal) Schur functions by the method of vertex operators. This approach is logically independent from the Jacobi-Trudi formula. The method can be further used to derive Cauchy-type identities for skew Schur functions as well as skew sympletic/orthogonal Schur functions. In addition, we show that vertex operator realizations for skew (sympletic/orthogonal) Schur functions agree with general branching rule for sympletic/orthogonal Schur functions.

**Lemma 5.1.** For  $x = (x_1, x_2, ..., x_N)$ , we have

(5.1) 
$$\Gamma_{-}(\lbrace x \rbrace)|0\rangle = \sum_{\lambda} s_{\lambda}(x)|\lambda\rangle$$

(5.2) 
$$\Gamma_{-}(\lbrace x \rbrace)|0\rangle = \prod_{1 \leq i < j \leq N} (1 - x_i x_j)^{-1} \sum_{\lambda} s_{\lambda}(x)|\lambda^{sp}\rangle$$

(5.3) 
$$\Gamma_{-}(\lbrace x \rbrace)|0\rangle = \prod_{1 < i < j < N} (1 - x_i x_j)^{-1} \sum_{\lambda} s_{\lambda}(x)|\lambda^{o}\rangle,$$

where the sum is over all partitions  $\lambda$  with  $l(\lambda) \leq N$ .

*Proof.* We first prove (5.1) by a similar method as in Proposition 3.1, which is different from that of [11]. Using the relations  $X(z)\Gamma_+(z^{-1}) = \Gamma_-(z)$  and  $\Gamma_+(z_1^{-1})\Gamma_-(z_2) = (1 - \frac{z_2}{z_1})^{-1}\Gamma_-(z_2)\Gamma_+(z_1^{-1})$  for  $|z_1| > |z_2|$ , one has

$$\Gamma_{-}(\lbrace x \rbrace)|0\rangle 
= \prod_{1 \leq i < j \leq N} (1 - \frac{x_{j}}{x_{i}})^{-1} X(x_{1}) \cdots X(x_{N})|0\rangle 
= \prod_{1 \leq i < j < N} (1 - \frac{x_{j}}{x_{i}})^{-1} \sum_{n_{1}, \dots, n_{N}} x_{1}^{n_{1}} \cdots x_{N}^{n_{N}} X_{-n_{1}} \cdots X_{-n_{N}}|0\rangle.$$
(5.4)

By  $X_i X_j = -X_{j+1} X_{i-1}$ , one can shuffle the factors to get

$$(5.5) \varepsilon(\sigma) X_{-\lambda_1} \cdots X_{-\lambda_N} = X_{-\lambda_{\sigma(1)} + \sigma(1) - 1} \cdots X_{-\lambda_{\sigma(i)} + \sigma(i) - i} \cdots X_{-\lambda_{\sigma(N)} + \sigma(N) - N},$$

where  $\sigma \in S_N$ . Thus the coefficient of  $|\lambda\rangle = X_{-\lambda_1} \cdots X_{-\lambda_N} |0\rangle$  in  $\Gamma_-(\{x\})|0\rangle(5.4)$  is

$$\prod_{1 \leq i < j \leq N} (1 - \frac{x_j}{x_i})^{-1} \sum_{\sigma} \varepsilon(\sigma) x_1^{\lambda_{\sigma(1)} - \sigma(1) + 1} \cdots x_i^{\lambda_{\sigma(i)} - \sigma(i) + i} \cdots x_N^{\lambda_{\sigma(N)} - \sigma(N) + N}$$

$$= \prod_{1 \leq i < j \leq N} (x_i - x_j)^{-1} \sum_{\sigma} \varepsilon(\sigma) x_1^{\lambda_{\sigma(1)} - \sigma(1) + N} \cdots x_i^{\lambda_{\sigma(i)} - \sigma(i) + N} \cdots x_N^{\lambda_{\sigma(N)} - \sigma(N) + N}$$

$$= \frac{\det(x_i^{\lambda_j + N - j})_{1 \leq i, j \leq N}}{\prod_{1 \leq i < j \leq N} (x_i - x_j)} = \frac{\det(x_i^{\lambda_j + N - j})_{1 \leq i, j \leq N}}{\det(x_i^{N - j})_{1 \leq i, j \leq N}} = s_{\lambda}(x).$$

Then the relation (2.10) gives  $\langle \lambda | \Gamma_{-}(\{x\}) | 0 \rangle = s_{\lambda}(x)$  for any  $\lambda$ , subsequently

$$\Gamma_{-}(\lbrace x \rbrace)|0\rangle = \sum_{\substack{\lambda \ l(\lambda) \leq N}} s_{\lambda}(x)|\lambda\rangle.$$

The other two relations can be proved similarly with the help of

(5.7) 
$$\varepsilon(\sigma)Y_{-\lambda_1}\cdots Y_{-\lambda_N} = Y_{-\lambda_{\sigma(1)}+\sigma(1)-1}\cdots Y_{-\lambda_{\sigma(i)}+\sigma(i)-i}\cdots Y_{-\lambda_{\sigma(N)}+\sigma(N)-N},$$

$$(5.8) \varepsilon(\sigma)W_{-\lambda_1}\cdots W_{-\lambda_N} = W_{-\lambda_{\sigma(1)}+\sigma(1)-1}\cdots W_{-\lambda_{\sigma(i)}+\sigma(i)-i}\cdots W_{-\lambda_{\sigma(N)}+\sigma(N)-N},$$

where 
$$\sigma \in S_N$$
.

By direct calculation, we have the following two lemmas.

**Lemma 5.2.** From the commutation relations (2.1) and (3.1), we have

(5.9) 
$$\langle 0|\Gamma_{+}(\{x\})\Gamma_{-}(\{y\})|0\rangle = \prod_{i=1}^{N} \prod_{j=1}^{K} (1 - x_{i}y_{j})^{-1},$$

where  $x = (x_1, ..., x_N), y = (y_1, ..., y_K).$ 

Now we study some cases of the inner product  $\langle 0|\Gamma_{+}(\{x\})\Gamma_{-}(\{y\})|0\rangle$  related to symmetric functions. Due to (2.10), (2.11), (2.12), (3.10), (3.20), (3.25) and Lemma 5.1, we have the following result.

**Lemma 5.3.** For  $x = (x_1, \ldots, x_N), y = (y_1, \ldots, y_N), x^{\pm} = (x_1^{\pm}, \ldots, x_N^{\pm}), we have$ 

(5.10) 
$$\langle 0|\Gamma_{+}(\lbrace x\rbrace)\Gamma_{-}(\lbrace y\rbrace)|0\rangle = \sum_{\substack{\lambda\\l(\lambda) \leq N}} s_{\lambda}(x)s_{\lambda}(y),$$

(5.11) 
$$\langle 0|\Gamma_{+}(\{x^{\pm}\})\Gamma_{-}(\{y\})|0\rangle = \prod_{1 \le k < l \le N} (1 - y_{k}y_{l})^{-1} \sum_{\substack{\lambda \\ l(\lambda) \le N}} sp_{\lambda}(x^{\pm})s_{\lambda}(y),$$

(5.12) 
$$\langle 0|\Gamma_{+}(\{x^{\pm}\})\Gamma_{-}(\{y\})|0\rangle = \prod_{1 \le k \le l \le N} (1 - y_{k}y_{l})^{-1} \sum_{\substack{\lambda \\ l(\lambda) \le N}} o_{\lambda}(x^{\pm})s_{\lambda}(y).$$

Combining Lemma 5.2 and Lemma 5.3, we can prove the classical Cauchy identities associated to Schur functions, symplectic and orthogonal Schur functions respectively.

**Theorem 5.1** ( [3,13,24]). Let  $x = (x_1, \ldots, x_N), y = (y_1, \ldots, y_N), x^{\pm} = (x_1^{\pm}, \ldots, x_N^{\pm}).$  Then

(5.13) 
$$\sum_{\lambda \subset [N,\infty)} s_{\lambda}(x) s_{\lambda}(y) = \prod_{i,j=1}^{N} (1 - x_i y_j)^{-1},$$

(5.14) 
$$\sum_{\lambda \subseteq [N,\infty)} s_{\lambda}(y) = \prod_{i,j=1}^{N} \left[ (1 - x_i y_j) (1 - x_i^{-1} y_j) \right]^{-1} \prod_{1 \le k < l \le N} (1 - y_k y_l),$$

(5.15) 
$$\sum_{\lambda \subset [N,\infty)} o_{\lambda}(x^{\pm}) s_{\lambda}(y) = \prod_{i,j=1}^{N} \left[ (1 - x_i y_j) (1 - x_i^{-1} y_j) \right]^{-1} \prod_{1 \le k \le l \le N} (1 - y_k y_l),$$

where  $\lambda \subseteq [N, \infty)$  also denote partition  $\lambda$  with length  $l(\lambda) \leq N$ .

The following is a generalization of Lemma 5.1.

**Lemma 5.4.** For a partition  $\mu$  with length l and  $x = (x_1, x_2, \dots, x_N)$ , we have

(5.16) 
$$\Gamma_{-}(\lbrace x\rbrace)|\mu\rangle = \sum_{\mu\subset\lambda\subseteq[l+N,\infty)} s_{\lambda/\mu}(x)|\lambda\rangle$$

(5.17) 
$$\Gamma_{-}(\lbrace x\rbrace)|\mu^{sp}\rangle = \prod_{1 \le i < j \le N} (1 - x_i x_j)^{-1} \sum_{\mu \subset \lambda \subseteq [l+N,\infty)} S_{\lambda/\mu}^*(x)|\lambda^{sp}\rangle$$

(5.18) 
$$\Gamma_{-}(\lbrace x\rbrace)|\mu^{o}\rangle = \prod_{1 \leq i \leq j \leq N} (1 - x_{i}x_{j})^{-1} \sum_{\mu \subset \lambda \subset [l+N,\infty)} S_{\lambda/\mu}^{*}(x)|\lambda^{o}\rangle,$$

where

$$S_{\lambda/\mu}^*(x) = \frac{\det(c_{ij})_{i,j=1}^{l+N}}{\det(x_i^{N-j})_{1 \le i,j \le N}}$$

with

$$c_{ij} = \begin{cases} x_i^{\lambda_j - j + N} & 1 \le i \le N, \\ h_{\mu_{i-N} - \lambda_j + j - i}(x^{\pm}) & N + 1 \le i \le N + l. \end{cases}$$

*Proof.* We only prove (5.17), as the others can be handled similarly. By definition (2.2), we have

(5.19) 
$$\Gamma_{-}(\lbrace x \rbrace) = \frac{1}{\prod_{1 \le i \le j \le N} (1 - x_i x_j) (1 - x_i^{-1} x_j)} Y(x_1) \cdots Y(x_N) \Gamma_{+}(\lbrace x^{\pm} \rbrace),$$

where  $x^{\pm}=(x_1^{\pm},\ldots,x_N^{\pm})$ . It is easy to check that (by simple vertex operator calculus)

$$\Gamma_{+}(\lbrace x^{\pm}\rbrace)Y(z) = \frac{1}{\prod_{i=1}^{N} (1 - x_{i}z)(1 - x_{i}^{-1}z)} Y(z)\Gamma_{+}(\lbrace x^{\pm}\rbrace),$$

thus

$$\Gamma_{+}(\lbrace x^{\pm}\rbrace)Y_{n} = \sum_{i>0} h_{i}(x^{\pm})Y_{n+i}\Gamma_{+}(\lbrace x^{\pm}\rbrace).$$

Then

$$\prod_{1 \le i < j \le N} (1 - x_i x_j) (1 - x_i^{-1} x_j) \Gamma_-(\{x\}) | \mu^{sp} \rangle$$

$$= Y(x_1) \cdots Y(x_N) \sum_{k_{N+1}, \dots, k_{N+l} \ge 0} h_{k_{N+1}}(x^{\pm}) \cdots h_{k_{N+l}}(x^{\pm}) Y_{-\mu_1 + k_{N+1}} \cdots Y_{-\mu_l + k_{N+l}} | 0 \rangle$$

$$= \sum_{k_1, \dots, k_N \in \mathbb{Z}} x_1^{k_1} \cdots x_N^{k_N} \sum_{k_{N+1}, \dots, k_{N+l} \ge 0} h_{k_{N+1}}(x^{\pm}) \cdots h_{k_{N+l}}(x^{\pm}) Y_{-k_1} \cdots Y_{-k_N} Y_{-\mu_1 + k_{N+1}} \cdots Y_{-\mu_l + k_{N+l}} | 0 \rangle.$$

By (5.7), the coefficient of 
$$|\lambda^{sp}\rangle$$
 in  $\prod_{1\leq i< j\leq N} (1-x_ix_j)(1-x_i^{-1}x_j)\Gamma_-(\{x\})|\mu^{sp}\rangle$  is

$$\det(c_{ij})_{i,j=1}^{l+N}$$

with

$$c_{ij} = \begin{cases} x_i^{\lambda_j - j + i} & 1 \le i \le N, \\ h_{\mu_{i-N} - \lambda_j + j - i}(x^{\pm}) & N + 1 \le i \le N + l. \end{cases}$$

By mean of the Vandermonde identity, we can get (5.17).

**Remark 5.1.** For partition  $\mu = \emptyset$ ,  $S_{\lambda}^*(x) = s_{\lambda}(x)$ .

We now offer a vertex operator proof of the Cauchy-type identity for skew Schur functions [18, p.93], which can be seen as a generalized Cauchy identity for Schur functions.

**Theorem 5.2.** For two partitions  $\lambda$  and  $\mu$ ,

(5.20) 
$$\sum_{\rho} s_{\rho/\lambda}(x) s_{\rho/\mu}(y) = \prod_{i \ j} (1 - x_i y_j)^{-1} \sum_{\nu} s_{\mu/\tau}(x) s_{\lambda/\tau}(y),$$

where the sum is over all partitions  $\rho$  and  $\tau$  which make sense of skew Schur functions.

*Proof.* From (2.10), we can easy deduce

(5.21) 
$$\langle \lambda | \sum_{\rho} |\rho\rangle \langle \rho| = \langle \lambda |, \sum_{\rho} |\rho\rangle \langle \rho| |\lambda\rangle = |\lambda\rangle,$$

where the sum is over all partitions  $\rho$ . Thus

$$(5.22) \qquad \langle \lambda | \Gamma_{+}(\{x\}) \Gamma_{-}(\{y\}) | \mu \rangle = \langle \lambda | \Gamma_{+}(\{x\}) \sum_{\rho} |\rho\rangle \langle \rho | \Gamma_{-}(\{y\}) | \mu \rangle = \sum_{\rho} s_{\rho/\lambda}(x) s_{\rho/\mu}(y),$$

where we have used (3.7). We also have the following relation

$$\langle \lambda | \Gamma_{+}(\{x\}) \Gamma_{-}(\{y\}) | \mu \rangle = \prod_{i,j} (1 - x_{i}y_{j})^{-1} \langle \lambda | \Gamma_{-}(\{y\}) \Gamma_{+}(\{x\}) | \mu \rangle$$

$$(5.23) \qquad = \prod_{i,j} (1 - x_i y_j)^{-1} \langle \lambda | \Gamma_-(\{y\}) \sum_{\tau} |\tau\rangle \langle \tau | \Gamma_+(\{x\}) | \mu\rangle = \prod_{i,j} (1 - x_i y_j)^{-1} \sum_{\nu} s_{\mu/\tau}(x) s_{\lambda/\tau}(y).$$

Comparing (5.22) and (5.23), we get the identity.

We also extend the vertex operator approach to obtain Cauchy-type identities for skew symplectic/orthogonal Schur functions.

**Theorem 5.3.** For partition  $\mu = (\mu_1, \dots, \mu_l)$  and  $\lambda$  with length less than l + N - K, one has

(5.24) 
$$\sum_{\rho=(\rho_1,\dots,\rho_{l+N})} sp_{\rho/\mu}(x^{\pm}) S_{\rho/\lambda}^*(y) = \prod_{i=1}^N \prod_{j=1}^K \frac{1}{(1-x_i y_j)(1-x_i^{-1} y_j)} \sum_{\tau=(\tau_1,\dots,\tau_{l-K})} sp_{\lambda/\tau}(x^{\pm}) S_{\mu/\tau}^*(y),$$

$$(5.25) \sum_{\rho=(\rho_1,\ldots,\rho_{l+N})} o_{\rho/\mu}(x^{\pm}) S_{\rho/\lambda}^*(y) = \prod_{i=1}^N \prod_{j=1}^K \frac{1}{(1-x_i y_j)(1-x_i^{-1} y_j)} \sum_{\tau=(\tau_1,\ldots,\tau_{l-K})} o_{\lambda/\tau}(x^{\pm}) S_{\mu/\tau}^*(y),$$

where 
$$x^{\pm} = (x_1^{\pm}, \dots, x_N^{\pm}), \ y = (y_1, \dots, y_K).$$

*Proof.* Using (2.11) and (2.12), for partition  $\nu = (\nu_1, \dots, \nu_n)$ , we have

(5.26) 
$$\langle \nu^{sp} | \sum_{\eta = (\eta_1, \dots, \eta_n)} | \eta^{sp} \rangle \langle \eta^{sp} | = \langle \nu^{sp} |, \sum_{\eta = (\eta_1, \dots, \eta_n)} | \eta^{sp} \rangle \langle \eta^{sp} | | \nu^{sp} \rangle = | \nu^{sp} \rangle,$$

(5.27) 
$$\langle \nu^o | \sum_{\eta = (\eta_1, \dots, \eta_n)} | \eta^o \rangle \langle \eta^o | = \langle \nu^o |, \sum_{\eta = (\eta_1, \dots, \eta_n)} | \eta^o \rangle \langle \eta^o | | \nu^o \rangle = | \nu^o \rangle,$$

where the sum is over all partitions  $\eta = (\eta_1, \dots, \eta_n)$ . On the one hand,

$$\langle \mu^{sp} | \Gamma_{+}(\{x^{\pm}\}) \Gamma_{-}(\{y\}) | \lambda^{sp} \rangle = \langle \mu^{sp} | \Gamma_{+}(\{x^{\pm}\}) \sum_{\rho = (\rho_{1}, \dots, \rho_{l+N})} |\rho^{sp} \rangle \langle \rho^{sp} | \Gamma_{-}(\{y\}) | \lambda^{sp} \rangle$$

$$= \sum_{\rho = (\rho_{1}, \dots, \rho_{l+N})} sp_{\rho/\mu}(x^{\pm}) S_{\rho/\lambda}^{*}(y),$$
(5.28)

where we used (3.14) and (5.17). On the other hand,

$$\langle \mu^{sp} | \Gamma_+(\{x^\pm\}) \Gamma_-(\{y\}) | \lambda^{sp} \rangle = \prod_{i=1}^N \prod_{j=1}^K \frac{1}{(1-x_i y_j)(1-x_i^{-1} y_j)} \langle \mu^{sp} | \Gamma_-(\{y\}) \sum_{\tau=(\tau_1,\dots,\tau_{l-K})} |\tau^{sp} \rangle \langle \tau^{sp} | \Gamma_+(\{x^\pm\}) | \lambda^{sp} \rangle$$

(5.29) 
$$= \prod_{i=1}^{N} \prod_{j=1}^{K} \frac{1}{(1 - x_i y_j)(1 - x_i^{-1} y_j)} \sum_{\tau = (\tau_1, \dots, \tau_{l-K})} s p_{\lambda/\tau}(x^{\pm}) S_{\mu/\tau}^*(y).$$

Comparing (5.28) with (5.29), we can get (5.24). (5.25) can be proved similarly.

Corollary 5.1. Skew Schur functions  $s_{\lambda/\mu}$ , skew symplectic Schur functions  $s_{p_{\lambda/\mu}}$  and skew orthogonal Schur functions  $o_{\lambda/\mu}$  satisfy the following general branching rules,

$$(5.30) s_{\lambda}(x;y) = \sum_{\mu \in \lambda} s_{\mu}(x) s_{\lambda/\mu}(y),$$

(5.31) 
$$sp_{\lambda}(x^{\pm}; y^{\pm}) = \sum_{\mu = (\mu_1, \dots, \mu_{n-k})} sp_{\mu}(x^{\pm}) sp_{\lambda/\mu}(y^{\pm}),$$

(5.32) 
$$o_{\lambda}(x^{\pm}; y^{\pm}) = \sum_{\mu = (\mu_1, \dots, \mu_{n-k})} o_{\mu}(x^{\pm}) o_{\lambda/\mu}(y^{\pm}),$$

where 
$$x = (x_1, \dots, x_{n-k}), y = (y_1, \dots, y_k), x^{\pm} = (x_1, x_1^{-1}, \dots, x_{n-k}, x_{n-k}^{-1})$$
 and  $y^{\pm} = (y_1, y_1^{-1}, \dots, y_k, y_k^{-1}).$ 

*Proof.* We only prove (5.31), the other two can be obtained similarly. From (3.14), we have

(5.33) 
$$\langle 0|\Gamma_{+}(x^{\pm};y^{\pm})|\lambda^{sp}\rangle = sp_{\lambda}(x^{\pm};y^{\pm}).$$

By (5.26),

$$\langle 0|\Gamma_{+}(x^{\pm};y^{\pm})|\lambda^{sp}\rangle = \langle 0|\Gamma_{+}(x^{\pm})\sum_{\mu=(\mu_{1},\dots,\mu_{n-k})}|\mu^{sp}\rangle\langle\mu^{sp}|\Gamma_{+}(y^{\pm})|\lambda^{sp}\rangle$$

(5.35) 
$$= \sum_{\mu=(\mu_1,\dots,\mu_{n-k})} sp_{\mu}(x^{\pm}) sp_{\lambda/\mu}(y^{\pm}).$$

Combining (5.33) and (5.34), we obtain the result.

**Remark 5.2.** For k = 1, the general branching rules (5.30), (5.31) and (5.32) reduce to branching rules for (symplectic/orthogonal) Schur functions [14, Theorem 3.1, Theorem 3.2]. The vertex operator constructions for skew-type symmetric functions are based on the general branching rules actually.

Remark 5.3. In [15] Lam studied some general symmetric functions via a boson-fermion correspondence. It will be interesting to study and realize the skew symmetric functions using vertex operators.

#### APPENDIX A

In this Appendix we give a simple vertex operator proof of Proposition 3.1 and (5.16).

*Proof.* From the definition of X(z), we have

$$\Gamma_{+}(\{x\})X(z) = \prod_{i=1}^{N} \frac{1}{1 - x_{i}z} X(z)\Gamma_{+}(\{x\}),$$

i.e.,

(5.36) 
$$\Gamma_{+}(\{x\})X_{n} = \sum_{i>0} h_{i}(x)X_{n+i}\Gamma_{+}(\{x\}).$$

Thus

$$\begin{split} \Gamma_{+}(\{x\})|\lambda\rangle = & \Gamma_{+}(\{x\})X_{-\lambda_{1}}\dots X_{-\lambda_{k}}|0\rangle \\ = & \sum_{i_{1},\dots,i_{k}\geq 0}h_{i_{1}}(x)\cdots h_{i_{k}}(x)X_{-\lambda_{1}+i_{1}}\dots X_{-\lambda_{k}+i_{k}}|0\rangle \\ = & \sum_{\nu}\sum_{\sigma\in S_{k}}\epsilon(\sigma)h_{\lambda_{1}-\nu_{\sigma(1)}+\sigma(1)-1}(x)\cdots h_{\lambda_{k}-\nu_{\sigma(k)}+\sigma(k)-k}(x)X_{-\nu_{\sigma(1)}+\sigma(1)-1}\cdots X_{-\nu_{\sigma(k)}+\sigma(k)-k}|0\rangle \\ = & \sum_{\nu}\det(h_{\lambda_{i}-\nu_{j}-i+j}(x))_{i,j=1}^{k}|\nu\rangle = \sum_{\nu}s_{\lambda/\nu}(x)|\nu\rangle, \end{split}$$

where we have used (5.5) and the fact  $\Gamma_+(\{x\})|0\rangle = |0\rangle$ . By (2.10), we have shown Proposition 3.1. Similarly, using (3.6) and (2.10), we can get

$$\langle \lambda | \Gamma_{-}(\{x\}) | \mu \rangle = s_{\lambda/\mu}(x).$$

It is clear that

$$\Gamma_{-}(\lbrace x \rbrace)|\mu\rangle = \sum_{\mu \subset \lambda} s_{\lambda/\mu}(x)|\lambda\rangle.$$
