# Lepton Flavor Violating $B \rightarrow K_{2}^{*}(1430) \mu^{ \pm} \tau^{\mp}$ Decays

A number of measurements in decays induced by the semileptonic $b \rightarrow s$ and $b \rightarrow c$ transitions hint towards a possible role of new physics in both sectors. Motivated by these anomalies, we investigate the lepton flavor violating $B \rightarrow K_{2}^{*}(1430) \mu^{ \pm} \tau^{\mp}$ decays. We calculate the two-fold angular distribution of $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ decay in presence of vector, axial-vector, scalar and pseudo-scalar new physics interactions. We then compute the branching fraction and lepton forward-backward asymmetry in the framework of $U_{1}^{2 / 3}$ vector leptoquark which is a viable solution to the current $B$ anomalies. We find that the upper limits are $\mathcal{B}\left(B \rightarrow K_{2}^{*} \mu^{-} \tau^{+}\right) \leq 1.64 \times 10^{-7}$ and $\mathcal{B}\left(B \rightarrow K_{2}^{*} \mu^{+} \tau^{-}\right) \leq 0.60 \times 10^{-7}$ at $90 \%$ C.L.

## I. INTRODUCTION

One of the most exciting experimental results in recent times in flavor physics is the violation of lepton flavor universality (LFU) in semileptonic $B$ meson decays (for a recent review, see Ref. [1]). These decays are mainly mediated by neutral current transition $b \rightarrow s \ell^{+} \ell^{-}(\ell=e, \mu)$ and charged current transition $b \rightarrow c \ell \bar{\nu}(\ell=e, \mu, \tau)$. However, in $b \rightarrow s \ell^{+} \ell^{-}$sector, the recent measured values of the LFU ratios $R_{K^{(*)}}=\mathcal{B}\left(B \rightarrow K^{(*)} \mu^{+} \mu^{-}\right) / \mathcal{B}\left(B \rightarrow K^{(*)} e^{+} e^{-}\right)$by the LHCb collaboration [2, 3] are now consistent with their Standard Model (SM) predictions. Still, there are other discrepancies reported in the observables related to $b \rightarrow s \mu^{+} \mu^{-}$decays such as the branching ratio of $B_{s} \rightarrow$ $\phi \mu^{+} \mu^{-}$, angular observables in $B \rightarrow K^{*} \mu^{+} \mu^{-}$decay [4-7]. These deviations are at the level of $\sim 2-4 \sigma$. A number of studies has been performed to explain all these deviations in both modelindependent (see for example Refs. [8-17]) as well as in specific new physics (NP) models such as $Z^{\prime}$ boson [18-23], Leptoquark [24-26] etc.

On the other hand, the flavor ratios in $b \rightarrow c \ell \bar{\nu}$ transition are defined as $R_{D^{(*)}}=\mathcal{B}(B \rightarrow$ $\left.D^{(*)} \tau \bar{\nu}\right) / \mathcal{B}\left(B \rightarrow D^{(*)} \ell \bar{\nu}\right)$, where $\ell=e$ or $\mu \quad[27-35]$. The present world averages of $R_{D}$ and $R_{D^{*}}$, including the correlation, are $\sim 3 \sigma$ away from their SM predictions [36]. Besides, the measured value of the ratio $R_{J / \psi}=\mathcal{B}\left(B_{c} \rightarrow J / \psi \tau \bar{\nu}\right) / \mathcal{B}\left(B_{c} \rightarrow J / \psi \mu \bar{\nu}\right)$ is found to be $\sim 2 \sigma$ higher than its SM value [37]. Very recently, the LHCb has measured another ratio in baryonic decays $R_{\Lambda_{c}}=$ $\mathcal{B}\left(\Lambda_{b} \rightarrow \Lambda_{c} \tau \bar{\nu}\right) / \mathcal{B}\left(\Lambda_{b} \rightarrow \Lambda_{c} \mu \bar{\nu}\right)$ which is consistent with its SM prediction [38]. In this context, various groups have proposed explanations in a model-independent approach [39-47] and also in different NP models. Some of the simplified NP models may include a new vector boson [48-51], a charged scalar [52-59] or a Leptoquark [60-64].

Several attempts are made to come up with a combined explanation of anomalies in both neutral current and charged current transitions [65-71]. Among these, the Leptoquark (LQ) solution is quite interesting and popular. However, the LQ could be either a scalar or a vector depending on its spin. A review on all kinds of LQs can be found in Ref. [72]. Among all the LQs, the vector $U_{1}$ with charge $+2 / 3$ and a $S U(2)_{L}$ singlet is a very good candidate to explain all these deviations simultaneously.

The hints of LFU violation in $B$ decays automatically lead to a possibility of having lepton flavor violation (LFV) in $B$ decays [18, 73-77]. In this work, we study the flavor violation in $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$, where $K_{2}^{*}$ is higher excited spin-2 state of $K^{*}$ meson. The tensor meson $K_{2}^{*}$ has additional polarizations compared to the $K^{*}$ meson which could provide new kinematical quantities that are sensitive to the NP. Therefore, $B \rightarrow K_{2}^{*}$ decay could be examined as a complementary
decay process to look for new helicity structures compared to the recently measured $B \rightarrow K^{* 0} \mu \tau$ decay [78]. Our main aim is to investigate the LFV properties of $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ decays if it could provide any interesting features. This decay is mediated by $b \rightarrow s \ell_{1} \ell_{2}$ where we consider $\ell_{1}$, $\ell_{2}=\mu$ or $\tau$. The flavor conserving $B \rightarrow K_{2}^{*} \ell^{+} \ell^{-}$decay has already been well studied within the SM as well as in the NP models [79-85]. In particular, BaBar [86] and Belle [87] have already observed the radiative decay $B \rightarrow K_{2}^{*} \gamma$ and the measured branching ratio is as comparable to that of $B \rightarrow K^{*} \gamma$. In this paper, we calculate the two-fold differential decay distribution of $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ in the presence of vector, axial-vector, scalar and pseudo-scalar NP operators. Then we investigate the sensitivities of the branching ratio and the forward-backward asymmetry in the $U_{1} \mathrm{LQ}$ model. In doing that, first we obtain the allowed NP parameter spaces of the model by using the most relevant constraints from the flavor observables. Finally, we compute the upper limits of these two observables in the $U_{1}$ model.

The paper is organized as follows. In sec.II, we start with the $b \rightarrow s \ell_{1} \ell_{2}$ NP Hamiltonian and calculate two-fold decay distribution of $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ decay. In sec.III, we discuss the $U_{1}$ LQ model and investigate its effect on the observables of $B \rightarrow K_{2}^{*} \mu^{ \pm} \tau^{\mp}$ decays. In sec. IV, we present our conclusions.

## II. DECAY DISTRIBUTION OF $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$

The LFV $b \rightarrow s \ell_{1} \ell_{2}$ transition is not allowed in the SM. Therefore, the NP effective Hamiltonian for $b \rightarrow s \ell_{1} \ell_{2}$ transition can be written as

where $\alpha_{\mathrm{em}}$ is the fine-structure constant, $G_{F}$ is the Fermi constant, $V_{t s}$ and $V_{t b}$ are the Cabibbo-Kobayashi-Maskawa (CKM) matrix elements. The $\mathcal{H}_{\text {eff }}$ contains four types of NP operators, vec$\operatorname{tor}(\mathrm{V})$, axial-vector(A), scalar(S) and pseudo-scalar(P), which can be expressed as

Here $P_{L(R)}=\left(1 \mp \gamma_{5}\right) / 2$ are the chirality operators. We note that the electromagnetic penguin operator $\mathcal{O}_{7}$ (appears in $b \rightarrow s \ell \ell$ decay):

cannot generate LFV contribution due to the universality of electromagnetic interaction. The NP Wilson coefficients (WCs) $C_{V, A, S, P}^{(\prime)}$ contain the short distance physics whereas the long-distance physics are embedded into the $B \rightarrow K_{2}^{*}$ hadronic matrix elements. For $B \rightarrow K_{2}^{*}$ transition, the hadronic matrix elements for V and A currents can be parameterized in terms of four form factors $V\left(q^{2}\right)$ and $A_{0,1,2}\left(q^{2}\right)$. These can be written as [88]

where $p$ and $k$ are the four momentum of $B$ and $K_{2}^{*}$ mesons, respectively. However, applying equation of motion, it can be shown that the matrix element of $B \rightarrow K_{2}^{*}$ transition for the scalar interaction ( $\bar{s} b$ ) vanishes and that for the pseudo-scalar interaction leads to

The polarization vector of $K_{2}^{*}$ is discussed in Appendix A. All form-factors have been calculated within the perturbative QCD approach [88] and also in Light-Cone QCD sum rule technique [8992]. In this work, we follow the latest values of form factors derived using the light cone QCD sum rule (LCSR) from Ref [92]. Within this method, each form factor can be expressed as follows

where $z(s)=\frac{\sqrt{t_{+}-s}-\sqrt{t_{+}-t_{0}}}{\sqrt{t_{+}-s+} \sqrt{t_{+}-t_{0}}}, t_{ \pm}=\left(m_{B} \pm m_{K_{2}^{*}}\right)^{2}, t_{0}=t_{+}\left(1-\sqrt{1-t_{-} / t_{+}}\right)$and $m_{R, F}$ is the resonance mass associated with the quantum numbers of corresponding form factor. The fit parameters $\alpha_{n}^{F}$ are given in Table I.

TABLE I: Fit parameters for $B \rightarrow K_{2}^{*}$ form factors using LCSR approach.

The three body $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ decay can be described by the leptonic polar angle $\theta_{\ell}$ and leptonic mass squared $q^{2}=(p-k)^{2}$. We take the $\theta_{\ell}$ angle as the angle made by the $\ell_{1}$ lepton w.r.t. to
the di-lepton rest frame. In terms of these two variables, we find the two-fold differential decay distribution as follows

Here $m_{ \pm}=\left(m_{1} \pm m_{2}\right), \beta_{ \pm}=\sqrt{1-\frac{\left(m_{\ell_{1}} \pm m_{\ell_{2}}\right)^{2}}{q^{2}}}$ and the expressions of transversity amplitudes $A$ 's are given in Appendix B. In Appendix C, we describe the lepton helicity amplitudes used in our analysis. Integrating Eq. (7) over $\theta_{\ell}$, we get the differential decay rate

whereas the lepton forward-backward asymmetry is found to be

## III. THE VECTOR $S U(2)_{L}$ SINGLET LQ

We consider the weak singlet vector LQ $U_{1}^{2 / 3}$ since it can give rise to a good explanation of both types of anomalies in $b \rightarrow c \ell \bar{\nu}$ and $b \rightarrow s \mu^{+} \mu^{-}$transitions, simultaneously [67, 68, 70]. In fact, this LQ model attracts a lot of attention in the literature. The interaction Lagrangian between the $U_{1}$ LQ and the SM fermions can be written as [72]

where $h_{L, R}^{i j}$ are the LQ couplings with the generation indexes $i, j, Q_{L}\left(L_{L}\right)$ is the SM left-handed quark (lepton) doublet and $d_{R}\left(\ell_{R}\right)$ is the right-handed down quark (lepton) singlet. We consider the minimal framework where $h_{R}^{i j}=0$. We also assume the LQ couplings are real and couplings to the first generation are zero. This leads to the following flavor structure of the LQ couplings

To calculate the NP parameters $h_{L}$ 's, one needs to consider all the relevant constraints from low energy observables. In $U_{1} \mathrm{LQ}$ model, these constraints would include from $2 q 2 \ell$ processes which involve second and third generations. In our analysis, we consider only those processes which contribute at the tree level. These observables can be divided into following categories

- $b \rightarrow s \mu^{+} \mu^{-}$data : In presence of $U_{1}$ LQ, the vector and axial-vector NP WCs of $b \rightarrow s \mu^{+} \mu^{-}$ can be written as

where $C_{V(A)}^{\mu \mu}$ denotes the NP WC of $\left[\bar{s} \gamma^{\alpha} P_{L} b\right]\left[\bar{\mu} \gamma_{\alpha}\left(\gamma_{5}\right) \mu\right]$ operator. From recent global fits of all $b \rightarrow s \mu^{+} \mu^{-}$data, the most preferred value is $C_{V}^{\mu \mu}=-C_{A}^{\mu \mu}=-0.19 \pm 0.06$ [17] which is used in our calculation.

- $b \rightarrow c(u) \ell \bar{\nu}$ data: In case of $b \rightarrow c \tau \bar{\nu}$, the NP WC can also be expressed in following form

where $C_{V_{L}}^{\tau}$ is the NP WC of the NP operator $\mathcal{O}_{V_{L}}=\left(\bar{c} \gamma_{\mu} P_{L} b\right)\left(\bar{\tau} \gamma^{\mu} P_{L} \nu\right)$. In this sector, we consider four flavor ratios $R_{D}, R_{D^{*}}, R_{J / \psi}$ and $R_{\Lambda_{c}}$. The expressions for these ratios can be found in Ref. [93, 94]. In addition, $\mathcal{B}\left(B_{c} \rightarrow \tau \bar{\nu}\right)$ puts an important constraint on the NP parameter space, particularly for scalar and pseudo-scalar interactions. This decay has not yet been measured. However, the LEP data at Z peak imposes a constraint $\mathcal{B}\left(B_{c} \rightarrow \tau \bar{\nu}\right)<10 \%$ [95] and a $30 \%$ limit can be achieved using the $B_{c}$ lifetime [96]. In our analysis we use the $30 \%$ bound on $B_{c} \rightarrow \tau \bar{\nu}$. There are two more LFU ratios $R_{D}^{\mu / e}=\mathcal{B}(B \rightarrow$ $D \mu \bar{\nu}) / \mathcal{B}(B \rightarrow D e \bar{\nu})$ and $R_{D^{*}}^{e / \mu}=\mathcal{B}\left(B \rightarrow D^{*} e \bar{\nu}\right) / \mathcal{B}\left(B \rightarrow D^{*} \mu \bar{\nu}\right)$ have been measured [97, 98]. These measurements are well in agreement with their SM predictions. In this case, the $U_{1}$ LQ contribute to $b \rightarrow c \mu \bar{\nu}$ decay and the NP WC looks as

The $U_{1} \mathrm{LQ}$ can also contribute to charged current transition $b \rightarrow u \tau \bar{\nu}$. Here one potential observable is $\mathcal{B}(B \rightarrow \tau \bar{\nu})$. The $U_{1}$ model contribute the this decay through the following NP WC

where $V_{u b}$ and $V_{u s}$ are the CKM matrix elements. The measured value of the branching ratio is in agreement with its SM prediction $\left.\mathcal{B}(B \rightarrow \tau \bar{\nu})\right|_{\text {SM }}=(0.812 \pm 0.054) \times 10^{-4}$ [99]. The current measured values of all these quantities are listed in Table II.

- LFV decays: The LFV decays of $B$ meson are mediated by $b \rightarrow s \tau^{ \pm} \mu^{\mp}$ which occur at tree level under exchange of $U_{1} \mathrm{LQ}$. In this model, the NP WCs take the following for

We note that the $b \rightarrow s \mu^{-} \tau^{+}\left(b \rightarrow s \mu^{+} \tau^{-}\right)$decay depends on $h_{L}^{23} h_{L}^{32}\left(h_{L}^{22} h_{L}^{33}\right)$ combination. This includes the current upper limits on $B \rightarrow K \mu^{ \pm} \tau^{\mp}, B \rightarrow K^{* 0} \mu^{ \pm} \tau^{\mp}$ and $B_{s} \rightarrow \mu^{ \pm} \tau^{\mp}$, listed in Table II. In addition, there could be constraints from $\Upsilon(n S) \rightarrow \tau^{ \pm} \mu^{\mp}$ and $\tau \rightarrow \mu \phi$ which are governed by $b \bar{b} \rightarrow \mu^{ \pm} \tau^{\mp}$ and $\tau \rightarrow \mu \bar{s} s$ respectively. For these decays, the NP WCs in the $U_{1}$ model can be written as

Among three LFV decays of $\Upsilon(n S)$, the $\Upsilon(3 S)$ decay puts the most strongest constraint which is used in our analysis. The expressions of all these LFV observables can be found in Ref. [67].

- $b \rightarrow s \tau^{+} \tau^{-}$decay: There could be important constraints from the rare decays $B \rightarrow K \tau^{+} \tau^{-}$ and $B_{s} \rightarrow \tau^{+} \tau^{-}$which are mediated by $b \rightarrow s \tau^{+} \tau^{-}$transition. In the $U_{1}$ LQ model, the NP WCs for this transition can be written as

The expressions for the branching fractions can be found in Ref. [68]. These decays are not observed so far, but we have the experimental upper limits, listed in Table II.

In our analysis, we assume the LQ mass to be 1.8 TeV . This is the lower limit on the mass of vector LQ obtained from an analysis of LHC direct and indirect high $p_{T}$ searches [70]. Now we perform a $\chi^{2}$ analysis to find the NP parameter space allowed by the current flavor data. The $\chi^{2}$ function is defined as

where $\mathcal{O}_{k}^{\text {theory }}$ is the theoretical prediction, $\mathcal{O}_{k}^{\text {expt }}$ is the experimental central value and $\sigma_{\text {total,k }}$ is the total uncertainty (theoretical and experimental errors are added in quadrature) for each observable. The measured values and the upper limits of each observable are listed in Table II which went into the fit. However, we note that there are only a $90 \%$ CL upper limit on the branching ratios of $B \rightarrow K^{* 0} \tau^{ \pm} \mu^{\mp}, \tau \rightarrow \mu \phi, B_{s} \rightarrow \tau^{ \pm} \mu^{\mp}$ and $B_{s} \rightarrow \tau^{+} \tau^{-}$. In order to incorporate these observables into our fit, we take the branching ratio to be ( $0.0 \pm$ U.L./1.645). The allowed NP couplings are obtained by minimizing the $\chi^{2}$ function. For the minimization, we use the CERN Minuit library [105]. We obtain the NP parameter spaces in the planes of $h_{L}^{22}-h_{L}^{33}$ and $h_{L}^{23}-h_{L}^{32}$ allowed at
$90 \%$ C.L. around the $\chi_{\text {min }}^{2}$. These regions are shown in Fig. 1. In particular, we note that the regions are symmetric for each plot.


FIG. 1: The plot on the left (right) panel represents the allowed 90\% C.L. region in the $h_{L}^{22}-h_{L}^{33}\left(h_{L}^{23}-h_{L}^{32}\right)$ plane for $M_{U_{1}}=1.8 \mathrm{TeV}$.

Now we calculate the maximum values of branching ratios and forward-backward asymmetries of $B \rightarrow K_{2}^{*} \mu^{ \pm} \tau^{\mp}$ decays for the allowed NP parameter space. In order to do that, we scan over the allowed regions and find the benchmark point from each of the plots. From the left plot of Fig. 1, we find $h_{L}^{22} h_{L}^{33}=0.025$ whereas from the right plot we get $h_{L}^{23} h_{L}^{32}=0.042$. At these values, we find the maximum values of branching fractions to be

and those for forward-backward asymmetries are

We also plot the differential branching ratio and the forward-backward asymmetry as a function of $q^{2}$ for the same NP benchmark points. The plots are shown in Fig. 2. In these plots, the dashed curves represent the central values and solid curves indicates the widths of errors, mainly, due to the form factors. From both the differential branching ratio plot and Eq. (23), it is evident that the order of magnitude is same for both decay. However the maximum value of $\mathcal{B}\left(B \rightarrow K_{2}^{*} \mu^{+} \tau^{-}\right)$is less than $\mathcal{B}\left(B \rightarrow K_{2}^{*} \mu^{-} \tau^{+}\right)$. From the $A_{\mathrm{FB}}$ plot, we find that the $A_{\mathrm{FB}}\left(q^{2}\right)$ of $B \rightarrow K_{2}^{*} \mu^{-} \tau^{+}$is negative through out the whole $q^{2}$ region. However, the $A_{\mathrm{FB}}\left(q^{2}\right)$ of $B \rightarrow K_{2}^{*} \mu^{+} \tau^{-}$has a zero-crossing point at $q^{2}=10 \mathrm{GeV}^{2}$.

## IV. CONCLUSIONS

Inspired by the current $B$ physics anomalies, we investigate the LFV $B \rightarrow K_{2}^{*} \mu^{ \pm} \tau^{\mp}$ decays. These decays are forbidden in the SM and hence any hint of these decays would imply a smoking gun signal of physics beyond the SM. In this work, we compute the two-fold angular distribution of $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ in presence of vector, axial-vector, scalar and pseudo-scalar NP interactions. From the differential decay distribution, we extract two observables: the branching fraction and the lepton forward-backward asymmetry. Finally, we calculate these observables in the vector $U_{1}$ LQ model which is a very popular model in explaining all the $B$ anomalies. In particular, we compute the upper limits of the branching fraction and the forward-backward asymmetry at $90 \%$ confidence level. We find that the upper limits of branching fractions are $\mathcal{O}\left(10^{-7}\right)$. We hope these upper limits may be measurable at LHCb.

## Appendix A: Polarization of $K_{2}^{*}$

The polarization $\epsilon^{\mu \nu}(n)$ of tensor meson $K_{2}^{*}$, which has four momentum $\left(k_{0}, 0,0, \vec{k}\right)$, can be written in terms of the spin-1 polarization vectors [106]

We study $B \rightarrow K_{2}^{*} \ell_{1} \ell_{2}$ decay where we have two leptons in the final state so in this case, the $n= \pm 2$ helicity states of the $K_{2}^{*}$ is not realized. Therefore a new polarization vector is introduced [90]

The lepton helicity amplitudes not mentioned above are all zero. Note that the scalar transitions $S$ and $P$ (also the timelike ones) are diagonal since $\lambda_{\ell}=\lambda_{1}-\lambda_{2}=0$.
