Quantum metrology with ultracold chemical reactions

Chemical chain reactions are known to enable extremely sensitive detection schemes in chemical, biological, and medical analysis, and have even been used in the search for dark matter. Here we show that coherent, ultracold chemical reactions harbor great potential for quantum metrology: In an atom-molecule Bose-Einstein condensate (BEC), a weak external perturbation can modify the reaction dynamics and lead to the coherent creation of molecules in an atom-dominant regime which can be selectively detected with modern spectroscopic techniques. This promises to substantially improve the viability of previously proposed BEC-based sensors for acceleration, gravitational waves, and other physical quantities, including the detection of dark matter, that so far relied on the detection of the tiny density modulations caused by the creation of single phonons.

Chemical chain reactions, such as the polymerase chain reaction that has become popular in COVID-19 tests, have developed to one of the most important, highly sensitive analysis and detection schemes not only in medicine, but more generally in biological and chemical analysis [1]. Within physics, a "DNA detector" for dark matter particles was proposed [2, 3]. However, the potential of ultracold coherent chemical reactions for quantum metrology has not been studied so far.

The conventional picture of chemical reactions being due to (classical) collisions gets modified drastically at ultralow temperatures. Specifically, when bosonic atoms and molecules lose their individual character and condense in coherent matter waves [4–7], chemical reactions can lead to coherent macroscopic, non-linear oscillatory dynamics even for simple reactions such as $A + A \rightarrow A_2$ for which no classical chemical oscillations are possible. Such a collectively enhanced "superchemistry" was demonstrated experimentally by coherent Rabi oscilations between atomic and molecular fields driven by magnetic Feshbach resonances or Raman transitions [8]. The collective chemical reactions of bosonic matter fields lead to a novel type of quasiparticle, which we coin the reacton. It is analogous to phonons in single-component BECs, but represents an elementary excitation of a quantized time- and space-dependent chemical reaction field with vector character that fully describes the reaction dynamics, rather than a single scalar density perturbation.

Its composition in terms of atomic and molecular amplitudes and the corresponding holes can be largely tuned through system parameters.

In what follows, we show that in this regime counting individual molecules facilitates the detection of small perturbations applied to the ultracold gas. We demonstrate that a lower bound of the classical Fisher information from counting molecules approaches the quantum Fisher information which sets the upper bound on the sensitivity with which the perturbation parameter can be estimated [9–11]. Corresponding sensors have been proposed e.g. for measuring acceleration [12], the detection of gravitational waves (GW) [13–16], for gravimeters and measuring the gravitational field gradient on a millimetre scale [17], and the detection of dark matter [18]. However, the classical Fisher information for specific and realizable measurements, and hence the sensitivity in practical realizations for these proposals, is unknown so far. Only the theoretically achievable maximum sensitivity based on the quantum Fisher information (QFI) was established. Ultimately, these proposed sensors require measuring density modulations from a small number of phonons in a BEC, but single phonon detection in condensates has been achieved experimentally so far only in the superfluid helium II [19] and there is no report of achieving single phonon detection in BECs yet. Since, on the other hand, molecules in a BEC can be detected on a single-particle level with spectroscopic techniques [20, 21] (the coherent formation of single molecules was demonstrated in [22]), our scheme presents an important step forward towards the realization of quantum sensors based on density perturbations in a condensate.

Molecular condensates were demonstrated experimentally via magnetic Feshbach resonances and photoassociation [23–25], and coherent oscillations between atomic and molecular condensates were observed [26–28]. Effective quantum field theories were proposed [6, 29–32] for photoassociation and direct reactions, leading to predictions of non-linear effects known from non-linear optics such as solitons [6], and classical wave chaos [33].

To set the stage of our analysis, we first develop the full quantum field theory of ultracold chemical reactions. Most calculations are delegated to the Supplemental Material.

Quantized chemical reactions

In the Heisenberg picture, the reaction $A + A \rightarrow A_2$ of two ultracold bosonic atoms A in a condensate to an

ultracold bosonic molecule A_2 is described in quantum field theory by the Hamiltonian [29, 30, 32]

+ \frac{\alpha}{\sqrt{2}} \int d^3r \, \left\{ \hat{\psi}_m^{\dagger}(\mathbf{r}, t) \, \hat{\psi}_a(\mathbf{r}, t) \, \hat{\psi}_a(\mathbf{r}, t) + h.c. \right\}, \tag{1}$$

where $\hat{\psi}_a(\mathbf{r},t)$ and $\hat{\psi}_m(\mathbf{r},t)$ are position- and timedependent annihilation operators of a bosonic atom and molecule, respectively. Furthermore, m_a and $m_m (\simeq 2m_a)$ are atom and molecule mass, respectively; $V_a\left(\boldsymbol{r},t\right)$ and $V_m\left(\boldsymbol{r},t\right)$ are the trap potentials for atoms and molecules, and g_a , g_m , and g_{am} are the contactinteraction couplings between two atoms, between two molecules, and between atoms and molecules, respectively. Finally, the parameter ϵ denotes the energy difference between two atoms and a molecule, α is the coupling coefficient that determines the coherent conversion rate of two atoms to a molecule, and h.c. means hermitian conjugate. Eq. (1) is a real-space version of the experimentally realizable momentum-space hamiltonian of photo-association for vanishing photon-momentum [29, 30].

The operator for the total number of atoms (including the ones bound in molecules),

commutes with the Hamiltonian in Eq. (1), is not explicitly time-dependent, and hence conserved; we denote by N the average value of \hat{N} .

Mean-field description

We expand $\hat{\psi}_{j}(\mathbf{r},t) = \psi_{j}(\mathbf{r},t) + \delta\hat{\psi}_{j}(\mathbf{r},t)$ where $\psi_{j}(\mathbf{r},t) \coloneqq \left\langle \hat{\psi}_{j}(\mathbf{r},t) \right\rangle$ is the mean-field value of $\hat{\psi}_{j}(\mathbf{r},t)$ for j=a,m, for small corrections $\delta\hat{\psi}_{j}(\mathbf{r},t) \ll \psi_{j}(\mathbf{r},t)$ where most of atoms and molecules are condensed, respectively. For a box trap [34], where $V_{a}(\mathbf{r},t) = 0$ and $V_{m}(\mathbf{r},t) = 0$, let V be the system volume and $n \coloneqq N/V$ the total number density. $\psi_{a}(\mathbf{r},t) = |\psi_{a}(t)| \exp\left[i\left\{\varphi_{a}(t) - \mu t/\hbar\right\}\right]$ and $\psi_{m}(\mathbf{r},t) = |\psi_{m}(t)| \exp\left[i\left\{\varphi_{m}(t) - 2\mu t/\hbar\right\}\right]$ satisfy the mean field Eqs. (S4) [35], and the mean-field Hamiltonian H_{0} reads

where we have normalized the couplings as follows, $\tilde{g}_m := g_m/g_a$, $\tilde{g}_{am} := g_{am}/g_a$, $\tilde{\alpha} := \alpha \sqrt{2n}/(g_a n)$, $\tilde{\epsilon} := \epsilon/(g_a n)$, $\varphi_{am}(t) := \varphi_m(t) - 2\varphi_a(t)$, $x(t) := |\psi_a(t)|/\sqrt{n}$, and $y(t) := |\psi_m(t)|/\sqrt{n}$. Note that Eq. (3) is minimized for $\alpha \cos \varphi_{am}(t) = -|\alpha| \text{ since } x^2(t) \ge 0$.

We use below in (5) a Bogoliubov expansion to go beyond mean field theory. In order to not mask the effects of the time-dependent perturbation (whose amplitude we want to probe), by a time-dependent mean-field background, we impose vanishing mean-field Josephson oscillations between atoms and molecules [36] (cf. Eq. (S4) in the Supplement). This can be achieved as follows: From Eq. (S6), $\varphi_{am}(t)$ can be set to be a constant, and hence, when $\alpha \cos \varphi_{am}(t) = -|\alpha|$, from Eq. (S5), x(t) and y(t) are also constant in time. Rendering $\varphi_{am}(t)$ constant in time with $\alpha \cos \varphi_{am} = -|\alpha|$ is possible by tuning $\tilde{\epsilon}$ to

Then $\varphi_a(t)$ and $\varphi_m(t)$ become constant in time, and by minimizing $H_0 - \mu N$, x and y follow from Eq. (S12) and $x = \sqrt{1 - 2y^2}$ from Eq. (2) (see supplemental material I for derivations). For simplicity, we will set $\varphi_a = 0$ and $\tilde{g}_m = 0$ in what follows.




FIG. 1. Physical values of y ($y \in \mathbb{R}$ and $0 \le y \le 1/\sqrt{2}$) as a function of \tilde{g}_{am} and $|\tilde{\alpha}|$. y_j is the j-th solution of Eq. (S12). For $\tilde{g}_{am} < 0$, y_1 is the physical value of y, whereas for $\tilde{g}_{am} > 1$, y_2 or y_3 are physical values of y. In the gray zones, no physical solution of y exists (upper zone: $y > 1/\sqrt{2}$ and x is imaginary; lower zone: no real solutions x and y exist). The orange plane is a projection of the physical values of y_1 .

Fig 1 shows the physical parameter regimes of \tilde{g}_{am} and $|\tilde{\alpha}|$, defined by $x,y\geq 0$, hence $0\leq y\leq 1/\sqrt{2}$. We focus on the atom-dominated case, so for $\tilde{g}_{am}>1$, we choose y_3 , the third solution of Eq. (S12). For $\tilde{g}_{am}<0$, Fig. 1 shows that only the first solution y_1 of Eq. (S12) is physical and hence we choose that one.

Quasiparticle excitations: Reactons

A Bogoliubov expansion [37] of the grand canonical

Hamiltonian corresponding to (1) in Fourier space gives (up to $O\left(\delta\hat{\Psi}_j^3\right)$)

$$+\frac{g_{a}n}{2}\sum_{p=1,2}\sum_{\mathbf{k}\neq0}\begin{bmatrix} \tilde{\omega}_{p}(k)\hat{b}_{p}^{\dagger}(\mathbf{k},t)\hat{b}_{p}(\mathbf{k},t)\\ +\tilde{\omega}_{p}^{*}(k)\hat{b}_{p}(-\mathbf{k},t)\hat{b}_{p}^{\dagger}(-\mathbf{k},t) \end{bmatrix}, (5)$$

where $\tilde{\omega}_p(k) := \hbar \omega_p(k) / (g_a n)$, $\tilde{\omega}_p^*(k)$ is the complex conjugate of $\tilde{\omega}_p(k)$, and we label p = 1, 2 such that $\operatorname{Re} \{\omega_2(0)\} \geq \operatorname{Re} \{\omega_1(0)\}$. Note that Eq. (5) gives $\hat{b}_p(\mathbf{k},t) = \exp[-i\operatorname{Re} \{\omega_p(k)\}t]\hat{b}_p(\mathbf{k},0)$, which shows that our Bogoliubov Hamiltonian in Eq. (5) is constant in time t.

The $\hat{b}_p(\mathbf{k},t)$ are bosonic annihilation operators of the pth Bogoliubov mode (p=1,2), i.e. linear combinations of the Fourier transforms of $\delta\hat{\psi}_a\left(\mathbf{r},t\right)$ and $\delta\hat{\psi}_m\left(\mathbf{r},t\right)$ and their hermitian conjugates via Eq. (S20). These linear combinations are "reaction fields" whose time-evolution due to the coherent, collective chemical reactions determines the dynamics of the spatiotemporal dependence of the atomic and molecular concentrations. The $\hat{b}_p\left(\mathbf{k},t\right)$ describe quantized excitations of the reaction fields, and $M_{11}(k), M_{22}(k)$ are defined in Eqs. (S16) and (S17).

The dimensionless eigenvalues $\tilde{\omega}_p(k)$ of the *p*th Bogoliubov mode define the two dispersion branches of reactons. They come in pairs of opposite signs, where, however, only the positive-frequency branches are physically meaningful [37]. We additionally define the dimensionless gap $\Delta\tilde{\omega}(0) := \tilde{\omega}_2(0) - \tilde{\omega}_1(0)$ for convenience.

Using the approach of [36] facilitates analytic expressions for $\tilde{\omega}_p(k)$ in Eqs. (S47). We find that $\tilde{\omega}_p(k)$ depends on $|\tilde{\alpha}|$, and expand $\tilde{\omega}_p(k)$ up to $O\left(k^2\right)$ in Eqs. (S59). Two important features reveal themselves $(A_1, B_1, B_2, \text{ and } B_3 \text{ are defined in Eqs. (S55) to (S58)):}$ (1) $\tilde{\omega}_1(0)$ becomes imaginary if $A_1 < 0$. (2) When $A_1 \geq 0$, $\tilde{\omega}_1(k) = k\xi_a\sqrt{B_2 - B_3/(4A_1)}$. Thus, if $B_2 - B_3/(4A_1) < 0$, $\tilde{\omega}_1(k)$ becomes purely imaginary. Fig 2 (a) shows the gap $\Delta\tilde{\omega}(0)$, where grey regions represent that the gap has nonzero imaginary value and black regions that $\tilde{\omega}_1(k)$ becomes imaginary. In both regions, the system is unstable and we will thus exclude them.

Sources of damping for collective excitations in single-component BECs are Landau damping, which is dominant at higher temperatures and is $\propto k_B T$ for $k_B T \gg mc_s^2$, and Beliaev damping at low temperatures $(k_B T \ll mc_s^2)$ and if $\hbar k \ll mc_s$ [38]. For $\hbar \omega_1(k)$ linear in k (corresponding to Nambu-Goldstone modes), in a large range, Landau and Beliaev dissipation and quasiparticle damping are negligible [39]. We will focus on an atom-rich regime, and hence expect that these damping mechanisms can also be neglected in our system.




FIG. 2. (a): Excitation gap $\Delta \tilde{\omega} (0)$ as a function of \tilde{g}_{am} and $|\tilde{\alpha}|$. The frequency $\tilde{\omega}_1(k)$ becomes imaginary in the black regions, whereas y does not have physical values in the grey regions. The gap increases with \tilde{g}_{am} and $|\tilde{\alpha}|$. (b): c_r/c_s as a function of \tilde{g}_{am} and $|\tilde{\alpha}|$. (c): Dispersion relations $\tilde{\omega}_p(k)$ as a function of $k\xi_a$ of the two reacton species: Massless reacton (red continuous line) $\tilde{\omega}_1$, massive reacton (blue line) $\tilde{\omega}_2$, with expansion of $\tilde{\omega}_1(k)$ up to O(k) (black dotted line), and expansion of $\tilde{\omega}_2(k)$ up to $O(k^2)$ (green dot-dashed line); $\tilde{g}_{am} = 100$ and $\tilde{\alpha} = 1$, which renders y = 0.0026. Here, $\xi_a = \hbar/\sqrt{2m_a g_a n}$ is the atomic healing length. (d) Parameters used in our numerical calculations. Our system is a 1D BEC with length L.

For $\omega_p(k) \in \mathbb{R}$, since $i\partial \hat{b}_p(\mathbf{k},t)/\partial t = \omega_p(k) \hat{b}_p(\mathbf{k},t)$, from Eq. (5), if $\omega_1(k) = c_r k + O(k^2)$, we have $k^2 \hat{b}_1(\mathbf{k},t) + (1/c_r^2) \partial^2 \hat{b}_1(\mathbf{k},t)/\partial t^2 = O(k^3)$, which is a wave equation for $\hat{b}_1(\mathbf{k},t)$ in the

small k limit, with the reacton propagation speed c_r . We have $c_r = (\xi_a g_a n/\hbar) \sqrt{B_2 - B_3/(4A_1)} = \sqrt{B_2 - B_3/(4A_1)} \sqrt{g_a n/(2m_a)}$, which leads to $c_r/c_s = \sqrt{\{B_2 - B_3/(4A_1)\}/2}$ shown in Fig. 2 (b).

Since our Hamiltonian in Eq. (5) is constant in time, from the Bogoliubov expansion in Eq. (S20), using the notation of Eq. (S31), the annihilation operator for reaction branch p can be decomposed as

We define a cutoff k_c and choose parameters \tilde{g}_{am} and $\tilde{\alpha}$ such that $\omega_1\left(k\right)\ll\omega_2\left(0\right)$ for $k< k_c$ implying that excitations of the second reacton branch can be neglected, and such that for $k>k_c$, $v_{11}\left(k\right)$ and $v_{12}\left(k\right)\to0$. Then in summations involving $v_{11}\left(k\right)$ or $v_{12}\left(k\right)$ over all k, the effect of the massive reacton branch is negligible. From now on, we set for concreteness $\tilde{g}_{am}=100$ and $\tilde{\alpha}=1$ where $\tilde{\omega}_1\left(k_c\right)=0.1\tilde{\omega}_2\left(0\right)=19.6$ with $k_c\xi_a=4.32$. Then the mean-field state is an "atom-rich" state as $y^2=6.5\times10^{-6}$. For these and $\varphi_a=0$ and $\alpha\cos\varphi_{am}=-|\alpha|$, the eigenvectors $\left[u_{p1}\left(k\right)\;u_{p2}\left(k\right)\;v_{p1}\left(k\right)\;v_{p2}\left(k\right)\right]^T$ are all real.




FIG. 3. Bogoliubov mode amplitudes in Eq. (6), u_{11} (Orange line), $-v_{11}$ (Black line), u_{12} (Red dashed), and $-v_{12}$ (Blue dashed) as a function of $k\xi_a$ at $\tilde{g}_{am}=100$ and $\tilde{\alpha}=1$. Inset: u_{12} (Red dashed) and $-v_{12}$ (Blue dashed) with $0< k\xi_a < 0.001$. As $k\to 0$, $u_{1p}/(-v_{1p})\to 1$, which implies that atomic (or molecular) creation- and annihilation operators contribute equally to \hat{b}_1 near k=0.

Fig. 3 shows that for $k < k_c$, \hat{b}_1 is more "atomic" in the sense that the coefficient of $\delta \hat{\Psi}_a$ is bigger than that of $\delta \hat{\Psi}_m$, i.e. also in the reacton excitations atoms

dominate over molecules. Also, $u_{1q}(k) \simeq -v_{1q}(k)$ for q=1,2, which means that \hat{b}_1 has approximate particle-hole symmetry near k=0 as for a single-component BEC.




FIG. 4. $\alpha\Xi_{13}(k)$ which determines reaction rates (see Eqs. (S97), (S98), (S100)) as a function of \tilde{g}_{am} and $\tilde{\alpha}$. Left figure is for $k=2\pi/L$, and right figure is for $k=20\pi/L$ with parameters in the table (d) of 2. y does not have physical values in the grey regions.

In the Supplement III, we show that creation and annihilation of pairs of reactons, $\hat{b}_{1}^{\dagger}(\mathbf{k},t)\,\hat{b}_{1}^{\dagger}(-\mathbf{k},t)$ and $\hat{b}_{1}(\mathbf{k},t)\,\hat{b}_{1}(-\mathbf{k},t)$ over any nonzero \mathbf{k} converts atoms to molecules and vice versa. This can be formalized in a reaction rate operator $\hat{R}_{2}(t)$ defined in Eq. (S97), which shows that $\alpha\Xi_{13}(k)$ determines the reaction rate, up to the expectation values of $\hat{b}_{1}^{\dagger}(\mathbf{k},t)\,\hat{b}_{1}^{\dagger}(-\mathbf{k},t)-h.c.$ that depend on the specific quantum state of the reactons. Ξ_{13} is defined in (S90). Fig. 4 shows that $\alpha\Xi_{13}(k)$ is symmetric in $\tilde{\alpha}$ and its absolute value increases as k increases. It also increases as one approaches the boundary of the grey regions where y does not have physical values.

Metrology with quantized chemical reactions

We now demonstrate the metrological usefulness of

ultracold chemical reactions for which small molecule concentrations can be detected [21]. To that end, we compare a lower bound of the classical Fisher information (CFI) based on molecule counting with the quantum Fisher information (QFI) for various small, time-dependent perturbations $\hat{V}(t)$ turned on at time t=0. As until t=0 our Hamiltonian is time-independent (see Eq. (5)), we use the interaction picture with state $|\Psi_I(t)\rangle$ and initial state $|\Psi_I(0)\rangle = |\text{vac}\rangle$ to calculate the response to $\hat{V}(t)$. Here, $|\text{vac}\rangle$ is the Bogoliubov vacuum, $\hat{b}_{1,I}(\boldsymbol{k},t\leq 0)|\text{vac}\rangle = 0$, and $\hat{b}_{1,I}(\boldsymbol{k},t)$ are the Bogoliubov operators in the interaction picture. Hence, before time-dependent perturbations are applied, the system has lowest energy up to $O\left(\delta\hat{\Psi}_j^3\right)$ (see Eq. (5)).

We calculate the QFI and a lower bound to the CFI derived in [40]; for details see the Supplement IV. The inverse of the QFI defines the smallest uncertainty with which a parameter can be estimated, optimized over all possible ("positive operator-valued measure", POVM) measurements and data analysis schemes with unbiased estimators. This so-called quantum Cramér-Rao bound [41, 42] can be saturated in the limit of a large number of measurements and hence constitutes an important fundamental benchmark for the sensitivity with which a parameter can be estimated that is in principle achievable once all technical noise has been eliminated and only noise inherent in the quantum state remains. While our scheme is general, we illustrate it at the hand of one example: the amplitude of a metric perturbation that arises e.g. from a gravitational wave on top of a flat Minkowski space-time background.

A metric perturbation $h_{\xi\xi}(\xi,\eta,\zeta,t)$ on top of a flat Minkowski spacetime, created by a gravitational wave propagating in ζ -direction, leads to a Newtonian tidal force in ξ direction on non-relativistic particles of mass m given by (see eq.(8.2) in [43]) $F_{\xi} = (m/2)\xi\ddot{h}_{\xi\xi}$, where h is in transverse traceless gauge, $\mathbf{r} = (\xi,\eta,\zeta)$ and time t are coordinates in the proper detector frame of a free-falling observer, and a dot signifies time-derivative. In the simplest mono-chromatic case, $h_{\xi\xi} = \tilde{h}_{\xi\xi}\sin(k_{\zeta}\zeta - \omega_{\text{GW}}t)$. The force derives from a potential $U = -(m/4)\xi^2\ddot{h}_{\xi\xi}$, which translates to an interaction hamiltonian between the GW and the BEC located at $\zeta = 0$ given in second quantization by $\hat{V}_S(t)$ with

$$-\frac{L^2 \omega_{\text{GW}}^2}{48} \tilde{h}_{\xi\xi} \sin(\omega_{\text{GW}} t) \sum_{l=a,m} m_l \sum_{\mathbf{k} \neq 0} \delta \hat{\psi}_l^{\dagger}(\mathbf{k}) \delta \hat{\psi}_l(\mathbf{k}), \quad (7)$$

where we assumed a 1D BEC aligned in ξ direction, and approximated $(1/L) \int_{-L/2}^{L/2} d\xi \, e^{i(k'_\xi - k_\xi)\xi} \xi^2 \simeq L^2 \delta_{k_\xi,k'_\xi}/12$, where L is the length of the quasi-1D BEC. The latter approximation means that the GW couples purely to mass density and scattering of reactons due to the spatial structure of the GW is neglected on the length-scale of the BEC. The parts linear in $\delta \hat{\psi}_l(\boldsymbol{r},t)$ vanish as we set our background mean-field to be homogeneous in space (i.e. it has only a $\boldsymbol{k}=0$ component).

The perturbation in Eq. (7) applied to the system with box trap potentials satisfies $V_m(t) = 2V_a(t)$ and hence, from Eqs. (S5) and (S6), the background mean field remains homogeneous in space. One can write $\hat{V}_S(t)$ as a "density perturbation" of the general form $\hat{V}_S(t) = V_{ex}f(t)\int d^3r \qquad \left\{\delta\hat{\psi}_a^{\dagger}(\mathbf{r})\,\delta\hat{\psi}_a(\mathbf{r}) + 2\delta\hat{\psi}_m^{\dagger}(\mathbf{r})\,\delta\hat{\psi}_m(\mathbf{r})\right\}$ with $V_{ex} = -L^2\omega_{\mathrm{GW}}^2\tilde{h}_{\xi\xi}m_a/48$ and $f(t) = \sin(\omega_{\mathrm{GW}}t)$. Throughout, we assume that the perturbations are small such that $V_{ex} \ll \hbar\omega_1(k)$ for $k \neq 0$.

A large class of sensing applications, including the one mentioned above, is covered by the following generic perturbation, bilinear in the lower reacton branch basis, which acts on the system from t=0:

$$\hat{V}_{S}(t) = V_{ex}f(t) \sum_{\mathbf{k} \neq 0} \mathbb{V}_{1}(k) \,\hat{b}_{1}^{\dagger}(\mathbf{k}) \,\hat{b}_{1}(\mathbf{k})
+ V_{ex}f(t) \sum_{\mathbf{k} \neq 0} \left\{ \mathbb{V}_{2}(k) \,\hat{b}_{1}^{\dagger}(\mathbf{k}) \,\hat{b}_{1}^{\dagger}(-\mathbf{k}) + h.c. \right\}, (8)$$

where V_{ex} , f(t), and $\mathbb{V}_1(k)$ are real. $V_{ex} > 0$ has units of energy and we define the dimensionless $\tilde{V}_{ex} \coloneqq V_{ex}/(g_a n)$. Also, for periodic perturbations with angular frequency ω_a , we set $\tilde{\omega}_a \coloneqq \hbar \omega_a/(g_a n)$. We assume $|f(t)| \le 1 \ \forall t$ and focus on a 1D system with parameters given in table (d) in Fig. 2 using values of a ⁸⁷Rb BEC experiment [44] and define $k_{n_1} \coloneqq 2\pi n_1/L$ where the summation over k becomes a summation over integers n_1 . We define the cutoff n_c such that $\tilde{\omega}_1(k_{n_c}) = 0.1\tilde{\omega}_2(0)$ in order not to excite any massive reactions, as this would complicate the dynamics substantially. Since $k_c \xi_a = 4.32$, the closest integer n_c is 110 where $k_{n_c} = 4.28$, which satisfies $v_{11}(k_{n_c})$ and $v_{12}(k_{n_c}) \to 0$, cf. left panel of Fig. 3.

We give the result for the QFI and the CFI based on molecule counting for a general perturbation (8) in Eqs. (S147) and (S151). In Fig. 5 we show the ratio of the lower bound $I_C(\tilde{t})$ of the CFI and the QFI $I_Q(\tilde{t})$ for 6 different temporal perturbation profiles for density perturbations when estimating $|\tilde{V}_{ex}|$. In the Supplement IV B, we show that our QFI calculation for $t \gg 1$ and the perturbation (7) is consistent with [14] when there are no BEC molecules in the system. While the functional form of the ratio $I_C(\tilde{t})/I_Q(\tilde{t})$ depends on the form of the signal, the most important message is that CFI and QFI are on the same order of magnitude. Counting molecules therefore constitutes a close-to-optimal measurement for homogeneous density perturbations. This is a central result of this paper that goes beyond previous proposals of sensors based on density perturbations in BECs [12–18] for which so far no practical measurement schemes with corresponding sensitivities were known.

Conclusion and outlook

In summary, we explored quantized chemical reactions in ultracold gases of atoms and molecules for their use in quantum metrology. Both the atom/molecule ratio in the mean-field ground state and the composition of the "reacton" quasiparticles, the quantized excitation of




FIG. 5. The lower bound of the CFI $(I_C(\tilde{t}))$ over QFI $(I_Q(\tilde{t}))$ for density perturbations as a function of \tilde{t} with perturbation profiles $f(t) = \sin(\omega_a t)$ for $\tilde{t} \geq 0$ (Red line), $f(t) = \cos(\omega_a t)$ for $\tilde{t} \geq 0$ (Blue line), $f(t) = \{1 - \cos(\omega_a t)\}/2$ for $\tilde{t} \geq 0$ (Yellow line), $f(t) = \{1 + \cos(\omega_a t)\}/2$ for $\tilde{t} \geq 0$ (Purple line), $f(t) = \theta(t)$ for $\tilde{t} \geq 0$ (Black line), and $f(t) = \delta(t)$ (Orange line).

the fields that describe the chemical reactions in space and time, can be widely tuned with the parameters of the system. We identified an atom-rich regime, where the mean-field dynamics is shut off, and the creation of molecules dominated by the response to an external perturbation. We showed that a measurement of the number of molecules in this regime is very close to reaching maximum possible sensitivity for perturbations that couple to the total density of atoms (including the molecules). Since single-molecule counting can be achieved with established spectroscopic techniques, our scheme offers an attractive alternative to proposed quantum metrological schemes that require the detection of single phonons in BECs [13, 45], which is an extremely challenging task experimentally [46, 47]. With spatially resolved molecule detection one might even be able to identify the modes in which the molecules are created and hence acquire additional information about an external perturbation of the system.

Numerous other avenues of quantum metrology based on ultracold chemistry can be explored, such as the exploration of unstable regions, or more complex reactions. Atomic analogues of superconducting transition-edge detectors [48] might be envisaged, and chemical chain reactions in the regime of ultracold quantum gases explored (see also [49] for the benefits of chaotic dynamics for metrology). Quantized reaction rates could also be studied on a self-consistent level [50], creating an avenue to many-body quantum chemical oscillations and their metrology beyond Bogoliubov theory.

From now on, we will set <math>\int d^{3}r \ |\psi_{j}(\mathbf{r},t)|^{2} = N_{j,c}(t) \text{ so that } \psi_{j}(\mathbf{r},t) \text{ is the mean-field value of the } \hat{\psi}_{j}(\mathbf{r},t).$ Then we have $\left\langle \hat{\Phi}_{j,c}^{\dagger}(t) \hat{\Phi}_{j,c}(t) \right\rangle = 1$ and for $N_{j,c}(t) \gg 1$, $\left[\hat{\Phi}_{j,c}(t), \hat{\Phi}_{j,c}^{\dagger}(t)\right] = 1/N_{j,c}(t) \to 0$. We will additionally substitute $\hat{\Phi}_{j,c}(t) \to 1$ for calculational convenience, which gives the usual non-number conserving approach $\hat{\psi}_{j}(\mathbf{r},t) = \psi_{j}(\mathbf{r},t) + \delta \hat{\psi}_{j}(\mathbf{r},t)$.

We normalize to atomic condensate units as follows: $\tilde{t} := g_a n t / \hbar$, $\tilde{g}_{am} := g_{am} / g_a$, $\tilde{g}_m := g_m / g_a$, $\tilde{\alpha} := \alpha \sqrt{2n} / (g_a n)$, $\tilde{\mu} := \mu / (g_a n)$, $\tilde{\epsilon} := \epsilon / (g_a n)$, $\xi_a := \hbar / \sqrt{2m_a g_a n}$ is the atomic healing length, and $\varphi_{am}(\mathbf{r}, t) := \varphi_m(\mathbf{r}, t) - 2\varphi_a(\mathbf{r}, t)$. When the system is in box traps $(V_a(\mathbf{r}, t) = V_m(\mathbf{r}, t) = 0)$ or $V_m(\mathbf{r}, t) = 2V_a(\mathbf{r}, t) = F_{tr}(t)$ where $F_{tr}(t)$ is some real function which is homogeneous in space, Eqs. (S5) and (S6) can have solutions where $x(\mathbf{r}, t)$, $y(\mathbf{r}, t)$, and $\varphi_{am}(\mathbf{r}, t)$ do not depend on space.

This leads to the following conclusion: Suppose we add a spatially homogeneous density perturbation at $t \geq 0$ to the system with atoms and molecules trapped in box potentials. Let $\psi_{j,0}(t)$ be the homogeneous mean-field of this system for t < 0 and $\psi_{j,1}(\mathbf{r},t)$ be the mean-field of the system for $t \geq 0$ (j = a, m). Then, from Eqs. (S5) and (S6), $\psi_{j,1}(\mathbf{r},t) = \psi_{j,0}(t) e^{-i\int_0^t dt_1 V_j(t_1)/\hbar}$. From now on, we will consider these homogeneous solutions whose mean-field Hamiltonian $H_0(t)$ is

Thus, by assuming $g_a > 0$, $H_0(t)$ is minimized when $\alpha \cos \varphi_{am}(t) = -|\alpha|$. Since $\alpha \cos \varphi_{am}(t) = -|\alpha|$ makes $\sin \varphi_{am} = 0$, which forces x(t) and y(t) to be constant according to Eqs. (S5), from now on, we will write x(t) as x and y(t) as y.

where V is the volume of the system. Now, let

Since we set $\cos \varphi_{am} = -\operatorname{sign}(\alpha)$, $\sin \varphi_{am} = 0$ and $\hat{R}(t) = \hat{R}_2(t) + O\left(\delta \hat{\Psi}_j^3\right)$. We also imposed $\varphi_a = 0$ below Eq. (S18), which leads to

Thus, if $x = \sqrt{1 - 2y^2}$, y, α , U(k), and V(k) are all real, from Eqs. (S92), (S93), (S94), (S95), and (S96), $\Xi_{pp}(k) = 0$ and $\Xi_{pq}(k) \in \mathbb{R}$ for $p \neq q$.

For low temperatures, $0 \le \hbar\omega_1(k)$, $k_BT \ll \hbar\omega_2(k)$, the massive reactors are frozen out and the system is to good approximation in Bogoliubov mode 1 (states purely created by $\hat{b}_1^{\dagger}(\mathbf{k},t)$). $\hat{R}_2(t)$ in Eq. (S91) then simplifies as

We now present examples of the vacuum expectation values of $\hat{R}(t)$ for two quantum-mechanical reactor states.

(a) We define the squeezed coherent state as $|\beta_1(\mathbf{k}_1,t),\zeta(\mathbf{k}_1)\rangle := \hat{D}(\beta_1(\mathbf{k}_1,t))\hat{D}(\beta_1(-\mathbf{k}_1,t))\hat{S}(\zeta(\mathbf{k}_1))|\text{vac}\rangle$, where the displacement and squeezing operators read $\hat{D}(\beta_1(\mathbf{k},t)) := e^{\beta_1(\mathbf{k},t)\hat{b}_1^{\dagger}(\mathbf{k},t)-\beta_1^*(\mathbf{k},t)\hat{b}_1(\mathbf{k},t)}, \hat{S}(\zeta(\mathbf{k})) := e^{\zeta(\mathbf{k})\hat{b}_1^{\dagger}(\mathbf{k},t)\hat{b}_1^{\dagger}(-\mathbf{k},t)-\zeta^*(\mathbf{k})\hat{b}_1(\mathbf{k},t)\hat{b}_1(-\mathbf{k},t)}$, respectively. Here, $|\text{vac}\rangle$ represents the reaction quasi-particle vacuum at initial time t=0 where $\hat{b}_p(\mathbf{k},0)|\text{vac}\rangle = 0$. Since $\hat{b}_p(\mathbf{k},t) = e^{-i\omega_p(k)t}\hat{b}_p(\mathbf{k},0)$ from our Hamiltonian in Eq. (5), we get $\hat{b}_p(\mathbf{k},t)|\text{vac}\rangle = 0$ for all t. With $|\text{vac}\rangle$, we obtain the reaction rate (to $O(\delta\hat{\Psi}_j^3)$)

$$\langle \beta_{1}\left(\boldsymbol{k}_{1},t\right),\zeta\left(\boldsymbol{k}_{1}\right)|\hat{R}\left(t\right)|\beta_{1}\left(\boldsymbol{k}_{1},t\right),\zeta\left(\boldsymbol{k}_{1}\right)\rangle_{\mathrm{squeezed\ state}}=2\tilde{\alpha}\Xi_{13}\left(k_{1}\right)\left[\begin{array}{c}2\mathrm{Im}\left\{\beta_{1}^{*}\left(\boldsymbol{k}_{1},t\right)\beta_{1}^{*}\left(-\boldsymbol{k}_{1},t\right)\right\}\\+\mathrm{sinh}\left(2\left|\zeta\left(\boldsymbol{k}_{1}\right)\right|\right)\mathrm{Im}\left\{\zeta^{*}\left(\boldsymbol{k}_{1}\right)/\left|\zeta\left(\boldsymbol{k}_{1}\right)\right|\right\}\end{array}\right].$$

The quantum mechanical nature of this average rate is manifest in the third line, containing the squeezing parameter $\zeta(\mathbf{k}_1)$.

(b) A reacton pair state may be defined as

where $\theta(\mathbf{k}_1)$ is the phase of the excited pair relative to the vacuum. Then the reaction rate turns out to be

displaying the factor $\propto \sin \theta (\mathbf{k}_1)$, which is due to quantum interference.

IV. SMALL PERTURBATIONS AND HAMILTONIAN BILINEARIZATION

In the Schrödinger picture, let the time dependent bilinear Hamiltonian be $\hat{H}_{S}\left(t\right)$ where

$$\hat{V}_{S}(t) = V_{ex}f(t)\sum_{\boldsymbol{k}\neq 0} \left\{ \mathbb{V}_{1}(k)\,\hat{b}_{1}^{\dagger}(\boldsymbol{k})\,\hat{b}_{1}(\boldsymbol{k}) + \mathbb{V}_{2}(k)\,\hat{b}_{1}^{\dagger}(\boldsymbol{k})\,\hat{b}_{1}^{\dagger}(-\boldsymbol{k}) + \mathbb{V}_{2}^{*}(k)\,\hat{b}_{1}(\boldsymbol{k})\,\hat{b}_{1}(-\boldsymbol{k}) \right\}$$
(S102)

a small perturbation. Here, V_{ex} , f(t), and $\mathbb{V}_1(k)$ are real and f(t) = 0 for t < 0 so that our Hamiltonian is a time-independent operator at t < 0. We assume a small perturbation, i.e. $0 \le V_{ex} \ll \hbar\omega_1(k)$ for $k \ne 0$, and also assume that the Bogoliubov excitation energies $\omega_1(k)$ and $\omega_2(k)$ are real and positive so that the system is in a stable state. For simplicity, let $\omega_1(k) \ll \omega_2(k)$ so that one may neglect effects of $\hat{b}_2(k)$.

To solve this perturbation problem with time dependent perturbation $\hat{V}_S(t)$, we use the interaction picture instead of the Heisenberg picture. Let $\hat{H}_{0,S} := \hbar \sum_{\mathbf{k} \neq 0} \omega_1(k) \, \hat{b}_1^{\dagger}(\mathbf{k}) \, \hat{b}_1(\mathbf{k})$. By denoting states in Schrödinger picture as $|\psi_S(t)\rangle$,

states in interaction picture as $|\psi_I(t)\rangle := \hat{U}_0(t) |\psi_S(t)\rangle$ where $\hat{U}_0(t) := \exp\left(i\hat{H}_{0,S}t/\hbar\right)$, and the time evolution operator as $\hat{U}_I(t)$ where $|\psi_I(t)\rangle = \hat{U}_I(t) |\psi_I(0)\rangle$, $i\hbar\partial\hat{U}_I(t)/\partial t = \hat{V}_I(t)\hat{U}_I(t)$ where $\hat{V}_I(t) := \hat{U}_0(t)\hat{V}_S(t)\hat{U}_0^{\dagger}(t)$, we get

With our $\hat{H}_{0,S}$, $\hat{U}_{0}\left(t\right)\hat{b}_{1}\left(\mathbf{k}\right)\hat{U}_{0}^{\dagger}\left(t\right)=e^{-i\omega_{1}\left(k\right)t}\hat{b}_{1}\left(\mathbf{k}\right)$ and hence the time evolution operator $\hat{U}_{I}\left(\tilde{t}\right)$ is

$$\delta\hat{\psi}_{a}\left(\boldsymbol{r},t\right) = e^{-i\int^{t}dt_{1} V_{a}\left(\boldsymbol{r},t_{1}\right)/\hbar}e^{-i\mu t/\hbar}\sum_{\boldsymbol{k}\neq0}\mathcal{B}\left(\boldsymbol{r},\boldsymbol{k}\right)\left\{u_{11}\left(k\right)\hat{b}_{1}\left(\boldsymbol{k},t\right) + v_{11}^{*}\left(k\right)\hat{b}_{1}^{\dagger}\left(-\boldsymbol{k},t\right)\right\},\quad\mathcal{B}\left(\boldsymbol{r},\boldsymbol{k}\right) = \frac{1}{\sqrt{V}}e^{i\boldsymbol{k}\cdot\boldsymbol{r}},\quad(S131)$$

where the $\mathcal{B}(\mathbf{r}, \mathbf{k})$ span an orthonormal basis of the single-particle Hilbert space that satisfies $\int d^3r \, \mathcal{B}^*(\mathbf{r}, \mathbf{k}_1) \, \mathcal{B}(\mathbf{r}, \mathbf{k}_2) = \delta_{\mathbf{k}_1, \mathbf{k}_2}$. When $f(t) = \sin(\omega_a t)$, from Eqs. (S125), (S126), and (S127), we get

where $\omega_1(k_r) = \omega_a/2$ (Remember that we define $\tilde{\omega}_1(k) := \hbar \omega_1(k)/(g_a n)$, $\tilde{t} := g_a n t/\hbar$, and $\tilde{V}_{ex} := V_{ex}/(g_a n)$ in the main text). For $V_{ex} = (m_a \mathcal{G}/2) (L^2/12)$ (our approximation of the density perturbation due to gravitational wave in Eq. (7)), we get

For $\hat{V}_S(t) = \sin(\omega_a t) \int d^3r \ (m_a \mathcal{G} r_1^2/2) \hat{\psi}_a^{\dagger}(\mathbf{r}) \hat{\psi}_a(\mathbf{r})$ where $\mathbf{r} = \sum_{j=1}^3 r_j \mathbf{e}_j$ (\mathbf{e}_j are Cartesian basis vectors), [14] independently calculated $I_Q(\mathcal{G}, t)$ for a quasi-1D system with $-L/2 < r_1 < L/2$ and $t \gg 1$ by taking $\mathbf{B}(\mathbf{r}, \mathbf{k}) = \sqrt{2/(AL)} \cos\{k_{n_1}(r_1 + L/2)\}$ with $k_{n_1} = n_1 \pi/L$ (n_1 are positive integers). Their results for mode k_r where $\omega_1(k_r) = \omega_a/2$ can be written as

$$\rightarrow \left| 2 \left\{ \frac{m_{a}}{2} \int d^{3}r \, r_{1}^{2} \mathcal{B}^{*}\left(\boldsymbol{r},\boldsymbol{k}_{r}\right) \mathcal{B}\left(\boldsymbol{r},\boldsymbol{k}_{r}\right) \right\} \frac{t}{\hbar} u_{11}\left(k_{r}\right) v_{11}\left(k_{r}\right) \right|^{2}. \tag{S134}$$

One can see that Eq. (S134) becomes Eq. (S133) if one takes $\mathcal{B}(\mathbf{r}, \mathbf{k}) = \left(1/\sqrt{V}\right)e^{i\mathbf{k}\cdot\mathbf{r}}$ as we do. Since BEC atoms are confined in $-L/2 < r_1 < L/2$, $\delta\hat{\psi}_a(\mathbf{r}, t)$ should be zero at $r_1 = \pm L/2$ and our choice of $\mathcal{B}(\mathbf{r}, \mathbf{k})$ can satisfy this condition by taking $\mathbf{k} \to (2\pi/L) \mathbf{e}_1$ which make $\mathcal{B}((-L/2, r_2, r_3), \mathbf{k}) = \mathcal{B}((L/2, r_2, r_3), \mathbf{k})$.

V. SYMPLECTIC FORMALISM AND FISHER INFORMATION

Suppose that the Hamiltonian $\hat{H}_S(t)$ in Schrödinger picture is given as $\hat{H}_S(t) = \sum_{\mathbf{k} \neq 0} \hat{H}_c(\mathbf{k}, t)$. The time evolution operator $\hat{U}_S(t)$ in the Schrödinger picture satisfies $i\hbar \frac{\partial \hat{U}_S(t)}{\partial t} = \hat{H}_S(t) \hat{U}_S(t)$.

From Appendix A of [55], let $\hat{U}_S(t) = \hat{U}_1(t) \hat{U}_2(t) \hat{U}_3(t)$ with $\hat{U}_j(t) = \exp \left\{ -i \sum_{\boldsymbol{k} \neq 0} F_j(k,t) \hat{G}_j(\boldsymbol{k}) \right\}$ for j = 1, 2, 3 where $k \coloneqq |\boldsymbol{k}|$. Then we get

Let $n_b(\mathbf{k})$ be the number of reactons with momentum \mathbf{k} . From now on, we will denote the state with $n_b(\mathbf{k}_j) = n_b(-\mathbf{k}_j)$ for all j which satisfy $|\mathbf{k}_j| \le |\mathbf{k}_c|$ as $|n_b(\mathbf{k}_1), n_b(\mathbf{k}_2), \dots, n_b(\mathbf{k}_c)\rangle$ where \mathbf{k}_c is the cutoff. By defining

$$= n_{b}(\mathbf{k}_{j}) | n_{b}(\mathbf{k}_{1}), \dots, n_{b}(\mathbf{k}_{j}) - 1, \dots, n_{b}(\mathbf{k}_{c}) \rangle, \qquad (S138)$$

and

$$= \frac{1}{2} \left\{ \underbrace{n_{b}(\mathbf{k}_{j})}_{\text{with } \hat{b}_{1}^{\dagger}(\mathbf{k}_{j}) \hat{b}_{1}(\mathbf{k}_{j})} + \underbrace{n_{b}(\mathbf{k}_{j}) + 1}_{\text{with } \hat{b}_{1}(-\mathbf{k}_{j}) \hat{b}_{1}^{\dagger}(-\mathbf{k}_{j})} \right\} |n_{b}(\mathbf{k}_{1}), \dots, n_{b}(\mathbf{k}_{j}), \dots, n_{b}(\mathbf{k}_{c})\rangle$$

$$= \left\{ n_{b}(\mathbf{k}_{j}) + \frac{1}{2} \right\} |n_{b}(\mathbf{k}_{1}), \dots, n_{b}(\mathbf{k}_{j}), \dots, n_{b}(\mathbf{k}_{c})\rangle. \tag{S139}$$

Additionally, we will assume that $\mathbb{V}_2(k) \in \mathbb{R}$ like Eq. (S129). By choosing $\hat{G}_1(\mathbf{k}) = \hat{K}_z(\mathbf{k})$, $\hat{G}_2(\mathbf{k}) = \hat{K}_x(\mathbf{k})$, and $\hat{G}_3(\mathbf{k}) = \hat{K}_y(\mathbf{k})$, we get

$$I_{Q,\text{exact}}\left(\tilde{V}_{ex},t\right) = \frac{1}{4} \sum_{k \neq 0} \text{Tr}\left[\left\{\frac{\partial \Gamma\left(k,t\right)}{\partial \tilde{V}_{ex}} \Gamma^{-1}\left(k,t\right)\right\}^{2}\right] \quad \text{where } \Gamma\left(k,t\right) = \Lambda\left(k,t\right) \Lambda^{T}\left(k,t\right). \tag{S147}$$

+\mathbb{M}_{3}(k) \left[\sin\left\{2F_{1}(k,t)\right\} \sinh\left\{2F_{2}(k,t)\right\} \sinh\left\{2F_{3}(k,\tilde{t})\right\} \\
+\cos\left\{2F_{1}(k,t)\right\} \cosh\left\{2F_{3}(k,t)\right\} + i\sin\left\{2F_{1}(k,t)\right\} \cosh\left\{2F_{2}(k,t)\right\} \right], \quad (S148)$$

$$\mathbb{B}_{3}(k,t) := \mathbb{M}_{2}(k) \cosh\left\{2F_{2}(k,\tilde{t})\right\} \cosh\left\{2F_{3}(k,\tilde{t})\right\} \\ -2\mathbb{M}_{3}(k) \left[\sin\left\{2F_{1}(k,t)\right\} \sinh\left\{2F_{2}(k,t)\right\} \cosh\left\{2F_{3}(k,\tilde{t})\right\} + \cos\left\{2F_{1}(k,t)\right\} \sinh\left\{2F_{3}(k,t)\right\}\right]. \tag{S149}$$
