# COUNTING CLIQUES IN A RANDOM GRAPH

#### Abstract

We show that the expected number of cliques in the Erdős-Rényi random graph $G(n, p)$ is $n^{\frac{1}{-2 \log p}(\log n-2 \log \log n+O(1))}$.


## 1. Introduction

In this note we estimate the expected number of cliques in a random graph. We start with some definitions. Let $n$ be a positive integer, and let $0<p<1$ be a real number. Let $G(n, p)$ denote the Erdős-Rényi random graph, that is, it has $n$ vertices and each of the $\binom{n}{2}$ possible edges occurs independently with probability $p$. A clique is a maximal complete subgraph of a graph. Let $X_{n, p}$ be a random variable counting cliques in $G(n, p)$. Our main result is the following.

Theorem 1.

$$
\mathbb{E}\left[X_{n, p}\right]=n^{\frac{1}{-2 \log p}(\log n-2 \log \log n+O(1))} .
$$

Using Markov's inequality Theorem 1 has the following immediate consequence.

## Corollary 1.

$$
\lim _{n \rightarrow \infty} \mathbb{P}\left[X_{n, p}<n^{\frac{\log n}{-2 \log p}}\right]=1
$$

A $k$-clique is a clique with $k$ vertices. The expected number of $k$-cliques in $G(n, p)$ is

$$
F_{n}(k):=\binom{n}{k} p^{\binom{k}{2}}\left(1-p^{k}\right)^{n-k},
$$

and so $\mathbb{E}\left[X_{n, p}\right]=\sum_{k=1}^{n} F_{n}(k)$. What is the most popular size $k$ which maximizes $F_{n}(k)$ ? If this is given by $k=\tilde{k}$, then $F_{n}(\tilde{k}) \leq \mathbb{E}\left[X_{n, p}\right] \leq n F_{n}(\tilde{k})$. We show that $\tilde{k}$ is around $\frac{\log n}{-\log p}$, and $F_{n}(\tilde{k})=n^{\frac{1}{-2 \log p}}(\log n-2 \log \log n+O(1))$.

Cliques (or independent sets) are one of the main objects in graph theory. Moon and Moser [4] obtained the maximum number of cliques in a graph. Bollobás and Erdős [1] studied the maximum size of cliques, and the number of different sizes of cliques in $G(n, p)$. Our result is motivated by a recent result due to the first author [6] concerning the number of maximal complete bipartite subgraphs of a random bipartite graph, which comes from a problem of counting formal concepts of random formal contexts in the theory of formal concept analysis originated by Wille [7]. See also [2, 3] for some application related to the number of cliques in $G(n, p)$.

The problem counting cliques in $G(n, p)$ naturally extends to the hypergraph setting. Let $G^{(r)}(n, p)$ denote the random $r$-uniform hypergraph with $n$ vertices where each of the $\binom{n}{r}$ possible hyperedge occurs independently with probability $p$. In this case a clique is a maximal complete subhypergraph. Let $X_{n, p}^{(r)}$ be a random variable counting cliques in $G^{(r)}(n, p)$. Then we have

$$
\begin{equation*}
\mathbb{E}\left[X_{n, p}^{(r)}\right]=\sum_{k=1}^{n}\binom{n}{k} p^{\binom{k}{r}}\left(1-p^{\binom{k}{r-1}}\right)^{n-k} . \tag{1}
\end{equation*}
$$

## Conjecture 1.

$$
\mathbb{E}\left[X_{n, p}^{(r)}\right]=\exp \left(\left(\frac{\log n}{-\log p}\right)^{\frac{1}{r-1}}\left(\left(1-\frac{1}{r!}\right) \log n-\frac{1}{r-1} \log \log n+O(1)\right)\right)
$$

By a routine computation of the term for $k=\left\lfloor\frac{\log n}{-\log p}\right\rfloor$ in (1) one can verify that the right hand side of the conjecture is indeed a lower bound for $\mathbb{E}\left[X_{n, p}^{(r)}\right]$. Theorem 1 shows that the conjecture is true for $r=2$.

## 2. Proof

Let us define

$$
\begin{equation*}
f_{n}(x):=\log F_{n}(x)=\log \binom{n}{x}+\binom{x}{2} \log p+(n-x) \log \left(1-p^{x}\right), \tag{2}
\end{equation*}
$$

and we will show that

$$
\max _{1 \leq k \leq n} f_{n}(k)=\frac{\log n}{-2 \log p}(\log n-2 \log \log n+O(1))
$$

### 2.1. Lower bound.

Lemma 1. Let $x=\frac{\log n}{-\log p}+O(1)$. Then $f_{n}(x)=\frac{\log n}{-2 \log p}(\log n-2 \log \log n+O(1))$.
Proof. Let $c=\frac{1}{-\log p}$. Using Stirling's formula we have

$$
\binom{n}{x}=(1+o(1)) \sqrt{\frac{n}{2 \pi x(n-x)}} \frac{n^{n}}{x^{x}(n-x)^{n-x}}
$$

By the Taylor expansion we get $\log \left(1-\frac{x}{n}\right)=-\frac{c \log n}{n}+O\left(\frac{1}{n}\right)$. Thus it follows that

$$
\begin{aligned}
\log \binom{n}{x}= & \frac{1}{2}(\log n-\log 2 \pi-\log x-\log (n-x)) \\
& \quad+n \log n-x \log x-(n-x) \log (n-x)+o(1) \\
= & x \log n-x \log x+O(\log n) \\
= & c(\log n)^{2}-c \log n \log \log n+O(\log n) .
\end{aligned}
$$

We also have $(n-x) \log \left(1-p^{x}\right)=-1+O\left(\frac{\log n}{n}\right)$. Finally we can rewrite (2) to obtain

$$
\begin{aligned}
f_{n}(x) & =c(\log n)^{2}-c \log n \log \log n+\frac{1}{2}(c \log n)^{2} \log p+O(\log n) \\
& =\frac{\log n}{-2 \log p}(\log n-2 \log \log n+O(1)),
\end{aligned}
$$

as needed.
2.2. Upper bound. To give an upper bound for $f_{n}(x)$ from (2) we use $\binom{n}{x} \leq \frac{n^{n}}{x^{x}(n-x)^{n-x}}$, or equivalently, $\log \binom{n}{x} \leq x \log n-x \log x-(n-x) \log \left(1-\frac{x}{n}\right)$ for $0<x<n$. Then we have $f_{n}(x) \leq g_{n}(x)$, where

$$
g_{n}(x):=x \log n-x \log x-(n-x) \log \left(1-\frac{x}{n}\right)+\frac{x(x-1)}{2} \log p .
$$

Lemma 2. For $1 \leq x \leq n-1$ we have $g_{n}(x) \leq \frac{\log n}{-2 \log p}(\log n-2 \log \log n+O(1))$.
We distinguish the cases $x \geq \frac{\log n}{-\log p}$ and $x<\frac{\log n}{-\log p}$.
Claim 1. Lemma 2 is true for $x \geq \frac{\log n}{-\log p}$.
Proof. Let $a_{n}(x):=x \log n+\frac{x(x-1)}{2} \log p$. Since $a_{n}^{\prime \prime}(x)=\log p<0$ it follows that $a_{n}^{\prime}(x)$ is decreasing in $x$, and if $a_{n}^{\prime}(x)=0$ then $x=\frac{\log n}{-\log p}+\frac{1}{2}$. Thus

$$
a_{n}(x) \leq a_{n}\left(\frac{\log n}{-\log p}+\frac{1}{2}\right)=\frac{(2 \log n-\log p)^{2}}{-8 \log p}=\frac{(\log n)^{2}}{-2 \log p}+O(\log n) .
$$

Next let $b_{n}(x):=-x \log x-(n-x) \log \left(1-\frac{x}{n}\right)$. Since $b_{n}^{\prime}(x)=-\log x+\log \left(1-\frac{x}{n}\right)<0$ it follows that $b_{n}(x)$ is decreasing in $x$, and

$$
\begin{aligned}
b_{n}(x) & \leq b_{n}\left(\frac{\log n}{-\log p}\right) \\
& =\frac{\log n}{-\log p}\left(-\log \log n+\log (-\log p)+\log \left(1+\frac{\log n}{n \log p}\right)\right)-n \log \left(1+\frac{\log n}{n \log p}\right) \\
& =\frac{\log n}{-\log p}(-\log \log n+O(1)) .
\end{aligned}
$$

Then the result follows from $g_{n}(x)=a_{n}(x)+b_{n}(x)$.
Claim 2. Lemma 2 is true for $x<\frac{\log n}{-\log p}$.
Proof. Let

$$
h_{n}(x):=x \log n-x \log x+\frac{x(x-1)}{2} \log p .
$$

Then we have $g_{n}(x)=h_{n}(x)+O(\log n)$ because $\left|(n-x) \log \left(1-\frac{x}{n}\right)\right| \leq\left|n \log \left(1-\frac{x}{n}\right)\right|=$ $O(\log n)$ for $x<\frac{\log n}{-\log p}$. To estimate $h_{n}(x)$ we have

$$
h_{n}^{\prime}(x)=\log n-\log x-1+x \log p-\frac{1}{2} \log p
$$

and

$$
h_{n}^{\prime \prime}(x)=-\frac{1}{x}+\log p<0 .
$$

So $h_{n}^{\prime}(x)$ is decreasing in $x$. By solving $h_{n}^{\prime}(x)=0$ we get

$$
x=\frac{W\left(\frac{-n \log p}{e \sqrt{p}}\right)}{-\log p}=\frac{1}{-\log p}(\log n-\log \log n+O(1))=: \tilde{x},
$$

where $W$ is the Lambert $W$ function [5]. Thus $h_{n}(x)$ is maximized at $x=\tilde{x}$ and the corresponding maximum value is

$$
h_{n}(\tilde{x})=\frac{\log n}{-2 \log p}(\log n-2 \log \log n+O(1)),
$$

which gives the desired upper bound for $g_{n}(x)$.

### 2.3. Proof of Theorem 1.

Proof. By Lemmas 1 and 2 we have

$$
\tilde{f}_{n}:=\max _{1 \leq k \leq n} f_{n}(k)=\frac{\log n}{-2 \log p}(\log n-2 \log \log n+O(1))
$$

and

$$
\mathbb{E}\left[X_{n, p}\right]=\exp \left(\tilde{f}_{n}+O(\log n)\right)=n^{\frac{1}{-2 \log p}(\log n-2 \log \log n+O(1))} .
$$
