# Finite groups with some bounded codegrees

#### Abstract

For a character $\chi$ of a finite group $G$, the number $\operatorname{cod}(\chi):=|G: \operatorname{ker}(\chi)| / \chi(1)$ is called the codegree of $\chi$. In this paper, we give a solvability criterion for a finite group $G$ depending on the minimum of the ratio $\chi(1)^{2} / \operatorname{cod}(\chi)$, when $\chi$ varies among the irreducible characters of $G$.


Key words. Finite group, codegree, degree, simple group.

## 1 Introduction

Throughout all groups are finite and $p$ is a prime number. Let $G$ be a group. We denote by $\operatorname{Irr}(G)$ the set of irreducible characters of $G$; and use $\operatorname{cd}(G)$ to denote the set of all irreducible character degrees of $G$. Let $\chi$ be a character of $G$. Qian, et al. 10 called the positive integer $\operatorname{cod}(\chi):=|G: \operatorname{ker}(\chi)| / \chi(1)$ the codegree of the character $\chi$ and studied the connection between the structure of a group and the codegrees of its irreducible characters (see the details in [6], [11], [9]). In these papers, they studied the groups through considering the prime divisors of the codegrees of its irreducible characters. In [13], Yang et al. obtained that the group $G$ is solvable if $\operatorname{cod}(\chi) \leq p_{\chi} \cdot \chi(1)$ for each nonlinear irreducible character $\chi$ of a group $G$, where $p_{\chi}$ is the largest prime divisor of $|G: \operatorname{ker}(\chi)|$. Notice that the codegree is larger than its degree for any nonprincipal irreducible character of $G$ (for any nonprincipal irreducible character $\chi$ of $G, \chi \in \operatorname{Irr}(G / \operatorname{ker}(\chi))$, so that $|G / \operatorname{ker}(\chi)|>\chi(1)^{2}$ since $G / \operatorname{ker}(\chi)>1)$. So, it is natural to ask that what positive real number $k$ such that

$$
\begin{equation*}
k \cdot \operatorname{cod}(\chi) \leq \chi(1)^{2} \tag{*}
\end{equation*}
$$

for all nonlinear irreducible characters $\chi$ of $G$ guarantees the solvability of $G$. In the next theorem, we give a sharp lower bound of $k$.

Theorem A. Let $G$ be a finite group with $k \cdot \operatorname{cod}(\chi) \leq \chi(1)^{2}$ for every nonlinear irreducible character $\chi$ of $G$. If $k>a=\frac{2^{9} \cdot 3^{2} \cdot 19^{2}}{5 \cdot 7^{3} \cdot 11 \cdot 31}$, then $G$ is solvable. The real number $a$ is best possible.

[^0]The positive real number $a$ in the above theorem is best possible. For instance, let $G \cong O^{\prime} N$, and let $\theta \in \operatorname{Irr}(G)$ be of minimal degree $10944\left(=2^{6} \cdot 3^{2} \cdot 19\right)$, we get

$$
a \cdot|G|=2^{18} \cdot 3^{6} \cdot 19^{3}=\theta(1)^{3} .
$$

It forces $a \cdot|G| \leq \theta(1)^{3}$ for every nonlinear irreducible character $\theta$ of a nonabelian simple group $G$.

More generally, given a positive integer $s$, one could ask what positive real number $k$ such that

$$
k \cdot \operatorname{cod}(\chi) \leq \chi(1)^{s}
$$

for all nonlinear irreducible characters $\chi$ of $G$ guarantees the solvability of $G$.

## 2 Proof

At first, we gather some lemmas before we actually prove the main theorem.
Lemma 2.1. Suppose that $N$ is a minimal normal nonabelian subgroup of a group $G$. Then there exists an irreducible character $\theta$ of $N$ such that $\theta$ is extendible to $G$ with $\theta(1) \geq 5$.

Proof. See [7, Theorem 1.1].
We also need the following result regarding the characters of simple groups of Lie type.
Lemma 2.2. Let $S$ be a simple group of Lie type in characteristic $p$ defined over a field of size $q$. Assume that $S \nexists A_{1}(q),{ }^{2} F_{4}(2)^{\prime}$. Then there exist two irreducible characters $\theta_{i}$, $i=1,2$, of $S$ such that both $\theta_{i}$ extend to $\operatorname{Aut}(S)$ with $1<\theta_{1}(1)<\theta_{2}(1)$ and $\theta_{2}(1)=|S|_{p}$.

Proof. See [12, Lemma 2.4].
Our proof will be based on the classification of finite simple groups. The main point of the classification is that if $S$ is a nonabelian simple group, then $S$ is either a simple group of Lie type, an alternating group of degree at least 5 , one of 26 sporadic simple groups, or the Tits group. Often the Tits group, which denoted by ${ }^{2} F_{4}(2)^{\prime}$, is lumped in the groups of Lie type. Since the Tits group is in the Atlas [4], here we will consider this simple group separately.

For the simple groups of Lie type, there is a particular character called Steinberg character. If $S$ is a simple group of Lie type with defining characteristic $p$ and $\theta$ is the Steinberg character of $S$, then $\theta(1)=|S|_{p}$. By Lemma 2.1, if $G$ has a normal subgroup $S$ such that $S$ is isomorphic to a finite simple group of Lie type, then the Steinberg character of $S$ extends to $G$. Actually, the character $\theta_{2}$ in Lemma 2.2 is the Steinberg character (see for instance [8, Proposition 3.1]).

For the alternating groups $A_{n}$, where $n \geq 5$, the automorphism group of $A_{n}$ is $S_{n}$ except $n=6$. In [2, Theorem 3], it is proved that $A_{n}$, where $n \geq 6$, has a character of degree $\frac{n(n-3)}{2}$ which is extendible to $\operatorname{Aut}\left(A_{n}\right)$.

For the sporadic simple groups, irreducible character degrees are available in the Atlas [4]. In Table 2, we list some character degrees of sporadic simple groups which will be relevant to our problems.

Lemma 2.3. Let $S$ be a simple group and $k>a=\frac{2^{9} \cdot 3^{2} \cdot 19^{2}}{5 \cdot 77^{3} \cdot 11 \cdot 31}$. If $S$ is not isomorphic to one of the groups in $\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right), F i_{22}\right\}$, then $S$ has some nontrivial irreducible character $\theta$ that is extendible to $\operatorname{Aut}(S)$ and such that $k \cdot|S|>\theta(1)^{3}$.

For a simple group of Lie type $S$, we know from [1, Lemma 2.6] that $|S|<\theta(1)^{3}$ for the Steinberg character $\theta$ (which is actually the $\theta_{2}$ in Lemma 2.2). By Lemma 2.2, it is natural to check whether the character $\theta_{1}$ of $S$ satisfies $k \cdot|S|>\theta_{1}(1)^{3}$ or not. Based on the proof of [12, Lemma 2.4], Table 1 lists $\theta_{1}(1)$ for every simple group of Lie type in Lemma 2.3.

Proof of Lemma 2.3 Observe that $k>a=\frac{2^{9} \cdot 3^{2} \cdot 19^{2}}{5 \cdot 7^{3} \cdot 11 \cdot 31}>\frac{5}{2}$.
Assume that $S$ is an alternating group $A_{n}$, where $n \geq 5$. By [2, Theorem 3], $S$ has some irreducible character $\theta$ of degree $\frac{n(n-3)}{2}$ that extends to $\operatorname{Aut}\left(A_{n}\right)$. Furthermore, we have

$$
\frac{k \cdot\left|A_{n}\right|}{\theta(1)^{3}}=\frac{4 k \cdot(n-1)(n-2) \cdot(n-4)!}{n^{2}(n-3)^{2}} .
$$

Note that $(n-1)(n-2)>n(n-3)$. If $n \geq 6$, then $4 k \cdot(n-4)!>n(n-3)$ and hence $k \cdot\left|A_{n}\right|>\theta(1)^{3}$. If $n=5, A_{5}$ has an irreducible character $\theta$ of degree 4 that is extendible to $\operatorname{Aut}\left(A_{5}\right)$, and we have $k \cdot\left|A_{5}\right|>2^{3} \cdot 3 \cdot 5>4^{3}=\theta(1)^{3}$, and we are done for the alternating groups $A_{n}$ of degree at least 5 .

Assume that $S$ is a sporadic simple group other than $F i_{22}$. By [2, Theorem 4], there exists some irreducible character $\theta \in \operatorname{Irr}(S)$ of degree as in Table 2 that is extendible to $\operatorname{Aut}(S)$. Also, it's easy to check $k \cdot|S|>\theta(1)^{3}$, we are also done for the sporadic simple groups but other than $F i_{22}$.

Assume that $S \cong{ }^{2} F_{4}(2)^{\prime}$, by the Atlas [4], $S$ has an irreducible character $\theta$ of degree 27 that is extendible to $\operatorname{Aut}(S)$. Obviously, we also have $k \cdot|S|=k \cdot 2^{11} \cdot 3^{3} \cdot 5^{2} \cdot 13>27^{3}=\theta(1)^{3}$.

Assume that $S$ is a simple group of Lie type and $S \notin\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right)\right\}$. Take $\theta \in \operatorname{Irr}(S)$ as the irreducible character $\theta_{1}$ in Lemma [2.2, we have that $\theta$ is extendible to $\operatorname{Aut}(S)$. Next we will check the stronger conclusion that $|S|>\theta(1)^{3}$ and hence the result follows immediately.

If $S \cong A_{n}(q)$, where $n \geq 2$, then

$$
\begin{aligned}
\left|A_{n}(q)\right| & =\frac{1}{(n+1, q-1)} q^{\frac{n(n+1)}{2}}\left(q^{2}-1\right)\left(q^{3}-1\right) \cdots\left(q^{n+1}-1\right) \\
& >\frac{1}{q-1} q^{\frac{n(n+1)}{2}} q \cdot q^{2} \cdots q^{n}=\frac{q^{n(n+1)}}{q-1}
\end{aligned}
$$

By Table 1 , choose $\theta \in \operatorname{Irr}(S)$ with $\theta(1)=\frac{q\left(q^{n}-1\right)}{q-1}<\frac{q^{n+1}}{q-1}$, and we have

$$
\frac{|S|}{\theta(1)^{3}}>\frac{q^{n(n+1)}(q-1)^{3}}{q^{3 n+3}(q-1)}=q^{n^{2}-2 n-3} \cdot(q-1)^{2}=q^{(n-1)^{2}-4}(q-1)^{2} .
$$

If $n \geq 3$, it is obvious that $(n-1)^{2}-4 \geq 0$. That means $|S|>\theta(1)^{3}$. If $n=q=2$, then there exists a $\theta \in \operatorname{Irr}(S)$ of degree 3 such that $|S|>\theta(1)^{3}$ by [4]. If $n=2$ and $q \geq 3$, then since $|S|=\left|A_{2}(q)\right| \geq \frac{1}{q-1} q^{3}\left(q^{3}-1\right)\left(q^{2}-1\right)=q^{3}\left(q^{3}-1\right)(q+1)$ and $\theta(1)=q(q+1)$ we have

$$
\frac{|S|}{\theta(1)^{3}}>\frac{q^{3}\left(q^{3}-1\right)(q+1)}{q^{3}(q+1)^{3}}=\frac{q^{3}-1}{(q+1)^{2}}>1
$$

This yields $|S|>\theta(1)^{3}$.
For every remaining simple group of Lie type, it is routine to check $|S|>\theta(1)^{3}$ for character $\theta$ of degree as in Table $\mathbb{1}$ (The similar calculation process is omitted here). Therefore, the proof is complete.

Let $H$ be a subgroup of a finite group $G$, and let $\theta$ be an irreducible character of $H$. We use $\operatorname{Irr}(G \mid \theta)$ to denote the set of irreducible characters of $G$ lying over $\theta$.

Lemma 2.4. Let $G$ be a group and $N$ be its nonsolvable minimal normal subgroup. Suppose that $\operatorname{cod}(\chi) \leq \chi(1)^{2}$ for each nonlinear irreducible character $\chi$ of $G$. Then $N$ is nonabelian simple.

Proof. Let $N=S_{1} \times \cdots \times S_{t}$ where $S_{i} \cong S$ for a nonabelian simple group $S$. By the unique minimality of $N$, it follows that $G$ acts transitively on $\left\{S_{1}, S_{2}, \cdots, S_{t}\right\}$. Let $S=S_{1}$. Then $S \unlhd N_{G}(S)$ and $t=\left|G: N_{G}(S)\right|$. By Lemma [2.1, $S$ has some irreducible nonlinear character $\theta$ such that $\theta$ is extendible to $N_{G}(S)$. Take $\chi \in \operatorname{Irr}(G \mid \theta)$. Then $\chi(1) \leq \mid G$ : $N_{G}(S) \mid \cdot \theta(1)=t \cdot \theta(1)$.

Note that $\operatorname{ker}(\chi)=1$. So, we conclude from the hypothesis that $|G| \leq \chi(1)^{3}$. Furthermore,

$$
t^{3} \cdot \theta(1)^{3} \geq \chi(1)^{3} \geq|G| \geq\left|G: N_{G}(S)\right| \cdot|N|=t \cdot|S|^{t}
$$

Since $\theta(1)^{2}<|S|$, we have

$$
t^{2} \geq \frac{|S|^{t}}{\theta(1)^{3}}>|S|^{t-\frac{3}{2}}
$$

If $t \geq 3$, then since $t-\frac{3}{2} \geq \frac{t}{2}$ we have $t^{2}>|S|^{t-\frac{3}{2}} \geq|S|^{\frac{t}{2}}=\sqrt{|S|^{t}>7^{t} \text {, a contradiction. }}$ Similarly, if $t=2$, we have $4>\sqrt{|S|}>7$, which is also a contradiction. Thus $t=1$.

Lemma 2.5. If $q=p^{f}$ is a power of a prime $p$ such that $q \equiv 3(\bmod 6)$, then $f<q^{\frac{1}{3}}$.
Proof. If $f=1$, we are done immediately. If $f=2$, it follows from $q \geq 9$ that $2 \leq q^{\frac{1}{3}}$. Let function $T(x)=p^{\frac{x}{3}}-x$, where $x \geq 3$. Then the derivative function $T^{\prime}(x)=\frac{\ln p}{3} \cdot p^{\frac{x}{3}}-1 \geq$ $\ln p-1 \geq 0$. That means $T(f) \geq T(0)>0$. That is, $f<p^{\frac{f}{3}}=q^{\frac{1}{3}}$.

Recall that $\Phi_{n}(x)$ is the $n$-th cyclotomic polynomial with indeterminate $x$. For a simple group of Lie type over finite field of $q$ elements, we define $\Phi_{n}=\Phi_{n}(q)$. Next we will prove Theorem A.

Proof of the Theorem A. Suppose that $G$ is a nonsolvable group of minimal order which satisfies the hypothesis of Theorem A.

We claim that $G$ is not simple. Suppose not. If $G \notin\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right), F i_{22}\right\}$, by Lemma 2.3, there exists some nonlinear irreducible character $\chi$ of $G$ such that $k \cdot|G|>\chi(1)^{3}$. That is, $k \cdot \operatorname{cod}(\chi)>\chi(1)^{2}$, which is contrary to the hypothesis. If $G$ is isomorphic to one of the group in $\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right), F i_{22}\right\}$, similarly, to get a contradiction, we just need to show that there also exists some nonlinear irreducible character $\theta$ of $G$ such that $k \cdot|G|>\theta(1)^{3}$.

Suppose that $G \cong A_{1}(q)$. Let $\chi \in \operatorname{Irr}(G)$ be of degree $q-1$. Then since $k>\frac{5}{2}$ we have

$$
k \cdot|G|>q\left(q^{2}-1\right)>(q-1)^{3}=\chi(1)^{3} .
$$

Suppose that $G \cong G_{2}(q)$. Since $G_{2}(2) \cong U_{3}(3) .2$ is not simple, we can assume that $q \geq 3$. Note that the character degrees of $G_{2}(q)$ are listed in the paper [3]. If $q \equiv 1(\bmod 6)$ or $q \equiv 4(\bmod 6)$, then $\Phi_{2} \Phi_{6} \in \operatorname{cd}(G)$. If $q \equiv 2(\bmod 6)$ or $q \equiv 5(\bmod 6)$, then $\Phi_{1} \Phi_{3} \in \operatorname{cd}(G)$. If $q \equiv 3(\bmod 6)$, then $\Phi_{3} \Phi_{6} \in \operatorname{cd}(G)$. It follows that

$$
\frac{k \cdot|G|}{\left(\Phi_{3} \Phi_{6}\right)^{3}}=\frac{3 q^{6}\left(q^{6}-1\right)\left(q^{2}-1\right)}{\left(q^{2}+q+1\right)^{3}\left(q^{2}-q+1\right)^{3}}>\frac{3\left(q^{2}-1\right)^{4}}{q^{6}-1}>1 .
$$

Obviously, $\Phi_{3} \Phi_{6}>\Phi_{2} \Phi_{6}>\Phi_{1} \Phi_{3}$. So there always exists some character $\chi$ of $G$ such that $k \cdot|G|>\chi(1)^{3}$.

Suppose that $G \cong{ }^{2} G_{2}\left(q^{2}\right)$, where $q^{2}=3^{2 m+1}$. Taking $\chi \in \operatorname{Irr}(G)$ with degree $\Phi_{12}$. Then

$$
\frac{k \cdot|G|}{\Phi_{12}{ }^{3}} \geq \frac{q^{6}\left(q^{6}+1\right)\left(q^{2}-1\right) \cdot\left(q^{2}+1\right)^{3}}{\left(q^{4}+q^{2}+1\right)^{3} \cdot\left(q^{2}+1\right)^{3}} \geq \frac{\left(q^{2}-1\right)\left(q^{2}+1\right)^{3}}{q^{6}-1}>1 .
$$

Suppose that $G \cong F i_{22}$. By the Atlas [4], it is easy to get that $k \cdot|G|>\chi(1)^{3}$ for some nonlinear $\chi \in \operatorname{Irr}(G)$.

We next conclude the final contradiction. Note that $G$ is not simple. Assume that $G$ has distinct minimal normal subgroups, says $N_{1}, N_{2}$. It follows from the minimality of $G$ that $G / N_{i}$ is solvable for $i=1,2$, and then $G \lesssim G / N_{1} \times G / N_{2}$ is solvable, a contradiction. So we may assume that $G$ has a unique minimal normal subgroup $N$; and, similarly, $G / N$ is solvable; and this means that $N$ is also nonsolvable. Hence $N$ is a direct product of isomorphic nonabelian simple groups. Since $\operatorname{cod}(\chi)<k \cdot \operatorname{cod}(\chi) \leq \chi(1)^{2}$ for every nonlinear irreducible character $\chi$ of $G$, it follows from Lemma 2.4 that the minimal normal subgroup $N$ of $G$ is simple. If $N \notin\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right), F i_{22}\right\}$, then, by Lemma 2.3, $N$ has some nontrivial irreducible character $\theta$ that is extendible to $\operatorname{Aut}(N)$ (also to $G$ ) and $k \cdot|N|>\theta(1)^{3}$. Let $\chi \in \operatorname{Irr}(G)$ be such that $\chi_{N}=\theta$. Then

$$
k \cdot|G|>k \cdot|N|>\theta(1)^{3}=\chi(1)^{3} .
$$

Observe that $\operatorname{ker}(\chi)=1$. This means $k \cdot \operatorname{cod}(\chi)>\chi(1)^{2}$, a contradiction. Next we will also get a contradiction when $N$ is isomorphic to one of the groups in $\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right), F i_{22}\right\}$.
(1) Suppose that $N \cong A_{1}(q)$. Let $\theta \in \operatorname{Irr}(N)$ be the Steinberg character. Then there exists $\chi \in \operatorname{Irr}(G)$ such that $\chi_{N}=\theta$. Thus

$$
k \cdot|G| \geq 2 k \cdot|N| \geq k q\left(q^{2}-1\right)>q^{3}=\theta(1)^{3}=\chi(1)^{3} .
$$

(2) Suppose that $N \cong G_{2}(q)$, where $q=p^{f}$. Then $|N|=q^{6}\left(q^{6}-1\right)\left(q^{2}-1\right)$.

If $q \not \equiv 3(\bmod 6)$, then, by the Atlas [4], we obtain $|G: N| \leq|\operatorname{Out}(N)| \leq q$. Also, there exists some $\theta \in \operatorname{Irr}(N)$ of degree at most $q^{3}+1$ (see for instance [3]). Let $\chi \in \operatorname{Irr}(G \mid \theta)$. It follows that $\chi(1) \leq|G: N| \cdot \theta(1) \leq q\left(q^{3}+1\right)$. Hence

$$
\frac{k \cdot|G|}{\chi(1)^{3}} \geq \frac{k \cdot q^{6}\left(q^{6}-1\right)\left(q^{2}-1\right)}{q^{3}\left(q^{3}+1\right)^{3}}=\frac{k \cdot q^{3}\left(q^{3}-1\right)\left(q^{2}-1\right)}{\left(q^{3}+1\right)^{2}} .
$$

Note that $k>a>\frac{5}{2}$. Since $k \cdot q^{3}(q-1)>q^{3}+1$ and $\left(q^{3}-1\right)(q+1)>q^{3}+1$, then we have $k \cdot|G|>\chi(1)^{3}$.

If $q \equiv 3(\bmod 6)$, then $|G: N| \leq|\operatorname{Out}(N)| \leq 2 \cdot f<2 \cdot q^{\frac{1}{3}}$ where the last inequality follows from Lemma [2.5. Now let $\theta \in \operatorname{Irr}(N)$ be of degree $\left(q^{2}+q+1\right)\left(q^{2}-q+1\right)$ and $\chi \in \operatorname{Irr}(G \mid \theta)$. Then $\chi(1)<2 \cdot q^{\frac{1}{3}}\left(q^{2}+q+1\right)\left(q^{2}-q+1\right)$. Thus

$$
\frac{k \cdot|G|}{\chi(1)^{3}} \geq \frac{k \cdot q^{6}\left(q^{6}-1\right)\left(q^{2}-1\right)}{8 q \cdot\left(q^{2}+q+1\right)^{3}\left(q^{2}-q+1\right)^{3}}=\frac{k \cdot q^{5}\left(q^{2}-1\right)^{4}}{8\left(q^{6}-1\right)^{2}}=\frac{k \cdot q^{5}(q+1)^{4}(q-1)^{4}}{8\left(q^{6}-1\right)^{2}} .
$$

Since $q^{5}(q+1)>q^{6}-1$ and $(q+1)^{3}>q^{3}+1$, it follows that

$$
\frac{k \cdot|G|}{\chi(1)^{3}} \geq \frac{k(q+1)^{3}(q-1)^{4}}{8\left(q^{6}-1\right)} \geq \frac{k(q-1)^{4}}{8\left(q^{3}-1\right)} .
$$

Recall that $q \equiv 3(\bmod 6)$. If $q \geq 9$, it is easy to get $k \cdot|G|>\chi(1)^{3}$. If $q=3$,

$$
\frac{k \cdot|G|}{\chi(1)^{3}} \geq \frac{2 k \cdot|N|}{\chi(1)^{3}}=\frac{k \cdot 2^{4} \cdot 3^{6}\left(3^{6}-1\right)}{2^{3} \cdot 3 \cdot 13^{3} \cdot 7^{3}}=\frac{2 k \cdot 3^{5}\left(3^{6}-1\right)}{13^{3} \cdot 7^{3}}>1 .
$$

(3) Suppose that $N \cong{ }^{2} G_{2}\left(q^{2}\right)$, where $q^{2}=3^{2 m+1}$. Since $q^{2}=3^{2 m+1} \equiv 3(\bmod 6)$, it follows from Lemma 2.5 that $|G: N| \leq|\operatorname{Out}(N)|=2 m+1<q^{\frac{2}{3}}$. Let $\theta \in \operatorname{Irr}(N)$ be of degree $\Phi_{12}$ and $\chi \in \operatorname{Irr}(G \mid \theta)$. Then $\chi(1) \leq|G: N| \cdot \theta(1) \leq q^{\frac{2}{3}} \cdot \Phi_{12}$. Thus

$$
\frac{3 \cdot|G|}{\chi(1)^{3}} \geq \frac{q^{6}\left(q^{6}+1\right)\left(q^{2}-1\right) \cdot\left(q^{2}+1\right)^{3}}{q^{2} \cdot\left(q^{4}+q^{2}+1\right)^{3} \cdot\left(q^{2}+1\right)^{3}} \geq \frac{\left(q^{2}-1\right)\left(q^{2}+1\right)^{3}}{q^{2}\left(q^{6}-1\right)}>1 .
$$

(4) Suppose that $N \cong F i_{22}$. By the Atlas [4, $N$ has an irreducible character $\theta$ of degree 78. Let $\chi \in \operatorname{Irr}(G \mid \theta)$. Then since $\operatorname{Out}(N)=2$ we get $\chi(1) \leq|G: N| \cdot \theta(1)=156=2^{2} \cdot 3 \cdot 13$. It follows that

$$
k \cdot|G| \geq 2 k \cdot|N|=k \cdot 2^{18} \cdot 3^{9} \cdot 5^{2} \cdot 7 \cdot 11 \cdot 13>\left(2^{2} \cdot 3 \cdot 13\right)^{3}=\chi(1)^{3} .
$$

Therefore we can find an irreducible character $\chi$ of $G$ such that $k \cdot|G|>\chi(1)^{3}$ when $N \in\left\{A_{1}(q), G_{2}(q),{ }^{2} G_{2}\left(q^{2}\right), F i_{22}\right\}$. Since $\left[\chi_{N}, 1_{N}\right]=0$, it follows from the minimality of $N$ that $\operatorname{ker}(\chi)=1$. So $k \cdot \operatorname{cod}(\chi)>\chi(1)^{2}$, a contradiction. The proof is established.
