# Efficient Concentration with Gaussian Approximation

#### Abstract

Concentration inequalities for the sample mean, like those due to Bernstein and Hoeffding, are valid for any sample size but overly conservative, yielding confidence intervals that are unnecessarily wide. The central limit theorem (CLT) provides asymptotic confidence intervals with optimal width, but these are invalid for all sample sizes. To resolve this tension, we develop new computable concentration inequalities with asymptotically optimal size, finite-sample validity, and subGaussian decay. These bounds enable the construction of efficient confidence intervals with correct coverage for any sample size. We derive our inequalities by tightly bounding the Hellinger distance, Stein discrepancy, non-uniform Kolmogorov distance, and Wasserstein distance to a Gaussian, and, as a byproduct, we obtain the first explicit bounds for the Hellinger CLT.

## 1. Introduction

Concentration inequalities for the sample mean are ubiquitous in probability theory, statistics, and machine learning. Given $n$ independent and identically distributed (i.i.d.) observations $W_{1}, \ldots, W_{n}$ they allow us to give finite sample and high probability guarantees that the sample mean $\bar{W}_{n} \triangleq$ $\frac{1}{n} \sum_{i=1}^{n} W_{i}$ is not too far away from the population mean $\mathbb{E}\left(W_{1}\right)$. Specifically, they provide upper bounds for the probability $P\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right)$ for each $t \geq 0$. Such inequalities lie at the heart of decision-making in reinforcement learning (Mnih et al., 2008; Audibert et al., 2009), generalization guarantees in high-dimensional statistics, machine learning, and deep learning (Wainwright, 2019; Bartlett and Mendelson, 2002; Zhou et al., 2018), and the design of efficient learning procedures (Maurer and Pontil, 2009).

However, standard concentration inequalities are overly conservative yielding confidence intervals that are unnecessarily wide and generalization guarantees that are weaker than needed. This is notably the case for the commonly used concentration inequalities of Hoeffding (1963) and Bernstein (1924). For random variables with bounded deviations $\left|W_{1}-\mathbb{E}\left(W_{1}\right)\right| \leq R$ and variance $\sigma^{2} \triangleq \operatorname{Var}\left(W_{1}\right)$, the Hoeffding and Bernstein inequalities respectively state that

& P\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right) \leq e^{-\frac{t^{2}}{2 R^{2}}} \text { and }  \tag{1}\\
& P\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right) \leq e^{-\frac{t^{2}}{2\left(\sigma^{2}+R t / 3\right)}} . \tag{2}
\end{align*}
$$

Meanwhile, the central limit theorem (CLT) identifies the exact limit for these tail probabilities:

$$
\begin{equation*}
P\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right) \xrightarrow{n \rightarrow \infty} \Phi^{c}\left(\frac{t}{\sigma}\right), \tag{3}
\end{equation*}
$$

where $\Phi(\cdot)$ is the cumulative distribution function (CDF) of a standard normal distribution and $\Phi^{c}(\cdot)=1-\Phi(\cdot)$. As a result, standard confidence intervals based on the CLT are asymptotically exact and often much narrower than those obtained using concentration inequalities. However, these intervals are typically only asymptotically valid and provide incorrect coverage for every sample size $n$.

The choice between concentration inequalities that are finite-sample valid but loose and CLTbased approximations that are asymptotically tight but invalid is very unsatisfying. In this paper we derive new bounds that offer the best of both worlds: our new concentration inequalities are both finite-sample valid and efficient-that is, asymptotically of minimal width when scaled by $\sqrt{n}$. We achieve this by deriving explicit and practical bounds for the distance between the sample mean and a Gaussian with matching variance. In Secs. 3, 4, 5, and 6, we measure the distance in four different ways: via the Hellinger distance, the Stein discrepancy (as defined by Ledoux et al. (2015)), a non-uniform Kolmogorov distance, and the $p$-Wassertein distance, respectively. In each case, our Gaussian approximation bounds yield efficient concentration inequalities of the form

\begin{equation*}
\mathbb{P}\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right) \leq \Phi^{c}(t / \sigma)+r_{n}(t / \sigma) \tag{4}
\end{equation*}
$$

with explicit remainder terms $r_{n}(t / \sigma)$. For example, in the non-uniform Kolmogorov case, $r_{n}(t / \sigma)$ decreases at an $O\left(n^{-1 / 2}\right)$ rate in $n$ and at a sub-Gaussian $e^{-\Omega\left(t^{2}\right)}$ rate in $t$.

It is informative to compare these results with those obtained using classical CLT corrections. For random variables with bounded deviations, the Berry-Esseen bound (Esseen, 1942) guarantees that

\left|\mathbb{P}\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right)-\Phi^{c}(t / \sigma)\right| \leq \frac{C R}{\sigma \sqrt{n}} \quad \text { for all } \quad t \geq 0, \tag{5}
\end{equation*}
$$

and some universal constant $C$. This yields an efficient concentration inequality, but the bound is overly conservative as the correction is independent of $t$. Non-uniform Berry-Esseen bounds (Nagaev, 1965; Bikyalis, 1966) ameliorate this behavior by identifying a constant $\tilde{C}$ satisfying

$$
\left|P\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right) \geq t / \sqrt{n}\right)-\Phi^{c}(t / \sigma)\right| \leq \frac{\tilde{C} R}{\sigma \sqrt{n}(1+t / \sigma)^{3}} \quad \text { for all } \quad t \geq 0
$$

Appealingly, this non-uniformity yields tighter bounds for larger $t$. However, the correction has only cubic, that is, $O\left(t^{-3}\right)$, decay in $t$ as the underlying argument only exploits the existence of a third moment of $\bar{W}_{n}$. Quantile coupling inequalities (see, e.g., Mason and Zhou, 2012) like the groundbreaking Komlós-Major-Tusnády approximations (Komlós et al., 1975, 1976; Bretagnolle and Massart, 1989, Thm. 1) and the strong embedding bounds of Chatterjee (2012); Bhattacharjee and Goldstein (2016) improve this $t$ dependence for $W_{1}$ with finite exponential moments but provide at best exponential decay in $t$ and $O(\log n / \sqrt{n})$ decay in $n$. By exploiting the sub-Gaussianity of $W_{1}$, our theorems provide a correction term with squared-exponential $e^{-\Omega\left(t^{2}\right)}$ decay, leading to much sharper bounds for larger $t$. In addition, our non-uniform Kolmogorov bounds eliminate the extraneous $\log n$ factor from the decay rate.

As the Hellinger, Stein, non-uniform Kolmogorov, and Wasserstein distances each measure separate properties of the empirical average, the inequalities we obtain are complementary and hold under distinct conditions. For example, when controlling the Hellinger distance, the remainder term in Eq. (4) depends on the score function of the random variable $W_{1}$. When controlling the Stein discrepancy, the remainder term instead depends on the moments of a quantity called the Stein

kernel, defined in Sec. 4. As the Stein kernel and the score function can be controlled in different settings those bounds complement each other. Finally, the bounds obtained using non-uniform Kolmogorov and $p$-Wassertein distances apply to all bounded-deviation variables with no additional distributional assumptions. We note in general that when the random variables are continuous and the score function can be controlled (see Thm. 4 and Thm. 8) we can improve the tightness of our results by avoiding a lossy union bound. This is complemented by tighter efficient bounds for smoothed observations, which will hold under minimum conditions. We also propose new quantile bounds that are also valid for finite samples and efficient. Finally, with analogy to the empirical Bernstein bound (Mnih et al., 2008; Audibert et al., 2009; Maurer and Pontil, 2009), we develop new empirical Berry-Esseen bounds that are efficient and finite-sample valid even when the variance parameter $\sigma^{2}$ is unknown. We confirm numerically that these new bounds improve upon the most commonly used confidence intervals and the efficient $I_{n, 3}$ confidence interval of Romano and Wolf (2000).

As a by-product of our inquiry we obtain the first computable bounds on the Hellinger distance to Gaussianity. Our bounds depend on the moments of the score function of $W_{1}$. This is to contrast with the currently known rates of convergence of the entropic central limit theorems which are either not in closed form (Bobkov et al., 2013), require conditions on the spectral gap (Artstein et al., 2004), or depend on the Stein kernel (Ledoux et al., 2015). In addition, we propose a novel bound that, beyond empirical averages, upper-bounds the Hellinger distance between general random variables and a normal.

### 1.1. Overview

In Sec. 2 we define the notion of efficient concentration and quantiles, present some of the assumptions we will work with, and introduce notations. In Sec. 3 we propose efficient concentration inequalities using the Hellinger distance, under the condition that the random variables are continuous. Moreover, we propose the first-ever computable rate of convergence of the CLT in terms of the Hellinger distance. In Sec. 4 we propose three different efficient tail bounds under the condition that the random variables $Y_{1}$ admits a Stein kernel. Each one of those tail bounds will hold under different conditions and we contrast those to each other and previously known techniques. In Sec. 5 we use zero-bias couplings to bound non-uniform Kolmogorov distances and thereby obtain efficient tail bounds using only the bounded deviation assumption. In Sec. 6 we use the $p$-Wassertein distances to obtain efficient tail bounds and quantile bounds under minimal conditions. In Sec. 7 we obtain even tighter efficient concentration inequalities for smoothed observations. Finally, in Sec. 8 we propose empirical efficient quantile bounds that can be computed without requiring any prior knowledge about the variance and present some numerical evaluations of these bounds. Throughout, we present sketches of the proofs of the derived results and defer full proofs to the appendices.

### 1.2. Notation

Throughout, we will let $\varphi(x) \triangleq \frac{1}{\sqrt{2 \pi}} e^{-x^{2} / 2}$ designate the probability density function (PDF) of a standard normal random variable and write $a_{n} \lesssim b_{n}$ to indicate that two sequences $\left(a_{n}\right)$ and ( $b_{n}$ ) satisy $a_{n} \leq b_{n}\left[1+o_{n}(1)\right]$. We define $a^{+}=\max (a, 0)$ and make use of the following notation:

Y_{i} \triangleq W_{i}-\mathbb{E}\left(W_{1}\right), \quad S_{n} \triangleq \sqrt{n}\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right)\right), \quad \tilde{S}_{n} \triangleq \sigma^{-1} S_{n}, \quad \tilde{R} \triangleq \sigma^{-1} R, \\
A_{p} \triangleq \frac{\sqrt{e} \sqrt{p+2}(2 e)^{1 / p}}{\sqrt{2}}, \quad A_{n, p}^{*} \triangleq \frac{(p+2) n^{1 / p}}{2 \sqrt{n}}, \quad \tilde{A}_{n, p} \triangleq A_{n, p}^{*} \tilde{R}^{-2 / p} .
\end{gathered}

## 2. Defining Efficient Concentration

To match the setting of the classical Bernstein inequality Eq. (2), we will focus on random variables satisfying the following bounded deviations assumption.
Assumption $(R, \sigma)$ The scaled deviations $\left(S_{n}\right)_{n \geq 1}$ satisfy $S_{n}=\sqrt{n}\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right)\right)$ for a shared sequence of i.i.d. variables $\left(W_{i}\right)_{i \geq 1}$ with $\bar{W}_{n} \triangleq \frac{1}{n} \sum_{i=1}^{n} W_{i}$. We write the centered random variables $Y_{i} \triangleq W_{i}-\mathbb{E}\left(W_{1}\right)$, and we suppose that $\operatorname{Var}\left(Y_{1}\right)=\sigma^{2}$ and $\left|Y_{1}\right| \leq R$ almost surely.

Our first inferential goal is to tightly upper bound the tail probability $\mathbb{P}\left(S_{n} \geq t\right)$ for a given threshold $t \geq 0$. The CLT provides an asymptotic lower bound for this problem as $\mathbb{P}\left(S_{n} \geq t\right)$ is known to converge precisely to $\Phi^{c}\left(\frac{t}{\sigma}\right)$ as $n$ increases.

Proposition 1 (Asymptotic lower bound for valid tail bounds) Fix any $t \geq 0$, any sequence of scaled deviations $\left(S_{n}\right)_{n \geq 1}$ satisfying Assump. $(R, \sigma)$, and any sequence of candidate tail bounds $\left(\delta_{n}(t)\right)_{n \geq 1}$. If $\mathbb{P}\left(S_{n} \geq t\right) \leq \delta_{n}(t)$ for all $n$, then $\Phi^{c}\left(\frac{t}{\sigma}\right) \leq \liminf _{n \rightarrow \infty} \delta_{n}(t)$.
Proof Suppose that a sequence $\delta_{n}(t)$ satisfies $\lim \inf _{n \rightarrow \infty} \delta_{n}(t)<\Phi^{c}\left(\frac{t}{\sigma}\right)$. Then there exists an $\epsilon>0$ such that $\delta_{n}(t) \leq \Phi^{c}\left(\frac{t}{\sigma}\right)-\epsilon$ for infinitely many $n$. However, by the CLT (see, e.g., Durrett, 2019, Thm. 3.4.1), there exists an $n_{\epsilon}$ such that, for all $n>n_{\epsilon}, \Phi^{c}\left(\frac{t}{\sigma}\right)-\epsilon<\mathbb{P}\left(S_{n} \geq t\right)$. Therefore, $\delta_{n}(t)<\mathbb{P}\left(S_{n} \geq t\right)$ for infinitely many $n$, confirming the claim via its contrapositive.

Unfortunately, the CLT limit does not provide a suitable tail bound for any finite $n$, as $\mathbb{P}\left(S_{n} \geq\right.$ $t)>\Phi^{c}\left(\frac{t}{\sigma}\right)$ for many $S_{n}$ satisfying Assump. $(R, \sigma)$. However, by tightly bounding the distance between the distribution of $S_{n}$ and the distribution of a Gaussian we can correct the asymptotic bound to obtain one that is both valid in finite samples and asymptotically exact. We will call such bounds efficient concentration inequalities.

Our second inferential goal is to tightly bound the quantiles of $S_{n}$. That is, given a tail probability $\delta \in(0,1)$ we wish to find $q_{n}(R, \delta, \sigma)$ (a measurable function of $\left(W_{i}\right)_{i=1}^{n}, R, \sigma$, and $\delta$ ) satisfying $\mathbb{P}\left(S_{n} \geq q_{n}(R, \delta, \sigma)\right) \leq \delta$. Such quantile bounds immediately deliver both one- and two-sided confidence intervals for the population mean $\mathbb{E}\left(W_{1}\right)$ as

$$
\mathbb{P}\left(\bar{W}_{n}-\frac{q_{n}(R, \delta, \sigma)}{\sqrt{n}} \leq \mathbb{E}\left(W_{1}\right)\right) \wedge \mathbb{P}\left(\left|\mathbb{E}\left(W_{1}\right)-\bar{W}_{n}\right| \leq \frac{q_{n}(R, \delta / 2, \sigma)}{\sqrt{n}}\right) \geq 1-\delta .
$$

The interval efficiency theory of Romano and Wolf (2000) implies that the CLT once again provides an asymptotic lower bound for any valid sequence of quantile bounds.

Proposition 2 (Asymptotic lower bound for valid quantile bounds) Fix any $R>0$, any $\delta \in$ ( $0, \frac{1}{2}$ ), and any nonnegative candidate quantile bounds $\left(q_{n}(R, \delta, \sigma)\right)_{n \geq 1, \sigma>0}$. Suppose that, for each $\sigma \in(0, R]$ and all $\left(S_{n}\right)_{n \geq 1}$ satisfying Assump. $(R, \sigma), \mathbb{P}\left(S_{n} \geq q_{n}(R, \delta, \sigma)\right) \leq \delta$ for all $n$. Then $\left(q_{n}(R, \delta, \sigma)\right)_{n \geq 1}$ is not asymptotically concentrated ${ }^{1}$ on $[0, a]$ for any $a<-\sigma \Phi^{-1}(\delta)$.

Proof The result follows by applying Thm. 2.1 of Romano and Wolf (2000) to the conservative confidence intervals $I_{n}(\delta, \sigma)=\bar{W}_{n}+\frac{1}{\sqrt{n}}\left[-q_{n}(R, \delta, \sigma), q_{n}(R, \delta, \sigma)\right]$ for the unknown mean $\mathbb{E}\left(W_{1}\right)$.

To construct efficient quantile bounds, we will once again tightly bound the distance between $S_{n}$ and its Gaussian limit.

## 3. Efficient Concentration with Hellinger Approximation

For two continuous real-valued random variables $X$ and $Y$ be with respective probability density functions (PDFs) $f_{X}$ and $f_{Y}$ we define the Hellinger distance as

$$
H(X, Y)^{2} \triangleq \frac{1}{2} \int_{\mathbb{R}}\left(\sqrt{f_{X}(x)}-{\left.\sqrt{f_{Y}(x)}\right)^{2} d x .}\right.
$$

In this section we show how the Hellinger distance can be used to obtain efficient concentration inequalities, and derive a bound for the Hellinger distance between $S_{n}$ and its normal limit. Note that by doing so we establish, for the first time, an explicit rate of convergence for the central limit theorem in terms of the Hellinger distance, which is of independent interest.
Throughout this section, we suppose that the random variables $\left(Y_{i}\right)$ are real valued continuous random variables.

Assumption $(\tilde{f})$ The random variable $Y_{1}$ is continuous with a probability density function $\tilde{f}$ that is continuously differentiable almost everywhere on its support.

### 3.1. Concentration inequalities and the Hellinger distance

Under Assump. $(\tilde{f})$ the Hellinger distance between $S_{n}$ and its normal limit is properly defined and upper bounded by 2 . We show that this can be used to obtain efficient concentration inequalities for $S_{n}$ if the assumption Assump. $(R, \sigma)$ also holds. In this goal, we take $\hat{Q}_{n}(u)$ to be any known upper bound for $P\left(S_{n} \geq u \sigma\right)$ and $\hat{Q}_{n}^{d}(u)$ to be any known upper bound for $P\left(\left|S_{n}\right| \geq u \sigma\right)$. Possible choices are the classical Hoeffding or Bernstein bounds Eqs. (1) and (2) or the new Wassersteinapproximation bounds we derive in Sec. 6 (which hold whenever Assump. $(R, \sigma)$ holds).

Theorem 3 (Efficient Hellinger tail bound) Suppose that the random variables $\left(Y_{i}\right)$ satisfy Assump. $(R, \sigma)$ and Assump. $(\tilde{f})$. Let $\hat{Q}_{n}(u)$ be an any arbitrary upper bound to $\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq$ $\hat{Q}_{n}(u)$. We denote by $H(\cdot, \cdot)$ the Hellinger distance and write $Z \sim N(0,1)$ as a standard normal random variable. Then the following holds

$$
\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \Phi^{c}(u)+\sqrt{2} H\left(\sigma^{-1} S_{n}, Z\right)\left[\sqrt{\hat{Q}_{n}(u)}+\sqrt{\Phi^{c}(u)}\right]
$$

Moreover let $\hat{Q}_{n}^{d}(u)$ be an any arbitrary upper bound to $\mathbb{P}\left(\left|S_{n}\right| \geq \sigma u\right) \leq \hat{Q}_{n}^{d}(u)$

$$
P\left(\left|S_{n}\right| \geq \sigma u\right) \leq 2 \Phi^{c}(u)+\sqrt{2} H\left(\sigma^{-1} S_{n}, Z\right)\left[\sqrt{2 \Phi^{c}(u)}+\sqrt{\hat{Q}_{n}^{d}(u)}\right] .
$$

In Thm. 4 we prove that there is a constant $K$, that we derive, such that $\sqrt{2} H\left(\sigma^{-1} S_{n}, Z\right) \leq \frac{K \log (n)}{\sqrt{n}}$. This directly implies that:

$$
\begin{aligned}
\mathbb{P}\left(S_{n} \geq \sigma u\right) & \leq \Phi^{c}(u)+\frac{K \log (n)}{\sqrt{n}}\left[\sqrt{\hat{Q}_{n}(u)}+\sqrt{\Phi^{c}(u)}\right] \\
& \leq \Phi^{c}(u)+\frac{K \log (n)}{\sqrt{n}}\left[\sqrt{e^{-\frac{u^{2} \sigma^{2}}{2 R^{2}}}}+\sqrt{\Phi^{c}(u)}\right] .
\end{aligned}
$$

We note that in practice we will want to use the upper bound derived in Thm. 13 for $\hat{Q}_{n}(u)$ rather than the Hoeffding bound which will provide us with significantly tighter upper bounds. We also remark that the correction term $\frac{K \log (n)}{\sqrt{n}}\left[\sqrt{e^{-\frac{u^{2} \sigma^{2}}{2 R^{2}}}}+\sqrt{\Phi^{c}(u)}\right]$ is sub-Gaussian in $u$ and decreases as $\frac{\log (n)}{\sqrt{n}}$.

### 3.2. CLT rate of convergence in terms of the Hellinger distance

In this section we derive the rate of convergence of $S_{n}$ to its normal limit in terms of the Hellinger distance which is of independent interest as no explicit bound was previously known. To do so we need to impose some moment conditions on the score function of $Y_{1}$ which we denote $S_{Y_{1}}(\cdot)$ and is defined as $S_{Y_{1}}(\cdot)=-\frac{\tilde{f}^{\prime}(\cdot)}{\tilde{f}(\cdot)}$.

Assumption $\left(S_{Y_{1}}, p^{\prime}\right)$ Let $p^{\prime} \geq 1$, we assume that the norm $\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)\right\|_{\frac{2 p^{\prime}}{p^{\prime}-1}}<\infty$ is finite. Write $\Omega \subset \mathbb{R}$ the support of $Y_{1}$, we suppose that $\left.\tilde{f}\right|_{\delta \Omega}=0$.

Let $Z \sim N(0,1)$ be a standard normal random variable. For all $p \in\left[1, p^{\prime}\right]$, we introduce the following notation for $A_{n, \frac{2 p}{p-1}}$ and $A_{n, \frac{2 p}{p-1}}^{*}$ defined in Sec. 1.2:

$$
C_{p} \triangleq \min \left\{\begin{array}{l}
\sqrt{\frac{2 p}{p-1}-1}\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)\right\|_{\frac{2 p}{p-1}} \\
A_{n, \frac{2 p}{*-1}}^{*}\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)\right\|_{\frac{2 p}{p-1}}+A_{n, \frac{2 p}{p-1}}\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)\right\|_{2}
\end{array} .\right.
$$

Theorem 4 (Hellinger CLT bound) Let $p^{\prime} \geq 1$ be a real. Suppose that the random variables $\left(Y_{i}\right)$ satisfy Assump. $(R, \sigma)$, Assump. $(\tilde{f})$ and Assump. $\left(S_{Y_{1}}, p^{\prime}\right)$. Write $\tilde{R} \triangleq \frac{R}{\sigma}$. Then we obtain that

$$
\begin{aligned}
& \sqrt{2} H\left(\tilde{S}_{n}, Z\right) \lesssim \inf \underset{\substack{D>0 \\
\kappa \geq \tilde{R}^{2} D}}{ }\left\{\frac{\sqrt{e} \tilde{R}^{2}\left(e^{2 \kappa}-1\right)}{\sqrt{3} D \sqrt{n} \kappa}+\frac{\log \left(n / D^{2}\right)}{4 \sqrt{2} \sqrt{n}}(\tilde{R}-1)-\frac{1}{2} \log \left(1-\frac{D}{\sqrt{n}}\right)\right. \\
&+\inf _{p^{\prime} \geq p \geq 1} C_{p}\left\{\frac{\sqrt{2 p-1} \tilde{R}}{\sqrt{n \kappa}}+\frac{2 \sqrt{e} \sqrt{2 p-1} \tilde{R}}{\sqrt{3 n \kappa}}\left[2-\frac{2}{3 \tilde{R}}\right]\right. \\
&\left.\left.\times\left[e^{2(2 p-1) \kappa}-1-2(2 p-1) \kappa\right]+\frac{\tilde{R}^{2}}{2 n \kappa M_{n, \kappa}}\left[U_{n, 2 p}+\tilde{U}_{n, 2 p}\right]\right\}\right\} .
\end{aligned}
$$

Moreover they are constants $K_{1}, K_{2}$ and $K_{3}$ given in Eq. (24) such that

$$
\begin{aligned}
\sqrt{2} H\left(\sigma^{-1} S_{n}, Z\right) & \lesssim \frac{K_{1}}{D \sqrt{n}}+\frac{D}{2 \sqrt{n}}+\frac{\log \left(n / D^{2}\right)}{4 \sqrt{2} \sqrt{n}}(\tilde{R}-1)+\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)\right\|_{2}\left\{\frac{K_{2} \tilde{R}}{\sqrt{n}}+\frac{K_{3}}{\sqrt{n}}\right\} \\
& =O\left(\frac{\log (n)}{\sqrt{n}}\right) .
\end{aligned}
$$

Note that an exact and a tighter computable bound can be found in Thm. 22. The latter is less interpretable but is useful for deriving as tight as possible quantiles bounds using Thm. 3. The proof can be found in App. C.

### 3.3. General bound for the Hellinger distance

We remark that Thm. 4 establishes a rate of convergence for the Hellinger distance under moment conditions for the score function of $Y_{1}$. This result is novel. In this section we present the general bound we established and used to derive Thm. 4. Our proof technique relies on the OrnsteinUlbheck interpolation, the heat equation, and the Stein exchangeable pair method. The latter takes inspiration from the ideas Bonis (2015) adapted to obtain a rate in the Wassertein distance. This provides us with an easily computable bound that only depends on the moments of the score function and the moments of the random variable itself. This is to contrast with the known bounds for the

KL divergence (which upper-bounds the square of the Hellinger distance), which are either not in closed form (Bobkov et al., 2013), require conditions on the spectral gap (Artstein et al., 2004) or depend on the moment of the Stein kernel (Ledoux et al., 2015) which is often significantly harder to upper-bound and does not always exists.

Let $S$ be a real valued random variable with PDF $f_{S} \in \mathbb{C}^{1}(\mathbb{R})$ with support $\Omega_{S} \subset \mathbb{R}$. We write its score function $S_{S}(\cdot)$. Let $h_{k}(x) \triangleq e^{x^{2} / 2} \frac{\partial^{k}}{\partial x} e^{-x^{2} / 2}$ designate the Hermite polynomials, and denote $H_{k} \triangleq h_{k}(Z)$ where $Z \sim \mathcal{N}(0,1)$ is a standard normal. We write the interpolated process as

$$
X_{t}^{S} \triangleq e^{-t} S+\sqrt{1-e^{-2 t}} Z
$$

We denote by $f_{t}^{S}$ the PDF of $X_{t}^{S}$ and define $S_{X_{t}^{S}}$ to be the score function of $X_{t}^{S}$. We remark that for all $t>0$ the function $f_{t}^{S} \in \mathbb{C}^{\infty}(\mathbb{R})$ is smooth and we write $I_{t}^{S}(\cdot)=\frac{f_{t}^{S^{\prime \prime}}(\cdot)}{f_{t}^{S}(\cdot)}$. For every $t \geq 0$ choose $S^{t}$ to be a random variable such that $\left(S, S^{t}\right)$ is an exchangeable pair. For all $t>0$ we define

$$
\begin{gather*}
\tau_{t}^{S} \triangleq \sum_{k=1}^{\infty} \frac{e^{-k t}}{k!\sqrt{1-e^{-2 t}} k} \mathbb{E}\left(\left(S^{t}-S\right)^{k} \mid S\right) H_{k-1}(Z) ;  \tag{6}\\
\tau_{t}^{\prime}, S \triangleq \sum_{k=1}^{\infty} \frac{e^{-k t}}{k!\sqrt{1-e^{-2 t}}} \mathbb{E}\left(\left(S^{t}-S\right)^{k} \mid S\right) H_{k}(Z) \tag{7}
\end{gather*}
$$

Theorem 5 (Bounding Hellinger distance to a Gaussian) Assume that $S$ is standardized meaning that $\mathbb{E}(S)=0$ and that $\operatorname{var}(\mathrm{S})=1$. Suppose that $\left.f_{S}\right|_{\delta \Omega_{S}}=0$. Then the following holds

$$
\begin{aligned}
\sqrt{2} H(S, Z) \leq & \int_{0}^{\infty}\left\|I_{t}^{S}\left(X_{t}^{S}\right)-\left(X_{t}^{S}\right)^{2}+1-X_{t}^{S}\left(S_{X_{t}^{S}}-X_{t}^{S}\right)\right\|_{2} d t \\
\leq & \inf _{p>0}\left\{\left\|S_{S}(S)\right\|_{\frac{2 p}{p-1}} \int_{0}^{-\frac{1}{2} \log \left(1-\frac{D}{\sqrt{n}}\right)}\left\|\frac{Z e^{-2 t}}{\sqrt{1-e^{-2 t}}}-e^{-t} S+\tau_{t}^{S}\right\|_{2 p} d t\right. \\
& \quad+\int_{-\frac{1}{2} \log \left(1-\frac{D}{\sqrt{n}}\right)}^{\infty}\left\|\frac{e^{-2 t}}{1-e^{-2 t}}\left(Z^{2}-1\right)-\frac{e^{-t}}{\sqrt{1-e^{-2 t}}} S Z+\tau_{t}^{\prime, S}\right\|_{2} d t \\
& \left.\quad-\frac{1}{2} \log \left(1-\frac{D}{\sqrt{n}}\right)\right\} .
\end{aligned}
$$

This new upper-bound for the Hellinger distance is the key to the proof of Thm. 4. Outside of giving us a bound for $H\left(\tilde{S}_{n}, Z\right)$, this result can be used to obtain bounds on $H(S, Z)$ for any other random variable $S$. We remark that this upper bound will depend on the moments of $S$ and of its score function. To do so one can pick any specific $D>0$ and $p>1$ and compute the corresponding bound. Note that we use this idea to obtain Thm. 4 and that any arbitrary choice of $D$ and $p$ give us that $\sqrt{2} H\left(\tilde{S}_{n}, Z\right)$ decreases at a rate of $O\left(\frac{\log (n)}{\sqrt{n}}\right)$. However depending on the choices of those coefficients the constants in the bound of $H\left(\tilde{S}_{n}, Z\right)$ will change. We note that this result plays a similar role to bounds that had been developed for the KL-divergence or the Wassertein distance see (Barron, 1986; Otto and Villani, 2000; Ledoux et al., 2015). The proof is presented in App. D.
In Bonis (2015) similar ideas could be exploited to obtain a bound for the $p$-Wassertein distance $\mathcal{W}_{p}(S, Z)$. Notably, it was established that

$$
\mathcal{W}_{p}(S, Z) \leq \int_{0}^{\infty}\left\|\frac{e^{-2 t}}{\sqrt{1-e^{-2 t}}} Z-e^{-t} S-\tau_{t}^{S}\right\|_{p} d t
$$

The Wassertein distance is a distance on the underlying geometry of the random variables. This is to contrast with the Hellinger distance which is an information-theoretic distance that intimately depends on the PDF and its smoothness. This difference explains why the latter can be upperbounded independently from the score function.

### 3.4. Proof sketch for Thm. 3

In each of the proof sketches to follow, we assume, without loss of generality, that $\sigma=1$.
The proof of Thm. 3 is a consequence of the Cauchy-Swartz inequality. Indeed let $\varphi(\cdot)$ be the PDF of a standard normal random variable, and $\tilde{f}_{n}$ the $\operatorname{PDF}$ of $S_{n}$. If we write $h(t)=\frac{\tilde{f}_{n}(t)}{\varphi(t)}$ then

$$
\begin{aligned}
\mathbb{P}\left(S_{n} \geq u\right)-\Phi^{c}(u) & =\int_{u}^{\infty}(h(t)-1) \varphi(t) d t \\
& \leq \int_{u}^{\infty}(\sqrt{h(t)}-1)(\sqrt{h(t)}+1) \varphi(t) d t \\
& \stackrel{(a)}{\leq} \sqrt{\int_{u}^{\infty}(\sqrt{h(t)}-1)^{2} \varphi(t) d t}\left[\sqrt{\Phi^{c}(u)}+\sqrt{\int_{u}^{\infty} h(t) \varphi(t) d t}\right]
\end{aligned}
$$

where (a) is consequence of Cauchy-Swartz inequality. Using the definition of $H(\cdot, \cdot)$ and $\hat{Q}_{n}(\cdot)$ we obtain the desired result.

### 3.5. Proof sketch for Thm. 5

The proof of Thm. 5 relies on the Ornstein-Ulbheck interpolation, the heat equation and the Stein exchangeable pair. To make this precise we define the interpolated process as $X_{t}^{S} \triangleq e^{-t} S+$ $\sqrt{1-e^{-2 t}} Z$ where $Z$ is an independent standard normal random variable. As $t$ varies from 0 to $\infty$ $X_{t}^{S}$ evolves from $S$ to $Z$. Indeed we remark that $X_{0}^{S}=S$ and $\lim _{t \rightarrow \infty} X_{t}^{S} \rightarrow Z$. For all $t>0$, as $X_{t}^{S}$ is the sum of $S$ with an independent normal it is a continuous random variable that admits a $\operatorname{PDF} f_{t}^{S}$ that is smooth. We write $h_{t}^{S}(x) \triangleq \frac{f_{t}^{S}(x)}{\varphi(x)}$.
Fix an arbitrary $T<\infty$. By definition we have

$$
H\left(S, X_{T}^{S}\right)^{2}=1-\int_{\mathbb{R}} \sqrt{f_{S}(x)} \sqrt{f_{T}^{S}(x)} d x
$$

We remark that for all $x \in \mathbb{R}$ the function $t \rightarrow f_{t}^{S}(x)$ is differentiable. Therefore we have $\int_{0}^{T} \partial_{t} \sqrt{f_{t}^{S}(x)} d t=\sqrt{f_{T}^{S}(x)}-\sqrt{f_{S}(x)}$ which implies that

$$
\begin{equation*}
H\left(S, X_{T}^{S}\right)^{2}=-\frac{1}{2} \int_{0}^{T} \int_{\mathbb{R}} \sqrt{f_{S}(x)} \partial_{t} \sqrt{f_{t}^{S}(x)} d x d t \tag{8}
\end{equation*}
$$

We use this characterization of the Hellinger distance to bound it in terms of information-theoretic quantities. Indeed, by the chain rule and the heat equation we obtain that

$$
\begin{aligned}
\partial_{t} \sqrt{f_{t}^{S}(x)} & =\frac{1}{2 \sqrt{f_{t}^{S}(x)}} \partial_{t} f_{t}^{S}(x)=\frac{\varphi(x)}{2 \sqrt{f_{t}^{S}(x)}} \partial_{t} \frac{f_{t}^{S}(x)}{\varphi(x)} \\
& =\frac{\varphi(x)}{2 \sqrt{f_{t}^{S}(x)}} \partial_{t} h_{t}^{S}(x)=\frac{\varphi(x)}{2 \sqrt{f_{t}^{S}(x)}}\left[h_{t}^{S^{\prime \prime}}(S)(x)-x h_{t}^{S^{\prime}}(x)\right] \\
& =\frac{f_{t}^{S}(x)}{2 \sqrt{f_{t}^{S}(x)}}\left[\frac{h_{t}^{S^{\prime \prime}}(x)}{h_{t}^{S}(x)}-x \frac{h_{t}^{S^{\prime}(x)}}{h_{t}^{S}(x)}\right] .
\end{aligned}
$$

Therefore by combining this with Eq. (8) we obtain that

$$
H\left(S, X_{T}^{S}\right)^{2}=-\frac{1}{2} \int_{0}^{T} \mathbb{E}\left(\frac{\sqrt{f_{S}\left(X_{t}^{S}\right)}}{2 \sqrt{f_{t}^{S}\left(X_{t}^{S}\right)}}\left[\frac{h_{t}^{S^{\prime \prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}-X_{t}^{S} \frac{h_{t}^{S^{\prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}\right]\right) d t .
$$

Using the fact that $\mathbb{E}\left(\frac{h_{t}^{S^{\prime \prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}-X_{t}^{S} \frac{h_{t}^{S^{\prime}\left(X_{t}^{S}\right)}}{h_{t}^{S}\left(X_{t}^{S}\right)}\right)=0$, the Cauchy-Swartz inequality and the definition of the Hellinger distance we then establish that

$$
H\left(S, X_{T}^{S}\right)^{2} \leq \frac{1}{\sqrt{2}} \sup _{t \leq T} H\left(S, X_{t}^{S}\right) \int_{0}^{T}\left\|\frac{h_{t}^{S^{\prime \prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}-X_{t}^{S} \frac{h_{t}^{S^{\prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}\right\|_{2} d t
$$

As this holds for any arbitrary $T<\infty$ this implies that

$$
H(S, Z) \leq \frac{1}{\sqrt{2}} \int_{0}^{\infty}\left\|\frac{h_{t}^{S^{\prime \prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}-X_{t}^{S} \frac{h_{t}^{S^{\prime}}\left(X_{t}^{S}\right)}{h_{t}^{S}\left(X_{t}^{S}\right)}\right\|_{2} d t
$$

This bound can be seen as the equivalent of the De Bruijn identity (see, e.g., Barron, 1986) for the KL-divergence or similar expressions obtained for $p$-Wassertein distance in the celebrated work of Otto and Villani (2000) and Ledoux et al. (2015). As we do not know $h_{t}^{S}$, the right hand side of this equation is not easy to directly control. To go around this issue we re-express $\frac{h_{t}^{S^{\prime \prime}}(x)}{h_{t}^{S}(x)}-x \frac{h_{t}^{S^{\prime}}(x)}{h_{t}^{S}(x)}$ in terms of the score function $S_{X_{t}^{S}}^{S}$ and $I_{t}^{S}$, which we can do as a simple consequence of the chainrule. The advantage of this is that using the Stein identity we can re-express the score function and $I_{t}^{S}$. Indeed we remark that $S_{t}^{S}\left(X_{t}^{S}\right)$ is the unique $X_{t}^{S}$-measurable random variable such that for all $\phi \in \mathbb{C}^{\infty}(\mathbb{R})$ we have

$$
\mathbb{E}\left(S_{t}^{S}\left(X_{t}^{S}\right) \phi\left(X_{t}^{S}\right)\right)=\mathbb{E}\left(\phi^{\prime}\left(X_{t}^{S}\right)\right)
$$

Similarly we remark that $I_{t}^{S}\left(X_{t}^{S}\right)$ is the unique $X_{t}^{S}$-measurable random variable such that for all $\phi \in \mathbb{C}^{\infty}(\mathbb{R})$ we have

$$
\mathbb{E}\left(I_{t}^{S}\left(X_{t}^{S}\right) \phi\left(X_{t}^{S}\right)\right)=\mathbb{E}\left(\phi^{\prime \prime}\left(X_{t}^{S}\right)\right)
$$

Therefore using the Stein identity we can prove that

$$
\begin{aligned}
& S_{X_{t}^{S}}^{S}\left(X_{t}^{S}\right)=\left\{\begin{array}{l}
e^{t} \mathbb{E}\left(S_{S}(S) \mid X_{t}^{S}\right) \\
\frac{1}{\sqrt{1-e^{-2 t}}} \mathbb{E}\left(Z \mid X_{t}^{S}\right)
\end{array}\right. \\
& I_{t}^{S}\left(X_{t}^{S}\right)=\left\{\begin{array}{l}
\frac{e^{t}}{\sqrt{1-e^{-2 t}}} \mathbb{E}\left(S_{S}(S) Z \mid X_{t}^{S}\right) \\
\frac{1}{1-e^{-2 t}} \mathbb{E}\left(Z^{2}-1 \mid X_{t}^{S}\right)
\end{array}\right.
\end{aligned}
$$

The last step of the proof is to notice that $\tau_{t}^{\prime}, S$ and $\tau_{t}^{S}$ are centered with respect to the conditional expectation: $\mathbb{E}\left(\tau_{t}^{S} \mid X_{t}^{S}\right)=\mathbb{E}\left(\tau_{t}{ }^{\prime}, S \mid X_{t}^{S}\right)=0$. Indeed we establish that for all smooth function $\Phi \in \mathbb{C}^{\infty}(\mathbb{R})$ we have

$$
\left.\begin{array}{rl}
\mathbb{E}\left(\tau_{t}^{\prime}, S\right. \\
S & \left.\left(X_{t}^{S}\right)\right)
\end{array}\right)=\mathbb{E}\left(\Phi\left(X_{t}^{S}\right)\right)-\mathbb{E}\left(\Phi\left(e^{-t} S^{t}+\sqrt{1-e^{-2 t}} Z\right)\right)
$$

where to obtain (a) we use the fact that $\left(S, S^{t}\right)$ is an exchangeable pair. As this holds for arbitrary $\Phi$ this directly implies that $\mathbb{E}\left(\tau_{t}^{\prime}, S \mid X_{t}^{S}\right)=0$. Similarly we prove that $\mathbb{E}\left(\tau_{t}^{S} \mid X_{t}^{S}\right)=0$. This establishes Thm. 5.

### 3.6. Proof sketch for Thm. 4

To prove Thm. 4 we build an exchangeable pair $\left(S_{n}, S_{n}^{t}\right)$ in the following way: We first start by drawing an independent copy $\left(Y_{i}^{\prime}\right)$ of $\left(Y_{i}\right)$. We set a $\kappa>0$ and write $c(t)=\sqrt{\kappa} \sqrt{1-e^{-2 t}}$. Then for every $t>0$ we choose an index $I \sim \operatorname{unif}\{1, \ldots, \mathrm{n}\}$ at random and change the random variable $Y_{i}$ by its independent copy $Y_{i}^{\prime}$ if and only if both $\left|Y_{i} / \sqrt{n}\right| \leq c(t)$ and $\left|Y_{i}^{\prime} / \sqrt{n}\right| \leq c(t)$ :

$$
S_{n}^{t} \triangleq S_{n}+\frac{1}{\sqrt{n}} \mathbb{I}\left(\left|Y_{i} / \sqrt{n}\right|,\left|Y_{i} / \sqrt{n}\right| \leq c(t)\right)\left(Y_{i}^{\prime}-Y_{i}\right) .
$$

As the observations $\left(Y_{i}\right)$ are i.i.d we remark that $\left(S_{n}, S_{n}^{t}\right)$ is indeed an exchangeable pair. The advantage of this choice of exchangeable pair is that we have

$$
\mathbb{E}\left(S_{n}^{t} \mid S_{n}\right) \approx S_{n}, \quad \frac{1}{2} \mathbb{E}\left(\left(S_{n}^{t}-S_{n}\right)^{2} \mid S_{n}\right) \approx 1
$$

This will allow us to obtain small upper bounds for $\left\|\frac{e^{-2 t}}{\sqrt{1-e^{-2 t}}} Z-e^{-t} \tilde{S}_{n}+\tau_{t}\right\|_{2 p^{\prime \prime}}$ and $\| \frac{e^{-2 t}}{1-e^{-2 t}}\left(Z^{2}-\right.$ 1) $-\frac{e^{-t}}{\sqrt{1-e^{-2 t}}} \tilde{S}_{n} Z+\tau_{t}^{\prime} \|_{2}$ and thereore control $H\left(S_{n}, Z\right)$.

## 4. Efficient Concentration with Stein Kernels

In the previous section, we showed how we can use the Hellinger distance to obtain an efficient concentration inequality when Assump. $(\tilde{f})$ holds. In this section, we will see how one can also obtain efficient concentration inequalities under the alternative condition than the random variables $\left(Y_{i}\right)$ admit a Stein kernel. This can be useful notably for a certain number of discrete random variables that have a Stein kernel but not a score function. However, we note that not all random variables that satisfy Assump. ( $\tilde{f}$ ) will also admit a Stein kernel or have it nicely controlled. Therefore the two approaches are complementary. Finally, we will see in Thm. 8 how when both exist we can exploit this to obtain an even tighter concentration inequality.

The notion of a Stein kernel was first used in Cacoullos and Papathanasiou (1992), although the term "Stein kernel" was introduced by Ley et al. (2017). A function $\tau$ is called the Stein kernel of a standardized random variable $X$ if for all functions $\phi \in \mathbb{C}^{1}(\mathbb{R})$ we have:

$$
\mathbb{E}(\phi(X) X)=\mathbb{E}\left(\tau(X) \phi^{\prime}(X)\right) .
$$

If $X$ is a continuous random variable with $\operatorname{PDF} f_{X}$, and if $f_{X}$ has as support a (potentially infinite) connected interval $(a, b)$ then, under some regular stability conditions on $f_{X}$, the Stein kernel is given by $\tau(x)=\frac{1}{f_{X}(x)} \int_{x}^{\infty} t f_{X}(t) d t$ (Ley et al., 2017). Notably, if $X$ is a standard normal random variable then its Stein kernel is given by $\tau(X)=1$. When the random variable $X$ does not possess such a density, the Stein kernel sometimes still exists, this is for example the case if the random variables satisfy a Poincare inequality (Fathi, 2019). In other cases, the existence has been established on a case-by-case basis.

This is notably true if $X$ is a symmetric random variable with support $\{-1,+1\}$ (Chatterjee, 2012). See Ley et al. (2017) for other examples of Stein kernels and discussion about its existence. However, it is important to note that, in general, a Stein kernel does not always exist (even when $X$ is continuous), and general conditions for its existence are not well determined.

## Efficient Concentration

The Stein kernel can measure the distance between $X$ and a standard normal random variable by defining the Stein discrepancy:

$$
\mathcal{S}(X \| Z) \triangleq\|\tau(X)-1\|_{2} .
$$

Similarly for $p \geq 2$, we can define the following distance $\mathcal{S}_{p}(X \| Z) \triangleq\|\tau(X)-1\|_{p}$. While the Stein kernel can be hard to control, it has proven to be a useful quantity. Notably, Ledoux et al. (2015) has explored how it can be used to bound the $p$-Wassertein distance and the KL divergence between a random variable and a standard normal random variable. It has also been used in Ledoux et al. (2015) to upper-bound the moments of Lipchitz functions of $S_{n}$. In this section, we established how it can also be used to obtain efficient concentration inequalities.

Assumption $\left(\tau_{\tilde{Y}_{1}}, p^{\prime}\right)$ Assume that $\sigma^{-1} Y_{1}$ admit a Stein kernel $\tau_{\tilde{Y}_{1}}$ and that $\left\|\tau_{\tilde{Y}_{1}}\left(\sigma^{-1} Y_{1}\right)\right\|_{p^{\prime}}<\infty$.
In the following we are going to take $\hat{Q}_{n}(x)$ to be such that for all $x>0$

$$
\sup _{t \geq 0} \mathbb{P}\left(e^{-t} \tilde{S}_{n}+\sqrt{1-e^{-2 t}} Z \geq x\right) \leq \hat{Q}_{n}(x)
$$

We prove in Lem. 28 that $\hat{Q}_{n}(x)$ can be chosen to be the Hoeffding bound for $R^{2}$ sub-Gaussian random variables or the upper bound obtained in Thm. 13. For all $p>1$ we write

$$
D_{p}\left(\tau_{\tilde{Y}_{1}}\right) \triangleq \min \left\{\begin{array}{l}
A_{p}\left\|\tau_{\tilde{Y}_{1}}\left(\sigma^{-1} Y_{1}\right)-1\right\|_{2}+A_{n, p}^{*}\left\|\tau_{\tilde{Y}_{1}}\left(\sigma^{-1} Y_{1}\right)-1\right\|_{p} . \\
\sqrt{p-1}\left\|\tau_{\tilde{Y}_{1}}\left(\sigma^{-1} Y_{1}\right)-1\right\|_{p}
\end{array} .\right.
$$

Theorem 6 (Efficient Stein kernel tail bound) Let $p^{\prime} \geq 2$. Suppose that the random variables $\left(Y_{i}\right)$ satisfy Assump. $(R, \sigma)$ and Assump. $\left(\tau_{\tilde{Y}_{1}}, p^{\prime}\right)$. Choose $\alpha>0$ and let $p \geq 1$ and $q \geq 2$. Define $u_{\alpha}(x) \triangleq \frac{1}{\alpha^{2}} \int_{x}^{x+\alpha} \int_{t}^{t+\alpha} \mathbb{I}(z \geq u) d z d t$ and let $Z \sim N(0,1)$ then we have

\begin{aligned}
& \mathbb{P}\left(S_{n} \geq \sigma u\right) \\
& \leq \mathbb{E}\left(u_{\alpha}(Z)\right)+\frac{D_{p}\left(\tau_{\tilde{Y}_{1}}\right)}{\sqrt{n}} \min \left\{\begin{array}{l}
\|Z\|_{p}\left[\left\|u_{\alpha}^{\prime}(Z)\right\|_{\frac{p}{p-1}}+\frac{\pi \mathcal{W}_{\frac{p q}{(p-1)}}\left(G, \tilde{S}_{n}\right) \hat{Q}_{n}(u-2 \alpha)^{\frac{(p-1)(q-1)}{p q}}}{4 \alpha^{2}}\right] \\
\frac{1}{2 \alpha^{2}} \hat{Q}_{n}(u-2 \alpha)^{\frac{(p-1)}{p}}
\end{array}\right] \\
& <\mathbb{P}(Z \geq u-2 \alpha)+\frac{D_{p}\left(\tau_{\tilde{Y}_{1}}\right)}{\sqrt{n}} \min \left\{\begin{array}{c}
\|Z\|_{p}\left[\frac{1}{\alpha} \mathbb{P}(Z \in[u-2 \alpha, u])^{\frac{p-1}{p}}+\frac{\pi}{4 \alpha^{2}} \mathcal{W}_{\frac{p q}{(p-1)}}\left(G, \tilde{S}_{n}\right)\right. \\
\left.\hat{Q}_{n}(u-2 \alpha)^{\frac{(p-1)(q-1)}{p q}}\right] \\
\frac{1}{2 \alpha^{2}} \hat{Q}_{n}(u-2 \alpha)^{\frac{(p-1)}{p}}
\end{array} .\right.
\end{aligned}
$$

Remark 1 We note that a tighter but less interpretable bound is presented in Lem. 27. Moreover we remark that as $p$ increases the terms $\left\|u_{\alpha}^{\prime}(Z)\right\|_{\frac{p}{p-1}}$ and $\hat{Q}_{n}(u-2 \alpha)^{\frac{(p-1)(q-1)}{p q}}$ decrease, and that both are asymptotically bounded by respectively $\mathbb{P}(Z \in[u-2 \alpha, u]) \leq 2 \alpha \varphi(u-2 \alpha)$ and $e^{-\frac{(u-2 \alpha)^{2}}{2 R^{2}}}$.

We remark that similarly to Thm. 5 we can obtain a similar efficient two-sided tail bound. This is presented in Lem. 25. The proof can be found in App. E. See Sec. 4.1 for a proof sketch.

Let us compare this result to what has been previously obtained in the literature. Under the condition that the Stein kernel $\tau_{\tilde{Y}_{1}}(\cdot)-1$ is almost surely bounded by $\mathcal{S}_{\infty}\left(\sigma^{-1} Y_{1} \| Z\right)$ then Chatterjee (2012) proved that there is $G \sim N(0,1)$ normally distributed such that for all $\theta>0$

$$
\mathbb{E}\left(e^{\theta\left|\tilde{S}_{n}-G\right|}\right) \leq 2 e^{2 \theta^{2} \mathcal{S}_{\infty}\left(\sigma^{-1} Y_{1} \| Z\right)^{2}} .
$$

$G$ is called a strong embedding of $\tilde{S}_{n}$. If the Stein kernel is not bounded or does not exist Bhattacharjee and Goldstein (2016) but $\mathbb{E}\left(Y_{1}^{3}\right)=0$, then Bhattacharjee and Goldstein (2016) proposed to study a slightly smoothed empirical average and obtained a similar inequality. Using a union bound and a Markov inequality, this can be used to obtain efficient concentration inequalities for $S_{n}$ :

Theorem 7 (Alternative Stein kernel tail bound) Suppose that the random variables satisfy Assump. $(R, \sigma)$ and Assump. $\left(\tau_{\tilde{Y}_{1}}, p^{\prime}\right)$ with $p^{\prime}=\infty$.

Then for all $u>0$ and $0<\alpha<u / 2$ the following holds

$$
\begin{equation*}
\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \Phi^{c}(u-2 \alpha)+2 e^{-\frac{n \alpha^{2}}{2 S_{\infty}\left(\sigma^{-1} Y_{1} \| Z\right)^{2}}} . \tag{9}
\end{equation*}
$$

We remark that Thm. 7 requires stronger moment conditions on the Stein kernel than Thm. 6 does. Moreover for illustration if we choose $p=q=2$ (which is not necessarly the optimal choice) then Thm. 6 tells us that

$$
\begin{align*}
& \mathbb{P}\left(S_{n} \geq \sigma u\right)  \tag{10}\\
& \leq \mathbb{E}\left(u_{\alpha}(Z)\right)+\frac{1}{\sqrt{n}}\left\|\tau_{\tilde{Y}_{1}}\left(\sigma^{-1} Y_{1}\right)-1\right\|_{2}\left[\left\|u_{\alpha}^{\prime}(Z)\right\|_{2}+\frac{\pi \mathcal{W}_{4}\left(G, \tilde{S}_{n}\right)}{4 \alpha^{2}} \hat{Q}_{n}(u-2 \alpha)^{\frac{1}{4}}\right] .
\end{align*}
$$

To contrast this with the bound obtained in Thm. 7, we note that $\mathbb{E}\left(u_{\alpha}(Z)\right) \leq \Phi^{c}(u-2 \alpha)$. Moreover we also remark that

$$
\left\|u_{\alpha}^{\prime}(Z)\right\|_{2} \leq \alpha^{-1} \sqrt{\mathbb{P}(Z \in[u-2 \alpha, u])} .
$$

Therefore we remark that the right-hand side of Eq. (10) is Sub-Gaussian in $u$. In contrast we notice that the second term in Eq. (9), $e^{-\frac{n \alpha^{2}}{2 S_{\infty}\left(\sigma^{-1} Y_{1} \| Z\right)^{2}}}$, does not depend on $u$. Therefore for large $u$ and moderate size $n$ the bound in Thm. 6 will tend to be tighter. Finally using Lem. 34 we know that there is a constant $K$ such that $\mathcal{W}_{4}\left(G, \tilde{S}_{n}\right) \leq \frac{\tilde{R} K}{\sqrt{n}}\left[1+o_{n}(1)\right]$.

We observe that if Assump. $(\tilde{f})$ also holds then by using Ledoux et al. (2015) we can exploit Thm. 3 to obtain an efficient concentration inequality that is exactly sub-Gaussian in $u$.
Theorem 8 (Efficient Hellinger-Stein kernel tail bound) Set $p^{\prime}=2$. Suppose that the random variables $\left(Y_{i}\right)$ satisfy Assump. $(R, \sigma)$, Assump. $(\tilde{f})$, Assump. $\left(S_{Y_{1}}, p^{\prime}\right)$ and Assump. $\left(\tau_{\tilde{Y}_{1}}, p^{\prime}\right)$. Let $\hat{Q}_{n}(u)$ and $\hat{Q}_{n}^{d}(u)$ be an any arbitrary upper bound to respectively $\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \hat{Q}_{n}(u)$ and $\mathbb{P}\left(\left|S_{n}\right| \geq \sigma u\right) \leq \hat{Q}_{n}^{d}(u)$. Suppose that $\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)\right\|_{2}<\infty$ and that $\mathcal{S}\left(\sigma^{-1} Y_{1} \| Z\right)<\infty$. Then for all $u \geq 0$ the following bounds hold

$$
\begin{aligned}
\left.\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \Phi^{c}(u)+\frac{\sqrt{2} \mathcal{S}_{2}\left(\sigma^{-1} Y_{1} \| Z\right)}{\sqrt{n}} \sqrt{\log \left(1+\frac{n\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)-\sigma^{-1} Y_{1}\right\|_{2}^{2}}{\mathcal{S}_{2}\left(\sigma^{-1} Y_{1} \| Z\right)^{2}}\right.}\right) \\
\times\left[\sqrt{\hat{Q}_{n}(u)}+\sqrt{\Phi^{c}(u)}\right]
\end{aligned}
$$

and

$$
\begin{aligned}
& \mathbb{P}\left(\left|S_{n}\right| \geq \sigma u\right) \leq 2 \Phi^{c}(u)+ \frac{\sqrt{2} \mathcal{S}_{2}\left(\sigma^{-1} Y_{1} \| Z\right)}{\sqrt{n}} \sqrt{\log \left(1+\frac{n\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)-\sigma^{-1} Y_{1}\right\|_{2}^{2}}{\mathcal{S}_{2}\left(\sigma^{-1} Y_{1} \| Z\right)^{2}}\right)} \\
& \times\left[\sqrt{\hat{Q}_{n}^{d}(u)}+\sqrt{2 \Phi^{c}(u)}\right]
\end{aligned}
$$

See Sec. 4.2 for a proof sketch and App. E. 3 for the proof. We note that the rate obtained in Thm. 8 is sub-Gaussian in $u$ and that the reminder terms decreases at a rate of $\sqrt{\log (n) / n}$. Therefore if in addition to the Stein Kernel we can also control the score function then we can obtain a tighter rate than in Thm. 7 and Thm. 6.

### 4.1. Proof sketch for Thm. 6

We note that $u_{\alpha}(x) \leq \mathbb{I}(x \leq u)$. By the monotony of the expectation this directly implies that $\mathbb{E}\left(u_{\alpha}\left(\tilde{S}_{n}\right)\right) \leq \mathbb{P}\left(\tilde{S}_{n} \geq u\right)$. Therefore if we obtain a bound on $\left|\mathbb{E}\left(u_{\alpha}\left(\tilde{S}_{n}\right)\right)-\mathbb{E}\left(u_{\alpha}(Z)\right)\right|$, we can use it to obtain a bound on $\mathbb{P}\left(\tilde{S}_{n} \geq u\right)$. The rest of the proof of Thm. 6 consists of using the Ornstein-Ulbheck interpolation and the heat equation.

To see this, we denote by $\tau_{\tilde{S}_{n}}(\cdot)$ the Stein kernel of $\tilde{S}_{n}$ and take $Z \sim N(0,1)$ to be an independent standard normal random variable. We define $P_{t} u_{\alpha}(x) \triangleq \mathbb{E}_{Z}\left(u_{\alpha}\left(e^{-t} x+\sqrt{1-e^{-2 t}} Z\right)\right)$. We remark that $t \rightarrow P_{t} u_{\alpha}$ interpolates between $P_{0} u_{\alpha}(x)=u_{\alpha}(x)$ and $P_{\infty} u_{\alpha}(x)=\mathbb{E}\left(u_{\alpha}(Z)\right)$. Therefore we have:

$$
\begin{aligned}
\left|\mathbb{E}\left(u_{\alpha}\left(\tilde{S}_{n}\right)\right)-\mathbb{E}\left(u_{\alpha}(Z)\right)\right| & =\left|\int_{0}^{\infty} \partial_{t} \mathbb{E}\left(P_{t} u_{\alpha}\left(\tilde{S}_{n}\right)\right) d t\right| \\
& \stackrel{(a)}{\leq}\left|\int_{0}^{\infty} \mathbb{E}\left(\Delta P_{t} u_{\alpha}\left(\tilde{S}_{n}\right)-\tilde{S}_{n} \nabla P_{t} u_{\alpha}\left(\tilde{S}_{n}\right)\right) d t\right| \\
& \stackrel{(b)}{\leq}\left|\int_{0}^{\infty} \mathbb{E}\left(\Delta P_{t} u_{\alpha}\left(\tilde{S}_{n}\right)\left(1-T_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)\right)\right) d t\right|
\end{aligned}
$$

where to obtain (a) we used the heat equation satisfied by the Ornstein-Uhlenbeck process and where (b) is a consequence of the definition of Stein kernels.

It is well known (see e.g (Ledoux et al., 2015)) that $\tau_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)=\mathbb{E}\left(\left.\frac{1}{n} \sum_{i=1}^{n} \tau_{\tilde{Y}_{1}}\left(Y_{i}\right) \right\rvert\, \tilde{S}_{n}\right)$. Therefore as $\mathbb{E}\left(\tau_{\tilde{Y}_{1}}\left(Y_{1}\right)\right)=1$ for all $p \geq 1$ there is a constant $K_{p}$ such that

$$
\left\|\tau_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)-1\right\|_{p} \leq\left\|\frac{1}{n} \sum_{i=1}^{n} \tau_{\tilde{Y}_{1}}\left(Y_{i}\right)-1\right\|_{p} \leq \frac{K_{p}}{\sqrt{n}}\left\|\tau_{\tilde{Y}_{1}}\left(Y_{1}\right)-1\right\|_{p}
$$

Therefore if we can control the size of $\partial_{t}^{2} P_{t} u_{\alpha}\left(\tilde{S}_{n}\right)$ then we will obtain that $\left|\mathbb{E}\left(u_{\alpha}\left(\tilde{S}_{n}\right)\right)-\mathbb{E}\left(u_{\alpha}(Z)\right)\right|=$ $O\left(\frac{1}{\sqrt{n}}\right)$. The remainder of the proof consists of controlling $\Delta P_{t} u_{\alpha}\left(\tilde{S}_{n}\right)$. This is what we do thanks to the Stein identity and the Wassertein distance.

### 4.2. Proof sketch of Thm. 8

The proof of Thm. 8 is based on Thm. 3 which guarantees that

$$
\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \Phi^{c}(u)+\sqrt{2} H\left(\sigma^{-1} S_{n}, Z\right)\left[\sqrt{\hat{Q}_{n}(u)}+\sqrt{\Phi^{c}(u)}\right]
$$

and Theorem 2.2 of Ledoux et al. (2015) which upper bounds the KL-divergence $K L\left(\tilde{S}_{n} \| Z\right)$ in terms of the Stein kernel.

## 5. Efficient Concentration with Zero-Bias Couplings

In the prior two sections, we showed how to obtain efficient concentration given auxiliary knowledge of a score function or Stein kernel. In the remainder, we will establish efficient concentration without any additional knowledge beyond Assump. $(R, \sigma)$. We achieve this in the present section by tightly bounding a non-uniform Kolmogorov distance using zero-bias couplings. As in Chen et al. (2011, Prop. 2.1), we say that $S^{\star}$ has the zero-bias distribution for a mean-zero random variable $S$ with $\operatorname{Var}(S)<\infty$ if the distribution of $S^{\star}$ is absolutely continuous with Lebesgue density $p^{\star}(x)=\mathbb{E}[S \mathbb{I}[S>x]] / \operatorname{Var}(S)$ or, equivalently, if $\sigma^{2} \mathbb{E}\left[f^{\prime}\left(S^{\star}\right)\right]=\mathbb{E}[S f(S)]$ for all absolutely continuous $f$ with $\mathbb{E}[|S f(S)|]<\infty$. Our main result, proved in App. F, uses a close coupling of $S_{n}$ and its zero-biased counterpart to establish efficient concentration.

Theorem 9 (Efficient zero-bias tail bound) Suppose $S_{n}=\sum_{i=1}^{n} X_{i}$ for independent $\left(X_{i}\right)_{i \geq 1}$ satisfying $\mathbb{E}\left[X_{i}\right]=0, \operatorname{Var}\left(X_{i}\right)=\sigma_{i}^{2}, \sum_{i=1}^{n} \sigma_{i}^{2}=\sigma^{2}$, and $\left|X_{i}\right| \leq \frac{R}{\sqrt{n}}$ almost surely. Define the auxiliary variable

$$
S_{n}^{\prime} \triangleq S_{n}+X_{I}^{\prime}-X_{I} \quad \text { for } \quad X_{i}^{\prime} \triangleq X_{i}^{\star}+U\left(X_{i}-X_{i}^{\star}\right) \quad \text { and } \quad \mathbb{P}(I=i)=\frac{\sigma_{i}^{2}}{\sigma^{2}} \mathbb{I}[1 \leq i \leq n]
$$

where each $X_{i}^{\star}$ has the zero-bias distribution of $X_{i}$, and $U \sim \operatorname{Unif}([0,1]), I$, and $\left(X_{i}^{\star}\right)_{i \geq 1}$ are mutually independent and independent of $\left(X_{i}\right)_{i \geq 1}$. Then, for all $u \geq 0$ and $\lambda \in[0,1]$,

$$
\begin{aligned}
\mathbb{P}\left(S_{n}>\sigma u+\frac{2 R}{\sqrt{n}}\right) & \leq \frac{\sigma \sqrt{n}}{\sigma \sqrt{n}+2 R \delta_{u}} \Phi^{c}(u)+\frac{2 R}{\sigma \sqrt{n}+2 R \delta_{u}}\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{P}\left(S_{n}^{\prime}>\lambda \sigma u\right) \\
& +\frac{2 R}{\sigma \sqrt{n}+2 R \delta_{u}} h_{u}(\lambda u)
\end{aligned}
$$

where, for all $w \leq u$,

$$
\begin{align*}
h_{u}(w) & \triangleq\left(w+\left(1+w^{2}\right) \sqrt{2 \pi} \exp \left(\frac{w^{2}}{2}\right) \Phi(w)\right) \Phi^{c}(u) \quad \text { and }  \tag{11}\\
\delta_{u} & \triangleq h_{u}(u)-\left(\frac{2}{u+\sqrt{u^{2}+8 / \pi}}-\frac{8 u}{\pi\left(u+\sqrt{u^{2}+8 / \pi}\right)^{2}}\right) \Phi(u) \tag{12}
\end{align*}
$$

If, in addition, $\left(X_{i}\right)_{i=1}^{n+1}$ are identically distributed, then

$$
\begin{aligned}
& \mathbb{P}\left(S_{n}>\sigma u \frac{\sqrt{n+1}}{\sqrt{n}}+\frac{R}{\sqrt{n}}\right) \\
& \leq \frac{\sigma \sqrt{n+1}}{\sigma \sqrt{n+1}+2 R \delta_{u}} \Phi^{c}(u)+\frac{2 R}{\sigma \sqrt{n+1}+2 R \delta_{u}}\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{P}\left(S_{n}+X_{n+1}^{\prime}>\lambda \sigma u\right) \\
& +\frac{2 R}{\sigma \sqrt{n+1}+2 R \delta_{u}} h_{u}(\lambda u) .
\end{aligned}
$$

Our next result, proved in App. G, shows how to convert concentration inequalities for bounded variables into valid tail bounds for $S_{n}^{\prime}$ and $S_{n}+X_{n+1}^{\prime}$.

Proposition 10 (Properties of $S_{n}^{\prime}$ ) Under the notation and assumptions of Thm. 9, the following claims hold for each $i \geq 1$ and $t \in \mathbb{R}$.

1. $\left|\mathbb{E}\left[X_{i}^{\prime}\right]\right| \leq \frac{R}{4 \sqrt{n}}, \quad \operatorname{Var}\left(X_{i}^{\prime}\right) \in \frac{\sigma_{i}^{2}}{3}+\left[\frac{R^{2}}{36 n}, \frac{R^{2}}{9 n}\right], \quad\left|X_{i}^{\prime}\right| \leq \frac{R}{\sqrt{n}} \quad$ almost surely.
2. $\mathbb{P}\left(S_{n}^{\prime}>t+\frac{R}{4 \sqrt{n}}\right) \leq \sum_{i=1}^{n} \frac{\sigma_{i}^{2}}{\sigma^{2}} \mathbb{P}\left(X_{i}^{\prime}-\mathbb{E}\left[X_{i}^{\prime}\right]+\sum_{j \neq i} X_{j}>t\right)$.
3. If, in addition, $\left(X_{i}\right)_{i=1}^{n+1}$ are identically distributed, then $S_{n}+X_{n+1}^{\prime} \stackrel{d}{=} \frac{\sqrt{n+1}}{\sqrt{n}} S_{n+1}^{\prime}$.

Remark 2 A convenient default upper bound is given by the minimum of the Hoeffding, Bernstein (Boucheron et al., 2013, Cor. 2.11), and Berry-Esseen (Shevtsova, 2010) tail bounds for unidentically distributed summands and $\sigma_{\mathrm{low}, i}^{2} \triangleq \sigma^{2}+\frac{R^{2}}{36 n}-\frac{2 \sigma_{i}^{2}}{3}$ :

$$
\begin{aligned}
& \mathbb{P}\left(S_{n}^{\prime}>t+\frac{R}{4 \sqrt{n}}\right) \\
\leq & \sum_{i=1}^{n} \frac{\sigma_{i}^{2}}{\sigma^{2}} \min \left(e^{-\frac{t^{2}}{2 R^{2}+\frac{9}{8 n} R^{2}}}, e^{-\frac{t^{2}}{2\left(s_{i}^{2}+\frac{R t}{3 \sqrt{n})}\right.}}, \Phi^{c}\left(\frac{t}{\sigma \operatorname{low}, i}\right)+\frac{0.56 R}{\sqrt{n}} \frac{\sigma^{2}+\left(5 R^{2}-21 n \sigma_{i}^{2}\right) /(36 n)}{\sigma_{\mathrm{low}, i}^{3}}\right) .
\end{aligned}
$$

where $\tilde{s}_{i}^{2}:=\sigma^{2}+\left(25 R^{2}-96 n \sigma_{i}^{2}\right) /(144 n)$.
Taken together, Thm. 9, Prop. 10, , and Rem. 2 imply that, for universal constants $c_{1}, c_{2}>0$ independent of ( $u, n, R, \sigma$ ),

$$
\mathbb{P}\left(S_{n} \geq \sigma u+\frac{2 R}{\sqrt{n}}\right) \leq \Phi^{c}(u)+\frac{c_{1} R}{\sigma \sqrt{n}} \exp \left(-c_{2} \frac{u^{2}}{R^{2}}\right)
$$

whenever Assump. $(R, \sigma)$ holds.

## 6. Efficient Concentration with Wasserstein Approximation

In the two previous sections, we showed how to obtain efficient concentration given auxiliary knowledge of a score function or Stein kernel. In this section, we again establish efficient concentration without any knowledge beyond Assump. $(R, \sigma)$. To do so, we measure how far $S_{n}$ is from a normal by the $p$-Wassertein distance $\mathcal{W}_{p}(\cdot, \cdot)$, defined in the following way:

$$
\mathcal{W}_{p}(\nu, \mu)=\inf _{\gamma \in \varphi(\nu, \mu)} \mathbb{E}_{(X, Y) \sim \gamma}\left(|X-Y|^{p}\right)^{1 / p}
$$

where $\gamma(\nu, \mu)$ is the set of all possible couplings of the probability distributions $\nu$ and $\mu$ on $\mathbb{R}$.

### 6.1. Efficient tail bounds

When Assump. $(R, \sigma)$ holds we obtain in Thm. 11 below that, for each $u>0$,

$$
\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \Phi^{c}\left(u-\frac{5.5 R \log (n)}{\sigma \sqrt{n}}\right)\left[1+o_{n}(1)\right]+\frac{5.5 R}{\sqrt{n} \sigma} \varphi\left(u-\frac{5.5 R \log (n)}{\sigma \sqrt{n}}\right)\left[1+o_{n}(1)\right] .
$$

Notably, this bound is asymptotically exact, converging to the correct asymptotic tail bound $\Phi^{c}(u)$ as $n \rightarrow \infty$, with an error term that is asymptotically sub-Gaussian in $u$. To state our result more precisely, we define the growth constant

$$
K \triangleq \frac{1}{\sqrt{0.4}}\left[R+\frac{\sqrt{0.4 e} \sigma}{2 \sqrt{2}}\right]+\frac{2 \sqrt{e} R}{\sqrt{1.2}}\left[e^{0.8}-1.8\right]\left[2-\frac{2 \sigma}{3 R}\right] \approx 3.71 R,
$$

the interpolation parameter

$$
\begin{aligned}
\rho_{n, u}^{\star} & \triangleq \frac{\sigma}{e K u}\left(\sqrt{n+\frac{2 e K}{\sigma^{2}}\left(\sqrt{n} u \sigma-e K\left(2+\log \left(\frac{\sqrt{2 \pi n \sigma^{2}}}{K e}\right)\right)\right)^{+}}-\sqrt{n}\right) \\
& \approx 1-\frac{e K \sigma}{\sqrt{n} u} \log \left(\frac{\sqrt{n} \sigma \sqrt{2 \pi}}{e K}\right) \approx 1-\frac{5 \cdot 05 R \log \left(0.25 n \sigma^{2} / R^{2}\right) \sigma}{\sqrt{n} u},
\end{aligned}
$$

and the correction power

$$
L_{n, u} \triangleq \frac{\left(1-\rho_{n, u}^{\star}\right) \sqrt{n} u \sigma}{K e}-2 \approx 5.05 R \log \left(0.25 n \sigma^{2} / R^{2}\right) .
$$

To first order, Thm. 11 establishes that $\mathbb{P}\left(S_{n} \geq \sigma u\right) \leq \Phi^{c}\left(\rho_{n, u}^{\star} u\right)\left[1+o_{n}(1)\right]+\frac{e K}{\sqrt{n} \sigma} \varphi\left(\rho_{n, u}^{\star} u\right)[1+$ $\left.o_{n}(1)\right]$. To make this bound exact we incorporate a small correction term $r_{n, u}$ of order $\frac{R^{2} \log (n)^{5 / 2}}{\sigma^{2} n} \varphi\left(\rho_{n, u}^{\star} u\right)$ defined in App. H.1. Under this notation, we have the following efficient tail bound for $S_{n}$, proved in App. H.
Theorem 11 (Efficient tail bound) If $S_{n}$ satisfies Assump. $(R, \sigma)$ and $2 \leq L_{n, u} \leq 1+\frac{0.4 \sigma^{2} n}{R^{2}}$, then

$$
\begin{aligned}
\mathbb{P}\left(S_{n} \geq \sigma u\right) & \leq \Phi^{c}\left(\rho_{n, u}^{\star} u\right)+\frac{e K}{\sqrt{n} \sigma} \varphi\left(\rho_{n, u}^{\star} u\right)\left[1+r_{n, u}\right]^{L_{n, u}} \\
& \underset{n \rightarrow \infty}{\lesssim} \Phi^{c}\left(u-\frac{\stackrel{\star}{R} \log (n)}{\sigma \sqrt{n}}\right)+\frac{\stackrel{\star}{R}}{\sqrt{n} \sigma} \varphi\left(u-\frac{\stackrel{\star}{R} \log (n)}{\sigma \sqrt{n}}\right)+O\left(\frac{R^{2} \log (n)^{5 / 2}}{\sigma^{2} n} \varphi\left(\rho_{n, u}^{\star} u\right)\right),
\end{aligned}
$$

where $\stackrel{\star}{R}:=5.5 R$.
Remark 3 The constant 5.5 can be significantly reduced at the price of a more complicated expression. We also present a tighter but less interpretable bound that holds for all $u \geq 0$ in Sec. 6.3.

### 6.2. Efficient quantile bounds

Similarly to how the Wassertein distance can be used to obtain efficient tail bounds it can also be used to obtain efficient quantile bounds. To do so we once again tightly bound the distance between $S_{n}$ and its Gaussian limit. The quantile bounds we obtain in Thm. 12 are of the order

$$
\begin{aligned}
q_{n}(R, \delta, \sigma) & \underset{n \rightarrow \infty}{\sim}-\sigma \Phi^{-1}\left(\delta-\frac{e K}{\sigma \sqrt{n}} \varphi\left(\Phi^{-1}(\delta)\right)\right)+\frac{e K}{\sqrt{n}} \log \left(\frac{\sqrt{n} \sigma}{e K} \varphi\left(\Phi^{-1}(\delta)\right)^{-1}\right) \\
& \approx-\sigma \Phi^{-1}\left(\delta-\frac{10.1 R}{\sigma \sqrt{n}} \varphi\left(\Phi^{-1}(\delta)\right)\right)+\frac{10.1 R}{\sqrt{n}} \log \left(\frac{\sqrt{n} \sigma}{10.1 R} \varphi\left(\Phi^{-1}(\delta)\right)^{-1}\right)
\end{aligned}
$$

Notably, as the sample size increases these bounds converge to the true asymptotic quantiles $-\sigma \Phi^{-1}(\delta)$, guaranteeing efficiency. To state our result in full, we introduce the shorthand

$$
A_{\delta}^{n} \triangleq \log \left(\frac{\sqrt{n} \sigma}{e K} \varphi\left(\Phi^{-1}(\delta)\right)^{-1}\right)
$$

and an explicit correction term $s_{\delta, n}$ of order $\frac{R^{2} \log (n)^{5 / 2}}{n \sigma}$ defined in App. H.3. With this notation in place, we have the following efficient quantile bound for $S_{n}$, proved in App. H.
Theorem 12 (Efficient quantile bound) If $S_{n}$ satisfies Assump. $(R, \sigma), A_{\delta}^{n} \geq 2$, and $0 \leq \frac{R^{2}\left(A_{\delta}^{n}-1\right)}{0.4 n \sigma^{2}} \leq$ 1 then $P\left(S_{n} \geq q_{n}(R, \delta, \sigma)\right) \leq \delta$ for

$$
\begin{aligned}
q_{n}(R, \delta, \sigma) & \triangleq \sigma \Phi^{-1}\left(\delta-\frac{e K}{\sigma \sqrt{n}} \varphi\left(\Phi^{-1}(\delta)\right)\right)+\frac{e\left[A_{\delta}^{n}+2\right]}{\sqrt{n}}\left[K+s_{\delta, n}\right] \\
& \approx-\sigma \Phi^{-1}\left(\delta-\frac{10.1 R}{\sqrt{n}} \varphi\left(\Phi^{-1}(\delta)\right)\right)+\frac{10.1 R}{\sqrt{n}} \log \left(\frac{\sqrt{n} \sigma}{10.1 R} \varphi\left(\Phi^{-1}(\delta)\right)^{-1}\right) .
\end{aligned}
$$

Remark 4 This bound can be used to build efficient confidence intervals with nominal coverage. Moreover, the constant 10.1 can be significantly reduced at the price of a more complicated expression. In Sec. 6.3, we present a tighter but less interpretable quantile bound (Thm. 14) that holds for all $\delta \in(0,1)$.

Efficient Concentration

### 6.3. Tighter computable bounds

In this section we propose tighter concentration inequalities and quantile approximations for $S_{n}$ than the ones presented in Sec. 6. While these bounds are less interpretable, they are straightforwardly computed and hence can be used to produce tighter tail bounds and confidence intervals in practice.

First, we obtain a tighter bound for $\mathbb{P}\left(S_{n} \geq \sigma u\right)$, proved in App. I.
Theorem 13 (Tighter efficient tail bound) If $S_{n}$ satisfies Assump. ( $R, \sigma$ ), then, for any auxiliary upper bounds $\hat{Q}_{n}(u)$ and $\hat{Q}_{n}^{d}(u)$ on $P\left(S_{n} \geq \sigma u\right)$ and $P\left(\left|S_{n}\right| \geq \sigma u\right)$ respectively, we have

$$
\begin{gathered}
P\left(S_{n} \geq \sigma u\right) \leq \min \left(\inf _{p \in[2, \infty) \bigcap\{1\}, \rho \in(0,1)} \Phi^{c}(\rho u)+\frac{\omega_{p}^{R}(\sigma)^{p}}{(1-\rho)^{p}(u \sigma)^{p}}, \hat{Q}_{n}(u)\right) ; \quad \text { and } \\
P\left(\left|S_{n}\right| \geq \sigma u\right) \leq \min \left(\inf _{p \in[2, \infty) \bigcap\{1\}, \rho \in(0,1)} 2 \Phi^{c}(\rho u)+\frac{\omega_{p}^{R}(\sigma)^{p}}{(1-\rho)^{p}(u \sigma)^{p}}, \hat{Q}_{n}^{d}(u)\right)
\end{gathered}
$$

for $\omega_{p}^{R}(\sigma)$ a computable bound on $\frac{1}{\sigma} \mathcal{W}_{p}\left(S_{n}, \mathcal{N}\left(0, \sigma^{2}\right)\right)$ defined in App. I.1 that is non-decreasing in $\sigma$.

Remark 5 (Auxiliary tail bounds) We include the auxiliary bounds $\hat{Q}_{n}(u)$ and $\hat{Q}_{n}^{d}(u)$ to emphasize that our efficient bounds can be paired with any valid tail bounds to simultaneously reap the large-sample benefits of the former and the small-sample benefits of the latter. The HoeffdingBernstein bounds $\hat{Q}_{n}(u)=\min \left(e^{-\frac{u^{2} \sigma^{2}}{2 R^{2}}}, e^{-\frac{u^{2}}{2(1+R u / 3 \sigma)}}\right)$ and $\hat{Q}_{n}^{d}(u)=2 \hat{Q}_{n}(u)$ provide a convenient default choice.

By choosing $p=L_{n, u}$ and $\rho=\rho_{n, u}^{\star}$ in Thm. 13 we obtain a tightened version of the inequality in Thm. 11. Further improvements are obtained in practice by explicitly optimizing over $p$ and $\rho$.

Next we obtain tighter bounds for the quantiles of $S_{n}$, proved in App. I.
Theorem 14 (Tighter efficient quantile bound) If $S_{n}$ satisfies Assump. $(R, \sigma)$, and some auxiliary deterministic bounds $\tilde{q}_{n}$ and $\tilde{q}_{n}^{d}$ satisfy $P\left(S_{n} \geq \tilde{q}_{n}(R, \delta, \sigma)\right) \leq \delta$ and $P\left(\left|S_{n}\right| \geq \tilde{q}_{n}^{d}(R, \delta, \sigma)\right) \leq$ $\delta$, then

$$
\mathbb{P}\left(S_{n} \geq q_{n}(R, \delta, \sigma)\right) \leq \delta, \quad \mathbb{P}\left(\left|S_{n}\right| \geq q_{n}^{d}(R, \delta, \sigma)\right) \leq \delta
$$

for $\omega_{p}^{R}(\sigma)$ a computable bound on $\frac{1}{\sigma} \mathcal{W}_{p}\left(S_{n}, \mathcal{N}\left(0, \sigma^{2}\right)\right)$ defined in App. I.1 that is non-decreasing in $\sigma$ and

$$
\begin{aligned}
& q_{n}(R, \delta, \sigma) \triangleq \min \left(\inf _{p \geq 2, \rho \in(0,1)} \frac{\sigma \omega_{p}^{R}(\sigma)}{(\delta(1-\rho))^{1 / p}}-\sigma \Phi^{-1}(\delta \rho), \tilde{q}_{n}(R, \delta, \sigma)\right) \\
& q_{n}^{d}(R, \delta, \sigma) \triangleq \min \left(\inf _{p \geq 2, \rho \in(0,1)} \frac{\sigma \omega_{p}^{R}(\sigma)}{(\delta(1-\rho))^{1 / p}}-\sigma \Phi^{-1}\left(\frac{\delta \rho}{2}\right), \tilde{q}_{n}^{d}(R, \delta, \sigma)\right)
\end{aligned}
$$

Remark 6 (Auxiliary quantile bounds) We again highlight that our efficient bounds can be paired with any valid quantile bounds $\tilde{q}_{n}(R, \delta, \sigma)$ and $\tilde{q}_{n}^{d}(R, \delta, \sigma)$ to inherit the benefits of each. Convenient defaults are provided by the minimum of the Bernstein quantiles (Boucheron et al., 2013, Thm. 2.10) and the Berry-Esseen quantiles (Shevtsova, 2011),

$$
\begin{aligned}
& \tilde{q}_{n}(R, \delta, \sigma)=\min \left(\frac{R}{3 \sqrt{n}} \log (1 / \delta)+\sigma \sqrt{2 \log (1 / \delta)},-\sigma \Phi^{-1}\left(\delta-\frac{C_{R, \sigma}}{\sqrt{n}}\right)\right) \\
& \tilde{q}_{n}^{d}(R, \delta, \sigma)=\min \left(\frac{R}{3 \sqrt{n}} \log (2 / \delta)+\sigma \sqrt{2 \log (2 / \delta)},-\sigma \Phi^{-1}\left(\frac{\delta}{2}-\frac{C_{R, \sigma}}{\sqrt{n}}\right)\right)
\end{aligned}
$$

where we set $C_{R, \sigma}=\min (.3328(\tilde{R}+.429), .33554(\tilde{R}+.415))$.

### 6.4. Proof sketch for Thms. 11 and 13

Similarly to the proof of Thm. 6 and Thm. 3, the main idea of the proofs is to use the fact that $S_{n}=\frac{1}{\sqrt{n}} \sum_{i \leq n} Y_{i}$ is close to being normally distributed if the sample size $n \in \mathbb{N}$ is large. For ease of notation, the rest of this section we will suppose that $\sigma=1$. Note that there is no loss of generality by doing so. Fix $t \geq 0, \rho \in[0,1)$, and $p \geq 1$. For all $\epsilon>0$ we remark that there is a coupling $\left(S_{n}, G\right)$ with $G \sim N(0,1)$ such that $\left\|S_{n}-G\right\|_{p} \leq \mathcal{W}_{p}\left(S_{n}, G\right)+\epsilon$. Therefore we have

$$
\begin{aligned}
\mathbb{P}\left(S_{n} \geq t\right) & =\mathbb{P}\left(G+S_{n}-G \geq t\right) \\
& \leq \mathbb{P}(G \geq \rho t)+\mathbb{P}\left(S_{n}-G \geq(1-\rho) t\right) \\
& \leq \Phi^{c}(\rho t)+\frac{\mathbb{E}\left(\left|S_{n}-G\right|^{p}\right)}{(1-\rho)^{p} t^{p}} \\
& \leq \Phi^{c}(\rho t)+\frac{\left(\mathcal{W}_{p}\left(S_{n}, G\right)+\epsilon\right)^{p}}{(1-\rho)^{p} t p} .
\end{aligned}
$$

As this holds for any arbitrary $\epsilon>0$ we get that

$$
\begin{aligned}
\mathbb{P}\left(S_{n} \geq t\right) & =\mathbb{P}\left(G+S_{n}-G \geq t\right) \\
& \leq \Phi^{c}(\rho t)+\frac{\mathcal{W}_{p}\left(S_{n}, G\right)^{p}}{(1-\rho)^{p} t^{p}} .
\end{aligned}
$$

Imagine that $\mathcal{W}_{p}\left(S_{n}, G\right) \leq \frac{\tilde{K} p}{\sqrt{n}}$ for a constant $\tilde{K}$ and that we set $p=\frac{\sqrt{n} t(1-\rho)}{e \tilde{K}}$ then we obtain

$$
\mathbb{P}\left(S_{n} \geq t\right) \leq \Phi^{c}(\rho t)+e^{-\frac{\sqrt{n} t(1-\rho)}{e K}} .
$$

If in addition we choose ,

$$
\rho \triangleq \frac{-C_{n, t}+\sqrt{C_{n, t}^{2}+2 t^{2}\left(C_{n, t}+1-\log \left(C_{n, t} \sqrt{2 \pi} / t\right)\right)}}{t^{2}}
$$

with $C_{n, t} \triangleq \frac{\sqrt{n} t}{e \bar{K}}$ then we have

$$
\mathbb{P}\left(S_{n} \geq t\right) \lesssim \Phi^{c}(\rho t)+\frac{e \tilde{K}}{\sqrt{n}} \varphi(\rho t) ;
$$

This gives us the desired bound.

### 6.5. Proof sketch for Thms. 12 and 14

Quantiles are obtained by following a similar reasoning. Let $\delta \in\left(0, \frac{1}{2}\right)$ be a confidence level and $\alpha \in(0, \delta)$. Choose $\epsilon>0$ and $\left(S_{n}, G\right)$ to be a coupling of $S_{n}$ with a standard normal random variable that satisfies $\left\|S_{n}-G\right\|_{p} \leq \mathcal{W}_{p}\left(S_{n}, \mathcal{N}(0,1)\right)+\epsilon$. Then for all $p \geq 2$, if we write $u \triangleq$ $\frac{\mathcal{W}_{p}\left(S_{n}, G\right)}{\alpha^{1 / p}}$ then we obtain

$$
\begin{aligned}
\mathbb{P}\left(S_{n} \geq-\Phi^{-1}(\delta-\alpha)+u\right) & \leq \mathbb{P}\left(G \geq-\Phi^{-1}(\delta-\alpha)\right)+\mathbb{P}\left(S_{n}-G \geq u\right) \\
& \leq \delta-\alpha+\frac{\left(\left\|S_{n}-G\right\|_{p}+\epsilon\right)^{p}}{u^{p}} .
\end{aligned}
$$

As the choice of $\epsilon>0$ can be arbitrarily small we obtain

$$
\mathbb{P}\left(S_{n} \geq-\Phi^{-1}(\delta-\alpha)+u\right) \leq \delta-\alpha+\frac{\mathcal{W}_{p}\left(S_{n}, G\right)^{p}}{u^{p}} \leq \delta
$$

Therefore to obtain a good approximation of the quantiles of $S_{n}$ we need to choose a candidate for $\alpha$ and $p$. If we choose $p=-\log (\alpha)$ then we obtain then we can upper bound the quantile of $S_{n}$ by

$$
-\Phi^{-1}(\delta-\alpha)+e \mathcal{W}_{-\log (\alpha)}\left(S_{n}, G\right) \triangleq O\left(-\Phi^{-1}(\delta-\alpha)+\frac{-\log (\alpha)}{\sqrt{n}}\right)
$$

We choose $\alpha=O\left(\frac{\varphi\left(\Phi^{-1}(\delta)\right)}{\sqrt{n}}\right)$.

## 7. Efficient Concentration Inequalities for Smoothed Observations

We notice that when we had some additional information on the distribution of the random variables $\left(Y_{i}\right)$, e.g about their score function (see Thm. 4) and their Stein kernel (see Thm. 8), then we were able to avoid potentially lossy union bound and obtained tighter concentration inequalities. In this section we show that if the observations $\left(Y_{i}\right)$ are smoothed then we can obtain (potentially) tighter concentration inequalities without requiring any additional properties of the distribution of the random variables $\left(Y_{i}\right)$. In this goal let $D>0$ be a real and let $Z$ be an independent standard normal random variable. We define

$$
\tilde{S}_{n}^{\text {noisy }} \triangleq \sqrt{1-\frac{D}{\sqrt{n}}} \tilde{S}_{n}+\frac{\sqrt{D}}{n^{1 / 4}} Z, \quad S_{n}^{\text {noisy }} \triangleq \sigma \tilde{S}_{n}^{\text {noisy }}
$$

We show how we can obtain efficient tail bounds for $\tilde{S}_{n}^{\text {noisy }}$. In this goal, we write $\omega_{1, p, q}=$ $\mathcal{W}_{\frac{2 p q}{q-1}}\left(\tilde{S}_{n}, Z\right)$ and $\omega_{2, p, q}=\|Z\|_{\frac{p q}{q-1}}$.

Theorem 15 (Efficient smoothed tail bound) Assume that the random variables $\left(Y_{i}\right)$ satisfy Assump. $(R, \sigma)$. Let $\hat{Q}_{n}(u)$ be an arbitrary upper bound for $\mathbb{P}\left(\tilde{S}_{n} \geq u\right) \leq \hat{Q}_{n}(u)$. Then the following holds for all $\kappa \geq \max \left(\frac{\tilde{R}^{2}}{n}, \frac{\tilde{R}^{2}}{\sqrt{n} D}\right)$

$$
\begin{aligned}
& \mathbb{P}\left(S_{n}^{\text {noisy }} \geq \sigma u\right) \\
& \lesssim \Phi^{c}(u)+\inf _{p \geq 2} \frac{\hat{Q}_{n}(u)^{\frac{p-1}{p}}}{\sqrt{n}}\left\{\frac{\sqrt{e}(p-1) \tilde{R}^{2}\left(e^{2 \kappa(p-1)}-1\right)}{\sqrt{3} D \kappa}+\frac{\log \left(\frac{n}{D^{2}}\right) \sqrt{p-1} A_{p}(\tilde{R}-1)}{4 \sqrt{2}}\right\} .
\end{aligned}
$$

Remark 7 The exact bound is presented in Thm. 36. We also note that this bound could not be obtained by directly applying Thm. 4 or Thm. 8. Indeed while the score function $\tilde{S}_{n}^{\text {noisy }}$ can be seen as an empirical average of continuous random variables the amount of Gaussian noise injected is not sufficient to control its score function or its Stein kernel.

Note that one can straightforwardly bound the Wassertein distance between $S_{n}^{\text {noisy }}$ and $S_{n}$ and use this to obtain an efficient concentration inequality for the latter. Similarly if $S_{n}$ admits a Stein kernel then one could use strong embeddings (Chatterjee, 2012, Thm. 1.2) to control the tail bound of $\left|S_{n}-S_{n}^{\text {noisy }}\right|$ and use Thm. 15 to obtain an efficient concentration inequality for $S_{n}$.

### 7.1. Proof sketch for Thm. 15

The proof relies on the Ornstein-Ulbheck interpolation and the heat equation. To make this precise we write the interpolated process $X_{t} \triangleq e^{-t} \tilde{S}_{n}+\sqrt{1-e^{-2 t}} Z$. As $t$ varies from 0 to $\infty$, then $X_{t}$
transforms from $\tilde{S}_{n}$ to $Z$. We define $T_{n} \triangleq-\frac{1}{2} \log \left(1-\frac{D}{\sqrt{n}}\right)$. We note that $X_{T_{n}}$ has the same distribution than $\tilde{S}_{n}^{\text {noisy }}$. The key to the proof is then to use the heat equation to establish the following equality:

$$
\begin{aligned}
& \left|\mathbb{P}\left(\tilde{S}_{n}^{\text {noisy }} \geq u\right)-\Phi^{c}(u)\right| \\
& =\left|\int_{T_{n}}^{\infty} \mathbb{E}\left[\mathbb{I}\left(X_{t} \geq u\right) \mathbb{E}\left[\left.\frac{e^{-2 t}}{1-e^{-2 t}}\left(Z^{2}-1\right)-\frac{e^{-t}}{\sqrt{1-e^{-2 t}}} \tilde{S}_{n} Z-\tau_{t}^{\prime} \right\rvert\, X_{t}\right]\right] d t\right| .
\end{aligned}
$$

where $\left(\tau_{t}^{\prime}\right)$ is the quantity defined in Eq. (14). The proof is finished by using Hölder's inequality and bounding the norms $\left\|\frac{e^{-2 t}}{1-e^{-2 t}}\left(Z^{2}-1\right)-\frac{e^{-t}}{\sqrt{1-e^{-2 t}}} \tilde{S}_{n} Z-\tau_{t}^{\prime}\right\|_{p}$ (see Lem. 19 and Lem. 21).

## 8. Application: Efficient Empirical Berry-Esseen Bounds

The preceding sections assumed that the variance parameter $\sigma^{2}$ was a known quantity, but, in many applications, the variance is unknown and can only be estimated from data. In this section, we leverage efficient known-variance bounds to develop efficient quantile bounds that are valid even when $\sigma$ is unknown. We refer to these constructions as empirical Berry-Esseen (EBE) bounds as they combine Gaussian approximation in the spirit of Berry-Esseen Eq. (5) with empirical variance estimation.

We begin by showing how to convert generic known-variance quantile bounds into valid empiricalvariance quantile bounds. Our construction in Thm. 16 depends on the following readily-computed quantities:

- the empirical variance: $\hat{\sigma}^{2} \triangleq \frac{1}{n} \sum_{i \leq n}\left(W_{i}-\bar{W}_{n}\right)^{2}$,
- the empirical centered third moment: $\hat{m}_{3} \triangleq \frac{1}{n} \sum_{i \leq n}\left(W_{i}-\bar{W}_{n}\right)^{3}$,
- the empirical variance of $\left(W_{i}-\bar{W}_{n}\right)^{2}: \hat{m}_{4} \triangleq \frac{1}{n} \sum_{i \leq n}\left(\left(W_{i}-\bar{W}_{n}\right)^{2}-\hat{\sigma}^{2}\right)^{2}$,
- the $1-\frac{a}{4}$ quantile of the two-sided Kolmogorov-Smirnov distribution: $q_{n}^{\mathrm{KS}}(a / 4)$,
- a lower estimate for $\sigma^{2}: \sigma_{\mathrm{l}, \mathrm{a}}^{2} \triangleq \hat{\sigma}^{2}-R^{2} q_{n}^{\mathrm{KS}}\left(\frac{a}{4}\right), \quad$ and

Remark 8 The maximum and minimum elements of $A_{\delta, a_{n}}^{n}$ are roots of a depressed quartic equation that can be solved in closed form or with standard software.

Next we prove that efficient quantile bounds give rise to efficient empirical quantile bounds.
Theorem 17 (Efficient empirical Berry-Esseen bounds) Under the assumptions of Thm. 16, suppose $\tilde{q}_{n}^{d}\left(R, \sigma_{n}, \delta_{n}\right) \rightarrow-\sigma \Phi^{-1}\left(\frac{\delta}{2}\right)$ whenever $\left(\sigma_{n}, \delta_{n}\right) \rightarrow(\sigma, \delta)$. If $a_{n} \rightarrow 0, \frac{\log \left(a_{n}\right)}{n} \rightarrow 0$, and $c_{2}^{a_{n}}\left(s_{1, a_{n}}\right) \xrightarrow{\text { a.s. }} 0$, then

Remark 9 As convenient default choices, we recommend setting $a_{n}=\frac{\log n}{n}$ and taking $\tilde{q}_{n}^{d}$ and $\tilde{q}_{n}$ to be the efficient quantile bounds $q_{n}^{d}, q_{n}$ of Thm. 14 with the auxiliary bounds of Rem. 6.

Proof For brevity, we will adopt the shorthand $\hat{q}_{n}^{d} \triangleq \hat{q}_{n}^{d}\left(R, \delta, a_{n}\right)$ and $\tilde{q}_{n}^{d} \triangleq \tilde{q}_{n}^{d}\left(R, \delta-a_{n}, \sigma_{1, a_{n}}\right)$. We will also write $T_{n, \delta}^{d}:=\frac{\tilde{q}_{n}^{d} / \sigma_{1, a_{n}}^{2}}{1-c_{1}^{\delta-a_{n}}\left(\sigma_{\left.1, a_{n}\right)}\right)}$. Since $\sqrt{n} A_{\delta, a_{n}}^{n}$ is the sublevel set of the norm-coercive monic polynomial

$\hat{q}_{n}^{d}$ is necessarily a root of this polynomial.
Moreover, the coefficients of this polynomial converge as follows. First, the Dvoretsky-KieferWolfowitz inequality (Dvoretzky et al., 1956) implies that

for some constant $C$. Our assumption $\frac{\log \left(a_{n}\right)}{n} \rightarrow 0$ therefore yields $q_{n}^{\mathrm{KS}}\left(\frac{a_{n}}{4}\right) \rightarrow 0$. Moreover, by the strong law of large numbers (Durrett, 2019, Thm. 2.4.1), $\hat{\sigma}^{2} \xrightarrow{\text { a.s. }} \sigma^{2}, \hat{m}_{4} \xrightarrow{\text { a.s. }} s_{4}^{2}$, and $\hat{m}_{3} \xrightarrow{\text { a.s. }}$ $\mathbb{E}\left[\left(W_{i}-\mathbb{E} W_{1}\right)^{3}\right]$ and hence $\sigma_{1, \mathrm{a}}^{2} \xrightarrow{\text { a.s. }} \sigma^{2}$ and $s_{1, \mathrm{a}}^{2} \xrightarrow{\text { a.s. }} s_{4}^{2}$ as well. Since $a_{n} \rightarrow 0$, we therefore have $\tilde{q}_{n}^{d} \xrightarrow{\text { a.s. }}-\sigma \Phi^{-1}\left(\frac{\delta}{2}\right)$ and $c_{1}^{\delta-a_{n}}\left(\sigma_{1, a_{n}}\right) \xrightarrow{\text { a.s. }} 0$. Finally, as $c_{2}^{a_{n}}\left(s_{1, a_{n}}\right) \rightarrow 0$, the polynomial Eq. (13) converges almost surely to the monic polynomial $y \mapsto\left(y^{2}-\left(-\sigma \Phi^{-1}\left(\frac{\delta}{2}\right)\right)\right)^{2}$. Hence, by $\operatorname{Artin}$ (2011, Prop. 5.2.1), $\hat{q}_{n}^{d}$ converges almost surely to the unique positive root of this polynomial, $-\sigma \Phi^{-1}\left(\frac{\delta}{2}\right)$.

### 8.1. Numerical evaluation

We next turn to a numerical evaluation of our efficient EBE bound. Python code implementing our bound and reproducing all plots can be found at https://github.com/lmackey/gauss_ conc/. Fig. 1 compares the efficient EBE bound of Thm. 17 and Rem. 9 with the Hoeffding quantile bound, $\mathbb{P}\left(\left|S_{n}\right| \geq R \sqrt{2 \log (2 / \delta)}\right) \leq \delta$; the empirical Bernstein quantile bound (Maurer and Pontil, 2009, Thm. 4) commonly deployed in reinforcement learning (Mnih et al., 2008; Audibert et al., 2009), $\mathbb{P}\left(\left|S_{n}\right| \geq \hat{\sigma} \sqrt{2 \log (2 / \delta) \frac{n}{n-1}}+\frac{14}{3} R \log (2 / \delta) \frac{\sqrt{n}}{n-1}\right) \leq \delta$; and the efficient $I_{n, 3}$ quantile bound of Romano and Wolf (2000), ${ }^{2}$ with its free parameter $\beta_{n}$ set to match our default value, $a_{n}=\frac{\log n}{n}$.

As advertised, the efficient bounds converge to the optimal asymptotic size as $n$ increases, while the Bernstein and Hoeffding inequalities remain bounded away from the optimum for all $n$. Moreover, the efficient EBE bound of Thm. 16 provides a tighter estimate than the optimized RomanoWolf bound in all settings. Here the efficient empirical bound is constructed with $\hat{m}_{3}=R \hat{\sigma}^{2}$ and $\hat{m}_{4}=R^{2} \hat{\sigma}^{2}-\hat{\sigma}^{4}$ and, as we show in App. M, changes only minimally as $\hat{m}_{3}$ and $\hat{m}_{4}$ vary.

## 9. Discussion and Related Work

In this work, we have derived new computable tail and quantile bounds for the scaled deviations $S_{n}=\sqrt{n}\left(\bar{W}_{n}-\mathbb{E}\left(W_{1}\right)\right)$ with asymptotically optimal size, finite-sample validity, and sub-Gaussian decay. These bounds enable the construction of efficient confidence intervals with correct coverage for any sample size. Our concentration inequalities arise from new computable bounds on the Hellinger distance, Stein discrepancy, non-uniform Kolmogorov distance, and Wasserstein distance to a Gaussian, and, as a byproduct, we obtain the first explicit bounds for the Hellinger CLT. We also develop a general method for bounding the Hellinger distance between a Gaussian and any other random variable.

The notion of efficient confidence intervals for the mean was introduced by Romano and Wolf (2000). In their Thm. 2.1, Romano and Wolf showed that efficient-that is, asymptotically minimallength when scaled by $\sqrt{n}$-confidence intervals must converge to the width of the asymptotic Gaussian intervals implied by the CLT Eq. (3). Moreover, Sec. 3 of Romano and Wolf surveys a number of procedures for constructing confidence intervals that are either finite-sample invalid (including the bootstrap (Efron, 1992) and methods based on Edgeworth expansions (Hall, 2013)) or inefficient (including the methods of Anderson (1969) and Gasko (1991)). Romano and Wolf conclude by developing an efficient valid confidence interval for the mean of variables supported on $[0,1]$ but report that it is "unfortunately, much too wide for a reasonable sample." Our new efficient bounds are developed in an entirely different manner, and, as we demonstrate in Sec. 8.1, improve upon the Romano-Wolf interval and the most commonly used empirical concentration inequalities.

Our results also suggest simple strategies for making any concentration inequality or confidence region efficient. For efficient concentration, one can simply take the minimum of any existing tail bound and Thm. 9 or Thm. 13 to simultaneously reap the small-sample benefits of the former and the large-sample benefits of the latter. For efficient confidence, one can divide the total confidence budget between an existing region and the efficient region of Thm. 17 and then intersect the two regions. The result will remain efficient if the budget allocated to the auxiliary region vanishes as $n$ grows. These strategies are particularly relevant given the recent renewed interest in deriving

tighter concentration inequalities for bounded random variables (see, e.g., Jun and Orabona, 2019; Waudby-Smith and Ramdas, 2020; Orabona and Jun, 2021).

Our Hellinger bound is, to the best of our knowledge, the first known explicit rate of convergence for the central limit theorem in terms of the Hellinger distance. Indeed while rates were known for the KL divergence, none were explicitly derived for the Hellinger distance. Moreover, the KL rates are neither explicit nor computable and require stronger conditions. However, our proof technique
builds on previously developed ideas. Notably, we use the Ornstein-Ulenbeck semigroup to interpolate between $\tilde{S}_{n}$ and a normal. This allows us to re-express the Hellinger distance as an integral over the norm of information-theoretic quantities of the interpolated process. This can be seen as the equivalent of the De Bruijn identity (see e.g (Barron, 1986)) for the KL-divergence or similar expressions obtained for $p$-Wassertein distance in the celebrated work of Otto and Villani (2000) and in Ledoux et al. (2015). Then we take inspiration from Bonis (2015) which proposed to use an exchangeable pair argument to give a closed form upper bound to the $p$-Wassertein distance and develop similar techniques. This provides us with an easily computable bound that only depends on the moments of the score function and the moments of the random variable itself. This is to contrast with the known bounds for the KL divergence, which are either not in closed form (Bobkov et al., 2013), require conditions on the spectral gap (Artstein et al., 2004) or depend on the moment of the Stein kernel (Ledoux et al., 2015).

The notion of a Stein kernel (sometimes known under the name of Stein factor, $\omega$-function, or covariance kernel (Ley et al., 2017, Rem. 4.6)) is born from the literature of Stein's approximation and is found implicitly in many of the earlier works (see for e.g the original monograph (Stein, 1986)). It was however first formally introduced in Cacoullos and Papathanasiou (1992) and has been the subject of a lot of recent development including to establish multivariate central limit theorems (Nourdin et al., 2010), to compare univariate distributions (Ley et al., 2017) for its connection with the total variation distance (Cacoullos et al., 1994), the $p$-Wassertein distance (Ledoux et al., 2015; Bonis, 2015), the entropic central limit theorem (Nourdin et al., 2014; Ledoux et al., 2015), covariance bounds (Ernst et al., 2020) and concentration inequalities (Ledoux et al., 2015; Nourdin and Viens, 2009; Saumard, 2019). Our theorem Thm. 6 takes inspiration from the concentration inequalities obtained in Ledoux et al. (2015), but the inequality that we obtain is efficient and is on the tail of the $S_{n}$ rather than on the moments of Lipcthiz functions of $S_{n}$. The Stein kernel is however sadly not always guaranteed to exist. This led to a large body of work investigating under what conditions such a quantity exists and how to compute it ( see e.g (Courtade et al., 2017; Fathi, 2019)).

Our zero-bias coupling arguments generalize the uniform, $u$-independent bounds of Chen et al. (2011); Ross (2011) to derive tighter non-uniform bounds with sub-Gaussian decay. Our Wassersteinbounding arguments in Sec. 6 build on the pioneering work of Bonis (2015) who derived Wasserstein convergence rates for the CLT with inexplicit constants. Our new arguments lead to tighter estimates of the distance to Gaussianity and explicit, practical constants.

An important open question is if a similar approach could be used for other statistics, beyond sample means, that are known to be asymptotically normal. Another natural direction for future work is to relax the assumption than the random variables are bounded to conditions on the moments of $\left(W_{i}\right)_{i \geq 1}$.

## Appendix A. Appendix Overview and Notation

The proofs of Thms. 11 and 12 to 14 are each broken into two parts. In App. I. 1 we derive upper bounds for the Wassertein distances between $S_{n}$ and its asymptotic distribution $\mathcal{N}\left(0, \sigma^{2}\right)$. In Apps. H.2, H.4, and I we exploit those upper bounds to establish the individual theorem claims.

Throughout the appendix, we will designate by $\left(X_{i}\right)_{i \geq 1}$ the rescaled random variables $X_{i}=$ $\frac{W_{i}-\mathbb{E}\left(W_{i}\right)}{\sqrt{n}}=\frac{Y_{i}}{\sqrt{n}}$. We remark that $\mathbb{E}\left(X_{1}\right)=0$, that $\operatorname{Var}\left(X_{1}\right)=\frac{\operatorname{Var}\left(Y_{1}\right)}{n}=\frac{\sigma^{2}}{n}$ and that $\left\|X_{1}\right\|_{\infty} \leq$ $R / \sqrt{n}$. K L\left(\tilde{S}_{n} \| Z\right) \leq \frac{1}{n} \mathcal{S}_{2}^{2}\left(\sigma^{-1} Y_{1} \| Z\right) \log \left(1+\frac{n\left\|S_{\tilde{S}_{S}}\left(\tilde{S}_{n}\right)-\tilde{S}_{n}\right\|_{2}^{2}}{\mathcal{S}_{2}^{2}\left(\sigma^{-1} Y_{1} \| Z\right)}\right) .
$$

Moreover we know that $S_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)$ is the only $\tilde{S}_{n}$-measurable random variable such that for all $\phi \in$ $\mathbb{C}^{\infty}(\mathbb{R})$ we have

$$
\mathbb{E}\left(\phi\left(\tilde{S}_{n}\right) S_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)\right)=\mathbb{E}\left(\phi^{\prime}\left(\tilde{S}_{n}\right)\right)
$$

Therefore we know that $S_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)=\mathbb{E}\left(\left.\frac{1}{\sqrt{n}} \sum_{i \leq n} S_{Y_{1}}\left(\sigma Y_{i}\right) \right\rvert\, \tilde{S}_{n}\right)$. Therefore by Jensen inequality, we obtain that:

$$
\left\|S_{\tilde{S}_{n}}\left(\tilde{S}_{n}\right)-\tilde{S}_{n}\right\|_{2} \leq\left\|S_{Y_{1}}\left(\sigma Y_{1}\right)-\sigma^{-1} Y_{1}\right\|_{2} .
$$

This implies the desired result.

## Appendix F. Proof of Thm. 9: Efficient zero-bias tail bound

The crux of our argument, inspired by Ross (2011, Thm. 3.27) and proved in App. F.1, shows that a zero-biased version $S^{\star}$ of a random variable $S$ has tails close to those of a Gaussian whenever $S^{\star}$ and $S$ have a close coupling.

Theorem 29 (Zero-bias tail bounds) Suppose that $S^{\star}$ has the zero-bias distribution for a random variable $S$ with $\mathbb{E}[S]=0$ and $\operatorname{Var}(S)=1$ and that $S^{\star}-S \leq \delta$ almost surely. For $U \sim \operatorname{Unif}[0,1]$ independent of $\left(S, S^{\star}\right)$, define the intermediate variable $S^{\prime} \triangleq S^{\star}+U\left(S-S^{\star}\right)$. Then, for all $u \geq 0$ and $\lambda \in[0,1]$,

$$
\mathbb{P}\left(S^{\star}>u\right)-\Phi^{c}(u) \leq \delta\left[h_{u}(\lambda u)+\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{P}\left(S^{\prime}>\lambda u\right)-\delta_{u} \mathbb{P}\left(S^{\prime}>u\right)\right],
$$

for $h_{u}$ and $\delta_{u}$ defined in Eq. (11) and Eq. (12) respectively. If, in addition, $S-S^{\star} \leq \delta$ almost surely, then

$$
\mathbb{P}(S>u+\delta) \leq \frac{1}{1+\delta \delta_{u}} \Phi^{c}(u)+\frac{\delta}{1+\delta \delta_{u}}\left(h_{u}(\lambda u)+\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{P}\left(S^{\prime}>\lambda u\right)\right) .
$$

Hence, to establish the first claim, it only remains to construct a suitable zero-bias coupling for $S_{n} / \sigma$. By Chen et al. (2011, Lem. 2.8), $S_{n}^{\star}=S_{n}+X_{I}^{\star}-X_{I}$ has the zero-bias distribution for $S_{n}$. Therefore, by the zero-bias definition, $S_{n}^{\star} / \sigma$ has the zero-bias distribution for $S_{n} / \sigma$. Finally, $\left|S_{n}^{\star} / \sigma-S_{n} / \sigma\right|=\left|X_{I}^{\star}-X_{I}\right| / \sigma \leq 2 R /(\sigma \sqrt{n})$ almost surely. The advertised result thus follows from the second claim of Thm. 29 applied with $S=S_{n} / \sigma, S^{\star}=S_{n}^{\star} / \sigma$, and $\delta=2 R /(\sigma \sqrt{n})$.

Now suppose the random variables $\left(X_{i}\right)_{i=1}^{n+1}$ are identically distributed, define $S_{n+1}=\frac{\sqrt{n}}{\sqrt{n+1}}\left(S_{n}+\right.$ $\left.X_{n+1}\right)$, and consider an independently generated index $J \sim \operatorname{Unif}(\{1, \ldots, n+1\})$. By Chen et al. (2011, Lem. 2.8), $S_{n+1}^{\star}=S_{n+1}+X_{J}^{\star}-X_{J}$ has the zero-bias distribution for $S_{n+1}$. Define the intermediate variable $S_{n+1}^{\prime} \triangleq\left(S_{n+1}^{\star}+U\left(S_{n+1}-S_{n+1}^{\star}\right)\right)$. By symmetry, $S_{n}+X_{n+1}^{\star} \stackrel{d}{=} \frac{\sqrt{n+1}}{\sqrt{n}} S_{n+1}^{\star}$ and hence $S_{n}+X_{n+1}^{\prime} \stackrel{d}{=} \frac{\sqrt{n+1}}{\sqrt{n}} S_{n+1}^{\prime}$. In addition, since $X_{n+1}^{\star} \wedge X_{n+1}^{\prime} \geq-\frac{R}{\sqrt{n}}$,

$$
\begin{aligned}
& \mathbb{P}\left(S>\sigma u \frac{\sqrt{n+1}}{\sqrt{n}}+\frac{R}{\sqrt{n}}\right) \leq \mathbb{P}\left(S+X_{n+1}^{\star} \wedge X_{n+1}^{\prime}>\sigma u \frac{\sqrt{n+1}}{\sqrt{n}}\right) \\
& \leq \mathbb{P}\left(S_{n+1}^{\star}>\sigma u\right) \wedge \mathbb{P}\left(S_{n+1}^{\prime}>\sigma u\right) .
\end{aligned}
$$

The result now follows from the first result of Thm. 29 with $S=S_{n+1} / \sigma, S^{\star}=S_{n+1}^{\star} / \sigma$, and $\delta=2 R /(\sigma \sqrt{n+1})$.

## F.1. Proof of Thm. 29: Zero-bias tail bounds

Fix any $u \in \mathbb{R}$. Our proof structure, based on Stein's method, mimics that of Ross (2011, Thm. 3.27) but employs $u$-dependent bounds in place of the $u$-independent bounds invoked by Ross.

Solving the Stein equation Next we define the Stein equation (Stein, 1986)

f_{u}^{\prime}(w)-w f_{u}(w)=\mathbb{I}[w \leq u]-\Phi(u) .
$$

By Chen et al. (2011, Lem. 2.2), the absolutely continuous function

\begin{equation*}
f_{u}(w)=\sqrt{2 \pi} \exp \left(\frac{w^{2}}{2}\right) \Phi(w \wedge u) \Phi^{c}(w \vee u) \tag{26}
\end{equation*}
$$

solves the Stein equation, and we can therefore write

\mathbb{P}\left(S^{\star} \leq u\right)-\Phi(u)=\mathbb{E}\left[f_{u}^{\prime}\left(S^{\star}\right)-S^{\star} f_{u}\left(S^{\star}\right)\right]=
$$

where the final equality uses the definition of the zero-biased distribution. Negating both sides, we obtain

$$
\mathbb{P}\left(S^{\star}>u\right)-\Phi^{c}(u)=\mathbb{E}\left[S^{\star} f_{u}\left(S^{\star}\right)-S f_{u}(S)\right] .
$$

Bounding the Stein solution Now let $g_{u}(w)=w f_{u}(w)$. By Chen et al. (2011, Eq. (2.81)), the function

\begin{align*}
h_{u}(w) & \triangleq \begin{cases}\sqrt{2 \pi} \Phi^{c}(u)\left(\left(1+w^{2}\right) \exp \left(w^{2} / 2\right) \Phi(w)+w / \sqrt{2 \pi}\right) & \text { if } w \leq u \\
\sqrt{2 \pi} \Phi(u)\left(\left(1+w^{2}\right) \exp \left(w^{2} / 2\right) \Phi^{c}(w)-w / \sqrt{2 \pi}\right) & \text { if } w>u\end{cases}  \tag{27}\\
& =w\left(\Phi^{c}(u)-\mathbb{I}[w>u]\right)+\left(1+w^{2}\right) f_{u}(w) \\
& =w\left(\mathbb{T}[w \leq u] \Phi^{c}(u)-\mathbb{I}[w>u] \Phi(u)\right)+\left(1+w^{2}\right) f_{u}(w)
\end{align*}
$$

matches the derivative of $g_{u}(w)$ whenever $w \neq u$. Since the absolute continuity of $f_{u}$ implies that $g_{u}$ is absolutely continuous on compact intervals, the fundamental theorem of calculus yields

$$
\mathbb{E}\left[g_{u}\left(S^{\star}\right)-g_{u}(S)\right]=\mathbb{E}\left[\int_{0}^{1} h_{u}\left(S^{\star}+x\left(S-S^{\star}\right)\right)\left(S^{\star}-S\right) d x\right]=\mathbb{E}\left[h_{u}\left(S^{\prime}\right)\left(S^{\star}-S\right)\right]
$$

Our next result, proved in App. F. 2 provides a suitable $u$-dependent bound on $h_{u}$.
Lemma 30 (Growth of $h_{u}$ ) For any $u \geq 0, \lambda \in[0,1]$, and $w \in \mathbb{R}$,

$$
0 \leq h_{u}(w) \leq h_{u}(\lambda u)+\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{I}[w>\lambda u]-\delta_{u} \mathbb{I}[w>u]
$$

for $h_{u}$ and $\delta_{u}$ defined in Eq. (27) and Eq. (12) respectively.
$S^{\star}$ tail bound Fix any $\lambda \in[0,1]$. Lem. 30, our almost sure assumption $S^{\star}-S \leq \delta$, and the definition of $S^{\prime}$ together imply that

$$
\begin{align*}
& \mathbb{P}\left(S^{\star}>u\right)-\Phi^{c}(u) \leq \delta \mathbb{E}\left[h_{u}\left(S^{\prime}\right)\right] \\
& \leq \delta\left[h_{u}(\lambda u)+\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{P}\left(S^{\prime}>\lambda u\right)-\delta_{u} \mathbb{P}\left(S^{\prime}>u\right)\right] \tag{28}
\end{align*}
$$

From $S$ tails to $S^{\star}$ tails When $S-S^{\star} \leq \delta$ almost surely, we additionally have

$$
\begin{aligned}
S-S^{\prime} & \leq\left(S-S^{\star}\right)(1-U) \leq \delta \quad \text { and therefore } \\
\mathbb{P}(S>u+\delta) & =\mathbb{P}\left(S^{\star} \wedge S^{\prime}>u+\delta+S^{\star} \wedge S^{\prime}-S\right) \\
& \leq \mathbb{P}\left(S^{\star} \wedge S^{\prime}>u\right) \leq \mathbb{P}\left(S^{\star}>u\right) \wedge \mathbb{P}\left(S^{\prime}>u\right)
\end{aligned}
$$

Combining this inequality with our $S^{\star}$ tail bound Eq. (28) yields

$$
\begin{aligned}
& \mathbb{P}(S>u+\delta) \\
& \leq \Phi^{c}(u)+\delta\left[h_{u}(\lambda u)+\left(h_{u}(u)-h_{u}(\lambda u)\right) \mathbb{P}\left(S^{\prime}>\lambda u\right)-\delta_{u} \mathbb{P}(S>u+\delta)\right]
\end{aligned}
$$

Rearranging the terms of this expression yields the final advertised result.

## F.2. Proof of Lem. 30: Growth of $h_{u}$

Our proof makes use of the following bound on the growth of $\Phi^{c}$, established in App. F.3.

Lemma 31 (Growth of $\Phi^{c}$ ) If $w \geq 0$ then

\sqrt{2 \pi}\left(1+w^{2}\right) \exp \left(w^{2} / 2\right) \Phi^{c}(w)-w \leq b(w) \triangleq \frac{2}{w+\sqrt{w^{2}+8 / \pi}}-\frac{8 w}{\pi\left(w+\sqrt{w^{2}+8 / \pi}\right)^{2}}
$$

Fix any $u \geq 0, \lambda \in[0,1]$, and $w \in \mathbb{R}$. We will divide our proof into cases based on the value of $w$.

Lower bound, $w \neq u: \quad$ Since $g_{u}$ is differentiable for $w \neq u$ and increasing by Chen et al. (2011, Lem. 2.3), $h_{u}(w)=g_{u}^{\prime}(w) \geq 0$.

Lower bound, $w=u: \quad$ We have $h_{u}(u)=\lim _{v \uparrow u} h_{u}(v) \geq 0$.

Upper bound, $w>u$ : From the definition of $f_{u}$ Eq. (26) and the $\Phi^{c}$ growth bound (Lem. 31), we have

\begin{aligned}
\left(1+w^{2}\right) f_{u}(w) \mathbb{I}[w>u] & =\sqrt{2 \pi}\left(1+w^{2}\right) \exp \left(w^{2} / 2\right) \Phi^{c}(w) \Phi(u) \mathbb{I}[w>u] \\
& \leq(b(u)+w) \Phi(u) \mathbb{I}[w>u] .
\end{aligned}
$$

Hence,

$$
h_{u}(w) \mathbb{I}[w>u]=\left(1+w^{2}\right) f_{u}(w) \mathbb{I}[w>u]-w \Phi(u) \mathbb{I}[w>u] \leq b(u) \Phi(u) \mathbb{I}[w>u] .
$$

Upper bound, $\lambda u \geq w \geq 0$ : Since $g_{u}$ is increasing (Chen et al., 2011, Lem. 2.3), $f_{u}$ is increasing for $w<u$, and $\lambda u f_{u}(\lambda u)+\Phi^{c}(u)$ is nonnegative, we have

$$
\begin{aligned}
h_{u}(w) \mathbb{I}[\lambda u \geq w \geq 0] & =\left(f_{u}(w)+w\left(w f_{u}(w)+\Phi^{c}(u)\right)\right) \mathbb{I}[\lambda u \geq w \geq 0] \\
& \leq\left[f_{u}(\lambda u)+w\left(\lambda u f_{u}(\lambda u)+\Phi^{c}(u)\right)\right] \mathbb{I}[\lambda u \geq w \geq 0] \\
& \leq\left[f_{u}(\lambda u)+\lambda u\left(\lambda u f_{u}(\lambda u)+\Phi^{c}(u)\right)\right] \mathbb{I}[\lambda u \geq w \geq 0] \\
& =h_{u}(\lambda u) \mathbb{I}[\lambda u \geq w \geq 0]=h_{u}(\lambda u)(\mathbb{I}[w \geq 0]-\mathbb{I}[w>\lambda u]) .
\end{aligned}
$$

Upper bound, $w<0$ : Since $w<0 \leq u$, we use the definition of $f_{u}$ Eq. (26), the $\Phi^{c}$ growth bound (Lem. 31), the nonnegativity of $\Phi^{c}$, and the fact that $b$ is decreasing to derive

$$
\begin{aligned}
\left(1+w^{2}\right) f_{u}(w) \mathbb{I}[w<0] & =\sqrt{2 \pi} \exp \left(w^{2} / 2\right) \Phi^{c}(|w|) \Phi^{c}(u) \mathbb{I}[w<0] \\
& \leq(b(|w|)+|w|) \Phi^{c}(u) \mathbb{I}[w<0] \\
& \leq(b(0)+|w|) \Phi^{c}(u) \mathbb{I}[w<0] .
\end{aligned}
$$

Since $\lambda u \geq 0$ by assumption, our prior derivation implies $h_{u}(\lambda u) \geq h_{u}(0)$ and hence,

$$
\begin{aligned}
h_{u}(w) \mathbb{I}[w<0] & =((b(0)+|w|)-|w|) \Phi^{c}(u) \mathbb{I}[w<0] \\
& =b(0) \Phi^{c}(u) \mathbb{I}[w<0]=\sqrt{\frac{\pi}{2}} \Phi^{c}(u) \mathbb{I}[w<0] \\
& =h_{u}(0) \mathbb{I}[w<0] \leq h_{u}(\lambda u) \mathbb{I}[w<0] .
\end{aligned}
$$

Upper bound, $u \geq w>\lambda u$ : Since $u, w, f_{u}(u)$, and $\Phi^{c}(u)$ are nonnegative, $g_{u}$ is increasing (Chen et al., 2011, Lem. 2.3), and $u \geq w$, we have

$$
\begin{aligned}
h_{u}(w) \mathbb{I}[u \geq w>\lambda u] & =\left(f_{u}(w)+w\left(w f_{u}(w)+\Phi^{c}(u)\right)\right) \mathbb{I}[u \geq w>\lambda u] \\
& \leq\left(f_{u}(u)+w\left(u f_{u}(u)+\Phi^{c}(u)\right)\right) \mathbb{I}[u \geq w>\lambda u] \\
& \leq\left(f_{u}(u)+u\left(u f_{u}(u)+\Phi^{c}(u)\right)\right) \mathbb{I}[u \geq w>\lambda u] \\
& =h_{u}(u) \mathbb{I}[u \geq w>\lambda u]=h_{u}(u)(\mathbb{I}[w>\lambda u]-\mathbb{I}[w>u]) .
\end{aligned}
$$

Complete upper bound Taken together, our upper bounds yield

$$
\begin{aligned}
h_{u}(w) \leq & b(u) \Phi(u) \mathbb{I}[w>u]+h_{u}(u)(\mathbb{I}[w>\lambda u]-\mathbb{I}[w>u]) \\
& \quad+h_{u}(\lambda u)(\mathbb{I}[w \geq 0]-\mathbb{I}[w>\lambda u])+h_{u}(\lambda u) \mathbb{I}[w<0] \\
\leq & \left(b(u) \Phi(u)-h_{u}(u)\right) \mathbb{I}[w>u]+\left(h_{u}(u)-h_{u}(\lambda u) \mathbb{I}[w>\lambda u]+h_{u}(\lambda u) .\right.
\end{aligned}
$$

## F.3. Proof of Lem. 31: Growth of $\Phi^{c}$

By Abramowitz and Stegun (1964, 7.1.13)

$$
\exp \left(w^{2} / 2\right) \Phi^{c}(w) \leq \sqrt{2 / \pi} /\left(w+\sqrt{w^{2}+8 / \pi}\right)
$$

Therefore,

\begin{aligned}
& \sqrt{2 \pi}\left(1+w^{2}\right) \exp \left(w^{2} / 2\right) \Phi^{c}(w)-w \\
& \leq 2\left(1+w^{2}\right) /\left(w+\sqrt{w^{2}+8 / \pi}\right)-w \\
& =\left(2\left(1+w^{2}\right)-w^{2}-w \sqrt{w^{2}+8 / \pi}\right) /\left(w+\sqrt{w^{2}+8 / \pi}\right) \\
& =\left(2+w\left(w-\sqrt{w^{2}+8 / \pi}\right)\right) /\left(w+\sqrt{w^{2}+8 / \pi}\right) \\
& =\frac{2}{w+\sqrt{w^{2}+8 / \pi}}-\frac{8 w}{\pi\left(w+\sqrt{w^{2}+8 / \pi}\right)^{2}}
\end{aligned}
$$

## Appendix G. Proof of Prop. 10: Properties of $S_{n}^{\prime}$

Instantiate the notation and assumptions of Thm. 9, and fix any $i \in\{1, \ldots, n\}$ and $t \in \mathbb{R}$. We invoke the definition of $X_{i}^{\prime}$, Lem. 2.1(iv) of Goldstein and Reinert (1997), and our $X_{i}$ boundedness assumption in turn to find that

\left|\mathbb{E}\left[X_{i}^{\prime}\right]\right|=\frac{1}{2}\left|\mathbb{E}\left[X_{i}^{\star}\right]\right|=\frac{1}{4 \sigma_{i}^{2}}\left|\mathbb{E}\left[X_{i}^{3}\right]\right| \leq \frac{R}{4 \sqrt{n}} .
$$

The same invocations, coupled with the independence of $X_{i}, U$, and $X_{i}^{\star}$, imply

$$
\begin{aligned}
\operatorname{Var}\left(X_{i}^{\prime}\right) & =\mathbb{E}\left[\left(U X_{i}+(1-U)\left(X_{i}^{\star}-\mathbb{E}\left[X_{i}^{\star}\right]\right)\right)^{2}\right] \\
& =\mathbb{E}\left[U^{2}\right] \operatorname{Var}\left(X_{i}\right)+\mathbb{E}\left[(1-U)^{2}\right] \operatorname{Var}\left(X_{i}^{\star}\right) \\
& =\frac{1}{3} \sigma_{i}^{2}+\frac{1}{3} \operatorname{Var}\left(X_{i}^{\star}\right)=\frac{1}{3} \sigma_{i}^{2}+\frac{1}{3}\left(\mathbb{E}\left[X_{i}^{\star 2}\right]-\mathbb{E}\left[X_{i}^{\star}\right]^{2}\right) \\
& =\frac{1}{3} \sigma_{i}^{2}+\frac{1}{9 \sigma_{i}^{2}} \mathbb{E}\left[X_{i}^{4}\right]-\frac{1}{12 \sigma_{i}^{4}} \mathbb{E}\left[X_{i}^{3}\right]^{2} \leq \frac{1}{3} \sigma_{i}^{2}+\frac{R^{2}}{9 n} .
\end{aligned}
$$

Moreover, since $\mathbb{E}\left[X_{i}^{3}\right]^{2} \leq \mathbb{E}\left[X_{i}^{2}\right] \mathbb{E}\left[X_{i}^{4}\right]$ by Cauchy Schwartz, we have

$$
\operatorname{Var}\left(X_{i}^{\prime}\right) \geq \frac{1}{3} \sigma_{i}^{2}+\frac{1}{9 \sigma_{i}^{2}} \mathbb{E}\left[X_{i}{ }^{4}\right]-\frac{1}{12 \sigma_{i}^{2}} \mathbb{E}\left[X_{i}{ }^{4}\right]=\frac{1}{3} \sigma_{i}^{2}+\frac{1}{36 \sigma_{i}^{2}} \mathbb{E}\left[X_{i}{ }^{4}\right] \geq \frac{1}{3} \sigma_{i}^{2}+\frac{R^{2}}{36 n} .
$$

Next, by Goldstein and Reinert (1997, Lem. 2.1(ii)), the support of $X_{i}^{\star}$ is the closed convex hull of the support of $X_{i}$. Therefore, by the triangle inequality,

\left|X_{i}^{\prime}\right| \leq U\left|X_{i}\right|+(1-U)\left|X_{i}^{\star}\right| \leq \frac{R}{\sqrt{n}} \quad \text { almost surely. }
$$

The final result is justified exactly as in App. F.

## Appendix H. Proof of Thms. 11 and 12: Efficient Concentration with Wasserstein Approximation

The proofs of Thm. 11 and Thm. 12 exploit the following upper bound for $\mathcal{W}_{p}\left(S_{n}, \mathcal{N}\left(0, \sigma^{2}\right)\right)$.

Lemma 32 If the conditions of Thm. 11 hold and we write $D_{n, p} \triangleq \sqrt{1-\frac{\tilde{R}^{2}(p-1)}{C n}}$ where $C=0.4$, then for all $p \geq 2$ the following upper-bound holds:

\mathcal{W}_{p}\left(\tilde{S}_{n}, Z\right) & \leq \frac{(p-1)}{\sqrt{0.4 n}}\left[\tilde{R}\left(1+\frac{\tilde{U}_{n, p}}{2 \sqrt{n}}\right)+\frac{\tilde{R}}{2 \sqrt{n}}\left(\frac{3 A_{p}}{2}+\tilde{R}^{1+2 / p} \tilde{A}_{n, p}\right)\right. \\
& \left.+\frac{\sqrt{0.4}}{2 \sqrt{p-1}}\left(1-\frac{\tilde{R} \sqrt{p-1}}{\sqrt{0.4 n}}\right)\left[U_{n, p}-\tilde{R}^{-1} \tilde{U}_{n, p}\right]\right] \\

The first step is to notice that by definition of the metric $\mathcal{W}_{p}(\cdot, \cdot)$ for all $\epsilon>0$ we can find $G \sim$ $\mathcal{N}\left(0, \sigma^{2}\right)$ a normally distributed random variable that respects $\left\|S_{n}-G\right\|_{p} \leq \epsilon+\mathcal{W}_{p}\left(S_{n}, \mathcal{N}\left(0, \sigma^{2}\right)\right)$. This implies that for all $\rho \in(0,1)$ we have

Our objective is to upper bound the right-hand side of this equation. In this goal and for ease of notation we shorthand $\omega_{p} \triangleq \mathcal{W}_{p}\left(S_{n}, \mathcal{N}\left(0, \sigma^{2}\right)\right)$. This directly implies that:

Let $u>0$ be such that $\frac{\mathcal{W}_{p}\left(S_{n}, \mathcal{N}\left(0, \sigma^{2}\right)\right)^{p}}{u^{p}} \leq \alpha$ then for any $t<\frac{1}{2}$ we have:

Given a confidence level $\alpha>0$, our first goal is to find the smallest $u^{*}$ such that $\frac{\mathcal{W}_{p}\left(S_{n}, \mathcal{N}(0,1)\right)^{p}}{u^{p}} \leq$ $\alpha$. With that goal we define

(47).We remark that if $\tilde{\sigma}=\sigma$ is the true variance of $Y_{1}$ then $\omega_{p}^{R, \kappa}(\sigma)$ is an upper bound on the Wassertein distance $\mathcal{W}_{p}\left(S_{n}, Z\right)$ (see Lem. 34 for a proof). Finally, we define:

This directly implies that

& \leq \frac{c_{2}^{a_{n}}\left(s_{4}\right)}{\left.1-c_{2}^{a_{n}( } s_{4}\right)}\left[v_{4}\left(\hat{\mu}, \hat{m}_{2}(\hat{\mu})\right)+c_{3} \Delta \hat{\mu}^{2}+\Delta \hat{\mu} c_{4}+s_{4}^{2}-v_{4}\left(\mu, \sigma^{2}\right)\right]
\end{aligned}
$$

According to Lem. 41, we have:

P\left(\left|s_{4}^{2}-v_{4}\left(\mu, \sigma^{2}\right)\right| \geq R^{4} q_{n}^{\mathrm{KS}}\left(\frac{a_{n}}{4}\right)\right) \leq \frac{a_{n}}{4} .

We write the event $E_{4} \triangleq\left\{\left|s_{4}^{2}-v_{4}\left(\sigma^{2}\right)\right| \leq R^{4} q_{n}^{\mathrm{KS}}\left(\frac{a_{n}}{4}\right)\right\}$. Then when the event $E_{3}$ and $E_{4}$ both hold then

## Appendix L. Additional Lemmas

Lemma 37 Let $S$ be a standardized bounded random variable, and let $Z$ be an independent standard normal random variable. For all $t>0$, write $X_{t}^{S} \triangleq e^{-t} S+\sqrt{1-e^{-2 t}} Z$. Let $S^{t}$ be another real valued bounded random variables such that $\left(S, S^{t}\right)$ are an exchangeable pair. Let $\tau_{t}^{\prime, S}$ and $\tau_{t}^{S}$ be the quantities defined respectively in Eq. (6) and Eq. (7) then

Proof For all measurable function $h$, we write $P_{t}(h): x \rightarrow \mathbb{E}\left(h\left(e^{-t} x+\sqrt{1-e^{-2 t}} Z\right)\right)$. Let $\Phi \in \mathbb{C}^{\infty}(\mathbb{R})$ be a smooth function then

& \stackrel{(a)}{=} \sum_{k=1}^{\infty} \frac{e^{-k t}}{k!} \mathbb{E}\left(\mathbb{E}\left(\left(S^{t}-S\right)^{k} \mid S\right) \Phi^{(k)}\left(X_{t}^{S}\right)\right) \\
&=\sum_{k=1}^{\infty} \frac{e^{-k t}}{k!} \mathbb{E}\left(\left(S^{t}-S\right)^{k} \mathbb{E}\left(\Phi^{(k)}\left(X_{t}^{S}\right) \mid S\right)\right) \\
&=\sum_{k=1}^{\infty} \frac{e^{-k t}}{k!} \mathbb{E}\left(\left(S^{t}-S\right)^{k}\left(P_{t} \Phi\right)^{(k)}(S)\right) \\

where (a) is a consequence of the Stein identity that implies for any measurable function $f \in \mathbb{C}^{k}(\mathbb{R})$ we have $\mathbb{E}\left(f(Z) H_{k}(Z)\right)=\mathbb{E}\left(f^{(k)}(Z)\right)$ and where the last equality is obtained by exploiting the fact that $S \stackrel{d}{=} S^{t}$. Similarly we can prove that $\mathbb{E}\left(\tau_{t}^{S} \mid X_{t}\right)=0$.

Lemma 38 Let $h_{k}(x) \triangleq e^{x^{2} / 2} \frac{\partial^{k}}{\partial x} e^{-x^{2} / 2}$. Shorthand $H_{K} \triangleq h_{k}(Z)$. Then the following holds for all $k, p \in \mathbb{N}$ :

Lemma 40 (Rosenthal inequality with explicit constants) Let $\left(\tilde{X}_{i}\right)$ be a sequence of centered i.i.d observations. Assume that they are admit a p-th moment then the following holds for all $p \geq 2$

$$

Proof According to Nagaev and Pinelis (1978, Thm. 2) we have

$$

where $B(\cdot, \cdot)$ is the Beta function. Choose $c=\frac{p}{2}+1$ then we obtain

& =\left(\frac{p}{2}+1\right)^{p} n^{1-\frac{p}{2}}\left\|\tilde{X}_{1}\right\|_{p}^{p}+2\left(\frac{p}{2}+1\right)^{\frac{p}{2}} e^{\frac{p}{2}+1}\left\|\tilde{X}_{1}\right\|_{2}^{p} .

Therefore this directly implies that

Lemma 41 ((Romano and Wolf, 2000)) Let $\left(X_{i}\right)$ be a sequence of i.i.d random variables taking value in $[0,1]$. Let $\alpha>0$ be a level of confidence. Let $q_{n}^{\mathrm{KS}}(\alpha)$ be the $1-\alpha$ th quantile of a two-sided Kolmogorov-Smirnov distribution with parameter $n$. Let $k \in \mathbb{N}$ be an integer, then the following holds:

P\left(\left|\hat{m}_{k}-m_{k}\right| \geq q_{n}^{\mathrm{KS}}(\alpha)\right) \leq \alpha
$$

where $\hat{m}_{k} \triangleq \frac{1}{n} \sum_{i \leq n} X_{i}^{k}$.
Proof According to Proposition 3.1 of (Romano and Wolf, 2000) if you denote by $d_{K}$ the KolmogorovSmirnov distance then for any two distributions on $[0,1] \mu, \nu$ and any $k \in \mathbb{N}$ the following holds

\left|\mathbb{E}_{X \sim \nu}\left(X^{k}\right)-\mathbb{E}_{X \sim \mu}\left(X^{k}\right)\right| \leq d_{K}(\mu, \nu)
$$

Write $K S(n)$ the Kolmogorov-Smirnov distribution with parameter $n$ and $F_{X_{1}}$ the distribution of $X_{1}$. Now suppose that the $\left(X_{i}\right)$ are continuous random variables then we know that $d_{K}\left(\frac{1}{n} \sum_{i \leq n} \delta_{=X_{i}}, F_{X_{1}}\right) \sim$ $K S(n)$. Therefore this implies that

P\left(\left|\hat{m}_{k}-m_{k}\right| \geq q_{n}^{\mathrm{KS}}(\alpha)\right) \leq P\left(d_{K}\left(\frac{1}{n} \sum_{i \leq n} \delta \cdot=X_{i}, F_{X_{1}}\right) \geq q_{n}^{\mathrm{KS}}(\alpha)\right) \leq \alpha
$$

Now if $\left(X_{i}\right)$ are not continuous, let $\left(U_{i}\right)$ be an iid sequence of uniform random variables in $[0,1]$. Define:

X_{i}^{\epsilon} \triangleq \frac{1}{1+\epsilon}\left(X_{i}+\epsilon U_{i}\right)
$$

Then the $\left(X_{i}^{\epsilon}\right)$ are continuous random variables on $[0,1]$ we know that:

P\left(\left|\frac{1}{n} \sum_{i \leq n}\left(X_{i}^{\epsilon}\right)^{k}-\mathbb{E}\left(\left(X_{1}^{\epsilon}\right)^{k}\right)\right| \geq q_{n}^{\mathrm{KS}}(\alpha)\right) \leq \alpha
$$

As this holds for any arbitrary choice of $\epsilon>0$ we get the desired result.

## Appendix M. Additional Plots

The supplementary plots in this section demonstrate that the efficient EBE bounds of Fig. 1 vary only minimally as the empirical parameters $\hat{m}_{3}$ and $\hat{m}_{4}$ vary over their feasible ranges $\left[-R \hat{\sigma}^{2}, R \hat{\sigma}^{2}\right]$ and $\left[0, R^{2} \hat{\sigma}^{2}-\hat{\sigma}^{4}\right]$ respectively.
