# Generating multiparticle entangled states by self-organization of driven ultracold atoms

#### Abstract

We describe a mechanism for guiding the dynamical evolution of ultracold atomic motional degrees of freedom toward multiparticle entangled Dicke-squeezed states, via nonlinear self-organization under external driving. Two examples of many-body models are investigated. In the first model, the external drive is a temporally oscillating magnetic field leading to self-organization by interatomic scattering. In the second model, the drive is a pump laser leading to transverse self-organization by photon-atom scattering in a ring cavity. We numerically demonstrate the generation of multiparticle entangled states of atomic motion and discuss prospective experimental realizations of the models. For the cavity case, the calculations with adiabatically eliminated photonic sidebands show significant momentum entanglement generation can occur even in the "bad cavity" regime. The results highlight the potential for using self-organization of atomic motion in quantum technological applications.


The study of self-organization of ultracold atoms is a wellestablished research direction, with many notable experimental and theoretical results [1, 2]. Following the pioneering works on self-organization of cold [3, 4] and ultracold [5, 6] atoms coupled to a single longitudinal mode of a Fabry-Perot cavity, the multimode aspects of optomechanical self-organization in cold and ultracold atoms have recently started to generate significant interest [7-26]. In parallel to the work on optomechanical self-organization, there has been great progress in studying the atomic self-organization arising due to atom-atom interactions being modulated by an external B-field [27-31].

Although the majority of these works have studied the nonequilibrium phase diagrams in the mean field limit, where quantum correlations can be neglected, a number of works have shown that the quantum nature of light and matter can play an important role for self-organization [6, 32-41].

Quantum correlated squeezed and entangled states can be used for quantum enhanced measurements, which go beyond classical metrology [42, 43]. In this context, squeezing and entanglement of the internal atomic degrees of freedom [4455], but recently also the external ones [56-60], have been recognized as attractive tools for metrological applications.

Here, we focus on external degrees of freedom and study the spontaneous generation of multiparticle entangled (also called Dicke squeezed) states in the atomic motion [53, 61-66], by self-organization of an externally driven Bose-Einstein condensate (BEC). The mechanism of this phenomenon is four-wave mixing [67-73] of zero-order modes with the spontaneously generated transverse sidebands, and we demonstrate the effect numerically for two different models. In the first model, the self-organization arises due to an external periodic modulation in interatomic scattering, driven by a temporally oscillating B-field. In the second model, it arises from laser driving in a ring cavity. A confinement along the $y$ and $z$ axes allows us to restrict the analysis to 1D structures in an elongated cloud.

Driving by B-field modulation. In the first model, shown in Fig. 1a), a spatially homogeneous and temporally oscillating B-field in the $z$-direction is modulated near a Feshbach resonance of the atoms. The B-field sinusoidally modulates

the atomic s-wave scattering length with frequency $\omega_{\text {mod }}$ and amplitude $a_{\text {mod }}$, thus driving the pattern formation [31]. For a collisionally thin medium, this four-wave mixing process is described by the three-mode Hamiltonian:

where $g_{\text {mod }}=2 \pi \hbar a_{\text {mod }} / m V, m$ is the atom mass, $V$ is the vol-
ume of the condensate, and $b_{0}, b_{ \pm}$are the bosonic momentum annihilation operators for the transverse modes of momenta $0, \pm \hbar k_{f}$, where $k_{f}=\sqrt{m \omega_{\text {mod }} / \hbar}$. The mechanism of pattern formation in this system is illustrated in Fig. 1b). When a pair of atoms with zero transverse momenta absorbs a quantum of energy $\hbar \omega_{\text {mod }}$, they scatter into modes with opposite momenta and kinetic energies $\hbar \omega_{\text {mod }} / 2$. This momentum conserving process leads in the semiclassical picture to a formation of stripe patterns in the atomic density.

Note that the Hamiltonian $H_{B}$ describes the same physics for atoms as the two-photon formalism of [74-77] does for photon pairs generated in optical parametric amplifiers. Moreover, $H_{B}$ is the atomic momentum equivalent of the Hamiltonian used in $\operatorname{SU}(1,1)$ spin-1 atom interferometry $[78,79]$.

Laser driving with ring cavity feedback. The second model we study is based on laser driving of a BEC in a ring cavity, as illustrated in Fig. 1c). This novel setup is inspired by earlier theoretical proposals [32-34, 80-82]. Such transverse self-organization has been observed in nearly degenerate FabryPerot cavity experiments with vertical-cavity regenerative amplifiers [83] and photorefractive crystals [84, 85]. For a BEC in a cavity, in addition to the three atomic motional modes with annihilation operators $b_{0}, b_{ \pm}$for transverse momenta $0, \pm \hbar q_{c}$ (with $q_{c}=2 \pi / \Lambda_{c}$ for the pattern lengthscale $\Lambda_{c}$ ), we have also the corresponding intracavity photonic modes with annihilation operators $a_{0}, a_{ \pm}$. In this system, a continuous-wave (cw) laser of frequency $\omega$ drives the zero-order cavity mode of frequency $\omega_{0}$ with pump rate $\eta$. Above some critical pump level $\eta_{c}$, this leads to spontaneous generation of sideband modes with frequency $\omega_{0}^{\prime}$, concurrently with atomic momentum sideband modes. The effective Hamiltonian of the problem is given by $H_{c a v}=H_{0}+H_{F W M}^{(1)}+H_{F W M}^{(2)}$, with:

and the four-wave mixing terms:

where $\bar{\Delta}_{c}=\omega-\omega_{0}-N U_{0}, \bar{\Delta}_{c}^{\prime}=\omega-\omega_{0}^{\prime}-N U_{0}$ are the effective pump detunings from the on-axis and sideband cavity modes, respectively, $n_{0}=a_{0}^{\dagger} a_{0}, n_{ \pm}=a_{ \pm}^{\dagger} a_{ \pm}, N_{0}=b_{0}^{\dagger} b_{0}, N_{ \pm}=$ $b_{ \pm}^{\dagger} b_{ \pm}, U_{0}=g_{0}^{2} / \Delta_{a}$ is the single atom light shift, $\Delta_{a}=\omega-\omega_{a}$ is the laser-atom detuning of the two-level optical transition, $g_{0}$ is the atom-cavity coupling strength, and $\hbar \omega_{R}=\left(\hbar q_{c}\right)^{2} / 2 m$ is the transverse recoil energy. Following [5, 6], we here concentrate on the system dynamics for $\bar{\Delta}_{c}^{\prime}<0$, where $\omega_{0}^{\prime}$ (i.e. $\Lambda_{c}$ ) is tunable via Fourier filtering of the intracavity light [86].

Generation of correlated atom pairs via the four-wave mixing terms of $H_{F W M}^{(1)}$ can be explained by a scattering process illustrated in Fig. 1d). A photon scattered from the coherent onaxis mode into the initially empty (vacuum) sideband mode $a_{ \pm}$,
via $a_{ \pm}^{\dagger} a_{0} b_{\mp}^{\dagger} b_{0}$, can be scattered back into the on-axis mode via $a_{0}^{\dagger} a_{ \pm} b_{ \pm}^{\dagger} b_{0}$. This momentum conserving process creates a correlated pair of indistinguishable atoms with opposite momenta, which can lead to multiparticle entanglement during transient dynamics in a dissipative cavity, as numerically demonstrated in this Letter.

The process can also be described by the atom-only Hamiltonian $H_{a d}$, for which the photonic modes are adiabatically eliminated (valid for $\left|\bar{\Delta}_{c}\right|,\left|\bar{\Delta}_{c}^{\prime}\right| \gg \omega_{R}$ ), given by $H_{a d}=H_{p a i r}+H_{a d}^{\prime}$, where:

with parameter $g_{c a v}=2 U_{0}^{2} \eta_{e f f}^{2}\left|\bar{\Delta}_{c}^{\prime}\right| /\left[\left(\bar{\Delta}_{c}^{\prime 2}+\kappa^{2}\right)\left(\bar{\Delta}_{c}^{2}+\kappa^{2}\right)\right]$ (where $\bar{\Delta}_{c}^{\prime}<0$ ). In deriving $H_{a d}$ we have neglected $H_{F W M}^{(2)}$, the influence of photonic sideband creation/annihilation on the coherent field in the on-axis mode, along with the influence of photonic sideband quantum noise on the atomic motion. The relationship of $H_{B}$ and $H_{c a v}$ becomes now more apparent. Indeed, $H_{p a i r}$ has the form equivalent to $H_{B}$, while $H_{a d}^{\prime}$ describes the energy shifts related to self-organization in the laser driven system ( $H_{a d}^{\prime}$ and details of the derivation are given in [87]).

Dicke squeezed states in transverse atomic momentum. Our aim is to study the phenomenon of Dicke squeezing and the associated multiparticle (many-atom) entanglement for the Hamiltonians $H_{B}, H_{a d}$ and $H_{c a v}$. To this end we define the sideband operators: $\delta n=n_{+}-n_{-}, \delta N=N_{+}-N_{-}$, along with: $J_{x}=\left(b_{+}^{\dagger} b_{-}+b_{-}^{\dagger} b_{+}\right) / 2, J_{y}=\left(b_{+}^{\dagger} b_{-}-b_{-}^{\dagger} b_{+}\right) / 2 i, J_{z}=$ $\delta N / 2$, which are analogous to Schwinger's angular momentum operators [88], with $J_{e f f}^{2}=J_{x}^{2}+J_{y}^{2}$.

Dicke squeezed states for the transverse momentum sidebands, depicted on the Bloch sphere in Fig. 2b), are characterized by a low $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle$, large $\left\langle J_{\text {eff }}^{2}\right\rangle$ and $\left\langle J_{x}\right\rangle=\left\langle J_{y}\right\rangle=\left\langle J_{z}\right\rangle=0$ [53, 62, 63, 65, 66]. For the two transverse modes, the criterion for Dicke state multiparticle entanglement of identical atoms is given by [66, 89]:

where $N=N_{0}+N_{+}+N_{-}$is the total number of atoms, taken as constant in our simulations.

One can easily show that $J_{\text {eff }}^{2}=N_{+} N_{-}+\left(N_{+}+N_{-}\right) / 2$, such that $\left\langle J_{\text {eff }}^{2}\right\rangle=\left\langle N_{+} N_{-}\right\rangle+\left\langle N_{+}+N_{-}\right\rangle / 2$, where $\left\langle N_{+} N_{-}\right\rangle$is a measure of sideband momentum correlations. For the maximally entangled state, $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle=0$ and $\left\langle J_{e f f}^{2}\right\rangle=N(N+2) / 4$. In the atomic many-body basis, this maximally multiparticle entangled state is the ideal Dicke state, for even $N$ given by $|0\rangle_{0}|N / 2\rangle_{+}|N / 2\rangle_{-}$.

Continuous translational symmetry of $H_{B}$ and $H_{\text {cav }}$. Both $H_{B}$ and $H_{c a v}$ are symmetric to continuous translations along the $x$ axis, which leads to $\left[\delta N, H_{B}\right]=0$ and $\left[\delta n+\delta N, H_{c a v}\right]=0$, where $\left\langle J_{x}\right\rangle=\left\langle J_{y}\right\rangle=\left\langle J_{z}\right\rangle=0$ for both unitary evolution with $H_{B}$ and dissipative evolution with $H_{c a v}$ [87]. The continuous translational symmetry of $H_{B}$ and $H_{c a v}$ is preserved by the density matrix during temporal evolution. These translationally

symmetric self-organized states are analogous to maximally amplitude squeezed photonic states, for which the phase of the electric field is undetermined $[90,91]$.

Unitary evolution under $H_{B}$ and $H_{a d}$. We now discuss the solutions of the Schrödinger equation for $H_{B}$ and $H_{a d}$. Due to $\left[J_{z}, H_{B}\right]=\left[J_{z}, H_{a d}\right]=0$, for a system starting in the state $|N\rangle_{0}|0\rangle_{+}|0\rangle_{-}$, all moments of $J_{z}$ will be equal to zero at all $t$, leading to $\xi_{g e n}^{2}=0$.

The temporal evolution of $\left\langle J_{\text {eff }}^{2}\right\rangle$ is plotted in Fig. 2c). The $\left\langle J_{e f f}^{2}\right\rangle$ initially rises, and then starts to approximately periodically oscillate in time, with the characteristic timescale $\tau \sim$ $2 \pi /\left(N g_{\text {mod }}\right)$ for $H_{B}$ and $\tau \sim 2 \pi /\left(N g_{\text {cav }}\right)=4 \pi \eta_{c}^{2} /\left(\omega_{R} \eta_{\text {eff }}^{2}\right)$ for $H_{a d}$ [92]. For $H_{B}$, the atoms scatter in and out of the transverse sidebands by absorbing and emitting energy quanta from and to the driving magnetic field, while for $H_{a d}$ one observes sloshing dynamics (see below). The value of $\left\langle J_{\text {eff }}^{2}\right\rangle$ oscillates with a large amplitude, nearly reaching 0 at its trough and $N(N+2) / 4$ for $H_{B}$ at its peak.

The available Hilbert space is for this initial condition significantly reduced, as states keep zero transverse atomic momentum during unitary evolution, allowing for simulations with
relatively large $N$. Plotting the highest $J_{\text {eff }}^{2}$ reached during temporal evolution for $H_{B}$ and $H_{a d}$, denoted by $J_{\max }^{2}$, versus $N$, reveals a rise parallel to the $N(N+2) / 4$ line over nearly three orders of magnitude, up to the maximum atom number tractable by the computational resources available, see Fig. 2a).

The $N^{2}$ scaling of $J_{\text {max }}^{2}$, observed for large $N$ during unitary evolution, demonstrates the high efficiency of $H_{B}$ and $H_{a d}$ in generating momentum entangled atoms, which echoes the efficiency of optical parametric amplifiers in generating photonic entanglement [77].

Dissipative dynamics under $H_{\text {cav }}$ and $H_{a d}$. We first look at the full photon-atom dynamics for both the coherent unitary evolution and for including the cavity photon decay in the Lindblad master equation. Due to conservation of momentum in the combined photon-atom four-wave mixing, we have $\left[\delta n+\delta N, H_{c a v}\right]=0$, but $\left[J_{z}, H_{c a v}\right] \neq 0$. The Hilbert space is in this problem considerably larger than for $H_{B}$, which limits the tractable atom number to $N=8$ for the calculations of full quantum dynamics. Parameter values for this case are taken such that maximal Dicke squeezing is observed, and experimentally accessible parameters are discussed in [87].

Due to $\left[\delta n+\delta N, H_{c a v}\right]=0$, the variance of $2 J_{z}$ is equal to the variance of $\delta n$ for the unitarily evolving system. This indicates that a reduction of $\xi_{g e n}^{2}$ will benefit from lower $\delta n$ variances, which in general occur when $\left\langle n_{0}\right\rangle$ and $\left\langle n_{ \pm}\right\rangle$are lower, e.g. at larger $\left|\bar{\Delta}_{c}\right|,\left|\bar{\Delta}_{c}^{\prime}\right|$, as long as $\left\langle J_{\text {eff }}^{2}\right\rangle$ is large.

In Figs. 3a,b) we plot the temporal evolution of the relevant atomic observables for varying the pump strength $\eta$ in the case with dissipation of photons out of the cavity. For the dissipative case, the equality of $\delta N$ and $\delta n$ variances no longer holds and the dissipation of photons out of the cavity makes $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle$ increase almost linearly with time, with the slope increasing with the pump amplitude $\eta$. This indicates that there is still correlation between $\delta N$ and $\delta n$ even in the dissipative case, i.e. the low $\delta n$ variances obtained for lower $\left\langle n_{ \pm}\right\rangle$will lead to lower $\delta N$ variances.

The $\left\langle J_{\text {eff }}^{2}\right\rangle$ initially increases and oscillates in time, again indicating sloshing dynamics, with continuous oscillations between the bunched and nearly homogeneous structures in the self-ordered atomic lattice (see also [6, 93]). Increasing the pump $\eta$, both the growth rate and maximum value of $\left\langle J_{e f f}^{2}\right\rangle$ are increased. The growth rate of $\left\langle J_{\text {eff }}^{2}\right\rangle$ increases faster with distance to threshold than the growth rate of $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle$, which, from Eq. (6), leads to a decrease in $\xi_{g e n}^{2}$ for larger $\eta$. Increasing the $\eta$ values several times above the semiclassically calculated threshold $\eta_{c}=\left[-\omega_{R}\left(\bar{\Delta}_{c}^{2}+\kappa^{2}\right)\left(\bar{\Delta}_{c}^{\prime 2}+\right.\right.$ $\left.\left.\kappa^{2}\right) /\left(4 N U_{0}^{2} \bar{\Delta}_{c}^{\prime}\right)\right]^{1 / 2} \approx 13 \omega_{R}$ [87], the $\xi_{m}^{2}$, given by the lowest $\xi_{\text {gen }}^{2}$ attained during temporal evolution, reaches values of $\xi_{m}^{2}=0.03$ for the unitary and $\xi_{m}^{2}=0.18$ for the dissipative case, see Fig. 3c). We have also performed simulations of dissipative dynamics with adiabatically eliminated photonic modes, described by a Lindblad master equation with $H_{a d}$ and decay rate $\gamma=U_{0}^{2} \eta_{e f f}^{2} \kappa /\left[\left(\bar{\Delta}_{c}^{\prime 2}+\kappa^{2}\right)\left(\bar{\Delta}_{c}^{2}+\kappa^{2}\right)\right]$. The $H_{a d}$ calculations with $\eta_{\text {eff }}=0.56 \eta$ reproduce well the squeezing for

the full model, as shown in Fig. 3c). The rescaling of $\eta_{e f f}$ with respect to $\eta$ is a consequence of neglecting the nonlinear saturation and on-axis mode depletion terms in deriving $H_{a d}$ [87].

For higher $N$ calculations, reachable with the $H_{a d}$ model, the $\xi_{m}^{2}$ again decreases for decreasing the decay rate $\kappa$ at fixed detunings $\bar{\Delta}_{c}, \bar{\Delta}_{c}^{\prime}$ and $\eta_{e f f} / \eta_{c}$ [see Fig. 4a)], which is a consequence of increasing the ratio $-g_{c a v} / \gamma=2\left|\bar{\Delta}_{c}^{\prime}\right| / \kappa$, leading towards coherent cavity dynamics similarly to the single mode cavity case [54, 92]. The parameters $\bar{\Delta}_{c}^{\prime} / \kappa$ and $\eta_{e f f} / \eta_{c}$ completely determine the open system dynamics for $H_{a d}$ with $N$ atoms. Intriguingly, significant squeezing can be achieved in this model for large $-\bar{\Delta}_{c}^{\prime} / \kappa$ even with "bad cavity" parameters. Indeed, using the finesse $F=250$ and a free spectral range of $\mathrm{FSR}=1.5 \mathrm{GHz}$, with $\kappa /(2 \pi)=\mathrm{FSR} /(2 F)=3 \mathrm{MHz}$ and $\omega_{R}=2 \pi \times 0.1 \mathrm{kHz}$, we demonstrate in Fig. 4b) that nearly 10 dB squeezing is attainable for $N=120$ atoms.

Conclusion. Momentum entanglement of ultracold atoms holds great potential for enhancing matter wave interferometry [94]. We have theoretically and numerically explored two methods for producing momentum multiparticle entangled (Dicke squeezed) states of atoms with one internal ground state (spin-0), by nonlinear self-organization in driven systems. For $H_{B}$ the drive is an oscillating magnetic field, and the method is based on the experiment of Ref. [31]. A novel model $H_{c a v}$, based on laser driving of a two-level optical transition of a

BEC with ring cavity feedback, is also developed and explored. Although entanglement occurs here in the transient dynamical regime, it can readily be shown that switching off the driving field at the moment of optimal squeezing preserves the momentum distribution and thus also the entanglement for a longer time [87]. The three mode picture, for which the higher order momentum sideband population is considered negligible, can prove incomplete when scattering to higher order modes is strong, which is explored in [87].

Experimental determination of $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle$ and $\left\langle J_{\text {eff }}^{2}\right\rangle$ relies on assessing the momentum correlations via $\left\langle N_{+} N_{-}\right\rangle$. Absorption imaging of the atomic momentum distribution with a highly efficient camera can be used to measure $N_{+} N_{-}$for each experimental realization, and $\left\langle N_{+} N_{-}\right\rangle$can then be determined by taking the average for many realizations. Alternative ways of measuring atomic momentum correlations are given e.g. in [63, 95]. Note that Dicke squeezing generation described in this Letter is based on continuous symmetry of $H_{B}$ and $H_{c a v}$, which is also present for some prominent recent models describing self-organization of ultracold atoms [17, 23].

Moreover, since the calculations show significant momentum squeezing is available even for low finesse values, a relatively simple setup with a nearly degenerate cavity external to the vacuum chamber may be sufficient to realize it experimentally. Another highly intriguing prospect is the possibility of generating correlations in thermal and ultracold atomic degrees of freedom in a single mirror feedback setup [12, 26, 96-100] or using counterpropagating beams [9, 101, 102].

## DERIVATION OF $H_{B}$ AND $H_{c a v}$

The derivation of $H_{B}$ is given for 2D clouds in the Methods section of Ref. [S1], and can be readily simplified to the 1D case. The starting Hamiltonian is for this case given by:

$$
\begin{equation*}
h_{B}=\int_{V} d^{3} r \psi^{\dagger}(\mathbf{r})\left[\frac{\mathbf{p}^{2}}{2 m}+\frac{g(t)}{2} \psi^{\dagger}(\mathbf{r}) \psi(\mathbf{r})\right] \psi(\mathbf{r}), \tag{S1}
\end{equation*}
$$

with $g(t)=\frac{4 \pi \hbar^{2}}{m}\left[a_{d c}+a_{\text {mod }} \sin \left(\omega_{\text {mod }} t\right)\right]$, where $a_{d c}$ is a small offset scattering length required for the stability of the condensate. In the experiment of $\operatorname{Ref}[\mathrm{S} 1], a_{\text {mod }}=22.5 a_{d c}$, and thus $g(t)$ is approximated as $g(t) \approx \frac{4 \pi \hbar^{2}}{m} a_{\text {mod }} \sin \left(\omega_{\text {mod }} t\right)$. Neglecting here the higher order momentum terms (see section "Suppression of higher order sideband excitation"), the atomic field operator is approximated as:

\psi(\mathbf{r})=\frac{1}{\sqrt{V}}\left(b_{0}+b_{+} e^{i k_{f} x}+b_{-} e^{-i k_{f} x}\right) \tag{S2}

where $b_{j}$ is the bosonic annihilation operator of the $j$-th transverse atomic momentum mode and $k_{f}$ is the critical wavenumber. The Hamiltonian now has the form:

We now provide the details of the derivation of $H_{c a v}$. A cigar-shaped zero-temperature Bose-Einstein condensate (BEC) is placed in an effectively plano-planar ring cavity of effective diffractive length $L$ with one lossy and three perfectly reflecting mirrors ( $\kappa$ - cavity photon decay rate), which is pumped by a coherent electric field with pump strength $\eta$ at frequency $\omega$ (see Fig. S1a) and section "Experimental design of the ring cavity setup" for details). A strong confinement along the $y$ and $z$ axes allows to restrict the analysis to 1 D structures. The pump drive excites on-axis running waves with spatial profile $e^{i k_{0} z}$, with the spontaneously generated sidebands having the profile $e^{i k_{0} z} e^{ \pm i q_{c} x}$, where $k_{0}=2 \pi / \lambda_{0}$ is the cavity longitudinal mode (also called the on-axis or zero-order mode) wavenumber, $q_{c}=2 \pi / \Lambda_{c}$ and $\Lambda_{c}$ is the pattern lengthscale, tunable via Fourier filtering of intracavity light [S2].

Following Refs. [S3-S5], we take the electric field modes as:

In writing Eq. (S11) we have neglected the random collisions between the atoms in the dilute BEC cloud, as we are here interested on highlighting the consequences of light-matter interaction. The number of atoms is fixed and given by $N=N_{0}+N_{+}+N_{-}$, where $N_{0}=b_{0}^{\dagger} b_{0}, N_{ \pm}=b_{ \pm}^{\dagger} b_{ \pm}$.

Generation of transverse sidebands via $H_{F W M}^{(1)}$ can be explained by the momentum conserving processes illustrated in Fig. 1d) of the main text. The $H_{F W M}^{(2)}$ describes the secondary wave mixing process for stripe patterns, in which a scattering of a photon sideband with $\pm q_{c}$ into the mode with $\mp q_{c}$ leads to a transition of an atom from the state with transverse momentum $\mp \hbar q_{c}$ into the state with transverse momentum $\pm \hbar q_{c}$. This process leads to saturation of the sideband mode population far above threshold [S9].

## MEAN FIELD EVOLUTION EQUATIONS FOR $H_{c a v}$

We first look at the temporal evolution of the field operators [S10]. The Heisenberg equation for an operator $O(t)$ has the form:

The structure of the expression (S47) for $\eta_{c}$ bears similarity to the threshold for the transversely pumped single mode cavity, given by $\sqrt{-\omega_{R}\left(\bar{\Delta}_{c}^{2}+\kappa^{2}\right) /\left(2 N \bar{\Delta}_{c}\right)}$ [S12].

We now numerically investigate the system dynamics in the mean-field limit of the dissipative evolution for the Hamiltonian $H_{c a v}$. In Fig. S1b) we plot the square root of the diffracted photon number $\left|\alpha_{ \pm}^{S}\right|=\left(\left\langle n_{ \pm}\right\rangle_{S} / N\right)^{1 / 2}$ and the transverse atomic sideband population $\left|\beta_{ \pm}^{S}\right|=\left(\left\langle N_{ \pm}\right\rangle_{S} / N\right)^{1 / 2}$ vs. the pump $\eta$. For the results in Fig. S1b), the equations (S26)-(S31) are solved numerically and the steady state values are plotted for different $\eta$ 's. In the inset we plot the temporal evolution of the roll patterns in the atomic density, given by $n(x, t)=\left|\beta_{0}(t)+\beta_{+}(t) \exp \left(i q_{c} x\right)+\beta_{-}(t) \exp \left(-i q_{c} x\right)\right|^{2}$, and in the electric field intensity, given by $I(x, t)=\left|\alpha_{0}(t)+\alpha_{+}(t) \exp \left(i q_{c} x\right)+\alpha_{-}(t) \exp \left(-i q_{c} x\right)\right|^{2}$, normalized to the steady state $\left|\alpha_{0}^{S}\right|^{2}$, denoted by $I_{0}$.

The mean field patterns appear for the pump rate $\eta>\eta_{c}$. The initial sharp increase in the transverse excitations, seen in Fig. S1b) for $\eta \gtrsim \eta_{c}$, gives way to saturation for larger $\eta$ 's. In the inset we plot the temporal evolution of the semiclassical stripe patterns in the atomic density $n(x, t)$ and the electric field intensity $I(x, t)$, normalized to the steady state $\left|\alpha_{0}^{S}\right|^{2}$, denoted by $I_{0}$.

The system starts with $\alpha_{0}(0)=\alpha_{ \pm}(0)=0$, with $\alpha_{0}(t)$ rising rapidly on the scale $1 / \kappa$, which is not detectable on the plot since the $t$ range is too large. This homogeneous state becomes unstable after around $10 / \omega_{R}$, a time determined by the initial fluctuations in the atomic density, which were made artificially small in the plots shown (note that the steady state in this self-organizing mean field model is the same for all reasonable values of initial fluctuations). Before reaching the steady state, the $\left|\alpha_{ \pm}(t)\right|$ and $\left|\beta_{ \pm}(t)\right|$ oscillate at a frequency of a few $\omega_{R}$. This oscillation of the sideband populations is a signature of the sloshing dynamics, i.e. the continuous oscillation between the bunched and homogeneous atomic structure in the optical lattice (studied e.g. in [S13, S14]). The stripes in $n(x, t)$ and $I(x, t)$ are complementary, which is a consequence of the optical dipole potential repulsing the atoms away from the intensity peaks for $U_{0}>0$ [S15, S16].

## CONTINUOUS TRANSLATIONAL SYMMETRY OF $H_{B}$ AND $H_{c a v}$

We start by writing again the operators for the photon and atomic momentum sidebands, which have the form $\delta n=n_{+}-n_{-}$, $\delta N=N_{+}-N_{-}$, with $n_{ \pm}=a_{ \pm}^{\dagger} a_{ \pm}$and $N_{ \pm}=b_{ \pm}^{\dagger} b_{ \pm}$. The Hamiltonian $H_{B}$ is symmetric to translations by a real-valued distance parameter $d$ along the $x$ axis, which transforms the wavefunction as $\psi(x) \rightarrow \psi(x+d)$, meaning it is symmetric under simultaneous transformations: $b_{0} \rightarrow b_{0}, b_{ \pm} \rightarrow e^{ \pm i d k_{f}} b_{ \pm}$. The generator of this symmetry is the $x$ component of the atomic momentum operator, in the many-body formalism given simply by $p_{x}=\hbar k_{f} \delta N$. The corresponding translation operation is performed by the unitary operator $T_{B}(d)=e^{i d p_{x} / \hbar}$. This continuous symmetry of $H_{B}$ leads to:

FIG. S1. (a) Schematics of the proposed experimental setup for observing Dicke state entanglement via self-organization of ultracold atoms in a laser pumped ring cavity. The ultracold BEC gas, strongly confined along the $y$ and $z$ axes, is placed in a ring cavity with linewidth $\kappa$, which is pumped by coherent on-axis light with drive amplitude $\eta$ (blue arrow). Effective cavity length $L$ can be controlled by adjustment of intracavity lenses (light blue) around the afocal telescopic condition, while pattern lengthscale $\Lambda_{c}$ is tuned via Fourier filtering (FF) of the photonic sidebands (red arrows). (b) Mean-field transverse optomechanical self-ordering in a leaky ring cavity. The square root of the steady state diffracted photon number $\left|\alpha_{ \pm}^{S}\right|$ (orange) and transverse atomic sideband population $\left|\beta_{ \pm}^{S}\right|$ (blue) for varying the input beam pump rate $\eta$ (see text). Inset: temporal evolution of the semiclassical stripe patterns in the atomic density $n(x, t)$ (upper) and the normalized electric field $I(x, t) / I_{0}$ (lower) at $\eta=1.2 \eta_{c}$ (see text). Simulation parameters: $N=10^{4}$ and $\left(\bar{\Delta}_{c}, \bar{\Delta}_{c}^{\prime}, U_{0}, \kappa\right)=\left(8.8,-10,1.2 \times 10^{-4}, 10\right) \omega_{R}$, with $\hbar=1$.

Note that the same conclusion can be reached from the opposite direction, by explicitly calculating $\left[\delta N, H_{B}\right]=0$ and finding the corresponding unitary symmetry operator. By using the Baker-Campbell-Hausdorff formula and the commutator $\left[\delta N, b_{ \pm}\right]=\mp b_{ \pm}$, it can then be readily shown that $T_{B}^{\dagger}(d) b_{ \pm} T_{B}(d)=e^{ \pm i d k_{f}} b_{ \pm}$.

The Hamiltonian $H_{c a v}$ is also symmetric to continuous translations by $d$ along the $x$ axis, which transforms the wavefunction and the electric field as $\psi(x) \rightarrow \psi(x+d), E(x) \rightarrow E(x+d)$, meaning it is symmetric under simultaneous transformations: $a_{0} \rightarrow a_{0}, a_{ \pm} \rightarrow e^{ \pm i q_{c} d} a_{ \pm}, b_{0} \rightarrow b_{0}, b_{ \pm} \rightarrow e^{ \pm i q_{c} d} b_{ \pm}$. The generator of this symmetry is the $x$ component of the combined photonic and atomic momentum operator, given by $P_{x}=\hbar q_{c}(\delta n+\delta N)$. The corresponding translation operation is performed by the unitary operator $T_{\text {cav }}(d)=e^{i d P_{x} / \hbar}$. This continuous symmetry of $H_{c a v}$ leads to:

T_{c a v}^{\dagger}(d) H_{c a v} T_{c a v}(d)=H_{c a v} \rightarrow\left[\delta n+\delta N, H_{c a v}\right]=0 \tag{S49}
\end{equation*}
$$

Again, the same conclusion can be reached from the opposite direction, by explicitly calculating [ $\left.\delta n+\delta N, H_{c a v}\right]=0$ and finding the corresponding unitary symmetry operator. Following the same procedure as above, it can readily be shown that now $T_{c a v}^{\dagger}(d) a_{ \pm} T_{c a v}(d)=e^{ \pm i d q_{c}} a_{ \pm}$and $T_{c a v}^{\dagger}(d) b_{ \pm} T_{c a v}(d)=e^{ \pm i d q_{c}} b_{ \pm}$.

To illustrate the meaning of preservation of translational symmetry during temporal evolution, we calculate the atomic spatial probability distribution $\left\langle\psi^{\dagger}(x) \psi(x)\right\rangle$ for $V=1$ as:

\left\langle\psi^{\dagger}(x) \psi(x)\right\rangle=\left\langle N_{0}\right\rangle+\left\langle N_{+}\right\rangle+\left\langle N_{-}\right\rangle+\left\langle b_{0}^{\dagger} b_{+}+b_{-}^{\dagger} b_{0}\right\rangle e^{i k x}+\left\langle b_{0}^{\dagger} b_{-}+b_{+}^{\dagger} b_{0}\right\rangle e^{-i k x}+\left\langle b_{-}^{\dagger} b_{+}\right\rangle e^{2 i k x}+\left\langle b_{+}^{\dagger} b_{-}\right\rangle e^{-2 i k x} \tag{S50}
\end{equation*}
$$

where $k=k_{f}$ for $H_{B}$ and $k=q_{c}$ for $H_{c a v}$. It can readily be shown that for a translationally invariant density matrix $\rho(t)=$ $T^{\dagger}(d) \rho(t) T(d)$, the inhomogeneous terms of Eq. (S50) vanish (see below), and $\left\langle\psi^{\dagger}(x) \psi(x)\right\rangle=N$, in contrast to the results for the semiclassical (mean-field) framework shown in Fig. S1. Such situation where atomic spatial probability distribution is homogeneous, even though self-organization takes place, occurs because of the Heisenberg uncertainty relation for position and momentum measurements. This means that, as the atoms are in a continuously translationally invariant state, a pattern realization with any displacement from $x=0$ (i.e. pattern phase) is equally probable.

Performing a measurement of the atomic position will collapse the system onto a state with an undetermined (i.e. one with maximum variance in) total momentum, which means the inhomogeneous terms of Eq. (S50) will be nonzero. The spatial probability distribution will then be sinusoidal, with a fixed spatial phase of the patterns. As the measured states have undetermined atomic positions, the measurement of the atomic distributions should yield random values of the pattern phases. This was indeed seen in the experiments of Ref. [S1], where pattern realizations with random pattern phases (displacements) and orientations, in a 2D system, were reported.

We note that the above described translationally invariant states are analogous to the maximally amplitude squeezed photonic states, for which the phase of the electric field is undetermined [S17]. Similar conclusions were previously also reached for the photonic self-organized patterns, as reported in [S4].

## VANISHING OF $\langle J\rangle$ DURING DYNAMICAL EVOLUTION

It can readily be shown that the expectation value of the total (vector) "angular momentum" operator of the atomic momentum sidebands vanishes, i.e. $\langle\mathbf{J}\rangle=0$, for both unitary evolution under $H_{B}$, along with unitary and dissipative evolution under $H_{c a v}$. To do this, we first write the atomic momentum ladder operators $J_{ \pm}=b_{ \pm}^{\dagger} b_{\mp}$, where the $J_{x}, J_{y}$ are now $J_{x}=\left(J_{+}+J_{-}\right) / 2, J_{y}=$ $\left(J_{+}-J_{-}\right) / 2 i$.

For $H_{B}$, in our simulations the system evolves from the initial state $\left|\psi_{0}\right\rangle=|N\rangle_{0}|0\rangle_{+}|0\rangle_{-}$to the state $|\psi(t)\rangle$, by unitary evolution $|\psi(t)\rangle=U_{B}(t)\left|\psi_{0}\right\rangle$, where $U_{B}(t)=e^{-i H_{B} t / \hbar}$. The expectation values of $J_{ \pm}$at time $t$ are thus given by $\left\langle J_{ \pm}\right\rangle=\langle\psi(t)| J_{ \pm}|\psi(t)\rangle$. Now, the temporal evolution of the state $\left|\psi_{0}\right\rangle$ via $H_{B}$ leaves the state $|\psi(t)\rangle$ on a part of the Hilbert space spanned by states with zero transverse momentum, since $H_{B}$ conserves the transverse momentum. In contrast, the operators $J_{ \pm}$act to transfer the state $|\psi(t)\rangle$ to an orthogonal part of the Hilbert space, since they increase/decrease the transverse momentum by $2 \hbar k_{f}$. The orthogonality of $J_{ \pm}|\psi(t)\rangle$ and $|\psi(t)\rangle$ thus leads to $\left\langle J_{ \pm}\right\rangle=0$, and correspondingly to $\left\langle J_{x}\right\rangle=\left\langle J_{y}\right\rangle=0$. Likewise, $\left\langle J_{z}\right\rangle=0$ follows from the fact that the total transverse momentum of the state $|\psi(t)\rangle$ remains zero for all time.

For unitary evolution under $H_{c a v}$, the initial state is in our simulations given by $\left|\psi_{0}\right\rangle=|0,0,0\rangle_{p h}|N\rangle_{0}|0\rangle_{+}|0\rangle_{-}$. The dynamics leads now to the state $|\psi(t)\rangle=U_{\text {cav }}(t)\left|\psi_{0}\right\rangle$, where $U_{c a v}(t)=e^{-i H_{c a v} t / \hbar \text {, for which the total photonic and atomic transverse }}$ momentum is equal to zero. As the operators $J_{ \pm}$do not conserve the transverse momentum, they take the state $|\psi(t)\rangle$ to an orthogonal part of the Hilbert space, and we again have $\left\langle J_{x}\right\rangle=\left\langle J_{y}\right\rangle=0$.

For $H_{c a v},\left\langle J_{z}\right\rangle=0$ follows from parity $(+\leftrightarrow-)$ symmetry of $H_{c a v}$, i.e. $P^{-1} H_{c a v} P=H_{c a v}$, where the operator $P$ inverts the $x$ axis, switching between the + and - modes. The parity symmetry of $H_{c a v}$ and $\left|\psi_{0}\right\rangle$ leads to a parity symmetry of the state $|\psi(t)\rangle$, which means $\left\langle J_{z}\right\rangle=\langle\psi(t)| J_{z}|\psi(t)\rangle=\langle\psi(t)| P^{-1} J_{z} P|\psi(t)\rangle=-\left\langle J_{z}\right\rangle$, leading to $\left\langle J_{z}\right\rangle=0$.

To show that $\langle\mathbf{J}\rangle=0$ during dissipative evolution for $H_{c a v}$, we write the Lindblad master equation for the density matrix $\rho(t)$ as [S10]:

\frac{d \rho}{d t}=\mathcal{L}[\rho], \text { where } \mathcal{L}[\rho]=-\frac{i}{\hbar}\left[H_{c a v}, \rho\right]+\kappa \sum_{j=0, \pm}\left(2 a_{j} \rho a_{j}^{\dagger}-a_{j}^{\dagger} a_{j} \rho-\rho a_{j}^{\dagger} a_{j}\right) \tag{S51}
\end{equation*}
$$

The above equation can be formally solved as [S18]:

\rho(t)=e^{\mathcal{L} t}[\rho(0)]=\rho(0)+t \mathcal{L}[\rho(0)]+\frac{t^{2}}{2} \mathcal{L}[\mathcal{L}[\rho(0)]]+\ldots \tag{S52}

By noting that $T_{c a v}(d) \rho(0) T_{c a v}^{\dagger}(d)=\rho(0)$, it can readily be shown that $T_{c a v}(d) \rho(t) T_{c a v}^{\dagger}(d)=\rho(t)$. To demonstrate this, we write for the first order term of (S52):

T_{c a v}(d) \mathcal{L}[\rho(0)] T_{c a v}^{\dagger}(d)=T_{c a v}(d)\left[-\frac{i}{\hbar}\left[H_{c a v}, \rho(0)\right]+\kappa \sum_{j=0, \pm}\left(2 a_{j} \rho(0) a_{j}^{\dagger}-a_{j}^{\dagger} a_{j} \rho(0)-\rho(0) a_{j}^{\dagger} a_{j}\right)\right] T_{c a v}^{\dagger}(d) \tag{S53}
\end{equation*}
$$

Now, the relations $T_{c a v}(d) H_{c a v} T_{c a v}^{\dagger}(d)=H_{c a v}, T_{c a v}(d) a_{0} T_{c a v}^{\dagger}(d)=a_{0}$ and $T_{c a v}(d) a_{ \pm} T_{c a v}^{\dagger}(d)=e^{\mp i d q_{c}} a_{ \pm}$lead to:

\begin{equation*}
T_{c a v}(d) \mathcal{L}[\rho(0)] T_{c a v}^{\dagger}(d)=\mathcal{L}[\rho(0)] \tag{S54}
\end{equation*}
$$

Similarly, we write the second order term of (S52) as:

T_{c a v}(d) \mathcal{L}[\mathcal{L}[\rho(0)]] T_{c a v}^{\dagger}(d)=T_{c a v}(d)\left[-\frac{i}{\hbar}\left[H_{c a v}, \mathcal{L}[\rho(0)]\right]+\kappa \sum_{j=0, \pm}\left(2 a_{j} \mathcal{L}[\rho(0)] a_{j}^{\dagger}-a_{j}^{\dagger} a_{j} \mathcal{L}[\rho(0)]-\mathcal{L}[\rho(0)] a_{j}^{\dagger} a_{j}\right)\right] T_{c a v}^{\dagger}(d) \tag{S55}
\end{equation*}
$$

Using now the same relations as above and Eq. (S54) leads to:

T_{c a v}(d) \mathcal{L}[\mathcal{L}[\rho(0)]] T_{c a v}^{\dagger}(d)=\mathcal{L}[\mathcal{L}[\rho(0)]] \tag{S56}
\end{equation*}
$$

Repeating the same procedure for all the higher order terms leads to:

T_{c a v}(d) \rho(t) T_{c a v}^{\dagger}(d)=\rho(t) \tag{S57}
\end{equation*}
$$

which can also be shown by using Eq. (2.4) of Ref. [S11].
One can then show that $\left\langle T_{c a v}^{\dagger}(d) J_{ \pm} T_{c a v}(d)\right\rangle=e^{\mp 2 i d q_{c}}\left\langle J_{ \pm}\right\rangle=\operatorname{Tr}\left(T_{\text {cav }}^{\dagger}(d) J_{ \pm} T_{c a v}(d) \rho(t)\right)=\operatorname{Tr}\left(J_{ \pm} T_{\text {cav }}(d) \rho(t) T_{c a v}^{\dagger}(d)\right)=\operatorname{Tr}\left(J_{ \pm} \rho(t)\right)=$ $\left\langle J_{ \pm}\right\rangle$, where we have used the invariance of trace under cyclic permutations, and the relations above. Since $e^{\mp 2 i d q_{c}}\left\langle J_{ \pm}\right\rangle=\left\langle J_{ \pm}\right\rangle$for any $d$ in the 1D space of the problem, we have $\left\langle J_{ \pm}\right\rangle=\left\langle J_{x}\right\rangle=\left\langle J_{y}\right\rangle=0$ during dynamical evolution.

To show that $\left\langle J_{z}\right\rangle=0$, we first note that the same procedure as above leads from $P \rho(0) P^{-1}=\rho(0)$ to $P \rho(t) P^{-1}=\rho(t)$. We then have $\left\langle P^{-1} J_{z} P\right\rangle=-\left\langle J_{z}\right\rangle=\operatorname{Tr}\left(P^{-1} J_{z} P \rho(t)\right)=\operatorname{Tr}\left(J_{z} P \rho(t) P^{-1}\right)=\operatorname{Tr}\left(J_{z} \rho(t)\right)=\left\langle J_{z}\right\rangle$, which leads to $\left\langle J_{z}\right\rangle=0$ during dynamical evolution.

Finally, we note that for the dissipative evolution, in contrast to the unitary case, the total momentum is not conserved, even though $\left\langle\mathcal{L}^{\dagger}[\delta n+\delta N]\right\rangle=0$ and $\langle\delta n\rangle=\langle\delta N\rangle=0$, as $\mathcal{L}^{\dagger}[\delta n+\delta N] \neq 0$ [S11]. Since $\delta n+\delta N$ does not commute with $a_{ \pm}, a_{ \pm}^{\dagger}$, this means that the higher moments of $\delta n+\delta N$ do not vanish in the dissipative case, see Fig. S2a). However, the continuous translational symmetry of the state is still preserved during temporal evolution, as $\rho(t)=T_{c a v}^{\dagger}(d) \rho(t) T_{\text {cav }}(d)$, because $T_{c a v}(d) H_{c a v} T_{c a v}^{\dagger}(d)=H_{c a v}$ and $T_{c a v}(d) a_{j} T_{c a v}^{\dagger}(d)=e^{i \phi_{j}} a_{j}$, for $j=0, \pm$. Operators of this type were discussed also in Ref. [S11].

## TEMPORAL EVOLUTION OF THE VARIANCES FOR $H_{c a v}$

We now discuss qualitatively the consequence of $\left[H_{c a v}, \delta n+\delta N\right]=0$ on the behavior of the variances of the $\delta n+\delta N, \delta n$ and $\delta N$ operators by looking at their temporal evolution, described by Eqs. (S15) and (S16). The expectation value and variance of the operator $\delta n+\delta N$ vanishes at $t=0$, as the system starts in a homogeneous state, i.e. self-organization has not yet taken place. In the unitary case, $\langle\delta n+\delta N\rangle$ remains zero for all time, as:

\begin{equation*}
\frac{d(\delta n+\delta N)}{d t}=\frac{i}{\hbar}\left[H_{c a v}, \delta n+\delta N\right]=0 . \tag{S58}
\end{equation*}
$$

Using the identity $[A, B C]=[A, B] C+B[A, C]$ cyclically, the unitary temporal evolution gives also constant values for the powers of the $\delta n+\delta N$ operator at all $t$, which means that all initially vanishing moments of this operator also vanish at all $t$. If one includes the cavity photon dissipation into the picture, the Lindblad-type evolution gives:

As $\langle\delta n\rangle=0$ for all $t$ due to the parity symmetry of $\rho(t)$ (see above), the $\langle\delta n+\delta N\rangle$ will also vanish in the dissipative case. For the variance, we look at the evolution of $\left\langle(\delta n+\delta N)^{2}\right\rangle$, described by:

\frac{d\left\langle(\delta n+\delta N)^{2}\right\rangle}{d t}=2 \kappa\left\langle n_{+}+n_{-}\right\rangle-4 \kappa\langle(\delta n+\delta N) \delta n\rangle \tag{S60}
\end{equation*}
$$

The right hand side no longer vanishes, which means $\left\langle(\delta n+\delta N)^{2}\right\rangle$ no longer vanishes for all $t$, leading to a nonvanishing variance of $\delta n+\delta N$ in the dissipative case.

Fig. S2a) shows the behavior of the $\delta n+\delta N$ variances in the case of unitary and dissipative evolution. In the unitary case, the variance vanishes (see Eq. (S58)), while in the dissipative case the variance increases almost linearly, indicating that the random dissipation of photons from the cavity increases the overall noise for both the photonic and atomic degrees of freedom.

The temporal evolution of the $\delta n$ and $\delta N$ operators is correlated due to $\left[H_{c a v}, \delta n\right]=-\left[H_{c a v}, \delta N\right]$. In the unitary case the evolution of the $\delta n$ and $\delta N$ operators is related by:

\frac{d \delta n}{d t}=\frac{i}{\hbar}\left[H_{c a v}, \delta n\right]=-\frac{i}{\hbar}\left[H_{c a v}, \delta N\right]=-\frac{d \delta N}{d t} \tag{S61}
\end{equation*}
$$

which, upon taking the expectation value and integration over $t$, leads to $\langle\delta n\rangle=-\langle\delta N\rangle$ for all $t$. Also, $\left\langle(\delta n)^{2}\right\rangle=\left\langle(\delta N)^{2}\right\rangle$ for all $t$, leading to equality of the variances of $\delta n$ and $\delta N$ for all $t$ in the unitary case (see Fig. S2b)). Smaller $\eta$ 's lead to smaller $\left\langle n_{0}\right\rangle$, $\left\langle n_{ \pm}\right\rangle$and $\delta n$ variances, meaning that the $J_{z}$ variance in the unitary case will be reduced for a smaller number of photons in the cavity.

For the dissipative case, the $\langle\delta n\rangle$ evolves as:

For the variances in the dissipative case we look at the evolution of $\left\langle(\delta n)^{2}\right\rangle$, given by:

where we have again used $[A, B C]=[A, B] C+B[A, C]$. The variances of $\delta n$ and $\delta N$ will no longer be equal at all $t$ in the dissipative case, although the temporal evolution of these operators is still coupled.

In Fig. S2b) we plot the evolution of $\delta n$ and $\delta N$ variances for the unitary and dissipative cases. As expected from Eq. (S61), the variances of $\delta n$ and $\delta N$ are equal for the unitary case, and not equal for the dissipative case, with the variance of $\delta N$ increasing almost linearly with time, and the $\delta n$ variance fluctuating around a small constant value. The reason for a relatively low $\delta n$ variance at the used parameters is the low intracavity photon number (see e.g. Fig. S5), occuring due to the laser-cavity detunings $\bar{\Delta}_{c}, \bar{\Delta}_{c}^{\prime}$ being much larger in absolute value than the cavity linewidth.

From Eq. (S65) it is also clear that when $\delta n$ is a zero matrix, which happens e.g. when there is no light in the cavity, the variance of $\delta N$ stays constant. This fact can be used to create steady state motional Dicke squeezing by turning off the pump drive at a suitable time (see Fig. S4).

## STEADY STATE DICKE ENTANGLEMENT GENERATION

In order to generate Dicke entanglement in the steady state, we move away from continuous wave (cw) driving and instead apply a temporally tailored driving field, given by a single square pulse amplitude starting instantaneously at $t=0$ and switching off instantaneously at $t=t_{O F F}$, where $t_{O F F}$ is the time for which strongest Dicke state entanglement is observed.

For unitary evolution with $N=80$ atoms under $H_{B}$, this switch off time is $t_{O F F}=0.064 / g_{\text {mod }}$, as shown in Fig. S3a). After switching off the driving $g_{\text {mod }}$, the $\left\langle J_{\text {eff }}^{2}\right\rangle$ stays near its maximum value (black dashed line) with $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle=0$, meaning the system is very near the ideal Dicke state. Note that we have here neglected the fact that a square-shaped driving will have in the spectrum the Fourier components with frequencies not equal to $\omega_{\text {mod }}$. The undesired part of the driving spectrum can however be readily suppressed by using a suitable window function for the pulse shape. Indeed, apparently steady state sideband momentum distributions with peaks at discrete momentum states at a ring of radius $\hbar k_{f}$ were measured after rapidly switching off the magnetic field driving in the 2D experiment of Ref. [S1].

For the dissipative evolution with $\kappa=5 \omega_{R}, N=8$ atoms under $H_{c a v}$, this switch off time is $t_{O F F}=0.75 / \omega_{R}$, see Fig. S4a). After switching off the laser pump, the light field inside the cavity drops to zero in a time $\sim 1 / \kappa$ (see Fig. $\mathrm{S} 4 \mathrm{~b}, \mathrm{c}$ ). In contrast, the atoms are left with a given momentum state distribution, and their kinetic energy at a constant value, as the light-matter interaction
vanishes and there are no other channels for energy exchange in the system, since interatomic collisions and atom losses are neglected in our model. Indeed, $\xi_{g e n}^{2}$ stays at a steady-state value of 0.18 , see Fig. S4a), which is also the lowest value attained for continuous driving. The lowest value attained in our simulations for the unitary case is $\xi_{g e n}^{2}=0.03$.

We introduce a slightly different figure of merit $\xi_{\text {eff }}^{2}$, which is used in the experimental work of [S19] for data analysis. The quantity is given by:

where the number of atoms in the sideband Dicke state has been postselected [S20], by replacing $N$ with $\left\langle N_{+}+N_{-}\right\rangle$in $\xi_{g e n}^{2}$. As shown in Fig. Fig. S4e), the population of sideband atoms $\left\langle N_{+}+N_{-}\right\rangle$initially increases and then oscillates in time for cw pumping, while for the square pulse the number stays at a constant value of $\left\langle N_{+}+N_{-}\right\rangle \approx 5$. For the square pulse case, the effective Dicke entanglement stays in our model at a constant value of $\xi_{\text {eff }}^{2}=0.08(-11 \mathrm{~dB})$, which is comparable to -11.4 dB of Ref. [S19], see Fig. S4d).

For both models the random collisions of the atoms in a BEC were neglected. The influence of such random collisions on the lifetime of motional state multiparticle entanglement in a BEC is currently under investigation.

## SUPPRESSION OF HIGHER ORDER SIDEBAND EXCITATION

Note that in writing the ansatz (S10), we have neglected the Fourier components with spatial periodicity of $\Lambda_{c} / 2, \Lambda_{c} / 3, \ldots$ in the atomic field, as was also done e.g. in Refs. [S13, S21]. In a transversely pumped Fabry-Perot cavity, the occurence of these higher order components in $\psi(x)$ is suppressed by the excitation of effectively only a single longitudinal optical mode. This leads to a preference of the atoms to bunch into the optical lattice with the spatial periodicity set by the longitudinal cavity mode. Similarly, in the setup for $H_{c a v}$, the suppression of higher order Fourier components of $\psi(x)$ is done by Fourier filtering of the intracavity light, which again leads to the preference for formation of an atomic field with periodicity $\Lambda_{c}$. Indeed, taking the self-organized potential depth in our calculations to be equal to $\hbar U_{0}\left\langle n_{+}+n_{-}\right\rangle \approx 1 \hbar \omega_{R}$ (see Fig. S5i)), and the atomic kinetic energy to be $\hbar \omega_{R}\left\langle N_{+}+N_{-}\right\rangle \approx 5 \hbar \omega_{R}$ (see Fig. S4e)), the ratio of the potential depth to kinetic energy is smaller than unity, which indicates weak localization of the atoms [S22]. This relatively shallow potential means that the atomic field should not be deformed with respect to the shape of the self-organized optical lattice, and the Eq. (S10) should be a good ansatz for the atomic field operator.

In contrast, the excitation of higher order sidebands in the experiment of Ref. [S1] is precluded only for $\left\langle N_{0}\right\rangle \gg\left\langle N_{ \pm}\right\rangle$. To clarify this, we first write the second order atomic field operator as:

Integration of the corresponding interatomic scattering term of the Hamiltonian, $\int d^{3} r \psi(\mathbf{r})^{\dagger} \psi(\mathbf{r})^{\dagger} \psi(\mathbf{r}) \psi(\mathbf{r})$, over the volume of the cloud, yields here the terms containing the second order sideband operators:

The dispersion for momentum states is $\varepsilon(k)=\hbar^{2} k^{2} / 2 m$, which gives for the single excitation states $\varepsilon_{ \pm}=\hbar^{2} k_{f}^{2} / 2 m=\varepsilon$, while for the double excitation states one has $\varepsilon_{2 \pm}=4 \hbar^{2} k_{f}^{2} / 2 m=4 \varepsilon$. Transforming to the rotating frame with $b_{ \pm} \rightarrow b_{ \pm} e^{-i \varepsilon t / \hbar}$, $b_{2 \pm} \rightarrow b_{2 \pm} e^{-4 i \varepsilon t / \hbar}$, and keeping only the terms resonant with the driving $\pm \hbar \omega_{\bmod }=2 \varepsilon$, leads now to the second order Hamiltonian:

It is clear from the Eq. (S72) that the higher order sideband terms are small with respect to the first order terms only if the number of single sideband excitations is much smaller than the number of ground state atoms, i.e. $\left\langle N_{0}\right\rangle \gg\left\langle N_{ \pm}\right\rangle$, which is satisfied for the weakly excited (collisionally thin) medium of Ref. [S1].

In the results plotted in Fig. S3b), we numerically demonstrate that the second order terms increase the $\xi_{g e n}^{2}$ parameter for the two first order sidebands, by increasing $\left\langle\left(\Delta J_{z}\right)^{2}\right\rangle$ and reducing $\left\langle J_{e f f}^{2}\right\rangle$. However, the $\xi_{e f f}^{2}$ parameter still reaches quite small
values (at short times after switching on the driving). We note here that it may turn out to be possible to filter out the higher order excitations in experiment, e.g. by judiciously tailoring the $a(t)$ or by removing the atoms in the second order modes from the self-organized lattice, which is a highly intriguing topic for future research, given the very large values of $\left\langle J_{\text {eff }}^{2}\right\rangle$ reached for the results of Fig. 2 of the main text.

## EXPERIMENTAL DESIGN OF THE RING CAVITY SETUP

To estimate the attainability of pattern formation and entanglement generation for realistic parameters, we first note the experimentally available $\kappa$ values of $2 \pi \times 0.13 \mathrm{MHz}$ [S23] and $2 \pi \mathrm{MHz}$ [S24]. Also, in state of the art experiments, cloud sizes for cigar-shaped BECs can be on the order of $\sim 250 \mu \mathrm{~m}$ [S25], which limits $\Lambda_{c}$ to values between approximately 1-50 $\mu \mathrm{m}$. On the short side, $\Lambda_{c}$ is limited by numerical aperture of the light collection system, while on the long side it is limited by the requirement of having at least a few periods of the transverse pattern in a cloud.

## Tuning the sideband frequency $\omega_{0}^{\prime}$ by varying effective cavity length $L$

The cavity configuration envisaged in Fig. S1a) consists of an afocal telescope in a ring cavity, such that the front focal plane of the right lens is a distance $L$ apart from the back focal plane of the left lens. This enables the tuning of the diffractive length of the cavity independent of the physical cavity length and thus enables flexibility with regard to distances of the optical elements to the BEC. In the focal plane between the two lenses, the spatial Fourier spectrum of the intra-cavity field at the position of the BEC is available for spatial filtering. The filter is transmitting the on-axis mode and the off-axis spatial sidebands at a particular transverse wavenumber $q_{c}$. The schematic with two intracavity lenses is conceptionally the simplest, however, to minimize Fresnel losses the system may be implemented using curved mirrors (see below).

The sideband cavity mode wavevector $\mathbf{k}_{0}^{\prime}$ (with length $k_{0}^{\prime}=2 \pi / \lambda_{0}^{\prime}$ ) is related to the on-axis cavity mode wavevector $\mathbf{k}_{0}=k_{0} \hat{\mathbf{z}}$ (with length $k_{0}=2 \pi / \lambda_{0}$ ) via the relation $\mathbf{k}_{0}^{\prime}=\mathbf{k}_{0}+\mathbf{q}_{c}$, where $\mathbf{q}_{c}=q_{c} \hat{\mathbf{x}}$ (with length $q_{c}=2 \pi / \Lambda_{c}$ ) is the transverse component of the sideband mode wavevector, which is in our case selected by Fourier filtering (see Fig. S1a)). For a ring cavity without the intracavity lenses, the dispersion relation of the on-axis modes is $\omega_{0}=c k_{0}$, while for the sideband with $q_{c}$ it is $\omega_{0}^{\prime}=c k_{0}^{\prime}=$ $c\left(k_{0}^{2}+q_{c}^{2}\right)^{1 / 2}=\omega_{0}\left(1+q_{c}^{2} / k_{0}^{2}\right)^{1 / 2}$.

For the cavity with two intracavity lenses of same focal length f , the diffractive length is given by $L$ (see Fig. S1a), where $L$ is also the combined distance of the two lenses from the 4 f configuration. In both the cavity with and without the intracavity lenses, the phase difference between the selected sideband mode and the on-axis mode after one round trip of duration $L_{\text {cav }} / c$ through the cavity is given by $\delta \phi=\left(\omega_{0}^{\prime}-\omega_{0}\right) L_{c a v} / c$, where $L_{c a v}$ is the length of the cavity. On the other hand, the diffraction of the sideband mode through the cavity with a diffractive length $L$ leads, in the paraxial limit (valid for small $q_{c} / k_{0}^{\prime}$ ), to a diffractive phase shift with respect to the on-axis mode of $\delta \phi \approx q_{c}^{2} L / 2 k_{0}^{\prime}=q_{c}^{2} c L / 2 \omega_{0}^{\prime}$, see e.g. Eq. (2) of Ref. [S9]. Equating the two expressions for the phase shift after one round trip through the cavity, the frequencies $\omega_{0}^{\prime}$ and $\omega_{0}$ are in this case related via the relations (valid for small $q_{c} / k_{0}^{\prime}$ ):

The frequency $\omega_{0}^{\prime}$ of the cavity mode with transverse wavevector $q_{c}$, selected by Fourier filtering, can thus be tuned relative to the on-axis mode frequency $\omega_{0}$, by translating the position of the intracavity lenses with respect to the 4 f configuration, which changes the effective cavity length $L$.

In the case when $L=0$ ( 4 f condition perfectly satisfied), all sidebands have equal frequencies. This situation corresponds to the multimode degenerate cavity case, where tilted beams with $\omega=\omega_{0}$ are resonant to the longitudinal cavity mode, see e.g. Ref. [S26]. Near cavity degeneracy, i.e. for $L \ll L_{\text {cav }}$, the quadratic relationship $\omega_{0}^{\prime}\left(q_{c}\right)-\omega_{0} \approx q_{c}^{2} \omega_{0} L /\left(2 k_{0}^{2} L_{c a v}\right)$ [S27, S28] is recovered. The difference with respect to the situation studied in [S27,S28], for which the patterns arise at $\Delta_{c}^{\prime}=0$, is the fact that Fourier filtering in our setup allows us to select $q_{c}$ and therefore the sideband detuning $\bar{\Delta}_{c}^{\prime}$ for a given pump laser frequency $\omega$.

We note here that the cavity mirrors might need to be slightly concave to allow intracavity propagation of sidebands with a slight tilt from the cavity axis in a system of finite extent. The stability of such cavities has been demonstrated e.g. in Refs. [S27, S28], where Fabry-Perot cavities were used for experimental measurements of transverse self-organization.

## Estimating pattern formation threshold and multiparticle entanglement for realistic parameter values

We here provide the experimental parameter values for the results of Fig. 4b) of the main text, and estimate the pattern formation threshold intensity for $N=5 \times 10^{5}$ atoms. To start, we take the relevant on-axis mode of the ring cavity to be detuned by $\Delta_{a}=2 \pi \times 50 \mathrm{GHz}$ from the ${ }^{87} \mathrm{Rb} \mathrm{D} 2$ line $\left(\omega_{R b}=2 \pi \times 384.23 \mathrm{THz}, \lambda_{R b}=780 \mathrm{~nm}\right.$, transition linewidth $\Gamma=2 \pi \times 6.066 \mathrm{MHz}$, recoil frequency $\omega_{r}=2 \pi \times 3.77 \mathrm{kHz}$ ). We take the cavity length of $L_{c a v}=20 \mathrm{~cm}$, the effective cavity length of $L=28.2 \mu \mathrm{~m}$ (i.e. very near the perfect 4 f condition) and the free spectral range of $c / L_{c a v}=1.5 \mathrm{GHz}$. Note that the effective cavity length $L$ can be tuned by translating an intracavity lens, where commercially available high precision mechanical translation stages have engravings of down to $0.5 \mu \mathrm{~m}$ per division, while piezoelectric stages have even higher resolutions of down to 1 nm .

In deriving $H_{c a v}$ we approximate the atom-cavity coupling $g_{0}$ for all three cavity modes to be equal, which is a good approximation in this case, as the mode frequencies and their volumes at the location of the atoms are approximately equal. Allowing for a reduction of the cavity finesse by the intracavity optics in the 4 f configuration ("bad cavity" regime), we take $\kappa=2 \pi \times 3 \mathrm{MHz}$ (finesse of 250 ) and $g_{0}=2 \pi \times 80 \mathrm{kHz}$, and get $U_{0}=g_{0}^{2} / \Delta_{a}=2 \pi \times 0.128 \mathrm{~Hz}$.

The transverse pattern recoil frequency $\omega_{R}$ for a sideband with $\Lambda_{c}=5 \mu \mathrm{~m}$ can be related to the optical transition recoil frequency $\omega_{r}$ via the relation $\omega_{R}=\omega_{r} \lambda_{R b}^{2} / \Lambda_{c}^{2}=2 \pi \times 92 \mathrm{~Hz}$, and for estimating the threshold we take the number of atoms to be $N=5 \times 10^{5}$. Finally, we tune the laser frequency at $\bar{\Delta}_{c}^{\prime}=-19 \kappa=-2 \pi \times 57 \mathrm{MHz}$ and $\bar{\Delta}_{c}=23 \kappa=2 \pi \times 69 \mathrm{MHz}$. For this optimal squeezing case from Fig. 4b), the frequency difference of the on-axis mode and the sideband is equal to $\omega_{0}^{\prime}-\omega_{0}=2 \pi \times 132 \mathrm{MHz}$. The critical pump rate is then given by $\eta_{c}=2 \pi \times 27.6 \mathrm{GHz}$.

Following Ref. [S29], the detuned saturation parameter of the intracavity beam is given by $s_{\Delta}=I / I_{s} /\left[1+\left(\Delta_{a} / \Gamma\right)^{2}\right]=$ $g_{0}^{2}\left\langle n_{0}\right\rangle /\left(\Delta_{a}^{2}+\Gamma^{2}\right)$, which gives for the threshold intracavity zero-order light intensity $I_{c}=g_{0}^{2} N\left|\alpha_{0}^{c}\right|^{2} I_{s} / \Gamma^{2}=70 \mathrm{~mW} / \mathrm{cm}^{2}$. The number of zero-order photons per atom at threshold can be estimated from Eq. (S38) to be equal to $\left|\alpha_{0}^{c}\right|^{2}=\left\langle n_{0}\right\rangle / N=$ $\eta_{c}^{2} / N /\left(\bar{\Delta}_{c}^{2}+\kappa^{2}\right)=0.32$.

## ADIABATIC ELIMINATION OF PHOTONIC MODES FOR $H_{c a v}$

To elucidate the relationship between $H_{B}$ and $H_{c a v}$, we adiabatically eliminate the photonic degrees of freedom, following the approach of [S30]. We start with the Hamiltonian:

where the saturation four-wave mixing terms were neglected. The $a_{0}$ evolution is now given by the input-output equation [S31, S32]:

where $c_{1,2}$ are the cavity input field operators from left (clockwise) and right (counterclokwise) directions. For a coherent input state from the counterclockwise direction, given by $\left|\eta^{\prime}\right\rangle$, we have $c_{1}\left|\eta^{\prime}\right\rangle=0$ and $c_{2}\left|\eta^{\prime}\right\rangle=\sqrt{\kappa} \eta^{\prime}\left|\eta^{\prime}\right\rangle$. The term proportional to $U_{0}$ in Eq. (S75) describes the influence of scattering into/out of the sideband photonic modes on the phase and amplitude of the on-axis field. This term can be neglected near threshold, where the on-axis mode is strongly populated compared to the sidebands. This results in the steady state solution:

Tracing over the zero-order photonic subspace for the input state $\left|\eta^{\prime}\right\rangle$, one gets $a_{0} \rightarrow\left\langle\eta^{\prime}\right| a_{0}\left|\eta^{\prime}\right\rangle=\sqrt{N} \alpha_{0}^{\text {eff }}$, where

For simplicity the trace notation is omitted in the calculations below, but it is always implied. Neglecting of the saturation four-wave mixing terms, and on-axis photonic mode depletion by scattering into sidebands, will lead to the rescaling of the pump rate $\eta_{\text {eff }}$ with respect to the pump rate $\eta$ of the full model. For the range of parameters discussed in the main text, it turns out that this can be taken into account by a single scaling factor $\eta_{e f f}=0.56 \eta$, as displayed in Fig. 3c).

The operator evolution equations for $a_{ \pm}$are now:

Note that, as in [S30], the photonic sideband Langevin noise terms are neglected in Eqs. (S75, S78). This assumes that the photon quantum noise has a negligible influence on the atomic motion. The atomic momentum fluctuations, induced by photons leaking out of the cavity without producing atom momentum pairs, will be taken into account via the Lindblad master equation (see below).

The coupling to the environment is modeled by the Lindblad Eq. (S51), which preserves translational symmetry [see Eq. (S57)], meaning that the atomic density distribution will be homogeneous during irreversible evolution. Measurement-induced effects, which in single mode cavities can lead to atomic momentum diffusion near cavity resonance [S33, S34], will be studied in future work.

Assuming that the fast photonic degrees of freedom adiabatically follow the slow atomic motional degrees of freedom (valid for $\left|\bar{\Delta}_{c}\right|,\left|\bar{\Delta}_{c}^{\prime}\right| \gg \omega_{R}$ ), now gives [putting $\dot{a}_{ \pm}=0$ in Eq. (S78)]:

Putting these terms into the Eq. (S74), one gets the Hamiltonian $H_{a d}=H_{p a i r}+H_{a d}^{\prime}$, where:

where $\bar{\Delta}_{c}^{\prime}<0$, as in the remainder of the manuscript. The $H_{a d}^{\prime}$ term describes the $\eta_{e f f}$ dependent relative energy shifts of the three momentum states, which give the energy cost or gain of pattern formation. The momentum mixing term $H_{\text {pair }}$ is proportional to $H_{B}$ for driving with a cosine function [see Eq. (S8)].

To include fluctuations due to photons decaying out of the cavity, we use the Linbdblad master equation:

Taking the above mentioned tracing over the coherent input photonic state, and adiabatically eliminating the sideband photonic operators, one gets the master equation describing the evolution of the atomic momentum density matrix $\rho_{a t}$ :

The derivation of $H_{a d}$ can shed some light on the physical mechanism leading to the production of correlated pairs via $H_{\text {pair }}$. In $H_{c a v}^{\prime}$, the term $h_{1}=\hbar U_{0} \sqrt{N} \alpha_{0}^{e f f}\left(b_{-}^{\dagger} a_{+}^{\dagger}+b_{+}^{\dagger} a_{-}^{\dagger}\right) b_{0}$, describes the excitation of $\pm$ atomic sidebands by scattering from the on-axis mode into the $\mp$ photonic mode, while the term $h_{2}=\hbar U_{0} \sqrt{N} \alpha_{0}^{e f f *}\left(b_{+}^{\dagger} a_{+}+b_{-}^{\dagger} a_{-}\right) b_{0}$ describes excitation of $\pm$ atomic sidebands by scattering from the $\pm$ photonic mode into the on-axis mode. Using $h_{1}$ to derive the dynamical equations for $a_{ \pm}$, one gets: $a_{ \pm}^{(1)} \propto b_{\mp}^{\dagger} b_{0}$, while using $h_{2}$ to derive the dynamical equations for $a_{ \pm}^{\dagger}$, one gets: $a_{ \pm}^{(2) \dagger} \propto b_{ \pm}^{\dagger} b_{0}$, after adiabatic elimination.

Inserting now $a_{ \pm}^{(1)}$ into $h_{2}$, and $a_{ \pm}^{(2) \dagger}$ into $h_{1}$, one gets the terms proportional to $b_{+}^{\dagger} b_{-}^{\dagger} b_{0} b_{0}$ from the interaction part of $H_{c a v}^{\prime}$. The photon associated with the process $h_{1}\left(h_{2}\right)$ creates correlated pairs of atomic momentum sidebands when scattering from the atoms via process $h_{2}\left(h_{1}\right)$. The creation of the atomic momentum pairs thus relies on photons associated with both $h_{1}$ and $h_{2}$, and not the photons associated with only $h_{1}$ or only $h_{2}$. The term $b_{0}^{\dagger} b_{0}^{\dagger} b_{+} b_{-}$in the interaction part of $H_{c a v}^{\prime}$, is derived by considering the conjugate process, governed by $h_{1}^{\dagger}$ and $h_{2}^{\dagger}$. The terms in $H_{a d}^{\prime}$ are derived by inserting $a_{ \pm}^{(1)}\left(a_{ \pm}^{(1) \dagger}\right)$ into $h_{1}^{\dagger}\left(h_{1}\right)$, and $a_{ \pm}^{(2)}\left(a_{ \pm}^{(2) \dagger}\right)$ into $h_{2}\left(h_{2}^{\dagger}\right)$.

## LIMITATIONS FOR THE NUMERICAL SIMULATIONS WITH $H_{c a v}$

When solving the Schrödinger and master equations for $H_{c a v}$ numerically, we truncate the infinite-dimensional Fock space of the photonic degrees of freedom into a finite-sized Fock space. This limits the maximal pump strength $\eta$ that can be used in our simulations, as higher pump rates will naturally lead to larger $\left\langle n_{0}\right\rangle$ and $\left\langle n_{ \pm}\right\rangle$values, such that higher dimensional photonic Fock spaces are needed to correctly capture the system dynamics. The limits of the calculations are in our case set by the size of the working memory of the computational nodes.

To demonstrate the numerical accuracy of the plots in the main text, we have compared the results for the dynamical evolution of the relevant observables for the case where the maximal photon number state in all modes is $|4\rangle_{0}|3\rangle_{+}|3\rangle_{-}$, to the case with the same total maximal photon number but where the state with the maximal photon number in all modes is $|5\rangle_{0}|3\rangle_{+}|2\rangle_{-}$, both at $N=8$ atoms, and at largest $\eta$ used in the unitary and dissipative cases.

In Fig. S5 we compare the two Fock space truncations by plotting the temporal evolution of relevant variables for the maximum $\eta$ values used in the unitary ( $\eta=40 \omega_{R}$ ) and dissipative ( $\eta=50 \omega_{R}$ ) cases of the main text. The plots confirm that the truncation of Fock space where the state with the maximal number of photons in each mode is $|4\rangle_{0}|3\rangle_{+}|3\rangle_{-}$, accurately describes the dynamics in the simulated time interval.

In the unitary case the evolution of both the atomic and photonic variables exhibit fast oscillatory motion, a signature of Vacuum Rabi oscillations occuring in the quantum electrodynamic treatment of light-matter interaction of atoms in a cavity [S35]. In the dissipative case with $\kappa=5$, these fast oscillations are averaged out. However, the slow oscillations, a signature of the sloshing dynamics where atoms slosh around the minima of the dynamical potential and periodically amplify the transverse patterns [S14], still persist.
