# Matrix periods and competition periods of Boolean Toeplitz matrices

#### Abstract

In this paper, we study the matrix period and the competition period of Toeplitz matrices over a binary Boolean ring $\mathbb{B}=\{0,1\}$. Given subsets $S$ and $T$ of $\{1, \ldots, n-$ $1\}$, an $n \times n$ Toeplitz matrix $A=T_{n}\langle S ; T\rangle$ is defined to have 1 as the ( $i, j$ )-entry if and only if $j-i \in S$ or $i-j \in T$. We show that if $\max S+\min T \leq n$ and $\min S+\max T \leq n$, then $A$ has the matrix period $d / d^{\prime}$ and the competition period 1 where $d=\operatorname{gcd}(s+t \mid s \in S, t \in T)$ and $d^{\prime}=\operatorname{gcd}(d, \min S)$. Moreover, it is shown that the limit of the matrix sequence $\left\{A^{m}\left(A^{T}\right)^{m}\right\}_{m=1}^{\infty}$ is a directed sum of matrices of all ones except zero diagonal. In many literatures we see that graph theoretic method can be used to prove strong structural properties about matrices. Likewise, we develop our work from a graph theoretic point of view.

## 1 Introduction

A binary Boolean ring $(\mathbb{B},+, \cdot)$ is a set $\mathbb{B}=\{0,1\}$ with two binary operations + and $\cdot$ on $\mathbb{B}$ defined by

In this paper, we consider Boolean matrices with entries from a binary Boolean ring, and the set of $n \times n$ Boolean matrices is denoted by $\mathbb{B}_{n}$. Take $A \in \mathbb{B}_{n}$. The matrix period
of $A$ is the smallest positive integer $p$ for which there is a positive integer $M$ such that $A^{m}=A^{m+p}$ for any integer $m \geq M$. We note that the rows $i$ and $j$ of $A^{m}$ have a common nonzero entry in some column if and only if the $(i, j)$-entry of $A^{m}\left(A^{T}\right)^{m}$ is 1 . Consider the matrix sequence $\left\{A^{m}\left(A^{T}\right)^{m}\right\}_{m=1}^{\infty}$. Since $\left|\mathbb{B}_{n}\right|=2^{n^{2}}$, there is the smallest positive integer $q$ such that

$$
A^{q+i}\left(A^{T}\right)^{q+i}=A^{q+r+i}\left(A^{T}\right)^{q+r+i}
$$

for some positive integer $r$ and every nonnegative integer $i$. Then there is also the smallest positive integer $p$ such that $A^{q}\left(A^{T}\right)^{q}=A^{q+p}\left(A^{T}\right)^{q+p}$. Those integers $q$ and $p$ are called the competition index and competition period of $A$, respectively, which was introduced by Cho and Kim [3]. Refer to [4, 5, 6, 7, 8] for further results on competition indices and competition periods of digraphs.

An $n \times n$ matrix $A \in \mathbb{B}_{n}$ is called primitive if $A^{m}$ is the all ones matrix for some integer $m \geq 1$. The minimum such $m$ is known as the exponent of $A$ denoted by $\exp (A)$. Clearly, if $A \in \mathbb{B}_{n}$ is primitive, then its matrix period and competition period are 1 . Wielandt's theorem [2] states that $\exp (A) \leq(n-1)^{2}+1$ for an $n \times n$ primitive matrix $A \in \mathbb{B}_{n}$. Moreover, there is a primitive matrix $W \in \mathbb{B}_{n}$ such that $\exp (W)=(n-1)^{2}+1$. Recently, it is shown [1] that the matrix $W$ is permutation equivalent to the ( 0,1 )-Toeplitz matrix for odd $n \geq 6$. In this paper, we extend the work done in [1] by studying the matrix period and the competition period of Toeplitz matrices in $\mathbb{B}_{n}$.

A $(0,1)$-matrix $A=\left(a_{i j}\right) \in \mathbb{B}_{n}$ is called a Boolean Toeplitz matrix if $a_{i j}=a_{j-i} \in \mathbb{B}$, i.e. $A$ is of the Toeplitz form:

a_{-1} & a_{0} & \ddots & \vdots \\
\vdots & \ddots & \ddots & a_{1} \\
a_{-n+1} & \cdots & a_{-1} & a_{0}
\end{array}\right]
$$

Accordingly, a Boolean Toeplitz matrix $A \in \mathbb{B}_{n}$ is determined by two nonempty subsets $S$ and $T$, not necessarily disjoint, of $\{1, \ldots, n-1\}$ so that $a_{i j}=1$ if and only if $j-i \in S$ or $i-j \in T$. We assume that $S=\left\{s_{1}, \ldots, s_{k_{1}}\right\}$ and $T=\left\{t_{1}, \ldots, t_{k_{2}}\right\}$ where

$$
1 \leq s_{1}<\ldots<s_{k_{1}}<n \quad \text { and } \quad 1 \leq t_{1}<\ldots<t_{k_{2}}<n
$$

Note that $S=\left\{j \mid a_{j}=1\right\}$ and $T=\left\{i \mid a_{-i}=1\right\}$. In this context, we denote a Boolean Toeplitz matrix $A$ associated with index sets $S$ and $T$ by $T_{n}\left\langle s_{1}, \ldots, s_{k_{1}} ; t_{1}, \ldots, t_{k_{2}}\right\rangle$ or simply by $T_{n}\langle S ; T\rangle$.

Consider the Boolean Toeplitz matrix

$$
A=T_{5}\langle 2 ; 4\rangle=\left[\begin{array}{ccccc}
0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 & 0 \\
1 & 0 & 0 & 0 & 0
\end{array}\right] .
$$

Then

$$
A^{3 k-1}=\left[\begin{array}{lllll}
0 & 0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 & 0 \\
1 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 \\
0 & 0 & 1 & 0 & 0
\end{array}\right], \quad A^{3 k}=\left[\begin{array}{ccccc}
1 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 \\
0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 1
\end{array}\right], \quad A^{3 k+1}=\left[\begin{array}{lllll}
0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 & 0 \\
1 & 0 & 0 & 0 & 0
\end{array}\right]
$$

for any integer $k \geq 1$. Thus $A^{m}$ is not a Toeplitz matrix for any integer $m \geq 2$. This happening cannot occur for a Toeplitz matrix $T_{n}\langle S ; T\rangle$ with the property that max $S+$ $\min T \leq n$ and $\min S+\max T \leq n$ (Theorem 2.11).

In many literatures we see that graph theoretic method can be used to prove strong structural properties about matrices. We proceed this work from a graph theoretic point of view. The support of an $n \times n$ matrix $A=\left(a_{i j}\right)$ is the $(0,1)$-matrix with $a_{i j}=1$ whenever $a_{i j} \neq 0$. If the support of $A$ is the adjacency matrix of a digraph $D$ then $D$ is called the digraph of $A$. A sequence of $m$ arcs of the form $\left(v_{0}, v_{1}\right),\left(v_{1}, v_{2}\right), \ldots,\left(v_{m-1}, v_{m}\right)$ is called a directed $\left(v_{0}, v_{m}\right)$-walk of length $m$. This walk is also denoted by

$$
v_{0} \rightarrow v_{1} \rightarrow v_{2} \rightarrow \cdots \rightarrow v_{m}
$$

Now let $D$ be a digraph with $n$ vertices. For a positive integer $m$, a graph is called the $m$ step competition graph [10] of $D$, provided that it has the same vertex set as $D$ and $\{u, v\}$ is an edge if and only if there is a vertex $w$ in $D$ such that there are directed $(u, w)$-walk of length $m$ and directed $(v, w)$-walk of length $m$. We denote the $m$-step competition graph of $D$ by $C^{m}(D)$. In particular, the 1-step competition graph of $D$ is called the competition graph of $D$ and it is denoted by $C(D)$.

Throughout this paper, we focus on Boolean Toeplitz matrices $A=T_{n}\langle S ; T\rangle$ satisfying the conditions $\max S+\min T \leq n$ and $\min S+\max T \leq n$. See Remark 3.4 to see why those are the most that we may consider. The digraph $D$ of an $n \times n$ Toeplitz matrix $T_{n}\langle S ; T\rangle$ is assumed to have the vertex set $[n]$, the $n$-set $\{1, \ldots, n\}$. By definition, it is obvious that if $i<j$ then $(i, j)$ is an arc in $D$ if and only if $j-i \in S$, and if $i>j$ then $(i, j)$ is an $\operatorname{arc}$ in $D$ if and only if $i-j \in T$. For example, see Figure 1.

As results, in Section 2 we show that they have the matrix period $d / d^{\prime}$ and the competition period is 1 where $d=\operatorname{gcd}(s+t \mid s \in S, t \in T)$ and $d^{\prime}=\operatorname{gcd}(d, \min S)$ (Theorem 2.4). It is worth noting that the competition period of a Toeplitz matrix $A$ is 1 no matter whether $A$ is primitive. It is also proved that the limit of the matrix sequence $\left\{A^{m}\left(A^{T}\right)^{m}\right\}_{m=1}^{\infty}$ is a directed sum of matrices of all ones except zero diagonal for $A$ with $\max S+\min T \leq n$ and $\min S+\max T \leq n$ (Corollary 2.5 ). Theorem 2.10 plays a key role in proving these two main results and will be separately proven in Section 4 . Section 3 is devoted to building a directed $(u, v)$-walk having a designated number of certain types of arcs, which will be used as a useful tool in Section 4. Finally, we give an upper bound for the competition index of a specific type of Boolean Toeplitz matrices (Theorem 3.5).

## 2 Main Results

Recall that $T_{n}\langle S ; T\rangle$ represents an $n \times n$ Boolean Toeplitz matrix with

$$
S=\left\{s_{1}, \ldots, s_{k_{1}}\right\} \quad \text { and } \quad T=\left\{t_{1}, \ldots, t_{k_{2}}\right\}
$$

where $s_{1}=\min S, s_{k_{1}}=\max S, t_{1}=\min T$, and $t_{k_{2}}=\max T$. From now on, we assume that $|S|=k_{1}$ and $|T|=k_{2}$ for $T_{n}\langle S ; T\rangle$ unless otherwise mentioned.

The following lemma gives a necessary condition for the existence of a directed walk from a certain vertex to a certain vertex in the digraph of a Toeplitz matrix (it is restated under our definition of the directed graph of a Toeplitz matrix, which is isomorphic to that of the digraph of a Toeplitz matrix in [1]).

Lemma 2.1 ([1]). Let $D$ be the digraph of $T_{n}\langle S ; T\rangle$ and $W$ be a $(u, v)$-directed walk of length $m$ in $D$. Then there are nonnegative integer sequences $\left(a_{i}\right)_{i=1}^{k_{1}}$ and $\left(b_{i}\right)_{i=1}^{k_{2}}$ such that

$$
\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i}=v-u \quad \text { and } \quad m=\sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}
$$

We will examine $A^{m}\left(A^{T}\right)^{m}=\left[b_{i j}\right]$ for $A=T_{n}\langle S ; T\rangle$ in a graph theoretic view. Recall that $b_{i j}=1$ if and only if the rows $i$ and $j$ of $A^{m}$ have a common nonzero entry in some column. Thus $b_{i j}=1$ if and only if for some vertex $v$ in $D$ there exist a directed $\left(u_{i}, v\right)$-walk and a directed $\left(u_{j}, v\right)$-walk of length $m$ where $u_{i}$ and $u_{j}$ are vertices of $D$ corresponding to the rows $i$ and $j$ of $A$, that is, $u_{i}$ and $u_{j}$ are adjacent in $C^{m}(D)$. Hence, by Lemma 2.1, there are some nonnegative integer sequences $\left(a_{i}\right)_{i=1}^{k_{1}},\left(b_{i}\right)_{i=1}^{k_{2}},\left(c_{i}\right)_{i=1}^{k_{1}}$, and $\left(d_{i}\right)_{i=1}^{k_{2}}$ such that

$$
\begin{equation*}
v-u_{i}=\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i}, \quad v-u_{j}=\sum_{i=1}^{k_{1}} c_{i} s_{i}-\sum_{i=1}^{k_{2}} d_{i} t_{i}, \tag{1}
\end{equation*}
$$

and

$$
\begin{equation*}
m=\sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}=\sum_{i=1}^{k_{1}} c_{i}+\sum_{i=1}^{k_{2}} d_{i} . \tag{2}
\end{equation*}
$$

Since $a_{i} s_{i}$ is written as a repeated sum $s_{i}+\cdots+s_{i}$ of $a_{i}$ summands (similarly, $b_{i} t_{i}, c_{i} s_{i}$, $d_{i} t_{i}$ ), it follows from (1) and (2) that the number of total summands of $s_{i}$ 's and $-t_{i}$ 's representing $v-u_{1}$ and $v-u_{2}$ are the same as $m$. Therefore
( $\star) u_{2}-u_{1}=\left(v-u_{1}\right)-\left(v-u_{2}\right)$ can be represented by a linear combination (with integer coeffcients) of elements in the set

$$
U_{S, T}:=\left\{s_{j}-s_{i}>0 \mid s_{i}, s_{j} \in S\right\} \cup\left\{t_{j}-t_{i}>0 \mid t_{i}, t_{j} \in T\right\} \cup\{s+t \mid s \in S, t \in T\} .
$$

Let $\operatorname{gcd}\left(U_{S, T}\right)$ and $\operatorname{gcd}(S+T)$ denote the greatest common divisors of the elements in the set $U_{S, T}$ and $\{s+t \mid s \in S, t \in T\}$, respectively. From now on, we assume that the sets $S$ and $T$ for $\operatorname{gcd}(S+T)$ are from the Toeplitz matrix $A_{n}\langle S ; T\rangle$. Then we have the following proposition.

Proposition 2.2. For $S, T \subseteq[n-1], \operatorname{gcd}\left(U_{S, T}\right)=\operatorname{gcd}(S+T)$.
Proof. For brevity, let $d=\operatorname{gcd}\left(U_{S, T}\right)$ and $d^{\prime}=\operatorname{gcd}(S+T)$. By definition, $d^{\prime} \mid d$. We show that $d \mid d^{\prime}$. Let $i_{1}, i_{2} \in\left[k_{1}\right]$ be given. Since $d \mid\left(s_{i_{1}}+t_{1}\right)$ and $d \mid\left(s_{i_{2}}+t_{1}\right)$, we have $d \mid\left(s_{i_{1}}-s_{i_{2}}\right)$. Similarly, $d \mid\left(t_{j_{1}}-t_{j_{2}}\right)$ for each $j_{1}, j_{2} \in\left[k_{2}\right]$. Thus $d \mid d^{\prime}$.

By ( $\star$ ) and Propostition 2.2, we have the following theorem.
Theorem 2.3. Let $D$ be the digraph of $T_{n}\langle S ; T\rangle$. If two vertices $u$ and $v$ are adjacent in $C^{m}(D)$ for some positive integer $m$, then $u-v$ is a multiple of $\operatorname{gcd}(S+T)$.

The converse of Theorem 2.3 is also true for sufficiently large $m$ as long as max $S+$ $\min T \leq n$ and $\min S+\max S \leq n$ by the following theorem, which is one of our main theorems.

Theorem 2.4. Let $D$ be the digraph of $T_{n}\langle S ; T\rangle$ with $\max S+\min T \leq n$, $\min S+\max S \leq$ $n, d=\operatorname{gcd}(S+T)$, and $d^{\prime}=\operatorname{gcd}\left(d, s_{1}\right)$. Then
(a) the matrix period of $D$ is $d / d^{\prime}$;
(b) the competition period of $D$ is 1 ;
(c) the limit of $\left\{C^{m}(D)\right\}_{m=1}^{\infty}$ is the disjoint union of cliques $\{v \in[n] \mid v \equiv i(\bmod d)\}$ over all $i$ such that $1 \leq i \leq d$.

Theorem 2.4 can be restated in the viewpoint of matrix as follows.

Corollary 2.5. Let $A=T_{n}\langle S ; T\rangle$ be a Boolean Toeplitz matrix with $\max S+\min T \leq n$, $\min S+\max S \leq n, d=\operatorname{gcd}(S+T)$, and $d^{\prime}=\operatorname{gcd}\left(d, s_{1}\right)$. Then
(a) the matrix period of $A$ is $d / d^{\prime}$;
(b) the competition period of $A$ is 1 ;
(c) there exists a permutation $P$ such that

$$
P\left(A^{m}\left(A^{T}\right)^{m}\right) P^{T} \rightarrow\left[\begin{array}{ccc}
J_{m_{1}} & & O \\
& \ddots & \\
O & & J_{m_{d}}
\end{array}\right] \text { as } m \rightarrow \infty
$$

where $J_{m_{i}}$ is the all-ones matrix of order $m_{i}:=|\{v \in[n] \mid v \equiv i(\bmod d)\}|$.
To prove the above theorem, we need to introduce the following sets. For a positive integer $n$, we denote the interval $[-n+1, n-1]$ by $\mathcal{I}_{n}$.

Definition 2.6. For nonempty sets $S, T \subseteq[n-1]$ and a positive integer $i$, we introduce the following sets:

- $P_{i}=\left\{\ell \in \mathcal{I}_{n} \mid \ell \equiv i s_{1}(\bmod d)\right\}$ where $d=\operatorname{gcd}(S+T)$;
- $Q_{i}=\left\{\sum_{j=1}^{k_{1}} a_{j} s_{j}-\sum_{j=1}^{k_{2}} b_{j} t_{j} \in \mathcal{I}_{n} \mid a_{j}, b_{j} \in \mathbb{Z}_{0}^{+}, \sum_{j=1}^{k_{1}} a_{j}+\sum_{j=1}^{k_{2}} b_{j}=i\right\} ;$
- $R_{i}$ be the set of $\ell \in \mathcal{I}_{n}$ such that, for any vertices $u$ and $v$ with $v-u=\ell$, there exists a directed $(u, v)$-walk of length $i$ in the digraph of $T_{n}\langle S ; T\rangle$.

It is immediately true by Lemma 2.1 that $R_{i} \subseteq Q_{i}$ for any positive integer $i$. Moreover, it is a direct consequence of the following proposition that $Q_{i} \subseteq P_{i}$ for any positive integer $i$. Thus

$$
\begin{equation*}
R_{i} \subseteq Q_{i} \subseteq P_{i} \tag{3}
\end{equation*}
$$

for any positive integer $i$.
Proposition 2.7. For nonempty sets $S, T \subseteq[n-1]$, let $d=\operatorname{gcd}(S+T)$. Then for any integers $a_{i}, b_{j}$,

$$
\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i} \equiv\left(\sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}\right) s_{1} \quad(\bmod d)
$$

Proof. By the definition of $d$,

$$
\begin{aligned}
\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i} & =\sum_{i=1}^{k_{1}} a_{i}\left(s_{i}+t_{1}-t_{1}\right)-\sum_{i=1}^{k_{2}} b_{i}\left(t_{i}+s_{1}-s_{1}\right) \\
& \equiv \sum_{i=1}^{k_{1}} a_{i}\left(-t_{1}\right)-\sum_{i=1}^{k_{2}} b_{i}\left(-s_{1}\right) \quad(\bmod d) \\
& \equiv \sum_{i=1}^{k_{1}} a_{i}\left(-t_{1}+\left(s_{1}+t_{1}\right)\right)-\sum_{i=1}^{k_{2}} b_{i}\left(-s_{1}\right) \quad(\bmod d) \\
& =\left(\sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}\right) s_{1} .
\end{aligned}
$$

Example 2.8. Let $D$ be the digraph of $T_{8}\langle 1,4 ; 2,5\rangle$. Then $\operatorname{gcd}(S+T)=3$ and $P_{3}=$ $\{-6,-3,0,3,6\}$. Since

$$
\begin{gathered}
-6=\left(0 \times s_{1}+0 \times s_{2}\right)-\left(3 \times t_{1}+0 \times t_{2}\right) ; \quad-3=\left(1 \times s_{1}+0 \times s_{2}\right)-\left(2 \times t_{1}+0 \times t_{2}\right) \\
0=\left(2 \times s_{1}+0 \times s_{2}\right)-\left(1 \times t_{1}+0 \times t_{2}\right) ; \quad 3=\left(3 \times s_{1}+0 \times s_{2}\right)-\left(0 \times t_{1}+0 \times t_{2}\right) \\
6=\left(2 \times s_{1}+1 \times s_{2}\right)-\left(0 \times t_{1}+0 \times t_{2}\right)
\end{gathered}
$$

we have $Q_{3} \supseteq\{-6,-3,0,3,6\}$. Then $P_{3}=Q_{3}$ by $(3)$.
To check whether $\ell$ is an element of $R_{3}$ or not, one may check existence of a directed $(u, v)$-walk of length 3 for every pair $(u, v)$ with $v-u=\ell$. For $\ell=-3,(4,1),(5,2),(6,3),(7,4),(8,5)$ are the pairs $(u, v)$ with $v-u=\ell$ and $\ell \in R_{3}$ since there are directed walks in $D$ such as

$$
\begin{aligned}
4 \rightarrow 5 \rightarrow 3 & \rightarrow 1 ; \quad 5 \rightarrow 6 \rightarrow 4 \rightarrow 2 ; \quad 6 \rightarrow 7 \rightarrow 5 \rightarrow 3 \\
7 & \rightarrow 8 \rightarrow 6 \rightarrow 4 ; \quad 8 \rightarrow 6 \rightarrow 4 \rightarrow 5
\end{aligned}
$$

Similarly, one can check to conclude that $R_{3} \supseteq\{-6,-3,0,3,6\}$. Therefore $P_{3}=Q_{3}=R_{3}$. Indeed, there exists a sufficiently large positive integer $M_{D}$ such that if $i \geq M_{D}$, then $P_{i}=Q_{i}=R_{i}$, by Theorem 2.10 below. One may guess that $P_{i}=Q_{i}=R_{i}$ for every positive integer $i$. Yet, not necessarily $P_{i}=Q_{i}=R_{i}$ for every positive integer $i$ as one can show that $P_{1}=\{-5,-2,1,4,7\} \supsetneq\{-5,-2,1,4\}=R_{1}$.

Theorem 2.4, which is our main result, can be proven by the following two assertions.
Lemma 2.9. For nonempty sets $S, T \subseteq[n-1]$, let $d=\operatorname{gcd}(S+T)$ and $d^{\prime}=\operatorname{gcd}\left(s_{1}, d\right)$. Then the following are true for any positive integer $i$ :
(a) $P_{i}=P_{i+d / d^{\prime}}$;
(b) $P_{i}, \ldots, P_{i-1+d / d^{\prime}}$ are mutually disjoint;
(c) $P_{i}=\left\{\ell \in \mathcal{I}_{n} \mid \ell-s_{1} \in P_{i-1}\right.$ or $\left.\ell+t_{1} \in P_{i-1}\right\}$ for any $i \geq 2$.

Proof. Fix a positive integer $i$. By the definition of $P_{i},\left(i+d / d^{\prime}\right) s_{1}=i s_{1}+\left(s_{1} / d^{\prime}\right) d \equiv i s_{1}$ $(\bmod d)$, so $P_{i}=P_{i+d / d^{\prime}}$. Therefore (a) holds. To show (b), suppose $(i+j) s_{1} \equiv(i+k) s_{1}$ $(\bmod d)$ for $\{j, k\} \subseteq\left[d / d^{\prime}\right]$. Then $d \mid(k-j) s_{1}$, so $d / d^{\prime} \mid(k-j)\left(s_{1} / d^{\prime}\right)$. Since $d / d^{\prime}$ and $s_{1} / d^{\prime}$ are relatively prime, $d / d^{\prime} \mid k-j$ and so $i+j=i+k$. Therefore $P_{1}, \ldots, P_{d / d^{\prime}}$ are mutually disjoint. Finally, we show (c). If $\ell \in P_{i-1}$, then $\ell+s_{1} \equiv(i-1) s_{1}+s_{1} \equiv i s_{1}$ $(\bmod d)$ and $\ell-t_{1} \equiv(i-1) s_{1}-t_{1} \equiv i s_{1}(\bmod d)$. Thus

$$
\left(\left\{\ell+s_{1} \in \mathcal{I}_{n} \mid \ell \in P_{i-1}\right\} \cup\left\{\ell-t_{1} \in \mathcal{I}_{n} \mid \ell \in P_{i-1}\right\}\right) \subseteq P_{i}
$$

Now take $m \in P_{i}$. Then $-n+1 \leq m \leq n-1$,

$$
m-s_{1} \equiv i s_{1}-s_{1} \equiv(i-1) s_{1} \quad(\bmod d)
$$

and

$$
m+t_{1} \equiv i s_{1}-s_{1} \equiv(i-1) s_{1} \quad(\bmod d)
$$

Therefore, if $m \in[-n+1,0]$, then

$$
m+t_{1} \geq-n+1 \quad \text { and } \quad m+t_{1} \leq t_{1} \leq n-1
$$

and so $m+t_{1} \in P_{i-1}$, i.e. $m \in\left\{\ell-t_{1} \in \mathcal{I}_{n} \mid \ell \in P_{i-1}\right\}$; if $m \in P_{i} \cap[0, n-1]$, then

$$
m-s_{1} \geq-s_{1} \geq-t_{1}+1 \geq-n+1 \quad \text { and } \quad m-s_{1} \leq n-1
$$

and so $m-s_{1} \in P_{i-1}$, i.e. $\ell \in\left\{\ell+s_{1} \in \mathcal{I}_{n} \mid \ell \in P_{i-1}\right\}$. Thus

$$
P_{i} \subseteq\left\{\ell+s_{1} \in \mathcal{I}_{n} \mid \ell \in P_{i-1}\right\} \cup\left\{\ell-t_{1} \in \mathcal{I}_{n} \mid \ell \in P_{i-1}\right\}
$$

Hence, $P_{i}=\left\{\ell \in \mathcal{I}_{n} \mid \ell-s_{1} \in P_{i-1}\right.$ or $\left.\ell+t_{1} \in P_{i-1}\right\}$.
The following theorem plays a key role in proving Theorem 2.4. The next two sections will be devoted to proving it.

Theorem 2.10. Let $D$ be the digraph of $T_{n}\langle S ; T\rangle$ with $\max S+\min T \leq n$, $\min S+$ $\max S \leq n$, and $d=\operatorname{gcd}(S+T)$. Then there is a positive integer $M$ such that $P_{i}=Q_{i}=R_{i}$ for any integer $i \geq M$.

Theorem 2.10 also enables us to prove Theorem 2.11 mentioned earlier.
Proof of Theorem 2.4. Take two vertices $u, v$ in $D$. Then $u-v \in \mathcal{I}_{n}$. Since $s_{k_{1}} \leq n-t_{1}$ and $t_{k_{2}} \leq n-s_{1}$, it follows from Theorem 2.10 that there is a positive integer $M$ such that, for any integer $i \geq M$,

$$
\begin{equation*}
P_{i}=R_{i} \tag{4}
\end{equation*}
$$

Then $v-u \equiv i s_{1}(\bmod d)$ if and only if there is a directed $(u, v)$-walk of length $i$ for any vertices $u$ and $v$ in $D$.

Take an integer $\ell \geq M$. To show (a), we note that $P_{\ell}=P_{\ell+d / d^{\prime}}$ by Lemma 2.9(a). Then, by (4), $R_{\ell}=R_{\ell+d / d^{\prime}}$. Thus $D^{\ell}=D^{\ell+d / d^{\prime}}$.

Take a positive integer $p<d / d^{\prime}$. Then $P_{\ell}$ and $P_{\ell+p}$ are disjoint by Lemma 2.9(b). Thus there is an integer $x \in \mathcal{I}_{n}$ such that $a \in P_{\ell} \backslash P_{\ell+p}$, that is, $a \equiv \ell s_{1}(\bmod d)$ and $a \not \equiv(\ell+p) s_{1}(\bmod d)$. Since $a \in \mathcal{I}_{n}$, there are some vertices $u, v$ in $D$ such that $v-u=a$. Since $P_{\ell}=R_{\ell}$ and $P_{\ell+p}=R_{\ell+p}$, there is a directed $(u, v)$-walk of length $\ell$ while there is no directed $(u, v)$-walk of length $\ell+p$. Thus $D^{\ell} \neq D^{\ell+p}$. Hence the matrix period of $D$ is $d / d^{\prime}$.

To show (b) and (c), we take two vertices $u$ and $v$ in $D$. We may assume $u<v$. Suppose $u \equiv v(\bmod d)$. By the division algorithm, $\ell s_{1}=d q+r$ for some integers $q$ and $r$ with $0 \leq r \leq d-1$. Let $w=v-r$. Then $v-w=\ell s_{1}-d q$ and $u<u+d \leq v-r \leq v$. Since $u \equiv v(\bmod d), v-w \equiv u-w \equiv \ell s_{1}(\bmod d)$. Thus, by (4), there exist a directed $(v, w)$-walk of length $\ell$ and a directed $(u, w)$-walk of length $\ell$ in $D$. Therefore $u$ and $v$ are adjacent in $C^{\ell}(D)$. Thus

$$
\{v \in V(D) \mid v \equiv i \quad(\bmod d)\}
$$

is a clique in $C^{\ell}(D)$ for $i=1, \ldots, d$. If $u \not \equiv v(\bmod d)$, then $u$ and $v$ are not adjacent in $C^{\ell}(D)$ by Proposition 2.3. Hence $C^{\ell}(D)$ is a disjoint union of $d$ cliques $\{v \in V(D) \mid v \equiv 1$ $(\bmod d)\}, \ldots,\{v \in V(D) \mid v \equiv d(\bmod d)\}$. Consequently, we have shown that the competition period of $D$ is 1 and the limit of $\left\{C^{m}(D)\right\}_{m=1}^{\infty}$ is the disjoint union of cliques $\{v \in V(D) \mid v \equiv 1(\bmod d)\}, \ldots,\{v \in V(D) \mid v \equiv d(\bmod d)\}$.

Given a digraph $D$ and a positive integer $m$, we denote by $D^{m}$ the digraph with vertex set same as $D$ and an arc $(u, v)$ if and only if there is a directed $(u, v)$-walk of length $m$.

Theorem 2.11. Let $A=T_{n}\langle S ; T\rangle$ be a Boolean Toeplitz matrix with

$$
\max S+\min T \leq n \quad \text { and } \quad \min S+\max T \leq n
$$

Then there exists some positive integer $M$ such that, for every positive integer $m>M$, $A^{m}$ is a Toeplitz matrix.

Proof. By Theorem 2.10, there is a positive integer $M$ such that $P_{i}=R_{i}$ for any integer $m \geq M$. Suppose that ( $u, v$ ) -entry of $A^{m}$ is 1 for some integer $m \geq M$. Then there exists directed $(u, v)$-walk of length $m$ in the digraph $D$ of $A$. Therefore $v-u \equiv m s_{1}(\bmod d)$ by Lemma 2.1 and Proposition 2.7. Thus $v-u \in P_{m}$. Since $P_{m}=R_{m}, v-u \in R_{m}$. Then, there is a directed $\left(u^{\prime}, v^{\prime}\right)$-walk of length $m$ in $D$ for any $v^{\prime}-u^{\prime}=v-u$. Therefore the diagonal containing $(u, v)$ consists of ones. Since $(u, v)$ was arbitrarily chosen, $A^{m}$ is Toeplitz.

## 3 Building specific directed walks in the digraph of $T_{n}\langle S ; T\rangle$

For notational convenience, we call an arc $u \rightarrow v$ of $D$ an $s_{i}$-arc (resp. $t_{j}$-arc) if $v-u=s_{i}$ (resp. $u-v=t_{j}$ ) for $i \in\left[k_{1}\right]$ (resp. $j \in\left[k_{2}\right]$ ).

This section is devoted to building a directed $(u, v)$-walk having a designated number of $s_{i}$-arcs for each $i=2,3, \ldots, k_{1}$ and a designated number of $t_{j}$-arcs for each $j=2,3, \ldots, k_{2}$. In addition, we give an upper bound for the competition index of a Toeplitz matrix $T_{n}\langle S ; T\rangle$ with $s_{k_{1}} \leq n-t_{1}, t_{k_{2}} \leq n-s_{1}$.

To initiate Theorem 3.3, we take the digraph $D$ of $T_{8}\langle 1,4 ; 2,5\rangle$ given in Figure 1 and consider the vertex 7 . We wish to construct a directed walk from 7 containing exactly five $\operatorname{arcs}(u, v)$ with $v-u=4$ and exactly six arcs $(u, v)$ with $u-v=5$ (it may contain arcs ( $u, v$ ) with $v-u=1$ or $u-v=2$ as many as is desired). We begin with a directed walk $W_{0}=7$. Using $\operatorname{arcs}(u, v)$ with $u-v=2$, we reach the vertex 1 , which is the smallest vertex that can be reached from 7 by using arcs $(u, v)$ with $u-v=2$. It can be done by the directed path $W_{1}=7 \rightarrow 5 \rightarrow 3 \rightarrow 1$. Now we add an $(u, v)$ arc with $v-u=4$ to have $W_{2}:=W_{1} \rightarrow 5$. To realize another $(u, v)$ arc with $v-u=4$, we take $W_{3}:=W_{2} \rightarrow 3 \rightarrow 1$ by using $\operatorname{arcs}(u, v)$ with $u-v=2$ and add the arc $(1,5)$ at the end. We repeat this process until we achieve five $\operatorname{arcs}(u, v)$ with $v-u=4$. We observe that this procedure works because $s_{2}+t_{1}=4+2 \leq 8=n$. By repeatedly reaching the vertex 8 , which is the largest vertex that can be reached from $\operatorname{arcs}(u, v)$ with $v-u=1$, by going through a similar process as above, we may eventually obtain a desired directed walk. This idea is generalized to Theorem 3.3.

Lemma 3.1 ([9]). Let $D$ be the digraph of $T_{n}\langle S ; T\rangle$ and take vertices $u$ and $b$ in $D$ with $u<v$. Then $u$ and $v$ are adjacent in $C(D)$ if and only if one of the following is true:

$$
v-u= \begin{cases}s_{i}-s_{j} & \text { for some } s_{i} \in S \cap[n-u] \text { and } s_{j} \in S \cap[n-v] ;  \tag{5}\\ t_{i}-t_{j} & \text { for some } t_{i} \in T_{k_{2}} \cap[v-1] \text { and } t_{j} \in T_{k_{2}} \cap[u-1] ; \\ s_{i}+t_{j} & \text { for some } s_{i} \in S \text { and } t_{j} \in T_{k_{2}} .\end{cases}
$$

Lemma 3.2 ([1]). Let $S$ and $T$ be nonempty subsets of $[n-1]$ with $n \geq \max S+\max T$. For an integer $m \in[n]$ and any nonzero sequences $\left(a_{i, m}\right)_{i=1}^{k_{1}}$ and $\left(b_{i, m}\right)_{i=1}^{k_{2}}$ of nonnegative integers satisfying

$$
\begin{equation*}
1 \leq m+\sum_{i=1}^{k_{1}} a_{i, m} s_{i}-\sum_{j=1}^{k_{2}} b_{j, m} t_{j} \leq n \tag{8}
\end{equation*}
$$

there is an integer sequence of length $\sum_{i=1}^{k_{1}} a_{i, m}+\sum_{j=1}^{k_{2}} b_{j, m}$ satisfying the following:

- each term equals $s_{i}$ or $t_{j}$ for some $i \in\left[k_{1}\right]$ and $j \in\left[k_{2}\right]$ and $s_{i}$ and $t_{j}$ appear $a_{i, m}$ times and $b_{j, m}$ times, respectively, for each $i \in\left[k_{1}\right]$ and $j \in\left[k_{2}\right]$;
- its $k$ th partial sum is between $1-m$ and $n-m$ for any $1 \leq k \leq \sum_{i=1}^{k_{1}} a_{i, m}+\sum_{j=1}^{k_{2}} b_{j, m}$.

The original statement of Lemma 3.2 includes the condition that $S$ and $T$ are disjoint. However, the condition was not used in the proof of Lemma 3.2 and is deleted in the current statement.

Theorem 3.3. Let $D$ be the digraph of $T_{n}\langle S ; T\rangle$ with $\max S+\min T \leq n$ and $\min S+$ $\max S \leq n$. Suppose that a vertex $v$ of $D$ and nonnegative integers $a_{2}, \ldots, a_{k_{1}}, b_{2}, \ldots, b_{k_{2}}$ are given. Then the following are true:
(a) There is a directed walk $W$ of length $\ell$ starting from $v$ and containing exactly $a_{i}$ $s_{i}$-arcs and $b_{j} t_{j}$-arcs for each $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$ where

$$
\ell \leq\left(a_{2}+\ldots+a_{k_{1}}+b_{2}+\ldots+b_{k_{2}}\right)\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right)
$$

(b) Given $W$ in part (a), if $a \geq a_{1}$ and $b \geq b_{1}$ satisfy the inequalities

$$
1 \leq v+a s_{1}+\sum_{i=2}^{k_{1}} a_{i} s_{i}-b t_{1}-\sum_{j=2}^{k_{2}} b_{j} t_{j} \leq n
$$

where $a_{1}$ and $b_{1}$ are the numbers of $s_{1}$-arcs and $t_{1}$-arcs, respectively, in $W$. Then there is a directed walk starting from $v$ in $D$ containing exactly a $s_{1}$-arcs, $b t_{1}$-arcs, $a_{i} s_{i}$-arcs and $b_{j} t_{j}$-arcs for all $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$.

Proof. We prove (a) by induction on $m:=a_{2}+\cdots+a_{k_{1}}+b_{2}+\cdots+b_{k_{2}}$ for some nonnegative integers $a_{2}, \ldots, a_{k_{1}}, b_{2}, \ldots, b_{k_{2}}$. If $m=0$, then the walk $v$ contains neither $s_{i}$-arcs nor $t_{j^{-}}$ $\operatorname{arcs}$ for each $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$. Suppose $m \geq 1$ and assume that the statement is true for $m-1$.

Now take nonnegative integers $a_{2}, \ldots, a_{k_{1}}, b_{2}, \ldots, b_{k_{2}}$ with $a_{2}+\cdots+a_{k_{1}}+b_{2}+\cdots+b_{k_{2}}=$ $m$. Since $m \geq 1$, there is a positive integer $p$ or $q$ such that $a_{p} \geq 1$ or $b_{q} \geq 1$. By symmetry, we may assume that $a_{p} \geq 1$. Since $a_{2}+\cdots+a_{p-1}+\left(a_{p}-1\right)+a_{p+1}+\cdots+a_{k_{1}}+b_{2}+\cdots+b_{k_{2}}=$ $m-1$, by the induction hypothesis, there is a directed walk $W$ of length $\ell$ starting from $v$ such that

$$
\ell \leq(m-1)\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right)
$$

and $W$ contains exactly $a_{p}-1 s_{p}$-arcs, $a_{i} s_{i}$-arcs, and $b_{j} t_{j}$-arcs for $2 \leq i \leq k_{1}, i \neq p$, $2 \leq j \leq k_{2}$.

Let $w$ be the terminus of $W$. Then there exists a nonnegative integer $r$ such that $1 \leq w-r t_{1} \leq t_{1}$. Since $s_{p} \leq s_{k_{1}} \leq n-t_{1}$, we have $1 \leq w-r t_{1} \leq n-s_{p}$. Now, let $r_{0}$ be the smallest one satisfying $1 \leq w-r_{0} t_{1} \leq n-s_{p}$. Then

$$
r_{0}=\max \left\{0,\left\lceil\frac{w-n+s_{p}}{t_{1}}\right\rceil\right\} \leq\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil .
$$

Moreover, $W_{1}:=w \rightarrow\left(w-t_{1}\right) \rightarrow \cdots \rightarrow\left(w-r_{0} t_{1}\right)$ is a directed walk from $w$ to $w-r_{0} t_{1}$ in $D$ consisting of only $r_{0} t_{1}$-arcs. Since $w-r_{0} t_{1} \leq n-s_{p}, w-r_{0} t_{1}+s_{p} \leq n$ and so $w-r_{0} t_{1}+s_{p}$ is a vertex in $D$. Then $\left(w-r_{0} t_{1}\right) \rightarrow\left(w-r_{0} t_{1}+s_{p}\right)$ in $D$, so the directed

walk $W \rightarrow W_{1} \rightarrow\left(w-r_{0} t_{1}+s_{p}\right)$ is a desired one starting from $v$ containing exactly $a_{i}$ $s_{i}$-arcs and $b_{j} t_{j}$-arcs for $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$ and of length

$$
\begin{aligned}
\ell+r_{0}+1 & \leq(m-1)\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right)+\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil+1 \\
& \leq m\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right) .
\end{aligned}
$$

To show (b), suppose $a \geq a_{1}, b \geq b_{1}$, and

$$
1 \leq v+a s_{1}+\sum_{i=2}^{k_{1}} a_{i} s_{i}-b t_{1}-\sum_{j=2}^{k_{2}} b_{j} t_{j} \leq n .
$$

We note that the terminus of $W$ is

$$
v+\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{j=1}^{k_{2}} b_{j} t_{j} .
$$

Then a desired directed walk can be obtained by attaching to $W$ a directed walk $W^{\prime}$ containing $a-a_{1} s_{1}$-arcs and $b-b_{1} t_{1}$-arcs. By applying Lemma 3.2 to $T_{n}\left\langle s_{1} ; t_{1}\right\rangle$ and $v+\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{j=1}^{k_{2}} b_{j} t_{j}$, we may obtain $W^{\prime}$.
Remark 3.4. If $s_{k_{1}}>n-t_{1}$ or $t_{k_{2}}>n-s_{1}$, there is no guarantee that there is a directed walk fulfilling the condition given in Theorem 3.3(a). For example, the digraph of $T_{6}\langle 2,4 ; 4,5\rangle$ has two strong components with vertex sets $\{1,3,5\}$ and $\{2,4,6\}$ without arcs going from $\{1,3,5\}$ to $\{2,4,6\}$ and $(u, v)=(6,1)$ is the only arc with $u-v=5$ in $D$ (see Figure 2). Therefore there is no directed walk containing arc ( $u, v$ ) with $u-v=5$ starting from 1 .

We present an upper bound for the competition index of a Toeplitz matrix $T_{n}\langle S ; T\rangle$ with $s_{k_{1}} \leq n-t_{1}, t_{k_{2}} \leq n-s_{1}$.

Theorem 3.5. Let $A=T_{n}\langle S ; T\rangle$ with $\max S+\min T \leq n, \min S+\max S \leq n$, $d=$ $\operatorname{gcd}(S+T)$, and $d^{\prime}=\operatorname{gcd}\left(d, s_{1}\right)$. If the principal submatrix of $A A^{T}$ determined by the rows and columns indexed by $\{v \in[n] \mid v \equiv i(\bmod d)\}$ is irreducible for each $1 \leq i \leq d$, then the competition index of $A$ is at most

$$
2(\lceil n / d\rceil-1)\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right)+2\left(s_{1}+t_{1}\right)
$$

Proof. Let $D$ be the digraph of $A$ and take two distinct vertices $u$ and $v$ in $D$. If $u \not \equiv v$ $(\bmod d)$, then $u$ and $v$ are not adjacent in $C^{m}(D)$ for any positive integer $m$ by Proposition 2.3 .

We denote by $G_{i}$ the subgraph of $C(D)$ induced by the vertex set $\{v \in[n] \mid v \equiv i$ $(\bmod d)\}$ for $1 \leq i \leq d$. Then $G_{i}$ is a component of $C(D)$ for any $1 \leq i \leq d$ by the hypothesis.

Now suppose $u \equiv v(\bmod d)$. Then $u$ and $v$ belong to $G_{j}$ for some $j \in[d]$ and so there is a path from $u$ to $v$ in $C(D)$. Take one of such paths and let $v_{0} v_{1} \cdots v_{\ell}$ be its sequence with $v_{0}=u$ and $v_{\ell}=v$. Then there is a common out-neighbor $w_{i}$ of $v_{i}$ and $v_{i+1}$ for $0 \leq i \leq \ell-1$. We note that $w_{i}-v_{i}=s_{j}$ or $-t_{k}$ for some $j \in\left[k_{1}\right], k \in\left[k_{2}\right]$. For each $1 \leq i \leq k_{1}$, let $a_{i}$ (resp. $a_{i}^{\prime}$ ) be the number of $s_{i}$-arcs among $\left(v_{0}, w_{0}\right), \ldots,\left(v_{\ell-1}, w_{\ell-1}\right)$ (resp. $\left.\left(v_{1}, w_{0}\right), \ldots,\left(v_{\ell}, w_{\ell-1}\right)\right)$, that is,

$$
a_{i}=\left|\left\{j \mid w_{j}-v_{j}=s_{i}, 0 \leq j \leq \ell-1\right\}\right| \quad \text { and } \quad a_{i}^{\prime}=\left|\left\{j \mid w_{j}-v_{j+1}=s_{i}, 0 \leq j \leq \ell-1\right\}\right|

Then

v_{\ell}-v_{0}=\sum_{i=0}^{\ell-1}\left(w_{i}-v_{i}\right)-\sum_{i=0}^{\ell-1}\left(w_{i}-v_{i+1}\right)=\left(\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i}\right)-\left(\sum_{i=1}^{k_{1}} a_{i}^{\prime} s_{i}-\sum_{i=1}^{k_{2}} b_{i}^{\prime} t_{i}\right)
$$

Thus

On the other hand, by Theorem 3.3(a), there is a directed walk $W_{u}$ starting from $u$ such that $W_{u}$ contains exactly $a_{i} s_{i}$-arcs and $b_{j} t_{j}$-arcs for each $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$ with length at most

Let $a$ and $b$ be the numbers of $s_{1}$-arcs and $t_{1}$-arcs, respectively, on $W_{u}$. Then there is a nonnegative integer $c$ such that $a+c t_{1} \geq a_{1}$ and $b+c s_{1} \geq b_{1}$. Take $c$ be the smallest nonnegative integer among such integers. Then $c=0$ or $a+c t_{1}<a_{1}+t_{1}$ or $b+c s_{1}<b_{1}+s_{1}$. Let $a_{1}^{*}=a+c t_{1}$ and $b_{1}^{*}=b+c s_{1}$. Then

\end{aligned}

Then, by Theorem 3.3(b), there is a directed walk $W_{u}^{*}$ starting from $u$ such that $W_{u}^{*}$ contains exactly $a_{1}^{*} s_{1}$-arcs, $b_{1}^{*} t_{1}$-arcs, $a_{i} s_{i}$-arcs and $b_{j} t_{j}$-arcs for each $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$ with length

& \leq\left(a_{1}+\cdots+a_{k_{1}}+b_{2}+\cdots+b_{k_{2}}\right)\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}\right)+s_{1} .

If $b+c s_{1}<b_{1}+s_{1}$, then $\ell_{u}<\ell\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}\right)+s_{1}+t_{1}$ by a similar argument.
Hence, we have $\ell_{u}<\ell\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right)+s_{1}+t_{1}$ for each cases.

Then $W_{u}^{*}$ has exactly $a_{i} s_{i}$-arcs and $b_{j} t_{j}$-arcs for $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$. Moreover, $W_{u}^{*}$ has $a_{1}^{*} s_{1}$-arcs and $b_{1}^{*} t_{1}$-arcs.

By Theorem 3.3(b) again, one can make a directed walk $W_{v}^{*}$ starting from $v$ such that $W_{v}^{*}$ contains $a_{1}^{* *} \geq a_{1}^{\prime} s_{1}$-arcs and $b_{1}^{* *} \geq b_{1}^{\prime} t_{1}$-arcs and has length

& \leq \ell\left(\max \left\{\left\lceil\frac{t_{k_{2}}}{s_{1}}\right\rceil,\left\lceil\frac{s_{k_{1}}}{t_{1}}\right\rceil\right\}+1\right)+s_{1}+t_{1} . \tag{15}
\end{align*}
$$

Let $z_{u}$ and $z_{v}$ be the termini of $W_{u}^{*}$ and $W_{v}^{*}$, respectively. Then

Then, by Lemma 3.2, there exist a directed walk $W_{u}^{\prime}$ from $z_{u}$ to $z$ of length $a_{1}^{* *}-a_{1}^{\prime}+b_{1}^{* *}-b_{1}^{\prime}$ and a directed walk $W_{v}^{\prime}$ from $z_{v}$ to $z$ of length $a_{1}^{*}-a_{1}+b_{1}^{*}-b_{1}$ in $T_{n}\left\langle s_{1} ; t_{1}\right\rangle$. Since $T_{n}\left\langle s_{1} ; t_{1}\right\rangle$ is a subdigraph of $D, W_{u}^{\prime}$ and $W_{v}^{\prime}$ are also directed walks in $D$. Thus $W_{u}^{*} \rightarrow W_{u}^{\prime}$ is a $(u, z)$ directed walk of length $\ell_{u}+\left(a_{1}^{* *}-a_{1}^{\prime}\right)+\left(b_{1}^{* *}-b_{1}^{\prime}\right)$ and $W_{v}^{*} \rightarrow W_{v}^{\prime}$ is a $(v, z)$-directed walk of length $\ell_{v}+\left(a_{1}^{*}-a_{1}\right)+\left(b_{1}^{*}-b_{1}\right)$ in $D$. By (11) and (14),

Since there is at most $\lceil n / d\rceil$ vertices in $G_{i}$ for each $1 \leq i \leq d$, we have $\ell \leq\lceil n / d\rceil-1$. Thus $W_{u}^{*} \rightarrow W_{u}^{\prime}$ and $W_{v}^{*} \rightarrow W_{v}^{\prime}$ has the same length at most

## 4 A Proof of Theorem 2.10

## $4.1 \quad\left(\exists m^{*} \in \mathbb{N}\right)\left[P_{m^{*}} \subseteq Q_{m^{*}}\right]$

We will show that there is a positive integer $m^{\star}$ such that $P_{m^{\star}} \subseteq Q_{m^{\star}}$. Prior to that, we take number theoretic approach to deduce the following two results.

Bézout's identity asserts that if $\operatorname{gcd}(a, b)=d$ then there exist integers $x$ and $y$ such that $a x+b y=d$. Thus, if $d=\operatorname{gcd}(S+T)$ then by Proposition 2.2 together with Bézout's identity there exit some integers $\alpha_{i, j}, \beta_{i, j}, \gamma_{i, j}$ such that

d=\sum_{1 \leq i<j \leq k_{1}} \alpha_{i, j}\left(s_{j}-s_{i}\right)+\sum_{1 \leq i<j \leq k_{2}} \beta_{i, j}\left(t_{j}-t_{i}\right)+\sum_{1 \leq i \leq k_{1}, 1 \leq j \leq k_{2}} \gamma_{i, j}\left(s_{i}+t_{j}\right) \tag{16}
\end{equation*}
$$

Lemma 4.1. Let $d=\operatorname{gcd}(S+T)$. Then there exist integers $a_{i}, b_{i}$ such that

d=\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i} \quad \text { and } \quad \sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}=0

Proof. By noting that $s_{j}-s_{i}=\left(s_{j}-s_{j-1}\right)+\left(s_{j-1}-s_{j-2}\right)+\cdots+\left(s_{i+1}-s_{i}\right)$ and $t_{j}-t_{i}=$ $\left(t_{j}-t_{j-1}\right)+\cdots+\left(t_{i+1}-t_{i}\right)$, the right-hand side of (16) gives

& +\sum_{1 \leq i \leq k_{1}, 1 \leq j \leq k_{2}} \gamma_{i, j}\left(\sum_{k=2}^{i}\left(s_{k}-s_{k-1}\right)+\sum_{k=2}^{j}\left(t_{k}-t_{k-1}\right)+\left(s_{1}+t_{1}\right) .\right) \\
= & \sum_{i=2}^{k_{1}} \alpha_{i}\left(s_{i}-s_{i-1}\right)+\sum_{i=2}^{k_{2}} \beta_{i}\left(t_{i}-t_{i-1}\right)+\gamma\left(s_{1}+t_{1}\right)
\end{aligned}
$$

where

$$
\begin{aligned}
\alpha_{i} & =\sum_{1 \leq j<i \leq k \leq k_{1}} \alpha_{j, k}+\sum_{2 \leq i \leq j \leq k_{1}, 1 \leq k \leq k_{2}} \gamma_{j, k}, \\
\beta_{i} & =\sum_{1 \leq j<i \leq k \leq k_{2}} \beta_{j, k}+\sum_{1 \leq j \leq k_{1}, 2 \leq i \leq k \leq k_{2}} \gamma_{j, k}
\end{aligned}
$$

and

$$
\gamma=\sum_{1 \leq i \leq k_{1}, 1 \leq j \leq k_{2}} \gamma_{i, j}
$$

Therefore

$$
\begin{aligned}
d= & \sum_{i=2}^{k_{1}} \alpha_{i}\left(s_{i}-s_{i-1}\right)+\sum_{i=2}^{k_{2}} \beta_{i}\left(t_{i}-t_{i-1}\right)+\gamma\left(s_{1}+t_{1}\right) \\
= & \left(\gamma-\alpha_{2}\right) s_{1}+\sum_{i=2}^{k_{1}-1}\left(\alpha_{i}-\alpha_{i+1}\right) s_{i}+\alpha_{k_{1}} s_{k_{1}} \\
& -\left(\beta_{2}-\gamma\right) t_{1}-\sum_{i=2}^{k_{2}-1}\left(\beta_{i+1}-\beta_{i}\right) t_{i}-\left(-\beta_{k_{2}}\right) t_{k_{2}}
\end{aligned}
$$

Thus there are some integers $a_{i}, b_{i}$ such that

d=\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i} \quad \text { and } \quad \sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}=0
$$

Theorem 4.2. Let $d=\operatorname{gcd}(S+T)$. For a given positive integer $k$, there is an integer $r$ such that for any $j \in[k]$,

r+j d=\sum_{i=1}^{k_{1}} a_{i, j} s_{i}-\sum_{i=1}^{k_{2}} b_{i, j} t_{i}
$$

for some nonnegative integers $a_{i, j}, b_{i, j}$ with the constant $f(j):=\sum_{i=1}^{k_{1}} a_{i, j}+\sum_{i=1}^{k_{2}} b_{i, j}$.
Proof. By Lemma 4.1, there are some integers $a_{i}, b_{i}$ such that

d=\sum_{i=1}^{k_{1}} a_{i} s_{i}-\sum_{i=1}^{k_{2}} b_{i} t_{i} \quad \text { and } \quad \sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}=0

Thus

j d=\sum_{i=1}^{k_{1}}\left(j a_{i}\right) s_{i}-\sum_{i=1}^{k_{2}}\left(j b_{i}\right) t_{i}

for each $j \in[k]$. By adding $r:=\sum_{i=1}^{k_{1}}\left(k\left|a_{i}\right|\right) s_{i}-\sum_{i=1}^{k_{2}}\left(k\left|b_{i}\right|\right) t_{i}$ to both sides of the above equality, we have

where $a_{i, j}=j a_{i}+k\left|a_{i}\right|$ and $b_{i, j}=j b_{i}+k\left|b_{i}\right|$, which are nonnegative for each $j \in[k]$. Moreover,

\sum_{i=1}^{k_{1}} a_{i, j}+\sum_{i=1}^{k_{2}} b_{i, j} & =j\left(\sum_{i=1}^{k_{1}} a_{i}+\sum_{i=1}^{k_{2}} b_{i}\right)+b\left(\sum_{i=1}^{k_{1}}\left|a_{i}\right|+\sum_{i=1}^{k_{2}}\left|b_{i}\right|\right) \\
& =k\left(\sum_{i=1}^{k_{1}}\left|a_{i}\right|+\sum_{i=1}^{k_{2}}\left|b_{i}\right|\right)
\end{aligned}
$$

for each $j \in[k]$ and so $f(j)$ is constant.
Theorem 4.3. There exists a positive integer $m^{\star}$ such that $P_{m^{\star}} \subseteq Q_{m^{\star}}$.
Proof. For given sets of positive integers $S$ and $T$, let $d=\operatorname{gcd}(S+T)$. By Lemma 4.1, there are some integers $a_{i}, b_{i}$ such that

Take a sufficiently large positive integer $k$ such that

By Theorem 4.2, there are an integer $r$ and nonnegative integers $a_{i, j}, b_{i, j}$ such that for each $j \in[k]$,

with $\sum_{i=1}^{k_{1}} a_{i, j}+\sum_{i=1}^{k_{2}} b_{i, j}$ constant.
Case 1. $r+d<-(n-1)$. Then there is the smallest positive integer $c$ such that

for each $2 \leq i \leq k_{1}$ and $1 \leq j \leq k$. Then, by (18),

which is constant, and

r^{\prime}+j d=\sum_{i=1}^{k_{1}} a_{i, j}^{\prime} s_{i}-\sum_{i=1}^{k_{2}} b_{i, j} t_{i} \tag{21}
\end{equation*}
$$

for each $j \in[k]$. By Proposition 2.7,

r^{\prime} \equiv m s_{1} \quad(\bmod d)
$$

Moreover,

r^{\prime}+d<-(n-1)
$$

by the choice of $c$. On the other hand, by (17) and (19),

Take $p \in P_{m}$. Then $p \equiv m s_{1} \equiv r^{\prime}(\bmod d)$ and

Therefore $p \in\left\{r^{\prime}+d, \ldots, r^{\prime}+k d\right\}$. Thus $p \in Q_{m}$ by (20) and (21).
Case 2. $r+d \geq-(n-1)$. Then there is the smallest positive integer $c^{\prime}$ such that

r^{\prime \prime}=r-\left(c^{\prime}-1\right) t_{1}, \quad b_{1, j}^{\prime}=b_{1, j}+c^{\prime}-1, \quad \text { and } \quad b_{i, j}^{\prime}=b_{i, j}
$$

for each $2 \leq i \leq k_{2}$ and $1 \leq j \leq k$. Then, by (18),

$$
\begin{equation*}
m:=r^{\prime \prime}+j d=\sum_{i=1}^{k_{1}} a_{i, j} s_{i}-\sum_{i=1}^{k_{2}} b_{i, j}^{\prime} t_{i} \tag{23}
\end{equation*}
$$

with $\sum_{i=1}^{k_{1}} a_{i, j}+\sum_{i=1}^{k_{2}} b_{i, j}^{\prime}$ constant for each $j \in[k]$. Then $r^{\prime \prime} \equiv m s_{1}(\bmod d)$ by Proposition 2.7. Moreover, $r^{\prime \prime}+d<-(n-1)$ by the choice of $c^{\prime}$ and, by (17) and (22),

$$
r^{\prime \prime}+k d=\left(r^{\prime \prime}+d+t_{1}\right)+\left((k-1) d-t_{1}\right) \geq\left(r+d-c^{\prime} t_{1}\right)+2(n-1) \geq n-1
$$

Take $p \in P_{m}$. Then $p \equiv m s_{1} \equiv r^{\prime \prime}(\bmod d)$ and $r^{\prime \prime}+d \leq p \leq r^{\prime \prime}+b d$, i.e. $p \in$ $\left\{r^{\prime \prime}+d, \ldots, r^{\prime \prime}+b d\right\}$. Thus $p \in Q_{m}$ by (23). Hence, in both cases, we have shown that there is a positive integer $m^{*}$ such that $P_{m^{*}} \subseteq Q_{m^{*}}$.

### 4.2 Taking a candidate for $M$ satisfying Theorem 2.10

We have shown there exists a positive integer $m^{*}$ such that $P_{m^{*}} \subseteq Q_{m^{*}}$. Now fix $p \in P_{m^{*}}$. Then $p \in Q_{m^{*}}$ and there are nonnegative integers $a_{i, p}, b_{i, p}$ such that

$$
\begin{equation*}
\sum_{i=1}^{k_{1}} a_{i, p}+\sum_{i=1}^{k_{2}} b_{i, p}=m^{*} \quad \text { and } \quad p=\sum_{i=1}^{k_{1}} a_{i, p} s_{i}-\sum_{i=1}^{k_{2}} b_{i, p} t_{i} . \tag{24}
\end{equation*}
$$

By Theorem 3.3(a) and (24),
$(\star)$ for each vertex $v \in V(D)$, there exists a directed walk $W_{v, p}$ starting from $v$ such that $W_{v, p}$ contains exactly $a_{i, p} s_{i}$-arcs and $b_{j, p} t_{j}$-arcs for each $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$ where $\sum_{i=1}^{k_{1}} a_{i, p}+\sum_{i=1}^{k_{2}} b_{i, p}=m^{*}$ and $p=\sum_{i=1}^{k_{1}} a_{i, p} s_{i}-\sum_{i=1}^{k_{2}} b_{i, p} t_{i}$.

Let $a_{v, p}$ (resp. $b_{v, p}$ ) be the number of $s_{1}$-arcs (resp. $t_{1}$-arcs) in $W_{v, p}$. Then there exists some positive integer $c$ such that

$$
a_{1, p}+c t_{1} \geq \max _{v \in V(D)} a_{v, p} \quad \text { and } \quad b_{1, p}+c s_{1} \geq \max _{v \in V(D)} b_{v, p}
$$

Now, by (24),

$$
\begin{equation*}
p=\sum_{i=2}^{k_{1}} a_{i, p} s_{i}-\sum_{i=2}^{k_{2}} b_{i, p} t_{i}+\left(a_{1, p}+c t_{1}\right) s_{1}-\left(b_{1, p}+c s_{1}\right) t_{1} . \tag{25}
\end{equation*}
$$

We note that

$$
\sum_{i=2}^{k_{1}} a_{i, p}+\sum_{i=2}^{k_{2}} b_{i, p}+\left(a_{1, p}+c t_{1}\right)+\left(b_{1, p}+c s_{1}\right)=\sum_{i=2}^{k_{1}} a_{i, p}+\sum_{i=1}^{k_{2}} b_{i, p}+c\left(s_{1}+t_{1}\right)=m^{*}+c\left(s_{1}+t_{1}\right) .
$$

Let

$$
M=m^{*}+c\left(s_{1}+t_{1}\right)
$$

which is a candidate for Theorem 2.10. Then, since $d \mid\left(s_{1}+t_{1}\right)$,

$$
\begin{equation*}
P_{m^{*}}=P_{M} . \tag{26}
\end{equation*}
$$

## $4.3 \quad(\forall i \geq M)\left[P_{i} \subseteq R_{i}\right]$

Since $R_{i} \subseteq Q_{i} \subseteq P_{i}$ for any positive integer $i$ by (3), $(\forall i \geq M)\left[P_{i} \subseteq R_{i}\right]$ implies $(\forall i \geq M)\left[P_{i}=\right.$ $\left.Q_{i}=R_{i}\right]$. Thus proving that $P_{i} \subseteq R_{i}$ for any integer $i \geq M$ will complete the proof of Theorem 2.10.

Now fix $\ell \geq M$. By Lemma 2.9(c),
$P_{\ell}=\left\{p \in \mathcal{I}_{n} \mid p=p_{0}+a s_{1}-b t_{1}\right.$ for some $p_{0} \in P_{M}$ and nonnegative integers $a$ and $b$ with $a+b=\ell-M\}$.

To show $P_{\ell} \subseteq R_{\ell}$, take $p \in P_{\ell}$. Then there exist some $p_{0} \in P_{M}$, and nonnegative integers $a$ and $b$ such that

$$
p=p_{0}+a s_{1}-b t_{1} \quad \text { and } \quad a+b=\ell-M
$$

Furthermore, by (24) and (26),

$$
p_{0}=\sum_{i=1}^{k_{1}} a_{i, 0} s_{i}-\sum_{j=1}^{k_{2}} b_{j, 0} t_{j}
$$

where $a_{i, 0}, b_{j, 0}$ are nonnegative integers with

$$
\sum_{i=1}^{k_{1}} a_{i, 0}+\sum_{j=1}^{k_{2}} b_{j, 0}=m^{\star}
$$

Therefore

$$
p=\sum_{i=2}^{k_{1}} a_{i, 0} s_{i}-\sum_{j=2}^{k_{2}} b_{j, 0} t_{j}+\left(a_{1,0}+c t_{1}+a\right) s_{1}-\left(b_{1,0}+c s_{1}+b\right) t_{1} .
$$

Now,

$$
\begin{aligned}
\sum_{i=2}^{k_{1}} a_{i, 0} & +\sum_{j=2}^{k_{2}} b_{j, 0}+\left(a_{1,0}+c t_{1}+a\right)+\left(b_{1,0}+c s_{1}+b\right) \\
& =\sum_{i=1}^{k_{1}} a_{i, 0}+\sum_{j=1}^{k_{2}} b_{j, 0}+c\left(s_{1}+t_{1}\right)+(a+b) \\
& =m^{\star}+c\left(s_{1}+t_{1}\right)+(\ell-M)=M+(\ell-M)=\ell .
\end{aligned}
$$

To show $p \in R_{\ell}$, take vertices $v$ and $v+p$ of $D$. Then there exists a directed walk $W_{v, 0}$ that contains exactly $a_{i, 0} s_{i}$-arcs and $b_{j, 0} t_{j}$-arcs for each $2 \leq i \leq k_{1}$ and $2 \leq j \leq k_{2}$ by $(\star)$. Now we need to extend $W_{v, 0}$ by attaching to its terminus

$$
w:=v+\sum_{i=2}^{k_{1}} a_{i, 0}-\sum_{j=2}^{k_{2}} b_{j, 0}
$$

a directed walk consisting of $s_{1}$-arcs exactly as many as $a_{1,0}+c t_{1}+a$ and $t_{1}$-arcs exactly as many as $b_{1,0}+c s_{1}+b$. We note that

$$
w+\left(a_{1,0}+c t_{1}+a\right) s_{1}-\left(b_{1,0}+c s_{1}+b\right) t_{1}=v+p
$$

Since $v+p$ is a vertex in $D, 1 \leq v+p \leq n$ and so the existence of such a directed walk to be attached to $W_{v, 0}$ is guaranteed by applying Theorem 3.3(b). Since $v$ was arbitrarily chosen, $p \in R_{\ell}$. In addition, $p$ was arbitrarily chosen, and so we finally have

$$
P_{\ell} \subseteq R_{\ell}
$$
