# PRODUCT MANIFOLDS AND THE CURVATURE OPERATOR OF THE SECOND KIND 

XIAOLONG LI


#### Abstract

We investigate the curvature operator of the second kind on product Riemannian manifolds and obtain some optimal rigidity results. For instance, we prove that the universal cover of an $n$-dimensional non-flat complete locally reducible Riemannian manifold with ( $n+\frac{n-2}{n}$ )-nonnegative (respectively, $\left(n+\frac{n-2}{n}\right)$-nonpositive) curvature operator of the second kind must be isometric to $\mathbb{S}^{n-1} \times \mathbb{R}$ (respectively, $\mathbb{H}^{n-1} \times \mathbb{R}$ ) up to scaling. We also prove analogous optimal rigidity results for $\mathbb{S}^{n_{1}} \times \mathbb{S}^{n_{2}}$ and $\mathbb{H}^{n_{1}} \times \mathbb{H}^{n_{2}}, n_{1}, n_{2} \geq$ 2 , among product Riemannian manifolds, as well as for $\mathbb{C P}^{m_{1}} \times \mathbb{C P}^{m_{2}}$ and $\mathbb{C} \mathbb{H}^{m_{1}} \times \mathbb{C} \mathbb{H}^{m_{2}}, m_{1}, m_{2} \geq 1$, among product Kähler manifolds. Our approach is pointwise and algebraic.


## 1. Introduction

On a Riemannian manifold ( $M^{n}, g$ ), the curvature operator of the second kind at $p \in M$ refers to the symmetric bilinear form $\stackrel{\circ}{R}: S_{0}^{2}\left(T_{p} M\right) \times S_{0}^{2}\left(T_{p} M\right) \rightarrow \mathbb{R}$ defined by

\stackrel{\circ}{R}(\varphi, \psi)=R_{i j k l} \varphi_{i l} \psi_{j k},
$$

where $S_{0}^{2}\left(T_{p} M\right)$ is the space of traceless symmetric two-tensors on $T_{p} M$. The terminology is due to Nishikawa Nis86. Early works studying this notion of curvature operator are BK78, OT79, Nis86] and Kas93.

In the past year, the notion of the curvature operator of the second kind has received much attention. See the recent works CGT21, Li21, Li22b, Li22c, Li22a, [NPW22] and (NPWW22]. In particular, the longstanding conjecture of Nishikawa Nis86, which asserts that a closed Riemannian manifold with positive curvature operator of the second kind is diffeomorphic to a spherical space form and a closed Riemannian manifold with nonnegative curvature operator of the second kind is diffeomorphic to a Riemannian locally symmetric space, has been resolved in CGT21, Li21 and NPW22, under weaker assumptions but with stronger conclusions. More precisely, it is known now that

Theorem 1.1. Let $\left(M^{n}, g\right)$ be a closed Riemannian manifold of dimension $n \geq 3$.
(1) If $\left(M^{n}, g\right)$ has three-positive curvature operator of the second kind, then $M$ is diffeomorphic to a spherical space form.

[^0](2) If $\left(M^{n}, g\right)$ has three-nonnegative curvature operator of the second kind, then $M$ is either flat or diffeomorphic to a spherical space form.

The key observation in CGT21 is that two-positive curvature operator of the second kind implies strictly PIC1 (i.e. $M \times \mathbb{R}$ has positive isotropic curvature). This is sufficient to solve the positive case of Nishikawa's conjecture, as one can appeal to a result of Brendle Bre08 stating that the Ricci flow on a compact manifold starting with a strictly PIC1 metric exists for all time and converge to a limit metric with constant positive sectional curvature. Shortly after, the author showed that strictly PIC1 is implied by three-positivity of the curvature operator of the second kind, thus getting an improvement of the result in [CGT21. To deal with the nonnegative case, the author Li21] reduces the problem to the locally irreducible case by proving that a complete $n$-dimensional Riemannian manifold with $n$-nonnegative curvature operator of the second kind is either flat or locally irreducible (see also Theorem 1.6 for an improvement of this result). Finally, Kähler manifolds are ruled out using Li21, Theorem 1.9] (see also Li22a for an improvement) and irreducible symmetric spaces are ruled out using [NPW22, Theorem A]. We refer the reader to Li22c or Li22a for a detailed account on the notion of the curvature operator of the second kind, as well as some recent developments.

The aim of this article is to study the curvature operator of the second kind on product manifolds and obtain some optimal rigidity results. We first recall the following definition. For $\alpha \in\left[1, \frac{(n-1)(n+2)}{2}\right]$, we say $\left(M^{n}, g\right)$ has $\alpha$-positive (respectively, $\alpha$-nonnegative) curvature operator of the second kind for if for any $p \in M$ and any orthonormal basis $\left\{\varphi_{i}\right\}_{1 \leq i \leq \frac{(n-1)(n+2)}{2}}$ of $S_{0}^{2}\left(T_{p} M\right)$, it holds that

\end{equation*}

Here and in the rest of this article, $\lfloor x\rfloor$ denotes the floor function defined by

$$
\lfloor x\rfloor:=\max \{m \in \mathbb{Z}: m \leq x\} .
$$

When $\alpha=k$ is an integer, this reduces to the usual definition, which means the sum of the smallest $k$ eigenvalues of the matrix $\stackrel{\circ}{R}\left(\varphi_{i}, \varphi_{j}\right)$ is positive/nonnegative for any orthonormal basis $\left\{\varphi_{i}\right\}_{i=1}^{N}$ of $S_{0}^{2}\left(T_{p} M\right)$. Similarly, $\left(M^{n}, g\right)$ is said to have $\alpha$-negative (respectively, $\alpha$-nonpositive) if the direction of the inequality (1.1) is reversed.

The first main result of this article is the following rigidity result for $\mathbb{S}^{n-1} \times \mathbb{R}$ and $\mathbb{H}^{n-1} \times \mathbb{R}$. Here and in the rest of this article, $\mathbb{S}^{n}$ and $\mathbb{H}^{n}, n \geq 2$, denote the $k$-dimensional sphere and hyperbolic space with constant sectional curvature 1 and -1 , respectively.

Theorem 1.2. Let $\left(M^{n}, g\right)$ be a nonflat complete locally reducible Riemannian manifold of dimension $n \geq 4$.
(1) If $M$ has $\left(n+\frac{n-2}{n}\right)$-nonnegative curvature operator of the second kind, then the universal cover of $M$ is, up to scaling, isometric to the $\mathbb{S}^{n-1} \times \mathbb{R}$.
(2) If $M$ has $\left(n+\frac{n-2}{n}\right)$-nonpositive curvature operator of the second kind, then the universal cover of $M$ is, up to scaling, isometric to the $\mathbb{H}^{n-1} \times \mathbb{R}$.

Closely related is the following holonomy restriction theorem in the spirit of NPWW22.

Theorem 1.3. Let $\left(M^{n}, g\right)$ be a (not necessarily complete) Riemannian manifold of dimension $n \geq 3$. Suppose that $(M, g)$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<n+\frac{n-2}{n}$. Then either $M$ is flat or the restricted holonomy of $M$ is $\mathrm{SO}(n)$.

Theorems 1.2 and 1.3 improve previous results obtained in Li21 and NPWW22. The author [i21, Theorem 1.8] proved that an $n$-dimensional complete Riemannian manifold with $n$-nonnegative curvature operator of the second kind is either flat or locally reducible. This result plays a significant role in resolving the nonnegative part of Nishikawa's conjecture in Li21, as it allows one to reduce the problem to the locally irreducible setting. Moreover, a slight modification of the proof yields the same conclusion under $n$-nonpositive curvature operator of the second kind. The method used in Li21 is pointwise and algebraic. In NPWW22, it is shown that if the curvature operator of the second kind of an $n$-dimensional Riemannian manifold, not necessarily complete, is $n$-nonnegative or $n$-nonpositive, then either the restricted holonomy of $M$ is $\mathrm{SO}(n)$ or $M$ is flat. This is a generalization of the author's result in [Li21. The approach of NPWW22] is local and the key idea is that unless the restricted holonomy is generic, there exists a parallel form, at least locally on the manifold, but on the other hand, Bochner technique with the curvature assumption implies that no such local parallel form exists unless the manifold is flat. Theorem 1.3 can also be viewed as supporting evidence of the author's conjecture in Li22c]: a closed $n$-dimensional Riemannian manifold with $\left(n+\frac{n-2}{n}\right)$ positive curvature operator of the second kind is diffeomorphic to a spherical space form.

We would like to point out that the number $n+\frac{n-2}{n}$ in Theorems 1.2 and 1.3 is optimal in all dimensions, in view of the fact that $\mathbb{S}^{n-1} \times \mathbb{R}$ and $\mathbb{H}^{n-1} \times \mathbb{R}$ have $\left(n+\frac{n-2}{n}\right)$-nonnegative and $\left(n+\frac{n-2}{n}\right)$-nonpositive curvature operator of the second kind, respectively, and they both have restricted holonomy $\mathrm{SO}(n-1)$. In dimension four, $\mathbb{C P}^{2}$ and $\mathbb{C H}^{2}$ have $4 \frac{1}{2}$-nonnegative and $4 \frac{1}{2}$-nonpositive curvature operator of the second kind, respectively, and they both have restricted holonomy U(2).

As a generalization of Theorem 1.1, the author proved in Li22c that a closed Riemannian manifold of dimension $n \geq 4$ with $4 \frac{1}{2}$-positive curvature operator of the second kind is homeomorphic to a spherical space form. This is obtained by showing that $4 \frac{1}{2}$-positive curvature operator of the second kind implies positive isotropic curvature and $\left(n+\frac{n-2}{n}\right)$-positive curvature operator of the second kind implies positive Ricci curvature, and then making use of the work of Micallef and Moore MM88. A classification result of closed manifolds with $4 \frac{1}{2}$-nonnegative curvature operator of the second kind was also obtained in [Li22c, Theorem 1.4]. Using Theorem 1.2, together with Li22a, Theorem 1.2] and NPW22, Theorem B], we get an improvement of [Li22c, Theorem 1.4].

Theorem 1.4. Let $\left(M^{n}, g\right)$ be a closed non-flat Riemannian manifold of dimension $n \geq 4$. Suppose that $M$ has $4 \frac{1}{2}$-nonnegative curvature operator of the second kind, then one of the following statements holds:
(1) $M$ is homeomorphic (diffeomorphic if either $n=4$ or $n \geq 12$ ) to a spherical space form;
(2) $n=4$ and $M$ is isometric to $\mathbb{C P}^{2}$ with Fubini-Study metric up to scaling;
(3) $n=4$ and the universal cover of $M$ is isometric to $\mathbb{S}^{3} \times \mathbb{R}$ up to scaling.

Our second main result is about the rigidity of $\mathbb{S}^{n_{1}} \times \mathbb{S}^{n_{2}}$ and $\mathbb{H}^{n_{1}} \times \mathbb{H}^{n_{2}}$ among product Riemannian manifolds.

Theorem 1.5. Let $\left(M_{i}^{n_{i}}, g_{i}\right)$ be a Riemannian manifold of dimension $n_{i} \geq 2$ for $i=1,2$, and let $\left(M^{n_{1}+n_{2}}, g\right)=\left(M_{1}^{n_{1}} \times M_{2}^{n_{2}}, g_{1} \oplus g_{2}\right)$. Set

$$
\begin{equation*}
A_{n_{1}, n_{2}}:=1+n_{1} n_{2}+\frac{n_{1}\left(n_{2}-1\right)+n_{2}\left(n_{1}-1\right)}{n_{1}+n_{2}} \tag{1.2}
\end{equation*}
$$

Then
(1) If $M$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<A_{n_{1}, n_{2}}$, then $M$ is flat.
(2) If $M$ has $A_{n_{1}, n_{2}}$-nonnegative curvature operator of the second kind, then both $M_{1}$ and $M_{2}$ have constant sectional curvature $c \geq 0$.
(3) If $M$ has $A_{n_{1}, n_{2}}$-nonpositive curvature operator of the second kind, then both $M_{1}$ and $M_{2}$ have constant sectional curvature $c \leq 0$.

If $M$ is further assumed to be complete and nonflat, then the universal cover of $M$ is isometric to $\mathbb{S}^{n_{1}} \times \mathbb{S}^{n_{2}}$ in part (2) and $\mathbb{H}^{n_{1}} \times \mathbb{H}^{n_{2}}$ in part (3), up to scaling.

The author proved in [Li21, Proposition 5.1] that an $n$-manifold with $(k(n-$ $k)+1$ )-nonnegative curvature operator of the second kind cannot split off a $k$ dimensional factor with $1 \leq k \leq n / 2$, unless it is flat. The number $k(n-k)+1$ is only optimal for some special $n$ and $k$. Combining Theorem 1.2 and Theorem 1.5 we get the following generalization, which is optimal for any $n$ and $1 \leq k \leq n / 2$.

Theorem 1.6. An n-dimensional Riemannian manifold with $\alpha$-nonnegative or $\alpha$ nonpositive curvature operator of the second kind for some

$$
\alpha<k(n-k)+\frac{2 k(n-k)}{n}
$$

cannot locally split off a $k$-dimensional factor with $1 \leq k \leq n / 2$, unless it is flat.
In another direction, the curvature operator of the second kind has been investigated for Kähler manifolds in BK78, Li21, Li22b, Li22a and NPWW22. For instance, it was shown in Li22a that $m$-dimensional Kähler manifolds with $\frac{3}{2}\left(m^{2}-1\right)$-nonnegative curvature operator of the second kind have constant nonnegative holomorphic sectional curvature, and a closed $m$-dimensional Kähler manifold with $\left(\frac{3 m^{3}-m+2}{2 m}\right)$-positive curvature operator of the second kind has positive orthogonal bisectional curvature, thus being biholomorphic to $\mathbb{C P}{ }^{m}$. Here we prove the following rigidity result for $\mathbb{C P}^{m_{1}} \times \mathbb{C P}^{m_{2}}$ and $\mathbb{C H}^{m_{1}} \times \mathbb{C H}^{m_{2}}$ (all equipped with their standard metrics).
Theorem 1.7. Let $\left(M_{i}^{m_{i}}, g_{i}\right)$ be a Kähler manifold of complex dimension $m_{i} \geq 1$ for $i=1,2$, and let $\left(M^{m_{1}+m_{2}}, g\right)=\left(M_{1}^{m_{1}} \times M_{2}^{m_{2}}, g_{1} \oplus g_{2}\right)$. Set

$$
\begin{equation*}
B_{m_{1}, m_{2}}:=4 m_{1} m_{2}+\frac{3}{2}\left(m_{1}^{2}+m_{2}^{2}\right)+\frac{m_{1} m_{2}}{m_{1}+m_{2}} \tag{1.3}
\end{equation*}
$$

Then
(1) If $M$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<B_{m_{1}, m_{2}}$, then $M$ is flat.
(2) If $M$ has $B_{m_{1}, m_{2}}$-nonnegative curvature operator of the second kind, then both $M_{1}$ and $M_{2}$ have constant holomorphic sectional curvature $c \geq 0$.
(3) If $M$ has $B_{m_{1}, m_{2}}$-nonpositive curvature operator of the second kind, then both $M_{1}$ and $M_{2}$ have constant holomorphic sectional curvature $c \leq 0$.

If $M$ is further assumed to be complete and nonflat, then the universal cover of $M$ is isometric to $\mathbb{C P}^{m_{1}} \times \mathbb{C P}^{m_{2}}$ in part (2) and $\mathbb{C H}^{m_{1}} \times \mathbb{C H}^{m_{2}}$ in part (3), up to scaling.

Our investigation of the curvature operator of the second kind on product manifolds is motivated not only by the above-mentioned optimal rigidity results, but also by the fact that the spectrum of $\stackrel{\circ}{R}$ are known only for a few examples: space forms with constant sectional curvature, Kähler and quaternion-Kähler space forms (BK78), $\mathbb{S}^{2} \times \mathbb{S}^{2}\left(\underline{\text { CGT21] }), ~} \mathbb{S}^{n-1} \times \mathbb{R}(\right.$ Li21 $), \mathbb{S}^{p} \times \mathbb{S}^{q}($ NPWW22 $)$. In the present paper, we determine the spectrum of $R$ for a class of product manifold by proving the following theorem.
Theorem 1.8. Let $\left(M_{i}, g_{i}\right)$ be an $n_{i}$-dimensional Einstein manifold with $\operatorname{Ric}\left(g_{i}\right)=$ $\rho_{i} g_{i}$ and $n_{i} \geq 1$ for $i=1,2$. Denote by $\stackrel{R}{R}_{i}$ the curvature operator of the second kind of $M_{i}$ for $i=1,2$, and $\stackrel{\dot{R}}{ }$ the curvature operator of the second kind of the product manifold

$$
\left(M^{n_{1}+n_{2}}, g\right)=\left(M_{1}^{n_{1}} \times M_{2}^{n_{2}}, g_{1} \oplus g_{2}\right) .
$$

Then the eigenvalues of $\stackrel{\circ}{R}$ are precisely those of $\AA_{1}$ and $\stackrel{\circ}{R}_{2}$, and 0 with multiplicity $n_{1} n_{2}$, and $-\frac{n_{1} \rho_{2}+n_{2} \rho_{1}}{n_{1}+n_{2}}$ with multiplicity one.

Theorem 1.8 enables us to determine the spectrum of the curvature operator of the second kind on $\left(M_{1}, g_{1}\right) \times\left(M_{2}, g_{2}\right)$, with $\left(M_{i}, g_{i}\right)$ being either a space form with constant sectional curvature or a Kähler space form with constant holomorphic sectional curvature for $i=1,2$. Examples are listed at the end of Section 2. More generally, Theorem 1.8 can be applied repeatedly to calculate the spectrum of $\mathscr{R}$ for product manifolds of the form $\left(M_{1}, g_{1}\right) \times \cdots \times\left(M_{k}, g_{k}\right)$, provided that each $\left(M_{i}, g_{i}\right)$ is Einstein and the eigenvalues of $\dot{R}_{i}$ on $M_{i}$ are known.

Let's discuss the strategy of our proofs. The key idea to prove Theorems 1.2 1.5 and 1.7 is to use the corresponding borderline example, such as $\mathbb{S}^{n-1} \times \mathbb{R}$, $\mathbb{S}^{n_{1}} \times \mathbb{S}^{n_{2}}$ or $\mathbb{C P}^{m_{1}} \times \mathbb{C P}^{m_{2}}$, as a model space and apply $R$ to the eigenvectors of the curvature operator of the second kind on the model space. This idea has been successfully employed by the author in [Li22c] with $\mathbb{C P}^{2}$ and $\mathbb{S}^{3} \times \mathbb{R}$ as model spaces, in Li22b with $\mathbb{S}^{2} \times \mathbb{S}^{2}$ as the model space and in Li22a with $\mathbb{C P}^{m}$ and $\mathbb{C P}^{m-1} \times \mathbb{C P}^{1}$ as model spaces. With the right choice of model space, this strategy leads to optimal results as the inequalities are all achieved as equalities on the model space. Theorem 1.6 is essentially a consequence of Theorems 1.2 and 1.5 The proof of Theorem [1.3]uses Berger's classification of restricted holonomy groups, together with Propositions 3.1 and 4.1 and results in [i22a and [NPWW22]. The proof of Theorem 1.8 replies on the fact that when both factor are Einstein, we can choose an orthonormal basis of the space of traceless symmetric two-tensors that diagonalizes the curvature operator of the second kind on the product manifold.

At last, we emphasize that our approach is of pointwise nature, and therefore, many of our results are of pointwise nature and the completeness of the metric is not required. Another feature is that our proofs are purely algebraic and work equally well for nonpositivity conditions on $\stackrel{\circ}{R}$.

The article is organized as follows. In Section 2, we study the curvature operator of the second kind on product Riemannian manifolds and prove Theorem 1.8 . We present the proofs of Theorems 1.2 and 1.4 in Section 3. The proofs of Theorems 1.5 and 1.6 are given in Section 4. In Section 5, we prove Theorem 1.3. Section 6 is devoted to the proof of Theorem 1.7

Throughout this paper, all manifolds are assumed to be connected. We use the same notations and conventions as in Li21] or Li22c or [Li22a].

## 2. Product Manifolds

In this section, we study the curvature operator of the second kind on product Riemannian manifolds and prove Theorem 1.8

Recall that for Riemannian manifolds $\left(M_{1}, g_{1}\right)$ and $\left(M_{2}, g_{2}\right)$, the product metric $g_{1} \oplus g_{2}$ on $M_{1} \times M_{2}$ is defined by

$$
g\left(X_{1}+X_{2}, Y_{1}+Y_{2}\right)=g_{1}\left(X_{1}, Y_{1}\right)+g_{2}\left(X_{2}, Y_{2}\right)
$$

for $X_{i}, Y_{i} \in T_{p_{i}} M_{i}$ under the natural identification

$$
T_{\left(p_{1}, p_{2}\right)}\left(M_{1} \times M_{2}\right)=T_{p_{1}} M_{1} \oplus T_{p_{2}} M_{2}
$$

Let $R$ denote the Riemann curvature tensor of $M=M_{1} \times M_{2}$, and $R_{1}, R_{2}$ denote the Riemann curvature tensor of $M_{1}$ and $M_{2}$, respectively. Then one can relate $R$, $R_{1}$ and $R_{2}$ by

\begin{aligned}
& R\left(X_{1}+X_{2}, Y_{1}+Y_{2}, Z_{1}+Z_{2}, W_{1}+W_{2}\right) \\
= & R_{1}\left(X_{1}, Y_{1}, Z_{1}, W_{1}\right)+R_{2}\left(X_{2}, Y_{2}, Z_{2}, W_{2}\right),
\end{aligned}
$$

where $X_{i}, Y_{i}, Z_{i}, W_{i} \in T M_{i}$. As the reader will see, the above equation, which is a consequence of the product structure, plays a significant role in this section.

From now on, let's focus on a single point in a product manifold and work in an purely algebraic way. For $i=1,2$, let $\left(V_{i}, g_{i}\right)$ be an Euclidean vector space of dimension $n_{i} \geq 1$. The product space $V=V_{1} \times V_{2}$ will be naturally identified with $V_{1} \oplus V_{2}$ via the isomorphism $\left(X_{1}, X_{2}\right) \rightarrow X_{1}+X_{2}$ for $X_{i} \in V_{i}$. The product metric on $V$, denoted by $g=g_{1} \oplus g_{2}$, is defined by

g\left(X_{1}+X_{2}, Y_{1}+Y_{2}\right)=g_{1}\left(X_{1}, Y_{1}\right)+g_{2}\left(X_{2}, Y_{2}\right) \tag{2.1}
\end{equation*}

for $X_{i}, Y_{i} \in V_{i}$.
Denote by $S_{B}^{2}\left(\Lambda^{2} V\right)$ the space of algebraic curvature operators on $(V, g)$. That is to say, $R \in S_{B}^{2}\left(\Lambda^{2} V\right)$ is a symmetric two-tensor on the space of two-forms $\Lambda^{2} V$ on $V$ and $R$ also satisfies the first Bianchi identity. Given $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ for $i=1,2$, we define $R \in S_{B}^{2}\left(\Lambda^{2} V\right)$ by

& R\left(X_{1}+X_{2}, Y_{1}+Y_{2}, Z_{1}+Z_{2}, W_{1}+W_{2}\right)  \tag{2.2}\\
= & R_{1}\left(X_{1}, Y_{1}, Z_{1}, W_{1}\right)+R_{2}\left(X_{2}, Y_{2}, Z_{2}, W_{2}\right),
\end{align*}

for $X_{i}, Y_{i}, Z_{i}, W_{i} \in V_{i}$. Throughout this paper, we simply write

$$
R=R_{1} \oplus R_{2}
$$

whenever $R, R_{1}$ and $R_{2}$ are related by (2.2). We also denote by $\stackrel{\circ}{R}, \stackrel{\circ}{R}_{1}$ and $\stackrel{\circ}{R}_{2}$ the associated curvature operator of the second kind for $R=R_{1} \oplus R_{2}, R_{1}$ and $R_{2}$, respectively.

The key result of this section is the following proposition.
Proposition 2.1. Let $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ for $i=1,2$ with $\operatorname{dim}\left(V_{i}\right)=n_{i} \geq 1$ and let $R=R_{1} \oplus R_{2}$. If $\operatorname{Ric}\left(R_{i}\right)=\rho_{i} g_{i}$ for $i=1,2$, then the eigenvalues of $\stackrel{\circ}{R}$ are precisely those of $\stackrel{\circ}{R}_{1}$ and $\stackrel{\circ}{R}_{2}$, together with 0 with multiplicity $n_{1} n_{2}$ and $-\frac{n_{2} \rho_{1}+n_{1} \rho_{2}}{n_{1}+n_{2}}$ with multiplicity one.

We will present the proof of Proposition 2.1 after we establish the following three lemmas. In the rest of this section, $\stackrel{\circ}{R}$ acts on the space of symmetric two-tensors $S^{2}(V)$ via

$$
\stackrel{\circ}{R}(\varphi)_{i j}=\sum_{k, l=1}^{n} R_{i j k l} \varphi_{k l}
$$

Note that the curvature operator of the second kind (defined as a symmetric bilinear form in the Introduction) is equivalent to the symmetric bilinear form associated to the self-adjoint operator $\pi \circ \stackrel{\circ}{R}: S_{0}^{2}(V) \rightarrow S_{0}^{2}(V)$, where $\pi: S^{2}(V) \rightarrow S_{0}^{2}(V)$ is the projection map. This can be seen as

$$
\stackrel{\circ}{R}(\varphi, \psi)=\langle\stackrel{\circ}{R}(\varphi), \psi\rangle=\langle(\pi \circ \stackrel{\circ}{R})(\varphi), \psi\rangle=(\pi \circ \stackrel{\circ}{R})(\varphi, \psi)
$$

for $\varphi, \psi \in S_{0}^{2}(V)$. Therefore, the spectrum of the curvature operator of the second kind $\stackrel{\circ}{R}$ (as a bilinear form) is the same as the spectrum of the self-adjoint operator $\pi \circ \stackrel{\circ}{R}$.

First of all, we observe that (2.2) implies that zero is an eigenvalue of $\stackrel{\circ}{R}$ with multiplicity (at least) $n_{1} n_{2}$. This is also observed in NPWW22, Lemma 2.1].

Lemma 2.1. Let $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ for $i=1,2$ with $\operatorname{dim}\left(V_{i}\right)=n_{i} \geq 1$ and let $R=R_{1} \oplus R_{2}$. Let $E$ be the subspace of $S_{0}^{2}\left(V_{1} \times V_{2}\right)$ given by

$$
E=\operatorname{span}\left\{u \odot v: u \in V_{1}, v \in V_{2}\right\}
$$

Then $E$ lies in the kernel of $\stackrel{\circ}{R}$. In particular, 0 is an eigenvalue of $\stackrel{\circ}{R}$ with multiplicity (at least) $n_{1} n_{2}$.

Proof. We start by constructing an orthonormal basis of $E$. Let $\left\{e_{i}\right\}_{i=1}^{n_{1}}$ be an orthonormal basis of $V_{1}$ and $\left\{e_{i}\right\}_{i=n_{1}+1}^{n_{1}+n_{2}}$ be an orthonormal basis of $V_{2}$. Then $\left\{e_{i}\right\}_{i=1}^{n_{1}+n_{2}}$ is an orthonormal basis of $V=V_{1} \times V_{2}$. Define

$$
\xi_{p q}=\frac{1}{\sqrt{2}} e_{p} \odot e_{q}
$$

for $1 \leq p \leq n_{1}$ and $n_{1}+1 \leq q \leq n_{1}+n_{2}$. Then one can verify that the $\xi_{p q}$ 's are traceless symmetric two-tensors on $V_{1} \times V_{2}$ and they form an orthonormal basis of $E$. In particular, $\operatorname{dim}(E)=n_{1} n_{2}$.

To prove that $E$ lies in the kernel of $\stackrel{\circ}{R}$, it suffices to show that $\stackrel{\circ}{R}\left(\xi_{p q}\right)=0$. We first observe that (2.2) implies that

$$
R\left(e_{i}, e_{j}, e_{k}, e_{l}\right)= \begin{cases}R_{1}\left(e_{i}, e_{j}, e_{k}, e_{l}\right), & i, j, k, l \in\left\{1, \cdots, n_{1}\right\}  \tag{2.3}\\ R_{2}\left(e_{i}, e_{j}, e_{k}, e_{l}\right), & i, j, k, l \in\left\{n_{1}+1, \cdots, n_{1}+n_{2}\right\} \\ 0, & \text { otherwise }\end{cases}
$$

We then compute, using $\left(e_{p} \odot e_{q}\right)\left(e_{j}, e_{k}\right)=\left(\delta_{p j} \delta_{q k}+\delta_{q j} \delta_{p k}\right)$, that

$$
\begin{aligned}
\stackrel{\circ}{R}\left(\xi_{p q}\right)\left(e_{i}, e_{l}\right) & =\sum_{j, k=1}^{n} R\left(e_{i}, e_{j}, e_{k}, e_{l}\right) \xi_{p q}\left(e_{j}, e_{k}\right) \\
& =\frac{1}{\sqrt{2}} \sum_{j, k=1}^{n} R\left(e_{i}, e_{j}, e_{k}, e_{l}\right)\left(\delta_{p j} \delta_{q k}+\delta_{q j} \delta_{p} k\right) \\
& =\frac{1}{\sqrt{2}} \sum_{j, k=1}^{n_{1}}\left(R\left(e_{i}, e_{p}, e_{q}, e_{l}\right)+R\left(e_{i}, e_{q}, e_{p}, e_{l}\right)\right) \\
& =0,
\end{aligned}
$$

where the last step is because of (2.3) and the fact that $1 \leq p \leq n_{1}$ and $n_{1}+1 \leq$ $q \leq n_{1}+n_{2}$. Thus we have proved that 0 is an eigenvalue of $\stackrel{\circ}{R}$ with multiplicity (at least) $n_{1} n_{2}$.

Next, we show that the eigenvalues of $R_{1}$ and $R_{2}$ are also eigenvalues of $R=$ $R_{1} \oplus R_{2}$, provided that both $R_{1}$ and $R_{2}$ are Einstein.

Lemma 2.2. Let $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ for $i=1,2$ with $\operatorname{dim}\left(V_{i}\right)=n_{i} \geq 1$ and let $R=R_{1} \oplus R_{2}$. If $R_{1}$ (respectively, $R_{2}$ ) is Einstein, then the eigenvalues of $\stackrel{\circ}{R}_{1}$ (respectively, $\stackrel{\circ}{R}_{2}$ ) are also eigenvalues of $\stackrel{\circ}{R}$.

Proof. It suffices to prove the statement for $R_{1}$. Since $R_{1}$ is Einstein, we have that $\stackrel{\circ}{R}_{1}: S_{0}^{2}\left(V_{1}\right) \rightarrow S_{0}^{2}\left(V_{1}\right)$ is a self-adjoint operator. We can then choose an orthonormal basis $\left\{\varphi_{p}\right\}_{p=1}^{N_{1}}$ of $S_{0}^{2}\left(V_{1}\right)$ such that

$$
\stackrel{\circ}{R}_{1}\left(\varphi_{p}\right)=\lambda_{p} \varphi_{p}
$$

where $N_{1}=\frac{\left(n_{1}-1\right)\left(n_{1}+2\right)}{2}$ is the dimension of $S_{0}^{2}\left(V_{1}\right)$. Note that we may also view the $\varphi_{p}$ 's as elements in $S_{0}^{2}\left(V_{1} \times V_{2}\right)$ via zero extension, namely,

$$
\varphi_{p}\left(X_{1}+X_{2}, Y_{1}+Y_{2}\right)=\varphi_{p}\left(X_{1}, Y_{1}\right)
$$

for $X_{i}, Y_{i} \in V_{i}$. Then we have

$$
\varphi_{p}\left(e_{j}, e_{k}\right)= \begin{cases}\varphi_{p}\left(e_{j}, e_{k}\right), & j, k \in\left\{1, \cdots, n_{1}\right\}  \tag{2.4}\\ 0, & \text { otherwise }\end{cases}
$$

where $\left\{e_{i}\right\}_{i=1}^{n_{1}+n_{2}}$ is the same basis of $V$ in Lemma 2.1.

Next, we calculate using (2.4) that for $1 \leq i, l \leq n_{1}$,

$$
\begin{aligned}
\stackrel{\circ}{R}\left(\varphi_{p}\right)\left(e_{i}, e_{l}\right) & =\sum_{j, k=1}^{n_{1}+n_{2}} R\left(e_{i}, e_{j}, e_{k}, e_{l}\right) \varphi_{p}\left(e_{j}, e_{k}\right) \\
& =\sum_{j, k=1}^{n_{1}} R\left(e_{i}, e_{j}, e_{k}, e_{l}\right) \varphi_{p}\left(e_{j}, e_{k}\right) \\
& =\sum_{j, k=1}^{n_{1}} R_{1}\left(e_{i}, e_{j}, e_{k}, e_{l}\right) \varphi_{p}\left(e_{j}, e_{k}\right) \\
& =\lambda_{p} \varphi_{p}\left(e_{i}, e_{l}\right)
\end{aligned}
$$

and for $n_{1}+1 \leq i, l \leq n_{1}+n_{2}$,

$$
\begin{aligned}
\stackrel{\circ}{R}\left(\varphi_{p}\right)\left(e_{i}, e_{l}\right) & =\sum_{j, k=1}^{n_{1}+n_{2}} R\left(e_{i}, e_{j}, e_{k}, e_{l}\right) \varphi_{p}\left(e_{j}, e_{k}\right) \\
& =\sum_{j, k=1}^{n_{1}} R\left(e_{i}, e_{j}, e_{k}, e_{l}\right) \varphi_{p}\left(e_{j}, e_{k}\right) \\
& =0 \\
& =\lambda_{p} \varphi_{p}\left(e_{i}, e_{l}\right) .
\end{aligned}
$$

Therefore, we have proved $\stackrel{\circ}{R}\left(\varphi_{p}\right)=\lambda_{p} \varphi_{p}$ for $1 \leq p \leq N_{1}$. Hence the eigenvalues of $\stackrel{\circ}{R}_{1}$ are also eigenvalues of $\stackrel{\circ}{R}$ with the same eigenvectors.

Finally, we prove that
Lemma 2.3. Let $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ for $i=1,2$ with $\operatorname{dim}\left(V_{i}\right)=n_{i} \geq 1$ and let $R=R_{1} \oplus R_{2}$. If $\operatorname{Ric}\left(R_{i}\right)=\rho_{i} g_{i}$ for $i=1,2$, then $-\frac{n_{2} \rho_{1}+n_{1} \rho_{2}}{n_{1}+n_{2}}$ is an eigenvalue of $\stackrel{\circ}{R}$ with eigenvector $n_{2} g_{1}-n_{1} g_{2}$.

Proof. As in the proof of Lemma 2.2, we may also view $g_{1}$ and $g_{2}$ as elements in $S_{0}^{2}\left(V_{1} \times V_{2}\right)$ via zero extension. Clearly, $\operatorname{tr}\left(n_{2} g_{1}-n_{1} g_{2}\right)=n_{2} n_{1}-n_{1} n_{2}=0$. So we have $n_{2} g_{1}-n_{1} g_{2} \in S_{0}^{2}\left(V_{1} \times V_{2}\right)$.

We then compute that

$$
\begin{aligned}
\stackrel{\circ}{R}\left(n_{2} g_{1}-n_{1} g_{2}\right) & =n_{2} \stackrel{\circ}{R}\left(g_{1}\right)-n_{1} \stackrel{\circ}{R}\left(g_{2}\right) \\
& =n_{2} \stackrel{\circ}{R}_{1}\left(g_{1}\right)-n_{1} \stackrel{\circ}{R}_{2}\left(g_{2}\right) \\
& =-n_{2} \operatorname{Ric}\left(R_{1}\right)+n_{1} \operatorname{Ric}\left(R_{2}\right) \\
& =-n_{2} \rho_{1} g_{1}+n_{1} \rho_{2} g_{2},
\end{aligned}
$$

where we have used $\stackrel{\circ}{R}_{i}\left(g_{i}\right)=-\operatorname{Ric}\left(R_{i}\right)=-\rho_{i} g_{i}$ for $i=1,2$.
Using

$$
\operatorname{tr}\left(-n_{2} \rho_{1} g_{1}+n_{1} \rho_{2} g_{2}\right)=-n_{1} n_{2}\left(\rho_{1}-\rho_{2}\right)
$$

we then obtain that

$$
\begin{aligned}
& (\pi \circ \stackrel{\circ}{R})\left(n_{2} g_{1}-n_{1} g_{2}\right) \\
= & -n_{2} \rho_{1} g_{1}+n_{1} \rho_{2} g_{2}-\frac{-n_{1} n_{2}\left(\rho_{1}-\rho_{2}\right)}{n_{1}+n_{2}}\left(g_{1}+g_{2}\right) \\
= & -n_{2} g_{1}\left(\rho_{1}-\frac{n_{1}\left(\rho_{1}-\rho_{2}\right)}{n_{1}+n_{2}}\right)+n_{1} g_{2}\left(\rho_{2}+\frac{n_{2}\left(\rho_{1}-\rho_{2}\right)}{n_{1}+n_{2}}\right) \\
= & -\left(\frac{n_{1} \rho_{2}+n_{2} \rho_{1}}{n_{1}+n_{2}}\right)\left(n_{2} g_{1}-n_{1} g_{2}\right) .
\end{aligned}
$$

Thus, we see that $-\frac{n_{1} \rho_{2}+n_{2} \rho_{1}}{n_{1}+n_{2}}$ is an eigenvalue of $\stackrel{\circ}{R}$ with eigenvector $n_{2} g_{1}-n_{1} g_{2}$. The proof is now complete.

Proof of Proposition 2.1. Let $\left\{e_{i}\right\}_{i=1}^{n_{1}+n_{2}}$ be an orthonormal basis of $V$ with $e_{1}, \cdots e_{n_{1}} \in$ $V_{1}$ and $e_{n_{1}+1}, \cdots e_{n_{1}+n_{2}} \in V_{2}$. Let $\left\{\varphi_{p}\right\}_{p=1}^{N_{1}}$ be an orthonormal basis of $S_{0}^{2}\left(V_{1}\right)$ such that $\stackrel{\circ}{R}_{1}\left(\varphi_{p}\right)=\lambda_{p} \varphi_{p}$ and $\left\{\psi_{q}\right\}_{q=1}^{N_{2}}$ be an orthonormal basis of $S_{0}^{2}\left(V_{2}\right)$ such that $\stackrel{\circ}{R}_{2}\left(\psi_{q}\right)=\mu_{q} \psi_{q}$, where $N_{i}=\frac{\left(n_{i}-1\right)\left(n_{i}+2\right)}{2}$ is the dimension of $S_{0}^{2}\left(V_{i}\right)$ for $i=1,2$. We then define the following traceless symmetric two-tensors on $V$ :

$$
\xi_{p q}=\frac{1}{\sqrt{2}} e_{p} \odot e_{q}
$$

for $1 \leq p \leq n_{1}$ and $n_{1}+1 \leq q \leq n_{1}+n_{2}$, and

$$
\zeta=\frac{1}{\sqrt{n_{1} n_{2}\left(n_{1}+n_{2}\right)}}\left(n_{2} g_{1}-n_{1} g_{2}\right)
$$

Then one can verify, via straightforward computations, that

$$
\left\{\varphi_{p}\right\}_{p=1}^{N_{1}} \cup\left\{\psi_{q}\right\}_{q=1}^{N_{2}} \cup\left\{\xi_{p q}\right\}_{1 \leq p \leq n_{1}, n_{1}+1 \leq q \leq n_{1}+n_{2}} \cup\{\zeta\}
$$

form an orthonormal basis of $S_{0}^{2}(V)$.
According to Lemma 2.1, 2.2 and 2.3, the above basis diagonalizes $\stackrel{\circ}{R}$ as
$\left(\begin{array}{lll|lll|ll|l}\lambda_{1} & & & & & & & \\ & \ddots & & & & & & & \\ & & \lambda_{N_{1}} & & & & & & \\ \hline & & & \mu_{1} & & & & & \\ & & & & \ddots & & & & \\ & & & & \mu_{N_{2}} & & & \\ \hline & & & & 0 & & \\ & & & & & & \ddots & & \\ \hline & & & & & & & -\frac{n_{2} \rho_{1}+n_{1} \rho_{2}}{n_{1}+n_{2}}\end{array}\right)$

Theorem 1.8 now follows immediately from Proposition 2.1 since on a product manifold the product metric satisfies (2.1) and the Riemann curvature tensor satisfies (2.2).

Since the spectrum of $\stackrel{\circ}{R}$ are known on space forms with constant sectional curvature and Kähler space forms with constant holomorphic sectional curvature, we can use Theorem 1.8 or Proposition 2.1 to determine the eigenvalues of the curvature operator of the second kind on their product.

In the rest of this section,

- $\mathbb{S}^{n}(\kappa)$ and $\mathbb{H}^{n}(-\kappa), n \geq 2$ and $\kappa>0$, denote the $n$-dimensional simplyconnected space form with constant sectional curvature $\kappa$ and $-\kappa$, respectively.
- $\mathbb{C P}^{m}(\kappa)$ and $\mathbb{C} \mathbb{H}^{m}(-\kappa), m \geq 1$ and $\kappa>0$, denote the (complex) $m$ dimensional simply-connected Kähler space form with constant holomorphic sectional curvature $4 \kappa$ and $-4 \kappa$, respectively.
Example 2.1. $\stackrel{\circ}{R}=\kappa \mathrm{id}_{S_{0}^{2}}$ on $\mathbb{S}^{n}(\kappa) . \stackrel{\circ}{R}=-\kappa \mathrm{id}_{S_{0}^{2}}$ on $\mathbb{H}^{n}(-\kappa)$.
Example 2.2. $\stackrel{\circ}{R}$ has two distinct eigenvalues on $\mathbb{C P}^{m}(\kappa):-2 \kappa$ with multiplicity $(m-1)(m+1)$ and $4 \kappa$ with multiplicity $m(m+1) . \stackrel{\circ}{R}$ has two distinct eigenvalues on $\mathbb{C} \mathbb{H}^{m}(-\kappa): 2 \kappa$ with multiplicity $(m-1)(m+1)$ and $-4 \kappa$ with multiplicity $m(m+1)$. See BK78.

Example 2.3. Let $M=\mathbb{S}^{n_{1}}\left(\kappa_{1}\right) \times \mathbb{S}^{n_{2}}\left(\kappa_{2}\right)$. Then the curvature operator of the second kind of $M$ has eigenvalues: $\kappa_{1}$ with multiplicity $\frac{\left(n_{1}-1\right)\left(n_{1}+2\right)}{2}, \kappa_{2}$ with multiplicity $\frac{\left(n_{2}-1\right)\left(n_{2}+2\right)}{2}, 0$ with multiplicity $n_{1} n_{2}$ and $-\frac{n_{1}\left(n_{2}-1\right) \kappa_{2}+n_{2}\left(n_{1}-1\right) \kappa_{1}}{n_{1}+n_{2}}$ with multiplicity one.

Example 2.4. Let $M=\mathbb{H}^{n_{1}}\left(-\kappa_{1}\right) \times \mathbb{H}^{n_{2}}\left(-\kappa_{2}\right)$. Then the curvature operator of the second kind of $M$ has eigenvalues: $-\kappa_{1}$ with multiplicity $\frac{\left(n_{1}-1\right)\left(n_{1}+2\right)}{2},-\kappa_{2}$ with multiplicity $\frac{\left(n_{2}-1\right)\left(n_{2}+2\right)}{2}, 0$ with multiplicity $n_{1} n_{2}$ and $\frac{n_{1}\left(n_{2}-1\right) \kappa_{2}+n_{2}\left(n_{1}-1\right) \kappa_{1}}{n_{1}+n_{2}}$ with multiplicity one.
Example 2.5. Let $M=\mathbb{S}^{n_{1}}\left(\kappa_{1}\right) \times \mathbb{R}^{n_{2}}$. Then the curvature operator of the second kind of $M$ has eigenvalues: $\kappa_{1}$ with multiplicity $\frac{\left(n_{1}-1\right)\left(n_{1}+2\right)}{2}$, 0 with multiplicity $n_{1} n_{2}+\frac{\left(n_{2}-1\right)\left(n_{2}+2\right)}{2}$ and $-\frac{n_{2}\left(n_{1}-1\right) \kappa_{1}}{n_{1}+n_{2}}$ with multiplicity one.
Example 2.6. Let $M=\mathbb{H}^{n_{1}}\left(-\kappa_{1}\right) \times \mathbb{R}^{n_{2}}$. Then the curvature operator of the second kind of $M$ has eigenvalues: $-\kappa_{1}$ with multiplicity $\frac{\left(n_{1}-1\right)\left(n_{1}+2\right)}{2}, 0$ with multiplicity $n_{1} n_{2}+\frac{\left(n_{2}-1\right)\left(n_{2}+2\right)}{2}$ and $\frac{n_{2}\left(n_{1}-1\right) \kappa_{1}}{n_{1}+n_{2}}$ with multiplicity one.
Example 2.7. Let $M=\mathbb{S}^{n_{1}}\left(\kappa_{1}\right) \times \mathbb{H}^{n_{2}}\left(-\kappa_{2}\right)$. Then the curvature operator of the second kind of $M$ has eigenvalues: $\kappa_{1}$ with multiplicity $\frac{\left(n_{1}-1\right)\left(n_{1}+2\right)}{2},-\kappa_{2}$ with multiplicity $\frac{\left(n_{2}-1\right)\left(n_{2}+2\right)}{2}, 0$ with multiplicity $n_{1} n_{2}$ and $-\frac{n_{1} n_{2}\left(\kappa_{1}-\kappa_{2}\right)+n_{1} \kappa_{2}-n_{2} \kappa_{1}}{n_{1}+n_{2}}$ with multiplicity one.

Example 2.8. Let $M=\mathbb{C P}^{m_{1}}\left(\kappa_{1}\right) \times \mathbb{C P}^{m_{2}}\left(\kappa_{2}\right)$. Then the curvature operator of the second kind of $M$ has eigenvalues: $-2 \kappa_{1}$ with multiplicity $\left(m_{1}-1\right)\left(m_{1}+1\right)$, $-2 \kappa_{2}$ with multiplicity $\left(m_{2}-1\right)\left(m_{2}+1\right), 4 \kappa_{1}$ with multiplicity $m_{1}\left(m_{1}+1\right), 4 \kappa_{2}$ with multiplicity $m_{2}\left(m_{2}+1\right), 0$ with multiplicity $4 m_{1} m_{2}$, and $-\frac{2 m_{1}\left(m_{2}+1\right) \kappa_{2}+2 m_{2}\left(m_{1}+1\right) \kappa_{1}}{m_{1}+m_{2}}$ with multiplicity one.
Example 2.9. Let $M=\mathbb{C} \mathbb{H}^{m_{1}}\left(-\kappa_{1}\right) \times \mathbb{C} \mathbb{H}^{m_{2}}\left(-\kappa_{2}\right)$. Then the curvature operator of the second kind of $M$ has eigenvalues: $2 \kappa_{1}$ with multiplicity $\left(m_{1}-1\right)\left(m_{1}+1\right), 2 \kappa_{2}$
with multiplicity $\left(m_{2}-1\right)\left(m_{2}+1\right)$, $-4 \kappa_{1}$ with multiplicity $m_{1}\left(m_{1}+1\right),-4 \kappa_{2}$ with multiplicity $m_{2}\left(m_{2}+1\right), 0$ with multiplicity $4 m_{1} m_{2}$, and $\frac{2 m_{1}\left(m_{2}+1\right) \kappa_{2}+2 m_{2}\left(m_{1}+1\right) \kappa_{1}}{m_{1}+m_{2}}$ with multiplicity one.

Example 2.10. Let $M=\mathbb{C P}^{m_{1}}\left(\kappa_{1}\right) \times \mathbb{C}^{m_{2}}$. Then the curvature operator of the second kind of $M$ has eigenvalues: $-2 \kappa_{1}$ with multiplicity $\left(m_{1}-1\right)\left(m_{1}+1\right), 4 \kappa_{1}$ with multiplicity $m_{1}\left(m_{1}+1\right)$, 0 with multiplicity $4 m_{1} m_{2}+\left(2 m_{2}-1\right)\left(m_{2}+1\right)$, and $-\frac{2 m_{2}\left(m_{1}+1\right) \kappa_{1}}{m_{1}+m_{2}}$ with multiplicity one.

Example 2.11. Let $M=\mathbb{C} \mathbb{H}^{m_{1}}\left(-\kappa_{1}\right) \times \mathbb{C}^{m_{2}}$. Then the curvature operator of the second kind of $M$ has eigenvalues: $2 \kappa_{1}$ with multiplicity $\left(m_{1}-1\right)\left(m_{1}+1\right),-4 \kappa_{2}$ with multiplicity $m_{1}\left(m_{1}+1\right)$, 0 with multiplicity $4 m_{1} m_{2}+\left(2 m_{2}-1\right)\left(m_{2}+1\right)$, and $\frac{2 m_{2}\left(m_{1}+1\right) \kappa_{1}}{m_{1}+m_{2}}$ with multiplicity one.

Example 2.12. Let $M=\mathbb{C P}^{m_{1}}\left(\kappa_{1}\right) \times \mathbb{C H}^{m_{2}}\left(-\kappa_{2}\right)$. Then the curvature operator of the second kind of $M$ has eigenvalues: $-2 \kappa_{1}$ with multiplicity $\left(m_{1}-1\right)\left(m_{1}+1\right), 4 \kappa_{2}$ with multiplicity $m_{1}\left(m_{1}+1\right), 2 \kappa_{2}$ with multiplicity $\left(m_{2}-1\right)\left(m_{2}+1\right),-4 \kappa_{2}$ with multiplicity $m_{2}\left(m_{2}+1\right), 0$ with multiplicity $4 m_{1} m_{2}$, and $-\frac{2 m_{1} m_{2}\left(\kappa_{1}-\kappa_{2}\right)+2 m_{2} \kappa_{1}-2 m_{1} \kappa_{2}}{m_{1}+m_{2}}$ with multiplicity one.

In particular, we have the following observation, which will be needed later on.
Proposition 2.2. For $n_{1}, n_{2} \geq 2, m_{1}, m_{2} \geq 1, \kappa_{1}, \kappa_{2}>0$, the following statements hold:
(1) $\mathbb{S}^{n_{1}}\left(\kappa_{1}\right) \times \mathbb{S}^{n_{2}}\left(\kappa_{2}\right)$ has $A_{n_{1}, n_{2}}$-nonnegative curvature operator of the second kind if and only if $\kappa_{1}=\kappa_{2}>0$;
(2) $\mathbb{H}^{n_{1}}\left(-\kappa_{1}\right) \times \mathbb{H}^{n_{2}}\left(-\kappa_{2}\right)$ has $A_{n_{1}, n_{2}}-$ nonpositive curvature operator of the second kind if and only if $\kappa_{1}=\kappa_{2}>0$;
(3) $\mathbb{C P}^{m_{1}}\left(\kappa_{1}\right) \times \mathbb{C P}^{m_{2}}\left(\kappa_{2}\right)$ has $B_{m_{1}, m_{2}}$-nonnegative curvature operator of the second kind if and only if $\kappa_{1}=\kappa_{2}>0$;
(4) $\mathbb{C} \mathbb{H}^{m_{1}}\left(-\kappa_{1}\right) \times \mathbb{C} \mathbb{H}^{m_{2}}\left(-\kappa_{2}\right)$ has $B_{m_{1}, m_{2}}$-nonpositive curvature operator of the second kind if and only if $\kappa_{1}=\kappa_{2}<0$.

## 3. Rigidity of $\mathbb{S}^{n-1} \times \mathbb{R}$ and $\mathbb{H}^{n-1} \times \mathbb{R}$

In this section, we prove Theorem 1.2 . The key result of this section is the following proposition.

Proposition 3.1. Let $(V, g)$ be a Euclidean vector space of dimension $(n-1)$ with $n \geq 2$ and let $R_{1} \in S_{B}^{2}\left(\Lambda^{2} V\right)$.
(1) Suppose that $R=R_{1} \oplus 0 \in S_{B}^{2}\left(\Lambda^{2}(V \times \mathbb{R})\right)$ has $\left(n+\frac{n-2}{n}\right)$-nonnegative curvature operator of the second kind. Then $R_{1}$ has constant nonnegative sectional curvature.
(2) Suppose that $R=R_{1} \oplus 0 \in S_{B}^{2}\left(\Lambda^{2}(V \times \mathbb{R})\right)$ has $\left(n+\frac{n-2}{n}\right)$-nonpositive curvature operator of the second kind. Then $R_{1}$ has constant nonpositive sectional curvature.
(3) Suppose that $R=R_{1} \oplus 0 \in S_{B}^{2}\left(\Lambda^{2}(V \times \mathbb{R})\right)$ has $\alpha$-nonnegative or $\alpha$ nonpositive curvature operator of the second kind for some $\alpha<n+\frac{n-2}{n}$, then $R$ is flat.

Proof. (1). Let $\left\{e_{i}\right\}_{i=1}^{n-1}$ be an orthonormal basis of $V$ and let $e_{n}$ be a unit vector in $\mathbb{R}$. Then $\left\{e_{i}\right\}_{i=1}^{n}$ is an orthonormal basis of $V \times \mathbb{R} \cong V \oplus \mathbb{R}$. Next, we define the following symmetric two-tensors on $V \oplus \mathbb{R}$ :

$$
\begin{aligned}
\xi_{i} & =\frac{1}{\sqrt{2}} e_{i} \odot e_{n} \text { for } 1 \leq i \leq n-1 \\
\varphi_{k l} & =\frac{1}{\sqrt{2}} e_{k} \odot e_{l} \text { for } 1 \leq k<l \leq n-1 \\
\zeta & =\frac{1}{2 \sqrt{n(n-1)}}\left(\sum_{p=1}^{n-1} e_{p} \odot e_{p}-(n-1) e_{n} \odot e_{n}\right)
\end{aligned}
$$

One easily verifies that $\left\{\xi_{i}\right\}_{i=1}^{n-1} \cup\left\{\varphi_{k l}\right\}_{1 \leq k<l \leq n-1} \cup\{\zeta\}$ form an orthonormal subset of $S_{0}^{2}\left(\Lambda^{2}(V \oplus \mathbb{R})\right)$.

Since $R=R_{1} \oplus 0$, we have by (2.2) that

$$
R\left(e_{i}, e_{j}, e_{k}, e_{l}\right)= \begin{cases}R_{1}\left(e_{i}, e_{j}, e_{k}, e_{l}\right), & i, j, k, l \in\{1, \cdots, n-1\}  \tag{3.1}\\ 0, & \text { otherwise }\end{cases}
$$

In particular, we have $R_{n j n j}=0$ for $1 \leq j \leq n-1$.
Direct calculation using the identity

$$
\stackrel{\circ}{R}\left(e_{i} \odot e_{j}, e_{k} \odot e_{l}\right)=2\left(R_{i k l j}+R_{i l k j}\right)
$$

shows that

$$
\begin{aligned}
\stackrel{\circ}{R}\left(\xi_{i}, \xi_{i}\right) & =0 \text { for } 1 \leq i \leq n-1 \\
\stackrel{\circ}{R}\left(\varphi_{k l}, \varphi_{k l}\right) & =\left(R_{1}\right)_{k l k l} \text { for } 1 \leq k<l \leq n-1 \\
\stackrel{\circ}{R}(\zeta, \zeta) & =-\frac{1}{n(n-1)} S_{1}
\end{aligned}
$$

where $S_{1}$ is the scalar curvature of $R_{1}$. Note that $S_{1} \geq 0$ since $S_{1}$ is also equal to the scalar curvature of $R$, which must be nonnegative since $R$ has $\left(n+\frac{n-2}{n}\right)$-nonnegative curvature operator of the second kind (see for instance Li21, Proposition 4.1, part (1)]).

Since $R$ has $\left(n+\frac{n-2}{n}\right)$-nonnegative curvature operator of the second kind, we get that for any $1 \leq k<l \leq n-1$,

$$
\begin{aligned}
0 & \leq \stackrel{\circ}{R}(\zeta, \zeta)+\sum_{i=1}^{n-1} \stackrel{\circ}{R}\left(\xi_{i}, \xi_{i}\right)+\frac{n-2}{n} \stackrel{\circ}{R}\left(\psi_{k l}, \psi_{k l}\right) \\
& =-\frac{1}{n(n-1)} S_{1}+\frac{n-2}{n}\left(R_{1}\right)_{k l k l} \\
& =\frac{n-2}{n}\left(\left(R_{1}\right)_{k l k l}-\frac{S_{1}}{(n-1)(n-2)}\right)
\end{aligned}
$$

Summing over $1 \leq k<l \leq n-1$ yields

$$
S_{1} \leq \sum_{1 \leq k<l \leq n-1}\left(R_{1}\right)_{k l k l}
$$

On the other hand,

$$
S_{1}=\sum_{1 \leq k<l \leq n-1}\left(R_{1}\right)_{k l k l}
$$

Therefore, we must have $\left(R_{1}\right)_{k l k l}=\frac{S_{1}}{(n-1)(n-2)}$ for all $1 \leq k<l \leq n-1$. Since the orthonormal basis $\left\{e_{1}, \cdots, e_{n-1}\right\}$ is arbitrary, we conclude that $R_{1}$ has constant nonnegative sectional curvature.
(2). Apply (1) to $-R$.
(3). By (1) and (2), we have $R=c I_{n-1} \oplus 0$ for some $c \in \mathbb{R}$, where $I_{n-1}$ is the Riemann curvature tensor of $\mathbb{S}^{n-1}$. However, $R=c I_{n-1} \oplus 0$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<n+\frac{n-2}{n}$ if and only if $c=0$. Therefore, $R$ is flat.

We now present the proof of Theorem 1.2

Proof of Theorem 1.2. (1). Recall that we say that $\left(M^{n}, g\right)$ is locally reducible if there exists a nontrivial subspace of $T_{p} M$ which is invariant under the action of the restricted holonomy group. By a theorem of de Rham, a complete Riemannian manifold is locally reducible if and only if its universal cover is isometric to the product of two Riemannian manifolds of lower dimension.

Denote by $(\widetilde{M}, \tilde{g})$ the universal cover of $M$ with the lifted metric $\tilde{g}$. Since $M$ is locally reducible, $(\widetilde{M}, \tilde{g})$ is isometric to a product of the form $\left(M_{1}^{k}, g_{1}\right) \times\left(M_{2}^{n-k}, g_{2}\right)$, where $1 \leq k \leq \frac{n}{2}$. Note that $k \geq 2$ implies

$$
k(n-k)+1 \geq n+\frac{n-2}{n}
$$

so $\widetilde{M}$ must be flat if $k \geq 2$, according to Li21, Proposition 5.1] (or its improvement Theorem (1.6). Thus we must have $k=1$ and $\widetilde{M}$ is isometric to $N^{n-1} \times \mathbb{R}$. By part (1) of Proposition 3.1, $N$ has pointwise constant nonnegative sectional curvature. Since $n-1 \geq 3$, Schur's lemma implies that $N$ must have constant nonnegative sectional curvature. Therefore, $M$ is either flat or its universal cover is isometric to $\mathbb{S}^{n-1} \times \mathbb{R}$ by scaling.
(2). This is similar to the proof of (1), by noticing that [Li21, Proposition 5.1] is also valid for the nonpositivity condition (alternatively, one can use Theorem 1.6 here).

Proof of Theorem 1.4. Let $\left(M^{n}, g\right)$ be a closed non-flat Riemannian manifold of dimension $n \geq 4$ and suppose that $M$ has $4 \frac{1}{2}$-nonnegative curvature operator of the second kind. It was shown in Li22c that one of the following statements holds:
(a) $M$ is homeomorphic (diffeomorphic if $n=4$ or $n \geq 12$ ) to a spherical space form;
(b) $n=2 m$ and the universal cover of $M$ is a Kähler manifold biholomorphic to $\mathbb{C P}^{m}$;
(c) $n=4$ and the universal cover of $M$ is diffeomorphic to $\mathbb{S}^{3} \times \mathbb{R}$;
(d) $n \geq 5$ and $M$ is isometric to a quotient of a compact irreducible symmetric space.

By Theorem 1.2 in Li22a, the Kähler manifold in part (2) is either flat or isometric to $\mathbb{C P}^{2}$ with the Fubini-Study metric, up to scaling. In part (c), the manifold is reducible and we conclude using Theorem 1.2 that the universal cover of $M$ is
isometric to $\mathbb{S}^{3} \times \mathbb{R}$, up to scaling. Part (d) can be ruled out using NPW22, Theorem B], as the manifold is either flat or a homology sphere.

## 4. Rigidity of $\mathbb{S}^{n_{1}} \times \mathbb{S}^{n_{2}}$ and $\mathbb{H}^{n_{1}} \times \mathbb{H}^{n_{2}}$

In this section, we prove Theorem 1.5. The key result of this section is the following proposition. In this section, $I_{n}, n \geq 2$, denotes the Riemann curvature tensor of the $n$ sphere with constant sectional curvature 1 .

Proposition 4.1. For $i=1,2$, let $\left(V_{i}, g_{i}\right)$ be a Euclidean vector space of dimension $n_{i}$ with $n_{i} \geq 2$. Let $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ and $R=R_{1} \oplus R_{2} \in S_{B}^{2}\left(\Lambda^{2}\left(V_{1} \times V_{2}\right)\right)$.
(1) Suppose that $R$ has $A_{n_{1}, n_{2}}$-nonnegative curvature operator of the second kind. Then $R=c\left(I_{n_{1}} \oplus I_{n_{2}}\right)$ for some $c \geq 0$.
(2) Suppose that $R$ has $A_{n_{1}, n_{2}}$-nonpositive curvature operator of the second kind. Then $R=c\left(I_{n_{1}} \oplus I_{n_{2}}\right)$ for some $c \leq 0$.
(3) Suppose that $R$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<A_{n_{1}, n_{2}}$, then $R$ is flat.

We need an elementary lemma, which can be found in Li22a, Lemma 5.1].
Lemma 4.1. Let $N$ be a positive integer and $A$ be a collection of $N$ real numbers. Denote by $a_{i}$ the $i$-th smallest number in A for $1 \leq i \leq N$. Define a function $f(A, x)$ by

$$
f(A, x)=\sum_{i=1}^{\lfloor x\rfloor} a_{i}+(x-\lfloor x\rfloor) a_{\lfloor x\rfloor+1},
$$

for $x \in[1, N]$. Then we have

$$
\begin{equation*}
f(A, x) \leq x \bar{a} \tag{4.1}
\end{equation*}
$$

where $\bar{a}:=\frac{1}{N} \sum_{i=1}^{N} a_{i}$ is the average of all numbers in $A$. Moreover, the equality holds for some $x \in[1, N)$ if and only if $a_{i}=\bar{a}$ for all $1 \leq i \leq N$.

Proof of Proposition 4.1. (1). Let $\left\{e_{i}\right\}_{i=1}^{n_{1}}$ be an orthonormal basis of $V_{1}$ and let $\left\{e_{i}\right\}_{i=n_{1}+1}^{n_{1}+n_{2}}$ be an orthonormal basis of $V_{2}$. Then $\left\{e_{i}\right\}_{i=1}^{n_{1}+n_{2}}$ is an orthonormal basis of $V_{1} \times V_{2} \cong V_{1} \oplus V_{2}$.

We construct an orthonormal basis of $S_{0}^{2}\left(V_{1} \times V_{2}\right)$ as follows. Choose an orthonormal basis $\left\{\varphi_{i}\right\}_{i=1}^{N_{1}}$ of $S_{0}^{2}\left(V_{1}\right)$ and an orthonormal basis $\left\{\psi_{i}\right\}_{i=1}^{N_{2}}$ of $S_{0}^{2}\left(V_{2}\right)$, where $N_{i}=\operatorname{dim}\left(S_{0}^{2}\left(V_{i}\right)\right)=\frac{\left(n_{i}-1\right)\left(n_{i}+2\right)}{2}$ for $i=1,2$. Note that $h \in S_{0}^{2}\left(V_{1}\right)$ can be identified with the element $\pi^{*} h$ in $S_{0}^{2}\left(V_{1} \times V_{2}\right)$ via

$$
\left(\pi^{*} h\right)\left(X_{1}+X_{2}, Y_{1}+Y_{2}\right)=h\left(X_{1}, X_{2}\right)
$$

where $X_{i}, Y_{i} \in V_{i}$ for $i=1,2$. We shall simply write $\pi^{*} h$ as $h$. Similarly, $S_{0}^{2}\left(V_{2}\right)$ can be identified with a subspace of $S_{0}^{2}\left(V_{1} \times V_{2}\right)$. Next we define the following symmetric two-tensors on $V_{1} \times V_{2}$ :

$$
\begin{aligned}
\xi_{k l} & =\frac{1}{\sqrt{2}} e_{k} \odot e_{l} \text { for } 1 \leq k \leq n_{1}, n_{1}+1 \leq l \leq n_{1}+n_{2} \\
\zeta & =\frac{1}{\sqrt{n_{1} n_{2}\left(n_{1}+n_{2}\right)}}\left(n_{2} g_{1}-n_{1} g_{2}\right)
\end{aligned}
$$

One verifies that

$$
\left\{\varphi_{i}\right\}_{i=1}^{N_{1}} \cup\left\{\psi_{i}\right\}_{i=1}^{N_{2}} \cup\left\{\xi_{k l}\right\}_{1 \leq k \leq n_{1}, n_{1}+1 \leq l \leq n_{1}+n_{2}} \cup\{\zeta\}
$$

form an orthonormal basis of $S_{0}^{2}\left(V_{1} \times V_{2}\right)$. This corresponds to the orthogonal decomposition

$$
S_{0}^{2}\left(V_{1} \times V_{2}\right)=S_{0}^{2}\left(V_{1}\right) \oplus S_{0}^{2}\left(V_{2}\right) \oplus \operatorname{span}\left\{u \odot v, u \in V_{1}, v \in V_{2}\right\} \oplus \mathbb{R} \zeta
$$

The next step is to calculate some diagonal elements of the matrix representing $\stackrel{\circ}{R}$ with respect to the above basis. Since $R=R_{1} \oplus R_{2}$, we have by (2.2) that

$$
R\left(e_{i}, e_{j}, e_{k}, e_{l}\right)= \begin{cases}R_{1}\left(e_{i}, e_{j}, e_{k}, e_{l}\right), & i, j, k, l \in\left\{1, \cdots, n_{1}\right\}  \tag{4.2}\\ R_{2}\left(e_{i}, e_{j}, e_{k}, e_{l}\right), & i, j, k, l \in\left\{n_{1}+1, \cdots, n_{1}+n_{2}\right\} \\ 0, & \text { otherwise }\end{cases}
$$

In particular, we have $R_{k l k l}=0$ if $1 \leq k \leq n_{1}$ and $n_{1} \leq l \leq n_{1}+n_{2}$. Using the identity

$$
\stackrel{\circ}{R}\left(e_{i} \odot e_{j}, e_{k} \odot e_{l}\right)=2\left(R_{i k l j}+R_{i l k j}\right),
$$

we get

$$
\begin{equation*}
\sum_{\substack{1 \leq k \leq n_{1}, n_{1}+1 \leq l \leq n_{1}+n_{2}}} \stackrel{\circ}{R}\left(\xi_{k l}, \xi_{k l}\right)=\sum_{\substack{1 \leq k \leq n_{1} \\ n_{1}+1 \leq l \leq n_{1}+n_{2}}} R_{k l k l}=0 \tag{4.3}
\end{equation*}
$$

We also calculate

$$
\begin{aligned}
\stackrel{\circ}{R}(\zeta, \zeta) & =\frac{1}{n_{1} n_{2}\left(n_{1}+n_{2}\right)}\left(n_{2}^{2} \stackrel{\circ}{R}\left(g_{1}, g_{1}\right)+n_{1}^{2} \stackrel{\circ}{R}\left(g_{2}, g_{2}\right)+2 n_{1} n_{2} \stackrel{\circ}{R}\left(g_{1}, g_{2}\right)\right) \\
& =\frac{1}{n_{1} n_{2}\left(n_{1}+n_{2}\right)}\left(n_{2}^{2} \stackrel{\circ}{R}\left(g_{1}, g_{1}\right)+n_{1}^{2} \stackrel{\circ}{R}\left(g_{2}, g_{2}\right)\right) \\
& =-\frac{n_{2}^{2} S_{1}+n_{1}^{2} S_{2}}{n_{1} n_{2}\left(n_{1}+n_{2}\right)},
\end{aligned}
$$

where $S_{i}$ denotes the scalar curvature of $R_{i}$ for $i=1,2$.
Let $A$ be the collection of the values of $\stackrel{\circ}{R}\left(\varphi_{i}, \varphi_{i}\right)$ for $1 \leq i \leq N_{1}$ and let $B$ be the collection of the values of $\stackrel{\circ}{R}\left(\psi_{i}, \psi_{i}\right)$ for $1 \leq i \leq N_{2}$. Denote by $\bar{a}$ and $\bar{b}$ the average of all numbers is $A$ and $B$, respectively. Then

$$
\begin{aligned}
& \bar{a}=\frac{1}{N_{1}} \sum_{i=1}^{N_{1}} \stackrel{\circ}{R}\left(\varphi_{i}, \varphi_{i}\right)=\frac{1}{N_{1}} \sum_{i=1}^{N_{1}} \stackrel{\circ}{R}_{1}\left(\varphi_{i}, \varphi_{i}\right)=\frac{S_{1}}{n_{1}\left(n_{1}-1\right)}, \\
& \bar{b}=\frac{1}{N_{2}} \sum_{i=1}^{N_{2}} \stackrel{\circ}{R}\left(\psi_{i}, \psi_{i}\right)=\frac{1}{N_{2}} \sum_{i=1}^{N_{2}} \stackrel{\circ}{R}_{2}\left(\psi_{i}, \psi_{i}\right)=\frac{S_{2}}{n_{2}\left(n_{2}-1\right)},
\end{aligned}
$$

where we have used

$$
\sum_{i=1}^{N_{1}} \stackrel{\circ}{R}_{1}\left(\psi_{i}, \psi_{i}\right)=\frac{n_{1}+2}{2 n_{1}} S_{1} \text { and } \sum_{i=1}^{N_{2}} \stackrel{\circ}{R}_{2}\left(\psi_{i}, \psi_{i}\right)=\frac{n_{2}+2}{2 n_{2}} S_{2}
$$

For simplicity, we write

$$
A_{1}=\frac{n_{2}\left(n_{1}-1\right)}{n_{1}+n_{2}} \text { and } A_{2}=\frac{n_{1}\left(n_{2}-1\right)}{n_{1}+n_{2}}
$$

Notice that we have $A_{1}<N_{1}, A_{2}<N_{2}$ and

$$
\begin{equation*}
A_{n_{1}, n_{2}}=1+n_{1} n_{2}+A_{1}+A_{2} \tag{4.4}
\end{equation*}
$$

Also, the expression for $\stackrel{\circ}{R}(\zeta, \zeta)$ can be written as

$$
\begin{equation*}
\stackrel{\circ}{R}(\zeta, \zeta)=-A_{1} \bar{a}-A_{2} \bar{b} \tag{4.5}
\end{equation*}
$$

Since $R$ has $A_{n_{1}, n_{2}}$-nonnegative curvature operator of the second kind, we get using (4.3), (4.4) and (4.5) that

$$
\begin{align*}
-\stackrel{\circ}{R}(\zeta, \zeta) & \leq f\left(A,\left\lfloor A_{1}\right\rfloor\right)+f\left(B, A_{1}+A_{2}-\left\lfloor A_{1}\right\rfloor\right)  \tag{4.6}\\
& \leq\left\lfloor A_{1}\right\rfloor \bar{a}+\left(A_{1}+A_{2}-\left\lfloor A_{1}\right\rfloor\right) \bar{b} \\
& =A_{1} \bar{a}+A_{2} \bar{b}+\left(A_{1}-\left\lfloor A_{1}\right\rfloor\right)(\bar{b}-\bar{a})
\end{align*}
$$

where $f$ is the function defined in Lemma 4.1 and we have used Lemma 4.1 in estimating $f$. Similarly, we also have

$$
\begin{align*}
-\stackrel{\circ}{R}(\zeta, \zeta) & \leq f\left(A, A_{1}+A_{2}-\left\lfloor A_{2}\right\rfloor\right)+f\left(B,\left\lfloor A_{2}\right\rfloor\right)  \tag{4.7}\\
& \leq\left(A_{1}+A_{2}-\left\lfloor A_{2}\right\rfloor\right) \bar{a}+\left\lfloor A_{2}\right\rfloor \bar{b} \\
& =A_{1} \bar{a}+A_{2} \bar{b}+\left(A_{2}-\left\lfloor A_{2}\right\rfloor\right)(\bar{a}-\bar{b})
\end{align*}
$$

Therefore, we get from (4.6) if $\bar{a} \geq \bar{b}$ and from (4.7) if $\bar{a} \leq \bar{b}$ that

$$
A_{1} \bar{a}+A_{2} \bar{b}=-\stackrel{\circ}{R}(\zeta, \zeta) \leq A_{1} \bar{a}+A_{2} \bar{b}
$$

This implies that, either in (4.6) or (4.7), we must have equalities in the inequalities used for $f$. We then get from Lemma 4.1, that all the values in $A$ are equal to $\bar{a}$ and all the values in $B$ are equal to $\bar{b}$. Hence, both $R_{1}$ and $R_{2}$ have constant sectional curvature, that is to say, $R=c_{1} I_{n_{1}} \oplus c_{2} I_{n_{2}}$ for $c_{1}, c_{2} \in \mathbb{R}$.

Finally, we must have $c_{1}=c_{2} \geq 0$, as $R=c_{1} I_{n_{1}} \oplus c_{2} I_{n_{2}}$ has $A_{n_{1}, n_{2}}$-nonnegative curvature operator of the second kind if and only if $c_{1}=c_{2} \geq 0$ by Proposition [2.2,
(2). Apply (1) to $-R$.
(3). This follows from the fact that $R=c\left(I_{n_{1}} \oplus I_{n_{2}}\right)$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<A_{n_{1}, n_{2}}$ if and only if $c=0$.

At last, we give the proof of Theorem 1.5
Proof of Theorem 1.5. (1). This is an immediate consequence of part (3) of Proposition 4.1
(2). Let $\left(p_{1}, p_{2}\right) \in M_{1} \times M_{2}$. By part (2) of Proposition 4.1, we have

$$
R\left(p_{1}, p_{2}\right)=c\left(p_{1}, p_{2}\right) I_{n_{1}} \oplus I_{n_{2}}
$$

Fixing $p_{1}$ while letting $p_{2}$ vary in $M_{2}$ shows that $c\left(p_{1}, p_{2}\right)$ is independent of $p_{2}$. Similarly, $c\left(p_{1}, p_{2}\right)$ is also independent of $p_{1}$. This shows that both factors have constant sectional curvature $c \geq 0$.

If $M$ is further assumed to be complete, then $M$ is either flat or isometric to $\mathbb{S}^{n_{1}} \times \mathbb{S}^{n_{2}}$, up to scaling.
(3). Similar to the proof of (2).

Proof of Theorem 1.6. Suppose that $\left(M^{n}, g\right)$ splits locally near $q \in M$ as a Riemannian product $\left(M_{1}^{k} \times M_{2}^{n-k}, g_{1} \oplus g_{2}\right)$ with $1 \leq k \leq n / 2$. Then the Riemann curvature tensor $R$ of $M$ satisfies $R=R_{1} \oplus R_{2}$ near $q$, where $R_{i}$ denotes the Riemann curvature tensor of $M_{i}$ for $i=1,2$.

By part (3) of Proposition 3.1 if $k=1$ and part (3) of Proposition 4.1 if $2 \leq$ $k \leq n / 2$, the assumption

$$
\alpha<k(n-k)+\frac{2 k(n-k)}{n}
$$

implies that $M$ must be flat.

## 5. Holonomy Restriction

We prove Theorem 1.3 in this section.
Proof of Theorem 1.3. Suppose that $\left(M^{n}, g\right)$ splits locally near $q \in M$ as a Riemannian product $\left(M_{1}^{k} \times M_{2}^{n-k}, g_{1} \oplus g_{2}\right)$ with $2 \leq k \leq n / 2$. Then the Riemann curvature tensor $R$ of $M$ satisfies $R=R_{1} \oplus R_{2}$ near $q$, where $R_{i}$ denotes the Riemann curvature tensor of $M_{i}$ for $i=1,2$.

Noticing that

$$
\alpha<n+\frac{n-2}{n} \leq A_{k, n-k}=k(n-k)+\frac{2 k(n-k)}{n}
$$

for any $1 \leq k \leq n / 2$, we conclude from part (3) of Propositions 3.1 if $k=1$ and part (3) of Proposition 4.1 if $2 \leq k \leq n / 2$ that $M$ is locally flat. Since the restricted holonomy does not depend on $q \in M$, we conclude that $M$ is flat. Therefore, $M$ is either locally irreducible or flat.

If $n=3$, then the holonomy of $M$ must be $\mathrm{SO}(3)$ as $M$ is locally irreducible. So we may assume $n \geq 4$ below.

If $M$ is an irreducible locally symmetric space, then it is Einstein. Since

$$
\alpha<n+\frac{n-2}{n} \leq \frac{3 n}{2} \frac{n+2}{n+4}
$$

for any $n \geq 4$, we get from [NPWW22, Theorem B] that either $M$ is flat or the restricted holonomy of $M$ is $\mathrm{SO}(n)$.

So we may assume that $M$ is not locally symmetric with irreducible holonomy representation. Then the restricted holonomy of $M$ is contained in Berger's list of holonomy groups Ber55: $\mathrm{SO}(n), \mathrm{U}\left(\frac{n}{2}\right), \mathrm{SU}\left(\frac{n}{2}\right), \mathrm{Sp}\left(\frac{n}{4}\right) \operatorname{Sp}(1), \mathrm{Sp}\left(\frac{n}{4}\right), \mathrm{G}_{2}$ and $\mathrm{Spin}_{7}$. $M$ must have Ricci flat and thus flat if its restricted holonomy is $\operatorname{SU}\left(\frac{n}{2}\right), \operatorname{Sp}\left(\frac{n}{4}\right), \mathrm{G}_{2}$ or $\mathrm{Spin}_{7}$.

If the restricted holonomy of $M$ is $\operatorname{Sp}\left(\frac{n}{4}\right) \operatorname{Sp}(1)$, then $M$ is quaternion-Kähler and thus Einstein. In this case, either the restricted holonomy of $M$ is $\mathrm{SO}(n)$ or $M$ is flat by [NPWW22, Theorem B].

If the restricted holonomy of $M$ is $\mathrm{U}\left(\frac{n}{2}\right)$, then $M$ is Kähler. Noticing that $\alpha<n+\frac{n-2}{n} \leq \frac{3}{2}\left(\frac{n^{2}}{4}-1\right)$ for any $n \geq 4, M$ must be flat by LLi22a, Therorem 1.2].

Overall, either the restricted holonomy of $M$ is $\mathrm{SO}(n)$ or $M$ is flat.

## 6. KÄhler Manifolds

In this section, we prove Theorem 1.7. The proof shares the same idea as in the Section 4, but use the orthonormal basis of a complex Euclidean space constructed in Li22a based on $\mathbb{C P}^{m}$.

In the following, $B_{m_{1}, m_{2}}$ is the expression defined in (1.3) and $R_{\mathbb{C P}^{m}}$ denotes the Riemann curvature tensor of the complex projective space with constant holomorphic sectional curvature 4 . We establish the following proposition.

Proposition 6.1. For $i=1,2$, let $\left(V_{i}, g_{i}, J_{i}\right)$ be a complex Euclidean vector space of complex dimension $m_{i} \geq 1$. Let $R_{i} \in S_{B}^{2}\left(\Lambda^{2} V_{i}\right)$ and $R=R_{1} \oplus R_{2} \in S_{B}^{2}\left(\Lambda^{2}\left(V_{1} \times V_{2}\right)\right)$.
(1) Suppose that $R$ has $B_{m_{1}, m_{2}}$-nonnegative curvature operator of the second kind. Then $R=c\left(R_{\mathbb{C P}^{m_{1}}} \oplus R_{\mathbb{C P}^{m_{2}}}\right)$ for some $c \geq 0$.
(2) Suppose that $R$ has $B_{m_{1}, m_{2}}$-nonpositive curvature operator of the second kind. Then $R=c\left(R_{\mathbb{C P}^{m_{1}}} \oplus R_{\mathbb{C P}^{m_{2}}}\right)$ for some $c \leq 0$.
(3) Suppose that $R$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<B_{m_{1}, m_{2}}$, then $R$ is flat.

Proof. (1). Let $\left\{e_{1}, \cdots, e_{m_{1}}, J_{1} e_{1}, \cdots, J_{1} e_{m_{1}}\right\}$ be an orthonormal basis of ( $\left.V_{1}, g_{1}, J_{1}\right)$ and $\left\{e_{m_{1}+1}, \cdots, e_{m_{1}+m_{2}}, J_{2} e_{m_{1}+1}, \cdots, J_{2} e_{m_{1}+m_{2}}\right\}$ be an orthonormal basis of $\left(V_{2}, g_{2}, J_{2}\right)$.

As in Section 4, we have the orthogonal decomposition

$$
S_{0}^{2}\left(V_{1} \times V_{2}\right)=S_{0}^{2}\left(V_{1}\right) \oplus S_{0}^{2}\left(V_{2}\right) \oplus \operatorname{span}\left\{u \odot v: u \in V_{1}, v \in V_{2}\right\} \oplus \mathbb{R} \zeta
$$

where

$$
\zeta=\frac{1}{\sqrt{2 m_{1} m_{2}\left(m_{1}+m_{2}\right)}}\left(m_{2} g_{1}-m_{1} g_{2}\right)
$$

The same computation as in Section 4 gives that

$$
\begin{equation*}
\stackrel{\circ}{R}(\zeta, \zeta)=-\frac{m_{2}^{2} S_{1}+m_{1}^{2} S_{2}}{2 m_{1} m_{2}\left(m_{1}+m_{2}\right)} \tag{6.1}
\end{equation*}
$$

where $S_{i}$ denotes the scalar curvature of $R_{i}$ for $i=1,2$.
By Lemma 2.1, the subspace $\operatorname{span}\left\{u \odot v: u \in V_{1}, v \in V_{2}\right\}$ lies in the kernel of $\stackrel{\circ}{R}$ and its real dimension is $4 m_{1} m_{2}$.

For $S_{0}^{2}\left(V_{1}\right)$ and $S_{0}^{2}\left(V_{2}\right)$, we use the orthonormal bases constructed in Section 4 of Li22a. More precisely, the following traceless symmetric two-tensors form an
orthonormal basis of $S_{0}^{2}\left(V_{1}\right)$ :

$$
\begin{aligned}
\varphi_{i j}^{1, \pm}= & \frac{1}{2}\left(e_{i} \odot e_{j} \mp J_{1} e_{i} \odot J_{1} e_{j}\right), \text { for } 1 \leq i<j \leq m_{1}, \\
\psi_{i j}^{1, \pm}= & \frac{1}{2}\left(e_{i} \odot J_{1} e_{j} \pm J_{1} e_{i} \odot e_{j}\right), \text { for } 1 \leq i<j \leq m_{1}, \\
\alpha_{i}^{1}= & \frac{1}{2 \sqrt{2}}\left(e_{i} \odot e_{i}-J_{1} e_{i} \odot J e_{i}\right), \text { for } 1 \leq i \leq m_{1}, \\
\alpha_{m_{1}+i}^{1}= & \frac{1}{\sqrt{2}}\left(e_{i} \odot J_{1} e_{i}\right), \text { for } 1 \leq i \leq m_{1}, \\
\eta_{k}^{1}= & \frac{k}{\sqrt{8 k(k+1)}}\left(e_{k+1} \odot e_{k+1}+J_{1} e_{k+1} \odot J_{1} e_{k+1}\right) \\
& -\frac{1}{\sqrt{8 k(k+1)}} \sum_{i=1}^{k}\left(e_{i} \odot e_{i}+J_{1} e_{i} \odot J_{1} e_{i}\right), \\
& \text { for } 1 \leq k \leq m_{1}-1
\end{aligned}
$$

Similarly, the traceless symmetric two-tensors

$$
\begin{aligned}
\varphi_{i j}^{2, \pm}= & \frac{1}{2}\left(e_{i} \odot e_{j} \mp J_{2} e_{i} \odot J_{2} e_{j}\right), \text { for } m_{1}+1 \leq i<j \leq m_{1}+m_{2}, \\
\psi_{i j}^{2, \pm}= & \frac{1}{2}\left(e_{i} \odot J_{2} e_{j} \pm J_{2} e_{i} \odot e_{j}\right), \text { for } m_{1}+1 \leq i<j \leq m_{1}+m_{2}, \\
\alpha_{i}^{2}= & \frac{1}{2 \sqrt{2}}\left(e_{i} \odot e_{i}-J_{1} e_{i} \odot J e_{i}\right), \text { for } m_{1}+1 \leq i \leq m_{1}+m_{2}, \\
\alpha_{m_{2}+i}^{2}= & \frac{1}{\sqrt{2}}\left(e_{i} \odot J_{1} e_{i}\right), \text { for } m_{1}+1 \leq i \leq m_{1}+m_{2}, \\
\eta_{k}^{2}= & \frac{k}{\sqrt{8 k(k+1)}}\left(e_{k+1} \odot e_{k+1}+J_{2} e_{k+1} \odot J_{2} e_{k+1}\right) \\
& -\frac{1}{\sqrt{8 k(k+1)}} \sum_{i=1}^{k}\left(e_{i} \odot e_{i}+J_{2} e_{i} \odot J_{2} e_{i}\right), \\
& \text { for } m_{1}+1 \leq k \leq m_{1}+m_{2}-1,
\end{aligned}
$$

form an orthonormal basis for $S_{0}^{2}\left(V_{2}\right)$. Here the superscripts 1 and 2 indicate that these are quantities associated to the space $V_{1}$ and $V_{2}$, respectively.

By Lemma 4.3 in Li22a, we have

$$
\begin{align*}
& \sum_{1 \leq i<j \leq m_{1}}\left(\stackrel{\circ}{R}\left(\varphi_{i j}^{1,-}, \varphi_{i j}^{1,-}\right)+\stackrel{\circ}{R}\left(\psi_{i j}^{1,-}, \psi_{i j}^{1,-}\right)\right)+\sum_{k=1}^{m_{1}-1} \stackrel{\circ}{R}\left(\eta_{k}, \eta_{k}\right)  \tag{6.2}\\
= & -\frac{m_{1}-1}{2 m_{1}} S_{1}
\end{align*}
$$

and

$$
\begin{align*}
& \sum_{m_{1}+1 \leq i<j \leq m_{1}+m_{2}}\left(\stackrel{\circ}{R}\left(\varphi_{i j}^{2,-}, \varphi_{i j}^{2,-}\right)+\stackrel{\circ}{R}\left(\psi_{i j}^{2,-}, \psi_{i j}^{2,-}\right)\right)+\sum_{k=m_{1}+1}^{m_{1}+m_{2}-1} \stackrel{\circ}{R}\left(\eta_{k}, \eta_{k}\right)  \tag{6.3}\\
= & -\frac{m_{2}-1}{2 m_{2}} S_{2} .
\end{align*}
$$

Combining (6.1), (6.2) and (6.3) together yields

$$
\begin{aligned}
& \sum_{1 \leq i<j \leq m_{1}}\left(\stackrel{\circ}{R}\left(\varphi_{i j}^{1,-}, \varphi_{i j}^{1,-}\right)+\stackrel{\circ}{R}\left(\psi_{i j}^{1,-}, \psi_{i j}^{1,-}\right)\right) \\
+ & \sum_{m_{1}+1 \leq i<j \leq m_{1}+m_{2}}\left(\stackrel{\circ}{R}\left(\varphi_{i j}^{2,-}, \varphi_{i j}^{2,-}\right)+\stackrel{\circ}{R}\left(\psi_{i j}^{2,-}, \psi_{i j}^{2,-}\right)\right) \\
& +\sum_{k=1}^{m_{1}-1} \stackrel{\circ}{R}\left(\eta_{k}, \eta_{k}\right)+\sum_{k=m_{1}+1}^{m_{1}+m_{2}-1} \stackrel{\circ}{R}\left(\eta_{k}, \eta_{k}\right)+\stackrel{\circ}{R}(\zeta, \zeta) \\
= & -\frac{m_{1}-1}{2 m_{1}} S_{1}-\frac{m_{2}-1}{2 m_{2}} S_{2}+\stackrel{\circ}{R}(\zeta, \zeta) \\
= & -\frac{1}{2}\left(m_{1}^{2}-1\right) \bar{a}-\frac{1}{2}\left(m_{2}^{2}-1\right) \bar{b}-\frac{m_{2}^{2} S_{1}+m_{1}^{2} S_{2}}{2 m_{1} m_{2}\left(m_{1}+m_{2}\right)} \\
= & -B_{1} \bar{a}-B_{2} \bar{b},
\end{aligned}
$$

where we have introduced

$$
B_{1}=\frac{1}{2}\left(m_{1}^{2}-1\right)+\frac{\left(m_{1}+1\right) m_{2}}{2\left(m_{1}+m_{2}\right)} \text { and } B_{2}=\frac{1}{2}\left(m_{2}^{2}-1\right)+\frac{\left(m_{2}+1\right) m_{1}}{2\left(m_{1}+m_{2}\right)}
$$

for simplicity of notations. Note that $-B_{1} \bar{a}-B_{2} \bar{b}$ is the sum of

$$
1+4 m_{1} m_{2}+\left(m_{1}^{2}-1\right)+\left(m_{2}^{2}-1\right)
$$

-many diagonal elements of the matrix representation of $\stackrel{\circ}{R}$ with respect to the orthonormal basis of $S_{0}^{2}\left(V_{1} \times V_{2}\right)$ constructed above (here one can pick any orthonormal basis for the subspace $\operatorname{span}\left\{u \odot v: u \in V_{1}, v \in V_{2}\right\}$ as it is in the kernel of $\stackrel{\circ}{R}$ ).

Let $A$ be the collection of the values $\stackrel{\circ}{R}\left(\alpha_{i}^{1}, \alpha_{i}^{1}\right)$ for $1 \leq i \leq 2 m_{1}, \stackrel{\circ}{R}\left(\varphi_{i j}^{1,+}, \varphi_{i j}^{1,+}\right)$ and $\stackrel{\circ}{R}\left(\psi_{i j}^{1,+}, \psi_{i j}^{1,+}\right)$ for $1 \leq i<j \leq m$. By Lemma 4.3 in [Li22a, we know that $A$ contains two copies of $R\left(e_{i}, J_{1} e_{i}, e_{i}, J_{1} e_{i}\right)$ for each $1 \leq i \leq m_{1}$ and two copies of $2 R\left(e_{i}, J_{1} e_{i}, e_{j}, J_{2} e_{j}\right)$ for each $1 \leq i<j \leq m_{1}$. Therefore, the sum of all values in $A$ is equal to $S_{1}$, the scalar curvature of $R_{1}$, and $\bar{a}$, the average of all values in $A$, is given by

$$
\bar{a}=\frac{S_{1}}{m_{1}\left(m_{1}+1\right)} .
$$

Similarly, let $B$ be the collection of the values $\stackrel{\circ}{R}\left(\alpha_{i}^{2}, \alpha_{i}^{2}\right)$ for $m_{1}+1 \leq i \leq$ $m_{1}+2 m_{2}, \stackrel{\circ}{R}\left(\varphi_{i j}^{2,+}, \varphi_{i j}^{2,+}\right)$ and $\stackrel{\circ}{R}\left(\psi_{i j}^{2,+}, \psi_{i j}^{2,+}\right)$ for $m_{1}+1 \leq i<j \leq m_{1}+m_{2}$. By Lemma 4.3 in Li22a, we know that $B$ contains two copies of $R\left(e_{i}, J_{2} e_{i}, e_{i}, J_{2} e_{i}\right)$ for each $m_{1}+1 \leq i \leq m_{1}+m_{2}$ and two copies of $2 R\left(e_{i}, J_{2} e_{i}, e_{j}, J_{2} e_{j}\right)$ for each $m_{1}+1 \leq i<j \leq m_{1}+m_{2}$. Therefore, the sum of all values in $B$ is equal to $S_{2}$, the scalar curvature of $R_{2}$, and $\bar{b}$, the average of all values in $B$, is given by

$$
\bar{b}=\frac{S_{2}}{m_{2}\left(m_{2}+1\right)} .
$$

Noticing that

$$
B_{m_{1}, m_{2}}=1+\left(m_{1}^{2}-1\right)+\left(m_{2}^{2}-1\right)+4 m_{1} m_{2}+B_{1}+B_{2}
$$

the assumption $R$ has $B_{m_{1}, m_{2}}$-nonnegative curvature operator of the second kind implies that

$$
\begin{align*}
B_{1} \bar{a}+B_{2} \bar{b} & \leq f\left(A,\left\lfloor B_{1}\right\rfloor\right)+f\left(B, B_{1}+B_{2}-\left\lfloor B_{1}\right\rfloor\right)  \tag{6.4}\\
& \leq\left\lfloor B_{1}\right\rfloor \bar{a}+\left(B_{1}+B_{2}-\left\lfloor B_{1}\right\rfloor\right) \bar{b} \\
& =B_{1} \bar{a}+B_{2} \bar{b}+\left(B_{1}-\left\lfloor B_{1}\right\rfloor\right)(\bar{b}-\bar{a})
\end{align*}
$$

and

$$
\begin{align*}
B_{1} \bar{a}+B_{2} \bar{b} & \leq f\left(A, B_{1}+B_{2}-\left\lfloor B_{2}\right\rfloor\right)+f\left(B,\left\lfloor B_{2}\right\rfloor\right)  \tag{6.5}\\
& \leq\left(B_{1}+B_{2}-\left\lfloor B_{2}\right\rfloor\right) \bar{a}+\left\lfloor B_{2}\right\rfloor \bar{b} \\
& =B_{1} \bar{a}+B_{2} \bar{b}+\left(B_{2}-\left\lfloor B_{2}\right\rfloor\right)(\bar{a}-\bar{b})
\end{align*}
$$

where $f$ is the function defined in Lemma 4.1 and we have used Lemma 4.1 to estimate $f$. So we get from (6.4) if $\bar{a} \geq \bar{b}$ and from (6.5) if $\bar{a} \leq \bar{b}$ that

$$
B_{1} \bar{a}+B_{2} \bar{b} \leq B_{1} \bar{a}+B_{2} \bar{b}
$$

Therefore, either in (6.4) or (6.5), we must have equalities in the inequalities used for $f$. By Lemma 4.1, we get that all the values in $A$ are equal to $\bar{a}$ and all the values in $B$ are equal to $\bar{b}$. Hence, both $R_{1}$ and $R_{2}$ have constant holomorphic sectional curvature, that is to say, $R=c_{1} R_{\mathbb{C P}^{m_{1}}} \oplus c_{2} R_{\mathbb{C P} m_{2}}$ for $c_{1}, c_{2} \in \mathbb{R}$.

Finally, we must have $c_{1}=c_{2} \geq 0$, as $R=c_{1} R_{\mathbb{C P}^{m_{1}}} \oplus c_{2} R_{\mathbb{C P}^{m_{2}}}$ has $B_{m_{1}, m_{2}}-$ nonnegative curvature operator of the second kind if and only if $c_{1}=c_{2} \geq 0$ by Proposition 2.2
(2). Apply (1) to $-R$.
(3). This follows from the fact that $R=c\left(R_{\mathbb{C P} m_{1}} \oplus R_{\mathbb{C P} m_{2}}\right)$ has $\alpha$-nonnegative or $\alpha$-nonpositive curvature operator of the second kind for some $\alpha<B_{m_{1}, m_{2}}$ if and only if $c=0$.

Proof of Theorem 1.7. Once we have Proposition6.1, this is similar to the proof of Theorem 1.5 .
