# Distribution of a second-class particle's position in the two-species ASEP with a special initial configuration

#### Abstract

In this paper, we consider the two-species asymmetric simple exclusion process (ASEP) consisting of $N-1$ first-class particles and one second-class particle. We assume that all particles are located at arbitrary positions but the second-class particle is the rightmost particle at time $t=0$. We find the exact formula of the distribution of the second-class particle's position at time $t$ by directly using the transition probabilities of the twospecies ASEP, which is a different approach from the coupling method Tracy and Widom used in [21].


## 1 Introduction

The multi-species asymmetric simple exclusion process is a generalization of the asymmetric simple exclusion process (ASEP) in the sense that each particle may belong to a different species. In principle, particles follow the rules of the ASEP, that is, a particle tries to jump to the right with probability $p$ or to the left with probability $q=1-p$ after exponential

[^0]waiting time with parameter 1. But a particle belonging to a higher species is given priority when it tries to jump to a site already occupied by a lower species. To be more specific, let us denote a species by an integer $l$. If a particle belonging to a species $l$ tries to jump to a site already occupied by a particle belonging to $l^{\prime}<l$, then the particle belonging to $l$ can jump by interchanging its position with the position of the particle belonging to $l^{\prime}$. However, if it tries to jump to a site occupied by a particle $l^{\prime \prime} \geq l$, the jump is not allowed. In the two-species ASEP, it is common that a lower species particle is called a second-class particle and a higher species particle is called a first-class particle.

The multi-species ASEP is mainly being considered on the one-dimensional finite integer lattice or infinite lattice $\mathbb{Z}$. Some featured results about the multi-species ASEP on a finite integer lattice are found in $[1,5,6,6,8,19]$ where the steady state of the process is one of the main interests. In the multi-species ASEP on $\mathbb{Z}$, the exact formulas of the transition probability and some probability distributions were studied in [4, 10, 11, 13, 16, 21, 22]. Also, the twospecies with a special initial configuration, called the step initial condition, has drawn an attention in studying a partial differential equation as the hydrodynamic limit of the onedimensional ASEP [7, 17], the competition interface in the last-passage percolation [9] and some asymptotics in the realm of the KPZ statistics [18]. Moreover, the multi-species ASEP was recently studied in more general context, the coloured stochastic vertex model [2, 3].

In this paper, we consider the two-species ASEP. The main purpose of this paper is to provide the exact formula of the probability distribution of the second-class particle's position at time $t$ for an $N$-particle system with $(N-1)$ first-class particles and one second-class particle. The initial configuration of our interest is that the second-class particle is the rightmost particle and the positions of the particles are arbitrarily fixed. In fact, Tracy and Widom have already found the probability distribution of the second-class particle's position at time $t$ for an infinite system with all positive sites occupied by first-class particles and the origin occupied by a second-class particle and all negative sites unoccupied at $t=0$ [21]. The method Tracy and Widom used is the coupling method for two (single-species) ASEPs with a single discrepancy in their initial configurations where the discrepancy can be viewed as the second-class particle. But the coupling method in [21, Section 2] is for a system with only one second-class particle, and it is not clear if the coupling method in Tracy and Widom's work can be extended to a system with multiple second-class particles. In this paper, we provide a different method for the probability distribution of the second-class particle's position. Our approach is to use the transition probabilities of the two-species ASEP. Since the transition probabilities of the two-species ASEP are fully known [15], it should be possible to find the probability distribution of a second-class particle's position even when there are multiple second-class particles initially. The method using the transition probabilities of the twospecies ASEP is straightforward in the sense that the required probability is obtained by summing the transition probabilities over all possible configurations but a huge computation is needed for a large system or the proof for a general $N$-particle system. One contribution
of this paper is to provide a method for the huge computation although we focus on the system with one second-class particle. It remains to be seen how much useful this method is for multiple second-class particle cases, but in the authors' another ongoing work, we could successfully obtain the exact formula of the probability distribution of the leftmost secondclass particle's position in a small system (with one first-class particle and three second-class particles) by using some techniques in this paper. Also, since we assume that the positions of the particles are arbitrarily fixed initially (but the second-class particle is the rightmost particle) in this paper, we expect that our formula can be used for a different special initial condition such as flat initial condition.

To overview our approach and state the main result, let us denote a state of the process by $(X, \nu)$ where $X=\left(x_{1}, \ldots, x_{N}\right)$ with $x_{1}<\cdots<x_{N}$ represents the positions of $N$ particles, and $\nu$ is a permutation of the multi-set $[1,2, \ldots, 2]$ with cardinality $N$, representing the order of particles. (A permutation of a multi-set is an ordered arrangement of all elements of the multi-set. Thus, the multi-set $[1,2, \ldots, 2]$ with cardinality $N$ has $N$ permutations.) Here, " 1 " represents a particle belonging to species 1 (a second-class particle) and " 2 " represents a particle belonging to species 2 (a first-class particle). Let us denote by $\nu(n)$ the $n$th number in the permutation $\nu$ and denote by $\nu_{n}$ the permutation $\nu$ with $\nu(n)=1$. The probability that the process is at state $(X, \pi)$ at time $t$ given that the initial configuration is $(Y, \nu)$ is denoted by $P_{(Y, \nu)}(X, \pi ; t)$. For simplicity of notations, we write $P_{\left(Y, \nu_{N}\right)}\left(X, \nu_{n} ; t\right)=P_{Y}\left(X, \nu_{n} ; t\right)$ because, in this paper, we will consider only $\nu_{N}$ for the initial order of particles. One of the authors of this paper found the transition probabilities of the $N$-particle multi-species ASEP with arbitrary combination of species [15]. In particular, the transition probabilities of interest in this paper are given by

where $c$ is a counterclockwise circle centered at the origin with sufficiently small radius $r$ and $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$ is in the form of

where the product is taken over all inversions $(\beta, \alpha)$ in $\sigma$ and $R_{\beta \alpha}$ is one of

or zero [15, 16]. How to choose $R_{\beta \alpha}$ from $S_{\beta \alpha}, p T_{\beta \alpha}, Q_{\beta \alpha}, 0$ for each inversion ( $\beta, \alpha$ ) depends on $\sigma$ and $\nu_{n}$. See Appendix A for the details on $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$ or directly see Theorem 1.2 (a), Theorem 1.4, Theorem 1.6, Theorem 1.7, and Proposition 1.8 in [16] for the explicit formulas of $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$. Here, $\sum_{\sigma \epsilon \mathcal{S}_{N}}$ implies the sum over all permutations of the symmetric
group $\mathcal{S}_{N}$ and $f$ implies $(1 / 2 \pi i) \int$ throughout this paper. We recall that, in the case of the single-species ASEP, the formula of the transition probabilities,

was obtained by Tracy and Widom [20].

### 1.1 Main results

Let us denote by $\mathbb{P}$ the probability measure of the process with the initial state ( $Y, \nu_{N}$ ) and let $\eta(t)$ be the random variable of the position of the second-class particle at time $t$. Then, it is obvious that

It is not hard to compute (4) for a small system such as $N=2$, but even for $N=3,4$, it requires a tedious and long computation together with contour deformations. Moreover, it is not easy to even conjecture the formula for general $N$ from the results for $N=2,3,4$. One contribution of this paper is to provide a novel idea to evaluate the sum (4) to enable us to prove the formula for general $N$. We introduce some notations that will be used throughout the paper.

### 1.1.1 Notations

We write $\mathcal{S}_{U}$ for the set of all permutations on a finite set $U$. If $U=\{1, \ldots, n\}$, we simply write $\mathcal{S}_{U}=\mathcal{S}_{n}$. For a set $U=\left\{u_{1}, \ldots, u_{n}\right\}$ of positive integers with $u_{1}<\cdots<u_{n}$, we write $\boldsymbol{\xi}_{U}=$ $\left(\xi_{u_{1}}, \ldots, \xi_{u_{n}}\right) \in \mathbb{C}^{n}$ and $Y_{U}=\left(y_{u_{1}}, \ldots, y_{u_{n}}\right)$, an ordered $n$-tuple of integers with $y_{u_{1}}<\cdots<y_{u_{n}}$. If $U=\{1, \ldots, N\}$ where $N$ is the total number of particles in the system, then we simply write $\boldsymbol{\xi}_{U}=\boldsymbol{\xi}$ and $Y_{U}=Y$. For a nonempty finite set of positive integers $U$, define $g_{U}: U \rightarrow \mathbb{Z}$ by $g_{U}(u)=i$ where $i$ implies that $u$ is the $i$ th smallest number in $U$. For a nonempty subset $S$ of $U$, we define

and $\Sigma_{U}(\varnothing):=0$. For example, if $U=\{2,4,7\}$, then $g_{U}(2)=1, g_{U}(4)=2, g_{U}(7)=3$, and for $S=\{2,7\} \subset U$,

If $U=\{1, \ldots, n\}$ for a given positive integer $n$, then we write $\Sigma_{U}(S)=\Sigma(S)$ for simplicity, which implies the sum of all elements in $S$. For $U=\left\{u_{1}, \ldots, u_{n}\right\}$, let

### 1.1.2 Statements of results

Theorem 1.1. If the initial configuration is $(Y, 2 \cdots 21)$, then the probability distribution of the second-class particle's position at time $t$, denoted by $\eta(t)$, is

where $S^{c}=\{1, \ldots, N\} \backslash S$ and $T_{\beta \alpha}$ is given in (2).
The formula (11) in [21] by Tracy and Widom for an infinite system with step initial condition was given by the contour integrals with large contours. On the other hand, our formula (5) which is for a finite system is given by the contour integrals with small contours. We did not try to rediscover Tracy and Widom's formula from our result but we believe that it is possible. Also, to the best of authors' knowledge, the probability distribution of the secondclass particle for flat initial condition has not been obtained. It would be interesting to see
if our formula can be used to find a formula for flat initial condition (see [12] for some exact formulas in the single-species ASEP with flat initial condition).
A simple but interesting result can be obtained in the limit $p \rightarrow \frac{1}{2}$.
Corollary 1.2. In the two-species symmetric exclusion process

Note that $y_{N}$ in (77) is the initial position of the second-class particle. It is interesting that the formula (7) is the same as the probability distribution of the continuous-time symmetric random walk on $\mathbb{Z}$ when the random walk's initial position is $y_{N}$. Hence, roughly speaking, our result implies that the second-class particle behaves like the symmetric random walk although it is affected by the first-class particles.

### 1.2 Organization of the paper

In Section 2, we provide some lemmas for the proof of Theorem 1.1. In Section 3, we find the exact formula of the probability distribution for a small system with $N=3$. Section 3 will serve as a warmup for proving the general formula for $N$-particle system. The main idea of the proof for the general formula in Section 4 is based on the techniques in Section 3. Finally, we prove our main result, Theorem 1.1, in Section 4.

## 2 Lemmas

In this section, we provide some results which will be used for the proof of our main theorem. First, Lemma 2.1 is a part of the proof of Lemma 3.1 in [20] and is used to prove Lemma 2.2 .

Lemma 2.1. [20] Suppose that $f\left(\xi_{1}, \ldots, \xi_{n}\right)$ is analytic for all $\xi_{i} \neq 0$ and that for $i>k$,

as $\xi_{k} \rightarrow 0$, uniformly when all $\xi_{j}$ with $j \neq k$ are bounded and bounded away from zero. Then,

then $f\left(\xi_{1}, \ldots, \xi_{n}\right)$ satisfies the hypothesis of Lemma 2.1. (See Proof of Theorem 3.2 in [20].) Now, we provide Lemma 2.2 which will be used to prove Lemma 2.3.

Lemma 2.2. Let $U=\left\{u_{1}, \ldots, u_{n}\right\} \subset\{1,2, \ldots\}$ for $n \geq 2, T_{\beta \alpha}$ be given in (22), $A_{\sigma}$ with a permutation $\sigma$ on $U$ be given by (3), and

is true for $n .\left(\sum_{S \subset U}\right.$ implies the sum over all nonempty subsets $S \subset U$.)
Proof. We will prove for the case of $U=\{1, \ldots, n\}$ without loss of generality. Let us write the left-hand side of (10) as

Note that any nonempty subset of $\{1, \ldots, n\}$ is a nonempty subset $S^{\prime}$ of $\{1, \ldots, n-1\}$ or $S^{\prime} \cup\{n\}$ or $\{n\}$. Let us consider a pair of integral terms for a set $\varnothing \neq S^{\prime}=\left\{s_{1}, \ldots, s_{r}\right\} \subset$ $\{1, \ldots, n-1\}$ and $S=S^{\prime} \cup\{n\}$ in (12):

In (13), if we enlarge the contour $c$ for the variable $\xi_{n}$ to a sufficiently large circle $C$ for the convergence of the sum over $z_{n}$, then we encounter a pole at $\xi_{n}=1$ that comes from $I\left(\boldsymbol{\xi}_{S}\right)$ and poles $\xi_{n}=\left(\xi_{\alpha}-p\right) / q \xi_{\alpha}$ that come from $T_{n \alpha}$. By Lemma 2.1, the residue at $\xi_{n}=\left(\xi_{\alpha}-p\right) / q \xi_{\alpha}$ is zero when integrated over $\xi_{\alpha}$. Hence, (13) equals

& \sum_{z_{n}=1}^{\infty} c_{S} f_{c} \cdots f_{a} f_{C}\left(\prod_{\substack{\alpha<\beta, \alpha, \beta \in S}} T_{\beta \alpha}\right) I\left(\boldsymbol{\xi}_{S}\right) W_{t, x, Y_{S}}\left(\boldsymbol{\xi}_{S}\right)\left(\xi_{s_{1}} \cdots \xi_{s_{r}} \xi_{n}\right)^{-z_{n}} d \boldsymbol{\xi}_{S}  \tag{15}\\
& \quad-\sum_{z_{n}=1}^{\infty} c_{S^{\prime}} f_{c} \cdots f_{c}\left(\prod_{\substack{\alpha<\beta, \alpha, \beta \in S^{\prime}}} T_{\beta \alpha}\right) I\left(\boldsymbol{\xi}_{S^{\prime}}\right) W_{t, x, Y_{S^{\prime}}}\left(\boldsymbol{\xi}_{S^{\prime}}\right)\left(\xi_{s_{1}} \cdots \xi_{s_{r}}\right)^{-z_{n}} d \boldsymbol{\xi}_{S^{\prime}}
\end{align*}

where $c_{S^{\prime}}$ is due to the facts that

We note that the second term in (15) can cancel with (14). Evaluating the first sum in (15) and then shrinking $C$ back to $c$, we obtain the sum of (13) and (14) equal to

Finally, the sum of the integral for $S=\{n\}$ over $z_{n}$ in (12) is

Remark 2.1. Recall that $W_{t, x, Y_{U}}\left(\boldsymbol{\xi}_{U}\right)$ is analytic for each variable $\xi_{u_{i}}$ except at the origin. If $W_{t, x, Y_{U}}\left(\boldsymbol{\xi}_{U}\right)$ and $W_{t, x, Y_{S}}\left(\boldsymbol{\xi}_{S}\right)$ are replaced with $f\left(\boldsymbol{\xi}_{U}\right)$ and $\left.f\left(\boldsymbol{\xi}_{U}\right)\right|_{\xi_{i}=1, i \notin S}$, respectively, for any analytic function $f\left(\boldsymbol{\xi}_{U}\right)$ for each variable $\xi_{u_{i}}$ inside a sufficiently large circle centered at the origin except at the origin, then the constant 1 on the right-hand side of (10) is replaced with $f(1, \ldots, 1)$. The proofs are almost the same.

For nonnegative integer $n$, we define

Proof. We will prove by mathematical induction for the case of $U=\{1, \ldots, n\}$ without loss of generality. When $n=2$, a simple manipulation of the contour (that is, enlarging and then shrinking back after summation) shows that

where the single variable integrals in (18) and (19) are the residues at $\xi_{1}=1$ and $\xi_{2}=1$, respectively, and the sum of (18) and (19) shows that (9) holds for $n=2$.

Suppose that (9) holds for $n-1$. Let us decompose $\sum_{\sigma \in \mathcal{S}_{n}}$ in the left-hand side of (9) as follows:

Note that $(\star)$ is analytic for each variable $\xi_{i} \neq \xi_{l}$ inside a sufficiently large circle centered at the origin except at the origin. Hence, by Remark 2.1 which supplements Lemma 2.2, (20) becomes

with $A=\{1, \ldots, n\} \backslash\{l\}$. If $\langle l\rangle$ is the number of elements in $A \backslash S^{\prime}$ larger than $l$,

in (21), and we note that $(q / p)^{n-l}=c_{S}$ when $S=\{l\}$. This completes the proof.

## 3 Formula for $N=3$

In this section, we find $\mathbb{P}(\eta(t)=x)$ for $N=3$. The methods used in the section are further generalized in the next section for general $N$-particle systems.

### 3.1 Decomposition of the transition probability

For $N=3$, it is straightforward that

where the matrix elements $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, 221}$ are given as in Table 1, which can be obtained by the formulas of $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$ in [16].

## 4 Proof of Theorem 1.1

K\left(A^{c}, S^{\prime}\right)= \begin{cases}\left(\prod_{\alpha, \beta \in S^{\prime}}^{\alpha<\beta}, T_{\beta \alpha}\right)\left(\prod_{\substack{\alpha<\beta, \beta \\ \alpha, \beta \in A^{c}}} T_{\beta \alpha}\right)\left(\prod_{\substack{\alpha<\beta \neq N \\ \beta \in S^{\prime}, \alpha \in A^{c}}} S_{\beta \alpha}\right)\left(\prod_{\alpha \in A^{c}} T_{N \alpha}\right) & \text { if } N \in S^{\prime}, \\ \left(\prod_{\substack{\alpha<\beta, \alpha, \beta \in S^{\prime}}} T_{\beta \alpha}\right)\left(\prod_{\substack{\alpha<\beta, A^{c} \\ \alpha, \beta \in A^{c}}} T_{\beta \alpha}\right)\left(\prod_{\substack{\alpha<\beta \neq N \\ \beta \in S^{\prime}, \alpha \in A^{c}}} S_{\beta \alpha}\right) & \text { if } N \notin S^{\prime}\end{cases}
$$

(iv) Step 4. Finally, we compute

$$
\begin{equation*}
\sum_{\substack{A \\|A|=n, N \in A}} \sum_{S^{\prime} \subset A} c_{A, S^{\prime}} f_{c} \cdots f_{c} K\left(A^{c}, S^{\prime}\right) I\left(\boldsymbol{\xi}_{S^{\prime} \cup A^{c}}\right) W_{t, x, Y_{S^{\prime} \cup A}}\left(\boldsymbol{\xi}_{S^{\prime} \cup A^{c}}\right) \boldsymbol{d} \boldsymbol{\xi}_{S^{\prime} \cup A^{c}} \tag{61}
\end{equation*}
$$

Note that if we let $S=S^{\prime} \cup A^{c}$, then $\Sigma\left(A \backslash S^{\prime}\right)=\Sigma\left(S^{c}\right)$ and $\left|A \backslash S^{\prime}\right|=\left|S^{c}\right|$. This implies that if a pair $\left(A, S^{\prime}\right)$ such that $N \in A \subset\{1, \ldots, N\}$ with $|A|=n$ and $S^{\prime} \subset A$, and another pair $\left(A^{\prime}, S^{\prime \prime}\right)$ such that $N \in A^{\prime} \subset\{1, \ldots, N\}$ with $\left|A^{\prime}\right|=n$ and $S^{\prime \prime} \subset A^{\prime}$ satisfy $S^{\prime} \cup A^{c}=S^{\prime \prime} \cup A^{\prime c}$, then $c_{A, S^{\prime}}=c_{A^{\prime}, S^{\prime \prime}}$. Hence, the sum (61) is equivalent to

$$
\begin{align*}
\sum_{\substack{S \\
|S| \ggg-n}} & \sum_{\left(S_{1}, S_{2}\right)} \hat{c}_{S} f_{c} \cdots f_{c} K\left(S_{2}, S_{1}\right) I\left(\boldsymbol{\xi}_{S}\right) W_{t, x, Y_{S}}\left(\boldsymbol{\xi}_{S}\right) \boldsymbol{d} \boldsymbol{\xi}_{S} \\
& +\sum_{\substack{S \\
|S i t h\\
| N-N-n, N \notin S}} \hat{c}_{S} f_{c} \cdots f_{c} K(S, \varnothing) I\left(\boldsymbol{\xi}_{S}\right) W_{t, x, Y_{S}}\left(\boldsymbol{\xi}_{S}\right) \boldsymbol{d} \boldsymbol{\xi}_{S} \tag{62}
\end{align*}
$$

where

$$
\hat{c}_{S}= \begin{cases}(-1)^{N-n} q^{n(n-1) / 2} p^{(N-n)(N-n+1) / 2} \frac{q^{\Sigma\left(S^{c}\right)-n\left|S^{c}\right|}}{p^{\Sigma\left(S^{c}\right)-\left|S^{c}\right| \mid\left(S^{c} \mid+1\right) / 2}} & \text { if } N \in S, \\ (-1)^{N-n} q^{n(n-1) / 2} p^{(N-n)(N-n-1) / 2} \frac{q^{\Sigma\left(S^{c}\right)-n\left|S^{c}\right|-(N-n)}}{p^{\Sigma\left(S^{c}\right)-\left|S^{c}\right| \mid\left(S^{C} \mid+1\right) / 2-(N-n)}} & \text { if } N \notin S\end{cases}
$$

and $\sum_{\left(S_{1}, S_{2}\right)}$ is the sum over all partitions of $S=S_{1} \cup S_{2}$ such that $\left|S_{2}\right|=N-n$ and $N \notin S_{2}$. By using Lemma 2.5,

$$
\sum_{\left(S_{1}, S_{2}\right)} K\left(S_{2}, S_{1}\right)= \begin{cases}{\left[\begin{array}{c}
|S|-1 \\
N-n
\end{array}\right] \prod_{\substack{\alpha<\beta \\
\alpha, \beta \in S}} T_{\beta \alpha}} & \text { if } N \in S, \\
{\left[\begin{array}{c}
|S| \\
N-n
\end{array}\right] \prod_{\substack{\alpha<\beta \\
\alpha, \beta \in S}} T_{\beta \alpha}} & \text { if } N \notin S\end{cases}
$$

and we note that

$$
K(S, \varnothing)=\prod_{\substack{\alpha<\beta, \alpha, \beta \in S}} T_{\beta \alpha}
$$

Hence, (62) implies (44).
(Continuing the proof of Theorem (1.1) Now, finally, we sum (44) over $n=1, \ldots, N$. Note that by the convention (17),

$$
\sum_{n=1}^{N} \tilde{c}_{S}=\left\{\begin{array}{cc}
\sum_{n=N-|S|+1}^{N} \tilde{c}_{S} & \text { if } N \in S \\
\sum_{n=N-|S|}^{N} \tilde{c}_{S} & \text { if } N \notin S
\end{array}\right.
$$

If $N \in S$, then

$$
\sum_{n=N-|S|+1}^{N} \tilde{c}_{S}=\left(\prod_{i=1}^{|S|-1}\left(q^{i}-p^{i}\right)\right)\left(\frac{q}{p}\right)^{\Sigma\left(S^{c}\right)-\left|S^{c}\right|\left(\left|S^{c}\right|+1\right) / 2}
$$

by Lemma 2.6 where $l-1$ is replaced by $|S|-1$ and $k$ is replaced by $N-n$. For the case of $N \notin S$, observe that

$$
\left(\frac{q}{p}\right)^{\Sigma\left(S^{c}\right)-\left|S^{c}\right|\left(\left|S^{c}\right|+1\right) / 2}=\left(\frac{q}{p}\right)^{|S|}\left(\frac{q}{p}\right)^{\Sigma\left(S^{c}\right)-\left|S^{c}\right| \mid\left(S^{c} \mid-1\right) / 2-N}
$$

and then apply Lemma 2.6 where $l-1$ is replaced by $|S|$ and $k$ is replaced by $N-n$. Then, we obtain

$$
\sum_{n=N-|S|}^{N} \tilde{c}_{S}=\frac{1}{p^{|S|}}\left(\prod_{i=1}^{|S|}\left(q^{i}-p^{i}\right)\right)\left(\frac{q}{p}\right)^{\Sigma\left(S^{c}\right)-\left|S^{c}\right|\left(\left|S^{c}\right|-1\right) / 2-N}
$$

Hence,

$$
c_{S}= \begin{cases}\left(\prod_{i=1}^{|S|-1}\left(q^{i}-p^{i}\right)\right)\left(\frac{q}{p}\right)^{\Sigma\left(S^{c}\right)-\left|S^{c}\right|\left(\left|S^{c}\right|+1\right) / 2} & \text { if } N \in S, \\ \frac{1}{p^{|S|}}\left(\prod_{i=1}^{|S|}\left(q^{i}-p^{i}\right)\right)\left(\frac{q}{p}\right)^{\Sigma\left(S^{c}\right)-\left|S^{c}\right|\left(\left|S^{c}\right|-1\right) / 2-N} & \text { if } N \notin S .\end{cases}
$$

This completes the proof of Theorem 1.1.

## Appendix A Formulas of $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$ in (1)

In this appendix, we briefly summarize how to find the formulas of $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$ in (1), which were developed in [15, 16]. For a permutation $\sigma$ in the symmetric group $\mathcal{S}_{N}, \mathbf{A}_{\sigma}$ is an $N^{N} \times N^{N}$ matrix which is obtained as follows. Let $\mathrm{T}_{i}$ be the simple transposition which interchanges the $i^{t h}$ element and the $(i+1)^{\text {st }}$ element and leaves everything else fixed. Then, any permutation $\sigma \in \mathcal{S}_{N}$ can be written as a product of simple transpositions, that is,

$$
\begin{equation*}
\sigma=\mathrm{T}_{i_{j}} \cdots \mathrm{~T}_{i_{1}} \tag{63}
\end{equation*}
$$

for some $i_{1}, \ldots, i_{j} \in\{1, \ldots, N-1\}$. Of course, the form of (63) is not unique. For example, a permutation $(321) \in \mathcal{S}_{3}$ is written as

$$
(321)=\mathrm{T}_{1} \mathrm{~T}_{2} \mathrm{~T}_{1}=\mathrm{T}_{2} \mathrm{~T}_{1} \mathrm{~T}_{2} .
$$

If $\mathrm{T}_{i}$ interchanges $\alpha$ at the $i^{\text {th }}$ slot and $\beta$ at the $(i+1)^{\text {st }}$ slot in a permutation, that is,

$$
\mathrm{T}_{i}(\cdots \alpha \beta \cdots)=(\cdots \beta \alpha \cdots),
$$

we denote this $\mathrm{T}_{i}$ by $\mathrm{T}_{i}(\beta, \alpha)$ to show explicitly which numbers are interchanged. For example,

$$
(321)=\mathrm{T}_{1}(3,2) \mathrm{T}_{2}(3,1) \mathrm{T}_{1}(2,1)
$$

Hence, we may have an expression

$$
\begin{equation*}
\sigma=\mathrm{T}_{i_{j}}\left(\beta_{j}, \alpha_{j}\right) \cdots \mathrm{T}_{i_{1}}\left(\beta_{1}, \alpha_{1}\right) \tag{64}
\end{equation*}
$$

for any permutation $\sigma$. Given $\mathrm{T}_{i}(\beta, \alpha)$, we define $N^{N} \times N^{N}$ matrix $\mathbf{T}_{i}(\beta, \alpha)$ by

$$
\mathbf{T}_{i}(\beta, \alpha)=\underbrace{\mathbf{I}_{N} \otimes \cdots \otimes \mathbf{I}_{N}}_{(i-1) \text { times }} \otimes \mathbf{R}_{\beta \alpha} \otimes \underbrace{\mathbf{I}_{N} \otimes \cdots \otimes \mathbf{I}_{N}}_{(N-i-1) \text { times }}
$$

where $\mathbf{I}_{N}$ is the $N \times N$ identity matrix and $\mathbf{R}_{\beta \alpha}$ is an $N^{2} \times N^{2}$ matrix, where $\mathbf{R}_{\beta \alpha}$ is defined as follows. Let us label all columns and rows of $N^{2} \times N^{2}$ matrices by $i j$ where $i, j=1, \ldots, N$ in the lexicographical order. The $(i j, k l)$ entry of the matrix $\mathbf{R}_{\beta \alpha}$ is defined to be

$$
\left[\mathbf{R}_{\beta \alpha}\right]_{i j, k l}= \begin{cases}S_{\beta \alpha} & \text { if } i j=k l \text { with } i=j ; \\ P_{\beta \alpha} & \text { if } i j=k l \text { with } i<j ; \\ Q_{\beta \alpha} & \text { if } i j=k l \text { with } i>j ; \\ p T_{\beta \alpha} & \text { if } i j=l k \text { with } i<j ; \\ q T_{\beta \alpha} & \text { if } i j=l k \text { with } i>j ; \\ 0 & \text { for all other cases }\end{cases}
$$

where

$$
\begin{array}{ll}
S_{\beta \alpha}=-\frac{p+q \xi_{\alpha} \xi_{\beta}-\xi_{\beta}}{p+q \xi_{\alpha} \xi_{\beta}-\xi_{\alpha}}, & P_{\beta \alpha}=\frac{\left(p-q \xi_{\alpha}\right)\left(\xi_{\beta}-1\right)}{p+q \xi_{\alpha} \xi_{\beta}-\xi_{\alpha}} \\
T_{\beta \alpha}=\frac{\xi_{\beta}-\xi_{\alpha}}{p+q \xi_{\alpha} \xi_{\beta}-\xi_{\alpha}}, & Q_{\beta \alpha}=\frac{\left(p-q \xi_{\beta}\right)\left(\xi_{\alpha}-1\right)}{p+q \xi_{\alpha} \xi_{\beta}-\xi_{\alpha}} .
\end{array}
$$

Now, for a given expression (64), define

$$
\begin{equation*}
\mathbf{A}_{\sigma}:=\mathbf{T}_{i_{j}}\left(\beta_{j}, \alpha_{j}\right) \cdots \mathbf{T}_{i_{1}}\left(\beta_{1}, \alpha_{1}\right) . \tag{65}
\end{equation*}
$$

It is a known fact that $\mathbf{A}_{\sigma}$ is well-defined in the sense that (65) represents the same matrix for any expression (64). We have just constructed an $N^{N} \times N^{N}$ matrix $\mathbf{A}_{\sigma}$ for a given permutation $\sigma$. Now, let us label all columns and rows of $\mathbf{A}_{\sigma}$ by $\nu=i_{1} \cdots i_{N}$ where $i_{j} \in$ $\{1, \ldots, N\}, j=1, \ldots, N$ in the lexicographical order. In this paper, we denote $2 \cdots 212 \cdots 2$ by $\nu_{n}$ if 1 is the $n^{\text {th }}$ leftmost number.

Since $\mathbf{A}_{\sigma}$ is a product of matrices, in general, the matrix elements $\left[\mathbf{A}_{\sigma}\right]_{\pi, \nu}$ are possibly written as a sum of the products of the matrix elements of $\mathbf{T}_{i_{j}}\left(\beta_{j}, \alpha_{j}\right), \ldots, \mathbf{T}_{i_{1}}\left(\beta_{1}, \alpha_{1}\right)$ in (65). However, it was shown in [16] that, for some special cases of initial order of particles $\nu$, $\left[\mathbf{A}_{\sigma}\right]_{\pi, \nu}$ are expressed as a product of the matrix elements of $\mathbf{T}_{i_{j}}\left(\beta_{j}, \alpha_{j}\right), \ldots, \mathbf{T}_{i_{1}}\left(\beta_{1}, \alpha_{1}\right)$, not a sum of the products. In particular, for the initial order of particles $\nu_{N}$, that is, $2 \cdots 21$, the formulas $\left[\mathbf{A}_{\sigma}\right]_{\nu_{n}, \nu_{N}}$ are given in Theorem 1.2 (a), Theorem 1.4, Theorem 1.6, Theorem 1.7, and Proposition 1.8 in [16].
