### Leptogenesis from composite singlets

#### Abstract

We argue that composite singlets accommodate thermal leptogenesis along with one right-handed neutrino. This framework suggests that the reheating temperature is as low as  $\mathcal{O}(10^5)$  GeV, and the quasi-degenerate neutrino masses are present at  $\mathcal{O}(0.01)$  eV.

The baryon asymmetry of the universe is an interesting topic in particle physics. According to the CMS report [1], the baryon abundance (denote  $\eta_B$ ) to that of photons (denoted  $\eta_{\gamma}$ ) is estimated as

$$\frac{\eta_B}{\eta_\gamma} \simeq 6 \times 10^{-10}.\tag{1}$$

Regarding the explanation for its origin, thermal leptogenesis provides an elegant mechanism in which the lepton number from the right-handed neutrino decay is fractionally converted into the baryon number via a sphaleron process [2–5]. The hypothesis, however, entails a high reheating temperature of  $T_{RH} \gtrsim 10^9$  GeV caused by the heavy right-handed neutrino(s), which encounters the gravitino overproduction under the circumstance of  $m_{3/2} \lesssim 1$  GeV.

In this letter, we demonstrate that the composite singlets, along with one right-handed neutrino, could make the leptogenesis most viable in the context of supersymmetry (SUSY), wherein we show that  $T_{RH}$  is rendered  $\mathcal{O}(10^5)$  GeV, and the quasi-degenerate neutrino masses are embodied at  $\mathcal{O}(0.01)$  eV, without invoking the grand unification theory (GUT) [6].

Explicit model based on SU(2) gauge group

Let us illustrate an explicit model within the SUSY framework. As displayed in Tables 1, we assume a SU(2) gauge group of  $N_F = 4$  and one gauge singlet that corresponds to the right-handed neutrino superfield. Additionally, we suppose that  $U(1)_R$  symmetry preserves up to the renormalizable interactions, which is broken down to the R-parity due to the Planck-suppressed couplings:

The most general superpotential consistent with the SU(2) and R symmetry is written as

where  $W_{RE}$ ,  $W_{NRE}$  denote the renormalizable and non-renormalizable interactions, respectively. Also,  $W_{RE}^{low}$ ,  $W_{NRE}^{low}$  are the superpotential couplings formed below the SU(2) dynamical scale (denoted  $\Lambda$ ).  $H_u, L_i (i = 1 - 3)$  are the up-type Higgs and the  $SU(2)_L$  lepton superfields in the minimal supersymmetry standard model (MSSM).

 $10^{18}$  GeV.  $\kappa_{13}, \lambda_{klmn}, h_{kmi}$  and  $y_i$  are the dimensionless coupling constants.

Diagonalizing the  $S^{km}$  mass matrix, we rewrite the relevant couplings in terms of the eigenstates (denoted  $S^A(A=1-4)$ ) as follows:

where  $h'_{Ai}$  denotes the coupling constant corresponding to  $h_{kmi}$ .

In what follows, we take  $r_A$  (A = 1 - 4) = 1/2in Eq.(6) for simplicity and use the notation of

Relevant Lagrangian density

After diagonalizing the fermion mass matrix obtained from Eqs.(4) and (5), the relevant Lagrangian density is approximately written in terms of the mass eigenstate:

 $M_{pl}$  stands for the reduced Planck scale of  $2.4 \times$  Each eigenstate is related to  $N, S^A$  through the Unitary matrix U:

Here,  $l_i$ ,  $H_u$  denote the lepton and the up-type Higgs boson, while  $L_i$ ,  $h_u$  are the slepton and the higgsino, respectively. Meanwhile, the scalar potential is written as

Here,  $\tilde{S}^A$ ,  $\tilde{N}$  denote the scalar component of  $S^A$ and N, respectively. Using the mass eigenstates, we approximately express the above interactions:

where  $\Phi_{1,2}$  denote the eigenstate. Each has the eigen mass of  $\sim M$ , which is roughly written as the linear combination:

On the other hand, we refer to the other eigenstates with lighter masses of  $m_{\phi_a}$  as  $\phi_a$ ; altogether, each eigenstate is expressed using the Unitary matrix

Generation of lepton number

## • From composite fermions

First, we evaluate the lepton asymmetry brought from the composite fermion decay. Each decay rate of  $\chi_a$  is given by

Noting that  $\psi_1, \psi_2$  or  $\Phi_1, \Phi_2$  serve as the internal line, we find that  $\chi_a$  decays, via the vertex correction and the wave function renormalization, yield the lepton number:

Here, we followed [3, 4] but with the factor 5/6entailed by our model [7].

#### • From composite bosons

Additionally, the composite boson decay comparably contributes to the generation of the lepton number. Let us derive the decay rate of  $\phi_a$ , and we thus obtain the lepton asymmetry [3,4]:

Similar to the previous case, our model leads to the appearance of the factor 1/3 in Eqs. (29) and (30) [7].

Baryon asymmetry and Neutrino mass

Let us evaluate the baryon asymmetry that emerges from the sphaleron process, taking account of the neutrino mass generated by the See-Saw mechanism [8]. Under the circumstance of  $K_i < 1$ , i.e. the weak washout regime, the final efficient factor is reduced to the following form, depending on  $T_{RH} < m_{\chi_a}$ ,  $m_{\phi_a}$  or  $T_{RH} > m_{\chi_a}$ ,  $m_{\phi_a}$ :

Here,  $K_i$  (the subscript i denotes the composite—the total baryon asymmetry [11]: fermion/boson) is conventionally defined as

where the former expression corresponds to the reheating stage, while the latter is for the usual radiation-dominated epoch [9].  $g_*(T)$  is the degree of freedom of radiative particles, and we used  $g_*\left(m_{\chi_a}\right)\simeq g_*\left(m_{\phi_a}\right)\simeq g_*\left(T_{RH}\right)=228.75.$  Choosing  $m_1\,=\,3.2\times10^5$  GeV,  $m_2\,=\,3.1\times10^5$  GeV,  $m_3 = 3.0 \times 10^5 \text{ GeV}, \ m_4 = 2.9 \times 10^5 \text{ GeV},$  $M=10^{10}~{\rm GeV}$  and  $\Lambda=2\times10^{12}~{\rm GeV}$  and setting  $h'_{1i} = -e^{i\alpha}, h'_{2i} = h'_{3i} = h'_{4i} = e^{i\alpha}$  ( $\alpha$ : pure phase), one derives the eigen mass [10]:

Besides, taking into consideration that the composite fermions have the eigen mass of  $m_{\chi_a}$  for  $\chi_a$  (a = 2 - 4) and  $\sim M$  for  $\psi_{1,2}$ , we estimate the neutrino mass:

where  $\mathcal{M}_F$  is the  $6 \times 6$  fermion mass matrix including  $l_i$  which follows from Eq.(9). Meanwhile,  $v_u$  denotes the VEV (vacuum expectation value) of the  $H_u$  boson. We then obtain the baryon asymmetry for  $|y_2| = 0.910$ ,  $|y_3| = 0.906$ :

$$m_{\nu 3} \simeq 7.23 \times 10^{-2} \left(\frac{v_u}{170 \text{ GeV}}\right)^2 \text{ eV}.$$

We note that this spectrum reproduces the experimental result [13]:

$$\Delta m_{21}^2 \simeq 2.44 \times 10^{-3} \text{ eV}^2,$$
  
 $\Delta m_{32}^2 \simeq 7.53 \times 10^{-5} \text{ eV}^2.$  (47)

Discussion and Conclusion

We showed that the composite singlets play a crucial role in implementing thermal leptogenesis at low reheating temperature. On theoretical grounds, our proposal is motivated by the observation that the composite SM quark or lepton would lead to the Planck-suppressed Yukawa coupling of the first (and the second) generation, so that u, d $quark/e^-$  lepton can be made much lighter than  $t, b \text{ quark}/\tau^-$  lepton [14]. Provided that the neutrino sector should possess the same structure, we constructed an explicit model that accommodates  $T_{RH} \simeq 3 \times 10^5 \text{ GeV}$  and the quasi-degenerate neutrino mass without any relation to the GUT breaking scale. Depending on the set of parameters, successful leptogenesis could be achieved even with a lower reheating temperature. For future research, supposing that the composite singlets originate from the dual theory such as the Intriligator-Seiberg-Shih model [15], our finding may be described within the direct-mediated SUSY breaking at metastable vacuum [16, 17].
