# Embedding theorems for quantizable pseudo-Kähler manifolds

#### Abstract

Given a compact quantizable pseudo-Kähler manifold ( $M, \omega$ ) of constant signature, there exists a Hermitian line bundle ( $L, h$ ) over $M$ with curvature $-2 \pi i \omega$. We shall show that the asymptotic expansion of the Bergman kernels for $L^{\otimes k}$-valued $(0, q)$-forms implies more or less immediately a number of analogues of well-known results, such as Kodaira embedding theorem and Tian's almost-isometry theorem.

## 1 Introduction

Given a compact symplectic manifold $(M, \omega)$ such that $[\omega] \in H^{2}(M, \mathbb{Z})$ we can define a Hermitian line bundle ( $L, h^{L}$ ) having a unique holomorphic connection whose curvature is $R^{L}=-2 \pi i \omega$. One can always pick an almost complex structure $J$ compatible with $\omega$, in [SZ under the assumption of $L$ being positive a space of almost holomorphic sections $H_{J}^{0}\left(M, L^{\otimes k}\right)$ is defined and the authors prove symplectic analogues of standard results in complex geometry; particularly those involving the zero sets of sections and the corresponding maps they define into complex projective space. As far as the authors are aware, if the positivity assumption on $L$ is dropped no such results are known and in fact one can not expect the dimensions of $H_{J}^{0}\left(M, L^{\otimes k}\right)$ to grow as in the positive case as $k$ goes to infinity in general. From the other hand, since the curvature of the line bundle $L$ in non-degenerate, suppose that it has constant signature ( $n_{-}, n_{+}$), one can try to replace the spaces $H_{J}^{0}\left(M, L^{\otimes k}\right)$ with spaces of harmonic $L^{\otimes k}$-valued ( $0, n_{-}$)-forms, this is suggested by results contained in (HM and (MM concerning the asymptotic expansion of the Bergman kernel for $(0, q)$ forms for high tensor powers of $L$ (see also HS and HM2 for the Szegő kernels for $(0, q)$ forms). The aim of this paper is to define embeddings of $(M, \omega)$ which are asymptotically symplectic; since the results in $[\mathrm{HM}$ are presented in the holomorphic

[^0]category we focus on the case when $J$ is an integrable structure. We now recall some known results and state the main theorems.

We refer to Section 2 for notations and preliminaries. Let $\left(L, h^{L}\right) \rightarrow M$ be a holomorphic line bundle, where $M$ is a compact complex manifold of complex dimension $n$ and $h^{L}$ is the Hermitian metric of $L$. Let $R^{L}$ be the curvature of $L$ induced by $h^{L}$. In this work, we assume that $R^{L}$ is non-degenerate of constant signature $\left(n_{-}, n_{+}\right)$on $M, n_{-}+n_{+}=n$.

Remark 1.1. Suppose $M$ is connected. Notice that when $\omega$ is non-degenerate we can prove that $\omega$ has constant signature. For each point $m$ in $M$ consider the continuous map $m \mapsto \lambda_{j}(m)$ which is the $j$-th eugenvalue of $\omega_{m}$. By absurd suppose that there exists $x, y$ in $M$ and $j=1, \ldots, n$ such that $\lambda_{j}(x)>0$ and $\lambda_{j}(y)<0$. Since $\lambda_{j}$ is continuous, by the intermediate value theorem there exists $z$ such that $\lambda_{j}(z)=0$, which contradicts the hypothesis.

Fix a Hermitian metric $\langle\cdot \mid \cdot\rangle$ on the holomorphic tangent bundle $T^{1,0} M$. The Hermitian metric $\langle\cdot \mid \cdot\rangle$ on $T^{1,0} M$ induces a Hermitian metric on $T M \otimes \mathbb{C}$ and also on

$$
\bigoplus_{q \in \mathbb{N} \cup\{0\}, 0 \leq q \leq n} T^{* 0, q} M,
$$

where $T^{* 0, q} M$ is the bundle of $(0, q)$ forms. Consider the vector bundle $T^{* 0, q} M \otimes L^{\otimes k}$ whose space of smooth sections is denoted by $\Omega^{0, q}\left(M, L^{\otimes k}\right)$. Let $\left\{\bar{e}_{j}\right\}_{j=1}^{n}$ be a basis of $T^{0,1} M:=\overline{T^{1,0} M}$ on an open set $D$ of $M$. For any strictly increasing multi-index $I=\left(i_{1}, \ldots, i_{q}\right), 1 \leq i_{j} \leq n$, we denote

$$
\bar{e}^{I}:=\bar{e}_{i_{1}} \wedge \cdots \wedge \bar{e}_{i_{q}} .
$$

On $D$, we can write a $(0, q)$-form $f \in \Omega^{0, q}\left(M, L^{\otimes k}\right)$ as follows

$$
\begin{equation*}
f_{\mid D}=\sum_{|I|=q}^{<} f_{I}(z) \bar{e}^{I} \tag{1}
\end{equation*}
$$

where $f_{I} \in \mathcal{C}^{\infty}\left(D, L^{k}\right)$, for each $I$ and $\sum^{<}$means that the summation is performed only over strictly increasing multi-indices. In this paper all multi-indices will be supposed to be strictly increasing. The Hermitian metrices $\langle\cdot \mid \cdot\rangle$ and $h^{L}$ induce a new Hermitian metric $\langle\cdot \mid \cdot\rangle_{h^{L^{\otimes k}}}$ on $T^{* 0, q} M \otimes L^{\otimes k}$, the corresponding norm is denoted by $|\cdot|_{h^{L \otimes k}}$. We can define the $L^{2}$-inner product as follows:

$$
\left(s_{1}, s_{2}\right)_{k}=\int_{M}\left\langle s_{1} \mid s_{2}\right\rangle_{h^{L^{\otimes k}}} \mathrm{dV}_{M} \quad s_{1}, s_{2} \in \Omega^{0, q}\left(M, L^{\otimes k}\right),
$$

and we denote by $\|\cdot\|_{k}$ the corresponding norm, where $\mathrm{dV}_{M}$ is the volume form on $M$ induced by $\langle\cdot \mid \cdot\rangle$. Let $L_{0, q}^{2}\left(M, L^{\otimes k}\right)$ be the completion of $\Omega^{0, q}\left(M, L^{\otimes k}\right)$ with respect to $(\cdot, \cdot)_{k}$. Let $\square_{k}^{(q)}: \Omega^{0, q}\left(M, L^{\otimes k}\right) \rightarrow \Omega^{0, q}\left(M, L^{\otimes k}\right)$ be the Kodaira Laplacian. We denote by the same symbol the $L^{2}$ extension of $\square_{k}^{(q)}$ :

\square_{k}^{(q)}: \operatorname{Dom} \square_{k}^{(q)} \subset L_{0, q}^{2}\left(M, L^{\otimes k}\right) \rightarrow L_{0, q}^{2}\left(M, L^{\otimes k}\right),
$$

where $\operatorname{Dom} \square_{k}^{(q)}=\left\{u \in L_{0, q}^{2}\left(M, L^{\otimes k}\right) ; \square_{k}^{(q)} u \in L_{0, q}^{2}\left(M, L^{\otimes k}\right)\right\}$. The projection

$$
P_{k}^{(q)}: L_{0, q}^{2}\left(M, L^{\otimes k}\right) \rightarrow H^{q}\left(M, L^{\otimes k}\right):=\operatorname{Ker} \square_{k}^{(q)}
$$

onto the kernel of $\square_{k}^{(q)}$ is called Bergman projector or Bergman projection. Since $\square_{k}^{(q)}$ is elliptic, its distributional kernel satisfies

$$
P_{k}^{(q)}(\cdot, \cdot) \in \mathcal{C}^{\infty}\left(M \times M, L^{k} \otimes\left(T^{* 0, q} M \boxtimes\left(T^{* 0, q} M\right)^{*}\right) \otimes\left(L^{k}\right)^{*}\right)
$$

and along the diagonal we have a smooth section

$$
z \mapsto P_{k}^{(q)}(z, z) \in \operatorname{End}\left(T_{z}^{* 0, q} M\right)
$$

called local density of states.
In the standard situation, when the line bundle is positive, we consider $q=0$ and we define an embedding by setting the holomorphic map

$$
\Phi_{k}: M \rightarrow \mathbb{C P}^{d_{k}}, \quad z \mapsto\left[S_{0}(z): \cdots: S_{d_{k}}(z)\right]
$$

where $\left[S_{0}(z): \cdots: S_{d_{k}}(z)\right]$ denotes the line through $\left(S_{0}(z), \cdots, S_{d_{k}}(z)\right)$ as defined in a local holomorphic frame and where $S_{0}, \ldots, S_{d_{k}}$, is an orthonormal basis of the vector space $H^{0}\left(M, L^{\otimes k}\right)$. Since all the components transform by the same scalar under a change of frame and since

$$
P_{k}^{(0)}(z, z)=\sum_{j=0}^{d_{k}}\left|S_{j}(z)\right|_{h^{L^{\otimes k}}}^{2}=O\left(k^{n}\right),
$$

it is easy to see that the sections $S_{j}$ do not share common zeros and the map $\Phi_{k}$ is well defined. Notice that for $(0, q)$-forms we have in local coordinates an expression such as (1), so we need to modify this construction as follows. Consider $L_{1}, \ldots, L_{n} \in T^{1,0} M$ be an orthonormal basis of $T^{1,0} M$ with respect to $\langle\cdot \mid \cdot\rangle$ so that $R^{L}\left(L_{j}, L_{k}\right)=\lambda_{j} \delta_{j, k}$ with $\lambda_{1}<0, \ldots, \lambda_{n_{-}}<0$ and $\lambda_{n_{-}+1}>0, \ldots, \lambda_{n}>0$. We always assume $q=n_{-}$and we denote by $J_{0}$ the multi-index $(1,2, \ldots, q)$. Denote by $e_{1}, \ldots, e_{n} \in T^{* 1,0} M$ a dual basis of $L_{1}, \ldots, L_{n}$ and by $\bar{e}_{J_{0}}=\bar{e}_{1} \wedge \cdots \wedge \bar{e}_{q}$, we also set

$$
\begin{equation*}
S_{j, J_{0}}=\left\langle S_{j} \mid \bar{e}_{J_{0}}\right\rangle \in \mathcal{C}^{\infty}\left(M, L^{\otimes k}\right) \tag{2}
\end{equation*}
$$

where $S_{0}, \ldots, S_{d_{k}}$ is an orthonormal basis of $H^{q}\left(M, L^{\otimes k}\right)$, with $\operatorname{dim}_{\mathbb{C}} H^{q}\left(M, L^{\otimes k}\right)=d_{k}+1$, in view of notation (2) define a map $\Phi_{k}^{(q)}: M \rightarrow \mathbb{C P}^{d_{k}}$ such that

$$
\begin{equation*}
\Phi_{k}^{(q)}(z):=\left[S_{0, J_{0}}(z): \cdots: S_{d_{k}, J_{0}}(z)\right] \in \mathbb{C P}^{d_{k}} \quad \text { on } M \tag{3}
\end{equation*}
$$

we shall show that this map is well-defined if $k$ is sufficiently large. We now state the main theorem of this paper.
Theorem 1.1. Let $\left(L, h^{L}\right) \rightarrow M$ be a holomorphic line bundle over a compact complex manifold $M$. Let $R^{L}$ be the curvature of $L$ induced by $h^{L}$. Assume that $R^{L}$ is non-degenerate of constant signature ( $n_{-}, n_{+}$). With the notations used above, the map

$$
\Phi_{k}^{\left(n_{-}\right)}: M \rightarrow \mathbb{C P}^{d_{k}}
$$

given by (3) above is an embedding and

$$
\left\|\frac{1}{k} \Phi_{k}^{\left(n_{-}\right) *}\left(\omega_{F S}\right)-\omega\right\|_{\mathcal{C}^{\infty}} \rightarrow 0
$$

as $k$ goes to infinity in the $\mathcal{C}^{\infty}$ topology, where $\omega_{F S}$ denotes the Fubini-Study metric on $\mathbb{C P}^{d_{k}}$ and $\omega:=\frac{i}{2 \pi} R^{L}$.

Recall that when $L$ is positive, the convergence of $\Phi_{k}^{\left(n_{-}\right) *}\left(\omega_{F S}\right) / k$ to $\omega$ was proved in Tian Tian. Notice that, the pull-back of a positive form is not necessarily positive, and in fact in our setting $\omega$ is only assumed to be a closed non-degenerate 2 -form. Furthermore, let us remark that, in general, $\Phi_{k}^{\left(n_{-}\right)}$is not holomorphic. In fact, if $\Phi_{k}^{\left(n_{-}\right)}$was holomorphic, then $\Phi_{k}^{\left(n_{-}\right) *}\left(\omega_{F S}\right)$ would be a Kähler form for each $k$.

In [MM, Chapter 5.1.4] an embedding is defined into a Grassmannian using the Bergman kernel for $E \otimes L^{\otimes k}$, where $E$ is a vector bundle of rank $e$. Here we are tensoring $L^{\otimes k}$ with $T^{* 0, q} M$.

Put

$$
\widetilde{T}^{1,0} M:=\operatorname{span}\left\{\bar{L}_{1}, \ldots, \bar{L}_{n_{-}}, L_{n_{-}+1}, \cdots, L_{n}\right\} .
$$

Then, $\widetilde{T}^{1,0} M$ is an almost complex structure on $M$. The second main result of this paper is the following

Theorem 1.2. With the notations and assumptions used above, the map $\Phi_{k}^{\left(n_{-}\right)}$is pointwise asymptotically holomorphic with respect to $\widetilde{T}^{1,0} M$ in the following sense: Let $p \in M$ and take $s$ be a local holomorphic trivializing section of $L$ defined on an open set $D$ of $p$ with $|s|_{h}^{2}=$ $e^{-2 \phi}, \phi \in \mathcal{C}^{\infty}(D, \mathbb{R}), \phi(x)=O\left(|x-p|^{2}\right)$. Write $S_{j, J_{0}}=s^{k} \otimes \tilde{S}_{j, J_{0}}$ on $D, \tilde{S}_{j, J_{0}} \in \mathcal{C}^{\infty}(D)$, $j=0,1, \ldots, d_{k}$. We have

$$
\begin{align*}
& \sum_{j=0}^{d_{k}}\left|\left(L_{t} \tilde{S}_{j, J_{0}}\right)(p)\right|^{2}=O\left(k^{n}\right), \quad t=1, \ldots, n_{-}, \\
& \sum_{j=0}^{d_{k}}\left|\left(\bar{L}_{t} \tilde{S}_{j, J_{0}}\right)(p)\right|^{2}=O\left(k^{n}\right), \quad t=n_{-}+1, \ldots, n . \tag{4}
\end{align*}
$$

Remark 1.2. With the notations and assumptions used in Theorem 1.2] in general, we have that (see the proof of HM, Theorem 4.3])

$$
\sum_{j=0}^{d_{k}}\left|\left(Z \hat{S}_{j, J_{0}}\right)(p)\right|^{2}=O\left(k^{n+\frac{1}{2}}\right)
$$

where $Z \in \mathcal{C}^{\infty}(M, T M \otimes \mathbb{C})$. The equation (4) says that we can have better estimates if $Z=L_{t}$, $t \in\left\{1, \ldots, n_{-}\right\}$or $Z=\bar{L}_{t}, t \in\left\{n_{-}+1, \ldots, n\right\}$.

## 2 Preliminaries

Let $E$ be a $\mathcal{C}^{\infty}$ vector bundle over $M$. The fiber of $E$ at $x \in M$ will be denoted by $E_{x}$. Let $F$ be another vector bundle over $X$. We write $F \boxtimes E^{*}$ to denote the vector bundle over $M \times M$ with fiber over $(x, y) \in M \times M$ consisting of the linear maps from $E_{y}$ to $F_{x}$.

Let $D$ be an open set of $M$. The spaces of smooth sections of $E$ over $D$ and distribution sections of $E$ over $D$ will be denoted by $\mathcal{C}^{\infty}(D, E)$ and $\mathcal{D}^{\prime}(D, E)$ respectively. Let $\mathcal{E}^{\prime}(D, E)$ be the subspace of $\mathcal{D}^{\prime}(D, E)$ whose elements have compact support in $D$. Put $\mathcal{C}_{c}^{\infty}(D, E):=$ $\mathcal{C}^{\infty}(D, E) \bigcap \mathcal{E}^{\prime}(D, E)$. We write $\Omega^{0, q}(D, E)$ and $\Omega^{0, q}(D)$ to denote $\mathcal{C}^{\infty}\left(D, T^{* 0, q} M \otimes E\right)$ and $\mathcal{C}^{\infty}\left(D, T^{* 0, q} M\right)$ respectively. Put $\Omega_{c}^{0, q}(D, E):=\Omega^{0, q}(D, E) \cap \mathcal{E}^{\prime}(D, E), \Omega_{c}^{0, q}(D):=\Omega^{0, q}(D) \cap$ $\mathcal{E}^{\prime}(D)$. Let $W_{1}, W_{2}$ be bounded open subsets of $\mathbb{R}^{n_{1}}$ and $\mathbb{R}^{n_{2}}$, respectively. Let $E$ and $F$ be complex or real vector bundles over $W_{1}$ and $W_{2}$, respectively. Let $s_{1}, s_{2} \in \mathbb{R}$ and $n_{0} \in \mathbb{Z}$. For a $k$-dependent continuous function $F_{k}: \mathcal{C}_{c}^{\infty}\left(W_{1}, E\right) \rightarrow \mathcal{D}^{\prime}\left(W_{2}, F\right)$ with distribution kernel $F_{k}(x, y) \in \mathcal{C}^{\infty}\left(W_{2} \times W_{1}, F \boxtimes E^{*}\right)$. We write $F_{k}=O\left(k^{-\infty}\right)$ on $W_{2} \times W_{1}$ or $F_{k}(x, y)=O\left(k^{-\infty}\right)$ on $W_{2} \times W_{1}$ if for every compact set $K \Subset W_{2} \times W_{1}$, every $m \in \mathbb{N} \bigcup\{0\}$ and every $N>0$, there is a constant $C_{N, m, K}>0$ independent of $k$ such that

$$
\left\|F_{k}(x, y)\right\|_{\mathcal{C}^{m}\left(K, F \boxtimes E^{*}\right)} \leq C_{N, m, K} k^{-N},
$$

for every $k \gg 1$. Let $G_{k}: \mathcal{C}_{c}^{\infty}\left(W_{1}, E\right) \rightarrow \mathcal{D}^{\prime}\left(W_{2}, F\right)$ be another $k$-dependent continuous operator with distribution kernel $G_{k}(x, y) \in \mathcal{C}^{\infty}\left(W_{2} \times W_{1}, F \boxtimes E^{*}\right)$. We write $F_{k}=G_{k}+O\left(k^{-\infty}\right)$ on $W_{2} \times W_{1}$ or $F_{k}(x, y)=G_{k}(x, y)+O\left(k^{-\infty}\right)$ on $W_{2} \times W_{1}$ if $F_{k}-G_{k}=O\left(k^{-\infty}\right)$ on $W_{2} \times W_{1}$.

We recall the definition of the semi-classical symbol spaces
Definition 2.1. Let $W$ be an open set in $\mathbb{R}^{N}$. We let $S(1 ; W)$ be the set of $a \in \mathcal{C}^{\infty}(W)$ such that for every $\alpha \in(\mathbb{N} \bigcup\{0\})^{N}$, there exists $C_{\alpha}>0$ such that

$$
\left|\partial^{\alpha} a(x)\right| \leq C_{\alpha},
$$

for every $x \in W$. For $m \in \mathbb{R}$, let

$$
S^{m}(1)=S^{m}(1 ; W):=\left\{(a(\cdot, k))_{k \in \mathbb{R}} \mid\left(k^{-m} a(\cdot, k)\right) \in S^{0}(1 ; W)\right\} .
$$

Consider a sequence $a_{j} \in S^{m_{j}}(1), j \in \mathbb{N} \cup\{0\}$, where $m_{j} \searrow-\infty$, and let $a \in S^{m_{0}}(1)$. We say that

$$
a(\cdot, k) \sim \sum_{j=0}^{\infty} a_{j}(\cdot, k) \text { in } S^{m_{0}}(1)
$$

if for every $\ell \in \mathbb{N} \cup\{0\}$ we have $a-\sum_{j=0}^{\ell} a_{j} \in S^{m_{\ell+1}}(1)$. For a given sequence $a_{j}$ as above, we can always find such an asymptotic sum $a$, which is unique up to an element in $S^{-\infty}(1)=$ $S^{-\infty}(1 ; W):=\cap_{m} S^{m}(1)$.

We say that $a(\cdot, k) \in S^{m}(1)$ is a classical symbol on $W$ of order $m$ if

\begin{equation*}
a(\cdot, k) \sim \sum_{j=0}^{\infty} k^{m-j} a_{j} \text { in } S^{m}(1), \quad a_{j}(x) \in S^{0}(1), j=0,1 \ldots \tag{5}
\end{equation*}
$$

The set of all classical symbols on $W$ of order $m$ is denoted by $S_{\mathrm{cl}}^{m}(1)=S_{\mathrm{cl}}^{m}(1 ; W)$.
Similarly, we define $S^{m}(1 ; Y, E), S_{\mathrm{cl}}^{m}(1 ; Y, E)$ in the standard way, where $Y$ is a smooth manifold and $E$ is a vector bundle over $Y$.

We come back to our situation. We will use the same notations as Section 11. We will identify the curvature form $R^{L}$ with the Hermitian matrix

$$
\dot{R}^{L} \in \mathcal{C}^{\infty}\left(M, \operatorname{End}\left(T^{1,0} M\right)\right), \quad\left\langle R^{L}(z), U \wedge \bar{V}\right\rangle=\left\langle\dot{R}^{L}(z) U \mid V\right\rangle
$$

for every $U$ and $V$ in $T_{z}^{1,0} M, z \in M$. We denote by $W$ the subbundle of rank $q=n_{-}$of $T^{1,0} M$ generated by the eigenvectors corresponding to negative eigenvalues of $\dot{R}^{L}$. Then, det $\bar{W}^{*}:=$ $\Lambda^{q} \bar{W}^{*}$ is a rank one subbundle, where $\bar{W}^{*}$ is the dual bundle of the complex conjugate bundle of $W$ and $\Lambda^{q} \bar{W}^{*}$ is the vector space of all finite sum of $v_{1} \wedge \cdots \wedge v_{q}, v_{1}, \ldots, v_{q} \in \bar{W}^{*}$. We denote by $I_{\operatorname{det}} \bar{W}^{*}$ the orthogonal projection from $T^{* 0, q} M$ onto $\operatorname{det} \bar{W}^{*}$. For $x \in M$, let $\operatorname{det} \dot{R}^{L}(x):=$ $\mu_{1}(x) \cdots \mu_{n}(x)$, where $\mu_{j}(x), j=1, \ldots, n$, are eigenvalues of $\dot{R}^{L}(x)$.

Let $s$ and $s_{1}$ be local holomorphic trivializing sections of $L$ defined on open sets $D \subset M$ and $D_{1} \subset M$ respectively, $|s|_{h^{L}}^{2}=e^{-2 \phi},\left|s_{1}\right|_{h^{L}}^{2}=e^{-2 \phi_{1}}, \phi \in \mathcal{C}^{\infty}(D, \mathbb{R}), \phi \in \mathcal{C}^{\infty}\left(D_{1}, \mathbb{R}\right)$. The localization of $P_{k}^{(q)}$ with respect to $s, s_{1}$ are given by

$$
\begin{aligned}
P_{k, s, s_{1}}^{(q)}: \Omega_{c}^{0, q}(D) & \rightarrow \Omega^{0, q}\left(D_{1}\right) \\
u & \rightarrow s_{1}^{-k} e^{-k \phi_{1}}\left(P_{k}^{(q)}\left(s^{k} e^{k \phi} u\right)\right)
\end{aligned}
$$

Let $P_{k, s, s_{1}}^{(q)}(x, y) \in \mathcal{C}^{\infty}\left(D_{1} \times D, T^{* 0, q} M \boxtimes\left(T^{* 0, q} M\right)^{*}\right)$ be the distribution kernel of $P_{k, s, s_{1}}^{(q)}$. When $D=D_{1}, s=s_{1}$, we write $P_{k, s}^{(q)}:=P_{k, s, s}^{(q)}, P_{k, s}^{(q)}(x, y):=P_{k, s, s}^{(q)}(x, y)$. We recall the following result [HM, Theorem 4.11]

Theorem 2.1. With the notations and assumptions used above and recall that we let $q=n_{-}$. Let s be a local holomorphic trivializing section of $L$ defined on an open set $D \subset M,|s|_{h^{L}}^{2}=e^{-2 \phi}$. We have

$$
\begin{equation*}
P_{k, s}^{(q)}(x, y)=e^{i k \Psi(x, y)} b(x, y, k)+O\left(k^{-\infty}\right) \quad \text { on } D \times D \tag{6}
\end{equation*}
$$

where $b(x, y, k) \in S_{\mathrm{cl}}^{n}\left(1 ; D \times D, T^{* 0, q} M \boxtimes\left(T^{* 0, q} M\right)^{*}\right), b(x, y, k) \sim \sum_{j=0} b_{j}(x, y) k^{n-j}$ in $S_{\mathrm{cl}}^{n}(1 ; D \times$ $\left.D, T^{* 0, q} M \boxtimes\left(T^{* 0, q} M\right)^{*}\right), b_{j}(x, y) \in \mathcal{C}^{\infty}\left(D \times D, T^{* 0, q} M \boxtimes\left(T^{* 0, q} M\right)^{*}\right), j=0,1, \ldots$,

$$
\begin{equation*}
b_{0}(x, x)=(2 \pi)^{-n} I_{\operatorname{det} \bar{W}^{*}}\left|\operatorname{det} \dot{R}^{L}(x)\right|, \quad \text { for every } x \in M \tag{7}
\end{equation*}
$$

and $\Psi(x, y) \in \mathcal{C}^{\infty}(D \times D)$,

$$
\begin{equation*}
\Psi(x, y)=-\bar{\Psi}(y, x) \tag{8}
\end{equation*}
$$

there is a $c>0$ such that $\operatorname{Im} \Psi(x, y) \geq c|x-y|^{2}$, for all $x, y \in D$,
$\Psi(x, y)=0$ if and only of $x=y$.

Fix $p \in D$, take $z=\left(z_{1}, \ldots, z_{n}\right)$ be local coordinates of $M$ defined on $D$ and $s$ so that

$$
\begin{align*}
& z(p)=0 \\
& \left\langle\left.\frac{\partial}{\partial z_{j}} \right\rvert\, \frac{\partial}{\partial z_{t}}\right\rangle=\delta_{j, t}+O(|z|), \quad j, t=1, \ldots, n  \tag{9}\\
& \phi(z)=\sum_{j=1}^{n} \lambda_{j}\left|z_{j}\right|^{2}+O\left(|z|^{3}\right)
\end{align*}
$$

then

$$
\begin{equation*}
\Psi(z, w)=i \sum_{j=1}^{n}\left|\lambda_{j}\right|\left|z_{j}-w_{j}\right|^{2}+i \sum_{j=1}^{n} \lambda_{j}\left(\bar{z}_{j} w_{j}-z_{j} \bar{w}_{j}\right)+O\left(|(z, w)|^{3}\right) . \tag{10}
\end{equation*}
$$

## 3 Proof of Theorem 1.1

We always assume $q=n_{-}$. In view of Theorem [2.1, we have

$$
\begin{equation*}
P_{k}^{(q)}(z, z)=\mathbf{b}_{\mathbf{0}}(z) \mathrm{I}_{\mathrm{det}} \bar{W}^{*} k^{n}+O\left(k^{n-1}\right) \tag{11}
\end{equation*}
$$

with $\mathbf{b}_{\mathbf{0}}(z)>0$. By (11) follows that the map $\Phi_{k}^{(q)}$ is well-defined.
We shall now prove that $\Phi_{k}^{(q)}$ is injective. By contrary, up to consider a subsequence, suppose that we can find $x_{k}, y_{k}$ in $M$, such that $x_{k} \neq y_{k}$ and $\Phi_{k}^{(q)}\left(x_{k}\right)=\Phi_{k}^{(q)}\left(y_{k}\right)$, for each $k$. Thus, by noticing

$$
\begin{align*}
& \forall k: \Phi_{k}^{(q)}\left(x_{k}\right)=\Phi_{k}^{(q)}\left(y_{k}\right) \Longleftrightarrow  \tag{12}\\
& \forall k, \exists \lambda_{k} \in \mathbb{C}^{*}:\left(S_{0, J_{0}}\left(x_{k}\right), \ldots, S_{d_{k}, J_{0}}\left(x_{k}\right)\right)=\lambda_{k} \cdot\left(S_{0, J_{0}}\left(y_{k}\right), \ldots, S_{d_{k}, J_{0}}\left(y_{k}\right)\right)
\end{align*}
$$

we can also assume that for each harmonic $(0, q)$-forms $g_{k} \in H^{q}\left(M, L^{\otimes k}\right)$, we have

$$
\begin{equation*}
\left|g_{k, J_{0}}\left(x_{k}\right)\right|_{h^{\triangleright \otimes k}}^{2} \geq\left|g_{k, J_{0}}\left(y_{k}\right)\right|_{h^{L^{\otimes k}}}^{2}, \text { for all } k \gg 1 . \tag{13}
\end{equation*}
$$

Assume that $\lim _{k \rightarrow+\infty} x_{k}=p, \lim _{k \rightarrow+\infty} y_{k}=q, p \neq q$. Let $s$ and $s_{1}$ be local holomorphic trivializing sections of $L$ defined on open sets $D \subset M$ and $D_{1} \subset M$ respectively, $p \in D, q \in D_{1}$, $\bar{D} \cap \bar{D}_{1}=\emptyset$. From [HM1, Lemma 3.7], we see that

$$
\begin{equation*}
P_{k, s, s_{1}}^{(q)}(x, y)=O\left(k^{-\infty}\right) \text { on } D \times D_{1} \tag{14}
\end{equation*}
$$

From Theorem 2.1 and (14), we can find $g_{k} \in H^{q}\left(M, L^{\otimes k}\right)$ such that

$$
\begin{equation*}
\left|g_{k, J_{0}}\left(x_{k}\right)\right|_{h^{\perp \otimes k}}^{2}<\left|g_{k, J_{0}}\left(y_{k}\right)\right|_{h^{L^{\otimes k}}}^{2}, \quad \text { for all } k \gg 1 . \tag{15}
\end{equation*}
$$

From (13) and (15), we get a contradiction. Therefore, $x_{k}$ and $y_{k}$ must converge to the same point $p \in M$. We can distinguish two cases: either $\left.\left.\lim \sup _{k} \sqrt{k}\left|x_{k}-y_{k}\right|=C>0, C \in\right] 0, \infty\right]$ or $\lim \sup _{k} \sqrt{k}\left|x_{k}-y_{k}\right|=0$. Here the distance $\left|x_{k}-y_{k}\right|, x_{k}, y_{k} \in M$, is meant with respect to the Riemannian structure $g=(\langle\cdot, \cdot\rangle+\overline{\langle\cdot, \cdot\rangle}) / 2$ on $T M$.

Let $s$ be local holomorphic trivializing section of $L$ defined on an open set $D \subset M, p \in D$, $|s|_{h^{L}}^{2}=e^{-2 \phi}$. Let us study the first case. For every $y_{k} \in D$, let us set

$$
g_{k}(\cdot):=P_{k}^{(q)}\left(\cdot, y_{k}\right) \bar{e}_{J_{0}}\left(y_{k}\right) \in H^{q}\left(M, L^{\otimes k}\right)
$$

On $D$, write $g_{k}=s^{k} \otimes \tilde{g}_{k}, \tilde{g}_{k} \in \Omega^{0, q}(D)$. Put $\hat{g}_{k}:=e^{-k \phi} \tilde{g}_{k}$. In view of Theorem 2.1, we have

$$
\hat{g}_{k}(x)=e^{i k \Psi\left(x, y_{k}\right)} b\left(x, y_{k}, k\right) \bar{e}_{J_{0}}\left(y_{k}\right)+O\left(k^{-\infty}\right) \text { on } D .
$$

Let $\hat{g}_{k, J_{0}}(x):=\left\langle\hat{g}_{k}(x) \mid \bar{e}_{J_{0}}(x)\right\rangle \in \mathcal{C}^{\infty}(D)$. Notice that

$$
\begin{aligned}
& \left|\hat{g}_{k, J_{0}}\left(x_{k}\right)\right|^{2}=\left|e^{i k \Psi\left(x_{k}, y_{k}\right)}\left\langle b\left(x_{k}, y_{k}, k\right) \bar{e}_{J_{0}}\left(y_{k}\right) \mid \bar{e}_{J_{0}}\left(x_{k}\right)\right\rangle\right|^{2}+O\left(k^{-\infty}\right) \\
& \leq e^{-2 k \operatorname{Im} \Psi\left(x_{k}, y_{k}\right)}\left|\left\langle b\left(x_{k}, y_{k}, k\right) \bar{e}_{J_{0}}\left(y_{k}\right) \mid e_{J_{0}}\left(x_{k}\right)\right\rangle\right|^{2}+O\left(k^{-\infty}\right)
\end{aligned}
$$

and

$$
\left|\hat{g}_{k, J_{0}}\left(y_{k}\right)\right|^{2}=\left|\left\langle b\left(y_{k}, y_{k}, k\right) \bar{e}_{J_{0}}\left(y_{k}\right) \mid e_{J_{0}}\left(x_{k}\right)\right\rangle\right|^{2}+O\left(k^{-\infty}\right)
$$

Thus, by recalling that $x_{k}, y_{k} \rightarrow p$, we get

$$
\lim _{k \rightarrow+\infty} \frac{\left|\hat{g}_{k, J_{0}}\left(x_{k}\right)\right|^{2}}{k^{2 n}} \leq e^{-2 c C^{2}}\left|b_{0}(p, p)\right|^{2}<\left|b_{0}(p, p)\right|^{2}=\lim _{k \rightarrow+\infty} \frac{\left|\hat{g}_{k, J_{0}}\left(y_{k}\right)\right|^{2}}{k^{2 n}}
$$

which contradicts (13), where $c>0$ is a constant independent of $k$.
Now, let us focus on the second case. Put $P_{k, s, J_{0}, J_{0}}^{(q)}(x, y):=\left\langle P_{k, s}^{(q)}(x, y) e_{J_{0}}(y) \mid e_{J_{0}}(x)\right\rangle$ and let $P_{k, s, J_{0}, J_{0}}^{(q)}(x):=P_{k, s, J_{0}, J_{0}}^{(q)}(x, x)$. Let us set

$$
f_{k}(t):=\frac{\left|P_{k, s, J_{0}, J_{0}}^{(q)}\left(t x_{k}+(1-t) y_{k}, y_{k}\right)\right|^{2}}{P_{k, s, J_{0}, J_{0}}^{(q)}\left(t x_{k}+(1-t) y_{k}\right) P_{k, s, J_{0}, J_{0}}^{(q)}\left(y_{k}\right)}
$$

From Theorem 2.1, it is then easy to prove that

$$
\begin{equation*}
f_{k}(t) \sim e^{-2 k \operatorname{Im} \Psi\left(t x_{k}+(1-t) y_{k}, y_{k}\right)} \cdot\left[1+\frac{1}{\sqrt{k}} R_{k}(t)\right] \tag{16}
\end{equation*}
$$

where $R_{k}=O(1)$ and the symbol $\sim$ means "has the same asymptotic as". For ease of notation, let us set $F_{k}(t):=-2 k \operatorname{Im} \Psi\left(t x_{k}+(1-t) y_{k}, y_{k}\right)$ for given $x_{k}, y_{k}$. Now, by applying the following formulas

$$
\left|F_{k}^{\prime}(t)\right|=\left|\left\langle-2 k \operatorname{Im} \Psi_{x}^{\prime}\left(t x_{k}+(1-t) y_{k}, y_{k}\right), x_{k}-y_{k}\right\rangle\right| \leq \frac{1}{c_{0}} k\left|x_{k}-y_{k}\right|^{2}
$$

and

$$
F_{k}^{\prime \prime}(t)=\left\langle-2 k \operatorname{Im} \Psi_{x}^{\prime \prime}\left(t x_{k}+(1-t) y_{k}, y_{k}\right), x_{k}-y_{k}\right\rangle<-c_{0} k\left|x_{k}-y_{k}\right|^{2}
$$

for the computation of the second derivative of $f_{k}(t)$ in equation (16), here $c_{0}$ is a positive constant, and by using the assumption $\lim \sup _{k} \sqrt{k}\left|x_{k}-y_{k}\right|=0$, after some computations, we obtain that

$$
\begin{equation*}
\limsup _{k} \frac{f^{\prime \prime}(t)}{k\left|x_{k}-y_{k}\right|^{2}}<0 \tag{17}
\end{equation*}
$$

for each $t$.
We now show that if we apply the assumption (12) for computing the limsup appearing in (17) we get a different result. By Cauchy-Schwartz inequality we have $0 \leq f_{k}(t) \leq 1$, for any $t \in[0,1]$ and $f_{k}(0)=f_{k}(1)=1$. Thus, for each $k$, there is a $t_{k} \in[0,1]$ such that $f^{\prime \prime}\left(t_{k}\right)=0$. Hence,

$$
\limsup _{k} \frac{f^{\prime \prime}(t)}{k\left|x_{k}-y_{k}\right|^{2}} \geq 0
$$

which contradicts (17).
Eventually, we shall prove the last part of the theorem concerning pull-back of the FubiniStudy form, as a corollary we get that $\mathrm{d} \Phi_{k}^{(q)}$ is injective and thus $\Phi_{k}^{(q)}$ is an embedding (see MM, Lemma 5.16]). Recall that the Fubini Study Kähler form on $\mathbb{C} \mathbb{P}^{m}$ is given in homogeneous coordinates $\left[w_{0}: \cdots: w_{m}\right]$ by

$$
\begin{equation*}
\omega_{\mathrm{FS}}:=\frac{i}{2 \pi} \partial \bar{\partial} \log \left(\sum_{j=0}^{m}\left|w_{i}\right|^{2}\right) \tag{18}
\end{equation*}
$$

Let us apply (18) to our setting; local holomorphic section $s$ of $L$ over an open set $D$ in $M$. It induces a section $s^{k}$ of the $k$-th tensor power of the line bundle $L^{\otimes k}$ on $D$. By recalling (2), we
have $S_{j, J_{0}}=f_{j, J_{0}}(z) \otimes s^{k}$ for a smooth function $f_{j, J_{0}}$ on $D, j=0,1, \ldots, d_{k}$. By definition (3), we get

$$
\begin{aligned}
\frac{1}{k} \Phi_{k}^{(q) *}\left(\omega_{\mathrm{FS}}\right)_{z} & =\frac{i}{2 \pi k} \partial \bar{\partial} \log \left(\sum_{j=0}^{d_{k}}\left|f_{j, J_{0}}(z)\right|^{2}\right)=\frac{i}{2 \pi k} \partial \bar{\partial} \log \left(\sum_{j=0}^{d_{k}} \frac{\left|S_{j, J_{0}}(z)\right|_{h^{\Sigma \otimes k}}^{2}}{\left|s^{k}(z)\right|_{h^{\llcorner\otimes k}}^{2}}\right) \\
& =\frac{i}{\pi} \partial \bar{\partial} \phi+\frac{i}{2 \pi k} \partial \bar{\partial} \log \left(\sum_{j=0}^{d_{k}}\left|S_{j, J_{0}}(z)\right|_{h^{L \otimes k}}^{2}\right)
\end{aligned}
$$

Thus, the statement of the theorem follows from

$$
\left\|\partial \bar{\partial} \log P_{k, s, J_{0}, J_{0}}^{(q)}(x, x)\right\|_{\mathcal{C}_{\infty}}=O(1)
$$

in view of the asymptotic expansion of $P_{k, s}^{(q)}(x, x)$.

## 4 Proof of Theorem 1.2

Fix $p \in M$ and let $s$ be a local trivializing section of $L$ defined on an open set $D$ of $p,|s|_{h^{L}}^{2}=e^{-2 \phi}$. Let $z=\left(z_{1}, \ldots, z_{n}\right)=\left(x_{1}, \ldots, x_{2 n}\right), z_{j}=x_{2 j-1}+i x_{2 j}, j=1, \ldots, n$, be local coordinates of $M$ defined on $D$. We take $z$ and $s$ so that (9) hold. Assume that $\lambda_{1}<0, \ldots, \lambda_{n_{-}}<0$, $\lambda_{n_{-}+1}>0, \ldots, \lambda_{n}>0$. We have $L_{j}=\frac{\partial}{\partial z_{j}}$ at $p, j=1, \ldots, n$. We need

Lemma 4.1. Let $u \in H^{q}\left(M, L^{\otimes k}\right)$ with $\|u\|_{k}=1$. On $D$, write $u=s^{k} \otimes \tilde{u}, \tilde{u} \in \Omega^{0, q}(D)$. Put $\tilde{u}_{J_{0}}(x):=\left\langle\tilde{u}(x) \mid \bar{e}_{J_{0}}(x)\right\rangle \in \mathcal{C}^{\infty}(D)$. There is a constant $C>0$ independent of $k$ and $u$ such that

$$
\begin{align*}
\left|\left(L_{t} \tilde{u}_{J_{0}}\right)(p)\right|^{2} \leq C k^{n}, \quad t=1, \ldots, n_{-}, \\
\left|\left(\bar{L}_{t} \tilde{u}_{J_{0}}\right)(p)\right|^{2} \leq C k^{n}, \quad t=n_{-}+1, \ldots, n . \tag{19}
\end{align*}
$$

Proof. Put $Z_{t}=L_{t}, t=1, \ldots, n_{-}, Z_{t}=\bar{L}_{t}, t=n_{-}+1, \ldots, n$. Fix $t \in\{1, \ldots, n\}$. From Theorem 2.1] and off-diagonal expansion of $P_{k}^{(q)}$ (see (14)), we have

$$
\begin{equation*}
\left|\left(Z_{t} \tilde{u}_{J_{0}}\right)(p)-\int e^{i k \Psi(0, y)-k \phi(y)}\left(r_{0}(y) k^{n+1}+r_{1}(y, k)\right) \chi(y) \tilde{u}(y) \mathrm{dV}_{M}(y)\right| \leq C_{N} k^{-N}, \tag{20}
\end{equation*}
$$

for every $N>0$, where $C_{N}>0$ is a constant independent of $k, u$ and $r_{0}(y)=O\left(|y|^{2}\right)$, $r_{1}(y, k) \in S_{\mathrm{cl}}^{n}\left(1 ; D, \mathbb{C} \boxtimes\left(T^{* 0, q} M\right)^{*}\right), \chi \in \mathcal{C}_{c}^{\infty}(D), \chi=1$ near 0 . From $\operatorname{Im} \Psi(0, y) \sim|y|^{2}$ and some straightforward computations, we can check that

$$
\begin{align*}
& \left|\int e^{i k \Psi(0, y)-k \phi(y)}\left(r_{0}(y) k^{n+1}+r_{1}(y, k)\right) \chi(y) \tilde{u}(y) \mathrm{dV}_{M}(y)\right| \\
& \leq C\left|\int e^{-c k|y|^{2}}\left(k^{2 n+2}|y|^{4}+k^{2 n}\right) d y\right|^{\frac{1}{2}} \leq \hat{C} k^{n} \tag{21}
\end{align*}
$$

where $C>0, c>0, \hat{C}>0$ are constants independent of $k$ and $u$. From (20) and (21), we get (19).

We can now prove Theorem 1.2, We may assume that $\sum_{j=0}^{d_{k}}\left|\left(Z_{t} \tilde{S}_{j, J_{0}}\right)(p)\right|^{2} \neq 0$. Let

$$
u:=\frac{\sum_{j=0}^{d_{k}} S_{j} \overline{\left(Z_{t} \tilde{S}_{j, J_{0}}\right)(p)}}{\sqrt{\sum_{j=0}^{d_{k}}\left|\left(Z_{t} \tilde{S}_{j, J_{0}}\right)(p)\right|^{2}}} .
$$

Then, $u \in H^{q}\left(M, L^{\otimes k}\right)$ with $\|u\|_{k}=1$. From Lemma 4.1, we get

$$
\left|\left(Z_{t} \tilde{u}_{J_{0}}\right)(p)\right|^{2}=\sum_{j=0}^{d_{k}}\left|\left(Z_{t} \tilde{S}_{j, J_{0}}\right)(p)\right|^{2} \leq C k^{n}
$$

The theorem follows.
