# TANGLE CONTACT HOMOLOGY 

JOHAN ASPLUND


#### Abstract

Knot contact homology is an ambient isotopy invariant of knots and links in $\mathbb{R}^{3}$. The purpose of this paper is to extend this definition to an ambient isotopy invariant of tangles and prove that gluing of tangles gives a gluing formula for knot contact homology. As a consequence of the gluing formula we obtain that the tangle contact homology weakly detects the 1-dimensional untangle.

## 1. Introduction

Knot contact homology is an ambient isotopy invariant of knots and links in $\mathbb{R}^{3}$ first defined combinatorially by Ng Ng05a, Ng 05 b . It is known to be isomorphic to the homology of the Chekanov-Eliashberg dg-algebra associated to the unit conormal bundle of the link, with homology coefficients EENS13. Knot contact homology detects the unlink, cabled knots, composite knots and torus knots [GL17, Ng08, Proposition 5.10] and [CELN17, Corollary 1.5]. An enhanced version of the knot contact homology is in fact a complete knot invariant [ENS18]. We refer the reader to Ng14 and references therein for a complete survey of knot contact homology.

The unit conormal bundle of a link $K \subset \mathbb{R}^{3}$ is the set

$$
\Lambda_{K}:=\left\{(x, v) \in T^{*} \mathbb{R}^{3}\left|x \in K,|v|=1,\left\langle v, T_{x} K\right\rangle=0\right\}\right.
$$

for some metric on $\mathbb{R}^{3}$. The unit cotangent bundle of $\mathbb{R}^{3}$, denoted by $S T^{*} \mathbb{R}^{3}$, is a contact manifold when equipped with the one-form $\alpha:=\left.\left(p_{1} d x+p_{2} d y+p_{3} d z\right)\right|_{S T^{*} \mathbb{R}^{3}}$ where $(x, y, z)$ are local coordinates in $\mathbb{R}^{3}$ and $\left(p_{1}, p_{2}, p_{3}\right)$ are local coordinates in the fiber directions. The unit conormal $\Lambda_{K} \subset S T^{*} \mathbb{R}^{3}$ is Legendrian, meaning that $\left.\alpha\right|_{\Lambda_{K}}=0$. The homology of the Chekanov-Eliashberg dg-algebra is a Legendrian isotopy invariant of Legendrian submanifolds in contact manifolds EES05, EES07, EN15, DR16, Kar20]. The differential of the Chekanov-Eliashberg dg-algebra is defined by counting punctured $J$-holomorphic disks in $\mathbb{R} \times S T^{*} \mathbb{R}^{3}$ with boundary in $\mathbb{R} \times \Lambda_{K}$. It was first studied independently by Chekanov and Eliashberg Che02, Eli98 and it is part of the more general symplectic field theory package defined by Eliashberg-Givental-Hofer [EGH00.

In this paper we are concerned with the fully non-commutative version of knot contact homology of links in $\mathbb{R}^{3}$ [EENS13, CELN17, ENS18] which for our purposes is defined as the ChekanovEliashberg dg-algebra of $\Lambda_{K}$ in the unit cotangent bundle of $\mathbb{R}^{3}$ with loop space coefficients, denoted by $K C C_{\mathrm{EENS}}^{*}(K):=C E^{*}\left(\Lambda_{K}, C_{-*}\left(\Omega \Lambda_{K}\right)\right)$, see [EL17] for the definition of Chekanov-Eliashberg dg-algebras with loop space coefficients. Using methods developed in [AE22] we may understand the Chekanov-Eliashberg dg-algebra with loop space coefficients as the Chekanov-Eliashberg dgalgebra of a cotangent neighborhood of $\Lambda_{K}$, denoted by $N\left(\Lambda_{K}\right)$, together with a choice of handle decomposition $h$ which encodes both the handles and their attaching maps. Using the latter point of view, we define $K C C^{*}(K, h):=C E^{*}\left(\left(N\left(\Lambda_{K}\right), h\right) ; T^{*} \mathbb{R}^{3}\right)$ using notation as in AE22]. For each choice of $h, K C C^{*}(K, h)$ is an ambient isotopy invariant of the link $K \subset \mathbb{R}^{3}$, and for a certain choice of $h$ it recovers $K C C_{\text {EENS }}^{*}(K)$, see Theorem 3.17.
1.1. Statement of results. The main construction in this paper is that of tangle contact homology. It is the homology of a dg-algebra associated to a tangle $T$ in $\mathbb{R}_{x \geq 0}^{3}$, and a choice of handle decomposition $h$ of a Weinstein neighborhood of its unit conormal bundle which is denoted by $N\left(\Lambda_{T}\right)$. It is an ambient isotopy invariant of $T$ (with fixed boundary).

Suppose that $K \subset \mathbb{R}^{3}$ is a link and $H \subset \mathbb{R}^{3}$ is a smooth submanifold that is diffeomorphic to $\mathbb{R}^{2}$ such that $K$ intersects $H$ orthogonally with respect to some metric on $\mathbb{R}^{3}$ (which for technical reasons is assumed to be such that $H$ is not totally geodesic). The hypersurface $H$ splits $K$ into two tangles $T_{1}, T_{2} \subset \mathbb{R}_{x \geq 0}^{3}$, and conversely we say that $K$ is the gluing of $T_{1}$ and $T_{2}$.

Let $\mathcal{G}_{T_{i} \rightarrow H \rightarrow T_{j}}$ denote the set of words of oriented binormal geodesic chords in of the form

$$
T_{i} \rightarrow H \rightarrow \cdots \rightarrow H \rightarrow T_{j},
$$

where " $H \rightarrow H$ " is taken to mean an oriented binormal geodesic chord of $H$ in either of the two copies of $\mathbb{R}_{x \geq 0}^{3}$.

Our main result is the following gluing formula for $K C C^{*}(K, h)$.
Theorem 1.1 Theorem 3.28. Let $T_{1}$ and $T_{2}$ be two tangles in $\mathbb{R}_{x \geq 0}^{3}$ whose gluing is the link $K \subset \mathbb{R}^{3}$, where $H:=\partial \mathbb{R}_{x \geq 0}^{3}$. Let $h_{1}$ and $h_{2}$ be choices of handle decomposition of $N\left(\Lambda_{T_{1}}\right)$ and $N\left(\Lambda_{T_{2}}\right)$, respectively. Then we have a quasi-isomorphism of dg-algebras

$$
K C C^{*}\left(K, h_{1} \# h_{2}\right) \cong K C C^{*}\left(T_{1}, h_{1}\right) *_{K C C^{*}\left(\partial T, h_{\partial}\right)} K C C^{*}\left(T_{2}, h_{2}\right) *\left\langle\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{2}}\right\rangle *\left\langle\mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{1}}\right\rangle,
$$

where the right hand side is equipped with the same differential as in $K_{C C}^{*}\left(K, h_{1} \# h_{2}\right)$.
Here $\langle\mathcal{S}\rangle$ denotes the free algebra on the set $\mathcal{S}, *$ denotes free product, and $*_{C}$ denotes amalgamated free product, see Remark 2.38 for details.
Remark 1.2. (1) Only knowing $K C C^{*}\left(T_{1}, h_{1}\right)$ and $K C C^{*}\left(T_{2}, h_{2}\right)$ is not sufficient to recover $K C C^{*}\left(K, h_{1} \# h_{2}\right)$. To recover $K C C^{*}\left(K, h_{1} \# h_{2}\right)$ we also need to understand the set of oriented binormal geodesic chords between $T_{i}$ and $H$ and between $H$ and $T_{j}$ in the two copies of $\mathbb{R}_{x \geq 0}^{3}$.
(2) The two algebras $\left\langle\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{2}}\right\rangle$ and $\left\langle\mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{1}}\right\rangle$ and their free product by themselves are not dg-algebras when equipped with the differential in $K C C^{*}\left(K, h_{1} \# h_{2}\right)$.
(3) See Section 3.4.1 and in particular Figures 15 and 16 for a discussion which handle decompositions to consider in order to recover $K C C_{\text {EENS }}^{*}(K)$.
(4) A version of Theorem 1.1 still holds if the link $K \subset \mathbb{R}^{3}$ is split into tangles by any smooth codimension 1 submanifold of $\mathbb{R}^{3}$ that is not necessarily diffeomorphic to $\mathbb{R}^{2}$.

We have the following geometric characterization of tangle contact homology.
Theorem 1.3 Theorem 3.25. Let $T$ be a tangle in $\mathbb{R}_{x \geq 0}^{3}$ where $H:=\partial \mathbb{R}_{x \geq 0}^{3}$. Let $h$ be a choice of handle decomposition of $N\left(\Lambda_{T}\right)$. The dg-algebra $K C C^{*}(T, h)$ is quasi-isomorphic to a dg-algebra generated by
(1) Composable words of oriented binormal geodesic chords in $\mathbb{R}_{x \geq 0}^{3}$ of the form $T \rightarrow T$ or

$$
T \rightarrow H \rightarrow \cdots \rightarrow H \rightarrow T
$$

(2) Oriented binormal geodesic chords $\partial T \rightarrow \partial T$ in $H$.

The differential on this dg-algebra is defined to be the same as the one on $\operatorname{KCC}^{*}(T, h)$.
Remark 1.4. The construction of $K C C^{*}(T, h)$ makes sense for tangles of any dimension, and a version of Theorem 1.1 still holds in this case.
1.2. Construction and method of proof. We first give a rough description of the definition of tangle contact homology of a tangle $T \subset \mathbb{R}_{x \geq 0}^{3}$. Taking the unit conormal bundle of $T$ (denoted by $\Lambda_{T}$ ) naturally yields a Legendrian submanifold in the contact boundary of the (open) Weinstein sector $T^{*} \mathbb{R}_{x \geq 0}^{3}$. This sector corresponds to the Weinstein pair $\left(B^{6}, T^{*} H\right)$ where $H:=\partial \mathbb{R}_{x \geq 0}^{3}$ and $\Lambda_{T}$ is viewed as a Legendrian submanifold in $\partial B^{6}$ with Legendrian boundary in $\partial T^{*} H$. After picking a handle decomposition $h_{T}$ of $N\left(\Lambda_{T}\right)$ which is a Weinstein neighborhood of $\Lambda_{T}$, the dgalgebra $K C C^{*}\left(T, h_{T}\right)$ is defined as the Chekanov-Eliashberg dg-algebra of the pair $\left(N\left(\Lambda_{T}\right), h_{T}\right)$ in $\left(B^{6}, T^{*} H\right)$, see Section 3.3 for details. This is the natural definition of what the ChekanovEliashberg dg-algebra with loop space coefficients would be for a Legendrian with boundary.

In order to prove Theorem 1.1 we generalize the gluing formulas for Chekanov-Eliashberg dgalgebras proven in AE22, Asp23, to hold for Chekanov-Eliashberg dg-algebras with loop space coefficients. We now give a rough sketch of the gluing formula.

First consider two Weinstein pairs $\left(X_{1}, V\right)$ and $\left(X_{2}, V\right)$, we glue $X_{1}$ and $X_{2}$ together along their common Weinstein hypersurface $V^{2 n-2} \hookrightarrow \partial X^{2 n}$ to obtain a new Weinstein manifold denoted by $X_{1} \#_{V} X_{2}$. This operation is called Weinstein connected sum Avd21, Eli18, ÁGEN22, and gives gluing formulas for the Chekanov-Eliashberg dg-algebra with field coefficients of the Legendrian attaching link AE22, Asp23.

For the generalization of the above, assume we have two Weinstein pairs ( $X_{1}, W_{1}$ ) and ( $X_{2}, W_{2}$ ) where $W_{i}=V_{i}^{2 n-2} \#_{Q^{2 n-4}}\left(V^{\prime}\right)^{2 n-2}$ for $i \in\{1,2\}$. We glue $X_{1}$ and $X_{2}$ along the common Weinstein subhypersurface $\left(V^{\prime}\right)^{2 n-2} \subset W_{i}^{2 n-2}$. The result is a new Weinstein pair $(X, V)$, where $X=$ $X_{1} \#_{V^{\prime}} X_{2}$, and $V=V_{1} \#_{Q} V_{2}$, see Figure 1. We show that this type of gluing yields a gluing formula for the Chekanov-Eliashberg dg-algebra of the Weinstein hypersurface ( $V, h$ ) where $h$ is a handle decomposition of $V$, which for certain choices of $h$ is the Chekanov-Eliashberg dg-algebra with loop space coefficients, see Section 2.3 for details.
1.3. Applications. A consequence of Theorem 1.1, and by known properties of the fully noncommutative knot contact homology for links, we obtain the following.
Theorem 1.5 Theorem 3.35). Let $h$ be one of the two handle decompositions described in Section 3.4.1. Then $K C C^{*}(T, h)$ weakly detects the 1 -dimensional $r$-component untangle.
Remark 1.6. The definition of weak detection is found in Definition 3.34. The consequence of Theorem 1.1 is that $K C C^{*}(T, h)$ is a priori only able to detect tangles for which the isomorphism classes of the modules of oriented binormal geodesics between the tangle and $H$ are isomorphic to those corresponding to $T$. This seems like a rather mild restriction, see Example 3.36.


Figure 1. The Weinstein pair $\left(X_{1} \#_{V^{\prime}} X_{2}, V_{1} \#_{Q} V_{2}\right)$ obtained by gluing together the Weinstein pairs $\left(X_{1}, W_{1}\right)$ and ( $X_{2}, W_{2}$ ) along their common Weinstein subhypersurface $V^{\prime} \subset W_{1}, W_{2}$.

Knot contact homology of (framed oriented) knots in $\mathbb{R}^{3}$ is closely related to several smooth knot invariants. Some examples include string homology, the cord algebra, the Alexander polynomial and the augmentation polynomial which is closely related to the $A$-polynomial (and also conjectured to be related to a specialization of the HOMFLY-PT polynomial) Ng05b, Ng08, CELN17, Ekh18]. The knot group and its peripheral subgroup can be extracted from the enhanced version of the knot contact homology [ENS18].

In view of Theorem 1.3, it is natural to propose the following conjecture, extending the scope of [CELN17, Theorem 1.1]. Roughly, we define $\operatorname{Cord}(T, H)$ to be the framed cord algebra of $T$, relative to $H$. In addition to the usual cord algebra of a tangle (which is defined by mimicking [Ng05b, Section 4.3] and (Ng08, Section 2.1]) we allow cords to have either or both endpoints on $H$.

Conjecture 1.7. If $T$ is a framed oriented $r$-component tangle in $\mathbb{R}_{x \geq 0}^{3}$ there exists a choice of handle decomposition $h$ of $N\left(\Lambda_{T}\right)$ such that we have an isomorphism of $\mathbb{Z}\left[\mu_{1}^{ \pm 1}, \ldots, \mu_{r}^{ \pm 1}\right]$-algebras

$$
K C H^{0}(T, h) \cong \operatorname{Cord}(T, H)
$$

Remark 1.8. We furthermore conjecture that the choice of handle decomposition in Conjecture 1.7 should be such that there is a single top handle of $\Lambda_{T}$ (see Figure 16). There is a certain asymmetry in choices of handle decompositions $h_{1}$ and $h_{2}$ to recover $K C C_{\text {EENS }}^{*}(K)$ as described in Section 3.4.1. Thus we expect to find a gluing formula similar to that of Theorem 1.1, recovering Cord $(K)$ from $\operatorname{Cord}\left(T_{1}, H\right)$ and $\widetilde{\operatorname{Cord}}\left(T_{2}, H\right)$ where $\widetilde{\operatorname{Cord}}\left(T_{2}, H\right):=K C H^{0}\left(T_{2}, h_{2}\right)$ with $h_{2}$ chosen as in Figure 15 . We also expect there to be a suitable topological interpretation of $\widetilde{\operatorname{Cord}}\left(T_{2}, H\right)$.
1.4. Related work. Dattin has defined a sutured Legendrian isotopy invariant of sutured Legendrian submanifolds in sutured contact manifolds called cylindrical sutured homology [Dat22. In case the sutured contact manifold is balanced, we expect that the dg-algebra of $\Lambda_{T} \subset \partial T^{*} \mathbb{R}_{x \geq 0}^{3}$ defined by Dattin is quasi-isomorphic to $K C C^{*}(T, h)$.

Let $\Sigma$ be a surface without boundary and let $B \subset \Sigma \times[-1,1]$ be a braid. It is proven that a certain quotient of cylindrical sutured homology of $\Lambda_{B} \subset \partial T^{*}(\Sigma \times[-1,1])$ together with a product structure gives a complete invariant of braids [Dat22, Dat].
Outline. In Section 2 we generalize results from Asp23. Namely we construct simplicial decompositions of Weinstein pairs, and prove that the Chekanov-Eliashberg dg-algebra of top attaching spheres satisfies a gluing formula. This specializes to gluing formulas for the Chekanov-Eliashberg dg-algebra with loop space coefficients.

In Section 3 we define tangle contact homology for tangles in $\mathbb{R}_{x \geq 0}^{3}$. We apply the machinery of Section 2 to show that gluing of tangles induces gluing formulas for the tangle contact homologies.

In Section 4 we compute tangle contact homology in some examples and end with a calculation of the knot contact homology of the unknot via the gluing formula.

## 2. Simplicial decompositions for Weinstein pairs

In this section we generalize the notion of a simplicial decomposition of a Weinstein manifold introduced in Asp23 to Weinstein pairs.
2.1. Construction of simplicial decompositions for Weinstein pairs. We assume in the following that the reader is familiar with the construction of a simplicial decomposition of a Weinstein manifold as defined in Asp23, Section 2.2].
Remark 2.1. Recall that a Weinstein pair $\left(X^{2 n}, P^{2 n-2}\right)$ corresponds to a Weinstein sector $X^{\prime}$ via convex completion GPS20, Section 2.7]. We may thus think about constructions in this section as a generalization of the simplicial decomposition of a Weinstein manifold as constructed in Asp23 to a simplicial decomposition of a Weinstein sector.

In the following the superscript $X^{(k)}$ is used to indicate that $X$ has codimension $2 k$ for $k \in \mathbb{Z}_{\geq 0}$. We give a quick recap of the definition of a simplicial decomposition and refer to Asp23, Section 2.2 f for details. A simplicial decomposition of a Weinstein manifold $X$ is a tuple $(C, \boldsymbol{V})$ where $C$ is a simplicial complex and $\boldsymbol{V}$ is a set containing one Weinstein manifold $V_{\sigma_{k}}^{(k)}$ for each $k$-face $\sigma_{k} \in C$ (ranging over all $k$ ) and a certain Weinstein hypersurface associated to each $k$-face $\sigma_{k} \in C$ (ranging over all $k$ ). Associated to each $V_{\sigma_{k}}^{(k)}$ is the "basic building block" $V_{\sigma_{k}}^{(k)} \times T^{*} \Delta^{k}$ which is a Weinstein cobordism defined in Asp23, Section 2.1]. We define $\# \boldsymbol{V}$ to be the gluing of all the building blocks $V_{\sigma_{k}}^{(k)} \times T^{*} \Delta^{k}$ using certain gluing maps induced by the Weinstein hypersurfaces in $\boldsymbol{V}$. The condition required for $(C, \boldsymbol{V})$ to be a simplicial decomposition of $X$ is that there is a Weinstein isomorphism $X \cong \# \boldsymbol{V}$.

Definition 2.2. Let $(C, \boldsymbol{V})$ be a simplicial decomposition. For a $k$-face $\sigma_{k} \in C$ we define $\boldsymbol{V}_{\supsetneq \sigma_{k}} \subset \boldsymbol{V}$ (and $\left.\boldsymbol{V}_{\supset \sigma_{k}} \subset \boldsymbol{V}\right)$ to be the subset consisting of only those Weinstein manifolds $V_{\sigma_{i}} \in \boldsymbol{V}$ for which $\sigma_{i} \supsetneq \sigma_{k}$ (and $\sigma_{i} \supset \sigma_{k}$ ), and the corresponding Weinstein hypersurfaces.

Definition 2.3 (Hypersurface inclusion of simplicial decompositions). Let $(X, P)$ be a Weinstein pair. Let $(C, \boldsymbol{V})$ be a simplicial decomposition of $X^{2 n}$ and let $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right)$ be a simplicial decomposition of $P^{2 n-2}$. A hypersurface inclusion of simplicial decompositions $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right) \hookrightarrow(C, \boldsymbol{V})$ consists of
(1) A simplicial subcomplex $i: C^{\prime} \hookrightarrow C$. When no confusion can arise we use the notation $\sigma_{k}:=i\left(\sigma_{k}^{\prime}\right)$ for each $\sigma_{k}^{\prime} \in C^{\prime}$.
(2) A Weinstein hypersurface

$$
\#\left(\boldsymbol{V}_{\supset \sigma_{k}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\supsetneq \sigma_{k}}\right) \hookrightarrow \partial V_{\sigma_{k}}
$$

for each $\sigma_{k}^{\prime} \in C^{\prime}$, where

$$
\boldsymbol{V}_{\supset \sigma_{k}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\supsetneq \sigma_{k}}:=\boldsymbol{V}_{\supset \sigma_{k}^{\prime}}^{\prime} \cup \boldsymbol{V}_{\supsetneq \sigma_{k}} \cup \bigcup_{\sigma_{j}^{\prime} \supset \sigma_{k}^{\prime}}\left\{V_{\sigma_{j}^{\prime}}^{\prime} \hookrightarrow \partial V_{\sigma_{j}}\right\}
$$

see Definition 2.2 and Asp23, Section 2.2] for the notation.

Definition 2.4 (Simplicial decomposition of a Weinstein pair). A simplicial decomposition of the Weinstein pair $(X, P)$ which is denoted by $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ consists of

- A simplicial decomposition $(C, \boldsymbol{V})$ of $X$.
- A simplicial decomposition $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right)$ of $P$.
- A hypersurface inclusion of simplicial decompositions $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right) \hookrightarrow(C, \boldsymbol{V})$.
such that

$$
X \cong \# \boldsymbol{V}, \quad P \cong \# \boldsymbol{V}^{\prime}
$$

We now describe simplicial decompositions of Weinstein pairs in simple examples.
$C=\Delta^{1}:$ A simplicial decomposition of $X$ over the 1 -simplex is a tuple $\left(\Delta^{1}, \boldsymbol{V}\right)$ where $\boldsymbol{V}:=$ $\left\{V^{2 n-2}, X_{1}^{2 n}, X_{2}^{2 n}, \iota_{1}: V \hookrightarrow \partial X_{1}, \iota_{2}: V \hookrightarrow \partial X_{2}\right\}$. Here $V$ is a Weinstein $(2 n-2)$-manifold corresponding to the single edge of $\Delta^{1}, X_{1}^{2 n}$ and $X_{2}^{2 n}$ are two Weinstein $2 n$-manifolds corresponding to each vertex of $\Delta^{1}$ and $\iota_{1}, \iota_{2}$ are two Weinstein hypersurfaces corresponding to the face inclusion of each vertex in the single edge of the 1 -simplex.

Using the tuple $\left(\Delta^{1}, \boldsymbol{V}\right)$ we construct a Weinstein pair through the following surgery presentation. The basic building block associated to $V$ is the Weinstein cobordism ( $V \times$ $\left.D_{\varepsilon} T^{*} \Delta^{1}, \lambda_{V}+2 x d y+y d x\right)$ where $D_{\varepsilon} T^{*} \Delta^{1}$ is the $\varepsilon$-disk cotangent bundle of $\Delta^{1}, y$ is a coordinate in the $\Delta^{1}$-factor and $x$ is a coordinate in the fiber direction. The negative end of this cobordism is $V \times D_{\varepsilon} T^{*}\left(\left.\Delta^{1}\right|_{\partial \Delta^{1}}\right)=(V \times(-\varepsilon, \varepsilon)) \sqcup(V \times(-\varepsilon, \varepsilon))$. Using the Weinstein hypersurfaces $\iota_{1}, \iota_{2} \in \boldsymbol{V}$ we attach the Weinstein cobordism $V \times D_{\varepsilon} T^{*} \Delta^{1}$ to $X_{1} \sqcup X_{2}$ along $(V \times(-\varepsilon, \varepsilon)) \sqcup(V \times(-\varepsilon, \varepsilon))$ and denote the resulting Weinstein manifold by $\# \boldsymbol{V}$, or $X_{1} \#_{V} X_{2}$ using more common notation, as this is nothing but the Weinstein connected sum of $X_{1}$ and $X_{2}$ over $V$ Avd21, ÁGEN22, Eli18.

We require $C^{\prime}$ to be a simplicial subcomplex of $C$ and consider the two cases $C^{\prime}=\Delta^{0}, \Delta^{1}$. $C^{\prime}=\Delta^{0}:$ In this case we set $\boldsymbol{V}^{\prime}=\left\{P^{2 n-2}\right\}$. By Definition 2.3 we now specify a hypersurface inclusion $\left(\Delta^{0}, \boldsymbol{V}^{\prime}\right) \hookrightarrow\left(\Delta^{1}, \boldsymbol{V}\right)$. It consists of an inclusion $\Delta^{0} \hookrightarrow \Delta^{1}$ as a simplicial subcomplex. We include $\Delta^{0}$ into the first vertex, which corresponds to $X_{1}$. Next, we have a Weinstein hypersurface $\iota_{P, 1}: P^{2 n-2} \hookrightarrow \partial X_{1}^{2 n}$ whose image is disjoint from the image of $\iota_{1} \in \boldsymbol{V}$. Item (3) is in fact equivalent to the data provided by item (2), because $\boldsymbol{V}_{\supsetneq \sigma_{0}}=\varnothing$ in this case, where $\sigma_{0}$ is the vertex of $C$ corresponding to $C^{\prime}$. Such a hypersurface inclusion $\left(\Delta^{0}, \boldsymbol{V}^{\prime}\right) \hookrightarrow\left(\Delta^{1}, \boldsymbol{V}\right)$ now allows us to construct the Weinstein pair ( $X_{1} \#_{V} X_{2}, P$ ), by simply taking the Weinstein connected sum of $X_{1}$ and $X_{2}$ along $V$. The Weinstein hypersurface $P$ being disjoint from $V$ in $\partial X_{1}$ ensures that $P$ is a Weinstein hypersurface in $X_{1} \#_{V} X_{2}$, see Figure 2.


Figure 2. Left: The surgery presentation of the Weinstein pair $\left(X_{1} \#_{V} X_{2}, P\right)$. Right: The simplicial subcomplex $C^{\prime} \hookrightarrow C$.
$C^{\prime}=\Delta^{1}:$ In this case $\boldsymbol{V}^{\prime}=\left\{Q^{2 n-4}, P_{1}^{2 n-2}, P_{2}^{2 n-2}, \iota_{Q, 1}: Q \hookrightarrow \partial P_{1}^{2 n-2}, \iota_{Q, 2}: Q \hookrightarrow \partial P_{2}^{2 n-2}\right\}$ where $Q$ is a Weinstein $(2 n-4)$-manifold, $P_{1}$ and $P_{2}$ are Weinstein $(2 n-2)$-manifolds and $\iota_{Q, 1}$ and $\iota_{Q, 2}$ are Weinstein hypersurfaces. This gives the surgery presentation $P=P_{1} \#_{Q} P_{2}$ as described above.
Pick the hypersurface inclusion $\left(\Delta^{1}, \boldsymbol{V}^{\prime}\right) \hookrightarrow\left(\Delta^{1}, \boldsymbol{V}\right)$ such that $\Delta^{1} \hookrightarrow \Delta^{1}$ is the identity map. By the definition Definition 2.3 the hypersurface inclusion additionally consists of the following.
(1) A Weinstein hypersurface $Q^{2 n-4} \hookrightarrow \partial V^{2 n-2}$.
(2) Two Weinstein hypersurfaces $P_{i} \#_{Q} V \hookrightarrow \partial X_{i}$ for $i \in\{1,2\}$.

The Weinstein hypersurface $Q \hookrightarrow \partial V$ extends to a Weinstein hypersurface $Q \times D_{\varepsilon} T^{*} \Delta^{1} \hookrightarrow$ $\partial_{\infty}\left(V \times D_{\varepsilon} T^{*} \Delta^{1}\right)$ which is glued together with each of the negative ends of $Q \times$ $D_{\varepsilon} T^{*} \Delta^{1} \hookrightarrow \partial X_{i}$ along $\partial V$ for $i \in\{1,2\}$. The result is a Weinstein hypersurface $P_{1} \#_{Q} P_{2} \hookrightarrow \partial\left(X_{1} \#_{V} X_{2}\right)$, see Figure 3.


Figure 3. Left: The surgery presentation of the Weinstein pair $\left(X_{1} \#_{V} X_{2}, P_{1} \#_{Q} P_{2}\right)$. Right: The simplicial subcomplex $C^{\prime} \hookrightarrow C$.
$C=\Delta^{2}$ : We consider a simplicial decomposition $\left(\Delta^{2}, \boldsymbol{V}\right)$ of $X$ as follows. Let

$$
\boldsymbol{V}:=\left\{V_{1}^{2 n-2}, V_{2}^{2 n-2}, V_{3}^{2 n-2}, W^{2 n-4}, X_{1}^{2 n}, X_{2}^{2 n}, X_{3}^{2 n}, \iota_{12}, \iota_{23}, \iota_{13}, \iota_{1}, \iota_{2}, \iota_{3}\right\},
$$

where

- $X_{1}, X_{2}$ and $X_{3}$ are Weinstein $2 n$-manifolds corresponding to the vertices of $\Delta^{2}$.
- $V_{1}, V_{2}$ and $V_{3}$ are Weinstein $(2 n-2)$-manifolds corresponding to the edges of $\Delta^{2}$.
- $W$ is a Weinstein $(2 n-4)$-manifold corresponding to the 2 -face of $\Delta^{2}$.
- $\iota_{i}: W \hookrightarrow \partial V_{i}$ is a Weinstein hypersurface for $i \in\{1,2,3\}$ corresponding to the inclusions of the edges into the 2 -simplex.
- $\iota_{12}: V_{1} \#_{W} V_{2} \hookrightarrow \partial X_{3}, \iota_{23}: V_{2} \#_{W} V_{3} \hookrightarrow \partial X_{1}$ and $\iota_{13}: V_{3} \#_{W} V_{1} \hookrightarrow \partial X_{2}$ are Weinstein hypersurfaces corresponding to the inclusion of the vertices into the 2 -simplex.
We describe a simplicial decomposition of the Weinstein pair $(X, P)$ in the two cases $C^{\prime}=\Delta^{1}$ and $C^{\prime}=\Delta^{2}$ below.
$C^{\prime}=\Delta^{1}$ : As above we have a simplicial decomposition over the 1 -simplex $\left(\Delta^{1}, \boldsymbol{V}^{\prime}\right)$ of $P$ so that $P \cong P_{1} \#_{Q} P_{2}$. We choose the hypersurface inclusion $\left(\Delta^{1}, \boldsymbol{V}^{\prime}\right) \hookrightarrow\left(\Delta^{2}, \boldsymbol{V}\right)$ that is given by the following.
(1) An inclusion $\Delta^{1}$ as a simplicial subcomplex of $\Delta^{2}$ as the edge corresponding to $V_{1}$.
(2) A Weinstein hypersurface $Q^{2 n-4} \hookrightarrow \partial V_{1}^{2 n-2}$.
(3) Two Weinstein hypersurfaces $P_{1} \#_{Q} V_{1} \hookrightarrow \partial X_{2}$ and $P_{2} \#_{Q} V_{1} \hookrightarrow \partial X_{3}$.

As before the Weinstein hypersurface $Q \hookrightarrow \partial V$ extends to a Weinstein hypersurface $Q \times D_{\varepsilon} T^{*} \Delta^{1} \hookrightarrow \partial_{\infty}\left(V \times D_{\varepsilon} T^{*} \Delta^{1}\right)$ which results in a Weinstein hypersurface $P_{1} \#_{Q} P_{2} \hookrightarrow$ $\partial X$, see Figure 4


Figure 4. Left: The surgery presentation of the Weinstein pair ( $\# \boldsymbol{V}, P_{1} \#_{Q} P_{2}$ ). Right: The simplicial subcomplex $C^{\prime} \hookrightarrow C$ included as the edge in $C=\Delta^{2}$ connecting the vertices 2 and 3 .
$C^{\prime}=\Delta^{2}$ : Pick a simplicial decomposition $\left(\Delta^{2}, \boldsymbol{V}^{\prime}\right)$ of $P$ as follows. Let

$$
\boldsymbol{V}^{\prime}:=\left\{Q_{1}^{2 n-4}, Q_{2}^{2 n-4}, Q_{3}^{2 n-4}, R^{2 n-6}, P_{1}^{2 n-2}, P_{2}^{2 n-2}, P_{3}^{2 n-2}, j_{12}, j_{23}, j_{13}, j_{1}, j_{2}, j_{3}\right\}
$$

where

- $P_{1}, P_{2}$ and $P_{3}$ are Weinstein $(2 n-2)$-manifolds corresponding to the vertices of $\Delta^{2}$.
- $Q_{1}, Q_{2}$ and $Q_{3}$ are Weinstein $(2 n-4)$-manifolds corresponding to the edges of $\Delta^{2}$.
- $R$ is a Weinstein $(2 n-6)$-manifold corresponding to the 2 -face of $\Delta^{2}$.
- $j_{i}: R \hookrightarrow \partial Q_{i}$ is a Weinstein hypersurface for $i \in\{1,2,3\}$ corresponding to the inclusions of the edges into the 2-simplex.
- $j_{12}: Q_{1} \#_{R} Q_{2} \hookrightarrow \partial P_{3}, j_{23}: Q_{2} \#_{R} Q_{3} \hookrightarrow \partial P_{1}$ and $j_{13}: Q_{3} \#_{R} Q_{1} \hookrightarrow \partial P_{2}$ are Weinstein hypersurfaces corresponding to the inclusion of the vertices into the 2simplex.
We choose the hypersurface inclusion $\left(\Delta^{2}, \boldsymbol{V}^{\prime}\right) \hookrightarrow\left(\Delta^{2}, \boldsymbol{V}\right)$ that is given by the following.
(1) The identity map $\Delta^{2} \hookrightarrow \Delta^{2}$.
(2) Weinstein hypersurfaces $Q_{i} \hookrightarrow \partial V_{i}$ for $i \in\{1,2,3\}$ whose images are disjoint from the images of $\iota_{i} \in \boldsymbol{V}$.
(3) A Weinstein hypersurface $\iota_{R}: R \hookrightarrow \partial W$.
(4) Weinstein hypersurfaces $\iota_{i, R}: Q_{i} \#{ }_{R} W \hookrightarrow \partial V_{i}$ for $i \in\{1,2,3\}$.
(5) Weinstein hypersurfaces $\# \widetilde{\boldsymbol{V}}_{i} \hookrightarrow \partial X_{i}$ for $i \in\{1,2,3\}$ where

$$
\begin{aligned}
\tilde{\boldsymbol{V}}_{i}:= & \left\{P_{i}, R, W, \iota_{R}\right\} \\
& \cup\left\{Q_{k}, V_{k}, j_{k}, \iota_{k, R}\right\}_{k \in\{1,2,3\} \backslash\{i\}} \cup\left\{j_{k \ell}\right\}_{\{k, \ell\}=\{1,2,3\} \backslash\{i\}}
\end{aligned}
$$

see Figure 5.
Each Weinstein hypersurface $\iota_{k, R}$ extends over the 1-simplex handles $V_{k} \times D_{\varepsilon} T^{*} \Delta^{1}$ to a Weinstein hypersurface

$$
\left(Q_{k} \#_{R} W\right) \times D_{\varepsilon} T^{*} \Delta^{1} \hookrightarrow \partial_{\infty}\left(V_{k} \times D_{\varepsilon} T^{*} \Delta^{1}\right),
$$



Figure 5. Part of the Weinstein hypersurface $P=\# \boldsymbol{V}^{\prime}$ lying in $\partial X_{2}$.
and the Weinstein hypersurface $\iota_{R}: R \hookrightarrow \partial W$ extends to a Weinstein hypersurface $R \times D_{\varepsilon} T^{*} \Delta^{2} \hookrightarrow \partial_{\infty}\left(W \times D_{\varepsilon} T^{*} \Delta^{2}\right)$. These Weinstein hypersurfaces all glue together the same way as 2 -simplex handles are defined, see Asp23, Section 2.2]. The result is a Weinstein hypersurface $\# \boldsymbol{V}^{\prime} \hookrightarrow \partial(\# \boldsymbol{V})$, see Figure 6 .


Figure 6. The Weinstein hypersurface $\# \boldsymbol{V}^{\prime} \hookrightarrow \partial \# \boldsymbol{V}$ depicted in red.
Remark 2.5. From the point of view of Weinstein sectors, part of the the surgery description presented above corresponds to partial gluing of two Weinstein sectors along a shared subsector in the boundary, which was already described in [GPS22, Construction 12.18].
2.1.1. Good sectorial covers for sectors. The notion of a good sectorial cover of a Weinstein manifold introduced in Asp23 now has a natural extension to Weinstein sectors. First recall the definition of a sectorial cover of a Liouville sector.

Definition 2.6 (Sectorial cover GPS22, Definition 12.2 and Definition 12.19]). Let $X$ be a Liouville sector. Suppose $X=X_{1} \cup \cdots \cup X_{n}$, where each $X_{i}$ is a manifold-with-corners with precisely two faces $\partial^{1} X_{i}:=X_{i} \cap \partial X$ and the point set topological boundary $\partial^{2} X_{i}$ of $X_{i} \subset X$, meeting along the corner locus $\partial X \cap \partial^{2} X_{i}=\partial^{1} X_{i} \cap \partial^{2} X_{i}$. Such a covering $X=X_{1} \cup \cdots \cup X_{n}$ is called sectorial if and only if $\forall i \in\{1, \ldots, n\}$ there are functions $I_{i}: N^{Z}\left(\partial^{2} X_{i}\right) \longrightarrow \mathbb{R}$ (where $N^{Z}$ denotes a neighborhood which is cylindrical with respect to the Liouville vector field $Z$ ) which is linear at infinity such that:

- $X_{I_{i}}$ is outward pointing along $\partial^{2} X_{i}$.
- $X_{I_{i}}$ is tangent to $\partial^{2} X_{j}$ along $\partial^{2} X_{i} \cap \partial^{2} X_{j}$ for $i \neq j$.
- $\left[X_{I_{i}}, X_{I_{j}}\right]=0$ along $N^{Z}\left(\partial^{2} X_{i}\right) \cap N^{Z}\left(\partial^{2} X_{j}\right)$.

Lemma $2.7\left(\boxed{G P S 22}\right.$, Lemma 12.11]). Let $X$ be a Liouville sector and suppose $X=X_{1} \cup \cdots \cup X_{n}$ is a sectorial cover. For any $\varnothing \neq A \subset\{1, \ldots, n\}$ we have a Liouville isomorphism

$$
\begin{equation*}
N^{Z}\left(\bigcap_{i \in A} \partial^{2} X_{i}\right) \cong\left(X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}, \lambda_{X_{A}^{(k)}}+\lambda_{T^{*} \mathbb{R}^{k}}+d f\right) \tag{2.1}
\end{equation*}
$$

where $k:=|A|-1, X_{A}^{(k)}$ is a $(2 n-2 k)$-dimensional Weinstein manifold and $f$ is a real-valued function on $X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}$ with support in $K \times T^{*} \mathbb{R}^{k}$ for some compact $K \subset X_{A}^{(k)}$.

Definition 2.8 (Good sectorial cover). Let $X$ be a Weinstein sector, and suppose $X=X_{1} \cup \cdots \cup X_{m}$ is a sectorial cover. We say that the sectorial cover is good if for every $\varnothing \neq A \subset\{1, \ldots, m\}$ we have a Weinstein isomorphism

$$
\begin{equation*}
N^{Z}\left(\bigcap_{i \in A} X_{i}\right) \cong\left(X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}, \lambda_{X_{A}^{(k)}}+\lambda_{T^{*} \mathbb{R}^{k}}+d f\right) \tag{2.2}
\end{equation*}
$$

extending the Weinstein isomorphism (2.1), where $k:=|A|-1, X_{A}^{(k)}$ is a $(2 n-2 k)$-dimensional Weinstein sector and $f$ is a real-valued function on $X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}$ with support in $K \times T^{*} \mathbb{R}^{k}$ for some compact $K \subset X_{A}^{(k)}$.

Definition 2.9 (Simplicial decomposition of a Weinstein sector). A simplicial decomposition of a Weinstein sector $X$ is defined to be a simplicial decomposition of the Weinstein pair $(\widetilde{X}, P)$ which corresponds to $X$ via convex completion.

Theorem 2.10. Let $X$ be a Weinstein sector. There is a one-to-one correspondence (up to Weinstein homotopy) between good sectorial covers of $X$ and simplicial decompositions of $X$.

Proof. This is similar and a slight generalization of Asp23, Theorem 3.11].
Given a simplicial decomposition $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ of the Weinstein pair $(\tilde{X}, P)$, it follows from Asp23, Theorem 3.11] that we obtain a good sectorial cover $\widetilde{X}=\widetilde{X}_{1} \cup \cdots \cup \widetilde{X}_{m}$ of $\widetilde{X}$. By definition we have that for any $\varnothing \neq A \subset\{1, \ldots, m\}$

$$
N^{Z}\left(\bigcap_{i \in A} \widetilde{X}_{i}\right) \cong X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}
$$

where each $X_{A}^{(k)}$ is a Weinstein $(2 n-2 k)$-manifold. Letting $P_{A}:=\left.P\right|_{A}$ with the restricted Weinstein structure gives a Weinstein manifold $P_{A} \hookrightarrow \partial X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}$ which comes from a Weinstein hypersurface $P_{A}^{\prime} \hookrightarrow \partial X_{A}^{(k)}$. Each pair $\left(X_{A}^{(k)}, P_{A}^{\prime}\right)$ corresponds to a Weinstein $(2 n-2 k)$-sector $X_{A}^{(k)^{\prime}}$ via convex completion GPS20, Section 2.7], and thus $\widetilde{X}_{1} \cup \cdots \cup \widetilde{X}_{m}$ is a good sectorial cover of $(\widetilde{X}, P)$, which by definition is a good sectorial cover for $X$.

To finish the proof we need to reconstruct the simplicial decomposition $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ of $(\tilde{X}, P)$ using the good sectorial cover $X_{1} \cup \cdots \cup X_{m}$ of $X$. For any $\varnothing \neq A \subset\{1, \ldots, m\}$ we have

$$
N^{Z}\left(\bigcap_{i \in A} X_{i}\right) \cong X_{A}^{(k)} \times T^{*} \mathbb{R}^{k}
$$

where each $X_{A}^{(k)}$ is a Weinstein $(2 n-2 k)$-sector which via convex completion [GPS20, Section 2.7] corresponds to the Weinstein pair $\left(X_{A}^{(k)^{\prime}}, P_{A}^{\prime}\right)$. The simplicial complex $C$ is given by the Čech nerve of the cover $X_{1} \cup \cdots \cup X_{m}$ of $X$. The simplicial subcomplex $i: C^{\prime} \hookrightarrow C$ is given by the Čech nerve of the restriction of the cover $X_{1} \cup \cdots \cup X_{m}$ to $\partial X$. The Weinstein hypersurface $P_{A}^{\prime}$ is precisely of the form $\#\left(\boldsymbol{V}_{\supset \sigma_{k}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\supsetneq \sigma_{k}}\right) \hookrightarrow \partial X_{A}^{(k)^{\prime}}$ where $\sigma_{k}$ is the face corresponding to $A \subset\{1, \ldots, m\}$. Forgetting the Weinstein hypersurface $P$ makes $X_{1} \cup \cdots \cup X_{m}$ a good sectorial cover of $\widetilde{X}$ which via Asp23, Theorem 3.11] corresponds to a simplicial decomposition $(C, \boldsymbol{V})$. The set $\boldsymbol{V}_{\partial \sigma_{k}^{\prime}}^{\prime}$ consists of the Weinstein manifolds which are restrictions of $P_{A}^{\prime}$ to further intersections, with the corresponding Weinstein hypersurfaces which also is equal to a restriction of $P \hookrightarrow \partial \widetilde{X}$. Taking the union over all $\varnothing \neq A \subset\{1, \ldots, m\}$ we obtain $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right)$ which by construction is a simplicial decomposition of $P$, and by construction we have a hypersurface inclusion $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right) \hookrightarrow(C, \boldsymbol{V})$.
2.2. Weinstein hypersurfaces and simplicial decompositions. We now review the definition of the Chekanov-Eliashberg dg-algebra of a Weinstein hypersurface with a chosen handle decomposition from AE22 and review its relationship to Chekanov-Eliashberg dg-algebras with loop space coefficients. We describe the Chekanov-Eliashberg dg-algebra of a Weinstein hypersurface with respect to a simplicial decomposition of the corresponding Weinstein pair.

Let $X$ be a Weinstein $2 n$-manifold and let $V^{2 n-2} \hookrightarrow \partial X^{2 n}$ be a Weinstein hypersurface. Fix a Weinstein handle decomposition $h$ of $V$ which encodes both the Weinstein handles and the attaching maps. Now let $X_{V}$ be the Weinstein cobordism obtained by attaching the 1 -simplex handle $V \times D_{\varepsilon} T^{*} \Delta^{1}$ to $X \sqcup(\mathbb{R} \times(V \times \mathbb{R}))$, and let $\Sigma(h)$ denote the union of attaching spheres of the top handles of $V \times D_{\varepsilon} T^{*} \Delta^{1}$ in $X_{V}$. This is a link of Legendrian spheres in the positive end of $X_{V_{0}}$. The union of Legendrian spheres $\Sigma(h)$ has the following geometric description.


Figure 7. The Weinstein cobordism $X_{V}$ which we identify as the Weinstein manifold $X$ stopped at the Weinstein hypersurface $V \hookrightarrow \partial X$.

Lemma 2.11. Let $\ell:=\bigcup_{j} \ell_{j}$ denote the union of the core disks of the top handles in $h$. Then we have

$$
\Sigma(h)=\ell \cup_{\partial \ell \times\{-1\}}\left(\partial \ell \times \Delta^{1}\right) \cup_{\partial \ell \times\{1\}} \ell .
$$

Additionally let $\kappa:=\bigcup_{i} \kappa_{i}$ denote the union of attaching spheres of the top handles of $X$. Then $\Sigma(h) \cup \kappa$ is the union of attaching spheres of the top Weinstein handles of $X_{V}$.

Proof. This is part of [AE22, Lemma 3.1], cf. Asp23, Definition 2.20].
Lemma 2.12. For all $\mathfrak{a}>0$ there exists some $\delta>0$ and an arbitrary small perturbation of $V_{0}$ such that for all $0<\varepsilon<\delta$ the Reeb chords of $\Sigma(h)$ of action $<\mathfrak{a}$ are in one-to-one grading preserving correspondence with Reeb chords of $\ell \subset \partial X_{0}$, and Reeb chords of $\partial \ell \subset \partial V_{0}$ of action $<\mathfrak{a}$.

Proof. See [AE22, Lemma 2.3], cf. Asp23, Lemma 2.24].
Definition 2.13 ([AE22, Definition 3.2]). Let $X$ be a Weinstein manifold and $V \hookrightarrow \partial X$ a Weinstein hypersurface together with a chosen handle decomposition $h$ of $V$. We define the ChekanovEliashberg dg-algebra of the pair $(V, h)$ as

$$
C E^{*}((V, h) ; X):=C E^{*}\left(\Sigma(h) ; X_{V_{0}}\right)
$$

Lemma 2.14 ( AE22, Corollary 2.11]). There is a dg-subalgebra of $C E^{*}((V, h) ; X)$ which is canonically quasi-isomorphic to $C E^{*}\left(\partial \ell ; V_{0}\right)$.
Lemma 2.15 ( AE22, Lemma 4.2]). Let $X$ be a Weinstein manifold and $\Lambda \subset \partial X$ a smooth Legendrian submanifold. Let $V$ be a small cotangent neighborhood of $\Lambda$ and let $h$ be a choice of handle decomposition of $V$ with a single top handle. There is a quasi-isomorphism of dg-algebras

$$
C E^{*}\left(\partial \ell ; V_{0}\right) \cong C_{-*}(\Omega \Lambda)
$$

Proof. The idea of the proof is to construct a map $\varphi: C E^{*}\left(\partial \ell ; V_{0}\right) \longrightarrow C_{-*}(\Omega \Lambda)$ by counting $J$-holomorphic curves in $V_{0}$ such that the following diagram commutes up to dg-homotopy.


Here $F$ denotes a cotangent fiber in the Weinstein neighborhood $T^{*} \Lambda$ of $\Lambda \subset \partial X$. The map $\Psi$ is the surgery $A_{\infty}$-quasi-isomorphism from [BEE12], and $\Phi$ is the $A_{\infty}$-quasi-isomorphism from Abo12, Asp21, see AE22, Section 4] for details.

The following is now an immediate consequence of Lemma 2.15 and one of the main results of AE22.

Theorem 2.16 ( AE22, Theorem 1.2]). Let $X$ be a Weinstein manifold and $\Lambda \subset \partial X$ a smooth (possibly disconnected) Legendrian submanifold. Let $V$ be a small cotangent neighborhood of $\Lambda$ and let $h$ be a choice of handle decomposition such that $V$ has a single top handle for each component of $V$. There is a quasi-isomorphism of dg-algebras

$$
C E^{*}((V, h) ; X) \cong C E^{*}\left(\Lambda, C_{-*}\left(\bigsqcup_{i \in \pi_{0}(\Lambda)} \Omega \Lambda_{i}\right)\right),
$$

where $\Lambda_{i}$ denotes the $i$-th component of $\Lambda$ and where $C E^{*}\left(\Lambda, C_{-*}(\Omega \Lambda)\right)$ is the Chekanov-Eliashberg dg-algebra with loop space coefficients as defined in EL17].
Proof. See [AE22, Section 4].

Let $(X, P)$ be a Weinstein pair and let $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ be a simplicial decomposition of $(X, P)$. Pick a handle decomposition for each $V_{\sigma_{k}} \in \boldsymbol{V}$ and denote the set of all such by $\boldsymbol{h}$. Similarly let $\boldsymbol{h}^{\prime}$ denote the set of chosen handle decompositions of each $V_{\sigma_{k}^{\prime}}^{\prime} \in \boldsymbol{V}^{\prime}$. The union of the top attaching spheres of $X \cong \# \boldsymbol{V}$ is denoted by $\Sigma(\boldsymbol{h})$, see Asp23, Definition 2.20 and Lemma 2.21] for details on the constructions.


Figure 8. The Weinstein hypersurface $P \hookrightarrow \partial X$ presented as a join with respect to the simplicial decomposition $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right),\left(\boldsymbol{A}, \boldsymbol{A}^{\prime}\right)\right)$ where $C=C^{\prime}=\Delta^{2}$ and the simplicial subcomplex $C^{\prime} \hookrightarrow C$ being the identity map.

We now describe the union of the top attaching spheres of $X_{P}$ with respect to the simplicial decomposition of $(X, P)$. Let $\ell^{\prime}=\bigcup_{\sigma_{k}^{\prime} \in C^{\prime}} \ell_{\sigma_{k}^{\prime}}^{\prime}=\bigcup_{\sigma_{k}^{\prime} \in C^{\prime}} \bigcup_{j} \ell_{\sigma_{k}^{\prime}, j}^{\prime}$ denote the union of the core disks of the top handles of each $V_{\sigma_{k}^{\prime}}^{\prime} \in \boldsymbol{V}^{\prime}$. Let $i: C^{\prime} \hookrightarrow C$ be the simplicial subcomplex in the simplicial decomposition of $(X, P)$. For every $\sigma_{0} \in \operatorname{im} i$ we have the Weinstein hypersurface

$$
\begin{equation*}
\#\left(\boldsymbol{V}_{\supset \sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\supsetneq \sigma_{0}}\right) \hookrightarrow \partial V_{\sigma_{0}} \tag{2.3}
\end{equation*}
$$

as in Definition 2.3, see Figure 9.
Denote the union of the top attaching spheres of the $\#\left(\boldsymbol{V}_{\supset \sigma_{0}}^{\prime} \sqcup_{i} \boldsymbol{V} \supsetneq \sigma_{0}\right)$ by $\Sigma\left(\boldsymbol{h}_{\sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{h}_{\sigma_{0}}\right)$ where $\boldsymbol{h}_{\sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{h}_{\sigma_{0}}$ is the union of handle decompositions of the Weinstein manifolds in $\boldsymbol{V}_{\supset \sigma_{0}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\supsetneq \sigma_{0}}$. Let $\Delta\left(\boldsymbol{h}_{\sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{h}_{\sigma_{0}}\right)$ be the corresponding union of core disks of the top handles in $\boldsymbol{h}_{\sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{h}_{\sigma_{0}}$, and note that topologically $\Delta\left(\boldsymbol{h}_{\sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{h}_{\sigma_{0}}\right)$ is a union of $(n-1)$-disks in $\partial V_{\sigma_{0}}$ via the Weinstein embedding (2.3).

We then extend every $\Delta\left(\boldsymbol{h}_{\sigma_{0}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{h}_{\sigma_{0}}\right)$ trivially $\# \boldsymbol{V} \cong X$ and denote the result by $\Sigma_{P}\left(\boldsymbol{h}^{\prime}\right)$. The result is the union of top attaching spheres of the Weinstein manifold $P \cong \# \boldsymbol{V}^{\prime}$, see Asp23, Definition 2.20]. By construction we have a decomposition $\Sigma_{P}\left(\boldsymbol{h}^{\prime}\right)=\bigcup_{\sigma_{k}^{\prime} \in C^{\prime}} \Sigma_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)$, where $\Sigma_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)$ is the union of the top attaching spheres of $P$ living over the locus corresponding to the $k$-face $\sigma_{k}^{\prime} \in C^{\prime}$.

Lemma 2.17. The union of $(n-1)$-spheres $\Sigma_{P}\left(\boldsymbol{h}^{\prime}\right)$ is the union of the attaching spheres of the top handles of the Weinstein manifold $P$.

Proof. This is repetition of the proof of Asp23, Lemma 2.21].

The Weinstein hypersurface $\#\left(\boldsymbol{V}_{\supset\left(\sigma_{0}\right)_{2}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\left.\supsetneq\left(\sigma_{0}\right)_{2}\right)}\right) \hookrightarrow \partial X_{\left(\sigma_{0}\right)_{2}}$ which is a part of the construction of $P \hookrightarrow \partial X$ with respect to the simplicial decomposition $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ as in Figure 8. The Weinstein hypersurfaces $V_{\left(\sigma_{1}^{\prime}\right)_{3}}^{\prime} \#_{V_{\sigma_{2}^{\prime}}^{\prime}} W \hookrightarrow \partial V_{3}$ and $V_{\left(\sigma_{1}^{\prime}\right)_{1}}^{\prime} \# V_{\sigma_{2}^{\prime}} W \hookrightarrow \partial \overline{V_{1}}$ are also depicted.


Figure 10. The first gluing step in the construction of the Weinstein hypersurface $\#\left(\boldsymbol{V}_{\supset\left(\sigma_{0}\right)_{2}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\left.\supsetneq\left(\sigma_{0}\right)_{2}\right)}\right) \hookrightarrow \partial X_{\left(\sigma_{0}\right)_{2}}$ in Figure 9.

Let $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right)$ denote the union of the core disks of the top handles in $\boldsymbol{h}^{\prime}$. Since we have a Weinstein hypersurface $P \hookrightarrow \partial X$, it follows that $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right)$ is a Legendrian submanifold in $\partial X$ with boundary in $\partial P$. Like the attaching spheres, the core disks also decompose as $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right)=\bigcup_{\sigma_{k}^{\prime} \in C^{\prime}} \Delta_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)$ where $\Delta_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)$ is the core disk with boundary $\partial \Delta_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)=\Sigma_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)$.

Our next task is to describe the Chekanov-Eliashberg dg-algebra of the pair $\left(P, \boldsymbol{h}^{\prime}\right)$ in $X$. To that end, we construct $X_{P_{0}}$ by attaching the handle $P_{0} \times D_{\varepsilon} T^{*} \Delta^{1}$ to $X \sqcup(\mathbb{R} \times(P \times \mathbb{R}))$. By Lemma 2.11 we have that the union of attaching spheres of $X_{P_{0}}$ is

$$
\begin{equation*}
\Sigma_{X_{P}}\left(\boldsymbol{h}^{\prime}\right):=\Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \cup_{\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \times\{-1\}}\left(\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \times \Delta^{1}\right) \cup_{\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \times\{1\}} \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) . \tag{2.4}
\end{equation*}
$$

Below a given action bound on Reeb chords, and for arbitrarily thin simplicial handles it follows from Lemma 2.12 that the Reeb chords of $\Sigma_{X_{P}}\left(\boldsymbol{h}^{\prime}\right)$ corresponds to Reeb chords of $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \subset \partial X_{0}$ and Reeb chords of $\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right)=\Sigma_{P}\left(\boldsymbol{h}^{\prime}\right) \subset \partial P_{0}$.

Definition 2.18 (Asp23, Definition 2.22]). Let $(C, \boldsymbol{V})$ be a simplicial decomposition of $X$ and let $\boldsymbol{h}$ be a choice of handle decomposition of $\boldsymbol{V}$. Denote the union of core disks of the top handles in $h$ by $\ell$.
(1) Let $\mathcal{R}_{X}\left(\sigma_{k}\right)$ denote the set of Reeb chords of $\partial \ell_{\sigma_{k}} \cup \bigcup_{\substack{\sigma_{i} \supset \sigma_{k} \\ k+1 \leq i \leq m}}\left(\ell_{\sigma_{i}} \times \Delta^{i-k-1}\right) \subset \partial V_{\sigma_{k}, 0}^{(k)}$ for $k \in\{0, \ldots, m\}$, where $\ell_{\sigma_{i}} \times \Delta^{i-k-1}$ are the core disks of the top handles of $V_{\sigma_{i}, 0}^{(i)} \times$ $D_{\varepsilon} T^{*} \Delta^{i-k-1} \hookrightarrow \partial V_{\sigma_{k}, 0}^{(k)}$.
(2) Let $\mathcal{R}_{X}\left(\sigma_{k}, \mathfrak{a}\right)$ denote the set of Reeb chords in $\mathcal{R}_{X}\left(\sigma_{k}\right)$ of action $<\mathfrak{a}$.

Definition 2.19. Let $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ be a simplicial decomposition of the Weinstein pair $(X, P)$. Let $\boldsymbol{h}$ and $\boldsymbol{h}^{\prime}$ be choices of handle decompositions of $\boldsymbol{V}$ and $\boldsymbol{V}^{\prime}$ respectively. Denote the union of core disks of the top handles in $\boldsymbol{h}$ and $\boldsymbol{h}^{\prime}$ by $\ell$ and $\ell^{\prime}$ respectively.
(1) Let $\mathcal{R}_{(X, P)}\left(\sigma_{k}^{\prime}\right)$ denote the set of Reeb chords of $\ell_{\sigma_{k}^{\prime}}^{\prime} \cup \bigcup \underset{\substack{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime} \\ k+1 \leq i \leq m^{\prime}}}{ }\left(\ell_{\sigma_{i}^{\prime}}^{\prime} \times \Delta^{i-k}\right)$ for $k \in$ $\left\{0, \ldots, m^{\prime}\right\}$, where $\ell_{\sigma_{i}^{\prime}}^{\prime} \times \Delta^{i-k}$ are the core disks of the top handles of $V_{\sigma_{i}^{\prime}, 0}^{(i)} \times D_{\varepsilon} T^{*} \Delta^{i-k} \hookrightarrow$ $\partial V_{\sigma_{k}, 0}^{(k)}$.
(2) Let $\mathcal{R}_{(X, P)}\left(\sigma_{k}^{\prime}, \mathfrak{a}\right)$ denote the set of Reeb chords in $\mathcal{R}_{(X, P)}\left(\sigma_{k}^{\prime}\right)$ of action $<\mathfrak{a}$.

Recall that the precise construction of $\# \boldsymbol{V}$ depends on a size parameter $\boldsymbol{\varepsilon}=\left\{0<\varepsilon_{m}<\cdots<\varepsilon_{1}\right\}$, where each $\varepsilon_{k}>0$ is the size of the simplicial handle $H_{\varepsilon_{k}}^{k}\left(V_{\sigma_{k}}^{2 n-2 k}\right)$, see [Asp23, Definition 2.11]. For notational simplicity we write $0<\varepsilon<\delta$ to mean $0<\varepsilon_{m}$ and $\varepsilon_{1}<\delta$.

Lemma 2.20. For all $\mathfrak{a}>0$ there exists some $\delta>0$ and an arbitrary small perturbation of $\boldsymbol{V}_{0}$ such that for all $0<\varepsilon<\delta$ the following holds.
(1) There is a one-to-one grading preserving correspondence between Reeb chords of action $<\mathfrak{a}$ of $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \subset \partial X_{0}$ and Reeb chords in $\bigcup_{\substack{\sigma_{k}^{\prime} \in C^{\prime} \\ 0 \leq k \leq m^{\prime}}} \mathcal{R}_{(X, P)}\left(\sigma_{k}^{\prime}, \mathfrak{a}\right)$.
(2) There is a one-to-one grading preserving correspondence between Reeb chords of $\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \subset$ $\partial P_{0}$ of action $<\mathfrak{a}$ and Reeb chords in $\bigcup_{\substack{\sigma_{k}^{\prime} \in C^{\prime} \\ 0 \leq k \leq m^{\prime}}} \mathcal{R}_{P}\left(\sigma_{k}^{\prime}, \mathfrak{a}\right)$.

Proof. (1) It follows from the construction of $\# \boldsymbol{V}$ that Reeb chords of $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right) \subset \partial X_{0}$ of action $<\mathfrak{a}$ (possibly after shrinking the size of the simplicial handles) are contained in $\pi^{-1}(0,0)$ where $\pi: \partial V_{\sigma_{k}}^{(k)} \times D_{\varepsilon} T^{*} \Delta^{k} \longrightarrow D_{\varepsilon} T^{*} \Delta^{k}$ is the projection to the second factor, corresponding to each $\sigma_{k} \in C$, see Asp23, Lemma 2.24]. It follows from the construction of $\Delta_{P}\left(\boldsymbol{h}^{\prime}\right)$ that the part lying in the positive contact boundary of $V_{\sigma_{k}}^{(k)} \times D_{\varepsilon} T^{*} \Delta^{k}$ has the form $\left(\ell_{\sigma_{k}^{\prime}}^{\prime} \times \Delta^{k}\right) \cup$ $\bigcup \sigma_{i}^{\prime} \partial \sigma_{k}^{\prime}\left(\ell_{\sigma_{i}^{\prime}}^{\prime} \times \Delta^{i}\right)$ from which the result follows. $k+1 \leq i \leq m^{\prime}$
(2) The proof is the same as in (1) above.
2.3. Simplicial descent for Weinstein pairs. Let $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ be a simplicial decomposition of a Weinstein pair $(X, P)$. In this section we prove that we have a gluing formula for the Chekanov-Eliashberg dg-algebra $C E^{*}\left(\left(P, \boldsymbol{h}^{\prime}\right) ; X\right)$. In a special case this may be regarded as a gluing formula for the Chekanov-Eliashberg dg-algebra with loop space coefficients, see Remark 2.24.

Let $\boldsymbol{h}$ and $\boldsymbol{h}^{\prime}$ be handle decompositions of $\boldsymbol{V}$ and $\boldsymbol{V}^{\prime}$ respectively, as in Section 2.2. Let $\Sigma_{X_{P}}\left(\boldsymbol{h}^{\prime}\right) \subset$ $\partial X_{P_{0}}$ be the union of the top attaching spheres of the simplicial handle $P_{0} \times D_{\varepsilon} T^{*} \Delta^{1}$. We use the notation

$$
\Delta_{P, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right):=\bigcup_{\substack{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime} \\ k \leq i \leq m^{\prime}}} \Delta_{P, \sigma_{i}^{\prime}}\left(\boldsymbol{h}^{\prime}\right), \quad \Sigma_{X_{P}, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right):=\bigcup_{\substack{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime} \\ k \leq i \leq m^{\prime}}} \Sigma_{X_{P}, \sigma_{i}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) .
$$

From Asp23, Section 2.5.1] we recall the following. For each $k$-face $\sigma_{k} \in C$ define

$$
\tilde{V}_{\sigma_{i}}^{(i)}\left(\sigma_{k}\right):= \begin{cases}V_{\sigma_{i}}^{(i)} & \text { if } \sigma_{i} \supset \sigma_{k}  \tag{2.5}\\ (-\infty, 0] \times \bigsqcup_{f \in F}\left(\# \widetilde{\boldsymbol{V}}_{\supsetneq \sigma_{i}, f}\left(\sigma_{k}\right)\right) \times \mathbb{R} & \text { otherwise }\end{cases}
$$

where $\widetilde{\boldsymbol{V}}_{\supsetneq \sigma_{i}, f}\left(\sigma_{k}\right)$ is the set of Weinstein manifolds $\widetilde{V}_{\sigma_{\ell}}^{(\ell)}\left(\sigma_{k}\right)$ for $f \supset \sigma_{\ell} \supsetneq \sigma_{i}$ with the same Weinstein hypersurfaces as in $\boldsymbol{V}$, and the Weinstein hypersurfaces induced by the inclusion $\{0\} \times(W \times\{0\}) \hookrightarrow$ $(-\infty, 0] \times(W \times \mathbb{R})$ for those $\widetilde{V}_{\sigma_{\ell}}^{(\ell)}\left(\sigma_{k}\right)$ of the form as in the bottom row of 2.5). Finally define $\widetilde{\boldsymbol{V}}\left(\sigma_{k}\right):=\bigcup_{\sigma_{i} \subset f}^{f \in F} \widetilde{\boldsymbol{V}}_{\supsetneq \sigma_{i}, f}\left(\sigma_{k}\right)$ and

$$
\begin{equation*}
X\left(\sigma_{k}\right):=\# \tilde{\boldsymbol{V}}\left(\sigma_{k}\right) . \tag{2.6}
\end{equation*}
$$

Similarly, for each $\sigma_{k} \in C$ we define the Weinstein hypersurface $P\left(\sigma_{k}\right) \hookrightarrow \partial X\left(\sigma_{k}\right)$ as follows. If $\sigma_{k} \notin \operatorname{im} i$, then $P\left(\sigma_{k}\right):=P$. Else $P\left(\sigma_{k}^{\prime}\right)$ is defined in analogy with $X\left(\sigma_{k}\right)$ above.
Lemma 2.21. For all $\mathfrak{a}>0$ there exists some $\delta>0$ and an arbitrary small perturbation of $\boldsymbol{V}_{0}$ such that for all $0<\varepsilon<\delta$ the following holds.
(1) There is a one-to-one grading preserving correspondence between Reeb chords of action $<\mathfrak{a}$ of $\partial \Delta_{P, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) \subset \partial P\left(\sigma_{k}^{\prime}\right)_{0}$ and Reeb chords in $\bigcup_{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}} \mathcal{R}_{P}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right)$.
(2) There is a one-to-one grading preserving correspondence between Reeb chords of action $<\mathfrak{a}$ of $\Delta_{P, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) \subset \partial\left(X\left(\sigma_{k}^{\prime}\right)\right)_{P\left(\sigma_{k}^{\prime}\right)_{0}}$ and Reeb chords in $\bigcup_{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}} \mathcal{R}_{(X, P)}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right)$.
(3) There is a one-to-one grading preserving correspondence between Reeb chords of action $<\mathfrak{a}$ of $\left.\Sigma_{X_{P}, \supset \sigma_{k}^{\prime}} \boldsymbol{h}^{\prime}\right) \subset \partial\left(X\left(\sigma_{k}^{\prime}\right)\right)_{P\left(\sigma_{k}^{\prime}\right)_{0}}$ and Reeb chords in $\bigcup_{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}}\left(\mathcal{R}_{(X, P)}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right) \cup \mathcal{R}_{P}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right)\right)$.
Proof. (1) This follows from Asp23, Lemma 2.36].
(2) For sufficient thin handles, the Reeb chords in $\bigcup_{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}} \mathcal{R}_{(X, P)}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right)$ corresponds to Reeb chords of $\Delta_{P, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) \subset \partial X_{P_{0}}$ appearing in the loci of the contact boundary of $X_{P_{0}}$ corresponding to $\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}$ in the simplicial decomposition of $X$ in as in the proof of Lemma 2.20. These loci in $X_{P_{0}}$ are precisely those that are unchanged in the definition of $\boldsymbol{V}\left(\sigma_{k}^{\prime}\right)$, see (2.5). The previously existing Reeb chords of $\Delta_{P, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) \subset \partial X_{P_{0}}$ lying over critical points in loci corresponding to $i$-faces $\sigma_{i}^{\prime} \not \supset \sigma_{k}^{\prime}$ disappear when passing to $\partial\left(X\left(\sigma_{k}^{\prime}\right)\right)_{P\left(\sigma_{k}^{\prime}\right)_{0}}$, as the contact manifold in these loci are of the form $W \times \mathbb{R}$, where the Legendrian is contained in the $\mathbb{R}$-factor, see 2.5 .
(3) By construction of $\Sigma_{X_{P}, \partial \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right)$, see (2.4), this follows from items (1) and (2).

Theorem 2.22. (1) There is a quasi-isomorphism of dg-algebras

$$
C E^{*}\left(\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) ; P_{0}\right) \cong \operatorname{colim}_{\sigma_{k}^{\prime} \in C^{\prime}} C E^{*}\left(\partial \Delta_{P, \partial \sigma_{k}^{\prime}} ; P\left(\sigma_{k}^{\prime}\right)_{0}\right)
$$

(2) There is a quasi-isomorphism of dg-algebras

$$
C E^{*}\left(\Sigma_{X_{P}}\left(\boldsymbol{h}^{\prime}\right) ;\left(X_{P}\right)_{0}\right) \cong \operatorname{colim}_{\sigma_{k}^{\prime} \in C^{\prime}} C E^{*}\left(\Sigma_{X_{P}, \partial \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) ; X\left(\sigma_{k}^{\prime}\right)_{P\left(\sigma_{k}^{\prime}\right)_{0}}\right) .
$$

Proof. Let $\delta, \mathfrak{a}>0$ and $0<\varepsilon<\delta$.
(1) For any $\sigma_{k}^{\prime} \in C^{\prime}$, define $\mathcal{A}_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime} ; \boldsymbol{\varepsilon}, \mathfrak{a}\right)$ to be the dg-algebra generated by Reeb chords in $\bigcup_{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}} \mathcal{R}_{P}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right)$, and differential coinciding with the differential of $C E^{*}\left(\partial \Delta_{P}\left(\boldsymbol{h}^{\prime}\right) ; P_{0}\right)$. For $\delta>0$ small enough we have a quasi-isomorphism of dg-algebras $\mathcal{A}_{P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime} ; \boldsymbol{\varepsilon}, \mathfrak{a}\right) \cong$ $C E^{*}\left(\partial \Delta_{P, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) ; P\left(\sigma_{k}^{\prime}\right)_{0}\right)$ by Asp23, Lemma 2.37]. To spell out the details, we have that for $\delta>0$ small enough which by Lemma 2.21 yields a one-to-one correspondence between the generators. The one-to-one correspondence of $J$-holomorphic curves counted by the differentials follows from [Asp23, Lemma 2.26 and Corollary 2.28].
(2) Similar to the above, we define for any $\sigma_{k}^{\prime} \in C^{\prime}$ the dg-algebra $\mathcal{A}_{X, P, \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime} ; \boldsymbol{\varepsilon}, \mathfrak{a}\right)$ to be the dg-algebra generated by Reeb chords in $\bigcup_{\sigma_{i}^{\prime} \supset \sigma_{k}^{\prime}}\left(\mathcal{R}_{(X, P)}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right) \cup \mathcal{R}_{P}\left(\sigma_{i}^{\prime}, \mathfrak{a}\right)\right)$, and differential coinciding with the differential of $C E^{*}\left(\Sigma_{X_{P}}\left(\boldsymbol{h}^{\prime}\right) ;\left(X_{P}\right)_{0}\right)$. Again for $\delta>0$ small enough we have that Lemma 2.21 yields a one-to-one correspondence between the generators. The one-to-one correspondence between $J$-holomorphic curves is similar to item (1) and in particular Asp23, Lemma 2.26 and Corollary 2.28]. Namely, by construction of simplicial decompositions, the relevant $J$-holomorphic curves with positive puncture at a Reeb chord of $\Sigma_{X_{P}, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) \subset \partial X\left(\sigma_{k}^{\prime}\right)_{P\left(\sigma_{k}^{\prime}\right)_{0}}$ must be simplicial (see Asp23, Definition 2.27]) because both $(C, \boldsymbol{V})$ and $\left(C^{\prime}, \boldsymbol{V}^{\prime}\right)$ are simplicial decompositions of $X$ and $P$, respectively. Such $J$-holomorphic curves projects in each building block $V_{\sigma_{k}}^{(k)} \times T^{*} \Delta^{k}$ to the origin in the zero section of the second factor, or to stable manifolds of the origin of other building blocks $V_{\sigma_{\ell}}^{(\ell)} \times T^{*} \Delta^{\ell}$ for $\sigma_{\ell} \supset \sigma_{k}$.

Remark 2.23. Every colimit appearing in Theorem 2.22 is taken in the category dga consisting of associative, non-commutative, non-unital dg-algebras over varying non-unital rings, which is known to admit colimits, see Asp23, Section 2.5] for details. Every dg-algebra appearing in this paper is semi-free and hence the colimit is again a semi-free dg-algebra generated by the union of the generators.
Remark 2.24. Suppose $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ is a simplicial decomposition of the Weinstein pair $\left(X, T^{*} \Lambda\right)$, where $\Lambda \subset \partial X$ is a smooth Legendrian submanifold, such that the resulting handle decomposition of $P$ which is induced by $\boldsymbol{V}^{\prime}$ has a single top handle. In analogy with Theorem 2.16 we have quasiisomorphisms of dg-algebras $C E^{*}\left(\partial \Delta_{P}, P_{0}\right) \cong C_{-*}(\Omega \Lambda)$ and in particular a quasi-isomorphism of dg-algebras

$$
C E^{*}\left(\Sigma_{X_{P}}\left(\boldsymbol{h}^{\prime}\right) ;\left(X_{P}\right)_{0}\right) \cong C E^{*}\left(\Lambda, C_{-*}(\Omega \Lambda) ; X\right)
$$

The gluing formula in Theorem 2.22 may thus be interpreted in this special case as a gluing formula for the Chekanov-Eliashberg dg-algebra with loop space coefficients. However, we should be careful: Each of the dg-subalgebras $C E^{*}\left(\Sigma_{X_{P}, \supset \sigma_{k}^{\prime}}\left(\boldsymbol{h}^{\prime}\right) ; X\left(\sigma_{k}\right)_{P, 0}\right)$ is not necessarily quasi-isomorphic to a Chekanov-Eliashberg dg-algebra with loop space coefficients.
2.4. Relative Legendrian submanifolds. We first review a few definitions from AE22, Asp23 before generalizing them to the setting of simplicial decompositions of Weinstein pairs.
Definition 2.25 ( $(\boxed{A E 22}$, Section 6.1]). Let $(X, V)$ be a Weinstein pair. A Legendrian submanifold relative to $V$ is a Legendrian submanifold-with-boundary $\Lambda \subset \partial X$ such that $\partial \Lambda=\Lambda \cap V \subset \partial V$ is a Legendrian submanifold.

Definition 2.26 ([AE22, Section 6.1]). Let $(X, V)$ be a Weinstein pair, and let $\Lambda$ be a Legendrian submanifold relative to $V$. Let $\Sigma_{\Lambda}:=\Lambda \sqcup_{\partial \Lambda \times\{-1\}}\left(\partial \Lambda \times \Delta^{1}\right) \sqcup_{\partial \Lambda \times\{1\}}(\{0\} \times \partial \Lambda \times \mathbb{R}) \subset \partial X_{V_{0}}$ denote the union of top attaching spheres of $X_{V}$, and define

$$
C E^{*}(\Lambda, V ; X):=C E^{*}\left(\Sigma_{\Lambda} ; X_{V_{0}}\right)
$$

Lemma 2.27 ([AE22, Lemma 6.1]). There is a dg-subalgebra of $C E^{*}(\Lambda, V ; X)$ which is canonically quasi-isomorphic to $C E^{*}\left(\partial \Lambda ; V_{0}\right)$.
Definition 2.28 ( Asp23, Definition 4.1]). A Legendrian submanifold relative to a simplicial decomposition is a collection $\boldsymbol{\Lambda}$ consisting of one embedded Legendrian $(n-k-1)$-submanifold-with-boundary-and-corners $\Lambda_{\sigma_{k}} \subset \partial V_{\sigma_{k}}^{(k)}$ for each $\sigma_{k} \in C$, such that

$$
\partial \Lambda_{\sigma_{k}}=\# \boldsymbol{\Lambda}_{\supsetneq \sigma_{k}} \subset \partial \# \boldsymbol{V}_{\supsetneq \sigma_{k}}
$$

where $\boldsymbol{\Lambda}_{\supsetneq \sigma_{k}}:=\left\{\Lambda_{\sigma_{i}}\right\}_{\sigma_{i} \supsetneq \sigma_{k}}$, and $\# \boldsymbol{\Lambda}_{\supsetneq \sigma_{k}}$ is defined recursively in analogy to the Weinstein manifold $\# \boldsymbol{V}_{\supsetneq \sigma_{k}}$, see Asp23, Section 2.2].


Figure 11. The definition of $C E^{*}(\Lambda, V ; X)$ is given by the Chekanov-Eliashberg dg-algebra of the (non-compact) Legendrian submanifold $\Sigma_{\Lambda}$ which is shown in the figure.

We now extend these definitions to simplicial decompositions of Weinstein pairs.
Definition 2.29. A Legendrian submanifold relative to a simplicial decomposition of a Weinstein pair $(X, P)$ consists of a Legendrian submanifold $\boldsymbol{\Lambda}^{\prime}$ relative to the given simplicial decomposition of $P$ and a collection $\boldsymbol{\Lambda}$ consisting of one embedded Legendrian ( $n-k-1$ )-submanifold-with-boundary-and-corners $\Lambda_{\sigma_{k}} \subset \partial V_{\sigma_{k}}^{(k)}$ for each $\sigma_{k}^{\prime} \in C^{\prime}$ such that

$$
\partial \Lambda_{\sigma_{k}}=\#\left(\boldsymbol{\Lambda}_{\supset \sigma_{k}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{\Lambda}_{\supsetneq \sigma_{k}}\right) \supset \partial \#\left(\boldsymbol{V}_{\supset \sigma_{k}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{V}_{\supsetneq \sigma_{k}}\right),
$$

where $\boldsymbol{\Lambda}_{\supset \sigma_{k}^{\prime}}^{\prime} \sqcup_{i} \boldsymbol{\Lambda}_{\supsetneq \sigma_{k}}:=\boldsymbol{\Lambda}_{\supset \sigma_{k}^{\prime}}^{\prime} \cup \boldsymbol{\Lambda}_{\supsetneq \sigma_{k}}$.


Figure 12. An example of a Legendrian submanifold relative to a simplicial decomposition with $C^{\prime}=\Delta^{1}$. The ambient manifold in view is $V_{\sigma_{0}}$ and the Legendrian submanifold $\partial \Lambda_{\sigma_{0}}=\Lambda_{\sigma_{0}^{\prime}}^{\prime} \#_{\Lambda_{\sigma_{1}^{\prime}}^{\prime}} \Lambda_{\sigma_{1}}$ which is shown in the figure.

Remark 2.30. We point out that Legendrian submanifolds-with-boundary was also studied from the point of view of sutured contact manifolds by Dattin [Dat22], which is expected to generalize the results in this paper. From the point of view of sutured contact manifolds, Weinstein pairs
$(X, V)$ give rise to a balanced sutured contact manifold, and in that special case, we expect that our definition of $C E^{*}(\Lambda, V ; X)$ coincides with the definition in Dat22.

Definition 2.31. Extend the various Legendrian submanifolds-with-boundary-and-corners in $\boldsymbol{\Lambda}$ over the simplicial handles used to construct $X$ (cf. Asp23, Definition 4.2]). This yields a Legendrian submanifold $\bar{\Lambda} \subset \partial X$ relative to $P$. We call $\bar{\Lambda}$ the $\boldsymbol{V}$-completion of $\boldsymbol{\Lambda}$.
Definition 2.32. Let $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ be a simplicial decomposition of the Weinstein pair $(X, P)$ and let $\boldsymbol{\Lambda}$ be a Legendrian submanifold relative to $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$. Define

$$
C E^{*}(\boldsymbol{\Lambda} ;(X, P)):=C E^{*}(\bar{\Lambda}, P ; X),
$$

where $\bar{\Lambda}$ is the $\boldsymbol{V}$-completion of $\boldsymbol{\Lambda}$.
We now turn to the analogous results for Legendrian submanifolds relative to simplicial decompositions of Weinstein pairs. Let $\Sigma(\boldsymbol{h})$ denote the union of top attaching spheres of the simplicial handle $P \times D_{\varepsilon} T^{*} \Delta^{1}$ used to construct $X_{P}$.

We use the notation $X \rightarrow Y \rightarrow Z$ to mean a word of Reeb chords $v w$ where $w$ is a Reeb chord from $X$ to $Y$, and $w$ is a Reeb chord from $Y$ to $Z$. With the same notation as in Asp23, Section 4.1] we have the following.

Lemma 2.33. Assume $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ is a simplicial decomposition of $(X, P)$. For all $\mathfrak{a}>0$ there exists some $\delta>0$ and an arbitrarily small perturbation of $P$ such that for all $0<\varepsilon<\delta$, the generators of $C E^{*}(\boldsymbol{\Lambda} ;(X, P))$ are in one-to-one correspondence with composable words of Reeb chords of action $<\mathfrak{a}$ which are of the form $\boldsymbol{\Lambda} \rightarrow \boldsymbol{\Lambda}$ or

$$
\boldsymbol{\Lambda} \rightarrow \Sigma(\mathrm{h}) \rightarrow \cdots \rightarrow \Sigma(\mathrm{h}) \rightarrow \boldsymbol{\Lambda} .
$$

The differential on $C E^{*}(\boldsymbol{\Lambda} ;(X, P))$ is induced by the differential in the Chekanov-Eliashberg dgalgebra of $\Sigma_{\Lambda} \cup \Sigma(\boldsymbol{h}) \subset \partial\left(X_{P}\right)_{0}$.

Proof. The proof follows by the surgery description comparing generators before and after attachment of critical handles, see Asp23, Lemma 4.5] and [BEE12, Theorem 5.10].

Theorem 2.34. Suppose $\boldsymbol{\Lambda}$ is a Legendrian submanifold relative to the simplicial decomposition $\left(\left(C, C^{\prime}\right),\left(\boldsymbol{V}, \boldsymbol{V}^{\prime}\right)\right)$ of the Weinstein pair $(X, P)$. Suppose that there are no Reeb chords from $\bar{\Lambda}$ to $\Sigma(\boldsymbol{h})$ or that there are no Reeb chords from $\Sigma(\boldsymbol{h})$ to $\bar{\Lambda}$. Then there is a quasi-isomorphism of dg-algebras

$$
C E^{*}(\boldsymbol{\Lambda} ;(X, P)) \cong \underset{\sigma_{k}^{\prime} \in C^{\prime}}{\operatorname{colim}_{i}} C E^{*}\left(\boldsymbol{\Lambda} ;\left(X\left(\sigma_{k}\right), P\left(\sigma_{k}^{\prime}\right)\right)\right)
$$

Proof. By the surgery description of the generators in Lemma 2.33, the only Reeb chords of $\boldsymbol{\Lambda}$ of action $<\mathfrak{a}$ are $\boldsymbol{\Lambda} \rightarrow \boldsymbol{\Lambda}$ in $\partial X_{P_{0}}$. The proof now follows by repeating the idea of Asp23, Theorem 2.33].

Now we restrict attention to $C=C^{\prime}=\Delta^{1}$. Consider the case when $\Lambda$ is a Legendrian in $(X, P):=\left(X_{1}, P_{1}\right) \#_{V}\left(X_{2}, P_{2}\right)$ where $P_{i}=W_{i} \#_{Q_{i}} V$ for $i \in\{1,2\}$, where we assume that $W_{i}$ and $R_{i}$ are subcritical. Consider the Legendrian submanifold $\Lambda=\Lambda_{1} \# \partial \Lambda_{V} \Lambda_{2}$ in $\partial X$ relative to $P$, where $\partial \Lambda_{V}$ is the common boundary of $\partial \Lambda_{1}$ and $\partial \Lambda_{2}$ along $V$ in $P_{1}$ and $P_{2}$, respectively. Here $\Lambda_{i}$ is a Legendrian submanifold in $\partial X_{i}$ relative to $P_{i}$. Let $\Sigma(h)=\ell_{V} \sqcup\left(\partial \ell_{V} \times \Delta^{1}\right) \sqcup \ell_{V}$ be the top attaching sphere of the basic building block $V \times T^{*} \Delta^{1}$ used to construct $X$, where $\ell_{V}$ is the union of top core disks of a handle decomposition of $V$ (and hence of each $P_{i}$ by the subcriticality assumption on $W_{i}$ and $Q_{i}$ ).

Let $\mathbb{F}$ be a field and let $\boldsymbol{k}:=\bigoplus_{i \in \pi_{0}(\Lambda)} \mathbb{F} e_{i}$ where $\left\{e_{i}\right\}_{i \in \pi_{0}(\Lambda)}$ is a set of mutually orthogonal idempotents. We give an alternative description of the dg-algebra described in Lemma 2.33 as a $\boldsymbol{k}$-module. Let $\mathcal{A}_{i \rightarrow V}\left(\mathcal{A}_{V \rightarrow i}\right)$ denote the right (left) $C E^{*}\left((V, h) ; X_{i}\right)$-module freely generated by the Reeb chords from $\Lambda_{i}$ to $\ell_{V}$ and $\partial \Lambda_{V}$ to $\partial \ell_{V}\left(\ell_{V}\right.$ to $\Lambda_{i}$ and $\partial \ell_{V}$ to $\partial \Lambda_{V}$ ) in $\partial X_{i}$. Similarly we
let $\mathcal{A}_{i \rightarrow i}$ denote the algebra generated by Reeb chords from $\Lambda_{i}$ to $\Lambda_{i}$ in $\partial X_{i}$ and $\partial \Lambda_{i}$ to $\partial \Lambda_{i}$ in $\partial P_{i}$. Define the following modules over $\boldsymbol{k}$. Let $\mathcal{A}_{V}$ denote the set of Reeb chords of $\ell_{V}$ in $\partial X_{i}$ for $i \in\{1,2\}$. Let $\overline{\mathcal{A}}_{i \rightarrow V}\left(\overline{\mathcal{A}}_{V \rightarrow j}\right)$ be the right (left) module over the free algebra on $\mathcal{A}_{V}$ generated by the Reeb chords from $\Lambda_{i}$ to $\ell_{V}\left(\ell_{V}\right.$ to $\Lambda_{j}$ ).

$$
\begin{aligned}
& \mathcal{A}_{i \rightarrow V \rightarrow i}:=\mathcal{A}_{i \rightarrow V} \otimes_{C E^{*}\left((V, h) ; X_{i}\right)} \mathcal{A}_{V \rightarrow i}, \quad i \in\{1,2\} \\
& \mathcal{A}_{i \rightarrow V \rightarrow j}:=\overline{\mathcal{A}}_{i \rightarrow V} \otimes_{\mathcal{A}_{V}} \overline{\mathcal{A}}_{V \rightarrow j}, \quad i \neq j \in\{1,2\} .
\end{aligned}
$$

Lemma 2.35. (1) The dg-algebra $C E^{*}\left(\Lambda_{i}, P_{i} ; X_{i}\right)$ is quasi-isomorphic to the free dg-algebra generated by the set $\mathcal{A}_{i \rightarrow i} \cup \mathcal{A}_{i \rightarrow V \rightarrow i}$ and differential induced by the differential in the Chekanov-Eliashberg dg-algebra of $\Sigma_{V}(h) \cup \Lambda \subset \partial X_{V_{0}}$.
(2) The dg-algebra $C E^{*}(\Lambda, P ; X)$ is quasi-isomorphic to the free dg-algebra generated by the set

$$
\mathcal{A}_{1 \rightarrow 1} \cup \mathcal{A}_{2 \rightarrow 2} \cup \bigcup_{i, j \in\{1,2\}} \mathcal{A}_{i \rightarrow V \rightarrow j}
$$

and differential induced by the differential in the Chekanov-Eliashberg dg-algebra of $\Sigma_{V}(h) \cup$ $\Lambda \subset \partial X_{V_{0}}$.
Proof. Follows from the definition of $\mathcal{A}_{i \rightarrow i}, \mathcal{A}_{i \rightarrow V \rightarrow j}$ and Theorem 2.34.
In the following, we let $A * B$ and $A *_{C} B$ denote the free product and amalgamated free product of two algebras $A$ and $B$ (over $C$ ), respectively. For $\mathcal{S}$ a set, we let $\langle\mathcal{S}\rangle$ denote the free associative non-commutative algebra generated by $\mathcal{S}$.

## Corollary 2.36 .

(1) We have a quasi-isomorphism of dg-algebras

$$
C E^{*}\left(\Lambda_{i}, P_{i} ; X_{i}\right) \cong\left\langle\mathcal{A}_{i \rightarrow i}\right\rangle *\left\langle\mathcal{A}_{i \rightarrow V \rightarrow i}\right\rangle
$$

(2) We have a quasi-isomorphism of dg-algebras

$$
C E^{*}(\Lambda, P ; X) \cong C E^{*}\left(\Lambda_{1}, P_{1} ; X_{1}\right) *_{C E^{*}\left(\partial \Lambda_{V} ; V\right)} C E^{*}\left(\Lambda_{2}, P_{2} ; X_{2}\right) *\left\langle\mathcal{A}_{1 \rightarrow V \rightarrow 2}\right\rangle *\left\langle\mathcal{A}_{2 \rightarrow V \rightarrow 1}\right\rangle .
$$

Proof. This is simply a reformulation of Lemma 2.35, with the extra observation in item (2) that $C E^{*}\left(\partial \Lambda_{V} ; V\right)$ is quasi-isomorphic to dg-algebra generated by words of Reeb chords $\partial \Lambda_{V} \rightarrow \partial \ell_{V} \rightarrow$ $\cdots \rightarrow \partial \ell_{V} \rightarrow \partial \Lambda_{V}$ (see [AE22, Proposition 6.3]).
Remark 2.37. (1) Note that neither $\left\langle\mathcal{A}_{1 \rightarrow V \rightarrow 2}\right\rangle$ nor $\left\langle\mathcal{A}_{2 \rightarrow V \rightarrow 1}\right\rangle$ is a dg-algebra when equipped with the differential from $C E^{*}(\Lambda, P ; X)$.
(2) When $V$ is assumed to be subcritical we have $\mathcal{A}_{1 \rightarrow V \rightarrow 2}=\mathcal{A}_{2 \rightarrow V \rightarrow 1}=\varnothing$, and then Corollary 2.36 gives a special case of Theorem 2.34 when $C=C^{\prime}=\Delta^{1}$.
(3) Additionally, when $P=\varnothing$, and $V$ is assumed to be subcritical, then Corollary 2.36 recovers [AE22, Theorem 1.3] and a special case of Asp23, Theorem 1.1].
Remark 2.38. The free product and amalgamated free products used in Corollary 2.36 are both special cases of colimits in the category a which consists of associative, non-commutative, non-unital algebras over varying non-unital rings. Namely, there is a forgetful functor dga $\rightarrow \mathbf{a}$ by forgetting the differential and grading, which means that all colimits are preserved because forgetful functors are left adjoints. The free product is the coproduct in a and the amalgamated free product is the pushout in a. Colimits of free algebras in this category are again free algebras, generated by the union of the generators.

## 3. Tangle contact homology and gluing formulas

In this section we apply the results of Section 2 to define tangle contact homology and obtain gluing results for knot contact homology.

From now on and throughout the paper we let $\mathbb{R}_{x \geq 0}^{3}:=\left\{(x, y, z) \in \mathbb{R}^{3} \mid x \geq 0\right\}$, and we only consider metrics on $\mathbb{R}_{x \geq 0}^{3}$ such that $\partial \mathbb{R}_{x \geq 0}^{3} \subset \mathbb{R}_{x \geq 0}^{3}$ is not totally geodesic.
3.1. Unframed knot contact homology. In this section we first discuss the unframed knot contact homology and how the results of AE22, Asp23 yields gluing formulas for the unframed version of knot contact homology.

Definition 3.1 (Tangle). An $r$-component tangle in $\mathbb{R}_{x \geq 0}^{3}$ is a proper embedding

$$
T:\{1, \ldots, r\} \times[-1,1] \longrightarrow \mathbb{R}_{x \geq 0}^{3}
$$

such that $T(k, \pm 1) \subset\left\{y^{2}+z^{2}=1\right\} \subset \partial \mathbb{R}_{x \geq 0}^{3}$ for all $k \in\{1, \ldots, r\}$. We call $\bigcup_{k=1}^{r}\{T(k, 1), T(k,-1)\}$ the boundary of $T$ and denote it by $\partial T$.

By abuse of notation we often also refer to the image of $T$ as an $r$-component tangle.
Remark 3.2. In general we also allow components of a tangle to have empty boundary, but for notational simplicity we assume that each component of a tangle has boundary.

Definition 3.3 (Ambient isotopy). We say that two tangles $T_{1}$ and $T_{2}$ are equivalent if they are ambient isotopic. That is, if there exists an isotopy $h_{t}: \mathbb{R}_{x \geq 0}^{3} \longrightarrow \mathbb{R}_{x \geq 0}^{3}$ such that
(1) $h_{0}=\mathrm{id}$
(2) $\left.h_{1}\right|_{T_{1}}=T_{2}$
(3) $\left.h_{t}\right|_{\partial T_{1}}=\partial T_{2}$ such that $\left.h_{t}\right|_{\partial T_{1}} \subset\left\{y^{2}+z^{2}=1\right\} \subset \partial \mathbb{R}_{x \geq 0}^{3}$ for all $t \in[0,1]$.

Definition 3.4 (Trivial tangle). We say that an $r$-component tangle $T$ in $\mathbb{R}_{\geq 0}^{3}$ is trivial if it bounds $r$ disjoint embedded half-disks in $\mathbb{R}_{x \geq 0}^{3}$ whose $r$ boundary arcs are embedded and disjoint in $\left\{y^{2}+z^{2}=1\right\} \subset \mathbb{R}_{x=0}^{3}$.

Remark 3.5. Be aware that our notion of a trivial tangle may not be standard terminology. It is equivalent to there existing a projection in which the tangle diagram does not have any crossings.

Assumption 3.6. Tangles meet $\partial \mathbb{R}_{x \geq 0}^{3}$ orthogonally, and the geodesic binormal chords of a tangle are isolated.

Remark 3.7. Note that Assumption 3.6 does not lose generality. It can always be achieved by small perturbations of the tangle and the given metric on $\mathbb{R}_{x \geq 0}^{3}$.
Definition 3.8 (Gluing of tangles). Let $T_{1}$ and $T_{2}$ be two $r$-component tangles in $\mathbb{R}_{x \geq 0}^{3}$. The gluing of $T_{1}$ and $T_{2}$ is defined to be the link obtained by gluing the two copies of $\mathbb{R}_{x \geq 0}^{3}$ together along their common boundary by the identity map (possibly after an isotopy of $\partial \mathbb{R}_{x \geq 0}^{3}$ which matches up the boundaries of the two tangles).

Definition 3.9 (Knot contact homology following Ekholm-Etnyre-Ng-Sullivan). In previous work of Ekholm-Etnyre-Ng-Sullivan [EENS13], knot contact homology of an $r$-component link was defined as

$$
K C C_{\mathrm{EENS}}^{*}(K):=C E^{*}\left(\Lambda_{K}, \mathbb{Z}\left[\lambda_{1}^{ \pm 1}, \mu_{1}^{ \pm 1}, \ldots, \lambda_{r}^{ \pm 1}, \mu_{r}^{ \pm 1}\right] ; T^{*} \mathbb{R}^{3}\right),
$$

where $\lambda_{1}, \mu_{1}, \ldots, \lambda_{r}, \mu_{r}$ is a basis of $H_{1}\left(\Lambda_{K}\right)$ consisting of longitude classes and meridian classes, respectively.

Remark 3.10. We consider the fully non-commutative version of knot contact homology in which the generators $\lambda_{i}^{ \pm 1}$ and $\mu_{i}^{ \pm 1}$ for $i \in\{1, \ldots, r\}$ in Definition 3.9 are declared to not commute with Reeb chord generators.

Definition 3.11 (Unframed knot contact homology of a link). For a link $K \subset \mathbb{R}^{3}$ we define

$$
K C C_{u}^{*}(K):=C E^{*}\left(\Lambda_{K} ; T^{*} \mathbb{R}^{3}\right)=\left.K C C_{\mathrm{EENS}}^{*}(K)\right|_{\lambda_{1}=\cdots \lambda_{r}=\mu_{1}=\cdots \mu_{r}=1}
$$

Let $T$ be a tangle in $\mathbb{R}_{x \geq 0}^{3}$ and let $H:=\partial \mathbb{R}_{x \geq 0}^{3}$. After convex completion of the (open) Weinstein sector $T^{*} \mathbb{R}_{x \geq 0}^{3}$ we obtain the Weinstein pair $\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}, T^{*} H\right)$ [GPS20, Section 2.7]. Note that in our notation $\widetilde{T^{*} \mathbb{R}_{x>0}^{3}}$ is still an open Weinstein sector. We convex complete along the horizontal boundary $\partial T^{*} \mathbb{R}_{x \geq 0}^{3}=\left.T^{*} \mathbb{R}^{3}\right|_{x=0}$ only.

The unit conormal bundle of $T$ is a Legendrian submanifold $\Lambda_{T} \subset \partial_{\infty} \widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}$ relative to $T^{*} H$ in the sense of Definition 2.25.
Definition 3.12 (Unframed tangle contact homology algebra). Let $T$ be a tangle in $\mathbb{R}_{x \geq 0}^{3}$. We define the unframed tangle contact homology algebra of $T$ as

$$
K C C_{u}^{*}(T):=C E^{*}\left(\Lambda_{T}, T^{*} H ; \widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)
$$

The homology of the dg-algebra $K_{u} C_{u}^{*}(T)$ is called unframed tangle contact homology.
Lemma 3.13. There is a dg-subalgebra of $\operatorname{KCC}_{u}^{*}(T)$ which is canonically quasi-isomorphic to $K C C_{u}^{*}(\partial T)$.
Proof. By definition $K C C_{u}^{*}(T)=C E^{*}\left(\Lambda_{T}, T^{*} H ; \widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)$, and by Lemma 2.27 this dg-algebra contains a dg-subalgebra which is canonically quasi-isomorphic to $C E^{*}\left(\partial \Lambda_{T}, T^{*} H\right.$, and since $\partial \Lambda_{T}=\Lambda_{\partial T}$ in $S T^{*} H$ the result follows.
3.2. Knot contact homology for links. In this section we extend the definition of the fully noncommutative knot contact homology to a family of such homologies, depending on a choice of a handle decomposition $h$ of a small cotangent neighborhood of the unit conormal torus in $S T^{*} \mathbb{R}^{3}$. For certain choices of $h$ this definition recovers the Ekholm-Etnyre-Ng-Sullivan fully non-commutative knot contact homology defined in [EENS13, CELN17, ENS18].
Definition 3.14 (Knot contact homology for links). Let $K \subset \mathbb{R}^{3}$ be a link. Define

$$
K C C^{*}(K, h):=C E^{*}\left(\left(N\left(\Lambda_{K}\right), h\right) ; T^{*} \mathbb{R}^{3}\right),
$$

where $N\left(\Lambda_{K}\right) \cong D_{\varepsilon} T^{*} \Lambda_{K}$ is a small cotangent neighborhood of the unit conormal bundle of $K$, together with a chosen handle decomposition $h$.

In general we have that the quasi-isomorphism class of $K C C^{*}(K, h)$ depends on the handle decomposition $h$ as can be observed by [AE22, Example 7.4 and Example 7.5].

Lemma 3.15. Let $h_{1}$ and $h_{2}$ be two handle decompositions of $N\left(\Lambda_{K}\right)$.
(1) $K C C^{*}\left(K, h_{1}\right)$ and $K C C^{*}\left(K, h_{2}\right)$ are derived Morita equivalent.
(2) There is an isomorphism of algebras $H H_{*}\left(K C C^{*}\left(K, h_{1}\right)\right) \cong H H_{*}\left(K C C^{*}\left(K, h_{2}\right)\right)$, where $H H_{*}$ denotes Hochschild homology.
(3) Denote the subcollection of top handles of $h_{1}$ and $h_{2}$ by $h_{1}^{\text {top }}$ and $h_{2}^{\text {top }}$ respectively. If the core disks in $h_{1}^{\text {top }}$ and $h_{2}^{\text {top }}$ are related by a Legendrian isotopy $h_{t}^{\text {top }}$ in $T^{*} \mathbb{R}^{3}$ with the property that $\partial h_{t}^{\mathrm{top}}$ is a Legendrian isotopy of $\partial h_{1}^{\mathrm{top}}$ and $\partial h_{2}^{\mathrm{top}}$ in $\partial N\left(\Lambda_{K}\right)_{0}$ then we have that $K C C^{*}\left(K, h_{1}\right)$ and $K C C^{*}\left(K, h_{2}\right)$ are dg-homotopy equivalent.
Proof. The proof of (1) and (2) were sketched in [AE22, Remark 1.5]. For the sake of completeness we summarize the proofs below.
(1) By the surgery formula [AE22, Theorem 1.1] we have a quasi-isomorphism

$$
C E^{*}\left(\left(N\left(\Lambda_{K}\right), h\right) ; T^{*} \mathbb{R}^{3}\right) \cong C W^{*}\left(C(h) ;\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}\right),
$$

where $\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}$ is $T^{*} \mathbb{R}^{3}$ stopped at $\Lambda_{K}$ and where $C(h)$ is the union of cocore disks of the top handle of $\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}$ depending on the handle decomposition $h$ of $N\left(\Lambda_{K}\right)$. The wrapped Fukaya category $\mathcal{W}\left(\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}\right)$ is generated by the summands of $C(h)$ by CDRGG17,

Theorem 1.1] and [GPS22, Theorem 1.13]. As the derived module category is independent of choice of a generating set, the result follows.
(2) Attachment of the 1 -simplex handle $N\left(\Lambda_{K}\right)_{0} \times D_{\varepsilon} T^{*} \Delta^{1}$ gives rise to a natural geometric Weinstein cobordism with positive contact boundary $\partial\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}$ and negative contact boundary $\partial T^{*} \mathbb{R}^{3}$. By [BEE12, Theorem 5.6] we have a quasi-isomorphism

$$
S H^{*}\left(\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}\right) \cong H H_{*}\left(C E^{*}\left(\left(N\left(\Lambda_{K}\right), h\right) ; T^{*} \mathbb{R}^{3}\right)\right) \oplus S H^{*}\left(T^{*} \mathbb{R}^{3}\right)
$$

Since $S H^{*}\left(\left(T^{*} \mathbb{R}^{3}\right)_{\Lambda_{K}}\right)$ and $S H^{*}\left(T^{*} \mathbb{R}^{3}\right)$ does not depend on the handle decomposition $h$, it follows that the Hochschild homology of the Chekanov-Eliashberg dg-algebra also does not.
(3) Such Legendrian isotopies of $h_{1}^{\text {top }}$ and $h_{2}^{\text {top }}$ induces a Legendrian isotopy $\Sigma\left(h_{1}\right) \simeq \Sigma\left(h_{2}\right)$ and the result follows from the invariance of the Chekanov-Eliashberg dg-algebra up to dg-homotopy equivalent under Legendrian isotopy, see [EN15, Appendix A] and [EO17, Corollary 5.17].

Lemma 3.16. The dg-homotopy equivalence class of the dg-algebra $K C C^{*}(K, h)$ is an ambient isotopy invariant of $K \subset \mathbb{R}^{3}$

Proof. Ambient isotopies of $K$ induces Legendrian isotopies of $\Lambda_{K}$ which induces isotopies of Weinstein hypersurfaces $N\left(\Lambda_{K}\right) \hookrightarrow \partial T^{*} \mathbb{R}^{3}$. Such isotopies gives Legendrian isotopies as in item (3) of Lemma 3.15,

Theorem 3.17. Let $K \subset \mathbb{R}^{3}$ be a link. If $h$ is a handle decomposition of $N\left(\Lambda_{K}\right)$ such that each component of $N\left(\Lambda_{K}\right)$ has a single top handle, then there is a quasi-isomorphism

$$
K C C^{*}(K, h) \cong K C C_{\mathrm{EENS}}^{*}(K)
$$

Proof. By Theorem 2.16 it follows that $K C C^{*}(K, h) \cong C E^{*}\left(\Lambda_{K}, \bigoplus_{i} C_{-*}\left(\Omega \Lambda_{K_{i}}\right) ; T^{*} \mathbb{R}^{3}\right)$. Since $\Lambda_{K_{i}} \cong T^{2}$ for each component $K_{i}$ of $K$ it follows that we have a quasi-isomorphism $C_{-*}\left(\Omega \Lambda_{K_{i}}\right) \cong$ $\mathbb{Z}\left[H_{1}\left(\Lambda_{K_{i}}\right)\right]$ for each $i$. We obtain the fully non-commutative knot contact homology by definition of the Chekanov-Eliashberg dg-algebra with loop space coefficients as in [EL17] in which generators corresponding to chains of based loops do not commute with Reeb chord generators. The result follows.
3.3. Tangle contact homology. Given a tangle $T$ in $\mathbb{R}_{x \geq 0}^{3}$, its unit conormal bundle $\Lambda_{T}$ is a Legendrian relative to the Weinstein hypersurface $T^{*} H \hookrightarrow T^{*} \mathbb{R}_{x \geq 0}^{3}$ in the sense of Definition 2.25 where $H:=\partial \mathbb{R}_{x \geq 0}^{3}$. We consider handle decompositions $h$ of $N\left(\Lambda_{T}\right)$ as induced by a Morse function on $\Lambda_{T}$ treated as a compact manifold-with-boundary. That is, $h$ consists of both standard Weinstein handles, and Weinstein half-handles, see [CDRGG17, Section 2.3]. The standard model for Weinstein half-handles is revealed by studying Morse theory on manifolds with boundary, see [BNR16] and KM07, Section 2.4]. Let $V_{T}$ denote the subcritical part of $N\left(\Lambda_{T}\right)$ with respect to the handle decomposition $h$ of $N\left(\Lambda_{T}\right)$, and let $\ell_{T}$ be the union of core disks of the top handles in $h$. We have that $V_{T}$ is a Weinstein subsector of $\mathbb{R}_{x \geq 0}^{3}$ which meets $T^{*} H$ along $Q_{T}:=V_{T} \cap S T^{*} H$ since we assume that $T$ intersect $H$ orthogonally, see Assumption 3.6. After convex completion we have that $\ell_{T}$ is a Legendrian submanifold relative to the Weinstein pair $\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}, P_{T}\right)$ in the sense of Section 2.4 , where $P_{T}$ is the Weinstein hypersurface $P_{T}:=\widetilde{V_{T}} \# Q_{T} T^{*} H \hookrightarrow \partial_{\infty} \widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}$.
Definition 3.18 (Tangle contact homology). Let $T$ be a tangle in $\mathbb{R}_{x \geq 0}^{3}$ and let $h$ be a handle decomposition of $N\left(\Lambda_{T}\right)$. We define the tangle contact homology algebra of $T$ as

$$
K C C^{*}(T, h):=C E^{*}\left(\ell_{T}, P_{T} ; \widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)
$$

Lemma 3.19. Let $h$ be a handle decomposition of $N\left(\Lambda_{T}\right)$. The quasi-isomorphism class of the dg-algebra $\operatorname{KCC}^{*}(T, h)$ is an ambient isotopy invariant of $T \subset \mathbb{R}_{x \geq 0}^{3}$.
Proof. Ambient isotopies of $T$ induces Legendrian isotopies of the relative Legendrian submanifold $\ell_{T}$ in the sense of item (3) of Lemma 3.15. The result follows.
Lemma 3.20. Let $T$ be a tangle in $\mathbb{R}_{x \geq 0}^{3}$ and let $h$ be a handle decomposition of $N\left(\Lambda_{T}\right)$. There is a dg-subalgebra of $K C C^{*}(T, h)$ which is canonically quasi-isomorphic to $K C C^{*}\left(\partial T, h_{\partial}\right)$.
Proof. First we note that by definition of $K C C^{*}(T, h)$ and by Lemma 2.27 there is a dg-subalgebra of $K C C^{*}(T, h)$ canonically quasi-isomorphic to $C E^{*}\left(\partial \ell_{T} ; P_{T}\right)$ where

$$
\left.\left.\partial \ell_{T} \simeq \partial \ell_{T}\right|_{\partial \widetilde{V_{T}}} \sqcup \underbrace{\left(\partial \ell_{T} \cap \partial Q_{T} \times \Delta^{1}\right)}_{=: \ell_{\partial T}} \sqcup \partial \ell_{T}\right|_{S T^{*} H} .
$$

By construction we have $\partial \ell_{T} \subset \partial\left(\widetilde{V_{T}} \#_{Q_{T}} T^{*} H\right)$. By construction $Q_{T} \hookrightarrow \partial V_{T}, \partial T^{*} H$ is subcritical. Thus by the same proof as Asp23, Theorem 4.6] $C E^{*}\left(\partial \ell_{T} ; P_{T}\right)$ is quasi-isomorphic to the colimit of the following diagram

$$
\begin{aligned}
& C E^{*}\left(\ell_{\partial T}, Q_{T}\right) \longrightarrow C E^{*}\left(\left.\partial \ell_{T}\right|_{S T^{*} H}, Q_{T} ; T^{*} H\right) \\
& \downarrow \\
& E^{*}\left(\left.\partial \ell_{T}\right|_{\partial \widetilde{V_{T}}}, Q_{T} ; \widetilde{V_{T}}\right)
\end{aligned}
$$

In particular we note that by definition $C E^{*}\left(\left.\partial \ell_{T}\right|_{S T^{*} H}, Q_{T} ; T^{*} H\right)=K C C^{*}\left(\partial T, h_{\partial}\right)$, and this is a dg-subalgebra of $C E^{*}\left(\partial \ell_{T} ; P_{T}\right)$ and hence of $K C C^{*}(T, h)$.
3.4. Gluing formula. Let $T_{1}$ and $T_{2}$ be two tangles in $\mathbb{R}_{x \geq 0}^{3}$. Let $h_{1}$ and $h_{2}$ be a handle decomposition of $N\left(\Lambda_{T_{1}}\right)$ and $N\left(\Lambda_{T_{2}}\right)$, respectively, such that the handle decompositions $\left(h_{1}\right)_{\partial}$ and $\left(h_{2}\right)_{\partial}$ of the boundary $N\left(\partial \Lambda_{T}\right)$ agree. Suppose that the gluing of the two tangles $T_{1}$ and $T_{2}$ gives a link $K$. This induces a gluing of $N\left(\Lambda_{T_{1}}\right)$ and $N\left(\Lambda_{T_{2}}\right)$ such that it respects the handle decompositions $h_{1}$ and $h_{2}$ in the sense that the boundary critical points along $N\left(\partial \Lambda_{T}\right)$ match up after the gluing. This gives an induced handle decomposition on $N\left(\Lambda_{K}\right)$ which we denoted by $h_{1} \# h_{2}$, and we call such $h_{1}$ and $h_{2}$ gluing compatible.

Let $h_{H}$ be a handle decomposition with a single top handle of $T^{*} H \cong T^{*} \mathbb{R}^{2}$ viewed as $B^{4}$ stopped at the unknot. Let $\ell_{H}$ denote the 2 -dimensional core disk in $h_{H}$ and let $\Sigma_{H}\left(h_{H}\right)$ denote the 2dimensional attaching sphere of the handle $T^{*} H \times T^{*} \Delta^{1}$ in $\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)_{T^{*} H}$, used in the definition of $K C C^{*}\left(T_{i}, h_{i}\right)$. We use the notation $\partial \ell_{H}^{1}$ to denote the 1-dimensional core disk of a handle decomposition of $T^{*}$ (unknot) such that by attaching a stop on the unknot using this handle decomposition, the top attaching sphere of $T^{*} \mathbb{R}^{2}$ becomes exactly $\partial \ell$, see Figure 13 .

Applying Lemma 2.33 we first describe the dg-algebras $K C C^{*}\left(T_{i}, h_{i}\right):=C E^{*}\left(\ell_{T_{i}}, P_{T_{i}} ; \widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)$. Let $\Sigma_{T_{i}}\left(h_{i}\right)=\ell_{T_{i}} \sqcup_{\partial \ell_{T_{i}} \times\{-1\}}\left(\partial \ell_{T_{i}} \times \Delta^{1}\right) \sqcup_{\partial \ell_{T_{i}} \times\{1\}}\left(\{0\} \times \partial \ell_{T_{i}} \times \mathbb{R}\right) \subset \partial\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)_{P_{T_{i}}}$ be the noncompact Legendrian as in Definition 2.26. Let $\partial \ell_{T_{i}}^{H}:=\partial \ell_{T_{i}} \cap B^{4}$, where $B^{4}$ is the subcritical part of $T^{*} H$, see Figure 14.
Lemma 3.21. (1) The dg-algebra $K C C^{*}(T, h)$ is quasi-isomorphic to the dg-algebra generated by composable words of Reeb chords of the form $\Sigma_{T}(h) \rightarrow \Sigma_{T}(h)$ and $\Sigma_{T}(h) \rightarrow \Sigma_{H}\left(h_{H}\right) \rightarrow$ $\cdots \rightarrow \Sigma_{H}\left(h_{H}\right) \rightarrow \Sigma_{T}(h)$, and where the differential is the one induced from the differential of the Chekanov-Eliashberg dg-algebra of $\Sigma_{T}(h) \cup \Sigma_{H}\left(h_{H}\right) \subset \partial\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}\right)_{P_{T, 0}}$.
(2) The dg-subalgebra $K C C^{*}\left(\partial T, h_{\partial}\right) \subset K C C^{*}\left(T_{i}, h_{i}\right)$ is quasi-isomorphic to the dg-algebra generated by composable words of Reeb chords of the form $\partial \ell_{T_{i}}^{H} \rightarrow \partial \ell_{T_{i}}^{H}$ and $\partial \ell_{T_{i}}^{H} \rightarrow \partial \ell_{H}^{1} \rightarrow$

$\cdots \rightarrow \partial \ell_{H}^{1} \rightarrow \partial \ell_{T_{i}}^{H}$ and where the differential is the one induced from the differential of the Chekanov-Eliashberg dg-algebra of $\partial \ell_{T_{i}}^{H} \cup \partial \ell_{H}^{1} \subset \partial P_{T_{i}}$.

Proof. This is a special case of Lemma 2.33 and Asp23, Theorem 4.6].
After gluing two tangles $T_{1}, T_{2} \subset \mathbb{R}_{x>0}^{3}$ to a link $K \subset \mathbb{R}^{3}$ we obtain the following description of $K C C^{*}(K, h)$ in terms of $K C C^{*}\left(T_{i}, h_{i}\right)$ and $K C C^{*}\left(\partial T, h_{\partial}\right)$. After gluing the two pairs $\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}, P_{T_{1}}\right)$ and $\left(\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}, P_{T_{2}}\right)$ along their common Weinstein subhypersurface $T^{*} H$ we obtain the Weinstein pair $\left(T^{*} \mathbb{R}^{3}, P\right)$ where $P:=\widetilde{V}_{T_{1}} \#_{Q_{T}} \widetilde{V}_{T_{2}}$ with notation as in Section 3.3. Let $\Sigma_{P}(h)$ denote the union of the top attaching spheres of the handle $T^{*} H \times T^{*} \Delta^{1}$ used in the construction of
the pair $\left(T^{*} \mathbb{R}^{3}, P\right)$. Let $\ell_{K}$ denote the result of gluing $\ell_{T_{1}}$ and $\ell_{T_{2}}$ along their common boundary in $\partial B^{4}$ over the handle $B^{4} \times T^{*} \Delta^{1}$. Furthermore let $\Sigma_{P}(h)$ and $\Sigma_{K}\left(h_{1} \# h_{2}\right)$ denote the corresponding Legendrians after stopping $T^{*} \mathbb{R}^{3}$ at $P$.

Lemma 3.22. The dg-algebra $K C C^{*}\left(K, h_{1} \# h_{2}\right)$ is quasi-isomorphic to the dg-algebra generated by composable words of Reeb chords of the form $\Sigma_{K}\left(h_{1} \# h_{2}\right) \rightarrow \Sigma_{K}\left(h_{1} \# h_{2}\right)$ and $\Sigma_{K}\left(h_{1} \# h_{2}\right) \rightarrow$ $\Sigma_{P}(h) \rightarrow \cdots \rightarrow \Sigma_{P}(h) \rightarrow \Sigma_{K}\left(h_{1} \# h_{2}\right)$, and where the differential is the one induced from the differential of the Chekanov-Eliashberg dg-algebra of $\Sigma_{K}\left(h_{1} \# h_{2}\right) \cup \Sigma_{P}(h) \subset \partial\left(T^{*} \mathbb{R}^{3}\right)_{P_{0}}$.
Proof. Follows immediately by the construction and from Lemma 2.33.
We proceed to give a topological description of some of the generators appearing in Lemma 3.21,
Lemma 3.23. Let $T \subset \mathbb{R}_{x \geq 0}^{3}$ be a tangle and let $h$ be a handle decomposition of $N\left(\Lambda_{T}\right)$.
(1) Reeb chords of the form $\ell_{T} \rightarrow \ell_{T}$ are in one-to-one correspondence with oriented binormal geodesic chords of $T \subset \mathbb{R}_{x \geq 0}^{3}$,
(2) Composable words of Reeb chords of the form $\partial \ell_{T}^{H} \rightarrow \partial \ell_{T}^{H}$ or $\partial \ell_{T}^{H} \rightarrow \partial \ell_{H}^{1} \rightarrow \cdots \rightarrow \partial \ell_{H}^{1} \rightarrow$ $\partial \ell_{T}^{H}$ are in one-to-one correspondence with oriented binormal geodesic chords of $\partial T \subset H$,
(3) Reeb chords of the form $\ell_{H} \rightarrow \ell_{T}$ or $\ell_{T} \rightarrow \ell_{H}$ are in one-to-one correspondence with oriented binormal geodesic chords from $H$ to $T$ and $T$ to $H$ in $\mathbb{R}_{x \geq 0}^{3}$, respectively.
(4) Reeb chords of the form $\ell_{H} \rightarrow \ell_{H}$ are in one-to-one correspondence with oriented binormal geodesic $H$ in $\mathbb{R}_{\geq 0}^{3}$.

Proof. (1) This follows from the fact that the Reeb flow in $S T^{*} \mathbb{R}_{x \geq 0}^{3}$ away from $x=0$ corresponds to geodesic flow in $\mathbb{R}_{x>0}^{3}$.
(2) This follows from Lemma 2.33, and in particular AE22, Proposition 6.2].
(3) This follows from the fact that the Reeb flow in $S T^{*} \mathbb{R}_{x \geq 0}^{3}$ away from $x=0$ corresponds to geodesic flow in $\mathbb{R}_{x \geq 0}^{3}$. By construction we have that the top attaching sphere $\ell_{H}$ of $T^{*} H$ in $\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}$ is the Legendrian lift of $H \subset \mathbb{R}_{x \geq 0}^{3}$ after convex completion. From this point of view, $H \subset T^{*} \mathbb{R}_{x \geq 0}^{3}$ behaves serves as the front projection of $\ell_{H}$, from which the correspondence follows.
(4) This is the same proof as item (3).

Let $\mathcal{G}_{\partial H}=C E^{*}\left(\partial \ell_{H},\left(B^{4}\right)_{D^{2}}\right)$, see Figure 13. We define $\mathcal{G}_{T \rightarrow H}\left(\mathcal{G}_{H \rightarrow T}\right)$ denote the right (left) module over the algebra $\mathcal{G}_{\partial H}$ generated by Reeb chords from $\ell_{T}$ to $\ell_{H}$ and $\partial \ell_{T}^{H}$ to $\partial \ell_{H}^{1}$ ( $\ell_{H}$ to $\ell_{T}$ and $\partial \ell_{H}^{1}$ to $\partial \ell_{T}^{H}$. Similarly, let $\mathcal{G}_{T \rightarrow T}$ denote the set of Reeb chords of $\ell_{T} \subset \partial \widetilde{T}^{*} \mathbb{R}_{x \geq 0}^{3}$. We define

$$
\begin{equation*}
\mathcal{G}_{T \rightarrow H \rightarrow T}:=\mathcal{G}_{T \rightarrow H} \otimes_{\mathcal{G}_{\partial H}} \mathcal{G}_{H \rightarrow T}, \tag{3.1}
\end{equation*}
$$

as modules. In the following we will only consider the underlying sets of $\mathcal{G}_{T \rightarrow T}, \mathcal{G}_{T \rightarrow H}, \mathcal{G}_{H \rightarrow T}$ and $\mathcal{G}_{T \rightarrow H \rightarrow T}$.
Corollary 3.24. Let $T \subset \mathbb{R}_{x \geq 0}^{3}$ be a tangle and let $h$ be a handle decomposition of $N\left(\Lambda_{T}\right)$.
(1) Elements of $\mathcal{G}_{T \rightarrow T}$ are in one-to-one correspondence with oriented binormal geodesic chords of $T \subset \mathbb{R}_{x \geq 0}^{3}$.
(2) Elements of $\mathcal{G}_{T \rightarrow H \rightarrow T}$ are in one-to-one correspondence with oriented binormal geodesic chords of $\partial T \subset H$ and words of oriented binormal geodesic chords in $\mathbb{R}_{x \geq 0}^{3}$ of the form $T \rightarrow H \rightarrow \cdots \rightarrow H \rightarrow T$.

Proof. (1) This is a reformulation of item (1) of Lemma 3.23.
(2) By construction we have that elements of $\mathcal{G}_{T \rightarrow H \rightarrow T}$ consists of words of Reeb chords of the form
(a) $\partial \ell_{T}^{H} \rightarrow \partial \ell_{H}^{1} \rightarrow \cdots \rightarrow \partial \ell_{H}^{1} \rightarrow \partial \ell_{T}^{H}$, and
(b) $\ell_{T} \rightarrow \ell_{H} \rightarrow \cdots \rightarrow \ell_{H} \rightarrow \ell_{T}$.

Note that there are no other words, because there are no Reeb chords of the form $\partial \ell_{H}^{1} \rightarrow \ell_{H}$ by construction, see [AE22, Section 2.2] and Asp23, Section 2.1] for a discussion of Reeb flows in the standard building blocks that we are using.

Words of the form (a) corresponds to oriented binormal geodesic chords of $T \subset \mathbb{R}_{x \geq 0}^{3}$ by item (2) of Lemma 3.23. Words of the form (b) corresponds to words of oriented binormal geodesic chords in $\mathbb{R}_{x \geq 0}^{3}$ of the form $T \rightarrow H \rightarrow \cdots \rightarrow H \rightarrow T$ by items (3) and (4) of Lemma 3.23.

Theorem 3.25. Let $T \subset \mathbb{R}_{x \geq 0}^{3}$ be a tangle. Let $h$ be a choice of handle decomposition of $N\left(\Lambda_{T}\right)$. Then we have a quasi-isomorphism of dg-algebras

$$
K C C^{*}(T, h) \cong\left\langle\mathcal{G}_{T \rightarrow T}\right\rangle *\left\langle\mathcal{G}_{T \rightarrow H \rightarrow T}\right\rangle
$$

Proof. This follows from Corollary 2.36. Let us spell out the details. By item (1) of Lemma 3.21 we have that $K C C^{*}(T, h)$ is quasi-isomorphic to the dg-algebra generated by words of Reeb chords of the form $\Sigma_{T}(h) \rightarrow \Sigma_{T}(h)$ and $\Sigma_{T}(h) \rightarrow \Sigma_{H}\left(h_{H}\right) \rightarrow \cdots \rightarrow \Sigma_{H}\left(h_{H}\right) \rightarrow \Sigma_{T}(h)$. We need to show that such Reeb chords correspond to elements in the set $\mathcal{G}_{T \rightarrow T} \cup \mathcal{G}_{T \rightarrow H \rightarrow T}$.

It follows from studying the Reeb dynamics in the standard building block $V \times T^{*} \Delta^{1}$ as defined in AE22, Section 2.2] and Asp23, Section 2.1]. Namely, there are no Reeb chords from $\partial \ell_{T} \times \Delta^{1} \subset$ $\partial_{\infty}\left(P_{T} \times T^{*} \Delta^{1}\right)$ to $\ell_{T} \subset \partial T^{*} \mathbb{R}_{x \geq 0}^{3}$. Hence, after removing the top handles of $P_{T}$, the available words are of the form $\partial \ell_{T}^{H} \rightarrow \partial \ell_{H}^{1} \rightarrow \cdots \rightarrow \partial \ell_{H}^{1} \rightarrow \partial \ell_{T}^{H}$ or $\ell_{T} \rightarrow \ell_{H} \rightarrow \cdots \rightarrow \ell_{H} \rightarrow \ell_{T}$.

Remark 3.26. Neither $\mathcal{G}_{T \rightarrow T}$ nor $\mathcal{G}_{T \rightarrow T}$ become dg-algebras when equipped with the differential used in $K C C^{*}(T, h)$, however the free algebra becomes a dg-algebra when equipped with the differential used in $K C C^{*}(T, h)$.

Now let $T_{1}$ and $T_{2}$ be two tangles in $\mathbb{R}_{x \geq 0}^{3}$. As the discussion surrounding (3.1) we define $\mathcal{G}_{T_{i} \rightarrow T_{i}}$, $\mathcal{G}_{T_{i} \rightarrow H \rightarrow T_{i}}$ in the same way for $i \in\{1,2\}$. Additionally we define $\mathcal{G}_{H}$ to denote the set of Reeb chords of $\ell_{H}$ in either one of the two copies of $\widetilde{T^{*} \mathbb{R}_{x \geq 0}^{3}}$. Let $\overline{\mathcal{G}}_{T_{i} \rightarrow H}$ (and $\overline{\mathcal{G}}_{H \rightarrow T_{j}}$ ) be the right (left) module over the free algebra on $\mathcal{G}_{H}$ generated by Reeb chords from $\ell_{T_{i}}$ to $\ell_{H}\left(\ell_{H}\right.$ to $\ell_{T_{j}}$ ). Then define

$$
\begin{equation*}
\mathcal{G}_{T_{i} \rightarrow H \rightarrow T_{j}}:=\overline{\mathcal{G}}_{T_{i} \rightarrow H} \otimes \mathcal{G}_{H} \overline{\mathcal{G}}_{H \rightarrow T_{j}}, \tag{3.2}
\end{equation*}
$$

for $i \neq j \in\{1,2\}$.
Lemma 3.27. Let $T_{1} \subset\left(\mathbb{R}_{x \geq 0}^{3}\right)_{1}$ and $T_{2} \subset\left(\mathbb{R}_{x \geq 0}^{3}\right)_{2}$ be two tangles. Elements of $\mathcal{G}_{T_{i} \rightarrow H \rightarrow T_{j}}$ for $i \neq j \in\{1,2\}$ are in one-to-one correspondence with words of oriented binormal geodesic chords in of the form $T_{i} \rightarrow H \rightarrow \cdots \rightarrow H \rightarrow T_{j}$, where " $H \rightarrow H$ " is taken to mean an oriented binormal geodesic chord of $H$ in either of the two copies of $\mathbb{R}_{x \geq 0}^{3}$.

Proof. This follows from Lemma 3.22 in combination with item (3) of Lemma 3.23.
Theorem 3.28 Theorem 1.1. Let $T_{1}$ and $T_{2}$ be two tangles in $\mathbb{R}_{x \geq 0}^{3}$ whose gluing is the link $K \subset \mathbb{R}^{3}$, where $H:=\partial \mathbb{R}_{x \geq 0}^{3}$. Let $h_{1}$ and $h_{2}$ be choices of handle decomposition of $N\left(\Lambda_{T_{1}}\right)$ and $N\left(\Lambda_{T_{2}}\right)$, respectively. Then we have a quasi-isomorphism of dg-algebras

$$
K C C^{*}\left(K, h_{1} \# h_{2}\right) \cong K C C^{*}\left(T_{1}, h_{1}\right) *_{K C C^{*}\left(\partial T, h_{\partial}\right)} K C C^{*}\left(T_{2}, h_{2}\right) *\left\langle\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{2}}\right\rangle *\left\langle\mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{1}}\right\rangle
$$

where the right hand side is equipped with the same differential as in $K C C^{*}\left(K, h_{1} \# h_{2}\right)$.

Proof. This follows from Corollary 2.36. Let us spell out the details. By Lemma 3.22 and the same discussion regarding Reeb dynamics as in the proof of Theorem 3.25 we see that

$$
\begin{aligned}
K C C^{*}\left(K, h_{1} \# h_{2}\right) & \cong\left\langle\mathcal{G}_{T_{1} \rightarrow T_{1}} \cup \mathcal{G}_{T_{2} \rightarrow T_{2}} \cup \mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{1}} \cup \mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{2}} \cup \mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{1}} \cup \mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{2}}\right\rangle \\
& =\left\langle\mathcal{G}_{T_{1} \rightarrow T_{1}} \cup \mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{1}} \cup \mathcal{G}_{T_{2} \rightarrow T_{2}} \cup \mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{2}}\right\rangle *\left\langle\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{2}}\right\rangle *\left\langle\mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{1}}\right\rangle .
\end{aligned}
$$

Now $\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{1}}$ and $\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{1}}$ has a common subset consisting of words of oriented binormal geodesic chords of $\partial T \subset H$. The dg-algebra generated by such is quasi-isomorphic with $K C C^{*}\left(\partial T, h_{\partial}\right)$ when equipped with the differential of $K C C^{*}\left(K, h_{1} \# h_{2}\right)$ by Lemma 3.21. Hence

$$
\begin{aligned}
& \left\langle\mathcal{G}_{T_{1} \rightarrow T_{1}} \cup \mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{1}} \cup \mathcal{G}_{T_{2} \rightarrow T_{2}} \cup \mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{2}}\right\rangle \\
& \cong\left\langle\mathcal{G}_{T_{1} \rightarrow T_{1}} \cup \mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{1}}\right\rangle *_{K C C^{*}\left(\partial T, h_{\partial}\right)}\left\langle\mathcal{G}_{T_{2} \rightarrow T_{2}} \cup \mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{2}}\right\rangle \\
& \stackrel{\text { Theoren 3.25 }}{\cong} K C C^{*}\left(T_{1}, h_{1}\right) *_{K C C^{*}\left(\partial T, h_{\partial}\right)} K C C^{*}\left(T_{2}, h_{2}\right),
\end{aligned}
$$

and the result follows.
Remark 3.29. We remark again that neither $\mathcal{G}_{T_{1} \rightarrow H \rightarrow T_{2}}$ nor $\mathcal{G}_{T_{2} \rightarrow H \rightarrow T_{1}}$ become dg-algebras when equipped with the differential in $K C C^{*}\left(K, h_{1} \# h_{2}\right)$.
3.4.1. Handle decompositions recovering the Ekholm-Etnyre-Ng-Sullivan knot contact homology. Let $T_{1}$ and $T_{2}$ be two tangles in $\mathbb{R}_{x>0}^{3}$ whose gluing is the knot $K \subset \mathbb{R}^{3}$. Using the gluing formula Lemma 3.22 we can recover $K C C^{\star}\left(K, h_{1} \# h_{2}\right)$. The purpose of this section is to show that we can choose $h_{1}$ and $h_{2}$ so that $h_{1} \# h_{2}$ has a single top handle and hence so that the assumptions of Theorem 3.17 holds.

Let $h_{1}$ be the handle decomposition induced by a Morse function on $\Lambda_{T_{1}} \cong S^{1} \times I$ with two interior critical points of indices 0 and 1 respectively, and two boundary-unstable critical points of indices 1 and 2 respectively, on each of the two components of $\partial \Lambda_{T_{1}}$, see Figure 15. Let $h_{2}$ be

the handle decomposition induced by a Morse function on $\Lambda_{T_{2}} \cong S^{1} \times I$ with two interior critical points of indices 1 and 2 respectively, and two boundary-stable critical points of indices 0 and 1 respectively, on each of the two components of $\partial \Lambda_{T_{2}}$, see Figure 16.
3.5. Untangle detection. In this section we prove that $K C C^{*}(T, h)$ for $h=h_{1}$ or $h=h_{2}$ as defined in Section 3.4.1 detects the $r$-component untangle.

Lemma 3.30. Suppose that $T_{1}$ and $T_{2}$ are two r-component tangles such that $T_{2}$ is trivial and $K:=T_{1} \# T_{2}$ is an $r$-component link. Then $K$ is trivial if and only if $T_{1}$ is trivial.

Proof. Since $T_{2}$ is trivial it bounds $r$ disjoint embedded half-disks in $\mathbb{R}_{x \geq 0}^{3}$ whose $r$ boundary arcs are embedded and disjoint in $\left\{y^{2}+z^{2}=1\right\} \subset \partial \mathbb{R}_{x \geq 0}^{3}$. Since the gluing is such that the resulting link also has $r$ components there is a unique way (up to permuting the components) of gluing the two tangles together. We see that extending the disks with boundary on $T_{2}$ through the boundary to $T_{1}$ gives a Seifert surface in which case we see that $T_{1} \# T_{2}$ is trivial if and only if $T_{1}$ is.

Remark 3.31. The assumption Lemma 3.30 that $T_{1} \# T_{2}$ is a link consisting of the same number of components as $T_{1}$ and $T_{2}$ is crucial, see Figure 17

Lemma 3.32. $K C H_{\mathrm{EENS}}^{*}(K)$ detects the r-component unlink up to ambient isotopy and mirroring for any $r \geq 1$.

Proof. This is already known in the case $r=1$ by [CELN17, Proposition 2.19]. The same argument as in CELN17, Proposition 2.21] and [CELN17, Proof of Corollary 1.5] (cf. [GL17, Remark 5]) can be used for $r>1$, which we recall below.

By [CELN17, Theorem 1.2 and Proposition 2.21] we have that

$$
\begin{equation*}
K C H_{\mathrm{EENS}}^{0}(K) \cong \mathfrak{R} \tag{3.3}
\end{equation*}
$$

for framed oriented non-trivial knots in $\mathbb{R}^{3}$. Here $\mathfrak{R}$ is defined as the subring of $\mathbb{Z}\left[\pi_{1}\left(\mathbb{R}^{3} \backslash K\right)\right]$ generated by $\pi_{1}\left(\lambda_{1}^{ \pm 1}, \mu_{1}^{ \pm 1}, \ldots, \lambda_{r}^{ \pm 1}, \mu_{r}^{ \pm 1}\right)$, and $\operatorname{im}\left(1-\mu_{i}\right)$ for $i \in\{1, \ldots, r\}$ where $1-\mu_{i}$ denotes the map $\mathbb{Z}\left[\pi_{1}\left(\mathbb{R}^{3} \backslash K\right)\right] \longrightarrow \mathbb{Z}\left[\pi_{1}\left(\mathbb{R}^{3} \backslash K\right)\right]$ given by left multiplication by $1-\mu_{i}$. We claim that (3.3) still holds for framed oriented $r$-component non-trivial links using the same argument as in [CELN17, Proof of Proposition 2.21].

By [HS85, Lemma 2] we have that $\pi_{1}\left(\mathbb{R}^{3} \backslash K\right)$ is locally indicable and hence $\mathbb{Z}\left[\pi_{1}\left(\mathbb{R}^{3} \backslash K\right)\right]$ is an integral domain by Hig40, Theorem 12]. By computation we have that

$$
K C H_{\mathrm{EENS}}^{0}(U) \cong \mathbb{Z}\left[\pi_{1}\left(\lambda_{1}^{ \pm 1}, \mu_{1}^{ \pm 1}, \ldots, \lambda_{r}^{ \pm 1}, \mu_{r}^{ \pm 1}\right)\right] /\left\langle\left(\left(1-\lambda_{i}\right)\left(1-\mu_{i}\right)|i \in\{1, \ldots, r\}\rangle\right.\right.
$$

(see [EENS13]) which is not an integral domain, and thus $K C H_{\text {EENS }}^{*}(K) \neq K C H_{\text {EENS }}^{*}(U)$.

Lemma 3.33. Let $T, T^{\prime} \subset \mathbb{R}_{x>0}^{3}$ be two tangles. Assume that $\overline{\mathcal{G}}_{T \rightarrow H} \cong \overline{\mathcal{G}}_{T^{\prime} \rightarrow H}$ and $\overline{\mathcal{G}}_{H \rightarrow T} \cong \overline{\mathcal{G}}_{H \rightarrow T^{\prime}}$ as right and left modules over $\overline{\mathcal{G}}_{H}$, respectively. Then if there is a quasi-isomorphism of dg-algebras $K C C^{*}(T, h) \cong K C C^{*}\left(T^{\prime}, h^{\prime}\right)$ we have a quasi-isomorphism

$$
K C C^{*}\left(T \# T^{\prime \prime}, h \# h^{\prime \prime}\right) \cong K C C^{*}\left(T^{\prime} \# T^{\prime \prime}, h^{\prime} \# h^{\prime \prime}\right) .
$$

Proof. This follows from the definition (3.2). Indeed, if $\overline{\mathcal{G}}_{T \rightarrow H} \cong \overline{\mathcal{G}}_{T^{\prime} \rightarrow H}$ and $\overline{\mathcal{G}}_{H \rightarrow T} \cong \overline{\mathcal{G}}_{H \rightarrow T^{\prime}}$ as right and left modules over $\mathcal{G}_{H}$, respectively, then it follows that

$$
\mathcal{G}_{T \rightarrow H \rightarrow T^{\prime \prime}} \cong \mathcal{G}_{T^{\prime} \rightarrow H \rightarrow T^{\prime \prime}}, \quad \mathcal{G}_{T^{\prime \prime} \rightarrow H \rightarrow T} \cong \mathcal{G}_{T^{\prime \prime} \rightarrow H \rightarrow T^{\prime}}
$$

from which the conclusion holds by Theorem 3.28.
Definition 3.34 (Weak detection). We say that tangle contact homology weakly detects a tangle $T \subset \mathbb{R}_{x \geq 0}^{3}$ if for any tangle $T^{\prime}$ that satisfies $\mathcal{G}_{T \rightarrow H} \cong \mathcal{G}_{T^{\prime} \rightarrow H}$ and $\mathcal{G}_{H \rightarrow T} \cong \mathcal{G}_{H \rightarrow T^{\prime}}$ as right and left modules over $\mathcal{G}_{H}$, respectively, we have that $K C C^{*}(T, h) \cong K C C^{*}\left(T^{\prime}, h^{\prime}\right)$ implies $T \simeq T^{\prime}$.
Theorem 3.35. Let $T \subset \mathbb{R}_{x>0}^{3}$ be a tangle and let $h$ be one of the handle decompositions $h_{1}$ and $h_{2}$ of $N\left(\Lambda_{T}\right)$ from Section 3.4.1. The tangle contact homology of $T$ weakly detects the $r$-component untangle.

Proof. Let $K=T_{1} \# T_{2}$ be a splitting of the $r$-component unlink into two trivial $r$-component tangles. Let $T_{1}^{\prime}$ be any $r$-component tangle which is not ambient isotopic to $T_{1}$ and so that it satisfies $\mathcal{G}_{T_{1} \rightarrow H} \cong \mathcal{G}_{T_{1}^{\prime} \rightarrow H}$ and $\mathcal{G}_{H \rightarrow T_{1}} \cong \mathcal{G}_{H \rightarrow T_{1}^{\prime}}$ as right and left modules over $\mathcal{G}_{H}$, respectively. Then by Lemma 3.30 it follows that $K^{\prime}:=T_{1}^{\prime} \# T_{2}$ is a non-trivial $r$-component link. Let $h_{1}$ and $h_{2}$ be the two handle decompositions as in Section 3.4.1. By Lemma 3.32 we thus have $K C H_{\text {EENS }}^{*}(K) \neq$ $K C H_{\text {EENS }}^{*}\left(K^{\prime}\right)$. It then follows from Lemma 3.33 that $K C C^{*}\left(T_{1}, h_{1}\right) \not \neq K C C^{*}\left(T_{1}^{\prime}, h_{1}\right)$.

Example 3.36. To illustrate the definition of weak detection in Definition 3.34, we consider the tangle $T_{\beta}$ as shown in Figure 18. We have that Theorem 3.35in particular shows that $K C C^{*}\left(T_{\beta}, h_{1}\right)$ detects the untangle among the tangles $T_{\beta}$. This is because we can do crossing changes to pass from $T_{\beta}$ to $T_{\beta}^{\prime}$ which is not ambient isotopic to $T_{\beta}$. We may assume that the strands of $T_{\beta}$ are arranged so that $\mathcal{G}_{T_{\beta} \rightarrow H}$ and $\mathcal{G}_{H \rightarrow T_{\beta}}$ are both generated by one oriented binormal geodesic per strand in $\mathbb{R}_{x>0}^{3}$, see Figure 18. After changing a crossing in the braid, the same remains true and so we have $\mathcal{G}_{T_{\beta} \rightarrow H} \cong \mathcal{G}_{T_{\beta}^{\prime} \rightarrow H}$ and $\mathcal{G}_{H \rightarrow T_{\beta}} \cong \mathcal{G}_{H \rightarrow T_{\beta}^{\prime}}$ as right and left modules over $\mathcal{G}_{\partial H}$, respectively.
Definition 3.37 (Ambient isotopy with moving boundary). We say that two tangles $T_{1}$ and $T_{2}$ in $\mathbb{R}_{x \geq 0}^{3}$ are ambient isotopic with moving boundary if there is an isotopy $h_{t}: \mathbb{R}_{x \geq 0}^{3} \longrightarrow \mathbb{R}_{x \geq 0}^{3}$ such that items (1) and (2) (but not necessarily item (3)) in Definition 3.3 holds.
Corollary 3.38. The quasi-isomorphism class of $\operatorname{KCC}^{*}(T, h)$ is not invariant under ambient isotopies with moving boundary of $T$.
Proof. This follows the proof of Theorem 3.35 by choosing $T_{1}^{\prime}$ to be a tangle which is not ambient isotopic to $T_{1}$ but ambient isotopic with moving boundary. We may for instance take $T_{1}$ and $T_{1}^{\prime}$ as shown in Figure 17.

## 4. Examples

Example 4.1 (Unframed subalgebra). Let us first consider a single stranded braid $T \subset \mathbb{R}_{x \geq 0}^{3}$. Its boundary is two points in $\partial \mathbb{R}_{x \geq 0}^{3} \cong \mathbb{R}^{2}$. The unframed knot contact homology $K C C_{u}^{*}(\partial T)$ is simply the knot contact homology (without homology coefficients) of two points $z_{1}, z_{2} \in \mathbb{R}^{2}$. As $K C C_{u}^{*}(\partial T)$ is generated by oriented binormal geodesics, we know that there are two generators $c_{1}$ and $c_{2}$, both in degree 0 . Their differentials are also trivial. Hence $K C C_{u}^{*}(\partial T) \cong \boldsymbol{k}\left[c_{1}, c_{2}\right]$. Computing the degree and differential is done using the front projection of $\Lambda_{z_{1}}, \Lambda_{z_{2}} \subset S T^{*} \mathbb{R}^{2} \cong J^{1}\left(S^{1}\right)$, which lie in $S^{1} \times \mathbb{R} \cong \mathbb{R}^{2} \backslash\{0\}$, see Figure 19.

The front projection of the zero section of $J^{1}\left(S^{1}\right)$ is the central gray circle.

We now give a surgery presentation of $K C C_{u}^{*}(\partial T)$. Namely, present $T^{*} \mathbb{R}^{2}$ as $B^{4}$ stopped at the standard unknot $\Lambda_{\text {unknot }} \subset S^{3}=\partial B^{4}$, see also [AE22, Example 7.4]. This means that we present $T^{*} \mathbb{R}^{2}$ as the result of attaching a copy of $T^{*}\left(\Lambda_{\text {unknot }} \times \mathbb{R}_{\geq 0}\right)$ to $B^{4}$ along a cotangent neighborhood of $\Lambda_{\text {unknot }}$, see Figure 20. Now, we can use surgery techniques to give a quasi-

isomorphic presentation of $K C C_{u}^{*}(\partial T)$ which is more amenable to proving the gluing formulas in this paper. Namely, removing the cotangent bundle $T^{*}\left(\Lambda_{\text {unknot }} \times \mathbb{R}_{\geq 0}\right)$, we are left with the Legendrians $\Lambda_{z_{1}}, \Lambda_{z_{2}}, \Lambda_{\text {unknot }} \subset S^{3}=\partial B^{4}$. By the same technique used to prove BEE12, Theorem 5.10] and [Ekh19, Theorem 1.2] we have that $K C C_{u}^{*}(\partial T)$ is quasi-isomorphic to the dg-algebra generated by composable words of Reeb chords of the form

\Lambda_{z_{i}} \rightarrow \bar{\Lambda}_{\text {unknot }} \rightarrow \cdots \rightarrow \bar{\Lambda}_{\text {unknot }} \rightarrow \Lambda_{z_{j}} \tag{4.1}
\end{equation*}
$$

for $i, j \in\{1,2\}$ where $\bar{\Lambda}_{\text {unknot }}$ is a Legendrian submanifold in the positive boundary of the Weinstein cobordism obtained by attaching a handle $\left(B^{2} \times D_{\varepsilon} T^{*}[0,1], \frac{1}{2}(q d p-p d q)+2 x d y+y d x\right)$ to $B^{4} \sqcup$
$\left((-\infty, 0] \times B^{2} \times \mathbb{R}\right)$, see [AE22, Section 1.2] for a general description. The Legendrian $\bar{\Lambda}_{\text {unknot }}$ is now defined in the same way as $\Sigma(h)$ in [AE22, Equation (1.1)]. This is geometrically saying that we consider loop space coefficients in the component $\Lambda_{\text {unknot }}$ only. The differential used in the dg-algebra generated by words of the form as in (4.1) is induced by the differential of the ChekanovEliashberg dg-algebra of the Legendrian link $\Lambda_{z_{1}} \cup \Lambda_{z_{2}} \cup \bar{\Lambda}_{\text {unknot }} \subset \partial B_{T^{*} D^{2}}^{4}$. After a Legendrian isotopy this link fits in a Darboux chart and the front projection in $\mathbb{R}^{2}$ is shown in Figure 21. The


Figure 21. The front projection of the Legendrian link $\Lambda_{z_{1}} \cup \Lambda_{z_{2}} \cup \ell_{\text {unknot }}$ in a Darboux chart.

Legendrian $\bar{\Lambda}_{\text {unknot }}$ consists of a 1-dimensional disk $\ell_{\text {unknot }}$ with boundary $\partial \ell_{\text {unknot }} \subset B^{2}$ where $B^{2}$ is the subcritical part after a choice of handle decomposition of a Weinstein neighborhood of $\Lambda_{\text {unknot }}$. It follows from AE22, Lemma 3.4] that Reeb chords of $\bar{\Lambda}_{\text {unknot }}$ corresponds to Reeb chords of $\ell_{\text {unknot }}$ that are contained in $S^{3}$ (this is the Reeb chord labeled by $a$ in Figure 21) and Reeb chords of $\partial \ell_{\text {unknot }} \subset B^{2}$. The Reeb chords of the latter kind corresponds to Reeb chords of two points in the boundary of $B^{2}$, and they form a dg-subalgebra described in detail in EN15, Section 2.3], see also [AE22, Example 7.3] and references therein. With appropriate choices of Maslov potential, the two shortest Reeb chords corresponding to the point $t$ in Figure 21 are denoted by $t_{12}^{0}$ and $t_{21}^{1}$ using the notation as in [AE22, Example 7.3].

Inside this Darboux chart there are two Reeb chords between $\Lambda_{z_{1}}$ and $\Lambda_{\text {unknot }}$ and also two Reeb chords between $\Lambda_{z_{2}}$ and $\Lambda_{\text {unknot }}$, labeled in Figure 21 by $q_{1}, p_{1}$ and $q_{2}, p_{2}$, respectively. Note that since this Legendrian link is in $S^{3}$, there are in general more Reeb chords that necessarily leaves the Darboux chart. Using EN15, Lemma 4.6] and an action argument like the proof of EN15, Lemma 5.6] we obtain that $K C C_{u}^{*}(\partial T)$ is quasi-isomorphic to the dg-algebra generated by composable words formed by products of the following two kinds:
(1) $a_{1}$ and $a_{2}$ both in degree 1 .
(2) The words $q_{j} c^{k} p_{i}$ for $k \geq 0, i, j \in\{1,2\}$, where $c$ is any Reeb chord $\bar{\Lambda}_{\text {unknot }}$, of degree $|c|$. The differential is induced by the differential of the Chekanov-Eliashberg dg-algebra of $\Lambda_{z_{1}} \cup \Lambda_{z_{2}} \cup$ $\bar{\Lambda}_{\text {unknot }}$ which can be computed from Figure 21 to be as follows with coefficients in $\mathbb{Z}_{2}$

where $e_{\text {unknot }}$ denotes the idempotent corresponding to the component $\bar{\Lambda}_{\text {unknot }}$. By the general theory the just described dg-algebra is quasi-isomorphic to $K C C_{u}^{*}(\partial T)$ although we do not attempt to exhibit an explicit such quasi-isomorphism.

Example 4.2 (Framed subalgebra). We upgrade Example 4.1 and now compute $K C C^{*}\left(\partial T, h_{\partial}\right)$. The difference is now that we pick a handle decomposition $h_{\partial}$ of a chosen Weinstein neighborhood $N\left(\Lambda_{\partial T}\right)=N\left(\Lambda_{z_{1}}\right) \cup N\left(\Lambda_{z_{2}}\right)$. We construct $\bar{\Lambda}_{z_{i}}$ for $i \in\{1,2\}$ in the same way as $\bar{\Lambda}_{\text {unknot }}$ in Example 4.1. Computationally, we have two more infinite families of Reeb chords to take into account, indicated by the two points $t(1)$ and $t(2)$, see Figure 22. By the general theory we now

have that the dg-algebra $K C C^{*}(\partial T)$ is quasi-isomorphic to the dg-algebra generated by composable words formed by products of the following two kinds:
(1) $a_{1}$ and $a_{2}$ both in degree 1
(2) Reeb chords $t(1)_{i j}^{p}$ and $t(2)_{i j}^{p}$ with notation as in AE22, Example 7.3].
(3) The words $q_{j} c^{k} p_{i}$ for $k \geq 0, i, j \in\{1,2\}$, where $c$ is any Reeb chord $\bar{\Lambda}_{\text {unknot }}$, of degree $|c|$. The differential is induced by the differential of the Chekanov-Eliashberg dg-algebra of $\bar{\Lambda}_{z_{1}} \cup \bar{\Lambda}_{z_{2}} \cup$ $\bar{\Lambda}_{\text {unknot }}$ which can be computed from Figure 22 to be as follows with coefficients in $\mathbb{Z}_{2}$

where $e_{i}$ and $e_{\text {unknot }}$ denotes the idempotent corresponding to the components $\bar{\Lambda}_{z_{i}}$ and $\bar{\Lambda}_{\text {unknot }}$, respectively for $i \in\{1,2\}$.

Above and in Example 4.1 we have used a description of $K C C^{*}\left(\partial T, h_{\partial}\right)$ which only uses Reeb chords of the front projecting appearing in the Darboux chart. Instead, we consider $\bar{\Lambda}_{\text {unknot }}$ and $\overline{\Lambda_{z_{i}}}$ before applying the Legendrian isotopy to make them fit in a Darboux chart. Namely, the Reeb chords of the link $\bar{\Lambda}_{z_{1}} \cup \bar{\Lambda}_{z_{2}} \cup \bar{\Lambda}_{\text {unknot }}$ come in two families of $S^{1}$-families, one corresponding to Reeb chords of $\bar{\Lambda}_{z_{1}} \cup \bar{\Lambda}_{\text {unknot }}$ and one corresponding to Reeb chords of $\bar{\Lambda}_{z_{2}} \cup \bar{\Lambda}_{\text {unknot }}$. After Morsification, the shortest Reeb chords are as indicated in the following diagram.

The differential (with coefficients in $\mathbb{Z}_{2}$ ) is given by the following.

Example 4.3 (Unframed trivial tangle). Let us now consider $T \subset \mathbb{R}_{x \geq 0}^{3}$ the trivial tangle as depicted in Figure 23. The hypersurface $H$ is the graph of the function $f(x, y)=x^{2}-y^{2}$ with a saddle point at the origin. By Lemma 3.21 we know that $K C C_{u}^{*}(T)$ is quasi-isomorphic to the

dg-algebra generated by oriented binormal geodesic chords between $T$ and $H$, since there are no binormal geodesic chords of $T$ and none of $H$. We also know that $K C C_{u}^{*}(\partial T) \subset K C C_{u}^{*}(T)$ is a dg -subalgebra that we have already described in Example 4.1. The degree of both of the two Reeb chords $c_{T \rightarrow H}$ and $c_{H \rightarrow T}$ is 1 . The differential is given by

$$

\partial c_{T \rightarrow H}=q_{1}+q_{2}  \tag{4.3}\\
\partial c_{H \rightarrow T}=p_{1}+p_{2}
\end{array}\right.
$$

For each Reeb chord, the two $J$-holomorphic disks may be visualized in Figure 23 by imagining that the oriented binormal geodesic chord moving right or left and shrinks down to a point.
Example 4.4 (Framed trivial tangle). Let us now consider $T \subset \mathbb{R}_{x \geq 0}^{3}$ the trivial tangle, see Figure 23. We let $h_{1}$ and $h_{2}$ be the handle decomposition of $N\left(\Lambda_{T}\right)$ as depicted in Figure 15 and Figure 16, respectively. The subalgebra $K C C^{*}\left(\partial T, h_{\partial}\right)$ is as described in Example 4.2.

We first consider $K C C^{*}\left(T, h_{2}\right)$. There is one additional set of generators corresponding to $\left.\partial \ell_{T}\right|_{V_{T}}$, see Figure 14. This set of generators is denoted by $\left\{\hat{t}_{i j}^{p}\right\}$ and should be interpreted as follows. In $V_{T}$ there is a one-parameter family of dg-algebras all of which is quasi-isomorphic to the Chekanov-Eliashberg dg-algebra of two distinct points in $S^{1}$. After Morsification by a function with a maximum in the interior and two minima at the boundary of $\Lambda_{T}$. The generators $\left\{\hat{t}_{i j}^{p}\right\}$ correspond to the maximum and $\left\{t(i)_{i j}^{p}\right\}$ correspond to the two minima; they are depicted in Figure 24 . Together $\left\{\hat{t}_{i j}^{p}, t(1)_{i j}^{p}, t(2)_{i j}^{p}\right\}$ generate a dg-algebra that is quasi-isomorphic to $C E^{*}\left(\left.\partial \ell_{T}\right|_{V_{T}}, Q_{T} ; V_{T}\right)$, see Figure 22 and Figure 24 . The differential of $\widehat{t}_{i j}^{p}$ is given by

where $G$ is defined as follows on monomials

G\left(\widehat{t}_{i_{1} j_{1}}^{p_{1}} \widehat{t}_{i_{2} j_{2}}^{p_{2}} \cdots \widehat{t}_{i_{m} j_{m}}^{p_{m}}\right)= & \widehat{t}_{i_{1} j_{1}}^{p_{1}} t(2)_{i_{2} j_{2}}^{p_{2}} \cdots t(2)_{i_{m} j_{m}}^{p_{m}}+t(1)_{i_{1} j_{1}}^{p_{1}} \widehat{t}_{i_{2} j_{2}}^{p_{2}} \cdots \widehat{t}(2)_{i_{m} j_{m}}^{p_{m}} \\
& +\cdots t(1)_{i_{1} j_{1}}^{p_{1}} t(1)_{i_{2} j_{2}}^{p_{2}} \cdots \hat{t}_{i_{m} j_{m}}^{p_{m}},
\end{aligned}
$$

and extended to the whole algebra by linearity [EK08, Corollary 5.6].
As in Example 4.3 we have two unoriented binormal geodesic chords $c_{T \rightarrow H}$ and $c_{H \rightarrow T}$ corresponding to generators of $K C C^{*}\left(T, h_{2}\right)$ of degree 1 . Their differential is given by the same formula as in the unframed case, namely as in (4.3).

Similar to the above we now describe $K C C^{*}\left(T, h_{1}\right)$. The dg-algebra $C E^{*}\left(\left.\partial \ell\right|_{V_{T}}, Q_{T} ; V_{T}\right)$ is now more complicated and we do not fully describe it. We remark however that if setting $t(1)_{i j}^{p}=t(2)_{i j}^{p}$, it is quasi-isomorphic to the one exhibited in [EN15, Section 2.5] which is the Chekanov-Eliashberg dg-algebra of the top attaching sphere of $T^{*} T^{2}$ equipped with its standard handle decomposition consisting of one 0 -handle, two 1 -handles and one 2 -handle.

Furthermore, there is a certain dg-subalgebra of $C E^{*}\left(\left.\partial \ell\right|_{V_{T}}, Q_{T} ; V_{T}\right)$ that is generated by $\left\{c_{i j}^{p}\right\}$ which again is quasi-isomorphic to the Chekanov-Eliashberg dg-algebra of two points in $S^{1}$, see Figure 25 As above we have two unoriented binormal geodesic chords $c_{T \rightarrow H}$ and $c_{H \rightarrow T}$ corresponding

to generators of $K C C^{*}\left(T, h_{1}\right)$ of degree 1 . Their differential is given by the following.

\partial c_{H \rightarrow T}=p_{1}+c_{21}^{1} p_{2}

Example 4.5 (Unknot). Let $K \subset \mathbb{R}^{3}$ be the unknot. First split $K$ into the gluing with $H$ that is (an affine transformation of) the graph of $f(x, y)=x^{2}-y^{2}$ of two tangles as shown in Figure 26 and Figure 27.


Figure 26. The unknot obtained by gluing of the two tangles $T_{1}$ and $T_{2}$.
Let $h_{1}$ be the handle decomposition of $N\left(\Lambda_{T_{1}}\right)$ depicted in Figure 16 and let $h_{2}$ be the handle decomposition of $N\left(\Lambda_{T_{2}}\right)$ depicted in Figure 15. We already computed $K C C^{*}\left(T_{2}, h_{2}\right)$ in Example 4.4 so we will focus on $\operatorname{KCC}^{*}\left(T_{1}, h_{1}\right)$. From Figure 26 we see that we have two unoriented binormal geodesic chords $c$ and $e$ corresponding to Reeb chords $c_{1}, c_{2}, e_{T_{1} \rightarrow H}, e_{H \rightarrow T_{1}}$, where $|c|=1$ and $|e|=2$. Furthermore we have that Figure 27 reveals two more unoriented binormal geodesic chords

$a$ and $a^{\prime}$ with $|a|=\left|a^{\prime}\right|=1$. The differentials are given by (with coefficients in $\mathbb{Z}_{2}$ ) the following.
